# A HLL_nc (HLL nonconservative) method for the one-dimensional nonconservative Euler system

#### Abstract

An adaption of the original HLL scheme for the one-dimensional nonconservative Euler system modeling gaz flow in variational porosity media is proposed. Numerical scheme is detailed and algorithm is tested with two Riemann problems. Keywords nonconservative Euler system, finite volumes, HLLC.


## 1 The nonconservative Euler system

We consider the one-dimensional nonconservative Euler system modeling a compressible flow across a porous media:

where $\phi$ stands for the porosity, $\rho$ the gas density, $u$ the velocity, $P$ the pressure and $E$ the total energy composed of the internal energy $e$ and the kinetic energy: $E=\rho\left(\frac{1}{2} u^{2}+e\right)$. In addition, we close the system using the perfect gas law $P=(\gamma-1) \rho e$ with $\gamma>1$. Such a system casts in the general nonconservative form

where $U$ stands for the conservative variable vector, $F(U)$ is the conservative flux and $G(U) \partial_{x} \phi$ represents the nonconservative contribution due to the $\phi$ parameter derivative.

The conservative quantities (or conservative state) belongs to the conservative variable phase space $\Omega_{c} \subset \mathbb{R}^{+} \times \mathbb{R} \times \mathbb{R}^{+}$while the physical (primitive) variables vector $V=(\phi, \rho, u, P)$ belongs to the physical variable phase space $\Omega_{p} \subset \mathbb{R}^{+} \times \mathbb{R}^{+} \times \mathbb{R} \times \mathbb{R}^{+}$. We have a one to one mapping $(\phi, U) \rightarrow \widehat{V}(\phi, U)$ such that $V(x, t)=\widehat{V}(\phi(x), U(x, t))$ with inverse function $V \rightarrow(\phi, \widehat{U}(V))$ such that $\widehat{U}(V(x, t))=U(x, t)$. In the sequel, we shall drop the hat symbol for the sake of simplicity and we denote by $F^{\alpha}(V)=F^{\alpha}(U(V))$ and $G^{\alpha}(V)=G^{\alpha}(U(V))$ with $\alpha=\rho, u$, e the componants of vector $F(V)$ and $G(V)$ respectively.

## 2 Steady-state solutions

From a numerical point of view, the main challenge for nonconservative systems is the steady-state preservation of the numerical approximations. Let us consider a regular stationary solution $U(x)$ of system (1), we then have

Assume that $\phi=\phi(x)$ is a strictly monotone function on interval $\left[x^{-}, x^{+}\right]$ with $x^{-}<0<x^{+}$which ranges between $\phi^{-}=\phi\left(x^{-}\right), \phi^{+}=\phi\left(x^{+}\right)$and denote $U^{-}=U\left(x^{-}\right), U^{+}=U\left(x^{+}\right)$. We change the variable $x$ by the variable $\phi$ setting $U(x)=\widetilde{U}(\phi(x))=\widetilde{U}(\phi)$ solution of the system

\begin{equation*}
\frac{d}{d \phi} F(\widetilde{U}(\phi))=G(\widetilde{U}(\phi)) \tag{4}
\end{equation*}
$$

We drop the tilde symbol for the sake of simplicity and deduce that $U=$ $U(\phi)$ belongs to an integral curve parameterized with $\phi$. For a given $U^{-}$ and $\phi^{-}$, we have (at least locally) a unique curve $\mathcal{W}\left(\phi ; V^{-}\right)$solution of (4) with $\mathcal{W}\left(\phi^{-} ; V^{-}\right)=U^{-}$and $\mathcal{W}\left(\phi^{+} ; V^{-}\right)=U^{+}$.

The main advantage to use $\phi$ as a variable is that relation (4) still holds even if $\phi(x)$ is a discontinuous function of $x$ when $x^{+}, x^{+}$tend to 0 . The ability to handle the $\phi$ discontinuity is of crucial importance for the Riemann problem. Indeed, function $\phi$ is constant in the open sets $x<0$ and $x>0$ and the nonconservative problem turns to a conservative one on each half line as noticed by Andrianov \& Warnecke (2004). The nonconservative part only acts at the interface $x=0$ where $\phi$ jumps from $\phi^{-}$to $\phi^{+}$.

System (4) provides the three relations
(a) $\phi \rho u=D$,
(b) $\frac{d}{d \phi}\left(\phi \rho u^{2}+\phi P\right)=P$,
(c) $u^{2}+\frac{2 \gamma}{\gamma-1} \frac{P}{\rho}=H$,
where $D$ and $H$ are constants which correspond to the mass flow rate and the enthalpy respectively. If $u=0$, we get that $P$ and $\rho$ are constant. Assuming now that $u \neq 0$ then the curve $\mathcal{W}\left(\phi, V^{-}\right)$is implicitly given by the three relations (see Clain \& Rochette (2009)):

\end{equation*}

where constants $D, H$ and $S$ are determined by the initial condition $V^{-}$. We deduce from relation (6) an implicit relation $P=P(\phi)$ given by

In particular, when $\phi$ ranges between $\phi^{-}$and $\phi^{+}$, we deduce from relation (4) the following equality:

F^{u}\left(U^{+}\right)-F^{u}\left(U^{-}\right)=\int_{\phi^{-}}^{\phi^{+}} P(\phi) d \phi \tag{8}
\end{equation*}

## 3 The HLL_nc numerical flux

In Toro et al. (1994), the authors propose an extention of the Harten, Lax and Van Leer scheme (Harten et al. (1983)) introducing an intermediate wave which corresponds to the contact discontinuity associated to eigenvalue $\lambda=u$. To evaluate the solution, the authors use the Riemann invariants i.e. the pressure and the velocity invariance in the Euler case to provide a new set of equations. Following the same idea, we introduce the intermediate wave which corresponds to the contact discontinuity $\lambda_{0}=0$ deriving from the porosity change across the interface $x=0$ and use the associated Riemann invariants.

Let us consider the Riemann problem with initial conditions $V_{L}$ and $V_{R}$ such that $U(x, 0)=U_{L}, \phi(x)=\phi_{L}$ for $x<0$ and $U(x, 0)=U_{R}, \phi(x)=\phi_{R}$ for $x>0$. We assume that we know two approximations $S_{L}<S_{R}$ of $\lambda_{1}=u-c$ and $\lambda_{3}=u+c$ respectively and we seek an approximation of the Riemann problem solution introducing intermediate states $V_{L}^{*}, V_{R}^{*}$ and $V_{a}$. Three situations then arise whether $S_{R}<0, S_{L}>0$ or $S_{L}<0<S_{R}$ (see figure 1). The goal is to evaluate a flux approximation $F^{-}$and $F^{+}$on the left and right sides of the interface $x=0$ which shall be used in the finite volume scheme. We now detail the three situations in the following section.


Figure 1: Supersonic configuration with $S_{L}>0$ (left), supersonic configuration with $S_{R}<0$ (right), subsonic configuration (bottom).

### 3.1 The supersonic case $S_{L}>0$

We first treat the situation when $S_{L}>0$. In this case we obtain the following configuration depicted in figure 1 (left). We have to compute $F^{-}=F_{L}$ and $F^{+}=F_{R}^{*}$ to provide the flux accross the interface.

### 3.1.1 Equations

From the conservation of mass and energy, we have

\end{align*}

On the other hand, we want to preserve the Riemann invariants hence

$$
\begin{align*}
F_{L}^{\rho}=\phi_{L} \rho_{L} u_{L} & =\phi_{R} \rho_{R}^{*} u_{R}^{*}  \tag{11}\\
F_{L}^{P}=\phi_{L} u_{L}\left(E_{L}+P_{L}\right) & =\phi_{R} u_{R}^{*}\left(E_{R}^{*}+P_{R}^{*}\right)  \tag{12}\\
\frac{P_{L}}{\left(\rho_{L}\right)^{\gamma}} & =\frac{P_{R}^{*}}{\left(\rho_{R}^{*}\right)^{\gamma}} \tag{13}
\end{align*}
$$

with $E_{L}=\frac{1}{2} \rho_{L}\left(u_{L}\right)^{2}+\frac{P_{L}}{\gamma-1}$ and $E_{R}^{*}=\frac{1}{2} \rho_{R}^{*}\left(u_{R}^{*}\right)^{2}+\frac{P_{R}^{*}}{\gamma-1}$.
Finally, we use the fact that $U_{L}$ and $U_{L}^{*}$ belong to the same integral curve and relation (8) writes

F_{R}^{*, u}-F_{L}^{u}=\int_{\phi_{L}}^{\phi_{R}} P(\phi) d \phi=F^{u}\left(U_{R}^{*}\right)-F^{u}\left(U_{L}\right) \tag{14}
\end{equation*}
$$

which leads to $F_{R}^{*, u}=F^{u}\left(U_{R}^{*}\right)=\phi_{R}\left(\rho_{R}^{*}\left(u_{R}^{*}\right)^{2}+P_{R}^{*}\right)$. Note that the computation of $U_{a}$ and the other fluxes are not performed since we only require the fluxes on both side of the interface $x=0$.

To sum-up, we obtain the following system

E_{L}=\frac{1}{2} \rho_{L}\left(u_{L}\right)^{2}+\frac{P_{L}}{\gamma-1}, \\
E_{R}^{*}=\frac{1}{2} \rho_{R}^{*}\left(u_{R}^{*}\right)^{2}+\frac{P_{R}^{*}}{\gamma-1} \\
F_{R}^{*, u}=\phi_{R}\left(\rho_{R}^{*}\left(u_{R}^{*}\right)^{2}+P_{R}^{*}\right)
\end{array}\right.
$$

where $\phi_{L}, \rho_{L}, u_{L}, P_{L}, \phi_{R}$ are given and $\rho_{R}^{*}, u_{R}^{*}, P_{R}^{*}, F_{R}^{*}$ are the unknowns.

### 3.1.2 Resolution

To solve system $\left(\mathcal{S}_{L}\right)$, we introduce a function

$$
\rho \rightarrow g_{\text {sup }}\left(\rho ; V_{L}, \phi_{R}\right)=g_{\text {sup }}(\rho)
$$

such that $g_{\text {sup }}\left(\rho_{R}^{*}\right)=0$. For a given predicted value $\rho_{R}^{*}$, we compute $P_{R}^{*}$ with relation (13)

$$
P_{R}^{*}=P_{R}^{*}\left(\rho_{R}^{*}\right)=P_{L} \frac{\left(\rho_{R}^{*}\right)^{\gamma}}{\left(\rho_{L}\right)^{\gamma}}
$$

Using relation (11), we deduce the velocity

$$
u_{R}^{*}=u_{R}^{*}\left(\rho_{R}^{*}\right)=u_{L} \frac{\phi_{L} \rho_{L}}{\phi_{R} \rho_{R}^{*}}
$$

On the other hand, relations (12) and (11) give

$$
\frac{E_{L}+P_{L}}{\rho_{L}}=\frac{E_{R}^{*}+P_{R}^{*}}{\rho_{R}^{*}}
$$

which provides the equality

$$
E_{R}^{*}=E_{R}^{*}\left(\rho_{R}^{*}\right)=\left(E_{L}+P_{L}\right) \frac{\rho_{R}^{*}}{\rho_{L}}-P_{R}^{*}
$$

Let us define the function

$$
g_{\text {sup }}\left(\rho_{R}^{*}\right)=E_{R}^{*}-\frac{1}{2} \rho_{R}^{*}\left(u_{R}^{*}\right)^{2}-\frac{P_{R}^{*}}{\gamma-1}
$$

we then seek $\rho_{R}^{*}$ such that $g_{\text {sup }}\left(\rho_{R}^{*}\right)=0$ where the physical state $V_{R}^{*}=$ $\left(\phi_{R}, \rho_{R}^{*}, u_{R}^{*}, P_{R}^{*}\right)$ has to correspond to a supersonic state.

Problem $\left(\mathcal{S}_{L}\right)$ has zero, one or two solutions (see Clain \& Rochette (2009)). For the two zeros cases, we have $\rho_{\text {sup }}<\rho_{\text {sub }}$ and choose $\rho_{\text {sup }}$ which corresponds to the supersonic case. Numericaly, we employ a Lagrange algorithm or an inexact Newton method taking a very small value for $\rho$ as an initial condition to converge to density $\rho_{\text {sup }}$.

### 3.2 The supersonic case $S_{R}<0$

In case $S_{R}<0$, we have to compute $F^{-}=F_{L}^{*}$ and $F^{+}=F_{R}$ to provide the flux accross the interface. The system of equation is similar to the previous one where we substitute variables $V_{L}$ and $V_{R}^{*}$ with $V_{L}^{*}$ and $V_{R}$ respectively.

### 3.3 The subsonic case

We now face the more complex situation since all the states have to be estimated to compute $F^{-}=F_{L}^{*}$ and $F^{+}=F_{R}^{*}$. We consider the configuration depicted in figure ( 1, bottom) where we assume that $V_{L}$ and $V_{L}^{*}$ are separated with a shock of velocity $S_{L}$ and $V_{R}$ and $V_{R}^{*}$ by a shock of velocity $S_{R}$ while interface $x=0$ corresponds to the porosity change.

### 3.3.1 Equations

Rankine-Hugoniot relations associated to the waves $S_{L}$ and $S_{R}$ yield

On the other hand, we assume that $V_{L}^{*}$ and $V_{R}^{*}$ are linked with the Riemann invariants across the contact discontinuity generated by the porosity hence

\phi_{R} u_{R}^{*}\left(E_{R}^{*}+P_{R}^{*}\right) & =\phi_{L} u_{L}^{*}\left(E_{L}^{*}+P_{L}^{*}\right),  \tag{18}\\
\frac{P_{R}^{*}}{\left(\rho_{R}^{*}\right)^{\gamma}} & =\frac{P_{L}^{*}}{\left(\rho_{L}^{*}\right)^{\gamma}} . \tag{19}
\end{align*}

For the density and the energy equations, relations cast in the conservative form

$$
\begin{align*}
F_{R}^{*, \rho} & =F_{L}^{*, \rho},  \tag{20}\\
F_{R}^{*, P} & =F_{L}^{*, P} . \tag{21}
\end{align*}
$$

For the impulsion equation, since $U_{L}^{*}$ and $U_{R}^{*}$ belongs to the same integral curve, the flux variation across the interface is given by

F_{R}^{*, u}-F_{L}^{*, u}=\int_{\phi_{L}}^{\phi_{R}} P(\phi) d \phi=F^{u}\left(U_{R}^{*}\right)-F^{u}\left(U_{L}^{*}\right) . \tag{22}

At last, the definition of the total energy gives

To sum-up, we obtain the following system $\left(\mathcal{S}_{\text {sub }}\right)$

### 3.3.2 Resolution

To solve system (24)-(33), we introduce a function $\rho \rightarrow g_{\text {sub }}(\rho)$ such that $g_{\text {sub }}\left(\rho_{L}^{*}\right)=0$. For a given predicted value $\rho_{L}^{*}$, we compute

and relations (26) and (24) yield

Relations (25), (28), (34) and (35) give the following linear system

and we deduce $P_{L}^{*}\left(\rho_{L}^{*}\right), P_{R}^{*}\left(\rho_{L}^{*}\right), E_{R}^{*}\left(\rho_{L}^{*}\right)$ and $E_{L}^{*}\left(\rho_{L}^{*}\right)$.
Substituting $F_{L}^{*, u}$ from equation (30) and $F_{R}^{*, u}$ from equation (31) in relation (29) provide

Mass flow $D=\phi_{R} \rho_{R}^{*} u_{R}^{*}=\phi_{L} \rho_{L}^{*} u_{L}^{*}$ is then given by

and we finally compute $u_{L}^{*}, u_{R}^{*}$ with relation (24). The predicted value $\rho_{L}^{*}$ if a correct estimate is relation (32) or (33) are satisfied so we define

## 4 Numerical tests

Two Riemann problems are considered to test the new scheme. The following table gives the initial conditions where the initial discontinuity is situated at $x=0.8$. We use uniform mesh of 200 cells on domain $[0,2]$ while the time step is controled by the classical CFL condition.

We plot in figure (2) the density, pressure and velocity of two approximations (see Clain \& Rochette (2009) for the Rusanov nonconservative scheme) and exact solution for the supersonic situation. We observe that the 0 -contact discontinuity is very well approximated due to the specific scheme we employ. Figure ( 2 , right bottom) represents function $g_{\text {sup }}$ where the smaller zero corresponds to $\rho_{R}^{*}$. Note that the Lagrange algorithm easily converges since the bassin convergence is very large.

We plot in figure (3) the density, pressure and velocity of two approximations and exact solution for the subsonic situation. We observe that

the 0 -contact discontinuity is still very well approximated while the other shock waves are smooth due to the numerical viscosity. Figure (3, right bottom) represent function $g_{\text {sub }}$. We have two branches but only the left one has a physical interest. The bassin convergence is narrow and Lagrange algorithm fails if one starts with a wrong predicted density (on the wrong branch for example).
