# UPPER SEMICONTINUITY OF TRAJECTORY ATTRACTORS OF 3D NAVIER-STOKES EQUATIONS WITH HYPERVISCOSITY

#### Abstract

We regularized the 3D Navier-Stokes equations by adding a fourthorder viscosity term. We study the upper semicontinuity, of the global attractors of the Leray-Hopf weak solutions of the regularized 3D Navier-Stokes equations, as the artificial dissipation $\varepsilon$ goes to 0 , and the regularized problem (see equation (1.1)) limits to the standard 3D Navier-Stokes equations. We also consider applications of obtained results to the regularized problem by allowing the family of forcing functions to vary with $\varepsilon$, for $\varepsilon>0$.


## 1. Introduction

In this paper, we study the robustness, or upper semicontinuity of the global attractors of the Leray-Hopf weak solutions of modified three dimensional NavierStokes equations. We regularized the 3D Navier-Stokes system by adding a fourth order artificial viscosity term (Laplacian square) to the conventional system

p\left(x+L e_{i}, t\right)=p(x, t), u^{\varepsilon}\left(x+L e_{i}, t\right)=u^{\varepsilon}(x, t) i=1,2,3, t \in(0, \infty)
\end{gather*}

where $\Omega=(0, L)^{3}$ with periodic boundary conditions and $\left(e_{1}, \ldots, e_{d}\right)$ is the natural basis of $\mathbb{R}^{d}$. Here $\varepsilon>0$ is the artificial dissipation parameter, $u^{\varepsilon}$ is the velocity vector field, $p$ is the pressure, $\nu>0$ is the kinematic viscosity of the fluid and $f$ is a given force field. For $\varepsilon=0$, the model is reduced to 3D Navier-Stokes system.

Mathematical model for such fluid motion has been used extensively in turbulence simulations (see e.g. [3, 4, 7, 10]). For further discussion of theoretical results concerning (1.1), see [1, 2, 5, 12, 15, 16, 20.

For the 3D Navier-Stokes system weak solutions of problem are known to exist by a basic result by J. Leray from 1934 [11], only the uniqueness of weak solutions remains as an open problem. Then the known theory of global attractors of infinite dimensional dynamical systems is not applicable to the 3D Navier-Stokes system.

The theory of trajectory attractors for evolution partial differential equations was developed in [14, 18, which the uniqueness theorem of solutions of the corresponding initial-value problem is not proved yet, e.g. for the 3D Navier-Stokes system (see [8, 14, 17, 18). Such trajectory attractor is a classical global attractor but in the space of weak solutions defined on $[0, \infty)$, with the corresponding semigroup being simply the translation in time of such solutions. A compact set $\mathfrak{A} \Subset E$ is said to be a global attractor of a semigroup $\{S(t), t>0\}$ acting in a Banach or

[^0]Hilbert space $E$ if $\mathfrak{A}$ is strictly invariant with respect to $\{S(t)\}: S(t) \mathfrak{A}=\mathfrak{A} \forall t \geq 0$ and $\mathfrak{A}$ attracts any bounded set $B \subset E: \operatorname{dist}(S(t) B, \mathfrak{A}) \rightarrow 0(t \rightarrow \infty)$ (see [13], [14], 17], 18, (20]).

In this article, we study the upper semicontinuity, of the global attractors of the Leray-Hopf weak solutions of a regularized 3D. Navier-Stokes equations, as the artificial dissipation $\varepsilon$ goes to 0 , and the regularized problem (1.1) limits to the standard 3D Navier-Stokes equations. While there exist other examples of such robustness in the literature of the Navier-Stokes equations, the specific emphasis on the regularized problem is new for the 3D Navier-Stokes equations and is of interest. This would bean extension of the earlier work on Ou and Sritharan for the 2D Navier-Stokes equations, see references [15] and [16]. It is now known that there is a global attractor $\mathfrak{A}_{0}$ for the Leray-Hopf weak solutions of the 3D NavierStokes equations, see Sell [17] or [18].

The main object of this paper to show that there is a global attractor, which one might denote by $\mathfrak{A}_{\varepsilon}$, for the regularized problem (1.1), and that the family $\left\{\mathfrak{A}_{\varepsilon}\right\}$ is upper semicontinuous at $\varepsilon=0$. Moreover, we can modify the argument described above so that the final result will have broader applicability by allowing the family of forcing functions $f^{\varepsilon}$ to vary with $\varepsilon$, for $\varepsilon>0$.

The family of sets $\mathfrak{A}_{\varepsilon}, 0<\varepsilon \leq 1$ is robust at $\mathfrak{A}_{0}$, or is upper semicontinuous with respect to $\varepsilon$ at $\varepsilon_{0}=0$, provided that, for every $\varepsilon_{0}>0$, there is a neighborhood $O\left(\varepsilon_{0}\right)$ of $0 \in \mathbb{R}$ and a neighborhood $N_{\varepsilon_{0}}\left(\mathfrak{A}_{0}\right)$ of $\mathfrak{A}_{0}$, such that $\mathfrak{A}_{\varepsilon} \subset N_{\varepsilon_{0}}\left(\mathfrak{A}_{0}\right)$, for every $\varepsilon \in O\left(\varepsilon_{0}\right)$ with $\varepsilon>0$, see (23.13) in 18 .

The paper is organized as follows. In Section 2, we present the relevant mathematical framework for the paper. In Section 3, we recall the definition of the trajectory attractor $\mathfrak{A}_{0}$ of the conventional 3-D Navier-Stokes equations. In Section 4, we study the regularized problem (see equation (1.1)) limits to the standard 3D Navier-Stokes equations, as the artificial dissipation $\varepsilon$ goes to 0 , then we show the existence of trajectory attractor $\mathfrak{A}_{\varepsilon}$. In Section 5 , we present the main result of this paper, that is, a theorem on the upper semicontinuity on the attractors $\mathfrak{A}_{\varepsilon}$. Finally, an application of our general results to the study of the robustness of the system (1.1) with a perturbed external force.

## 2. Preliminary

We denote by $H^{m}(\Omega)$, the Sobolev space of $L$-periodic functions endowed with the inner product

and by $H^{-m}(\Omega)$ the dual space of $H^{m}(\Omega)$. We denote by $\dot{H}^{m}(\Omega)$ the subspace of $H^{m}(\Omega)$ with, zero average $\dot{H}^{m}(\Omega)=\left\{u \in H^{m}(\Omega) ; \int_{\Omega} u(x) d x=0\right\}$.

- We introduce the following solenoidal subspaces $V_{s}, s \in \mathbb{R}^{+}$which are important to our analysis

see [20]. We refer the reader to Temam [21] for details on these spaces. Here the faces of $\Omega$ are numbered as

Here $\gamma_{0}, \gamma_{1}$ are the trace operators and $n$ is the unit outward normal on $\partial \Omega$.

- The space $V_{0}$ is endowed with the inner product $(u, v)_{L^{2}(\Omega)}$ and norm $\|u\|=(u, u)_{L^{2}(\Omega)}^{1 / 2}$.
- $V_{1}$ is the Hilbert space with the norm $\|u\|_{1}=\|u\|_{V_{1}}$. The norm induced by $\dot{H}^{1}(\Omega)$ and the norm $\|\nabla u\|_{L^{2}(\Omega)}$ are equivalent in $V_{1}$.
- $V_{2}$ is the Hilbert space with the norm $\|u\|_{2}=\|u\|_{V_{2}}$. In $V_{2}$ the norm induced by $\dot{H}^{2}(\Omega)$ is equivalent to the norm $\|\Delta u\|_{L^{2}(\Omega)}$.
$V_{s}^{\prime}$ denote the dual space of $V_{s}$. We present the topology to be used for generating the neighborhood of robustness. Let $F$ any vector space. A metric $d(f, g)$ on $F$ is said to be invariant if one has

A Fréchet space is a complete topological vector space whose topology is induced by a translation invariant metric $d(f, g)$. Given a Banach space $X$, with norm $\|\cdot\|_{X}$ and $1 \leq p<\infty$, we denote by $L_{l o c}^{p}[0, \infty ; X)$ the Fréchet space of mesurable functions $f:[0, \infty) \rightarrow X$ that are $p$-integrable over $[0, T]$, for each $0<T<\infty$, endow with the metric

We denote by $L_{l o c}^{p}(0, \infty ; X)$ the Fréchet space of mesurable functions $f:(0, \infty) \rightarrow X$ that are $p$-integrable over $\left[t_{0}, T\right]$, for each $0<t_{0} \leq T<\infty$ endow with the metric

Similarly for $p=\infty$, we will let $L_{l o c}^{\infty}(0, \infty ; X)$ denote the collection of all functions $f:(0, \infty) \rightarrow X$ with the property that, for all $\tau$ and $T$ with $0<T<\infty$, one has ess $\sup _{0<s<T}\|f\|_{X}<\infty$. We denote by $C[0, \infty ; X)$ the space of strongly continuous functions from $[0, \infty)$ to $X$, endowed with the topologie of the uniform convergence over compact sets and by $C_{w}[0, \infty ; X)$ the space of weakly continuous functions from $[0, \infty)$ to $X$. We denote by $L^{\infty} C=L^{\infty}(\mathbb{R}, X) \cap C(\mathbb{R}, X)$ the Fréchet space $L^{\infty} C$ endow with the $L_{\text {loc }}^{\infty}$-topology, wich is the topology of uniform convergence on bounded sets.

Let $E$ be a complete metric space with metric $d$. We write $B_{r}$ for the open ball centre $0 \in E$ and radius $r$. The following quantity is called the Hausdorff (non-symmetric) semidistance from a set $X$ to a set $Y$ in a Banach space $E$

Let $M$ be a subset of $E$ and let $\mathbb{R}^{+}=[0, \infty)$. A mapping $\sigma=\sigma(u, t)$, where $\sigma: M \times[0, \infty) \rightarrow M$ is said to be a semiflow on $M$ provided the following hold

1) $\sigma(w, 0)=w$, for all $w \in M$.
2) The semigroup property holds, i. e,

3) The mapping $\sigma: M \times(0, \infty) \rightarrow M$ is continuous.

If in addition the mapping $\sigma: M \times[0, \infty) \rightarrow M$ is continuous we will say that the semiflow is continuous at $t=0$. Here we use $t>0$ in order that the Robustness Theorem 23.14 in [18] is valid, see Sell [18] and Hale [8]. For any $u \in M$ the positive trajectory through $u$ is defined as the set $\gamma^{+}(u)=\{\sigma(t) u, t \geq 0\}$. For any set $B \subset M$ we define the positive hull $\mathcal{H}^{+}(B)$ and the omega limit set $\omega(B)$ as follows

If $\mathcal{A} \subset E$ and $\varepsilon>0$ we write

for the open $\varepsilon$-neighbourhood of $\mathcal{A}$.
We denote by $A$ the Stokes operator $A u=-\triangle u$ for $u \in D(A)$.We recall that the operator $A$ is a closed positive self-adjoint unbounded operator, with
$D(A)=\left\{u \in V_{0}, A u \in V_{0}\right\}$. We have in fact, $D(A)=\dot{H}^{2}(\Omega) \cap V_{0}=V_{2}$. The spectral theory of $A$ allows us to define the powers $A^{l}$ of $A$ for $l \geq 1, A^{l}$ is an unbounded self-adjoint operator in $V_{0}$ with a domain $D\left(A^{l}\right)$ dense in $V_{2} \subset V_{0}$. We set here

The space $D\left(A^{l}\right)$ is endowed with the scalar product and the norm

Now define the trilinear form $b(., .,$.$) associated with the inertia terms$

The continuity property of the trilinear form enables us to define (using Riesz representation theorem) a bilinear continuous operator $B(u, v) ; V_{2} \times V_{2} \rightarrow V_{2}^{\prime}$ will be defined by

Hereafter, $c_{i} \in \mathbb{N}$, will denote a dimensionless scale invariant positive constant which might depend on the shape of the domain. The trilinear form $b(., .,$.$) is$ continuous on $\dot{H}^{m_{1}}(\Omega) \times \dot{H}^{m_{2}+1}(\Omega) \times \dot{H}^{m_{3}}(\Omega), m_{i} \geq 0$

see [6, 18. The bilinear operator satisfies the inequality

We recall some inequalities that we will be using in what follows.
Young's inequality

where $\lambda_{1}$ is the smallest eigenvalue of the Stokes operator $A$.

## 3. Navier-Stokes equations

The conventional Navier-Stokes system can be written in the evolution form

\end{gather*}

Let $f \in L^{\infty}\left(0, \infty ; V_{0}\right)$ be given. We will say that a function $u$ is a weak solution of the 3D Navier-Stokes of Class $L H$ (Leray-Hopf ) on $[0, \infty)$ provided that $u(x, 0)=u_{0}(x) \in V_{0}$, and the following properties hold

1) $u \in L^{\infty}\left(0, \infty ; V_{0}\right) \cap L_{l o c}^{2}\left[0, \infty ; V_{1}\right)$.
2) $\frac{d u}{d t} \in\left[L_{l o c}^{\frac{4}{3}} 0, \infty ; V_{1}^{\prime}\right)$.

Taking the inner product of (3.1) with $u$, and using (2.4) we have

by application of Young's inequality and the Poincaré's Lemma, yields

3) which implies that

Integrating (3.2) over $\left[t_{0}, t\right]$ we find that

4) The function $u$ satisfies the following equality

for all $v \in V_{1}$ and for all $t \geq t_{0} \geq 0$.
The proof of the following theorem is given in [12, [13, 21].
Theorem 3.1. Let $f \in V_{1}^{\prime}$ and $u_{0} \in V_{0}$ be given. Then for every $T>0$, there exists a weak solution $u(t)$ of (3.1) from the space $L^{2}\left(0, T ; V_{1}\right) \cap L^{\infty}\left(0, T ; V_{0}\right)$, such that $u(x, 0)=u_{0}$ and $u(t)$ satisfies the energy equality (3.6).

Moreover (see [21]), $u($.$) is weakly continuous from [0, T]$ into $V_{0}$, the function $u \in C_{w}\left([0, T] ; V_{0}\right)$ and consequently $u(x, 0)=u_{0}(x) \in V_{0}$. Let $W$ is the set of all Leray-Hopf weak solutions $u$ (.) of equation (3.1) in the space $L^{\infty}\left(0, \infty ; V_{0}\right) \cap$ $L_{l o c}^{2}\left[0, \infty ; V_{1}\right)$ that satisfy the following properties

- $\frac{d u}{d t} \in L_{l o c}^{\frac{4}{3}}\left(0, \infty ; V_{1}^{\prime}\right)$;
- for almost all $t$ and $t_{0}$, with $t>t_{0}>0$, inequalities (3.5 3.6) are valid.

Let $X^{0}$ denote the Fréchet space used to define the Leray-Hopf weak solutions. Thus

where $\varphi \in C_{w}\left[0, \infty ; V_{0}\right)$ and we let $\mathfrak{F}^{0}$ denote a compact, translation invariant set of forcing functions $f$ in

L^{\infty} C=L^{\infty}\left(\mathbb{R}, L^{2}(\Omega)\right) \cap C\left(\mathbb{R}, L^{2}(\Omega)\right)
$$

where the topology on the Fréchet space $L^{\infty} C$ is the topology of uniform convergence on bounded sets in $\mathbb{R}$.

Then, we use the Leray-Hopf solutions of the 3D Navier-Stokes equations with $\varepsilon=0$ to generate a semiflow $\pi^{0}$ on $\mathfrak{F}^{0} \times X^{0}$, where

$f_{\tau}(t)=f(\tau+t)$ and $u(t)=S^{0}(f, t) \varphi$ is the Leray-Hopf solution of the 3D NavierStokes equations that satisfies $u(0)=S^{0}(f, 0) \varphi=\varphi(0)$. By using the theory of generalized weak solutions, as in Sell [17] or [18], we note that $\pi^{0}$ has a global attractor $\mathfrak{A}_{0} \subset \mathfrak{F}^{0} \times X^{0}$ see Theorem 65.12 in [18].

## 4. The regularized Navier-Stokes system

Using the operators defined in the previous section, we can write the modified system (1.1) in the evolution form

For $\varepsilon>0$, we let $\pi^{\varepsilon}$ denote the semiflow on $\mathfrak{F}^{0} \times X^{0}$ generated by the weak solutions of regularized 3D Navier-Stokes equations of (4.1). Thus

is the weak solution of (4.1) that satisfies $u^{\varepsilon}(0)=\varphi(0)=u_{0}^{\varepsilon}(0)$.
Theorem 4.1. Let $\Omega \subset \mathbb{R}^{3}$ and let $f \in L^{2}\left(0, T ; V_{0}\right)$ and $u_{0}^{\varepsilon} \in V_{1}$ be given. Then there exists a unique weak solution of (4.1) which satisfies $u^{\varepsilon} \in L^{\infty}\left(0, T ; V_{0}\right) \cap L^{2}\left[0, T ; V_{1}\right)$ and $u^{\varepsilon} \in C_{w}\left([0, T] ; V_{0}\right), \forall T>0$.

For the proof see, J. Lions [12, Remark 6.11].
Proposition 4.2. $f \in L^{2}\left(0, T ; V_{0}\right) \cap L^{\infty}\left(0, T ; H^{-4}\right)$ and $u^{\varepsilon} \in V_{0}$ then the weak solution $u^{\varepsilon}(t)$ of the modified Navier-Stokes equations satisfy
i) $u^{\varepsilon}$ is uniformly bounded in $L^{2}\left(0, T ; V_{2}\right)$,
ii) $u^{\varepsilon}$ is uniformly bounded in $L^{\infty}\left(0, T ; V_{0}\right)$,
iii) $\frac{d}{d t} u^{\varepsilon}(t)$ is uniformly bounded in $L^{\infty}\left(0, T ; H^{-4}\right)$.

Proof. Taking the inner product of 4.1) by $u^{\varepsilon} \in V_{2}$, we obtain

We need three forms of convergence for appropriate subsequences.
Lemma 4.3. There exist a sequence $\varepsilon_{n}$ Such that For
(i) $u^{\varepsilon_{n}} \rightarrow u \quad$ in $L^{2}\left(0, T ; V_{1}\right)$ weakly;
(ii) $u^{\varepsilon_{n}} \rightarrow u \quad$ in $L^{\infty}\left(0, T ; V_{0}\right)$ weak-star;
(iii) $u^{\varepsilon_{n}} \rightarrow u \quad$ in $L^{2}\left(0, T ; V_{0}\right)$ strongly,
as $\varepsilon_{n} \rightarrow 0$.
Proof. It follows from Proposition $4.2(i)$ and (ii), that easily $u^{\varepsilon_{n}} \in L^{2}\left(0, T ; V_{1}\right) \cap L^{\infty}\left(0, T ; V_{0}\right)$ with bounds independent of $\varepsilon_{n}$. The convergence results $(i)$ and (ii) are satisfied by the weak solutions. Hence the sequence $u^{\varepsilon_{n}}$ converges strongly in $L^{2}\left(0, T ; V_{0}\right)$ and so the item (iii) is true for $u^{\varepsilon_{n}}$.

As a consequence of Proposition 4.2, we have

Proposition 4.4. $\forall w \in L^{2}\left(0, T ; V_{1}\right), \forall w^{\prime} \in L^{2}\left(0, T ; V_{1}^{\prime}\right)$
a) $\lim _{n \rightarrow \infty} \int_{0}^{T}\left(\partial_{t} u^{\varepsilon_{n}}(t), w\right) d t=\int_{0}^{T}\left(\partial_{t} u(t), w(t)\right) d t$,
b) $\lim _{n \rightarrow \infty} \int_{0}^{T}\left(\nabla u^{\varepsilon_{n}}(t), \nabla w(t)\right) d t=\int_{0}^{T}(\nabla u(t), \nabla w(t)) d t$,
c) $\lim _{n \rightarrow \infty} \int_{0}^{T} b\left(u^{\varepsilon_{n}}(t), u^{\varepsilon_{n}}(t), w(t)\right) d t=\int_{0}^{T} b(u(t), u(t), w(t)) d t$.
the strong convergence of $u^{\varepsilon_{n}} \rightarrow u$ in $L^{2}\left(0, T ; V_{0}\right)$ implies $\left.c\right)$.
Theorem 4.5. [22, Lemma 4.2]
The injection of $\mathcal{X}=\left\{u \in L^{2}\left(0, T ; V_{1}\right) \cap L^{\infty}\left(0, T ; V_{0}\right) ; \frac{d u}{d t} \in L^{\infty}\left(0, T ; H^{-4}\right)\right\}$ into $\mathcal{Y}=\left\{u \in L^{2}\left(0, T ; V_{0}\right) \cap C\left(0, T ; H^{-4}\right)\right\}$ is compact.

Theorem 4.6. Let $\Omega \subset \mathbb{R}^{3}$ and $u^{\varepsilon}(t)$, be the weak solution of problem 4.1) given by Theorem 4.1 Then as $\varepsilon \rightarrow 0$, the solution $u^{\varepsilon}$ converges to the weak solution of the Navier-Stokes equations.

Proof. From $i$ ) and $i i$ ) of Proposition 4.2 we can deduce that the weak solutions $u^{\varepsilon_{n}} \in L^{2}\left(0, T ; V_{1}\right) \cap L^{\infty}\left(0, T ; V_{0}\right)$ are bounded in independent of $\varepsilon_{n}$. This establishes items $(i)$ and $(i i)$ of Lemma4.3. Additionally, $\frac{d u^{\varepsilon_{n}}}{d t} \in L^{\infty}\left(0, T ; H^{-4}\right)$ with bounds independent of $\varepsilon_{n}$ indicates that $u^{\varepsilon_{n}} \in \mathcal{X}$. The compactness Theorem 4.5 implies the strong convergence in (iii) of Lemma4.3.

Taking the inner product of (4.1) with a test function $\varphi \in \mathcal{D}\left(0, T ; \mathcal{D}\left(A^{2}\right)\right)$ 21] and then integrate by parts to get,

The term $\varepsilon_{n} \int_{0}^{T}\left(\triangle u^{\varepsilon_{n}}(t), \triangle \varphi(t)\right) d t \rightarrow 0$ as $\varepsilon_{n} \rightarrow 0$, since the weak solution $u^{\varepsilon_{n}} \in L^{2}\left(0, T ; V_{1}\right)$ with bound uniform in $\varepsilon_{n}$ and

Since $u \in L^{2}\left(0, T ; V_{1}\right) \cap L^{\infty}\left(0, T ; V_{0}\right)$, we can conclude that $u$ is indeed the weak solution for the conventional Navier-Stokes equations. We need the following fact

Since $f^{n} \rightarrow f^{0}$ in the $L^{\infty} C$ topology and $\varphi^{n} \rightarrow \varphi_{0}$ in the $X^{0}$-topology this means that $\left\|g_{n}\right\| \rightarrow 0$ and $\left\|w_{n}(0)\right\| \rightarrow 0$ as $n \rightarrow \infty$, it follows from (4.22) that $\left\|S^{\varepsilon_{n}}\left(f^{n}, t\right) \varphi^{n}-S^{\varepsilon_{0}}\left(f^{0}, t\right) \varphi^{0}\right\| \leq C_{2}\left\|u_{0}^{\varepsilon_{n}}-u_{0}^{\varepsilon_{0}}\right\|^{2}+\frac{T C_{2}}{\nu}\left\|f^{n}-f\right\|^{2} \rightarrow 0$, as $n \rightarrow \infty$.
It follows that $\pi^{\varepsilon}$ is a continuous semiflows on $X^{0}$. Hence $\pi^{\varepsilon}$ approximates $\pi^{0}$ on $B_{R_{1}}$ uniformly on $[0, T]$.

Regarding the existence of the attractor $\mathfrak{A}_{\varepsilon}$ when $\varepsilon>0$, we use especially the related papers of Chepyzhov and Vishik, such as 14 to show that the system (4.1) possesses a global attractor. For $\varepsilon>0$, we consider the trajectory space $\mathcal{K}_{\varepsilon}$ of the modified Navier-Stokes equations (4.1). $\mathcal{K}_{\varepsilon}$ is the union of all weak solutions $u^{\varepsilon} \in X^{0}$ that satisfy (4.1), see (6.163) in [12]. Using the described scheme in [14], we construct the spaces $\mathcal{S}_{b}$

\|v\|_{L_{b}^{2}\left(0, T ; V_{1}\right)}=\sup _{t \geq 0}\left(\int_{t}^{t+1}\|v(s)\|_{1}^{2} d s\right)^{\frac{1}{2}},\|v\|_{L^{\infty}\left(0, T ; V_{0}\right)}=\operatorname{ess} \sup _{t \geq 0}\|v\|
$$

and

\left\|\partial_{t} v\right\|_{L_{b}^{2}\left(0, T ; D(A)^{\prime}\right)}=\sup _{t \geq 0}\left(\int_{t}^{t+1}\|v(s)\|_{D(A)^{\prime}}^{2} d s\right)^{\frac{1}{2}}

We need a topology in the space $\mathcal{K}_{\varepsilon}$. We define on $X^{0}$ the following sequential topology which we denote $\Gamma$.

By definition, a sequence of functions $\left\{v_{n}\right\} \subseteq X^{0}$ converges to a function $v \in X^{0}$ in the topology $\Gamma$ as $n \rightarrow \infty$ if, for any $T>0, v_{n} \rightarrow v$ weakly in $L^{2}\left(0, T ; V_{1}\right)$; $v_{n} \rightarrow v$ weak-* in $L^{\infty}\left(0, T ; V_{0}\right)$ and $v_{n} \rightarrow v$ strongly in $L^{2}\left(0, T ; V_{0}\right)$, as $n \rightarrow \infty$.

We consider the topology $\Gamma$ on $\mathcal{K}_{\varepsilon}$. It is easy prove that the space $\mathcal{K}_{\varepsilon}$ is closed in $\Gamma$. From the definition of $\mathcal{K}_{\varepsilon}$, it follows that $\pi^{\varepsilon} \mathcal{K}_{\varepsilon} \subset \mathcal{K}_{\varepsilon}$ for all $t \geq 0$.

Proposition 4.10. If $u^{\varepsilon}(t)$ is a solution of 4.1), then the following inequalities hold for all $t>0$

\nu \int_{t}^{t+1}\left\|u^{\varepsilon}(s)\right\|_{1}^{2} d s \leq \frac{e^{-\nu \lambda_{1} t}}{\nu \lambda_{1}}\left\|u_{0}^{\varepsilon}\right\|^{2}+\frac{\|f\|^{2}}{\nu^{2} \lambda_{1}^{2}}+\frac{\|f\|^{2}}{\nu \lambda_{1}} . \tag{4.25}

& +\frac{c_{0}\|f\|^{4}}{\nu^{4} \lambda_{1}^{4}}+c_{0} e^{-\nu 2 \lambda_{1} t}\left\|u_{\varepsilon}(0)\right\|^{4}+2 c_{0} \frac{\|f\|^{2}}{\nu^{2} \lambda_{1}^{2}} e^{-\nu \lambda_{1} t}\left\|u_{\varepsilon}(0)\right\|^{2} \\
& \leq \frac{c_{7} e^{-\nu \lambda_{1} t}}{\nu \lambda_{1}}\left\|u_{\varepsilon}(0)\right\|^{2}+\frac{c_{7}\|f\|^{2}}{\nu^{2} \lambda_{1}^{2}}+C_{3}
\end{aligned}
$$

where $c_{7}=\left(c_{5}+c_{6} \nu\right)$ and

Moreover, due to estimates (4.23) and (4.28), we also have the uniform estimate.
Proposition 4.12. If $f \in V_{0}$, then any solution $u_{\varepsilon}(t)$ of problem 4.1) satisfies the inequality

where the positive constant $C_{4}$ is independent of $\varepsilon$.

From Proposition 4.10 it follows that $\mathcal{K}_{\varepsilon} \subset \mathcal{S}_{b}$ for all $\varepsilon>0$ and for all $\tau>0$. Also Proposition 4.10 implies that the semigroup $\pi^{\varepsilon}$ has absorbing set in $\mathcal{K}_{\varepsilon}$ for all $\varepsilon>0$ and for all $\tau>0$ (We note, that this absorbing set does not depend on $\varepsilon$, since the constant $C_{4}$ in (4.30) is independent of $\varepsilon$ ), bounded in $\mathcal{S}_{b}$ and inequality (4.30) implies that absorbing set is compact in $\Gamma$. The continuity of $\pi^{\varepsilon}$ is proved. These facts are sufficient to state that $\pi^{\varepsilon}$ has a global attractor $\mathfrak{A}_{\varepsilon}$. Such that $\mathfrak{A}_{\varepsilon} \subset \mathfrak{F}^{0} \times X^{0}$, bounded in $\mathcal{S}_{b}$ and compact in $\Gamma$. For a more detailed, see [14].

## 5. Upper semicontinuity of attractors

We now prove the robustness property for the global attractor $\mathfrak{A}_{\varepsilon}$. We have shown in Theorem 4.9 the continuity of the family of semiflows $\pi^{\varepsilon}$ on $X^{0}$. Having done this, We can simply invoke Theorem 23.14 in [18] to complete the proof of the robustness for the family of attractors $\mathfrak{A}_{\varepsilon}$ at $\varepsilon=0$. Clearly, it is sufficient to show that the small $\varepsilon_{0}$-neighbourhood of attractor $\mathfrak{A}_{0}$ is an absorbing set and that $\pi^{\varepsilon}$ approximates $\pi^{0}$ on $B_{R_{1}}=\left\{u^{\varepsilon}(0) \in V_{1} ;\left\|u_{0}^{\varepsilon}\right\|_{1} \leq R_{1}\right\}$ uniformly on compact sets of $[0, \infty)$.
Theorem 5.1. The family of attractors $\left\{\mathfrak{A}_{\varepsilon}, 0<\varepsilon \leq 1\right\}$ of the continuous family of semiflows $\pi^{\varepsilon}$ generated by the weak solutions of regularized 3D Navier-Stokes equations (1.1) is upper semicontinuous with respect to $\varepsilon$ at $\varepsilon=0$.

Proof. Let $N_{\varepsilon_{0}}\left(\mathfrak{A}_{0}\right)$ be the $\varepsilon_{0}$-neighborhood of $\mathfrak{A}_{0}$. Since $\mathfrak{A}_{0}$ is a global attractor, for any bounded set $B_{R_{0}}=\left\{u(0) \in V_{0} ;\|u(0)\| \leq R_{0}\right\} \subset V_{0}$, we have

Thus, there exists $\varepsilon_{0}>0$ and $t>t_{\varepsilon_{0}}$ such that

This shows that $N_{\varepsilon_{0}}\left(\mathfrak{A}_{0}\right)$ is an absorbing set. To establish the second step, we use Lemma 4.7 which states that any ball $B_{R_{1}}=\left\{u_{0}^{\varepsilon} \in V_{1} ;\left\|A^{\frac{1}{2}} u_{0}^{\varepsilon}(0)\right\| \leq R_{1}\right\}$ in $V_{1}$, with radius $R_{1}>\frac{1}{\nu^{2} \lambda_{1}}\|f\|_{\infty}^{2}$ will satisfy

This means if $u_{\varepsilon 0} \in B_{R_{1}}$, then $\pi^{\varepsilon}(t) u_{0}^{\varepsilon}$ is defined and belongs to $B_{R_{1}}$ for $t \geq 0$. The ball $B_{R_{1}}$ is therefore invariant under the map $\pi^{\varepsilon}$. Since $\pi^{\varepsilon}$ approximates $\pi^{0}$ on $B_{R_{1}}$ uniformly on $[0, T]$, we have for any $\varepsilon_{0}>0$, there are $\varepsilon_{1}>0$ and $\tau_{0}>0$ such that

\pi^{\varepsilon}\left(B_{R_{0}} \cap B_{R_{1}}\right) \subset N_{\varepsilon_{0}}\left(\mathfrak{A}_{0}\right), \text { for } 0<\varepsilon<\varepsilon_{1}, t \geq \tau_{0} \tag{5.5}
\end{equation*}

Since the attractor $\mathfrak{A}_{\varepsilon}$ is contained in $B_{R_{0}} \cap B_{R_{1}}$, an open neighborhood in the $X^{0}$ Fréchet space [18, Item (2) Theorem 23.14], we have

Since $\mathfrak{A}_{\varepsilon}$ is an invariant set, we deduce that

Moreover, since $\varepsilon_{0}$ is arbitrary, we obtain the upper semicontinuity of $\mathfrak{A}_{\varepsilon}$, at $\varepsilon=0$

One can modify the argument described above so that the final result will have broader applicability by allowing the family of forcing functions to vary with $\varepsilon$, for $\varepsilon>0$. Thus, we consider the regularized Navier-Stokes system (1.1) with a perturbed external force $f^{\varepsilon}$ in place of $f$, for $\varepsilon>0$. Then (4.1) becomes

u^{\varepsilon}(x)=u_{0}^{\varepsilon},  \tag{5.9}\\
\text { in } \Omega .
\end{gather*}
$$

We show that the trajectory attractor of the perturbed system (5.9) coincides with the trajectory attractor $\mathfrak{A}_{\varepsilon}$ of the unperturbed system (1.1). Our results rely on the work of Hale ( $[14$ ) who show that the limit behaviour is valid even through $\mathfrak{F}^{\varepsilon}$, where $\mathfrak{F}^{\varepsilon}$ denote a compact, translation invariant set of perturbed forcing functions to vary with $\varepsilon$, for $\varepsilon>0$ and satisfy the condition

Thus we would use $\mathfrak{F}^{\varepsilon}$ in place of $\mathfrak{F}^{0}$, for $\varepsilon>0$. Moreover, by using a metric $d$ on the $L^{\infty} C$-toplogy, see [18] for some samples, we can note that (5.10) is equivalent to saying that for every $\delta>0$ there is an $\varepsilon_{1}>0$ and $T_{\delta}=T(\delta) \geq 0$ such that

where $N_{\delta}$ denotes the $\delta$-neighborhood of $\mathfrak{F}^{0}$ in $L^{\infty} C$. The resulting argument for robustness will then depend on two parameters $\lambda=(\varepsilon, \delta)$, where $\lambda \rightarrow(0,0)$.

The following statement generalizes Theorem 5.1
Theorem 5.2. Under the above conditions, the trajectory attractor of the perturbed $3 D$ Navier-Stokes system (5.9) coincides with the trajectory attractor $\mathfrak{A}_{\varepsilon}$ of the non-perturbed system 4.1 ). Moreover, the perturbed attractor of (5.9) is upper semicontinuous with respect to $\varepsilon$ at $\varepsilon=0$.

Proof. The existence of trajectory attractor $\mathfrak{A}_{\varepsilon}$ is treated above. The proof follows from formulas (5.10), (5.11) and Theorem 5.1 .

Our future investigations will be concerned with the corresponding problem but with $p$-Laplacian and perturbed external force.
