# A going-down theorem for Chow-Grothendieck motives

#### Abstract

Let $(M(X), p)$ be a direct summand of the motive associated with a geometrically split, geometrically irreducible variety over a field $F$ satisfying the nilpotence principle. We show that under some conditions, if $\left(M\left(X_{E}\right), p_{E}\right)$ is a direct summand of another motive $M_{E}$ over a field extension $E$, then $(M(X), p)$ is a direct summand of $M$ over $F$.


## | Introduction

Throughout this note, $\Lambda$ will always be a finite field. Given a field $F$, an $F$-variety will be understood as a separated scheme of finite type over $F$. Given such $\Lambda$ and an $F$-variety $X$, we can consider $C H_{i}(X ; \Lambda)$, the Chow group of $i$-dimensional cycles on $X$ with coefficients in $\Lambda$, defined by $C H_{i}(X) \otimes_{\mathbb{Z}} \Lambda$. These groups are the first step in the construction of the category $C M(F ; \Lambda)$ of Chow-Grothendieck motives with coefficients in $\Lambda$. This category is constructed as the pseudoabelian enveloppe of the category $C R(F ; \Lambda)$ of correspondences with coefficients in $\Lambda$. Our main reference for the construction and the main properties of these categories is [2].

Definition I.1. Let $X$ be an $F$-variety. A field extension $E / F$ is a splitting field of $X$ if the $E$-motive $X_{E}$ is isomorphic to a finite direct sum of twisted Tate motives.

Following [2], we will write $C H(\bar{X} ; \Lambda)$ for the colimit of all $C H\left(X_{E} ; \Lambda\right)$, where $E$ runs through all field extensions $E / F$. We will say that an $F$-variety $X$ is geometrically split if $X$ splits over the algebraic closure of $F$.

For any field extension $E / F$, we will say that any element of $C H(\bar{X} ; \Lambda)$ lying in the image of the restriction morphism $C H\left(X_{E} ; \Lambda\right) \longrightarrow C H(\bar{X} ; \Lambda)$ is $E$-rational.

The purpose of this note is to generalize the following result, proved by N. Karpenko ([3, Proposition 4.6]).

Theorem I.2. Let $X$ be a geometrically irreducible, geometrically split variety satisfying the nilpotence principle and $M$ be a motive. Assume that there exists a field extension $E / F$ such that

1. the field extension $E(X) / F(X)$ is purely transcendental;
2. the upper indecomposable summand of $M(X)_{E}$ is also lower and is a summand of $M_{E}$.

Then the upper indecomposable summand of $M(X)$ is a summand of $M$.
The class of geometrically split, geometrically irreducible $F$-varieties satisfying the nilpotence principle is quite large (see [2], [1], [4]). N. Karpenko uses this result for instance to prove several motivic decompositions in $C M(F ; \Lambda)([3$, lemma 7.1$])$. Here we generalize theorem I. 2 by replacing the motive $M(X)$ by the direct summand $(M(X), p)$ associated with a projector $p \in C H_{\operatorname{dim}(X)}(X \times$ $X ; \Lambda)$.

## II The Chow group of a geometrically split $F$-variety

Let $X$ be a geometrically split $F$-variety. Let us consider the motivic decomposition

$$
M\left(X_{E}\right) \simeq \bigoplus_{i=1}^{m} \Lambda\left(a_{i}\right)
$$

where $m$ and $a_{i}$ are integers, over a splitting field $E$ of $X$.
By definition of morphisms in $C M(E ; \Lambda), \operatorname{Hom}_{C M(E ; \Lambda)}(\Lambda(i), \Lambda(j)) \simeq \delta_{i j} \Lambda$, where $\delta_{i j}$ stands for the Kronecker symbol. Therefore there is an integer $n$ called the rank of $X$ such that

$$
C H\left(X_{E} ; \Lambda\right) \simeq \bigoplus_{i=1}^{n} \Lambda
$$

Moreover, the isomorphism between $M\left(X_{E}\right)$ and the previous direct sum of twisted Tate motives defines an homogeneous basis $\left(x_{k}\right)_{k=1}^{n}$ of the $\Lambda$-module $C H\left(X_{E} ; \Lambda\right)$.

Proposition II.1. Let $X$ be a geometrically split F-variety. then the pairing

$$
\Psi: \begin{array}{clc}
C H(\bar{X} ; \Lambda) \times C H(\bar{X} ; \Lambda) & \longrightarrow & \Lambda \\
(\alpha, \beta) & \longmapsto & \operatorname{deg}(\alpha \cdot \beta)
\end{array}
$$

is bilinear, symetric and non-degenerate.

## Proof. c.f. [5, Remark 5.6]

Since the bilinear form $\Psi$ is non-degenerate, it gives rise to an isomorphism of $\Lambda$-modules between $C H(\bar{X} ; \Lambda)$ and its dual space $\operatorname{Hom}_{\Lambda}(C H(\bar{X} ; \Lambda), \Lambda)$ given by

$$
f: \begin{array}{ccc}
C H(\bar{X} ; \Lambda) & \longrightarrow & \operatorname{Hom}_{\Lambda}(C H(\bar{X} ; \Lambda), \Lambda) \\
u & \longmapsto & \Psi(u, \cdot)
\end{array}
$$

Now consider the dual basis $\left(x_{i}^{\prime}\right)_{i=0}^{n}$ of the basis $\left(x_{i}\right)_{i=0}^{n}$. We define the antedual basis of $\left(x_{i}\right)_{i=0}^{n}$ by $\left(x_{i}^{*}\right)_{i=0}^{n}$, where $x_{i}^{*}:=f^{-1}\left(x_{i}^{\prime}\right)$. By definition of the antedual basis, we have $\Psi\left(x_{i}, x_{j}^{*}\right)=\delta_{i j}$, where $\delta_{i j}$ is the Kronecker symbol.

Proposition II.2. Let $M$ and $N$ be two motives in $\operatorname{CM}(F ; \Lambda)$, with $M$ split. Then there is an isomorphism of $\Lambda$-modules

$$
C H^{*}(M ; \Lambda) \otimes C H^{*}(N ; \Lambda) \longrightarrow C H^{*}(M \otimes N ; \Lambda)
$$

Proof. c.f. [2, Proposition 64.3].

Computations become much simpler on split varieties.

Lemma II.3. Let $X$ be a split variety of rank $n$ and two smooth complete varieties $Y$ and $Y^{\prime}$. Consider the homogeneous basis $\left(x_{k}\right)_{k=1}^{n}$ defined previously and its antedual basis $\left(x_{k}^{*}\right)_{k=1}^{n}$. Then for all cycles $y \in C H(Y ; \Lambda), y^{\prime} \in C H\left(Y^{\prime} ; \Lambda\right)$ and for all $1 \leq i, j \leq n$,

$$
\left(x_{i} \times y\right) \circ\left(y^{\prime} \times x_{j}^{*}\right)=\delta_{i j}\left(y^{\prime} \times y\right) .
$$

Proof. We set 1 for the identity class, either in $\mathrm{CH}(Y ; \Lambda)$ or in $\mathrm{CH}\left(Y^{\prime} ; \Lambda\right)$.

$$
\begin{aligned}
\left(x_{i} \times y\right) \circ\left(y^{\prime} \times x_{j}^{*}\right) & =\left({ }^{Y} p_{X}^{\prime}\right)_{*}\left(\left(Y^{\prime} \times X_{p_{Y}}\right)^{*}\left(y^{\prime} \times x_{j}^{*}\right) \cdot\left(p_{Y^{\prime}}^{X} \times Y\right)^{*}\left(x_{i} \times y\right)\right) \\
& =\left({ }^{\prime} p_{X}^{\prime}\right)_{*}\left(\left(y^{\prime} \times x_{j}^{*} \times 1\right) \cdot\left(1 \times x_{i} \times y\right)\right) \\
& =\left({ }^{\prime} p_{X}^{Y}\right)_{*}\left(y^{\prime} \times\left(x_{j}^{*} \cdot x_{i}\right) \times y\right) \\
& =\operatorname{deg}\left(x_{j}^{*} \cdot x_{i}\right)\left(y^{\prime} \times y\right) \\
& =\delta_{i j}\left(y^{\prime} \times y\right)
\end{aligned}
$$

## III Direct summands of geometrically split $F$-varieties

Let $X$ be an $F$-variety and $p \in C H_{\operatorname{dim}(X)}(X \times X ; \Lambda)$ be the projector defining the direct summand $(X, p)$. A direct summand of the motive $(X, p)$ is given by a projector in $E n d_{C M(F ; \Lambda)}((X, p),(X, p))$, by definition of the category $C M(F ; \Lambda)$.

Lemma III.1. Let $X$ be an $F$-variety, and $p \in C H_{\operatorname{dim}(X)}(X \times X ; \Lambda)$ the projector defining the direct summand $(X, p)$. Then every direct summand of $(X, p)$ is a summand $(X, q)$ associated with a projector $q \in C H_{\operatorname{dim}(X)}(X \times X ; \Lambda)$ satisfying $p \circ q \circ p=q$.

Proof. Indeed we have $E n d_{C M(F ; \Lambda)}((X, p),(X, p))=p \circ C H_{\operatorname{dim}(X)}(X \times X ; \Lambda) \circ p$, thus for any projector $q \in \operatorname{End}_{C M(F ; \Lambda)}((X, p),(X, p))$, there is a cycle $s \in C H_{\operatorname{dim}(X)}(X \times X ; \Lambda)$ such that $q=p \circ s \circ p$. But $p$ is itself a projector, therefore $p \circ q \circ p=p^{2} \circ s \circ p^{2}=p \circ s \circ p=q$.

We now study the notion of upper and lower direct summands of a direct summand ( $M(X), p)$. From now on, we consider a geometrically split $F$-variety $X$ of rank $n$. We keep the notation $\left(x_{k}\right)_{k=1}^{n}$ for the homogeneous basis of $C H(\bar{X} ; \Lambda)$ and $\left(x_{k}^{*}\right)_{k=1}^{n}$ for the antedual basis of $\left(x_{k}\right)_{k=1}^{n}$ associated with the pairing $\Psi$.

Definition III.2. Let $X$ a geometrically split $F$-variety and $p \in C H_{\operatorname{dim}(X)}(X \times X ; \Lambda)$ be a nonzero projector. We denote by $\bar{p}$ the image of $p$ under the restriction map to a splitting field $E$ of $X$. Considering the bases $\left(x_{i}\right)_{i=1}^{n}$ and $\left(x_{i}^{*}\right)_{i=1}^{n}$ of $C H\left(X_{E} ; \Lambda\right)$, we have

$$
\bar{p}=\sum_{i=1}^{n} \sum_{j=1}^{n} p_{i j}\left(x_{i} \times x_{j}^{*}\right)
$$

We define the lowest codimension of $p$ by

$$
\left.\operatorname{cdmin}(p):=\min _{p_{i j} \neq 0}\left(\operatorname{codim}\left(x_{i}\right)\right)\right)
$$

where codim $\left(x_{i}\right)$ stands for the codimension in $C H(X ; \Lambda)$.
As $X$ is geometrically split, the summand $(X, p)$ associated with the projector $p \in C H_{\operatorname{dim}(X)}(X \times$ $X ; \Lambda)$ splits over a field extension $E / F$ :

$$
\begin{equation*}
\left(X_{E}, p_{E}\right) \simeq \bigoplus_{i=1}^{m}\left(\Lambda\left(a_{i}\right)\right)^{m_{i}} \tag{III.1}
\end{equation*}
$$

where $a_{i}, m_{i}$ and $m$ are integers, and we set $i<j \Rightarrow a_{i}<a_{j}$.

Definition III.3. Let $X$ be a geometrically split $F$-variety, and $(X, p)$ be a summand of $X$. Let also $(X, q)$ be a direct summand of the motive ( $X, p$ ). Consider the decomposition III. 1 of ( $X, p$ ) in a splitting field $E$ of $X$. The summand $(X, q)$ is :

1. upper in $(X, p)$ if $C H^{a_{1}}\left(\left(X_{E}, q_{E}\right)\right) \neq 0$.
2. lower in $(X, p)$ if $C H_{a_{m}}\left(\left(X_{E}, q_{E}\right)\right) \neq 0$.

By definition, a direct summand $(X, q)$ is upper in $(X, p)$ if and only if $\left(X(-\operatorname{dim}(X)),{ }^{t} q\right)$ is lower in the dual motive $\left(X(-\operatorname{dim}(X)),{ }^{t} p\right)$. We can now study the link between the lowest codimension of a summand and the position of its motivic decomposition.

Proposition III.4. Let $X$ be a geometrically split $F$-variety, and $p \in C H_{\operatorname{dim}(X)}(X \times X ; \Lambda)$ the projector defining the summand $(X, p)$. Consider the motivic decomposition III. 1 given above of the motive $\left(X_{E}, p_{E}\right)$, where $E$ is a splitting field of $X$. Then

$$
a_{1}=c d \min (p)
$$

Proof. Let us show first that $\operatorname{cdmin}(p) \geq a_{1}$. Indeed we consider the motivic decomposition III.1, thus

$$
C H^{a_{1}}\left(\left(X_{E}, p_{E}\right) ; \Lambda\right) \simeq \bigoplus_{i=1}^{m} \operatorname{Hom}_{C M(E ; \Lambda)}\left(\Lambda\left(a_{i}\right), \Lambda\left(a_{1}\right)\right)^{m_{i}} \simeq \Lambda^{m_{1}} \neq 0
$$

Consequently $C H^{a_{1}}\left(X_{E}, \Lambda\right) \circ p_{E} \neq 0$ by definition of Chow groups in $C M(E ; \Lambda)$.
Let $x \in C H^{a_{1}}\left(X_{E} ; \Lambda\right)$ such that $x \circ p_{E} \neq 0$. Since $\left(x_{i}\right)_{i=1}^{n}$ is homogeneous, we can consider the base $\left(x_{k}\right)_{k \in K}$ of the $\Lambda$-module $C H^{a_{1}}\left(X_{E} ; \Lambda\right)$ and write $x=\sum_{k \in K} \lambda_{k} x_{k}$. Then

$$
\begin{aligned}
x \circ p_{E} \neq 0 & \Rightarrow\left(\sum_{k \in K} \lambda_{k} x_{k}\right) \circ\left(\sum_{i=1}^{n} \sum_{j=1}^{n} p_{i j}\left(x_{i} \times x_{j}^{*}\right)\right) \neq 0 \\
& \Rightarrow \sum_{i=1}^{n} \sum_{k \in K} \lambda_{k} p_{i k} x_{i} \neq 0 \\
& \Rightarrow \exists\left(i_{0}, k_{0}\right) \in\{1, . ., n\} \times K, \quad p_{i_{0} k_{0}} \neq 0
\end{aligned}
$$

Then since $\operatorname{codim}\left(x_{i_{0}}\right)=\operatorname{dim}\left(X_{E}\right)-\operatorname{codim}\left(x_{k_{0}}^{*}\right)=\operatorname{codim}\left(x_{k_{0}}\right)=a_{1}$ we have proven that $c d \min (p) \leq a_{1}$.

Suppose on the other hand that $\operatorname{cdmin}(p)=s<a_{1}$. Then there are two index $i_{0}, j_{0}$ in $\{1, . ., n\}$ such that $p_{i_{0} j_{0}} \neq 0$, and $\operatorname{codim}\left(x_{i_{0}}\right)=s$. Then $x_{j_{0}} \circ p_{E}=\sum_{i=0}^{n} p_{j_{0}} x_{i} \neq 0$, therefore $C H^{s}\left(X_{E} ; \Lambda\right) \circ p_{E} \neq 0$, as $\operatorname{codim}\left(x_{i_{0}}\right)=\operatorname{codim}\left(x_{j_{0}}\right)$. But this contradicts the fact that

$$
\begin{aligned}
C H^{s}\left(X_{E} ; \Lambda\right) \circ p_{E} & =\operatorname{Hom}_{C M(E ; \Lambda)}\left(\left(X_{E}, p_{E}\right) ; \Lambda(s)\right) \\
& =\bigoplus_{i=1}^{m} \operatorname{Hom}_{C M(E ; \Lambda)}\left(\Lambda\left(a_{i}\right) ; \Lambda(s)\right)^{m_{i}} \\
& =0
\end{aligned}
$$

Therefore $\operatorname{cdmin}(p)=a_{1}$.

Proposition III.5. Let $X$ be a geometrically split $F$-variety, and $p$ the projector defining the summand $(M(X), p)$. Let also be $(M(X), q)$ a direct summand of $(M(X), p)$. Then

$$
\operatorname{cdmin}(p)=\operatorname{cdmin}(q) \Leftrightarrow(X, q) \text { is upper in }(X, p) .
$$

Proof. We keep the same notations as in proposition III.4.
As $q$ defines a direct summand of $(X, p)$ we have $q=p \circ q \circ p$ by lemma III.1, thus for any $k$

$$
\begin{aligned}
C H^{k}\left(\left(X_{E}, q_{E}\right) ; \Lambda\right) & =C H^{k}\left(X_{E} ; \Lambda\right) \circ q_{E} \\
& =C H^{k}\left(X_{E} ; \Lambda\right) \circ\left(p_{E} \circ q_{E} \circ p_{E}\right)
\end{aligned}
$$

But $q_{E} \circ p_{E}=\left(p_{E} \circ q_{E} \circ p_{E}\right) \circ p_{E}=p_{E} \circ q_{E} \circ p_{E}=q_{E}$, thus

$$
\left.C H^{k}\left(\left(X_{E}, q_{E}\right) ; \Lambda\right)=\left(C H^{k}\left(X_{E} ; \Lambda\right) \circ p_{E}\right)\right) \circ q_{E}=C H^{k}\left(\left(X_{E}, p_{E}\right) ; \Lambda\right) \circ q_{E} \cdot(*)
$$

Therefore for any $k$ such that $C H^{k}\left(\left(X_{E}, p_{E}\right) ; \Lambda\right)=0$, we have shown that $C H^{k}\left(\left(X_{E}, q_{E}\right) ; \Lambda\right)=$ 0.

Now write the decomposition of $\left(X_{E}, q_{E}\right)$ :

$$
\left(X_{E}, q_{E}\right) \simeq \bigoplus_{j=1}^{s}\left(\Lambda\left(b_{j}\right)\right)^{s_{i}}
$$

with $i<j \Rightarrow b_{i}<b_{j}$. Equality $(*)$ implies that for all $j \in\{1, . ., s\}, b_{j} \geq a_{1}$. But proposition III. 4 implies that $b_{1}=\operatorname{cdmin}(q)$, thus

$$
\begin{aligned}
\operatorname{cdmin}(p)=\operatorname{cdmin}(q) & \Leftrightarrow b_{1}=a_{1} \\
& \Leftrightarrow C H^{a_{1}}\left(\left(X_{E}, q_{E}\right) ; \Lambda\right) \neq 0
\end{aligned}
$$

## IV Proof of the main theorem

Following [3], we recall some results on the category generated by geometrically split $F$-varieties satisying the nilpotence principle in $C M(F ; \Lambda)$. We will say that a pseudo-abelian category satisfies the Krull-Schmidt principle if every object of this category decomposes in a unique way as a direct sum of indecomposable objects (up to permutation of these indecomposable summands).

Lemma IV.1. ([3, Corollary 3.2]) Let $X$ be a geometrically split F-variety satisfying the nilpotence principle. Then an appropriate power of any endomorphism of the motive $X$ is a projector.

Proposition IV.2. ([3, Corollary 3.3])The Krull-Schmidt principle holds for the pseudo-abelian Tate subcategory of $C M(F, \Lambda)$ generated by the motives of geometrically split $F$-varieties satisfying the nilpotence principle.

Remark IV.3. More generally, proposition IV.2 is true when $\Lambda$ is any finite commutative ring (see [3, Corollary 3.2]). The Krull-Schmidt principle also holds for the category generated by motives of quadrics when the ring of coefficients $\Lambda$ is $\mathbb{Z}$. Nevertheless, the Krull-Schmidt principle does not hold in the category generated by the motives of projective homogeneous varieties when $\Lambda=\mathbb{Z}$ (see [6]) and this is one of the reasons why we suppose that $\Lambda$ is a finite field.

Let $X$ be a geometrically split $F$-variety. Let $p \in C H_{\operatorname{dim}(X)}(X \times X ; \Lambda)$ be the projector defining the direct summand $(X, p)$ of $X$. As seen before, the homogeneous base $\left(x_{k}\right)_{k=1}^{n}$ and its antedual base $\left(x_{k}^{*}\right)_{k=1}^{n}$ relatively to the pairing $\Psi$ allow us to decompose $p$ in a splitting field $E$ of the motive $X$, that is to say $p_{E}=\sum_{i=1}^{n} \sum_{j=1}^{n} p_{i j}\left(x_{i} \times x_{j}^{*}\right)$.

Definition IV.4. Let $X$ be a geometrically split F-variety and $E$ a splitting field of the motive $X$. Let $p$ be the projector defining the direct summand $(X, p)$. We say that couple $(i, j) \in\{1, . ., n\}^{2}$ is contained in $p_{E}$ if $p_{i j} \neq 0$. We will also say that an element $x_{i} \times x_{j}^{*}$ of the base of $C H_{\operatorname{dim}\left(X_{E}\right)}\left(X_{E} \times\right.$ $\left.X_{E} ; \Lambda\right)$ is contained in $p_{E}$ if the couple $(i, j)$ is contained in $p_{E}$.

Notation IV.5. The set of all elements $x_{i} \times x_{j}^{*}$ of $C H_{\operatorname{dim}\left(X_{E}\right)}\left(X_{E} \times X_{E} ; \Lambda\right)$ which are contained in the projector $p_{E}$ will be called the base of $p_{E}$, and denoted $\mathcal{B}\left(p_{E}\right)$.

Definition IV.6. Let $X$ be a geometrically split $F$-variety and two projectors $p$ and $q$ defining the two direct summand $(X, p)$ and $(X, q)$. Let $E$ be a splitting field of $X$. We say that $p$ contains $q$ if $\mathcal{B}\left(q_{E}\right) \subset \mathcal{B}\left(p_{E}\right)$. We will say that $q$ intersects $p$ if $\mathcal{B}\left(q_{E}\right) \cap \mathcal{B}\left(p_{E}\right) \neq \emptyset$.

Remark IV.7. Given a geometrically split $F$-variety $X$ and two direct summands $(X, p)$ and $(X, q)$ of the motive $X$ defined by the two projectors $p$ and $q$, we will also say that the summand $(X, p)$ contains the summand $(X, q)$ if the projector $p$ contains the projector $q$.

Since $\Lambda$ is a finite field, we have seen that the category generated by motives of geometrically split $F$-varieties satisfying the nilpotence principle satisfies the Krull-Schmidt principle (proposition IV.2). By definition of the category $C M(F ; \Lambda)$, direct summands of the motive of an $F$-variety correspond to projectors in $E n d_{C M(F ; \Lambda)}(X)$, thus in a splitting field $E$ of the motive $X$, every $F$-rational cycle in $C H_{\operatorname{dim}(X)}(\bar{X} \times \bar{X} ; \Lambda)$ is a linear combination of minimal $F$-rational cycles, corresponding to indecomposable direct summands of $X$. We now prove the key-lemma.

Lemma IV.8. Let $X$ be a geometrically split, geometrically irreducible $F$-variety satisfying the nilpotence principle. Let $p$ be the projector defining the direct summand $N:=(X, p)$ of $X$. Let also $Y$ be a smooth complete $F$-variety, and $M:=(Y, q)$ the direct summand of $Y$ induced by the projector $q$. Assume that there is a field extension $E / F$ and two $E$-rational correspondences $h: X_{E} \rightarrow M_{E}$ and $k: M_{E} \rightarrow X_{E}$ such that

1. every $E(X)$-rational cycle in $C H(\bar{X} \times \bar{Y} ; \Lambda)$ is also $F(X)$-rational;
2. $k \circ h \in C H_{\operatorname{dim}\left(X_{E}\right)}\left(X_{E} \times X_{E} ; \Lambda\right)$ defines an upper direct summand $\left(X_{E}, k \circ h\right)$ of $N_{E}$.

Then there exists an F-rational cycle $h^{\prime}$ and a E-rational cycle $k^{\prime}$ such that

- $k^{\prime} \circ h_{E}^{\prime}$ is a non-zero projector in $C H_{\operatorname{dim}\left(X_{E}\right)}\left(X_{E} \times X_{E} ; \Lambda\right)$;
- the E-motive $\left(X_{E}, k^{\prime} \circ h_{E}^{\prime}\right)$ contains every upper indecomposable summand of $\left(X_{E}, k \circ h\right)$;
- the cycle $k^{\prime}$ is $F$-rational if $k$ is $F$-rational.

Proof. We denote by $s$ the composite $k \circ h$. By assumption, $s$ is a projector in $C H_{\operatorname{dim}\left(X_{E}\right)}\left(X_{E} \times\right.$ $X_{E} ; \Lambda$ ) satisfying $s=p_{E} \circ s \circ p_{E}$ by lemma III.1. Moreover we suppose that $(M(X), s)$ is upper in $\left(M(X), p_{E}\right)$, that is to say $c d \min (s)=c d \min (p)$ by proposition III.5.

Let us decompose the images of the cycles $h, k, s$ and $p$ in a splitting field of the $F$-variety $X$ of rank $n$ :

1. $\bar{h}=\sum_{i=1}^{n} h_{i}\left(x_{i} \times y_{i}\right)$
2. $\bar{k}=\sum_{j=1}^{n} k_{j}\left(y_{j}^{\prime} \times x_{j}^{*}\right)$
3. $\bar{s}=\sum_{i=1}^{n} \sum_{j=1}^{n} s_{i j}\left(x_{i} \times x_{j}^{*}\right)$
4. $\bar{p}=\sum_{i=1}^{n} \sum_{j=1}^{n} p_{i j}\left(x_{i} \times x_{j}^{*}\right)$
with $s_{i j}=h_{i} k_{j} \operatorname{deg}\left(y_{j}^{\prime} \cdot y_{i}\right)$ by definition of $s$.

Since $E(X)$ is a field extension of $E$, the cycle $\bar{h}$ is $E(X)$-rational, hence $F(X)$-rational by assumption 1).

Now consider the morphism $\operatorname{Spec}(F(X)) \longrightarrow \bar{X}$ induced by the generic point of the geometrically irreducible variety $X$. It induces a morphism

$$
\epsilon:(\bar{X} \times \bar{Y})_{F(X)} \longrightarrow \bar{X} \times \bar{Y} \times \bar{X}
$$

whose pull-back $\epsilon^{*}: C H_{\operatorname{dim}(X)}(\bar{X} \times \bar{Y} \times \bar{X} ; \Lambda) \longrightarrow C H_{\operatorname{dim}(X)}(\bar{X} \times \bar{Y} ; \Lambda)$ maps every cycles of the form $\sum_{i} \lambda_{i}\left(\alpha_{i} \times \beta_{i} \times 1\right)$ on $\sum_{i} \lambda_{i}\left(\alpha_{i} \times \beta_{i}\right)$ and vanishes on elements of the form $\sum_{i} \lambda_{i}\left(\alpha_{i} \times \beta_{i} \times \gamma_{i}\right)$, where $\operatorname{codim}\left(\gamma_{i}\right)>0$.

Moreover, the pull-back $\epsilon^{*}$ induces a surjection of $F$-rational cycles onto $F(X)$-rational cycles ([2, corollary 57.11]). Therefore we can choose an $F$-rational cycle $\overline{h_{1}} \in C H_{\operatorname{dim}(X)}(\bar{X} \times \bar{Y} \times \bar{X} ; \Lambda)$ such that $\epsilon^{*}\left(\overline{h_{1}}\right)=\bar{h}$.

By definition of $\epsilon^{*}$ we have

$$
\overline{h_{1}}=\sum_{i=1}^{n} h_{i}\left(x_{i} \times y_{i} \times 1\right)+\sum(\alpha \times \beta \times \gamma)
$$

where cycles $\gamma$ are of strictly positive codimension.
Now let us look at the cycle $\overline{h_{1}}$ as a correspondence $\overline{h_{1}}: \bar{X} \longrightarrow \bar{Y} \times \bar{X}$. Setting $\overline{h_{2}}:=\overline{h_{1}} \circ \bar{p}$, $\overline{h_{2}}$ is $F$-rational and its image in a splitting field of $X$ is

$$
\begin{aligned}
\overline{h_{2}} & =\left(\sum_{i=1}^{n} h_{i}\left(x_{i} \times y_{i} \times 1\right)\right) \circ p+\left(\sum(\alpha \times \beta \times \gamma)\right) \circ p \\
& =\sum_{i=1}^{n} \sum_{j=1}^{n} h_{j} p_{i j}\left(x_{i} \times y_{j} \times 1\right)+\sum \tilde{\alpha} \times \tilde{\beta} \times \tilde{\gamma}
\end{aligned}
$$

where cycles $\tilde{\gamma}$ are of strictly positive codimension and cycles $\tilde{\alpha}$ satisfies $\operatorname{codim}(\tilde{\alpha}) \geq \operatorname{cdmin}(p)$.
Consider now the diagonal embedding

$$
\Delta: \begin{array}{clc}
\bar{X} \times \bar{Y} & \longrightarrow & \bar{X} \times \bar{Y} \times \bar{X} \\
(x, y) & \longmapsto & (x, y, x)
\end{array} .
$$

The morphism $\Delta$ induces a pull-back $\Delta^{*}: C H_{\operatorname{dim}(X)}(\bar{X} \times \bar{Y} \times \bar{X} ; \Lambda) \longrightarrow C H_{\operatorname{dim}(X)}(\bar{X} \times \bar{Y} ; \Lambda)$. Setting $\overline{h_{3}}:=\Delta^{*}\left(\overline{h_{2}}\right), \overline{h_{3}}$ is an $F$-rational cycle and

$$
\overline{h_{3}}=\sum_{i=1}^{n} \sum_{j=1}^{n} h_{j} p_{i j}\left(x_{i} \times y_{j}\right)+\sum(\tilde{\alpha} \cdot \tilde{\gamma}) \times \tilde{\beta}
$$

where $\operatorname{codim}(\tilde{\alpha} \cdot \tilde{\gamma})>\operatorname{cdmin}(p)$ since $\operatorname{codim}(\tilde{\alpha}) \geq \operatorname{cdmin}(p)$ and $\operatorname{codim}(\tilde{\gamma})>0$.
The next step consists of computing the composite $\bar{k} \circ \overline{h_{3}}$ :

$$
\begin{aligned}
\bar{k} \circ \overline{h_{3}} & =\left(\sum_{l=1}^{n} k_{l}\left(y_{l}^{\prime} \times x_{l}^{*}\right)\right) \circ\left(\sum_{i=1}^{n} \sum_{j=1}^{n} h_{j} p_{i j}\left(x_{i} \times y_{j}\right)\right)+\left(\sum_{l=1}^{n} k_{l}\left(y_{l}^{\prime} \times x_{l}^{*}\right)\right) \circ\left(\sum(\tilde{\alpha} \cdot \tilde{\gamma}) \times \tilde{\beta}\right) \\
& =\sum_{i=1}^{n} \sum_{l=1}^{n}\left(\sum_{j=1}^{n} k_{l} h_{j} p_{i j}\left(y_{l}^{\prime} \times x_{l}^{*}\right) \circ\left(x_{i} \times y_{j}\right)\right)+\sum \bar{\alpha} \times \bar{\beta} \\
& =\sum_{i=1}^{n} \sum_{l=1}^{n}\left(\sum_{j=1}^{n} k_{l} h_{j} p_{i j} \operatorname{deg}\left(y_{l}^{\prime} \cdot y_{j}\right)\right)\left(x_{i} \times x_{l}^{*}\right)+\sum \bar{\alpha} \times \bar{\beta}
\end{aligned}
$$

Where cycles $\bar{\alpha}$ satisfy $\operatorname{codim}(\bar{\alpha})>c d \min (p)=c d m i n(s)$.
Let us show that for any $(i, l) \in\{1, . ., n\}^{2}, \sum_{j=1}^{n} k_{l} h_{j} p_{i j} \operatorname{deg}\left(y_{l}^{\prime} \cdot y_{j}\right)=s_{i l}$. First $s$ defines a direct summand of $\left(X, p_{E}\right)$, thus by lemma III. $1 s \circ p_{E}=p_{E} \circ s \circ p_{E} \circ p_{E}=p_{E} \circ s \circ p_{E}=s$. Now compute $\bar{s} \circ \bar{p}$ :

$$
\begin{aligned}
\bar{s} \circ \bar{p} & =\left(\sum_{i=1}^{n} \sum_{j=1}^{n} s_{i j}\left(x_{i} \times x_{j}^{*}\right)\right) \circ\left(\sum_{l=1}^{n} \sum_{t=1}^{n} p_{l t}\left(x_{l} \times x_{t}^{*}\right)\right) \\
& =\sum_{j=1}^{n} \sum_{l=1}^{n} \sum_{i=1}^{n} \sum_{t=1}^{n} s_{i j} p_{l t}\left(x_{i} \times x_{j}^{*}\right) \circ\left(x_{l} \times x_{t}^{*}\right) \\
& =\sum_{j=1}^{n} \sum_{l=1}^{n}\left(\sum_{i=1}^{n} s_{i j} p_{l i}\right)\left(x_{l} \times x_{j}^{*}\right)
\end{aligned}
$$

Therefore for any $(i, l)$ with $\operatorname{codim}\left(x_{i}\right)=c d \min (s)$, the component of $\bar{k} \circ \overline{h_{3}}$ over $x_{i} \times x_{l}^{*}$ is equal to $\sum_{j=1}^{n} k_{l} h_{j} p_{i j} \operatorname{deg}\left(y_{l}^{\prime} \cdot y_{j}\right)$ and we have

$$
\begin{aligned}
\sum_{j=1}^{n} k_{l} h_{j} p_{i j} \operatorname{deg}\left(y_{l}^{\prime} \cdot y_{j}\right) & =\sum_{j=1}^{n} s_{j l} p_{i j} \\
& =s_{i l}
\end{aligned}
$$

We thus have obtained

$$
\left(\bar{k} \circ \overline{h_{3}}\right)=\sum_{\operatorname{codim}\left(x_{i}\right)=\operatorname{cdmin}(p)} \sum_{j=1}^{n} s_{i j}\left(x_{i} \times x_{j}^{*}\right)+\sum \bar{\alpha} \times \bar{\beta}
$$

where cycles $\bar{\alpha}$ satisfy $\operatorname{codim}(\bar{\alpha})>c d m i n(p)=c d \min (s)$.
As $\Lambda$ is finite, there exists an integer $n_{0}$ such that $\left(g \circ\left(f_{3}\right)_{E}\right)^{\circ n_{0}}$ is a projector by lemma IV.1. Setting $h^{\prime}=\overline{h_{3}}$ and $k^{\prime}=\left(\bar{k} \circ \overline{h_{3}}\right)^{\circ n_{0}-1} \circ \bar{k}$, we see that

$$
\left(\overline{k^{\prime}} \circ \overline{h^{\prime}}\right)=\sum_{\operatorname{codim}\left(x_{i}\right)=\operatorname{cdmin}(p)} \sum_{j=1}^{n} s_{i j}\left(x_{i} \times x_{j}^{*}\right)+\sum \widehat{\alpha} \times \widehat{\beta}
$$

where $\operatorname{codim}(\widehat{\alpha})>\operatorname{cdmin}(p)$, therefore $k^{\prime} \circ h_{E}^{\prime}$ is non-zero.
If $k$ is $F$-rational, then $k^{\prime}=\left(\bar{k} \circ \overline{h_{3}}\right)^{\circ n_{0}-1} \circ k$ is also $F$-rational. Moreover, the cycle $k^{\prime} \circ h^{\prime}$ intersects every projector $w \in C H(\bar{X} \times \bar{X} ; \Lambda)$ satisfying $\operatorname{cdmin}(w)=c d \min (k \circ h)$, and $\mathcal{B}(w) \subset$ $\mathcal{B}(k \circ h)$. In particular $k^{\prime} \circ h^{\prime}$ intersects every upper direct summand of the motive ( $X_{E}, k \circ h$ ), and therefore contains every indecomposable direct summand of the motive ( $X_{E}, k \circ h$ ).

The main theorem is a direct consequence of lemma IV.8.

Theorem IV.9. Let $X$ be a geometrically irreducible, geometrically split $F$-variety satisfying the nilpotence principle. Consider the projector $p$ defining the indecomposable direct summand $N:=$ $(X, p)$ of the motive $X$. Let also $Y$ be a smooth complete $F$-variety and $M:=(Y, q)$ the direct summand induced by a projector $q$. Assume the existence of a field extension $E / F$ such that

1. every $E(X)$-rational cycle in $C H(\bar{X} \times \bar{Y} ; \Lambda)$ is also $F(X)$-rational;
2. the E-motive $N_{E}$ contains an indecomposable direct summand $\left(X_{E}, s\right)$ both lower and upper and is a direct summand of $M_{E}$.

Then the motive $N$ is a direct summand of the motive $M$.
Proof. By assumption, the $E$-motive $N_{E}$ is a direct summand of $M_{E}$, that is to say there are two correspondences $f \in C H_{\operatorname{dim}\left(X_{E}\right)}\left(X_{E} \times Y_{E} ; \Lambda\right)$ and $g \in C H_{\operatorname{dim}\left(Y_{E}\right)}\left(Y_{E} \times X_{E} ; \Lambda\right)$ such that $g \circ f=p_{E}$. Let us apply lemma IV.8.

Lemma IV. 8 implies that there are two correspondences $g^{\prime} \in C H_{\operatorname{dim}\left(Y_{E}\right)}\left(Y_{E} \times X_{E} ; \Lambda\right)$ and $f^{\prime} \in C H_{\operatorname{dim}\left(X_{E}\right)}\left(X_{E} \times Y_{E} ; \Lambda\right)$, with $\overline{f^{\prime}} F$-rational, such that $g^{\prime} \circ f_{E}^{\prime}$ is a non-zero projector and the motive $\left(X_{E}, g^{\prime} \circ f_{E}^{\prime}\right)$ contains every upper indecomposable summand of $\left(X_{E}, p_{E}\right)$.

Now consider the cycle $p_{E} \circ g^{\prime} \circ f_{E}^{\prime} \circ p_{E}$. Lemma IV. 1 justifies the existence of an integer $n_{0}$ such that $\left(p_{E} \circ g^{\prime} \circ f_{E}^{\prime} \circ p_{E}\right)^{n_{0}}$ is a projector. Moreover we have the decomposition

$$
\overline{g^{\prime}} \circ \overline{f^{\prime}}=\sum_{\operatorname{codim}\left(x_{i}\right)=\operatorname{cdmin}(p)} \sum_{j=1}^{n} p_{i j}\left(x_{i} \times x_{j}^{*}\right)+\sum \bar{\alpha} \times \bar{\beta}
$$

with $\operatorname{codim}(\bar{\alpha})>\operatorname{cdmin}(p)$.
Set $\bar{g}:=\left(p_{E} \circ g^{\prime} \circ f_{E}^{\prime} \circ p_{E}\right)^{\circ n_{0}-1} \circ p_{E} \circ g^{\prime}$ and $\bar{f}:=f^{\prime} \circ p$. The cycle $\bar{g} \circ \bar{f}_{E}$ is a projector satisfying $p_{E} \circ \bar{g} \circ \bar{f}_{E} \circ p_{E}=\bar{g} \circ \bar{f}_{E}$. Besides in a splitting field of $X$

$$
\bar{g} \circ \overline{\bar{f}_{E}}=\sum_{\operatorname{codim}\left(x_{i}\right)=\operatorname{cdmin}(p)} \sum_{j=1}^{n} p_{i j}\left(x_{i} \times x_{j}^{*}\right)+\sum \hat{\alpha} \times \hat{\beta}
$$

with $\operatorname{codim}(\hat{\alpha})>\operatorname{cdmin}(p)$, therefore the motive $\left(X_{E}, \bar{g} \circ \bar{f}_{E}\right)$ is an upper direct summand of the motive $N_{E}$. Besides $\left(X_{E}, \bar{g} \circ \bar{f}_{E}\right)$ intersects any upper direct summand of $N_{E}$, thus contains the indecomposable direct summand $\left(X_{E}, s\right)$. It follows that the summand $\left(X_{E}, \bar{g} \circ \bar{f}_{E}\right)$ is both upper and lower in $N_{E}$.

Transposing, the summand $\left(X_{E}\left(-\operatorname{dim}\left(X_{E}\right)\right),{ }^{t} \bar{f}_{E} \circ^{t} \bar{g}\right)$ is a direct summand of the dual motive $N_{E}^{*}$ which is upper, as ( $X_{E}, \bar{g} \circ \bar{f}_{E}$ ) is lower in $N_{E}$, therefore we can apply lemma IV. 8 again.

Lemma IV. 8 justifies the existence of an $F$-rational cycle $\widetilde{g}$ and another cycle $\widetilde{f}$ which is also $F$-rational, such that ${ }^{t} \widetilde{f}_{E} \circ^{t} \widetilde{g}_{E}$ is a non-zero projector in $E n d_{C M(E ; \Lambda)}\left(N_{E}^{*}\right)$. Transposing again, the cycle $\widetilde{g}_{E} \circ \widetilde{f}_{E}$ is a non-zero projector in $C H_{\operatorname{dim}\left(X_{E}\right)}\left(X_{E} \times X_{E} ; \Lambda\right)$.

By nilpotence principle, an appropriate power $(\widetilde{g} \circ \widetilde{f})^{\tilde{n}}$ is a non-zero projector in $C H_{\operatorname{dim}(X)}(X \times$ $X ; \Lambda)$. Setting $\mathfrak{g}:=(\widetilde{g} \circ \widetilde{f})^{\tilde{n}-1} \circ \widetilde{g}$ and $\mathfrak{f}:=\widetilde{f}$, the cycle $\mathfrak{g} \circ \mathfrak{f}$ is a non zero-projector. But the motive $N$ is indecomposable, therefore we can conclude that $\mathfrak{g} \circ \mathfrak{f}=p$, that is to say $N$ is a direct summand of $M$.
