# Uniform stabilization in weighted Sobolev spaces for the KdV equation posed on the half-line

#### Abstract

Studied here is the large-time behavior of solutions of the Korteweg-de Vries equation posed on the right half-line under the effect of a localized damping. Assuming as in 20] that the damping is active on a set $\left(a_{0},+\infty\right)$ with $a_{0}>0$, we establish the exponential decay of the solutions in the weighted spaces $L^{2}\left((x+1)^{m} d x\right)$ for $m \in \mathbb{N}^{*}$ and $L^{2}\left(e^{2 b x} d x\right)$ for $b>0$ by a Lyapunov approach. The decay of the spatial derivatives of the solution is also derived. MSC: Primary: 93D15, 35Q53; Secondary: 93B05. Key words. Exponential Decay, Korteweg-de Vries equation, Stabilization.


## 1 Introduction

The Korteweg-de Vries (KdV) equation was first derived as a model for the propagation of small amplitude long water waves along a channel [9, 16, 17]. It has been intensively studied from various aspects for both mathematics and physics since the 1960s when solitons were discovered through solving the KdV equation, and the inverse scattering method, a so-called nonlinear Fourier transform, was invented to seek solitons [14, 22]. It is now well known that the KdV equation is not only a good model for water waves but also a very useful approximation model in nonlinear studies whenever one wishes to include and balance weak nonlinear and dispersive effects.

The initial boundary value problems (IBVP) arise naturally in modeling small-amplitude long waves in a channel with a wavemaker mounted at one end [1, 2, 3, 29]. Such mathematical formulations have received considerable attention in the past, and a satisfactory theory of global wellposedness is available for initial and boundary conditions satisfying physically relevant smoothness and consistency assumptions (see e.g. [1, 芼, 6, 可, 11, 12, 13] and the references therein).

The analysis of the long-time behavior of IBVP on the quarter-plane for KdV has also received considerable attention over recent years, and a review of some of the results related to the issues we address here can be found in [5, 7, 19]. For stabilization and controllability issues on the half line, we refer the reader to 20] and 27, 28], respectively.

In this work, we are concerned with the asymptotic behavior of the solutions of the IBVP for the KdV equation posed on the positive half line under the presence of a localized damping represented by the function $a$; that is,

u(x, 0)=u_{0}(x), \quad x>0
\end{array}\right.
$$

[^0]Assuming $a(x) \geq 0$ a.e. and that $u(., t) \in H^{3}\left(\mathbb{R}^{+}\right)$, it follows from a simple computation that

\frac{d E}{d t}=-\int_{0}^{\infty} a(x)|u(x, t)|^{2} d x-\frac{1}{2}\left|u_{x}(0, t)\right|^{2} \tag{2}
\end{equation*}
$$

where

$$
\begin{equation*}
E(t)=\frac{1}{2} \int_{0}^{\infty}|u(x, t)|^{2} d x \tag{3}
\end{equation*}
$$

is the total energy associated with (11). Then, we see that the term $a(x) u$ plays the role of a feedback damping mechanism and, consequently, it is natural to wonder whether the solutions of (11) tend to zero as $t \rightarrow \infty$ and under what rate they decay. When $a(x)>a_{0}>0$ almost everywhere in $\mathbb{R}^{+}$, it is very simple to prove that $E(t)$ converges to zero as $t$ tends to infinity. The problem of stabilization when the damping is effective only in a subset of the domain is much more subtle. The following result was obtained in 20.

Theorem 1.1 Assume that the function $a=a(x)$ satisfies the following property

a \in L^{\infty}\left(\mathbb{R}^{+}\right), a \geq 0 \text { a.e. in } \mathbb{R}^{+} \text {and } a(x) \geq a_{0}>0 \text { a.e. in }\left(x_{0},+\infty\right) \tag{4}
\end{equation*}

for some numbers $a_{0}, x_{0}>0$. Then for all $R>0$ there exist two numbers $C>0$ and $\nu>0$ such that for all $u_{0} \in L^{2}\left(\mathbb{R}^{+}\right)$with $\left\|u_{0}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)} \leq R$, the solution $u$ of ( $\left.\mathbb{1}\right)$ satisfies

\begin{equation*}
\|u(t)\|_{L^{2}\left(\mathbb{R}^{+}\right)} \leq C e^{-\nu t}\left\|u_{0}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)} \tag{5}
\end{equation*}
$$

Actually, Theorem 1.1 was proved in 20] under the additional hypothesis that

a(x) \geq a_{0} \text { a.e. in }(0, \delta) \tag{6}
\end{equation*}
$$

for some $\delta>0$, but (6) may be dropped by replacing the unique continuation property 20, Lemma 2.4] by [30, Theorem 1.6]. The exponential decay of $E(t)$ is obtained following the methods in [23, 25, 26] which combine multiplier techniques and compactness arguments to reduce the problem to some unique continuation property for weak solutions of KdV.

Along this work we assume that the real-valued function $a=a(x)$ satisfies the condition (4) for some given positive numbers $a_{0}, x_{0}$. In this paper we investigate the stability properties of (11) in the weighted spaces introduced by Kato in 15. More precisely, for $b>0$ and $m \in \mathbb{N}$, we prove that the solution $u$ exponentially decays to 0 in $L_{b}^{2}$ and $L_{(x+1)^{m} d x}^{2}$ (if $u(0)$ belongs to one of these spaces), where

L_{b}^{2} & =\left\{u: \mathbb{R}^{+} \rightarrow \mathbb{R} ; \int_{0}^{\infty}|u(x)|^{2} e^{2 b x} d x<\infty\right\} \\
L_{(x+1)^{m} d x}^{2} & =\left\{u: \mathbb{R}^{+} \rightarrow \mathbb{R} ; \int_{0}^{\infty}|u(x)|^{2}(x+1)^{m} d x<\infty\right\}
\end{aligned}
$$

The following weighted Sobolev spaces

$$
H_{b}^{s}=\left\{u: \mathbb{R}^{+} \rightarrow \mathbb{R} ; \partial_{x}^{i} u \in L_{b}^{2} \text { for } 0 \leq i \leq s ; u(0)=0 \text { if } s \geq 1\right\}
$$

and

$$
H_{(x+1)^{m} d x}^{s}=\left\{u: \mathbb{R}^{+} \rightarrow \mathbb{R} ; \partial_{x}^{i} u \in L_{(x+1)^{m-i} d x}^{2} \text { for } 0 \leq i \leq s ; u(0)=0 \text { if } s \geq 1\right\}
$$

endowed with their usual inner products, will be used thereafter. Note that $H_{b}^{0}=L_{b}^{2}$ and that $H_{(x+1)^{m} d x}^{0}=L_{(x+1)^{m} d x}^{2}$.

The exponential decay in $L_{(x+1)^{m} d x}^{2}$ is obtained by constructing a convenient Lyapunov function (which actually decreases strictly on the sequence of times $\{k T\}_{k \geq 0}$ ) by induction on $m$. For $u_{0} \in L_{(x+1)^{m} d x}^{2}$, we also prove the following estimate

\begin{equation*}
\|u(t)\|_{H_{(x+1)^{m} d x}^{1}} \leq C \frac{e^{-\mu t}}{\sqrt{t}}\left\|u_{0}\right\|_{L_{(x+1)^{m} d x}^{2}} \tag{7}
\end{equation*}
$$

in two situations: (i) $m=1$ and $\left\|u_{0}\right\|_{L_{(x+1)^{m} d x}^{2}}$ is arbitrarily large; (ii) $m \geq 2$ and $\left\|u_{0}\right\|_{L_{(x+1)^{m} d x}^{2}}$ is small enough. In the situation (ii), we first establish a similar estimate for the linearized system and next apply the contraction mapping principle in a space of functions fulfilling the exponential decay. Note that (7) combines the (global) Kato smoothing effect to the exponential decay.

The exponential decay in $L_{b}^{2}$ is established for any initial data $u_{0} \in L_{b}^{2}$ under the additional assumption that $4 b^{3}+b<a_{0}$. Next, we can derive estimates of the form

\|u(t)\|_{H_{b}^{s}} \leq C \frac{e^{-\mu t}}{t^{s / 2}}\left\|u_{0}\right\|_{L_{b}^{2}}
$$

for any $s \geq 1$, revealing that $u(t)$ decays exponentially to 0 in strong norms.
It would be interesting to see if such results are still true when the function $a$ has a smaller support. It seems reasonable to conjecture that similar positive results can be derived when the support of $a$ contains a set of the form $\cup_{k \geq 1}\left[k a_{0}, k a_{0}+b_{0}\right]$ where $0<b_{0}<a_{0}$, while a negative result probably holds when the support of $a$ is a finite interval, as the $L^{2}$ norm of a soliton-like initial data may not be sufficiently dissipated over time. Such issues will be discussed elsewhere.

The plan of this paper is as follows. Section 2 is devoted to global well-posedness results in the weighted spaces $L_{b}^{2}$ and $L_{(x+1)^{2} d x}^{2}$. In section 3 , we prove the exponential decay in $L_{(x+1)^{m} d x}^{2}$ and $L_{b}^{2}$, and establish the exponential decay of the derivatives as well.

## 2 Global well-posedness

### 2.1 Global well-posedness in $L_{b}^{2}$

Fix any $b>0$. To begin with, we apply the classical semigroup theory to the linearized system

u(0, t)=0, \quad t>0 \\
u(x, 0)=u_{0}(x), \quad x>0

$$

Let us consider the operator

$$
A: D(A) \subset L_{b}^{2} \rightarrow L_{b}^{2}
$$

with domain

$$
D(A)=\left\{u \in L_{b}^{2} ; \partial_{x}^{i} u \in L_{b}^{2} \text { for } 1 \leq i \leq 3 \text { and } u(0)=0\right\}
$$

defined by

$$
A u=-u_{x x x}-u_{x}-a(x) u
$$

Then, the following result holds.
Lemma 2.1 The operator A defined above generates a continuous semigroup of operators $(S(t))_{t \geq 0}$ in $L_{b}^{2}$.

Proof. We first introduce the new variable $v=e^{b x} u$ and consider the following (IBVP)

v_{t}+\left(\partial_{x}-b\right) v+\left(\partial_{x}-b\right)^{3} v+a(x) v=0, \quad x, t \in \mathbb{R}^{+}  \tag{9}\\
v(0, t)=0, \quad t>0 \\
v(x, 0)=v_{0}(x)=e^{b x} u_{0}(x), \quad x>0
\end{array}\right.
$$

Clearly, the operator $B: D(B) \subset L^{2}\left(\mathbb{R}^{+}\right) \rightarrow L^{2}\left(\mathbb{R}^{+}\right)$with domain

$$
D(B)=\left\{u \in H^{3}\left(\mathbb{R}^{+}\right) ; u(0)=0\right\}
$$

defined by

$$
B v=-\left(\partial_{x}-b\right) v-\left(\partial_{x}-b\right)^{3} v-a(x) v
$$

is densely defined and closed. So, we are done if we prove that for some real number $\lambda$ the operator $B-\lambda$ and its adjoint $B^{*}-\lambda$ are both dissipative in $L^{2}\left(\mathbb{R}^{+}\right)$. It is readily seen that $B^{*}: D\left(B^{*}\right) \subset L^{2}\left(\mathbb{R}^{+}\right) \rightarrow L^{2}\left(\mathbb{R}^{+}\right)$is given by $B^{*} v=\left(\partial_{x}+b\right) v+\left(\partial_{x}+b\right)^{3} v-a(x) v$ with domain

$$
D\left(B^{*}\right)=\left\{v \in H^{3}\left(\mathbb{R}^{+}\right) ; v(0)=v^{\prime}(0)=0\right\}
$$

Pick any $v \in D(B)$. After some integration by parts, we obtain that

$$
(B v, v)_{L^{2}}=-\frac{1}{2} v_{x}^{2}(0)-3 b \int_{0}^{\infty} v_{x}^{2} d x+\left(b+b^{3}\right) \int_{0}^{\infty} v^{2} d x-\int_{0}^{\infty} a(x) v^{2} d x
$$

that is,

$$
\left(\left[B-\left(b^{3}+b\right)\right] v, v\right)_{L^{2}} \leq 0
$$

Analogously, we deduce that for any $v \in D\left(B^{*}\right)$

$$
\left(v,\left[B^{*}-\left(b^{3}+b\right)\right] v\right)_{L^{2}} \leq 0
$$

which completes the proof.

The following linear estimates will be needed.
Lemma 2.2 Let $u_{0} \in L_{b}^{2}$ and $u=S(\cdot) u_{0}$. Then, for any $T>0$

\frac{1}{2} \int_{0}^{\infty}|u(x, T)|^{2} d x-\frac{1}{2} \int_{0}^{\infty}\left|u_{0}(x)\right|^{2} d x+\int_{0}^{T} \int_{0}^{\infty} a(x)|u|^{2} d x d t+\frac{1}{2} \int_{0}^{T} u_{x}^{2}(0, t) d t=0 \tag{10}
\end{equation*}
$$

$$
\begin{align*}
& \frac{1}{2} \int_{0}^{\infty}|u(x, T)|^{2} e^{2 b x} d x-\frac{1}{2} \int_{0}^{\infty}\left|u_{0}(x)\right|^{2} e^{2 b x} d x+3 b \int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x d t \\
& -\left(4 b^{3}+b\right) \int_{0}^{T} \int_{0}^{\infty} u^{2} e^{2 b x} d x d t+\int_{0}^{T} \int_{0}^{\infty} a(x)|u|^{2} e^{2 b x} d x d t+\frac{1}{2} \int_{0}^{T} u_{x}^{2}(0, t) d t=0 \tag{11}
\end{align*}
$$

As a consequence,

$$
\begin{equation*}
\|u\|_{L^{\infty}\left(0, T ; L_{b}^{2}\right)}+\left\|u_{x}\right\|_{L^{2}\left(0, T ; L_{b}^{2}\right)} \leq C\left\|u_{0}\right\|_{L_{b}^{2}}, \tag{12}
\end{equation*}
$$

where $C=C(T)$ is a positive constant.

Proof. Pick any $u_{0} \in D(A)$. Multiplying the equation in (11) by $u$ and integrating over $(0,+\infty) \times$ $(0, T)$, we obtain (10). Then, the identity may be extended to any initial state $u_{0} \in L_{b}^{2}$ by a density argument. To derive (11) we first multiply the equation by $\left(e^{2 b x}-1\right) u$ and integrate by parts over $(0,+\infty) \times(0, T)$ to deduce that

$$
\begin{aligned}
& \frac{1}{2} \int_{0}^{\infty}|u(x, T)|^{2}\left(e^{2 b x}-1\right) d x-\frac{1}{2} \int_{0}^{\infty}\left|u_{0}(x)\right|^{2}\left(e^{2 b x}-1\right) d x+ \\
& +3 b \int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x d t-\left(4 b^{3}+b\right) \int_{0}^{T} \int_{0}^{\infty} u^{2} e^{2 b x} d x d t+ \\
& +\int_{0}^{T} \int_{0}^{\infty} a(x)|u|^{2}\left(e^{2 b x}-1\right) d x d t=0
\end{aligned}
$$

Adding the above equality and (10) hand to hand, we obtain (11) using the same density argument. Then, Gronwall inequality, (4) and (11) imply that

\|u\|_{L^{\infty}\left(0, T ; L_{b}^{2}\right)} \leq C\left\|u_{0}\right\|_{L_{b}^{2}},
$$

with $C=C(T)>0$. This estimate together with (11) gives us

$$
\left\|u_{x}\right\|_{L^{2}\left(0, T ; L_{b}^{2}\right)} \leq C\left\|u_{0}\right\|_{L_{b}^{2}},
$$

where $C=C(T)$ is a positive constant.

The global well-posedness result reads as follows:
Theorem 2.3 For any $u_{0} \in L_{b}^{2}$ and any $T>0$, there exists a unique solution $u \in C\left([0, T] ; L_{b}^{2}\right) \cap$ $L^{2}\left(0, T ; H_{b}^{1}\right)$ of (11).

Proof. By computations similar to those performed in the proof of Lemma 2.2, we obtain that for any $f \in C^{1}\left([0, T] ; L_{b}^{2}\right)$ and any $u_{0} \in D(A)$, the solution $u$ of the system

\begin{cases}u_{t}+u_{x}+u_{x x x}+a(x) u=f, & x \in \mathbb{R}^{+}, t \in(0, T) \\ u(0, t)=0, & t \in(0, T), \\ u(x, 0)=u_{0}(x), & x \in \mathbb{R}^{+},\end{cases}
$$

fulfills

$$
\begin{equation*}
\sup _{0 \leq t \leq T}\|u(t)\|_{L_{b}^{2}}+\left(\int_{0}^{T} \int_{0}^{\infty}\left|u_{x}\right|^{2} e^{2 b x} d x d t\right)^{\frac{1}{2}} \leq C\left(\left\|u_{0}\right\|_{L_{b}^{2}}+\int_{0}^{T}\|f\|_{L_{b}^{2}} d t\right) \tag{13}
\end{equation*}
$$

for some constant $C=C(T)$ nondecreasing in $T$. A density argument yields that $u \in C\left([0, T] ; L_{b}^{2}\right)$ when $f \in L^{1}\left(0, T ; L_{b}^{2}\right)$ and $u_{0} \in L_{b}^{2}$.

Let $u_{0} \in L_{b}^{2}$ be given. To prove the existence of a solution of (11) we introduce the map $\Gamma$ defined by

(\Gamma u)(t)=S(t) u_{0}+\int_{0}^{t} S(t-s) N(u(s)) d s
$$

where $N(u)=-u u_{x}$, and the space

$$
F=C\left([0, T] ; L_{b}^{2}\right) \cap L^{2}\left(0, T ; H_{b}^{1}\right)
$$

endowed with its natural norm. We shall prove that $\Gamma$ has a fixed-point in some ball $B_{R}(0)$ of $F$. We need the following

Claim 1. If $u \in H_{b}^{1}$ then

$$
\left\|u^{2} e^{2 b x}\right\|_{L^{\infty}\left(\mathbb{R}^{+}\right)} \leq(2+2 b)\|u\|_{L_{b}^{2}}\|u\|_{H_{b}^{1}}
$$

From Cauchy-Schwarz inequality, we get for any $\bar{x} \in \mathbb{R}^{+}$

\begin{aligned}
& u^{2}(\bar{x}) e^{2 b \bar{x}}=\int_{0}^{\bar{x}}\left[u^{2} e^{2 b x}\right]_{x} d x=\int_{0}^{\bar{x}}\left[2 u u_{x} e^{2 b x}+2 b u^{2} e^{2 b x}\right] d x \\
& \leq 2\left(\int_{0}^{\infty} u^{2} e^{2 b x} d x\right)^{\frac{1}{2}}\left(\int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x\right)^{\frac{1}{2}}+2 b \int_{0}^{\infty} u^{2} e^{2 b x} d x \leq(2+2 b)\|u\|_{L_{b}^{2}}\|u\|_{H_{b}^{1}}
\end{aligned}
$$

which guarantees that Claim 1 holds.
Claim 2. There exists a constant $K>0$ such that for $0<T \leq 1$

\|\Gamma(u)-\Gamma(v)\|_{F} \leq K T^{\frac{1}{4}}\left(\|u\|_{F}+\|v\|_{F}\right)\|u-v\|_{F}, \quad \forall u, v \in F
$$

According to the previous analysis,

$$
\|\Gamma(u)-\Gamma(v)\|_{F} \leq C\left\|u u_{x}-v v_{x}\right\|_{L^{1}\left(0, T ; L_{b}^{2}\right)}
$$

So, applying triangular inequality and Hölder inequality, we have

$$
\begin{align*}
\| \Gamma(u)- & \Gamma(v) \|_{F} \leq C\left\{\|u-v\|_{L^{2}\left(0, T ; L^{\infty}(0, \infty)\right)}\|u\|_{L^{2}\left(0, T ; H_{b}^{1}\right)}+\right. \\
& \left.+\|v\|_{L^{2}\left(0, T ; L^{\infty}(0, \infty)\right)}\|u-v\|_{L^{2}\left(0, T ; H_{b}^{1}\right)}\right\} . \tag{14}
\end{align*}
$$

Now, by Claim 1, we have

$$
\begin{equation*}
\|u\|_{L^{2}\left(0, T ; L^{\infty}(0, \infty)\right)} \leq C T^{\frac{1}{4}}\|u\|_{L^{\infty}\left(0, T ; L_{b}^{2}\right)}^{\frac{1}{2}}\|u\|_{L^{2}\left(0, T ; H_{b}^{1}\right)^{\frac{1}{2}}} \tag{15}
\end{equation*}
$$

Then, combining (14) and (15), we deduce that

$$
\begin{equation*}
\|\Gamma(u)-\Gamma(v)\|_{F} \leq C T^{\frac{1}{4}}\left\{\|u\|_{F}+\|v\|_{F}\right\}\|u-v\|_{F} \tag{16}
\end{equation*}
$$

Let $T>0, R>0$ be numbers whose values will be specified later, and let $u \in B_{R}(0) \subset F$ be given. Then, by Claim 2 and Lemma 2.2, $\Gamma u \in F$ and

\|\Gamma u\|_{F} \leq C\left(\left\|u_{0}\right\|_{L_{b}^{2}}+T^{\frac{1}{4}}\|u\|_{F}^{2}\right)
$$

Consequently, for $R=2 C\left\|u_{0}\right\|_{L_{b}^{2}}$ and $T>0$ small enough, $\Gamma$ maps $B_{R}(0)$ into itself. Moreover, we infer from (16) that this mapping contracts if $T$ is small enough. Then, by the contraction mapping theorem, there exists a unique solution $u \in B_{R}(0) \subset F$ to the problem (両) for $T$ small enough.

In order to prove that this solution is global, we need some a priori estimates. So, we proceed as in the proof of Lemma 2.2 to obtain for the solution $u$ of (目)

\end{equation*}
$$

and

$$
\begin{align*}
& \frac{1}{2} \int_{0}^{\infty}|u(x, T)|^{2} e^{2 b x} d x-\frac{1}{2} \int_{0}^{\infty}\left|u_{0}(x)\right|^{2} e^{2 b x} d x+\frac{1}{2} \int_{0}^{T} u_{x}^{2}(0, t) d t \\
& \quad+3 b \int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x d t-\left(4 b^{3}+b\right) \int_{0}^{T} \int_{0}^{\infty} u^{2} e^{2 b x} d x d t \\
& \quad+\int_{0}^{T} \int_{0}^{\infty} a(x)|u|^{2} e^{2 b x} d x d t-\frac{2 b}{3} \int_{0}^{T} \int_{0}^{\infty} u^{3} e^{2 b x} d x d t=0 \tag{18}
\end{align*}
$$

First, observe that

\left|\int_{0}^{\infty} u^{2} e^{2 b x} d x\right|=\left|-\frac{1}{b} \int_{0}^{\infty} u u_{x} e^{2 b x} d x\right| \leq \frac{1}{b}\left(\int_{0}^{\infty} u^{2} e^{2 b x} d x\right)^{\frac{1}{2}}\left(\int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x\right)^{\frac{1}{2}}

therefore,

& \leq \delta\left\|u_{x}\right\|_{L^{2}\left(0, T ; L_{b}^{2}\right)}^{2}+C_{\delta}\|u\|_{L^{2}\left(0, T ; L_{b}^{2}\right)}^{2},
\end{aligned}
$$

where $\delta>0$ is arbitrarily chosen and $C=C\left(b, \delta,\left\|u_{0}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)}\right)$is a positive constant. Combining this inequality (with $\delta<9 / 2$ ) to (18) results in

### 2.2 Global well-posedness in $L_{(x+1)^{2} d x}^{2}$

Definition 2.4 For $u_{0} \in L_{(x+1)^{2} d x}^{2}$ and $T>0$, we denote by a mild solution of (11) any function $u \in C\left([0, T] ; L_{(x+1)^{2} d x}^{2}\right) \cap L^{2}\left(0, T ; H_{(x+1)^{2} d x}^{1}\right)$ which solves (11), and such that for some $b>0$ and some sequence $\left\{u_{n, 0}\right\} \subset L_{b}^{2}$ we have

& u_{n} \rightarrow u \text { weakly in } L^{2}\left(0, T ; H_{(x+1)^{2} d x}^{1}\right),
\end{aligned}
$$

$u_{n}$ denoting the solution of (1]) emanating from $u_{n, 0}$ at $t=0$.
Theorem 2.5 For any $u_{0} \in L_{(x+1)^{2} d x}^{2}$ and any $T>0$, there exists a unique mild solution $u \in$ $C\left([0, T] ; L_{(x+1)^{2} d x}^{2}\right) \cap L^{2}\left(0, T ; H_{(x+1)^{2} d x}^{1}\right)$ of (1).

Proof. We prove the existence and the uniqueness in two steps.
Step 1. Existence
Since the embedding $L_{b}^{2} \subset L_{(x+1)^{2} d x}^{2}$ is dense, for any given $u_{0} \in L_{(x+1)^{2} d x}^{2}$ we may construct a sequence $\left\{u_{n, 0}\right\} \subset L_{b}^{2}$ such that $u_{n, 0} \rightarrow u_{0}$ in $L_{(x+1)^{2} d x}^{2}$ as $n \rightarrow \infty$. For each $n$, let $u_{n}$ denote the solution of (11) emanating from $u_{n, 0}$ at $t=0$, which is given by Theorem 2.3. Then $u_{n} \in$ $C\left([0, T] ; L_{b}^{2}\right) \cap L^{2}\left(0, T ; H_{b}^{1}\right)$ and it solves

Multiplying (19) by $(x+1)^{2} u_{n}$ and integrating by parts, we obtain

& -\int_{0}^{T} \int_{0}^{\infty}(x+1)\left|u_{n}\right|^{2} d x d t-\frac{2}{3} \int_{0}^{T} \int_{0}^{\infty}(x+1) u_{n}^{3} d x d t+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{2} u_{n}^{2} a(x) d x
\end{aligned}
$$

$$
\begin{equation*}
=\frac{1}{2} \int_{0}^{\infty}(x+1)^{2}\left|u_{n, 0}(x)\right|^{2} d x \tag{22}
\end{equation*}
$$

Scaling in (19) by $u_{n}$ gives

\begin{aligned}
& \frac{1}{2} \int_{0}^{\infty}\left|u_{n}(x, T)\right|^{2} d x+\frac{1}{2} \int_{0}^{T}\left|u_{n, x}(0, t)\right|^{2} d t+\int_{0}^{T} \int_{0}^{\infty} a(x)\left|u_{n}(x, t)\right|^{2} d x d t \\
& =\frac{1}{2} \int_{0}^{\infty}\left|u_{n, 0}(x)\right|^{2} d x
\end{aligned}
$$

hence

\left\|u_{n}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)} \leq\left\|u_{n, 0}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)} \leq C \tag{23}
\end{equation*}
$$

where $C=C\left(\left\|u_{0}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)}\right)$. It follows that

\frac{2}{3} \int_{0}^{\infty}(x+1)\left|u_{n}\right|^{3} d x & \leq \frac{2 \sqrt{2}}{3}\left\|u_{n, x}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)}^{\frac{1}{2}}\left\|u_{n}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)}^{\frac{3}{2}}\left\|(x+1) u_{n}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)} \\
& \leq \int_{0}^{\infty}(x+1)\left|u_{n, x}\right|^{2} d x+C \int_{0}^{\infty}(x+1)^{2}\left|u_{n}\right|^{2} d x \tag{24}
\end{align*}
$$

which, combined to (22), gives

& \quad \leq \frac{1}{2} \int_{0}^{\infty}(x+1)^{2}\left|u_{n, 0}(x)\right|^{2} d x+C \int_{0}^{T} \int_{0}^{\infty}(x+1)^{2}\left|u_{n}(x, t)\right|^{2} d x d t
\end{aligned}
$$

An application of Gronwall's lemma yields

\left\|u_{n, x}(0, .)\right\|_{L^{2}(0, T)} & \leq C\left(T,\left\|u_{n, 0}\right\|_{L_{(x+1)^{2} d x}^{2}}^{2}\right)
\end{aligned}
$$

Therefore, there exists a subsequence of $\left\{u_{n}\right\}$, still denoted by $\left\{u_{n}\right\}$, such that

u_{n, x}(0, .) \rightharpoonup u_{x}(0, .) \text { weakly in } L^{2}(0, T) .
\end{array}\right.
$$

Note that, for all $L>0,\left\{u_{n}\right\}$ is bounded in $L^{2}\left(0, T ; H^{1}(0, L)\right) \cap H^{1}\left(0, T ; H^{-2}(0, L)\right)$, hence by Aubin's lemma, we have (after extracting a subsequence if needed)

This gives that $u_{n} u_{n, x} \rightarrow u u_{x}$ in the sense of distributions, hence the limit $u \in L^{\infty}\left(0, T ; L_{(x+1)^{2} d x}^{2}\right) \cap$ $L^{2}\left(0, T ; H_{(x+1)^{2} d x}^{1}\right)$ is a solution of (11). Let us check that $u \in C\left([0, T] ; L_{(x+1)^{2} d x}^{2}\right)$. Since $u \in$ $C\left([0, T] ; H^{-2}\left(\mathbb{R}^{+}\right)\right) \cap L^{\infty}\left(0, T ; L_{(x+1)^{2} d x}^{2}\right)$, we have that $u \in C_{w}\left([0, T] ; L_{(x+1)^{2} d x}^{2}\right)$ (see e.g. [21]), where $C_{w}\left([0, T] ; L_{(x+1)^{2} d x}^{2}\right)$ denotes the space of sequentially weakly continuous functions from $[0, T]$ into $L_{(x+1)^{2} d x}^{2}$.

We claim that $u \in L^{3}\left(0, T ; L^{3}\left(\mathbb{R}^{+}\right)\right)$. Indeed, from Moser estimate (see [31])

and Young inequality we get

\end{equation*}

where $\varepsilon>0$ is arbitrarily chosen and $c_{\varepsilon}$ denotes some positive constant. Since $u \in C_{w}\left([0, T] ; L_{(x+1)^{2} d x}^{2}\right) \cap$ $L^{2}\left(0, T ; H_{(x+1)^{2} d x}^{1}\right)$, it follows that $u \in L^{3}\left(0, T ; L^{3}\left(\mathbb{R}^{+}\right)\right)$. On the other hand, $u(0, t)=0$ for $t \in(0, T)$ and $u_{x}(0,.) \in L^{2}(0, T)$. Scaling in (1]) by $(x+1)^{2} u$ yields for all $t_{1}, t_{2} \in(0, T)$

& =-3 \int_{t_{1}}^{t_{2}} \int_{0}^{\infty}(x+1)\left|u_{x}\right|^{2} d x d t-\frac{1}{2} \int_{t_{1}}^{t_{2}}\left|u_{x}(0, t)\right|^{2} d t+\int_{t_{1}}^{t_{2}} \int_{0}^{\infty}(x+1)|u|^{2} d x d t \\
& +\frac{2}{3} \int_{t_{1}}^{t_{2}} \int_{0}^{\infty}(x+1) u^{3} d x d t-\int_{t_{1}}^{t_{2}} \int_{0}^{\infty}(x+1)^{2} a(x)|u|^{2} d x d t . \tag{27}
\end{align*}
$$

Therefore $\lim _{t_{1} \rightarrow t_{2}}| | u\left(t_{2}\right)\left\|_{L_{(x+1)^{2} d x}^{2}}^{2}-\right\| u\left(t_{1}\right) \|_{L_{(x+1)^{2} d x}^{2}}^{2} \mid=0$. Combined to the fact that $u \in C_{w}\left([0, T] ; L_{(x+1)^{2} d x}^{2}\right)$ this yields $u \in C\left([0, T], L_{(x+1)^{2} d x}^{2}\right)$.
Step 2. Uniqueness
Here, $C$ will denote a universal constant which may vary from line to line. Pick $u_{0} \in L_{(x+1)^{2} d x}^{2}$, and let $u, v \in C\left([0, T] ; L_{(x+1)^{2} d x}^{2}\right) \cap L^{2}\left(0, T ; H_{(x+1)^{2} d x}^{1}\right)$ be two mild solutions of (11). Pick two sequences $\left\{u_{n, 0}\right\},\left\{v_{n, 0}\right\}$ in $L_{b}^{2}$ for some $b>0$ such that

& u_{n, 0} \rightarrow u_{0} \text { strongly in } L_{(x+1)^{2} d x}^{2},  \tag{28}\\
& u_{n} \rightarrow u \text { weakly } * \text { in } L^{\infty}\left(0, T ; L_{(x+1)^{2} d x}^{2}\right),  \tag{29}\\
& u_{n} \rightarrow u \text { weakly in } L^{2}\left(0, T ; H_{(x+1)^{2} d x}^{1}\right) \tag{30}
\end{align*}
$$

and also

& v_{n, 0} \rightarrow u_{0} \text { strongly in } L_{(x+1)^{2} d x}^{2},  \tag{31}\\
& v_{n} \rightarrow v \text { weakly } * \text { in } L^{\infty}\left(0, T ; L_{(x+1)^{2} d x}^{2}\right),  \tag{32}\\
& v_{n} \rightarrow v \text { weakly in } L^{2}\left(0, T ; H_{(x+1)^{2} d x}^{1}\right) \tag{33}
\end{align*}
$$

We shall prove that $w=u-v$ vanishes on $\mathbb{R}^{+} \times[0, T]$ by providing some estimate for $w_{n}=u_{n}-v_{n}$. Note first that $w_{n}$ solves the system

& \leq \frac{1}{2} \int_{0}^{\infty}(x+1)\left|w_{n, 0}\right|^{2} d x+\int_{0}^{t}\left(\int_{0}^{\infty}(x+1)\left|w_{n}\right|^{2} d x\right)^{\frac{1}{2}}\left(\int_{0}^{\infty}(x+1)\left|f_{n}\right|^{2} d x\right)^{\frac{1}{2}} d \tau \\
& \leq \frac{1}{2} \int_{0}^{\infty}(x+1)\left|w_{n, 0}\right|^{2} d x+\frac{1}{4} \sup _{0<\tau<t} \int_{0}^{\infty}(x+1)\left|w_{n}(x, \tau)\right|^{2} d x \\
& \quad+\left[\int_{0}^{T}\left(\int_{0}^{\infty}(x+1)\left|f_{n}\right|^{2} d x\right)^{\frac{1}{2}} d \tau\right]^{2} .
\end{aligned}

Since $\left\|w_{n}(t)\right\|_{L^{2}\left(\mathbb{R}^{+}\right)} \leq\left\|w_{n}(t)\right\|_{L_{(x+1) d x}^{2}}$, this yields for $T<1 / 10$

It remains to estimate $\int_{0}^{T}\left(\int_{0}^{\infty}(x+1)\left|f_{n}\right|^{2} d x\right)^{\frac{1}{2}} d t$. We split $f_{n}$ into

& \leq\left(\int_{0}^{T}\left\|w_{n}\right\|_{L^{\infty}\left(\mathbb{R}^{+}\right)}^{2} d t\right)^{\frac{1}{2}}\left(\int_{0}^{T} \int_{0}^{\infty}(x+1)\left|v_{n, x}\right|^{2} d x d t\right)^{\frac{1}{2}}
\end{aligned}

By Sobolev embedding, we have that

& \leq \sqrt{T} \sup _{0<t<T}\left\|w_{n}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)}+\left\|w_{n, x}\right\|_{L^{2}\left(0, T ; L^{2}\left(\mathbb{R}^{+}\right)\right)}
\end{aligned}
$$

Thus

& \int_{0}^{T}\left(\int_{0}^{\infty}(x+1)\left|f_{n}^{1}\right|^{2} d x\right)^{\frac{1}{2}} d t \leq\left\|v_{n, x}\right\|_{L^{2}\left(0, T ; L_{(x+1) d x}^{2}\right)}\left(\sqrt{T} \sup _{0<t<T}\left\|w_{n}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)}\right. \\
& \left.\quad+\left\|w_{n, x}\right\|_{L^{2}\left(0, T ; L^{2}\left(\mathbb{R}^{+}\right)\right)}\right) \tag{38}
\end{align*}
$$

On the other hand, we have that

\begin{aligned}
& \int_{0}^{T}\left(\int_{0}^{\infty}(x+1)\left|f_{n}^{2}\right|^{2} d x\right)^{\frac{1}{2}} d t \\
& \quad=\int_{0}^{T}\left(\int_{0}^{\infty}(x+1)\left|u_{n}\right|^{2}\left|w_{n, x}\right|^{2} d x\right)^{\frac{1}{2}} d t \\
& \leq \int_{0}^{T}\left\|(x+1)^{\frac{1}{2}} u_{n}\right\|_{L^{\infty}\left(\mathbb{R}^{+}\right)}\left\|w_{n, x}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)} d t \\
& \leq C \int_{0}^{T}\left(\left\|(x+1)^{\frac{1}{2}} u_{n}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)}+\left\|(x+1)^{\frac{1}{2}} u_{n, x}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)}\right)\left\|w_{n, x}\right\|_{L^{2}\left(\mathbb{R}^{+}\right)} d t \\
& \leq C\left(\sqrt{T}\left\|(x+1) u_{n}\right\|_{L^{\infty}\left(0, T ; L^{2}\left(\mathbb{R}^{+}\right)\right)}\right. \\
& \quad\left.\quad+\left\|(x+1)^{\frac{1}{2}} u_{n, x}\right\|_{L^{2}\left(0, T, L^{2}\left(\mathbb{R}^{+}\right)\right)}\right)\left\|w_{n, x}\right\|_{L^{2}\left(0, T ; L^{2}\left(\mathbb{R}^{+}\right)\right)} .
\end{aligned}
$$

Gathering together (37), (38) and (39), we conclude that for $T<1 / 10$

$$
h_{n}(T) \leq K_{n}(T) h_{n}(T)+C\left\|w_{n, 0}\right\|_{L_{(x+1) d x}^{2}}^{2}
$$

where

$$
\begin{align*}
h_{n}(t):= & \sup _{0<\tau<T} \int_{0}^{\infty}(x+1)\left|w_{n}(x, \tau)\right|^{2} d x+\int_{0}^{T} \int_{0}^{\infty}\left|w_{n, x}\right|^{2} d x d t  \tag{40}\\
K_{n}(T) \leq & C\left(\int_{0}^{T} \int_{0}^{\infty}(x+1)\left|v_{n, x}\right|^{2} d x d t+T| |(x+1) u_{n} \|_{L^{\infty}\left(0, T ; L^{2}\left(\mathbb{R}^{+}\right)\right)}^{2}\right. \\
& \left.+\int_{0}^{T} \int_{0}^{\infty}(x+1)\left|u_{n, x}\right|^{2} d x d t\right) \tag{41}
\end{align*}
$$

and $C$ denotes a universal constant. The following claim is needed.
Claim 3.

$$
\lim _{T \rightarrow 0} \limsup _{n \rightarrow \infty} \int_{0}^{T} \int_{0}^{\infty}(x+1)\left|u_{n, x}\right|^{2} d x d t=0, \quad \lim _{T \rightarrow 0} \limsup _{n \rightarrow \infty} \int_{0}^{T} \int_{0}^{\infty}(x+1)\left|v_{n, x}\right|^{2} d x d t=0
$$

Clearly, it is sufficient to prove the claim for the sequence $\left\{u_{n}\right\}$ only. From (27) applied with $u=u_{n}$ on $[0, T]$, we obtain

& \frac{1}{2} \int_{0}^{\infty}(x+1)^{2}\left|u_{n}(x, T)\right|^{2} d x+3 \int_{0}^{T} \int_{0}^{\infty}(x+1)\left|u_{n, x}\right|^{2} d x d t \\
& \leq \frac{1}{2} \int_{0}^{\infty}(x+1)^{2}\left|u_{n, 0}\right|^{2} d x+\int_{0}^{T} \int_{0}^{\infty}(x+1)\left|u_{n}\right|^{2} d x d t+\frac{2}{3} \int_{0}^{T} \int_{0}^{\infty}(x+1)\left|u_{n}\right|^{3} d x d t
\end{aligned}
$$

Combined to (23)-(24), this gives

$$
\begin{align*}
& \left\|u_{n}(T)\right\|_{L_{(x+1)^{2} d x}^{2}}^{2}+\int_{0}^{T} \int_{0}^{\infty}(x+1)\left|u_{n, x}\right|^{2} d x d t \\
& \quad \leq\left\|u_{n, 0}\right\|_{L_{(x+1)^{2} d x}^{2}}^{2}+C \int_{0}^{T}\left\|u_{n}\right\|_{L_{(x+1)^{2} d x}^{2}}^{2} d t . \tag{42}
\end{align*}
$$

It follows from Gronwall lemma that

Using (43) in (42) and taking the limit sup as $n \rightarrow \infty$ gives for a.e. $T$

As $u$ is continuous from $\mathbb{R}^{+}$to $L_{(x+1)^{2} d x}^{2}$, we infer that

\lim _{T \rightarrow 0} \limsup _{n \rightarrow \infty} \int_{0}^{T} \int_{0}^{\infty}\left|u_{n, x}\right|^{2} d x d t=0 .
$$

The claim is proved. Therefore, we have that for $T>0$ small enough and $n$ large enough, $K_{n}(T)<$ $\frac{1}{2}$, and hence

and $u=v$ for $0<t<T$. This proves the uniqueness for $T$ small enough. The general case follows by a classical argument.

Remark 2.6 1. If we assume only that $u_{0} \in L_{(x+1) d x}^{2}$, then a proof similar to Step 1 gives the existence of a mild solution $u \in C\left([0, T] ; L_{(x+1) d x}^{2}\right) \cap L^{2}\left(0, T ; H_{(x+1) d x}^{1}\right)$ of (11). The uniqueness of such a solution is open. The existence and uniqueness of a solution issuing from $u_{0} \in L_{(x+1) d x}^{2}$ in a class of functions involving a Bourgain norm has been given in [13].
2. If $u_{0} \in L_{(x+1)^{m} d x}^{2}$ with $m \geq 3$, then $u \in C\left([0, T] ; L_{(x+1)^{m} d x}^{2}\right) \cap L^{2}\left(0, T ; H_{(x+1)^{m} d x}^{1}\right)$ for all $T>0$ (see below Theorem 3.1).

## 3 Asymptotic Behavior

### 3.1 Decay in $L_{(x+1)^{m} d x}^{2}$

Theorem 3.1 Assume that the function $a=a(x)$ satisfies (4). Then, for all $R>0$ and $m \geq 1$, there exist numbers $C>0$ and $\nu>0$ such that

$$
\|u(t)\|_{L_{(x+1)^{m}{ }_{d x}}^{2}} \leq C e^{-\nu t}\left\|u_{0}\right\|_{L_{(x+1)^{m}}^{2}}
$$

for any solution given by Theorem 2.5, whenever $\left\|u_{0}\right\|_{L_{(x+1)^{m} d x}^{2}} \leq R$.
Proof. The proof will be done by induction in $m$. We set

$$
\begin{equation*}
V_{0}(u)=E(u)=\frac{1}{2} \int_{0}^{\infty} u^{2} d x \tag{44}
\end{equation*}
$$

and define the Lyapunov function $V_{m}$ for $m \geq 1$ in an inductive way

$$
\begin{equation*}
V_{m}(u)=\frac{1}{2} \int_{0}^{\infty}(x+1)^{m} u^{2} d x+d_{m-1} V_{m-1}(u), \tag{45}
\end{equation*}
$$

where $d_{m-1}>0$ is chosen sufficiently large (see below).
Suppose first that $m=1$ and put $V=V_{1}$. Multiplying the first equation in (1) by $u$ and integrating by parts over $\mathbb{R}^{+} \times(0, T)$, we obtain

\frac{1}{2} \int_{0}^{\infty}|u(x, T)|^{2} d x=\frac{1}{2} \int_{0}^{\infty}\left|u_{0}(x)\right|^{2} d x-\int_{0}^{T} \int_{0}^{\infty} a(x)|u|^{2} d x d t-\frac{1}{2} \int_{0}^{T} u_{x}^{2}(0, t) d t \tag{46}
\end{equation*}
$$

Now, multiplying the equation by $x u$, we deduce that

& \frac{1}{2} \int_{0}^{\infty} x|u(x, T)|^{2} d x-\frac{1}{2} \int_{0}^{\infty} x\left|u_{0}(x)\right|^{2} d x+\frac{3}{2} \int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} d x d t \\
& -\frac{1}{2} \int_{0}^{T} \int_{0}^{\infty} u^{2} d x d t-\frac{1}{3} \int_{0}^{T} \int_{0}^{\infty} u^{3} d x d t+\int_{0}^{T} \int_{0}^{\infty} x a(x)|u|^{2} d x d t=0 \tag{47}
\end{align*}
$$

Combining (46) and (47) it follows that

\begin{array}{r}
V(u)-V\left(u_{0}\right)+\left(d_{0}+1\right)\left(\frac{1}{2} \int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty} a(x)|u|^{2} d x d t\right) \\
+\frac{3}{2} \int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} d x d t-\frac{1}{2} \int_{0}^{T} \int_{0}^{\infty} u^{2} d x d t-\frac{1}{3} \int_{0}^{T} \int_{0}^{\infty} u^{3} d x d t \\
+\int_{0}^{T} \int_{0}^{\infty} x a(x)|u|^{2} d x d t=0 . \tag{48}
\end{array}
$$

The next step is devoted to estimate the nonlinear term in the left hand side of (48). To do that, we first assume that $\left\|u_{0}\right\|_{L^{2}} \leq 1$.

By (26) we have that

\int_{0}^{\infty}|u|^{3} d x \leq \varepsilon\left\|u_{x}\right\|_{L^{2}}^{2}+c_{\varepsilon}\|u\|_{L^{2}}^{\frac{10}{3}}
$$

for any $\varepsilon>0$ and some constant $c_{\varepsilon}>0$. Thus, if $\left\|u_{0}\right\|_{L^{2}} \leq 1$, we have $\|u\|_{L^{2}}^{\frac{10}{3}} \leq\|u\|_{L^{2}}^{2}$ and

\begin{equation*}
\int_{0}^{T} \int_{0}^{\infty}|u|^{3} d x d t \leq \varepsilon \int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} d x d t+c_{\varepsilon} \int_{0}^{T} \int_{0}^{\infty} u^{2} d x d t \tag{49}
\end{equation*}
$$

Moreover, according to 20], there exists $c_{1}>0$, satisfying

\int_{0}^{T} \int_{0}^{\infty} u^{2} d x d t \leq c_{1}\left\{\frac{1}{2} \int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty} a(x) u^{2} d x d t\right\} \tag{50}
\end{equation*}
$$

Now, combining (48)-(50) and taking $\varepsilon<\frac{1}{2}$ and $d_{0}:=2 c_{1}\left(\frac{1}{2}+\frac{c_{\varepsilon}}{3}\right)$ we obtain

& V(u(T))-V\left(u_{0}\right)+\frac{d_{0}+1}{2}\left(\frac{1}{2} \int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty} a(x)|u|^{2} d x d t\right) \\
& \quad+\left(\frac{3}{2}-\frac{\varepsilon}{3}\right) \int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} d x d t+\int_{0}^{T} \int_{0}^{\infty} x a(x)|u|^{2} d x d t \leq 0 \tag{51}
\end{align*}
$$

or

$$
\begin{equation*}
V(u(T))-V\left(u_{0}\right) \leq-\widetilde{c}\left\{\int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty}(x+1) a(x)|u|^{2} d x d t+\int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} d x d t\right\} \tag{52}
\end{equation*}
$$

where $\widetilde{c}>0$. We aim to prove the existence of a constant $c>0$ satisfying

V(u(T))-V\left(u_{0}\right) \leq-c V\left(u_{0}\right) \tag{53}
\end{equation*}
$$

Indeed, such an inequality gives at once the decay $V(u(t)) \leq c e^{-\nu t} V\left(u_{0}\right)$. To this end, we need to establish two claims.

Claim 4. There exists $c>0$ such that

\leq & \frac{c_{1} d_{0}}{2}\left\{\frac{1}{2} \int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty} a(x) u^{2} d x d t\right\} \\
& +\frac{1}{2} \int_{0}^{T} \int_{0}^{x_{0}}(x+1) u^{2} d x d t+\frac{1}{2} \int_{0}^{T} \int_{x_{0}}^{\infty}(x+1) u^{2} d x d t \\
\leq & \frac{c_{1} d_{0}}{2}\left\{\frac{1}{2} \int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty} a(x) u^{2} d x d t\right\} \\
& +\frac{1}{2}\left(x_{0}+1\right) \int_{0}^{T} \int_{0}^{x_{0}} u^{2} d x d t+\frac{1}{2} \int_{0}^{T} \int_{x_{0}}^{\infty}(x+1) \frac{a(x)}{a_{0}} u^{2} d x d t \\
\leq & c\left\{\int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty}(x+1) a(x) u^{2} d x d t\right\}
\end{aligned}
$$

Claim 5.

$$
\begin{equation*}
V\left(u_{0}\right) \leq C\left(\int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty}(x+1) a(x) u^{2} d x d t+\int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} d x d t\right) \tag{54}
\end{equation*}
$$

where $C>0$.
Multiplying the first equation in (11) by $(T-t) u$ and integrating by parts in $(0, \infty) \times(0, T)$, we obtain

\begin{align*}
& \frac{T}{2} \int_{0}^{\infty}\left|u_{0}(x)\right|^{2} d x= \\
& \frac{1}{2} \int_{0}^{T} \int_{0}^{\infty}|u|^{2} d x d t+\int_{0}^{T} \int_{0}^{\infty}(T-t) a(x)|u|^{2} d x d t+\frac{1}{2} \int_{0}^{T}(T-t) u_{x}^{2}(0, t) d t \tag{55}
\end{align*}
$$

and therefore, using (50)

$$
\begin{equation*}
\int_{0}^{\infty}\left|u_{0}(x)\right|^{2} d x \leq C\left(\int_{0}^{T} \int_{0}^{\infty} a(x)|u|^{2} d x d t+\int_{0}^{T} u_{x}^{2}(0, t) d t\right) \tag{56}
\end{equation*}
$$

Now, multiplying by $(T-t) x u$, it follows that

\begin{aligned}
& -\frac{T}{2} \int_{0}^{\infty} x\left|u_{0}(x)\right|^{2} d x+\frac{1}{2} \int_{0}^{T} \int_{0}^{\infty} x|u|^{2} d x d t+\frac{3}{2} \int_{0}^{T} \int_{0}^{\infty}(T-t) u_{x}^{2} d x d t \\
& -\frac{1}{2} \int_{0}^{T} \int_{0}^{\infty}(T-t) u^{2} d x d t+\int_{0}^{T} \int_{0}^{\infty}(T-t) x a(x)|u|^{2} d x d t- \\
& -\frac{1}{3} \int_{0}^{T} \int_{0}^{\infty}(T-t) u^{3} d x d t=0
\end{aligned}
$$

The identity above and (49) allow us to conclude that

\begin{align*}
& \int_{0}^{\infty} x\left|u_{0}(x)\right|^{2} d x \\
& \leq C\left\{\int_{0}^{T} \int_{0}^{\infty}(x+1)|u|^{2} d x d t+\int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} d x d t+\int_{0}^{T} \int_{0}^{\infty} x a(x)|u|^{2} d x d t+\right.  \tag{57}\\
& \left.+\int_{0}^{T} \int_{0}^{\infty}|u|^{3} d x d t\right\} \leq C\left\{\int_{0}^{T} V(u(t)) d t+\int_{0}^{T} \int_{0}^{\infty} x a(x) u^{2} d x d t+\int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} d x d t\right\}
\end{align*}
$$

for some $C>0$. Claim 5 follows from Claim 4 and (56)-(57).

The previous computations give us (53) (and the exponential decay) when
$\left\|u_{0}\right\|_{L^{2}} \leq 1$. The general case is proved as follows. Let $u_{0} \in L_{(x+1) d x}^{2} \subset L^{2}$ be such that $\left\|u_{0}\right\|_{L^{2}} \leq R$. Since $u \in C\left(\mathbb{R}^{+} ; L^{2}\left(\mathbb{R}^{+}\right)\right)$and $\|u(t)\|_{L^{2}} \leq \alpha e^{-\beta t}\left\|u_{0}\right\|_{L^{2}}$, where $\alpha=\alpha(R)$ and $\beta=\beta(R)$ are positive constants, $\|u(T)\|_{L^{2}} \leq 1$ if we pick $T$ satisfying $\alpha e^{-\beta T} R<1$. Then, it follows from (48)-(26) and (53) that for some constants $\nu>0, c>0, C>0$

V(u(t+T)) \leq c e^{-\nu t} V(u(T)) \leq c\left(T\left\|u_{0}\right\|_{L^{2}}^{2}+T\left\|u_{0}\right\|_{L^{2}}^{\frac{10}{3}}+V\left(u_{0}\right)\right) e^{-\nu t}
$$

hence

V(u(t)) \leq C e^{-\nu t} V\left(u_{0}\right)
$$

where $C=C(R)$, which concludes the proof when $m=1$.
Induction Hypothesis: There exist $c>0$ and $\rho>0$ such that if $V_{m-1}\left(u_{0}\right) \leq \rho$, we have

& \leq-c\left\{\int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} u_{x}^{2} d x d t+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m} a(x) u^{2} d x d t\right\} \\
& V_{m}\left(u_{0}\right) \\
& \leq c\left\{\int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} u_{x}^{2} d x d t+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m} a(x) u^{2} d x d t\right\}
\end{aligned}
$$

By (52)-(54), the induction hypothesis is true for $m=1$. Pick now an index $m \geq 2$ and assume that $d_{0}, \ldots, d_{m-2}$ have been constructed so that $(*)_{k}-(* *)_{k}$ are fulfilled for $1 \leq k \leq m-1$. We aim to prove that for a convenient choice of the constant $d_{m-1}$ in (45), the properties $(*)_{m}-(* *)_{m}$ hold true.

Let us investigate first $(*)_{m}$. We multiply the first equation in (11) by $(x+1)^{m} u$ to obtain

& +\frac{3 m}{2} \int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} u_{x}^{2} d x d t-\frac{m}{2} \int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} u^{2} d x d t  \tag{58}\\
& -\frac{m}{3} \int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} u^{3} d x d t+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m} a(x) u^{2} d x d t=0
\end{align*}
$$

The next steps are devoted to estimate the terms in the above identity. First, combining (4) and (50) we infer the existence of a positive constant $c>0$ such that

& =\int_{0}^{T} \int_{0}^{x_{0}}(x+1)^{m-1} u^{2} d x d t+\int_{0}^{T} \int_{x_{0}}^{\infty}(x+1)^{m-1} u^{2} d x d t \\
& \leq\left(x_{0}+1\right)^{m-1} \int_{0}^{T} \int_{0}^{\infty} u^{2} d x d t+\frac{1}{a_{0}} \int_{0}^{T} \int_{0}^{\infty} a(x)(x+1)^{m-1} u^{2} d x d t  \tag{59}\\
& \leq c\left\{\int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} a(x) u^{2} d x d t\right\} \\
& \leq-c\left\{V_{m-1}(u)-V_{m-1}\left(u_{0}\right)\right\}
\end{align*}
$$

where we used $(*)_{m-1}$. In the same way

& \int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-3} u^{2} d x d t \\
& \leq \int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} u^{2} d x d t \leq-c\left\{V_{m-1}(u)-V_{m-1}\left(u_{0}\right)\right\} \tag{60}
\end{align*}
$$

where $c>0$ is a positive constant. Moreover, assuming $V_{m-1}\left(u_{0}\right) \leq \rho$ with $\rho>0$ small enough (so that by exponential decay of $V_{m-1}(u(t))$ we have $\int_{0}^{\infty}(x+1)^{m-1}|u(x, t)|^{2} d x \leq 1$ for all $\left.t \geq 0\right)$ and proceeding as in the case $m=1$, we obtain the existence of $\varepsilon>0$ and $c_{\varepsilon}>0$ satisfying

& \int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1}|u|^{3} d x d t  \tag{61}\\
& \leq \varepsilon \int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} u_{x}^{2} d x d t+c_{\varepsilon} \int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} u^{2} d x d t
\end{align*}
$$

Indeed,

& \int_{0}^{\infty}(x+1)^{m-1}|u|^{3} d x  \tag{62}\\
& \leq\|u\|_{L^{\infty}} \int_{0}^{\infty}(x+1)^{m-1} u^{2} d x \leq \sqrt{2}\left\|u_{x}\right\|_{L^{2}}^{\frac{1}{2}}\|u\|_{L^{2}}^{\frac{1}{2}} \int_{0}^{\infty}(x+1)^{m-1} u^{2} d x \\
& \leq \varepsilon \int_{0}^{\infty}(x+1)^{m-1} u_{x}^{2} d x+c_{\varepsilon} \int_{0}^{\infty} u^{2} d x+c_{\varepsilon}\left(\int_{0}^{\infty}(x+1)^{m-1} u^{2} d x\right)^{2}
\end{align*}
$$

Then, if we return to (58) and take $\varepsilon<9 / 2$ and $d_{m-1}>0$ large enough, from (59)-(61) if follows that

$$
\begin{align*}
& V_{m}(u)-V_{m}\left(u_{0}\right) \\
& \leq-c\left\{\int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} u_{x}^{2} d x d t+\int_{0}^{T} \int_{0}^{\infty} a(x)(x+1)^{m} u^{2} d x d t\right\}  \tag{63}\\
& +\frac{d_{m-1}}{2}\left(V_{m-1}(u)-V_{m-1}\left(u_{0}\right)\right)
\end{align*}
$$

This yields $(*)_{m}$, by $(*)_{m-1}$. Let us now check $(* *)_{m}$. It remains to estimate the terms in the right hand side of (63). We multiply the first equation in (11) by $(T-t)(x+1)^{m} u$ to obtain

& +\frac{3 m}{2} \int_{0}^{T} \int_{0}^{\infty}(T-t)(x+1)^{m-1} u_{x}^{2} d x d t-\frac{m}{2} \int_{0}^{T} \int_{0}^{\infty}(T-t)(x+1)^{m-1} u^{2} d x d t \\
& -\frac{m}{3} \int_{0}^{T} \int_{0}^{\infty}(T-t)(x+1)^{m-1} u^{3} d x d t+\int_{0}^{T} \int_{0}^{\infty}(T-t)(x+1)^{m} a(x) u^{2} d x d t
\end{aligned}
$$

Then, proceeding as above, we deduce that

& \int_{0}^{T}(x+1)^{m} u_{0}^{2} d x \\
& \leq c\left\{\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} u^{2} d x d t+\int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} u_{x}^{2} d x d t\right. \\
& \left.+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m} a(x) u^{2} d x d t\right\} \\
& \leq c\left\{\int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} u_{x}^{2} d x d t+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m} a(x) u^{2} d x d t\right\}
\end{aligned}
$$

Combined to $(* *)_{m-1}$, this yields $(* *)_{m}$. This completes the construction of the sequence $\left\{V_{m}\right\}_{m \geq 1}$ by induction.

Let us now check the exponential decay of $V_{m}$ for $m \geq 2$. It follows from $(*)_{m}-(* *)_{m}$ that

Corollary 3.2 Let $a=a(x)$ fulfilling (4) and $a \in W^{2, \infty}(0, \infty)$. Then for any $R>0$, there exist positive constants $c=c(R)$ and $\mu=\mu(R)$ such that

Proof. Pick any $R>0$ and any $u_{0} \in L_{(x+1) d x}^{2}$ with $\left\|u_{0}\right\|_{L_{(x+1) d x}^{2}} \leq R$. By Theorem 3.1 there are some constants $C=C(R)$ and $\nu=\nu(R)$ such that

& =-\frac{1}{3} \int_{t_{1}}^{t_{2}} \int_{0}^{\infty} u^{3} d x d t+\frac{t_{2}}{3} \int_{0}^{\infty} u^{3}\left(x, t_{2}\right) d x+\int_{t_{1}}^{t_{2}} \int_{0}^{\infty} t u^{3} a(x) d x d t \\
& +\int_{t_{1}}^{t_{2}} \int_{0}^{\infty} u_{x}^{2} d x d t+\int_{t_{1}}^{t_{2}} \int_{0}^{\infty} t a^{\prime \prime}(x) u^{2} d x d t \tag{66}
\end{align*}
$$

1. Let us assume first that $T>1$. Applying (66) on the time interval $[T-1, T]$, we infer that

To estimate the cubic terms in (67), we use (26) to obtain

& \quad+c_{\varepsilon}\left(\|u(T)\|_{L^{2}\left(\mathbb{R}^{+}\right)}^{\frac{10}{3}}+\int_{T-1}^{T}\left(\|u\|_{H^{1}\left(\mathbb{R}^{+}\right)}^{2}+\|u\|_{L^{2}\left(\mathbb{R}^{+}\right)}^{\frac{10}{3}}\right) d t\right) \tag{68}
\end{align*}
$$

Note that by (65)

\|u(T)\|_{L^{2}\left(\mathbb{R}^{+}\right)}^{\frac{10}{3}} \leq\left(C e^{-\nu T}\left\|u_{0}\right\|_{L_{(x+1) d x}^{2}}\right)^{\frac{10}{3}} \leq C^{\frac{10}{3}} R^{\frac{4}{3}} e^{-\nu T}\left\|u_{0}\right\|_{L_{(x+1) d x}^{2}}^{2}
$$

It follows from (48), (26), and (65) that

& \int_{T-1}^{T}\left(\|u\|_{H^{1}\left(\mathbb{R}^{+}\right)}^{2}+\|u\|_{L^{2}\left(\mathbb{R}^{+}\right)}^{\frac{10}{3}}\right) d t \\
& \quad \leq C\left(V_{1}(u(T-1))+\int_{T-1}^{T}\left(\|u\|_{L^{2}\left(\mathbb{R}^{+}\right)}^{2}+\|u\|_{L^{2}\left(\mathbb{R}^{+}\right)}^{\frac{10}{3}}\right) d t\right) \\
& \quad \leq C e^{-\nu T}\left\|u_{0}\right\|_{L_{(x+1) d x}^{2}}^{2} \tag{69}
\end{align*}
$$

where $C=C(R, \nu)$. (64) for $T \geq 1$ follows from (68) and (69) by choosing $\varepsilon<1$ and $\mu<\nu$.
2. Assume now that $T \leq 1$. Estimating again the cubic terms in (66) (with $\left[t_{1}, t_{2}\right]=[0, T]$ ) by using (26), we obtain

& +C_{\varepsilon} \int_{0}^{T}\left(\|u\|_{H^{1}\left(\mathbb{R}^{+}\right)}^{2}+\|u\|_{L^{2}\left(\mathbb{R}^{+}\right)}^{\frac{10}{3}}\right) d t \tag{70}
\end{align*}
$$

By (48), (26) and (65), we have that

Corollary 3.2 may be extended (locally) to the weighted space $L_{(x+1)^{m} d x}^{2}(m \geq 2)$ in following the method of proof of [24, Theorem 1.1].

Corollary 3.3 Let $a=a(x)$ fulfilling (4) and $m \geq 2$. Then there exist some constants $\rho>0$, $C>0$ and $\mu>0$ such that

for all $t>0$ and all $u_{0} \in L_{(x+1)^{m} d x}^{2}$ satisfying $\left\|u_{0}\right\|_{L_{(x+1)^{m} d x}^{2}} \leq \rho$.

Proof. We first prove estimates for the linearized problem

CLaim 6. Let $k \in\{0, \ldots, 3\}$. Then there exists a constant $C_{k}>0$ such that for any $u_{0} \in H_{(x+1)^{m} d x}^{k}$,

Indeed, if $u_{0} \in H_{(x+1)^{m} d x}^{3}$, then $u_{t}(., 0) \in L_{(x+1)^{m-3} d x}^{2}$, and since $v=u_{t}$ solves (72)-(73), we also have that

This proves (75) for $k=3$. The fact that (75) is valid for $k=1,2$ follows from a standard interpolation argument, for $H_{(x+1)^{m} d x}^{k}=\left[H_{(x+1)^{m} d x}^{0}, H_{(x+1)^{m} d x}^{3}\right]_{\frac{k}{3}}$.

Lemma 3.4 Pick any number $\mu \in(0, \nu)$. Then there exists some constant $C=C(\mu)>0$ such that for any $u_{0} \in L_{(x+1)^{m} d x}^{2}$

Proof. Let $u_{0} \in L_{(x+1)^{m} d x}^{2}$ and set $u(t)=W(t) u_{0}$ for all $t \geq 0$. By scaling in (72) by $(x+1)^{m} u$, we see that for some constant $C_{K}=C_{K}(T)$

This implies that $u(t) \in H_{(x+1)^{m} d x}^{1}$ for a.e. $t \in(0,1)$ which, combined to (75), gives that $u(t) \in$ $H_{(x+1)^{m} d x}^{1}$ for all $t>0$. Pick any $T \in(0,1]$. Note that, by (75),

Integrating with respect to $t$ in (77) yields

\left[C_{1}^{-1}\|u(T)\|_{H_{(x+1)^{m} d x}^{1}}\right]^{2} \int_{0}^{T} e^{2 \nu(T-t)} d t \leq \int_{0}^{T}\|u(t)\|_{H_{(x+1)^{m} d x}^{1}}^{2} d t
$$

and hence

\|u(T)\|_{H_{(x+1)^{m} d x}^{1}} & \leq C_{K} C_{1} \sqrt{\frac{2 \nu}{e^{2 \nu T}-1}}\left\|u_{0}\right\|_{L_{(x+1)^{m} d x}^{2}} \\
& \leq \frac{C_{K} C_{1}}{\sqrt{T}}\left\|u_{0}\right\|_{L_{(x+1)^{m} d x}^{2}}
\end{aligned}
$$

for $0<T \leq 1$. Therefore

\begin{equation*}
\|u(t)\|_{H_{(x+1)^{m} d x}^{1}} \leq C_{K} C_{1} e^{\nu} \frac{e^{-\nu t}}{\sqrt{t}}\left\|u_{0}\right\|_{L_{(x+1)^{m} d x}^{2}} \quad \forall t \in(0,1) \tag{78}
\end{equation*}
$$

(76) follows from (78) and (75), since $\mu<\nu$.

Let us return to the proof of Corollary 3.3. Fix a number $\mu \in(0, \nu)$, where $\nu$ is as in (75), and let us introduce the space

Let $u_{0} \in H_{(x+1)^{m} d x}^{1}$ and $u \in F$ with $\left\|u_{0}\right\|_{H_{(x+1)^{m} d x}^{1}} \leq r_{0}$ and $\|u\|_{F} \leq R, r_{0}$ and $R$ being chosen later. We introduce the map $\Gamma$ defined by

We shall prove that $\Gamma$ has a fixed point in the closed ball $B_{R}(0) \subset F$ provided that $r_{0}>0$ is small enough.

For the forcing problem

u(x, 0)=u_{0}(x)
\end{array}\right.
$$

we have the following estimate

\sup _{0 \leq t \leq T}\|u(t)\|_{L_{(x+1)^{m} d x}^{2}}^{2}+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1} u_{x}^{2} d x d t \\
\quad \leq C\left(\left\|u_{0}\right\|_{L_{(x+1)^{m} d x}^{2}}^{2}+\|f\|_{L^{1}\left(0, T ; L_{(x+1)^{m} d x}^{2}\right.}^{2}\right)
\end{gathered}
$$

Let us take $f=N(u)=-u u_{x}$. Observe that for all $x>0$

$$
\begin{aligned}
(x+1) u^{2}(x) & =\left|\int_{0}^{\infty} \frac{d}{d x}\left[(x+1) u^{2}(x)\right] d x\right| \\
& \leq C\left(\int_{0}^{\infty}(x+1)^{m}|u|^{2} d x+\int_{0}^{\infty}(x+1)^{m-1}\left|u_{x}\right|^{2} d x\right)
\end{aligned}
$$

whenever $m \geq 2$. It follows that for some constant $K>0$

\begin{aligned}
\left\|u u_{x}\right\|_{L_{(x+1)^{m} d x}^{2}}^{2} & \leq\left\|(x+1) u^{2}\right\|_{L^{\infty}\left(\mathbb{R}^{+}\right)} \int_{0}^{\infty}(x+1)^{m-1}\left|u_{x}\right|^{2} d x \\
& \leq K\|u\|_{H_{(x+1)^{m} d x}^{1}}^{4}
\end{aligned}
$$

Therefore, for any $T>0$,

\begin{aligned}
& \sup _{0 \leq t \leq T}\|(\Gamma u)(t)\|_{L_{(x+1)^{m} d x}^{2}}^{2}+\int_{0}^{T} \int_{0}^{\infty}(x+1)^{m-1}\left|(\Gamma u)_{x}\right|^{2} d x d t \\
& \quad \leq C\left(\left\|u_{0}\right\|_{L_{(x+1)^{m} d x}^{2}}^{2}+\left(\int_{0}^{T}\|u(t)\|_{H_{(x+1)^{m} d x}^{1}}^{2} d t\right)^{2}\right)<\infty
\end{aligned}
$$

Thus $\Gamma u \in C\left(\mathbb{R}^{+}, L_{(x+1)^{m} d x}^{2}\right) \cap L_{l o c}^{2}\left(\mathbb{R}^{+} ; H_{(x+1)^{m} d x}^{1}\right)$ with $(\Gamma u)(0)=u_{0}$. We claim that $\Gamma u \in F$. Indeed, by (75),

and for all $t \geq 0$

\left\|e^{\mu t} \int_{0}^{t} W(t-s) N(u(s)) d s\right\|_{H_{(x+1) m_{d x}}^{1}} & \leq C e^{\mu t} \int_{0}^{t} \frac{e^{-\mu(t-s)}}{\sqrt{t-s}}\|N(u(s))\|_{L_{(x+1)}^{2} m_{d x}} d s \\
& \leq C \int_{0}^{t} \frac{e^{\mu s}}{\sqrt{t-s}} K\left(e^{-\mu s}\|u\|_{F}\right)^{2} d s \\
& \leq C K\|u\|_{F}^{2} \int_{0}^{t} \frac{e^{-\mu(t-s)}}{\sqrt{s}} d s \\
& \leq C K\left(2+\mu^{-1}\right)\|u\|_{F}^{2}
\end{aligned}
$$

where we used Lemma 3.4. Pick $R>0$ such that $C K\left(2+\mu^{-1}\right) R \leq \frac{1}{2}$, and $r_{0}$ such that $C_{1} r_{0}=\frac{R}{2}$. Then, for $\left\|u_{0}\right\|_{H_{(x+1) m_{d x}}^{1}} \leq r_{0}$ and $\|u\|_{F} \leq R$, we obtain that

Hence $\Gamma$ maps the ball $B_{R}(0) \subset F$ into itself. Similar computations show that $\Gamma$ contracts. By the contraction mapping theorem, $\Gamma$ has a unique fixed point $u$ in $B_{R}(0)$. Thus $\|u(t)\|_{H_{(x+1)^{m}{ }_{d x}}^{1}} \leq$ $C e^{-\mu t}\left\|u_{0}\right\|_{\left.H_{(x+1)}^{1}\right)_{d x}}$ provided that $\left\|u_{0}\right\|_{H_{(x+1))^{m} d x}^{1}} \leq r_{0}$ with $r_{0}$ small enough. Proceeding as in the proof of Lemma 3.4, we have that

Corollary 3.5 Assume that $a(x)$ satisfies (\$) and that $\partial_{x}^{k} a \in L^{\infty}\left(\mathbb{R}^{+}\right)$for all $k \geq 0$. Pick any $u_{0} \in L_{(x+1)^{m} d x}^{2}$. Then for all $\varepsilon>0$, all $T>\varepsilon$, and all $k \in\{1, \ldots, m\}$, there exists a constant $C=C(\varepsilon, T, k)>0$ such that

$$
\begin{equation*}
\int_{\varepsilon}^{\infty}(x+1)^{m-k}\left|\partial_{x}^{k} u(x, t)\right|^{2} d x \leq C| | u_{0} \|_{L_{(x+1) m_{d x}}^{2}}^{2} \quad \forall t \in[\varepsilon, T] . \tag{81}
\end{equation*}
$$

Proof. The proof is very similar to the one in [18, Lemma 5.1] and so we only point out the small changes. First, it should be noticed that the presence in the KdV equation of the extra terms $u_{x}$ and $a(x) u$ does not cause any serious trouble. On the other hand, choosing a cut-off function in $x$ of the form $\eta(x)=\psi_{0}(x / \varepsilon)$ (instead of $\eta(x)=\psi_{0}\left(x-x_{0}+2\right)$ as in 18$)$ where $\psi_{0} \in C^{\infty}(\mathbb{R},[0,1])$ satisfies $\psi_{0}(x)=0$ for $x \leq 1 / 2$ and $\psi_{0}(x)=1$ for $x \geq 1$, allows to overcome the fact that $u$ is a solution of (지) on the half-line only.

### 3.2 Decay in $L_{b}^{2}$

This section is devoted to the exponential decay in $L_{b}^{2}$. Our result reads as follows:

Theorem 3.6 Assume that the function $a=a(x)$ satisfies (4) with $4 b^{3}+b<a_{0}$. Then, for all $R>0$, there exist $C>0$ and $\nu>0$, such that

$$
\|u(t)\|_{L_{b}^{2}} \leq C e^{-\nu t}\left\|u_{0}\right\|_{L_{b}^{2}} \quad t \geq 0
$$

for any solution $u$ given by Theorem 2.3.
Proof. We introduce the Lyapunov function

$$
\begin{equation*}
V(u)=\frac{1}{2} \int_{0}^{\infty} u^{2} e^{2 b x} d x+c_{b} \int_{0}^{\infty} u^{2} d x \tag{82}
\end{equation*}
$$

where $c_{b}$ is a positive constant that will be chosen later. Then, adding (17) and (18) hand by hand we obtain

$$
\begin{align*}
V(u)-V\left(u_{0}\right)= & \left(4 b^{3}+b\right) \int_{0}^{T} \int_{x_{0}}^{\infty} u^{2} e^{2 b x} d x d t+\left(4 b^{3}+b\right) \int_{0}^{T} \int_{0}^{x_{0}} u^{2} e^{2 b x} d x d t \\
& -3 b \int_{0}^{\infty} \int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x d t+\frac{2 b}{3} \int_{0}^{T} \int_{0}^{\infty} u^{3} e^{2 b x} d x d t  \tag{83}\\
& -\left(c_{b}+\frac{1}{2}\right) \int_{0}^{T} u_{x}^{2}(0, t) d t-\int_{0}^{T} \int_{0}^{\infty} a(x)|u|^{2}\left(e^{2 b x}+2 c_{b}\right) d x d t
\end{align*}
$$

where $x_{0}$ is the number introduced in (母). On the other hand, since $L_{b}^{2} \subset L_{(x+1) d x}^{2},\|u(t)\|_{L^{2}(0, \infty)}$ and $\left\|u_{x}(t)\right\|_{L^{2}(0, \infty)}$ decays to zero exponentially. Consequently, from Moser estimate we deduce that $\|u(t)\|_{L^{\infty}(0, \infty)} \rightarrow 0$. We may assume that $(2 b / 3)\|u(t)\|_{L^{\infty}}<\varepsilon=a_{0}-\left(4 b^{3}+b\right)$ for all $t \geq 0$, by changing $u_{0}$ into $u\left(t_{0}\right)$ for $t_{0}$ large enough. Therefore

$$
\begin{align*}
& \frac{2 b}{3} \int_{0}^{T} \int_{0}^{\infty}|u|^{3} e^{2 b x} d x d t  \tag{84}\\
& \leq \frac{2 b}{3} \int_{0}^{T}\|u(t)\|_{L^{\infty}(0, \infty)}\left(\int_{0}^{\infty}|u|^{2} e^{2 b x} d x\right) d t \leq \varepsilon \int_{0}^{T} \int_{0}^{\infty} u^{2} e^{2 b x} d x d t
\end{align*}
$$

So, returning to (83), the following holds

$$
\begin{align*}
& V(u)-V\left(u_{0}\right)-\left(4 b^{3}+b+\varepsilon\right) \int_{0}^{T} \int_{0}^{x_{0}} u^{2} e^{2 b x} d x d t \\
& +3 b \int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x d t+\left(c_{b}+\frac{1}{2}\right) \int_{0}^{T} u_{x}^{2}(0, t) d t+2 c_{b} \int_{0}^{T} \int_{0}^{\infty} a(x)|u|^{2} d x d t \leq 0 \tag{85}
\end{align*}
$$

Moreover, according to 20] there exists $C>0$ satisfying

$$
\begin{aligned}
& \int_{0}^{T} \int_{0}^{x_{0}} u^{2} e^{2 b x} d x d t \\
& \leq e^{2 b x_{0}} \int_{0}^{T} \int_{0}^{x_{0}} u^{2} d x d t \leq C\left\{\int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty} a(x) u^{2} d x d t\right\}
\end{aligned}
$$

since $L_{b}^{2} \subset L^{2}\left(\mathbb{R}^{+}\right)$. Then, choosing $c_{b}$ sufficiently large, the above estimate and (85) give us that

$$
\begin{align*}
V(u)-V\left(u_{0}\right) \leq- & C\left\{\int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty} a(x) u^{2} d x d t\right. \\
& \left.+\int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x d t\right\} \leq-C V\left(u_{0}\right) \tag{86}
\end{align*}
$$

which allows to conclude that $V(u)$ decays exponentially. The last inequality is a consequence of the following results:

Claim 7. There exists a positive constant $C>0$, such that

$$
\int_{0}^{T} V(u(t)) d t \leq C \int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x d t
$$

First, observe that

$$
\left|\int_{0}^{\infty} u^{2} e^{2 b x} d x\right|=\left|-\frac{1}{b} \int_{0}^{\infty} u u_{x} e^{2 b x} d x\right| \leq \frac{1}{b}\left(\int_{0}^{\infty} u^{2} e^{2 b x} d x\right)^{\frac{1}{2}}\left(\int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x\right)^{\frac{1}{2}}
$$

therefore,

$$
\begin{equation*}
\int_{0}^{\infty} u^{2} e^{2 b x} d x \leq \frac{1}{b^{2}} \int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x \tag{87}
\end{equation*}
$$

Then, from (4) and (87) we have

$$
V(u(t)) \leq\left(\frac{1}{2}+c_{b}\right) \int_{0}^{\infty} u^{2} e^{2 b x} d x \leq\left(\frac{1}{2}+c_{b}\right) b^{-2} \int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x
$$

which gives us Claim 7.
Claim 8.

$$
V\left(u_{0}\right) \leq C\left\{\int_{0}^{T} u_{x}^{2}(0, t) d t+\int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x d t+\int_{0}^{T} V(u(t)) d t\right\}
$$

where $C$ is a positive constant.
Multiplying the first equation in (1) by $(T-t) u e^{2 b x}$ and integrating by parts in $(0, \infty) \times(0, T)$, we obtain

$$
\begin{align*}
& -\frac{T}{2} \int_{0}^{\infty}\left|u_{0}(x)\right|^{2} e^{2 b x} d x+\frac{1}{2} \int_{0}^{T} \int_{0}^{\infty}|u|^{2} e^{2 b x} d x d t+3 b \int_{0}^{T} \int_{0}^{\infty}(T-t) u_{x}^{2} e^{2 b x} d x d t \\
& +\frac{1}{2} \int_{0}^{T}(T-t) u_{x}^{2}(0, t) d t-\left(4 b^{3}+b\right) \int_{0}^{T} \int_{0}^{\infty}(T-t) u^{2} e^{2 b x} d x d t  \tag{88}\\
& +\int_{0}^{T} \int_{0}^{\infty}(T-t) a(x)|u|^{2} e^{2 b x} d x d t-\frac{2 b}{3} \int_{0}^{T} \int_{0}^{\infty}(T-t) u^{3} e^{2 b x} d x d t=0
\end{align*}
$$

and therefore,

$$
\begin{align*}
& \int_{0}^{\infty}\left|u_{0}(x)\right|^{2} e^{2 b x} d x \leq C\left(\int_{0}^{T} u_{x}^{2}(0, t) d t+\frac{1}{2} \int_{0}^{T} \int_{0}^{\infty} u^{2} e^{2 b x} d x d t\right.  \tag{89}\\
& \left.+\int_{0}^{T} \int_{0}^{\infty} u_{x}^{2} e^{2 b x} d x d t+\int_{0}^{T} \int_{0}^{\infty}|u|^{3} e^{2 b x} d x d t\right) .
\end{align*}
$$

Then, combining (87) and (84), we derive Claim 8. (86) follows at once. This proves the exponential decay when $\|u(t)\|_{L^{\infty}} \leq 3 \varepsilon /(2 b)$. The general case is obtained as in Theorem 3.1

Corollary 3.7 Assume that the function $a=a(x)$ satisfies (4) with $4 b^{3}+b<a_{0}$. Then for any $R>0$, there exist positive constants $c=c(R)$ and $\mu=\mu(R)$ such that

$$
\begin{equation*}
\left\|u_{x}(t)\right\|_{L_{b}^{2}} \leq c \frac{e^{-\mu t}}{\sqrt{t}}\left\|u_{0}\right\|_{L_{b}^{2}} \tag{90}
\end{equation*}
$$

for all $t>0$ and all $u_{0} \in L_{b}^{2}$ satisfying $\left\|u_{0}\right\|_{L_{b}^{2}} \leq R$.

Corollary 3.8 Assume that the function $a=a(x)$ satisfies (4) with $4 b^{3}+b<a_{0}$, and let $s \geq 2$. Then there exist some constants $\rho>0, C>0$ and $\mu>0$ such that

$$
\|u(t)\|_{H_{b}^{s}} \leq C \frac{e^{-\mu t}}{t^{\frac{s}{2}}}\left\|u_{0}\right\|_{L_{b}^{2}}
$$

for all $t>0$ and all $u_{0} \in L_{b}^{2}$ satisfying $\left\|u_{0}\right\|_{L_{b}^{2}} \leq \rho$.
The proof of Corollary 3.7 (resp. 3.8) is very similar to the proof of Corollary 3.2 (resp. 3.3), so it is omitted.
