A dynamic unilateral contact problem with adhesion and friction in viscoelasticity

Abstract

The aim of this paper is to study an interaction law coupling recoverable adhesion, friction and unilateral contact between two viscoelastic bodies of Kelvin-Voigt type. A dynamic contact problem with adhesion and nonlocal friction is considered and its variational formulation is written as the coupling between an implicit variational inequality and a parabolic variational inequality describing the evolution of the intensity of adhesion. The existence and approximation of variational solutions are analysed, based on a penalty method, some abstract results and compactness properties. Finally, some numerical examples are presented.

1 Introduction

In this paper we consider an interaction law including dynamic unilateral contact, recoverable adhesion and nonlocal friction between two viscoelastic bodies. The adhesion is characterized by the intensity of adhesion, first introduced by M. Frémond (see, e.g., [13, 14]). An interface law for a quasistatic evolution where rebonding is not allowed was originally proposed in [22] in the framework of continuum thermodynamics. The corresponding quasistatic problem coupling unilateral contact, adhesion and local friction

for an elastic body has been analysed in [8]. This interface law has been used on various applications : fibre-matrix interaction in the context of composite materials [24], steel-concrete interaction [23] and, more recently, tectonic plates interaction in the context of earthquakes.

The extension to reversible adhesion proposed in the present paper constitutes an approximation of interactions of van der Waals type for rubber glass contact and other specific phenomena as those studied by M. Barquins [3] and K.L. Johnson, K. Kendall, A.D. Roberts [16, 17]. This model, which extends the one considered in [22, 24], is dedicated to the description of bond damage and can be called a healing model because it allows us to describe both the formation and the rupture of adhesive contacts during the approach of the bodies. Also, in this model bond damage and healing behaviours are rate-dependent. The dissipation effects are related to both viscoelasticity and adhesion.

Dynamic frictional contact problems with normal compliance laws for a viscoelastic body have been considered by J.A.C. Martins and J.T. Oden [20], K.L. Kuttler [18], O. Chau, W. Han and M. Sofonea [6]. Dynamic unilateral or bilateral contact problems with friction for viscoelastic bodies have been studied in [12, 19, 9] and dynamic frictionless problems with adhesion have been analysed in [28] and in the references therein.

In this work we consider a coupled dynamic problem combining reversible adhesion, friction and unilateral contact. In section 2, classical and variational formulations of the dynamic contact problem are presented. The variational formulation is given as an implicit variational inequality coupled with a parabolic variational inequality which describes the evolution of the intensity of adhesion. Also, classical and variational formulations of an auxiliary penalized problem are considered. In section 3, general existence and uniqueness results are proved. In section 4, these abstract results are used to prove the existence and the uniqueness of penalized solutions and the existence of solutions to unilateral contact problem. In section 5, some numerical examples are presented and discussed.

2 Classical and variational formulations

We consider two viscoelastic bodies, characterized by a Kelvin-Voigt constitutive law, which occupy the reference domains Ω^{α} of \mathbb{R}^d , d = 2 or 3, with Lipschitz continuous boundaries $\Gamma^{\alpha} = \partial \Omega^{\alpha}$, $\alpha = 1, 2$. In this paper we assume the small deformation hypothesis and we use Cartesian coordinate representations.

Let Γ_U^{α} , Γ_F^{α} and Γ_C^{α} be three open disjoint sufficiently smooth parts of Γ^{α}

such that $\Gamma^{\alpha} = \overline{\Gamma}^{\alpha}_{U} \cup \overline{\Gamma}^{\alpha}_{F} \cup \overline{\Gamma}^{\alpha}_{C}$ and, to simplify the estimates, meas $(\Gamma^{\alpha}_{U}) > 0$, $\alpha = 1, 2$.

We denote by $\boldsymbol{y}^{\alpha}(\boldsymbol{x}^{\alpha},t)$ the position at time $t \in [0,T]$, where T > 0, of the material point represented by \boldsymbol{x}^{α} in the reference configuration, by $\boldsymbol{u}^{\alpha}(\boldsymbol{x}^{\alpha},t) := \boldsymbol{y}^{\alpha}(\boldsymbol{x}^{\alpha},t) - \boldsymbol{x}^{\alpha}$ the displacement vector of \boldsymbol{x}^{α} at time t, with the Cartesian coordinates $u^{\alpha} = (u_{1}^{\alpha},...,u_{d}^{\alpha}) = (\overline{u}^{\alpha},u_{d}^{\alpha})$. Let $\boldsymbol{\varepsilon}^{\alpha}$, with the Cartesian coordinates $\boldsymbol{\varepsilon}^{\alpha} = (\varepsilon_{ij}(u^{\alpha}))$, and $\boldsymbol{\sigma}^{\alpha}$, with the Cartesian coordinates $\sigma^{\alpha} = (\sigma_{ij}^{\alpha})$, be the infinitesimal strain tensor and the stress tensor, respectively, corresponding to $\Omega^{\alpha}, \alpha = 1, 2$.

Excepting in the last section, to simplify notations we assume that the displacement $U^{\alpha} = 0$ is prescribed on $\Gamma_{U}^{\alpha} \times [0, T[, \alpha = 1, 2, \text{ and that the densities of both bodies are equal to 1. Let <math>\mathbf{f} = (\mathbf{f}^{1}, \mathbf{f}^{2})$ and $\mathbf{F} = (\mathbf{F}^{1}, \mathbf{F}^{2})$ denote the given body forces in $\Omega^{1} \cup \Omega^{2}$ and tractions on $\Gamma_{F}^{1} \cup \Gamma_{F}^{2}$, respectively. The initial displacements and velocities of the bodies are denoted by $\mathbf{u}_{0} = (\mathbf{u}_{0}^{1}, \mathbf{u}_{0}^{2}), \ \mathbf{u}_{1} = (\mathbf{u}_{1}^{1}, \mathbf{u}_{1}^{2})$. The usual summation convention will be used for $i, j, k, l = 1, \ldots, d$.

We suppose that the solids can be in unilateral contact between the potential contact surfaces Γ_C^1 and Γ_C^2 . We assume also that the surfaces Γ_C^1 and Γ_C^2 can be parametrized by two C^1 functions, φ^1, φ^2 , defined on an open subset Ξ of \mathbb{R}^{d-1} such that $\varphi^1(\xi) - \varphi^2(\xi) \ge 0 \quad \forall \xi \in \Xi$ and each Γ_C^{α} is the graph of φ^{α} on Ξ that is $\Gamma_C^{\alpha} = \{ (\xi, \varphi^{\alpha}(\xi)) \in \mathbb{R}^d ; \xi \in \Xi \}, \ \alpha = 1, 2.$ Let $\mathbf{m}^{\alpha} : \Xi \to \mathbb{R}^d$, with $\mathbf{m}^1(\xi) := (\nabla \varphi^1(\xi), -1), \ \mathbf{m}^2(\xi) := (-\nabla \varphi^2(\xi), 1),$ $\forall \xi \in \Xi$, be the outward normal to $\Gamma_C^{\alpha}, \ \alpha = 1, 2$. Since the displacements, their derivatives and the gap are assumed small, by using a similar method as the one considered by P. Boieri, F. Gastaldi and D. Kinderlehrer [4] (see also [9]) we obtain the following contact condition at time t on the set Ξ :

Let $\mathbf{n}^{\alpha} := \mathbf{m}^{\alpha}/|\mathbf{m}^{\alpha}|$ denote the unit outward normal vector to Γ_{C}^{α} , $\alpha = 1, 2$. The initial normalized gap between the two contact surfaces is defined as

We shall use the following notations for the normal and tangential components of a displacement field v^{α} , $\alpha = 1, 2$, of the relative displacement corresponding to $\boldsymbol{v} := (\boldsymbol{v}^1, \boldsymbol{v}^2)$, by including the initial gap g_0 in the normal direction, and of the stress vector $\boldsymbol{\sigma}^{\alpha} \boldsymbol{n}^{\alpha}$ on Γ_C^{α} :

for all $\xi \in \Xi$ and for all $t \in [0,T]$. We denote also by $g := -[u_N] = g_0 - u_N^1 - u_N^2$ the gap corresponding to the solution $\boldsymbol{u} := (\boldsymbol{u}^1, \boldsymbol{u}^2)$. Assuming that $\nabla \varphi^1(\xi) \simeq \nabla \varphi^2(\xi)$, it follows that the unilateral contact condition (2.1) at time t can be written as

Following M. Frémond [13, 14], we introduce the internal state variable β , which represents the intensity of adhesion ($\beta = 1$ means that the adhesion is total, $\beta = 0$ means that there is no adhesion and $0 < \beta < 1$ is the case of partial adhesion). In the following, we will consider only isothermal evolutions.

2.1 Classical formulation

Let \mathcal{A}^{α} , \mathcal{B}^{α} denote two fourth-order tensors, the elasticity tensor and the viscosity tensor corresponding to Ω^{α} , with the components $\mathcal{A}^{\alpha} = (\mathcal{A}_{ijkl}^{\alpha})$ and $\mathcal{B}^{\alpha} = (\mathcal{B}_{ijkl}^{\alpha})$, respectively. We assume that these components satisfy the following classical symmetry and ellipticity conditions: $\mathcal{C}_{ijkl} = \mathcal{C}_{jikl} = \mathcal{C}_{klij} \in W^{1,\infty}(\mathbb{R}^d), \forall i, j, k, l = 1, \ldots, d, \exists \alpha_{\mathcal{C}} > 0$ such that $\mathcal{C}_{ijkl}\tau_{ij}\tau_{kl} \geq \alpha_{\mathcal{C}}\tau_{ij}\tau_{ij} \forall \tau = (\tau_{ij})$ verifying $\tau_{ij} = \tau_{ji}, \forall i, j = 1, \ldots, d$, where $\mathcal{C}_{ijkl} = \mathcal{A}_{ijkl}^{\alpha}$, $\mathcal{C} = \mathcal{A}^{\alpha}$ or $\mathcal{C}_{ijkl} = \mathcal{B}_{ijkl}^{\alpha}, \mathcal{C} = \mathcal{B}^{\alpha} \forall i, j, k, l = 1, \ldots, d, \alpha = 1, 2$.

We choose the following state variables (see [22], [10]): the infinitesimal strain tensor $\boldsymbol{\varepsilon} = (\boldsymbol{\varepsilon}^1, \boldsymbol{\varepsilon}^2) = (\boldsymbol{\varepsilon}(\boldsymbol{u}^1), \boldsymbol{\varepsilon}(\boldsymbol{u}^2))$ in $\Omega^1 \cup \Omega^2$, the normal relative displacement $[\boldsymbol{u}_N] = \boldsymbol{u}_N^1 + \boldsymbol{u}_N^2 - g_0$, the tangential relative displacement $[\boldsymbol{u}_T] =$ $\boldsymbol{u}_T^1 - \boldsymbol{u}_T^2$, and the intensity of adhesion β in Ξ . We assume that $\boldsymbol{\sigma}^1 \boldsymbol{n}^1 =$ $-\boldsymbol{\sigma}^2 \boldsymbol{n}^2$ in Ξ , that the normal behaviour is purely elastic for a fixed value of β and that the only dissipative processes on the potential contact surfaces are adhesion and friction.

We define $\vartheta : \mathbb{R} \to \mathbb{R}$ a truncation operator as $\vartheta(s) = -r$ if $s \leq -r$, $\vartheta(s) = s$ if |s| < r and $\vartheta(s) = r$ if $s \geq r$, where r > 0 is a given characteristic length (see, e.g., [22, 28]).

We consider the following classical formulation of the dynamic problem coupling adhesion, nonlocal friction and unilateral contact.

Problem \mathcal{P}_c : Find $\boldsymbol{u} = (\boldsymbol{u}^1, \boldsymbol{u}^2)$ and β such that $\boldsymbol{u}(0) = \boldsymbol{u}_0, \ \dot{\boldsymbol{u}}(0) = \boldsymbol{u}_1, \ \beta(0) = \beta_0$ and

where $\beta_0 \in [0, 1]$ in Ξ , $C_N > 0$, b > 0, w > 0, $\sigma^{\alpha} = \sigma^{\alpha}(\boldsymbol{u}^{\alpha}, \boldsymbol{\dot{u}}^{\alpha})$, $\alpha = 1, 2$, $\sigma_N := \sigma_N^1$, $\sigma_T := \sigma_T^1$, $\sigma := \sigma^1$, μ is the coefficient of friction and \mathcal{R} is a regularization with good approximation properties which will be presented later.

Note that the healing (rebonding) process is allowed. In the particular case when $\beta = 0$, that is the adhesion is totally broken, the classical Signorini's conditions with nonlocal friction are obtained.

2.2 Variational formulation

We shall adopt the following notations for some Sobolev spaces and corresponding duality pairings:

3 General existence and uniqueness results

The existence and uniqueness of solutions of problems $\mathcal{P}_{\varepsilon}$ will be obtained by using the following abstract problem.

+ \int_0^t b_0(\dot{u}_{\beta_1} - \dot{u}_{\beta_2}, \dot{u}_{\beta_1} - \dot{u}_{\beta_2}) \, ds \le \eta_2 \int_0^t |\beta_1 - \beta_2|_{\Pi_0} \|\dot{u}_{\beta_1} - \dot{u}_{\beta_2}\| \, ds \\
+ \eta_2 \int_0^t \left(\|u_{\beta_1} - u_{\beta_2}\| \|\dot{u}_{\beta_1} - \dot{u}_{\beta_2}\| + |\dot{u}_{\beta_1} - \dot{u}_{\beta_2}| \|\dot{u}_{\beta_1} - \dot{u}_{\beta_2}\| \right) \, ds$$

Using Young's inequalities for the last three terms with an appropriate constant, and V_0 - ellipticity of a_0 , b_0 , it follows that

$$\frac{1}{2}|\dot{u}_{\beta_{1}}(t) - \dot{u}_{\beta_{2}}(t)|^{2} + \frac{A}{2}||u_{\beta_{1}}(t) - u_{\beta_{2}}(t)||^{2} + \frac{B}{2}\int_{0}^{t}||\dot{u}_{\beta_{1}} - \dot{u}_{\beta_{2}}||^{2} ds$$
$$\leq \frac{3\eta_{2}^{2}}{2B}\int_{0}^{t}|\beta_{1} - \beta_{2}|_{\Pi_{0}}^{2} ds + \frac{3\eta_{2}^{2}}{2B}\int_{0}^{t}(||u_{\beta_{1}} - u_{\beta_{2}}||^{2} + |\dot{u}_{\beta_{1}} - \dot{u}_{\beta_{2}}|^{2}) ds.$$

By Gronwall's lemma we obtain the estimate (3.16).

Now, for every element $u \in W^{1,2}(0,T;V_0)$, we consider the inequality (3.15) with the initial condition β_0 , the solution of which is denoted by β_u .

The existence and uniqueness results for this parabolic inequality follow by classical references, see, e.g., [5] or [2], but we prefer to present a direct proof based on an incremental technique, for the convenience of the reader.

Proposition 3.3. For each $u \in W^{1,2}(0,T;V_0)$ there exists a unique $\beta_u \in X \cap W^{1,\infty}(0,T;\Pi_0)$, solution of the inequality (3.15).

Proof. We consider an incremental formulation obtained by using an implicit time discretization scheme for (3.15). For $n \in \mathbb{N}^*$, we set $\Delta t := T/n$ and $t_i := i \Delta t$, i = 0, 1, ..., n, and $\beta^0 := \beta_0$. If ψ is a continuous function of $t \in [0, T]$ valued in some vector space, we use the notations $\psi^i := \psi(t_i)$ and if $(\theta^i)_{i \in \{0, 1, ..., n\}}$ are elements of some vector space, then for all $i \in \{0, 1, ..., n-1\}$ we set $\Delta \theta^i := \theta^{i+1} - \theta^i$. We then approximate (3.15) using the sequence of following incremental problems: for i = 0, 1, ..., n-1, find $\beta^{i+1} \in \Lambda_0$ such that

$$\left(\frac{\Delta\beta^{i}}{\Delta t}, \lambda - \beta^{i+1}\right)_{\Pi_{0}} + \gamma_{0}(u^{i+1}, \beta^{i+1}, \lambda - \beta^{i+1}) \ge (\chi_{0}^{i+1}, \lambda - \beta^{i+1})_{\Pi_{0}} \quad \forall \lambda \in \Lambda_{0}.$$

As the previous inequality can be written in the equivalent form

which is an elliptic variational inequality of the first kind that contains the scalar product in Π_0 and γ_0 satisfying (3.3)-(3.5), by a classical result it follows that there exists a unique solution β^{i+1} of (3.17).

Taking in (3.17) $\lambda = \beta^i$, using (3.4) and Cauchy-Schwarz inequality, we have

$$\leq m_{\gamma}(\|u^{i+1}\| + |\beta^{i+1}|_{\Pi_{0}})|\Delta\beta^{i}|_{\Pi_{0}} + |\chi_{0}^{i+1}|_{\Pi_{0}}|\Delta\beta^{i}|_{\Pi_{0}}$$

Hence,

$$\frac{|\Delta\beta^{i}|_{\Pi_{0}}}{\Delta t} \le m_{\gamma}(||u^{i+1}|| + |\beta^{i+1}|_{\Pi_{0}}) + |\chi_{0}^{i+1}|_{\Pi_{0}}, \text{ for } i = 0, 1, ..., n - 1.$$
(3.18)

Let us define the following functions:

$$\beta_{n}(0) = \hat{\beta}_{n}(0) = \beta^{0}, \ u_{n}(0) = u^{0}, \ \chi_{n}(0) = \chi_{0}^{0} \text{ and}$$

$$\forall i \in \{0, 1, ..., n - 1\}, \ \forall t \in]t_{i}, t_{i+1}],$$

$$\beta_{n}(t) = \beta^{i+1}, \ \hat{\beta}_{n}(t) = \beta^{i} + (t - t_{i}) \frac{\Delta \beta^{i}}{\Delta t},$$

$$u_{n}(t) = u^{i+1}, \ \chi_{n}(t) = \chi_{0}^{i+1}.$$
(3.19)

Then $\beta_n \in L^2(0,T;\Pi_0), \ \hat{\beta}_n \in W^{1,2}(0,T;\Pi_0), \ u_n \to u \text{ in } L^2(0,T;V_0), \ \chi_n \to \chi_0 \text{ in } L^2(0,T;\Pi_0) \text{ and } \beta_n(t) \in \Lambda_0, \ u_n(t) \to u(t) \text{ in } V_0, \ \chi_n(t) \to \chi_0(t) \text{ in } \Pi_0 \quad \forall t \in [0,T]. \text{ Since } u \in W^{1,2}(0,T;V_0) \subset C^0([0,T];V_0), \ \chi_0 \in W^{1,2}(0,T;\Pi_0) \subset C^0([0,T];\Pi_0), \text{ it follows that } (\|u_n(t)\|)_{n\in\mathbb{N}^*} \text{ and } (|\chi_n(t)|_{\Pi_0})_{n\in\mathbb{N}^*} \text{ are bounded by constants independent of } t \in [0,T].$

Also, for all $n \in \mathbb{N}^*$ we have

and the estimates (3.18), i = 0, 1, ..., n - 1, imply the following relation:

Thus, there exists a constant $C_2 > 0$ satisfying

Applying a diagonal process, see, e.g., [7], it follows from (3.22), (3.20) that, up to a subsequence,

which implies that $\beta_u(0) = \beta_0$ and $\beta_u(t) \in \Lambda_0$ for all $t \in [0, T[$.

We shall prove that the limit β_u is a solution of the inequality (3.15). The sequence of inequalities (3.17), i = 0, 1, ..., n - 1, is equivalent to the following incremental formulation: $\beta_n(t) \in \Lambda_0$ for all $t \in [0, T]$ and

$$\left(\frac{d}{dt}\hat{\beta}_{n}(t),\lambda-\beta_{n}(t)\right)_{\Pi_{0}}+\gamma_{0}(u_{n}(t),\beta_{n}(t),\lambda-\beta_{n}(t))$$

Integrating both sides of (3.25) over [0,T] it follows that for all $\lambda \in L^2(0,T;\Pi_0)$ such that $\lambda(t) \in \Lambda_0$ for a.e. $t \in]0,T[$,

Therefore, by passing to the limit we obtain

$$\begin{split} \lim_{n \to \infty} \int_0^T \left(\frac{d}{dt} \hat{\beta}_n(t), \lambda(t) \right)_{\Pi_0} dt &= \int_0^T (\dot{\beta}_u(t), \lambda(t))_{\Pi_0} dt, \\ \lim_{n \to \infty} \int_0^T \gamma_0(u_n(t), \beta_n(t), \lambda(t)) dt \\ &= \lim_{n \to \infty} \int_0^T [\gamma_0(u_n(t), \beta_n(t), \lambda(t)) - \gamma_0(u(t), \beta_n(t), \lambda(t))] dt \\ &+ \lim_{n \to \infty} \int_0^T \gamma_0(u(t), \beta_n(t), \lambda(t)) dt = \int_0^T \gamma_0(u(t), \beta_u(t), \lambda(t)) dt, \\ \lim_{n \to \infty} \int_0^T (\chi_n(t), \lambda(t) - \beta_n(t))_{\Pi_0} dt = \int_0^T (\chi_0(t), \lambda(t) - \beta_u(t))_{\Pi_0} dt, \end{split}$$

finally by passing to the limit in (3.26), we obtain that for all $\lambda \in L^2(0,T;\Pi_0)$ such that $\lambda(t) \in \Lambda_0$ for a.e. $t \in]0, T[$

$$\int_0^T (\dot{\beta}_u(t), \lambda(t) - \beta_u(t))_{\Pi_0} dt + \int_0^T \gamma_0(u(t), \beta_u(t), \lambda(t) - \beta_u(t)) dt$$
$$\geq \int_0^T (\chi_0(t), \lambda(t) - \beta_u(t))_{\Pi_0} dt.$$

By Lebesgue's theorem, it follows that β_u is a solution of the parabolic inequality (3.15).

In order to show the uniqueness of β_u , let β_1 , β_2 be two solutions of (3.15) corresponding to $u \in W^{1,2}(0,T;V_0)$. Taking in each inequality $\lambda = \beta_2$ and $\lambda = \beta_1$, respectively, we derive that for a.e. $s \in [0, T]$

the implies that $\beta_1 = \beta_2.$

which implies that $\beta_1 = \beta_2$.

Lemma 3.4. Let $u_1, u_2 \in W^{1,2}(0,T;V_0)$ and let $\beta_{u_1}, \beta_{u_2} \in X$ be the corresponding solutions of (3.15) with the same initial condition β_0 , respectively. Then there exists a constant $C_3 > 0$, independent of $u_1, u_2, \beta_{u_1}, \beta_{u_2}$, such that for all $t \in [0,T]$

$$|\beta_{u_1}(t) - \beta_{u_2}(t)|^2_{\Pi_0} \le C_3 \int_0^t ||u_1(s) - u_2(s)||^2 \, ds.$$
(3.27)

Proof. Let β_{u_1} , β_{u_2} be the solutions of (3.15) corresponding to u_1 , u_2 . Taking in each inequality $\lambda = \beta_{u_2}$, $\lambda = \beta_{u_1}$, respectively, for all $t \in [0, T[$, by integrating over [0, t], using (3.4) and some elementary inequality we have

$$\begin{split} \frac{1}{2} |\beta_{u_1}(t) - \beta_{u_2}(t)|_{\Pi_0}^2 \\ &\leq \int_0^t [\gamma_0(u_2, \beta_{u_2}, \beta_{u_1} - \beta_{u_2}) - \gamma_0(u_1, \beta_{u_1}, \beta_{u_1} - \beta_{u_2})] \, ds \\ &= \int_0^t [\gamma_0(u_2, \beta_{u_2}, \beta_{u_1} - \beta_{u_2}) - \gamma_0(u_2, \beta_{u_1}, \beta_{u_1} - \beta_{u_2})] \, ds \\ &+ \int_0^t [\gamma_0(u_2, \beta_{u_1}, \beta_{u_1} - \beta_{u_2}) - \gamma_0(u_1, \beta_{u_1}, \beta_{u_1} - \beta_{u_2})] \, ds \\ &\leq m_\gamma \int_0^t |\beta_{u_1} - \beta_{u_2}|_{\Pi_0}^2 \, ds + m_\gamma \int_0^t ||u_1 - u_2|| \, |\beta_{u_1} - \beta_{u_2}|_{\Pi_0} \, ds \\ &\leq \frac{m_\gamma}{2} \int_0^t ||u_1(s) - u_2(s)||^2 \, ds + \frac{3m_\gamma}{2} \int_0^t |\beta_{u_1}(s) - \beta_{u_2}(s)|_{\Pi_0}^2 \, ds, \end{split}$$

where, to simplify, the variable s was omitted in some relations. By Gronwall's lemma we obtain the estimate (3.27).

Now we can prove the following existence and uniqueness result.

Theorem 3.5. Assume that (3.1)-(3.12) and the compatibility condition (3.13) hold. Then there exists a unique solution of the problem Q.

Proof. For every $\beta \in X$ let $u_{\beta} \in W^{2,2}(0,T;H_0) \cap W^{1,2}(0,T;V_0)$ be the solution of the inequality (3.14) corresponding to β such that $u_{\beta}(0) = u_0$, $\dot{u}_{\beta}(0) = u_1$ and let $\beta_{u_{\beta}} \in X \cap W^{1,\infty}(0,T;\Pi_0)$ be the solution of the inequality (3.15) corresponding to u_{β} . We define the mapping $\mathcal{T}: X \to X$ by $\forall \beta \in X \quad \mathcal{T}\beta = \beta_{u_{\beta}}$ and we will prove that $\mathcal{T}: X \to X$ has a unique fixed point, which is equally the solution of the problem \mathcal{Q} .

For all $\beta_1, \beta_2 \in X$, for all $t \in [0, T]$, using (3.27) and (3.16), we have

$$\begin{aligned} |\mathcal{T}\beta_{1}(t) - \mathcal{T}\beta_{2}(t)|_{\Pi_{0}}^{2} &\leq C_{3} \int_{0}^{t} \|u_{\beta_{1}}(s) - u_{\beta_{2}}(s)\|^{2} ds \\ &\leq C_{1} C_{3} \int_{0}^{t} \left(\int_{0}^{s} \exp(-2kr) \, \exp(2kr) \, |\beta_{1}(r) - \beta_{2}(r)|_{\Pi_{0}}^{2} dr \right) ds \\ &\leq C_{1} C_{3} \, \|\beta_{1} - \beta_{2}\|_{k}^{2} \int_{0}^{t} \frac{\exp(2ks)}{2k} \, ds \\ &\leq \frac{C_{1} C_{3}}{4k^{2}} \cdot \exp(2kt) \, \|\beta_{1} - \beta_{2}\|_{k}^{2}. \end{aligned}$$

Then

$$\begin{aligned} \|\mathcal{T}\beta_1 - \mathcal{T}\beta_2\|_k &= \max_{t \in [0,T]} \left[\exp(-kt) \left| \mathcal{T}\beta_1(t) - \mathcal{T}\beta_2(t) \right|_{\Pi_0} \right] \\ &\leq \frac{\sqrt{C_1 C_3}}{2k} \|\beta_1 - \beta_2\|_k. \end{aligned}$$

Hence, for all $\beta_1, \beta_2 \in X$

$$\|\mathcal{T}\beta_1 - \mathcal{T}\beta_2\|_k \le \frac{\sqrt{C_1 C_3}}{2k} \|\beta_1 - \beta_2\|_k,$$

so that if k is sufficiently large it follows that \mathcal{T} is a contraction and its fixed point is the solution of the problem \mathcal{Q} .

4 Approximation and existence of variational solutions

Now, the previous general results are applied to analyse the penalized and the unilateral contact problems.

4.1 Existence and uniqueness of penalized solutions

We prove the following existence and uniqueness result for the penalized problem.

Theorem 4.1. There exists a unique solution to the problem $\mathcal{P}_{\varepsilon}$.

Proof. We apply Theorem 3.5 to $H_0 = \mathbf{H}$, $V_0 = \mathbf{V}$, $\Pi_0 = L^2(\Xi)$, $\Lambda_0 = \Lambda$, $u_0 = \mathbf{u}_0$, $u_1 = \mathbf{u}_1$, $a_0 = a$, $b_0 = b$, $L_0 = \mathbf{L}$, $(.,.)_{\Pi_0} = (.,.)_{\Xi}$, $|.|_{\Pi_0} = |.|_{\Xi}$, $\gamma_0 = \gamma$, $\chi_0 = \chi$ and

$$\begin{split} \phi_0(t,\lambda,\boldsymbol{u},\boldsymbol{v},\boldsymbol{w}) &= p_{\varepsilon}(\boldsymbol{u},\boldsymbol{w}) + c(\lambda,\boldsymbol{u},\boldsymbol{w}) + J(\lambda,\boldsymbol{u},\boldsymbol{v},\boldsymbol{w}) \\ \forall t \in [0,T], \ \forall \lambda \in L^2(\Xi), \ \forall \, \boldsymbol{u}, \, \boldsymbol{v}, \, \boldsymbol{w} \in \boldsymbol{V}. \end{split}$$

As meas(Γ_U^{α}) > 0, the ellipticity property of the coefficients $\mathcal{A}_{ijkl}^{\alpha}$, $\mathcal{B}_{ijkl}^{\alpha}$ and the Korn's inequality imply that there exist $A^{\alpha}, B^{\alpha} > 0$ such that

$$a^{\alpha}(\boldsymbol{v}^{\alpha},\boldsymbol{v}^{\alpha}) \geq A^{\alpha} \|\boldsymbol{v}^{\alpha}\|_{\boldsymbol{V}^{\alpha}}^{2}, \ b^{\alpha}(\boldsymbol{v}^{\alpha},\boldsymbol{v}^{\alpha}) \geq B^{\alpha} \|\boldsymbol{v}^{\alpha}\|_{\boldsymbol{V}^{\alpha}}^{2} \quad \forall \, \boldsymbol{v}^{\alpha} \in \boldsymbol{V}^{\alpha}, \ \alpha = 1, 2,$$

and we obtain

$$a(\boldsymbol{v}, \boldsymbol{v}) \ge A \|\boldsymbol{v}\|^2, \ b(\boldsymbol{v}, \boldsymbol{v}) \ge B \|\boldsymbol{v}\|^2 \ \forall \, \boldsymbol{v} \in \boldsymbol{V},$$
 (4.1)

where $A = \min(A^1, A^2), B = \min(B^1, B^2).$

For all $\boldsymbol{u}_{1,2} \in \boldsymbol{V}, \ \delta_{1,2} \in \Lambda, \ \lambda \in L^2(\Xi)$, we have the following relations:

$$|\gamma(\boldsymbol{u}_1, \delta_1, \lambda) - \gamma(\boldsymbol{u}_2, \delta_2, \lambda)| = \left|\frac{C_N}{b} \int_{\Xi} \left(\vartheta([u_{1N}]^2) \,\delta_1 - \vartheta([u_{2N}]^2) \,\delta_2\right) \lambda \,d\xi\right|$$

$$\begin{split} &= \left| \frac{C_N}{b} \int_{\Xi} \left[(\vartheta([u_{1N}])^2 - \vartheta([u_{2N}])^2) \,\delta_1 + \vartheta([u_{2N}]^2) (\delta_1 - \delta_2) \right] \lambda \, d\xi \right| \\ &\leq \frac{C_N}{b} \int_{\Xi} \left[2r |\vartheta([u_{1N}]) - \vartheta([u_{2N}])| + r^2 |\delta_1 - \delta_2| \right] |\lambda| \, d\xi \\ &\leq \max(2r, r^2) \frac{C_N}{b} \int_{\Xi} \left(|[u_{1N}] - [u_{2N}]| + |\delta_1 - \delta_2| \right) |\lambda| \, d\xi \\ &= \max(2r, r^2) \frac{C_N}{b} \int_{\Xi} \left(|u_{1N}^1 + u_{1N}^2 - u_{2N}^1 - u_{2N}^2| + |\delta_1 - \delta_2| \right) |\lambda| \, d\xi \\ &\leq m_\gamma(||u_1 - u_2|| + |\delta_1 - \delta_2|_{\Xi}) \, |\lambda|_{\Xi}. \end{split}$$

Thus, (3.2) and (3.4) are satisfied. We can also easily verify (3.1), (3.3) and (3.5).

For all $\lambda \in L^2(\Xi)$, $\boldsymbol{u} \in \boldsymbol{V}$, the mappings $p_{\varepsilon}(\boldsymbol{u}, \cdot)$, $c(\lambda, \boldsymbol{u}, \cdot)$ are linear on \boldsymbol{V} and the mapping $J(\lambda, \boldsymbol{u}, \boldsymbol{v}, \cdot)$ is a semi-norm on \boldsymbol{V} , which imply that ϕ_0 satisfies conditions (3.7), (3.8). The mapping ϕ_0 equally satisfies (3.6) and (3.9).

We set

4.2 Existence of a variational solution

We shall use several times the following compactness theorem proved by J. Simon [27].

Theorem 4.2. Let X, U and Y be three Banach spaces such that $X \subset U \subset Y$ with compact imbedding $X \to U$.

Let \mathcal{F} be bounded in $L^p(0,T;X)$, where $1 \leq p < \infty$, and $\partial \mathcal{F}/\partial t = \{\dot{f}; f \in \mathcal{F}\}$ be bounded in $L^1(0,T;Y)$. Then \mathcal{F} is relatively compact in $L^p(0,T;U)$.

Let \mathcal{F} be bounded in $L^{\infty}(0,T;X)$ and $\partial \mathcal{F}/\partial t$ be bounded in $L^{r}(0,T;Y)$, where r > 1. Then \mathcal{F} is relatively compact in $C^{0}([0,T];U)$.

Theorem 4.3. Under the assumptions of Section 2 there exists a solution of the problem \mathcal{P}_v .

Proof. First, we establish some estimates on the penalized solutions u_{ε} and β_{ε} which will enable us to pass to the limit in $\mathcal{P}_{\varepsilon}$ in order to obtain a solution

$$\int_0^T (\dot{\beta}, \lambda - \beta)_{\Xi} dt + \int_0^T \gamma(\boldsymbol{u}, \beta, \lambda - \beta) dt \ge \int_0^T (\chi, \lambda - \beta)_{\Xi} dt$$
$$\forall \lambda \in L^2(0, T; L^2(\Xi)) \text{ with } \lambda(t) \in \Lambda \text{ a.e. } t \in]0, T[.$$

By Lebesgue's theorem, it follows that (u, β) verify also the parabolic inequality (2.14).

We note that the abstract results presented in section 3 can be also applied to prove the existence and uniqueness of solutions to dynamic contact problems with normal compliance and adhesion between a viscoelastic body and an obstacle.

Similar results as the previous ones are easily seen to hold for the contact with irreversible adhesion, where the evolution of the intensity of adhesion is governed by a differential equation satisfying the relation (3.27), see, e.g., [28].

5 Numerical examples

In this section, an example is presented to illustrate the mechanical behaviour associated with this interface law and to study the influence of the main mechanical parameters on the solution. The dynamic behaviour of a cylindrical viscoelastic block in adhesive frictional contact ($\mu = 0.2$) under axisymmetric conditions with a stiff sphere is analysed, see Figure 1.

The previous sections concern a dynamic contact problem in viscoelasticity, which constitutes an extension of the model considered in [22, 24] to the case of recoverable adhesion. In elastodynamics, the discrete problem, the algorithms and the numerical solution were given in [24, 1] for non recoverable adhesion. They are based on a combination of the Non Smooth Contact Dynamics (NSCD) method, developed by M. Jean and J.J. Moreau [15, 21, 11], and the methods proposed in [22, 24] for the treatment of the adhesion. This approach is extended here to viscoelasticity and to healing process, see also [25, 26].

The evolution of the adhesion β is computed by using an implicit method and so a fixed point on β is necessary (the convergence test on the relative variation is taken as 10^{-5}). The convergence of the relaxation method included in the NSCD algorithm is tested on the relative variation of the contact power (test condition : 10^{-5}). The implementation of the model with recoverable adhesion was conducted in the finite element code LMGC90 [11].

The finite element discretizations consist of P_1 elements and an initial triangulation with 480 nodes for the cross-section of the block and 270 nodes for the cross-section of the sphere is considered. The corresponding size of minimal length of edge mesh is $h_c = 0.33 \ \mu\text{m}$. A θ -method is used to solve the dynamic equations and the choice $\theta = 0.51$ gives good stability and a small numerical damping.

The sphere is initially in contact with the viscoelastic block at the point O. A compressive cycle is imposed with a prescribed displacement $U^{1}(t) =$

 $u_z(t)\boldsymbol{e}_z$ on the upper part of the sphere, see Figure 2. The viscoelastic con-

stitutive law is described by the following relations:

$$\begin{split} \boldsymbol{\sigma} &= \boldsymbol{\sigma}^r + \boldsymbol{\sigma}^{ir}, \\ \boldsymbol{\varepsilon} &= \frac{1+\nu}{E} \boldsymbol{\sigma}^r - \frac{\nu}{E} tr(\boldsymbol{\sigma}^r) \boldsymbol{I}, \\ \dot{\boldsymbol{\varepsilon}} &= \frac{1+\tilde{\nu}}{\tilde{E}} \boldsymbol{\sigma}^{ir} - \frac{\tilde{\nu}}{\tilde{E}} tr(\boldsymbol{\sigma}^{ir}) \boldsymbol{I}, \end{split}$$

where E is Young's modulus, ν is Poisson's ratio and \tilde{E} , $\tilde{\nu}$ are the viscosity coefficients. We considered for the sphere $E^{(1)} = 2.10^{11}$ Pa, $\nu^{(1)} = 0.3$, $\rho^{(1)}=7800$ kg.m⁻³, $\tilde{E}^{(1)} = \eta^{(1)}E^{(1)}$ with $\eta^{(1)} \to 0$, and for the block $\tilde{E}^{(2)} = \eta^{(2)}E^{(2)}$ with $\eta := \eta^{(2)} \in [0, 10]$ s, $E^{(2)} = 5.10^6$ Pa, $\nu^{(2)} = \tilde{\nu}^{(2)} = 0.48$, $\rho^{(2)} = 1000$ kg.m⁻³.

This example is used to investigate the dependency of the solution on the variation of the following parameters:

- the adhesion parameters C_N and w,
- the volumic viscosity parameter $\eta,$

- the mesh size.

5.1 Effect of adhesion parameters

We consider here three cases of interfacial behaviour with different choices of the adhesion parameters C_N and w as given in Table 1.

For $\eta = 1$ s, the evolution of β at the candidate contact point *B* (see Figure 1) and the evolution of contact radius, characterized by the relation g = 0, in these three cases are presented in Figures 3 and 4, respectively.

In case 1, the bonds are weak and brittle. Adhesion has minor effect on the solution and a loss of contact is observed. In case 2, the bonds are strong and brittle. An initial contact is observed (radius 0.9 mm), which is due to the stronger adhesion that acts during the initial step, when only gravity is

concerned. A loss of contact is still observed at t=10 s because the evolution of the adhesion is still brittle. In case 3, the bonds are strong and resilient. Adhesion has major effect on the solution and the two bodies remain always in contact even at t=10 s.

5.2 Effect of the volumic viscosity

The evolutions of the displacement vector and of the intensity of adhesion in case 1, as presented in Figures 5 and 6, show a good convergence of viscoelastic solutions towards an elastic solution as η tends to 0.

5.3 Effect of the mesh size

We consider the case 3 with η equal to 1 s. The distributions of the normal and tangential components of the stress vector, σ_N and σ_T , versus the position r are displayed at t = 8 s in Figure 7 for different meshes, as given in Table 2.

The bodies are in contact ($\sigma_N \leq 0$ and g = 0) for $r \leq r_C$, where $r_C \simeq 4.5$ mm is the contact radius, and the bodies are in adhesion ($\sigma_N \geq 0$) for

 $r_A > r > r_C$, where $r_A \simeq 5.5$ mm is the adhesion radius. For $r \ge r_A$ the stress vector is negligible.
