### 19 Synopsis

20

21 *Plasmodium falciparum* is incapable of *de novo* purine biosynthesis, and is absolutely 22 dependent on transporters to salvage purines from the environment. Only one low-23 affinity adenosine transporter has been characterised to date. Here we report a comprehensive study of purine nucleobase and nucleoside transport by 24 25 intraerythrocytic P. falciparum parasites. Isolated trophozoites expressed (a) a high 26 affinity hypoxanthine transporter with a secondary capacity for purine nucleosides, (b) 27 a separate high affinity transporter for adenine (c) a low affinity adenosine transporter and (d) a low affinity/high capacity adenine carrier. Hypoxanthine was taken up with 28 29 12-fold higher efficiency than adenosine. Using a parasite clone with a disrupted 30 *PfNT1* gene we found that the high affinity hypoxanthine/nucleoside transport activity 31 was completely abolished whereas the low affinity adenosine transport activity was 32 unchanged. Adenine transport was increased, presumably to partly compensate for the 33 loss of the high affinity hypoxanthine transporter. We thus propose a model for purine 34 salvage in *P. falciparum*, based on the highly efficient uptake of hypoxanthine by 35 PfNT1 and a high capacity for purine nucleoside uptake by a lower affinity carrier.

# 47 Introduction

49 Plasmodium spp. are auxotrophic for purines, as are all other parasitic protozoa studied to date, and require an efficient salvage system for these essential nutrients 50 51 [1]. Purine salvage may be especially important during the fast dividing intra-52 erythrocytic stages, and it has long been known that *Plasmodium* trophozoites 53 accumulate some purines very rapidly [1,2]. Tracy and Sherman [2] found that 54 hypoxanthine, adenosine and inosine but not adenine or nucleotides were efficiently 55 taken up by the avian malaria parasite P. lophurae. Similarly, the rodent malaria P. 56 berghei was reported to have two separate uptake systems for purines: one for adenine 57 and one for adenosine, inosine and hypoxanthine [3]. The study of purine metabolism 58 in the human malaria species P. falciparum, however, showed clearly that 59 hypoxanthine was by far the preferred purine source for the parasite, with very high 60 activities hypoxanthine-guanine phosphoribosyltransferase and inosine of 61 phosphorylase but not of adenine phosphoribosyltransferase or adenosine kinase [4]. 62 Adenosine salvage appeared to proceed through rapid deamination to inosine and 63 thence to hypoxanthine [4], and this process mostly occurs extracellularly [5]. This 64 explains the observation of Hansen et al. [3] that inhibition of adenosine deaminase with deoxycoformycin potently reduced  $[^{3}H]$ -adenosine uptake by *P. berghei*. The 65 resulting model of a crucial role for hypoxanthine transport in Plasmodium purine 66 67 salvage was further validated by the study of Berman et al. [6] who showed that 68 depletion of hypoxanthine from infected erythrocytes by xanthine oxidase reduced P. 69 *falciparum* growth by ~90%.

70 While hypoxanthine transport clearly plays a pivotal role in an essential 71 function of the malaria parasite, almost all available information on Plasmodium 72 purine transporters concerns uptake of adenosine. Penny et al. [7] injected Xenopus 73 oocytes with mRNA from P. falciparum and observed increased uptake of adenosine 74 and hypoxanthine, sensitive to at least partial reciprocal inhibition, demonstrating the 75 presence of at least one transporter capable of recognizing both substrates. Two 76 groups have independently cloned the same P. falciparum gene of the Equilibrative 77 Nucleoside Transporter family, which they termed *PfENT1* or *PfNT1*, respectively [8,9], and the PfNT1 protein was found to be localised in the parasite's plasma 78 79 membrane [10]. Both groups expressed the cloned transporter in Xenopus oocytes for 80 characterization, but they arrived at strikingly different conclusions. Carter et al. [9] 81 described PfNT1 as a broad specificity nucleoside transporter of moderately high 82 affinity for adenosine and inosine and no affinity for nucleobases. In contrast, Parker 83 et al. [8] report a purine nucleoside/nucleobase transporter with a similar, but low, 84 affinity for adenosine, adenine and hypoxanthine. The presence of a low affinity adenosine transporter was recently confirmed by Downie et al. [11] using P. 85 86 falciparum trophozoites isolated after treatment with saponin. On the basis of the 87 adenosine K<sub>m</sub> value, they concluded that this activity must be PfNT1, and this seemed 88 to be confirmed by expression of *PfNT1* in oocytes, which revealed a low affinity 89 nucleoside transporter. However, in the current manuscript we will demonstrate 90 conclusively that the low affinity adenosine transporter is not encoded by *PfNT1*.

91 Studies to date have not investigated the possibility of a very high affinity 92 purine transporter, such as found in other intracellular [12-14] and extracellular 93 [15,16] protozoan parasites. However, a recent report [17] did strongly suggest that 94 *PfNT1* must encode a high affinity purine transporter, as wild-type *P. falciparum* were 95 able to grow in very low levels of purines, but  $\Delta PfNT1$  parasites grew only in >10  $\mu$ M 96 hypoxanthine, adenosine or inosine. The same study also showed that, at 1  $\mu$ M

97 concentrations, accumulation of those three purines was reduced in  $\Delta PfNT1$  but the 98 characteristics of this transporter in terms of substrate affinity and specificity was not 99 further investigated.

100 We report here the first systematic study of high affinity hypoxanthine, 101 adenine and adenosine transport activities in P. falciparum trophozoites. We have 102 identified and characterised a broad-specificity carrier that transports hypoxanthine, guanine, adenosine, guanosine and inosine, but not for adenine. In addition we 103 104 characterised a low affinity adenosine transporter (which we denote PfLAAT) and a 105 high affinity adenine transporter (denoted PfADET1) and demonstrate the existence of a further low affinity uptake route for adenine (PfADET2). To confirm our 106 107 hypothesis that the high affinity transport activity is encoded by the previously 108 reported PfNT1, we generated a mutant parasite clone with a disrupted PfNT1 gene, designated  $\Delta P fnt I^{GU}$  to distinguish itself from the clone generated by El Bissati et al. 109 [17].  $\Delta P fnt I^{GU}$  had completely lost both the high affinity adenosine uptake capacity 110 and over 85% of hypoxanthine uptake, while low affinity adenosine uptake was 111 112 unchanged and high affinity adenine uptake was slightly increased. We therefore 113 conclude that *PfNT1* encodes a high affinity hypoxanthine/purine nucleoside 114 transporter.

115 We present for the first time a comprehensive model of purine uptake by P. 116 falciparum, in which the intraerthrocytic stages express at least four distinct purine transport activities. This model finally identifies the biochemical and genetic basis for 117 118 the parasite's overwhelming reliance on hypoxanthine salvage as its main purine 119 source and is in line with a recent analysis of the P. falciparum permeome that 120 showed the presence of four genes of the Equilibrative Nucleoside Transporter (ENT) family in its genome [18]. This family includes all protozoan purine transporters 121 122 known to date [1].

# 123 **Experimental**

# 125 *Plasmodium* lines, human cells and chemicals.

126 All transport experiments were performed with the standard 3D7 drug sensitive 127 laboratory clone of *Plasmodium falciparum*, originally obtained from David Walliker, 128 University of Edinburgh, UK. Human blood and serum used for *Plasmodium* culture 129 was obtained from the Glasgow and West of Scotland Blood Transfusion Service. 130 Standard chemicals including purines and pyrimidines were obtained from Sigma and 131 of the highest purity available. The purine analogues JA-23 (2-Amino-N<sup>6</sup>-amino-N<sup>6</sup>methyladenosine), JA-24 (2-Amino-N<sup>6</sup>-amino-adenosine) and JA-32 (N<sup>6</sup>-Hydroxy-132 9H-purin-6-amine) were kindly donated by Daniel Brown and David Loakes of the 133 134 MRC Laboratory of Molecular Biology, Cambridge, UK.

# 136 Culturing of *P. falciparum* for transport assays

Asexual parasites of P. falciparum were maintained in continuous culture using 137 138 slightly modified standard methods [19]. Briefly, parasites were grown in RPMI 1640 139 medium supplemented with 5.94 g/l HEPES, 0.21% NaHCO<sub>3</sub> and 10% heat-140 inactivated normal human serum at 5% haematocrit. The culture was incubated at 37 141 <sup>o</sup>C under a gas mixture of 1% O<sub>2</sub>, 3% CO<sub>2</sub>, 96% N<sub>2</sub> and medium was changed daily. 142 Parasitaemia of the culture was routinely maintained below 5%, unless otherwise 143 stated. Prior to use in experiments, parasite cultures were synchronised using a 144 previously described method [20]. Transport experiments were performed with 145 cultures of parasitaemia between 7 and 10% in order to maximise yield.

# 147 Saponin permeabilization of *P. falciparum*-infected erythrocytes

Permeabilised P. falciparum-infected erythrocytes were prepared by incubating 148 149 parasitised red blood cells with 0.15% (w/v) saponin as described [21]. Briefly, the 150 culture was centrifuged at  $600 \times g$  and the supernatant removed. The cell pellets were 151 re-suspended in 5 volumes of 0.15% (w/v) saponin in phosphate-buffered saline (137) 152 mM NaCl, 27 mM KCl, 1.76 mM K<sub>2</sub>HPO<sub>4</sub>, 8 mM Na<sub>2</sub>HPO<sub>4</sub>) for one minute. The 153 freed parasites were washed three times with purine-free RPMI 1640 culture medium 154 without serum, and resuspended in the same medium. Parasitaemia was determined by 155 microscopical examination of thin blood smears stained with Giemsa's stain, and red 156 cell density was estimated using a Neubauer counting chamber.

# 158 Transport assays with saponin-permeabilised *Plasmodium falciparum*-159 infected erythrocytes

160 Transport assays were performed with synchronised cultures in the trophozoite stage. 161 After permeabilisation of the erythrocytes with saponin [22], which leaves the parasite 162 plasma membrane intact [23,24], the cells were resuspended in purine-free RPMI 1640 at a concentration of  $5 \times 10^8$  cells/ml. Uptake of [<sup>3</sup>H]-hypoxanthine (GE 163 164 Healthcare, 31 Ci/mmol), [<sup>3</sup>H]-adenosine (GE Healthcare, 16.0 Ci/mmol), or [<sup>3</sup>H]adenine (Perkin-Elmer, 32.2 Ci/mmol) by P. falciparum trophozoites was measured 165 166 using a rapid stop/spin method essentially as described previously for Trypanosoma 167 brucei [25], Leishmania spp [14,26], Toxoplasma gondii [13] and human erythrocytes 168 [27]. Transport was measured either at various time intervals to generate plots of 169 uptake rate versus time, or over fixed time intervals in the presence of variable 170 inhibitor concentrations to generate plots for the determination of K<sub>m</sub> and K<sub>i</sub> values, using non-linear regression (GraphPad Prism version 4). Briefly, equal volumes of a 171 172 suspension of permeabilised-infected erythrocytes and a radiolabeled permeant at 173 twice its final concentration (as well as inhibitor at  $2\times$  concentration, where 174 applicable) were mixed for a predetermined time. Influx of permeant into the cells 175 was terminated by adding 1 ml ice-cold stop solution (unlabelled permeant at 176 saturating concentrations) and immediately pelleting the cells by centrifugation at  $13,000 \times g$  in a microfuge through an oil-mix (300µl of 5 parts dibutylphthalate 177 178 (Aldrich):4 parts dioctylphthalate (Aldrich), v/v), thus preventing further uptake of 179 permeant, which remains in the aqueous layer. Non-mediated influx of the respective 180 permeant was assessed by determining the rate of uptake of the radiolabelled 181 permeant in the presence of a saturating concentration of unlabelled permeant at both 182 room temperature and 0 °C.

183 The parasite pellets were processed after the uptake using the method 184 previously described by Saliba et al [28], with a slight modification. The aqueous phase was removed by aspiration and the inside walls of the tube carefully washed 185 186 with distilled water. The water was aspirated out, followed by the oil-mix, and the inside of the tube wiped with folded tissue paper. The cells were resuspended in 200 187 188  $\mu$ l of 1% Triton X-100 in water (v/v) for 10 minutes at room temperature and proteins were precipitated with 200 µl of 5% trichloroacetic acid (TCA). The mixture was 189 190 finally centrifuged for 7 minutes at 13000  $\times$  g and the supernatant transferred into a 191 scintillation vial and mixed with 3.5 ml scintillation fluid (OptiPhase HiSafe, Perkin 192 Elmer). Radioactivity was determined with a Perkin-Elmer 1450 Microbeta Wallac 193 Trilux liquid scintillation counter. All uptake experiments were performed in 194 triplicate.

For any given permeant, the linear phase of uptake was first determined, with 195 196 a constant permeant concentration incubated for various times to generate a plot of 197 uptake versus time. Linearity was assessed using linear regression and defined as a correlation coefficient >0.95 and significant difference from zero uptake (F-test; 198 199 GraphPad Prism version 4). When uptake was too rapid to obtain linearity of transport 200 at room temperature, this was reassessed at 6 °C using a ThermoStat plus (Eppendorf, 201 Germany), as indicated in Results. Inhibition studies were always performed well 202 within the linear phase of uptake, and thus reflect true initial rates of transport across 203 the *P. falciparum* plasma membrane rather than rates of metabolism or sequestration.

# 205 Generation of *Plasmodium falciparum* clones with disrupted PfNT1

206 Our strategy for knocking-out the *Plasmodium* gene *PfNT1* relies on single crossover 207 homologous recombination and full details of the methods are provided in the on-line 208 data supplement. Briefly, a plasmid was constructed containing the central sequence 209 of *PfNT1* spanning the predicted transmembrane domains 3-6 and part of 210 transmembrane domain 2. The construct was used to transfect P. falciparum parasites 211 of clone 3D7 using standard methods [29], with control parasites treated similarly but 212 with no construct present during electroporation. Transformed parasites were selected 213 with blasticidin and cloned. Successful disruption of the gene was confirmed using 214 PCR and Southern blot as described in the data supplement.

# 215 Results and Discussion216

### High affinity hypoxanthine transport in *P. falciparum* trophozoites

218 In order to study the transporters in the plasma membrane of *P. falciparum*, infected 219 human erythrocytes were permeabilised with saponin, after which the erythrocyte 220 plasma membrane ceases to be a barrier to the passage of solutes [22] but the parasite 221 membranes are not significantly affected by this saponin treatment protocol [23,24]. 222 The parasitophorous vacuole membrane remains but this membrane is intrinsically 223 permeable to small solutes [30]. Therefore, initial rates of transport measured in this 224 system reflect uptake by the Plasmodium-encoded transporters located in the 225 parasite's plasma membrane.

Uptake of 0.25  $\mu$ M or 0.1  $\mu$ M [<sup>3</sup>H]-hypoxanthine followed a hyperbolical 226 curve, which was linear for up to 120 s at 20 °C, with a rate of  $0.62 \pm 0.04$  and  $0.40 \pm$ 227 0.03 pmol(10<sup>7</sup> cells)<sup>-1</sup>s<sup>-1</sup>, respectively, and was completely inhibited by 1 mM 228 229 hypoxanthine (Figure 1A). The hypoxanthine thus accumulated would, in the absence 230 of metabolism, reach very high intracellular concentrations: based on an intracellular volume of  $2.8 \times 10^{-7}$  l/10<sup>7</sup> parasites isolated by saponin treatment [28] uptake of 0.25 231 232 µM hypoxanthine would be over 1000-fold concentrated in the parasite – reaching a 233 level of 260 µM in 2 minutes. Transport rates remained constant during this time (i.e. 234 linear phase of uptake) because the rate of metabolism was greater than the rate of 235 transport, making transport the rate-limiting step. Alternatively, high affinity purine 236 transport in P. falciparum may be energy-dependent, as it is in other protozoan 237 species [31,16,25], allowing uptake against a concentration gradient - but this 238 possibility was not further investigated in this study.

239 Determining [<sup>3</sup>H]-hypoxanthine transport at sub-micromolar concentrations revealed a very high affinity transporter for oxopurines, with a mean K<sub>m</sub> value for 240 hypoxanthine of 0.34  $\pm$  0.05  $\mu$ M (n = 6; Figure 1B, inset), a V<sub>max</sub> of 0.36  $\pm$  0.12 241 pmol( $10^7$  cells)<sup>-1</sup>s<sup>-1</sup> (n=6) and a mean K<sub>i</sub> value of 0.11 ± 0.01 µM for guanine (n=3). 242 In addition, the nucleosides adenosine (Figure 1B), inosine and guanosine displayed 243 244 affinity in the low micromolar range (Table 1). This hypoxanthine transporter with 245 high affinity for purine nucleosides was designated Plasmodium falciparum 246 Nucleoside Transporter 1 (PfNT1) based on our later observations linking the PfNT1 gene to this transport activity (see "Purine transport in the  $\Delta pfnt 1^{GU}$  clone"). 247

248 PfNT1 exhibited low affinity for pyrimidines. Only uridine, uracil and 249 thymidine inhibited transport of 30 nM [<sup>3</sup>H]-hypoxanthine significantly, at a 250 concentration of 1 mM inhibitor, by  $36 \pm 9\%$  (P<0.05),  $49 \pm 6\%$  (P<0.01) and  $57 \pm$ 251 6% (P<0.02) respectively (Paired Student's *t*-test against no-inhibitor control, based 252 on four independent experiments in duplicate). Cytosine, thymine and cytidine (up to 253 1 mM) did not significantly inhibit 30 nM [<sup>3</sup>H]-hypoxanthine transport (data not 254 shown). This result is not surprising, in the light of the well-documented inability of 255 *Plasmodium* spp to salvage preformed pyrimidine nucleobases and nucleosides [1,32].

256 Of all the natural purines tested, only adenine had very little effect on transport 257 of 0.03  $\mu$ M [<sup>3</sup>H]-hypoxanthine, with less than 50% inhibition at 1 mM. However, the 258 antiplasmodial adenine analogue JA-32 [33] displayed a K<sub>i</sub> value of  $14 \pm 3 \mu$ M (Fig. 259 1B), probably as a result of its 'hypoxanthine-like' conformation (i.e. lactam 260 hydrogen on N1 and H-bond acceptor at the N<sup>6</sup> position, see figure 1B). Two N<sup>6</sup> 261 substituted adenosine analogues, JA-23 and JA-24, with antiplasmodial activities in 262 the low micromolar range [33], had little (K<sub>i</sub> =  $320 \pm 80 \mu$ M for JA-24) or no effect 263 (JA23) on high affinity hypoxanthine transport (not shown).

264 The transporter appeared to display a preference for oxopurine nucleobases 265 over aminopurine bases whereas this preference appears to be curiously absent in the 266 binding of nucleosides: e.g. guanine is the highest affinity nucleobase whereas 267 guanosine is the lowest affinity purine nucleoside (Table 1). Two testable hypotheses 268 may be proposed to explain this apparent paradox: (i) the nucleosides are not actually substrates, but allosteric inhibitors of hypoxanthine transport, or (ii) the nucleosides 269 270 and nucleobases assume a different orientation within the binding pocket, due to the 271 presence of the ribose moiety. In order to distinguish between these alternatives, we 272 assessed the uptake of low concentrations of [<sup>3</sup>H]-adenosine.

# High affinity adenosine transport in *P. falciparum* trophozoites

Uptake of 0.25  $\mu$ M [<sup>3</sup>H]-adenosine proceeded with a rate of 0.015 ± 0.002 pmol(10<sup>7</sup> cells)<sup>-1</sup>s<sup>-1</sup> over the linear phase (at least 30 s), and was completely inhibited by 1 mM adenosine (see figure S1 of the supplementary material). At the end of linear phase, cells had transported approx. 0.55 pmol [<sup>3</sup>H]-adenosine/10<sup>7</sup> cells, which would correspond to ~8-fold the extracellular concentration if unmetabolised. Both the rate of uptake and the level of concentration of adenosine were much less than for hypoxanthine.

Uptake of 0.25  $\mu$ M [<sup>3</sup>H]-adenosine was potently inhibited by hypoxanthine 282 (mean  $K_i = 0.75 \pm 0.18 \mu$ M; n=3) and unlabelled adenosine, but only by very high 283 284 concentrations of adenine (Figure 2). Over three separate experiments, the average of 285 the extrapolated values for an adenine IC<sub>50</sub> value would be  $\sim 1 \text{ mM}$  – three orders of 286 magnitude lower affinity than for hypoxanthine. In the same three experiments, the 287 inhibition by hypoxanthine was not quite complete at 100  $\mu$ M (6.1 ± 0.2%; P<0.05, 288 paired Student's t-test), possibly the result of a minor contribution to 0.25  $\mu$ M [<sup>3</sup>H]-289 adenosine flux from a second, low affinity adenosine transporter, that is insensitive to 290 hypoxanthine (see "Low affinity transport of [<sup>3</sup>H]-adenosine in *P. falciparum* 291 trophozoites"). The mean K<sub>m</sub> for adenosine on the high affinity transporter was determined to be 2.0  $\pm$  0.2  $\mu$ M and the V<sub>max</sub> as 0.18  $\pm$  0.08 pmol(10<sup>7</sup> cells)<sup>-1</sup>s<sup>-1</sup> (n=3; 292 293 Figure 2, inset). The strikingly similar reciprocal K<sub>m</sub> and K<sub>i</sub> values for adenosine and hypoxanthine uptake are consistent with high affinity uptake of both hypoxanthine 294 295 and adenosine by PfNT1. However, the V<sub>max</sub>/K<sub>m</sub> ratio indicates an 11.9-fold higher 296 efficiency of translocation for hypoxanthine compared to adenosine, consistent with 297 the preference for hypoxanthine for optimal growth in vitro.

The different selectivity for aminopurine nucleobases and nucleosides noted in the previous section thus seems to indicate that nucleobases and nucleosides orient differently in the same binding site and the kinetic profiles presented here are consistent with competitive inhibition (Figures 1B and 2). There are precedents for this; for instance, there is good evidence for different binding orientations for xanthine and uric acid in the *Aspergillus nidulans* UapA purine transporter [34].

# 305 Uptake of [<sup>3</sup>H]-adenine is mediated by a separate high affinity 306 transporter

At  $1 \mu M$  of  $[{}^{3}H]$ -adenine, uptake was  $0.0091 \pm 0.0025 \text{ pmol}(10^{7} \text{ cells})^{-1}\text{s}^{-1}$  over the linear phase (6 s;  $r^{2} = 0.93$ ) and mostly inhibited by 1 mM unlabelled adenine (data not shown). At 120 s the accumulation ratio (intracellular/extracellular radiolabel concentration based on the intracellular volume of  $2.8 \times 10^{-7} \text{ l/10}^{7}$  parasites cited above) had reached ~0.6, consistent with an equilibrative process and at best a slow rate of metabolism or no metabolism at all. We tentatively designate this novel 313 transport activity *Plasmodium falciparum* adenine transporter 1 (PfADET1), pending 314 the identification of the encoding gene.

In order to determine the K<sub>m</sub> value for this high affinity transporter, uptake of 315 316 adenine was assessed at 50 nM of radiolabel. Uptake was linear and did not reach 317 equilibrium for up to 240 s (accumulation ratio was 0.65) (Figure 3A). This allowed 318 inhibition experiments at an incubation time of 150 s, although it was clear that there 319 was a small uptake component that was not sensitive to 1 mM adenine (Figure 3A) – 320 possibly resulting from the presence of a very low affinity transporter. Adenine 321 transport was not inhibited by the oxopurines hypoxanthine (Figure 3B), guanine and 322 inosine (not shown), though it was sensitive to adenosine, with a K<sub>i</sub> value of  $2.0 \pm 0.2$ 323  $\mu$ M (Figure 3B). The sub-micromolar K<sub>m</sub> value, similar to the hypoxanthine K<sub>m</sub> for PfNT1, and very low V<sub>max</sub> (Figure 3B), make PfADET1 a high affinity but low 324 325 capacity transport system with a maximum uptake rate 2 - 3 orders of magnitude 326 lower than that measured for high affinity transport of hypoxanthine and adenosine 327 (Table 1).

# 329 A very low affinity/high capacity transporter of adenine

328

As the uptake of 0.05  $\mu$ M [<sup>3</sup>H]-adenine was consistently not fully inhibited by 1 mM 330 331 unlabelled adenine (previous section) we investigated the possible presence of a low-332 affinity adenine transport activity in saponin-isolated P. falciparum trophozoites. Uptake of 10  $\mu$ M [<sup>3</sup>H]-adenine was linear for up to 12 s, with a rate of 0.13  $\pm$  0.01 333  $pmol(10^7 \text{ cells})^{-1} \text{s}^{-1}$  ( $r^2 = 0.96$ ), reaching an accumulation ratio of 0.85 in 30 s. This 334 335 could not be entirely attributed to simple diffusion as it was partly inhibited ( $\sim 60\%$ ) 336 by 1 mM adenine (Figure S2A, supplementary material). Attempts to establish a K<sub>m</sub> value for  $[^{3}H]$ -adenine uptake on this transporter were unsuccessful – due in part to 337 338 the high rate of diffusion of adenine at high concentrations, as reported for the related 339 apicomplexan parasite Toxoplasma gondii [13], and because the limitations of adenine 340 solubility prevented the determination of a complete inhibition curve (Figure S2B, 341 supplementary material). However, the K<sub>m</sub> for adenine was estimated to be 342 approximately 1 mM, and the K<sub>1</sub> value for adenosine >2.5 mM. There was no clear inhibition by up to 1 mM hypoxanthine (data not shown). This observation, and the 343 fact that these experiments were carried out at 10  $\mu$ M [<sup>3</sup>H]adenine – which fully 344 345 saturates PfADET1 – as well as the low affinity for adenosine, clearly shows that this 346 adenine transport phenomenon must be mediated by a low affinity transporter separate 347 from either PfNT1 or PfADET1. The low affinity adenine transport activity was 348 provisionally designated PfADET2.

349 Despite the presence of two adenine transporters, it is not at all clear whether 350 adenine salvage is important to *Plasmodium* spp and there is considerable controversy 351 about whether Plasmodium can utilise adenine at all, as several groups report the 352 inability to identify genes encoding adenine phosphoribosyltransferase (APRT) and 353 methylthioadenosine phosphorylase in any Plasmodium species [35,36] nor is there any evidence for the activity of adenine deaminase [35]. Yet, the characterisation of 354 355 APRT from P. chabaudi and P. falciparum have been reported [37,38]. In addition, P. 356 falciparum is reportedly able to grow in vitro on adenine as sole purine source [39] 357 and P. knowlesi incorporated adenine into nucleic acids [32]. Although these latter 358 observations could be explained by conversion of the adenine to hypoxanthine in the 359 host cell. Van Dyke reported that the free parasite can also incorporate adenine into 360 nucleic acids, albeit at 1% of the efficiency by which hypoxanthine is incorporated 361 [40]. The report here of uptake of adenine by *P. falciparum* trophozoites, however 362 inefficient, would be compatible with the view that adenine can be utilised in some

363 way but is unlikely to play any major role in the synthesis of nucleotides. It is 364 conceivable that the parasite has a different use for low levels of adenine, which it 365 conceivable that the parasite has a different use for low levels of adenine, which it 366 could be deaminated by adenosine deaminase.

# 368 Low affinity transport of [<sup>3</sup>H]-adenosine in *P. falciparum* trophozoites

369 Several groups have reported a much lower affinity adenosine transport process than 370 the K<sub>m</sub> value reported here for PfNT1 [8, 9, 11]. We therefore decided to reinvestigate the presence of such a transporter and found that 25  $\mu$ M [<sup>3</sup>H]-adenosine is extremely 371 rapidly taken up at room temperature (22 °C) (see Figure S3A, supplementary data). 372 373 as reported by Downie et al. [11], reaching an accumulation ratio of ~0.6 by 30 s. We 374 therefore conducted our experiments at 6 °C and consistently found that uptake of 25 375  $\mu$ M [<sup>3</sup>H]-adenosine was linear over a period of 4 – 6 s at this temperature (see Figure 376 S3B, supplementary data), and that initial rates of transport could therefore be assessed over a three second interval. At 22 °C, 10 °C or 6 °C we found that transport 377 378 was saturable by 1 mM unlabelled adenosine, although this never inhibited fully 379 100% of transport (Figures 4 and S3), reflecting the low affinity of this transporter for the substrate. At 6 °C the rate of uptake of 25  $\mu$ M/<sup>3</sup>H]-adenosine was 0.041  $\pm$  0.004 380 pmol  $(10^7 \text{ cells})^{-1}$ . The mean K<sub>m</sub> value under these conditions was  $197 \pm 20 \mu M$ , with 381 a  $V_{\text{max}}$  of 0.19  $\pm$  0.03 pmol(10<sup>7</sup> cells)<sup>-1</sup>s<sup>-1</sup> (n=3; Figure 4). This transporter was not 382 sensitive to the nucleoside transport inhibitor dipyridamole at concentrations up to 25 383 µM (data not shown). We have designated this activity the P. falciparum Low 384 385 Affinity Adenosine Transporter (PfLAAT).

These observations are entirely consistent with the only other characterisation of adenosine transport in *P. falciparum* trophozoites, by Downie et al. [11]. They reported a low affinity adenosine transporter that mediated uptake of adenosine, inosine and thymidine very quickly, equilibrating within seconds, and insensitive to dipyridamole.

# 392 Disruption of the *PfNT1* gene.

In order to gain insight into the possible role of PfNT1 in purine salvage, a parasite 393 394 line with a disrupted locus was generated. Single crossover homologous 395 recombination at the PfNTI locus was expected to generate a pseudodiploid 396 configuration, with both truncated copies lacking some of the transmembrane domains 397 of the protein predicted to be essential for the function of the protein (Supplementary 398 data; Figure S4). As the parasite is haploid and *PfNT1* is a single copy gene, only one 399 round of drug selection is necessary to obtain a null-mutant. Four parasite clones, 400 denoted B11, D6, B7 and B9, were obtained, and successful disruption of the *PfNT1* 401 gene was verified in each clone by PCR and by Southern blot (Figures S5 and S6, supplementary data). The mutant *PfNT1* clones were designated  $\Delta pfnt1^{GU}$ , in order to 402 distinguish them from the independently derived *Apfnt1* clone of El Bissati et al. [17]. 403

# 405 Purine transport in the $\Delta pfnt1^{GU}$ clone.

We next determined the purine uptake profile in  $\Delta pfnt1^{GU}$  clone D6, using as controls untransformed parasites (wild-type) that had undergone the same procedures. The transport assays were performed simultaneously on both clones, to assess which, if any, of the above identified purine transport activities was affected in the parasites with the disrupted gene. Uptake of 25  $\mu$ M [<sup>3</sup>H]-adenosine at 6 °C was not affected by the disruption of *PfNT1*, and identical rates of uptake were measured in the two lines:

412  $0.069 \pm 0.05$  and  $0.070 \pm 0.07$  pmol(10<sup>7</sup> cells)<sup>-1</sup>s<sup>-1</sup> for  $\Delta pfntI^{GU}$  and control, 413 respectively (Figure 5A).

In contrast, in several experiments uptake of 0.25  $\mu$ M [<sup>3</sup>H]-adenosine was 414 reduced by 97 – 100% in  $\Delta p fnt I^{GU}$  (n = 3; Figure 5B), clearly indicating the loss of 415 high-affinity transport in the mutant line. Similarly, uptake of 0.4  $\mu$ M [<sup>3</sup>H]-416 417 hypoxanthine over 120 s was reduced by 82 - 98% (n = 3; Figure 5C). The small 418 residual hypoxanthine transport leads us to speculate that a low-affinity hypoxanthine 419 activity might also be expressed in *P. falciparum*. This would be consistent with the 420 observation of El Bissati et al. [17] that *Apfnt1 P. falciparum* are able to grow in the 421 presence of high concentrations of hypoxanthine but not in low concentrations.

422 Transport rates of 1  $\mu$ M [<sup>3</sup>H]-adenine were not affected in the  $\Delta PfNT1$ 423 parasites: the initial rates of transport over 12 s were not significantly different in the  $\Delta pfntI^{GU}$  line and control cells (n = 3; Paired t-test, P>0.05) (Figure 5D and inset). 424 However, in three independent experiments the maximum level of [<sup>3</sup>H]-adenine 425 transport in the  $\Delta p fnt I^{GU}$  line was double that of the control (0.16 ± 0.06 vs 0.077 ± 426  $0.022 \text{ pmol}(10^7 \text{ cells})^{-1}\text{s}^{-1}$ ; n=3, non-linear regression). Rather than upregulation of the 427 428 transporter we believe this may reflect an increased rate of adenine metabolism in the 429 absence of a source for hypoxanthine.

430 The clear conclusion from these results is that *PfNT1* encodes the high affinity 431 hypoxanthine/adenosine transporter. This conclusion is somewhat at odds with the 432 reports of PfNT1 as a relatively low affinity transporter when expressed in Xenopus laevis oocytes [8,9,11]. However, these previous reports differ substantially from each 433 434 other, producing adenosine  $K_m$  values of 320  $\mu$ M, 13.2  $\mu$ M and 1.86 mM, 435 respectively. It may be that the *Xenopus* expression system produces ambiguous 436 results when expressing some *Plasmodium* transporters, possibly as a result of the 437 extremely high A+T content of the P. falciparum genome [41]; PfNT1 is 72% A+T. 438 This would also explain the reported difficulties of expressing other P. falciparum 439 ENT genes in this system [11]. Also, the Carter study used a different parasite clone 440 than the Parker and Downie studies (W2 and 3D7, respectively), which had a single 441 amino acid difference in their *PfNT1* gene (Leu or Phe, respectively, at position 385). 442 This could perhaps explain some of the discrepancy, especially since the Phe385 443 polymorphism is unusual: in a multiple alignment of 28 protozoan ENT family genes 444 plus the four human ENT sequences, the equivalent amino acid residue was conserved 445 in so far as it was never aromatic, amide, charged, cysteine or proline. However, it is 446 unlikely that the 3D7 clone of *P. falciparum* encodes a partly deficient *PfNT1*, as this 447 clone was also used in the study reported by El Bissati et al that first suggested that 448 PfNT1 is essential for growth on low purine concentrations [17]. We also used the 449 3D7 clone here and verified that its PfNT1 sequence was 100% identical to the entry 450 in PlasmoDB (PF13 0252) and to the sequence reported by Parker et al. [8].

## 452 A new model for purine salvage by *P. falciparum*.

453 Our results, establishing a central role for a high affinity hypoxanthine 454 transporter in the purine salvage of *Plasmodium falciparum*, agree very well with the 455 early studies of purine salvage in other *Plasmodium* species, which describe a 456 transport system for hypoxanthine with secondary capacity for purine nucleosides and 457 a separate uptake system for adenine [1]. It is also consistent with the current 458 understanding that purine nucleotide synthesis in *Plasmodium* spp. is overwhelmingly 459 through phosphoribosylation of nucleobases, particularly hypoxanthine, rather than 460 nucleoside kinases [4,5,42] and they do not seem to encode an adenosine kinase in Б

461 their genome [35,36]. Furthermore, it brings purine uptake in *P. falciparum* very close 462 to purine transport activities reported for other protozoa, which typically display K<sub>m</sub> 463 values in the  $0.2 - 5 \mu M$  range for their substrates [1]. Earlier proposals that P. 464 falciparum may rely exclusively on low affinity purine transporters seemed hard to 465 reconcile with a free concentration of purine nucleosides and bases in the infected erythrocyte that is presumably at best in the low micromolar range. Both the hENT1 466 467 nucleoside [43] and hFNT1 nucleobase [27] transporters of human erythrocytes are 468 equilibrative, making it impossible for the free concentrations of substrates to exceed 469 those in plasma. Nor is it likely that purine concentrations are much higher at the parasite plasma membrane, as the parasitophorous vacuole membrane is freely 470 471 permeable to such low molecular weight solutes [30].

472 However, at adenosine concentrations that saturate the high affinity PfNT1 transporter, a very rapid and saturable nucleoside transport activity, PfLAAT, was 473 observed. Our transport experiments with  $\Delta P fnt I^{GU}$  prove that this is indeed a 474 475 separate transporter from PfNT1. We conclude that P. falciparum trophozoites 476 express both a high affinity purine nucleobase/nucleoside transporter and a low 477 affinity/high capacity adenosine transporter in addition to a saturable transport system for  $[^{3}H]$ -adenine. The K<sub>m</sub> value of ~200  $\mu$ M for PfLAAT rules out the possibility that 478 479 it might be identical to the high affinity adenine transporter PfADET1 (K<sub>i</sub>(adenosine) 480  $= 2.0 \mu$ M) and equally appears to rule out that it is identical to the low affinity adenine 481 transport activity PfADET2 that is almost insensitive to adenosine. However, this 482 awaits formal proof, consisting of experiments with genetic deletion lines of the genes 483 encoding these purine transporters – which are in progress.

484 Thus a model arises (depicted in Figure 6) that closely mirrors the model for purine transport in the only other apicomplexan parasite for which purine transport 485 486 has been studied in detail. Toxoplasma gondii is known to express a low affinity 487 adenosine transporter TgAT1, with a  $K_m$  value of ~110  $\mu$ M [13,44,45], as well as a high affinity transporter TgAT2 (Km is 0.49 µM for adenosine and 0.77 µM for 488 489 inosine) [13]. The main difference between purine salvage in the two apicomplexan 490 species is that, unlike P. falciparum, T. gondii expresses separate high affinity 491 transporters for purine nucleosides (TgAT2) and oxopurine nucleobases (TgNBT1). 492 Like PfNT1, TgNBT1 does not transport adenine [13].

Inset: conversion to a Michaelis-Menten plot. Error bars are 699 SEM; where not shown fall within the symbol.
