# Multidegree for bifiltered $D$-modules

#### Abstract

In commutative algebra, E. Miller and B. Sturmfels defined the notion of multidegree for multigraded modules over a multigraded polynomial ring. We apply this theory to bifiltered modules over the Weyl algebra $D$. The bifiltration is a combination of the standard filtration by the order of differential operators and of the so-called $V$-filtration along a coordinate subvariety of the ambient space defined by M. Kashiwara. The multidegree we define provides a new invariant for $D$-modules. We investigate its relation with the $L$-characteristic cycles considered by Y. Laurent. We give examples from the theory of $A$-hypergeometric systems $M_{A}(\beta)$ defined by I. M. Gelfand, M. M. Kapranov and A. V. Zelevinsky. We consider the $V$-filtration along the origin. When the toric projective variety defined from the matrix $A$ is Cohen-Macaulay, we have an explicit formula for the multidegree of $M_{A}(\beta)$.


## Introduction

We consider finite type modules over the Weyl algebra

$$
D=\mathbb{C}\left[x_{1}, \ldots, x_{n}\right]\left\langle\partial_{1}, \ldots, \partial_{n}\right\rangle
$$

It is classical to endow $D$ with the filtration by the order in $\partial_{1}, \ldots, \partial_{n}$, which we call the $F$-filration, and to endow a $D$-module $M$ with a good $F$-filtration. For instance that leads to the notion of the characteristic variety, which is the support of $\mathrm{gr}^{F}(M)$, and to the characteristic cycle. M. Kashiwara introduced another kind of filtration, the $V$-filtration along a smooth subvariety $Y$ of $\mathbb{C}^{n}$. Then one has the notion of a good ( $F, V$ )-bifiltration (c.f. [12]), and we can also consider intermediate filtrations $L$ between $F$ and $V$ as developed by Y. Laurent in his theory of slopes (c.f. [11]). This leads to $L$-characteristic varieties (the support of $\left.\mathrm{gr}^{L}(M)\right)$ and $L$-characteristic cycles.

Exploring that theory with homological methods, M. Granger, T. Oaku and N . Takayama considered $(F, V)$-bifiltered free resolutions of finite type $D$ modules in [8], [15]. More precisely, dealing with local analytic $D$-modules, they can define minimal bifiltered free resolutions. That provides invariants attached to a bifiltered module: the ranks, also called Betti numbers, and the shifts appearing in the minimal resolution. In the category of modules over the global

Weyl algebra, $(F, V)$-bifiltered free resolutions still can be considered, but the minimality no longer makes sense.

Our main purpose in this paper is to introduce a new invariant, the multidegree, derived from the Betti numbers and shifts arising from any bifiltered free resolution of a $(F, V)$-bifiltered $D$-module. It will be independent of the good bifiltration, i.e. a chosen presentation of the module. We will relate this invariant to the $L$-characteristic cycles.

To achieve this, we use the theory of $K$-polynomial and multidegree, as was developed by E. Miller and B. Sturmfels in [13]. The multidegree is a generalization of the usual degree in projective geometry; it is defined for finite type multigraded modules over a polynomial ring. After reviewing this theory in Section 1, we adapt it first to $F$-filtered $D$-modules in Section 2. We obtain the notion of multidegree for a $F$-filtered $D$-module, which is independent of the good filtration. This multidegree is a monomial $m T^{d}$ with $m \in \mathbb{N}$; we interpret $m$ and $d$ as a generic multiplicity and a generic codimension respectively.

Then we adapt the theory of multidegree to $(F, V)$-bifiltered $D$-modules in section 3. The multidegree is an element of $\mathbb{Z}\left[T_{1}, T_{2}\right]$, denoted by $\mathcal{C}_{F, V}\left(M ; T_{1}, T_{2}\right)$, homogeneous in $T_{1}, T_{2}$. Its degree $d$ has to be fixed because of the non-positivity of the multigrading considered: if $Y$ is the origin in $\mathbb{C}^{n}, d$ is the codimension of the $V$-homogenization module $\mathbf{R}_{V}(M)$. Using a proof in [12], we can show that $\mathcal{C}_{F, V}\left(M ; T_{1}, T_{2}\right)$ is an invariant attached to the module, indepedently of the good bifiltration.

In section 4 , we assume a strong regularity condition on the $(F, V)$-bifiltered module, which we call a nicely bifiltered module. We prove that in the holonomic case, this condition implies that the module has no slopes along $Y$. Then we show that the multidegree of such a module almost only depends on the $L$ characteristic cycle of the module, with $L$ an intermediate filtration close to $F$ or close to $V$. Let us note here that we have to deal with some codimensions which may alter the link between mutidegree and $L$-characteristic cycle: the codimension of the module $\mathbf{R}_{V}(M)$ may not be equal to that of $\mathrm{gr}^{L}(M)$.

Finally, we use the theory of hypergeometric systems to provide interesting examples in section 5 . We consider the hypergeometric module $M_{A}(\beta)$ introduced by I. M. Gelfand, M. M. Kapranov and A. V. Zelevinsky in [5], in the case where the semigroup generated by the columns $a_{1}, \ldots, a_{n}$ of the matrix $A$ is pointed. We take $Y$ to be the origin in $\mathbb{C}^{n}$. In that case the problems about codimensions described above does not remain, and the multidegree only depends on the $L$-characteristic cycle if $M_{A}(\beta)$ is nicely bifiltered. Let $\operatorname{vol}(A)$ denotes the normalized volume of the convex hull of the set $\left\{0, a_{1}, \ldots, a_{n}\right\}$ in $\mathbb{R}^{d}$. Let us assume that the closure in $\mathbb{P}^{n}$ of the variety defined by $I_{A}$ is Cohen-Macaulay. Then for generic parameters $\beta$ (or for all parameters if $I_{A}$ is homogeneous), niceness holds and we have:

$$
\mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)=\operatorname{vol}(A) \cdot \sum_{j=d}^{n}\binom{n-d}{j-d} T_{1}^{j} T_{2}^{n-j} .
$$

We give examples, computed with the computer algebra systems Singular [10] and Macaulay2 [9].

## 1 Multidegree for modules over a commutative polynomial ring

### 1.1 Review of the theory

Let us give a review of the theory of $K$-polynomials and multidegrees in the commutative setting. Let $S=k\left[x_{1}, \ldots, x_{n}\right]$ with $k$ a field. A multigrading on $S$ is given by a homomorphism of abelian groups deg : $\mathbb{Z}^{n} \rightarrow \mathbb{Z}^{d}$ with, denoting by $e_{1}, \ldots, e_{n}$ the canonical base of $\mathbb{Z}^{n}, \operatorname{deg}\left(e_{i}\right)=a_{i} \in \mathbb{Z}^{d}$. Identifying the set of monomials of $S$ with $\mathbb{N}^{n}$, we have $\operatorname{deg}\left(x_{1}^{\alpha_{1}} \ldots x_{n}^{\alpha_{n}}\right)=\sum \alpha_{i} a_{i}$, and $S$ becomes a multigraded ring over $\mathbb{Z}^{d}$.

Let $M=\bigoplus_{a \in \mathbb{Z}^{d}} M_{a}$ be a multigraded $S$-module of finite type. For $b \in \mathbb{Z}^{d}$, let us denote by $S[b]$ the module $S$ endowed with the multigrading such that for any $a \in \mathbb{Z}^{d}, S[b]_{a}=S_{a-b}$. A multigraded free module is a module isomorphic to $\bigoplus_{j=1}^{r} S\left[b_{j}\right]$, with $b_{1}, \ldots, b_{r} \in \mathbb{Z}^{d}$.

Take a multigraded free resolution, i.e. a multigraded exact sequence

$$
0 \rightarrow \mathcal{L}_{\delta} \rightarrow \cdots \rightarrow \mathcal{L}_{1} \rightarrow \mathcal{L}_{0} \rightarrow M \rightarrow 0
$$

with $\mathcal{L}_{i}$ a multigraded free module.
Definition 1.1. For $b=\left(b_{1}, \ldots, b_{d}\right) \in \mathbb{Z}^{d}$, the $K$-polynomial of $S[b]$ is defined by

$$
K\left(S[b] ; T_{1}, \ldots, T_{d}\right)=T_{1}^{b_{1}} \ldots T_{d}^{b_{d}} \in \mathbb{Z}\left[T_{1}, \ldots, T_{d}, T_{1}^{-1}, \ldots, T_{d}^{-1}\right]
$$

For $b_{1}, \ldots, b_{r} \in \mathbb{Z}^{d}$, The $K$-polynomial of $\mathcal{L}=\bigoplus_{j=1}^{r} S\left[b_{j}\right]$ is defined by

$$
K\left(\mathcal{L} ; T_{1}, \ldots, T_{d}\right)=\sum_{j} K\left(S\left[b_{j}\right] ; T_{1}, \ldots, T_{d}\right) \in \mathbb{Z}\left[T_{1}, \ldots, T_{d}, T_{1}^{-1}, \ldots, T_{d}^{-1}\right]
$$

Then the K-polynomial of $M$ is defined by

$$
K(M ; T)=\sum_{i}(-1)^{i} K\left(\mathcal{L}_{i} ; T_{1}, \ldots, T_{d}\right) \in \mathbb{Z}\left[T_{1}, \ldots, T_{d}, T_{1}^{-1}, \ldots, T_{d}^{-1}\right]
$$

Proposition 1.1 ([13], Theorem 8.34). The definition of $K\left(M ; T_{1}, \ldots, T_{d}\right)$ does not depend on the multigraded free resolution.

If we substitute $T_{1}, \ldots, T_{d}$ by $1-T_{1}, \ldots, 1-T_{d}$ in $K\left(M ; T_{1}, \ldots, T_{d}\right)$, we get a well-defined power series in $\mathbb{Z}\left[\left[T_{1}, \ldots, T_{d}\right]\right]$. We then consider the total degree in $T_{1}, \ldots, T_{d}$.

Definition 1.2. We denote by $\mathcal{C}\left(M ; T_{1}, \ldots, T_{d}\right) \in \mathbb{Z}\left[T_{1}, \ldots, T_{d}\right]$ the sum of the terms whose total degree equals $\operatorname{codim} M$ in $K\left(M ; 1-T_{1}, \ldots, 1-T_{d}\right)$. This is called the multidegree of $M$.

Remind that the module $M$ defines an algebraic cycle $\sum m_{i} Z_{i}$, where $Z_{i}$, defined by ideals $\mathfrak{p}_{i}$, are the irreducible components of $\operatorname{rad}(\operatorname{ann} M)$ and $m_{i}$ is the multiplicity of $M_{\mathfrak{p}_{i}}$. It turns out that the multidegree depends only on the algebraic cycle.

Proposition 1.2 ([13], Theorem 8.53). If $\mathfrak{p}_{1}, \ldots, \mathfrak{p}_{k}$ are the maximal dimensional associated primes of $M$, then

$$
\mathcal{C}\left(M ; T_{1}, \ldots, T_{d}\right)=\sum_{i}\left(\operatorname{mult}_{\mathfrak{p}_{i}} M\right) \mathcal{C}\left(S / \mathfrak{p}_{k} ; T_{1}, \ldots, T_{d}\right)
$$

$S$ is said to be positively multigraded if moreover for any $b \in \mathbb{Z}^{d}$, we have $\operatorname{dim}_{k} S_{b}<\infty$. In that case we can consider the Hilbert series

$$
H\left(M ; T_{1}, \ldots, T_{d}\right)=\sum_{b \in \mathbb{Z}^{d}}\left(\operatorname{dim}_{k} M_{b}\right) T_{1}^{b_{1}} \ldots T_{d}^{b_{d}} \in \mathbb{Z}\left[\left[T_{1}, \ldots, T_{d}\right]\right]
$$

If $b=\left(b_{1}, \ldots, b_{d}\right) \in \mathbb{Z}^{d}$, let us denote by $T^{b}$ the product $T_{1}^{b_{1}} \ldots T_{d}^{b_{d}}$.
Proposition 1.3. Let $S$ be positively multigraded. Then
1.

$$
H\left(M ; T_{1}, \ldots, T_{d}\right)=\frac{K\left(M ; T_{1}, \ldots, T_{d}\right)}{\Pi\left(1-T^{a_{i}}\right)}
$$

2. If $M \neq 0$, then $\mathcal{C}\left(M ; T_{1}, \ldots, T_{d}\right) \neq 0$, moreover $\mathcal{C}\left(M ; T_{1}, \ldots, T_{d}\right)$ is the sum of the non-zero terms of least total degree in $K\left(M ; 1-T_{1}, \ldots, 1-T_{d}\right)$.

The assertion 1 is [13], Theorem 8.20, and the assertion 2 follows from [13], Claim 8.54 and Exercise 8.10.

### 1.2 Genericity

Let $S=k\left[\lambda_{1}, \ldots, \lambda_{p}\right]\left[x_{1}, \ldots, x_{n}\right]$ be multigraded by $\operatorname{deg} x_{i}=a_{i} \in \mathbb{Z}^{d}$ and $\operatorname{deg} \lambda_{i}=0$. We consider $\lambda_{1}, \ldots, \lambda_{p}$ as parameters and study the behaviour of the $K$-polynomial under the specialization.

Let $\mathbb{K}=\operatorname{Frac}\left(k\left[\lambda_{1}, \ldots, \lambda_{p}\right]\right)$. Let $M=S^{r} / N$ be a multigraded finite type $S$-module. For $c \in k^{p}$, let

$$
M^{c}=\frac{S}{\left\langle\lambda_{1}-c_{1}, \ldots, \lambda_{p}-c_{p}\right\rangle} \otimes M
$$

considered as a multigraded $k\left[x_{1}, \ldots, x_{n}\right]$-module. We are going to state that if $c$ is generic, then $K(\mathbb{K} \otimes M ; T)=K\left(M^{c} ; T\right)$. More precisely, we shall describe the exceptional values of $c$ in terms of Gröbner bases.

Let $<$ be a well-ordering on $\mathbb{N}^{n} \times\{1, \ldots, r\}$, such that for any $\alpha, \beta, \delta \in \mathbb{N}^{n}$ and $i, i^{\prime} \in\{1, \ldots, r\}$, we have

$$
(\alpha, i)<\left(\beta, i^{\prime}\right) \Rightarrow(\alpha+\delta, i)<\left(\beta+\delta, i^{\prime}\right)
$$

and let $<^{\prime}$ be the well-ordering on $\mathbb{N}^{p} \times \mathbb{N}^{n} \times\{1, \ldots, r\}$ defined by

$$
(\alpha, \beta, i)<^{\prime}\left(\alpha^{\prime}, \beta^{\prime}, i^{\prime}\right) \text { iff }\left\{\begin{array}{l}
(\beta, i)<\left(\beta^{\prime}, i^{\prime}\right) \\
\text { or }\left((\beta, i)=\left(\beta^{\prime}, i^{\prime}\right) \text { and } \alpha<_{\operatorname{lex}} \alpha^{\prime}\right)
\end{array}\right.
$$

Let $P_{1}, \ldots, P_{s}$ be a Gröbner base of $N$. For $1 \leq i \leq s, q_{i}(\lambda) \in k[\lambda]$ denotes the leading coefficient, with respect to $<$, of the image of $P_{i}$ in $\mathbb{K} \otimes S$. For $P \in k[x]^{r}$ or $P \in \mathbb{K}[x]^{r}$, we denote by $\operatorname{Exp}_{<} P \in \mathbb{N}^{n} \times\{1, \ldots, r\}$ the leading exponent of $P$ with respect to $<$.

Proposition 1.4 ([14], Propositions 6 and 7). 1. $P_{1}, \ldots, P_{s}$ is a Gröbner base of $\mathbb{K} \otimes N$.
2. Let $c \in k^{n}$ such that $c \notin \bigcup_{i}\left(q_{i}=0\right)$. Then $P_{1}(c), \ldots, P_{s}(c)$ is a Gröbner base of $N^{c}$ and $\operatorname{Exp}_{<} \mathbb{K} \otimes N=\operatorname{Exp}_{<} N^{c}$.

Proposition 1.5. Let $c \in k^{n}$ such that $c \notin \bigcup_{i}\left(q_{i}=0\right)$. Then $K(\mathbb{K} \otimes M ; T)=$ $K\left(M^{c} ; T\right)$. Consequently $\mathcal{C}(\mathbb{K} \otimes M ; T)=\mathcal{C}\left(M^{c} ; T\right)$.

This follows from Proposition 1.4 and from [13], Theorem 8.36 which asserts that the $K$-polynomial remains the same when taking the initial module with respect to any well-ordering.

## 2 Multidegree for $F$-filtered $D$-modules

Let $D=\mathbb{C}\left[x_{1}, \ldots, x_{n}\right]\left\langle\partial_{1}, \ldots, \partial_{n}\right\rangle$ be the Weyl algebra. A vector $(\mathbf{u}, \mathbf{v}) \in$ $\mathbb{Z}^{n} \times \mathbb{Z}^{n}$ is called an admissible weight vector for $D$ if for all $i, u_{i}+v_{i} \geq 0$. For $P=\sum a_{\alpha, \beta}(x) x^{\alpha} \partial^{\beta} \in D$, we define

$$
\operatorname{ord}^{(\mathbf{u}, \mathbf{v})}(P)=\max _{(\alpha, \beta) \mid a_{\alpha, \beta} \neq 0}\left(\sum u_{i} \alpha_{i}+\sum v_{i} \beta_{i}\right)
$$

We then define an increasing filtration by $F_{d}^{(\mathbf{u}, \mathbf{v})}(D)=\left\{P \in D, \operatorname{ord}^{F}(P) \leq d\right\}$ with $d \in \mathbb{Z}$.

In this section we consider only the weight vector $(\mathbf{0}, \mathbf{1})$; we will simply denote the associated filtration by $\left(F_{d}(D)\right)_{d \in \mathbb{N}}$, called the $F$-filtration. We have $\operatorname{gr}^{F}(D) \simeq \mathbb{C}\left[x_{1}, \ldots, x_{n}, \xi_{1}, \ldots, \xi_{n}\right]$.

Let $M$ be a $D$-module. An $F$-filtration of $M$ is an exhausting increasing filtration $\left(F_{d}(M)\right)_{d \in \mathbb{N}}$ compatible with the $F$-filtration of $D$. For $\mathbf{n}=$ $\left(n_{1}, \ldots, n_{r}\right) \in \mathbb{Z}^{r}$, let us denote by $D^{r}[\mathbf{n}]$ the module $D^{r}$ endowed with the $F$-filtration such that $F_{d}\left(D^{r}[\mathbf{n}]\right)=\bigoplus_{i=1}^{r} F_{d-n_{i}}(D)$. If $N$ is a submodule of $D^{r}$, we endow $D^{r}[\mathbf{n}] / N$ with the quotient filtration, i.e.

$$
F_{d}\left(\frac{D^{r}[\mathbf{n}]}{N}\right)=\frac{F_{d}\left(D^{r}[\mathbf{n}]\right)+N}{N} .
$$

We say that a filtration $F_{d}(M)$ is good if $M$ is isomorphic as an $F$-filtered $D$-module to a module of the type $D^{r}[\mathbf{n}] / N$.

Let us take a filtered free resolution

$$
0 \rightarrow D^{r_{\delta}}\left[\mathbf{n}^{(\delta)}\right] \rightarrow \cdots \rightarrow D^{r_{1}}\left[\mathbf{n}^{(1)}\right] \rightarrow D^{r_{0}}\left[\mathbf{n}^{(0)}\right] \rightarrow M \rightarrow 0
$$

Its existence can be proved in the same way as [8], Theorem 3.4, forgetting the minimality.

Definition 2.1. The $K$-polynomial of $D^{r}[\mathbf{n}]$ is defined by

$$
K_{F}\left(D^{r}[\mathbf{n}] ; T\right)=\sum_{i} T^{\mathbf{n}_{i}} \in \mathbb{Z}[T] .
$$

The K-polynomial of $M$ is defined by

$$
K_{F}(M ; T)=\sum_{i}(-1)^{i} K_{F}\left(D^{r_{i}}\left[\mathbf{n}^{(i)}\right] ; T\right) \in \mathbb{Z}[T] .
$$

Proposition 2.1. The definition of $K_{F}(M ; T)$ does not depend on the filtered free resolution.

Proof. Let $R=\operatorname{gr}^{F}(D)$, and for $\mathbf{n}=\left(n_{1}, \ldots, n_{r}\right), R^{r}[\mathbf{n}]=\oplus_{i=1}^{r} R\left[n_{i}\right]$. By grading the filtered free resolution we get a graded free resolution over the commutative ring $R$ :

$$
0 \rightarrow R^{r_{\delta}}\left[\mathbf{n}^{(\delta)}\right] \rightarrow \cdots \rightarrow R^{r_{1}}\left[\mathbf{n}^{(1)}\right] \rightarrow R^{r_{0}}\left[\mathbf{n}^{(0)}\right] \rightarrow \operatorname{gr}^{F}(M) \rightarrow 0
$$

The $K$-polynomial is unchanged. Then apply Proposition 1.1.
Definition 2.2. We denote by $\mathcal{C}_{F}(M ; T)$ the term of least degree in $T$ in $K_{F}(M ; 1-T)$. This is the multidegree of $M$ with respect to $F$.

Proposition 2.2. $\mathcal{C}_{F}(M ; T)$ does not depend on the good filtration.
Proof. Again we argue by grading. We have $\mathcal{C}_{F}(M ; T)=\mathcal{C}\left(\mathrm{gr}^{F}(M) ; T\right)$. Let $\mathbb{K}=\operatorname{Frac}(\mathbb{C}[x])$. We have $\mathcal{C}\left(\operatorname{gr}^{F}(M) ; T\right)=\mathcal{C}\left(\mathbb{K} \otimes \operatorname{gr}^{F}(M) ; T\right)$. The graded ring $\mathbb{K} \otimes \operatorname{gr}^{F}(D)$ is a positively graded ring. Hence the $K$-polynomial is equal to the numerator of the Hilbert series, by Proposition 1.3. The multidegree is of the form $m T^{d}$ with $d=\operatorname{codim} \mathbb{K} \otimes \operatorname{gr}^{F}(M)$ (unless it is 0 ), and $m$ is the multiplicity of $\mathbb{K} \otimes \operatorname{gr}^{F}(M)$ along the maximal ideal $\xi_{1}, \ldots, \xi_{n}$. We can show that this data is independent of the good filtration in the same way as [7], Remark 12 and Proposition 25.

Let us give some interpretation. We have $\mathcal{C}_{F}(M ; T)=m T^{d}$. For $x_{0} \in \mathbb{C}^{n}$, the graded $\mathbb{C}[\xi]$-module $\left(\operatorname{gr}^{F}(M)\right)^{x_{0}}$ is defined as in the section 1.2.

Proposition 2.3. 1. $m$ and $d$ are equal respectively to the multiplicity and the codimension of the graded $\mathbb{C}[\xi]$-module $\operatorname{gr}^{F}(M)^{x_{0}}$ for $x_{0}$ generic. Let us denote by $\pi: T^{*} \mathbb{C}^{n} \rightarrow \mathbb{C}^{n}$ the canonical projection. $d$ is equal to the codimension of the variety char $M \cap \pi^{-1}\left(x_{0}\right)$ for $x_{0}$ generic.
2. If moreover $M$ is holonomic, then $m=\operatorname{rank} M=\operatorname{dim}_{\mathbb{K}} \mathbb{K} \otimes \operatorname{gr}^{F}(M)$.

Proof. 1. This is Proposition 1.5.
2. In the holonomic case, $\mathbb{K} \otimes \operatorname{gr}^{F}(M)$ is finite dimensional over $\mathbb{K}$, and we have

$$
\operatorname{dim}_{\mathbb{K}} \mathbb{K} \otimes \operatorname{gr}^{F}(M)=H\left(\mathbb{K} \otimes \operatorname{gr}^{F}(M) ; T\right)_{\mid T=1}
$$

The result follows, by using Proposition 1.3.

## 3 Multidegree for ( $F, V$ )-bifiltered $D$-modules

Now set $D=\mathbb{C}\left[x_{1}, \ldots, x_{n}, t_{1}, \ldots, t_{p}\right]\left\langle\partial_{x_{1}}, \ldots, \partial_{x_{n}}, \partial_{t_{1}}, \ldots, \partial_{t_{p}}\right\rangle$. We still endow it with the $F$-filtration. We introduce the $V$-filtration along $t_{1}=\cdots=t_{p}=0$. This is the filtration defined by assigning the weight vector $(\mathbf{0},-\mathbf{1}, \mathbf{0}, \mathbf{1})$ to the set of variables $\left(x, t, \partial_{x}, \partial_{t}\right)$. We denote this filtration by $\left(V_{k}(D)\right)_{k \in \mathbb{Z}}$.

Then we have the $(F, V)$-bifiltration on $D$ defined by $F_{d, k}(D)=F_{d}(D) \cap$ $V_{k}(D)$ for $d, k \in \mathbb{Z}$. For $\mathbf{n}, \mathbf{m} \in \mathbb{Z}^{r}$, let us denote by $D^{r}[\mathbf{n}][\mathbf{m}]$ the module $D^{r}$ endowed with the bifiltration such that

$$
F_{d, k}\left(D^{r}[\mathbf{n}][\mathbf{m}]\right)=\bigoplus_{i=1}^{r} F_{d-n_{i}, k-m_{i}}(D)
$$

A quotient $D^{r}[\mathbf{n}][\mathbf{m}] / N$ is endowed with the bifiltration $F_{d, k}\left(D^{r}[\mathbf{n}][\mathbf{m}] / N\right)=$ $\left(F_{d, k}\left(D^{r}[\mathbf{n}][\mathbf{m}]\right)+N\right) / N$.

Let $M$ be a $D$-module. A good bifiltration $\left(F_{d, k}(M)\right)_{d \in \mathbb{N}, k \in \mathbb{Z}}$ is an exhaustive increasing bifiltration, compatible with the bifiltration $\left(F_{d, k}(D)\right)$, such that $M$ is isomorphic as a bifiltered module to a module of the type $D^{r}[\mathbf{n}][\mathbf{m}] / N$.

Proposition 3.1. $M$ admits a bifiltered free resolution, i.e. a bifiltered exact sequence

$$
0 \rightarrow D^{r_{\delta}}\left[\mathbf{n}^{(\delta)}\right]\left[\mathbf{m}^{(\delta)}\right] \rightarrow \cdots \rightarrow D^{r_{1}}\left[\mathbf{n}^{(1)}\right]\left[\mathbf{m}^{(1)}\right] \rightarrow D^{r_{0}}\left[\mathbf{n}^{(0)}\right]\left[\mathbf{m}^{(0)}\right] \rightarrow M \rightarrow 0 .
$$

We shall prove this proposition in a constructive way. For this purpose, let us introduce some Rees algebras. First, we have the Rees algebra with respect to the $F$-filtration (c.f. [3]):

$$
\mathcal{R}_{F}(D)=\bigoplus_{d} F_{d}(D) \tau^{d}
$$

This is endowed with the $V$-filtration :

$$
V_{k}\left(\mathcal{R}_{F}(D)\right)=\bigoplus_{k \in \mathcal{Z}} F_{d, k}(\mathcal{D}) \tau^{d} \text { for } d \in \mathbb{N}
$$

$\mathcal{R}_{F}(D)$ is isomorphic to the $\mathbb{C}$-algebra generated by $x_{i}, t_{i},\left(\partial_{x_{i}} \tau\right),\left(\partial_{t_{i}} \tau\right), \tau$, subject to the relations $\left[\partial_{x_{i}} \tau, x_{i}\right]=\tau$ and $\left[\partial_{t_{i}} \tau, t_{i}\right]=\tau$, the commutators involving other pairs of generators being zero. This is a noetherian algebra. We will replace respectively the generators $x_{i}, t_{i}, \partial_{x_{i}} \tau, \partial_{t_{i}} \tau, \tau$ by $x_{i}, t_{i}, \partial_{x_{i}}, \partial_{t_{i}}, h$, thus we identify $\mathcal{R}_{F}(D)$ with the $\mathbb{C}$-algebra, denoted $D^{(h)}$, generated by $x_{i}, t_{i}$, $\partial_{x_{i}}, \partial_{t_{i}}, h$, subject to the relations

$$
\left[\partial_{x_{i}}, x_{i}\right]=h \quad \text { and } \quad\left[\partial_{t_{i}}, t_{i}\right]=h
$$

An admissible weight vector for $D^{(h)}$ is a vector $(\mathbf{u}, \mathbf{v}, l) \in \mathbb{Z}^{n+p} \times \mathbb{Z}^{n+p} \times \mathbb{Z}$ such that for any $i, u_{i}+v_{i} \geq l$. A filtration is associated with such a vector by assigning it to the set of variables $\left(x, t, \partial_{x}, \partial_{t}, h\right)$. The filtration associated with $(\mathbf{u}, \mathbf{v}, l)=(\mathbf{0},-\mathbf{1}, \mathbf{0}, \mathbf{1}, 0)$ gives the $V$-filtration. The bigraded ring $\mathrm{gr}^{V}\left(D^{(h)}\right)$ is isomorphic to $D^{(h)}$ endowed with the following multigrading :

$$
\begin{array}{ll}
\operatorname{deg}\left(x_{i}\right)=(0,0), & \operatorname{deg}\left(t_{i}\right)=(0,-1), \quad \operatorname{deg}(h)=(1,0), \\
\operatorname{deg}\left(\partial_{x_{i}}\right)=(1,0), & \operatorname{deg}\left(\partial_{t_{i}}\right)=(1,1) .
\end{array}
$$

Let us denote $F_{d}(M)=\bigcup_{k} F_{d, k}(M)$. We associate with $M$ a $\mathcal{R}_{F}(D)$-module $\mathcal{R}_{F}(M)=\oplus_{d} F_{d}(M) \tau^{d}$, this is endowed with a $V$-filtration $V_{k}\left(\mathcal{R}_{F}(M)\right)=$ $\oplus_{d} F_{d, k}(M) \tau^{d}$.

Conversely, there exists a dehomogenizing functor $\rho_{F}$ (see [8], where this functor is denoted by $\rho$ ), from the category of $V$-filtered graded $D^{(h)}$-modules to the category of bifiltered $D$-modules. A $D^{(h)}$-module is said to be $h$-saturated if the action of $h$ on this module is injective. [8], Proposition 3.6 states that the functors $\rho_{F}$ and $\mathcal{R}_{F}$ give an equivalence of categories between the category of $h$ saturated $D^{(h)}$-modules with good $V$-filtrations and the category of $D$-modules with good bifiltrations, and that moreover these functors are exact.

We have also the Rees algebra of $D$ with respect to $V$ :

$$
\mathcal{R}_{V}(D)=\bigoplus_{k \in \mathbb{Z}} V_{k}(\mathcal{D}) \theta^{k}
$$

This is endowed with the following filtration :

$$
F_{d}\left(\mathcal{R}_{V}(D)\right)=\bigoplus_{k \in \mathbb{Z}} F_{d, k}(\mathcal{D}) \theta^{k} \text { for } d \in \mathbb{N}
$$

$\mathcal{R}_{V}(D)$ is generated as a $\mathbb{C}$-algebra by $x_{i} \tilde{\sim}^{0}, \partial_{x_{i}} \theta^{0}, t_{i} \theta^{-1}, \partial_{t_{i}} \theta, \theta$. Let us denote respectively those elements by $\tilde{x_{i}}, \tilde{\partial_{x_{i}}}, \tilde{t_{i}}, \tilde{\partial_{t_{i}}}, \theta$. The following lemma is clear.
Lemma 3.1. $\mathcal{R}_{V}(D)$ is isomorphic to the algebra $\mathbb{C}\left[\tilde{x_{i}}, \tilde{t_{i}}, \theta\right]\left\langle\tilde{\partial_{x_{i}}}, \tilde{\partial_{t_{i}}}\right\rangle$ subject to the relations $\left[\tilde{\partial_{x_{i}}}, \tilde{x_{i}}\right]=1$ and $\left[\tilde{\partial_{t}}, \tilde{t_{i}}\right]=1$ for any $i$.
The $F$-filtration is then given by assigning the weight vector $(\mathbf{0}, \mathbf{0}, 0, \mathbf{1}, \mathbf{1})$ to the set of variables $\left(\tilde{x}, \tilde{t}, \theta, \tilde{\partial}_{x}, \tilde{\partial}_{t}\right)$.

Then the bigraded ring $\underset{\sim}{\operatorname{gr}}{ }^{F}\left(\mathcal{R}_{V}(D)\right)$ is isomorphic to the commutative polynomial ring $\mathbb{C}\left[\tilde{x_{i}}, \tilde{t_{i}}, \theta, \tilde{\partial_{x_{i}}}, \tilde{\partial_{t_{i}}}\right]$ endowed with the following multigrading :

$$
\begin{aligned}
& \operatorname{deg}\left(\tilde{x_{i}}\right)=(0,0), \quad \operatorname{deg}\left(\tilde{t_{i}}\right)=(0,-1), \quad \operatorname{deg}(\theta)=(0,1), \\
& \operatorname{deg}\left(\tilde{\partial_{x_{i}}}\right)=(1,0), \quad \operatorname{deg}\left(\tilde{\partial_{i}}\right)=(1,1) .
\end{aligned}
$$

Similarly, we define the Rees module associated with $M$ with respect to $V$ :

$$
\mathcal{R}_{V}(M)=\bigoplus_{k \in \mathbb{Z}} V_{k}(M) \theta^{k}
$$

where $V_{k}(M)=\bigcup_{d} F_{d, k}(M)$. It admits an $F$-filtration

$$
F_{d}\left(\mathcal{R}_{V}(M)\right)=\bigoplus_{k \in \mathbb{Z}} F_{d, k}(M) \theta^{k}
$$

such that $\operatorname{gr}^{F}\left(\mathcal{R}_{V}(M)\right)$ is isomorphic to

$$
\bigoplus_{d, k} \frac{F_{d, k}(M)}{F_{d-1, k}(M)} \theta^{k}
$$

Conversely, as it has been stated before, there exists a dehomogenizing functor $\rho_{V}$, from the category of $F$-filtered graded $\mathcal{R}_{V}(D)$-modules to the category of bifiltered $D$-modules. A $\mathcal{R}_{V}(D)$-module is said to be $\theta$-saturated if the action of $\theta$ on this module is injective. The functors $\rho_{V}$ and $\mathcal{R}_{V}$ give an equivalence of categories between the category of $\theta$-saturated $\mathcal{R}_{V}(D)$-modules with good $F$-filtrations and the category of $D$-modules with good bifiltrations. Moreover these functors are exact.

Proof of Proposition 3.1. $\mathcal{R}_{F}(M)$ is a finite type $D^{(h)}$-module isomorphic as a $V$-filtered graded $D^{(h)}$-module to a quotient of $\left(D^{(h)}\right)^{r}[\mathbf{m}]$. A presentation of $\mathcal{R}_{F}(M)$ can be obtained by means of $F$-adapted Gröbner bases. By replacing $D$ by $D^{(h)}$ in [16], section 3, we can construct a $V$-adapted free resolution of $\mathcal{R}_{F}(M)$. Dehomogenizing this resolution provides a bifiltered free resolution of $M$.

We can use also the $V$-homogenization. Using [16], section 3, we construct a presentation of $\mathcal{R}_{V}(M)$. We take a bigraded free resolution of $\mathrm{gr}^{F} \mathcal{R}_{V}(M)$, which can be lifted to a $F$-adapted resolution of $\mathcal{R}_{V}(M)$, as in [8], Proposition 2.7. Taking $\rho_{V}$ gives a bifiltered free resolution of $M$.

Definition 3.1. The $K$-polynomial of $D^{r}[\mathbf{n}][\mathbf{m}]$ with respect to $(F, V)$ is defined by

$$
K_{F, V}\left(D^{r}[\mathbf{n}][\mathbf{m}] ; T_{1}, T_{2}\right)=\sum_{i} T_{1}^{\mathbf{n}_{i}} T_{2}^{\mathbf{m}_{i}} \in \mathbb{Z}\left[T_{1}, T_{2}, T_{2}^{-1}\right] .
$$

The K-polynomial of $M$ with respect to $(F, V)$ is defined by

$$
K_{F, V}\left(M ; T_{1}, T_{2}\right)=\sum_{i}(-1)^{i} K_{F, V}\left(D^{r_{i}}\left[\mathbf{n}^{(i)}\right]\left[\mathbf{m}^{(i)}\right] ; T_{1}, T_{2}\right) \in \mathbb{Z}\left[T_{1}, T_{2}, T_{2}^{-1}\right]
$$

Proposition 3.2. The definition of $K_{F, V}\left(M ; T_{1}, T_{2}\right)$ does not depend on the bifiltered free resolution.
Proof of Proposition 3.2. A bifiltered free resolution of $M$ induces a bigraded free resolution of $\operatorname{gr}^{F}\left(\mathcal{R}_{V}(M)\right)$. Thus $K_{F, V}\left(M ; T_{1}, T_{2}\right)=K\left(\operatorname{gr}^{F}\left(\mathcal{R}_{V}(D)\right) ; T_{1}, T_{2}\right)$ and we can apply Proposition 1.1.

Let $\mathbb{K}=\operatorname{Frac}\left(\mathbb{C}\left[x_{1}, \ldots, x_{n}\right]\right)$. Instead of $D$, we shall work with $\mathbb{K} \otimes D$. This has no influence on the bifiltration.

Definition 3.2. We denote by $\mathcal{C}_{F, V}\left(M ; T_{1}, T_{2}\right)$ the sum of the terms whose total degree in $T_{1}, T_{2}$ equals codim $\left(K \otimes g r^{F}\left(\mathcal{R}_{V}(M)\right)\right)$ in the expansion of $K_{F, V}(M ; 1-$ $\left.T_{1}, 1-T_{2}\right)$. This is the multidegree of $M$ with respect to $(F, V)$.
Theorem 3.1. $\mathcal{C}_{F, V}\left(M ; T_{1}, T_{2}\right)$ does not depend on the good bifiltration.
Proof. As before we take the Rees algebra with respect to $V$. We get

$$
\mathcal{R}_{V}(\mathbb{K} \otimes D) \simeq \mathbb{K}\left[\tilde{t_{i}}, \theta\right]\left\langle\tilde{\partial_{x_{i}}}, \tilde{\partial_{t_{i}}}\right\rangle
$$

and

$$
A:=\operatorname{gr}^{F}\left(\mathcal{R}_{V}(\mathbb{K} \otimes D)\right) \simeq \mathbb{K}\left[\tilde{t_{i}}, \theta, \tilde{\partial_{x_{i}}}, \tilde{\partial_{t_{i}}}\right]
$$

The ring $A$ is bigraded as follows:

$$
\operatorname{deg}\left(\tilde{t_{i}}\right)=(0,-1), \quad \operatorname{deg}(\theta)=(0,1), \quad \operatorname{deg}\left(\tilde{\partial_{x_{i}}}\right)=(1,0), \quad \operatorname{deg}\left(\tilde{\partial_{t_{i}}}\right)=(1,1)
$$

This is not a positive grading since $\mathbb{K}\left[\left(\tilde{t}_{i} \theta\right)\right]=A_{0,0}$ is infinite over $\mathbb{K}$. Let

$$
\tilde{M}=\mathbb{K} \otimes \operatorname{gr}^{F}\left(\mathcal{R}_{V}(M)\right)
$$

A bifiltered free resolution of $M$ induces a bigraded free resolution of $\tilde{M}$, thus $K_{F, V}\left(M ; T_{1}, T_{2}\right)=K\left(\tilde{M} ; T_{1}, T_{2}\right)$.

Let us endow $M$ with another good bifiltration $\left(F_{d, k}^{\prime}(M)\right)_{d, k}$. We denote by $M^{\prime}$ the module $M$ endowed with this bifiltration. In view of Proposition 1.2, it is sufficient to prove

- $\operatorname{rad}(\operatorname{ann} \tilde{M})=\operatorname{rad}\left(\operatorname{ann} \tilde{M}^{\prime}\right)$
- For any prime ideal $\mathfrak{p}$ of $A, \operatorname{mult}_{\mathfrak{p}} \tilde{M}=\operatorname{mult}_{\mathfrak{p}} \tilde{M^{\prime}}$.

To prove these two assertions, we argue exactly in the same way as in the proof of Proposition 1.3.2 of [12]. For the convenience of the reader, we give here the details.

We shall also use the behaviour of dimensions and multiplicities in short exact sequences.

Lemma 3.2 ([7], Proposition 24). Let

$$
0 \rightarrow E \rightarrow F \rightarrow G \rightarrow 0
$$

be an exact sequence of finite type $A$-modules, and let $\mathfrak{p}$ be a prime ideal of $A$. Then

1. $\operatorname{dim} F_{\mathfrak{p}}=\max \left(\operatorname{dim} E_{\mathfrak{p}}, \operatorname{dim} G_{\mathfrak{p}}\right)$.
2. If $\operatorname{dim} E_{\mathfrak{p}}=\operatorname{dim} G_{\mathfrak{p}}$, then mult $\operatorname{mult}_{\mathfrak{p}} E=\operatorname{mult}_{\mathfrak{p}} G$.

If $\operatorname{dim} E_{\mathfrak{p}}<\operatorname{dim} G_{\mathfrak{p}}$, then mult ${ }_{\mathfrak{p}} F=$ mult $_{\mathfrak{p}} G$.
If $\operatorname{dim} E_{\mathfrak{p}}>\operatorname{dim} G_{\mathfrak{p}}$, then mult ${ }_{\mathfrak{p}} F=$ mult $_{\mathfrak{p}} E$.

We will follow the proof of [12] and indicate at each step how to prove :
Claim 1. $\operatorname{rad}(\operatorname{ann} \tilde{M}) \subset \operatorname{rad}\left(\operatorname{ann} \tilde{M}^{\prime}\right)$,
Claim 2. $\operatorname{mult}_{\mathfrak{p}} \tilde{M} \geq \operatorname{mult}_{\mathfrak{p}} \tilde{M}^{\prime}$ if $\operatorname{dim} \tilde{M}_{\mathfrak{p}}=\operatorname{dim} \tilde{M}^{\prime}{ }_{\mathfrak{p}}$.
First, since $F_{d, k}(M)$ and $F_{d, k}^{\prime}(M)$ are good bifiltrations, there exist $d_{0}, k_{0} \in$ $\mathbb{N}$ such that for any $d, k, F_{d, k}(M) \subset F_{d+d_{0}, k+k_{0}}^{\prime}(M)$. Let us denote by $M^{\prime \prime}$ the module $M$ endowed with the bifiltration $\left(F_{d+d_{0}, k+k_{0}}^{\prime}(M)\right)_{d, k}$. The algebraic cycle associated with $\tilde{M}^{\prime}$ is equal to the algebraic cycle associated with $\tilde{M}^{\prime \prime}$. Thus we can suppose $F_{d, k}^{\prime}(M) \subset F_{d, k}(M)$.

Let us introduce the Rees algebra $\mathcal{R}(D)$ with respect to the bifiltration $F, V$, i.e.

$$
\mathcal{R}(D)=\bigoplus_{d, k} F_{d, k}(D) \tau^{d} \theta^{k}
$$

This is isomorphic to the $\mathbb{C}$-algebra generated by $x_{i}, t_{i} \theta^{-1}, \partial_{x_{i}} \tau, \partial_{t_{i}} \tau \theta, \tau$ and $\theta$, subject to the relations $\left[\partial_{x_{i}} \tau, x_{i}\right]=\tau$ and $\left[\partial_{t_{i}} \tau \theta, t_{i} \theta^{-1}\right]=\tau$. This is a noetherian algebra.

We define also the Rees module $\mathcal{R}(M)=\bigoplus_{d, k} F_{d, k}(M) \tau^{d} \theta^{k}$. We have

$$
\operatorname{gr}^{F}\left(\mathcal{R}_{V}(M)\right) \simeq \frac{\mathcal{R}(M)}{\tau \mathcal{R}(M)} .
$$

Let us suppose moreover that there exists $r \geq 1$ such that for any $d, k$, $F_{d, k}^{\prime}(M) \subset F_{d, k}(M) \subset F_{d+r, k}^{\prime}(M)$. Let $F_{d, k}^{\prime \prime}(M)=F_{d, k}(M) \cap F_{d+1, k}^{\prime}(M)$. We have
$F_{d, k}^{\prime}(M) \subset F_{d, k}^{\prime \prime}(M) \subset F_{d+1, k}^{\prime}(M) \quad$ and $\quad F_{d-r+1, k}(M) \subset F_{d, k}^{\prime \prime}(M) \subset F_{d, k}(M)$.

By induction on $r$ we can suppose $r=1$, i.e. $\tau \mathcal{R}(M) \subset \mathcal{R}\left(M^{\prime}\right) \subset \mathcal{R}(M)$. Then we have the following exact sequences of $\operatorname{gr}^{F} \mathcal{R}_{V}(D)$-modules of finite type:

$$
\begin{aligned}
& 0 \rightarrow \frac{\tau \mathcal{R}(M)}{\tau \mathcal{R}\left(M^{\prime}\right)} \rightarrow \frac{\mathcal{R}\left(M^{\prime}\right)}{\tau \mathcal{R}\left(M^{\prime}\right)} \rightarrow \frac{\mathcal{R}\left(M^{\prime}\right)}{\tau \mathcal{R}(M)} \rightarrow 0 \\
& 0 \rightarrow \frac{\mathcal{R}\left(M^{\prime}\right)}{\tau \mathcal{R}(M)} \rightarrow \frac{\mathcal{R}(M)}{\tau \mathcal{R}(M)} \rightarrow \frac{\mathcal{R}(M)}{\mathcal{R}\left(M^{\prime}\right)} \rightarrow 0
\end{aligned}
$$

After tensorizing by $\mathbb{K}$, we deduce $\underset{\sim}{\operatorname{rad}}(\operatorname{ann} \tilde{M})=\operatorname{rad}\left(\operatorname{ann} \tilde{M}^{\prime}\right)$. Then using Lemma 3.2, we get $\operatorname{mult}_{\mathfrak{p}} \tilde{M}=\operatorname{mult}_{\mathfrak{p}} \tilde{M}^{\prime}$.

Let $F_{d, k}^{\prime \prime}(M)=F_{d, k}(M) \cap\left(\cup_{i} F_{i, k}^{\prime}(M)\right)$. We have :

$$
\mathcal{R}\left(M^{\prime \prime}\right)=\mathcal{R}(M) \cap\left(\cup_{i \geq 0} \tau^{-i} \mathcal{R}\left(M^{\prime}\right)\right) .
$$

Let $\mathcal{L}_{j}=\mathcal{R}(M) \cap\left(\cup_{0 \leq i \leq j} \tau^{-i} \mathcal{R}\left(M^{\prime}\right)\right)$. This is an ascending chain of finite type sub-modules of $\mathcal{R}(M)$. Hence it is stationary and there exists an integer $r \geq 0$ such that

$$
\mathcal{R}\left(M^{\prime \prime}\right)=\mathcal{R}(M) \cap \tau^{-r} \mathcal{R}\left(M^{\prime}\right) .
$$

In particular $\mathcal{R}\left(M^{\prime \prime}\right)$ is of finite type and $F_{d, k}^{\prime \prime}(M)$ is a good bifiltration. We have $\tau^{r} \mathcal{R}\left(M^{\prime \prime}\right) \subset \mathcal{R}\left(M^{\prime}\right) \subset \mathcal{R}\left(M^{\prime \prime}\right)$, i.e. we are in the situation of the previous paragraph. This implies $\operatorname{rad}\left(\operatorname{ann} \tilde{M}^{\prime \prime}\right)=\operatorname{rad}\left(\operatorname{ann} \tilde{M}^{\prime}\right)$ and $\operatorname{mult}_{\mathfrak{p}} \tilde{M}^{\prime \prime}=$ mult $_{\mathfrak{p}} \tilde{M}^{\prime}$.

On the other hand, we have a canonical injection

$$
\frac{\mathcal{R}\left(M^{\prime \prime}\right)}{\tau \mathcal{R}\left(M^{\prime \prime}\right)} \rightarrow \frac{\mathcal{R}(M)}{\tau \mathcal{R}(M)}
$$

Then $\operatorname{rad}\left(\operatorname{ann} \tilde{M}^{\prime \prime}\right) \subset \operatorname{rad}(\operatorname{ann} \tilde{M})$, and Claim 1 is proved. From this canonical injection, we deduce Claim 2 by using Lemma 3.2.

## 4 Nicely bifiltered $D$-modules

In this section we consider a bifiltered $D$-module satisfying the following condition:

Definition 4.1. Let $M$ be a D-module endowed with a good bifiltration. We say that the bifiltration is nice if for any $d, k$,

$$
\begin{equation*}
\left(\bigcup_{d^{\prime}} F_{d^{\prime}, k}(M)\right) \bigcap\left(\bigcup_{k^{\prime}} F_{d, k^{\prime}}(M)\right)=F_{d, k}(M) \tag{1}
\end{equation*}
$$

In such a case, we say that $M$ is nicely bifiltered.
Definition 4.2. Let $N$ be a bigraded $g r^{V}\left(D^{(h)}\right)$-module. $N$ is said to be $h$ saturated if the map $N \rightarrow N$ sending $m$ to hm is injective.
Let $N$ be a bigraded $g r^{F}\left(\mathcal{R}_{V}(D)\right)$-module. $N$ is said to be $\theta$-saturated if the map $N \rightarrow N$ sending $m$ to $\theta m$ is injective.

Lemma 4.1. The following are equivalent :

1. $M$ is nicely bifiltered,
2. $\operatorname{gr}^{V}\left(\mathcal{R}_{F}(M)\right)$ is $h$-saturated,
3. $\operatorname{gr}^{F}\left(\mathcal{R}_{V}(M)\right)$ is $\theta$-saturated.

Proof. By definition, 2) and 3) are equivalent to the following: $\forall d, k, F_{d+1, k}(M) \cap$ $F_{d, k+1}(M) \subset F_{d, k}(M)$. By [2], Lemma 1.1, this is equivalent to 1$)$.
$h$-saturatedness and Gröbner bases. Let us give a criterion for $h$-saturatedness using Gröbner bases. Using the preceding lemma, that leads to a criterion for the niceness of a bifiltration. Let in this paragraph $D^{(h)}=\mathbb{C}\left[x_{1}, \ldots, x_{n}\right]\left\langle\partial_{1}, \ldots, \partial_{n}, h\right\rangle$. It is graded by setting for any $i, \operatorname{deg} x_{i}=0, \operatorname{deg} \partial_{i}=1$ and $\operatorname{deg} h=1$.

Let $<\prime$ be a well-order on $\mathbb{N}^{2 n}$, compatible with sums. Then we define a well-order $<^{\prime}$ on $\mathbb{N}^{2 n+1}$ by

$$
(\alpha, \beta, k)<^{\prime}\left(\alpha^{\prime}, \beta^{\prime}, k^{\prime}\right) \quad \text { iff }
$$

$$
\left\{\begin{array}{l}
|\beta|+k<\left|\beta^{\prime}\right|+k^{\prime} \\
\text { or } \quad|\beta|+k=\left|\beta^{\prime}\right|+k^{\prime} \quad \text { and } \quad|\beta|<\left|\beta^{\prime}\right| \\
\text { or } \quad|\beta|+k=\left|\beta^{\prime}\right|+k^{\prime},|\beta|=\left|\beta^{\prime}\right| \text { and }(\alpha, \beta) \ll^{\prime \prime}\left(\alpha^{\prime}, \beta^{\prime}\right) .
\end{array}\right.
$$

This is a well-order on the monomials of $D^{(h)}$ adapted to the $F$-filtration. To deal with submodules of $\left(D^{(h)}\right)^{r}$, we define a well-ordering $<$ on $\mathbb{N}^{2 n+1} \times$ $\{1, \ldots, r\}$ by

$$
(\alpha, \beta, k, i)<\left(\alpha^{\prime}, \beta^{\prime}, k^{\prime}, i^{\prime}\right) \quad \text { iff } \quad\left\{\begin{array}{l}
(\alpha, \beta, k)<^{\prime}\left(\alpha^{\prime}, \beta^{\prime}, k^{\prime}\right) \\
\text { or }(\alpha, \beta, k)=\left(\alpha^{\prime}, \beta^{\prime}, k^{\prime}\right) \quad \text { and } \quad i<i^{\prime} .
\end{array}\right.
$$

Note that if $(\alpha, \beta, k, i) \geq\left(\alpha^{\prime}, \beta^{\prime}, k^{\prime}, i^{\prime}\right)$ and $|\beta|+k=\left|\beta^{\prime}\right|+k^{\prime}$, then $k \leq k^{\prime}$. If $P \in W^{r}$, we denote by in $(P)$ the leading monomial of $P$.

Definition 4.3. Let $P_{1}, \ldots, P_{s}$ be a Gröbner base of a homogeneous submodule $N \subset\left(D^{(h)}\right)^{r}$. Such a base is called minimal if

$$
\forall i, \operatorname{Exp} P_{i} \notin \bigcup_{j \neq i}\left(\operatorname{Exp} P_{j}+\mathbb{N}^{2 n+1}\right)
$$

Proposition 4.1. The following assertions are equivalent:

1. $\left(D^{(h)}\right)^{r} / N$ is $h$-saturated.
2. For any minimal homogeneous Gröbner base $P_{1}, \ldots, P_{s}$ of $N$, for any $i$, $h$ does not divide in $P_{i}$.
3. There exists a minimal homogeneous Gröbner base $P_{1}, \ldots, P_{s}$ of $N$, such that for any $i, h$ does not divide in $P_{i}$.

Proof. Let us prove 1) $\Rightarrow 2$ ) Let $P_{1}, \ldots, P_{s}$ be a minimal homogeneous Gröbner base of $N$. Suppose that there exists $i$ such that $h$ divides in $P_{i}$. Then $h$ divides $P_{i}$ by the definition of $<$. By $h$-saturatedness, $P_{i} / h \in N$. Thus

$$
\operatorname{Exp} \frac{P_{i}}{h} \in \bigcup_{j \neq i}\left(\operatorname{Exp} P_{j}+\mathbb{N}^{2 n+1}\right)
$$

then

$$
\operatorname{Exp} P_{i}=h \operatorname{Exp} \frac{P_{i}}{h} \in \bigcup_{j \neq i}\left(\operatorname{Exp} P_{j}+\mathbb{N}^{2 n+1}\right),
$$

which contradicts the minimality.
$2) \Rightarrow 3$ ) is obvious. Let us show 3$) \Rightarrow 1$ ). Let $P \in\left(D^{(h)}\right)^{r}$ homogeneous such that $h P \in N$. We shall show that $P \in N$. By division, $h P=\sum Q_{i} P_{i}$ with for any $i, Q_{i} \in D^{(h)}$ homogeneous, $\operatorname{deg}\left(Q_{i} P_{i}\right)=\operatorname{deg}(h P)$, and ord ${ }^{F}\left(Q_{i} P_{i}\right) \leq$ $\operatorname{ord}^{F}(h P)$.

Let us suppose that there exists $i$ such that $h$ does not divide $Q_{i}$. Then $\operatorname{ord}^{F} Q_{i}=\operatorname{deg} Q_{i}$. Since $h$ does not divide $P_{i}$, we have $\operatorname{ord}^{F} P_{i}=\operatorname{deg} P_{i}$. Then

$$
\operatorname{ord}^{F}\left(Q_{i} P_{i}\right)=\operatorname{ord}^{F}\left(Q_{i}\right)+\operatorname{ord}^{F}\left(P_{i}\right)=\operatorname{deg} Q_{i}+\operatorname{deg} P_{i}=\operatorname{deg}(h P)
$$

But

$$
\operatorname{ord}^{F}\left(Q_{i} P_{i}\right) \leq \operatorname{ord}^{F}(h P)<\operatorname{deg}(h P)
$$

a contradiction. Thus for any $i, h$ divides $Q_{i}$ and $P=\sum\left(Q_{i} / h\right) P_{i} \in N$.
We shall make a link between the $(F, V)$-multidegree and the theory of slopes of Y. Laurent, c.f. [11]. We consider intermediate filtrations $L$ between $F$ and $V$, denoted by $p F+q V$ with $p>0, q>0$, defined by

$$
L_{r}(D)=\sum_{d p+k q \leq r} F_{d, k}(D) .
$$

Similarly we endow $M$ with the $L$-filtration $L_{r}(M)=\sum_{d p+k q \leq r} F_{d, k}(M)$, which is a good filtration since taking a bifiltered free presentation

$$
D^{r_{1}}\left[\mathbf{n}^{(1)}\right]\left[\mathbf{m}^{(1)}\right] \rightarrow D^{r_{0}}\left[\mathbf{n}^{(0)}\right]\left[\mathbf{m}^{(0)}\right] \rightarrow M \rightarrow 0
$$

we see that $\mathrm{gr}^{L}(M)$ is isomorphic to a quotient of $\mathrm{gr}^{L}\left(D^{r_{0}}\left[p \mathbf{n}^{(0)}+q \mathbf{m}^{(0)}\right]\right)$.
On the other hand, since $\mathrm{gr}^{V}(M)$ is isomorphic to a quotient of $\mathrm{gr}^{V}\left(D^{r_{0}}\left[\mathbf{m}^{(0)}\right]\right)\left[\mathbf{n}^{(0)}\right]$, it is endowed with a natural $F$-filtration. Similarly, $\operatorname{gr}^{F}(M)$ is isomorphic to a quotient of $\mathrm{gr}^{F}\left(D^{r_{0}}\left[\mathbf{n}^{(0)}\right]\right)\left[\mathbf{m}^{(0)}\right]$, and it is endowed with a natural $V$-filtration.

In [2], we considered also the bigraded module

$$
\operatorname{bigr}(M)=\bigoplus_{d, k} \frac{F_{d, k}(M)}{F_{d, k-1}(M)+F_{d-1, k}(M)}
$$

over the ring $\operatorname{bigr}(D) \simeq \operatorname{gr}^{V}\left(\operatorname{gr}^{F}(D)\right) \simeq \operatorname{gr}^{F}\left(\operatorname{gr}^{V}(D)\right)$.
Lemma 4.2. If $M$ is nicely bifiltered, we have

$$
\operatorname{bigr}(M) \simeq \operatorname{gr}^{V}\left(\operatorname{gr}^{F}(M)\right) \simeq \operatorname{gr}^{F}\left(\operatorname{gr}^{V}(M)\right)
$$

Proof. For the sake of simplicity, we suppose that $\mathbf{n}^{(0)}=\mathbf{m}^{(0)}=\mathbf{0}$ and consider $M=D^{r} / N$. We have

$$
F_{d, k}(M)=\frac{F_{d, k}\left(D^{r}\right)+N}{N}, \quad F_{d}(M)=\frac{F_{d}\left(D^{r}\right)+N}{N}, \quad V_{k}(M)=\frac{V_{k}\left(D^{r}\right)+N}{N} .
$$

The niceness assumption is equivalent to the following:

$$
\begin{equation*}
\forall d, k,\left(F_{d}\left(D^{r}\right)+N\right) \cap\left(V_{k}\left(D^{r}\right)+N\right) \subset F_{d, k}\left(D^{r}\right)+N . \tag{2}
\end{equation*}
$$

We have $\operatorname{gr}^{V}(M)=\operatorname{gr}^{V}\left(D^{r}\right) / \operatorname{gr}^{V}(N)$ with

$$
\operatorname{gr}^{V}(N)=\bigoplus_{k} \frac{V_{k}\left(D^{r}\right) \cap N+V_{k-1}\left(D^{r}\right)}{V_{k-1}\left(D^{r}\right)}
$$

We naturally define

$$
\begin{aligned}
F_{d}\left(\operatorname{gr}^{V}(N)\right) & =F_{d}\left(\operatorname{gr}^{V}\left(D^{r}\right)\right) \cap \operatorname{gr}^{V}(N) \\
& =\bigoplus_{k} \frac{F_{d, k}\left(D^{r}\right)+V_{k-1}\left(D^{r}\right)}{V_{k-1}\left(D^{r}\right)} \bigcap \frac{V_{k}\left(D^{r}\right) \cap N+V_{k-1}\left(D^{r}\right)}{V_{k-1}\left(D^{r}\right)} .
\end{aligned}
$$

Thus we have

$$
\operatorname{gr}^{F} \operatorname{gr}^{V}(N)=\bigoplus_{d, k} \frac{\left(F_{d, k}\left(D^{r}\right)+V_{k-1}\left(D^{r}\right)\right) \cap\left(V_{k}\left(D^{r}\right) \cap N+V_{k-1}\left(D^{r}\right)\right)}{\left(F_{d-1, k}\left(D^{r}\right)+V_{k-1}\left(D^{r}\right)\right) \cap\left(V_{k}\left(D^{r}\right) \cap N+V_{k-1}\left(D^{r}\right)\right)}
$$

This is included in

$$
\operatorname{gr}^{F} \operatorname{gr}^{V}\left(D^{r}\right)=\bigoplus_{d, k} \frac{F_{d, k}\left(D^{r}\right)}{F_{d-1, k}\left(D^{r}\right)+F_{d, k-1}\left(D^{r}\right)}
$$

via the map

$$
\left(F_{d, k}\left(D^{r}\right)+V_{k-1}\left(D^{r}\right)\right) \cap\left(V_{k}\left(D^{r}\right) \cap N+V_{k-1}\left(D^{r}\right)\right) \rightarrow F_{d, k}\left(D^{r}\right)+V_{k-1}\left(D^{r}\right) \rightarrow F_{d, k}\left(D^{r}\right) .
$$

## Hence

$$
\begin{aligned}
\operatorname{gr}^{F} \operatorname{gr}^{V}(M) & =\operatorname{gr}^{F} \operatorname{gr}^{V}(D) / \operatorname{gr}^{F} \operatorname{gr}^{V}(N) \\
& =\frac{F_{d, k}\left(D^{r}\right)}{F_{d, k}\left(D^{r}\right) \cap\left(V_{k}(N)+V_{k-1}\left(D^{r}\right)\right)+F_{d-1, k}\left(D^{r}\right)+F_{d, k-1}\left(D^{r}\right)} .
\end{aligned}
$$

On the other hand,

$$
\begin{aligned}
\operatorname{bigr}_{d, k}(M) & =\frac{F_{d, k}(M)}{F_{d-1, k}(M)+F_{d, k-1}(M)} \\
& =\frac{F_{d, k}\left(D^{r}\right)+N}{F_{d-1, k}\left(D^{r}\right)+F_{d, k-1}\left(D^{r}\right)+N} \\
& =\frac{F_{d, k}\left(D^{r}\right)}{F_{d, k}\left(D^{r}\right) \cap\left(F_{d-1, k}\left(D^{r}\right)+F_{d, k-1}\left(D^{r}\right)+N\right)} \\
& =\frac{F_{d, k}\left(D^{r}\right)}{F_{d-1, k}\left(D^{r}\right)+F_{d, k-1}\left(D^{r}\right)+N \cap F_{d, k}\left(D^{r}\right)} .
\end{aligned}
$$

We have to show

$$
\begin{align*}
F_{d-1, k}\left(D^{r}\right)+F_{d, k-1}\left(D^{r}\right)+N \cap F_{d, k}\left(D^{r}\right) & =F_{d, k}\left(D^{r}\right) \cap\left(V_{k}(N)+V_{k-1}\left(D^{r}\right)\right) \\
& +F_{d-1, k}\left(D^{r}\right)+F_{d, k-1}\left(D^{r}\right) \tag{3}
\end{align*}
$$

The inclusion $\subset$ is obvious. On the other hand,

$$
\begin{aligned}
F_{d, k}\left(D^{r}\right) \cap\left(V_{k}(N)+V_{k-1}\left(D^{r}\right)\right) & =F_{d, k}\left(D^{r}\right) \cap\left(N+V_{k-1}\left(D^{r}\right)\right) \\
& \subset\left(F_{d, k-1}\left(D^{r}\right)+N\right) \cap F_{d, k}\left(D^{r}\right) \quad \text { (using (2)) } \\
& \subset F_{d, k-1}\left(D^{r}\right)+N \cap F_{d, k}\left(D^{r}\right),
\end{aligned}
$$

which proves (3).
We have showed that $\operatorname{bigr}(M) \simeq \operatorname{gr}^{F}\left(\operatorname{gr}^{V}(M)\right)$, and by exchanging the role of $F$ and $V$ we show that $\operatorname{bigr}(M) \simeq \operatorname{gr}^{V}\left(\mathrm{gr}^{F}(M)\right)$.

Note also that under the niceness assumption, the module $\operatorname{bigr}(N)$ is identified with a submodule of $\operatorname{bigr}\left(D^{r}\right)$ such that $\operatorname{bigr}(M) \simeq \operatorname{bigr}\left(D^{r}\right) / \operatorname{bigr}(N)$.

Lemma 4.3 ([17], Lemma 2.1.6). For $\epsilon>0$ small enough,

$$
\operatorname{gr}^{V}\left(\operatorname{gr}^{F}(M)\right) \simeq \operatorname{gr}^{L}(M) \quad \text { with } \quad L=F+\epsilon V,
$$

and

$$
\operatorname{gr}^{F}\left(\operatorname{gr}^{V}(M)\right) \simeq \operatorname{gr}^{L}(M) \quad \text { with } \quad L=V+\epsilon F
$$

It is known that for any $L, \operatorname{gr}^{L}(M)$ defines an algebraic cycle independent of the good filtration (the proof is almost the same as for the $F$-filtration). The variety defined by the annihilator of $\mathrm{gr}^{L}(M)$ is denoted by $\operatorname{char}_{L}(M)$. Remember that $\mathbb{K}$ denotes the fraction field of $\mathbb{C}[x]$. The module $\mathbb{K} \otimes \operatorname{gr}^{L}(M)$ also defines an algebraic cycle independent of the good filtration.

Proposition 4.2. If $M$ is nicely bifiltered, we have

$$
K_{F, V}\left(M ; T_{1}, T_{2}\right)=K\left(\operatorname{bigr}(M) ; T_{1}, T_{2}\right)=K\left(\operatorname{gr}^{L} M ; T_{1}, T_{2}\right)
$$

with $L=V+\epsilon F$ or $L=F+\epsilon V$ with $\epsilon>0$ small enough. Here $\operatorname{gr}^{L} M$ is considered as a bigraded module.

Proof. Under this assumption, any bifiltered free resolution of $M$ induces a bigraded free resolution of $\operatorname{bigr} M$ (see [2], Theorem 1.1, forgetting the minimality). Thus $K_{F, V}\left(M ; T_{1}, T_{2}\right)=K\left(\operatorname{bigr} M ; T_{1}, T_{2}\right)$. But by Lemma 4.2 and Lemma 4.3, $\operatorname{bigr} M \simeq \operatorname{gr}^{L}(M)$.

Remark 4.1. The multidegree $\mathcal{C}_{F, V}\left(M ; T_{1}, T_{2}\right)$ has total degree

$$
d=\operatorname{codim} \mathbb{K} \otimes \operatorname{gr}^{F}\left(\mathcal{R}_{V}(M)\right),
$$

by definition. On the other hand, since the multigrading on $\mathbb{K} \otimes \operatorname{bigr} D$ is positive, we know that the first non-zero terms in the expansion of $K_{F, V}(M ; 1-$ $T_{1}, 1-T_{2}$ ) have total degree equal to

$$
d^{\prime}=\operatorname{codim}(\mathbb{K} \otimes \operatorname{bigr} M)
$$

Thus $d \leq d^{\prime}$. If $d<d^{\prime}$, then $\mathcal{C}_{F, V}\left(M ; T_{1}, T_{2}\right)=0$. We will see in the next section non trivial cases in which $d=d^{\prime}$.

We then have, applying Proposition 1.2 :
Theorem 4.1. The multidegree $\mathcal{C}_{F, V}\left(M ; T_{1}, T_{2}\right)$ only depends on codim $\mathbb{K} \otimes$ $\operatorname{gr}^{F}\left(\mathcal{R}_{V}(M)\right)$ and on the algebraic cycle defined by $\mathbb{K} \otimes \operatorname{gr}^{L}(M)$ with $L=V+\epsilon F$ or $L=F+\epsilon V$ with $\epsilon>0$ small enough.

Let us recall some geometric meaning related to the $L$-filtration. Let $X=$ $\mathbb{C}^{n+p}, Y=\{t=0\} \subset X$ and $\Lambda=T_{Y}^{*} X$ the conormal bundle. We have $\operatorname{gr}^{L}(D) \simeq \mathcal{O}\left(T^{*} \Lambda\right)$, c.f. [11]. Let $\pi: T^{*} \Lambda \rightarrow Y$ be the canonical projection.

By Proposition 1.5, $\mathcal{C}_{F, V}\left(\mathbb{K} \otimes \operatorname{gr}^{L}(M) ; T_{1}, T_{2}\right)=\mathcal{C}_{F, V}\left(\operatorname{gr}^{L}(M)^{y} ; T_{1}, T_{2}\right)$ for $y \in Y$ generic. This depends only on the algebraic cycle on $\pi^{-1}(y)$ defined by
$\operatorname{gr}^{L}(M)^{y}$ for $y$ generic. $d^{\prime}$ is equal to the codimension of $\operatorname{char}_{L}(M) \cap \pi^{-1}(y) \subset$ $\pi^{-1}(y)$, for $y$ generic.

For any $L$, we have $\mathrm{gr}^{L}(D) \simeq \operatorname{gr}^{F}\left(\mathrm{gr}^{V}(D)\right)$ thus $\mathrm{gr}^{L}(D)$ is a bigraded ring. Following the theory of Y. Laurent, we say that $M$ has no slopes along $Y$ if for any $L$, the ideal $\operatorname{rad}\left(\operatorname{ann} \operatorname{gr}^{L}(M)\right)$ (defining $\left.\operatorname{char}_{L}(M)\right)$ is bihomogeneous. The following means that niceness of the bifiltration is a strong regularity condition.

Proposition 4.3. If $M$ is a nicely bifiltered holonomic $D$-module, then $M$ has no slopes along $Y$.

Proof. As before, we identify $\mathcal{R}_{V}(D)$ with $D[\theta]$. Let us take a bifiltered free presentation

$$
\begin{equation*}
D^{s}[\mathbf{n}][\mathbf{m}] \xrightarrow{\phi_{1}} D^{r} \xrightarrow{\phi_{0}} M \rightarrow 0, \tag{4}
\end{equation*}
$$

with $\phi_{1}\left(e_{i}\right)=P^{(i)}=\sum_{j} P_{j}^{(i)} e_{j}$, and let $N=\operatorname{Im} \phi_{1}$. For the sake of simplicity, we have assumed $\mathbf{n}^{(0)}=\mathbf{m}^{(0)}=\mathbf{0}$. This induces a bigraded free resolution

$$
\operatorname{gr}^{F}(D[\theta])^{s}[\mathbf{n}][\mathbf{m}] \xrightarrow{\bar{\phi}_{7}} \operatorname{gr}^{F}(D[\theta])^{r} \xrightarrow{\bar{\phi}_{0}} \operatorname{gr}^{F} \mathcal{R}_{V} M \rightarrow 0 .
$$

Using the lifting ([8], Proposition 2.7), we can suppose that the presentation (4) is minimal, in the sense that the elements $\bar{\phi}_{1}\left(e_{i}\right)$ form a minimal set of generators of $\operatorname{Ker} \bar{\phi}_{0}$.

Let us introduce some notations in order to determine $\bar{\phi}_{1}\left(e_{i}\right)$.
If $P=\sum a_{\nu, \mu}\left(x, \partial_{x}\right) t^{\nu} \partial_{t}^{\mu} \in V_{k}(D)$, we define

$$
H_{k}^{V}(P)=\sum a_{\nu, \mu}\left(x, \partial_{x}\right) t^{\nu} \partial_{t}^{\mu} \theta^{k-(|\mu|-|\nu|)} \in D[\theta]
$$

and $H^{V}(P)=H_{\operatorname{ord}^{V}(P)}^{V}(P)$, the $V$-homogenization of $P$. Similarly if $P=$ $\sum P_{j} e_{j} \in \oplus V_{m_{j}}(D)$, we define $H_{\mathbf{m}}^{V}(P)=\sum H_{m_{j}}^{V}\left(P_{j}\right) e_{j} \in(D[\theta])^{r}$.
Now if $P=\sum a_{\beta}\left(x, t, \partial_{t}, \theta\right) \partial_{x}^{\beta} \in F_{d}(D[\theta])$, we define

$$
\sigma_{d}^{F}(P)=\sum_{|\beta|=d} a_{\beta}\left(x, t, \partial_{t}, \theta\right) \partial_{x}^{\beta} \in \operatorname{gr}_{d}^{F}(D[\theta]),
$$

and $\sigma^{F}(P)=\sigma_{\operatorname{ord}^{F}(P)}^{F} P$. Similarly if $P=\sum P_{j} e_{j} \in \oplus F_{n_{j}}(D[\theta])$, we define $\sigma_{\mathbf{n}}^{F}(P)=\sum \sigma_{n_{j}}^{F}\left(P_{j}\right) e_{j} \in \operatorname{gr}^{F}(D[\theta])^{r}$.

We have

$$
\bar{\phi}_{1}\left(e_{i}\right)=\sigma_{\mathbf{n}}^{F}\left(H_{\mathbf{m}}(P)\right) .
$$

For $P=\sum_{\nu, \beta, \mu} a_{\nu, \beta, \mu}(x) t^{\nu} \partial_{x}^{\beta} \partial_{t}^{\mu}$, let us define the Newton polygon by

$$
\mathcal{P}(P)=\bigcup_{(\nu, \beta, \mu) \mid a_{\nu, \beta, \mu}(x) \neq 0}(|\nu|-|\mu|,|\beta|+|\mu|)-\mathbb{N}^{2} \subset \mathbb{Z}^{2} .
$$

We say that $\mathcal{P}(P)$ is trivial if it is equal to a translate of $(-\mathbb{N}) \times(-\mathbb{N})$.

For $1 \leq i \leq s$, let $J(i)$ be the set of integers $1 \leq j \leq r$ such that

- $\operatorname{ord}^{F} P_{j}^{(i)}=n_{i}$,
- $\operatorname{ord}^{V} P_{j}^{(i)}=m_{i}$,
- $\mathcal{P}\left(P_{j}^{(i)}\right)$ is trivial.

We claim that for any $i$, the set $J(i)$ is non-empty. Otherwise, $\theta$ would divide $\bar{\phi}_{1}\left(e_{i}\right)$. By $\theta$-saturatedness, $\bar{\phi}_{1}\left(e_{i}\right) / \theta$ would belong to $\operatorname{gr}^{F} \mathcal{R}_{V} N$, thus the presentation (4) would not be minimal.

Then $\operatorname{bigr} N$ is generated by the elements

$$
\sum_{j \in J(i)} \sigma^{F} \sigma^{V}\left(P_{j}^{(i)}\right) e_{j}
$$

for $1 \leq i \leq s$. Let $L$ be an intermediate filtration. We have

$$
\sigma^{L}\left(P^{(i)}\right)=\sum_{j \in J(i)} \sigma^{L}\left(P_{j}^{(i)}\right) e_{j}=\sum_{j \in J(i)} \sigma^{F} \sigma^{V}\left(P_{j}^{(i)}\right) e_{j} .
$$

Thus for any $L$,

$$
\begin{equation*}
\operatorname{bigr} N \subset \operatorname{gr}^{L} N \tag{5}
\end{equation*}
$$

If $\mathcal{M}$ is a $\operatorname{gr}^{L}(D)$-module, we denote by supp $\mathcal{M}$ the zero-set of the annihilator of $\mathcal{M}$. By [19], Theorem 1.1 and [17], Theorem 2.2 .1 (valid for any $L$ ), $\operatorname{char}_{L}(M)=$ $\operatorname{supp}\left(\operatorname{gr}^{L}(M)\right)$ is pure of dimension $n+p$ for any $L$. Since $\operatorname{bigr} N=\operatorname{gr}^{F} \operatorname{gr}^{V}(N)=$ $\operatorname{gr}^{L}(N)$ for $L$ close to $V$, then $\operatorname{supp}(\operatorname{bigr} M)$ is pure of dimension $n+p$.

By (5), we have for any $L, \operatorname{char}_{L} M \subset \operatorname{supp}(\operatorname{bigr} M)$, thus $\operatorname{char}_{L} M$ is the union of some irreducible components of $\operatorname{supp}(\operatorname{bigr} M)$. The irreducible components are bihomogeneous (a bihomogeneous module admits a bihomogeneous primary decomposition), so $\operatorname{char}_{L} M$ is bihomogeneous.

## 5 Examples from the theory of hypergeometric systems

Let $D=\mathbb{C}\left[x_{1}, \ldots, x_{n}\right]\left\langle\partial_{1}, \ldots, \partial_{n}\right\rangle$. We consider the $A$-hypergeometric $D$-module $M_{A}(\beta)=D / H_{A}(\beta)$. This is a holonomic system associated with a $d \times n$ integer matrix $A$ and $\beta_{1}, \ldots, \beta_{d} \in \mathbb{C}$ as follows. We suppose that the abelian group generated by the columns $a_{1}, \ldots, a_{n}$ of $A$ is equal to $\mathbb{Z}^{d}$. Let $I_{A}$ be the ideal of $\mathbb{C}\left[\partial_{1}, \ldots, \partial_{n}\right]$ generated by the elements $\partial^{u}-\partial^{v}$ with $u, v \in \mathbb{N}^{n}$ such that $A . u=A . v$. The hypergeometric ideal $H_{A}(\beta)$ is the ideal of $D$ generated by $I_{A}$ and the elements $\sum_{j} a_{i, j} x_{j} \partial_{j}-\beta_{i}$ for $i=1, \ldots, d$. The hypergeometric modules were introduced by I. M. Gelfand, M. M. Kapranov and A. V. Zelevinsky in [5]; their holonomicity (in the general case) was proved by A. Adolphson in [1].

We endow $M$ with the quotient $F$-filtration and the quotient $V$-filtration with respect to $x_{1}=\cdots=x_{n}=0$.

Let us assume that the abelian group generated by the rows of $A$ contains a vector $\mathbf{w}=\left(w_{1}, \ldots, w_{n}\right) \in \mathbb{Z}_{>0}^{n}$. That is equivalent to the fact that the semigroup generated by the columns of $A$ is pointed. By applying the weight
vector $W=(-\mathbf{w}, \mathbf{w})$ to $(x, \partial)$, we get a grading on $D$. The hypergeometric module $M_{A}(\beta)$ is homogeneous w.r.t. to $W$.

Our first topic is to strenghten the correspondence between $\mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)$ and $\mathcal{C}\left(\operatorname{bigr} M_{A}(\beta) ; T_{1}, T_{2}\right)$, i.e. to prove that the modules $\operatorname{bigr} M_{A}(\beta)$ and $\operatorname{gr}^{F}\left(\mathbf{R}_{V}\left(M_{A}(\beta)\right)\right)$ have the same codimension if $M_{A}(\beta)$ is nicely bifiltered.

The codimension of a finite type $D$-module $M$ is by definition the codimension of $g r^{F}(M)$, that does not depend on the good $F$-filtration. In fact we can make the weight vector vary as well.

Proposition 5.1 ([17], pp. 65-66). Let $(\mathbf{u}, \mathbf{v}) \in \mathbb{N}^{2 n}$ be a weight vector such that for all $i, u_{i}+v_{i}>0$. Endow $M$ with $a \operatorname{good}(\mathbf{u}, \mathbf{v})$-filtration. Then $\operatorname{codim}\left(\operatorname{gr}^{(\mathbf{u}, \mathbf{v})}(M)\right)=\operatorname{codim} M$.

We have an analogous statement for $D^{(h)}$-modules, proved in the same way. Let $(\mathbf{u}, \mathbf{v}, t) \in \mathbb{N}^{2 n+1}$ such that for all $i, u_{i}+v_{i}>t$. Then $\operatorname{gr}^{(\mathbf{u}, \mathbf{v}, t)}\left(D^{(h)}\right)$ is commutative.

Definition 5.1. Let $M$ be a graded $D^{(h)}$-module of finite type. Endow $M$ with a good $(\mathbf{u}, \mathbf{v}, t)$-filtration. We define $\operatorname{codim} M=\operatorname{codim}\left(\mathrm{gr}^{(\mathbf{u}, \mathbf{v}, t)} M\right)$. This depends neither on the good filtration nor on the weight vector $(\mathbf{u}, \mathbf{v}, t)$.

Finally, since $\operatorname{gr}^{V}\left(D^{(h)}\right) \simeq D^{(h)}$, we define in the same way the codimension of a $\mathrm{gr}^{V}\left(D^{(h)}\right)$-module of finite type.

We adopt the following notation. If $P=\sum a_{\beta}(x) \partial_{x}^{\beta} \in F_{d}(D)$, we define $H_{d}(P)=\sum a_{\beta}(x) \partial_{x}^{\beta} h^{d-|\beta|} \in D^{(h)}$, and the $F$-homogenization $H(P)=$ $H_{\operatorname{ord}^{F}(P)}(P)$. If $I$ is an ideal of $D$, let $H(I)$ be the ideal of $D^{(h)}$ generated by the elements $H(P)$ such that $P \in I$. We have $\mathcal{R}_{F}(M)=D^{(h)} / H(I)$. Similarly we define the $V$-homogenization, denoted by $H^{V}(P) \in D[\theta]$ and $H^{V}(I) \subset D[\theta]$.

Proposition 5.2. Let $M=D / I$ be a $W$-homogeneous nicely bifiltered $D$ module. Then the modules $M, \operatorname{gr}^{F}\left(\mathbf{R}_{V}(M)\right), \operatorname{gr}^{V}\left(\mathbf{R}_{F}(M)\right)$ and $\operatorname{bigr} M$ all have the same codimension.

Proof. First, we prove that

$$
\operatorname{codim} \mathcal{R}_{F}(M)=\operatorname{codim} M
$$

Let $<$ be a well-order on $\mathbb{N}^{2 n}$ (the monomials of $D$ ) adapted to $F$, i.e. for any $\alpha, \alpha^{\prime}, \beta, \beta^{\prime},|\beta|<\left|\beta^{\prime}\right| \Rightarrow(\alpha, \beta)<\left(\alpha^{\prime}, \beta^{\prime}\right)$. We derive from it a well-order $<^{\prime}$ on $\mathbb{N}^{2 n+1}$ (the monomials of $\left(D^{(h)}\right)$ ) in the following way:

$$
(\alpha, \beta, k)<^{\prime}\left(\alpha^{\prime}, \beta^{\prime}, k^{\prime}\right) \quad \text { iff } \quad\left\{\begin{array}{l}
|\beta|+k<\left|\beta^{\prime}\right|+k^{\prime} \\
\text { or }\left\{\begin{array}{l}
|\beta|+k=\left|\beta^{\prime}\right|+k^{\prime} \\
\text { and }(\alpha, \beta)<\left(\alpha^{\prime}, \beta^{\prime}\right)
\end{array}\right.
\end{array}\right.
$$

which is adapted to the $F$-filtration. Let $P_{1}, \ldots, P_{s}$ be a Gröbner base of $I$ with respect to $<$. Then $H\left(P_{1}\right), \ldots, H\left(P_{s}\right)$ is a Gröbner base of $H(I)$ with respect to $<^{\prime}$ (use the Buchberger criterion). We have $\sigma^{F}\left(H\left(P_{i}\right)\right)=\sigma^{F}\left(P_{i}\right) \in \mathbb{C}[x, \xi]$, thus codim $\left(\operatorname{gr}^{F}\left(\mathbf{R}_{F}(M)\right)\right)=\operatorname{codim}\left(\operatorname{gr}^{F}(M)\right)$.

Now, we prove that

$$
\operatorname{codim}\left(\operatorname{gr}^{V}\left(\mathcal{R}_{F}(M)\right)\right)=\operatorname{codim} M
$$

The module $\mathcal{R}_{F}(M)$ is bihomogeneous with respect to the weight vectors ( $-\mathbf{w}, \mathbf{w}, 0$ ) and $(\mathbf{0}, \mathbf{1}, 1)$. Let $\mu=\max \left(w_{i}-1\right) \in \mathbb{N}$ and
$\Lambda=(-\mathbf{1}, \mathbf{1}, 0)-(-\mathbf{w}, \mathbf{w}, 0)+\mu .(\mathbf{0}, \mathbf{1}, 1)=(\mathbf{w}-\mathbf{1},(1+\mu) \mathbf{1}-\mathbf{w}, \mu . \mathbf{1}) \in \mathbb{N}^{2 n+1}$.
Using the bihomogeneity, a $V$-adapted base of $H(N)$ is also adapted to $\Lambda$, so $\operatorname{gr}^{\Lambda}\left(\mathcal{R}_{F}(M)\right)=\operatorname{gr}^{V}\left(\mathcal{R}_{F}(M)\right)$. Then

$$
\begin{aligned}
& \operatorname{codimgr} \\
&=\operatorname{codimgr}^{V}\left(\mathcal{R}_{F}(M)\right) \\
&=\operatorname{codimg}^{(0, \mathbf{1}, \mathbf{0})} \operatorname{gr}^{V}\left(\mathcal{R}_{F}(M)\right) \quad \text { (by definition) } \\
&=\operatorname{codimgr}^{\Lambda+\epsilon \cdot(\mathbf{0}, \mathbf{1}, 0)}\left(\mathcal{R}_{F}(M)\right) \quad \text { with } \epsilon>0
\end{aligned}
$$

by [17], Lemma 2.1.6, which proves our assertion since $\Lambda+\epsilon .(\mathbf{0}, \mathbf{1}, 0) \in \mathbb{N}^{2 n+1}$.
Next, let us see that

$$
\operatorname{codim}\left(\operatorname{gr}^{F}\left(\mathcal{R}_{V}(M)\right)\right)=\operatorname{codim} M
$$

We will slightly modify the problem using the niceness assumptiom. We can endow $\operatorname{gr}^{F}(D) \simeq \mathbb{C}[x, \xi]$ with a filtration with respect to the weight vector $(-\mathbf{1}, \mathbf{1})$, which we still call the $V$-filtration. The module $\operatorname{gr}^{F}(M) \simeq \operatorname{gr}^{F}(D) / \mathrm{gr}^{F}(I)$ is naturally endowed with the quotient $V$-filtration. In the same way as in the proof of Lemma 4.2, we have

$$
\operatorname{gr}^{F}\left(\mathcal{R}_{V}(M)\right)=\mathcal{R}_{V}\left(\operatorname{gr}^{F}(M)\right)
$$

Thus we are reduced to show $\operatorname{codim}\left(\mathcal{R}_{V}\left(\operatorname{gr}^{F}(M)\right)=\operatorname{codim} M\right.$. As before, let $\mu=\max \left(w_{i}-1\right)$ and define $\Lambda=V-(-\mathbf{w}, \mathbf{w})+\mu \cdot(\mathbf{0}, \mathbf{1}) \in \mathbb{N}^{2 n}$. We have a ring isomorphism

$$
\mathcal{R}_{V}\left(\operatorname{gr}^{F}(D)\right) \simeq \operatorname{gr}^{F}(D)[\theta] \simeq \mathcal{R}_{\Lambda}\left(\operatorname{gr}^{F}(D)\right)
$$

and $\mathcal{R}_{V}\left(\operatorname{gr}^{F}(M)\right) \simeq \mathcal{R}_{\Lambda}\left(\operatorname{gr}^{F}(M)\right)$ above this ring isomorphism. Next,

$$
\begin{aligned}
& \operatorname{codim} \mathcal{R}_{\Lambda}\left(\operatorname{gr}^{F}(M)\right)={\operatorname{codim~} \operatorname{gr}^{\Lambda} \operatorname{gr}^{F}(M)} \\
&=\operatorname{codimgr}^{F+\epsilon \Lambda}(M) \\
&=\operatorname{codim} M
\end{aligned}
$$

Finally, we show that

$$
\operatorname{codim}(\operatorname{bigr} M)=\operatorname{codim}(M)
$$

We have bigr $M \simeq \operatorname{gr}^{V} \operatorname{gr}^{F}(M)$, by Lemma 4.2. Taking again $\Lambda=V-(-\mathbf{w}, \mathbf{w})+$ $\mu \cdot(\mathbf{0}, \mathbf{1})$, the assertion follows from $\operatorname{gr}^{V} \operatorname{gr}^{F}(M)=\operatorname{gr}^{\Lambda} \operatorname{gr}^{F}(M)=\operatorname{gr}^{F+\epsilon \Lambda}(M)$.

Remark 5.1. If $M_{A}(\beta)$ is nicely bifiltered, then we have

$$
\mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)_{\mid T_{2}=0}=\left(\operatorname{rank} M_{A}(\beta)\right) \cdot T_{1}^{n}
$$

Indeed, a bifiltered free resolution induces a $F$-filtered free resolution, thus $K_{F}\left(M ; T_{1}\right)=K_{F, V}\left(M ; T_{1}, T_{2}\right)_{\mid T_{2}=1}$, so $K_{F}\left(M ; 1-T_{1}\right)=K_{F, V}\left(M ; 1-T_{1}, 1-\right.$ $\left.T_{2}\right)_{\mid T_{2}=0}$, and by the Proposition above, we have $\operatorname{codim} \operatorname{gr}^{F}\left(\mathcal{R}_{V}\left(M_{A}(\beta)\right)\right)=$ $\operatorname{codim} M=\operatorname{codim} \operatorname{gr}^{F}\left(M_{A}(\beta)\right)=n$. We conclude by using Proposition 2.3.

Let us note for $1 \leq i \leq d,(A x \xi)_{i}=\sum_{j} a_{i, j} x_{j} \xi_{j} \in \operatorname{gr}^{F}(D)$.

Lemma 5.1. If $\operatorname{gr}^{F}\left(\mathbb{C}[\partial] / I_{A}\right)$ is Cohen-Macaulay, then $(A x \xi)_{1}, \ldots,(A x \partial)_{d}$ is a regular sequence in $\mathrm{gr}^{F}\left(D / D I_{A}\right)$.

Proof. By [13], Proposition 7.5, $\operatorname{dim}\left(C[\partial] / I_{A}\right)=d$. Using Proposition 5.1, we get $\operatorname{dim}\left(\operatorname{gr}^{F}\left(D / D I_{A}\right)\right)=n+d$. But $\operatorname{dim}\left(\mathbb{C}[x, \xi] /\left(A x \xi+\operatorname{gr}^{F}\left(I_{A}\right)\right)=n\right.$ by [18], proof of Proposition 3.8. The results follows from the Cohen-Macaulay assumption.

### 5.1 The homogeneous case

We suppose moreover that the columns of $A$ lie in a common hyperplane, i.e. $(1, \ldots, 1)$ belongs to the $\mathbb{Q}$-row span of $A$. Then $I_{A}$ is homogeneous for the weight vector $(1, \ldots, 1)$ and $M_{A}(\beta)$ is $V$-homogeneous.

Lemma 5.2. $M_{A}(\beta)$ is nicely bifiltered.
Indeed, $M_{A}(\beta)$ is $V$-homogeneous, thus $\mathbf{R}_{F}\left(M_{A}(\beta)\right)$ is also $V$-homogeneous, thus $\operatorname{gr}^{V} \mathbf{R}_{F}\left(M_{A}(\beta)\right) \simeq \mathbf{R}_{F}\left(M_{A}(\beta)\right)$ is $h$-saturated. Then apply Lemma 4.1.

Lemma 5.3. Let $R=\operatorname{bigr} D$ and $M$ be a finite type bigraded $R$-module. Let $P \in R$ be bihomogeneous of degree $(d, k)$. If $P$ is a non zero-divisor on $M$ then

1. $K_{F, V}\left(M / P M ; T_{1}, T_{2}\right)=\left(1-T_{1}^{d} T_{2}^{k}\right) K_{F, V}\left(M ; T_{1}, T_{2}\right)$ and
2. $\mathcal{C}_{F, V}\left(M / P M ; T_{1}, T_{2}\right)=\left(d T_{1}+k T_{2}\right) \mathcal{C}_{F, V}\left(M ; T_{1}, T_{2}\right)$.

Proof. Let us prove 1). If $N$ is a bigraded $R$-module, let $S_{d, k}(N)$ be the bigraded module defined by $\left(S_{d, k}(N)\right)_{d^{\prime}, k^{\prime}}=N_{d^{\prime}-d, k^{\prime}-k}$. In particular, $S_{d, k}\left(D^{r}[\mathbf{n}][\mathbf{m}]\right)=$ $D^{r}[\mathbf{n}+d . \mathbf{1}][\mathbf{m}+k . \mathbf{1}]$. A bigraded free resolution

$$
\cdots \rightarrow \mathcal{L}_{1} \rightarrow \mathcal{L}_{0} \rightarrow M \rightarrow 0
$$

of $M$ induces a bigraded free resolution

$$
\cdots \rightarrow S_{d, k}\left(\mathcal{L}_{1}\right) \rightarrow S_{d, k}\left(\mathcal{L}_{0}\right) \rightarrow S_{d, k}(M) \rightarrow 0
$$

of $S_{d, k}(M)$. We have a bigraded exact sequence

$$
0 \rightarrow S_{d, k}(M) \xrightarrow{P} M \rightarrow \frac{M}{P M} \rightarrow 0 .
$$

Then taking the cone of the morphism of resolutions $S_{d, k}\left(\mathcal{L}_{\bullet}\right) \xrightarrow{P_{\rightarrow}} \mathcal{L}$ • gives a resolution

$$
\cdots \rightarrow S_{d, k}\left(\mathcal{L}_{1}\right) \oplus \mathcal{L}_{2} \rightarrow S_{d, k}\left(\mathcal{L}_{0}\right) \oplus \mathcal{L}_{1} \rightarrow \mathcal{L}_{0} \rightarrow \frac{M}{P M} \rightarrow 0
$$

of $M / P M$. Then 1) follows, and 2) follows from 1).
Let us denote by $\operatorname{vol}(A)$ the normalized volume of the convex hull in $\mathbb{R}^{d}$ of the set $\left\{0, a_{1}, \ldots, a_{n}\right\}$. The normalization means that the set $[0,1] \times \cdots \times[0,1] \subset \mathbb{R}^{d}$ has volume $d!$.

Theorem 5.1. If $\mathbb{C}[\partial] / I_{A}$ is homogeneous and Cohen-Macaulay, then for any $\beta \in \mathbb{C}^{d}$ we have

$$
\mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)=\operatorname{vol}(A) \cdot \sum_{j=d}^{n}\binom{n-d}{j-d} T_{1}^{j} T_{2}^{n-j}
$$

Proof. By Proposition 4.2, Proposition 5.2 and Lemma 5.2, $\mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)$ is equal to the sum of the terms of least degree in $K_{F, V}\left(\operatorname{bigr} M_{A}(\beta) ; 1-T_{1}, 1-T_{2}\right)$, and by Lemma 4.2 we have

$$
\operatorname{bigr} M_{A}(\beta) \simeq \operatorname{gr}^{F} \operatorname{gr}^{V}\left(M_{A}(\beta)\right)=\operatorname{gr}^{F}\left(M_{A}(\beta)\right)
$$

When $\mathbb{C}[\xi] / I_{A}$ is Cohen-Macaulay, $(A x \xi)_{1}, \ldots,(A x \xi)_{d}$ form a regular sequence in $\mathbb{C}[x, \xi] / I_{A}$, and $\operatorname{gr}^{F}\left(H_{A}(\beta)\right)$ is generated by $I_{A}$ and $(A x \xi)_{1}, \ldots,(A x \xi)_{d}$, by Lemma 5.1 and [17], Theorem 4.3.8. Using Lemma 5.3 repeatedly, we get

$$
\mathcal{C}_{F, V}\left(\operatorname{gr}^{F}\left(M_{A}(\beta)\right) ; T_{1}, T_{2}\right)=T_{1}^{d} \cdot \mathcal{C}_{F, V}\left(\mathbb{C}[x, \xi] / I_{A} ; T_{1}, T_{2}\right)
$$

But $\mathcal{C}_{F, V}\left(\mathbb{C}[x, \xi] / I_{A} ; T_{1}, T_{2}\right)=\mathcal{C}_{F, F}\left(\mathbb{C}[\xi] / I_{A} ; T_{1}, T_{2}\right)$ since $I_{A} \subset \mathbb{C}[\xi]$. Let $R=$ $\mathbb{C}[\xi], P\left(T_{1}, T_{2}\right)=K_{F, F}\left(R / I_{A} ; T_{1}, T_{2}\right)$ and $Q(T)=K_{F}\left(R / I_{A} ; T\right)$. Consider a graded free resolution

$$
0 \rightarrow R^{r_{\delta}}\left[\mathbf{n}^{(\delta)}\right] \rightarrow \cdots R^{r_{0}}\left[\mathbf{n}^{(0)}\right] \rightarrow R / I_{A} \rightarrow 0
$$

of $R / I_{A}$. Then we have a bigraded free resolution

$$
0 \rightarrow R^{r_{\delta}}\left[\mathbf{n}^{(\delta)}\right]\left[\mathbf{n}^{(\delta)}\right] \rightarrow \cdots R^{r_{0}}\left[\mathbf{n}^{(0)}\right]\left[\mathbf{n}^{(0)}\right] \rightarrow R / I_{A} \rightarrow 0
$$

of $R / I_{A}$. We deduce that $P\left(T_{1}, T_{2}\right)=Q\left(T_{1} T_{2}\right)$. We have $Q(1-T)=b_{n-d} T^{n-d}+$ $O(n-d+1)$, with $b_{n-d}=\operatorname{deg}\left(R / I_{A}\right) \neq 0$, and $O(n-d+1)$ denotes a polynomial of valuation greater than $n-d$. By [6], Chapter 6 , Theorem 2.3, $\operatorname{deg}\left(R / I_{A}\right)=$ $\operatorname{vol}(A)$. We have

$$
\begin{aligned}
P\left(1-T_{1}, 1-T_{2}\right) & =Q\left(\left(1-T_{1}\right)\left(1-T_{2}\right)\right) \\
& =Q\left(1-\left(T_{1}+T_{2}-T_{1} T_{2}\right)\right) \\
& =b_{n-d}\left(T_{1}+T_{2}\right)^{n-d}+O(n-d+1) \\
& =b_{n-d}\left(\sum_{i=0}^{n-d}\binom{n-d}{i} T_{1}^{i} T_{2}^{n-d-i}\right)+O(n-d+1)
\end{aligned}
$$

from which the statement follows.
To compute the multidegree in the following examples, we used the computer algebra systems Singular [10] and Macaulay2 [9].

Example 1. Let $A=\left(\begin{array}{lll}1 & 1 & 1 \\ 0 & 1 & 2\end{array}\right)$. Then $I_{A}$ is generated by $\partial_{1} \partial_{3}-\partial_{2}^{2}$. For all $\beta, \mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)=2 T_{1}^{3}+2 T_{1}^{2} T_{2}$.

Example 2. Let $A=\left(\begin{array}{llll}1 & 1 & 1 & 1 \\ 0 & 1 & 2 & 3\end{array}\right)$. Then $I_{A}$ is generated by $\partial_{2} \partial_{4}-$ $\partial_{3}^{2}, \partial_{1} \partial_{4}-\partial_{2} \partial_{3}, \partial_{1} \partial_{3}-\partial_{2}^{2}$. For all $\beta, \mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)=3 T_{1}^{4}+6 T_{1}^{3} T_{2}+3 T_{1}^{2} T_{2}^{2}$.

Let us give homogeneous non-Cohen-Macaulay examples from the book [17]. Using Proposition 1.5 repeatedly, we can establish the existence of a stratification of the space of the parameters $\beta_{1}, \beta_{2}$ by the multidegree. In the following two examples, this stratification equals the stratification by the holonomic rank.

Example 3. Let $A=\left(\begin{array}{cccc}1 & 1 & 1 & 1 \\ 0 & 1 & 3 & 4\end{array}\right)$. Then $I_{A}$ is generated by $\partial_{2} \partial_{4}^{2}-$ $\partial_{3}, \partial_{1} \partial_{4}-\partial_{2} \partial_{3}, \partial_{1} \partial_{3}^{2}-\partial_{2}^{2} \partial_{4}, \partial_{1}^{2} \partial_{3}-\partial_{2}^{3}$. For $\left(\beta_{1}, \beta_{2}\right) \neq(1,2)$, we have

$$
\mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)=4 T_{1}^{4}+8 T_{1}^{3} T_{2}+4 T_{1}^{2} T_{2}^{2}
$$

For $\left(\beta_{1}, \beta_{2}\right)=(1,2)$, we have

$$
\mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)=5 T_{1}^{4}+12 T_{1}^{3} T_{2}+10 T_{1}^{2} T_{2}^{2}+4 T_{1} T_{2}^{3}+T_{2}^{4} .
$$

Example 4. Let $A=\left(\begin{array}{ccccc}1 & 1 & 1 & 1 & 1 \\ 0 & 2 & 4 & 7 & 9\end{array}\right)$. Then $I_{A}$ is generated by $\partial_{2} \partial_{4}-$ $\partial_{3}^{2}, \partial_{1}^{2}-\partial_{2} \partial_{3}$. Let $E=\{(2,10),(2,12),(3,19)\}$. For $\left(\beta_{1}, \beta_{2}\right) \notin E$, we have

$$
\mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)=9 T_{1}^{5}+27 T_{1}^{4} T_{2}+27 T_{1}^{3} T_{2}^{2}+9 T_{1}^{2} T_{2}^{3} .
$$

For $\left(\beta_{1}, \beta_{2}\right) \in E$, we have

$$
\mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)=10 T_{1}^{5}+32 T_{1}^{4} T_{2}+37 T_{1}^{3} T_{2}^{2}+19 T_{1}^{2} T_{2}^{3}+5 T_{1} T_{2}^{4}+T_{2}^{5} .
$$

### 5.2 The inhomogeneous case

Following arguments in the book [17], we extend Theorem 5.1 in the inhomogeneous case, for generic parameters $\beta$.

Theorem 5.2. Assume that $\mathbb{C}[\partial, h] / H\left(I_{A}\right)$ is Cohen-Macaulay. Then for generic $\beta$, the module $M_{A}(\beta)$ is nicely bifiltered and

$$
\mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)=\operatorname{vol}(A) \cdot \sum_{j=d}^{n}\binom{n-d}{j-d} T_{1}^{j} T_{2}^{n-j} .
$$

Here, the assumption is that the closure of the variety defined by $I_{A}$ in the projective space $\mathbb{P}^{n}$ is Cohen-Macaulay.

Proof. First, note that the $\mathbb{C}[\partial, h]$-module $\mathbb{C}[\partial, h] / H\left(I_{A}\right)$ and the $\operatorname{gr}^{F}(\mathbb{C}[\partial])$ module $\mathrm{gr}^{F}(\mathbb{C}[\partial]) / \mathrm{gr}^{F}\left(I_{A}\right)$ have same codimension and same projective dimension. Thus by [4], Corollary 19.15, the Cohen-Macaulayness of the former is equivalent to that of the latter.

Also,

$$
\mathcal{C}\left(\operatorname{gr}^{F}(\mathbb{C}[\partial]) / \operatorname{gr}^{F}\left(I_{A}\right) ; T\right)=\mathcal{C}\left(\mathbb{C}[\partial, h] / H\left(I_{A}\right) ; T\right)=\operatorname{deg}\left(\mathbb{C}[\partial, h] / H\left(I_{A}\right)\right) T^{n-d}
$$

and again by $[6]$, Chapter 6 , Theorem $2.3, \operatorname{deg}\left(\mathbb{C}[\partial, h] / H\left(I_{A}\right)\right)=\operatorname{vol}(A)$.
For generic $\beta$, by [17], Theorem 3.1.3 (with $w=(1, \ldots, 1)$ ), and [16], Theorem 2.5,

$$
H^{V}\left(H_{A}(\beta)\right)=D[\theta] H^{V}\left(I_{A}\right)+\sum_{i} D[\theta]\left((A x \partial)_{i}-\beta_{i}\right) .
$$

By Lemma 5.1, because of the Cohen-Macaulay assumption, $(A x \xi)_{1}, \ldots,(A x \xi)_{d}$ is a regular sequence in $\operatorname{gr}^{F}(D[\theta]) / \mathrm{gr}^{F}\left(I_{A}\right)=\mathrm{gr}^{F}(D[\theta]) / \mathrm{gr}^{F}\left(H^{V}\left(I_{A}\right)\right)$. That implies that $H^{V}\left(I_{A}\right)$ and $\left((A x \partial)_{i}-\beta_{i}\right)_{i}$ form an $F$-involutive base of $H^{V}\left(H_{A}(\beta)\right)$ (see [17], Proposition 4.3.2). Then

$$
\begin{aligned}
\operatorname{gr}^{F}\left(H^{V}\left(H_{A}(\beta)\right)\right) & =\operatorname{gr}^{F}(D[\theta]) \operatorname{gr}^{F}\left(H^{V}\left(I_{A}\right)\right)+\sum_{i} \operatorname{gr}^{F}(D[\theta])(A x \partial)_{i} \\
& =\operatorname{gr}^{F}(D[\theta]) \operatorname{gr}^{F}\left(I_{A}\right)+\sum_{i} \operatorname{gr}^{F}(D[\theta])(A x \partial)_{i}
\end{aligned}
$$

Thus $\operatorname{gr}^{F}\left(H^{V}\left(H_{A}(\beta)\right)\right)$ is generated by elements independent of $\theta$; this implies that $\operatorname{gr}^{F}\left(\mathcal{R}_{V}\left(M_{A}(\beta)\right)\right)$ is $\theta$-saturated (consider the graduation given by the degree in $\theta$ ), which is equivalent to niceness by Lemma 4.1.

We have again $\operatorname{bigr} M_{A}(\beta) \simeq \operatorname{gr}^{F} \operatorname{gr}^{V}\left(M_{A}(\beta)\right)$. With same arguments as above, we show that $\operatorname{gr}^{F} \operatorname{gr}^{V}\left(H_{A}(\beta)\right)$ is generated by $\operatorname{gr}^{F}\left(I_{A}\right)$ and $(A x \xi)_{i}$ for generic $\beta$. We conclude the computation of the multidegree as in the proof of Theorem 5.1.

To finish, let us give examples in the inhomogeneous case.
Example 5. Let $A=\left(\begin{array}{lll}0 & 1 & 3 \\ 4 & 3 & 2\end{array}\right)$. Then $I_{A}$ is generated by $\partial_{1}^{7} \partial_{3}^{4}-\partial_{2}^{12}$. The ring $\mathbb{C}[\partial, h] / H\left(I_{A}\right)$ is Cohen-Macaulay. For any $\beta, M_{A}(\beta)$ is nicely bifiltered and $\mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)=12 T_{1}^{3}+12 T_{1}^{2} T_{2}$.

Example 6. Let $A=\left(\begin{array}{cccc}-2 & -1 & 0 & 1 \\ 1 & 1 & 2 & 2\end{array}\right)$. Then $I_{A}$ is generated by $\partial_{2}^{2} \partial_{4}^{2}-$ $\partial_{3}^{3}, \partial_{1} \partial_{4}-\partial_{2} \partial_{3}, \partial_{1} \partial_{3}^{2}-\partial_{2}^{3} \partial_{4}, \partial_{1}^{2} \partial_{3}-\partial_{2}^{4}$. The ring $\mathbb{C}[\partial, h] / H\left(I_{A}\right)$ is not CohenMacaulay. For $\beta$ generic, $M_{A}(\beta)$ is nicely bifiltered and

$$
\mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)=6 T_{1}^{4}+12 T_{1}^{3} T_{2}+6 T_{1}^{2} T_{2}^{2}
$$

We could check that the couple $\beta=(-1,2)$ is exceptional. In that case $M_{A}(\beta)$ is also nicely bifiltered and we have

$$
\mathcal{C}_{F, V}\left(M_{A}(\beta) ; T_{1}, T_{2}\right)=7 T_{1}^{4}+16 T_{1}^{3} T_{2}+12 T_{1}^{2} T_{2}^{2}+4 T_{1} T_{2}^{3}+T_{2}^{4}
$$

Let us remark that in Examples 1-6, the formula of Theorems 5.1 and 5.2 holds for generic $\beta$, sometimes without the Cohen-Macaulay assumption.
