# The Energy-Momentum Tensor on Spin ${ }^{\text {c }}$ Manifolds

#### Abstract

On Spin ${ }^{\text {c }}$ manifolds, we study the Energy-Momentum tensor associated with a spinor field. First, we give a spinorial Gauss type formula for oriented hypersurfaces of a Spin ${ }^{\text {c }}$ manifold. Using the notion of generalized cylinders, we derive the variationnal formula for the Dirac operator under metric deformation and point out that the Energy-Momentum tensor appears naturally as the second fundamental form of an isometric immersion. Finally, we show that generalized Spin ${ }^{\text {c }}$ Killing spinors for Codazzi Energy-Momentum tensor are restrictions of parallel spinors.


Key words: Spin ${ }^{\text {c }}$ structures, Spin $^{\text {c }}$ Gauss formula, metric variation formula for the Dirac operator, Energy-Momentum tensor, generalized cylinder, generalized Killing spinors.

## 1 Introduction

In [14], O. Hijazi proved that on a compact Riemannian spin manifold ( $M^{n}, g$ ) any eigenvalue $\lambda$ of the Dirac operator to which is attached an eigenspinor $\psi$ satisfies

\begin{equation*}
\lambda^{2} \geqslant \inf _{M}\left(\frac{1}{4} \mathrm{Scal}^{M}+\left|\ell^{\psi}\right|^{2}\right) \tag{1}
\end{equation*}
$$

where $\mathrm{Scal}^{M}$ is the scalar curvature of the manifold $M$ and $\ell^{\psi}$ is the field of symmetric endomorphisms associated with the field of quadratic forms $T^{\psi}$ called the EnergyMomentum tensor and defined on the complement set of zeroes of the eigenspinor $\psi$, for any vector $X \in \Gamma(T M)$ by

$$
T^{\psi}(X)=\operatorname{Re}<X \cdot \nabla_{X} \psi, \frac{\psi}{|\psi|^{2}}>.
$$

Here $\nabla$ denotes the Levi-Civita connection on the spinor bundle of $M$ and "." the Clifford multiplication. The limiting case of (1) is characterized by the existence of a spinor field $\psi$ satisfying for all $X \in \Gamma(T M)$,

$$
\begin{equation*}
\nabla_{X} \psi=-\ell^{\psi}(X) \cdot \psi . \tag{2}
\end{equation*}
$$

For Spin ${ }^{\text {c }}$ structures, the complex line bundle $L^{M}$ is endowed with an arbitrary connection and hence an arbitrary curvature $i \Omega^{M}$ which is an imaginairy 2 -form on the manifold. In terms of the Energy-Momentum tensor the author proved in [25] that on a compact Riemannian $\operatorname{Spin}^{\text {c }}$ manifold any eigenvalue $\lambda$ of the Dirac operator to which is attached an eigenspinor $\psi$ satisfies

$$
\begin{equation*}
\lambda^{2} \geqslant \inf _{M}\left(\frac{1}{4} \mathrm{Scal}^{M}-\frac{c_{n}}{4}\left|\Omega^{M}\right|+\left|\ell^{\psi}\right|^{2}\right), \tag{3}
\end{equation*}
$$

where $c_{n}=2\left[\frac{n}{2}\right]^{\frac{1}{2}}$. The limiting case of (3) is characterized by the existence of a spinor field $\psi$ satisfying for every $X \in \Gamma(T M)$,

$$
\left\{\begin{array}{l}
\nabla_{X}^{\Sigma M} \psi=-\ell^{\psi}(X) \cdot \psi,  \tag{4}\\
\Omega^{M} \cdot \psi=i \frac{c_{n}}{2}\left|\Omega^{M}\right| \psi .
\end{array}\right.
$$

Here $\nabla^{\Sigma M}$ denotes the Levi-Civita connection on the Spin ${ }^{c}$ spinor bundle and "." the Spin ${ }^{\text {c }}$ Clifford multiplication. In [25], the author showed also that the sphere with a special Spin $^{\text {c }}$ structure is a limiting manifold for (3).

Studying the Energy-Momentum tensor on a Riemannian or semi-Riemannian spin manifolds has been done by many authors, since it is related to several geometric constructions (see [12], [2], [24] and [6] for results in this topic). In this paper we study the Energy-Momentum tensor on Riemannian and semi-Riemannian Spin ${ }^{c}$ manifolds. First, we prove that the Energy-Momentum tensor appears in the study of the variations of the spectrum of the Dirac operator:

Proposition 1.1 Let $\left(M^{n}, g\right)$ be a $\operatorname{Spin}^{c}$ Riemannian manifold and $g_{t}=g+t k a$ smooth 1-parameter family of metrics. For any spinor field $\psi \in \Gamma(\Sigma M)$, we have

\begin{equation*}
\left.\frac{d}{d t}\right|_{t=0}\left(D^{M_{t}} \tau_{0}^{t} \psi, \tau_{0}^{t} \psi\right)_{g_{t}}=-\frac{1}{2} \int_{M}<k, T_{\psi}>d v_{g}, \tag{5}
\end{equation*}

where (., .) $=\int_{M} \operatorname{Re}\langle.,.\rangle d v_{g}$, the Dirac operator $D^{M_{t}}$ is the Dirac operator associated with $M_{t}=\left(M, g_{t}\right), T_{\psi}=|\psi|^{2} T^{\psi}=\operatorname{Re}<X \cdot \nabla_{X} \psi, \psi>$ and $\tau_{0}^{t} \psi$ is the image of $\psi$ under the isometry $\tau_{0}^{t}$ between the spinor bundles of $(M, g)$ and $\left(M, g_{t}\right)$.

This was proven in [4] by J. P. Bourguignon and P. Gauduchon for spin manifolds. Using this, we extend to Spin ${ }^{\text {c }}$ manifolds a result by Th. Friedrich and E. C. Kim in [8] on spin manifolds:

Theorem 1.2 Let $M$ be a $\operatorname{Spin}^{c}$ Riemannian manifold. A pair $\left(g_{0}, \psi_{0}\right)$ is a critical point of the Lagrange functional

\mathcal{W}(g, \psi)=\int_{U}\left(\mathrm{Scal}_{g}^{M}+\varepsilon \lambda<\psi, \psi>_{g}-<D_{g} \psi, \psi>_{g}\right) d v_{g}
$$

$(\lambda, \varepsilon \in \mathbb{R})$ for all open subsets $U$ of $M$ if and only if $\left(g_{0}, \psi_{0}\right)$ is a solution of the following system

$$
\left\{\begin{array}{r}
D_{g} \psi=\lambda \psi, \\
\operatorname{ric}_{g}^{M}-\frac{\mathrm{Scal}_{g}^{M}}{2} g=\frac{\varepsilon}{4} T_{\psi},
\end{array}\right.
$$

where $\mathrm{ric}_{g}^{M}$ denotes the Ricci curvature of $M$ considered as a symmetric bilinear form.

Now, we interprete the Energy-Momentum tensor as the second fundamental form of a hypersurface. In fact, we prove the following:

Proposition 1.3 Let $M^{n} \hookrightarrow(\mathcal{Z}, g)$ be any compact oriented hypersurface isometrically immersed in an oriented Riemannian $\operatorname{Spin}^{\mathrm{c}}$ manifold ( $\mathcal{Z}, g$ ), of constant mean curvature $H$ and Weingarten map $W$. We assume that $\mathcal{Z}$ admits a parallel spinor field $\psi$, then the Energy-Momentum tensor associated with $\varphi=: \psi_{\left.\right|_{M}}$ satisfies

$$
2 \ell^{\varphi}=-W .
$$

Moreover the hypersurface $M$ satisfies the equality case in (3) if and only if

$$
\begin{equation*}
\operatorname{Scal}^{\mathcal{Z}}-2 \operatorname{ric}^{\mathcal{Z}}(\nu, \nu)-c_{n}\left|\Omega^{M}\right|=0 \tag{6}
\end{equation*}
$$

This was proven by Morel in [24] for a compact oriented hypersurface of a spin manifold carrying parallel spinor but in this case the hypersurface $M$ is directly a limiting manifold for (1) without the condition (6).

Finally, we study generalized Killing spinors on $\operatorname{Spin}^{\text {c }}$ manifolds. They are characterized by the identity, for any tangent vector field $X$ on $M$,

$$
\begin{equation*}
\nabla_{X}^{\Sigma M} \psi=\frac{1}{2} F(X) \cdot \psi \tag{7}
\end{equation*}
$$

where $F$ is a given symmetric endomorphism on the tangent bundle. It is straightforward to see that

$$
2 T^{\psi}(X, Y)=-\langle F(X), Y\rangle .
$$

These spinors are closely related to the so-called $T$-Killing spinors studied by Friedrich and Kim in [9] on spin manifolds. It is natural to ask whether the tensor $F$ can be realized as the Weingarten tensor of some isometric embedding of $M$ in a manifold $\mathcal{Z}^{n+1}$ carrying parallel spinors. Morel studied this problem in the case of spin manifolds where the tensor $F$ is parallel and in [2], the authors studied the problem in the case of semi-Riemannian spin manifolds where the tensor $F$ is a Codazzi-Mainardi tensor. We establish the corresponding result for semi-Riemannian Spin ${ }^{\mathrm{c}}$ manifolds:

Theorem 1.4 Let $\left(M^{n}, g\right)$ be a semi-Riemannian Spin $^{c}$ manifold carrying a generalized Spin ${ }^{\text {c Killing spinor } \varphi \text { with a Codazzi-Mainardi tensor } F \text {. Then the generalized }}$ cylinder $\mathcal{Z}:=I \times M$ with the metric $d t^{2}+g_{t}$, where $g_{t}(X, Y)=g\left((\operatorname{Id}-t F)^{2} X, Y\right)$, equipped with the $\mathrm{Spin}^{\mathrm{c}}$ structure arising from the given one on $M$ has a parallel spinor whose restriction to $M$ is just $\varphi$.

A characterisation of limiting 3-dimensional manifolds for (3), having generalized Spin ${ }^{c}$ Killing spinors with Codazzi tensor is then given.

The paper is organised as follows: In Section 2, we collect basic material on spinors and the Dirac operator on semi-Riemannian $\mathrm{Spin}^{\mathrm{c}}$ manifolds. In Section 3, we study hypersurfaces of $\mathrm{Spin}^{\mathrm{c}}$ manifolds. We derive a spinorial Gauss formula after identifying the restriction of the $\mathrm{Spin}^{\mathrm{c}}$ spinor bundle of the ambient manifold with the Spin ${ }^{\text {c }}$ spinor bundle of the hypersurface. In Section 4, we define the generalized cylinder of a $\mathrm{Spin}^{\mathrm{c}}$ manifold $M$ and we collect formulas relating the curvature of a generalized cylinder to geometric data on $M$. In section 5 , we compare the Dirac operators for two differents semi-Riemannian metrics, then one first has to identify the spinor bundles using parallel transport. In the last section, we interprete the Energy-Momentum tensor as the second fundamental form of a hypersurface and we study generalized Spin ${ }^{\text {c }}$ Killing spinors. ## 2 The Dirac operator on semi-Riemannian Spin ${ }^{c}$ manifolds

In this section, we collect some algebraic and geometric preliminaries concerning the Dirac operator on semi-Riemannian Spin ${ }^{\text {c manifolds. Details can be found in [3] and }}$ [2]. Let $r+s=n$ and consider on $\mathbb{R}^{n}$ the nondegenerate symmetric bilinear form of
signature $(r, s)$ given by

$$
\langle v, w\rangle:=\sum_{j=1}^{r} v_{j} w_{j}-\sum_{j=r+1}^{n} v_{j} w_{j},
$$

for any $v, w \in \mathbb{R}^{n}$. We denote by $\mathrm{Cl}_{r, s}$ the real Clifford algebra corresponding to $\left(\mathbb{R}^{n},\langle\cdot, \cdot\rangle\right)$, this is the unitary algebra generated by $\mathbb{R}^{n}$ subject to the relations

$$
e_{j} \cdot e_{k}+e_{k} \cdot e_{j}=\left\{\begin{array}{cll}
-2 \delta_{j k} & \text { if } & j \leqslant r \\
2 \delta_{j k} & \text { if } & j>r,
\end{array}\right.
$$

where $\left(e_{j}\right)_{1 \leqslant j \leqslant n}$ is an orthonormal basis of $\mathbb{R}^{n}$ of signature $(r, s)$, i.e., $\left\langle e_{j}, e_{k}\right\rangle=\varepsilon_{j} \delta_{j k}$ and $\varepsilon_{j}= \pm 1$. The complex Clifford algebra $\mathbb{C l}_{r, s}$ is the complexification of $\mathrm{Cl}_{r, s}$ and it decomposes into even and odd elements $\mathbb{C l}_{r, s}=\mathbb{C l}_{r, s}^{0} \oplus \mathbb{C l}_{r, s}^{1}$. The real spin group is defined by

$$
\operatorname{Spin}(r, s):=\left\{v_{1} \cdot \ldots \cdot v_{2 k} \in \mathrm{Cl}_{r, s} \mid v_{j} \in \mathbb{R}^{n} \text { such that }\left\langle v_{j}, v_{j}\right\rangle= \pm 1\right\}
$$

The spin group $\operatorname{Spin}(r, s)$ is the double cover of $\mathrm{SO}(r, s)$, in fact the following sequence is exact

$$
1 \longrightarrow \mathbb{Z} / 2 \mathbb{Z} \longrightarrow \operatorname{Spin}(r, s) \xrightarrow{\xi} \mathrm{SO}(r, s) \longrightarrow 1,
$$

where $\xi=\operatorname{Ad}_{\left.\right|_{\operatorname{Spin}(r, s)}}$ and $\operatorname{Ad}$ is defined by

$$
\begin{aligned}
\operatorname{Ad}: \mathrm{Cl}_{r, s}^{*} & \longrightarrow \operatorname{End}\left(\mathbb{R}^{n}\right) \\
w & \longrightarrow \operatorname{Ad}_{w}: v \longrightarrow \operatorname{Ad}_{w}(v)=w \cdot v \cdot w^{-1}
\end{aligned}
$$

Here $\mathrm{Cl}_{r, s}^{*}$ denotes the group of units of $\mathrm{Cl}_{r, s}$. Since $\mathbb{S}^{1} \cap \operatorname{Spin}(r, s)=\{ \pm 1\}$, we define the complex spin group by

$$
\operatorname{Spin}^{c}(r, s)=\operatorname{Spin}(r, s) \times_{\mathbb{Z}_{2}} \mathbb{S}^{1}
$$

The complex spin group is the double cover of $\mathrm{SO}(r, s) \times \mathbb{S}^{1}$, this yields to the exact sequence

$$
1 \longrightarrow \mathbb{Z}_{2} \longrightarrow \operatorname{Spin}^{c}(r, s) \xrightarrow{\xi^{c}} \mathrm{SO}(r, s) \times \mathbb{S}^{1} \longrightarrow 1
$$

where $\xi^{c}=\left(\xi, \mathrm{Id}^{2}\right)$. When $n=2 m$ is even, $\mathbb{C l}_{r, s}$ has a unique irreducible complex representation $\chi_{2 m}$ of complex dimension $2^{m}, \chi_{2 m}: \mathbb{C l}_{r, s} \longrightarrow \operatorname{End}\left(\Sigma_{r, s}\right)$. If $n=$ $2 m+1$ is odd, $\mathbb{C l}_{r, s}$ has two inequivalent irreducible representations both of complex dimension $2^{m}, \chi_{2 m+1}^{j}: \mathbb{C l}_{r, s} \longrightarrow \operatorname{End}\left(\Sigma_{r, s}^{j}\right)$, for $j=0$ or 1 , where $\Sigma_{r, s}^{j}=\{\sigma \in$ $\left.\Sigma_{r, s}, \quad \chi_{2 m+1}^{j}\left(\omega_{r, s}\right) \sigma=(-1)^{j} \sigma\right\}$ and $\omega_{r, s}$ is the complex volume element

$$
\omega_{r, s}=\left\{\begin{array}{lll}
i^{m-s} & e_{1} \cdot \ldots \cdot e_{n} & \text { if } n=2 m \\
i^{m-1+s} & e_{1} \cdot \ldots \cdot e_{n} & \text { if } n=2 m+1 .
\end{array}\right.
$$

We define the complex spinorial representation $\rho_{n}$ by the restriction of an irreducible representation of $\mathbb{C l}_{r, s}$ to $\operatorname{Spin}^{c}(r, s)$ :

$$
\rho_{n}:=\left\{\begin{array}{ll}
\chi_{\left.2 m\right|_{\operatorname{Spin}^{c}(r, s)}} & \text { if } n=2 m, \\
\left.\chi_{2 m+1}^{0}\right|_{\operatorname{Spin}^{c}(r, s)} & \text { if } n=2 m+1,
\end{array} .\right.
$$

When $n=2 m$ is even, $\rho_{n}$ decomposes into two inequivalent irreductible representations $\rho_{n}^{+}$and $\rho_{n}^{-}$, i.e., $\rho_{n}=\rho_{n}^{+}+\rho_{n}^{-}: \operatorname{Spin}^{c}(r, s) \rightarrow \operatorname{Aut}\left(\Sigma_{r, s}\right)$. The space $\Sigma_{r, s}$ decomposes into $\Sigma_{r, s}=\Sigma_{r, s}^{+} \oplus \Sigma_{r, s}^{-}$, where $\omega_{r, s}$ acts on $\Sigma_{r, s}^{+}$as the identity and minus the identity on $\Sigma_{r, s}^{-}$. If $n=r+s$ is odd and when restricted to $\operatorname{Spin}^{c}(r, s)$, the two representations $\left.\chi_{2 m+1}^{0}\right|_{\operatorname{Spin}^{c}(r, s)}$ and $\left.\chi_{2 m+1}^{1}\right|_{\operatorname{SPin}^{c}(r, s)}$ are equivalent and we simply choose $\Sigma_{r, s}:=\Sigma_{r, s}^{0}$. The complex spinor bundle $\Sigma_{r, s}$ carries a Hemitian symmetric bilinear $\operatorname{Spin}^{c}(r, s)$-invariant form $\langle\cdot, \cdot\rangle$, such that

$$
\left\langle v \cdot \sigma_{1}, \sigma_{2}\right\rangle=(-1)^{s+1}\left\langle\sigma_{1}, v \cdot \sigma_{2}\right\rangle \text { for all } \sigma_{1}, \sigma_{2} \in \Sigma_{r, s} \text { and } v \in \mathbb{R}^{n}
$$

Now, we give the following isomorphism $\alpha$, which is of particular importance for the identification of the $\mathrm{Spin}^{\mathrm{c}}$ bundles in the context of immersions of hypersurfaces:

$$
\begin{align*}
\alpha: \mathbb{C l}_{r, s} & \rightarrow \mathbb{C l}_{r+1, s}^{0} \\
e_{j} & \rightarrow \nu \cdot e_{j}, \tag{8}
\end{align*}
$$

where we look at an embedding of $\mathbb{R}^{n}$ onto $\mathbb{R}^{n+1}$ such that $\left(\mathbb{R}^{n}\right)^{\perp}$ is spacelike and spanned by a spacelike unit vector $\nu$.

Let $N^{n}$ be an oriented semi-Riemannian manifold of signature $(r, s)$ and let $P_{\mathrm{SO}} N$ be the $\mathrm{SO}(r, s)$-principal bundle of positively space and time oriented orthonormal tangent frames. A complex $\operatorname{Spin}^{c}$ structure on $N$ is a $\operatorname{Spin}^{c}(r, s)$-principal bundle $P_{\text {Spinc }} N$ over $N$, an $\mathbb{S}^{1}$-principal bundle $P_{\mathbb{S} 1} N$ over $N$ together with a twofold covering map $\Theta: P_{\text {Spin }^{c}} N \longrightarrow P_{\mathrm{SO}} N \times_{N} P_{\mathbb{S}^{1}} N$ such that

$$
\Theta(u a)=\Theta(u) \xi^{c}(a),
$$

for every $u \in P_{\operatorname{Spin}^{c}} N$ and $a \in \operatorname{Spin}^{c}(r, s)$, i.e., $N$ has a $\operatorname{Spin}^{c}$ structure if and only if there exists an $\mathbb{S}^{1}$-principal bundle $P_{\mathbb{S}^{1}} N$ over $N$ such that the transition functions $g_{\alpha \beta} \times l_{\alpha \beta}: U_{\alpha} \cap U_{\beta} \longrightarrow \mathrm{SO}(r, s) \times \mathbb{S}^{1}$ of the $\mathrm{SO}(r, s) \times \mathbb{S}^{1}$-principal bundle $P_{\mathrm{SO}} N \times_{N} P_{\mathbb{S}^{1}} N$ admit lifts to $\operatorname{Spin}^{c}(r, s)$ denoted by $\widetilde{g}_{\alpha \beta} \times \widetilde{l}_{\alpha \beta}: U_{\alpha} \cap U_{\beta} \longrightarrow \operatorname{Spin}^{c}(r, s)$, such that $\xi^{c} \circ\left(\widetilde{g}_{\alpha \beta} \times \widetilde{l}_{\alpha \beta}\right)=g_{\alpha \beta} \times l_{\alpha \beta}$. This, anyhow, is equivalent to the second Stiefel-Whitney class $w_{2}(N)$ being equal, modulo 2 , to the first chern class $c_{1}\left(L^{N}\right)$ of the complex line bundle $L^{N}$. It is the complex line bundle associated with the $\mathbb{S}^{1}$-principal fibre bundle via the standard representation of the unit circle.

Let $\Sigma N:=P_{\text {Spinc }^{c}} N \times_{\rho_{n}} \Sigma_{r, s}$ be the spinor bundle associated with the spinor representation. A section of $\Sigma N$ will be called a spinor field. Using the cocycle condition of the transition functions of the two principal fibre bundles $P_{\text {Spinc }^{c}} N$ and $P_{\mathrm{SO}} N \times_{N} P_{\mathbb{S}^{1}} N$, we can prove that

$$
\Sigma N=\Sigma^{\prime} N \otimes\left(L^{N}\right)^{\frac{1}{2}},
$$

where $\Sigma^{\prime} N$ is the locally defined spin bundle and $\left(L^{N}\right)^{\frac{1}{2}}$ is locally defined too but $\Sigma N$ is globally defined. The tangent bundle $T N=P_{\mathrm{SO}} N \times_{\rho_{0}} \mathbb{R}^{n}$ where $\rho_{0}$ stands for the standard matrix representation of $\mathrm{SO}(r, s)$ on $\mathbb{R}^{n}$, can be seen as the associated vector bundle $T N \simeq P_{\mathrm{Spin}^{c}} N \times_{p r_{1} 0 \xi^{c}{ }_{o \rho} \rho_{0}} \mathbb{R}^{n}$ where $p r_{1}$ is the first projection. One defines the Clifford multiplication at every point $p \in N$ :

$$
\begin{aligned}
& T_{p} N \otimes \Sigma_{p} N \longrightarrow \Sigma_{p} N \\
& {[b, v] \otimes[b, \sigma] \longrightarrow[b, v] \cdot[b, \sigma]:=\left[b, v \cdot \sigma=\chi_{n}(v) \sigma\right],}
\end{aligned}
$$

where $b \in P_{\text {Spinc }^{c}} N, v \in \mathbb{R}^{n}, \sigma \in \Sigma_{r, s}$ and $\chi_{n}=\chi_{2 m}$ if $n$ is even and $\chi_{n}=\chi_{2 m+1}^{0}$ if $n$ is odd. The Clifford multiplication can be extended to differential forms. Clifford multiplication inherits the relations of the Clifford algebra, i.e., for $X, Y \in T_{p} N$ and $\varphi \in \Sigma_{p} N$ we have $X \cdot Y \cdot \varphi+Y \cdot X \cdot \varphi=-2\langle X, Y\rangle \varphi$. In even dimensions the spinor bundle splits into $\Sigma N=\Sigma^{+} N \oplus \Sigma^{-} N$, where $\Sigma^{ \pm} N=P_{\text {Spin }^{c}} N \times_{\rho_{n}^{ \pm}} \Sigma_{r, s}^{ \pm}$. Clifford multiplication by a non-vanishing tangent vector interchanges $\Sigma^{+} N$ and $\Sigma^{-} N$. The $\operatorname{Spin}^{c}(r, s)$-invariant nondegenerate symmetric sesquilinear form on $\Sigma_{r, s}$ and $\Sigma_{r, s}^{ \pm}$ induces inner products on $\Sigma N$ and $\Sigma^{ \pm} N$ which we again denote by $\langle\cdot, \cdot\rangle$ and it satisfies

$$
\langle X \cdot \psi, \varphi\rangle=(-1)^{s+1}\langle\psi, X \cdot \varphi\rangle,
$$

for every $X \in \Gamma(T N)$ and $\psi, \varphi \in \Gamma(\Sigma N)$. Additionally, given a connection 1-form $A^{N}$ on $P_{\mathbb{S}^{1}} N, A^{N}: T\left(P_{\mathbb{S}^{1}} N\right) \longrightarrow i \mathbb{R}$ and the connection 1-form $\omega^{N}$ on $P_{\mathrm{SO}} N$ for the Levi-Civita connection $\nabla^{N}$, we can define the connection

$$
\omega^{N} \times A^{N}: T\left(P_{\mathrm{SO}} N \times_{N} P_{\mathbb{S}^{1}} N\right) \longrightarrow \mathfrak{s o}_{n} \oplus i \mathbb{R}=\mathfrak{s p i n}_{n}^{\mathbb{C}}
$$

on the principal fibre bundle $P_{\mathrm{SO}} N \times_{N} P_{\mathbb{S}^{1}} N$ and hence a covariant derivative $\nabla^{\Sigma N}$ on $\Sigma N$ [7] given locally by

$$
\begin{align*}
\nabla_{e_{k}}^{\Sigma N} \varphi & =\left[\widetilde{b \times s}, e_{k}(\sigma)+\frac{1}{4} \sum_{j=1}^{n} \varepsilon_{j} e_{j} \cdot \nabla_{e_{k}}^{N} e_{j} \cdot \sigma+\frac{1}{2} A^{N}\left(s_{*}\left(e_{k}\right)\right) \sigma\right] \\
& =e_{k}(\varphi)+\frac{1}{4} \sum_{j=1}^{n} \varepsilon_{j} e_{j} \cdot \nabla_{e_{k}}^{N} e_{j} \cdot \varphi+\frac{1}{2} A^{N}\left(s_{*}\left(e_{k}\right)\right) \varphi \tag{9}
\end{align*}
$$

where $\varphi=\widetilde{[6 \times s}, \sigma]$ is a locally defined spinor field, $b=\left(e_{1}, \ldots, e_{n}\right)$ is a local space and time oriented orthonormal tangent frame, $s: U \longrightarrow P_{\mathbb{S}^{1}} N$ is a local section of
$P_{\mathbb{S}^{1}} N$ and $\widetilde{b \times s}$ is the lift of the local section $b \times s: U \rightarrow P_{\mathrm{SO}} N \times_{N} P_{\mathbb{S}^{1}} N$ to the 2fold covering $\Theta: P_{\text {Spinc }} N \longrightarrow P_{\text {SO }} N \times_{N} P_{\mathbb{S}^{1}} N$. The curvature of $A^{N}$ is an imaginary valued 2-form denoted by $F_{A^{N}}=d A^{N}$, i.e., $F_{A^{N}}=i \Omega^{N}$, where $\Omega^{N}$ is a real valued 2 -form on $P_{\mathbb{S}^{1}} N$. We know that $\Omega^{N}$ can be viewed as a real valued 2-form on $N[7]$. In this case $i \Omega^{N}$ is the curvature form of the associated line bundle $L^{N}$. The curvature tensor $\mathcal{R}^{\Sigma N}$ of $\nabla^{\Sigma N}$ is given by

$$
\begin{equation*}
\mathcal{R}^{\Sigma N}(X, Y) \varphi=\frac{1}{4} \sum_{j, k=1}^{n} \varepsilon_{j} \varepsilon_{k}\left\langle R^{N}(X, Y) e_{j}, e_{k}\right\rangle e_{j} \cdot e_{k} \cdot \varphi+\frac{i}{2} \Omega^{N}(X, Y) \varphi, \tag{10}
\end{equation*}
$$

where $R^{N}$ is the curvature tensor of the Levi-Civita connection $\nabla^{N}$. In the Spin $^{c}$ case, the Ricci identity translates, for every $X \in \Gamma(T N)$, to

$$
\begin{equation*}
\left.\sum_{k=1}^{n} \varepsilon_{k} e_{k} \cdot \mathcal{R}^{\Sigma N}\left(e_{k}, X\right) \varphi=\frac{1}{2} \operatorname{Ric}^{N}(X) \cdot \varphi-\frac{i}{2}(X\lrcorner \Omega^{N}\right) \cdot \varphi . \tag{11}
\end{equation*}
$$

Here $\mathrm{Ric}^{N}$ denotes the Ricci curvature considered as a field of endomorphism on $T N$. The Ricci curvature considered as a symmetric bilinear form will be written $\operatorname{ric}^{N}(Y, Z)=\left\langle\operatorname{Ric}^{N}(Y), Z\right\rangle$. The Dirac operator maps spinor fields to spinor fields and is locally defined by

$$
D^{N} \varphi=i^{s} \sum_{j=1}^{n} \varepsilon_{j} e_{j} \cdot \nabla_{e_{j}}^{\Sigma N} \varphi,
$$

for every spinor field $\varphi$. The Dirac operator is an elliptic operator, formally selfadjoint, i.e., if $\psi$ or $\varphi$ has compact support, then $\left(D^{N} \varphi, \psi\right)=\left(\varphi, D^{N} \psi\right)$, where $(\varphi, \psi)=$ $\int_{N}\langle\varphi, \psi\rangle d v_{g}$.

## 3 Semi-Riemannian $\operatorname{Spin}^{c}$ hypersurfaces and the Guass formula

In this section, we study $\operatorname{Spin}^{\text {c }}$ structures of hypersurfaces, such as the restriction of a Spin ${ }^{\text {c }}$ bundle of an ambient semi-Riemannian manifold and the complex spinorial Gauss formula.

Let $\mathcal{Z}$ be an oriented $(n+1)$-dimensional semi-Riemannian $\operatorname{Spin}^{c}$ manifold and $M \subset \mathcal{Z}$ a semi-Riemannian hypersurface with trivial spacelike normal bundle. This means that there is a vector field $\nu$ on $\mathcal{Z}$ along $M$ satisfying $\langle\nu, \nu\rangle=+1$ and $\langle\nu, T M\rangle=0$. Hence if the signature of $M$ is $(r, s)$, then the signature of $\mathcal{Z}$ is $(r+1, s)$.

Proposition 3.1 The hypersurface $M$ inherts a $\operatorname{Spin}^{c}$ structure from that on $\mathcal{Z}$, and we have

$$
\begin{cases}\Sigma \mathcal{Z}_{\left.\right|_{M}} \simeq \Sigma M & \text { if } n \text { is even } \\ \Sigma^{+} \mathcal{Z}_{\left.\right|_{M}} \simeq \Sigma M & \text { if } n \text { is odd }\end{cases}
$$

Moreover Clifford multiplication by a vector field $X$, tangent to $M$, is given by

$$
\begin{equation*}
X \bullet \varphi=(\nu \cdot X \cdot \psi)_{\left.\right|_{M}}, \tag{12}
\end{equation*}
$$

where $\psi \in \Gamma(\Sigma \mathcal{Z})$ (or $\psi \in \Gamma\left(\Sigma^{+} \mathcal{Z}\right)$ if $n$ is odd), $\varphi$ is the restriction of $\psi$ to $M$, "." is the Clifford multiplication on $\mathcal{Z}$, and " $\bullet$ " that on $M$.

Proof: The bundle of space and time oriented orthonormal frames of $M$ can be embedded into the bundle of space and time oriented orthonormal frames of $\mathcal{Z}$ restricted to $M$, by

$$
\begin{align*}
\Phi: \quad P_{\mathrm{SO}} M & \longrightarrow P_{\mathrm{SO}} \mathcal{Z}_{\left.\right|_{M}}  \tag{13}\\
\left(e_{1}, \cdots, e_{n}\right) & \longrightarrow\left(\nu, e_{1}, \cdots, e_{n}\right) .
\end{align*}
$$

The isomorphism $\alpha$, defined in (8) yields the following commutative diagram:

where the inclusion of $\mathrm{SO}(r, s)$ in $\mathrm{SO}(r+1, s)$ is that which fixes the first basis vector under the action of $\mathrm{SO}(r+1, s)$ on $\mathbb{R}^{n+1}$. This allows to pull back via $\Phi$ the principal bundle $P_{\text {Spinc }} \mathcal{Z}_{\left.\right|_{M}}$ as a $\operatorname{Spin}^{c}$ structure for $M$, denoted by $P_{\text {Spinc }} M$. Thus, we have the following commutative diagram:


The $\operatorname{Spin}^{c}(r, s)$-principal bundle $\left(P_{\text {Spin }} M, \pi, M\right)$ and the $\mathbb{S}^{1}$-principal bundle $\left(P_{\mathbb{S}^{1}} M=:\left.P_{\mathbb{S}^{1}} \mathcal{Z}\right|_{M}, \pi, M\right)$ define a $\operatorname{Spin}^{\mathrm{c}}$ structure on $M$. Let $\Sigma \mathcal{Z}$ be the spinor bundle on $\mathcal{Z}$,

$$
\Sigma \mathcal{Z}=P_{\mathrm{Spinc}^{\mathrm{c}}} \mathcal{Z} \times_{\rho_{n+1}} \Sigma_{r+1, s},
$$

where $\rho_{n+1}$ stands for the spinorial representation of $\operatorname{Spin}^{c}(r+1, s)$. Moreover, for any spinor $\psi=[\widetilde{b \times s}, \sigma] \in \Sigma \mathcal{Z}$ we can always assume that $p r_{1} \circ \Theta(\widetilde{b \times s})=b$ is a local section of $P_{\mathrm{SO}} \mathcal{Z}$ with $\nu$ for first basis vector where $p r_{1}$ is the projection into $P_{\mathrm{SO}} \mathcal{Z}$. Then we have

$$
\psi_{\left.\right|_{M}}=\left[\widetilde{b \times s_{\mid U \cap M}}, \sigma_{\mid U \cap M}\right],
$$

where the equivalence class is reduced to elements of $\operatorname{Spin}^{c}(r, s)$. It follows that one can realise the restriction to $M$ of the spinor bundle $\Sigma \mathcal{Z}$ as

$$
\Sigma \mathcal{Z}_{\left.\right|_{M}}=P_{\text {Spinc }^{c}} M \times_{\rho_{n+1} \circ \alpha} \Sigma_{r+1, s} .
$$

If $n=2 m$ is even, it is easy to check that $\chi_{2 m+1}^{0} \circ \alpha=\left.\chi_{2 m+1}^{0}\right|_{| |_{r+1, s}^{0}}$. Hence $\chi_{2 m+1}^{0} \circ \alpha$ is an irreductible representation of $\mathbb{C l}_{r, s}$ of dimension $2^{m}$, as $\chi_{2 m+\left.1\right|_{\mathrm{Cl}_{r+1, s}^{0}} ^{0}}$, and finally $\chi_{2 m+1}^{0} \circ \alpha \cong \chi_{2 m}$. We conclude that

$$
\rho_{2 m+1} \circ \alpha \cong \rho_{2 m}, \quad \text { and } \quad \Sigma \mathcal{Z}_{\left.\right|_{M}} \cong \Sigma M .
$$

If $n=2 m+1$ is odd, we know that $\chi_{2 m+1}^{0}$ is the unique irreductible representation of $\mathbb{C l}_{r, s}$ of dimension $2^{m}$ for which the action of the complex volume form is the identity. Since $n+1=2 m+2$ is even, $\Sigma \mathcal{Z}$ decomposes into positive and negative parts, $\Sigma^{ \pm} \mathcal{Z}=$ $P_{\text {Spinc }} \mathcal{Z} \times \times_{\rho_{2 m+1}^{ \pm}} \Sigma_{r+1, s}^{ \pm}$. It is easy to show that $\chi_{2 m+2} \circ \alpha=\chi_{2 m+\left.2\right|_{\mathbb{C}_{r+1, s}^{0}}}$, but $\chi_{2 m+2} \circ \alpha$ can be written as the direct sum of two irreductible inequivalent representations, as $\chi_{2 m+\left.2\right|_{\mathrm{cl}_{r+1, s}^{0}}}$. Hence, we have

$$
\chi_{2 m+2} \circ \alpha=\left(\chi_{2 m+2} \circ \alpha\right)^{+} \oplus\left(\chi_{2 m+1} \circ \alpha\right)^{-},
$$

where $\left(\chi_{2 m+2} \circ \alpha\right)^{ \pm}\left(\omega_{r, s}\right)= \pm \operatorname{Id}_{\Sigma_{r, s}}$. The representation $\chi_{2 m+1}^{0}$ being the unique representation of $\mathbb{C l}_{r, s}$ of dimension $2^{m}$ for which the action of the volume form is the identity, we get $\left(\chi_{2 m+2} \circ \alpha\right)^{+} \cong \chi_{2 m+1}^{0}$. Finally,

$$
\rho_{2 m+2}^{+} \circ \alpha \cong \rho_{2 m+1} \quad \text { and } \quad \Sigma^{+} \mathcal{Z}_{\left.\right|_{M}} \cong \Sigma M .
$$

Now, Equation (12) follows directly from the above identification.

Remarks 3.2 1. The algebraic remarks in the previous section show that if $n$ is odd we can also get $\Sigma^{-} \mathcal{Z}_{\left.\right|_{M}} \simeq \Sigma M$, where the Clifford multiplication by a vector field tangent to $M$ is given by $X \bullet \varphi=-(\nu \cdot X \cdot \psi)_{\left.\right|_{M}}$.
2. The connection 1-form defined on the restricted $\mathbb{S}^{1}$-principal bundle $\left(P_{\mathbb{S}_{1}} M=\right.$ : $\left.P_{\mathbb{S}^{1}} \mathcal{Z}_{\left.\right|_{M}}, \pi, M\right)$, is given by

$$
A^{M}=A_{\left.\right|_{M}}^{\mathcal{Z}}: T\left(P_{\mathbb{S}^{1}} M\right)=T\left(P_{\mathbb{S}^{1}} \mathcal{Z}\right)_{\left.\right|_{M}} \longrightarrow i \mathbb{R} .
$$

Then the curvature 2 -form $i \Omega^{M}$ on the $\mathbb{S}^{1}$-principal bundle $P_{\mathbb{S}^{1}} M$ is given by $i \Omega^{M}=$ $i \Omega^{\mathcal{Z}}{ }_{\left.\right|_{M}}$, which can be viewed as an imaginary 2-form on $M$ and hence as the curvature form of the line bundle $L^{M}$, the restriction of the line bundle $L^{\mathcal{Z}}$ to $M$.
3. For every $\psi \in \Gamma(\Sigma \mathcal{Z})\left(\psi \in \Gamma\left(\Sigma^{+} \mathcal{Z}\right)\right.$ if $n$ is odd $)$, the real 2 -forms $\Omega^{M}$ and $\Omega^{\mathcal{Z}}$ are related by the following formulas:

$$
\begin{equation*}
\left.\left|\Omega^{\mathcal{Z}}\right|^{2}=\left|\Omega^{M}\right|^{2}+\mid \nu\right\lrcorner\left.\Omega^{\mathcal{Z}}\right|^{2}, \tag{14}
\end{equation*}
$$

$$
\begin{equation*}
\left.\left(\Omega^{\mathcal{Z}} \cdot \psi\right)_{\left.\right|_{M}}=\Omega^{M} \bullet \varphi+(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \bullet \varphi . \tag{15}
\end{equation*}
$$

In fact, we can write

$$
\left.\Omega^{\mathcal{Z}}=\sum_{i=1}^{n} \Omega^{\mathcal{Z}}\left(\nu, e_{i}\right) \nu \wedge e_{i}+\sum_{i<j}^{n} \Omega^{\mathcal{Z}}\left(e_{i}, e_{j}\right) e_{i} \wedge e_{j}=-(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \wedge \nu+\Omega^{M},
$$

which is (14). When restricting the Clifford multiplication of $\Omega^{\mathcal{Z}}$ by $\psi$ to the hypersurface $M$ we obtain

$$
\begin{equation*}
\left.\left.\left(\Omega^{\mathcal{Z}} \cdot \psi\right)_{\left.\right|_{M}}=\left(\nu \cdot(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \psi\right)_{\left.\right|_{M}}+\left(\Omega^{M} \cdot \psi\right)_{\left.\right|_{M}}=(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \bullet \varphi+\Omega^{M} \bullet \varphi . \tag{16}
\end{equation*}
$$

Proposition 3.3 (The spinorial Gauss formula) We denote by $\nabla^{\Sigma \mathcal{Z}}$ the spinorial Levi-Civita connection on $\Sigma \mathcal{Z}$ and by $\nabla^{\Sigma M}$ that on $\Sigma M$. For all $X \in \Gamma(T M)$ and for every spinor field $\psi \in \Gamma(\Sigma \mathcal{Z})$, then

$$
\begin{equation*}
\left(\nabla_{X}^{\Sigma \mathcal{Z}} \psi\right)_{\left.\right|_{M}}=\nabla_{X}^{\Sigma M} \varphi-\frac{1}{2} W(X) \bullet \varphi \tag{17}
\end{equation*}
$$

where $W$ denotes the Weingarten map with respect to $\nu$ and $\varphi=\psi_{\left.\right|_{M}}$. Moreover, let $D^{\mathcal{Z}}$ and $D^{M}$ be the Dirac operators on $\mathcal{Z}$ and $M$. Denoting by the same symbol any spinor and it's restriction to $M$, we have

$$
\begin{equation*}
\nu \cdot D^{\mathcal{Z}} \varphi=\widetilde{D} \varphi+\frac{i^{s} n}{2} H \varphi-i^{s} \nabla_{\nu}^{\Sigma \mathcal{Z}} \varphi \tag{18}
\end{equation*}
$$

where $H=\frac{1}{n} \operatorname{tr}(W)$ denotes the mean curvature and $\widetilde{D}=D^{M}$ if $n$ is even and $\widetilde{D}=D^{M} \oplus\left(-D^{M}\right)$ if $n$ is odd.

Proof: The Riemannian Gauss formula is given, for every vector fields $X$ and $Y$ on $M$, by

$$
\begin{equation*}
\nabla_{X}^{\mathcal{Z}} Y=\nabla_{X}^{M} Y+\langle W(X), Y\rangle \nu \tag{19}
\end{equation*}
$$

Let $\left(e_{1}, e_{2}, \ldots, e_{n}\right)$ a local space and time oriented orthonormal frame of $M$, such that $b=\left(e_{0}=\nu, e_{1}, e_{2}, \ldots, e_{n}\right)$ is that of $\mathcal{Z}$. We consider $\psi$ a local section of $\Sigma \mathcal{Z}$, $\psi=[\widetilde{b \times s}, \sigma]$ where $s$ is a local section of $P_{\mathbb{S}^{1}} \mathcal{Z}$. Using (9), (19) and the fact that $\left.X(\psi)\right|_{M}=X(\varphi)$ for $X \in \Gamma(T M)$, we compute for $j=1, \ldots, n$

$$
\begin{aligned}
\left(\nabla_{e_{j}}^{\Sigma \mathcal{Z}} \psi\right)_{\left.\right|_{M}} & =e_{j}(\varphi)+\frac{1}{4} \sum_{k=0}^{n} \varepsilon_{k}\left(e_{k} \cdot \nabla_{e_{j}}^{\mathcal{Z}} e_{k} \cdot \psi\right)_{\left.\right|_{M}}+\frac{1}{2} A^{Z}\left(s_{*}\left(e_{j}\right)\right) \varphi \\
& =e_{j}(\varphi)+\frac{1}{4} \sum_{k=1}^{n} \varepsilon_{k}\left(e_{k} \cdot \nabla_{e_{j}}^{\mathcal{Z}} e_{k} \cdot \psi\right)_{\left.\right|_{M}}+\frac{1}{4}\left(\nu \cdot \nabla_{e_{j}}^{\mathcal{Z}} \nu \cdot \psi\right)_{\left.\right|_{M}}+\frac{1}{2} A^{M}\left(s_{*}\left(e_{j}\right)\right) \varphi \\
& =\nabla_{e_{j}}^{\Sigma M} \varphi+\frac{1}{4} \sum_{k=1}^{n} \varepsilon_{k}<W\left(e_{j}\right), e_{k}>\left(e_{k} \cdot \nu \cdot \psi\right)_{\left.\right|_{M}}-\frac{1}{4}\left(\nu \cdot W\left(e_{j}\right) \cdot \psi\right)_{\left.\right|_{M}} \\
& =\nabla_{e_{j}}^{\Sigma M} \varphi-\frac{1}{2}\left(\nu \cdot W\left(e_{j}\right) \cdot \psi\right)_{\left.\right|_{M}} \\
& =\nabla_{e_{j}}^{\Sigma M} \varphi-\frac{1}{2} W\left(e_{j}\right) \bullet \varphi .
\end{aligned}
$$

Moreover $\left(D^{\mathcal{Z}} \psi\right)_{\left.\right|_{M}}=i^{s} \sum_{j=1}^{n} \varepsilon_{j}\left(e_{j} \cdot \nabla_{e_{j}}^{\Sigma \mathcal{Z}} \psi\right)_{\left.\right|_{M}}+i^{s}\left(\nu \cdot \nabla_{\nu}^{\Sigma \mathcal{Z}} \psi\right)_{\left.\right|_{M}}$, and by (17),

$$
\begin{aligned}
i^{s} \sum_{j=1}^{n} \varepsilon_{j}\left(e_{j} \cdot \nabla_{e_{j}}^{\Sigma \mathcal{Z}} \psi\right)_{\left.\right|_{M}} & =i^{s} \sum_{j=1}^{n} \varepsilon_{j}\left(e_{j} \cdot \nabla_{e_{j}}^{\Sigma M} \varphi\right)-i^{s} \frac{1}{2} \sum_{j=1}^{n} \varepsilon_{j}\left(e_{j} \cdot \nu \cdot W\left(e_{j}\right) \cdot \psi\right)_{\left.\right|_{M}} \\
& =-i^{s} \nu \cdot \sum_{j=1}^{n} \varepsilon_{j} \nu \cdot e_{j} \cdot \nabla_{e_{j}}^{\Sigma M} \varphi+i^{s} \frac{1}{2} \sum_{j=1}^{n} \varepsilon_{j}\left(\nu \cdot e_{j} \cdot W\left(e_{j}\right) \cdot \psi\right)_{\left.\right|_{M}} \\
& =-\nu \cdot \widetilde{D} \varphi-\frac{i^{s}}{2} \operatorname{tr}(W)(\nu \cdot \psi)_{\left.\right|_{M}}
\end{aligned}
$$

Proposition 3.4 Let $\mathcal{Z}$ be an $(n+1)$-dimensional semi-Riemannian $\operatorname{Spin}^{c}$ manifold. Assume that $\mathcal{Z}$ carries a semi-Riemannian foliation by hypersurfaces with trivial spacelike normal bundle, i.e., the leaves $M$ are semi-Riemannian hypersurfaces and there exists a vector field $\nu$ on $\mathcal{Z}$ perpendicular to the leaves such that $\langle\nu, \nu\rangle=1$ and $\nabla_{\nu}^{\mathcal{Z}} \nu=0$. Then the commutator of the leafwise Dirac operator and the normal derivative is given by
$\left.i^{-s}\left[\nabla_{\nu}^{\Sigma \mathcal{Z}}, \widetilde{D}\right] \varphi=\mathfrak{D}^{W} \varphi-\frac{n}{2} \nu \cdot \operatorname{grad}^{M}(H) \cdot \varphi+\frac{1}{2} \nu \cdot \operatorname{div}^{M}(W) \cdot \varphi+\frac{i}{2} \nu \cdot(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \varphi$.
Here $\operatorname{grad}^{M}$ denotes the leafwise gradient, $\operatorname{div}^{M}(W)=\sum_{i=1}^{n} \varepsilon_{i}\left(\nabla_{e_{i}}^{M} W\right)\left(e_{i}\right)$ denotes the leafwise divergence of the endomorphism field $W$ and $\mathfrak{D}^{W} \varphi \stackrel{e_{i}}{=} \sum_{i=1}^{n} \varepsilon_{i} \nu \cdot e_{i}$. $\nabla_{W\left(e_{i}\right)}^{\Sigma M} \varphi$.

Proof: We choose a local oriented orthonormal tangent frame $\left(e_{1}, \ldots, e_{n}\right)$ for the leaves and we may assume for simplicity that $\nabla_{\nu}^{\mathcal{Z}} e_{j}=0$. Now, we compute

= & \sum_{j=1}^{n} \varepsilon_{j} \nu \cdot e_{j} \cdot\left(\nabla_{\nu}^{\Sigma \mathcal{Z}} \nabla_{e_{j}}^{\Sigma M} \varphi-\nabla_{e_{j}}^{\Sigma M} \nabla_{\nu}^{\Sigma \mathcal{Z}} \varphi\right) \\
\stackrel{(17)}{=} & \sum_{j=1}^{n} \varepsilon_{j} \nu \cdot e_{j} \cdot\left[\nabla_{\nu}^{\Sigma \mathcal{Z}}\left(\nabla_{e_{j}}^{\Sigma \mathcal{Z}}+\frac{1}{2} \nu \cdot W\left(e_{j}\right)\right)\right. \\
& \left.-\left(\nabla_{e_{j}}^{\Sigma \mathcal{Z}}+\frac{1}{2} \nu \cdot W\left(e_{j}\right)\right) \nabla_{\nu}^{\Sigma \mathcal{Z}}\right] \varphi \\
= & \sum_{j=1}^{n} \varepsilon_{j} \nu \cdot e_{j} \cdot\left(\mathcal{R}^{\Sigma \mathcal{Z}}\left(\nu, e_{j}\right)+\nabla_{\left[\nu, e_{j}\right]}^{\Sigma \mathcal{Z}}+\frac{1}{2} \nu \cdot\left(\nabla_{\nu}^{\mathcal{Z}} W\right)\left(e_{j}\right)\right) \varphi \\
\stackrel{(11)}{=} & \left.-\frac{1}{2} \nu \cdot \operatorname{Ric}^{\mathcal{Z}}(\nu) \cdot \varphi+\frac{i}{2} \nu \cdot(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \varphi \\
& +\sum_{j=1}^{n} \varepsilon_{j} \nu \cdot e_{j} \cdot\left(\nabla_{W\left(e_{j}\right)}^{\Sigma \mathcal{Z}}+\frac{1}{2} \nu \cdot\left(\nabla_{\nu}^{\mathcal{Z}} W\right)\left(e_{j}\right)\right) \varphi
\end{aligned}
$$

$$
\begin{aligned}
\stackrel{(17)}{=} & \left.-\frac{1}{2} \nu \cdot \operatorname{Ric}^{\mathcal{Z}}(\nu) \cdot \varphi+\frac{i}{2} \nu \cdot(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \varphi \\
& +\sum_{j=1}^{n} \varepsilon_{j} \nu \cdot e_{j} \cdot\left(\nabla_{W\left(e_{j}\right)}^{\Sigma M}-\frac{1}{2} \nu \cdot W^{2}\left(e_{j}\right)+\frac{1}{2} \nu \cdot\left(\nabla_{\nu}^{\mathcal{Z}} W\right)\left(e_{j}\right)\right) \varphi \\
= & \left.-\frac{1}{2} \nu \cdot \operatorname{Ric}^{\mathcal{Z}}(\nu) \cdot \varphi+\frac{i}{2} \nu \cdot(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \varphi+\mathfrak{D}^{W} \varphi \\
& +\frac{1}{2} \sum_{j=1}^{n} \varepsilon_{j} e_{j} \cdot\left(-W^{2}\left(e_{j}\right)+\left(\nabla_{\nu}^{\mathcal{Z}} W\right)\left(e_{j}\right)\right) \varphi .
\end{aligned}
$$

The Riccati equation for the Weingarten map $\left(\nabla_{\nu}^{\mathcal{Z}} W\right)(X)=R^{\mathcal{Z}}(X, \nu) \nu+W^{2}(X)$ yields

\begin{align*}
i^{-s}\left[\nabla_{\nu}^{\Sigma \mathcal{Z}}, \widetilde{D}\right] \varphi= & \left.-\frac{1}{2} \nu \cdot \operatorname{Ric}^{\mathcal{Z}}(\nu) \cdot \varphi+\frac{i}{2} \nu \cdot(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \varphi+\mathfrak{D}^{W} \varphi \\
& +\frac{1}{2} \sum_{j=1}^{n} \varepsilon_{j} e_{j} \cdot\left(R^{\mathcal{Z}}\left(e_{j}, \nu\right) \nu\right) \cdot \varphi \\
= & \left.-\frac{1}{2} \nu \cdot \operatorname{Ric}^{\mathcal{Z}}(\nu) \cdot \varphi+\frac{i}{2} \nu \cdot(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \varphi+\mathfrak{D}^{W} \varphi+\frac{1}{2} \operatorname{ric}^{\mathcal{Z}}(\nu, \nu) \varphi \\
= & \left.\mathfrak{D}^{W} \varphi-\frac{1}{2} \sum_{j=1}^{n} \varepsilon_{i} \operatorname{ric}^{\mathcal{Z}}\left(\nu, e_{j}\right) \nu \cdot e_{j} \cdot \varphi+\frac{i}{2} \nu \cdot(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \varphi \tag{20}
\end{align*}
$$

The Codazzi-Mainardi equation for $X, Y, V \in T M$ is given by $\left\langle R^{\mathcal{Z}}(X, Y) V, \nu\right\rangle=$ $\left\langle\left(\nabla_{X}^{M} W\right)(Y), V\right\rangle-\left\langle\left(\nabla_{Y}^{M} W\right)(X), V\right\rangle$. Thus,

\operatorname{ric}^{\mathcal{Z}}(\nu, X) & =\sum_{j=1}^{n} \varepsilon_{j}\left\langle R^{\mathcal{Z}}\left(X, e_{j}\right) e_{j}, \nu\right\rangle \\
& =\sum_{j=1}^{n} \varepsilon_{j}\left(\left\langle\left(\nabla_{X}^{M} W\right)\left(e_{j}\right), e_{j}\right\rangle-\left\langle\left(\nabla_{e_{j}}^{M} W\right)(X), e_{j}\right\rangle\right) \\
& =\operatorname{tr}\left(\nabla_{X}^{M} W\right)-\left\langle\operatorname{div}^{M}(W), X\right\rangle .
\end{aligned}
$$

Plugging this into (20) we get

& \left.+\frac{i}{2} \nu \cdot(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \varphi \\
= & \mathfrak{D}^{W} \varphi-\frac{1}{2} \sum_{j=1}^{n} \varepsilon_{j} e_{j}(\operatorname{tr}(W)) \nu \cdot e_{j} \cdot \varphi+\frac{1}{2} \nu \cdot \operatorname{div}^{M}(W) \cdot \varphi \\
& \left.+\frac{i}{2} \nu \cdot(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \varphi \\
= & \left.\mathfrak{D}^{W} \varphi-\frac{n}{2} \nu \cdot \operatorname{grad}^{M}(H) \cdot \varphi+\frac{1}{2} \nu \cdot \operatorname{div}^{M}(W) \cdot \varphi+\frac{i}{2} \nu \cdot(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \varphi .
\end{aligned}
$$

## 4 The generalized cylinder on semi-Riemannian Spin ${ }^{c}$ manifolds

Let $M$ be an $n$-dimensional smooth manifold and $g_{t}$ a smooth 1-parameter family of semi-Riemannian metrics on $M, t \in I$ where $I \subset \mathbb{R}$ is an interval. We define the generalized cylinder by

$$
\mathcal{Z}:=I \times M,
$$

with semi-Riemannian metric $g_{\mathcal{Z}}:=\langle\cdot, \cdot\rangle=d t^{2}+g_{t}$. The generalized cylinder is an $(n+1)$-dimensional semi-Riemannian manifold of signature $(r+1, s)$ if the signature of $g_{t}$ is $(r, s)$.

Proposition 4.1 There is a 1-1-correspondence between the $\operatorname{Spin}^{c}$ structures on $M$ and that on $\mathcal{Z}$.

Proof: As explained in Section 3, $\operatorname{Spin}^{\mathrm{c}}$ structures on $\mathcal{Z}$ can be restricted to $\mathrm{Spin}^{\mathrm{c}}$ structures on $M$. Conversely, given a $\mathrm{Spin}^{\mathrm{c}}$ structure on $M$ it can be pulled back to $I \times M$ via the projection $p r_{2}: I \times M \longrightarrow M$ yields a $\operatorname{Spin}^{c}$ structure on $\mathcal{Z}$. In fact, the pull back of the $\operatorname{Spin}^{c}(r, s)$-principal bundle $P_{\text {Spinc }} M$ on $M$ gives rise to a $\operatorname{Spin}^{c}(r, s)$-principal bundle on $\mathcal{Z}$ denoted by $P_{\text {Spinc }} \mathcal{Z}$


Enlarging the structure group via the embedding $\operatorname{Spin}^{c}(r, s) \hookrightarrow \operatorname{Spin}^{c}(r+1, s)$, which covers the standard embedding

$$
\begin{aligned}
\mathrm{SO}(r, s) \times \mathbb{S}^{1} & \hookrightarrow \mathrm{SO}(r+1, s) \times \mathbb{S}^{1} \\
(a, z) & \mapsto\left(\left(\begin{array}{cc}
1 & 0 \\
0 & \mathrm{a}
\end{array}\right), z\right),
\end{aligned}
$$

gives a $\operatorname{Spin}^{c}(r+1, s)$-principal fibre bundle on $\mathcal{Z}$, denoted also by $P_{\operatorname{Spin}^{c}} \mathcal{Z}$. The pull back of the line bundle $L^{M}$ on $M$ defining the Spin ${ }^{\text {c }}$ structure on $M$, gives a line bundle $L^{\mathcal{Z}}$ on $\mathcal{Z}$ such that the following diagram commutes


The line bundle $L^{\mathcal{Z}}$ on $\mathcal{Z}$ and the $\operatorname{Spin}^{c}(r+1, s)$-principal fibre bundle $P_{\text {Spinc }} \mathcal{Z}$ on $\mathcal{Z}$ yields the $\operatorname{Spin}^{\mathrm{c}}$ structure on $\mathcal{Z}$ which restricts to the given $\operatorname{Spin}^{\mathrm{c}}$ structure on $M$.

Remark 4.2 If $M$ is a $\operatorname{Spin}^{c}$ Riemannian manifold and if we denote by $i \Omega^{M}$ the imaginairy valued curvature on the line bundle $L^{M}$, we know that there exists a unique curvature 2-form, denoted by $i \Omega^{\mathcal{Z}}$, on the line bundle $L^{\mathcal{Z}}=p r_{2}^{*}\left(L^{M}\right)$, defined by $i \Omega^{\mathcal{Z}}=p r_{2}^{*}\left(i \Omega^{M}\right)$. Thus we have

$$
\Omega^{\mathcal{Z}}(X, Y)=\Omega^{M}(X, Y) \text { and } \Omega^{\mathcal{Z}}(\nu, Y)=0 \text { for any } X, Y \in \Gamma(T M) .
$$

Proposition 4.3 [2] On a generalized cylinder $\mathcal{Z}=I \times M$ with semi-Riemannian metric $g^{\mathcal{Z}}=\langle\cdot, \cdot\rangle=d t^{2}+g_{t}$ we define, in every $p \in M$ and $X, Y \in T_{p} M$, the first and second derivatives of $g_{t}$ by

$$
\dot{g}_{t}(X, Y):=\frac{d}{d t}\left(g_{t}(X, Y)\right) \quad \text { and } \quad \ddot{g}_{t}(X, Y):=\frac{d^{2}}{d t^{2}}\left(g_{t}(X, Y)\right) .
$$

Hence the following formulas hold:

$$
\begin{align*}
\langle W(X), Y\rangle= & -\frac{1}{2} \dot{g}_{t}(X, Y),  \tag{21}\\
\left\langle R^{\mathcal{Z}}(U, V) X, Y\right\rangle= & \left\langle R^{M_{t}}(U, V) X, Y\right\rangle  \tag{22}\\
& +\frac{1}{4}\left(\dot{g}_{t}(U, X) \dot{g}_{t}(V, Y)-\dot{g}_{t}(U, Y) \dot{g}_{t}(V, X)\right), \\
\left\langle R^{\mathcal{Z}}(X, Y) U, \nu\right\rangle= & \frac{1}{2}\left(\left(\nabla_{Y}^{M_{t}} \dot{g}_{t}\right)(X, U)-\left(\nabla_{X}^{M_{t}} \dot{g}_{t}\right)(Y, U)\right),  \tag{23}\\
\left\langle R^{\mathcal{Z}}(X, \nu) \nu, Y\right\rangle= & -\frac{1}{2}\left(\ddot{g}_{t}(X, Y)+\dot{g}_{t}(W(X), Y)\right), \tag{24}
\end{align*}
$$

where $X, Y, U, V \in T_{p} M, p \in M$.

## 5 The variation formula for the Dirac operator on Spin ${ }^{c}$ manifolds

First we give some facts about parallel transport on $\operatorname{Spin}^{c}$ manifolds along a curve $c$. We consider a Riemannian $\operatorname{Spin}^{\mathrm{c}}$ manifold $N$, we know that there exists a unique correspondence which associates to a spinor field $\psi(t)=\psi(c(t))$ along a curve $c$ : $I \longrightarrow N$ another spinor field $\frac{D}{d t} \psi$ along $c$, called the covariant derivative of $\psi$ along $c$, such that

$$
\begin{gathered}
\frac{D}{d t}(\psi+\varphi)=\frac{D}{d t} \psi+\frac{D}{d t} \varphi, \text { for any } \psi \text { and } \varphi \text { along the curve } c, \\
\frac{D}{d t}(f \psi)=f \frac{D}{d t} \psi+\left(\frac{d}{d t} f\right) \psi, \text { where } f \text { is a differentiable function on } I, \\
\nabla_{\dot{c}(t)}^{\Sigma N} \psi=\frac{D}{d t} \varphi, \text { where } \varphi(t)=\psi(c(t)) .
\end{gathered}
$$

A spinor field $\psi$ along a curve $c$ is called parallel when $\frac{D}{d t} \psi(t)=0$ for all $t \in I$. Now, if $\psi_{0}$ is a spinor at the point $c\left(t_{0}\right), t_{0} \in I,\left(\psi_{0} \in \Sigma_{c\left(t_{0}\right)} N\right)$ then there exists a unique parallel spinor $\varphi$ along $c$, such that $\psi_{0}=\varphi\left(t_{0}\right)$. The linear isometry $\tau_{t_{0}}^{t_{1}}$ defined by

$$
\begin{aligned}
\tau_{t_{0}}^{t_{1}}: \Sigma_{c\left(t_{0}\right)} N & \longrightarrow \Sigma_{c\left(t_{1}\right)} N \\
\psi_{0} & \longrightarrow \varphi\left(t_{1}\right),
\end{aligned}
$$

is called the parallel transport along the curve $c$ from $c\left(t_{0}\right)$ to $c\left(t_{1}\right)$. The basic property of the parallel transport on a Spin${ }^{\text {c }}$ manifold is the following: Let $\psi$ be a spinor field on a Riemannian Spin ${ }^{\text {c }}$ manifold $N, X \in \Gamma(T N), p \in N$ and $c: I \longrightarrow N$ an integral curve through $p$, i.e., $c\left(t_{0}\right)=p$ and $\frac{d}{d t} c(t)=X(c(t))$, we have

$$
\begin{equation*}
\left(\nabla_{X}^{\Sigma N} \psi\right)_{p}=\left.\frac{d}{d t}\left(\tau_{t}^{t_{0}}(\psi(t))\right)\right|_{t=t_{0}} . \tag{25}
\end{equation*}
$$

Now, we consider $g_{t}$ a smooth 1-parameter family of semi-Riemannian metrics on a Spin ${ }^{c}$ manifold $M$ and the generalized cylinder $\mathcal{Z}=I \times M$ with semi-Riemannian metric $g^{\mathcal{Z}}=\langle\cdot, \cdot\rangle=d t^{2}+g_{t}$. For $t \in I$ we denote by $M_{t}$ the manifold $\left(M, g_{t}\right)$. Let us write "." for the Clifford multiplication on $\mathcal{Z}$ and " $\bullet_{t}$ " for that on $M_{t}$. Recall from Section 4 that $\operatorname{Spin}^{c}$ structures on $M$ and $\mathcal{Z}$ are in 1-1-correspondence and $\left.\Sigma \mathcal{Z}\right|_{M_{t}}=$ $\Sigma M_{t}$ as hermitian vector bundles if $n=r+s$ is even and $\left.\Sigma^{+} \mathcal{Z}\right|_{M_{t}}=\Sigma M_{t}$ if $n$ is odd. For a given $x \in M$ and $t_{0}, t_{1} \in I$, parallel transport $\tau_{t_{0}}^{t_{1}}$ on the generalized cylinder $\mathcal{Z}$ along the curve $c: I \rightarrow I \times M, t \rightarrow(t, x)$ is given by

$$
\tau_{t_{0}}^{t_{1}}: \Sigma_{c\left(t_{0}\right)} \mathcal{Z} \simeq \Sigma_{x} M_{t_{0}} \longrightarrow \Sigma_{c\left(t_{1}\right)} \mathcal{Z} \simeq \Sigma_{x} M_{t_{1}} .
$$

This isomorphism satisfies

$$
\begin{gathered}
\tau_{t_{0}}^{t_{1}}\left(X \bullet_{t_{0}} \varphi\right)=\left(\zeta_{t_{0}}^{t_{1}} X\right) \bullet_{t_{1}}\left(\tau_{t_{0}}^{t_{1}} \varphi\right), \\
\quad<\tau_{t_{0}}^{t_{1}} \psi, \tau_{t_{0}}^{t_{1}} \varphi>=<\psi, \varphi>,
\end{gathered}
$$

where $\zeta_{t_{0}}^{t_{1}}: T_{\left(x, t_{0}\right)} \mathcal{Z} \simeq T_{x} M_{t_{0}} \rightarrow T_{\left(x, t_{1}\right)} \mathcal{Z} \simeq T_{x} M_{t_{1}}$ is the parallel transport on $\mathcal{Z}$ along the same curve $c, X \in T_{x} M_{t_{0}}$ and $\psi, \varphi \in \Sigma_{x} M_{t_{0}}$.

Theorem 5.1 On a $\mathrm{Spin}^{c}$ manifold $M$, let $g_{t}$ be a smooth 1-parameter family of semi-Riemannian metrics. Denote by $D^{M_{t}}$ the Dirac operator of $M_{t}$, and $\mathfrak{D}^{\dot{g}_{t}}=$ $\sum_{i, j=1}^{n} \varepsilon_{i} \varepsilon_{j} \dot{g}_{t}\left(e_{i}, e_{j}\right) e_{i} \bullet_{t} \nabla_{e_{j}}^{\sum M_{t}}$. Then for any smooth spinor field $\psi$ on $M_{t_{0}}$ we have $\left.\frac{d}{d t}\right|_{t=t_{0}} \tau_{t}^{t_{0}} D^{M_{t}} \tau_{t_{0}}^{t} \psi=-\frac{1}{2} \mathfrak{D}^{\dot{g}_{0}} \psi+\frac{1}{4} \operatorname{grad}^{M_{t_{0}}}\left(\operatorname{tr}_{g_{t_{0}}}\left(\dot{g}_{t_{0}}\right)\right) \bullet \bullet_{t_{0}} \psi-\frac{1}{4} \operatorname{div}^{M_{t_{0}}}\left(\dot{g}_{t_{0}}\right) \bullet_{t_{0}} \psi$.

Proof: The vector field $\nu:=\frac{\partial}{\partial t}$ is spacelike of unit length and orthogonal to the hypersurfaces $M_{t}:=\{t\} \times M$. Denote by $W_{t}$ the Weingarten map of $M_{t}$ with respect to
$\nu$ and by $H_{t}$ the mean curvature. If $X$ is a local coordinate field on $M$, then $\langle X, \nu\rangle=0$ and $[X, \nu]=0$. Thus

$$
\begin{aligned}
0 & =d_{\nu}\langle X, \nu\rangle=\left\langle\nabla_{\nu}^{\mathcal{Z}} X, \nu\right\rangle+\left\langle X, \nabla_{\nu}^{\mathcal{Z}} \nu\right\rangle=\left\langle\nabla_{X}^{\mathcal{Z}} \nu, \nu\right\rangle+\left\langle X, \nabla_{\nu}^{\mathcal{Z}} \nu\right\rangle \\
& =-\left\langle W_{t}(X), \nu\right\rangle+\left\langle X, \nabla_{\nu}^{\mathcal{Z}} \nu\right\rangle=\left\langle X, \nabla_{\nu}^{\mathcal{Z}} \nu\right\rangle
\end{aligned}
$$

and differentiating $\langle\nu, \nu\rangle=1$ yields $\left\langle\nu, \nabla_{\nu}^{\mathcal{Z}} \nu\right\rangle=0$. Hence $\nabla_{\nu}^{\mathcal{Z}} \nu=0$, i.e., for $x \in M$ the curves $t \mapsto(t, x)$ are geodesics parametrized by arclength. So the assumptions of Proposition 3.4 are satisfied for the foliation $\left(M_{t}\right)_{t \in I}$. By Remark 4.2, the commutator formula of Proposition 3.4 gives for a section $\varphi$ of $\Sigma M_{t}$, (or $\Sigma^{+} M_{t}$ if $n$ is odd)

$$
\begin{equation*}
i^{-s}\left[\nabla_{\nu}^{\Sigma \mathcal{Z}}, D^{M_{t}}\right] \varphi=\mathfrak{D}^{W_{t}} \varphi-\frac{n}{2} \operatorname{grad}^{M_{t}}\left(H_{t}\right) \bullet_{t} \varphi+\frac{1}{2} \operatorname{div}^{M_{t}}\left(W_{t}\right) \bullet_{t} \varphi \tag{26}
\end{equation*}
$$

From Proposition 4.3 we deduce

$$
\operatorname{div}^{M_{t}}\left(W_{t}\right)=-\frac{1}{2} \operatorname{div}^{M_{t}}\left(\dot{g}_{t}\right), \quad H_{t}=-\frac{1}{2 n} \operatorname{tr}_{g_{t}}\left(\dot{g}_{t}\right) \quad \text { and } \quad \mathfrak{D}^{W_{t}}=-\frac{1}{2} \mathfrak{D}^{\dot{g}_{t}}
$$

Thus (26) can be rewritten as

$$
\begin{equation*}
i^{-s}\left[\nabla_{\nu}^{\Sigma \mathcal{Z}}, D^{M_{t}}\right] \varphi=-\frac{1}{2} \mathfrak{D}^{\dot{g}_{t}} \varphi+\frac{1}{4} \operatorname{grad}^{M_{t}}\left(\operatorname{tr}_{g_{t}}\left(\dot{g}_{t}\right)\right) \bullet_{t} \varphi-\frac{1}{4} \operatorname{div}^{M_{t}}\left(\dot{g}_{t}\right) \bullet_{t} \varphi \tag{27}
\end{equation*}
$$

Now if $\varphi$ is parallel along the curves $t \mapsto(t, x)$, i.e., it is of the form $\varphi(t, x)=$ $\tau_{t_{0}}^{t} \psi\left(t_{0}, x\right)$ for some spinor field $\psi$ on $M_{t_{0}}$, then using (25) at $t=t_{0}$, the left hand side of (27) could be written as

$$
\begin{align*}
i^{-s}\left[\nabla_{\nu}^{\Sigma \mathcal{Z}}, D^{M_{t}}\right] \varphi & =i^{-s} \nabla_{\nu}^{\Sigma \mathcal{Z}} D^{M_{t}} \varphi=\left.i^{-s} \frac{d}{d t}\right|_{t=t_{0}} \tau_{t}^{t_{0}} D^{M_{t}} \varphi \\
& =\left.i^{-s} \frac{d}{d t}\right|_{t=t_{0}} \tau_{t}^{t_{0}} D^{M_{t}} \tau_{t_{0}}^{t} \psi, \tag{28}
\end{align*}
$$

which gives the variation formula for the Dirac operator.
Corollary 5.2 Let $\left(M^{n}, g\right)$ be a $\operatorname{Spin}^{\mathrm{c}}$ Riemannian manifold, if we consider the family of metrics defined by $g_{t}=g+t k$, where $k$ is a symmetric ( 0,2 )-tensor, we have

$$
\begin{equation*}
\left.\frac{d}{d t}\right|_{t=0} \tau_{t}^{0} D^{M_{t}} \tau_{0}^{t} \psi=-\frac{1}{2} \mathfrak{D}^{k} \psi+\frac{1}{4} \operatorname{grad}^{M}\left(\operatorname{tr}_{g}(k)\right) \cdot \psi-\frac{1}{4} \operatorname{div}^{M}(k) \cdot \psi, \tag{29}
\end{equation*}
$$

where ". $=\bullet_{t_{0}=0}$ " is the Clifford multiplicaton on $M$.

This formula has been proved in [4], Theorem 21 for spin Riemannian manifolds and in [2] for spin semi-Riemannian manifolds.

## 6 Energy-Momentum tensor on Spin ${ }^{c}$ manifolds

In this section we study the Energy-Momentum tensor on Spin ${ }^{\text {c }}$ Riemannian manifolds from a geometric point of vue. We begin by giving the proofs of Proposition 1.1, Theorem 1.2 and Proposition 1.3.

Proof of Proposition 1.1 : Using Equation (29) we calculate

$$
\begin{aligned}
\left.\frac{d}{d t}\right|_{t=0}\left(\tau_{t}^{0} D^{M_{t}} \tau_{0}^{t} \psi, \psi\right)_{g_{t}} & =\left.\frac{d}{d t}\right|_{t=0}\left(D^{M_{t}} \tau_{0}^{t} \psi, \tau_{0}^{t} \psi\right)_{g_{t}} \\
& =-\frac{1}{2}\left(\mathfrak{D}^{k} \psi, \psi\right)_{g} \\
& =-\frac{1}{2} \sum_{i, j} k\left(e_{i}, e_{j}\right)\left(e_{i} \cdot \nabla_{e_{j}}^{\Sigma M} \psi, \psi\right) \\
& =-\frac{1}{2} \int_{M}<k, T_{\psi}>d v_{g} .
\end{aligned}
$$

Proof of Theorem 1.2 : The Proof of this Theorem will be omitted since it is similar to the one given by Friedrich and Kim in [8] for spin manifolds.

Proof of Proposition 1.3 : Let $\psi$ be any parallel spinor field on $\mathcal{Z}$. Then Equation (17) yields

$$
\begin{equation*}
\nabla_{X}^{\Sigma M} \varphi=\frac{1}{2} W(X) \bullet \varphi \tag{30}
\end{equation*}
$$

Let $\left(e_{1}, \ldots, e_{n}\right)$ be a positively oriented local orthonormal basis of $T M$. For $j=1, \ldots, n$ we have

$$
\nabla_{e_{j}}^{\Sigma M} \varphi=\frac{1}{2} \sum_{k=1}^{n} W_{j k} e_{k} \bullet \varphi .
$$

Taking Clifford multiplication by $e_{i}$ and the scalar product with $\varphi$, we get

$$
\operatorname{Re}\left(e_{i} \bullet \nabla_{e_{j}}^{\Sigma M} \varphi, \varphi\right)=\frac{1}{2} \sum_{k=1}^{n} W_{j k} \operatorname{Re}\left(e_{i} \bullet e_{k} \bullet \varphi, \varphi\right)
$$

Since $\operatorname{Re}\left(e_{i} \bullet e_{k} \bullet \varphi, \varphi\right)=-\delta_{i k}|\varphi|^{2}$, it follows, by the symmetry of $W$

$$
\operatorname{Re}\left(e_{i} \bullet \nabla_{e_{j}}^{\Sigma M} \varphi+e_{j} \bullet \nabla_{e_{i}}^{\Sigma M} \varphi, \varphi\right)=-W_{i j}|\varphi|^{2}
$$

Therefore, $2 \ell^{\varphi}=-W$. Using Equation (18) it is easy to see that $\varphi$ is an eigenspinor associated with the eigenvalue $-\frac{n}{2} H$ of $\widetilde{D}$. Since $\operatorname{Scal}^{\mathcal{Z}}=\operatorname{Scal}^{M}+2 \operatorname{ric}^{\mathcal{Z}}(\nu, \nu)-$ $n^{2} H^{2}+|W|^{2}$ we get

$$
\begin{aligned}
\frac{1}{4}\left(\operatorname{Scal}^{M}-c_{n}\left|\Omega^{M}\right|\right)+\left|T^{\varphi}\right|^{2} & =\frac{1}{4}\left(\operatorname{Scal}^{\mathcal{Z}}-2 \operatorname{ric}^{\mathcal{Z}}(\nu, \nu)-c_{n}\left|\Omega^{M}\right|\right)+n^{2} \frac{H^{2}}{4} \\
& =n^{2} \frac{H^{2}}{4},
\end{aligned}
$$

hence $M$ satisfies the equality case in (3) if and only if (6) holds.
Corollary 6.1 Under the same conditions as Proposition 1.3, if $n=2$ or 3, the hypersurface $M$ satisfies the equality case in (3) if $\operatorname{Ric}^{\mathcal{Z}}(\nu)=0$ and $\mathrm{Scal}^{\mathcal{Z}} \geqslant 0$.

Proof: Since $\mathcal{Z}$ has a parallel spinor, we have (see [7])

$$
\begin{gather*}
\left.\left|\operatorname{Ric}^{\mathcal{Z}}(\nu)\right|=\mid \nu\right\lrcorner \Omega^{\mathcal{Z}} \mid  \tag{31}\\
\left.i(Y\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \psi=\operatorname{Ric}^{\mathcal{Z}}(Y) \cdot \psi \text { for every } \quad Y \in \Gamma(\Sigma \mathcal{Z}) \tag{32}
\end{gather*}
$$

For $Y=e_{j}$ in Equation (32) then taking Clifford multiplication by $e_{j}$ and summing from $j=1, \ldots, n+1$, we get

$$
\left.i \sum_{j=1}^{n+1} e_{j} \cdot\left(e_{j}\right\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \psi=\sum_{j=1}^{n+1} e_{j} \cdot \operatorname{Ric}^{\mathcal{Z}}\left(e_{j}\right) \cdot \psi=-\operatorname{Scal}^{\mathcal{Z}} \psi
$$

But $\left.2 \Omega^{\mathcal{Z}} \cdot \psi=\sum_{j=1}^{n+1} e_{j} \cdot\left(e_{j}\right\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \psi$, hence we deduce that $\Omega^{\mathcal{Z}} \cdot \psi=i \frac{\text { Scal }^{\mathcal{Z}}}{2} \psi$. By (31) and (15) we obtain $\Omega^{M} \bullet \varphi=i \frac{\text { Scal }^{Z}}{2} \varphi$. Since $n=2$ or 3 we have $\left|\Omega^{M}\right|=\frac{\text { Scal }^{Z}}{2}$ and Equation (6) is satisfied.

Corollary 6.2 Under the same conditions as Proposition 1.3, if the restriction of the complex line bundle $L^{\mathcal{Z}}$ is flat, i.e., $L^{M}$ is a flat complex line bundle $\left(\Omega^{M}=0\right)$, the hypersurface $M$ is a limiting manifold for (3).

Proof: Since $\Omega^{M}=0$, Equation (15) yields $\left.i \frac{\text { Scal }}{2}{ }^{\mathcal{Z}} \varphi=\Omega^{\mathcal{Z}} \cdot \psi_{\left.\right|_{M}}=(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \bullet \varphi$. But,

$$
\begin{align*}
\left.i(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \bullet \varphi & \left.=i\left(\nu \cdot(\nu\lrcorner \Omega^{\mathcal{Z}}\right) \cdot \psi\right)_{\left.\right|_{M}}=\left(\nu \cdot \operatorname{Ric}^{\mathcal{Z}}(\nu) \cdot \psi\right)_{\left.\right|_{M}} \\
& =-\operatorname{ric}^{\mathcal{Z}}(\nu, \nu) \varphi+\sum_{j=1}^{n} \operatorname{ric}^{\mathcal{Z}}\left(\nu, e_{j}\right) e_{j} \bullet \varphi \tag{33}
\end{align*}
$$

Taking the real part of the scalar product of Equation (33) with $\varphi$ yields $\frac{\text { Scal }^{\mathcal{Z}}}{2}=\operatorname{ric}^{\mathcal{Z}}(\nu, \nu)$, hence Equation (6) is satisfied.

Now, let $M$ be a $\operatorname{Spin}^{c}$ Riemannian manifold having a generalized Killing spinor field $\varphi$ with a symmetric endomorphism $F$ on the tangent bundle $T M$. As mentioned in the introduction, it is straightforward to see that $2 T^{\varphi}(X, Y)=-\langle F(X), Y\rangle$. We will study these generalized Killing spinors when the tensor $F$ is a Codazzi-Mainardi tensor, i.e., $F$ satisfies

$$
\begin{equation*}
\left(\nabla_{X}^{M} F\right)(Y)=\left(\nabla_{Y}^{M} F\right)(X) \text { for } X, Y \in \Gamma(T M) \tag{34}
\end{equation*}
$$

For this, we give the following lemma whose proof will be omitted since it is similar to Lemma 7.3 in [2].

Lemma 6.3 [2] Let $g_{t}$ be a smooth 1-parameter family of semi-Riemannian metrics on a $\mathrm{Spin}^{\mathrm{c}}$ manifold ( $M^{n}, g=g_{0}$ ) and let $F$ be a field of symmetric endomorphisms of $T M$. We consider the metric $g_{\mathcal{Z}}=\langle.,\rangle=.d t^{2}+g_{t}$ on $\mathcal{Z}$ such that $g_{t}(X, Y)=$ $g\left((\operatorname{Id}-t F)^{2} X, Y\right)$ for all vector fields $X, Y$ on $M$. We have $\left\langle R^{\mathcal{Z}}(U, \nu) \nu, V\right\rangle=0$ for all vector fields $U, V$ tangent to $M$ and if $F$ satisfies the Codazzi-Mainardi equation then $\left\langle R^{\mathcal{Z}}(U, V) W, \nu\right\rangle=0$ for all $U, V$ and $W$ on $\mathcal{Z}$.

Proof of Theorem 1.4: We define $\psi_{(0, x)}:=\varphi_{x}$ via the identification $\Sigma_{x} M \cong \Sigma_{(0, x)} \mathcal{Z}$ (resp. $\Sigma_{(0, x)}^{+} \mathcal{Z}$ for $n$ odd) and $\psi_{(t, x)}=\tau_{0}^{t} \psi_{(0, x)}$. By Equation (21), the endomorphism $F$ is the Weingarten tensor of the immersion of $\{0\} \times M$ in $\mathcal{Z}$ and hence by construction we have for all $X \in \Gamma(T M)$

$$
\begin{equation*}
\left.\nabla_{X}^{\Sigma \mathcal{Z}} \psi\right|_{\{0\} \times M}=0 \quad \text { and } \quad \nabla_{\nu}^{\Sigma \mathcal{Z}} \psi \equiv 0 \tag{35}
\end{equation*}
$$

Since the tensor $F$ satisfies the Codazzi-Mainardi equation, Lemma 6.3 yields $g_{\mathcal{Z}}\left(R^{\mathcal{Z}}(U, V) W, \nu\right)=0$ for all $U, V$ and $W \in \Gamma(\mathcal{Z})$ and $g_{\mathcal{Z}}\left(R^{\mathcal{Z}}(X, \nu) \nu, Y\right)=0$ for all $X$ and $Y$ tangent to $M$. Hence $R^{\mathcal{Z}}(\nu, X)=0$ for all $X \in \Gamma(T M)$. Let $X$ be a fixed arbitrary tangent vector field on $M$. Using (10) and (35) we get

$$
\nabla_{\nu}^{\Sigma \mathcal{Z}} \nabla_{X}^{\Sigma \mathcal{Z}} \psi=\mathcal{R}^{\Sigma \mathcal{Z}}(\nu, X) \psi=\frac{1}{2} R^{\mathcal{Z}}(X, \nu) \cdot \psi+\frac{i}{2} \Omega^{\mathcal{Z}}(X, \nu) \psi=0 .
$$

Thus showing that the spinor field $\nabla_{X}^{\Sigma \mathcal{Z}} \psi$ is parallel along the geodesics $\mathbb{R} \times\{x\}$. Now (35) shows that this spinor vanishes for $t=0$, hence it is zero everywhere on $\mathcal{Z}$. Since $X$ is arbitrary, this shows that $\psi$ is parallel on $\mathcal{Z}$.

Corollary 6.4 Let $\left(M^{3}, g\right)$ be a compact, oriented Riemannian manifold and $\varphi$ an eigenspinor associated with the first eigenvalue $\lambda_{1}$ of the Dirac operator such that the Energy-Momentum tensor associated with $\varphi$ is a Codazzi tensor. $M$ is a limiting manifold for (3) if and only if the generalized cylinder $\mathcal{Z}^{4}$, equipped with the Spin ${ }^{\text {c }}$ structure arising from the given one on $M$, is Kähler of positive scalar curvature and the immersion of $M$ in $\mathcal{Z}$ has constant mean curvature $H$.

Proof: First, we should point out that every 3-dimensional compact, oriented, smooth manifold has a Spin ${ }^{\text {c }}$ structure. Now, if $M^{3}$ is a limiting manifold for (3), by Theorem 1.4, the generalized cylinder has a parallel spinor whose restriction to $M$ is $\varphi$. Since $\mathcal{Z}$ is a 4 -dimensional $\mathrm{Spin}^{\mathrm{c}}$ manifold having parallel spinor, $\mathcal{Z}$ is Kähler [1]. Moreover, using (15), we have

$$
\Omega^{M} \bullet \varphi=i \frac{\mathrm{Scal}^{\mathcal{Z}}}{2} \varphi=i \frac{c_{n}}{2}\left|\Omega^{M}\right| \varphi,
$$

so Scal ${ }^{\mathcal{Z}} \geqslant 0$. Finaly $H=\frac{1}{n} \operatorname{tr}(W)=\frac{1}{n} \operatorname{tr}\left(-2 T^{\varphi}\right)=-\frac{2}{n} \lambda_{1}$, which is a constant. Now if the generalized cylinder is Kähler and $M$ is a compact hypersurface of constant mean curvature $H$, thus $M$ is compact hypersurface immersed in a $\operatorname{Spin}^{c}$ manifold having parallel spinor with constant mean curvature. Since Scal ${ }^{\mathcal{Z}} \geqslant 0$ and $\left.\nu\right\lrcorner \Omega^{\mathcal{Z}}=$ $\operatorname{Ric}^{\mathcal{Z}}(\nu)=0$, Corollary 6.1 gives the result.
