# The weak Stratonovich integral with respect to fractional Brownian motion with Hurst parameter 1/6

#### Abstract

Let $B$ be a fractional Brownian motion with Hurst parameter $H=1 / 6$. It is known that the symmetric Stratonovich-style Riemann sums for $\int g(B(s)) d B(s)$ do not, in general, converge in probability. We show, however, that they do converge in law in the Skorohod space of càdlàg functions. Moreover, we show that the resulting stochastic integral satisfies a change of variable formula with a correction term that is an ordinary Itô integral with respect to a Brownian motion that is independent of $B$.

## 1 Introduction

The Stratonovich integral of $X$ with respect to $Y$, denoted $\int_{0}^{t} X(s) \circ d Y(s)$, can be defined as the limit in probability, if it exists, of

$$
\begin{equation*}
\sum_{t_{j} \leq t} \frac{X\left(t_{j-1}\right)+X\left(t_{j}\right)}{2}\left(Y\left(t_{j}\right)-Y\left(t_{j-1}\right)\right), \tag{1.1}
\end{equation*}
$$

as the mesh of the partition $\left\{t_{j}\right\}$ goes to zero. Typically, we regard (1.1) as a process in $t$, and require that it converges uniformly on compacts in probability (ucp).

[^0]This is closely related to the so-called symmetric integral, denoted by $\int_{0}^{t} X(s) d^{\circ} Y(s)$, which is the ucp limit, if it exists, of

$$
\begin{equation*}
\frac{1}{\varepsilon} \int_{0}^{t} \frac{X(s)+X(s+\varepsilon)}{2}(Y(s+\varepsilon)-Y(s)) d s \tag{1.2}
\end{equation*}
$$

as $\varepsilon \rightarrow 0$. The symmetric integral is an example of the regularization procedure, introduced by Russo and Vallois, and on which there is a wide body of literature. For further details on stochastic calculus via regularization, see the excellent survey article [13] and the many references therein.

A special case of interest that has received considerable attention in the literature is when $Y=B^{H}$, a fractional Brownian motion with Hurst parameter $H$. It has been shown independently in [2] and [5] that when $Y=B^{H}$ and $X=g\left(B^{H}\right)$ for a sufficiently differentiable function $g(x)$, the symmetric integral exists for all $H>1 / 6$. Moreover, in this case, the symmetric integral satisfies the classical Stratonovich change of variable formula,

$$
g\left(B^{H}(t)\right)=g\left(B^{H}(0)\right)+\int_{0}^{t} g^{\prime}\left(B^{H}(s)\right) d^{\circ} B^{H}(s)
$$

However, when $H=1 / 6$, the symmetric integral does not, in general, exist. Specifically, in [2] and [5, it is shown that (1.2) does not converge in probability when $Y=B^{1 / 6}$ and $X=\left(B^{1 / 6}\right)^{2}$. It can be similarly shown that, in this case, 1.1) also fails to converge in probability.

This brings us naturally to the notion which is the focus of this paper: the weak Stratonovich integral, which is the limit in law, if it exists, of (1.1). We focus exclusively on the case $Y=B^{1 / 6}$. For simplicity, we omit the superscript and write $B=B^{1 / 6}$. Our integrands shall take the form $g(B(t))$, for $g \in C^{\infty}(\mathbb{R})$, and we shall work only with the uniformly spaced partition, $t_{j}=j / n$. In this case, (1.1) becomes

$$
I_{n}(g, B, t)=\sum_{j=1}^{\lfloor n t\rfloor} \frac{g\left(B\left(t_{j-1}\right)\right)+g\left(B\left(t_{j}\right)\right)}{2} \Delta B_{j}
$$

where $\lfloor x\rfloor$ denotes the greatest integer less than or equal to $x$, and $\Delta B_{j}=B\left(t_{j}\right)-B\left(t_{j-1}\right)$. We show that the processes $I_{n}(g, B)$ converge in law in $D_{\mathbb{R}}[0, \infty)$, the Skorohod space of càdlàg functions from $[0, \infty)$ to $\mathbb{R}$. We let $\int_{0}^{t} g(B(s)) d B(s)$ denote a process with this limiting law, and refer to this as the weak Stratonovich integral.

The weak Stratonovich integral with respect to $B$ does not satisfy the classical Stratonovich change of variable formula. Rather, we show that it satisfies a change of variable formula with a correction term that is a classical Itô integral. Namely,

$$
\begin{equation*}
g(B(t))=g(B(0))+\int_{0}^{t} g^{\prime}(B(s)) d B(s)-\frac{1}{12} \int_{0}^{t} g^{\prime \prime \prime}(B(s)) d \llbracket B \rrbracket_{s} \tag{1.3}
\end{equation*}
$$

where $\llbracket B \rrbracket$ is what we call the signed cubic variation of $B$. That is, $\llbracket B \rrbracket$ is the limit in law of the sequence of processes $V_{n}(B, t)=\sum_{j=1}^{\lfloor n t\rfloor} \Delta B_{j}^{3}$. It is shown in [11] that $\llbracket B \rrbracket=\kappa W$, where $W$ is a standard Brownian motion, independent of $B$, and $\kappa \simeq 2.322$. (See 2.5) for the exact
definition of $\kappa$.) The correction term in (1.3) is then a standard Itô integral with respect to Brownian motion.

Our precise results are actually somewhat stronger than this, in that we prove the joint convergence of the processes $B, V_{n}(B)$, and $I_{n}(g, B)$. (See Theorem 2.12.) We also discuss the joint convergence of multiple sequences of Riemann sums for different integrands. (See Theorem 2.13 and Remark 2.14.)

The work in this paper is a natural follow-up to [1] and [9]. There, analogous results were proven for $B^{1 / 4}$ in the context of midpoint-style Riemann sums. The results in [1] and [9] were proven through different methods, and in the present work, we combine the two approaches to prove our main results.

Finally, let us stress the fact that, as a byproduct of the proof of (1.3), we show in the present paper that

$$
n^{-1 / 2} \sum_{j=1}^{\lfloor n \cdot\rfloor} g\left(B\left(t_{j-1}\right)\right) h_{3}\left(n^{1 / 6} \Delta B_{j}\right) \rightarrow-\frac{1}{8} \int_{0}^{.} g^{\prime \prime \prime}(B(s)) d s+\int_{0}^{.} g(B(s)) d \llbracket B \rrbracket_{s},
$$

in the sense of finite-dimensional distributions on $[0, \infty)$, where $h_{3}(x)=x^{3}-3 x$ denotes the third Hermite polynomial. (See more precisely Theorem 3.7 below. Also see Theorem 3.8.) From our point of view, this result has also its own interest, and should be compared with the recent results obtained in [7, 8], concerning the weighted Hermite variations of fractional Brownian motion.

## 2 Notation, preliminaries, and main result

Let $B=B^{1 / 6}$ be a fractional Brownian motion with Hurst parameter $H=1 / 6$. That is, $B$ is a centered Gaussian process, indexed by $t \geq 0$, such that

$$
R(s, t)=E[B(s) B(t)]=\frac{1}{2}\left(t^{1 / 3}+s^{1 / 3}-|t-s|^{1 / 3}\right)
$$

Note that $E|B(t)-B(s)|^{2}=|t-s|^{1 / 3}$. For compactness of notation, we will sometimes write $B_{t}$ instead of $B(t)$. Given a positive integer $n$, let $\Delta t=n^{-1}$ and $t_{j}=t_{j, n}=j \Delta t$. We shall frequently have occasion to deal with the quantity $\beta_{j, n}=\beta_{j}=\left(B\left(t_{j-1}\right)+B\left(t_{j}\right)\right) / 2$. In estimating this and similar quantities, we shall adopt the notation $r_{+}=r \vee 1$, which is typically applied to nonnegative integers $r$. We shall also make use of the Hermite polynomials,

$$
\begin{equation*}
h_{n}(x)=(-1)^{n} e^{x^{2} / 2} \frac{d^{n}}{d x^{n}}\left(e^{-x^{2} / 2}\right) . \tag{2.1}
\end{equation*}
$$

Note that the first few Hermite polynomials are $h_{0}(x)=1, h_{1}(x)=x, h_{2}(x)=x^{2}-1$, and $h_{3}(x)=x^{3}-3 x$. The following orthogonality property is well-known: if $U$ and $V$ are jointly normal with $E(U)=E(V)=0$ and $E\left(U^{2}\right)=E\left(V^{2}\right)=1$, then

$$
E\left[h_{p}(U) h_{q}(V)\right]= \begin{cases}q!(E[U V])^{q} & \text { if } p=q  \tag{2.2}\\ 0 & \text { otherwise }\end{cases}
$$

If $X$ is a càdlàg process, we write $X(t-)=\lim _{s \uparrow t} X(s)$ and $\Delta X(t)=X(t)-X(t-)$. The step function approximation to $X$ will be denoted by $X_{n}(t)=X(\lfloor n t\rfloor / n)$, where $\lfloor\cdot\rfloor$ is the greatest integer function. In this case, $\Delta X_{n}\left(t_{j, n}\right)=X\left(t_{j}\right)-X\left(t_{j-1}\right)$. We shall frequently use the shorthand notation $\Delta X_{j}=\Delta X_{j, n}=\Delta X_{n}\left(t_{j, n}\right)$. For simplicity, positive integer powers of $\Delta X_{j}$ shall be written without parentheses, so that $\Delta X_{j}^{k}=\left(\Delta X_{j}\right)^{k}$.

The discrete $p$-th variation of $X$ is defined as

$$
V_{n}^{p}(X, t)=\sum_{j=1}^{\lfloor n t\rfloor}\left|\Delta X_{j}\right|^{p}
$$

and the discrete signed $p$-th variation of $X$ is

$$
V_{n}^{p \pm}(X, t)=\sum_{j=1}^{\lfloor n t\rfloor}\left|\Delta X_{j}\right|^{p} \operatorname{sgn}\left(\Delta X_{j}\right) .
$$

For the discrete signed cubic variation, we shall omit the superscript, so that

$$
\begin{equation*}
V_{n}(X, t)=V_{n}^{3 \pm}(X, t)=\sum_{j=1}^{\lfloor n t\rfloor} \Delta X_{j}^{3} \tag{2.3}
\end{equation*}
$$

When we omit the index $t$, we mean to refer to the entire process. So, for example, $V_{n}(X)=V_{n}(X, \cdot)$ refers to the càdlàg process which maps $t \mapsto V_{n}(X, t)$.

Let $\{\rho(r)\}_{r \in \mathbb{Z}}$ be the sequence defined by

$$
\begin{equation*}
\rho(r)=\frac{1}{2}\left(|r+1|^{1 / 3}+|r-1|^{1 / 3}-2|r|^{1 / 3}\right) . \tag{2.4}
\end{equation*}
$$

Note that $\sum_{r \in \mathbb{Z}}|\rho(r)|<\infty$ and $E\left[\Delta B_{i} \Delta B_{j}\right]=n^{-1 / 3} \rho(i-j)$ for all $i, j \in \mathbb{N}$. Let $\kappa>0$ be defined by

$$
\begin{equation*}
\kappa^{2}=6 \sum_{r \in \mathbb{Z}} \rho^{3}(r)=\frac{3}{4} \sum_{r \in \mathbb{Z}}\left(|r+1|^{1 / 3}+|r-1|^{1 / 3}-2|r|^{1 / 3}\right)^{3} \simeq 5.391, \tag{2.5}
\end{equation*}
$$

and let $W$ be a standard Brownian motion, defined on the same probability space as $B$, and independent of $B$. Define $\llbracket B \rrbracket_{t}=\kappa W(t)$. We shall refer to the process $\llbracket B \rrbracket$ as the signed cubic variation of $B$. The use of this term is justified by Theorem 2.11.

A function $g: \mathbb{R}^{d} \rightarrow \mathbb{R}$ has polynomial growth if there exist positive constants $K$ and $r$ such that $|g(x)| \leq K\left(1+|x|^{r}\right)$ for all $x \in \mathbb{R}^{d}$. If $k$ is a nonnegative integer, we shall say that a function $g$ has polynomial growth of order $k$ if $g \in C^{k}\left(\mathbb{R}^{d}\right)$ and there exist positive constants $K$ and $r$ such that $\left|\partial^{\alpha} g(x)\right| \leq K\left(1+|x|^{r}\right)$ for all $x \in \mathbb{R}^{d}$ and all $|\alpha| \leq k$. (Here, $\alpha \in \mathbb{N}_{0}^{d}=(\mathbb{N} \cup\{0\})^{d}$ is a multi-index, and we adopt the standard multi-index notation: $\partial_{j}=\partial / \partial x_{j}, \partial^{\alpha}=\partial_{1}^{\alpha_{1}} \cdots \partial_{d}^{\alpha_{d}}$, and $\left.|\alpha|=\alpha_{1}+\cdots+\alpha_{d}.\right)$

Given $g: \mathbb{R} \rightarrow \mathbb{R}$ and a stochastic process $\{X(t): t \geq 0\}$, the Stratonovich Riemann sum will be denoted by

$$
I_{n}(g, X, t)=\sum_{j=1}^{\lfloor n t\rfloor} \frac{g\left(X\left(t_{j-1}\right)\right)+g\left(X\left(t_{j}\right)\right)}{2} \Delta X_{j}
$$

The phrase "uniformly on compacts in probability" will be abbreviated "ucp." If $X_{n}$ and $Y_{n}$ are càdlàg processes, we shall write $X_{n} \approx Y_{n}$ or $X_{n}(t) \approx Y_{n}(t)$ to mean that $X_{n}-Y_{n} \rightarrow 0$ ucp. In the proofs in this paper, $C$ shall denote a positive, finite constant that may change value from line to line.

### 2.1 Conditions for relative compactness

The Skorohod space of càdlàg functions from $[0, \infty)$ to $\mathbb{R}^{d}$ is denoted by $D_{\mathbb{R}^{d}}[0, \infty)$. Note that $D_{\mathbb{R}^{d}}[0, \infty)$ and $\left(D_{\mathbb{R}}[0, \infty)\right)^{d}$ are not the same. In particular, the map $(x, y) \mapsto x+y$ is continuous from $D_{\mathbb{R}^{2}}[0, \infty)$ to $D_{\mathbb{R}}[0, \infty)$, but it is not continuous from $\left(D_{\mathbb{R}}[0, \infty)\right)^{2}$ to $D_{\mathbb{R}}[0, \infty)$. Convergence in $D_{\mathbb{R}^{d}}[0, \infty)$ implies convergence in $\left(D_{\mathbb{R}}[0, \infty)\right)^{d}$, but the converse is not true.

Note that if the sequences $\left\{X_{n}^{(1)}\right\}, \ldots,\left\{X_{n}^{(d)}\right\}$ are all relatively compact in $D_{\mathbb{R}}[0, \infty)$, then the sequence of $d$-tuples $\left\{\left(X_{n}^{(1)}, \ldots, X_{n}^{(d)}\right)\right\}$ is relatively compact in $\left(D_{\mathbb{R}}[0, \infty)\right)^{d}$. It may not, however, be relatively compact in $D_{\mathbb{R}^{d}}[0, \infty)$. We will therefore need the following well-known result. (For more details, see Section 2.1 of [1] and the references therein.)

Lemma 2.1. Suppose $\left\{\left(X_{n}^{(1)}, \ldots, X_{n}^{(d)}\right)\right\}_{n=1}^{\infty}$ is relatively compact in $\left(D_{\mathbb{R}}[0, \infty)\right)^{d}$. If, for each $j \geq 2$, the sequence $\left\{X_{n}^{(j)}\right\}_{n=1}^{\infty}$ converges in law in $D_{\mathbb{R}}[0, \infty)$ to a continuous process, then $\left\{\left(X_{n}^{(1)}, \ldots, X_{n}^{(d)}\right)\right\}_{n=1}^{\infty}$ is relatively compact in $D_{\mathbb{R}^{d}}[0, \infty)$.

Our primary criterion for relative compactness is the following moment condition, which is a special case of Corollary 2.2 in [1].

Theorem 2.2. Let $\left\{X_{n}\right\}$ be a sequence of processes in $D_{\mathbb{R}^{d}}[0, \infty)$. Let $q(x)=|x| \wedge 1$. Suppose that for each $T>0$, there exists $\nu>0, \beta>0, C>0$, and $\theta>1$ such that $\sup _{n} E\left[\left|X_{n}(T)\right|^{\nu}\right]<\infty$ and

$$
\begin{equation*}
E\left[q\left(X_{n}(t)-X_{n}(s)\right)^{\beta}\right] \leq C\left(\frac{\lfloor n t\rfloor-\lfloor n s\rfloor}{n}\right)^{\theta} \tag{2.6}
\end{equation*}
$$

for all $n$ and all $0 \leq s \leq t \leq T$. Then $\left\{X_{n}\right\}$ is relatively compact.
Of course, a sequence $\left\{X_{n}\right\}$ converges in law in $D_{\mathbb{R}^{d}}[0, \infty)$ to a process $X$ if $\left\{X_{n}\right\}$ is relatively compact and $X_{n} \rightarrow X$ in the sense of finite-dimensional distributions on $[0, \infty)$. We shall also need the analogous theorem for convergence in probability, which is Lemma A2.1 in [3]. Note that if $x:[0, \infty) \rightarrow \mathbb{R}^{d}$ is continuous, then $x_{n} \rightarrow x$ in $D_{\mathbb{R}^{d}}[0, \infty)$ if and only if $x_{n} \rightarrow x$ uniformly on compacts.

Lemma 2.3. Let $\left\{X_{n}\right\}, X$ be processes with sample paths in $D_{\mathbb{R}^{d}}[0, \infty)$ defined on the same probability space. Suppose that $\left\{X_{n}\right\}$ is relatively compact in $D_{\mathbb{R}^{d}}[0, \infty)$ and that for a dense set $H \subset[0, \infty), X_{n}(t) \rightarrow X(t)$ in probability for all $t \in H$. Then $X_{n} \rightarrow X$ in probability in $D_{\mathbb{R}^{d}}[0, \infty)$. In particular, if $X$ is continuous, then $X_{n} \rightarrow X$ ucp.

We will also need the following lemma, which is easily proved using the Prohorov metric.

Lemma 2.4. Let $(E, r)$ be a complete and separable metric space. Let $X_{n}$ be a sequence of $E$-valued random variables and suppose, for each $k$, there exists a sequence $\left\{X_{n, k}\right\}_{n=1}^{\infty}$ such that $\lim \sup _{n \rightarrow \infty} E\left[r\left(X_{n}, X_{n, k}\right)\right] \leq \delta_{k}$, where $\delta_{k} \rightarrow 0$ as $k \rightarrow \infty$. Suppose also that for each $k$, there exists $Y_{k}$ such that $X_{n, k} \rightarrow Y_{k}$ in law as $n \rightarrow \infty$. Then there exists $X$ such that $X_{n} \rightarrow X$ in law and $Y_{k} \rightarrow X$ in law.

### 2.2 Elements of Malliavin calculus

In the sequel, we will need some elements of Malliavin calculus that we collect here. The reader is referred to [6] or [10] for any unexplained notion discussed in this section.

We denote by $X=\{X(\varphi): \varphi \in \mathfrak{H}\}$ an isonormal Gaussian process over $\mathfrak{H}$, a real and separable Hilbert space. By definition, $X$ is a centered Gaussian family indexed by the elements of $\mathfrak{H}$ and such that, for every $\varphi, \psi \in \mathfrak{H}$,

$$
E[X(\varphi) X(\psi)]=\langle\varphi, \psi\rangle_{\mathfrak{H}} .
$$

We denote by $\mathfrak{H}^{\otimes q}$ and $\mathfrak{H}^{\odot q}$, respectively, the tensor space and the symmetric tensor space of order $q \geq 1$. Let $\mathscr{S}$ be the set of cylindrical functionals $F$ of the form

$$
\begin{equation*}
F=f\left(X\left(\varphi_{1}\right), \ldots, X\left(\varphi_{n}\right)\right), \tag{2.7}
\end{equation*}
$$

where $n \geq 1, \varphi_{i} \in \mathfrak{H}$ and the function $f \in C^{\infty}\left(\mathbb{R}^{n}\right)$ is such that its partial derivatives have polynomial growth. The Malliavin derivative $D F$ of a functional $F$ of the form (2.7) is the square integrable $\mathfrak{H}$-valued random variable defined as

$$
D F=\sum_{i=1}^{n} \frac{\partial f}{\partial x_{i}}\left(X\left(\varphi_{1}\right), \ldots, X\left(\varphi_{n}\right)\right) \varphi_{i} .
$$

In particular, $D X(\varphi)=\varphi$ for every $\varphi \in \mathfrak{H}$. By iteration, one can define the $m$ th derivative $D^{m} F$ (which is an element of $L^{2}\left(\Omega, \mathfrak{H}^{\odot m}\right)$ ) for every $m \geq 2$, giving

$$
D^{m} F=\sum_{i_{1}, \ldots, i_{m}}^{n} \frac{\partial^{m} f}{\partial x_{i_{1}} \cdots \partial x_{i_{m}}}\left(X\left(\varphi_{1}\right), \ldots, X\left(\varphi_{n}\right)\right) \varphi_{i_{1}} \otimes \cdots \otimes \varphi_{i_{m}}
$$

As usual, for $m \geq 1, \mathbb{D}^{m, 2}$ denotes the closure of $\mathscr{S}$ with respect to the norm $\|\cdot\|_{m, 2}$, defined by the relation

$$
\|F\|_{m, 2}^{2}=E F^{2}+\sum_{i=1}^{m} E\left\|D^{i} F\right\|_{\mathfrak{H}^{\otimes i}}^{2} .
$$

The Malliavin derivative $D$ satisfies the following chain rule: if $f: \mathbb{R}^{n} \rightarrow \mathbb{R}$ is in $C_{b}^{1}$ (that is, the collection of continuously differentiable functions with a bounded derivative) and if $\left\{F_{i}\right\}_{i=1, \ldots, n}$ is a vector of elements of $\mathbb{D}^{1,2}$, then $f\left(F_{1}, \ldots, F_{n}\right) \in \mathbb{D}^{1,2}$ and

$$
\begin{equation*}
D f\left(F_{1}, \ldots, F_{n}\right)=\sum_{i=1}^{n} \frac{\partial f}{\partial x_{i}}\left(F_{1}, \ldots, F_{n}\right) D F_{i} \tag{2.8}
\end{equation*}
$$

This formula can be extended to higher order derivatives as

$$
\begin{equation*}
D^{m} f\left(F_{1}, \ldots, F_{n}\right)=\sum_{v \in \mathcal{P}_{m}} C_{v} \sum_{i_{1}, \ldots, i_{k}=1}^{n} \frac{\partial^{k} f}{\partial x_{i_{1}} \cdots \partial x_{i_{k}}}\left(F_{1}, \ldots, F_{n}\right) D^{v_{1}} F_{i_{1}} \widetilde{\otimes} \cdots \widetilde{\otimes} D^{v_{k}} F_{i_{k}}, \tag{2.9}
\end{equation*}
$$

where $\mathcal{P}_{m}$ is the set of vectors $v=\left(v_{1}, \ldots, v_{k}\right) \in \mathbb{N}^{k}$ such that $k \geq 1, v_{1} \leq \cdots \leq v_{k}$, and $v_{1}+\cdots+v_{k}=m$. The constants $C_{v}$ can be written explicitly as $C_{v}=m!\left(\prod_{j=1}^{n} m_{j}!(j!)^{m_{j}}\right)^{-1}$, where $m_{j}=\left|\left\{\ell: v_{\ell}=j\right\}\right|$.
Remark 2.5. In (2.9), $a \widetilde{\otimes} b$ denotes the symmetrization of the tensor product $a \otimes b$. Recall that, in general, the symmetrization of a function $f$ of $m$ variables is the function $\tilde{f}$ defined by

$$
\begin{equation*}
\tilde{f}\left(t_{1}, \ldots, t_{m}\right)=\frac{1}{m!} \sum_{\sigma \in \mathfrak{S}_{m}} f\left(t_{\sigma(1)}, \ldots, t_{\sigma(m)}\right) \tag{2.10}
\end{equation*}
$$

where $\mathfrak{S}_{m}$ denotes the set of all permutations of $\{1, \ldots, m\}$.
We denote by $I$ the adjoint of the operator $D$, also called the divergence operator. A random element $u \in L^{2}(\Omega, \mathfrak{H})$ belongs to the domain of $I$, noted $\operatorname{Dom}(I)$, if and only if it satisfies

$$
\left|E\langle D F, u\rangle_{\mathfrak{H}}\right| \leq c_{u} \sqrt{E F^{2}} \quad \text { for any } F \in \mathscr{S},
$$

where $c_{u}$ is a constant depending only on $u$. If $u \in \operatorname{Dom}(I)$, then the random variable $I(u)$ is defined by the duality relationship (customarily called "integration by parts formula"):

$$
\begin{equation*}
E[F I(u)]=E\langle D F, u\rangle_{\mathfrak{H}}, \tag{2.11}
\end{equation*}
$$

which holds for every $F \in \mathbb{D}^{1,2}$.
For every $n \geq 1$, let $\mathcal{H}_{n}$ be the $n$th Wiener chaos of $X$, that is, the closed linear subspace of $L^{2}$ generated by the random variables $\left\{h_{n}(X(\varphi)): \varphi \in \mathfrak{H},|\varphi|_{\mathfrak{H}}=1\right\}$, where $h_{n}$ is the Hermite polynomial defined by (2.1). The mapping

$$
\begin{equation*}
I_{n}\left(\varphi^{\otimes n}\right)=h_{n}(X(\varphi)) \tag{2.12}
\end{equation*}
$$

provides a linear isometry between the symmetric tensor product $\mathfrak{H}^{\odot n}$ (equipped with the modified norm $\frac{1}{\sqrt{n!}}\|\cdot\|_{\mathfrak{H}^{\otimes n}}$ ) and $\mathcal{H}_{n}$. The following duality formula holds:

$$
\begin{equation*}
E\left[F I_{n}(f)\right]=E\left\langle D^{n} F, f\right\rangle_{\mathfrak{S}^{\otimes n}} \tag{2.13}
\end{equation*}
$$

for any element $f \in \mathfrak{H}^{\odot n}$ and any random variable $F \in \mathbb{D}^{n, 2}$. We will also need the following particular case of the classical product formula between multiple integrals: if $\varphi, \psi \in \mathfrak{H}$ and $m, n \geq 1$, then

$$
\begin{equation*}
I_{m}\left(\varphi^{\otimes m}\right) I_{n}\left(\psi^{\otimes n}\right)=\sum_{r=0}^{m \wedge n} r!\binom{m}{r}\binom{n}{r} I_{m+n-2 r}\left(\varphi^{\otimes(m-r)} \otimes \psi^{\otimes(n-r)}\right)\langle\varphi, \psi\rangle_{\mathfrak{H}}^{r} . \tag{2.14}
\end{equation*}
$$

Finally, we mention that the Gaussian space generated by $B=B^{1 / 6}$ can be identified with an isonormal Gaussian process of the type $B=\{B(h): h \in \mathfrak{H}\}$, where the real and
separable Hilbert space $\mathfrak{H}$ is defined as follows: (i) denote by $\mathscr{E}$ the set of all $\mathbb{R}$-valued step functions on $[0, \infty$ ), (ii) define $\mathfrak{H}$ as the Hilbert space obtained by closing $\mathscr{E}$ with respect to the scalar product

$$
\left\langle\mathbf{1}_{[0, t]}, \mathbf{1}_{[0, s]}\right\rangle_{\mathfrak{H}}=E[B(s) B(t)]=\frac{1}{2}\left(t^{1 / 3}+s^{1 / 3}-|t-s|^{1 / 3}\right) .
$$

In particular, note that $B(t)=B\left(\mathbf{1}_{[0, t]}\right)$. To end up, let us stress that the $m$ th derivative $D^{m}$ (with respect to $B$ ) verifies the Leibniz rule. That is, for any $F, G \in \mathbb{D}^{m, 2}$ such that $F G \in \mathbb{D}^{m, 2}$, we have

$$
\begin{equation*}
D_{t_{1}, \ldots, t_{m}}^{m}(F G)=\sum D_{J}^{|J|}(F) D_{J^{c}}^{m-|J|}(G), \quad t_{i} \in[0, T], \quad i=1, \ldots, m \tag{2.15}
\end{equation*}
$$

where the sum runs over all subsets $J$ of $\left\{t_{1}, \ldots, t_{m}\right\}$, with $|J|$ denoting the cardinality of $J$. Note that we may also write this as

$$
\begin{equation*}
D^{m}(F G)=\sum_{k=0}^{m}\binom{m}{k}\left(D^{k} F\right) \widetilde{\otimes}\left(D^{m-k} G\right) \tag{2.16}
\end{equation*}
$$

### 2.3 Expansions and Gaussian estimates

A key tool of ours will be the following version of Taylor's theorem with remainder.
Theorem 2.6. Let $k$ be a nonnegative integer. If $g \in C^{k}\left(\mathbb{R}^{d}\right)$, then

$$
g(b)=\sum_{|\alpha| \leq k} \partial^{\alpha} g(a) \frac{(b-a)^{\alpha}}{\alpha!}+R_{k}(a, b)
$$

where

$$
R_{k}(a, b)=k \sum_{|\alpha|=k} \frac{(b-a)^{\alpha}}{\alpha!} \int_{0}^{1}(1-u)^{k}\left[\partial^{\alpha} g(a+u(b-a))-\partial^{\alpha} g(a)\right] d u
$$

if $k \geq 1$, and $R_{0}(a, b)=g(b)-g(a)$. In particular, $R_{k}(a, b)=\sum_{|\alpha|=k} h_{\alpha}(a, b)(b-a)^{\alpha}$, where $h_{\alpha}$ is a continuous function with $h_{\alpha}(a, a)=0$ for all $a$. Moreover,

$$
\left|R_{k}(a, b)\right| \leq(k \vee 1) \sum_{|\alpha|=k} M_{\alpha}\left|(b-a)^{\alpha}\right|,
$$

where $M_{\alpha}=\sup \left\{\left|\partial^{\alpha} g(a+u(b-a))-\partial^{\alpha} g(a)\right|: 0 \leq u \leq 1\right\}$.
The following related expansion theorem is a slight modification of Corollary 4.2 in [1].
Theorem 2.7. Recall the Hermite polynomials $h_{n}(x)$ from (2.1). Let $k$ be a nonnegative integer. Suppose $\varphi: \mathbb{R} \rightarrow \mathbb{R}$ is measurable and has polynomial growth with constants $\widetilde{K}$ and $r$. Suppose $f \in C^{k+1}\left(\mathbb{R}^{d}\right)$ has polynomial growth of order $k+1$, with constants $K$ and $r$. Let $\xi \in \mathbb{R}^{d}$ and $Y \in \mathbb{R}$ be jointly normal with mean zero. Suppose that $E Y^{2}=1$ and $E \xi_{j}^{2} \leq \nu$ for some $\nu>0$. Define $\eta \in \mathbb{R}^{d}$ by $\eta_{j}=E\left[\xi_{j} Y\right]$. Then

$$
E[f(\xi) \varphi(Y)]=\sum_{|\alpha| \leq k} \frac{1}{\alpha!} \eta^{\alpha} E\left[\partial^{\alpha} f(\xi)\right] E\left[h_{|\alpha|}(Y) \varphi(Y)\right]+R,
$$

where $|R| \leq C K|\eta|^{k+1}$ and $C$ depends only on $\widetilde{K}, r, \nu, k$, and $d$.

Proof. Although this theorem is very similar to Corollary 4.2 in [1], we provide here another proof by means of Malliavin calculus.

Observe first that, without loss of generality, we can assume that $\xi_{i}=X\left(v_{i}\right), i=1, \ldots, d$, and $Y=X\left(v_{d+1}\right)$, where $X$ is an isonormal process over $\mathfrak{H}=\mathbb{R}^{d+1}$ and where $v_{1}, \ldots, v_{d+1}$ are some adequate vectors belonging in $\mathfrak{H}$. Since $\varphi$ has polynomial growth, we can expand it in terms of Hermite polynomials, that is $\varphi=\sum_{q=0}^{\infty} c_{q} h_{q}$. Thanks to (2.2), note that $q!c_{q}=E\left[\varphi(Y) h_{q}(Y)\right]$. We set

$$
\widehat{\varphi}_{k}=\sum_{q=0}^{k} c_{q} h_{q} \quad \text { and } \quad \check{\varphi}_{k}=\sum_{q=k+1}^{\infty} c_{q} h_{q} .
$$

Of course, we have

$$
E[f(\xi) \varphi(Y)]=E\left[f(\xi) \widehat{\varphi}_{k}(Y)\right]+E\left[f(\xi) \check{\varphi}_{k}(Y)\right]
$$

We obtain

$$
\begin{aligned}
E\left[f(\xi) \widehat{\varphi}_{k}(Y)\right] & =\sum_{q=0}^{k} \frac{1}{q!} E\left[\varphi(Y) h_{q}(Y)\right] E\left[f(\xi) h_{q}(Y)\right] \\
& =\sum_{q=0}^{k} \frac{1}{q!} E\left[\varphi(Y) h_{q}(Y)\right] E\left[f(\xi) I_{q}\left(v_{d+1}^{\otimes q}\right)\right] \quad \text { by 2.12) } \\
& =\sum_{q=0}^{k} \frac{1}{q!} E\left[\varphi(Y) h_{q}(Y)\right] E\left[\left\langle D^{q} f(\xi), v_{d+1}^{\otimes q}\right\rangle_{\mathfrak{H}^{\otimes q}}\right] \quad \text { by (2.13) } \\
& =\sum_{q=0}^{k} \frac{1}{q!} \sum_{i_{1}, \ldots, i_{q}=1}^{d} E\left[\varphi(Y) h_{q}(Y)\right] E\left[\frac{\partial^{q} f}{\partial x_{i_{1}} \cdots \partial x_{i_{q}}}(\xi)\right] \prod_{\ell=1}^{q} \eta_{i_{\ell}} \quad \text { by (2.9). }
\end{aligned}
$$

Since the map $\Phi:\{1, \ldots, d\}^{q} \rightarrow\left\{\alpha \in \mathbb{N}_{0}^{d}:|\alpha|=q\right\}$ defined by $\left(\Phi\left(i_{1}, \ldots, i_{q}\right)\right)_{j}=\left|\left\{\ell: i_{\ell}=j\right\}\right|$ is a surjection with $\left|\Phi^{-1}(\alpha)\right|=q!/ \alpha!$, this gives

$$
\begin{aligned}
E\left[f(\xi) \widehat{\varphi}_{k}(Y)\right] & =\sum_{q=0}^{k} \frac{1}{q!} \sum_{|\alpha|=q} \frac{q!}{\alpha!} E\left[\varphi(Y) h_{q}(Y)\right] E\left[\partial^{\alpha} f(\xi)\right] \eta^{\alpha} \\
& =\sum_{|\alpha| \leq k} \frac{1}{\alpha!} E\left[\varphi(Y) h_{|\alpha|}(Y)\right] E\left[\partial^{\alpha} f(\xi)\right] \eta^{\alpha} .
\end{aligned}
$$

On the other hand, the identity (2.2), combined with the fact that each monomial $x^{n}$ can be expanded in terms of the first $n$ Hermite polynomials, implies that $E\left[Y^{|\alpha|} \breve{\varphi}_{k}(Y)\right]=0$ for all $|\alpha| \leq k$. Now, let $U=\xi-\eta Y$ and define $g: \mathbb{R}^{d} \rightarrow \mathbb{R}$ by $g(x)=E\left[f(U+x Y) \check{\varphi}_{k}(Y)\right]$. Since $\varphi$ (and, consequently, also $\check{\varphi}_{k}$ ) and $f$ have polynomial growth, and all derivatives of $f$ up to order $k+1$ have polynomial growth, we may differentiate under the expectation and conclude that $g \in C^{k+1}\left(\mathbb{R}^{d}\right)$. Hence, by Taylor's theorem (more specifically, by the version
of Taylor's theorem which appears as Theorem 2.13 in [1]), and the fact that $U$ and $Y$ are independent,

$$
\begin{aligned}
E\left[f(\xi) \check{\varphi}_{k}(Y)\right]=g(\eta) & =\sum_{|\alpha| \leq k} \frac{1}{\alpha!} \eta^{\alpha} \partial^{\alpha} g(0)+R \\
& =\sum_{|\alpha| \leq k} \frac{1}{\alpha!} \eta^{\alpha} E\left[\partial^{\alpha} f(U)\right] E\left[Y^{|\alpha|} \check{\varphi}_{k}(Y)\right]+R=R
\end{aligned}
$$

where

$$
|R| \leq \frac{M d^{(k+1) / 2}}{k!}|\eta|^{k+1}
$$

and $M=\sup \left\{\left|\partial^{\alpha} g(u \eta)\right|: 0 \leq u \leq 1,|\alpha|=k+1\right\}$. Note that

$$
\partial^{\alpha} g(u \eta)=E\left[\partial^{\alpha} f(U+u \eta Y) Y^{|\alpha|} \check{\varphi}_{k}(Y)\right]=E\left[\partial^{\alpha} f(\xi-\eta(1-u) Y) Y^{|\alpha|} \check{\varphi}_{k}(Y)\right]
$$

Hence,

$$
\begin{aligned}
\left|\partial^{\alpha} g(u \eta)\right| & \leq K \widetilde{K} E\left[\left(1+|\xi-\eta(1-u) Y|^{r}\right)|Y|^{|\alpha|}\left(1+|Y|^{r}\right)\right] \\
& \leq K \widetilde{K} E\left[\left(1+2^{r}|\xi|^{r}+2^{r}|\eta|^{r}|Y|^{r}\right)\left(|Y|^{|\alpha|}+|Y|^{|\alpha|+r}\right) .\right.
\end{aligned}
$$

Since $|\eta|^{2} \leq \nu d$, this completes the proof.
The following special case will be used multiple times.
Corollary 2.8. Let $X_{1}, \ldots, X_{n}$ be jointly normal, each with mean zero and variance bounded by $\nu>0$. Let $\eta_{i j}=E\left[X_{i} X_{j}\right]$. If $f \in C^{1}\left(\mathbb{R}^{n-1}\right)$ has polynomial growth of order 1 with constants $K$ and $r$, then

$$
\begin{equation*}
\left|E\left[f\left(X_{1}, \ldots, X_{n-1}\right) X_{n}^{3}\right]\right| \leq C K \sigma^{3} \max _{j<n}\left|\eta_{j n}\right| \tag{2.17}
\end{equation*}
$$

where $\sigma=\left(E X_{n}^{2}\right)^{1 / 2}$ and $C$ depends only on $r, \nu$, and $n$.
Proof. Apply Theorem 2.7 with $k=0$.
Finally, the following covariance estimates will be critical.
Lemma 2.9. Recall the notation $\beta_{j}=\left(B\left(t_{j-1}\right)+B\left(t_{j}\right)\right) / 2$ and $r_{+}=r \vee 1$. For any $i, j$,
(i) $\left|E\left[\Delta B_{i} \Delta B_{j}\right]\right| \leq C \Delta t^{1 / 3}|j-i|_{+}^{-5 / 3}$,
(ii) $\left|E\left[B\left(t_{i}\right) \Delta B_{j}\right]\right| \leq C \Delta t^{1 / 3}\left(j^{-2 / 3}+|j-i|_{+}^{-2 / 3}\right)$,
(iii) $\left|E\left[\beta_{i} \Delta B_{j}\right]\right| \leq C \Delta t^{1 / 3}\left(j^{-2 / 3}+|j-i|_{+}^{-2 / 3}\right)$,
(iv) $\left|E\left[\beta_{j} \Delta B_{j}\right]\right| \leq C \Delta t^{1 / 3} j^{-2 / 3}$, and
(v) $C_{1}\left|t_{j}-t_{i}\right|^{1 / 3} \leq E\left|\beta_{j}-\beta_{i}\right|^{2} \leq C_{2}\left|t_{j}-t_{i}\right|^{1 / 3}$,
where $C_{1}, C_{2}$ are positive, finite constants that do not depend on $i$ or $j$.
Proof. (i) By symmetry, we may assume $i \leq j$. First, assume $j-i \geq 2$. Then

$$
E\left[\Delta B_{i} \Delta B_{j}\right]=\int_{t_{i-1}}^{t_{i}} \int_{t_{j-1}}^{t_{j}} \partial_{s t}^{2} R(s, t) d t d s
$$

where $\partial_{s t}^{2}=\partial_{1} \partial_{2}$. Note that for $s<t, \partial_{s t}^{2} R(s, t)=-(1 / 9)(t-s)^{-5 / 3}$. Hence,

$$
\left|E\left[\Delta B_{i} \Delta B_{j}\right]\right| \leq C \Delta t^{2}\left|t_{j-1}-t_{i}\right|^{-5 / 3} \leq C \Delta t^{1 / 3}|j-i|^{-5 / 3}
$$

Now assume $j-i \leq 1$. By Hölder's inequality, $\left|E\left[\Delta B_{i} \Delta B_{j}\right]\right| \leq \Delta t^{1 / 3}=\Delta t^{1 / 3}|j-i|_{+}^{-5 / 3}$.
(ii) First note that by (i),

$$
\left|E\left[B\left(t_{i}\right) \Delta B_{j}\right]\right| \leq \sum_{k=1}^{i}\left|E\left[\Delta B_{k} \Delta B_{j}\right]\right| \leq C \Delta t^{1 / 3} \sum_{k=1}^{j}|k-j|_{+}^{-5 / 3} \leq C \Delta t^{1 / 3}
$$

This proves the lemma when either $j=1$ or $|j-i|_{+}=1$. To complete the proof of (ii), suppose $j>1$ and $|j-i|>1$. Note that if $t>0$ and $s \neq t$, then

$$
\partial_{2} R(s, t)=\frac{1}{6} t^{-2 / 3}-\frac{1}{6}|t-s|^{-2 / 3} \operatorname{sgn}(t-s) .
$$

We may therefore write $E\left[B\left(t_{i}\right) \Delta B_{j}\right]=\int_{t_{j-1}}^{t_{j}} \partial_{2} R\left(t_{i}, u\right) d u$, giving

$$
\left|E\left[B\left(t_{i}\right) \Delta B_{j}\right]\right| \leq \Delta t \sup _{u \in\left[t_{j-1}, t_{j}\right]}\left|\partial_{2} R\left(t_{i}, u\right)\right| \leq C \Delta t^{1 / 3}\left(j^{-2 / 3}+|j-i|_{+}^{-2 / 3}\right),
$$

which is (ii).
(iii) This follows immediately from (ii).
(iv) Note that $2 \beta_{j} \Delta B_{j}=B\left(t_{j}\right)^{2}-B\left(t_{j-1}\right)^{2}$. Since $E B(t)^{2}=t^{1 / 3}$, the mean value theorem gives $\left|E\left[\beta_{j} \Delta B_{j}\right]\right| \leq C(\Delta t) t_{j}^{-2 / 3}=C \Delta t^{1 / 3} j^{-2 / 3}$.
(v) Without loss of generality, we may assume $i<j$. The upper bound follows from

$$
2\left(\beta_{j}-\beta_{i}\right)=\left(B\left(t_{j}\right)-B\left(t_{i}\right)\right)+\left(B\left(t_{j-1}\right)-B\left(t_{i-1}\right)\right),
$$

and the fact that $E|B(t)-B(s)|^{2}=|t-s|^{1 / 3}$. For the lower bound, we first assume $i<j-1$ and write

$$
2\left(\beta_{j}-\beta_{i}\right)=2\left(B\left(t_{j-1}\right)-B\left(t_{i}\right)\right)+\Delta B_{j}+\Delta B_{i}
$$

Hence,

$$
\left(E\left|\beta_{j}-\beta_{i}\right|^{2}\right)^{1 / 2} \geq\left|t_{j-1}-t_{i}\right|^{1 / 6}-\frac{1}{2}\left(E\left|\Delta B_{j}+\Delta B_{i}\right|^{2}\right)^{1 / 2}
$$

Since $\Delta B_{i}$ and $\Delta B_{j}$ are negatively correlated,

$$
E\left|\Delta B_{j}+\Delta B_{i}\right|^{2} \leq E\left|\Delta B_{j}\right|^{2}+E\left|\Delta B_{i}\right|^{2}=2 \Delta t^{1 / 3}
$$

Thus,

$$
\left(E\left|\beta_{j}-\beta_{i}\right|^{2}\right)^{1 / 2} \geq \Delta t^{1 / 6}|j-1-i|^{1 / 6}-2^{-1 / 2} \Delta t^{1 / 6} \geq C \Delta t^{1 / 6}|j-i|^{1 / 6}
$$

for some $C>0$. This completes the proof when $i<j-1$.
If $i=j-1$, the conclusion is immediate, since $2\left(\beta_{j}-\beta_{j-1}\right)=B\left(t_{j}\right)-B\left(t_{j-2}\right)$.

### 2.4 Sextic and signed cubic variations

Theorem 2.10. For each $T>0$, we have $E\left[\sup _{0 \leq t \leq T}\left|V_{n}^{6}(B, t)-15 t\right|^{2}\right] \rightarrow 0$ as $n \rightarrow \infty$. In particular, $V_{n}^{6}(B, t) \rightarrow 15 t u c p$.

Proof. Since $V_{n}^{6}(B)$ is monotone, it will suffice to show that $V_{n}^{6}(B, t) \rightarrow 15 t$ in $L^{2}$ for each fixed $t$. Indeed, the uniform convergence will then be a direct consequence of Dini's theorem. We write

$$
V_{n}^{6}(B, t)-15 t=\sum_{j=1}^{\lfloor n t\rfloor}\left(\Delta B_{j}^{6}-15 \Delta t\right)+15(\lfloor n t\rfloor / n-t)
$$

Since $|\lfloor n t\rfloor / n-t| \leq \Delta t$, it will suffice to show that $E\left|\sum_{j=1}^{\lfloor n t\rfloor}\left(\Delta B_{j}^{6}-15 \Delta t\right)\right|^{2} \rightarrow 0$. For this, we compute

$$
\begin{align*}
E\left|\sum_{j=1}^{\lfloor n t\rfloor}\left(\Delta B_{j}^{6}-15 \Delta t\right)\right|^{2} & =\sum_{i=1}^{\lfloor n t\rfloor} \sum_{j=1}^{\lfloor n t\rfloor} E\left[\left(\Delta B_{i}^{6}-15 \Delta t\right)\left(\Delta B_{j}^{6}-15 \Delta t\right)\right]  \tag{2.18}\\
& =\sum_{i=1}^{\lfloor n t\rfloor} \sum_{j=1}^{\lfloor n t\rfloor}\left(E\left[\Delta B_{i}^{6} \Delta B_{j}^{6}\right]-225 \Delta t^{2}\right) .
\end{align*}
$$

By Theorem 2.7, if $\xi, Y$ are jointly Gaussian, standard normals, then $E\left[\xi^{6} Y^{6}\right]=225+R$, where $|R| \leq C|E[\xi Y]|^{2}$. Applying this with $\xi=\Delta t^{-1 / 6} \Delta B_{i}$ and $Y=\Delta t^{-1 / 6} \Delta B_{j}$, and using Lemma 2.9(i), gives $\left.\mid E\left[\Delta B_{i}^{6} \Delta B_{j}^{6}\right]-225 \Delta t^{2}\right]\left|\leq C \Delta t^{2}\right| j-\left.i\right|_{+} ^{-10 / 3}$. Substituting this into (2.18), we have

$$
E\left|\sum_{j=1}^{\lfloor n t\rfloor}\left(\Delta B_{j}^{6}-15 \Delta t\right)\right|^{2} \leq C\lfloor n t\rfloor \Delta t^{2} \leq C t \Delta t \rightarrow 0
$$

which completes the proof.
Theorem 2.11. As $n \rightarrow \infty,\left(B, V_{n}(B)\right) \rightarrow(B, \llbracket B \rrbracket)$ in law in $D_{\mathbb{R}^{2}}[0, \infty)$.
Proof. By Theorem 10 in 【1], $\left(B, V_{n}(B)\right) \rightarrow(B, \kappa W)=(B, \llbracket B \rrbracket)$ in law in $\left(D_{\mathbb{R}}[0, \infty)\right)^{2}$. By Lemma 2.1, this implies $\left(B, V_{n}(B)\right) \rightarrow(B, \llbracket B \rrbracket)$ in $D_{\mathbb{R}^{2}}[0, \infty)$.

### 2.5 Main result

Given $g \in C^{\infty}(\mathbb{R})$, choose $G$ such that $G^{\prime}=g$. We then define

$$
\begin{equation*}
\int_{0}^{t} g(B(s)) d B(s)=G(B(t))-G(B(0))+\frac{1}{12} \int_{0}^{t} G^{\prime \prime \prime}(B(s)) d \llbracket B \rrbracket_{s} \tag{2.19}
\end{equation*}
$$

Note that, by definition, the change of variable formula (1.3) holds for all $g \in C^{\infty}$. We shall use the shorthand notation $\int g(B) d B$ to refer to the process $t \mapsto \int_{0}^{t} g(B(s)) d B(s)$. Similarly, $\int g(B) d \llbracket B \rrbracket$ and $\int g(B) d s$ shall refer to the processes $t \mapsto \int_{0}^{t} g(B(s)) d \llbracket B \rrbracket_{s}$ and $t \mapsto \int_{0}^{t} g(B(s)) d s$, respectively.

Our main result is the following.

Theorem 2.12. If $g \in C^{\infty}(\mathbb{R})$, then $\left(B, V_{n}(B), I_{n}(g, B)\right) \rightarrow\left(B, \llbracket B \rrbracket, \int g(B) d B\right)$ in law in $D_{\mathbb{R}^{3}}[0, \infty)$.

We also have the following generalization concerning the joint convergence of multiple sequences of Riemann sums.

Theorem 2.13. Fix $k \geq 1$. Let $g_{j} \in C^{\infty}(\mathbb{R})$ for $1 \leq j \leq k$. Let $J_{n}$ be the $\mathbb{R}^{k}$-valued process whose $j$-th component is $\left(J_{n}\right)_{j}=I_{n}\left(g_{j}, B\right)$. Similarly, define $J$ by $J_{j}=\int g_{j}(B) d B$. Then $\left(B, V_{n}(B), J_{n}\right) \rightarrow(B, \llbracket B \rrbracket, J)$ in law in $D_{\mathbb{R}^{k+2}}[0, \infty)$.

Remark 2.14. In less formal language, Theorem 2.13 states that the Riemann sums $I_{n}\left(g_{j}, B\right)$ converge jointly, and the limiting stochastic integrals are all defined in terms of the same Brownian motion. In other words, the limiting Brownian motion remains unchanged under changes in the integrand. In this sense, the limiting Brownian motion depends only on $B$, despite being independent of $B$ in the probabilistic sense.

The proofs of these two theorems are given in Section 5 .

## 3 Finite-dimensional distributions

Theorem 3.1. If $g \in C^{\infty}(\mathbb{R})$ is bounded with bounded derivatives, then

$$
\left(B, V_{n}(B), \frac{1}{\sqrt{n}} \sum_{j=1}^{\lfloor n \cdot\rfloor} \frac{g\left(B\left(t_{j-1}\right)\right)+g\left(B\left(t_{j}\right)\right)}{2} h_{3}\left(n^{1 / 6} \Delta B_{j}\right)\right) \rightarrow\left(B, \llbracket B \rrbracket, \int g(B) d \llbracket B \rrbracket\right),
$$

in the sense of finite-dimensional distributions on $[0, \infty)$.
The rest of this section is devoted to the proof of Theorem 3.1.

### 3.1 Some technical lemmas

During the proof of Theorem 3.1, we will need technical results that are collected here. Moreover, for notational convenience, we will make use of the following shorthand notation:

$$
\delta_{j}=\mathbf{1}_{\left[t_{j-1}, t_{j}\right]} \quad \text { and } \quad \varepsilon_{j}=\mathbf{1}_{\left[0, t_{j}\right]} .
$$

For future reference, let us note that by 2.10,

$$
\begin{equation*}
\varepsilon_{t}^{\otimes a} \widetilde{\otimes} \varepsilon_{s}^{\otimes(q-a)}=\binom{q}{a}^{-1} \sum_{\substack{i_{1}, \ldots, i_{i} \in\{s, t\} \\\left|\left\{j: i_{j}=s\right\}\right|=q-a}} \varepsilon_{i_{1}} \otimes \ldots \otimes \varepsilon_{i_{q}} . \tag{3.1}
\end{equation*}
$$

Lemma 3.2. We have
(i) $|E[B(r)(B(t)-B(s))]|=\left|\left\langle\mathbf{1}_{[0, r]}, \mathbf{1}_{[s, t]}\right\rangle_{\mathfrak{H}}\right| \leq|t-s|^{1 / 3}$ for any $r, s, t \geq 0$;
(ii) $\sup _{0 \leq s \leq T} \sum_{k=1}^{\lfloor n t\rfloor}\left|E\left[B(s) \Delta B_{k}\right]\right|=\sup _{0 \leq s \leq T} \sum_{k=1}^{\lfloor n t\rfloor}\left|\left\langle\mathbf{1}_{[0, s]}, \delta_{k}\right\rangle_{\mathfrak{H}}\right| \underset{n \rightarrow \infty}{=} O(1)$ for any fixed $t, T>0$;
(iii) $\sum_{k, j=1}^{\lfloor n t\rfloor}\left|E\left(B\left(t_{j-1}\right) \Delta B_{k}\right)\right|=\sum_{k, j=1}^{\lfloor n t\rfloor}\left|\left\langle\varepsilon_{j-1}, \delta_{k}\right\rangle_{\mathfrak{H}}\right| \underset{n \rightarrow \infty}{=} O(n)$ for any fixed $t>0$;
(iv) $\sum_{k=1}^{\lfloor n t\rfloor}\left|\left(E\left[B\left(t_{k-1}\right) \Delta B_{k}\right]\right)^{3}+\frac{1}{8 n}\right|=\sum_{k=1}^{\lfloor n t\rfloor}\left|\left\langle\varepsilon_{k-1}, \delta_{k}\right\rangle_{\mathfrak{H}}^{3}+\frac{1}{8 n}\right| \underset{n \rightarrow \infty}{\longrightarrow} 0$ for any fixed $t>0$;
(v) $\sum_{k=1}^{\lfloor n t\rfloor}\left|\left(E\left[B\left(t_{k}\right) \Delta B_{k}\right]\right)^{3}-\frac{1}{8 n}\right|=\sum_{k=1}^{\lfloor n t\rfloor}\left|\left\langle\varepsilon_{k}, \delta_{k}\right\rangle_{\mathfrak{H}}^{3}-\frac{1}{8 n}\right| \underset{n \rightarrow \infty}{\longrightarrow} 0$ for any fixed $t>0$.

## Proof.

(i) We have

$$
E(B(r)(B(t)-B(s)))=\frac{1}{2}\left(t^{1 / 3}-s^{1 / 3}\right)+\frac{1}{2}\left(|s-r|^{1 / 3}-|t-r|^{1 / 3}\right) .
$$

Using the classical inequality $\left||b|^{1 / 3}-|a|^{1 / 3}\right| \leq|b-a|^{1 / 3}$, the desired result follows.
(ii) Observe that

$$
E\left(B(s) \Delta B_{k}\right)=\frac{1}{2 n^{1 / 3}}\left(k^{1 / 3}-(k-1)^{1 / 3}-|k-n s|^{1 / 3}+|k-n s-1|^{1 / 3}\right) .
$$

We deduce, for any fixed $s \leq t$ :

$$
\begin{aligned}
& \sum_{k=1}^{\lfloor n t\rfloor}\left|E\left(B(s) \Delta B_{k}\right)\right| \leq \frac{1}{2} t^{1 / 3}+\frac{1}{2 n^{1 / 3}}\left((\lfloor n s\rfloor-n s+1)^{1 / 3}-(n s-\lfloor n s\rfloor)^{1 / 3}\right. \\
& \left.+\sum_{k=1}^{\lfloor n s\rfloor}\left((n s+1-k)^{1 / 3}-(n s-k)^{1 / 3}\right)+\sum_{k=\lfloor n s\rfloor+2}^{\lfloor n t\rfloor}\left((k-n s)^{1 / 3}-(k-n s-1)^{1 / 3}\right)\right) \\
& \quad=\frac{1}{2}\left(t^{1 / 3}+s^{1 / 3}+|t-s|^{1 / 3}\right)+R_{n}
\end{aligned}
$$

where $\left|R_{n}\right| \leq C n^{-1 / 3}$, and $C$ does not depend on $s$ or $t$. The case where $s>t$ can be obtained similarly. Taking the supremum over $s \in[0, T]$ gives us (ii).
(iii) is a direct consequence of (ii).
(iv) We have

$$
\begin{aligned}
\left|\left(E\left(B\left(t_{k-1}\right) \Delta B_{k}\right)\right)^{3}+\frac{1}{8 n}\right|= & \frac{1}{8 n}\left(k^{1 / 3}-(k-1)^{1 / 3}\right) \\
& \times\left|\left(k^{1 / 3}-(k-1)^{1 / 3}\right)^{2}-3\left(k^{1 / 3}-(k-1)^{1 / 3}\right)+3\right| .
\end{aligned}
$$

Thus, the desired convergence is immediately checked by combining the bound $0 \leq$ $k^{1 / 3}-(k-1)^{1 / 3} \leq 1$ with a telescoping sum argument.
(v) The proof is very similar to the proof of $(i v)$.

Lemma 3.3. Let $s \geq 1$, and suppose that $\phi \in C^{6}\left(\mathbb{R}^{s}\right)$ and $g_{1}, g_{2} \in C^{6}(\mathbb{R})$ have polynomial growth of order 6, all with constants $K$ and $r$. Fix $a, b \in[0, T]$. Then

$$
\sup _{u_{1}, \ldots, u_{s} \in[0, T]} \sup _{n \geq 1}^{\lfloor n a\rfloor} \sum_{i_{1}=1}^{\lfloor n b\rfloor} \sum_{i_{2}=1}^{\lfloor n b}\left|E\left(\phi\left(B\left(u_{1}\right), \ldots, B\left(u_{s}\right)\right) g_{1}\left(B\left(t_{i_{1}-1}\right)\right) g_{2}\left(B\left(t_{i_{2}-1}\right)\right) I_{3}\left(\delta_{i_{1}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{2}}^{\otimes 3}\right)\right)\right|
$$

is finite.
Proof. Let $C$ denote a constant depending only on $T, s, K$, and $r$, and whose value can change from one line to another. Define $f: \mathbb{R}^{s+3} \rightarrow \mathbb{R}$ by

$$
f(x)=\phi\left(x_{1}, \ldots, x_{s}\right) g_{1}\left(x_{s+1}\right) g_{2}\left(x_{s+2}\right) h_{3}\left(x_{s+3}\right)
$$

Let $\xi_{i}=B\left(u_{i}\right), i=1, \ldots, s ; \xi_{s+1}=B\left(t_{i_{1}-1}\right), \xi_{s+2}=B\left(t_{i_{2}-1}\right), \xi_{s+3}=n^{1 / 6} \Delta B_{i_{1}}$, and $\eta_{i}=n^{1 / 6} E\left[\xi_{i} \Delta B_{i_{2}}\right]$. Applying Theorem 2.7 with $k=5$, we obtain

$$
\begin{aligned}
& E\left(\phi\left(B\left(u_{1}\right), \ldots, B\left(u_{s}\right)\right) g_{1}\left(B\left(t_{i_{1}-1}\right)\right) g_{2}\left(B\left(t_{i_{2}-1}\right)\right) I_{3}\left(\delta_{i_{1}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{2}}^{\otimes 3}\right)\right) \\
& \quad=\frac{1}{n} E\left(\phi\left(B\left(u_{1}\right), \ldots, B\left(u_{s}\right)\right) g_{1}\left(B\left(t_{i_{1}-1}\right)\right) g_{2}\left(B\left(t_{i_{2}-1}\right)\right) h_{3}\left(n^{\frac{1}{6}} \Delta B_{i_{1}}\right) h_{3}\left(n^{\frac{1}{6}} \Delta B_{i_{2}}\right)\right) \\
& \quad=\frac{1}{n} \sum_{|\alpha|=3} \frac{6}{\alpha!} E\left[\partial^{\alpha} f(\xi)\right] \eta^{\alpha}+\frac{R}{n}
\end{aligned}
$$

where $|R| \leq C|\eta|^{6}$.
By Lemma $3.2(i)$, we have $\left|\eta_{i}\right| \leq n^{-1 / 6}$ for any $i \leq s+2$, and $\left|\eta_{s+3}\right| \leq 1$. Moreover, we have

$$
\left.\frac{1}{n} \sum_{i_{1}=1}^{\lfloor n a\rfloor} \sum_{i_{2}=2}^{\lfloor n b\rfloor}\left|\eta_{s+3}\right|=\frac{1}{2 n} \sum_{i_{1}=1}^{\lfloor n a\rfloor} \sum_{i_{2}=2}^{\lfloor n b\rfloor}| | i_{1}-i_{2}+\left.1\right|^{1 / 3}+\left|i_{1}-i_{2}-1\right|^{1 / 3}-2\left|i_{1}-i_{2}\right|^{1 / 3} \right\rvert\, \leq C .
$$

Therefore, by taking into account these two facts, we deduce $\frac{1}{n} \sum_{i_{1}=1}^{\lfloor n a\rfloor} \sum_{i_{2}=2}^{\lfloor n b\rfloor}|R| \leq C$.
On the other hand, if $\alpha \in \mathbb{N}_{0}^{s+3}$ is such that $|\alpha|=3$ with $\alpha_{s+3} \neq 0$, we have

$$
\begin{aligned}
& \frac{1}{n} \sum_{i_{1}=1}^{\lfloor n a\rfloor} \sum_{i_{2}=1}^{\lfloor n b\rfloor} \frac{6}{\alpha!}\left|E\left[\partial^{\alpha} f(\xi)\right]\right|\left|\eta^{\alpha}\right| \\
& \left.\quad \leq \frac{C}{n} \sum_{i_{1}=1}^{\lfloor n a\rfloor} \sum_{i_{2}=1}^{\lfloor n b\rfloor}| | i_{1}-i_{2}+\left.1\right|^{1 / 3}+\left|i_{1}-i_{2}-1\right|^{1 / 3}-2\left|i_{1}-i_{2}\right|^{1 / 3} \right\rvert\, \leq C
\end{aligned}
$$

Finally, if $\alpha \in \mathbb{N}_{0}^{s+3}$ is such that $|\alpha|=3$ with $\alpha_{s+3}=0$ then $\partial^{\alpha} f=\partial^{\alpha} \widehat{f} \otimes h_{3}$ with $\widehat{f}: \mathbb{R}^{s+2} \rightarrow \mathbb{R}$ defined by $\widehat{f}(x)=\phi\left(x_{1}, \ldots, x_{s}\right) g_{1}\left(x_{s+1}\right) g_{2}\left(x_{s+2}\right)$. Hence, applying Theorem 2.7 to $\widehat{f}$ with $k=2$, we deduce, for $\widehat{\eta} \in \mathbb{N}_{0}^{s+2}$ defined by $\widehat{\eta}_{i}=\eta_{i}$,

$$
\left|E\left[\partial^{\alpha} f(\xi)\right]\right|=\left|E\left[\partial^{\alpha} \widehat{f}(\xi) h_{3}\left(n^{1 / 6} \Delta B_{i_{1}}\right)\right]\right| \leq C|\widehat{\eta}|^{3} \leq C n^{-1 / 2}
$$

so that

$$
\frac{1}{n} \sum_{i_{1}=1}^{\lfloor n a\rfloor} \sum_{i_{2}=1}^{\lfloor n b\rfloor} \frac{6}{\alpha!}\left|E\left[\partial^{\alpha} f(\xi)\right]\right|\left|\eta^{\alpha}\right|=\frac{1}{n} \sum_{i_{1}=1}^{\lfloor n a\rfloor} \sum_{i_{2}=1}^{\lfloor n b\rfloor} \frac{6}{\alpha!}\left|E\left[\partial^{\alpha} f(\xi)\right]\right|\left|\widehat{\eta}^{\alpha}\right| \leq C .
$$

The proof of Lemma 3.3 is done.
Lemma 3.4. Let $g, h \in C^{q}(\mathbb{R}), q \geq 1$, having bounded derivatives, and fix $s, t \geq 0$. Set $\varepsilon_{t}=\mathbf{1}_{[0, t]}$ and $\varepsilon_{s}=\mathbf{1}_{[0, s]}$. Then $g(B(t)) h(B(s))$ belongs in $\mathbb{D}^{q, 2}$ and we have

$$
\begin{equation*}
D^{q}(g(B(t)) h(B(s)))=\sum_{a=0}^{q}\binom{q}{a} g^{(a)}(B(t)) h^{(q-a)}(B(s)) \varepsilon_{t}^{\otimes a} \widetilde{\otimes} \varepsilon_{s}^{\otimes(q-a)} \tag{3.2}
\end{equation*}
$$

Proof. This follows immediately from (2.16).
Lemma 3.5. Fix an integer $r \geq 1$, and some real numbers $s_{1}, \ldots, s_{r} \geq 0$. Suppose $\varphi \in C^{\infty}\left(\mathbb{R}^{r}\right)$ and $g_{j} \in C^{\infty}(\mathbb{R})$, $j=1,2,3,4$, are bounded with bounded partial derivatives. For $i_{1}, i_{2}, i_{3}, i_{4} \in \mathbb{N}$, set $\Phi\left(i_{1}, i_{2}, i_{3}, i_{4}\right):=\varphi\left(B_{s_{1}}, \ldots, B_{s_{r}}\right) \prod_{j=1}^{4} g_{j}\left(B_{s_{i_{j}}}\right)$. Then, for any fixed $a, b, c, d>0$, the following estimate is in order:

\begin{equation*}
\sup _{n \geq 1}^{\lfloor n a\rfloor} \sum_{i_{1}=1}^{\lfloor n b\rfloor} \sum_{i_{2}=1}^{\lfloor n c\rfloor} \sum_{i_{3}=1}^{\lfloor n d\rfloor} \sum_{i_{4}=1}^{\lfloor n\rfloor}\left|E\left(\Phi\left(i_{1}, i_{2}, i_{3}, i_{4}\right) I_{3}\left(\delta_{i_{1}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{2}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{3}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{4}}^{\otimes 3}\right)\right)\right|<\infty \tag{3.3}
\end{equation*}
$$

Proof. Using the product formula (2.14), we have that $I_{3}\left(\delta_{i_{3}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{4}}^{\otimes 3}\right)$ equals

$$
I_{6}\left(\delta_{i_{3}}^{\otimes 3} \otimes \delta_{i_{4}}^{\otimes 3}\right)+9 I_{4}\left(\delta_{i_{3}}^{\otimes 2} \otimes \delta_{i_{4}}^{\otimes 2}\right)\left\langle\delta_{i_{3}}, \delta_{i_{4}}\right\rangle_{\mathfrak{H}}+18 I_{2}\left(\delta_{i_{3}} \otimes \delta_{i_{4}}\right)\left\langle\delta_{i_{3}}, \delta_{i_{4}}\right\rangle_{\mathfrak{H}}^{2}+6\left\langle\delta_{i_{3}}, \delta_{i_{4}}\right\rangle_{\mathfrak{H}}^{3}
$$

As a consequence, we get

& \sum_{i_{1}=1}^{\lfloor n a\rfloor} \sum_{i_{2}=1}^{\lfloor n b\rfloor} \sum_{i_{3}=1}^{\lfloor n c\rfloor} \sum_{i_{4}=1}^{\lfloor n d\rfloor}\left|E\left(\Phi\left(i_{1}, i_{2}, i_{3}, i_{4}\right) I_{3}\left(\delta_{i_{1}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{2}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{3}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{4}}^{\otimes 3}\right)\right)\right| \\
& \leq \sum_{i_{1}=1}^{\lfloor n a\rfloor} \sum_{i_{2}=1}^{\lfloor n b\rfloor} \sum_{i_{3}=1}^{\lfloor n c\rfloor} \sum_{i_{4}=1}^{\lfloor n d\rfloor}\left|E\left(\Phi\left(i_{1}, i_{2}, i_{3}, i_{4}\right) I_{3}\left(\delta_{i_{1}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{2}}^{\otimes 3}\right) I_{6}\left(\delta_{i_{3}}^{\otimes 3} \otimes \delta_{i_{4}}^{\otimes 3}\right)\right)\right| \\
& \quad+9 \sum_{i_{1}=1}^{\lfloor n a\rfloor} \sum_{i_{2}=1}^{\lfloor n b\rfloor} \sum_{i_{3}=1}^{\lfloor n c\rfloor} \sum_{i_{4}=1}^{\lfloor n d\rfloor}\left|E\left(\Phi\left(i_{1}, i_{2}, i_{3}, i_{4}\right) I_{3}\left(\delta_{i_{1}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{2}}^{\otimes 3}\right) I_{4}\left(\delta_{i_{3}}^{\otimes 2} \otimes \delta_{i_{4}}^{\otimes 2}\right)\right)\right|\left|\left\langle\delta_{i_{3}}, \delta_{i_{4}}\right\rangle_{\mathfrak{H}}\right| \\
& \quad+18 \sum_{i_{1}=1}^{\lfloor n a\rfloor} \sum_{i_{2}=1}^{\lfloor n b\rfloor} \sum_{i_{3}=1}^{\lfloor n c\rfloor} \sum_{i_{4}=1}^{\lfloor n d\rfloor}\left|E\left(\Phi\left(i_{1}, i_{2}, i_{3}, i_{4}\right) I_{3}\left(\delta_{i_{1}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{2}}^{\otimes 3}\right) I_{2}\left(\delta_{i_{3}} \otimes \delta_{i_{4}}\right)\right)\right|\left\langle\delta_{i_{3}}, \delta_{i_{4}}\right\rangle_{\mathfrak{H}}^{2} \\
& \quad+6 \sum_{i_{1}=1}^{\lfloor n a\rfloor} \sum_{i_{2}=1}^{\lfloor n b\rfloor} \sum_{i_{3}=1}^{\lfloor n c\rfloor} \sum_{i_{4}=1}^{\lfloor n d\rfloor}\left|E\left(\Phi\left(i_{1}, i_{2}, i_{3}, i_{4}\right) I_{3}\left(\delta_{i_{1}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{2}}^{\otimes 3}\right)\right)\right|\left|\left\langle\delta_{i_{3}}, \delta_{i_{4}}\right\rangle_{\mathfrak{H}}\right|^{3} \\
&= A_{1}^{(n)}+9 A_{2}^{(n)}+18 A_{3}^{(n)}+6 A_{4}^{(n)} .

(1) First, we deal with the term $A_{1}^{(n)}$.

A_{1}^{(n)} & =\sum_{i_{1}=1}^{\lfloor n a\rfloor} \sum_{i_{2}=1}^{\lfloor n b\rfloor} \sum_{i_{3}=1}^{\lfloor n c\rfloor} \sum_{i_{4}=1}^{\lfloor n d\rfloor}\left|E\left(\Phi\left(i_{1}, i_{2}, i_{3}, i_{4}\right) I_{3}\left(\delta_{i_{1}}^{\otimes 3}\right) I_{3}\left(\delta_{i_{2}}^{\otimes 3}\right) I_{6}\left(\delta_{i_{3}}^{\otimes 3} \otimes \delta_{i_{4}}^{\otimes 3}\right)\right)\right| \\

& \sum_{j=1}^{\left\lfloor n u_{p}\right\rfloor} E\left(\left\langle D\left\langle\lambda, \mathbb{V}_{n}\right\rangle, \delta_{j}\right\rangle_{\mathfrak{H}}^{2}\right) \\
& \leq C n^{-1 / 3} \sup _{k=1, \ldots, m} \sum_{i, \ell=1}^{\left\lfloor n u_{k}\right\rfloor}\left|E\left(g_{k}^{\prime}\left(B\left(t_{i-1}\right)\right) g_{\ell}^{\prime}\left(B\left(t_{\ell-1}\right)\right) I_{3}\left(\delta_{i}^{\otimes 3}\right) I_{3}\left(\delta_{l}^{\otimes 3}\right)\right)\right| \\
& \times \sup _{i=1, \ldots,\left\lfloor n u_{k}\right\rfloor} \sum_{j=1}^{\left\lfloor n u_{p}\right\rfloor}\left|\left\langle\varepsilon_{i-1}, \delta_{j}\right\rangle_{\mathfrak{H}}\right|+C n^{-1 / 3}\left(\sum_{r \in \mathbb{Z}}|\rho(r)|\right)^{2} \leq C n^{-1 / 3},
\end{aligned}
$$

which is (3.6). The proof of (3.7) follows the same lines, and is left to the reader.

### 3.2 Proof of Theorem 3.1

We are now in position to prove Theorem 3.1. For $g: \mathbb{R} \rightarrow \mathbb{R}$, let

Our main theorem which will lead us toward the proof of Theorem 3.1 is the following.
Theorem 3.7. If $g \in C^{\infty}(\mathbb{R})$ is bounded with bounded derivatives, then the sequence $\left(B, G_{n}^{-}(1, B), G_{n}^{-}(g, B)\right)$ converges to $\left(B, \llbracket B \rrbracket,-(1 / 8) \int g^{\prime \prime \prime}(B) d s+\int g(B) d \llbracket B \rrbracket\right)$ in the sense of finite-dimensional distributions on $[0, \infty)$.
Proof. We have to prove that, for any $\ell+m \geq 1$ and any $u_{1}, \ldots, u_{\ell+m} \geq 0$ :

& \xrightarrow[n \rightarrow \infty]{\text { Law }}\left(B, \llbracket B \rrbracket_{u_{1}}, \ldots, \llbracket B \rrbracket_{u_{\ell}},-\frac{1}{8} \int_{0}^{u_{\ell+1}} g^{\prime \prime \prime}(B(s)) d s+\int_{0}^{u_{\ell+1}} g(B(s)) d \llbracket B \rrbracket_{s}, \ldots,\right. \\
& \\
& \left.\quad-\frac{1}{8} \int_{0}^{u_{\ell+m}} g^{\prime \prime \prime}(B(s)) d s+\int_{0}^{u_{\ell+m}} g(B(s)) d \llbracket B \rrbracket_{s}\right) .
\end{aligned}
$$

Actually, we will prove the following slightly stronger convergence. For any $m \geq 1$, any $u_{1}, \ldots, u_{m} \geq 0$ and all bounded functions $g_{1}, \ldots, g_{m} \in C^{\infty}(\mathbb{R})$ with bounded derivatives, we have

&\left.-\frac{1}{8} \int_{0}^{u_{m}} g_{m}^{\prime \prime \prime \prime}(B(s)) d s+\int_{0}^{u_{m}} g_{m}(B(s)) d \llbracket B \rrbracket_{s}\right) . \tag{3.10}
\end{align*}
$$

Using (2.12), observe that

The proof of 3.10 is divided into several steps, and follows the methodology introduced in [7].

Step 1.- We first prove that:

& \lim _{n \rightarrow \infty} E\left(\left\|\left(G_{n}^{-}\left(g_{1}, B, u_{1}\right), \ldots, G_{n}^{-}\left(g_{m}, B, u_{m}\right)\right)\right\|_{\mathbb{R}^{m}}^{2}\right)  \tag{3.12}\\
& \quad=\sum_{i=1}^{m}\left(\kappa^{2} \int_{0}^{u_{i}} E\left(g_{i}^{2}(B(s))\right) d s+\frac{1}{64} E\left(\int_{0}^{u_{i}} g_{i}^{\prime \prime \prime}(B(s)) d s\right)^{2}\right) .
\end{align*}
$$

For $g$ as in the statement of the theorem, we can write, for any fixed $t \geq 0$ :

& =\sum_{j=1}^{\lfloor n t\rfloor} E\left(\left\langle D^{3} g\left(B\left(t_{j-1}\right)\right), \delta_{j}^{\otimes 3}\right\rangle_{\mathfrak{H}^{\otimes 3}}\right) \quad \text { by (2.13) } \\
& =\sum_{j=1}^{\lfloor n t\rfloor} E\left(g^{\prime \prime \prime}\left(B\left(t_{j-1}\right)\right)\right)\left\langle\varepsilon_{j-1}, \delta_{j}\right\rangle_{\mathfrak{H}}^{3} \quad \text { by (2.8) } \\
& =-\frac{1}{8 n} \sum_{j=1}^{\lfloor n t\rfloor} E\left(g^{\prime \prime \prime}\left(B\left(t_{j-1}\right)\right)\right)+\sum_{j=1}^{\lfloor n t\rfloor} E\left(g^{\prime \prime \prime}\left(B\left(t_{j-1}\right)\right)\right)\left(\left\langle\varepsilon_{j-1}, \delta_{j}\right\rangle_{\mathfrak{H}}^{3}+\frac{1}{8 n}\right) \\
& \xrightarrow[n \rightarrow \infty]{\longrightarrow}-\frac{1}{8} \int_{0}^{t} E\left(g^{\prime \prime \prime}(B(s))\right) d s \quad \text { by Lemma 3.2 }(i v) .
\end{aligned}

Now, let us turn to the second part of (3.12). We have

& +18 I_{2}\left(\delta_{j} \otimes \delta_{k}\right)\left\langle\delta_{j}, \delta_{k}\right\rangle_{\mathfrak{H}}^{2}+6\left\langle\delta_{j}, \delta_{k}\right\rangle_{\mathfrak{H}}^{3}
\end{aligned}
$$

Thus, for any fixed $t \geq 0$,

= & \sum_{j, k=1}^{\lfloor n t\rfloor} E\left(g\left(B\left(t_{j-1}\right)\right) g\left(B\left(t_{k-1}\right)\right) I_{6}\left(\delta_{j}^{\otimes 3} \otimes \delta_{k}^{\otimes 3}\right)\right) \\
& +9 \sum_{j, k=1}^{\lfloor n t\rfloor} E\left(g\left(B\left(t_{j-1}\right)\right) g\left(B\left(t_{k-1}\right)\right) I_{4}\left(\delta_{j}^{\otimes 2} \otimes \delta_{k}^{\otimes 2}\right)\right)\left\langle\delta_{j}, \delta_{k}\right\rangle_{\mathfrak{H}} \\
& +18 \sum_{j, k=1}^{\lfloor n t\rfloor} E\left(g\left(B\left(t_{j-1}\right)\right) g\left(B\left(t_{k-1}\right)\right) I_{2}\left(\delta_{j} \otimes \delta_{k}\right)\right)\left\langle\delta_{j}, \delta_{k}\right\rangle_{\mathfrak{H}}^{2} \\
& +6 \sum_{j, k=1}^{\lfloor n t\rfloor} E\left(g\left(B\left(t_{j-1}\right)\right) g\left(B\left(t_{k-1}\right)\right)\right)\left\langle\delta_{j}, \delta_{k}\right\rangle_{\mathfrak{H}}^{3} \\
= & A_{n}+B_{n}+C_{n}+D_{n} .
\end{aligned}
$$

We will estimate each of these four terms using the Malliavin integration by parts formula (2.13). For that purpose, we use Lemma 3.4 and the notation of Remark 2.5.

First, we have

& \stackrel{(3.2)}{=} \sum_{j, k=1}^{\lfloor n t\rfloor} \sum_{a=0}^{6}\binom{6}{a} E\left(g^{(a)}\left(B\left(t_{j-1}\right)\right) g^{(6-a)}\left(B\left(t_{k-1}\right)\right)\right)\left\langle\varepsilon_{j-1}^{\otimes a} \widetilde{\otimes} \varepsilon_{k-1}^{\otimes(6-a)}, \delta_{j}^{\otimes 3} \otimes \delta_{k}^{\otimes 3}\right\rangle_{\mathfrak{H}^{\otimes 6}} \\
& \stackrel{(3.1)}{=} \sum_{j, k=1}^{\lfloor n t\rfloor} \sum_{a=0}^{6} E\left(g^{(a)}\left(B\left(t_{j-1}\right)\right) g^{(6-a)}\left(B\left(t_{k-1}\right)\right)\right) \\
& \quad \times \sum_{\substack{i_{1}, \ldots, i_{6} \in\{j-1, k-1\} \\
\left|\left\{\ell: i_{\ell}=j-1\right\}\right|=a}}\left\langle\varepsilon_{i_{1}} \otimes \ldots \otimes \varepsilon_{i_{6}}, \delta_{j}^{\otimes 3} \otimes \delta_{k}^{\otimes 3}\right\rangle_{\mathfrak{H}^{\otimes 6}} .
\end{aligned}
$$

Actually, in the previous double sum with respect to $a$ and $i_{1}, \ldots, i_{6}$, only the following term
is non-negligible:

&=E\left(\sum_{j=1}^{\lfloor n t\rfloor} g^{\prime \prime \prime}\left(B\left(t_{j-1}\right)\right)\left\langle\varepsilon_{j-1}, \delta_{j}\right\rangle_{\mathfrak{H}}^{3}\right)^{2} \\
&=E\left(-\frac{1}{8 n} \sum_{j=1}^{\lfloor n t\rfloor} g^{\prime \prime \prime}\left(B\left(t_{j-1}\right)\right)+\sum_{j=1}^{\lfloor n t\rfloor} g^{\prime \prime \prime}\left(B\left(t_{j-1}\right)\right)\left(\left\langle\varepsilon_{j-1}, \delta_{j}\right\rangle_{\mathfrak{H}}^{3}+\frac{1}{8 n}\right)\right)^{2} \\
& \xrightarrow[n \rightarrow \infty]{ } \frac{1}{64} E\left(\int_{0}^{t} g^{\prime \prime \prime}(B(s)) d s\right)^{2} \text { by Lemma 3.2 }(i v) .
\end{aligned}
$$

Indeed, the other terms in $A_{n}$ are all of the form

\sum_{j, k=1}^{\lfloor n t\rfloor} E\left(g^{(a)}\left(B\left(t_{j-1}\right)\right) g^{(6-a)}\left(B\left(t_{k-1}\right)\right)\right)\left\langle\varepsilon_{j-1}, \delta_{k}\right\rangle_{\mathfrak{H}} \prod_{i=1}^{5}\left\langle\varepsilon_{x_{i}-1}, \delta_{y_{i}}\right\rangle_{\mathfrak{H}} \tag{3.13}
\end{equation*}

where $x_{i}$ and $y_{i}$ are for $j$ or $k$. By Lemma 3.2 (iii), we have $\sum_{j, k=1}^{\lfloor n t\rfloor}\left|\left\langle\varepsilon_{j-1}, \delta_{k}\right\rangle_{\mathfrak{H}}\right|=O(n)$ as $n \rightarrow \infty$. By Lemma 3.2 (i), $\sup _{j, k=1, \ldots,[n t]} \prod_{i=1}^{5}\left|\left\langle\varepsilon_{x_{i}-1}, \delta_{y_{i}}\right\rangle_{\mathfrak{H}}\right|=O\left(n^{-5 / 3}\right)$ as $n \rightarrow \infty$. Hence, the quantity in (3.13) tends to zero as $n \rightarrow \infty$. We have proved

& \leq C n^{-4 / 3} \sum_{j, k=1}^{\lfloor n t\rfloor}\left|\left\langle\delta_{j}, \delta_{k}\right\rangle_{\mathfrak{H}}\right| \quad \text { by Lemma } 3.2(i) \\
& =C n^{-5 / 3} \sum_{j, k=1}^{\lfloor n t\rfloor}|\rho(j-k)| \leq C n^{-2 / 3} \sum_{r \in \mathbb{Z}}|\rho(r)|=C n^{-2 / 3} \underset{n \rightarrow \infty}{\longrightarrow} 0,
\end{aligned}

with $\rho$ defined by (2.4).

& \xrightarrow[n \rightarrow \infty]{\longrightarrow} 6 \sum_{r \in \mathbb{Z}} \rho^{3}(r) \int_{0}^{t} E\left(g^{2}(B(s))\right) d s=\kappa^{2} \int_{0}^{t} E\left(g^{2}(B(s))\right) d s
\end{aligned}
$$

the previous convergence being obtained as in the proof of (3.27) below. Finally, we have obtained

Step 2.- By Step 1, the sequence $\left(B, G_{n}^{-}\left(g_{1}, B, u_{1}\right), \ldots, G_{n}^{-}\left(g_{m}, B, u_{m}\right)\right)$ is tight in $D_{\mathbb{R}}[0, \infty) \times \mathbb{R}^{m}$. Consider a subsequence converging in law to some limit denoted by

We have to show that, conditioned on $B$, the laws of $\mathbb{V}_{\infty}$ and $\mathbb{W}$ are the same.
Let $\lambda=\left(\lambda_{1}, \ldots, \lambda_{m}\right)$ denote a generic element of $\mathbb{R}^{m}$ and, for $\lambda, \mu \in \mathbb{R}^{m}$, write $\langle\lambda, \mu\rangle$ for $\sum_{i=1}^{m} \lambda_{i} \mu_{i}$. We consider the conditional characteristic function of $\mathbb{W}$ given $B$ :

Observe that $\Phi(\lambda)=e^{i\langle\lambda, \mu\rangle-\frac{1}{2}\langle\lambda, Q \lambda\rangle}$, where $\mu_{k}:=-(1 / 8) \int_{0}^{u_{k}} g_{k}^{\prime \prime \prime}(B(s)) d s$ for $k=1, \ldots, m$, and $Q=\left(q_{i j}\right)_{1 \leq i, j \leq m}$ is the symmetric matrix given by

The point is that $\Phi$ is the unique solution of the following system of PDEs (see [12]):

where the unknown function $\varphi: \mathbb{R}^{m} \rightarrow \mathbb{C}$ satisfies the initial condition $\varphi(0)=1$. Hence, we have to show that, for every random variable $\xi$ of the form $\psi\left(B\left(s_{1}\right), \ldots, B\left(s_{r}\right)\right)$, with $\psi: \mathbb{R}^{r} \rightarrow \mathbb{R}$ belonging to $C_{b}^{\infty}\left(\mathbb{R}^{r}\right)$ and $s_{1}, \ldots, s_{r} \geq 0$, we have

If $g \in C^{\infty}(\mathbb{R})$ is bounded with bounded derivatives, then the sequence $\left(B, G_{n}^{+}(1, B), G_{n}^{+}(g, B)\right)$ converges to $\left(B, \llbracket B \rrbracket,(1 / 8) \int g^{\prime \prime \prime}(B) d s+\int g(B) d \llbracket B \rrbracket\right)$ in the sense of finite-dimensional distributions on $[0, \infty)$, where

Proof. The proof is exactly the same as the proof of Theorem 3.7, except $\varepsilon_{j-1}$ must be everywhere replaced $\varepsilon_{j}$, and Lemma $3.2(v)$ must used instead of Lemma 3.2 (iv).

Proof of Theorem 3.1. We begin by observing the following general fact. Suppose $U$ and $V$ are càdlàg processes adapted to a filtration under which $V$ is a semimartingale. Similarly, suppose $U$ and $\widetilde{V}$ are càdlàg processes adapted to a filtration under which $\widetilde{V}$ is a semimartingale. If the processes $(U, V)$ and $(\widetilde{U}, \widetilde{V})$ have the same law, then $\int_{0} U(s-) d V(s)$ and $\int_{0} \widetilde{U}(s-) d \widetilde{V}(s)$ have the same law. This is easily seen by observing that these integrals are the limit in probability of left-endpoint Riemann sums.

Now, let $G_{n}^{-}$and $G_{n}^{+}$be as defined previously in this section. Define

Let $\mathbf{t}=\left(t_{1}, \ldots, t_{d}\right)$, where $0 \leq t_{1}<\cdots<t_{d}$. Let

and similarly for $G_{n}^{+}, G^{-}$, and $G^{+}$. By Theorems 2.11, 3.7, and 3.8 , the sequence

is relatively compact in $D_{\mathbb{R}^{2}}[0, \infty) \times \mathbb{R}^{d} \times \mathbb{R}^{d}$. By passing to a subsequence, we may assume it converges in law in $D_{\mathbb{R}^{2}}[0, \infty) \times \mathbb{R}^{d} \times \mathbb{R}^{d}$ to $(B, \llbracket B \rrbracket, X, Y)$, where $X, Y \in \mathbb{R}^{d}$.

By Theorems 2.11 and 3.7, $\left\{\left(B, V_{n}(B), G_{n}^{-}(g, B, \mathbf{t})\right)\right\}$ is relatively compact in $D_{\mathbb{R}^{2}}[0, \infty) \times$ $\mathbb{R}^{d}$, and converges in the sense of finite-dimensional distributions to $\left(B, \llbracket B \rrbracket, G^{-}(g, B, \mathbf{t})\right)$. It follows that $\left(B, V_{n}(B), G_{n}^{-}(g, B, \mathbf{t})\right) \rightarrow\left(B, \llbracket B \rrbracket, G^{-}(g, B, \mathbf{t})\right)$ in law in $D_{\mathbb{R}^{2}}[0, \infty) \times \mathbb{R}^{d}$. Hence, $(B, \llbracket B \rrbracket, X)$ and $\left(B, \llbracket B \rrbracket, G^{-}(g, B, \mathbf{t})\right)$ have the same law in $D_{\mathbb{R}^{2}}[0, \infty) \times \mathbb{R}^{d}$. By the general fact we observed at the beginning of the proof, $\left(G^{-}(g, B), X\right)$ and $\left(G^{-}(g, B), G^{-}(g, B, \mathbf{t})\right)$ have the same law. In particular, $\left(G^{-}(g, B, \mathbf{t}), X\right)$ and $\left(G^{-}(g, B, \mathbf{t}), G^{-}(g, B, \mathbf{t})\right)$ have the same law. But this implies $G^{-}(g, B, \mathbf{t})-X$ has the same law as the zero random variable, which gives $G^{-}(g, B, \mathbf{t})-X=0$ a.s.

We have thus shown that $X=G^{-}(g, B, \mathbf{t})$ a.s. Similarly, $Y=G^{+}(g, B, \mathbf{t})$ a.s. It follows that

and therefore

$$

in the sense of finite-dimensional distributions on $[0, \infty)$, which is what was to be proved.

## 4 Moment bounds

The following four moment bounds are central to our proof of relative compactness in Theorem 2.12.

Theorem 4.1. There exists a constant $C$ such that

E\left|V_{n}(B, t)-V_{n}(B, s)\right|^{4} \leq C\left(\frac{\lfloor n t\rfloor-\lfloor n s\rfloor}{n}\right)^{2}
$$

for all $n, s$, and $t$.

Proof. The calculations in the proof of Theorem 10 in [11] show that

for all $n, s$, and $t$.
Theorem 4.2. Let $g \in C^{1}(\mathbb{R})$ have compact support. Fix $T>0$ and let $c$ and $d$ be integers such that $0 \leq t_{c}<t_{d} \leq T$. Then

E\left|\sum_{j=c+1}^{d} g\left(\beta_{j}\right) \Delta B_{j}^{5}\right|^{2} \leq C\|g\|_{1, \infty}^{2} \Delta t^{1 / 3}\left|t_{d}-t_{c}\right|^{4 / 3}
$$

where $\|g\|_{1, \infty}=\|g\|_{\infty}+\left\|g^{\prime}\right\|_{\infty}$, and $C$ depends only on $T$.
Proof. Note that

E\left|\sum_{j=c+1}^{d} g\left(\beta_{j}\right) \Delta B_{j}^{5}\right|^{2}=\sum_{i=c+1}^{d} \sum_{j=c+1}^{d} E_{i j}, \tag{4.1}

where $E_{i j}=E\left[g\left(\beta_{i}\right) \Delta B_{i}^{5} g\left(\beta_{j}\right) \Delta B_{j}^{5}\right]$. Let $K=\|g\|_{1, \infty}$, and define $f: \mathbb{R}^{3} \rightarrow \mathbb{R}$ by $f(x)=K^{-2} g\left(x_{1}\right) g\left(x_{2}\right) x_{3}^{5}$. Note that $f$ has polynomial growth of order 1 with constants $K=1$ and $r=5$.

Let $\xi_{1}=\beta_{i}, \xi_{2}=\beta_{j}, \xi_{3}=\Delta t^{-1 / 6} \Delta B_{i}, Y=\Delta t^{-1 / 6} \Delta B_{j}$, and $\varphi(y)=y^{5}$. Then $E_{i j}=K^{2} \Delta t^{5 / 3} E[f(\xi) \varphi(Y)]$. By Theorem 2.7 with $k=0,|E[f(\xi) \varphi(Y)]| \leq C|\eta|$, where $\eta_{j}=E\left[\xi_{j} Y\right]$. Using Lemma 2.9, we have

Theorem 4.3. Let $g \in C^{2}(\mathbb{R})$ have compact support. Fix $T>0$ and let $c$ and $d$ be integers such that $0 \leq t_{c}<t_{d} \leq T$. Then

E\left|\sum_{j=c+1}^{d} g\left(\beta_{j}\right) \Delta B_{j}^{3}\right|^{2} \leq\|g\|_{2, \infty}^{2}\left|t_{d}-t_{c}\right|
$$

where $\|g\|_{2, \infty}=\|g\|_{\infty}+\left\|g^{\prime}\right\|_{\infty}+\left\|g^{\prime \prime}\right\|_{\infty}$, and $C$ depends only on $T$.

Proof. Note that

E\left|\sum_{j=c+1}^{d} g\left(\beta_{j}\right) \Delta B_{j}^{3}\right|^{2}=\sum_{i=c+1}^{d} \sum_{j=c+1}^{d} E_{i j} \tag{4.2}

where $E_{i j}=E\left[g\left(\beta_{i}\right) \Delta B_{i}^{3} g\left(\beta_{j}\right) \Delta B_{j}^{3}\right]$. Let $K=\|g\|_{2, \infty}$, and define $f: \mathbb{R}^{3} \rightarrow \mathbb{R}$ by $f(x)=K^{-2} g\left(x_{1}\right) g\left(x_{2}\right) x_{3}^{3}$. Note that $f$ has polynomial growth of order 2 with constants $K=1$ and $r=3$.

Let $\xi_{1}=\beta_{i}, \xi_{2}=\beta_{j}, \xi_{3}=\Delta t^{-1 / 6} \Delta B_{i}, Y=\Delta t^{-1 / 6} \Delta B_{j}$, and $\varphi(y)=y^{3}$. Then $E_{i j}=K^{2} \Delta t E[f(\xi) \varphi(Y)]$. By Theorem 2.7 with $k=1, E[f(\xi) \varphi(Y)] \mid=\eta_{1} E\left[\partial_{1} f(\xi)\right]+$ $\eta_{2} E\left[\partial_{2} f(\xi)\right]+R$, where $|R| \leq C\left(\left|\eta_{3}\right|+|\eta|^{2}\right)$. By 2.17), if $j=1$ or $j=2,\left|E\left[\partial_{j} f(\xi)\right]\right| \leq$ $C\left(\left|E\left[\xi_{1} \xi_{3}\right]\right|+\left|E\left[\xi_{2} \xi_{3}\right]\right|\right)$. Therefore, using $\left|\eta_{3}\right|^{2} \leq\left|\eta_{3}\right|$ and $|a b| \leq|a|^{2}+|b|^{2}$,

$$
\left|E_{i j}\right| \leq C K^{2} \Delta t\left(\left|\eta_{3}\right|+\left|\eta_{1}\right|^{2}+\left|\eta_{2}\right|^{2}+\left|E\left[\xi_{1} \xi_{3}\right]\right|^{2}+\left|E\left[\xi_{2} \xi_{3}\right]\right|^{2}\right)
$$

Using Lemma 2.9, we have

$$
\begin{aligned}
& \left|E\left[\xi_{2} \xi_{3}\right]\right| \leq C \Delta t^{1 / 6}\left(i^{-2 / 3}+|j-i|_{+}^{-2 / 3}\right) \\
& \left|E\left[\xi_{1} \xi_{3}\right]\right| \leq C \Delta t^{1 / 6} i^{-2 / 3}
\end{aligned}
$$

Together with the estimates from the proof of Theorem 4.2, this gives

$$
\left|E_{i j}\right| \leq C K^{2}\left(\Delta t^{4 / 3}\left(i^{-4 / 3}+j^{-4 / 3}+|j-i|_{+}^{-4 / 3}\right)+\Delta t|j-i|_{+}^{-5 / 3}\right)
$$

Substituting this into (4.2) gives

$$
E\left|\sum_{j=c+1}^{d} g\left(B\left(t_{j}\right)\right) \Delta B_{j}^{3}\right|^{2} \leq C K^{2} \Delta t(d-c)=C K^{2}\left|t_{d}-t_{c}\right|
$$

which completes the proof.
Theorem 4.4. Suppose $g \in C^{3}(\mathbb{R})$ has compact support. Fix $T>0$ and let $c$ and $d$ be integers such that $0 \leq t_{c}<t_{d} \leq T$. Then

$$
E\left|\sum_{j=c+1}^{d}\left(g\left(\beta_{j}\right)-g\left(\beta_{c}\right)\right) \Delta B_{j}^{3}\right|^{2} \leq C\left|t_{d}-t_{c}\right|^{4 / 3}
$$

where $C$ depends only on $g$ and $T$.
Proof. Let $Y_{j}=g\left(\beta_{j}\right)-g\left(\beta_{c}\right)$, and note that

$$
\begin{equation*}
E\left|\sum_{j=c+1}^{d} Y_{j} \Delta B_{j}^{3}\right|^{2}=\sum_{i=c+1}^{d} \sum_{j=c+1}^{d} E_{i j} \tag{4.3}
\end{equation*}
$$

where $E_{i j}=E\left[Y_{i} \Delta B_{i}^{3} Y_{j} \Delta B_{j}^{3}\right]$. For fixed $i, j$, define $f: \mathbb{R}^{4} \rightarrow \mathbb{R}$ by

$$
f(x)=\left(\frac{g\left(x_{1}+\sigma_{i} x_{2}\right)-g\left(x_{1}\right)}{\sigma_{i}}\right)\left(\frac{g\left(x_{1}+\sigma_{j} x_{3}\right)-g\left(x_{1}\right)}{\sigma_{j}}\right) x_{4}^{3},
$$

where $\sigma_{j}^{2}=E\left|\beta_{j}-\beta_{c}\right|^{2}$. Note that $f$ has polynomial growth of order 2 with constants $K$ and $r$ that do not depend on $i$ or $j$.

Let $\xi_{1}=\beta_{c}, \xi_{2}=\sigma_{i}^{-1}\left(\beta_{i}-\beta_{c}\right), \xi_{3}=\sigma_{j}^{-1}\left(\beta_{j}-\beta_{c}\right), \xi_{4}=\Delta t^{-1 / 6} \Delta B_{i}, Y=\Delta t^{-1 / 6} \Delta B_{j}$, and $\varphi(y)=y^{3}$. Note that $E_{i j}=\sigma_{i} \sigma_{j} \Delta t E[f(\xi) \varphi(Y)]$, so that by Lemma 2.9.(v),

$$
\begin{equation*}
\left|E_{i j}\right| \leq C \Delta t^{4 / 3}|i-c|^{1 / 6}|j-c|^{1 / 6}|E[f(\xi) \varphi(Y)]| . \tag{4.4}
\end{equation*}
$$

By Theorem 2.7 with $k=1, E[f(\xi) \varphi(Y)]=3 \sum_{k=1}^{3} \eta_{k} E\left[\partial_{k} f(\xi)\right]+R$, where $|R| \leq$ $C\left(\left|\eta_{4}\right|+|\eta|^{2}\right)$. Using $|a b| \leq|a|^{2}+|b|^{2}$ and the fact that $\left|\eta_{j}\right|^{2} \leq|\eta|^{2}$, this gives

$$
|E[f(\xi) \varphi(Y)]| \leq C\left(\sum_{k=1}^{3}\left|E\left[\partial_{k} f(\xi)\right]\right|^{2}+\left|\eta_{4}\right|+|\eta|^{2}\right)
$$

By (2.17), for each $k \leq 3,\left|E\left[\partial_{k} f(\xi)\right]\right| \leq C \sum_{\ell=1}^{3}\left|E\left[\xi_{\ell} \xi_{4}\right]\right|$. Therefore, since $\eta_{j}=E\left[\xi_{j} Y\right]$, we have

$$
\begin{equation*}
|E[f(\xi) \varphi(Y)]| \leq C\left(E\left[\xi_{4} Y\right]+\sum_{k=1}^{3}\left(\left|E\left[\xi_{k} Y\right]\right|^{2}+\left|E\left[\xi_{k} \xi_{4}\right]\right|^{2}\right)\right) \tag{4.5}
\end{equation*}
$$

To estimate these covariances, first note that $d-c=n\left(t_{d}-t_{c}\right) \leq n T$. Hence, $\Delta t=n^{-1} \leq$ $C(d-c)^{-1}$. Now, using Lemma 2.9 ,

$$
\begin{aligned}
& \left|E\left[\xi_{1} Y\right]\right| \leq C \Delta t^{1 / 6}|j-c|^{-2 / 3} \leq C|d-c|^{-1 / 6}|j-c|^{-2 / 3} \leq C|j-c|^{-5 / 6}, \\
& \left|E\left[\xi_{2} Y\right]\right| \leq C|i-c|^{-1 / 6}\left(|j-c|^{-2 / 3}+|j-i|_{+}^{-2 / 3}\right) \\
& \left|E\left[\xi_{3} Y\right]\right| \leq C|j-c|^{-1 / 6}|j-c|^{-2 / 3}=C|j-c|^{-5 / 6} \\
& \left|E\left[\xi_{4} Y\right]\right| \leq C|j-i|_{+}^{-5 / 3}
\end{aligned}
$$

Similarly,

$$
\begin{aligned}
& \left|E\left[\xi_{1} \xi_{4}\right]\right| \leq C \Delta t^{1 / 6}|i-c|^{-2 / 3} \leq C|d-c|^{-1 / 6}|i-c|^{-2 / 3} \leq C|i-c|^{-5 / 6}, \\
& \left|E\left[\xi_{2} \xi_{4}\right]\right| \leq C|i-c|^{-1 / 6}|i-c|^{-2 / 3}=C|i-c|^{-5 / 6} \\
& \left|E\left[\xi_{3} \xi_{4}\right]\right| \leq C|j-c|^{-1 / 6}\left(|i-c|^{-2 / 3}+|j-i|_{+}^{-2 / 3}\right) .
\end{aligned}
$$

Substituting these estimates into (4.5) and using (4.4) gives

$$
\begin{aligned}
\left|E_{i j}\right| \leq & C \Delta t^{4 / 3}\left(|i-c|^{1 / 6}|j-c|^{1 / 6}|j-i|_{+}^{-5 / 3}\right. \\
& +|i-c|^{1 / 6}|j-c|^{-3 / 2}+|i-c|^{-1 / 6}|j-c|^{-7 / 6}+|i-c|^{-1 / 6}|j-c|^{1 / 6}|j-i|_{+}^{-4 / 3} \\
& \left.\quad+|i-c|^{-3 / 2}|j-c|^{1 / 6}+|i-c|^{-7 / 6}|j-c|^{-1 / 6}+|i-c|^{1 / 6}|j-c|^{-1 / 6}|j-i|_{+}^{-4 / 3}\right) .
\end{aligned}
$$

We can simplify this to

$$
\begin{aligned}
&\left|E_{i j}\right| \leq C \Delta t^{4 / 3}\left(|i-c|^{1 / 6}|j-c|^{1 / 6}|j-i|_{+}^{-4 / 3}\right. \\
&+|i-c|^{1 / 6}|j-c|^{-7 / 6} \\
&+|j-c|^{1 / 6}|j-i|_{+}^{-4 / 3} \\
&\left.+|i-c|^{-7 / 6}|j-c|^{1 / 6}+|i-c|^{1 / 6}|j-i|_{+}^{-4 / 3}\right)
\end{aligned}
$$

Using $|a b| \leq|a|^{2}+|b|^{2}$, this further simplifies to

$$
\begin{aligned}
&\left|E_{i j}\right| \leq C \Delta t^{4 / 3}\left(|i-c|^{1 / 3}|j-i|_{+}^{-4 / 3}+|j-c|^{1 / 3}|j-i|_{+}^{-4 / 3}\right. \\
&\left.+|i-c|^{1 / 6}|j-c|^{-7 / 6}+|i-c|^{-7 / 6}|j-c|^{1 / 6}\right)
\end{aligned}
$$

We must now make use of (4.3). Note that

$$
\begin{aligned}
\Delta t^{4 / 3} \sum_{i=c+1}^{d} \sum_{j=c+1}^{d}|i-c|^{1 / 3}|j-i|_{+}^{-4 / 3} \leq C \Delta t^{4 / 3} \sum_{i=c+1}^{d} \mid & |i-c|^{1 / 3} \\
& \leq C \Delta t^{4 / 3}(d-c)^{4 / 3}=C\left|t_{d}-t_{c}\right|^{4 / 3}
\end{aligned}
$$

Similarly,

$$
\Delta t^{4 / 3} \sum_{j=c+1}^{d} \sum_{i=c+1}^{d}|j-c|^{1 / 3}|j-i|_{+}^{-4 / 3} \leq C\left|t_{d}-t_{c}\right|^{4 / 3}
$$

Also,

$$
\begin{array}{r}
\Delta t^{4 / 3} \sum_{i=c+1}^{d} \sum_{j=c+1}^{d}|i-c|^{1 / 6}|j-c|^{-7 / 6} \leq C \Delta t^{4 / 3} \sum_{i=c+1}^{d}|i-c|^{1 / 6} \leq C \Delta t^{4 / 3}(d-c)^{7 / 6} \\
\leq C \Delta t^{4 / 3}(d-c)^{4 / 3}=C\left|t_{d}-t_{c}\right|^{4 / 3}
\end{array}
$$

and similarly,

$$
\Delta t^{4 / 3} \sum_{j=c+1}^{d} \sum_{i=c+1}^{d}|i-c|^{-7 / 6}|j-c|^{1 / 6} \leq C\left|t_{d}-t_{c}\right|^{4 / 3}
$$

It follows, therefore, that $\sum_{i=c+1}^{d} \sum_{j=c+1}^{d}\left|E_{i j}\right| \leq C\left|t_{d}-t_{c}\right|^{4 / 3}$. By (4.3), this completes the proof.

## 5 Proof of main result

Lemma 5.1. If $g \in C^{1}(\mathbb{R})$ has compact support, then $\sum_{j=1}^{\lfloor n t\rfloor} g\left(\beta_{j}\right) \Delta B_{j}^{5} \rightarrow 0 u c p$.
Proof. Let $X_{n}(g, t)=\sum_{j=1}^{\lfloor n t\rfloor} g\left(\beta_{j}\right) \Delta B_{j}^{5}$. Fix $T>0$ and let $0 \leq s<t \leq T$ be arbitrary. Then

$$
X_{n}(g, t)-X_{n}(g, s)=\sum_{j=c+1}^{d} g\left(\beta_{j}\right) \Delta B_{j}^{5}
$$

where $c=\lfloor n s\rfloor$ and $d=\lfloor n t\rfloor$. By Theorem 4.2.,

$$
E\left|X_{n}(g, t)-X_{n}(g, s)\right|^{2} \leq C \Delta t^{1 / 3}\left|t_{d}-t_{c}\right|^{4 / 3} \leq C\left|t_{d}-t_{c}\right|^{5 / 3}=C\left(\frac{\lfloor n t\rfloor-\lfloor n s\rfloor}{n}\right)^{5 / 3}
$$

where $C$ depends only on $g$ and $T$. This verifies condition (2.6) of Theorem 2.2. By Theorem 4.2, $\sup _{n} E\left|X_{n}(g, T)\right|^{2} \leq C T^{4 / 3}<\infty$. Hence, by Theorem $2.2,\left\{X_{n}(g)\right\}$ is relatively
compact in $D_{\mathbb{R}}[0, \infty)$. By Lemma 2.3 , it will therefore suffice to show that $X_{n}(g, t) \rightarrow 0$ in probability for each fixed $t$. But this follows easily by taking $s=0$ above, which gives $E\left|X_{n}(g, t)\right|^{2} \leq C \Delta t^{1 / 3}$ and completes the proof.

Lemma 5.2. If $g \in C^{6}(\mathbb{R})$ has compact support, then

$$
I_{n}\left(g^{\prime}, B, t\right) \approx g(B(t))-g(B(0))+\frac{1}{12} \sum_{j=1}^{\lfloor n t\rfloor} g^{\prime \prime \prime}\left(\beta_{j}\right) \Delta B_{j}^{3}
$$

Proof. Fix $a, b \in \mathbb{R}$. Let $x=(a+b) / 2$ and $h=(b-a) / 2$. By Theorem 2.6,

$$
\begin{aligned}
g(b)-g(a) & =(g(x+h)-g(x))-(g(x-h)-g(x)) \\
& =\sum_{j=1}^{6} g^{(j)}(x) \frac{h^{j}}{j!}-\sum_{j=1}^{6} g^{(j)}(x) \frac{(-h)^{j}}{j!}+R_{1}(x, h)-R_{1}(x,-h) \\
& =\sum_{\substack{j=1 \\
j \text { odd }}}^{6} \frac{1}{j!2^{j-1}} g^{(j)}(x)(b-a)^{j}+R_{1}(x, h)-R_{1}(x,-h) \\
& =g^{\prime}(x)(b-a)+\frac{1}{24} g^{\prime \prime \prime}(x)(b-a)^{3}+\frac{1}{5!2^{4}} g^{(5)}(x)(b-a)^{5}+R_{2}(a, b),
\end{aligned}
$$

where $R_{2}(a, b)=R_{1}(x, h)-R_{1}(x,-h)$ and

$$
R_{1}(x, h)=\frac{h^{6}}{5!} \int_{0}^{1}(1-u)^{6}\left[g^{(6)}(x+u h)-g^{(6)}(x)\right] d u .
$$

Similarly,

$$
\begin{aligned}
\frac{g^{\prime}(a)+g^{\prime}(b)}{2}-g^{\prime}(x) & =\frac{1}{2}\left(g^{\prime}(x+h)-g^{\prime}(x)\right)+\frac{1}{2}\left(g^{\prime}(x-h)-g^{\prime}(x)\right) \\
& =\frac{1}{2} \sum_{j=1}^{5} g^{(j+1)}(x) \frac{h^{j}}{j!}+\frac{1}{2} \sum_{j=1}^{5} g^{(j+1)}(x) \frac{(-h)^{j}}{j!}+R_{4}(a, b) \\
& =\frac{1}{8} g^{\prime \prime \prime}(x)(b-a)^{2}+\frac{1}{4!2^{4}} g^{(5)}(x)(b-a)^{4}+R_{4}(a, b)
\end{aligned}
$$

where $R_{4}(a, b)=R_{3}(x, h)+R_{3}(x,-h)$ and

$$
R_{3}(x, h)=\frac{h^{5}}{4!} \int_{0}^{1}(1-u)^{5}\left[g^{(6)}(x+u h)-g^{(6)}(x)\right] d u
$$

Combining these two expansions gives

$$
g(b)-g(a)=\frac{g^{\prime}(a)+g^{\prime}(b)}{2}(b-a)-\frac{1}{12} g^{\prime \prime \prime}(x)(b-a)^{3}+\gamma g^{(5)}(x)(b-a)^{5}+R_{6}(a, b),
$$

where $\gamma=\left(5!2^{4}\right)^{-1}-\left(4!2^{4}\right)^{-1}$ and

$$
R_{6}(a, b)=R_{2}(a, b)-R_{4}(a, b)(b-a) .
$$

Note that $R_{6}(a, b)=h(a, b)(b-a)^{6}$, where

$$
|h(a, b)| \leq C \sup _{0 \leq u \leq 1}\left|g^{(6)}(x+u h)-g^{(6)}(x)\right| .
$$

Taking $a=B\left(t_{j-1}\right)$ and $b=B\left(t_{j}\right)$ gives

$$
\begin{aligned}
& g\left(B\left(t_{j}\right)\right)-g\left(B\left(t_{j-1}\right)\right)=\frac{g^{\prime}\left(B\left(t_{j-1}\right)\right)+g^{\prime}\left(B\left(t_{j}\right)\right)}{2} \Delta B_{j}-\frac{1}{12} g^{\prime \prime \prime}\left(\beta_{j}\right) \Delta B_{j}^{3}+\gamma g^{(5)}\left(\beta_{j}\right) \Delta B_{j}^{5} \\
&+ h\left(B\left(t_{j-1}\right), B\left(t_{j}\right)\right) \Delta B_{j}^{6}
\end{aligned}
$$

Recall that $B_{n}(t)=B(\lfloor n t\rfloor / n)$, so that

$$
g(B(t))-g(B(0))=I_{n}\left(g^{\prime}, B, t\right)-\frac{1}{12} \sum_{j=1}^{\lfloor n t\rfloor} g^{\prime \prime \prime}\left(\beta_{j}\right) \Delta B_{j}^{3}+\varepsilon_{n}(g, t),
$$

where

$$
\varepsilon_{n}(g, t)=\gamma \sum_{j=1}^{\lfloor n t\rfloor} g^{(5)}\left(\beta_{j}\right) \Delta B_{j}^{5}+\sum_{j=1}^{\lfloor n t\rfloor} h\left(B\left(t_{j-1}\right), B\left(t_{j}\right)\right) \Delta B_{j}^{6}+g(B(t))-g\left(B_{n}(t)\right)
$$

It will therefore suffice to show that $\varepsilon_{n}(g, t) \rightarrow 0$ ucp.
By the continuity of $g$ and $B, g(B(t), t)-g\left(B_{n}(t),\lfloor n t\rfloor / n\right) \rightarrow 0$ uniformly on compacts, with probability one. By Lemma 5.1, since $g^{(5)} \in C^{1}(\mathbb{R}), \gamma \sum_{j=1}^{\lfloor n t\rfloor} g^{(5)}\left(\beta_{j}\right) \Delta B_{j}^{5} \rightarrow 0$ ucp. It remains only to show that

$$
\begin{equation*}
\sum_{j=1}^{\lfloor n t\rfloor} h\left(B\left(t_{j-1}\right), B\left(t_{j}\right)\right) \Delta B_{j}^{6} \rightarrow 0 \quad \text { ucp. } \tag{5.1}
\end{equation*}
$$

Fix $T>0$. Let $\{n(k)\}_{k=1}^{\infty}$ be an arbitrary sequence of positive integers. By Theorem 2.10 , we may find a subsequence $\{m(k)\}_{k=1}^{\infty}$ and a measurable subset $\Omega^{*} \subset \Omega$ such that $P\left(\Omega^{*}\right)=1$, $t \mapsto B(t, \omega)$ is continuous for all $\omega \in \Omega^{*}$, and

$$
\begin{equation*}
\sum_{j=1}^{\lfloor m(k) t\rfloor} \Delta B_{j, m(k)}(\omega)^{6} \rightarrow 15 t \tag{5.2}
\end{equation*}
$$

as $k \rightarrow \infty$ uniformly on $[0, T]$ for all $\omega \in \Omega^{*}$. Fix $\omega \in \Omega^{*}$. We will show that

$$
\sum_{j=1}^{\lfloor m(k) t\rfloor} h\left(B\left(t_{j-1}^{m(k)}, \omega\right), B\left(t_{j}^{m(k)}, \omega\right)\right) \Delta B_{j, m(k)}(\omega)^{6} \rightarrow 0
$$

as $k \rightarrow \infty$ uniformly on $[0, T]$, which will complete the proof.
For this, it will suffice to show that

$$
\sum_{j=1}^{\lfloor m(k) T\rfloor}\left|h\left(B\left(t_{j-1}^{m(k)}, \omega\right), B\left(t_{j}^{m(k)}, \omega\right)\right)\right| \Delta B_{j, m(k)}(\omega)^{6} \rightarrow 0
$$

as $k \rightarrow \infty$. We begin by observing that, by (5.2), there exists a constant $L$ such that $\sum_{j=1}^{\lfloor m(k) T\rfloor} \Delta B_{j, m(k)}(\omega)^{6}<L$ for all $k$. Now let $\varepsilon>0$. Since $g$ has compact support, $g$ is uniformly continuous. Hence, there exists $\delta>0$ such that $|b-a|<\delta$ implies $|h(a, b)|<\varepsilon / L$ for all $t$. Moreover, there exists $k_{0}$ such that $k \geq k_{0}$ implies $\left|\Delta B_{j, m(k)}(\omega)\right|<\delta$ for all $1 \leq j \leq\lfloor m(k) T\rfloor$. Hence, if $k \geq k_{0}$, then

$$
\sum_{j=1}^{\lfloor m(k) T\rfloor}\left|h\left(B\left(t_{j-1}^{m(k)}, \omega\right), B\left(t_{j}^{m(k)}, \omega\right)\right)\right| \Delta B_{j, m(k)}(\omega)^{6}<\frac{\varepsilon}{L} \sum_{j=1}^{\lfloor m(k) T\rfloor} \Delta B_{j, m(k)}(\omega)^{6}<\varepsilon
$$

which completes the proof.
Corollary 5.3. If $g \in C^{6}(\mathbb{R})$ has compact support, then $I_{n}\left(g^{\prime}, B, t\right) \approx X_{n}(t)$, where for any $T>0$,

$$
\sup _{n} \sup _{t \in[0, T]} E\left|X_{n}(t)\right|^{2}<\infty
$$

Proof. This follows immediately from Lemma 5.2 and Theorem 4.3 .
Lemma 5.4. If $g \in C^{6}(\mathbb{R})$ has compact support, then $\left\{I_{n}\left(g^{\prime}, B\right)\right\}$ is relatively compact in $D_{\mathbb{R}}[0, \infty)$.

Proof. Define

$$
\begin{aligned}
X_{n}(t) & :=\frac{1}{12} \sum_{j=1}^{\lfloor n t\rfloor} g^{\prime \prime \prime}\left(\beta_{j}\right) \Delta B_{j}^{3}, \\
Y(t) & :=g(B(t))-g(B(0)) \\
\varepsilon_{n}(t) & :=I_{n}\left(g^{\prime}, B, t\right)-Y(t)-X_{n}(t) .
\end{aligned}
$$

Since $(x, y, z) \mapsto x+y+z$ is a continuous function from $D_{\mathbb{R}^{3}}[0, \infty)$ to $D_{\mathbb{R}}[0, \infty)$, it will suffice to show that $\left\{\left(X_{n}, Y, \varepsilon_{n}\right)\right\}$ is relatively compact in $D_{\mathbb{R}^{3}}[0, \infty)$. By Lemma $5.2, \varepsilon_{n} \rightarrow 0$ ucp, and therefore in $D_{\mathbb{R}}[0, \infty)$. Hence, by Lemma 2.1, it will suffice to show that $\left\{X_{n}\right\}$ is relatively compact in $D_{\mathbb{R}}[0, \infty)$.

For this, we apply Theorem 2.2 with $\beta=4$. Fix $T>0$ and let $0 \leq s<t \leq T$. Let $c=\lfloor n s\rfloor$ and $d=\lfloor n t\rfloor$. Note that $q(a+b)^{4} \leq C\left(|a|^{2}+|b|^{4}\right)$. Hence, since $g$ has compact support and, therefore, $g^{\prime \prime \prime}$ is bounded,

$$
\begin{aligned}
E\left[q\left(X_{n}(t)-X_{n}(s)\right)^{4}\right] & =E\left[q\left(\frac{1}{12} \sum_{j=c+1}^{d} g^{\prime \prime \prime}\left(\beta_{j}\right) \Delta B_{j}^{3}\right)^{4}\right] \\
& \leq C E\left|\sum_{j=c+1}^{d}\left(g^{\prime \prime \prime}\left(\beta_{j}\right)-g^{\prime \prime \prime}\left(\beta_{c}\right)\right) \Delta B_{j}^{3}\right|^{2}+C E\left|\sum_{j=c+1}^{d} g^{\prime \prime \prime}\left(\beta_{c}\right) \Delta B_{j}^{3}\right|^{4} \\
& \leq C E\left|\sum_{j=c+1}^{d}\left(g^{\prime \prime \prime}\left(\beta_{j}\right)-g^{\prime \prime \prime}\left(\beta_{c}\right)\right) \Delta B_{j}^{3}\right|^{2}+C E\left|\sum_{j=c+1}^{d} \Delta B_{j}^{3}\right|^{4}
\end{aligned}
$$

Since $g^{\prime \prime \prime} \in C^{3}(\mathbb{R})$, we may apply Theorems 4.4 and 4.1, which give

$$
E\left[q\left(X_{n}(t)-X_{n}(s)\right)^{4}\right] \leq C\left|t_{d}-t_{c}\right|^{4 / 3}+C\left|t_{d}-t_{c}\right|^{2} \leq C\left(\frac{\lfloor n t\rfloor-\lfloor n s\rfloor}{n}\right)^{4 / 3}
$$

which verifies condition (2.6) of Theorem 2.2. As above,

$$
\begin{aligned}
E\left|X_{n}(T)\right|^{2} & \leq C E\left|\sum_{j=1}^{\lfloor n T\rfloor}\left(g^{\prime \prime \prime}\left(\beta_{j}\right)-g^{\prime \prime \prime}\left(\beta_{c}\right)\right) \Delta B_{j}^{3}\right|^{2}+C E\left|\sum_{j=1}^{\lfloor n T\rfloor} \Delta B_{j}^{3}\right|^{2} \\
& \leq C E\left|\sum_{j=1}^{\lfloor n T\rfloor}\left(g^{\prime \prime \prime}\left(\beta_{j}\right)-g^{\prime \prime \prime}\left(\beta_{c}\right)\right) \Delta B_{j}^{3}\right|^{2}+C\left(E\left|\sum_{j=1}^{\lfloor n T\rfloor} \Delta B_{j}^{3}\right|^{4}\right)^{1 / 2} \\
& \leq C T^{4 / 3}+C T .
\end{aligned}
$$

Hence, $\sup _{n} E\left|X_{n}(T)\right|^{2}<\infty$. By Theorem 2.2, $\left\{X_{n}\right\}$ is relatively compact, completing the proof.

Lemma 5.5. If $g \in C^{9}(\mathbb{R})$ has compact support, then

$$
I_{n}\left(g^{\prime}, B, t\right) \approx g(B(t))-g(B(0))+\frac{1}{12 \sqrt{n}} \sum_{j=1}^{\lfloor n t\rfloor} \frac{g^{\prime \prime \prime}\left(B\left(t_{j-1}\right)\right)+g^{\prime \prime \prime}\left(B\left(t_{j}\right)\right)}{2} h_{3}\left(n^{1 / 6} \Delta B_{j}\right)
$$

Proof. Using the Taylor expansions in the proof of Lemma 5.2, together with Lemma 5.1, we have

$$
\sum_{j=1}^{\lfloor n t\rfloor} g^{\prime \prime \prime}\left(\beta_{j}\right) \Delta B_{j}^{3} \approx \sum_{j=1}^{\lfloor n t\rfloor} \frac{g^{\prime \prime \prime}\left(B\left(t_{j-1}\right)\right)+g^{\prime \prime \prime}\left(B\left(t_{j}\right)\right)}{2} \Delta B_{j}^{3}
$$

By Lemma 5.2, since $h_{3}(x)=x^{3}-3 x$, it therefore suffices to show that

$$
n^{-1 / 3} \sum_{j=1}^{\lfloor n t\rfloor} \frac{g^{\prime \prime \prime}\left(B\left(t_{j-1}\right)\right)+g^{\prime \prime \prime}\left(B\left(t_{j}\right)\right)}{2} \Delta B_{j}=n^{-1 / 3} I_{n}\left(g^{\prime \prime \prime}, B, t\right) \approx 0
$$

Since $g^{\prime \prime \prime} \in C^{6}(\mathbb{R})$, this follows from Lemma 5.4, Corollary 5.3, and Lemma 2.3.
Proof of Theorem $\mathbf{2 . 1 2}$. We first assume that $g$ (and also $G$ ) has compact support. By Lemma 5.5 and Theorem 3.1, we need only show that $\left\{\left(B, V_{n}(B), I_{n}(g, B)\right)\right\}$ is relatively compact in $D_{\mathbb{R}^{3}}[0, \infty)$. By Lemma 2.1, it will suffice to show that $\left\{I_{n}(g, B)\right\}$ is relatively compact in $D_{\mathbb{R}}[0, \infty)$. But this follows from Lemma 5.4, completing the proof when $g$ has compact support.

Now consider general $g$. Let

$$
\Xi_{n}=\left(B, V_{n}(B), I_{n}(g, B)\right) \quad \text { and } \quad \Xi=\left(B, \llbracket B \rrbracket, \int g(B) d B\right)
$$

For $T>0$, define $\Xi_{n}^{T}(t)=\Xi_{n}(t) 1_{\{t<T\}}$ and $\Xi^{T}(t)=\Xi(t) 1_{\{t<T\}}$. By (3.5.2) in [4], if two càdlàg functions $x$ and $y$ agree on the interval $[0, T)$, then $r(x, y) \leq e^{-T}$, where $r$ is the metric on
$D_{\mathbb{R}^{d}}[0, \infty)$. Hence, by Lemma 2.4 , it will suffice to show that $\Xi_{n}^{T} \rightarrow \Xi^{T}$ in law, where $T>0$ is fixed.

Let $H: D_{\mathbb{R}^{3}}[0, \infty) \rightarrow \mathbb{R}$ be continuous and bounded, with $M=\sup |H(x)|$. Define $X_{n}=H\left(\Xi_{n}^{T}\right)$ and $X=H\left(\Xi^{T}\right)$, so that it will suffice to show that $X_{n} \rightarrow X$ in law. For each $k>0$, choose $G_{k} \in C^{6}(\mathbb{R})$ with compact support such that $G_{k}=G$ on $[-k, k]$. Let $g_{k}=G_{k}^{\prime}$,

$$
\widetilde{\Xi}_{n, k}=\left(B, V_{n}(B), I_{n}\left(g_{k}, B\right)\right), \quad \widetilde{\Xi}_{k}=\left(B, \llbracket B \rrbracket, \int g_{k}(B) d B\right)
$$

$X_{n, k}=H\left(\widetilde{\Xi}_{n, k}^{T}\right)$ and $Y_{k}=H\left(\widetilde{\Xi}_{k}^{T}\right)$. Note that $E\left|X_{n}-X_{n, k}\right| \leq \delta_{k}$, where

$$
\delta_{k}=2 M P\left(\sup _{0 \leq t \leq T}|B(t)| \geq k\right) .
$$

Also note that that $\delta_{k} \rightarrow 0$ as $k \rightarrow \infty$. Since $G_{k}$ has compact support, we have already proven that $X_{n, k} \rightarrow Y_{k}$ in law. Hence, by Lemma 2.4, it will suffice to show that $Y_{k} \rightarrow X$ in law. However, it is an immediate consequence of (2.19) that $\widetilde{\Xi}_{k}^{T} \rightarrow \Xi^{T}$ ucp, which completes the proof.

Proof of Theorem 2.13. As in the proof of Theorem 2.12, $\left\{\left(B, V_{n}(B), J_{n}\right)\right\}$ is relatively compact. Let $(B, X, Y)$ be any subsequential limit. By Theorem $2.11, X=\kappa W$, where $W$ is a standard Brownian motion, independent of $B$. Hence, $(B, X, Y)=(B, \llbracket B \rrbracket, Y)$. Fix $j \in\{1, \ldots, k\}$. By Theorem $\sqrt[2.12]{ },\left(B, \llbracket B \rrbracket, Y_{j}\right)$ has the same law as $\left(B, \llbracket B \rrbracket, \int g_{j}(B) d B\right)$. Using the general fact we observed at the beginning of the proof of Theorem 3.1, together with (2.19) and the definition of $\llbracket B \rrbracket$, this implies $\left(\int g_{j}(B) d B, Y_{j}\right)$ and $\left(\int g_{j}(B) d B, \int g_{j}(B) d B\right)$ have the same law. Hence, $Y_{j}=\int g_{j}(B) d B$ a.s., so $(B, X, Y)=(B, \llbracket B \rrbracket, J)$.
