# BOUNDARY VALUE PROBLEMS WITH MEASURES FOR ELLIPTIC EQUATIONS WITH SINGULAR POTENTIALS $『$

#### Abstract

We study the boundary value problem with Radon measures for nonnegative solutions of $L_{V} u:=-\Delta u+V u=0$ in a bounded smooth domain $\Omega$, when $V$ is a locally bounded nonnegative function. Introducing some specific capacity, we give sufficient conditions on a Radon measure $\mu$ on $\partial \Omega$ so that the problem can be solved. We study the reduced measure associated to this equation as well as the boundary trace of positive solutions. In the appendix A. Ancona solves a question raised by M. Marcus and L. Véron concerning the vanishing set of the Poisson kernel of $L_{V}$ for an important class of potentials $V$.

## 1 Introduction

Let $\Omega$ be a smooth bounded domain of $\mathbb{R}^{N}$ and $V$ a locally bounded real valued measurable function defined in $\Omega$. The first question we adress is the solvability of the following nonhomogeneous Dirichlet problem with a Radon measure for boundary data,

$$
\left\{\begin{align*}
-\Delta u+V u & =0 & & \text { in } \Omega  \tag{1.1}\\
u & =\mu & & \text { in } \partial \Omega .
\end{align*}\right.
$$

Let $\phi$ be the first (and positive) eigenfunction of $-\Delta$ in $W_{0}^{1,2}(\Omega)$. By a solution we mean a function $u \in L^{1}(\Omega)$, such that $V u \in L_{\phi}^{1}$, which satisfies

$$
\begin{equation*}
\int_{\Omega}(-u \Delta \zeta+V u \zeta) d x=-\int_{\partial \Omega} \frac{\partial \zeta}{\partial \mathbf{n}} d \mu \tag{1.2}
\end{equation*}
$$

for any function $\zeta \in C_{0}^{1}(\bar{\Omega})$ such that $\Delta \zeta \in L^{\infty}(\Omega)$. When $V$ is a bounded nonnegative function, it is straightforward that there exist a unique solution. However, it is less obvious to find general conditions which allow the solvability for any $\mu \in \mathfrak{M}(\partial \Omega)$, the set of Radon measures on $\partial \Omega$. In order to avoid difficulties due to Fredholm type obstructions, we shall most often assume that $V$ is nonnegative, in which case there exists at most one solution.

Let us denote by $K^{\Omega}$ the Poisson kernel in $\Omega$ and by $\mathbb{K}[\mu]$ the Poisson potential of a measure, that is

$$
\begin{equation*}
\mathbb{K}[\mu](x):=\int_{\partial \Omega} K^{\Omega}(x, y) d \mu(y) \quad \forall x \in \Omega \tag{1.3}
\end{equation*}
$$

We first observe that, when $V \geq 0$ and the measure $\mu$ satisfies

$$
\begin{equation*}
\int_{\Omega} \mathbb{K}[|\mu|](x) V(x) \phi(x) d x<\infty \tag{1.4}
\end{equation*}
$$

then problem (1.1) admits a solution. A Radon measure which satisfies (1.4) is called an admissible measure and a measure for which a solution exists is called a good measure.

We first consider the subcritical case which means that the boundary value is solvable for any $\mu \in \mathfrak{M}(\partial \Omega)$. As a first result, we prove that any measure $\mu$ is admissible if $V$ is nonnegative and satisfies

$$
\begin{equation*}
\sup _{y \in \partial \Omega} \operatorname{ess} \int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x<\infty \tag{1.5}
\end{equation*}
$$

where $\phi$ is the first positive eigenfuntion of $-\Delta$ in $W_{0}^{1,2}(\Omega)$. Using estimates on the Poisson kernel, this condition is fulfilled if there exists $M>0$ such that for any $y \in \partial \Omega$,

$$
\begin{equation*}
\int_{0}^{D(\Omega)}\left(\int_{\Omega \cap B_{r}(y)} V(x) \phi^{2}(x) d x\right) \frac{d r}{r^{N+1}} \leq M \tag{1.6}
\end{equation*}
$$

where $D(\Omega)=\operatorname{diam}(\Omega)$. We give also sufficient conditions which ensures that the boundary value problem (1.1) is stable from the weak*-topology of $\mathfrak{M}(\partial \Omega)$ to $L^{1}(\Omega) \cap L_{V \phi}^{1}(\Omega)$. One of the sufficient conditions is that $V \geq 0$ satisfies

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} \int_{0}^{\epsilon}\left(\int_{\Omega \cap B_{r}(y)} V(x) \phi^{2}(x) d x\right) \frac{d r}{r^{N+1}}=0 \tag{1.7}
\end{equation*}
$$

uniformly with respect to $y \in \partial \Omega$.
In the supercritical case problem (1.1) cannot be solved for any $\mu \in \mathfrak{M}(\partial \Omega)$. In order to characterize positive good measures, we introduce a framework of nonlinear analysis which have been used by Dynkin and Kuznetsov (see 16 and references therein) and Marcus and Véron [30] in their study of the boundary value problems with measures

$$
\left\{\begin{align*}
-\Delta u+|u|^{q-1} u & =0 & & \text { in } \Omega  \tag{1.8}\\
u & =\mu & & \text { in } \partial \Omega
\end{align*}\right.
$$

where $q>1$. In these works, positive good measures on $\partial \Omega$ are completely characterized by the $C_{2 / q, q^{\prime}}$-Bessel in dimension N-1 and the following property:

A measure $\mu \in \mathfrak{M}_{+}(\partial \Omega)$ is good for problem (1.8) if and only if it does charge Borel sets with zero $C_{2 / q, q^{\prime}}$-capacity, i.e

$$
\begin{equation*}
C_{2 / q, q^{\prime}}(E)=0 \Longrightarrow \mu(E)=0 \quad \forall E \subset \partial \Omega, E \text { Borel. } \tag{1.9}
\end{equation*}
$$

Moreover, any positive good measure is the limit of an increasing sequence $\left\{\mu_{n}\right\}$ of admissible measures which, in this case, are the positive measures belonging to the Besov space $B_{2 / q, q^{\prime}}(\partial \Omega)$. They also characaterize removable sets in terms of $C_{2 / q, q^{\prime}}$-capacity.

In our present work, and always with $V \geq 0$, we use a capacity associated to the Poisson kernel $K^{\Omega}$ and which belongs to a class studied by Fuglede 18 19]. It is defined by

$$
\begin{equation*}
C_{V}(E)=\sup \left\{\mu(E): \mu \in \mathfrak{M}_{+}(\partial \Omega), \mu\left(E^{c}\right)=0,\|V \mathbb{K}[\mu]\|_{L_{\phi}^{1}} \leq 1\right\} \tag{1.10}
\end{equation*}
$$

for any Borel set $E \subset \partial \Omega$. Furtheremore $C_{V}(E)$ is equal to the value of its dual expression $C_{V}^{*}(E)$ defined by

$$
\begin{equation*}
C_{V}^{*}(E)=\inf \left\{\|f\|_{L^{\infty}}: \check{\mathbb{K}}[f] \geq 1 \quad \text { on } E\right\} \tag{1.11}
\end{equation*}
$$

where

$$
\begin{equation*}
\check{\mathbb{K}}[f](y)=\int_{\Omega} K^{\Omega}(x, y) f(x) V(x) \phi(x) d x \quad \forall y \in \partial \Omega \tag{1.12}
\end{equation*}
$$

If $E$ is a compact subset of $\partial \Omega$, this capacity is explicitely given by

$$
\begin{equation*}
C_{V}(E)=C_{V}^{*}(E)=\max _{y \in E}\left(\int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x\right)^{-1} \tag{1.13}
\end{equation*}
$$

We denote by $Z_{V}$ the largest set with zero $C_{V}$ capacity, i.e.

$$
\begin{equation*}
Z_{V}=\left\{y \in \partial \Omega: \int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x=\infty\right\} \tag{1.14}
\end{equation*}
$$

and we prove the following.
1- If $\left\{\mu_{n}\right\}$ is an increasing sequence of positive good measures which converges to a measure $\mu$ in the weak* topology, then $\mu$ is a good measure.
2- If $\mu \in \mathfrak{M}_{+}(\partial \Omega)$ satisfies $\mu\left(Z_{V}\right)=0$, then $\mu$ is a good measure.

3- A good measure $\mu$ vanishes on $Z_{V}$ if and only if there exists an increasing sequence of positive admissible measures which converges to $\mu$ in the weak* topology.

In section 4 we study relaxation phenomenon in replacing (1.1) by the truncated problem

$$
\left\{\begin{align*}
&-\Delta u+V_{k} u=0  \tag{1.15}\\
& \text { in } \Omega \\
& u=\mu \\
& \text { in } \partial \Omega .
\end{align*}\right.
$$

where $\left\{V_{k}\right\}$ is an increasing sequence of positive bounded functions which converges to $V$ locally uniformly in $\Omega$. We adapt to the linear problem some of the principles of the reduced measure. This notion is introduced by Brezis, Marcus and Ponce 10] in the study of the nonlinear Poisson equation

$$
\begin{equation*}
-\Delta u+g(u)=\mu \quad \text { in } \Omega \tag{1.16}
\end{equation*}
$$

and extended to the Dirichlet problem

$$
\left\{\begin{align*}
-\Delta u+g(u)=0 & \text { in } \Omega  \tag{1.17}\\
u=\mu & \text { in } \partial \Omega
\end{align*}\right.
$$

by Brezis and Ponce (11]. In our construction, problem (1.15) admits a unique solution $u_{k}$. The sequence $\left\{u_{k}\right\}$ decreases and converges to some $u$ which satisfies a relaxed boundary value problem

$$
\left\{\begin{align*}
-\Delta u+V u & =0 & & \text { in } \Omega  \tag{1.18}\\
u & =\mu^{*} & & \text { in } \partial \Omega .
\end{align*}\right.
$$

The measure $\mu^{*}$ is called the reduced measure associated to $\mu$ and $V$. Note that $\mu^{*}$ is the largest measure for which the problem

$$
\left\{\begin{align*}
-\Delta u+V u & =0 & & \text { in } \Omega  \tag{1.19}\\
u & =\nu \leq \mu & & \text { in } \partial \Omega
\end{align*}\right.
$$

admits a solution. This truncation process allows to construct the Poisson kernel $K_{V}^{\Omega}$ associated to the operator $-\Delta+V$ as being the limit of the decreasing limit of the sequence of kernel functions $\left\{K_{V_{k}}^{\Omega}\right\}$ asociated to $-\Delta+V_{k}$. The solution $u=u_{\mu^{*}}$ of (1.18) is expressed by

$$
\begin{equation*}
u_{\mu^{*}}(x)=\int_{\partial \Omega} K_{V}^{\Omega}(x, y) d \mu(y)=\int_{\partial \Omega} K_{V}^{\Omega}(x, y) d \mu^{*}(y) \quad \forall x \in \Omega \tag{1.20}
\end{equation*}
$$

We define the vanishing set of $K_{V}^{\Omega}$ by

$$
\begin{equation*}
\mathcal{S}_{\text {ing }_{V}}(\Omega)=\left\{y \in \partial \Omega: K_{V}^{\Omega}\left(x_{0}, y\right)=0\right\} \tag{1.21}
\end{equation*}
$$

for some $x_{0} \in \Omega$, and thus for any $x \in \Omega$ by Harnack inequality. We prove
1- $\mathcal{S}_{i n g}(\Omega) \subset Z_{V}$.
$2-\mu^{*}=\mu \chi_{\operatorname{sing}_{V}(\Omega)}$.
A challenging open problem is to give conditions on $V$ which imply $\mathcal{S}_{\text {ing }}^{V}(\Omega)=Z_{V}$.
The last section is devoted to the construction of the boundary trace of positive solutions of

$$
\begin{equation*}
-\Delta u+V u=0 \quad \text { in } \Omega \tag{1.22}
\end{equation*}
$$

assuming $V \geq 0$. Using results of [28], we defined the regular set $\mathcal{R}(u)$ of the boundary trace of $u$. This set is a relatively open subset of $\partial \Omega$ and the regular part of the boundary trace is represented by a positive Radon measure $\mu_{u}$ on $\mathcal{R}(u)$. In order to study the singular set of the boundary trace $\mathcal{S}(u):=\partial \Omega \backslash \mathcal{R}(u)$, we adapt the sweeping method introduced by Marcus and Véron in [29] for equation

$$
\begin{equation*}
-\Delta u+g(u)=0 \quad \text { in } \Omega . \tag{1.23}
\end{equation*}
$$

If $\mu$ is a good positive measure concentrated on $\mathcal{S}(u)$, and $u_{\mu}$ is the unique solution of (1.1) with boundary data $\mu$, we set $v_{\mu}=\min \left\{u, u_{\mu}\right\}$. Then $v_{\mu}$ is a positive super solution which admits a positive trace $\gamma_{u}(\mu) \in \mathfrak{M}_{+}(\partial \Omega)$. The extended boundary trace $\operatorname{Tr}^{e}(u)$ of $u$ is defined by

$$
\begin{equation*}
\nu(u)(E):=\operatorname{Tr}^{e}(u)(E)=\sup \left\{\gamma_{u}(\mu)(E): \mu \text { good, } E \subset \partial \Omega, E \text { Borel }\right\} . \tag{1.24}
\end{equation*}
$$

Then $\operatorname{Tr}^{e}(u)$ is a Borel measure on $\Omega$. If we assume moreover that

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} \int_{0}^{\epsilon}\left(\int_{\Omega \cap B_{r}(y)} V(x) \phi^{2}(x) d x\right) \frac{d r}{r^{N+1}}=0 \quad \text { uniformly with respect to } y \in \partial \Omega, \tag{1.25}
\end{equation*}
$$

then $\operatorname{Tr}^{e}(u)$ is a bounded measure and therefore a Radon measure. Finally, if $N=2$ and (1.25) holds, or if $N \geq 3$ and there holds

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} \int_{0}^{\epsilon}\left(\int_{\Omega \cap B_{r}(y)} V(x)(\phi(x)-\epsilon)_{+}^{2} d x\right) \frac{d r}{r^{N+1}}=0 \tag{1.26}
\end{equation*}
$$

uniformly with respect to $\epsilon \in\left(0, \epsilon_{0}\right]$ and $y$ s.t. $\operatorname{dist}(x, \partial \Omega)=\epsilon$, then $u=u_{\nu(u)}$.
If $V(x) \leq v(\phi(x)$ for some $v$ which satisfies

$$
\begin{equation*}
\int_{0}^{1} v(t) t d t<\infty \tag{1.27}
\end{equation*}
$$

then Marcus and Véron proved in [28] that $u=u_{\nu_{u}}$. Actually, when $V$ has such a geometric form, the assumptions (1.25)-(1.26) and (1.27) are equivalent.

The Appendix, written by A. Ancona, answers a question raised by M. Marcus and L. Véron in 2005 about the vanishing set of $K_{V}$ when $V$ is nonnegative and $\delta_{\Omega}^{2} V$ is uniformly bounded. Such potentials play a very important role in the description of the fine trace of semilinear elliptic equations as in (1.8): actually, for such equations, $V=u^{q-1}$ satisfies this upper estimate as a consequence of Keller-Osserman estimate. The following result is proved
Let $y \in \partial \Omega$ and $C_{\epsilon, y}:=\left\{x \in \Omega: \delta_{\Omega}(x) \geq \epsilon|x-y|\right\}$ for $0<\epsilon<1$. If

$$
\begin{equation*}
\int_{C_{\epsilon, y}} \frac{V(x) d x}{|x-y|^{N-2}}=\infty \tag{1.28}
\end{equation*}
$$

for some $\epsilon>0$, then $y \in \mathcal{S}_{\text {ing }_{V}}(\Omega)$.

## 2 The subcritical case

In the sequel $\Omega$ is a bounded smooth domain in $\mathbb{R}^{N}$ and $V \in L_{l o c}^{\infty}$. We denote by $\phi$ the first eigenfunction of $-\Delta$ in $W_{0}^{1,2}(\Omega), \phi>0$ with the corresponding eigenvalue $\lambda$, by $\mathfrak{M}(\partial \Omega)$ the space of bounded Radon measures on $\partial \Omega$ and by $\mathfrak{M}_{+}(\partial \Omega)$ its positive cone. For any positive Radon measure on $\partial \Omega$, we shall denote by the same symbol the corresponding outer regular bounded Borel measure. Conversely, for any outer regular bounded Borel $\mu$, we denote by the same expression $\mu$ the Radon measure defined on $C(\partial \Omega)$ by

$$
\zeta \mapsto \mu(\zeta)=\int_{\partial \Omega} \zeta d \mu
$$

If $\mu \in \mathfrak{M}(\partial \Omega)$, we are concerned with the following problem

$$
\left\{\begin{align*}
&-\Delta u+V u=0  \tag{2.1}\\
& u=\mu \\
& \text { in } \Omega \\
& \text { in } \partial \Omega .
\end{align*}\right.
$$

Definition 2.1 Let $\mu \in \mathfrak{M}(\partial \Omega)$. We say that $u$ is a weak solution of (2.1), if $u \in L^{1}(\Omega)$, $V u \in L_{\phi}^{1}(\Omega)$ and, for any $\zeta \in C_{0}^{1}(\bar{\Omega})$ with $\Delta \zeta \in L^{\infty}(\Omega)$, there holds

$$
\begin{equation*}
\int_{\Omega}(-u \Delta \zeta+V u \zeta) d x=-\int_{\partial \Omega} \frac{\partial \zeta}{\partial \mathbf{n}} d \mu \tag{2.2}
\end{equation*}
$$

In the sequel we put

$$
T(\Omega):=\left\{\zeta \in C_{0}^{1}(\bar{\Omega}) \text { such that } \Delta \zeta \in L^{\infty}(\Omega)\right\}
$$

We recall the following estimates obtained by Brezis [9]
Proposition 2.2 Let $\mu \in L^{1}(\partial \Omega)$ and $u$ be a weak solution of problem (2.1). Then there holds

$$
\begin{gather*}
\|u\|_{L^{1}(\Omega)}+\left\|V_{+} u\right\|_{L_{\phi}^{1}(\Omega)} \leq\left\|V_{-} u\right\|_{L_{\phi}^{1}(\Omega)}+c\|\mu\|_{L^{1}(\partial \Omega)}  \tag{2.3}\\
\int_{\Omega}(-|u| \Delta \zeta+V|u| \zeta) d x \leq-\int_{\partial \Omega} \frac{\partial \zeta}{\partial \mathbf{n}}|\mu| d S \tag{2.4}
\end{gather*}
$$

and

$$
\begin{equation*}
\int_{\Omega}\left(-u_{+} \Delta \zeta+V u_{+} \zeta\right) d x \leq-\int_{\partial \Omega} \frac{\partial \zeta}{\partial \mathbf{n}} \mu_{+} d S \tag{2.5}
\end{equation*}
$$

for all $\zeta \in T(\Omega), \zeta \geq 0$.
We denote by $K^{\Omega}(x, y)$ the Poisson kernel in $\Omega$ and by $\mathbb{K}[\mu]$ the Poisson potential of $\mu \in$ $\mathfrak{M}(\partial \Omega)$ defined by

$$
\begin{equation*}
\mathbb{K}[\mu](x)=\int_{\partial \Omega} K^{\Omega}(x, y) d \mu(y) \quad \forall x \in \Omega \tag{2.6}
\end{equation*}
$$

Definition 2.3 $A$ measure $\mu$ on $\partial \Omega$ is admissible if

$$
\begin{equation*}
\int_{\Omega} \mathbb{K}[|\mu|](x)|V(x)| \phi(x) d x<\infty \tag{2.7}
\end{equation*}
$$

It is good if problem (2.1) admits a weak solution.

We notice that, if there exists at least one admissible positive measure $\mu$, then

$$
\begin{equation*}
\int_{\Omega} V(x) \phi^{2}(x) d x<\infty \tag{2.8}
\end{equation*}
$$

Theorem 2.4 Assume $V \geq 0$, then problem (2.1) admits at most one solution. Furthermore, if $\mu$ is admissible, then there exists a unique solution that we denote $u_{\mu}$.

Proof. Uniqueness follows from (2.3). For existence we can assume $\mu \geq 0$. For any $k \in \mathbb{N}_{*}$ set $V_{k}=\inf \{V, k\}$ and denote by $u:=u_{k}$ the solution of

$$
\left\{\begin{align*}
-\Delta u+V_{k}(x) u=0 & \text { in } \Omega  \tag{2.9}\\
u=\mu & \text { on } \partial \Omega .
\end{align*}\right.
$$

Then $0 \leq u_{k} \leq \mathbb{K}[\mu]$. By the maximum principle, $u_{k}$ is decreasing and converges to some $u$, and

$$
0 \leq V_{k} u_{k} \leq V \mathbb{K}[\mu]
$$

Thus, by dominated convergence theorem $V_{k} u_{k} \rightarrow V u$ in $L_{\phi}^{1}$. Setting $\zeta \in T(\Omega)$ and letting $k$ tend to infinity in equality

$$
\begin{equation*}
\int_{\Omega}\left(-u_{k} \Delta \zeta+V_{k} u_{k} \zeta\right) d x=-\int_{\partial \Omega} \frac{\partial \zeta}{\partial \mathbf{n}} d \mu \tag{2.10}
\end{equation*}
$$

implies that $u$ satisfies (2.2).
Remark. If $V$ changes sign, we can put $\tilde{u}=u+\mathbb{K}[\mu]$. Then (2.1) is equivalent to

$$
\left\{\begin{array}{rlrl}
-\Delta \tilde{u}+V \tilde{u} & =V \mathbb{K}[\mu] \quad \text { in } \Omega  \tag{2.11}\\
\tilde{u} & =0 & \text { in } \partial \Omega .
\end{array}\right.
$$

This is a Fredholm type problem (at least if the operator $\phi \mapsto R(v):=(-\Delta)^{-1}(V \phi)$ is compact in $\left.L_{\phi}^{1}(\Omega)\right)$. Existence will be ensured by orthogonality conditions.

If we assume that $V \geq 0$ and

$$
\begin{equation*}
\int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x<\infty \tag{2.12}
\end{equation*}
$$

for some $y \in \partial \Omega$, then $\delta_{y}$ is admissible. The following result yields to the solvability of (2.1) for any $\mu \in \mathfrak{M}_{+}(\Omega)$.

Proposition 2.5 Assume $V \geq 0$ and the integrals (2.12) are bounded uniformly with respect to $y \in \partial \Omega$. Then any measure on $\partial \Omega$ is admissible.

Proof. If $M$ is the upper bound of these integrals and $\mu \in \mathfrak{M}_{+}(\partial \Omega)$, we have,

$$
\begin{equation*}
\int_{\Omega} \mathbb{K}[\mu](x) V(x) \phi(x) d x=\int_{\partial \Omega}\left(\int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x\right) d \mu(y) \leq M \mu(\partial \Omega) \tag{2.13}
\end{equation*}
$$

by Fubini's theorem. Thus $\mu$ is admissible.
Remark. Since the Poisson kernel in $\Omega$ satisfies the two-sided estimate

$$
\begin{equation*}
c^{-1} \frac{\phi(x)}{|x-y|^{N}} \leq K^{\Omega}(x, y) \leq c \frac{\phi(x)}{|x-y|^{N}} \quad \forall(x, y) \in \Omega \times \partial \Omega, \tag{2.14}
\end{equation*}
$$

for some $c>0$, assumption (2.12) is equivalent to

$$
\begin{equation*}
\int_{\Omega} \frac{V(x) \phi^{2}(x)}{|x-y|^{N}} d x<\infty . \tag{2.15}
\end{equation*}
$$

This implies (2.8) in particular. If we set $D_{y}=\max \{|x-y|: x \in \Omega\}$, then

$$
\begin{aligned}
\int_{\Omega} \frac{V(x) \phi^{2}(x)}{|x-y|^{N}} d x & =\int_{0}^{D_{y}}\left(\int_{\{x \in \Omega:|x-y|=r\}} V(x) \phi^{2}(x) d S_{r}(x)\right) \frac{d r}{r^{N}} \\
& =\lim _{\epsilon \rightarrow 0}\left(\left[r^{-N} \int_{\Omega \cap B_{r}(y)} V(x) \phi^{2}(x) d x\right]_{\epsilon}^{D_{y}}+N \int_{\epsilon}^{D_{y}}\left(\int_{\Omega \cap B_{r}(y)} V(x) \phi^{2}(x) d x\right) \frac{d r}{r^{N+1}}\right)
\end{aligned}
$$

(both quantity may be infinite). Thus, if we assume

$$
\begin{equation*}
\int_{0}^{D_{y}}\left(\int_{\Omega \cap B_{r}(y)} V(x) \phi^{2}(x) d x\right) \frac{d r}{r^{N+1}}<\infty \tag{2.16}
\end{equation*}
$$

there holds

$$
\begin{equation*}
\liminf _{\epsilon \rightarrow 0} \epsilon^{-N} \int_{\Omega \cap B_{\epsilon}(y)} V(x) \phi^{2}(x) d S=0 . \tag{2.17}
\end{equation*}
$$

Consequently

$$
\begin{equation*}
\int_{\Omega} \frac{V(x) \phi^{2}(x)}{|x-y|^{N}} d x=D_{y}^{-N} \int_{\Omega} V(x) \phi^{2}(x) d x+N \int_{0}^{D_{y}}\left(\int_{\Omega \cap B_{r}(y)}^{V}(x) \phi^{2}(x) d x\right) \frac{d r}{r^{N+1}} . \tag{2.18}
\end{equation*}
$$

Therefore (2.12) holds and $\delta_{y}$ is admissible.
As a natural extension of Proposition 2.5, we have the following stability result.
Theorem 2.6 Assume $V \geq 0$ and

$$
\begin{equation*}
\lim _{\substack{E \text { Borel } \\|E| \rightarrow 0}} \int_{E} K^{\Omega}(x, y) V(x) \phi(x) d x=0 \quad \text { uniformly with respect to } y \in \partial \Omega . \tag{2.19}
\end{equation*}
$$

If $\mu_{n}$ is a sequence of positive Radon measures on $\partial \Omega$ converging to $\mu$ in the weak* topology, then $u_{\mu_{n}}$ converges to $u_{\mu}$ in $L^{1}(\Omega) \cap L_{V \phi}^{1}(\Omega)$ and locally uniformly in $\Omega$.

Proof. We put $u_{\mu_{n}}:=u_{n}$. By the maximum principle $0 \leq u_{n} \leq \mathbb{K}\left[\mu_{n}\right]$. Furthermore, it follows from (2.3) that

$$
\begin{equation*}
\left\|u_{n}\right\|_{L^{1}(\Omega)}+\left\|V u_{n}\right\|_{L_{\phi}^{1}(\Omega)} \leq c\left\|\mu_{n}\right\|_{L^{1}(\partial \Omega)} \leq C \tag{2.20}
\end{equation*}
$$

Since $-\Delta u_{n}$ is bounded in $L_{\phi}^{1}(\Omega)$, the sequence $\left\{u_{n}\right\}$ is relatively compact in $L^{1}(\Omega)$ by the regularity theory for elliptic equations. Therefore, there exist a subsequence $u_{n_{k}}$ and some function $u \in L^{1}(\Omega)$ with $V u \in L_{\phi}^{1}(\Omega)$ such that $u_{n_{k}}$ converges to $u$ in $L^{1}(\Omega)$, almost everywhere on $\Omega$ and locally uniformly in $\Omega$ since $V \in L_{l o c}^{\infty}(\Omega)$. The main question is to prove the convergence of $V u_{n_{k}}$ in $L_{\phi}^{1}(\Omega)$. If $E \subset \Omega$ is any Borel set, there holds

$$
\begin{aligned}
\int_{E} u_{n} V(x) \phi(x) d x & \leq \int_{E} \mathbb{K}\left[\mu_{n}\right] V(x) \phi(x) d x \\
& \leq \int_{\partial \Omega}\left(\int_{E} K^{\Omega}(x, y) V(x) \phi(x) d x\right) d \mu_{n}(y) \\
& \leq M_{n} \max _{y \in \partial \Omega} \int_{E} K^{\Omega}(x, y) V(x) \phi(x) d x
\end{aligned}
$$

where $M_{n}:=\mu_{n}(\partial \Omega)$. Thus

$$
\begin{equation*}
\int_{E} u_{n} V(x) \phi(x) d x \leq M_{n} \max _{y \in \partial \Omega} \int_{E} K^{\Omega}(x, y) V(x) \phi(x) d x . \tag{2.21}
\end{equation*}
$$

Then, by (2.19),

$$
\lim _{|E| \rightarrow 0} \int_{E} u_{n} V(x) \phi(x) d x=0
$$

As a consequence the set of function $\left\{u_{n} \phi V\right\}$ is uniformly integrable. By Vitali's theorem $V u_{n_{k}} \rightarrow V u$ in $L_{\phi}^{1}(\Omega)$. Since

$$
\begin{equation*}
\int_{\Omega}\left(-u_{n} \Delta \zeta+V u_{n} \zeta\right) d x=-\int_{\partial \Omega} \frac{\partial \zeta}{\partial \mathbf{n}} d \mu_{n} \tag{2.22}
\end{equation*}
$$

for any $\zeta \in T(\Omega)$, the function $u$ satisfies (2.2).
Assumption (2.19) may be difficult to verify and the following result gives an easier formulation.

Proposition 2.7 Assume $V \geq 0$ satisfies

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} \int_{0}^{\epsilon}\left(\int_{\Omega \cap B_{r}(y)} V(x) \phi^{2}(x) d x\right) \frac{d r}{r^{N+1}}=0 \quad \text { uniformly with respect to } y \in \partial \Omega . \tag{2.23}
\end{equation*}
$$

Then (2.19) holds.
Proof. If $E \subset \Omega$ is a Borel set and $\delta>0$, we put $E_{\delta}=E \cap B_{\delta}(y)$ and $E_{\delta}^{c}=E \backslash E_{\delta}$. Then

$$
\int_{E} \frac{V(x) \phi^{2}(x)}{|x-y|^{N}} d x=\int_{E_{\delta}} \frac{V(x) \phi^{2}(x)}{|x-y|^{N}} d x+\int_{E_{\delta}^{c}} \frac{V(x) \phi^{2}(x)}{|x-y|^{N}} d x
$$

Clearly

$$
\begin{equation*}
\int_{E_{\delta}^{c}} \frac{V(x) \phi^{2}(x)}{|x-y|^{N}} d x \leq \delta^{-N} \int_{E .} V(x) \phi^{2}(x) d x . \tag{2.24}
\end{equation*}
$$

Since (2.16) holds for any $y \in \partial \Omega$, (2.18) implies

$$
\begin{equation*}
\int_{E_{\delta}} \frac{V(x) \phi^{2}(x)}{|x-y|^{N}} d x=\delta^{-N} \int_{E_{\delta}} V(x) \phi^{2}(x) d x+N \int_{0}^{\delta}\left(\int_{E \cap B_{r}(y)} V(x) \phi^{2}(x) d x\right) \frac{d r}{r^{N+1}} \tag{2.25}
\end{equation*}
$$

Using (2.23), for any $\epsilon>0$, there exists $s_{0}>0$ such that for any $s>0$ and $y \in \partial \Omega$

$$
s \leq s_{0} \Longrightarrow N \int_{0}^{s}\left(\int_{B_{r}(y)} V(x) \phi^{2}(x) d x\right) \frac{d r}{r^{N+1}} \leq \epsilon / 2
$$

We fix $\delta=s_{0}$. Since (2.8) holds,

$$
\begin{equation*}
\lim _{\substack{E \text { Borel } \\|E| \rightarrow 0}} \int_{E} V(x) \phi^{2}(x) d x=0 . \tag{2.26}
\end{equation*}
$$

Then there exists $\eta>0$ such that for any Borel set $E \subset \Omega$,

$$
|E| \leq \eta \Longrightarrow \int_{E} V(x) \phi^{2}(x) d x \leq s_{0}^{N} \epsilon / 4
$$

Thus

$$
\int_{E} \frac{V(x) \phi^{2}(x)}{|x-y|^{N}} d x \leq \epsilon
$$

This implies the claim by (2.14).
An assumption which is used in [28, Lemma 7.4] in order to prove the existence of a boundary trace of any positive solution of (1.22) is that there exists some nonnegative measurable function $v$ defined on $\mathbb{R}_{+}$such that

$$
\begin{equation*}
|V(x)| \leq v(\phi(x)) \quad \forall x \in \Omega \quad \text { and } \int_{0}^{s} t v(t) d t<\infty \quad \forall s>0 \tag{2.27}
\end{equation*}
$$

In the next result we show that condition (2.27) implies (2.19).
Proposition 2.8 Assume $V$ satisfies (2.27). Then

$$
\begin{equation*}
\lim _{\substack{E \text { Borel } \\|E| \rightarrow 0}} \int_{E} K^{\Omega}(x, y)|V(x)| \phi(x) d x=0 \quad \text { uniformly with respect to } y \in \partial \Omega \text {. } \tag{2.28}
\end{equation*}
$$

Proof. Since $\partial \Omega$ is $C^{2}$, there exist $\epsilon_{0}>0$ such that any for any $x \in \Omega$ satisfying $\phi(x) \leq \epsilon_{0}$, there exists a unique $\sigma(x) \in \partial \Omega$ such that $|x-\sigma(x)|=\phi(x)$. We use (2.23) in Proposition 2.7 under the equivalent form

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} \int_{0}^{\epsilon}\left(\int_{\Omega \cap C_{r}(y)}|V(x)| \phi^{2}(x) d x\right) \frac{d r}{r^{N+1}}=0 \quad \text { uniformly with respect to } y \in \partial \Omega \tag{2.29}
\end{equation*}
$$

in which we have replaced $B_{r}(y)$ by the the cylinder $C_{r}(y):=\{x \in \Omega: \phi(x)<r,|\sigma(x)-y|<r\}$. Then

$$
\begin{aligned}
\int_{0}^{\epsilon}\left(\int_{\Omega \cap C_{r}(y)}|V(x)| \phi^{2}(x) d x\right) \frac{d r}{r^{N+1}} & \leq c \int_{0}^{\epsilon}\left(\int_{0}^{r} v(t) t^{2} d t\right) \frac{d r}{r^{2}} \\
& \leq c \int_{0}^{\epsilon} v(t)\left(1-\frac{t}{\epsilon}\right) t d t \\
& \leq c \int_{0}^{\epsilon} v(t) t d t
\end{aligned}
$$

Thus (2.23) holds.

## 3 The capacitary approach

Throughout this section $V$ is a locally bounded nonnegative and measurable function defined on $\Omega$. We assume that there exists a positive measure $\mu_{0}$ on $\partial \Omega$ such that

$$
\begin{equation*}
\int_{\Omega} \mathbb{K}\left[\mu_{0}\right] V(x) \phi(x) d x=\mathcal{E}\left(1, \mu_{0}\right)<\infty \tag{3.1}
\end{equation*}
$$

Definition 3.1 If $\mu \in \mathfrak{M}_{+}(\partial \Omega)$ and $f$ is a nonnegative measurable function defined in $\Omega$ such that

$$
(x, y) \mapsto \mathbb{K}[\mu](y) f(x) V(x) \phi(x) \in L^{1}(\Omega \times \partial \Omega ; d x \otimes d \mu)
$$

we set

$$
\begin{equation*}
\mathcal{E}(f, \mu)=\int_{\Omega}\left(\int_{\partial \Omega} K^{\Omega}(x, y) d \mu(y)\right) f(x) V(x) \phi(x) d x \tag{3.2}
\end{equation*}
$$

If we put

$$
\begin{equation*}
\check{K}_{V}[f](y)=\int_{\Omega} K^{\Omega}(x, y) f(x) V(x) \phi(x) d x \tag{3.3}
\end{equation*}
$$

then, by Fubini's theorem, $\check{K}_{V}[f]<\infty, \mu$-almost everywhere on $\partial \Omega$ and

$$
\begin{equation*}
\mathcal{E}(f, \mu)=\int_{\partial \Omega}\left(\int_{\Omega} K^{\Omega}(x, y) f(x) V(x) \phi(x) d x\right) d \mu(y) \tag{3.4}
\end{equation*}
$$

Proposition 3.2 Let $f$ be fixed. Then
(a) $y \mapsto \check{\mathbb{K}}_{V}[f](y)$ is lower semicontinuous on $\partial \Omega$.
(b) $\mu \mapsto \mathcal{E}(f, \mu)$ is lower semicontinuous on $\mathfrak{M}_{+}(\partial \Omega)$ in the weak*-topology

Proof. Since $y \mapsto K^{\Omega}(x, y)$ is continuous, statement (a) follows by Fatou's lemma. If $\mu_{n}$ is a sequence in $\mathfrak{M}_{+}(\partial \Omega)$ converging to some $\mu$ in the weak*-topology, then $\mathbb{K}\left[\mu_{n}\right]$ converges to $\mathbb{K}[\mu]$ everywhere in $\Omega$. By Fatou's lemma

$$
\mathcal{E}(f, \mu) \leq \liminf _{n \rightarrow \infty} \int_{\Omega} \mathbb{K}\left[\mu_{n}\right](x) f(x) V(x) \phi(x) d x=\liminf _{n \rightarrow \infty} \mathcal{E}\left(f, \mu_{n}\right)
$$

Notice that if $V \phi f \in L^{p}(\Omega)$, for $p>N$, then $\mathbb{G}[V f \phi] \in C^{1}(\bar{\Omega})$ and

$$
\begin{equation*}
\check{\mathbb{K}}[f](y):=\int_{\Omega} K^{\Omega}(x, y) V(x) f(x) \phi(x) d x=-\frac{\partial}{\partial \mathbf{n}} \mathbb{G}[V f \phi](y) . \tag{3.5}
\end{equation*}
$$

This is in particular the case if $f$ has compact support in $\Omega$.
Definition 3.3 We denote by $\mathfrak{M}^{V}(\partial \Omega)$ the set of all measures $\mu$ on $\partial \Omega$ such that $V \mathbb{K}[\mu] \in$ $L_{\phi}^{1}(\Omega)$. If $\mu$ is such a measure, we denote

$$
\begin{equation*}
\|\mu\|_{\mathfrak{M}^{V}}=\int_{\Omega}|\mathbb{K}[\mu](x)| V(x) \phi(x) d x=\|V \mathbb{K}[\mu]\|_{L_{\phi}^{1}} \tag{3.6}
\end{equation*}
$$

Clearly $\|\cdot\|_{\mathfrak{M}^{V}}$ is a norm. The space $\mathfrak{M}^{V}(\partial \Omega)$ is not complete but its positive cone $\mathfrak{M}_{+}^{V}(\partial \Omega)$ is complete. If $E \subset \partial \Omega$ is a Borel subset, we put

$$
\mathfrak{M}_{+}(E)=\left\{\mu \in \mathfrak{M}_{+}(\partial \Omega): \mu\left(E^{c}\right)=0\right\} \quad \text { and } \quad \mathfrak{M}_{+}^{V}(E)=\mathfrak{M}_{+}(E) \cap \mathfrak{M}^{V}(\partial \Omega) .
$$

Definition 3.4 If $E \subset \partial \Omega$ is any Borel subset we set

$$
\begin{equation*}
C_{V}(E):=\sup \left\{\mu(E): \mu \in \mathfrak{M}_{+}^{V}(E),\|\mu\|_{\mathfrak{M}^{V}} \leq 1\right\} . \tag{3.7}
\end{equation*}
$$

We notice that (3.7) is equivalent to

$$
\begin{equation*}
C_{V}(E):=\sup \left\{\frac{\mu(E)}{\|\mu\|_{\mathfrak{M}^{V}}}: \mu \in \mathfrak{M}_{+}^{V}(E)\right\} . \tag{3.8}
\end{equation*}
$$

Proposition 3.5 The set function $C_{V}$ satisfies.

$$
\begin{equation*}
C_{V}(E) \leq \sup _{y \in E}\left(\int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x\right)^{-1} \quad \forall E \subset \partial \Omega, E \text { Borel, } \tag{3.9}
\end{equation*}
$$

and equality holds in (3.9) if $E$ is compact. Moreover,

$$
\begin{equation*}
C_{V}\left(E_{1} \cup E_{2}\right)=\sup \left\{C_{V}\left(E_{1}\right), C_{V}\left(E_{2}\right)\right\} \quad \forall E_{i} \subset \partial \Omega, E_{i} \text { Borel. } \tag{3.10}
\end{equation*}
$$

Proof. Notice that $E \mapsto C_{V}(E)$ is a nondecreasing set function for the inclusion relation and that (3.7) implies

$$
\begin{equation*}
\mu(E) \leq C_{V}(E)\|\mu\|_{\mathfrak{M}^{V}} \quad \forall \mu \in \mathfrak{M}_{+}^{V}(E) \tag{3.11}
\end{equation*}
$$

Let $E \subset \partial \Omega$ be a Borel set and $\mu \in \mathfrak{M}_{+}(E)$. Then

$$
\begin{aligned}
\|\mu\|_{\mathfrak{M} V} & =\int_{E}\left(\int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x\right) d \mu(y) \\
& \geq \mu(E) \inf _{y \in E} \int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x .
\end{aligned}
$$

Using (3.7) we derive

$$
\begin{equation*}
C_{V}(E) \leq \sup _{y \in E}\left(\int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x\right)^{-1} . \tag{3.12}
\end{equation*}
$$

If $E$ is compact, there exists $y_{0} \in E$ such that

$$
\inf _{y \in E} \int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x=\int_{\Omega} K^{\Omega}\left(x, y_{0}\right) V(x) \phi(x) d x
$$

since $y \mapsto \check{\mathbb{K}}[1](y)$ is 1.s.c.. Thus

$$
\left\|\delta_{y_{0}}\right\|_{\mathfrak{M}^{V}}=\delta_{y_{0}}(E) \int_{\Omega} K^{\Omega}\left(x, y_{0}\right) V(x) \phi(x) d x
$$

and

$$
C_{V}(E) \geq \frac{\delta_{y_{0}}(E)}{\left\|\delta_{y_{0}}\right\|_{\mathfrak{M}^{V}}}=\sup _{y \in E}\left(\int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x\right)^{-1} .
$$

Therefore equality holds in (3.9). Identity (3.10) follows (3.9) when there is equality. Moreover it holds if $E_{1}$ and $E_{2}$ are two arbitrary compact sets. Since $C_{V}$ is eventually an inner regular capacity (i.e. $C_{V}(E)=\sup \left\{C_{V}(K): K \subset E, K\right.$ compact $\}$ ) it holds for any Borel set. However we give below a self-contained proof. If $E_{1}$ and $E_{2}$ be two disjoint Borel subsets of $\partial \Omega$, for any $\epsilon>0$ there exists $\mu \in \mathfrak{M}_{+}^{V}\left(E_{1} \cup E_{2}\right)$ such that

$$
\frac{\mu\left(E_{1}\right)+\mu\left(E_{2}\right)}{\|\mu\|_{\mathfrak{M}^{V}}} \leq C_{V}\left(E_{1} \cup E_{2}\right) \leq \frac{\mu\left(E_{1}\right)+\mu\left(E_{2}\right)}{\|\mu\|_{\mathfrak{M}^{V}}}+\epsilon .
$$

Set $\mu_{i}=\chi_{E_{i}} \mu$. Then $\mu_{i} \in \mathfrak{M}_{+}^{V}\left(E_{i}\right)$ and $\|\mu\|_{\mathfrak{M}^{V}}=\left\|\mu_{1}\right\|_{\mathfrak{M}^{V}}+\left\|\mu_{2}\right\|_{\mathfrak{M}^{V}}$. By (3.11)

$$
\begin{equation*}
C_{V}\left(E_{1} \cup E_{2}\right) \leq \frac{\left\|\mu_{1}\right\|_{\mathfrak{M}^{V}}}{\left\|\mu_{1}\right\|_{\mathfrak{M}^{V}}+\left\|\mu_{2}\right\|_{\mathfrak{M}^{V}}} C_{V}\left(E_{1}\right)+\frac{\left\|\mu_{2}\right\|_{\mathfrak{M}^{V}}}{\left\|\mu_{1}\right\|_{\mathfrak{M}^{V}}+\left\|\mu_{2}\right\|_{\mathfrak{M}^{V}}} C_{V}\left(E_{2}\right)+\epsilon \tag{3.13}
\end{equation*}
$$

This implies that there exists $\theta \in[0,1]$ such that

$$
\begin{equation*}
C_{V}\left(E_{1} \cup E_{2}\right) \leq \theta C_{V}\left(E_{1}\right)+(1-\theta) C_{V}\left(E_{2}\right) \leq \max \left\{C_{V}\left(E_{1}\right), C_{V}\left(E_{2}\right)\right\} \tag{3.14}
\end{equation*}
$$

Since $C_{V}\left(E_{1} \cup E_{2}\right) \geq \max \left\{C_{V}\left(E_{1}\right), C_{V}\left(E_{2}\right)\right\}$ as $C_{V}$ is increasing,

$$
\begin{equation*}
E_{1} \cap E_{2}=\emptyset \Longrightarrow C_{V}\left(E_{1} \cup E_{2}\right)=\max \left\{C_{V}\left(E_{1}\right), C_{V}\left(E_{2}\right)\right\} . \tag{3.15}
\end{equation*}
$$

If $E_{1} \cap E_{2} \neq \emptyset$, then $E_{1} \cup E_{2}=E_{1} \cup\left(E_{2} \cap E_{1}^{c}\right)$ and therefore

$$
C_{V}\left(E_{1} \cup E_{2}\right)=\max \left\{C_{V}\left(E_{1}\right), C_{V}\left(E_{2} \cap E_{1}^{c}\right)\right\} \leq \max \left\{C_{V}\left(E_{1}\right), C_{V}\left(E_{2}\right)\right\} .
$$

Using again (3.8) we derive (3.10).
The following set function is the dual expression of $C_{V}(E)$.

Definition 3.6 For any Borel set $E \subset \partial \Omega$, we set

$$
\begin{equation*}
C_{V}^{*}(E):=\inf \left\{\|f\|_{L^{\infty}}: \check{\mathbb{K}}[f](y) \geq 1 \quad \forall y \in E\right\} \tag{3.16}
\end{equation*}
$$

The next result is stated in 19, p 922] using minimax theorem and the fact that $K^{\Omega}$ is lower semi continuous in $\Omega \times \partial \Omega$. Although the proof is not explicited, a simple adaptation of the proof of $\mathbb{1 1}$, Th 2.5.1] leads to the result.

Proposition 3.7 For any compact set $E \subset \partial \Omega$,

$$
\begin{equation*}
C_{V}(E)=C_{V}^{*}(E) \tag{3.17}
\end{equation*}
$$

In the same paper [19], formula (3.9) with equality is claimed (if $E$ is compact).
Theorem 3.8 If $\left\{\mu_{n}\right\}$ is an increasing sequence of good measures converging to some measure $\mu$ in the weak* topology, then $\mu$ is good.

Proof. We use formulation (4.10). We take for test function the function $\eta$ solution of

$$
\left\{\begin{align*}
-\Delta \eta=1 & \text { in } \Omega  \tag{3.18}\\
\eta=0 & \text { on } \Omega
\end{align*}\right.
$$

there holds

$$
\int_{\Omega}(1+V) u_{\mu_{n}} \eta d x=-\int_{\partial \Omega} \frac{\partial \eta}{\partial \mathbf{n}} d \mu_{n} \leq c^{-1} \mu_{n}(\partial \Omega) \leq c^{-1} \mu(\partial \Omega)
$$

where $c>0$ is such that

$$
c^{-1} \geq-\frac{\partial \eta}{\partial \mathbf{n}} \geq c \quad \text { on } \partial \Omega
$$

Since $\left\{u_{\mu_{n}}\right\}$ is increasing and $\eta \leq c \phi$ by Hopf boundary lemma, we can let $n \rightarrow \infty$ by the monotone convergence theorem. If $u:=\lim _{n \rightarrow \infty} u_{\mu_{n}}$, we obtain

$$
\int_{\Omega}(1+V) u \eta d x \leq c^{-1} \mu(\partial \Omega)
$$

Thus $u$ and $\phi V u$ are in $L^{1}(\Omega)$. Next, if $\zeta \in C_{0}^{1}(\bar{\Omega}) \cap C^{1,1}(\bar{\Omega})$, then $u_{\mu_{n}}|\Delta \zeta| \leq C u_{\mu_{n}}$ and $V u_{\mu_{n}}|\zeta| \leq C V u_{\mu_{n}} \eta$. Because the sequence $\left\{u_{\mu_{n}}\right\}$ and $\left\{V u_{\mu_{n}} \eta\right\}$ are uniformly integrable, the same holds for $\left\{u_{\mu_{n}} \Delta \zeta\right\}$ and $\left\{V u_{\mu_{n}} \zeta\right\}$. Considering

$$
\int_{\Omega}\left(-u_{\mu_{n}} \Delta \zeta+V u_{\mu_{n}} \zeta\right) d x=-\int_{\partial \Omega} \frac{\partial \zeta}{\partial \mathbf{n}} d \mu_{n}
$$

it follows by Vitali's theorem,

$$
\int_{\Omega}(-u \Delta \zeta+V u \zeta) d x=-\int_{\partial \Omega} \frac{\partial \zeta}{\partial \mathbf{n}} d \mu
$$

Thus $\mu$ is a good measure.
We define the singular boundary set $Z_{V}$ by

$$
\begin{equation*}
Z_{V}=\left\{y \in \partial \Omega: \int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x=\infty\right\} \tag{3.19}
\end{equation*}
$$

Since $\check{\mathbb{K}}[1]$ is l.s.c., it is a Borel function and $Z_{V}$ is a Borel set. The next result characterizes the good measures.

Proposition 3.9 Let $\mu$ be an admissible positive measure. Then $\mu\left(Z_{V}\right)=0$.
Proof. If $K \subset Z_{V}$ is compact, $\mu_{K}=\chi_{K} \mu$ is admissible, thus, by Fubini theorem

$$
\left\|\mu_{K}\right\|_{\mathfrak{M}^{V}}=\int_{K}\left(\int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x\right) d \mu(y)<\infty
$$

Since

$$
\int_{\Omega} K^{\Omega}(x, y) V(x) \phi(x) d x \equiv \infty \quad \forall y \in K
$$

it follows that $\mu(K)=0$. This implies $\mu\left(Z_{V}\right)=0$ by regularity.
Theorem 3.10 Let $\mu \in \mathfrak{M}_{+}(\partial \Omega)$ such that

$$
\begin{equation*}
\mu\left(Z_{V}\right)=0 \tag{3.20}
\end{equation*}
$$

Then $\mu$ is good.
Proof. Since $\check{\mathbb{K}}[1]$ is l.s.c., for any $n \in \mathbb{N}_{*}$,

$$
K_{n}:=\{y \in \partial \Omega: \check{\mathbb{K}}[1](y) \leq n\}
$$

is a compact subset of $\partial \Omega$. Furthermore $K_{n} \cap Z_{V}=\emptyset$ and $\cup K_{n}=Z_{V}^{c}$. Let $\mu_{n}=\chi_{K_{n}} \mu$, then

$$
\begin{equation*}
\mathcal{E}\left(1, \mu_{n}\right)=\int_{\Omega} \mathbb{K}\left[\mu_{n}\right] V(x) \phi(x) d x \leq n \mu_{n}\left(K_{n}\right) . \tag{3.21}
\end{equation*}
$$

Therefore $\mu_{n}$ is admissible. By the monotone convergence theorem, $\mu_{n} \uparrow \chi_{z_{V C}} \mu$ and by Theorem 3.8, $\chi_{z_{V c}} \mu$ is good. Since (5.6) holds, $\chi_{Z_{V c}} \mu=\mu$, which ends the proof.

The full characterization of the good measures in the general case appears to be difficult without any further assumptions on $V$. However the following holds

Theorem 3.11 Let $\mu \in \mathfrak{M}_{+}(\partial \Omega)$ be a good measure. The following assertions are equivalent:
(i) $\mu\left(Z_{V}\right)=0$.
(ii) There exists an increasing sequence of admissible measures $\left\{\mu_{n}\right\}$ which converges to $\mu$ in the weak*-topology.

Proof. If (i) holds, it follows from the proof of Theorem 3.10 that the sequence $\left\{\mu_{n}\right\}$ increases and converges to $\mu$. If (ii) holds, any admissible measure $\mu_{n}$ vanishes on $Z_{V}$ by Proposition 3.9. Since $\mu_{n} \leq \mu$, there exists an increasing sequence of $\mu$-integrable functions $h_{n}$ such that $\mu_{n}=h_{n} \mu$. Then $\mu_{n}\left(Z_{V}\right)$ increases to $\mu\left(Z_{V}\right)$ by the monotone convergence theorem. The conclusion follows from the fact that $\mu_{n}\left(Z_{V}\right)=0$.

## 4 Representation formula and reduced measures

We recall the construction of the Poisson kernel for $-\Delta+V$ : if we look for a solution of

$$
\left\{\begin{align*}
-\Delta v+V(x) v & =0 & & \text { in } \Omega  \tag{4.1}\\
v & =\nu & & \text { in } \partial \Omega
\end{align*}\right.
$$

where $\nu \in \mathfrak{M}(\partial \Omega), V \geq 0, V \in L_{l o c}^{\infty}(\Omega)$, we can consider an increasing sequence of smooth domains $\Omega_{n}$ such that $\bar{\Omega}_{n} \subset \Omega_{n+1}$ and $\cup_{n} \Omega_{n}=\cup_{n} \bar{\Omega}_{n}=\Omega$. For each of these domains, denote by $K_{V \chi_{\Omega_{n}}}^{\Omega}$ the Poisson kernel of $-\Delta+V \chi_{\Omega_{n}}$ in $\Omega$ and by $\mathbb{K}_{V \chi_{\Omega_{n}}}$ [.] the corresponding operator. We denote by $K^{\Omega}:=K_{0}^{\Omega}$ the Poisson kernel in $\Omega$ and by $\mathbb{K}[$.$] the Poisson operator in \Omega$. Then the solution $v:=v_{n}$ of

$$
\left\{\begin{align*}
&-\Delta v+V \chi_{\Omega_{n}} v=0  \tag{4.2}\\
& v=\nu \\
& \text { in } \Omega \\
& v \Omega
\end{align*}\right.
$$

is expressed by

$$
\begin{equation*}
v_{n}(x)=\int_{\partial \Omega} K_{V \chi_{\Omega_{n}}}^{\Omega}(x, y) d \nu(y)=\mathbb{K}_{V \chi_{\Omega_{n}}}[\nu](x) \tag{4.3}
\end{equation*}
$$

If $G^{\Omega}$ is the Green kernel of $-\Delta$ in $\Omega$ and $\mathbb{G}[$.$] the corresponding Green operator, (4.3) is$ equivalent to

$$
\begin{equation*}
v_{n}(x)+\int_{\Omega} G^{\Omega}(x, y)\left(V \chi_{\Omega_{n}} v_{n}\right)(y) d y=\int_{\partial \Omega} K^{\Omega}(x, y) d \nu(y) \tag{4.4}
\end{equation*}
$$

equivalently

$$
v_{n}+\mathbb{G}\left[V \chi_{\Omega_{n}} v_{n}\right]=\mathbb{K}[\nu]
$$

Notice that this equality is equivalent to the weak formulation of problem (4.2): for any $\zeta \in T(\Omega)$, there holds

$$
\begin{equation*}
\int_{\Omega}\left(-v_{n} \Delta \zeta+V \chi_{\Omega_{n}} v_{n} \zeta\right) d x=-\int_{\partial \Omega} \frac{\partial \zeta}{\partial \mathbf{n}} d \nu \tag{4.5}
\end{equation*}
$$

Since $n \mapsto K_{V \chi_{\Omega_{n}}}^{\Omega}$ is decreasing, the sequence $\left\{v_{n}\right\}$ inherits this property and there exists

$$
\begin{equation*}
\lim _{n \rightarrow \infty} K_{V \chi_{\Omega_{n}}}^{\Omega}(x, y)=K_{V}^{\Omega}(x, y) \tag{4.6}
\end{equation*}
$$

By the monotone convergence theorem,

$$
\begin{equation*}
\lim _{n \rightarrow \infty} v_{n}(x)=v(x)=\int_{\partial \Omega} K_{V}^{\Omega}(x, y) d \nu(y) \tag{4.7}
\end{equation*}
$$

By Fatou's theorem

$$
\begin{equation*}
\int_{\Omega} G^{\Omega}(x, y) V(y) v(y) d y \leq \liminf _{n \rightarrow \infty} \int_{\Omega} G^{\Omega}(x, y)\left(V \chi_{\Omega_{n}} v_{n}\right)(y) d y \tag{4.8}
\end{equation*}
$$

and thus,

$$
\begin{equation*}
v(x)+\int_{\Omega} G^{\Omega}(x, y) V(y) v(y) d y \leq \mathbb{K}[\nu](x) \quad \forall x \in \Omega \tag{4.9}
\end{equation*}
$$

Now the main question is to know whether $v$ keeps the boundary value $\nu$. Equivalently, whether the equality holds in (4.8) with lim instead of liminf, and therefore in (4.9). This question is associated to the notion of reduced measured in the sense of Brezis-Marcus-Ponce: since $V v \in L_{\phi}^{1}(\Omega)$ and

$$
\begin{equation*}
-\Delta v+V(x) v=0 \quad \text { in } \Omega \tag{4.10}
\end{equation*}
$$

holds, the function $v+\mathbb{G}[V v]$ is positive and harmonic in $\Omega$. Thus it admits a boundary trace $\nu^{*} \in \mathfrak{M}_{+}(\partial \Omega)$ and

$$
\begin{equation*}
v+\mathbb{G}[V v]=\mathbb{K}\left[\nu^{*}\right] . \tag{4.11}
\end{equation*}
$$

Equivalently $v$ satisfies the relaxed problem

$$
\left\{\begin{array}{rlr}
-\Delta v+V(x) v & =0 &  \tag{4.12}\\
v & =\nu^{*} & \text { in } \Omega \\
& \text { in } \partial \Omega,
\end{array}\right.
$$

and thus $v=u_{\nu^{*}}$. Noticed that $\nu^{*} \leq \nu$ and the mapping $\nu \mapsto \nu^{*}$ is nondecreasing.
Definition 4.1 The measure $\nu^{*}$ is the reduced measure associated to $\nu$.
Proposition 4.2 There holds $\mathbb{K}_{V}[\nu]=\mathbb{K}_{V}\left[\nu^{*}\right]$. Furthermore the reduced measure $\nu^{*}$ is the largest measure for which the following problem

$$
\left\{\begin{align*}
-\Delta v+V(x) v & =0 & & \text { in } \Omega  \tag{4.13}\\
\lambda \in \mathfrak{M}_{+}(\partial \Omega), \lambda & \leq \nu & & \text { in } \partial \Omega,
\end{align*}\right.
$$

admits a solution.
Proof. The first assertion follows from the fact that $v=\mathbb{K}_{V}[\nu]$ by (4.6) and $v=u_{\nu^{*}}=\mathbb{K}_{V}\left[\nu^{*}\right]$ by (4.12). It is clear that $\nu^{*} \leq \nu$ and that the problem (4.13) admits a solution for $\lambda=\nu^{*}$. If $\lambda$ is a positive measure smaller than $\mu$, then $\lambda^{*} \leq \mu^{*}$. But if there exist some $\lambda$ such that the problem (4.13) admits a solution, then $\lambda=\lambda^{*}$. This implies the claim.

As a consequence of the characterization of $\nu^{*}$ there holds
Corollary 4.3 Assume $V \geq 0$ and let $\left\{V_{k}\right\}$ be an increasing sequence of nonnegative bounded measurable functions converging to $V$ a.e. in $\Omega$. Then the solution $u_{k}$ of

$$
\left\{\begin{align*}
-\Delta u+V_{k} u=0 & \text { in } \Omega  \tag{4.14}\\
u=\nu & \text { in } \partial \Omega,
\end{align*}\right.
$$

converges to $u_{\nu^{*}}$.
Proof. The previous construction shows that $u_{k}=\mathbb{K}_{V_{k}}[\nu]$ decreases to some $\tilde{u}$ which satisfies a relaxed equation, the boundary data of which, $\tilde{\nu}^{*}$, is the largest measure $\lambda \leq \nu$ for which problem (4.13) admits a solution. Therefore $\tilde{\nu}^{*}=\nu^{*}$ and $\tilde{u}=u_{\nu^{*}}$. Similarly $\left\{K_{V_{k}}^{\Omega}\right\}$ decreases and converges to $K_{V}^{\Omega}$.

We define the boundary vanishing set of $K_{V}^{\Omega}$ by

$$
\begin{equation*}
\mathcal{S}_{\text {ing }_{V}}(\Omega):=\left\{y \in \partial \Omega \mid K_{V}^{\Omega}(x, y)=0\right\} \quad \text { for some } x \in \Omega \tag{4.15}
\end{equation*}
$$

Since $V \in L_{l o c}^{\infty}(\Omega), \mathcal{S}_{i n g}^{V}(\Omega)$ is independent of $x$ by Harnack inequality; furthermore it is a Borel set. This set is called the set of finely irregular boundary points by E. B. Dynkin; the reason for such a denomination will appear in the Appendix.

Theorem 4.4 Let $\nu \in \mathfrak{M}_{+}(\partial \Omega)$.
(i) If $\nu\left(\left(\mathcal{S}_{\text {ing }}^{V}(\Omega)\right)^{c}\right)=0$, then $\nu^{*}=0$.
(ii) There always holds $\mathcal{S}_{\text {ing }_{V}}(\Omega) \subset Z_{V}$.

Proof. The first assertion is clear since $\nu=\chi_{\operatorname{sing}_{V}(\Omega)} \nu+\chi_{\left.\operatorname{sing}_{V}(\Omega)\right)^{c}} \nu=\chi_{\operatorname{sing}_{V}(\Omega)} \nu$ and, by Proposition 4.2,

$$
u_{\nu^{*}}(x)=\mathbb{K}_{V}\left[\nu^{*}\right](x)=\int_{\operatorname{Sing}_{V}(\Omega)} K_{V}^{\Omega}(x, y) d \nu(y)=0 \quad \forall x \in \Omega
$$

by definition of $\mathcal{S}_{i n g_{V}}(\Omega)$. For proving (ii), we assume that $C_{V}\left(\mathcal{S}_{i n g}(\Omega)\right)>0$; there exists $\mu \in \mathfrak{M}_{+}^{V}\left(\mathcal{S}_{i n g_{V}}(\Omega)\right)$ such that $\mu\left(\mathcal{S}_{i n g_{V}}(\Omega)\right)>0$. Since $\mu$ is admissible let $u_{\mu}$ be the solution of (1.1). Then $\mu^{*}=\mu$, thus $u_{\mu}=\mathbb{K}^{V}[\mu]$ and

$$
\mathbb{K}^{V}[\mu](x)=\int_{\partial \Omega} K_{V}^{\Omega}(x, y) d \mu(y)=\int_{\operatorname{Sing}_{V}(\Omega)} K_{V}^{\Omega}(x, y) d \mu(y)=0
$$

contradiction. Thus $C_{V}\left(\mathcal{S}_{\text {ing }}^{V}(\Omega)\right)=0$. Since (3.9) implies that $Z_{V}$ is the largest Borel set with zero $C_{V}$-capacity, it implies $\mathcal{S}_{i n g}(\Omega) \subset Z_{V}$.

In order to obtain more precise informations on $\mathcal{S}_{i n g_{V}}(\Omega)$ some minimal regularity assumptions on $V$ are needed. We also recall the following result due to Ancona [6] and developed in the appendix of the present work.

Theorem 4.5 Assume $V \geq 0$ satisfies $\delta_{\Omega}^{2} V \in L^{\infty}(\Omega)$. If for some $y \in \partial \Omega$ and some cone $C_{y}$ with vertex $y$ such that $\bar{C}_{y} \cap B_{r}(y) \subset \Omega \cup\{y\}$ for some $r>0$ there holds

$$
\begin{equation*}
\int_{C_{y}} \frac{V(x)}{|x-y|^{N-2}} d x=\infty \tag{4.16}
\end{equation*}
$$

then

$$
\begin{equation*}
K_{V}^{\Omega}(x, y)=0 \quad \forall x \in \Omega \tag{4.17}
\end{equation*}
$$

This means that (4.16) implies that $y$ belongs to $\mathcal{S}_{i n g}(\Omega)$. We define the conical singular boundary set

$$
\begin{equation*}
\tilde{Z}_{V}=\left\{y \in \partial \Omega: \int_{C_{y}} K^{\Omega}(x, y) V(x) \rho(x) d x=\infty \text { for some open cone } C_{y} \Subset \Omega\right\} \tag{4.18}
\end{equation*}
$$

where $C_{y} \Subset \Omega$ means that there exists $a>0$ such that $\bar{C}_{y} \cap \bar{B}_{a}(y) \subset \Omega \cup\{y\}$. Clearly $\tilde{Z}_{V} \subset Z_{V}$.

Corollary 4.6 Assume $V \geq 0$ satisfies $g d_{\Omega}^{2} V \in L^{\infty}(\Omega)$. Then $\tilde{Z}_{V}=\mathcal{S}_{\text {ing }}^{V}(\Omega)$.
Proof. Let $y \in \tilde{Z}_{V}$. Since there exists $c>0$ such that

$$
\begin{equation*}
c^{-1} V(x)|x-y|^{2-N} \leq K^{\Omega}(x, y) V(x) \rho(x) \leq c V(x)|x-y|^{2-N} \quad \forall x \in C_{y} \tag{4.19}
\end{equation*}
$$

there holds

$$
\int_{C_{y}} \frac{V(x) d x}{|x-y|^{N-2}}=\infty
$$

Thus $y \in \mathcal{S}_{i n g}(\Omega)$ by Theorem 4.5. Conversely, the above identity implies

$$
\int_{C_{y}} K^{\Omega}(x, y) V(x) \phi(x) d x=\infty
$$

by (4.19).
Remark. In situations coming from the nonlinear equation $-\Delta u+|u|^{q-1} u=0$ in $\Omega$ with $q>1$, $V=|u|^{q-1}$ not only satisfies $g d_{\Omega}^{2} V \in L^{\infty}(\Omega)$ but also the restricted oscillation condition: for any $y \in \partial \Omega$ and any open cone $C_{y}$ with vertex $y$ such that $C_{y} \Subset \Omega$, there exists $c>0$ such that

$$
\begin{equation*}
\forall(x, z) \in C_{y} \times C_{y},|x-y|=|z-y| \Longrightarrow c^{-1} \leq \frac{V(x)}{V(z)} \leq c \tag{4.20}
\end{equation*}
$$

It is a consequence of the Keller-Osserman estimate and Harnack inequality. In this case condition (4.16) is equivalent to

$$
\begin{equation*}
\int_{0}^{1} V(\gamma(t)) t d t=\infty \tag{4.21}
\end{equation*}
$$

at least for one path $\gamma \in C^{0,1}([0,1])$ such that $\gamma(0)=y$ and $\gamma\left((0,1] \subset C_{y}\right.$ for some cone $C_{y} \Subset \Omega$.

## 5 The boundary trace

### 5.1 The regular part

In this section, $V \in L_{l o c}^{\infty}(\Omega)$ is nonnegative. If $0<\epsilon \leq \epsilon_{0}$, we $\operatorname{denote} \delta_{\Omega}(x)=\operatorname{dist}(x, \partial \Omega)$ for $x \in \Omega$, and set $\Omega_{\epsilon}:=\left\{x \in \Omega: \delta_{\Omega}(x)>\epsilon\right\}, \Omega_{\epsilon}^{\prime}=\Omega \backslash \Omega_{\epsilon}$ and $\Sigma_{\epsilon}=\partial \Omega_{\epsilon}$. It is well known that there exists $\epsilon_{0}$ such that, for any $0<\epsilon \leq \epsilon_{0}$ and any $x \in \Omega_{\epsilon}^{\prime}$ there exists a unique projection $\sigma(x)$ of $x$ on $\partial \Omega$ and any $x \in \Omega_{\epsilon}^{\prime}$ can be written in a unique way under the form

$$
x=\sigma(x)-\delta_{\Omega}(x) \mathbf{n}
$$

where $\mathbf{n}$ is the outward normal unit vector to $\partial \Omega$ at $\sigma(x)$. The mapping $x \mapsto\left(\delta_{\Omega}(x), \sigma(x)\right)$ is a $C^{2}$ diffeomorphism from $\Omega_{\epsilon}^{\prime}$ to $\left(0, \epsilon_{0}\right] \times \partial \Omega$. We recall the following definition given in [28]. If $\mathcal{A}$ is a Borel subset of $\partial \Omega$, we set $\mathcal{A}_{\epsilon}=\left\{x \in \Sigma_{\epsilon}: \sigma(x) \in A\right\}$.

Definition 5.1 Let $\mathcal{A}$ be a relatively open subset of $\partial \Omega,\left\{\mu_{\epsilon}\right\}$ be a set of Radon measures on $\mathcal{A}_{\epsilon}$ $\left(0<\epsilon \leq \epsilon_{0}\right)$ and $\mu \in \mathfrak{M}(\mathcal{A})$. We say that $\mu_{\epsilon} \rightharpoonup \mu$ in the weak*-topology if, for any $\zeta \in C_{c}(\mathcal{A})$,

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} \int_{\mathcal{A}_{\epsilon}} \zeta(\sigma(x)) d \mu_{\epsilon}(x)=\int_{\mathcal{A}} \zeta d \mu \tag{5.1}
\end{equation*}
$$

A function $u \in C(\Omega)$ possesses a boundary trace $\mu \in \mathfrak{M}(\mathcal{A})$ if

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} \int_{\mathcal{A}_{\epsilon}} \zeta(\sigma(x)) u(x) d S(x)=\int_{\mathcal{A}} \zeta d \mu \quad \forall \zeta \in C_{c}(\mathcal{A}) \tag{5.2}
\end{equation*}
$$

The following result is proved in [28, p 694].
Proposition 5.2 Let $u \in C(\Omega)$ be a positive solution of

$$
\begin{equation*}
-\Delta u+V(x) u=0 \quad \text { in } \Omega \tag{5.3}
\end{equation*}
$$

Assume that, for some $z \in \partial \Omega$, there exists an open neighborhood $U$ of $z$ such that

$$
\begin{equation*}
\int_{U \cap \Omega} V u \phi(x) d x<\infty . \tag{5.4}
\end{equation*}
$$

Then $u \in L^{1}(K \cap \Omega)$ for any compact subset $K \subset G$ and there exists a positive Radon measure $\mu$ on $\mathcal{A}=U \cap \partial \Omega$ such that

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} \int_{U \cap \Sigma_{\epsilon}} \zeta(\sigma(x)) u(x) d S(x)=\int_{\mathcal{A}} \zeta d \mu \quad \forall \zeta \in C_{c}(U \cap \Omega) . \tag{5.5}
\end{equation*}
$$

Notice that any continuous solution of (5.3) in $\Omega$ belongs to $W_{\text {loc }}^{2, p}(\Omega)$ for any $(1 \leq p<\infty)$. This previous result yields to a natural definition of the regular boundary points.

Definition 5.3 Let $u \in C(\Omega)$ be a positive solution of (5.3). A point $z \in \partial \Omega$ is called a regular boundary point for $u$ if there exists an open neighborhood $U$ of $z$ such that (5.5) holds. The set of regular boundary points is a relatively open subset of $\partial \Omega$, denoted by $\mathcal{R}(u)$. The set $\mathcal{S}(u)=\partial \Omega \backslash \mathcal{R}(u)$ is the singular boundary set of $u$. It is a closed set.

By Proposition 5.2 and using a partition of unity, we see that there exists a positive Radon measure $\mu:=\mu_{u}$ on $\mathcal{R}(u)$ such that (5.5) holds with $U$ replaced by $\mathcal{R}(u)$. The couple $\left(\mu_{u}, \mathcal{S}(u)\right)$ is called the boundary trace of $u$. The main question of the boundary trace problem is to analyse the behaviour of $u$ near the set $\mathcal{S}(u)$.

For any positive good measure $\mu$ on $\partial \Omega$, we denote by $u_{\mu}$ the solution of (4.1) defined by (4.10)-(4.11).

Proposition 5.4 Let $u \in C(\Omega) \cap W_{\text {loc }}^{2, p}(\Omega)$ for any $(1 \leq p<\infty)$ be a positive solution of (5.3) in $\Omega$ with boundary trace $\left(\mu_{u}, \mathcal{S}(u)\right)$. Then $u \geq u_{\mu_{u}}$.

Proof. Let $G \subset \partial \Omega$ be a relatively open subset such that $\bar{G} \subset \mathcal{R}(u)$ with a $C^{2}$ relative boundary $\partial^{*} G=\bar{G} \backslash G$. There exists an increasing sequence of $C^{2}$ domains $\Omega_{n}$ such that $\bar{G} \subset \partial \Omega_{n}$, $\partial \Omega_{n} \backslash \bar{G} \subset \Omega$ and $\cup_{n} \Omega_{n}=\Omega$. For any $n$, let $v:=v_{n}$ be the solution of

$$
\left\{\begin{align*}
-\Delta v+V v & =0 & & \text { in } \Omega_{n}  \tag{5.6}\\
v & =\chi_{G} \mu & & \text { in } \partial \Omega_{n} .
\end{align*}\right.
$$

Let $u_{n}$ be the restriction of $u$ to $\Omega_{n}$. Since $u \in C(\Omega)$ and $V u \phi \in L^{1}\left(\Omega_{n}\right)$, there also holds $V u \phi_{n} \in L^{1}\left(\Omega_{n}\right)$ where we have denoted by $\phi_{n}$ the first eigenfunction of $-\Delta$ in $W_{0}^{1,2}\left(\Omega_{n}\right)$. Consequently $u_{n}$ admits a regular boundary trace $\mu_{n}$ on $\partial \Omega_{n}$ (i.e. $\mathcal{R}\left(u_{n}\right)=\partial \Omega_{n}$ ) and $u_{n}$ is the solution of

$$
\left\{\begin{align*}
-\Delta v+V v & =0 & & \text { in } \Omega_{n}  \tag{5.7}\\
v & =\mu_{n} & & \text { in } \partial \Omega_{n} .
\end{align*}\right.
$$

Furthermore $\left.\mu_{n}\right|_{G}=\chi_{G} \mu_{u}$. It follows from Brezis estimates and in particular (2.5) that $u_{n} \leq u$ in $\Omega_{n}$. Since $\Omega_{n} \subset \Omega_{n+1}, v_{n} \leq v_{n+1}$. Moreover

$$
v_{n}+\mathbb{G}^{\Omega_{n}}\left[V v_{n}\right]=\mathbb{K}^{\Omega_{n}}\left[\chi_{G} \mu\right] \quad \text { in } \Omega_{n}
$$

Since $\mathbb{K}^{\Omega_{n}}\left[\chi_{G} \mu_{u}\right] \rightarrow \mathbb{K}^{\Omega}\left[\chi_{G} \mu_{u}\right]$, and the Green kernels $G^{\Omega_{n}}(x, y)$ are increasing with $n$, it follows from monotone convergence that $v_{n} \uparrow v$ and there holds

$$
v+\mathbb{G}^{\Omega}[V v]=\mathbb{K}^{\Omega}\left[\chi_{G} \mu_{u}\right] \quad \text { in } \Omega
$$

Thus $v=u_{\chi_{G} \mu_{u}}$ and $u_{\chi_{G} \mu_{u}} \leq u$. We can now replace $G$ by a sequence $\left\{G_{k}\right\}$ of relatively open sets with the same properties as $G, \bar{G}_{k} \subset G_{k}$ and $\cup_{k} G_{k}=\mathcal{R}(u)$. Then $\left\{u_{\chi_{G_{k}} \mu_{u}}\right\}$ is increasing and converges to some $\tilde{u}$. Since

$$
u_{\chi_{G k} \mu_{u}}+\mathbb{G}^{\Omega}\left[V u_{\chi_{G k} \mu_{u}}\right]=\mathbb{K}^{\Omega}\left[\chi_{G k} \mu_{u}\right],
$$

and $\mathbb{K}^{\Omega}\left[\chi_{{ }_{G k}} \mu\right] \uparrow \mathbb{K}^{\Omega}\left[\mu_{u}\right]$, we derive

$$
\tilde{u}+\mathbb{G}^{\Omega}[V \tilde{u}]=\mathbb{K}^{\Omega}\left[\mu_{u}\right]
$$

This implies that $\tilde{u}=u_{\mu_{u}} \leq u$.

### 5.2 The singular part

The following result is essentially proved in [28, Lemma 2.8].
Proposition 5.5 Let $u \in C(\Omega)$ for any $(1 \leq p<\infty)$ be a positive solution of (5.3) and suppose that $z \in \mathcal{S}(u)$ and that there exists an open neighborhood $U_{0}$ of $z$ such that $u \in L^{1}\left(\Omega \cap U_{0}\right)$. Then for any open neighborhood $U$ of $z$, there holds

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} \int_{U \cap \Sigma_{\epsilon}} \zeta(\sigma(x)) u(x) d S(x)=\infty \tag{5.8}
\end{equation*}
$$

As immediate consequences, we have
Corollary 5.6 Assume $u$ satisfies the regularity assumption of Proposition 5.4. Then for any $z \in \mathcal{S}(u)$ and any open neighborhood $U$ of $z$, there holds

$$
\begin{equation*}
\limsup _{\epsilon \rightarrow 0} \int_{U \cap \Sigma_{\epsilon}} \zeta(\sigma(x)) u(x) d S(x)=\infty . \tag{5.9}
\end{equation*}
$$

Corollary 5.7 Assume u satisfies the regularity assumption of Proposition 5.4. If $u \in L^{1}(\Omega)$, Then for any $z \in \mathcal{S}(u)$ and any open neighborhood $U$ of $z$, (5.8) holds.

The two next results give conditions on $V$ which imply that $\mathcal{S}(u)=\emptyset$.
Theorem 5.8 Assume $N=2, V$ is nonnegative and satisfies (2.19). If $u$ is a positive solution of (5.3), then $\mathcal{R}(u)=\partial \Omega$.

Proof. We assume that

$$
\begin{equation*}
\int_{\Omega} V \phi u d x=\infty . \tag{5.10}
\end{equation*}
$$

If $0<\epsilon \leq \epsilon_{0}$, we denote by $\left(\phi_{\epsilon}, \lambda_{\epsilon}\right)$ are the normalized first eigenfunction and first eigenvalue of $-\Delta$ in $W_{0}^{1,2}\left(\Omega_{\epsilon}\right)$, then

\begin{equation*}
\lim _{\epsilon \rightarrow 0} \int_{\Omega_{\epsilon}} V \phi_{\epsilon} u d x=\infty . \tag{5.11}
\end{equation*}
$$

Because

$$
\int_{\Omega_{\epsilon}}\left(\lambda_{\epsilon}+\phi_{\epsilon} V\right) u d x=-\int_{\partial \Omega_{\epsilon}} \frac{\partial \phi_{\epsilon}}{\partial \mathbf{n}} u d S
$$

and

$$
c^{-1} \leq-\frac{\partial \phi_{\epsilon}}{\partial \mathbf{n}} \leq c
$$

for some $c>1$ independent of $\epsilon$, there holds

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} \int_{\partial \Omega_{\epsilon}} u d S=\infty . \tag{5.12}
\end{equation*}
$$

Denote by $m_{\epsilon}$ this last integral and set $v_{\epsilon}=m_{\epsilon}^{-1} u$ and $\mu_{\epsilon}=\left.m_{\epsilon}^{-1} u\right|_{\partial \Omega_{\epsilon}}$. Then

\begin{equation*}
v_{\epsilon}+\mathbb{G}^{\Omega_{\epsilon}}\left[V v_{\epsilon}\right]=\mathbb{K}^{\Omega_{\epsilon}}\left[\mu_{\epsilon}\right] \quad \text { in } \Omega_{\epsilon} \tag{5.13}
\end{equation*}
$$

where

$$
\begin{equation*}
\mathbb{K}^{\Omega_{\epsilon}}\left[\mu_{\epsilon}\right](x)=\int_{\partial \Omega_{\epsilon}} K^{\Omega_{\epsilon}}(x, y) \mu_{\epsilon}(y) d S(y) \tag{5.14}
\end{equation*}
$$

is the Poisson potential of $\mu_{\epsilon}$ in $\Omega_{\epsilon}$ and

$$
\mathbb{G}^{\Omega_{\epsilon}}[V u](x)=\int_{\Omega_{\epsilon}} G^{\Omega_{\epsilon}}(x, y) V(y) u(y) d y,
$$

the Green potential of $V u$ in $\Omega_{\epsilon}$. Furthermore

$$
\left\{\begin{align*}
-\Delta v_{\epsilon}+V v_{\epsilon} & =0 & & \text { in } \Omega_{\epsilon}  \tag{5.15}\\
v_{\epsilon} & =\mu_{\epsilon} & & \text { in } \partial \Omega_{\epsilon} .
\end{align*}\right.
$$

By Brezis estimates and regularity theory for elliptic equations, $\left\{\chi_{\Omega_{\epsilon}} v_{\epsilon}\right\}$ is relatively compact in $L^{1}(\Omega)$ and in the local uniform topology of $\Omega_{\epsilon}$. Up to a subsequence $\left\{\epsilon_{n}\right\}, \mu_{\epsilon_{n}}$ converges to a probability measure $\mu$ on $\partial \Omega$ in the weak*-topology. It is classical that

$$
\mathbb{K}^{\Omega_{e_{n}}}\left[\mu_{\epsilon_{n}}\right] \rightarrow \mathbb{K}[\mu]
$$

locally uniformly in $\Omega$, and $\chi_{\Omega_{\epsilon_{n}}} v_{\epsilon_{n}} \rightarrow v$ in the local uniform topology of $\Omega$, and a.e. in $\Omega$. Because $G^{\Omega_{\epsilon}}(x, y) \uparrow G^{\Omega}(x, y)$, there holds for any $x \in \Omega$

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \chi_{\Omega_{\epsilon_{n}}}(y) G^{\Omega_{\epsilon_{n}}}(x, y) V(y) v_{\epsilon_{n}}(y)=G^{\Omega}(x, y) V(y) v(y) \quad \text { for almost all } y \in \Omega \tag{5.16}
\end{equation*}
$$

Furthermore $v_{\epsilon_{n}} \leq \mathbb{K}^{\Omega_{\epsilon_{n}}}\left[\mu_{\epsilon_{n}}\right]$ reads

$$
v_{\epsilon_{n}}(y) \leq c \phi_{\epsilon_{n}}(y) \int_{\partial \Omega_{n}} \frac{\mu_{\epsilon_{n}}(z) d S(z)}{|y-z|^{2}} .
$$

In order to go to the limit in the expression

$$
\begin{equation*}
L_{n}:=\mathbb{G}^{\Omega_{\epsilon_{n}}}\left[V v_{\epsilon_{n}}\right](x)=\int_{\Omega} \chi_{\Omega_{\epsilon_{n}}}(y) G^{\Omega_{\epsilon_{n}}}(x, y) V(y) v_{\epsilon_{n}}(y) d y \tag{5.17}
\end{equation*}
$$

we may assume that $x \in \Omega_{\epsilon_{1}}$ where $0<\epsilon_{1} \leq \epsilon_{0}$ is fixed and write $\Omega=\Omega_{\epsilon_{1}} \cup \Omega_{\epsilon_{1}}^{\prime}$ where

$$
\Omega_{\epsilon_{1}}^{\prime}=\Omega \backslash \Omega_{\epsilon_{1}}:=\left\{x \in \Omega: \operatorname{dist}(x, \partial \Omega) \leq \epsilon_{1}\right\}
$$

and $L_{n}=M_{n}+P_{n}$ where

$$
\begin{equation*}
M_{n}=\int_{\Omega_{\epsilon_{1}}} \chi_{\Omega_{\epsilon_{n}}}(y) G^{\Omega_{\epsilon_{n}}}(x, y) V(y) v_{\epsilon_{n}}(y) d y \tag{5.18}
\end{equation*}
$$

and

$$
\begin{equation*}
P_{n}=\int_{\Omega_{\epsilon_{1}}^{\prime}} \chi_{\Omega_{\epsilon_{n}}}(y) G^{\Omega_{\epsilon_{n}}}(x, y) V(y) v_{\epsilon_{n}}(y) d y \tag{5.19}
\end{equation*}
$$

Since

$$
\begin{aligned}
\chi_{\Omega_{\epsilon_{1}}}(y) G^{\Omega_{\epsilon_{n}}}(x, y) V(y) v_{\epsilon_{n}}(y) & \leq c \chi_{\Omega_{\epsilon_{1}}}(y)|\ln (|x-y|)| V(y) v_{\epsilon_{n}}(y) \\
& \leq c\|V\|_{L^{\infty}\left(\Omega_{\epsilon_{1}}\right)} \chi_{\Omega_{\epsilon_{1}}}(y)|\ln (|x-y|)| v_{\epsilon_{n}}(y),
\end{aligned}
$$

it follows by the dominated convergence theorem that

\lim _{n \rightarrow \infty} M_{n}=\int_{\Omega_{\epsilon_{1}}} G^{\Omega}(x, y) V(y) v(y) d y \tag{5.20}
\end{equation*}
$$

Let $E \subset \Omega$ be a Borel subset. Then $G^{\Omega_{\epsilon_{n}}}(x, y) \leq c(x) \phi_{\epsilon_{n}}(y)$ if $y \in \Omega_{\epsilon_{1}}^{\prime}$. By Fubini,

\int_{\Omega_{\epsilon_{1}}^{\prime} \cap E} \chi_{\Omega_{\epsilon_{n}}}(y) G^{\Omega_{\epsilon_{n}}(x, y) V(y) v_{\epsilon_{n}}(y) d y} & \leq c c(x) \int_{\partial \Omega_{n}}\left(\int_{\Omega_{\epsilon_{1}} \cap E} \chi_{\Omega_{\epsilon_{n}}}(y) \frac{\phi_{\epsilon_{n}}^{2}(y) V(y)}{|y-z|^{2}} d y\right) \mu_{\epsilon_{n}}(z) d S(z) \\
& \leq c c(x) \max _{z \in \partial \Omega_{\epsilon_{n}}} \int_{\Omega_{\epsilon_{1}}^{\prime} \cap E} \chi_{\Omega_{\epsilon_{n}}}(y) \frac{\phi_{\epsilon_{n}}^{2}(y) V(y)}{|y-z|^{2}} d y \tag{5.21}
\end{align*}
$$

If $y \in \Omega_{\epsilon_{n}} \cap E$, there holds $\phi(y)=\phi_{\epsilon_{n}}(y)+\epsilon_{n}$. If $z \in \partial \Omega_{\epsilon_{n}} \cap E$ and we denote by $\sigma(z)$ the projection of $z$ onto $\partial \Omega$, there holds $|y-\sigma(z)| \leq|y-z|+\epsilon_{n}$. By monotonicity

$$
\begin{equation*}
\frac{\phi_{\epsilon_{n}}(y)}{|y-z|} \leq \frac{\phi_{\epsilon_{n}}(y)+\epsilon_{n}}{|y-z|+\epsilon_{n}} \leq \frac{\phi(y)}{|y-\sigma(z)|}, \tag{5.22}
\end{equation*}
$$

thus

$$
\begin{equation*}
\int_{\Omega_{\epsilon_{1}}^{\prime} \cap E} \chi_{\Omega_{\epsilon_{n}}}(y) G^{\Omega_{\epsilon_{n}}}(x, y) V(y) v_{\epsilon_{n}}(y) d y \leq c c(x) \max _{z \in \partial \Omega} \int_{\Omega_{\epsilon_{1}}^{\prime} \cap E} \chi_{\Omega_{\epsilon_{n}}}(y) \frac{\phi^{2}(y) V(y)}{|y-z|^{2}} d y \tag{5.23}
\end{equation*}
$$

By (2.19) this last integral goes to zero if $\left|\Omega_{\epsilon_{1}}^{\prime} \cap E \cap \Omega_{\epsilon_{n}}\right| \rightarrow 0$. Thus by Vitali's theorem, the sequence of functions $\left\{\chi_{\Omega_{\epsilon_{n}}}(.) G^{\Omega_{\epsilon_{n}}}(x, .) V(y) v_{\epsilon_{n}}(.)\right\}_{n \in \mathbb{N}}$ is uniformly integrable in $y$, for any $x \in \Omega$. It implies that

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \int_{\Omega} \chi_{\Omega_{\epsilon_{n}}}(y) G^{\Omega_{\epsilon_{n}}}(x, y) V(y) v_{\epsilon_{n}}(y) d y=\int_{\Omega} G^{\Omega}(x, y) V(y) v(y) d y \tag{5.24}
\end{equation*}
$$

and there holds $v+\mathbb{G}[V v]=\mathbb{K}[\mu]$. Since $u=m_{\epsilon} v_{\epsilon}$ in $\Omega$ and $m_{\epsilon} \rightarrow \infty$, we get a contradiction since it would imply $u \equiv \infty$.

In order to deal with the case $N \geq 3$ we introduce an additionnal assumption of stability.
Theorem 5.9 Assume $N \geq 3$. Let $V \in L_{\text {loc }}^{\infty}(\Omega), V \geq 0$ such that

\begin{equation*}
\lim _{\substack{E \text { Borel } \\|E| \rightarrow 0}} \int_{E} V(y) \frac{(\phi(y)-\epsilon)_{+}^{2}}{|y-z|^{N}} d y=0 \quad \text { uniformly with respect to } z \in \Sigma_{\epsilon} \text { and } \epsilon \in\left(0, \epsilon_{0}\right] \text {. } \tag{5.25}
\end{equation*}
$$

If $u$ is a positive solution of $(5.3)$, then $\mathcal{R}(u)=\partial \Omega$.
Proof. We proceed as in Theorem 5.8. All the relations (5.10)-(5.20) are valid and (5.21) has to be replaced by

$$
\begin{equation*}
\int_{\Omega_{\epsilon_{1}}^{\prime} \cap E} \chi_{\Omega_{\epsilon_{n}}}(y) G^{\Omega_{\epsilon_{n}}}(x, y) V(y) v_{\epsilon_{n}}(y) d y \leq c c(x) \max _{z \in \Sigma_{\epsilon_{n}}} \int_{\Omega_{\epsilon_{1}}^{\prime} \cap E} \chi_{\Omega_{\epsilon_{n}}}(y) \frac{\phi_{\epsilon_{n}}^{2}(y) V(y)}{|y-z|^{N+1}} d y \tag{5.26}
\end{equation*}
$$

Since (5.22) is no longer valid, (5.22) is replaced by

$$
\begin{equation*}
\int_{\Omega_{\epsilon_{1}}^{\prime} \cap E} \chi_{\Omega_{\epsilon_{n}}}(y) G^{\Omega_{\epsilon_{n}}}(x, y) V(y) v_{\epsilon_{n}}(y) d y \leq c c(x) \max _{z \in \Sigma_{\epsilon_{n}}} \int_{E} V(y) \frac{\left(\phi(y)-\epsilon_{n}\right)_{+}^{2}}{|y-z|^{N+1}} d y \tag{5.27}
\end{equation*}
$$

By (5.25) the left-hand side of (5.27) goes to zero when $|E| \rightarrow 0$, uniformly with respect to $\epsilon_{n}$. This implies that (5.24) is still valid and the conclusion of the proof is as in Theorem 5.8.

Remark. A simpler statement which implies (5.25) is the following.

\lim _{\delta \rightarrow 0} \int_{0}^{\delta}\left(\int_{B_{r}(z)} V(y)(\phi(y)-\epsilon)_{+}^{2} d y\right) \frac{d r}{r^{N+1}}=0 \tag{5.28}
\end{equation*}

uniformly with respect to $0<\epsilon \leq \epsilon_{0}$ and to $z \in \Sigma_{\epsilon}$. The proof is similar to the one of Proposition 2.7.

Remark. When the function $V$ depends essentially of the distance to $\partial \Omega$ in the sense that

|V(x)| \leq v(\phi(x)) \quad \forall x \in \Omega, \tag{5.29}
\end{equation*}
$$

and $v$ satisfies

$$
\begin{equation*}
\int_{0}^{a} t v(t) d t<\infty \tag{5.30}
\end{equation*}
$$

Marcus and Véron proved [28, Lemma 7.4] that $\mathcal{R}(u)=\partial \Omega$, for any positive solution $u$ of (5.3). This assumption implies also (5.25). The proof is similar to the one of Proposition 2.8.

### 5.3 The sweeping method

This method introduced in [32] for analyzing isolated singularities of solutions of semilinear equations has been adapted in [25] and [29] for defining an extended trace of positive solutions of differential inequalities in particular in the super-critical case. Since the boundary trace of a positive solutions of (5.3) is known on $\mathcal{R}(u)$ we shall study the sweeping with measure concentrated on the singular set $\mathcal{S}(u)$

Proposition 5.10 Let $u \in C(\Omega)$ be a positive solution of (5.3) with singular boundary set $\mathcal{S}(u)$. If $\mu \in \mathfrak{M}_{+}(\mathcal{S}(u))$ we denote $v_{\mu}=\inf \left\{u, u_{\mu}\right\}$. Then

$$
\begin{equation*}
-\Delta v_{\mu}+V(x) v_{\mu} \geq 0 \quad \text { in } \Omega, \tag{5.31}
\end{equation*}
$$

and $v_{\mu}$ admits a boundary trace $\gamma_{u}(\mu) \in \mathfrak{M}_{+}(\mathcal{S}(u))$. The mapping $\mu \mapsto \gamma_{u}(\mu)$ is nondecreasing and $\gamma_{u}(\mu) \leq \mu$.

Proof. By [33], (5.31) holds. But $V u_{\mu} \in L_{\phi}^{1}(\Omega) \Longrightarrow V v_{\mu} \in L_{\phi}^{1}(\Omega)$, if we set $w:=\mathbb{G}\left[V v_{\mu}\right]$, then $v_{\mu}+w$ is nonnegative and super-harmonic, thus it admits a boundary trace in $\mathfrak{M}_{+}(\partial \Omega)$ that we denote by $\gamma_{u}(\mu)$. Clearly $\gamma_{u}(\mu) \leq \mu$ since $v_{\mu} \leq u_{\mu}$ and $\gamma_{u}(\mu)$ is nondeacreasing with $\mu$ as $\mu \mapsto u_{\mu}$ is. Finally, since $v_{\mu}$ is a supersolution, it is larger that the solution of (5.3) with the same boundary trace $\gamma_{u}(\mu)$, and there holds

$$
\begin{equation*}
u_{\gamma_{u}(\mu)} \leq v_{\mu} . \tag{5.32}
\end{equation*}
$$

Proposition 5.11 Let

$$
\begin{equation*}
\nu_{S}(u):=\sup \left\{\gamma_{u}(\mu): \mu \in \mathfrak{M}_{+}(\mathcal{S}(u))\right\} . \tag{5.33}
\end{equation*}
$$

Then $\nu_{S}(u)$ is a Borel measure on $\mathcal{S}(u)$.
Proof. We borrow the proof to Marcus-Véron [29], and we naturally extend any positive Radon measure to a positive bounded and regular Borel measure by using the same notation. It is clear that $\nu_{S}(u):=\nu_{S}$ is an outer measure in the sense that

\nu_{S}(\emptyset)=0, \text { and } \nu_{S}(A) \leq \sum_{k=1}^{\infty} \nu\left(A_{k}\right), \text { whenever } A \subset \bigcup_{k=1}^{\infty} A_{k} . \tag{5.34}
\end{equation*}
$$

Let $A$ and $B \subset \mathcal{S}(u)$ be disjoint Borel subsets. In order to prove that

\nu_{S}(A \cup B)=\nu_{S}(A)+\nu_{S}(B), \tag{5.35}
\end{equation*}
$$

we first notice that the relation holds if $\max \left\{\nu_{S}(A), \nu_{S}(B)\right\}=\infty$. Therefore we assume that $\nu_{S}(A)$ and $\nu_{S}(B)$ are finite. For $\varepsilon>0$ there exist two bounded positive measures $\mu_{1}$ and $\mu_{2}$ such that

\gamma_{u}\left(\mu_{1}\right)(A) \leq \nu(A) \leq \gamma_{u}\left(\mu_{1}\right)(A)+\varepsilon / 2
$$

and

\gamma_{u}\left(\mu_{2}\right)(B) \leq \nu(B) \leq \gamma_{u}\left(\mu_{2}\right)(B)+\varepsilon / 2
$$

Hence

\begin{aligned}
\nu_{S}(A)+\nu_{S}(B) & \leq \gamma_{u}\left(\mu_{1}\right)(A)+\gamma_{u}\left(\mu_{2}\right)(B)+\varepsilon \\
& \leq \gamma_{u}\left(\mu_{1}+\mu_{2}\right)(A)+\gamma_{u}\left(\mu_{1}+\mu_{2}\right)(B)+\varepsilon \\
& =\gamma_{u}\left(\mu_{1}+\mu_{2}\right)(A \cup B)+\varepsilon \\
& \leq \nu_{S}(A \cup B)+\varepsilon .
\end{aligned}
$$

Therefore $\nu_{S}$ is a finitely additive measure. If $\left\{A_{k}\right\}(k \in \mathbb{N})$ is a sequence of of disjoint Borel sets and $A=\cup A_{k}$, then

$$
\nu_{S}(A) \geq \nu_{S}\left(\bigcup_{1 \leq k \leq n} A_{k}\right)=\sum_{k=1}^{n} \nu_{S}\left(A_{k}\right) \Longrightarrow \nu_{S}(A) \geq \sum_{k=1}^{\infty} \nu_{S}\left(A_{k}\right) .
$$

By (5.34), it implies that $\nu_{S}$ is a countably additive measure.
Definition 5.12 The Borel measure $\nu(u)$ defined by

\nu(u)(A):=\nu_{S}(A \cap \mathcal{S}(u))+\mu_{u}(A \cap \mathcal{R}(u)), \quad \forall A \subset \partial \Omega, A \text { Borel }, \tag{5.36}
\end{equation*}
$$

is called the extended boundary trace of $u$, denoted by $\operatorname{Tr}^{e}(u)$.
Proposition 5.13 If $A \subset \mathcal{S}(u)$ is a Borel set, then

\nu_{S}(A):=\sup \left\{\gamma_{u}(\mu)(A): \mu \in \mathfrak{M}_{+}(A)\right\} . \tag{5.37}
\end{equation*}
$$

Proof. If $\lambda, \lambda^{\prime} \in \mathfrak{M}_{+}(\mathcal{S}(u))$

$$
\inf \left\{u, u_{\lambda+\lambda^{\prime}}\right\}=\inf \left\{u, u_{\lambda}+u_{\lambda^{\prime}}\right\} \leq \inf \left\{u, u_{\lambda}\right\}+\inf \left\{u, u_{\lambda^{\prime}}\right\} .
$$

Since the three above functions admit a boundary trace, it follows that

\gamma_{u}\left(\lambda+\lambda^{\prime}\right) \leq \gamma_{u}(\lambda)+\gamma_{u}\left(\lambda^{\prime}\right) .
$$

If $A$ is a Borel subset of $\mathcal{S}(u)$, then $\mu=\mu_{A}+\mu_{A^{c}}$ where $\mu_{A}=\chi_{E} \mu$. Thus

\gamma_{u}(\mu) \leq \gamma_{u}\left(\mu_{A}\right)+\gamma_{u}\left(\mu_{A^{c}}\right),
$$

and

$$
\gamma_{u}(\mu)(A) \leq \gamma_{u}\left(\mu_{A}\right)(A)+\gamma_{u}\left(\mu_{A^{c}}\right)(A) .
$$

Since $\gamma_{u}\left(\mu_{A^{c}}\right) \leq \mu_{A^{c}}$ and $\mu_{A^{c}}(A)=0$, it follows

\gamma_{u}(\mu)(A) \leq \gamma_{u}\left(\mu_{A}\right)(A) .
$$

But $\mu_{A} \leq \mu$, thus $\gamma_{u}\left(\mu_{A}\right) \leq \gamma_{u}(\mu)$ and finally

\begin{equation*}
\gamma_{u}(\mu)(A)=\gamma_{u}\left(\mu_{A}\right)(A) . \tag{5.38}
\end{equation*}
$$

If $\mu \in \mathfrak{M}_{+}(A), \mu=\mu_{A}$, thus (5.37) follows.
Proposition 5.14 There always holds

$$
\begin{equation*}
\nu(u)\left(\mathcal{S i n g}_{V}(\Omega)\right)=0, \tag{5.39}
\end{equation*}
$$

where $\mathcal{S}_{\text {ing }}^{V}(\Omega)$ is the vanishing set of $K_{V}^{\Omega}(x,$.$) defined by (4.15).$
Proof. This follows from the fact that for any $\mu \in \mathfrak{M}_{+}(\partial \Omega)$ concentrated on $\mathcal{S}_{\text {ing }}(\Omega), u_{\mu}=0$. Thus $\gamma_{u}(\mu)=0$. If $\mu$ is a general measure, we can write $\mu=\chi_{\operatorname{sing}_{V}(\Omega)} \mu+\chi_{\left(\operatorname{sing}_{V}(\Omega) c\right.} \mu$, thus $u_{\mu}=u_{\chi_{\left(\operatorname{sing} V_{V}(\Omega)\right)^{c}} \mu}$. Because of (5.32)

$$
\gamma_{u}(\mu)\left(\mathcal{S i n g}_{V}(\Omega)\right)=\gamma_{u}\left(\chi_{\left(\operatorname{sing}_{V}^{(\Omega))^{c}}\right.} \mu\right)\left(\mathcal{S i n g}_{V}(\Omega)\right) \leq\left(\chi_{\left(\operatorname{sing}_{V}(\Omega)\right)^{c}} \mu\right)\left(\mathcal{S i n g}_{V}(\Omega)\right)=0,
$$

thus (5.39) holds.
Remark. This process for determining the boundary trace is ineffective if there exist positive solutions $u$ in $\Omega$ such that

\lim _{\delta_{\Omega}(x) \rightarrow 0} u(x)=\infty .
$$

This is the case if $\Omega=B_{R}$ and $V(x)=c(R-|x|)^{-2}(c>0)$. In this case $K_{V}^{\Omega}(x,.) \equiv 0$. For any $a>0$, there exists a radial solution of

-\Delta u+\frac{c u}{(R-|x|)^{2}}=0 \quad \text { in } B_{R} \tag{5.40}
\end{equation*}

under the form

$$
\begin{equation*}
u(r)=u_{a}(r)=a+c \int_{0}^{r} s^{1-N} \int_{0}^{s} u(t) \frac{t^{N-1} d t}{(R-t)^{2}} . \tag{5.41}
\end{equation*}
$$

Such a solution is easily obtained by fixed point, $u(0)=a$ and the above formula shows that $u_{a}$ blows up when $r \uparrow R$. We do not know if there a exist non-radial positive solutions of (5.40). More generaly, if $\Omega$ is a smooth bounded domain, we do not know if there exists a non trivial positive solution of

-\Delta u+\frac{c}{d^{2}(x)} u=0 \quad \text { in } \Omega . \tag{5.42}
\end{equation*}
$$

Theorem 5.15 Assume $V \geq 0$ and satisfies (2.19). If $u$ is a positive solution of (5.3), then $\operatorname{Tr}^{e}(u)=\nu(u)$ is a bounded measure.

Proof. Set $\nu=\nu(u)$ and asssume $\nu(\partial \Omega)=\infty$. By dichotomy there exists a decreasing sequence of relatively open domains $D_{n} \subset \partial \Omega$ such that $\bar{D}_{n} \subset D_{n-1}$, diam $D_{n}=r_{n} \rightarrow 0$ as $n \rightarrow \infty$, and $\nu\left(D_{n}\right)=\infty$. For each $n$, there exists a Radon measure $\mu_{n} \in \mathfrak{M}_{+}\left(D_{n}\right)$ such that $\gamma_{u}\left(\mu_{n}\right)\left(D_{n}\right)=n$, and

$$
u \geq v_{\mu_{n}}=\inf \left\{u, u_{\mu_{n}}\right\} \geq u_{\gamma_{u}\left(\mu_{n}\right)} .
$$

Set $m_{n}=n^{-1} \gamma_{u}\left(\mu_{n}\right)$, then $m_{n} \in \mathfrak{M}_{+}\left(D_{n}\right)$ has total mass 1 and it converges in the weak*topology to $\delta_{a}$, where $\{a\}=\cap_{n} D_{n}$. By Theorem 2.6, $u_{m_{n}}$ converges to $u_{\delta_{a}}$. Since $u \geq n u_{m_{n}}$, it follows that

$$
u \geq \lim _{n \rightarrow \infty} n u_{m_{n}}=\infty,
$$

a contradiction. Thus $\nu$ is a bounded Borel measure (and thus outer regular) and it corresponds to a unique Radon measure.
Remark. If $N=2$, it follows from Theorem 5.8 that $u=u_{\nu}$ and thus the extended boundary trace coincides with the usual boundary trace. The same property holds if $N \geq 3$, if (5.25) holds.

## A Appendix: A necessary condition for the fine regularity of a boundary point with respect to a Schrödinger equation

by Alano Anconat

This appendix is devoted to the derivation of a sufficient condition -stated in Theorem A. 1 below (section A1)- for the fine singularity of a boundary point of a Lipschitz domain with respect to a potential $V$. This theorem answers a question communicated by Moshe Marcus and Laurent Véron to the author -and related to the work [30] by Marcus and Véron-. The expounded proof goes back to the unpublished manuscript [6]. In a forthcoming paper other criterions for fine regularity will be given - in particular a simple explicit necessary and sufficient condition for the fine regularity of a boundary point and a criteria for having almost everywhere regularity in a subset of the boundary.

The exposition can be read independently of the above paper of L. Véron and C. Yarur. The few notions necessary to the statement of Theorem A. 1 are recalled in section ?? Section A2 is devoted to some known basic preliminary results and the proof of Theorem A. 1 is given in section A3.

## A. 1 Framework, notations and main result

Let $\Omega$ be a bounded Lipschitz domain in $\mathbb{R}^{N}$. Denote $\delta_{\Omega}(x):=d\left(x ; \mathbb{R}^{N} \backslash \Omega\right)$ the distance from $x$ to the complement of $\Omega$ in $\mathbb{R}^{N}$ and for $a>0$, let $\mathcal{V}(\Omega, a)$ denote the set of all nonnegative

[^1]measurable function $V: \Omega \rightarrow \mathbb{R}$ such that $V(x) \leq a /\left(\delta_{\Omega}(x)\right)^{2}$ in $\Omega$. We also let $x_{0}$ to denote a fixed reference point in $\Omega$.

For $V \in \mathcal{V}(a, \Omega)$, we will consider the Schrödinger operator $L_{V}:=\Delta-V$ associated with the potential $V$. Here $\Delta$ is the classical Laplacian in $\mathbb{R}^{N}$.
The kernels $K_{y}, \tilde{K}_{y}^{V}$ and $K_{y}^{V}$. It is well known $\left.\left.(22], 23\right]\right)$ that to each point $y \in \partial \Omega$ corresponds a unique positive harmonic function $K_{y}$ in $\Omega$ that vanishes on $\partial \Omega$ and satisfies the normalization condition $K_{y}\left(x_{0}\right)=1$. This function is the Martin kernel w.r. to the Laplacian in $\Omega$ with pole at $y$ and normalized at $x_{0}$. It may also be seen as a Poisson kernel with respect to $\Delta$ in $\Omega$.
The function $K_{y}$ is obviously superharmonic in $\Omega$ with respect to $L_{V}$ and we may hence consider its greatest $L_{V}$-harmonic minorant $\tilde{K}_{y}^{V}$ in $\Omega$ defining hence another kernel function at $y$.

By the results in [4] (see paragraph A2 below) it is also known that for each $y \in \partial \Omega$ there exists a unique positive $L_{V}$-harmonic function $K_{y}^{V}$ in $\Omega$ that vanishes on $\partial \Omega \backslash\{y\}$ and satisfies $K_{y}^{V}\left(x_{0}\right)=1$. Thus $\tilde{K}_{y}^{V}=c_{y} K_{y}^{V}$ with $c_{y}=\tilde{K}_{y}^{V}\left(x_{0}\right)$. Here a function $u: \Omega \rightarrow \mathbb{R}$ is $L_{V}$-harmonic if $u$ is the continuous representative of a weak solution $u$ of $L_{V}(u)=0$ (so $u \in H_{l o c}^{1}(\Omega)$ by assumption and necessarily $u \in W_{l o c}^{2, p}(\Omega)$ for all $\left.p<\infty\right)$.

The set of "finely" regular boundary points with respect to $L_{V}$ in $\Omega$ is

$$
\begin{equation*}
\mathcal{R}_{e g_{V}}(\Omega):=\left\{y \in \partial \Omega ; \tilde{K}_{y}^{V}>0\right\}=\left\{y \in \partial \Omega ; c_{y}>0\right\} \tag{A.1}
\end{equation*}
$$

-since $c$ is u.s.c. this is a $K_{\sigma}$ subset of $\partial \Omega$ - and the set of "finely" irregular boundary points is $\mathcal{S}_{i n g_{V}}(\Omega):=\partial \Omega \backslash \mathcal{R}_{e g_{V}}(\Omega)$. These notions were introduced by E. B. Dynkin in his study of positive solutions in $\Omega$ of a non linear equation such as $\Delta u=u^{q}, q>1$-in which case, given $u$, we recover Dynkin's definition on taking $V=|u|^{q-1}$. See the books [16], [17] of E. B. Dynkin and the references there. From the probabilistic point of view, a boundary point $y \in \partial \Omega$ is $L_{V}$ finely regular iff for the Brownian motion $\left\{\xi_{s}\right\}_{0 \leq s<\tau}$ starting say at $x_{0}$ and conditioned to exit from $\Omega$ at $y$, it holds that $\int_{0}^{\tau} V\left(\xi_{s}\right) d s<+\infty$ a.s., or in other words, iff the probability for this process to reach $y$ when killed at the rate $e^{-V\left(\xi_{s}\right) d s}$ is strictly positive.

Let us now state Theorem A.1. It answers the question (2005) of Marcus-Véron alluded to above: suppose that for sufficiently many Lipschitz path (resp. every linear path) $\gamma:[0, \eta] \rightarrow \bar{\Omega}$ such that $\gamma(0)=y$ and $d(\gamma(t), \partial \Omega) \geq c|\gamma(t)-y|$ for $0 \leq t \leq \eta$ and some $c>0$, it holds that

$$
\int_{0}^{\eta} t V(\gamma(t)) d t=+\infty
$$

does it follow that $y$ is finely singular w.r. to $V$ and $\Omega$ ?
Theorem A. 1 Let $y \in \partial \Omega$ and let $C_{\epsilon, y}:=\left\{x \in \Omega ; \delta_{\Omega}(x) \geq \varepsilon d(x, y)\right\}$ for $0<\varepsilon<1$. If

$$
\begin{equation*}
\int_{C_{\epsilon, y}} V(x) \frac{d x}{|x-y|^{N-2}}=+\infty \tag{A.2}
\end{equation*}
$$

for some $\varepsilon>0$, then $y \in \mathcal{S}_{i n g_{V}}(\Omega)$.

## A. 2 Boundary Harnack principle for $L_{V}$

To prove Theorem A. 1 we will rely on the main result of [4] (see also [5]) in well-known forms more or less explicit in [ $\left[\right.$ ] (see e.g. Theorem $5^{\prime}$ and Corollary 27 there) or [5]. In this section we state these needed ancillary results and fix some notations to be used in what follows.

Fix positive reals $r, \rho>0$ such that $0<10 r<\rho$ and let $f$ be a $\frac{\rho}{10 r}$ lipschitz function in the ball $B_{N-1}(0, r)$ of $\mathbb{R}^{N-1}$ - we let $B_{N-1}(m, s)$ to denote the ball in $\mathbb{R}^{10 r}$-1 of center $m$ and radius $r-$. Define then the region $U_{f}(r, \rho)$ in $\mathbb{R}^{N}$ as follows

$$
\begin{equation*}
U_{f}(r, \rho):=\left\{\left(x^{\prime}, x_{N}\right) \in \mathbb{R}^{N-1} \times \mathbb{R} \simeq \mathbb{R}^{N} ;\left|x^{\prime}\right|<r, f\left(x^{\prime}\right)<x_{N}<\rho\right\} \tag{A.3}
\end{equation*}
$$

We will also denote it $U$ (leaving $f, r$ and $\rho$ implicit) when convenient. Set $\partial_{\#} U:=\partial U \cap\{x=$ $\left.\left(x^{\prime}, x_{N}\right) \in \mathbb{R}^{N} ;\left|x^{\prime}\right| \leq r, x_{N}=f\left(x^{\prime}\right)\right\}$ and define $T(t):=B_{N-1}(0 ; t r) \times(-t \rho,+t \rho)$.

Recall $\mathcal{V}_{a}(U)$ is the set of all Borel nonnegative functions $V$ in $U$ such that $V(x) \leq \frac{a}{\delta(x)^{2}}$ for $x \in U$. For $V$ Hölder continuous (in fact for a natural class of second order elliptic operators) the following statement goes back to [2]. See also [13] for $V=0$.

Lemma A. 2 Let $V \in \mathcal{V}_{a}(U)$ and set $L_{V}:=\Delta-V$. There is a constant $C$ depending only on $N$, $a$ and $\frac{\rho}{r}$ such that for any two positive $L_{V}$-harmonic functions $u$ and $v$ in $U$ that vanish on $\partial_{\#} U$,

$$
\begin{equation*}
\frac{u(x)}{u(A)} \leq C \frac{v(x)}{v(A)} \quad \text { for all } x \in U \cap T\left(\frac{1}{2}\right) \tag{A.4}
\end{equation*}
$$

where $A=A_{U}=\left(0, \ldots, 0, \frac{\rho}{2}\right)$.
Proof. Let us briefly recall -for readers convenience- how this lemma follows from Theorem 1 in (4. By homogeneity we may assume that $r=1$ and that $\rho$ is fixed. Let $A^{\prime}=\left(0, \ldots, 0, \frac{2 \rho}{3}\right)$ and let $B_{N}$ denote the open ball $B_{N}(0,1)$ in $\mathbb{R}^{N}$. It is easy to construct a bi-Lipschitz map $F$ : $U \rightarrow B_{N}(0,1)$ with a bi-lipschitz constant depending only on $\rho$ and $N$ and which maps $A^{\prime}$ onto $0, U \cap T(1 / 2)$ onto $B_{N}^{-}:=\left\{x \in B_{N} ; x_{N}<-\frac{1}{2}\right\}$ and $U \backslash T\left(\frac{3}{4}\right)$ onto $B_{N}^{+}:=\left\{x \in B_{N} ; x_{N} \geq \frac{1}{2}\right\}$.

Standard calculations show that if $u$ is $\Delta-V$ harmonic in $U$ then the function $u_{1}:=$ $u \circ F^{-1}$ is $L_{1}-V \circ F^{-1}$ harmonic in $B_{N}$ for some (symmetric) divergence form elliptic operator $L_{1}=\sum_{i, j} \partial_{i}\left(a_{i j} \partial_{j}\right)$ in $B_{N}$ satisfying $C_{1}^{-1} I_{N} \leq\left\{a_{i j}\right\} \leq C_{1} I_{N}$ with $C_{1}=C_{1}\left(N, \frac{r}{\rho}\right) \geq 1$. Let $V_{1}=V \circ F_{1}^{-1}$. Clearly $V_{1} \in \mathcal{V}\left(B_{N}, a^{\prime}\right)$ for $a^{\prime}=C^{2} a$.

Other simple calculations show that the operator $\mathcal{L}=(1-|x|)^{2}\left(L_{1}-V_{1}\right)$ seen as a map $H_{l o c}^{1}\left(B_{N}\right) \rightarrow H_{l o c}^{-1}\left(B_{N}\right)$ is an adapted elliptic operator in divergence form over the hyperbolic ball $B_{N}$ (i.e. w.r. to the hyperbolic metric $d s^{2}=\frac{|d x|^{2}}{\left(1-|x|^{2}\right)^{2}}$ ) in the sense of [4]. Moreover since the form $\varphi \mapsto \int_{B_{N}} a_{i j} \partial_{i} \varphi \partial_{j} \varphi d x-\varepsilon_{0} \int_{B_{N}} \frac{\varphi^{2}}{(1-|x|)^{2}} d x$ is coercive for $\varepsilon_{0}=\varepsilon_{0}\left(C_{1}, N\right)>0$ chosen sufficiently small, the differential operator $\mathcal{L}$ is weakly coercive which means that there exists $\varepsilon_{0}=\varepsilon_{0}\left(N, \frac{r}{\rho}\right)>0$ such that $\mathcal{L}+\varepsilon_{0}$ admits a Green's function in $B_{N}$.

This shows that Theorem 1 in (4) applies to $\mathcal{L}$. Thus there is a constant $c=c\left(\varepsilon_{0}, C_{1}, N\right)$, $c \geq 1$, such that for $z=\left(z^{\prime}, z_{N}\right) \in B_{N}^{+}$and $y \in B_{N}^{-}$one has

$$
\begin{equation*}
c^{-1} G_{\mathcal{L}}(y, z) \leq G_{\mathcal{L}}(y, 0) G_{\mathcal{L}}(0, z) \leq c G_{\mathcal{L}}(y, z) \tag{A.5}
\end{equation*}
$$

Here we have also used the standard Harnack inequalities for $\mathcal{L}$ and have denoted $G_{\mathcal{L}}$ the $\mathcal{L}$ Green's function in $B_{N}$ w.r. to the hyperbolic metric (we adopt the notational convention that $u(x):=G_{\mathcal{L}}(x, y)$ satisfies $\mathcal{L} u=-\delta_{x}$ in the weak sense 33] w.r. to the hyperbolic volume). Notice that $G_{\mathcal{L}}(x, y)=\delta(y)^{N-2} g(x, y)$ if $g$ is Green's function of $L_{1}-V_{1}$ in $B_{N}$ (w.r. to the usual metric).

Supppose that $u_{1}$ is positive $\mathcal{L}$ harmonic (i.e. $L_{1}-V_{1}$ harmonic) in $B_{N}$ and that $u_{1}$ vanishes on $\partial B_{N} \cap\left\{x \in \partial B_{N} ; x_{N} \leq \frac{1}{2}\right\}$. Then $u_{1}$ can be represented as a Green potential in $B_{N} \cap\left\{x ; x_{N}<\right.$ $\left.\frac{1}{2}\right\}: u_{1}(y)=\int G_{\mathcal{L}}(y, z) d \nu(z)$ where $\nu$ is a nonnegative Borel measure on $\left\{z \in B_{N} ; z_{N}=\frac{1}{2}\right\}$ and $y_{N} \leq \frac{1}{2}$. So upon integrating (A.5 we get (with another constant $c$ )

$$
\begin{equation*}
c^{-1} u_{1}(y) \leq u_{1}(0) g(y, 0) \leq c u_{1}(y) \tag{A.6}
\end{equation*}
$$

for $y \in B_{N}^{-}$. Thus if $u$ is a positive $L_{V}$ solution in $U$ that vanishes in $\partial_{\#} U$ it follows -on using the change of variable $y=F(x)-$ that

$$
\begin{equation*}
c^{-1} u(x) \leq u\left(A^{\prime}\right) G\left(x, A^{\prime}\right) \leq c u(x) \tag{A.7}
\end{equation*}
$$

for $x \in U\left(\frac{1}{2}\right)$, where $G$ is Green's function w.r. to $L_{V}$ in $U$. Using Harnack inequalities for $L_{V}$, the lemma easily follows.

Remark. Using Lemma A.2, well known arguments (see [2]) show that for every bounded Lipschitz domain $\Omega$ in $\mathbb{R}^{N}$ and every $V \in \mathcal{V}(\Omega, a), a>0$, the following potential theoretic properties hold in $\Omega$ equipped with $L_{V}:=\Delta-V$ (we let $G_{y}^{V}$ to denote the $L_{V}$ Green's function in $\Omega$ with pole at $y$ ): (a) For each $P \in \partial \Omega$, the limit $K_{P}^{V}(x)=\lim _{y \rightarrow P} G_{y}^{V}(x) / G_{y}^{V}\left(x_{0}\right), x \in \Omega$, exists and $K_{P}^{L}$ is a positive $L_{V}$-harmonic function $K_{P}^{L}$ in $\Omega$ which depends continuously on $P$ and vanishes continuously in $\partial \Omega \backslash\{P\}$, (b) For each $P \in \partial \Omega$, every positive $L_{V}$-solution in $\Omega$ that vanishes on $\partial \Omega \backslash\{P\}$ is proportional to $K_{P}^{V}, \quad(c)$ Every positive $L_{V}$-solution $u$ in $\Omega$ can be written in a unique way as $u(x)=\int_{\partial \Omega} K_{P}^{V}(x) d \mu(P), x \in \Omega$, for some positive (finite) measure $\mu$ in $\partial \Omega$. See (4).

## A. 3 Proof of Theorem A. 1

Again $\Omega$ is a bounded Lipschitz domain in $\mathbb{R}^{N}$ and $V \in \mathcal{V}(\Omega, a), a \geq 0$.
For the proof we use a simple variant of the comparison principle given in Lemma A.2. Notations are as before, in particular $U=U_{f}(r, \rho)$ is the domain considered in A2 and $A=$ $A_{U}=\left(0, \ldots, 0, \frac{\rho}{2}\right)$. Let $A^{\prime}=\left(0, \ldots, 0, \frac{2 \rho}{3}\right)$.

Lemma A. 3 Let $u$ be positive harmonic (w.r. to $\Delta$ ) in $U$, let $v$ be positive $\Delta-V$-harmonic in $U$ and assume that $u=v=0$ in $\partial_{\#} U$. Then

$$
\begin{equation*}
\frac{v(x)}{v(A)} \leq c \frac{u(x)}{u(A)} \quad \text { for } \quad x \in U \cap T\left(\frac{1}{2}\right) \tag{A.8}
\end{equation*}
$$

for some positive constant $c$ depending only on $\rho / r$, the constant a and $N$.
Proof. We have seen that $v(x) \leq c v\left(A^{\prime}\right) G_{A^{\prime}}^{V}(x)$ in $U \cap T\left(\frac{1}{2}\right)$ and we know that $G_{A}^{V} \leq G_{A}^{0}$ in $U$ if $G_{A^{\prime}}^{V}$ is $(\Delta-V)$-Green's function in $U$ with pole at $A^{\prime}$. By maximum principle, Harnack
inequalities and the known behavior of $G_{A^{\prime}}^{0}$ in $B\left(A^{\prime}, \frac{r}{4}\right)$ (more precisely $G_{A}^{0}(x) \leq c_{1}:=c_{1}(r, N)$ in $\partial B\left(A^{\prime}, \frac{r}{4}\right)$ ) we have that $u(x) \geq c_{1} v(A) G_{A^{\prime}}^{0}(x)$ in $U \backslash B\left(A^{\prime}, \frac{r}{4}\right)$. So that -using Harnack inequalities in $B\left(A^{\prime}, \frac{r}{2}\right)$ for $u$ and $v$ - the lemma follows.
Remark. The opposite estimate, i.e. $\frac{u(x)}{u(A)} \leq C \frac{v(x)}{v(A)}$ (with another constant $C>0$ ), cannot be expected to hold in general as shown by simple (and obvious) examples.
Denote $g_{x_{0}}^{V}$ the Green's function with respect to $\Delta-V$ in $\Omega$ and with pole at $x_{0}$. For $y \in \partial \Omega$, a pseudo-normal for $\Omega$ at $y$ is a unit vector $\nu \in \mathbb{R}^{N}$ such that that for some small $\eta>0$, the set $C\left(y, \nu_{y}, \eta\right):=\left\{y+t\left(\nu_{y}+v\right) ; 0<t<\eta,\|v\| \leq \eta\right\}$ is contained in $\Omega$.

Proposition A. 4 Given $y \in \partial \Omega$ and a pseudo-normal $\nu_{y}$ at $y$ for $U$, the following assertions are equivalent:
(i) $\tilde{K}_{y}^{V}=0$ (i.e. $y \in \mathcal{S}_{\text {ing }_{V}}(\Omega)$ )
(ii) $\lim \sup _{t \downarrow 0} K_{y}^{V}\left(y+t \nu_{y}\right) / K_{y}\left(y+t \nu_{y}\right)=+\infty$
(iii) $\lim _{t \downarrow 0} K_{y}^{V}\left(y+t \nu_{y}\right) / K_{y}\left(y+t \nu_{y}\right)=+\infty$
(iv) $\lim _{x \rightarrow y} g_{x_{0}}^{V}(x) / g_{x_{0}}^{0}(x)=0$.

Proof. (a) We first recall a standard consequence of Lemma A. 2 that relates $g_{x_{0}}^{V}$ and $K_{y}^{V}$ near $y$ (for any $y \in \partial \Omega$ ).

Consider $u=K_{y}^{V}$ and $v:=g_{y+t \nu_{y}}^{V}$. Using Lemma A.2 and the fact that $v \sim t^{2-N}$ in $\partial B\left(y+t \nu_{y}, \frac{\eta}{2} t\right), 0<t<\eta$, we see that $u(x) \sim u\left(y+t \nu_{y}\right) t^{N-2} g_{y+t \nu_{y}}^{V}(x)$ for $x \in \Omega \backslash B\left(y+t \nu_{y}, t \eta / 2\right)$ (here $\sim$ means "is in between two constant times " with constants depending only on $y, \Omega, \nu_{y}$ and $a$ ).

Taking in particular $x=x_{0}$ we obtain that $K_{y}^{V}\left(y+t \nu_{y}\right) \sim 1 /\left(t^{N-2} g^{V}\left(y+t \nu_{y} ; x_{0}\right)\right)$. In particular considering the special case $V=0$, we get also that $K_{y}\left(y+t \nu_{y}\right) \sim 1 /\left(t^{N-2} g(y+\right.$ $\left.t \nu_{y} ; x_{0}\right)$ ).
(b) Using the above we see that (ii) is equivalent to (iv)': $\liminf _{t \downarrow 0} g_{x_{0}}^{V}\left(y+t \nu_{y}\right) / g_{x_{0}}^{0}\left(y+t \nu_{y}\right)=$ 0.
(c) Now to show that $(i v)$ and $(i v)^{\prime}$ are equivalent we may assume that $y=0, \nu_{y}=$ $(0, \ldots, 0,1)$ and (with the notations above in A.2) that $T(1) \cap \Omega=U, U=U_{f}(r, \rho)$ and $x_{0} \in \Omega \backslash \bar{U}$.

Applying Lemma A.3 to $U, u=g_{x_{0}}^{V}, v=g_{x_{0}}$, and $U_{t}=U_{t_{j}}$ for a sequence $t_{j}, t_{j} \downarrow 0$ such that $u\left(A_{t_{j}}\right)=o\left(v\left(A_{t_{j}}\right)\right), A_{t_{j}}=\left(0, \ldots, 0, t_{j}\right)$, we get that $u(x) \leq c \frac{u\left(A_{t_{j}}\right)}{v\left(A_{t_{j}}\right)} v(x)$ in $\Omega \cap T\left(t_{j} \frac{\rho}{2}\right)$. Hence (iv) ${ }^{\prime}$ imply (iv). And -using (a) again- conditions (ii), (iii) and (iv) are equivalent.
(d) Similarly if on the contrary $g^{V}\left(A_{j}, x_{0}\right) \geq c g\left(A_{j}, x_{0}\right)$, for some sequence $A_{j}=t_{j} \nu, t_{j} \downarrow 0$ and a positive real $c$, we have (since a priori $g^{V} \leq g$ ) that :

$$
\begin{equation*}
K_{A_{j}}^{V}(x):=g^{V}\left(A_{j}, x\right) / g^{V}\left(A_{j}, x_{0}\right) \leq c^{-1} K_{A_{j}}(x)=c^{-1} g\left(A_{j}, x\right) / g\left(A_{j}, x_{0}\right) \tag{A.9}
\end{equation*}
$$

and letting $j \rightarrow \infty$ we get $K_{y}^{V} \leq c^{-1} K_{y}$. Thus, (i) $\Rightarrow$ (iv).
Since obviously (ii) $\Rightarrow$ (i), Proposition A. 4 is proved.
The next lemma is the key for the proof of Theorem A.1. Returning again to the canonical Lipschitz domain $U=U_{f}(r, \rho)$, let $V \in \mathcal{V}_{a}(U)$ and for $\theta \in\left(0, \frac{1}{10}\right)$, let $U^{\theta}:=\{x \in U ; d(x, \partial U) \geq$ $\theta r\}, I_{U}^{\theta}:=\int_{U^{\theta}} V(x) \frac{d x}{\left|\delta_{U}(x)\right|^{N-2}}$.

Obviously $\frac{1}{r^{N-2}} \int_{U^{\theta}} V(x) d x \leq I_{U}^{\theta} \leq \frac{1}{(\theta r)^{N-2}} \int_{U^{\theta}} V(x) d x$.
Lemma A. 5 Let $u, \tilde{u}$ be two nonnegative continuous functions in $\bar{U}$ that are respectively $\Delta$ harmonic and $L_{V}$-harmonic in $U$. Assume that $\tilde{u} \leq u$ in $\partial U$ and $\tilde{u}=u=0$ in $\partial_{\#} U$. Then for some constant $c=c\left(\frac{r}{\rho}, a, \theta, N\right)>0$,

$$
\begin{equation*}
\left(1+c I_{\theta}\right) \tilde{u}(x) \leq u(x) \quad \text { for } x \in U \cap T\left(\frac{1}{2}\right) \tag{A.10}
\end{equation*}
$$

Proof. Since the assumptions and the conclusion are invariant under dilations we may assume that $r$ is fixed as well as $\rho$. Replacing $u$ by the harmonic function in $U$ with same boundary values as $\tilde{u}$ we may also assume that $u=\tilde{u}$ in $\partial U$. Since $\Delta(u-\tilde{u})=-V \tilde{u}$ and $u-\tilde{u}$ vanishes on $\partial U$, we see that $u-\tilde{u}=G_{U}(V \tilde{u})$ where $G_{U}$ is the usual Green's function in $U$.

By Harnack property and since $G_{U}(x, y) \geq c=c(\theta, a, N)>0$ for $x \in B_{1}=B\left(A_{1}, \frac{r}{100}\right)$, $A_{1}=\left(0, \ldots, 0, \frac{3 r}{4}\right)$, and $y \in U^{\theta}$, we have

$$
u(x)-\tilde{u}(x) \geq c I_{\theta} \tilde{u}\left(A_{1}\right), x \in B_{1} .
$$

Thus in $U, w(x):=u(x)-\tilde{u}(x) \geq c I_{\theta} \tilde{u}\left(A_{1}\right) R_{1}^{B_{1}}(x)$ where $R_{1}^{B_{1}}$ is the (classical) capacitary potential (15]) of $B_{1}$ in $U$ and using the comparison principle Lemma 1 for $V=0$ we have $w \geq c I_{\theta} \tilde{u}\left(\widehat{A_{1}}\right) \frac{u}{u\left(A_{1}\right)}$ in $U\left(\frac{1}{2}\right):=T\left(\frac{1}{2}\right) \cap U$.

Using then Lemma 4.2 (and Harnack inequalities)

$$
w(x) \geq c^{\prime \prime} I_{\theta} \tilde{u}\left(A_{1}\right) \frac{\tilde{u}(x)}{\tilde{u}\left(A_{1}\right)}=c^{\prime \prime \prime} I_{\theta} \tilde{u}(x), x \in U\left(\frac{1}{2}\right)
$$

Thus, $u(x) \geq\left(1+c^{\prime \prime \prime} I_{\theta}\right) \tilde{u}(x)$ in $U\left(\frac{1}{2}\right)$.

Proof of Theorem A.1. We may assume that $y=0$, that for some $r, \rho, f, \Omega \cap T(1)=U:=$ $U_{f}(r, \rho)$ (with the notation fixed above in section A2) and that $x_{0} \notin \bar{U}$.

Set $T_{n}=T\left(2^{-n}\right), C_{y}^{n}:=C_{\epsilon, y} \cap\left(T_{n} \backslash T_{n+1}\right)$ for $n \geq 1, u=G_{x_{0}}^{0}, \tilde{u}=G_{x_{0}}^{V}$ (where $G_{x_{0}}^{V}$ is Green's function with pole at $x_{0}$ with respect to $\Delta-V$ in $\Omega$ ). One may also observe that $\varepsilon$ may be assumed so small that $\Sigma_{0}^{\varepsilon}$ contains the truncated cone $C:=\left\{\left(x^{\prime}, x_{N}\right) ; x_{N}<\frac{\rho}{2},\left|x^{\prime}\right|<\frac{r}{\rho} x_{N}\right\}$.

For each $n \geq 0$ there is a greatest $\alpha_{n}>0$ such that $u \geq \alpha_{n} \tilde{u}$ in $U_{n}$ (we know that $\alpha_{n} \leq 1$ ). By the key Lemma A.5 (and elementary geometric considerations)

$$
\begin{equation*}
\alpha_{n+1} \geq \alpha_{n}\left(1+c I_{n+1}\right) \text { if } I_{m}:=\int_{C_{m}} \frac{V(x)}{\delta_{\Omega}(x)^{N-2}} d x \tag{A.11}
\end{equation*}
$$

for some constant $c=c\left(\varepsilon, \frac{r}{\rho}, a, N\right)$ independent of $n$. Thus

$$
\alpha_{n} \geq \alpha_{0} \prod_{k=1}^{n-1}\left(1+c I_{k}\right) \geq \alpha_{0}\left(1+c \sum_{k=1}^{n-1} I_{k}\right) \geq c \alpha_{0} \int_{C_{1} \backslash C_{n+1}} \frac{V(x)}{\delta_{\Omega}(x)^{N-2}} d x
$$

which shows that $\lim \alpha_{n}=+\infty$. Thus $G_{x_{0}}^{V}=o\left(G_{x_{0}}^{0}\right)$ at $y$ and by Proposition A.4 the point $y$ belongs to $\operatorname{Sing}_{V}(\Omega)$.
