# Bayesian nonparametric estimation of the spectral density of a long or intermediate memory Gaussian process

#### Abstract

A stationary Gaussian process is said to be long-range dependent (resp. anti-persistent) if its spectral density $f(\lambda)$ can be written as $f(\lambda)=|\lambda|^{-2 d} g(|\lambda|)$, where $0<d<1 / 2$ (resp. $-1 / 2<d<0$ ), and $g$ is continuous. We propose a novel Bayesian nonparametric approach for the estimation of the spectral density of such processes. Within this approach, we prove posterior consistency for both $d$ and $g$, under appropriate conditions on the prior distribution. We establish the rate of convergence for a general class of priors, and apply our results to the family of fractionally exponential priors. Our approach is based on the true likelihood function, and does not resort to Whittle's approximation, which is not valid in a long memory set-up.

Key-words: Bayesian nonparametric; consistency; FEXP priors; Gaussian long memory processes; rates of convergence


## 1 Introduction

Let $\mathbf{X}=\left\{X_{t}, t=1,2, \ldots\right\}$ be a real-valued stationary zero-mean Gaussian random process, with spectral density $f$, and covariance function $\gamma_{f}(\tau)=E\left(X_{t} X_{t+\tau}\right)$, so that

$$
\begin{equation*}
\gamma_{f}(\tau)=\int_{-\pi}^{\pi} f(\lambda) e^{i \tau \lambda} d \lambda \quad(\tau=0, \pm 1, \pm 2, \ldots) \tag{1.1}
\end{equation*}
$$

This process is long-range dependent (resp. anti-persistent) if there exist $C>0$ and a value $d, 0<d<1 / 2$ (resp. $-1 / 2<d<0$ ), such that $f(\lambda)|\lambda|^{2 d} \rightarrow C$ when $\lambda \rightarrow 0$. This may be conveniently rewritten as $f(\lambda)=\lambda^{-2 d} g(|\lambda|)$, where $g:[0, \pi] \rightarrow \mathbb{R}^{+}$is a continuous function.

Interest in long-range dependent and anti-persistent time series has increased steadily in the last fifteen years; see Beran (1994) for a comprehensive introduction and Doukhan et al. (2003) for a review of theoretical aspects and fields of applications, including telecommunications, economics, finance, astrophysics, medicine and hydrology. Research in parametric inference for long and intermediate memory processes have been pioneered by Mandelbrot and Van Ness (1968), Mandelbrot and Wallis (1969), and continued by Fox and Taqqu(1986), Dahlhaus (1989), Giraitis and Taqqu (1999), Geweke and Porter-Hudak (1983), and Beran (1993), among others. Unfortunately, parametric inference can be highly biased under mis-specification of the true model. This limitation makes semiparametric approaches particularly appealing (Robinson, 1995).

[^0]For instance, under the representation $f(\lambda)=|\lambda|^{-2 d} g(|\lambda|)$, one would like to estimate $d$ as a measure of long-range dependence, without resorting to parametric assumptions on the nuisance parameter $g$; see Liseo et al. (2001) for a Bayesian approach to this problem, and Bardet et al. (2003) for an exhaustive review of classical approaches. However, practically all the existing procedures either exploit the regression structure of the log-spectral density in a small neighborhood of the origin (Robinson, 1995), or use an approximate likelihood function based on Whittle's approximation (Whittle, 1962), where the original vector of observations $\mathbf{X}_{n}=$ $\left(X_{1}, X_{2}, \ldots, X_{n}\right)$ gets transformed into the periodogram $I(\lambda)$ computed at the Fourier frequencies $\lambda_{j}=2 \pi j / n, j=1,2, \ldots, n$, and the artificial observations $I\left(\lambda_{1}\right), \ldots, I\left(\lambda_{n}\right)$ are, under short range dependence, approximately independent. Unfortunately, Whittle's approximation is not valid in in the presence of long range dependence, at least for the smallest Fourier frequencies.

We propose a Bayesian nonparametric approach to the estimation of the spectral density of the stationary Gaussian process based on the true likelihood, without resorting to Whittle's approximation. We study the asymptotic properties of our procedure, including consistency and rates of convergence. Our study is based on standard tools for an asymptotic analysis of Bayesian approaches, e.g. Ghosal et al. (2000), i.e. quantities of interest are the prior probability of a small neighborhood around the true spectral density, and some kind of entropy measure for the prior distribution. Most technical details differ however, as the observed process is long-range dependent.

The paper is organised as follows. In Section 2, we introduce the model and the notations. In Section 3, we provide a general theorem that states sufficient conditions to ensure consistency of the posterior distribution, and of several Bayes estimators. We also introduce the class of FEXP (Fractional Exponential) priors, based on the FEXP representation of Robinson (1991), and show that such prior distributions fulfil these sufficient conditions for posterior consistency. In Section 4, we study the rate of convergence of the posterior in the general case, and specialise our results for the FEXP class. Section 5 gives the proofs of the main theorems of the two previous Sections. Section 6 discusses further research. The Appendix contains several technical lemmas.

## 2 Model and notations

The model consists of an observed vector $\mathbf{X}_{n}=\left(X_{1}, \ldots, X_{n}\right)$ of $n$ consecutive realizations from a zero-mean Gaussian stationary process, with spectral density $f$, which is either long-range dependent, short-range dependent, or anti-persistent. The likelihood function is

$$
\begin{equation*}
\varphi\left(\mathbf{X}_{n} ; f\right)=(2 \pi)^{-n / 2}\left|T_{n}(f)\right|^{-1 / 2} \exp \left\{-\frac{1}{2} \mathbf{X}_{n}^{t} T_{n}(f)^{-1} \mathbf{X}_{n}\right\} \tag{2.1}
\end{equation*}
$$

where $T_{n}(f)$ is the Toeplitz matrix associated to $\gamma_{f}$, see (1.1), i.e. $T_{n}(f)=\left[\gamma_{f}(j-k)\right]_{1 \leq j, k \leq n}$.
This model is parametrised by the pair $(d, g)$, which defines $f=F(d, g)$ through the factorisation

$$
\begin{aligned}
F:(-1 / 2,1 / 2) \times \mathcal{C}^{0}[0, \pi] & \rightarrow \mathcal{F} \\
(d, g) & \rightarrow f: f(\lambda)=|\lambda|^{-2 d} g(|\lambda|),
\end{aligned}
$$

where $\mathcal{C}^{0}[0, \pi]$ is the set of continuous functions over $[0, \pi]$, and $\mathcal{F}$ denotes the set of spectral densities, that is, the set of even functions $f:[-\pi, \pi] \rightarrow \mathbb{R}^{+}$such that $\int_{-\pi}^{\pi}|f(\lambda)| d \lambda<+\infty$.

The model is completed with a nonparametric prior distribution $\pi$ for $(d, g) \in(-1 / 2,1 / 2) \times$ $\mathcal{C}^{0}[0, \pi]$. (There should be no confusion whether $\pi$ refers to either the constant or the prior distribution in the rest of the paper.) All our results will assume that the model is valid for
some true' parameter $\left(d_{0}, g_{0}\right)$, associated to some 'true' spectral density $f_{0}=F\left(d_{0}, g_{0}\right)$, where $d_{0} \in(-1 / 2,1 / 2)$; conditions on $g_{0}$ are detailed in the next section.

We introduce several pseudo-distances on $\mathcal{F}$. The Kullback-Leibler divergence for finite $n$ is defined as

\begin{aligned}
K L_{n}\left(f_{0} ; f\right) & =\frac{1}{n} \int_{\mathbb{R}^{n}} \varphi\left(\mathbf{X}_{n} ; f_{0}\right)\left\{\log \varphi\left(\mathbf{X}_{n} ; f_{0}\right)-\log \varphi\left(\mathbf{X}_{n} ; f\right)\right\} d \mathbf{X}_{n} \\
& =\frac{1}{2 n}\left\{\operatorname{tr}\left[T_{n}\left(f_{0}\right) T_{n}^{-1}(f)-\mathbf{I}_{n}\right]-\log \operatorname{det}\left(T_{n}\left(f_{0}\right) T_{n}^{-1}(f)\right)\right\}
\end{aligned}
$$

where $\mathbf{I}_{n}$ represents the identity matrix of order $n$. Letting $n \rightarrow \infty$, we can define, when it exists, the quantity

$$
K L_{\infty}\left(f_{0} ; f\right)=\frac{1}{4 \pi} \int_{-\pi}^{\pi}\left[\frac{f_{0}(\lambda)}{f(\lambda)}-1-\log \frac{f_{0}(\lambda)}{f(\lambda)}\right] d \lambda
$$

We also define a symmetrised version of $K L_{n}$, i.e.

$$
h_{n}\left(f_{0}, f\right)=K L_{n}\left(f_{0} ; f\right)+K L_{n}\left(f ; f_{0}\right)
$$

and its limit as $n \rightarrow \infty$ :

$$
h\left(f_{0}, f\right)=\frac{1}{4 \pi} \int_{-\pi}^{\pi}\left[\frac{f_{0}(\lambda)}{f(\lambda)}+\frac{f(\lambda)}{f_{0}(\lambda)}-2\right] d \lambda=\frac{1}{2 \pi} \int_{0}^{\pi}\left(\frac{f_{0}(\lambda)}{f(\lambda)}-1\right)^{2} \frac{f(\lambda)}{f_{0}(\lambda)} d \lambda
$$

For technical reasons, we define also the pseudo-distance

$$
b_{n}\left(f_{0}, f\right)=\frac{1}{n} \operatorname{tr}\left[\left(T_{n}(f)^{-1} T_{n}\left(f_{0}-f\right)\right)^{2}\right]
$$

and its limit as $n \rightarrow+\infty$,

$$
b\left(f_{0}, f\right)=\frac{1}{4 \pi} \int_{-\pi}^{\pi}\left(\frac{f_{0}(\lambda)}{f(\lambda)}-1\right)^{2} d \lambda
$$

Finally, we consider the $L^{2}$ distance between the spectral log-densities Moulines and Soulier, 2003),

$$
\begin{equation*}
\ell\left(f_{0}, f\right)=\int_{-\pi}^{\pi}\left\{\log f_{0}(\lambda)-\log f(\lambda)\right\}^{2} d \lambda \tag{2.2}
\end{equation*}
$$

For the models considered in this paper, this distance always exists, whereas the $\mathrm{L}^{2}$ distance may not.

## 3 Consistency

We first state and prove the strong consistency of the posterior distribution under very general conditions on both $\pi$ and $f_{0}=F\left(d_{0}, g_{0}\right)$, i.e. as $n \rightarrow \infty$, and for $\varepsilon>0$ small enough,

$$
P^{\pi}\left[\mathcal{A}_{\varepsilon} \mid \mathbf{X}_{n}\right] \rightarrow 1, \quad \text { a.s. }
$$

where $P^{\pi}\left[. \mid \mathbf{X}_{n}\right]$ denotes posterior probabilities associated with the prior $\pi$, and

$$
\mathcal{A}_{\varepsilon}=\left\{(d, g) \in(-1 / 2,1 / 2) \times \mathcal{C}^{0}[0, \pi]: h\left(f_{0}, F(d, g)\right) \leq \varepsilon\right\}
$$

From this, we shall deduce the consistency of Bayes estimators of $f$ and $d$. Finally, we shall introduce the class of FEXP priors, and show that they allow for posterior consistency.

### 3.1 Main result

Consider the following sets:

$$
\begin{aligned}
\mathcal{G}(m, M) & =\left\{g \in \mathcal{C}^{0}[0, \pi]: m \leq g \leq M\right\} \\
\mathcal{G}(m, M, L, \rho) & =\left\{g \in \mathcal{G}(m, M):\left|g(\lambda)-g\left(\lambda^{\prime}\right)\right| \leq L\left|\lambda-\lambda^{\prime}\right|^{\rho}\right\} \\
\mathcal{G}(t, m, M, L, \rho) & =[-1 / 2+t, 1 / 2-t] \times \mathcal{G}(m, M, L, \rho)
\end{aligned}
$$

for $\rho \in(0,1], L>0, m \leq M, t \in(0,1 / 2)$. Restricting the parameter space to such sets makes the model identifiable (boundedness of $g$, provided $m>0$ ), and ensures that normalized traces of products of Toeplitz matrices that appear in the distances defined in the previous section converge (Hölder inequality).

We now state our main consistency result.
Theorem 3.1. For $\varepsilon>0$ small enough

$$
P^{\pi}\left[\mathcal{A}_{\varepsilon} \mid \mathbf{X}_{n}\right] \rightarrow 1, \quad \text { a.s. }
$$

provided the following conditions are fulfilled:

1. There exist $t, m, M, L>0, \rho \in(0,1]$, such that the set $\mathcal{G}(t, m, M, L, \rho)$ contains both the pair $\left(d_{0}, g_{0}\right)$ that defines the true spectral density $f_{0}=F\left(d_{0}, g_{0}\right)$ and the support of the prior distribution $\pi$.
2. For all $\varepsilon>0, \pi\left(\mathcal{B}_{\varepsilon}\right)>0$, where $\mathcal{B}_{\varepsilon}$ is defined by

$$
\mathcal{B}_{\varepsilon}=\left\{(d, g) \in \mathcal{G}(t, m, M, L, \rho): h\left(f_{0}, F(d, g)\right) \leq \varepsilon, 16\left|d_{0}-d\right|<\rho+1-t\right\}
$$

3. For $\varepsilon>0$ small enough, there exists a sequence $\mathcal{F}_{n}$ such that $\pi\left(\mathcal{F}_{n}\right) \geq 1-e^{-n r}$, $r>0$, and a net (i.e. a finite collection)

$$
\mathcal{H}_{n} \subset\left\{(d, g) \in[-1 / 2+t, 1 / 2-t] \times \mathcal{G}(m, M, L, \rho): h\left(f_{0} ; F(d, g)\right)>\varepsilon / 2\right\}
$$

such that, for $n$ large enough, for all $(d, g) \in \mathcal{F}_{n} \cap A_{\varepsilon}^{c}, f=F(d, g)$, there exists $\left(d_{i}, g_{i}\right) \in \mathcal{H}_{n}$, $f_{i}=F\left(d_{i}, g_{i}\right)$, such that $8\left(d_{i}-d\right) \leq \rho+1-t, f \leq f_{i}$, and:
(a) if $8\left|d_{i}-d_{0}\right| \leq \rho+1-t$,

$$
\frac{1}{2 \pi} \int_{-\pi}^{\pi} \frac{\left(f_{i}-f\right)(\lambda)}{f_{0}(\lambda)} d \lambda \leq h\left(f_{0}, f_{i}\right) / 4
$$

(b) if $8\left(d_{i}-d_{0}\right)>\rho+1-t$,

$$
b\left(f_{i}, f\right) \leq b\left(f_{0}, f_{i}\right)|\log \varepsilon|^{-1}
$$

(c) otherwise, if $8\left(d_{0}-d_{i}\right)>\rho+1-t$,

$$
\frac{1}{2 \pi} \int_{-\pi}^{\pi} \frac{\left(f_{i}-f\right)(\lambda)}{f_{i}(\lambda)} d \lambda \leq b\left(f_{i}, f_{0}\right)|\log \varepsilon|^{-1}
$$

4. The cardinality $\mathcal{C}_{n}$ of the net $\mathcal{H}_{n}$ defined above is such that $\log \mathcal{C}_{n} \leq n \varepsilon / \log (\varepsilon)$.

A proof is given in Section 5.1. Note that, in the above definition of the net $\mathcal{H}_{n}$, the $|\log \varepsilon|$ terms are here only to avoid writing inequalities in terms of awkward constants in the form $m / M$. If need be, we can replace the $|\log \varepsilon|$ by the correct constants as expressed in Appendix B. The definition of the above entropy is non-standard. The interest in expressing it in this general but non-standard form lies in the difficulty in dealing with spectral densities which diverge at 0 . In practise, the way one constructs the net $\mathcal{H}_{n}$ should vary according to the form of the prior on the short memory part $g$.

### 3.2 Consistency of point estimates

As explained in $\xi_{2}$, we focus on the quadratic loss function $\ell$ with respect to the logarithm of the spectral density. The corresponding Bayes estimator is

$$
\hat{d}=E^{\pi}\left[d \mid \mathbf{X}_{n}\right], \quad \hat{g}: \lambda \rightarrow \exp \left\{E^{\pi}\left[\log g(\lambda) \mid \mathbf{X}_{n}\right]\right\}, \quad \hat{f}=F(\hat{d}, \hat{g})
$$

Often, the real parameter of interest is $d$, and $g$ is a nuisance parameter. Consistency for $\hat{d}$ can be deduced from Theorem 3.1.

Corollary 1. Under the assumptions of Theorem 3.1, for $\varepsilon>0$ small enough,

$$
P^{\pi}\left[\left\{\left|d-d_{0}\right|>\varepsilon\right\} \mid \mathbf{X}_{n}\right] \rightarrow 0
$$

and $\hat{d} \rightarrow d_{0}$ as $n \rightarrow \infty$.
Proof. Lemma 10, see Appendix D, implies that

$$
P^{\pi}\left[\mathcal{A}_{\varepsilon}^{c} \mid \mathbf{X}_{n}\right] \geq P^{\pi}\left[\left\{\left|d-d_{0}\right|>\varepsilon^{\prime}\right\} \mid \mathbf{X}_{n}\right] \rightarrow 0 \quad \text { a.s. }
$$

as $n \rightarrow+\infty$, for some $\varepsilon^{\prime}>0$ and, by Jensen's inequality,

$$
\left(\hat{d}-d_{0}\right)^{2} \leq E^{\pi}\left[\left(d-d_{0}\right)^{2} \mid \mathbf{X}_{n}\right] \rightarrow 0, \quad \text { a.s. }
$$

Consistency results for a point estimate of $f$ can also be deduced:
Corollary 2. Under the assumptions of Theorem 3.1, one has, as $n \rightarrow \infty$,

$$
\ell\left(f_{0}, \hat{f}\right) \rightarrow 0, \quad \text { a.s. }
$$

Proof. For $f=F(d, g), f_{0}=F\left(d_{0}, g_{0}\right)$, one has $\ell\left(f_{0}, f\right) \leq h\left(f_{0}, f\right)$, since $x^{2} \leq e^{x}+e^{-x}-2$ for all $x$, and $\ell\left(f_{0}, f\right) \leq C$ for some well chosen constant $C$, provided $g, g_{0} \in \mathcal{G}(m, M)$. Thus, by Jensen inequality, and for all $\varepsilon>0$,

$$
\ell\left(f_{0}, \hat{f}\right) \leq E^{\pi}\left[\ell\left(f_{0}, f\right) \mid \mathbf{X}_{n}\right] \leq \varepsilon+C P^{\pi}\left[A_{\varepsilon}^{c} \mid \mathbf{X}_{n}\right]
$$

### 3.3 The FEXP prior

Following Hurvich et al. (2002), we consider the FEXP parameterisation of spectral densities, i.e. $f=\widetilde{F}(d, k, \theta)$, where

$$
\begin{align*}
\widetilde{F}: \mathcal{T} & \rightarrow \mathcal{F} \\
(d, k, \theta) & \rightarrow f: f(\lambda)=\left|1-e^{i \lambda}\right|^{-2 d} \exp \left\{\sum_{j=0}^{k} \theta_{j} \cos (j \lambda)\right\} . \tag{3.1}
\end{align*}
$$

and $\mathcal{T}=(-1 / 2+t, 1 / 2-t) \times\left\{\cup_{k=0}^{+\infty}\{k\} \times \mathbb{R}^{k+1}\right\}$, for some fixed $t \in(0,1 / 2)$. This FEXP representation is equivalent to our previous representation $f=F(d, g)$, provided $g=\psi^{-d} e^{w}$, $w(\lambda)=\left\{\sum_{j=0}^{k} \theta_{j} \cos (j \lambda)\right\}$ and $\psi(\lambda)=\left|1-e^{i \lambda}\right|^{2} / \lambda^{2}=2(1-\cos \lambda) / \lambda^{2}$ for $\lambda \neq 0, \psi(0)=1$.

The function $\psi$ is bounded, infinitely differentiable and positive for $\lambda \in[0, \pi]$. Thus $g$ and $w$ share the same regularity properties, i.e. $w$ is bounded and Hölder with exponent $\rho$ implies that $g$ is bounded and Hölder with exponent $\rho$, and vice versa. Under this parameterisation, the prior distribution $\pi$ is expressed as a trans-dimensional prior distribution on the random vector $(d, k, \theta)$, which, for convenience, factorises as $\pi_{d}(d) \pi_{k}(k) \pi_{\theta}(\theta \mid k)$.

We assume that $\pi$ puts mass one on the following Sobolev set:

$$
\begin{equation*}
\mathcal{S}(\beta, L)=\left\{(d, k, \theta) \in \mathcal{T}: \sum_{j=0}^{k} \theta_{j}^{2}(j+1)^{2 \beta} \leq L\right\} \tag{3.2}
\end{equation*}
$$

for some $\beta>1 / 2, L>0$. This ensures that the Fourier sum $w$, and thus the short-memory component $g$ of the spectral density $f$, as explained above, belong to some set $\mathcal{G}\left(m, M, L^{\prime}, \rho\right)$, i.e., both $w$ and $g$ are bounded and Hölder, for $\rho<\beta-1 / 2$. To see this, note that, for $(d, k, \theta) \in \mathcal{S}(\beta, L):$

$$
\begin{align*}
\sum_{j=0}^{k}\left|\theta_{j}\right| j^{r} & \leq \sum_{j=0}^{k} \theta_{j}^{2}(j+1)^{2 \beta}+\sum_{j=0}^{k}\left|\theta_{j}\right| j^{r} 11\left(\left|\theta_{j}\right| j^{r} \geq \theta_{j}^{2}(j+1)^{2 \beta}\right) \\
& \leq L+\sum_{j=0}^{+\infty}(j+1)^{2 r-2 \beta}<+\infty \tag{3.3}
\end{align*}
$$

provided $2 r-2 \beta<-1$. By taking $r=0$, one sees that $w$ is bounded, and by taking $r=\rho$, for any $\rho, 0<\rho<\beta-1 / 2$, one sees that $w$ is Hölder, with coefficient $\rho$, since, for $\lambda, \lambda^{\prime} \in[-\pi, \pi]$,

$$
\begin{aligned}
\left|w(\lambda)-w\left(\lambda^{\prime}\right)\right| & \leq 2 \sum_{j=0}^{k}\left|\theta_{j}\right| \times\left|\left\{\cos (\lambda j)-\cos \left(\lambda^{\prime} j\right)\right\} / 2\right|^{\rho} \\
& \leq 2^{1-\rho}\left(\sum_{j=0}^{k}\left|\theta_{j}\right| j^{\rho}\right)\left|\lambda-\lambda^{\prime}\right|^{\rho}
\end{aligned}
$$

Finally, we assume that $\pi$ assigns positive prior probability to the intersection of $\mathcal{S}(\beta, L)$ with any rectangle set of the form

$$
\left(a_{d}, b_{d}\right) \times\{k\} \times \prod_{j=1}^{k}\left(a_{\theta_{j}}, b_{\theta_{j}}\right)
$$

Alternatively, one could assume that the support of $\pi$ is included in a set of the form $\left\{(d, k, \theta) \in \mathcal{T}: \sum_{j=0}^{k}\left|\theta_{j}\right| j^{\rho} \leq L\right\}$. However Sobolev sets are more natural when dealing with rates of convergence, see Section 4.2, and are often considered in the non parametric literature, so we restrict our attention to these sets.

In the same spirit, we assume that the true spectral density admits a FEXP representation associated to an infinite Fourier series,

$$
f_{0}(\lambda)=\left|1-e^{i \lambda}\right|^{-2 d_{0}} \exp \left\{\sum_{j=0}^{+\infty} \theta_{0 j} \cos (j \lambda)\right\}
$$

i.e., $f_{0}=F\left(d_{0}, g_{0}\right)$ with $g_{0}=\psi^{-d_{0}} e^{w_{0}}$ and $w_{0}(\lambda)=\left\{\sum_{j=0}^{+\infty} \theta_{0 j} \cos (j \lambda)\right\}$. In addition, we assume that $w_{0}$ satisfies the same type of Sobolev inequality, namely

$$
\begin{equation*}
L_{0}=\sum_{j=0}^{+\infty} \theta_{0 j}^{2}(j+1)^{2 \beta}<L<+\infty \tag{3.4}
\end{equation*}
$$

which, as explained above, implies that $g_{0} \in \mathcal{G}(m, M, L, \rho)$, for some well chosen constants $m, M, L, \rho$. Note that it is essential to have a strict inequality in (3.4), i.e. $L_{0}<L$.
Theorem 3.2. Let $\pi$ be a prior distribution $\pi_{d}(d) \pi_{k}(k) \pi_{\theta}(\theta \mid k)$ which fulfils the above conditions, and, in addition, such that $\pi_{k}(k) \leq \exp (-C k \log k)$ for some $C>0$ and $k$ large enough. Then the conditions of Theorem 3.1 are fulfilled, and the posterior distribution is consistent.

Proof. Condition 1 of Theorem 3.1 is a simple consequence of (3.4) and (3.2), as explained above. For Condition 2, we noted, see (3.3), that $\sum_{j=0}^{+\infty} \theta_{0 j}^{2}(j+1)^{2 \beta} \leq L$ implies that $\sum_{j=0}^{+\infty}\left|\theta_{0 j}\right| \leq L^{\prime}<$ $+\infty$. Let $k$ such that $\sum_{j=k+1}^{\infty}\left|\theta_{0 j}\right| \leq \varepsilon / 14, \theta=\left(\theta_{0}, \ldots, \theta_{k}\right)$ such that $\sum_{j=0}^{k}\left|\theta_{0 j}-\theta_{j}\right| \leq \varepsilon / 14$, $d$ such that $\left|d-d_{0}\right| \leq \varepsilon / 7$, and let $f=\tilde{F}(d, k, \theta)$. Using Lemma 14, see Appendix D, one has $h\left(f, f_{0}\right) \leq \varepsilon$. Note that it is sufficient to prove that $\pi\left(\mathcal{B}_{\varepsilon}\right)>0$ for $\varepsilon$ small enough, hence we assume that $\varepsilon / 7<(\rho+1-t) / 16$. Thus, Condition 2 is verified as soon as the intersection of $\mathcal{S}(\beta, L)$ and the rectangle set

$$
\left[d_{0}-\varepsilon / 7, d_{0}+\varepsilon / 7\right] \times\{k\} \times \prod_{j=1}^{k}\left[\theta_{0 j}-\varepsilon / 14 k, \theta_{0 j}-\varepsilon / 14 k\right]
$$

is assigned positive prior probability. Now consider Condition 3. Let $\varepsilon>0$ and take

\mathcal{F}_{n}=\left\{(d, k, \theta) \in \mathcal{S}(\beta, L): k \leq k_{n}\right\}
$$

where $k_{n}=\lfloor\alpha n / \log n\rfloor$, for some $\alpha>0$, so that, for some $r$ depending on $\alpha, \pi\left(\mathcal{F}_{n}^{c}\right) \leq \pi_{k}(k>$ $\left.k_{n}\right) \leq e^{-n r}$. Let $f=\tilde{F}(d, k, \theta), f_{i}=(2 e)^{c \varepsilon} \tilde{F}\left(d_{i}, k, \theta_{i}\right)$, such that $k \leq k_{n}, d_{i}-c \varepsilon \leq d \leq d_{i}$, and $\sum_{j=0}^{k}\left|\theta_{j}-\theta_{i j}\right| \leq c \varepsilon$, for some $c>0$, then

$$
\frac{f(\lambda)}{f_{i}(\lambda)}=(2 e)^{-c \varepsilon}[2(1-\cos \lambda)]^{d_{i}-d} \exp \left\{\sum_{j=0}^{k}\left(\theta_{j}-\theta_{i j}\right) \cos (j \lambda)\right\} \leq 1
$$

and

$$
\frac{f(\lambda)}{f_{i}(\lambda)} \geq(1-\cos \lambda)^{c \varepsilon} 2^{-c \varepsilon} e^{-2 c \varepsilon}
$$

If $c$ is small enough, $f_{i}-f$ verifies the three inequalities considered in Condition 3. The number $\mathcal{C}_{n}$ of functions $f_{i}$ necessary to ensure that, for any $f$ in the support of $\pi$, at least one of them verify the above inequalities, can be bounded by, for $n$ large enough, and some well chosen constant $C$,

$$
\begin{aligned}
\mathcal{C}_{n} \leq k_{n}\left(C k_{n} / \varepsilon\right)^{k_{n}+2} & \leq k_{n}^{3 k_{n}} \\
& \leq \exp \{3 \alpha n[1+(\log \alpha-\log \log n) / \log n]\} \\
& \leq \exp \{6 \alpha n\}
\end{aligned}
$$

so Condition 4 is satisfied, provided one takes $\alpha=\varepsilon / 6 \log \varepsilon$.

A convenient default choice for $\pi$ is as follows: $\pi_{d}$ is uniform over $(-1 / 2+t, 1 / 2-t), \pi_{k}$ is Poisson, and $\pi_{\theta \mid k}$ has the following structure: the sum $S=\sum_{j=0}^{k} \theta_{j}^{2}(j+1)^{2 \beta}$ has a Gamma distribution truncated to interval $[0, L]$, independently of $S$, the vector $\left(\theta_{0}^{2}, \theta_{1}^{2} 2^{2 \beta}, \ldots, \theta_{k}^{2}(k+\right.$ $\left.1)^{2 \beta}\right) / S$ is Dirichlet with some coefficients $\alpha_{1, k}, \ldots, \alpha_{k, k}$, and the signs of $\theta_{0}, \ldots, \theta_{k}$ have equal
probabilities. In particular one may take $\alpha_{j, k}=1$ for all $j \leq k$, or, if one needs to generate more regular spectral densities, $\alpha_{j, k}=j^{-\kappa}$, for some fixed or random $\kappa>0$. Another interesting choice for the prior on $\theta$ is the following truncated Gaussian process: for each $k$, and each $j \leq k$, $\theta_{j} \sim \mathcal{N}\left(0, \tau_{0}^{2}(1+j)^{-2 \beta}\right)$ independently apart from the constraint, for some fixed, large $L>0$ :

$$
\sum_{j=1}^{k}(1+j)^{2 \beta} \theta_{j}^{2} \leq L
$$

Note that we can easily restrict ourselves to the important case $d \geq 0$, i.e. processes having long or short memory but not intermediate memory.

## 4 Rates of convergence

In this section we first provide a general theorem relating rates of convergence of the posterior distribution to conditions on the prior. These conditions are, in essence, similar to the conditions obtained in the i.i.d. case (e.g. Ghosal et al., 2000): i.e. a condition on the prior mass of KullbackLeibler neighborhoods of the true spectral density, and an entropy condition on the support of the prior. We then present results specialised to the FEXP prior case.

### 4.1 Main result

Theorem 4.1. Let $\left(u_{n}\right)$ be a sequence of positive numbers such that $u_{n} \rightarrow 0$, $n u_{n} \rightarrow+\infty$, and $\overline{\mathcal{B}}_{n}$ a sequence of balls belonging to $\mathcal{G}(t, m, M, L, \rho)$, and defined as

$$
\overline{\mathcal{B}}_{n}=\left\{(d, g): K L_{n}\left(f_{0} ; F(d, g)\right) \leq u_{n} / 4, b_{n}\left(f_{0}, F(d, g)\right) \leq u_{n}, d_{0} \leq d \leq d_{0}+\delta\right\}
$$

for some $\delta, L>0,0<m \leq M, \rho \in(0,1]$. Let $\pi$ be a prior which satisfies all the conditions of Theorem 3.1, and, in addition, such that:

1. For $n$ large enough, $\pi\left(\overline{\mathcal{B}}_{n}\right) \geq \exp \left(-n u_{n} / 2\right)$.
2. There exists $\varepsilon>0$ and a sequence of sets $\overline{\mathcal{F}}_{n} \subset\left\{(d, g): h\left(F(d, g), f_{0}\right) \leq \varepsilon\right\}$, such that, for $n$ large enough,

$$
\pi\left(\overline{\mathcal{F}}_{n}^{c} \cap\left\{(d, g): h\left(F(d, g), f_{0}\right) \leq \varepsilon\right\}\right) \leq \exp \left(-2 n u_{n}\right)
$$

3. There exists a positive sequence $\left(\varepsilon_{n}\right), \varepsilon_{n}^{2} \geq u_{n}, \varepsilon_{n}^{2} \rightarrow 0, n \varepsilon_{n}^{2} \geq C \log n$, for some $C>0$, satisfying the following conditions. Let

$$
\mathcal{V}_{n, l}=\left\{(d, g) \in \overline{\mathcal{F}}_{n} ; \varepsilon_{n}^{2} l \leq h_{n}\left(f_{0}, F(d, g)\right) \leq \varepsilon_{n}^{2}(l+1)\right\}
$$

with $l_{0} \leq l \leq l_{n}$, with fixed $l_{0} \geq 2$ and $l_{n}=\left\lceil\varepsilon^{2} / \varepsilon_{n}^{2}\right\rceil-1$. For each $l=l_{0}, \cdots, l_{n}$, there exists a net (i.e. a finite collection) $\overline{\mathcal{H}}_{n, l} \subset \mathcal{V}_{n, l}$, with cardinality $\overline{\mathcal{C}}_{n, l}$, such that for all $f=F(d, g),(d, g) \in \mathcal{V}_{n, l}$, there exists $f_{i, l}=F\left(d_{i, l}, g_{i, l}\right) \in \overline{\mathcal{H}}_{n, l}$ such that $f_{i, l} \geq f$ and

$$
0 \leq g_{i, l}(x)-g(x) \leq l \varepsilon_{n}^{2} g_{i, l} / 32 \quad 0 \leq d_{i, l}-d \leq l \varepsilon_{n}^{2}(\log n)^{-1}
$$

where

$$
\log \overline{\mathcal{C}}_{n, l} \leq n \varepsilon_{n}^{2} l^{\alpha}, \quad \text { with } \quad \alpha<1
$$

Then, there exist $C, C^{\prime}>0$ such that, for $n$ large enough,

$$
\begin{equation*}
E_{0}^{n}\left[P^{\pi}\left(h_{n}\left(f_{0}, F(d, g)\right) \geq l_{0} \varepsilon_{n}^{2} \mid \mathbf{X}_{n}\right)\right] \leq C n^{-3}+2 e^{-C^{\prime} n \varepsilon_{n}^{2}}+e^{-n u_{n} / 16} \tag{4.1}
\end{equation*}
$$

A proof is given in Section 5.2.
The conditions given in Theorem 4.1 are similar in spirit to those considered for rates of convergence of the posterior distribution in the i.i.d. case. The first condition is a condition on the prior mass of Kullback-Leibler neighborhoods of the true spectral density, the second one is necessary to allow for sets with infinite entropy (some kind of non compactness) and the third one is an entropy condition. The inequality (4.1) obtained in Theorem 4.1 is non asymptotic, in the sense that it is valid for all $n$. However, the distances considered in Theorem 4.1 heavily depend on $n$ and, although they express the impact of the differences between $f$ and $f_{0}$ on the observations, they are not of great practical use. For these reasons, the entropy condition is awkward and cannot be directly transformed into some more common entropy conditions. To state a result involving distances between spectral densities that might be more useful, we need to consider some specific class of priors. In the next section, we obtain rates of convergence in terms of the $\ell$ distance for the class of FEXP priors introduced in Section 3.3. The rates obtained are the optimal rates up to a $(\log n)$ term, at least on certain classes of spectral densities. It is to be noted that the calculations used when working on these classes of priors are actually more involved than those used to prove Theorem 4.1. This is quite usual when dealing with rates of convergence of posterior distributions, however this is emphasized here by the fact that distances involved in Theorem 4.1 are strongly dependent on $n$. The method used in the case of the FEXP prior can be extended to other types of priors.

### 4.2 Rates of convergence for the FEXP prior

We apply Theorem 4.1 to the class of FEXP priors introduced in Section 3.3. Recall that under such a prior a spectral density $f$ is parametrised as $f=\widetilde{F}(d, k, \theta)$, see (3.1). We make the same assumptions as in Section 3.3. In particular, the prior $\pi(d, k, \theta)$ factorises as $\pi_{d}(d) \pi_{k}(k) \pi_{\theta}(\theta \mid k)$, the right tail of $\pi_{k}$ is such that

$$
\exp \{-C k \log k\} \leq \pi_{k}(k) \leq \exp \left\{-C^{\prime} k \log k\right\}
$$

for some $C, C^{\prime}>0$, and for $k$ large enough, and there exists $\beta>1 / 2$ such that the Sobolev set $S(\beta, L)$ contains the support of $\pi$. The last condition means that $S=\sum_{j=0}^{k} \theta_{j}^{2}(j+1)^{2 \beta} \in[0, L]$ with prior probability one. In addition, we assume that the support of $\pi_{d}$ is $[-1 / 2+t, 1 / 2-t]$, and, for $d \in[-1 / 2+t, 1 / 2-t], \pi_{d}(d) \geq c_{d}>0$. Similarly, we assume that $\pi_{\theta \mid k}$ is such that the random variable $S=\sum_{j=0}^{k} \theta_{j}^{2}(j+1)^{2 \beta}$ is independent of $k$, and admits a probability density $\pi_{S}(s)$ with support $[0, L]$, and such that $\pi_{S}(s) \geq c_{s}>0$ for $s \in[0, L]$.
Theorem 4.2. For the FEXP prior described above, there exist $C, C^{\prime}>0$ such that, for $n$ large enough

$$
\begin{equation*}
E_{0}^{n}\left\{P^{\pi}\left[\left.\ell\left(f, f_{0}\right)>\frac{C \log n}{n^{2 \beta /(2 \beta+1)}} \right\rvert\, \mathbf{X}_{n}\right]\right\} \leq \frac{C}{n^{2}} \tag{4.2}
\end{equation*}
$$

where $f=\widetilde{F}(d, k, \theta)$ and

$$
\begin{equation*}
E_{0}^{n}\left[\ell\left(\hat{f}, f_{0}\right)\right] \leq \frac{C^{\prime}(\log n)}{n^{2 \beta /(2 \beta+1)}} \tag{4.3}
\end{equation*}
$$

where $\log \hat{f}(\lambda)=E^{\pi}\left[\log f(\lambda) \mid \mathbf{X}_{n}\right]$.
A proof is given in Appendix C.

## 5 Proofs of Theorems 3.1 and 4.1

### 5.1 Proof of Theorem 3.1

For the sake of conciseness, we introduce the following notations: for any pair $\left(f, f_{0}\right)$ of spectral densities,

The proof borrows ideas from Ghosal et al. (2000). The main difficulty is to formulate constraints on quantities such as $h_{n}\left(f, f_{0}\right)$ or $K L_{n}\left(f, f_{0}\right)$ in terms of distances between $f, f_{0}$, independent on $n$, and uniformly over $f$. One has

P^{\pi}\left[\mathcal{A}_{\varepsilon}^{c} \mid \mathbf{X}_{n}\right]=\frac{\int \mathbb{1}_{\mathcal{A}_{\varepsilon}^{c}}(f) \varphi\left(\mathbf{X}_{n} ; f\right) / \varphi\left(\mathbf{X}_{n} ; f_{0}\right) d \pi(f)}{\int \varphi\left(\mathbf{X}_{n} ; f\right) / \varphi\left(\mathbf{X}_{n} ; f_{0}\right) d \pi(f)} \triangleq \frac{N_{n}}{D_{n}} .
$$

Let $\delta \in(0, \varepsilon)$ and $P_{0}^{n}$ be a generic notation for probabilities associated to the distribution of $\mathbf{X}_{n}$, under the true spectral density $f_{0}=F\left(d_{0}, g_{0}\right)$. One has

P_{0}^{n}\left\{P^{\pi}\left[\mathcal{A}_{\varepsilon}^{c} \mid \mathbf{X}_{n}\right] \geq e^{-n \delta}\right\} \leq P_{0}^{n}\left[D_{n} \leq e^{-n \delta}\right]+P_{0}^{n}\left[N_{n} \geq e^{-2 n \delta}\right] \tag{5.1}
\end{equation*}
$$

The following Lemma bounds the first term.
Lemma 1. There exists $C>0$ such that

P_{0}^{n}\left[D_{n} \leq e^{-n \delta}\right] \leq C n^{-3} \tag{5.2}
\end{equation*}
$$

Proof. Lemma implies that, when $n$ is large enough, $\tilde{\mathcal{B}}_{n} \supset \mathcal{B}_{\delta / 8}$, where

\tilde{\mathcal{B}}_{n}=\left\{(d, g) \in[-1 / 2+t, 1 / 2-t] \times \mathcal{G}(m, M, L, \rho): K L_{n}\left(f_{0}, F(d, g)\right) \leq \delta / 4\right\}
$$

and Condition 2 implies that, for $n$ large enough, $\pi\left(\tilde{\mathcal{B}}_{n}\right) \geq \pi\left(\mathcal{B}_{\delta / 8}\right) \geq 2 e^{-n \delta / 2}$. Consider the indicator function

\Omega_{n}=\mathbb{1}\left[-\mathbf{X}_{n}^{t}\left\{T_{n}(f)^{-1}-T_{n}\left(f_{0}\right)^{-1}\right\} \mathbf{X}_{n}+\log \operatorname{det} A\left(f_{0}, f\right)>-n \delta\right],
$$

with implicit arguments $\left(f, \mathbf{X}_{n}\right)$, then, following Ghosal et al. (2000),

\begin{aligned}
P_{0}^{n}\left[D_{n} \leq e^{-n \delta}\right] & \leq P_{0}^{n}\left(\int \Omega_{n} 1_{\tilde{\mathcal{B}}_{n}}(f) \frac{\varphi\left(\mathbf{X}_{n} ; f\right)}{\varphi\left(\mathbf{X}_{n} ; f_{0}\right)} d \pi(f) \leq e^{-n \delta / 2} \frac{\pi\left(\tilde{\mathcal{B}}_{n}\right)}{2}\right) \\
& \leq P_{0}^{n}\left(E^{\pi}\left\{\Omega_{n} 1_{\tilde{\mathcal{B}}_{n}}(f)\right\} \leq \pi\left(\tilde{\mathcal{B}}_{n}\right) / 2\right) \\
& \leq P_{0}^{n}\left(E^{\pi}\left\{\left(1-\Omega_{n}\right) 1_{\tilde{\mathcal{B}}_{n}}(f)\right\} \geq \pi\left(\tilde{\mathcal{B}}_{n}\right) / 2\right) \\
& \leq \frac{2}{\pi\left(\tilde{\mathcal{B}}_{n}\right)} \int_{\tilde{\mathcal{B}}_{n}} E_{0}^{n}\left\{1-\Omega_{n}\right\} d \pi(f) .
\end{aligned}
$$

by Markov inequality. Besides,

\begin{aligned}
E_{0}^{n}\left\{1-\Omega_{n}\right\} & =P_{0}^{n}\left\{\mathbf{X}_{n}^{t}\left\{T_{n}(f)^{-1}-T_{n}\left(f_{0}\right)^{-1}\right\} \mathbf{X}_{n}-\log \operatorname{det} A\left(f_{0}, f\right)>n \delta\right\} \\
& =P_{\mathbf{Y}}\left\{\mathbf{Y}^{t} B\left(f_{0}, f\right) \mathbf{Y}-\operatorname{tr}\left[B\left(f_{0}, f\right)\right]>D\left(f_{0}, f\right)\right\}
\end{aligned}
$$

where $\mathbf{Y} \sim N_{n}\left(\mathbf{0}_{n}, \mathbf{I}_{n}\right)$, and, for $f \in \tilde{\mathcal{B}}_{n}$

$$
D\left(f_{0}, f\right) \triangleq n \delta+\log \operatorname{det} A\left(f_{0}, f\right)-\operatorname{tr}\left[B\left(f_{0}, f\right)\right]>n \delta / 2
$$

thus

$$
\begin{aligned}
E_{0}^{n}\left[1-\Omega_{n}\right] & \leq P_{\mathbf{Y}}\left\{\mathbf{Y}^{t} B\left(f_{0}, f\right) \mathbf{Y}-\operatorname{tr}\left[B\left(f_{0}, f\right)\right]>n \delta / 2\right\} \\
& \leq \frac{16}{n^{4} \delta^{4}} E_{\mathbf{Y}}\left[\left\{\mathbf{Y}^{t} B\left(f_{0}, f\right) \mathbf{Y}-\operatorname{tr}\left[B\left(f_{0}, f\right)\right]\right\}^{4}\right] \\
& \leq \frac{C}{n^{3} \delta^{4}}
\end{aligned}
$$

which concludes the proof.

A bound for the second term in (5.1) is obtained as follows:

using Condition 3, where

p \triangleq P_{0}^{n}\left[\int \mathbb{1}\left(A_{\varepsilon}^{c} \cap \mathcal{F}_{n}\right) \frac{\varphi\left(\mathbf{X}_{n} ; f\right)}{\varphi\left(\mathbf{X}_{n} ; f_{0}\right)} d \pi(f) \geq e^{-2 n \delta} / 2\right]
$$

Assuming $2 \delta<r$, we consider the following likelihood ratio tests for each $f_{i} \in \mathcal{H}_{n}$, and for some arbitrary values $\rho_{i}$,

\phi_{i}=\mathbb{1}\left\{\mathbf{X}_{n}^{t}\left[T_{n}^{-1}\left(f_{0}\right)-T_{n}^{-1}\left(f_{i}\right)\right] \mathbf{X}_{n} \geq n \rho_{i}\right\}

Lemmas 7, 8 and 9 given in Appendix B prove that, for each of the three cases in Condition 3 of Theorem 3.1, and well-chosen values of $\rho_{i}$, one has

for all $f_{i}$, for $f$ close to $f_{i}$ (in the sense defined in cases a,b, and c in Condition 3), where $C_{1}>0$ is a constant that does not depend on $f_{i}$, and $E_{f}^{n}$ stands for the expectation with respect to the likelihood $\varphi\left(\mathbf{X}_{n} ; f\right)$. Then one concludes easily as follows. Let $\phi^{(n)}=\max _{i} \phi_{i}$, then, using Markov inequality, for $n$ large enough,

& \leq \mathcal{C}_{n} e^{-n C_{1} \varepsilon}+2 e^{2 n \delta-n C_{1} \varepsilon} \\
& \leq e^{-n C_{1} \varepsilon / 2} \tag{5.5}
\end{align*}

provided $\delta<C_{1} \varepsilon / 4$. Combining (5.2), (5.3) and (5.5), there exists $\delta>0$ such that

for $n$ large enough, which implies that $P^{\pi}\left[A_{\varepsilon}^{c} \mid \mathbf{X}_{n}\right] \rightarrow 0$ a.s.

### 5.2 Proof of Theorem 4.1

This proof uses the same notations as the previous Section, e.g. $C, C^{\prime}$ denote generic constants, $f$, $d \pi(f)$ are short-hands for $f=F(d, g), d \pi(d, g)$, respectively, $A\left(f, f_{0}\right)$ and $B\left(f, f_{0}\right)$ have the same definition, and so on. In the proof of Theorem 3.1, we showed that $E_{0}^{n}\left[P^{\pi}\left(h\left(f, f_{0}\right) \geq \varepsilon \mid \mathbf{X}_{n}\right)\right] \leq$ $C n^{-3}$ for $\varepsilon$ small enough, $n$ large enough. Thanks to the uniform convergence Lemmas 3 and 4 in Appendix A, one sees that the same inequality holds if $h$ is replaced by $h_{n}$. Therefore, to obtain inequality (4.1), it is sufficient to bound the expectation of the sum of the following probabilities:

Note that $s_{0} \geq m /(M \pi)$ and that the constant $C$ in the above inequality can be chosen as $C=m /(32 M \pi)$. The second term of (5.6) equals

## 6 Discussion

In this paper we have considered the theoretical properties of Bayesian non parametric estimates of the spectral density for Gaussian long memory processes. Some general conditions on the prior and on the true spectral density are provided to ensure consistency and to determine concentration rates of the posterior distributions in terms of the pseudo-metric $h_{n}\left(f_{0}, f\right)$. To derive a posterior concentration rate in terms of a more common metric such as $l_{2}$, we have considered a specific family of priors based of the FEXP models and also used in the frequentist literature. Gaussian long memory processes lead to complex behaviours, which makes the derivation of concentration rates a difficult task. This paper is thus a step in the direction of better understanding the asymptotic behaviour of the posterior distribution in such models and could be applied to various types of priors on the short memory part - other than the FEXP priors.

The rates we have derived are optimal (up to a $\log n$ term) in Sobolev balls but not adaptive since the estimation procedure depends on the smoothness $\beta$. Another constraint in the paper is that the prior needs to be restricted to Sobolev balls with fixed though large radius, forbidding the use of Gaussian distributions on the coefficients appearing in the FEXP representation.

However, it is to be noted that even in the parametric framework existing results on the asymptotic behaviour of likelihood approaches, whether maximum likelihood estimators or Bayesian estimators are all assuming that the parameter space is compact, for the same reason that we have had to constraint the prior on fixed Sobolev balls in the FEXP example. The reason is that the short memory part of the spectral density needs to be uniformly bounded.

A related and fundamental problem is the practical implementation of the model described in the paper. Liseo and Rousseau (2006) adopted a Population MC algorithm which easily deals with the trans-dimensional parameter space issue. We are currently working on alternative computational approaches.

## A Technical Lemmas on convergence rates of products of Toeplitz matrices

We first give a set of inequalities on norms of matrices that are useful throughout the proofs. We then give three technical lemmas on the uniform convergence of traces of products of Toeplitz matrices, in the spirit of Lieberman et al. (2003) and Lieberman et al. (2009), but extending those previous results to functional classes instead of parametric classes.

## A. 1 Some matrix inequalities

Let $A$ and $B$ be $n$ dimensional matrices. We consider the following two norms:

## A. 2 Uniform convergence: Lemmas 3 and 4

We state two technical lemmas, which are extensions of Lieberman et al. (2003) on uniform convergence of traces of Toeplitz matrices, and which are repeatedly used in the paper.

This lemma is a direct adaptation from Lieberman et al. (2003); the only non obvious part is the change from the condition of continuous differentiability in that paper to the Lipschitz condition of order $\rho$. This different assumption affects only equation (30) of Lieberman et al. (2003), with $\eta_{n}$ replaced by $\eta_{n}^{\rho}$, which does not change the convergence results.

Lemma 4. Let $t>0, M, L, m>0$ and $\rho_{1}, \rho_{2} \in(0,1]$, let $p$ be a positive integer, we have, as $n \rightarrow+\infty$ :

Proof. This result is a direct consequence of Lemma 3, as in Lieberman et al. (2003). The only difference is in the proof of Lemma 5.2. of Dahlhaus (1989), i.e. in the study of terms in the form

& \times\left\|T_{n}\left(h_{1}\right)^{-1 / 2} T_{n}\left(\left|f_{1}-f_{2}\right|\right)^{1 / 2}\right\|\left\|T_{n}\left(\left|f_{1}-f_{2}\right|\right)^{1 / 2} T_{n}^{-1 / 2}\left(f_{2}\right)\right\| \\
& \leq C n^{3 \delta-1 / 2} \sqrt{h_{n}\left(f_{1}, f_{2}\right)}
\end{aligned}

Where the latter inequality comes from Lemma 5.3 of Dahlhaus (1989) and from the fact that

Then it is easy to see that $\pi\left(\overline{\mathcal{B}}_{n}\right) \geq \pi\left(\hat{\mathcal{B}}_{n}\right) \geq \exp \left\{-n u_{n} / 2\right\}$, provided $k_{0}$ is small enough, since $\pi_{k}\left(k \geq \bar{k}_{n}\right) \geq \exp \left\{-C \bar{k}_{n} \log \bar{k}_{n}\right\}$, and (C.3) for all $j$ implies that

Let $f=\tilde{F}(d, k, \theta)$, with $(d, k, \theta) \in \hat{\mathcal{B}}_{n}$. To prove that $(d, k, \theta) \in \overline{\mathcal{B}}_{n}$, it is sufficient to prove that $h_{n}\left(f, f_{0}\right) \leq u_{n} / 4$, since $h_{n}\left(f, f_{0}\right)=K L_{n}\left(f_{0} ; f\right)+K L_{n}\left(f ; f_{0}\right)$, and $K L_{n}\left(f ; f_{0}\right) \geq C b_{n}\left(f_{0}, f\right)$, using the same calculation as in Dahlhaus (1989, p. 1755) and the fact that $d \leq d_{0}$.

Since $f_{0} \in \mathcal{S}(\beta, L)$, and for the particular choice of $\bar{k}_{n}$ above,

Note that the calculations below follow the same lines and the same notations as the treatment of $\gamma(b)$ in Lemma 6, see Appendix A.

\begin{aligned}
b\left(f, f_{0}\right) & \geq \frac{1}{8 \pi} \int_{0}^{\pi} 11\left\{\lambda^{2\left(d_{0}-d\right)} \leq m / 2 M\right\} d \lambda \\
& \geq \frac{1}{8 \pi}\left(\frac{2 M}{m}\right)^{-1 / 2 \varepsilon}
\end{aligned}
$$

Lemma 12. For any $\tau \in(0,1 / 4)$, there exists $C>0$ such that

$$
d-d_{0}<\frac{1}{4}-\tau \Rightarrow b\left(f, f_{0}\right) \leq C h\left(f, f_{0}\right)
$$

Proof. If $d \leq d_{0}$, the bound is trivial, since $f / f_{0} \leq M / m \pi^{2\left(d_{0}-d\right)}$. Assume $d>d_{0}$, and let $A \geq 1 / 2$ some arbitrary large constant. Since $(x-1)^{2} \leq x^{2}$ for $x \geq 1 / 2$, one has

$$
\begin{align*}
b\left(f, f_{0}\right) & \leq A h\left(f, f_{0}\right)+\frac{M^{2}}{2 \pi m^{2}} \int_{0}^{\pi} 11\left\{f(\lambda) / f_{0}(\lambda) \geq A\right\} \lambda^{-4\left(d-d_{0}\right)} d \lambda \\
& \leq A h\left(f, f_{0}\right)+\frac{M^{2}}{2 \pi m^{2}} \int_{0}^{\pi} 11\left\{\lambda^{-2\left(d-d_{0}\right)} \geq A m / M\right\} \lambda^{-4\left(d-d_{0}\right)} d \lambda \\
& \leq A h\left(f, f_{0}\right)+\frac{C^{\prime}(A m / M)^{2-1 / 2\left(d-d_{0}\right)}}{1-4 t} \tag{D.1}
\end{align*}
$$

provided $A \geq M / m$ and $C^{\prime}=M^{2} / 2 \pi m^{2}$. In turn, since $(x-1)^{2} \geq x^{2} / 2$ for $x \geq 4$, and assuming $A \geq 4 M^{2} / m^{2}$, then $\lambda^{-2\left(d-d_{0}\right)} \geq A m / M$ implies that $f / f_{0} \geq A m^{2} / M^{2} \geq 4$, and $\left(f / f_{0}-1\right)^{2} f_{0} / f \geq f / 2 f_{0} \geq A m^{2} / 2 M^{2}$. Therefore

$$
\begin{align*}
h\left(f, f_{0}\right) & \geq \frac{1}{2 \pi} \int_{0}^{\pi} \mathbb{1}\left\{\lambda^{-2\left(d-d_{0}\right)} \geq A m / M\right\}\left(f / f_{0}-1\right)^{2} \frac{f_{0}}{f} d \lambda  \tag{D.2}\\
& \geq(A m / M)^{2-1 / 2\left(d-d_{0}\right)} / 4 \pi A \tag{D.3}
\end{align*}
$$

One concludes the proof by combining (D.1) with (D.3) and taking $A=4 M^{2} / \mathrm{m}^{2}$.

The lemma below makes the same assumptions with respect to $f$ and $f_{0}$, but it involves finite $n$ distances.

Lemma 13. One has:

$$
d>d_{0} \Rightarrow K L_{n}\left(f_{0} ; f\right) \geq \frac{m^{2}}{M^{2} \pi^{2}} b_{n}\left(f_{0}, f\right)
$$

Proof. Dahihaus (1989, p. 1755) proves that $K L_{n}\left(f_{0} ; f\right) \geq C^{-2} b_{n}\left(f_{0}, f\right)$ where $C$ is the largest eigenvalue of $T_{n}\left(f_{0}\right) T_{n}^{-1}(f)$. In our case, $f_{0} / f \leq M \pi^{2\left(d-d_{0}\right)} / m$, hence $C^{-2}=m^{2} / M^{2} \pi^{2\left(d-d_{0}\right)}$.

The last lemma in this section applies to the FEXP formulation of Section 3.3.
Lemma 14. Let

$$
f_{0}(\lambda)=(2-2 \cos \lambda)^{-d_{0}} \exp \left\{w_{0}(\lambda)\right\}, \quad f(\lambda)=(2-2 \cos \lambda)^{-d} \exp \{w(\lambda)\}
$$

then, for $\varepsilon \in(0,1 / 4)$,

$$
\left|d-d_{0}\right| \leq \varepsilon,\left|w-w_{0}\right| \leq \varepsilon \Rightarrow h\left(f, f_{0}\right) \leq 7 \varepsilon
$$

Proof. Without loss of generality, take $d-d_{0} \geq 0$. Then $f_{0} / f-1 \leq 2^{\varepsilon} e^{\varepsilon}-1 \leq(1+\log 2) \varepsilon$, since $e^{x} \leq 1+2 x$ for $x \in[0,1]$. Moreover, since $2(1-\cos \lambda) \geq \lambda^{2} / 3$ for $\lambda \in(0, \pi)$, one has

$$
\int_{0}^{\pi} \frac{f(\lambda)}{f_{0}(\lambda)} d \lambda=e^{\varepsilon} 3^{\left(d-d_{0}\right)} \int_{0}^{\pi} \lambda^{-2\left(d-d_{0}\right)} d \lambda \leq \frac{\pi e^{\varepsilon} 3^{\varepsilon}}{1-2 \varepsilon}
$$

and, to conclude, as again $e^{x} \leq 1+2 x$ for $x \in[0,1]$, and $e^{\varepsilon(1+\log 3)}(1-2 \varepsilon)^{-1}-1 \leq 10 \varepsilon$, for $\varepsilon \leq 1 / 4$,

$$
h\left(f, f_{0}\right)=\frac{1}{2 \pi} \int_{0}^{\pi}\left(\frac{f(\lambda)}{f_{0}(\lambda)}+\frac{f_{0}(\lambda)}{f(\lambda)}-2\right) d \lambda \leq(6+\log 2) \varepsilon .
$$
