TIME REVERSAL OF VOLTERRA PROCESSES DRIVEN STOCHASTIC DIFFERENTIAL EQUATIONS

L. DECREUSEFOND

ABSTRACT. We consider stochastic differential equations driven by some Volterra processes. Under time reversal, these equations are transformed into past dependent stochastic differential equations driven by a standard Brownian motion. We are then in position to derive existence and uniqueness of solutions of the Volterra driven SDE considered at the beginning.

1. Introduction

Fractional Brownian motion is one the first example of a process which is not a semi-martingale and for which we aim to develop a stochastic calculus. That means we want to define a stochastic integral and solve stochastic differential equations driven by such a process. From the very beginning of this program, two approaches do exist. One approach is based on the sample-paths properties of fBm, mainly its Hölder continuity or its finite p-variation. The other way to proceed relies on the gaussiannity of fBm. The former is mainly deterministic and was initiated by Zähle [41], Feyel, de la Pradelle [12] and Russo, Vallois [31, 32]. Then, came the notion of rough paths introduced by Lyons [22], whose application to fBm relies on the work of Coutin, Qian[4]. These works have been extended in the subsequent works [20, 21, 3, 15, 14, 23, 26, 27, 16, 25, 8]. A new way of thinking came with the independent but related works of Feyel, de la Pradelle [13] and Gubinelli [17]. The integral with respect to fBm was shown to exist as the unique process satisfying some characterization (analytic in the case of [13], algebraic in [17]). As a byproduct, this showed that almost all the existing integrals throughout the literature are all the same as they all satisfy these two conditions. Behind each approach but the last too, is a construction of an integral defined for a regularization of fBm, then the whole work is to show that under some convenient hypothesis, the approximate integrals converge to a quantity which is called the stochastic integral with respect to fBm. The main tool to prove the convergence is either integration by parts in the sense of fractional deterministic calculus, either enrichment of the fBm by some iterated integrals proved to exist independently or by analytic continuation [37, 36].

In the probabilistic approach [7, 6, 5, 9, 19, 30, 29, 2, 1], the idea is also to define an approximate integral and then prove its convergence. It turns out that the key tool is here the integration by parts in the sense of Malliavin calculus.

In dimension greater than one, with the deterministic approach, one knows how to define the stochastic integral and prove existence and uniqueness of fBm driven

SDEs for fBm with Hurst index greater than 1/4. Within the probabilistic framework, one knows how to define a stochastic integral for any value of H but one can't prove existence and uniqueness of SDEs whatever the value of H. The primary motivation of this work was to circumvent this problem.

In [7, 9], we defined stochastic integrals with respect to fBm as a "damped-Stratonovitch" integral with respect to the underlying standard Brownian motion. This integral is defined as the limit of Riemann-Stratonovitch sums, the convergence of which is proved after an integration by parts in the sense of Malliavin calculus. Unfortunately, this manipulation generates non-adaptiveness: Formally the result can be expressed as

$$\int_0^t u(s) \circ dB^H(s) = \delta(\mathcal{K}_t^* u) + \operatorname{trace}(\mathcal{K}_t^* \nabla u).$$

Even if u is adapted (with respect to the Brownian filtration), the process $(s \mapsto \mathcal{K}_t^*u(s))$ is anticipative. However, the stochastic integral process $(t \mapsto \int_0^t u(s) \circ dB^H(s))$ remains adapted so the anticipativeness is in some sense artificial. The motivation of this work is to show that up to time reversal, we can work with adapted process and Itô integrals. In what follows, there is no restriction about the dimension but we need to assume that for any component B^H is an fBm, the Hurst index of which is greater than 1/2.

Consider that we want to solve the equation

(1)
$$X_t = x + \int_0^t \sigma(X_s) \circ dB^H(s), \ 0 \le t \le T$$

where σ is a deterministic function whose properties will be fixed below. It turns out that it is essential to investigate the more general equations:

(A)
$$X_{r,t} = x + \int_{r}^{t} \sigma(X_{r,s}) \circ dB^{H}(s), \ 0 \le r \le t \le T.$$

The strategy is then the following: We will first consider the reciprocal problem:

(B)
$$Y_{r,t} = x - \int_r^t \sigma(Y_{s,t}) \circ dB^H(s), \ 0 \le r \le t \le T.$$

The first critical point is that when we consider $\{Z_{r,t} := Y_{t-r,t}, r \in [0,t]\}$, this process solves an adapted, past dependent, stochastic differential equation with respect to a standard Brownian motion. Moreover, because K_H is lower-triangular and sufficiently regular, the trace term vanishes in the equation defining Z. We have then reduced the problem to an SDE with coefficients dependent on the past, a problem which can be handled by the usual contraction methods. This paper is organized as follows: After the preliminaries of Section 2, we address, in Section 3, the problem of Malliavin calculus and time reversal. This part is interesting in its own since stochastic calculus of variations is a framework oblivious to time. Constructing such a notion of time is achieved using the notion of resolution of the identity as introduced in [40]. We then introduce the second key ingredient which is the notion of strict causality or quasinilpotence, see [42] for a related application. In Section 4, we show that solving Equation (B) reduces to solve a past dependent stochastic differential equation with respect to a standard Brownian motion, see Equation (C) below. In Section 5, we prove existence, uniqueness and some properties of this equation. Technical lemmas are postponed to Section 6.

2. Preliminaries

Let T > 0 be fix real number. For a function $f \in \mathcal{L}^1([0, T]; \mathbf{R}^n)$, we define $\tau_T f$ by

$$\tau_T f(s) = f(T-s)$$
 for any $s \in [0, T]$.

For $t \in [0, T]$, $e_t f$ will represent the restriction of f to [0, t], i.e., $e_t f = f \mathbf{1}_{[0, t]}$. For any linear map A, we denote by A_T^* , its adjoint in $\mathcal{L}^2([0, T]; \mathbf{R}^n)$. For $\eta \in (0, 1]$, the space of η -Hölder continuous functions on [0, T] is equipped with the norm

$$||f||_{\text{Hol}(\eta)} = \sup_{0 < s < t < T} \frac{|f(t) - f(s)|}{|t - s|^{\eta}} + ||f||_{\infty}.$$

Its topological dual is denoted by $\operatorname{Hol}(\eta)^*$. For $f \in \mathcal{L}^1([0,T]; \mathbf{R}^n; dt)$, (denoted by \mathcal{L}^1 for short) the left and right fractional integrals of f are defined by :

$$(I_{0+}^{\gamma}f)(x) = \frac{1}{\Gamma(\gamma)} \int_{0}^{x} f(t)(x-t)^{\gamma-1} dt , x \ge 0,$$

$$(I_{T-}^{\gamma}f)(x) = \frac{1}{\Gamma(\gamma)} \int_{x}^{T} f(t)(t-x)^{\gamma-1} dt , x \le T,$$

where $\gamma>0$ and $I_{0^+}^0=I_{T^-}^0=\mathrm{Id}$. For any $\gamma\geq0,\,p,q\geq1,$ any $f\in\mathcal{L}^p$ and $g\in\mathcal{L}^q$ where $p^{-1}+q^{-1}\leq\gamma,$ we have :

(2)
$$\int_0^T f(s)(I_{0+}^{\gamma}g)(s) \, ds = \int_0^T (I_{T-}^{\gamma}f)(s)g(s) \, ds.$$

The Besov-Liouville space $I_{0+}^{\gamma}(\mathcal{L}^p):=\mathcal{I}_{\gamma,p}^+$ is usually equipped with the norm :

(3)
$$||I_{0+}^{\gamma}f||_{\mathcal{I}_{\gamma,p}^{+}} = ||f||_{\mathcal{L}^{p}}.$$

Analogously, the Besov-Liouville space $I_{1^-}^\gamma(\mathcal{L}^p):=\mathcal{I}_{\gamma,p}^-$ is usually equipped with the norm :

$$||I_{1^{-}}^{-\gamma}f||_{\mathcal{I}_{\gamma,p}^{-}} = ||f||_{\mathcal{L}^{p}}.$$

We then have the following continuity results (see [12, 33]):

Proposition 2.1. i. If $0 < \gamma < 1$, $1 , then <math>I_{0+}^{\gamma}$ is a bounded operator from \mathcal{L}^p into \mathcal{L}^q with $q = p(1 - \gamma p)^{-1}$.

- ii. For any $0 < \gamma < 1$ and any $p \ge 1$, $\mathcal{I}_{\gamma,p}^+$ is continuously embedded in $\operatorname{Hol}(\gamma 1/p)$ provided that $\gamma 1/p > 0$.
- iii. For any $0 < \gamma < \beta < 1$, $Hol(\beta)$ is compactly embedded in $\mathcal{I}_{\gamma,\infty}$.
- iv. For $\gamma p < 1$, the spaces $\mathcal{I}_{\gamma,p}^+$ and $\mathcal{I}_{\gamma,p}^-$ are canonically isomorphic. We will thus use the notation $\mathcal{I}_{\gamma,p}$ to denote any of this spaces.

3. Malliavin calculus and time reversal

Our reference probability space is $\Omega = \mathcal{C}_0([0,T], \mathbf{R}^n)$, the space of \mathbf{R}^n -valued, continuous functions, null at time 0. The Cameron-Martin space is denoted by \mathbf{H} and is defined as $\mathbf{H} = I_{0+}^1(\mathcal{L}^2([0,T]))$. In what follows, the space $\mathcal{L}^2([0,T])$ is identified with its topological dual. We denote by κ the canonical embedding from \mathbf{H} into Ω . The probability measure \mathbf{P} on Ω is such that the canonical map $W: \omega \mapsto (\omega(t), t \in [0,T])$ defines a standard n-dimensional Brownian motion. A mapping ϕ from Ω into some separable Hilbert space \mathfrak{H} is called cylindrical if it is of the

form $\phi(w) = \sum_{i=1}^d f_i(\langle v_{i,1}, w \rangle, \cdots, \langle v_{i,n}, w \rangle) x_i$ where for each $i, f_i \in \mathcal{C}_0^{\infty}(\mathbf{R}^n, \mathbf{R})$ and $(v_{i,j}, j = 1 \dots n)$ is a sequence of Ω^* . For such a function we define $\nabla^{\mathbf{W}} \phi$ as

$$\nabla^{\mathbf{W}}\phi(w) = \sum_{i,j=1} \partial_j f_i(\langle v_{i,1}, w \rangle, \cdots, \langle v_{i,n}, w \rangle) \tilde{v}_{i,j} \otimes x_i,$$

where \tilde{v} is the image of $v \in \Omega^*$ by the map $(I_{0+}^1 \circ \kappa)^*$. From the quasi-invariance of the Wiener measure [39], it follows that ∇^{W} is a closable operator on $L^p(\Omega; \mathfrak{H})$, $p \geq 1$, and we will denote its closure with the same notation. The powers of ∇^{W} are defined by iterating this procedure. For p > 1, $k \in \mathbb{N}$, we denote by $\mathbb{D}_{p,k}(\mathfrak{H})$ the completion of \mathfrak{H} -valued cylindrical functions under the following norm

$$\|\phi\|_{p,k} = \sum_{i=0}^{k} \|(\nabla^{\mathbf{W}})^{i}\phi\|_{L^{p}(\Omega; \, \mathfrak{H}\otimes \mathcal{L}^{p}([0,1])^{\otimes i})}.$$

We denote by $\mathbb{L}_{p,1}$ the space $\mathbb{D}_{p,1}(\mathcal{L}^p([0,T];\mathbf{R}^n)$. The divergence, denoted δ^{W} is the adjoint of ∇^{W} : v belongs to $\mathrm{Dom}_p \delta^{\mathrm{W}}$ whenever for any cylindrical ϕ ,

$$|\mathbf{E}\left[\int_0^T v_s \nabla_s^{\mathbf{W}} \phi \, \mathrm{d}s\right]| \le c \|\phi\|_{L^p}$$

and for such a process v,

$$\mathbf{E}\left[\int_{0}^{T}v_{s}
abla_{s}^{\mathrm{W}}\phi\;\mathrm{d}s
ight]=\mathbf{E}\left[\phi\,\delta^{\mathrm{W}}v
ight].$$

We need first to introduce the "time reversal" operator, denoted by τ_T and defined by:

$$\tau_T: \mathcal{L}^0([0,T]; \mathbf{R}^n) \longrightarrow \mathcal{L}^0([0,T]; \mathbf{R}^n)$$

$$\omega \longmapsto \omega(T-.).$$

We introduced the temporary notation W for standard Brownian to clarify the forthcoming distinction between a standard Brownian motion and its time reversal. Actually, the time reversal of a standard Brownian is also a standard Brownian motion and thus, both of them "live" in the same Wiener space. We now precise how their respective Malliavin gradient and divergence are linked. Consider $B = (B(t), t \in [0, T])$ an n-dimensional standard Brownian motion and $\check{B}^T = (B(T) - B(T-t), t \in [0, T])$ its time reversal. Consider the following map

$$\Theta_T: \Omega \longrightarrow \Omega$$

$$\omega \longmapsto \check{\omega} = \omega(T) - \tau_T \omega.$$

and the commutative diagram

$$\begin{array}{ccc} \mathcal{L}^2 & \stackrel{\tau_T}{\longrightarrow} & \mathcal{L}^2 \\ I_{0+}^1 \Big\downarrow & & & \Big\downarrow I_{0+}^1 \\ \Omega \supset \mathbf{H} & \stackrel{\Theta_T}{\longrightarrow} & \mathbf{H} \subset \Omega \end{array}$$

Note that $\Theta_T^{-1} = \Theta_T$ since $\omega(0) = 0$. For a function $f \in \mathcal{C}_b^{\infty}(\mathbf{R}^{nk})$, we define

$$\nabla_r f(\omega(t_1), \dots, \omega(t_k)) = \sum_{\substack{j=1\\k}}^k \partial_j f(\omega(t_1), \dots, \omega(t_k)) \mathbf{1}_{[0, t_j]}(r) \text{ and }$$

$$\check{\nabla}_r f(\check{\omega}(t_1), \cdots, \check{\omega}(t_k)) = \sum_{j=1}^k \partial_j f(\check{\omega}(t_1), \cdots, \check{\omega}(t_k)) \mathbf{1}_{[0, t_j]}(r).$$

The operator $\nabla = \nabla^B$ (respectively $\check{\nabla} = \nabla^{\check{B}}$) is the Malliavin gradient associated with a standard Brownian motion (respectively its time reversal). Since,

$$f(\check{\omega}(t_1), \cdots, \check{\omega}(t_k)) = f(\omega(T) - \omega(T - t_1), \cdots, \omega(T) - \omega(T - t_k)),$$

we can consider $f(\check{\omega}(t_1), \dots, \check{\omega}(t_k))$ as a cylindrical function with respect to the standard Brownian motion. As such its gradient is given by

$$\nabla_r f(\check{\omega}(t_1), \cdots, \check{\omega}(t_k)) = \sum_{j=1}^k \partial_j f(\check{\omega}(t_1), \cdots, \check{\omega}(t_k)) \mathbf{1}_{[T-t_j, T]}(r).$$

We thus have, for any cylindrical function F,

(4)
$$\nabla F \circ \Theta_T(\omega) = \tau_T \check{\nabla} F(\check{\omega}).$$

Since $\Theta_T^* \mathbf{P} = \mathbf{P}$ and τ_T is continuous from \mathcal{L}^p into itself for any p, it is then easily shown that the spaces $\mathbb{D}_{p,k}$ and $\check{\mathbb{D}}_{p,k}$ (with obvious notations) coincide for any p,k and that (4) holds for any element of one of theses spaces. Hence we have proved the following theorem:

Theorem 3.1. For any $p \ge 1$ and any integer k, the spaces $\mathbb{D}_{p,k}$ and $\check{\mathbb{D}}_{p,k}$ coincide. For any $F \in \mathbb{D}_{p,k}$ for some p, k,

$$\nabla(F \circ \Theta_T) = \tau_T \check{\nabla}(F \circ \Theta_T), \mathbf{P} \ a.s..$$

By duality, an analog result about follows for divergences.

Theorem 3.2. A process u belongs to the domain of δ if and only if $\tau_T u$ belongs to the domain of $\check{\delta}$ and then, the following equality holds:

(5)
$$\check{\delta}(u(\check{\omega}))(\check{\omega}) = \delta(\tau_T u(\check{\omega}))(\omega) = \delta(\tau_T u \circ \Theta_T)(\omega).$$

Proof. For $h \in \mathcal{L}^2$, for cylindrical F, we have on the one hand:

$$\mathbf{E}\left[F(\check{\omega})\check{\delta}h(\check{\omega})\right] = \mathbf{E}\left[(\check{\nabla}F(\check{\omega}),\,h)_{\mathcal{L}^2}\right],$$

and on the other hand.

$$\begin{split} \mathbf{E}\left[(\check{\nabla}F(\check{\omega}),\,h)_{\mathcal{L}^{2}}\right] &= \mathbf{E}\left[(\tau_{T}\nabla F\circ\Theta_{T}(\omega),\,h)_{\mathcal{L}^{2}}\right] \\ &= \mathbf{E}\left[(\nabla F\circ\Theta_{T}(\omega),\,\tau_{T}h)_{\mathcal{L}^{2}}\right] \\ &= \mathbf{E}\left[F\circ\Theta_{T}(\omega)\delta(\tau_{T}h)(\omega)\right] \\ &= \mathbf{E}\left[F(\check{\omega})\delta(\tau_{T}h)(\omega)\right]. \end{split}$$

Since this is valid for any cylindrical F, (5) holds for $h \in \mathcal{L}^2$. Now, for u in the domain of divergence (see [28, 39]),

$$\delta u = \sum_{i} \Big((u, h_i)_{\mathcal{L}^2} \delta h_i - (\nabla u, h_i \otimes h_i)_{\mathcal{L}^2 \otimes \mathcal{L}^2} \Big),$$

where $(h_i, i \in \mathbf{N})$ is an orthonormal basis of $\mathcal{L}^2([0, T]; \mathbf{R}^n)$. Thus, we have

$$\begin{split} \check{\delta}(u(\check{\omega}))(\check{\omega}) &= \sum_{i} \Big((u(\check{\omega}), \, h_{i})_{\mathcal{L}^{2}} \check{\delta}h_{i}(\check{\omega}) - (\check{\nabla}u(\check{\omega}), h_{i} \otimes h_{i})_{\mathcal{L}^{2} \otimes \mathcal{L}^{2}} \Big) \\ &= \sum_{i} \Big((u(\check{\omega}), \, h_{i})_{\mathcal{L}^{2}} \delta(\tau_{T}h_{i})(\omega) - (\nabla u(\check{\omega}), \tau_{T}h_{i} \otimes h_{i})_{\mathcal{L}^{2} \otimes \mathcal{L}^{2}} \Big) \\ &= \sum_{i} \Big((\tau_{T}u(\check{\omega}), \, \tau_{T}h_{i})_{\mathcal{L}^{2}} \delta(\tau_{T}h_{i})(\omega) - (\nabla \tau_{T}u(\check{\omega}), \tau_{T}h_{i} \otimes \tau_{T}h_{i})_{\mathcal{L}^{2} \otimes \mathcal{L}^{2}} \Big), \end{split}$$

where we have taken into account that τ_T in an involution. Since $(h_i, i \in \mathbf{N})$ is an orthonormal basis of $\mathcal{L}^2([0,T];\mathbf{R}^n)$, identity (5) is satisfied for any u in the domain of δ .

3.1. Causality and quasi-nilpotence. In anticipative calculus, the notion of trace of an operator plays a crucial role, we refer to [10] for more details on trace.

Definition 3.1. Let V be a bounded map from $\mathcal{L}^2([0,T];\mathbf{R}^n)$ into itself. The map V is said to be trace-class whenever for one CONB $(h_n, n \ge 1)$ of $\mathcal{L}^2([0, T]; \mathbf{R}^n)$,

$$\sum_{n\geq 1} |(Vh_n, h_n)_{\mathcal{L}^2}| \text{ is finite.}$$

Then, the trace of V is defined by

$$\operatorname{trace}(V) = \sum_{n>1} (Vh_n, h_n)_{\mathcal{L}^2}.$$

It is easily shown that the notion of trace does not depend on the choice of the CONB.

Definition 3.2. A family E of projections E_{λ} , $\lambda \in [0,1]$ in a Hilbert space H is called a resolution of the identity if it satisfies the conditions

- (1) $E_0 = 0$ and $E_1 = \text{Id}$.
- (2) $E_{\lambda}E_{\mu} = E_{\lambda \wedge \mu}$. (3) $\lim_{\mu \downarrow \lambda} E_{\mu} = E_{\lambda}$ for any $\lambda \in [0, 1)$ and $\lim_{\mu \uparrow 1} E_{\mu} = \operatorname{Id}$.

For instance, the family $E = (e_{\lambda T}, \lambda \in [0, 1])$ is a resolution of the identity in $\mathcal{L}^2([0,T];\mathbf{R}^n).$

Definition 3.3. A partition π of [0, T] is a sequence $\{0 = t_0 < t_1 < ... < t_n = T\}$. Its mesh is denoted by $|\pi|$ and defined by $|\pi| = \sup_i |t_{i+1} - t_i|$. For $t \in \pi \setminus \{T\}$, t_+ is the least term of π strictly greater than t.

The causality plays a crucial role in what follows. The next definition is just the formalization in terms of operator of the intuitive notion of causality.

Definition 3.4. A continuous map V from an Hilbert space H into itself is said to be E-causal if the following condition holds:

$$E_{\lambda}VE_{\lambda} = E_{\lambda}V$$
 for any $\lambda \in [0, 1]$.

For instance, for $H = \mathcal{L}^2([0,T); \mathbf{R}^n)$, an operator V in integral form Vf(t) = $\int_0^T V(t,s)f(s) ds$ is causal if and only if V(t,s)=0 for $s\geq t$, i.e., computing V(t,s)=0needs only the knowledge of f up to time t and not after. Unfortunately, this notion of causality is insufficient for our purpose and we are led to introduce the notion of strict causality as in [11].

Definition 3.5. Let V be a causal operator. It is a strictly causal operator whenever for any $\varepsilon > 0$ there exists a partition π of [0,T] such that for any $\pi' \subset \pi$,

$$||(E_{t'_{+}} - E_{t'})V(E_{t'_{+}} - E_{t'})|| < \varepsilon \text{ for any } t' \in \pi'.$$

Note carefully that the identity map is causal but not strictly causal. Indeed, if $V = \mathrm{Id}$,

$$||(E_{t'_{+}} - E_{t'})V(E_{t'_{+}} - E_{t'})|| = ||E_{t'_{+}} - E_{t'}|| = 1$$

 $\|(E_{t'_+}-E_{t'})V(E_{t'_+}-E_{t'})\|=\|E_{t'_+}-E_{t'}\|=1$ since $E_{t'_+}-E_{t'}$ is a projection. However, for $\gamma>0$, we have the following result:

Lemma 3.3. Let $H = \mathcal{L}^2([0, T); \mathbf{R}^n)$. Assume the resolution of the identity to be either $E = (e_{\lambda T}, \lambda \in [0, 1])$ or $E = (\operatorname{Id} - e_{(1-\lambda)T}, \lambda \in [0, 1])$. If V is an E-causal map continuous from \mathcal{L}^2 into \mathcal{L}^p for some p > 2 then V is strictly E-causal.

Proof. Let π be any partition of [0, T]. Assume $E = (e_{\lambda T}, \lambda \in [0, 1])$, the very same proof (replacing t_+ by t_- and reordering bounds in the integrals) works for the other mentioned resolution of the identity. According to Hölder formula, we have: For any $t \in \pi$,

$$||(E_{t+} - E_t)V(E_{t+} - E_t)f||_{\mathcal{L}^2}^2 = \int_t^{t+} V(f\mathbf{1}_{(t,r]})(s)^2 ds$$

$$\leq (r-t)^{\gamma+1/2} ||V(f\mathbf{1}_{(t,r]})||_{\mathcal{L}^{2/(1-2\gamma)}}$$

$$\leq c (r-t)^{\gamma+1/2} ||f||_{\mathcal{L}^2}.$$

Thus for any $\varepsilon > 0$, there exists $\eta > 0$ such that $|\pi| < \eta$ implies $||(E_{t_+} - E_t)V(E_{t_+} - E_t)V($ $E_t)f\|_{\mathcal{L}^2} \leq \varepsilon$. The proof is thus complete.

The importance of strict causality lies in the next theorem we borrow from [11].

Theorem 3.4. The set of strictly causal operators coincides with the set of quasinilpotent operators, i.e., trace-class operators such that $trace(V^n) = 0$ for any integer $n \geq 1$.

Moreover, we have the following stability theorem.

Theorem 3.5. The set of strictly causal operators is a two-sided ideal in the set of causal operators.

Definition 3.6. Let E be a resolution of the identity in the Hilbert space $\mathcal{L}^2([0, T]; \mathbf{R}^n)$. Consider the filtration \mathcal{F}^E defined as

$$\mathcal{F}_t^E = \sigma\{\delta^W(E_{\lambda}h), \lambda \le t, h \in \mathcal{L}^2\}.$$

An \mathcal{L}^2 -valued random variable u is said to be \mathcal{F}^E -adapted if for any $h \in \mathcal{L}^2$, the real valued process $\langle E_{\lambda}u, h \rangle$ is \mathcal{F}^E -adapted. We denote by $\mathbb{D}^E_{p,k}(\mathfrak{H})$ the set of \mathcal{F}^E -adapted random variable belonging to $\mathbb{D}_{p,k}(\mathfrak{H})$.

If $E = (e_{\lambda T}, \lambda \in [0, 1])$, the notion of \mathcal{F}^E adaptedness coincides with the usual one for the Brownian filtration and it is well known that a process u is adapted if and only if $\nabla_r^{\mathbf{W}} u(s) = 0$ for r > s. This result can be generalized to any resolution of the identity.

Theorem 3.6 (Proposition 3.1 of [40]). Let u belongs to $\mathbb{L}_{p,1}$. Then u is \mathcal{F}^E adapted if and only if $\nabla^W u$ is E-causal.

We then have the following key theorem:

Theorem 3.7. Assume the resolution of the identity to be $E = (e_{\lambda T}, \lambda \in [0, 1])$ either $E = (\operatorname{Id} - e_{(1-\lambda)T}, \lambda \in [0, 1])$. Assume that V is continuous from \mathcal{L}^2 into \mathcal{L}^p for some p > 2 and that V is E-strictly causal. Let u be an element of $\mathbb{D}_{2,1}^E(\mathcal{L}^2)$. Then, $V \nabla^W u$ is of trace class and we have $\operatorname{trace}(V \nabla^W u) = 0$.

Proof. Since u is adapted, $\nabla^W u$ is E-causal. According to Theorem 3.5, $V\nabla^W u$ is strictly causal and the result follows by Theorem 3.4.

In what follows, E^0 is the resolution of the identity in the Hilbert space \mathcal{L}^2 defined by $e_{\lambda}f = f\mathbf{1}_{[0,\lambda T]}$ and \check{E}^0 is the resolution of the identity defined by $\check{e}_{\lambda}f = f\mathbf{1}_{[(1-\lambda)T,T]}$. The filtration \mathcal{F}^{E^0} and $\mathcal{F}^{\check{E}^0}$ are defined accordingly. Next lemma is immediate when V is given in the form $Vf(t) = \int_0^t V(t,s)f(s) \, ds$. Unfortunately such a representation as an integral operator is not always available. We give here an algebraic proof to emphasize the importance of causality.

Lemma 3.8. Let V a map from $\mathcal{L}^2([0, T]; \mathbf{R}^n)$ into itself such that V is E^0 -causal. Then, the map $\tau_T V_T^* \tau_T$ is E-causal.

Proof. This is a purely algebraic lemma once we have noticed that

(6)
$$\tau_T e_r = (\operatorname{Id} - e_{T-r}) \tau_T \text{ for any } 0 \le r \le T.$$

For, it suffices to write

(7)
$$\tau_T e_T f(s) = f(T-s) \mathbf{1}_{[0,\,r]} (T-s)$$

= $f(T-s) \mathbf{1}_{[T-r,\,T]} (s) = (\operatorname{Id} -e_{T-r}) \tau_T f(s)$, for any $0 \le s \le T$.

We have to show that

$$e_r \tau_T V_T^* \tau_T e_r = e_r \tau_T V_T^* \tau_T$$
 or equivalently $e_r \tau_T V \tau_T e_r = \tau_T V \tau_T e_r$,

since $e_r^* = e_r$ and $\tau_r^* = \tau_r$. Now, (7) yields

$$e_r \tau_T V \tau_T e_r = \tau_T V \tau_T e_r - e_{T-r} V \tau_T e_r.$$

Use (7) again to obtain

$$e_{T-r}V\tau_re_r=e_{T-r}V(\mathrm{Id}-e_{T-r})\tau_r=(e_{T-r}V-e_{T-r}Ve_{T-r})\tau_r=0,$$
 since V is E -causal. \Box

4. Stochastic integration with respect to Volterra processes

In what follows, η belongs to (0,1] and V is a linear operator. For any $p \geq 2$, we set

Hypothesis I (p, η) . The linear map V is continuous from $\mathcal{L}^p([0, T]; \mathbf{R}^n)$ into the Banach space $\text{Hol}(\eta)$.

Definition 4.1. Assume that Hypothesis $I(p, \eta)$ holds. The Volterra process associated to V, denoted by W^V is defined by

$$W^{V}(t) = \delta^{W}(V(\mathbf{1}_{[0,t]})), \text{ for all } t \in [0, T].$$

For any subdivision π of [0, T], i.e., $\pi = \{0 = t_0 < t_1 < \ldots < t_n = T\}$, of mesh $|\pi|$, we consider the Stratonovitch sums:

(8)
$$R^{\pi}(t,u) = \delta^{W} \left(\sum_{t_{i} \in \pi} \frac{1}{\theta_{i}} \int_{t_{i} \wedge t}^{t_{i+1} \wedge t} Vu(r) \, dr \, \mathbf{1}_{[t_{i}, t_{i+1})} \right) + \sum_{t_{i} \in \pi} \frac{1}{\theta_{i}} \iint_{[t_{i} \wedge t, t_{i+1} \wedge t]^{2}} V(\nabla_{r}^{W} u)(s) \, ds \, dr.$$

Definition 4.2. We say that u is V-Stratonovitch integrable on [0,t] whenever the family $R^{\pi}(t,u)$, defined in (8), converges in probability as $|\pi|$ goes to 0. In this case the limit will be denoted by $\int_0^t u(s) \circ dW^V(s)$.

Example 1. The first example is the so-called Lévy fractional Brownian motion of Hurst index H > 1/2, defined as

$$\frac{1}{\Gamma(H+1/2)} \int_0^t (t-s)^{H-1/2} dB_s = \delta(I_{T^-}^{H-1/2}(\mathbf{1}_{[0,t]})).$$

This amounts to say that $V = I_{T^-}^{H-1/2}$. Thus Hypothesis I(p, H-1/2-1/p) holds provided p(H-1/2) > 1.

Example 2. The other classical example is the fractional Brownian motion with stationary increments of Hurst index H > 1/2, which can be written as

$$\int_0^t K_H(t,s) \ dB(s),$$

where

$$K_H(t,r) = \frac{(t-r)^{H-\frac{1}{2}}}{\Gamma(H+\frac{1}{2})}F(\frac{1}{2}-H,H-\frac{1}{2},H+\frac{1}{2},1-\frac{t}{r})1_{[0,t)}(r).$$

The Gauss hyper-geometric function $F(\alpha, \beta, \gamma, z)$ (see [24]) is the analytic continuation on $\mathbb{C} \times \mathbb{C} \times \mathbb{C} \setminus \{-1, -2, \ldots\} \times \{z \in \mathbb{C}, Arg | 1 - z | < \pi\}$ of the power series

$$\sum_{k=0}^{+\infty} \frac{(\alpha)_k(\beta)_k}{(\gamma)_k k!} z^k,$$

and

$$(a)_0 = 1 \text{ and } (a)_k = \frac{\Gamma(a+k)}{\Gamma(a)} = a(a+1)\dots(a+k-1).$$

We know from [33] that K_H is an isomorphism from $\mathcal{L}^p([0,1])$ onto $\mathcal{I}^+_{H+1/2,p}$ and

$$K_H f = I_{0+}^1 x^{H-1/2} I_{0+}^{H-1/2} x^{1/2-H} f$$

Consider $K_H = I^{-1} \circ K_H$. Then it is clear that

$$\int_0^t K_H(t, s) \ dB(s) = \int_0^t (\mathcal{K}_H)_T^* (\mathbf{1}_{[0,t]})(s) \ dB(s),$$

hence that we are in the framework of Definition 4.2 provided that we take $V = (\mathcal{K}_H)_T^*$. Hypothesis I(p, H - 1/2 - 1/p) is satisfied provided that p(H - 1/2) > 1.

Example 3. Beyond these two well known cases, we can investigate the case of multi-fractional Brownian motion defined as

$$\int_0^t K_{H(t)}(t,s) \ dB(s),$$

for a deterministic function H. Consider the linear map M_H defined by

$$M_H: \mathcal{L}^2 \longrightarrow \mathcal{L}^2$$

$$f \longmapsto \int_0^t K_{H(t)}(t, s) f(s) \ ds.$$

The next result is extracted from [7].

Theorem 4.1. Let H belong to $\operatorname{Hol}(\eta)$ for some $\eta > 1/2$ and be such that $\inf_t H(t) > \eta$. Then M_H is continuous from \mathcal{L}^p into $I_{n+1/2,n}^+$.

If we consider $\mathcal{M}_H = I_{0+}^{-1} \circ M_H$, it holds that

$$\int_0^t K_{H(t)}(t,s) \ dB(s) = \int_0^t (\mathcal{M}_H)_T^*(\mathbf{1}_{[0,t]})(s) \ dB(s).$$

For, we remark that

$$(\mathcal{M}_H)_T^* = (M_H)_T^* \circ I_{T^-}^{-1} = -(M_H)_T^* \circ I_{0+}^{-1}.$$

Extending all the operators to distributions, we can write

$$(\mathcal{M}_H)_T^*(\mathbf{1}_{[0,t]})(s) = (M_H)_T^* \varepsilon_t(s) = \int_0^T K_{H(r)}(r,s) \ d\varepsilon_t(r) = K_{H(t)}(t,s).$$

Thus, Hypothesis $I(p, \eta - 1/2 - 1/p)$ is satisfied with $V = (\mathcal{M}_H)_T^*$ provided that $p(\eta - 1/2) > 1$.

Note that in this last example we do not have an expression of V as a kernel operator. This justifies the operator-theoretic approach of the sequel.

The next theorem then follows from [7]. For the sake of completeness, we reproduce its proof.

Theorem 4.2. Assume that Hypothesis $I(p, \eta)$ holds. Assume that u belongs to $\mathbb{L}_{p,1}$. Then u is V-Stratonovitch integrable, there exists a process which we denote by $D^{\mathbb{W}}Wu$ such that $D^{\mathbb{W}}u$ belongs to $L^p(\mathbf{P}\otimes ds)$ and

(9)
$$\int_{0}^{T} u(s) \circ dW^{V}(s) = \delta^{W}(Vu) + \int_{0}^{T} D^{W}u(s) ds.$$

Moreover, for any $r \leq T$, $e_r u$ is V Stratonovitch integrable and

$$\int_0^r u(s) \circ dW^V(s) = \int_0^T (e_r u)(s) \circ dW^V(s) = \delta^W(V e_r u) + \int_0^r D^W u(s) ds.$$

Proof. Since u belongs to $\mathbb{L}_{p,\,1}$, $d\mathbf{P}\otimes dr$ -a.s., the map $(s\mapsto \nabla^{\mathrm{W}}_r u_s)$ belongs to \mathcal{L}^p . Then, hypothesis $\mathrm{I}(p)$ entails that $(s\mapsto V(\nabla^{\mathrm{W}}_r u)_s)$ is η -Hölder continuous. The map

$$\Omega \times [0, T] \longrightarrow \operatorname{Hol}(\eta)^* \times \operatorname{Hol}(\eta)$$
$$(\omega, r) \longmapsto (\varepsilon_r, (s \mapsto V(\nabla_r^{\mathbf{W}} u)_s))$$

is measurable, hence the process

$$D^{\mathbf{W}}u(\omega, r) = \langle \varepsilon_r, V(\nabla_r^{\mathbf{W}}u)(.) \rangle_{\mathrm{Hol}(\eta)^*, \mathrm{Hol}(\eta)} = V(\nabla_r^{\mathbf{W}}u)(r),$$

is measurable. Moreover,

$$\mathbf{E}\left[\int_{0}^{T} |D^{\mathbf{W}}u(r)|^{p} dr\right] = \mathbf{E}\left[\int_{0}^{T} |\langle \varepsilon_{r}, V(\nabla_{r}^{\mathbf{W}}u)(.)\rangle_{\mathrm{Hol}(\eta)^{*},\mathrm{Hol}(\eta)}|^{p} dr\right]$$

$$\leq \mathbf{E}\left[\int_{0}^{T} \|\varepsilon_{r}\|_{\mathrm{Hol}(\eta)^{*}}^{p} \|V(\nabla_{r}^{\mathbf{W}}u)\|_{\mathrm{Hol}(\eta)}^{p} dr\right]$$

$$\leq c T^{p\eta} \|u\|_{\mathbb{L}_{p-1}}^{p}.$$
(10)

Then, we have

$$(11) \quad \mathbf{E} \left[\left| \sum_{t_{i} \in \pi} \frac{1}{\theta_{i}} \iint_{[t_{i} \wedge t, t_{i+1} \wedge t]^{2}} \left(V(\nabla_{r}^{\mathbf{W}} u)(s) - D^{\mathbf{W}} u(r) \right) \, \mathrm{d}s \, \mathrm{d}r \right|^{p} \right]$$

$$\leq \mathbf{E} \left[\left| \sum_{t_{i} \in \pi} \frac{1}{\theta_{i}} \iint_{[t_{i} \wedge t, t_{i+1} \wedge t]^{2}} \left| \langle \varepsilon_{s} - \varepsilon_{r}, V(\nabla_{r}^{\mathbf{W}} u) \rangle_{\mathrm{Hol}(\eta)^{*}, \mathrm{Hol}(\eta)} \right|^{p} \, \mathrm{d}s \, \mathrm{d}r \right] \right]$$

$$\leq \mathbf{E} \left[\left| \sum_{t_{i} \in \pi} \frac{1}{\theta_{i}} \iint_{[t_{i} \wedge t, t_{i+1} \wedge t]^{2}} \|\varepsilon_{s} - \varepsilon_{r}\|_{\mathrm{Hol}(\eta)^{*}}^{p} \|V(\nabla_{r}^{\mathbf{W}} u)\|_{\mathrm{Hol}(\eta)}^{p} \, \mathrm{d}s \, \mathrm{d}r \right] \right]$$

$$\leq c \, \mathbf{E} \left[\left| \sum_{t_{i} \in \pi} \frac{1}{\theta_{i}} \iint_{[t_{i} \wedge t, t_{i+1} \wedge t]^{2}} (s - r)^{p\eta} \int_{0}^{T} |\nabla_{r}^{\mathbf{W}} u(a)|^{p} \, \mathrm{d}a \, \mathrm{d}s \, \mathrm{d}r \right] \right]$$

$$\leq c \, |\pi|^{p\eta} \, \mathbf{E} \left[\left| \sum_{t_{i} \in \pi} \int_{t_{i} \wedge t}^{t_{i+1} \wedge t} \int_{0}^{T} |\nabla_{r}^{\mathbf{W}} u_{a}|^{p} \, \mathrm{d}a \, \mathrm{d}r \right]$$

$$\leq c \, |\pi|^{p\eta} \, \|u\|_{\|u_{i}\|_{L^{\infty}}^{p}}^{p}.$$

Since

$$\sum_{t_i \in \pi} \frac{1}{\theta_i} \iint_{[t_i \wedge t, t_{i+1} \wedge t]^2} D^{\mathbf{W}} u(r) \, ds \, dr = \int_0^T D^{\mathbf{W}} u(r) \, dr,$$

Eqn. (11) means that

$$\sum_{t_i \in \pi} \frac{1}{\theta_i} \iint_{[t_i \wedge t, t_{i+1} \wedge t]^2} V(\nabla_r^{\mathbf{W}} u)(s) \, dr \, ds \xrightarrow{L^p(\mathbf{P})}_{|\pi| \to 0} \int_0^T D^{\mathbf{W}} u(r) \, dr.$$

The remaining of the proof of (9) follows the classical proof for convergence of Stratonovitch sums as exposed in [28].

Theorem 4.3. Assume that Hypothesis $I(p, \eta)$ holds. Let u belong to $\mathbb{L}_{p,1}$. If $V\nabla^W u$ is of trace class, then

$$\int_0^T D^W u(s) \ ds = \operatorname{trace}(V \nabla^W u).$$

Moreover.

$$\mathbf{E}\left[\left|\operatorname{trace}(V\nabla^{W}u)\right|^{p}\right] \leq c \|u\|_{\mathbb{L}_{p,1}}^{p}.$$

Proof. For each k, let $(\phi_{k,m}, m = 1, \dots, 2^k)$ be the functions $\phi_{k,m} = 2^{k/2} \mathbf{1}_{[(m-1)2^{-k}, m2^{-k})}$. Let P_k be the projection onto the span of the $\phi_{k,m}$, since $\nabla^W V u$ is of trace class, we have (see [34])

$$\operatorname{trace}(V\nabla^{\mathbf{W}}p_tu) = \lim_{k \to +\infty} \operatorname{trace}(P_k V\nabla^{\mathbf{W}}p_tu P_k).$$

Now,

$$\operatorname{trace}(P_k V \nabla^{\mathbf{W}} u P_k) = \sum_{m=1}^k (V \nabla^{\mathbf{W}} p_t u, \ \phi_{k,m} \otimes \phi_{k,m})_{\mathcal{L}^2 \otimes \mathcal{L}^2}$$
$$= \sum_{m=1}^k 2^k \int_{(m-1)2^{-k} \wedge t}^{m2^{-k} \wedge t} \int_{(m-1)2^{-k} \wedge t}^{m2^{-k} \wedge t} V(\nabla_r^{\mathbf{W}} u)(s) \ ds \ dr.$$

According to the proof of Theorem 4.2, the first part of the theorem follows. The second part is then a rewriting of (10).

There is another result from [7] which is worth quoting for the sequel.

Theorem 4.4. Assume that Hypothesis $I(p, \eta)$ holds. Let u belong to $\mathbb{L}_{p,1}$. Then,

(12)
$$\mathbf{E}\left[\|\int_0^{\cdot} u(s) \circ dW^V(s)\|_{\mathrm{Hol}(\eta)}^p\right] \leq c \|u\|_{\mathbb{L}_{p,1}}^p,$$

where c does not depend on u.

We can then follow the approach given for Stratonovitch integral as in [28] and show that we have a substitution formula. For $p \ge 1$, let Γ_p be the set of random fields:

$$u: \mathbf{R}^m \longrightarrow \mathbb{L}_{p,1}$$

 $x \longmapsto ((\omega, s) \mapsto u(\omega, s, x))$

equipped with the semi-norms,

$$p_K(u) = \sup_{x \in K} ||u(x)||_{\mathbb{L}_{p,1}}$$

for any compact K of \mathbf{R}^m .

Corollary 4.5. Assume that Hypothesis $I(p, \eta)$ holds. Let $\{u(x), x \in \mathbf{R}^m\}$ belong to Γ_p . Let F be a random variable such that $((\omega, s) \mapsto u(\omega, s, F))$ belongs to $\mathbb{L}_{p,1}$. Then,

(13)
$$\int_0^T u(s,F) \circ dW^V(s) = \int_0^T u(s,x) \circ dW_s^V \bigg|_{x=F} .$$

Proof. Simple random fields of the form

$$u(\omega, s, x) = \sum_{l=1}^{K} H_l(x)u_l(\omega, s)$$

with H_l smooth and u_l in $\mathbb{L}_{p,1}$ are dense in Γ_p . In view of (12), it is sufficient to prove the result for such random fields. By linearity, we can reduce the proof to random fields of the form $H(x)u(\omega, s)$. Now for any partition π ,

$$\begin{split} \delta^{\mathrm{W}} \Big(\sum_{t_i \in \pi} \frac{1}{\theta_i} \int_{t_i \wedge t}^{t_{i+1} \wedge t} & H(F) V(u(\omega,.))(r) \ \mathrm{d}r \ \mathbf{1}_{[t_i, \ t_{i+1})} \Big) \\ &= H(F) \delta^{\mathrm{W}} \Big(\sum_{t_i \in \pi} \frac{1}{\theta_i} \int_{t_i \wedge t}^{t_{i+1} \wedge t} & V(u(\omega,.))(r) \ \mathrm{d}r \ \mathbf{1}_{[t_i, \ t_{i+1})} \Big) \\ &- \sum_{t_i \in \pi} \int_{t_i \wedge t}^{t_{i+1} \wedge t} \int_{t_i \wedge t}^{t_{i+1} \wedge t} & H'(F) \nabla_s^{\mathrm{W}} F \, Vu(r) \ \mathrm{d}s \ \mathrm{d}r. \end{split}$$

On the other hand,

$$\nabla_s^{W}(H(F)u(\omega, r)) = H'(F)\nabla_s^{W}Fu(r),$$

hence

$$\sum_{t_i \in \pi} \frac{1}{\theta_i} \iint_{[t_i \wedge t, t_{i+1} \wedge t]^2} V(\nabla_r^{\mathbf{W}} H(F) u)(s) \, ds \, dr$$

$$= \sum_{t_i \in \pi} \frac{1}{\theta_i} \iint_{[t_i \wedge t, t_{i+1} \wedge t]^2} H'(F) \nabla_s^{\mathbf{W}} F V u(r) \, ds \, dr.$$

According to Theorem 4.2, Eqn. (13) is satisfied for simple random fields. \Box

Definition 4.3. For any $0 \le r \le t \le T$, for u in $\mathbb{L}_{p,1}$, we define $\int_r^t u(s) \circ dW^V(s)$

$$\begin{split} \int_{r}^{t} u(s) \circ \ dW^{V}(s) &= \int_{0}^{t} u(s) \circ \ dW^{V}(s) - \int_{0}^{r} u(s) \circ \ dW^{V}(s) \\ &= \int_{0}^{T} e_{t} u(s) \ dW^{V}(s) - \int_{0}^{T} e_{r} u(s) \circ \ dW^{V}(s) \\ &= \delta^{W}(V(e_{t} - e_{r})u) + \int_{r}^{t} D^{W}u(s) \ ds. \end{split}$$

Lemma 4.6. Let A and B be two continuous maps from $\mathcal{L}^2([0, T]; \mathbf{R}^n)$ into itself. Then, the map $\tau_T A \otimes B$ (resp. $A\tau_T \otimes B$) is of trace class if and only if the map $A \otimes \tau_T B$ (resp. $A \otimes B\tau_T$) is of trace class. Moreover, in such a situation,

$$\operatorname{trace}(\tau_T A \otimes B) = \operatorname{trace}(A \otimes \tau_T B), \ \operatorname{resp.} \ \operatorname{trace}(A\tau_T \otimes B) = \operatorname{trace}(A \otimes B\tau_T).$$

Proof. The map $\tau_T A \otimes B$ is of trace class if and only if for $(h_n, n \geq 1)$ a CONB of \mathcal{L}^2 ,

$$\sum_{n} |(\tau_{T} A \otimes B, h_{n} \otimes h_{n})_{\mathcal{L}^{2}}| < \infty.$$

But,

$$\sum_{n} |(\tau_{T}A \otimes B, h_{n} \otimes h_{n})_{\mathcal{L}^{2}}| = \sum_{n} |(\tau_{T}Ah_{n}, Bh_{n})_{\mathcal{L}^{2}}|$$

$$= \sum_{n} |(Ah_{n}, \tau_{T}Bh_{n})_{\mathcal{L}^{2}}|$$

$$= \sum_{n} |(A \otimes \tau_{T}B, h_{n} \otimes h_{n})_{\mathcal{L}^{2}}|,$$

since τ_T is self-adjoint in \mathcal{L}^2 . The first result follows. The second part follows by adjunction.

Corollary 4.7. Let $u \in \mathbb{L}_{2,1}$ such that $\nabla^W \otimes \tau_T V u$ and $\nabla^W \otimes V \tau_T u$ are of trace class. Then, $\tau_T \nabla^W \otimes V u$ and $\nabla^W \tau_T \otimes V u$ are of trace class. Moreover, we have:

$$\operatorname{trace}(\nabla^W \otimes \tau_T V u) = \operatorname{trace}(\tau_T \nabla^W \otimes V u)$$

and
$$\operatorname{trace}(\nabla^W \otimes (V\tau_T)u) = \operatorname{trace}(\nabla^W \tau_T \otimes Vu).$$

Proof. For u simple, i.e., of the form

$$u(\omega, s) = \sum_{i=1}^{n} U_i(\omega) g_i(s),$$

the result follows from Lemma 4.6. Such random fields are dense in Γ_p and according to Theorem 4.3, the trace function is continuous on Γ_p hence the result is satisfied in full generality.

Theorem 4.8. Assume that Hypothesis $I(p, \eta)$ holds. Let u belong to $\mathbb{L}_{p,1}$ and let $\check{V}_T = \tau_t V \tau_T$. Assume furthermore that V is \check{E}_0 -causal and that $\check{u} = u \circ \Theta_T^{-1}$ is $\mathcal{F}^{\check{E}_0}$ -adapted. Then,

(14)
$$\int_{T-t}^{T-r} \tau_T u(s) \circ dW^V(s) = \int_r^t \check{V}_T(\mathbf{1}_{[r,t]}\check{u})(s) \ d\check{B}^T(s), \ 0 \le r \le t \le T,$$

where the last integral is an Itô integral with respect to the time reversed Brownian motion $\check{B}^T(s) = B(T) - B(T-s) = \Theta_T(B)(s)$.

Proof. We first study the divergence term. In view of 3.2, we have

$$\begin{split} \delta^B(V(e_{T-r}-e_{T-t})\tau_T\check{u}\circ\Theta_T) &= \delta^B(V\tau_T(e_t-e_r)\check{u}\circ\Theta_T) \\ &= \delta^B(\tau_T\check{V}_T(e_t-e_r)\check{u}\circ\Theta_T) \\ &= \check{\delta}(\check{V}_T(e_t-e_r)\check{u})(\check{\omega}) \\ &= \int_r^t \check{V}_T(\mathbf{1}_{[r,t]}\check{u})(s) \ \mathrm{d}B^T(s). \end{split}$$

According to Theorem 3.8, $(\check{V}_T)^*$ is \check{E}_0 causal and according to 3.3, it is strictly \check{E}_0 causal. Thus, Theorem 3.7 implies that $\check{\nabla}V(e_t-e_r)\check{u}$ is of trace class and quasi-nilpotent. Hence Lemma 4.7 induces that

$$\tau_T \check{V}_T \tau_T \otimes \tau_T \check{\nabla} \tau_T (e_t - e_r) \check{u}$$

is trace-class and quasi-nilpotent. Now, according to Theorem 3.1, we have

$$\tau_T \check{V}_T \tau_T \otimes \tau_T \check{\nabla} \tau_T (e_t - e_r) \check{u} = V(\nabla \tau_T (e_{T-r} - e_{T-t}) \check{u} \circ \Theta_T).$$

According to Theorem 4.2, we have proved (14).

Remark 4.1. Note that at a formal level, we could have an easy proof of this theorem. For instance, consider the Levy fBm, a simple computations shows that $\check{V}_T = I_{0+}^{H-1/2}$ for any T. Thus, we are led to compute $\operatorname{trace}(I_{0+}^{H-1/2}\nabla u)$. If we had sufficient regularity, we could write

$$\operatorname{trace}(I_{0+}^{H-1/2}\nabla u) = \int_{0}^{T} \int_{0}^{s} (s-r)^{H-3/2}\nabla_{s}u(r) \ dr \ ds = 0,$$

since $\nabla_s u(r) = 0$ for s > r for u adapted. Obviously, there are many flaws in these lines of proof: The operator $I_{0+}^{H-1/2} \nabla u$ is not regular enough for such an expression of the trace to be true. Even more, there is absolutely no reason for $\check{V}_T \nabla u$ to be a kernel operator so we can't hope such a formula. These are the reasons that we need to work with operators and not with kernels.

5. Volterra driven SDEs

Let \mathfrak{G} the group of homeomorphisms of \mathbf{R}^n equipped with the distance: We introduce a distance d on \mathfrak{G} by

$$d(\varphi, \phi) = \rho(\varphi, \phi) + \rho(\varphi^{-1}, \phi^{-1}),$$

where

$$\rho(\varphi,\,\phi) = \sum_{N=1}^{\infty} 2^{-N} \frac{\sup_{|x| \le N} |\varphi(x) - \phi(x)|}{1 + \sup_{|x| \le N} |\varphi(x) - \phi(x)|}.$$

Then, $\mathfrak G$ is a complete topological group. Consider the equations

(A)
$$X_{r,t} = x + \int_r^t \sigma(X_{r,s}) \circ dW^V(s), \ 0 \le r \le t \le T.$$

(B)
$$Y_{r,t} = x - \int_{r}^{t} \sigma(Y_{s,t}) \circ dW^{V}(s), \ 0 \le r \le t \le T.$$

Definition 5.1. By a solution of (A), we mean a measurable map

$$\Omega \times [0,T] \times [0,T] \longrightarrow \mathfrak{G}$$

 $(\omega, r, t) \longmapsto (x \mapsto X_{r,t}(\omega, x))$

such that the following properties are satisfied:

- (1) For any $0 \le r \le t \le T$, for any $x \in \mathbf{R}^n$, $X_{r,t}(\omega, x)$ is $\sigma\{W^V(s), r \le s \le t\}$ -measurable.
- (2) For any $0 \le r \le T$, for any $x \in \mathbf{R}^n$, the processes $(\omega, t) \mapsto X_{r,t}(\omega, x)$ and $(\omega, t) \mapsto X_{r,t}^{-1}(\omega, x)$ belong to $\mathbb{L}_{p,1}$ for some $p \ge 2$.
- (3) For any $0 \le r \le s \le t$, for any $x \in \mathbf{R}^n$, the following identity is satisfied:

$$X_{r,t}(\omega, x) = X_{s,t}(\omega, X_{r,s}(\omega, x)).$$

(4) Equation (A) is satisfied for any $0 \le r \le t \le T$ **P**-a.s..

Definition 5.2. By a solution of (B), we mean a measurable map

$$\Omega \times [0, T] \times [0, T] \longrightarrow \mathfrak{G}$$
$$(\omega, r, t) \longmapsto (x \mapsto Y_{r,t}(\omega, x))$$

such that the following properties are satisfied:

(1) For any $0 \le r \le t \le T$, for any $x \in \mathbf{R}^n$, $Y_{r,t}(\omega, x)$ is $\sigma\{W^V(s), r \le s \le t\}$ -measurable,

- (2) For any $0 \le r \le T$, for any $x \in \mathbf{R}^n$, the processes $(\omega, r) \mapsto Y_{r,t}(\omega, x)$ and $(\omega, r) \mapsto Y_{r,t}^{-1}(\omega, x)$ belong to $\mathbb{L}_{p,1}$ for some $p \geq 2$.
- (3) Equation (B) is satisfied for any $0 \le r \le t \le T$ **P**-a.s..
- (4) For any $0 \le r \le s \le t$, for any $x \in \mathbf{R}^n$, the following identity is satisfied:

$$Y_{r,t}(\omega, x) = Y_{r,s}(\omega, Y_{s,t}(\omega, x)).$$

At last consider the equation, for any $0 \le r \le t \le T$,

(C)
$$Z_{r,t} = x - \int_r^t \check{V}_T(\sigma \circ Z_{.,t} \mathbf{1}_{[r,t]})(s) \, d\check{B}^T(s)$$

where B is a standard n-dimensional Brownian motion.

Definition 5.3. By a solution of (C), we mean a measurable map

$$\Omega \times [0, T] \times [0, T] \longrightarrow \mathfrak{G}$$

 $(\omega, r, t) \longmapsto (x \mapsto Z_{r,t}(\omega, x))$

such that the following properties are satisfied:

- (1) For any $0 \le r \le t \le T$, for any $x \in \mathbf{R}^n$, $Z_{r,t}(\omega, x)$ is $\sigma\{\check{B}^T(s), s \le r \le t\}$ measurable.
- (2) For any $0 \le r \le t \le T$, for any $x \in \mathbf{R}^n$, the processes $(\omega, r) \mapsto Z_{r,t}(\omega, x)$ and $(\omega, r) \mapsto Z_{r,t}^{-1}(\omega, x)$ belong to $\mathbb{L}_{p,1}$ for some $p \geq 2$.

 (3) Equation (C) is satisfied for any $0 \leq r \leq t \leq T$ **P**-a.s..

Theorem 5.1. Assume that \check{V}_T is an E^0 causal map continuous from \mathcal{L}^p into $I_{\alpha,p}$ for $\alpha > 0$ and $p \geq 4$ such that $\alpha p > 1$. Assume σ is Lipschitz continuous and sub-linear, see Eqn. (21) for the definition. Then, there exists a unique solution to equation (C). Let Z denote this solution. For any (r, r'),

$$\mathbf{E}[|Z_{r,T} - Z_{r',T}|^p] \le c|r - r'|^{p\eta}.$$

Moreover.

$$(\omega, r) \mapsto Z_{r,s}(\omega, Z_{s,t}(\omega, x)) \in \mathbb{L}_{p,1}, \text{ for any } r \leq s \leq t \leq T.$$

Since this proof needs several lemmas, we defer it to Section 6.

Theorem 5.2. Assume that \check{V}_T is an E^0 causal map continuous from \mathcal{L}^p into $I_{\alpha,p}$ for $\alpha > 0$ and $p \geq 2$ such that $\alpha p > 1$. For fixed T, there exists a bijection between the space of solutions of Equation (B) on [0,T] and the set of solutions of Equation (C).

Proof. Set

$$Z_{r,T}(\check{\omega}, x) = Y_{T-r,T}(\Theta_T^{-1}(\check{\omega}), x)$$

or equivalently

(15)
$$Y_{r,T}(\omega, x) = Z_{T-r,T}(\Theta_T(\omega), x).$$

According to Theorem 4.8, Y is satisfies (B) if and only if Z satisfies (C). The regularity properties are immediate since \mathcal{L}^p is stable by τ_T .

The first part of the next result is then immediate.

Corollary 5.3. Assume that \check{V}_T is an E^0 causal map continuous from \mathcal{L}^p into $I_{\alpha,p}$ for $\alpha > 0$ and $p \geq 2$ such that $\alpha p > 1$. Then Equation (B) has one and only solution and for any $0 \leq r \leq s \leq t$, for any $x \in \mathbf{R}^n$, the following identity is satisfied:

$$(16) Y_{r,t}(\omega, x) = Y_{r,s}(\omega, Y_{s,t}(\omega, x)).$$

Proof. According to Theorem 5.2 and 5.1, (B) has at most one solution since (C) has a unique solution. As to the existence, point (1) to (3) are immediatly deduced from the corresponding properties of Z and Equation (15).

According to Theorem 5.1, $(\omega, r) \mapsto Y_{r,s}(\omega, Y_{s,t}(\omega, x))$ belongs to $\mathbb{L}_{p,1}$ hence we can apply the substitution formula and we get:

$$(17) \quad Y_{r,s}(\omega, Y_{s,t}(\omega, x)) = Y_{s,t}(\omega, x) - \int_{r}^{s} \sigma(Y_{\tau,s}(\omega, x)) \circ dW^{V}(\tau) \Big|_{x=Y_{s,t}(\omega, x)}$$
$$= x - \int_{s}^{t} \sigma(Y_{\tau,t}(\omega, x) \circ dW^{V}(\tau)$$
$$- \int_{r}^{s} \sigma(Y_{\tau,s}(\omega, Y_{s,t}(\omega, x))) \circ dW^{V}(\tau).$$

Set

$$R_{\tau,t} = \begin{cases} Y_{\tau,t}(\omega, x) & \text{for } s \le \tau \le t \\ Y_{\tau,s}(\omega, Y_{s,t}(\omega, x)) & \text{for } r \le \tau \le s. \end{cases}$$

Then, in view of (17), R appears to be the unique solution (B) and thus $R_{s,t}(\omega, x) = Y_{s,t}(\omega, x)$. Point (4) is thus proved.

Corollary 5.4. For x fixed, the random field $(Y_{r,t}(x), 0 \le r \le t \le T)$ admits a continuous version. Moreover,

$$\mathbf{E}[|Y_{r,s}(x) - Y_{r',s'}(x)|^p] \le c(1 + |x|^p)(|s' - s|^{p\eta} + |r - r'|^{p\eta}).$$

We still denote by Y this continuous version.

Proof. W.l.o.g. assume that $s \leq s'$ and remark that $Y_{s,\,s'(x)}$ thus belongs to $\sigma\{\check{B}_u^T,\,u\geq s\}.$

$$\begin{split} \mathbf{E} \left[|Y_{r,s}(x) - Y_{r',s'}(x)|^p \right] \\ & \leq c \left(\mathbf{E} \left[|Y_{r,s}(x) - Y_{r',s}(x)|^p \right] + \mathbf{E} \left[|Y_{r',s}(x) - Y_{r',s'}(x)|^p \right] \right) \\ & = c \left(\mathbf{E} \left[|Y_{r,s}(x) - Y_{r',s}(x)|^p \right] + \mathbf{E} \left[|Y_{r',s}(x) - Y_{r',s}(Y_{s,s'}(x))|^p \right] \right) \\ & = c \left(\mathbf{E} \left[|Z_{s-r,s}(x) - Z_{s-r',s}(x)|^p \right] + \mathbf{E} \left[|Z_{s-r',s}(x) - Z_{s-r',s}(Y_{s,s'}(x))|^p \right] \right). \end{split}$$

According to Theorem 6.2

(18)
$$\mathbf{E}\left[|Z_{s-r,s}(x) - Z_{s-r',s}(x)|^p\right] \le c|r - r'|^{p\eta}(1 + |x|^p).$$

In view of Theorem 4.8, the stochastic integral which appears in Equation (C) is also a Stratonovitch integral hence we can apply the substitution formula and say

$$Z_{s-r',s}(Y_{s,s'}(x)) = Z_{s-r',s}(y)|_{y=Y_{s,s'}(x)}$$
.

Thus we can apply Theorem 6.2 and we obtain

$$\mathbf{E}[|Z_{s-r',s}(x) - Z_{s-r',s}(Y_{s,s'}(x))|^p] \le c\mathbf{E}[|x - Y_{s,s'}(x)|^p].$$

The right hand side of this equation is in turn equal to $\mathbf{E}[|Z_{0,s'}-Z_{s'-s,s'}(x)|^p]$, thus, we get

(19)
$$\mathbf{E}\left[|Z_{s-r',s}(x) - Z_{s-r',s}(Y_{s,s'}(x))|^p\right] \le c(1+|x|^p)|s'-s|^{p\eta}$$

Combining (18) and (19) gives

$$\mathbf{E}[|Y_{r,s}(x) - Y_{r',s'}(x)|^p] \le c(1 + |x|^p)(|s' - s|^{p\eta} + |r - r'|^{p\eta}),$$

hence the result.

Thus, we have the main result of this paper.

Theorem 5.5. Assume that \check{V}_T is an E^0 causal map continuous from \mathcal{L}^p into $I_{\alpha,p}$ for $\alpha > 0$ and $p \geq 4$ such that $\alpha p > 1$. Then Equation (A) has one and only solution.

Proof. Under the hypothesis, we know that Equation (B) has a unique solution which satisfies (16). By definition of a solution of (B), the process $Y^{-1}:(\omega, s) \mapsto Y_{st}^{-1}(\omega, x)$ belongs to $\mathbb{L}_{p,1}$ hence we can apply the substitution formula. Following the lines of proof of the previous theorem, we see that Y^{-1} is a solution of (A).

In the reverse direction, two distinct solutions of (A) would give raise to two solutions of (B) by the same principles. Since this is definitely impossible in view of Theorem 5.3, Equation (A) has at most one solution.

6. The forward equation

Lemma 6.1. Assume that Hypothesis I holds and that σ is Lipschitz continuous. Then, for any $0 \le a \le b \le T$, the map

$$\check{V}_T \circ \sigma : C([0,T], \mathbf{R}^n) \longrightarrow C([0,T], \mathbf{R}^n)$$

$$\phi \longmapsto \check{V}_T(\sigma \circ \psi \ \mathbf{1}_{[a,b]})$$

is Lipschitz continuous and Gâteau differentiable. Its differential is given by:

(20)
$$d\check{V}_T \circ \sigma(\phi)[\psi] = \check{V}_T(\sigma' \circ \phi \ \psi).$$

Assume furthermore that σ is sub-linear, i.e.,

$$|\sigma(x)| \le c(1+|x|), \text{ for any } x \in \mathbf{R}^n.$$

Then, for any $\psi \in C([0,T], \mathbf{R}^n)$, for any $t \in [0,T]$,

$$|\check{V}_T(\sigma \circ \psi)(t)| \le cT^{\eta+1/p} (1 + \int_0^t |\psi(s)|^p ds)$$

$$\le cT^{\eta+1/p} (1 + ||\psi||_{\infty}).$$

Proof. Let ψ and ϕ be two continuous functions, since $C([0,T], \mathbf{R}^n)$ is continuously embedded in \mathcal{L}^p , $\check{V}_T(\sigma \circ \psi - \sigma \circ \phi)$ belongs to $\operatorname{Hol}(\eta)$. Morevover,

$$\sup_{t \leq T} |\check{V}_{T}(\sigma \circ \psi \ \mathbf{1}_{[a,b]})(t) - \check{V}_{T}(\sigma \circ \phi \ \mathbf{1}_{[a,b]})(t)| \leq c \, \|\check{V}_{T}((\sigma \circ \psi - \sigma \circ \phi) \ \mathbf{1}_{[a,b]})\|_{\mathrm{Hol}(\eta)}$$

$$\leq c \, \|(\sigma \circ \psi - \sigma \circ \phi) \ \mathbf{1}_{[a,b]}\|_{\mathcal{L}^{p}}$$

$$\leq c \, \|\phi - \psi\|_{\mathcal{L}^{p}([a,b])}$$

$$\leq c \, \sup_{t \leq T} |\psi(t) - \phi(t)|,$$

since σ is Lipschitz continuous.

Let ψ and ψ two continuous functions on [0,T]. Since σ is Lipschitz continuous, we have

$$\sigma(\psi(t) + \varepsilon \phi(t)) = \sigma(\psi(t)) + \varepsilon \int_0^1 \sigma'(u\psi(t) + (1 - u)\phi(t)) du.$$

Moreover, since σ is Lipschitz, σ' is bounded and

$$\int_0^T \left| \int_0^1 \sigma'(u\psi(t) + (1-u)\phi(t)) \, \mathrm{d}u \right|^p \, \mathrm{d}t \le c T.$$

This means that $(t \mapsto \int_0^1 \sigma'(u\psi(t) + (1-u)\phi(t)) du)$ belongs to \mathcal{L}^p . Hence, according to Hypothesis I,

$$\|\check{V}_T(\int_0^1 \sigma'(u\psi(.) + (1-u)\phi(.)) \, du)\|_C \le cT.$$

Thus.

$$\lim_{\varepsilon \to 0} \varepsilon^{-1} (\check{V}_T(\sigma \circ (\psi + \varepsilon \phi)) - \check{V}_T(\sigma \circ \psi)) \text{ exists},$$

and $\check{V}_T \circ \sigma$ is Gâteaux differentiable and its differential is given by (20). Since $\sigma \circ \psi$ belongs to $C([0,T], \mathbf{R}^n)$, according to Hypothesis I, we have:

$$|\check{V}_{T}(\sigma \circ \psi)(t)| \leq c \left(\int_{0}^{t} s^{\eta p} |\sigma(\psi(s))|^{p} ds \right)^{1/p}$$

$$\leq c T^{\eta} \left(\int_{0}^{t} (1 + |\psi(s)|^{p}) ds \right)^{1/p}$$

$$\leq c T^{\eta + 1/p} (1 + ||\psi||_{\infty}^{p})^{1/p}$$

$$\leq c T^{\eta + 1/p} (1 + ||\psi||_{\infty}^{p}).$$

The proof is thus complete.

Following [38], we then have the following non trivial result.

Theorem 6.2. Assume that Hypothesis I holds and that σ is Lipschitz continuous. Then, there exists one and only one measurable map from $\Omega \times [0,T] \times [0,T]$ into \mathfrak{G} which satisfies the first two points of Definition (C). Moreover,

$$\mathbf{E}[|Z_{r,t}(x) - Z_{r',t}(x')|^p] \le c(1 + |x|^p \lor |x'|^p) (|r - r'|^{p\eta} + |x - x'|^p).$$

Note even if x and x' are replaced by $\sigma\{\check{B}^T(u), t \leq u\}$ measurable random variables, the last estimate still holds.

Proof. Existence, uniqueness and homeomorphy of a solution of (C) follow from [38]. The regularity with respect to r and x is obtained as usual by BDG inequality and Gronwall Lemma. For x or x' random, use the independence of $\sigma\{\check{B}^T(u), t \leq u\}$ and $\sigma\{\check{B}^T(u), r \wedge r' \leq u \leq t\}$.

Corollary 6.3. Assume that Hypothesis I holds and that σ is Lipschitz continuous and sub-linear. Let Z be a solution of (C). Then, for any $x \in \mathbf{R}^n$, for any $0 \le r \le t \le T$, we have

$$\mathbf{E}[|Z_{r,t}(x)|^p] \le c(1+|x|^p)e^{cT^{\eta p+1}}$$

Proof. According to BDG inequality and Lemma 6.1, we have:

$$\mathbf{E} [|Z_{r,t}(x)|^p] \le c(|x|^p + \mathbf{E} \left[\int_r^t |\check{V}_T(\sigma \circ Z_{.,t}(x) \mathbf{1}_{[r,t]}(.))(s)|^p \, ds \right])$$

$$\le cT^{\eta p+1} (1 + |x|^p + \mathbf{E} \left[\int_r^t \int_r^s |Z_{\tau,t}(x)|^p \, d\tau \, ds \right]$$

$$\le cT^{\eta p+1} (1 + |x|^p + \int_r^t \mathbf{E} [|Z_{\tau,t}|^p] \, d\tau).$$

We then conclude by Gronwall Lemma.

Theorem 6.4. Assume that Hypothesis I holds and that σ is Lipschitz continuous and sub-linear. Then, for any $x \in \mathbf{R}^n$, for any $0 \le r \le s \le t \le T$, $(\omega, r) \mapsto Z_{r,s}(\omega, Z_{s,t}(x))$ and $(\omega, r) \mapsto Z_{r,t}^{-1}(\omega, x)$ belong to $\mathbb{L}_{p,1}$.

Proof. According to [18, Theorem 3.1], the differentiability of $\omega \mapsto Z_{r,t}(\omega, x)$ is ensured. Furthermore,

$$\nabla_u Z_{r,t} = -\check{V}_T(\sigma \circ Z_{.,t} \mathbf{1}_{[r,t]})(u) - \int_r^t \check{V}_T(\sigma'(Z_{.,t}) \cdot \nabla_u Z_{.,t} \mathbf{1}_{[r,t]})(s) \, d\check{B}(s),$$

where σ' is the differential of σ . Since \check{V}_T is continuous from \mathcal{L}^p in to itself and σ is Lipschitz, according to BDG inequality, for $r \leq u$,

$$\mathbf{E}\left[|\nabla_u Z_{r,t}|^p\right]$$

$$\leq c \mathbf{E} \left[|\check{V}_{T}(\sigma \circ Z_{.,t} \mathbf{1}_{[r,t]})(u)|^{p} \right] + c \mathbf{E} \left[\int_{r}^{t} |\check{V}_{T}(\sigma'(Z_{.,t}) \nabla_{u} Z_{.,t} \mathbf{1}_{[r,t]})(s)|^{p} \, \mathrm{d}s \right] \\
\leq c \left(1 + \mathbf{E} \left[\int_{r}^{t} u^{p\eta} \int_{r}^{u} |Z_{\tau,t}|^{p} \, \mathrm{d}\tau \, \mathrm{d}u \right] + \mathbf{E} \left[\int_{r}^{t} s^{p\eta} \int_{r}^{s} |\nabla_{u} Z_{\tau,t}|^{p} \, \mathrm{d}\tau \, \mathrm{d}s \right] \right) \\
\leq c \left(1 + \mathbf{E} \left[\int_{r}^{t} |Z_{\tau,t}|^{p} (t^{p\eta+1} - \tau^{p\eta+1}) \, \mathrm{d}\tau \right] + \mathbf{E} \left[\int_{r}^{t} |\nabla_{u} Z_{\tau,t}|^{p} (t^{p\eta+1} - \tau^{p\eta+1}) \, \mathrm{d}\tau \right] \right) \\
\leq c t^{p\eta+1} \left(1 + \mathbf{E} \left[\int_{r}^{t} |Z_{\tau,t}|^{p} \, \mathrm{d}\tau \right] + \mathbf{E} \left[\int_{r}^{t} |\nabla_{u} Z_{\tau,t}|^{p} \, \mathrm{d}\tau \right] \right).$$

Then, Gronwall Lemma entails that

$$\mathbf{E}\left[|\nabla_u Z_{r,t}|^p\right] \le c \left(1 + \mathbf{E}\left[\int_0^t |Z_{\tau,t}|^p \, d\tau\right]\right).$$

The integrability of $\mathbf{E}[|\nabla_u Z_{r,t}|^p]$ with respect to u follows.

Now, since $0 \le r \le s \le t \le T$, $Z_{s,t}(x)$ is independent of $Z_{r,s}(x)$, thus the previous computations still hold and $(\omega, r) \mapsto Z_{r,s}(\omega, Z_{s,t}(x))$ belong to $\mathbb{L}_{p,1}$.

According to [35], to prove that $Z_{r,t}^{-1}(x)$ belongs to $\mathbb{D}_{p,1}$, we need to prove

- (1) for every $h \in \mathcal{L}^2$, there exists an absolutely continuous version of the process $(t \mapsto Z_{r,t}^{-1}(\omega + th, x)),$
- (2) there exists $DZ_{r,t}^{-1}$, an \mathcal{L}^2 -valued random variable such that for every $h \in \mathcal{L}^2$,

$$\frac{1}{t}(Z_{r,t}^{-1}(\omega + th, x) - Z_{r,t}^{-1}(\omega, x)) \xrightarrow{t \to 0} \int_{0}^{T} DZ_{r,t}^{-1}(s)h(s) \, ds,$$

where the convergence holds in probability,

(3) $DZ_{r,t}^{-1}$ belongs to $\mathcal{L}^2(\Omega, \mathcal{L}^2)$.

We first show that

(22)
$$\mathbf{E}\left[\left|\frac{\partial Z_{r,t}}{\partial x}(\omega, Z_{r,t}^{-1}(x))\right|^{-p}\right] \text{ is finite.}$$

Since

$$\frac{\partial Z_{r,t}}{\partial x}(\omega, x) = \operatorname{Id} + \int_{r}^{t} \check{V}_{T}(\sigma'(Z_{.,t}(x)) \frac{\partial Z_{.,t}(\omega, x)}{\partial x})(s) \, d\check{B}(s),$$

Itô's formula and BDG inequality yield, for any $q \in \mathbf{R}$, for any $0 \le r \le v \le t \le T$,

$$\mathbf{E} \left[\sup_{u \leq v} |\partial_x Z_{u,t}(x)|^{2q} \right]$$

$$\leq c + c \mathbf{E} \left[\int_u^t \check{V}_T(\mathbf{1}_{[r,t]} \sigma'(Z_{.,t}(x)) \partial_x Z_{.,t}(x))(s)^2 |\partial_x Z_{s,t}(x)|^{2(q-1)} \, \mathrm{d}s \right]$$

$$+ c \mathbf{E} \left[\left(\int_u^t |\partial_x Z_{s,t}(x)|^{q-2} \check{V}_T(\mathbf{1}_{[r,t]} \sigma'(Z_{.,t}(x)) \partial_x Z_{.,t}(x))(s)^2 \, \mathrm{d}s \right)^2 \right].$$

Let $\Theta_v = \sup_{u < v} |\partial_x Z_{u,t}(x)|$, since \check{V}_T maps \mathcal{L}^p to \mathcal{L}^∞ , we have

$$\mathbf{E}\left[\Theta_v^{2q}\right] \le c + c \,\mathbf{E}\left[\int_u^t \Theta_s^{2(q-1)} \left(\int_u^s |\partial_x Z_{\tau,t}(x)|^p |\, d\tau\right)^{2/p} \, ds\right]$$

$$+ c \,\mathbf{E}\left[\left(\int_u^t \Theta_s^{q-2} \left(\int_u^s |\partial_x Z_{\tau,t}(x)|^p |\, d\tau\right)^{2/p}\right)^2 \, ds\right].$$

Hence,

$$\mathbf{E}\left[\Theta_v^{2q}\right] \leq c \left(1 + \int_v^t \mathbf{E}\left[\Theta_s^{2q}\right] \ \mathrm{d}s\right),$$

and (22) follows by Gronwall Lemma. Since $Z_{r,t}(\omega, Z_{r,t}^{-1}(\omega, x)) = x$, the implicit function theorem imply that $Z_{r,t}^{-1}(x)$ satisfies the first two properties and that

$$\nabla Z_{r,t}(\omega, Z_{r,t}^{-1}(x)) + \frac{\partial Z_{r,t}}{\partial x}(\omega, Z_{r,t}^{-1}(x))\tilde{\nabla} Z_{r,t}^{-1}(\omega, x).$$

It follows by Hölder inequality and Equation (22) that

$$||DZ_{r,t}^{-1}(x))||_{p,1} \le c||Z_{r,t}(x))||_{2p,1}||(\partial_x Z_{r,t}(x))^{-1}||_{2p,2}$$

hence $Z_{r,t}^{-1}$ belongs to $\mathbb{L}_{p,1}$.
