#### ERROR STUDIES OF THE COUPLING DARCY-STOKES SYSTEM

ABSTRACT. In this paper we study the Coupling Darcy-Stokes Systems. We establish a coupled variational formulation with the velocity and the pressure. The velocity is approximated with **curl** conforming finite elements and the pressure with standard continuous elements. We establish optimal a priori and a posteriori error estimates.

Keywords Stokes equations, Darcy equations, a piori and a posteriori errors.

#### 1. INTRODUCTION.

The numerical simulation of underground flows can be treated as cracks in porous media. Indeed, the flow of a viscous incompressible fluid in a porous medium is usually modelled by Darcy equations and, when the thickness of the crack is too large to be neglected, the Stokes system must be considered in the crack and coupled with these equations. In this work, we consider the following system already studied in [2], [3] and [4]:

Let  $\Omega$  and  $\Omega_F$  be bounded connected open domains in  $\mathbb{R}^3$  with Lipschitz-continuous boundaries, such that  $\overline{\Omega}_F$  is contained in  $\Omega$ . For simplicity, we also assume that  $\Omega_F$  is simply connected and has a connected boundary. We set  $\Omega_P = \Omega \setminus \overline{\Omega}_F$  and we denote by  $\Gamma = \partial \Omega_F$  the interface between  $\Omega_F$  and  $\Omega_P$ . Let also **n** stand for the unit outward normal vector to  $\Omega_P$  on its boundary  $\partial \Omega_P$ .

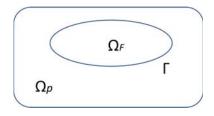


FIGURE 1. The geometry

We consider the following system of equations:

$$(P) \begin{cases} \mu \mathbf{u} + \nabla p = \mathbf{f} & \text{in } \Omega_P \\ -\nu \Delta \mathbf{u} + \nabla p = \mathbf{f} & \text{in } \Omega_F \\ \text{div } \mathbf{u} = 0 & \text{in } \Omega_P \cup \Omega_F \\ \mathbf{u}.\mathbf{n} = 0 & \text{on } \partial\Omega \\ (\mathbf{u}_{|\Omega_P} - \mathbf{u}_{|\Omega_F}).\mathbf{n} = 0 & \text{on } \Gamma \\ p_{|\Omega_P} - p_{|\Omega_F} = 0 & \text{on } \Gamma \\ \mathbf{curl } \mathbf{u}_{|\Omega_F} \times \mathbf{n} = 0 & \text{on } \Gamma \end{cases}$$

where **u** is the velocity, p the pressure, **f** the density of body forces and  $\nu$  and  $\mu$  positive constants.

For the Vorticity-velocity-pressure formulation for the Stokes problem, we refer to [6], [7] and [12]. In [1] and [8], we treat the Stokes problem with non-standard boundary conditions and we introduce velocity-pressure weak formulation. In [2], [3] and [4], the basic idea consists in introducing the vorticity  $\mathbf{w} = \mathbf{curl} \mathbf{u}$  as a new unknown on the fluid domain  $\Omega_F$ . However, we treat in this work the same systems with the unknowns  $\mathbf{u}$  and p without introducing the vorticity  $\mathbf{w}$ . Since, we can discretize the pressure and the velocity independently without a discrete inf-sup condition to obtain matrix systems with an optimal dimension and optimal time of resolution.

The outline of the paper is as follows:

- In Section 2, we introduce the problem, establish a decoupled variational formulation and prove its wellposedness.
- In section 3, we introduce the finite elements and a fully discrete system using the **curl** conforming finite elements for the velocity and the standard continuous elements for the pressure.
- We prove the a priori and a posteriori estimates in sections 4 and 5, respectively.

#### 2. Analysis of the model

In all the paper, we suppose that  $\mathbf{f} \in L^2(\Omega)^3$  and we denote by C and c generic positive constants.

In order to write the variational formulation of the previous problem, we introduce the following spaces:

$$W^{m,p}(\Omega) = \{ \mathbf{v} \in L^p(\Omega)^3, \, \partial^{\alpha} \mathbf{v} \in L^p(\Omega)^3, \, \forall \mid \alpha \mid \leq m \}, \\ H^m(\Omega) = W^{m,2}(\Omega),$$

equipped with the undermentionned semi-norm and norm:

$$|\mathbf{v}|_{m,p,\Omega} = \left(\sum_{|\alpha|=m} \int_{\Omega} |\partial^{\alpha} \mathbf{v}(x)|^p dx\right)^{1/p} \quad \text{and} \quad \|\mathbf{v}\|_{m,p,\Omega} = \left(\sum_{k \le m} |\mathbf{v}|_{k,p,\Omega}^p\right)^{1/p}$$

As usual, we shall omit p when p = 2 and denote by  $(\cdot, \cdot)$  the scalar product of  $L^2(\Omega)$ . Also, recall the familiar notation:

 $H_0^1(\Omega) = \{ \mathbf{v} \in H^1(\Omega); \ \mathbf{v} = 0 \text{ on } \partial\Omega \},\$ 

with the Poincaré inequality

$$\forall \mathbf{v} \in H_0^1(\Omega), \ ||\mathbf{v}||_{0,\Omega} \le C |\mathbf{v}|_{1,\Omega}.$$

Finally, we introduce the spaces:

$$\begin{aligned} H(\operatorname{div},\Omega) &= \{ \mathbf{v} \in L^2(\Omega)^3, \operatorname{div} \mathbf{v} \in L^2(\Omega) \}, \quad H_0(\operatorname{div},\Omega) = \{ \mathbf{v} \in H(\operatorname{div},\Omega), \mathbf{v} \cdot \mathbf{n} = 0 \text{ on } \partial\Omega \}, \\ H(\operatorname{\mathbf{curl}},\Omega) &= \{ \mathbf{v} \in L^2(\Omega)^3, \operatorname{\mathbf{curl}} \mathbf{v} \in L^2(\Omega)^3 \}, \quad H_0(\operatorname{\mathbf{curl}},\Omega) = \{ \mathbf{v} \in H(\operatorname{\mathbf{curl}},\Omega), \mathbf{v} \times \mathbf{n} = 0 \text{ on } \partial\Omega \}, \end{aligned}$$

normed respectively by:

$$\|\mathbf{v}\|_{H(\operatorname{div},\Omega)} = \left(\|\mathbf{v}\|_{0,\Omega}^2 + \|\operatorname{div}\mathbf{v}\|_{0,\Omega}^2\right)^{1/2},$$

and

$$\| \mathbf{v} \|_{H(\mathbf{curl},\Omega)} = \left( \| \mathbf{v} \|_{0,\Omega}^2 + \| \mathbf{curl} \mathbf{v} \|_{0,\Omega}^2 
ight)^{1/2}$$

We recall that the trace operator:  $\mathbf{v} \to \mathbf{v}.\mathbf{n}$  is continuous from  $H(\operatorname{div}, \Omega)$  onto  $H^{-1/2}(\partial\Omega)$  and the jump  $(\mathbf{v}|_{\Omega_{P}} - \mathbf{v}|_{\Omega_{F}}).\mathbf{n}$  vanishes on  $\Gamma$ .

We recall an important lemma which will be useful in the rest of the paper:

**Lemma 2.1.** There exists a unique solution  $\mathbf{w}$  in  $H^1(\Omega)/\mathbb{R}$  such that

$$(\nabla \mathbf{w}, \nabla \mathbf{v}) = (\mathbf{f}, \nabla \mathbf{v}), \ \forall \mathbf{v} \in H^1(\Omega) / \mathbb{R},$$

and there exists a positive constant C such that

$$\|\mathbf{w}\|_{1,\Omega} \leq C \|\mathbf{f}\|_{0,\Omega}$$
.

For the following regularity theorem, we refer to Nedelec [10].

**Theorem 2.2.** All functions  $\mathbf{v} \in L^2(\Omega_F)^3$  satisfying:

div 
$$\mathbf{v} = 0$$
,  $\operatorname{curl} \mathbf{v} \in L^2(\Omega_F)^3$ ,  $\mathbf{v} \cdot \mathbf{n} = 0$  on  $\Gamma$ ,

verify

 $||\mathbf{v}||_{0,\Omega_F} \leq C||\operatorname{\mathbf{curl}} \mathbf{v}||_{0,\Omega_F}$ 

If  $\Omega_F$  is convex, **v** belongs to  $H^1(\Omega_F)$  and we have

 $||\mathbf{v}||_{1,\Omega_F} \leq C ||\mathbf{curl}\,\mathbf{v}||_{0,\Omega_F}.$ 

We have also from [2] (page 10 lemma 2.2) the next lemma:

**Lemma 2.3.** For all functions  $\mathbf{v} \in L^2(\Omega)^3$  satisfying:

there exist a constant  $\alpha_0$  such that:

$$\|\mathbf{v}\|_{0,\Omega_F} \leq \alpha_0 \left(\|\mathbf{v}\|_{0,\Omega_P}^2 + \|\operatorname{\mathbf{curl}}\mathbf{v}\|_{0,\Omega_F}^2\right)^{1/2}.$$

In order to give the variational formulation of the problem (P), we introduce the space:

$$X = \{ \mathbf{v} \in L^2(\Omega)^3, \text{ curl } \mathbf{v}_{|_{\Omega_F}} \in L^2(\Omega_F)^3 \},\$$

provided with the norm

$$\parallel \mathbf{v} \parallel_X = \left( ||\mathbf{v}||^2_{0,\Omega} + \parallel \mathbf{curl} \; \mathbf{v} \parallel^2_{0,\Omega_F} 
ight)^{1/2}$$

We consider the following weak variational formulation, denoted by (V):

Find 
$$\mathbf{u} \in X$$
 and  $p \in H^1(\Omega)/\mathbb{R}$  such that

$$\mu(\mathbf{u}, \mathbf{v})_{\Omega_P} + \nu \ (\mathbf{curl} \, \mathbf{u}, \mathbf{curl} \, \mathbf{v})_{\Omega_F} + (\nabla p, \mathbf{v}) = (\mathbf{f}, \mathbf{v}), \quad \forall \, \mathbf{v} \in X$$
(2.2)

$$(\nabla q, \mathbf{u}) = 0, \quad \forall \ q \in H^1(\Omega) / \mathbb{R}$$
 (2.3)

**Theorem 2.4.** The problem (P) is equivalent to the weak variational formulation (V).

**Proof:** Suppose that  $(\mathbf{u}, p) \in X \times H^1(\Omega)/\mathbb{R}$  is a solution of (V).

The equation (2.3) gives the third equation of (P) in the distribution sense. Since  $\mathcal{D}(\Omega_P) \subset X$  and  $\mathcal{D}(\Omega_F) \subset X$ , we deduce from (2.2) and the relation  $-\Delta \mathbf{u} = \mathbf{curl} \mathbf{curl} \mathbf{u}$  (as we have div  $\mathbf{u} = 0$ ) the first and the second equation of (P). On the other hand,  $\mathbf{u} \in H(\operatorname{div}, \Omega)$  and  $(\mathbf{u}, \nabla q) = 0$  for all  $q \in H^1(\Omega)$  gives us  $(\mathbf{u}_{|\Omega_P} - \mathbf{u}_{|\Omega_F}) \cdot \mathbf{n} = 0$  on  $\Gamma$  and  $\mathbf{u} \cdot \mathbf{n} = 0$  in  $H^{-1/2}(\partial\Omega)$ . Since  $p \in H^1(\Omega)/\mathbb{R}$  we have  $(p_{|\Omega_P} - p_{|\Omega_F})|_{\Gamma} = 0$ . Finally, the second equation of (P) and the equation (2.2) gives

$$(\operatorname{curl}\operatorname{curl}\mathbf{u},\mathbf{v})_{\Omega_F} = (\operatorname{curl}\mathbf{u},\operatorname{curl}\mathbf{v})_{\Omega_F}, \quad \forall \mathbf{v} \in H(\operatorname{curl},\Omega_F)$$

which leads to the last condition **curl**  $\mathbf{u}_{|_{\Omega_F}} \times \mathbf{n} = 0$  on  $\Gamma$ .

Inversely, let  $(\mathbf{u}, p) \in X \times H^1(\Omega)/\mathbb{R}$  be a solution of (P). Multiplying the first equation of (P) by  $\mathbf{v} \in X$ and integrating over  $\Omega_F$  and using the Green formula, and the second equation by  $\mathbf{v}$  and integrating over  $\Omega_P$  gives the first equation of (V). The next three equations of (P) give the second equation of (V).  $\Box$ 

The variational formulation (V) can be splitted into a system for the velocity and a Poisson equation for the pressure. Let us introduce the space

$$U = \{ \mathbf{v} \in X; \ (\nabla q, \mathbf{v}) = 0, \ \forall q \in H^1(\Omega) / \mathbb{R} \}.$$

and remark that every  $\mathbf{v} \in U$  verify the lemma 2.3.

The lemmas 2.1 and 2.3 allow us to establish the following theorem:

**Theorem 2.5.** The problem (V) is equivalent to the problem

Find  $\mathbf{u} \in U$  such that

$$\mu(\mathbf{u}, \mathbf{v})_{\Omega_P} + \nu(\operatorname{\mathbf{curl}} \mathbf{u}, \operatorname{\mathbf{curl}} \mathbf{v})_{\Omega_F} = (\mathbf{f}, \mathbf{v}), \quad \forall \mathbf{v} \in U$$

Find  $p \in H^1(\Omega)/\mathbb{R}$  such that

$$\mu(\mathbf{u}, \nabla q)_{\Omega_P} + (\nabla p, \nabla q) = (\mathbf{f}, \nabla q), \quad \forall \ q \in H^1(\Omega) / \mathbb{R}.$$
(2.5)

Furthermore, there exists a unique solution and we have the following bounds

 $||\mathbf{u}||_{0,\Omega_P} + ||\mathbf{curl}\,\mathbf{u}||_{0,\Omega_F} \le C_1 ||\mathbf{f}||_{0,\Omega},$ 

$$|p|_{1,\Omega} \leq C_2 ||\mathbf{f}||_{0,\Omega}.$$

**Proof:** The equivalence of the two problems comes from the fact that every element  $\mathbf{v} \in X$  can be written as  $\mathbf{v} = \mathbf{w} + \nabla q$  where  $\mathbf{w} \in U$  and  $q \in H^1(\Omega)/\mathbb{R}$ .

The Lax-Milgram theorem gives the existence and the uniqueness of the solution of (2.4). Having the velocity, the Lax-Milgram theorem gives the existence and the uniqueness of the solution of (2.5). We obtain the inequalities by first taking  $\mathbf{v} = \mathbf{u}$  in the equation (2.4), next by taking q = p in the equation (2.5).

We denote by  $(V_1)$  the problem defined by (2.4) and (2.5). Then, it is easy to show that  $(V_1)$  is equivalent to the following problem denoted  $(V_2)$ :

Find  $\mathbf{u} \in X$ ,  $p \in H^1(\Omega)/\mathbb{R}$  such that

$$\mu(\mathbf{u}, \mathbf{v})_{\Omega_P} + \nu(\operatorname{\mathbf{curl}} \mathbf{u}, \operatorname{\mathbf{curl}} \mathbf{v})_{\Omega_F} + (\nabla p, \mathbf{v}) = (\mathbf{f}, \mathbf{v}), \quad \forall \ \mathbf{v} \in X$$
(2.6)

$$-\mu(\mathbf{u}, \nabla q)_{\Omega_F} + (\nabla p, \nabla q) = (\mathbf{f}, \nabla q), \quad \forall q \in H^1(\Omega) / \mathbb{R}.$$

#### 3. FINITE ELEMENT DISCRETIZATION

In what follows and for simplicity, we make the further assumption that both  $\Omega$  and  $\Omega_F$  are polyhedra. We introduce a regular family of triangulation  $(\tau_h)_h$  in the sense that:

- for each h,  $\overline{\Omega}$  is the union of all elements of  $\tau_h$ ;
- for each h, the intersection of two different elements of  $\tau_h$ , if not empty, is a corner, a whole edge or a whole face of both of them;
- the ratio of the diameter  $h_{\kappa}$  of an element  $\kappa$  in  $\tau_h$  to the diameter of its inscribed sphere is bounded by a constant independent of  $\kappa$  and h;

As usual, h denotes the maximum of the diameters of the elements of  $\tau_h$ . We denote by  $\tau_h^F$  (resp.  $\tau_h^P$ ) the set of elements  $\kappa$  of  $\tau_h$  which are contained in  $\Omega_F$  (resp.  $\Omega_P$ ).

Next, for each  $\kappa$  in  $\tau_h$ , we introduce the spaces  $\mathbb{P}_0(\kappa)$  of the restrictions to  $\kappa$  of constant functions on  $\mathbb{R}^3$ ,  $\mathbb{P}_1(\kappa)$  of the restrictions to  $\kappa$  of affine functions on  $\mathbb{R}$  and the space  $\mathbb{P}_K(\kappa)$  of the restrictions to  $\kappa$  of polynomials **v** of the form:

$$\mathbf{v}(\mathbf{x}) = \mathbf{a} + \mathbf{b} imes \mathbf{x}, \quad \mathbf{a} \in \mathbb{R}^3, \mathbf{b} \in \mathbb{R}^3.$$

The space  $\mathbb{P}_K(\kappa)$  and the corresponding finite elements are studied in [9]. Their degrees of freedom are the average flux along the edges  $\int_l (\mathbf{v}.\mathbf{t}) dl$ , for the six edges l of  $\kappa$ ,  $\mathbf{t}$  is the direction vector of l.

Hence, we associate the operator  $r_{\kappa}$  where  $r_{\kappa}(\mathbf{u})$  is the unique polynomial of  $\mathbb{P}_K$  that has the same flux along the edges as  $\mathbf{u}$ . We define also the operator  $I_{\kappa}$  where  $I_{\kappa}(q)$  is the unique polynomial of  $\mathbb{P}_1(\kappa)$  that has the same values on the vertex of  $\kappa$  as q. We have for all  $\kappa \in \tau_h$ :

$$r_{\kappa}(\nabla q) = \nabla I_{\kappa}(q) \qquad \forall q \in W^{2,t}(\kappa) \quad \text{for some } t > 2.$$

Next, let us introduce the discrete spaces:

$$X_h = \{ \mathbf{u}_h \in X; \mathbf{u}_{h|_{\kappa}} \in \mathbb{P}_K(\kappa), \, \forall \, \kappa \in \tau_h \},$$

$$(3.1)$$

$$Q_h = \{q_h \in C^0(\overline{\Omega}); q_{h|_{\kappa}} \in \mathbb{P}_1(\kappa), \ \forall \ \kappa \in \tau_h\},$$

$$(3.2)$$

With these spaces, the finite dimensional analogues of U is:

$$U_h = \{ \mathbf{v}_h \in X_h ; (\nabla q_h, \mathbf{v}_h) = 0, \quad \forall q_h \in Q_h \},\$$

We define the interpolation operators  $r_h$  from  $H^1(\Omega)^3$  onto  $X_h$ ,  $I_h$  from  $H^2(\Omega)$  onto  $Q_h$  by

 $r_h u = r_\kappa(u)$  on  $\kappa$ ,  $\forall \kappa \in \tau_h$  (similarly for  $I_h$ ).

We have the following result:

**Theorem 3.1.** Assume that the triangulation  $\tau_h$  is regular. We have:

$$\|\mathbf{u} - r_h \mathbf{u}\|_{0,\Omega} + h \|\operatorname{\mathbf{curl}}(\mathbf{u} - r_h \mathbf{u})\|_{0,\Omega} \leq Ch \|\mathbf{u}\|_{1,t,\Omega}, \ \forall \ \mathbf{u} \in W^{1,t}(\Omega)^3, \ \text{for some } t > 2.$$

Moreover, when  $\mathbf{u} \in H^k(\Omega)^3$ , k = 1, 2, we have:

$$\| \mathbf{u} - r_h \mathbf{u} \|_{0,\Omega} \le Ch^k \| \mathbf{u} \|_{k,\Omega}$$

and, when  $\mathbf{u} \in H^2(\Omega)^3$  we have:

$$\|\operatorname{\mathbf{curl}}(\mathbf{u}-r_h\mathbf{u})\|_{0,\Omega} \leq Ch \mid \mathbf{u}\mid_{2,\Omega}$$

**Theorem 3.2.** Let  $\Omega$  be a polyhedron and  $\Omega_F$  a convex polyhedron. Let  $\tau_h$  be a uniformly regular family of triangulation of  $\Omega$ . We have:

$$||\mathbf{u}_{h}||_{0,\Omega_{F}} \leq \alpha_{0} \left( ||\mathbf{u}_{h}||_{0,\Omega_{F}}^{2} + ||\mathbf{curl} \ u_{h}||_{0,\Omega_{F}}^{2} \right)^{1/2}, \quad \forall \mathbf{u}_{h} \in U_{h}$$
(3.3)

**Proof:** The inequality (3.3) is valid for every  $\mathbf{v} \in U$ . Let  $\Omega_F$  be convex, for every function  $\mathbf{u}_h$  in  $U_h$ , we consider the Dirichlet problem:

$$\nabla z, \nabla \mu)_{\Omega_F} = (\mathbf{u}_h, \nabla \mu)_{\Omega_F} \quad \forall \mu \in H^1(\Omega_F) / \mathbb{R}.$$

The difference  $\mathbf{w} = \mathbf{u}_h - \nabla z$  belongs to the space

$$U_{\Omega_F} = \{ \mathbf{v} \in H(\mathbf{curl}, \Omega_F); (\mathbf{v}, \nabla q)_{\Omega_F} = 0 \ \forall q \in H^1(\Omega_F) / \mathbb{R} \},\$$

and curl  $\mathbf{w} = \mathbf{curl} \mathbf{u}_h$ . It follows from theorem 2.2 that

(

$$||\mathbf{w}||_{1,\Omega_F} \le C_1 ||\operatorname{\mathbf{curl}} \mathbf{w}||_{0,\Omega_F}.$$

Therefore, we can apply the interpolation operator  $r_h$  to  $\mathbf{w}$ , and  $\mathbf{u}_h$  splits into:

 $\mathbf{u}_h = r_h \mathbf{w} + \nabla z_h$  with  $z_h \in Q_h$ .

Hence

$$||\mathbf{u}_h||_{0,\Omega_F} \le ||r_h \mathbf{w} - \mathbf{w}||_{0,\Omega_F} + ||\mathbf{w}||_{0,\Omega_F} + ||\nabla z_h||_{0,\Omega_F}.$$

Since on one hand

$$||\mathbf{w} - r_h \mathbf{w}||_{0,\Omega_F} \le C_2 ||\mathbf{w}||_{1,\Omega_F} \le C_3 ||\operatorname{\mathbf{curl}} \mathbf{w}||_{0,\Omega_F}$$

and on the other hand

$$||\mathbf{w}||_{0,\Omega_F} \leq ||\mathbf{w}||_{1,\Omega_F} \leq C_4 ||\operatorname{\mathbf{curl}} \mathbf{w}||_{0,\Omega_F}.$$

We see that it suffices to estimate  $||\nabla z_h||_{0,\Omega_F}$ . For all  $\mu_h \in Q_h$  we have:

$$(\nabla z_h, \nabla \mu_h)_{\Omega_F} = (\mathbf{u}_h - r_h \mathbf{w}, \nabla \mu_h)_{\Omega_F}$$

$$= (\mathbf{u}_h, \nabla \mu_h)_{\Omega_F} + (\mathbf{w} - r_h \mathbf{w}, \nabla \mu_h)_{\Omega_F}$$

$$= -(\mathbf{u}_h, \nabla \mu_h)_{\Omega_P} + (\mathbf{w} - r_h \mathbf{w}, \nabla \mu_h)_{\Omega_F},$$

$$\leq ||\mathbf{u}_h||_{0,\Omega_F} ||\nabla \mu_h||_{0,\Omega_F} + C_3 ||\operatorname{\mathbf{curl}} \mathbf{w}||_{0,\Omega_F} ||\nabla \mu_h||_{0,\Omega_F}$$

We choose  $\mu_h \in Q_h$  such that  $\mu_h|_{\overline{\Omega}_F} = z_h|_{\overline{\Omega}_F}$  and  $\mu_h = 0$  in  $\Omega_P$ . We obtain :  $||\nabla \mu_h||_{0,\Omega_P} \leq C_1 ||z_h||_{1/2,\Gamma} \leq C_2 ||\nabla z_h||_{0,\Omega_F}$  and we deduce

$$||\nabla z_h||_{0,\Omega_F} \leq C_3 (||\mathbf{u}_h||_{0,\Omega_P} + ||\operatorname{\mathbf{curl}} \mathbf{w}||_{0,\Omega_F})$$

and finally the result.

We discretize (V) by: Find  $\mathbf{u}_h \in U_h$  and  $p_h \in Q_h/\mathbb{R}$  such that

$$\mu(\mathbf{u}_h, \mathbf{v}_h)_{\Omega_P} + \nu(\operatorname{\mathbf{curl}} \mathbf{u}_h, \operatorname{\mathbf{curl}} \mathbf{v}_h)_{\Omega_F} + (\nabla p_h, \mathbf{v}_h) = (\mathbf{f}, \mathbf{v}_h) \quad \forall \mathbf{v}_h \in X_h.$$
(3.4)

As in the continuous way, the last problem can be splited to

Find  $\mathbf{u}_h \in U_h$  such that

$$\mu(\mathbf{u}_h, \mathbf{v}_h)_{\Omega_P} + \nu(\operatorname{\mathbf{curl}} \mathbf{u}_h, \operatorname{\mathbf{curl}} \mathbf{v}_h)_{\Omega_F} = (\mathbf{f}, \mathbf{v}_h), \quad \forall \mathbf{v}_h \in U_h,$$
(3.5)

Find  $p_h \in Q_h / \mathbb{R}$  such that

$$\mu(\mathbf{u}_h, \nabla q_h)_{\Omega_P} + (\nabla p_h, \nabla q_h) = (\mathbf{f}, \nabla q_h), \quad \forall q_h \in Q_h / \mathbb{R}.$$
(3.6)

Let  $\Omega_F$  be convex, it is easy to show, using the theorem 3.2, that these two last discrete problems have a unique solution and we have:

$$||\mathbf{u}_h||_{0,\Omega_P} + ||\mathbf{curl} \ u_h||_{0,\Omega_F} \le C_3 ||\mathbf{f}||_{0,\Omega_F}$$

and

$$|p_h|_{1,\Omega} \le C_4 ||\mathbf{f}||_{0,\Omega}$$

It is obvious that the last problem is equivalent to:

Find  $\mathbf{u}_h \in U_h$  and  $p_h \in Q_h/\mathbb{R}$  such that

$$\mu(\mathbf{u}_h, \mathbf{v}_h)_{\Omega_P} + \nu(\operatorname{\mathbf{curl}} \mathbf{u}_h, \operatorname{\mathbf{curl}} \mathbf{v}_h)_{\Omega_F} + (\nabla p_h, \mathbf{v}_h) = (\mathbf{f}, \mathbf{v}_h), \quad \forall \mathbf{v}_h \in X_h,$$
(3.7)

Find  $p_h \in Q_h/\mathbb{R}$  such that

$$-\mu(\mathbf{u}_h, \nabla q_h)_{\Omega_F} + (\nabla p_h, \nabla q_h) = (\mathbf{f}, \nabla q_h), \quad \forall \ q_h \in Q_h/\mathbb{R}.$$
(3.8)

#### 4. A priori error analysis

In this section, we will establish the error estimates for the pressure and the velocity. First of all, we consider the quantity  $\mathbf{u}_h - r_h \mathbf{u}$  and we consider the finite dimensional problem: Find  $\lambda_h \in Q_h/\mathbb{R}$  such that

$$\forall q_h \in Q_h / \mathbb{R}, \qquad \int_{\Omega} \nabla \lambda_h \nabla q_h = \int_{\Omega} (\mathbf{u}_h - r_h \mathbf{u}) \nabla q_h$$

which admits a unique solution  $\lambda_h$  such that  $\mathbf{w}_h = (\mathbf{u}_h - r_h \mathbf{u}) - \nabla \lambda_h$  is in the space  $U_h$  with  $\mathbf{curl} (\mathbf{u}_h - r_h \mathbf{u}) = \mathbf{curl} \mathbf{w}_h$ .

Furthermore we consider, for all  $q_h \in Q_h/\mathbb{R}$ , the relation

$$\int_{\Omega} \nabla \lambda_h \nabla q_h = \int_{\Omega} (\mathbf{u}_h - r_h \mathbf{u}) \nabla q_h = -\int_{\Omega} (r_h \mathbf{u} - \mathbf{u}) \nabla q_h$$

which gives by taking  $q_h = \lambda_h$  and supposing that  $\mathbf{u} \in H^1(\Omega)^3$ :

 $|\lambda_h|_{1,\Omega} \le C \, h ||\mathbf{u}||_{1,\Omega}$ 

To obtain the a priori error estimate for the velocity, it suffices to show an error estimate of  $\mathbf{w}_h$  and we conclude an error estimate of  $\mathbf{u} \in H^2(\Omega)^3$  by using the theorem 3.2. Let  $\Omega_F$  be convex. For all  $\mathbf{u}_h \in U_h$ ,

we have:

$$\begin{aligned} ||\mathbf{u} - \mathbf{u}_{h}||_{X}^{2} &\leq ||\mathbf{u} - r_{h}\mathbf{u}||_{0,\Omega}^{2} + ||r_{h}\mathbf{u} - \mathbf{u}_{h}||_{0,\Omega}^{2} + ||\operatorname{\mathbf{curl}}(\mathbf{u} - r_{h}\mathbf{u})||_{0,\Omega_{F}}^{2} + ||\operatorname{\mathbf{curl}}(r_{h}\mathbf{u} - \mathbf{u}_{h})||_{0,\Omega_{F}}^{2} \\ &\leq C_{1}(u,\Omega) \Big(h^{2} + ||r_{h}\mathbf{u} - \mathbf{u}_{h}||_{0,\Omega}^{2} + ||\operatorname{\mathbf{curl}}(r_{h}\mathbf{u} - \mathbf{u}_{h})||_{0,\Omega_{F}}^{2} \Big) \\ &\leq C_{2}(u,\Omega) \Big(h^{2} + ||\nabla\lambda_{h}||_{0,\Omega}^{2} + ||\mathbf{w}_{h}||_{0,\Omega}^{2} + ||\operatorname{\mathbf{curl}}\mathbf{w}_{h}||_{0,\Omega_{F}}^{2} \Big) \\ &\leq C_{3}(u,\Omega) \Big(h^{2} + ||\nabla\lambda_{h}||_{0,\Omega}^{2} + ||\mathbf{w}_{h}||_{0,\Omega_{F}}^{2} + ||\operatorname{\mathbf{curl}}\mathbf{w}_{h}||_{0,\Omega_{F}}^{2} \Big) \end{aligned}$$

$$(4.1)$$

Next, to obtain the error estimate for  $\mathbf{w}$ , we consider the difference of the equation (2.2) with  $\mathbf{v} = \mathbf{v}_h \in X_h$ and the equation (3.4):

$$\mu \int_{\Omega_P} (\mathbf{u} - \mathbf{u}_h) \mathbf{v}_h + \nu \int_{\Omega_F} \mathbf{curl} (\mathbf{u} - \mathbf{u}_h) \mathbf{curl} \mathbf{v}_h + \int_{\Omega} \nabla (p - p_h) \mathbf{v}_h = 0$$

We insert  $\pm r_h \mathbf{u}$  in the first and the second terms,  $\pm I_h p$  in the third term and we obtain:

$$\mu \int_{\Omega_P} (r_h \mathbf{u} - \mathbf{u}_h, \mathbf{v}_h) + \nu \int_{\Omega_F} \mathbf{curl} (r_h \mathbf{u} - \mathbf{u}_h) \mathbf{curl} \mathbf{v}_h = \\ \mu (r_h \mathbf{u} - \mathbf{u}, \mathbf{v}_h)_{\Omega_P} + \nu (\mathbf{curl} (r_h \mathbf{u} - \mathbf{u}_h), \mathbf{curl} \mathbf{v}_h)_{\Omega_F} - (\nabla (p - I_h p), \mathbf{v}_h) - (\nabla (I_h p - p_h), \mathbf{v}_h)$$

We replace  $\mathbf{u}_h - r_h \mathbf{u} = \nabla \lambda_h + \mathbf{w}_h$  and we choose  $\mathbf{v}_h = \mathbf{w}_h$  to obtain:

$$\begin{aligned} \mu ||\mathbf{w}_{h}||_{0,\Omega_{P}}^{2} + \nu ||\operatorname{\mathbf{curl}} \, \mathbf{w}_{h}||_{0,\Omega_{F}}^{2} = \\ -\mu \int_{\Omega_{P}} \nabla \lambda_{h} \mathbf{w}_{h} + \mu (r_{h} \mathbf{u} - \mathbf{u}, \mathbf{w}_{h})_{\Omega_{P}} + \nu (\operatorname{\mathbf{curl}} (r_{h} \mathbf{u} - \mathbf{u}_{h}), \operatorname{\mathbf{curl}} \, \mathbf{w}_{h})_{\Omega_{F}} - (\nabla (p - I_{h} p), \mathbf{w}_{h}) \end{aligned}$$

By supposing that  $p \in H^2(\Omega)$  and  $\mathbf{u} \in H^2(\Omega)^3$ , we deduce using the properties of  $r_h$  and  $I_h$ , the formula  $a.b \leq \frac{1}{2\varepsilon}a^2 + \frac{1}{2}\varepsilon b^2$  with a suitable choice of  $\varepsilon$  and the previous upper bound of  $\lambda$ :

$$\mu ||\mathbf{w}_h||_{0,\Omega_P}^2 + \nu ||\operatorname{\mathbf{curl}} \mathbf{w}_h||_{0,\Omega_F}^2 \le C(\Omega) h^2(||\mathbf{u}||_{2,\Omega}^2 + ||p||_{2,\Omega}^2)$$

Now, we will show an estimate for the pressure. We subtract the equation (2.5) with  $q = q_h \in Q_h/\mathbb{R}$ from the equation (3.6) to get

$$\mu \int_{\Omega_P} (\mathbf{u} - \mathbf{u}_h) \nabla q_h + \int_{\Omega} \nabla (p - p_h) \nabla q_h = 0$$

We insert  $\pm I_h p$  in the second term and we choose  $q_h = p_h - I_h p$  to obtain

$$|p_h - I_h p|_{1,\Omega} \le \mu || (\mathbf{u} - \mathbf{u}_h) ||_{0,\Omega_P} + |p - I_h p|_{1,\Omega}$$

We deduce the error estimate:

$$|p - p_h|_{1,\Omega} \leq |p - I_h p|_{1,\Omega} + |I_h p - p_h|_{1,\Omega} \\ \leq C(\Omega)(||p||_{2,\Omega} + ||\mathbf{u}||_{2,\Omega}) h$$
(4.2)

**Theorem 4.1.** If  $\mathbf{u} \in H^2(\Omega)^3$  and  $p \in H^2(\Omega)$ , the theoretical solution  $(\mathbf{u}, p)$  of the problem (2.4)-(2.5) and the numerical solution  $(\mathbf{u}_h, p_h)$  of the problem (3.5)-(3.6) verify the error estimate:

$$||\mathbf{u} - \mathbf{u}_h||_X + |p - p_h|_{1,\Omega} \le C(\Omega, \mathbf{u}, p) h$$

$$\tag{4.3}$$

#### 5. A posteriori error analysis

We now intend to prove a posteriori error estimates between the exact solution  $(\mathbf{u}, p)$  of the problem (2.4)-(2.5) and the numerical solution  $(\mathbf{u}_h, p_h)$  of the problem (3.7)-(3.8). In all the rest of the paper, we suppose that  $\mathbf{f} \in H(\operatorname{div}, \Omega)$ .

We first introduce the space

$$Z_h = \{ \mathbf{g}_h \in L^2(\Omega)^3; \ \forall \kappa \in \tau_h, \ \mathbf{g}_h |_{\kappa} \in \mathbb{P}_0(\kappa) \}$$

and we fix an approximation  $\mathbf{f}_h$  of the data  $\mathbf{f}$  in  $Z_h$ .

Next, we denote by  $\varepsilon_h$  the set of all faces of the elements. For every element  $\kappa$  in  $\tau_h$ , we denote by  $\varepsilon_{\kappa}$  the set of faces of  $\kappa$  that are not contained in  $\Gamma$ ,  $\Delta_{\kappa}$  (resp.  $\Delta_{\kappa}^F$  or  $\Delta_{\kappa}^P$ ) the set of union of elements of  $\tau_h$  that intersect  $\kappa$  (resp. contained in  $\Omega^F$  or contained in  $\Omega^P$ ),  $\Delta_e$  (resp.  $\Delta_e^F$  or  $\Delta_e^P$ ) the union of elements of  $\tau_h$  that intersect the face e (resp. contained in  $\Omega^F$  or contained in  $\Omega^P$ ),  $\Delta_e$  the diameter of  $\kappa$  and  $h_e$  the diameter of the face e. Also,  $\mathbf{n}_{\kappa}$  stands for the unit outward normal vector to  $\kappa$  on  $\partial \kappa$  and  $[\cdot]_e$  the jump through the face e of  $\kappa$ .

For the demonstration of the next theorems, we introduce for an element  $\kappa$  of  $\tau_h$ , the bull function  $\psi_{\kappa}$ (resp.  $\psi_e$  of the face e) which is equal to the product of the d + 1 barycentric coordinates associated with the vertices of  $\kappa$  (resp. of e) and  $\mathcal{L}_e$  (resp.  $\mathcal{L}_e^F$  or  $\mathcal{L}_e^P$ ) the lifting operator from polynomials defined on e into polynomials defined on the elements  $\kappa$  and  $\kappa'$  containing e (resp. elements contained in  $\Omega^F$  or contained in  $\Omega^P$ ), which is constructed by affine transformations from a fixed operator on the reference element.

**Property 5.1.** Denoting by  $P_r(e)$  the polynomial of degrees r on e, we have

$$\forall v \text{ polynom of } P_r(e) \qquad c \| v \|_{L^2(e)} \leq \| v \psi_e^{1/2} \|_{L^2(e)} \leq c' \| v \|_{L^2(e)}$$

and for any polynom v of  $P_r(e)$  which vanishes on  $\partial e$ , we have

$$\| \mathcal{L}_{e} v \|_{L^{2}(\kappa)} + h_{e} | \mathcal{L}_{e} v |_{H^{1}(\kappa)} \leq c h_{e}^{1/2} \| v \|_{L^{2}(e)}.$$

We denote by  $R_h$  the Clément operator [5]. For any function  $q \in H^1_0(\Omega)$ ,  $R_h q \in Q_h$  verifies

$$\| q - R_h q \|_{L^2(\kappa)} \le ch_{\kappa} \| q \|_{H^1(\Delta\kappa)},$$
  
$$\| q - R_h q \|_{L^2(e)} \le ch_e^{1/2} \| q \|_{H^1(\Delta e)}.$$
 (5.1)

We also denote by  $\mathcal{R}_h$  the Raviart-Thomas operator : for any smooth enough vectorial function **v** which is divergence-free on  $\Omega$ ,  $\mathcal{R}_h$ **v** belongs to  $X_h$  and satisfies

$$\forall e \in \varepsilon_h, \quad \int_e (\mathbf{v} - \mathcal{R}_{\mathbf{h}} \mathbf{v}) . \mathbf{n} d\tau = 0$$

Moreover, this operator satisfies, see [11] :  $\forall \mathbf{v} \text{ in } H^1(\Omega)^3$  and  $\forall \kappa \text{ in } \tau_h$ ,

$$\| \mathbf{v} - \mathcal{R}_h \mathbf{v} \|_{L^2(\kappa)^3} \leq ch_\kappa \| \mathbf{v} \|_{H^1(\kappa)^3}$$
  
$$\| \mathbf{v} - \mathcal{R}_h \mathbf{v} \|_{L^2(e)^3} \leq ch_e^{1/2} \| \mathbf{v} \|_{H^1(\Delta e)^3}$$
(5.2)

To prove the a posteriori estimates, we begin by decomposing  $\mathbf{u} - \mathbf{u}_h = \nabla \lambda + \mathbf{w}$  where  $\lambda \in H^1(\Omega)$  and  $\mathbf{w} \in U$ . Then, we establish a posteriori estimate for  $\lambda$  and  $\mathbf{w}$  to deduce using the lemma (2.3)

$$\begin{aligned} ||\mathbf{u} - \mathbf{u}_h||_X^2 &= ||\nabla \lambda + \mathbf{w}||_{0,\Omega}^2 + ||\operatorname{\mathbf{curl}} \mathbf{w}||_{0,\Omega_F}^2 \\ &\leq C(|\lambda|_{1,\Omega}^2 + ||\mathbf{w}||_{0,\Omega_F}^2 + ||\operatorname{\mathbf{curl}} \mathbf{w}||_{0,\Omega_F}^2) \end{aligned}$$

and we finish with the a posteriori estimate for the pressure.

The error function  $\mathbf{u} - \mathbf{u}_h$  belongs to X, there exists a unique solution  $\lambda_1 \in H^1(\Omega_F)/\mathbb{R}$  of the problem:

$$\int_{\Omega_F} \nabla \lambda_1 \nabla q = \int_{\Omega_F} (\mathbf{u} - \mathbf{u}_h) \nabla q \qquad \forall q \in H^1(\Omega_F) / \mathbb{R},$$

and the function  $\mathbf{w}_1 = (\mathbf{u} - \mathbf{u}_h) - \nabla \lambda_1$  belongs to  $U_F = \{\mathbf{v} \in H(\mathbf{rot}, \Omega_F)/(\mathbf{v}, \nabla q)_{\Omega_F} = 0; \forall q \in H^1(\Omega_F)\}$ . We define the function  $\tilde{\mathbf{w}}$ , equal to  $\mathbf{w}_1$  in  $\Omega_F$  and  $\mathbf{0}$  in  $\Omega_P$ , which belongs to U and verifies  $\mathbf{curl}\tilde{\mathbf{w}} = \mathbf{curl}\mathbf{w}_1$  in  $\Omega_F$ . Furthermore, there exists a unique solution  $\lambda \in H^1(\Omega)/\mathbb{R}$  of the problem:

$$\int_{\Omega} \nabla \lambda \nabla q = \int_{\Omega} (\mathbf{u} - \mathbf{u}_h) \nabla q \qquad \forall q \in H^1(\Omega) / \mathbb{R},$$

and the function  $\mathbf{w} = (\mathbf{u} - \mathbf{u}_h) - \nabla \lambda$  belongs to U and we have  $\operatorname{curl} \mathbf{w} = \operatorname{curl} (\mathbf{u} - \mathbf{u}_h)$  in  $\Omega_F$ . We have:  $\forall q \in H^1(\Omega)$ ,

$$\int_{\Omega} \nabla \lambda \nabla q = \int_{\Omega} (\mathbf{w} + \nabla \lambda) \nabla q = \int_{\Omega} (\mathbf{u} - \mathbf{u}_h) \nabla q = -\int_{\Omega} \mathbf{u}_h \nabla q$$
  
$$= -\int_{\Omega} \mathbf{u}_h \nabla (q - q_h) = -\frac{1}{2} \sum_{\kappa \in \tau_h} \left( \sum_{e \in \varepsilon_\kappa} \int_e [\mathbf{u}_h \cdot \mathbf{n}](q - q_h) \right) \quad \forall q_h \in Q_h.$$
(5.3)

We introduce the indicators

$$\xi_{\kappa} = \sum_{e \in \varepsilon_{\kappa}} h_e^{1/2} \parallel [\mathbf{u}_h . \mathbf{n}] \parallel_{0,e}$$
(5.4)

Theorem 5.2. The following bounds hold

$$||\nabla \lambda||_{0,\Omega} \le C \Big(\sum_{\kappa \in \tau_h} \xi_{\kappa}^2 \Big)^{1/2}$$

and

$$\xi_{\kappa} \le c ||\nabla \lambda||_{0,\Delta_{\kappa}} \tag{5.5}$$

**Proof:** First we take, in the equation (5.3),  $q = \lambda$  and  $q_h = R_h q$ , the image of q by the Clément type regularization operator, and we obtain the upper bound. In order to find the lower bound, we take in the equation (5.3)  $q_h = 0$  and  $q = \mathcal{L}_e([\mathbf{u}_h \cdot \mathbf{n}]\psi_e)$ , and we obtain

$$\| \left[ \mathbf{u}_h \cdot \mathbf{n} \right] \|_{0,e} \leq C \left( h_e^{-1/2} |\lambda|_{1,\kappa \cup \kappa'} \right)$$

which leads to

$$\xi_{\kappa} \le c \Big( |\lambda|_{1,\Delta_{\kappa}} \Big). \tag{5.6}$$

To find a posteriori estimates for  $\mathbf{w}$ , we begin to establish upper and lower bounds for **curl**  $\mathbf{w}$  in  $\Omega_F$ . We introduce the indicators

$$\gamma_{\kappa,F} = h_{\kappa} \parallel \mathbf{f}_{h} - \nabla p_{h} \parallel_{0,\kappa} + \frac{\nu}{2} \sum_{e \in \varepsilon_{\kappa}} h_{\kappa}^{1/2} \parallel [\mathbf{curl} \, \mathbf{u}_{h} \times \mathbf{n}] \parallel_{0,e}, \text{ if } \kappa \in \Omega_{F}$$
(5.7)

where  $[\cdot]_e$  is the jump through the face e of  $\kappa$ . If the face e is on  $\Gamma$ ,  $[\cdot]_e$  will be the trace on e from the domain  $\Omega_F$  containing  $\kappa$ .

**Theorem 5.3.** Let  $\Omega_F$  be convex. The following bounds hold:

$$\nu ||\mathbf{curl}\,\mathbf{w}||_{0,\Omega_F} \le C \Big(\sum_{\kappa \in \tau_h^F} h_\kappa^2 ||\mathbf{f} - \mathbf{f}_h||_{0,\kappa}^2 + \sum_{\kappa \in \tau_h^F} \gamma_{\kappa,F}^2 \Big)^{1/2}$$
(5.8)

and

$$\gamma_{\kappa,F} \le c \sum_{e \in \varepsilon_{\kappa}} \left( || \operatorname{\mathbf{curl}} \mathbf{w} ||_{0,\Delta_{e}^{F}}^{2} + h_{e}^{2} |p - p_{h}|_{1,\Delta_{e}^{F}}^{2} + h_{e}^{2} || \mathbf{f} - \mathbf{f}_{h} ||_{0,\Delta_{e}^{F}}^{2} \right)^{1/2}$$
(5.9)

**Proof**: The error function  $\mathbf{u} - \mathbf{u}_h$  verifies, by using the equations (2.2) and (3.4):  $\forall \mathbf{v} \in X$  and  $\forall \mathbf{v}_h \in X_h$ 

$$\mu \int_{\Omega_{P}} (\mathbf{u} - \mathbf{u}_{h}) \mathbf{v} + \nu \int_{\Omega_{F}} \mathbf{curl}(\mathbf{u} - \mathbf{u}_{h}) \mathbf{curl} \mathbf{v} + \int_{\Omega} \nabla(p - p_{h}) \mathbf{v}$$

$$= \mu \int_{\Omega_{P}} (\mathbf{u} - \mathbf{u}_{h}) (\mathbf{v} - \mathbf{v}_{h}) + \nu \int_{\Omega_{F}} \mathbf{curl}(\mathbf{u} - \mathbf{u}_{h}) \mathbf{curl} (\mathbf{v} - \mathbf{v}_{h}) + \int_{\Omega} \nabla(p - p_{h}) (\mathbf{v} - \mathbf{v}_{h})$$

$$= (\mathbf{f}, \mathbf{v} - \mathbf{v}_{h}) - \mu \int_{\Omega_{P}} \mathbf{u}_{h} (\mathbf{v} - \mathbf{v}_{h}) - \nu \int_{\Omega_{F}} \mathbf{curl} \mathbf{u}_{h} \mathbf{curl} (\mathbf{v} - \mathbf{v}_{h}) - \int_{\Omega} \nabla p_{h} (\mathbf{v} - \mathbf{v}_{h})$$

$$= ((\mathbf{f} - \mathbf{f}_{h}), \mathbf{v} - \mathbf{v}_{h}) + \int_{\Omega_{F}} (\mathbf{f}_{h} - \nabla p_{h}) (\mathbf{v} - \mathbf{v}_{h}) + \int_{\Omega_{P}} (\mathbf{f}_{h} - \nabla p_{h} - \mu \mathbf{u}_{h}) (\mathbf{v} - \mathbf{v}_{h})$$

$$- \nu \int_{\Omega_{F}} \mathbf{curl} \mathbf{u}_{h} \mathbf{curl} (\mathbf{v} - \mathbf{v}_{h})$$

$$(5.10)$$

We replace  $\mathbf{u} - \mathbf{u}_h$  by  $\mathbf{w} + \nabla \lambda$ , take  $\mathbf{v} = \tilde{\mathbf{w}}$  and  $\mathbf{v}_h = \mathcal{R}_h \mathbf{v}$ , remark that  $\operatorname{curl} \mathbf{w} = \operatorname{curl} \tilde{\mathbf{w}}$  in  $\Omega_F$  and use the integration by part formula to obtain:

$$\nu ||\mathbf{curl}\,\mathbf{w}||_{0,\Omega_{F}}^{2} = \int_{\Omega_{F}} (\mathbf{f} - \mathbf{f}_{h})(\tilde{\mathbf{w}} - \mathcal{R}_{h}\tilde{\mathbf{w}}) - \int_{\Omega_{F}} (\mathbf{f}_{h} - \nabla p_{h})(\tilde{\mathbf{w}} - \mathcal{R}_{h}\tilde{\mathbf{w}}) - \frac{\nu}{2} \sum_{\kappa \in \tau_{h}^{F}} \sum_{e \in \varepsilon_{\kappa}} \int_{e} [\mathbf{curl}\,\mathbf{u}_{h} \times \mathbf{n}] (\tilde{\mathbf{w}} - \mathcal{R}_{h}\tilde{\mathbf{w}})$$
(5.11)

Since  $\Omega_F$  is convex, the theorem 2.2 and the lemma 2.3 get:

$$\nu ||\mathbf{curl}\,\mathbf{w}||_{0,\Omega_F} \leq C \Big(\sum_{\kappa \in \tau_h^F} \left(h_{\kappa}^2 ||\mathbf{f} - \mathbf{f}_h||_{0,\kappa}^2 + h_{\kappa}^2 ||\mathbf{f}_h - \nabla p_h||_{0,\kappa}^2 \right)^{1/2} + \frac{\nu}{2} \sum_{\kappa \in \tau_h^F} \sum_{e \in \varepsilon_{\kappa}} h_{\kappa} ||[\mathbf{curl}\,\mathbf{u}_h \times \mathbf{n}]||_{0,e}^2 \Big)^{1/2} \\ \leq C \Big(\sum_{\kappa \in \tau_h^F} h_{\kappa}^2 ||\mathbf{f} - \mathbf{f}_h||_{0,\kappa}^2 + \sum_{\kappa \in \tau_h^F} \gamma_{\kappa,F}^2 \Big)^{1/2},$$

$$(5.12)$$

and we obtain the upper bound. For the lower bound, we choose in the equation (5.10),  $\mathbf{v}_h = 0$  and we take for an element  $\kappa \in \Omega_F$ ,  $\mathbf{v} = (\mathbf{f}_h - \nabla p_h)\psi_{\kappa}$  and remark that

$$\int_{\kappa} \mathbf{curl} \ \mathbf{u}_h \ \mathbf{curl} \ \mathbf{v} = \int_{\partial \kappa} (\mathbf{curl} \ \mathbf{u}_h \times \mathbf{n}) \ \mathbf{v} = 0$$

to obtain using the inverse inequality  $||\operatorname{\mathbf{curl}} \mathbf{v}||_{0,\kappa} \le h_{\kappa}^{-1} ||\mathbf{v}||_{0,\kappa}$ :

$$||\mathbf{f}_{h} - \nabla p_{h}||_{0,\kappa}^{2} \leq ||\mathbf{f} - \mathbf{f}_{h}||_{0,\kappa}^{2} + |p - p_{h}|_{1,\kappa}^{2} + h_{\kappa}^{-2}||\operatorname{\mathbf{curl}} \mathbf{w}||_{0,\kappa}^{2}$$

Next, we take  $\mathbf{v} = \mathcal{L}_e([\mathbf{curl} \mathbf{u}_h \times \mathbf{n}]\psi_e)$  and integrate by part the last term of the equation (5.10) to obtain

$$\nu ||[\mathbf{curl} \ \mathbf{u}_h \times \mathbf{n}] \psi_e^{1/2} ||_{0,e} \le c \left( h_e^{-1/2} || \mathbf{curl} \ \mathbf{w} ||_{0,\Delta_e^F} + h_e^{1/2} || p - p_h |_{1,\Delta_e^F} + h_e^{1/2} || \mathbf{f}_h - \nabla p_h ||_{0,\Delta_e^F} + h_e^{1/2} || \mathbf{f} - \mathbf{f}_h ||_{0,\Delta_e^F} \right)$$
  
and we deduce the lower bound.

To show an upper and a lower bound of the pressure, we define the indicators:

$$\eta_{\kappa} = \begin{cases} \eta_{\kappa}^{F} = \sum_{e \in \varepsilon_{\kappa}} h_{e}^{1/2} \| \left[ (\mathbf{f}_{h} - \nabla p_{h}) \cdot \mathbf{n} \right] \|_{L^{2}(e)} & \text{if } \kappa \in \Omega_{F} \\ \eta_{\kappa}^{P} = \sum_{e \in \varepsilon_{\kappa}} h_{e}^{1/2} \| \left[ (\mathbf{f}_{h} - \nabla p_{h} - \mu \mathbf{u}_{h}) \cdot \mathbf{n} \right] \|_{L^{2}(e)} & \text{if } \kappa \in \Omega_{P} \end{cases}$$

$$(5.13)$$

where  $[\cdot]_e$  is the jump through the face e of  $\kappa$ . If the face e is on  $\Gamma$  or  $\partial\Omega$ ,  $[\cdot]_e$  will be the trace on e from the domain  $(\Omega_P \text{ or } \Omega_F)$  containing  $\kappa$ .

Theorem 5.4. The following bounds hold

$$|p - p_h|_{1,\Omega} \leq C\left\{\mu \| \operatorname{\mathbf{curl}} \mathbf{w} \|_{0,\Omega_F}^2 + \mu \| \nabla \lambda \|_{0,\Omega_F}^2 + \sum_{\kappa \in \tau_h} \left(\eta_{\kappa}^2 + h_{\kappa}^2 \| \operatorname{div} \mathbf{f} \|_{L^2(\kappa)}^2 + \left(\sum_{e \in \varepsilon_{\kappa}} h_e^{1/2} \| [(\mathbf{f} - \mathbf{f}_h).\mathbf{n}] \|_{L^2(e)}\right)^2\right) \right\}^{1/2}$$
(5.14)

and

$$\begin{cases}
\eta_{\kappa}^{F} \leq C\left(||\mathbf{w}||_{0,\Delta_{\kappa}^{P}} + |p - p_{h}|_{H^{1}(\Delta_{\kappa}^{F})} + h_{e} \| \operatorname{div} \mathbf{f} \|_{L^{2}(\Delta_{\kappa}^{F})} + \sum_{e \in \varepsilon_{\kappa}} h_{e}^{1/2} \| \left[ (\mathbf{f} - \mathbf{f}_{h}).\mathbf{n} \right] \|_{L^{2}(e)} \right) \\
\eta_{\kappa}^{P} \leq C\left( ||\nabla\lambda||_{0,\Delta_{\kappa}^{P}} + |p - p_{h}|_{H^{1}(\Delta_{\kappa}^{P})} + h_{e} \| \operatorname{div} \mathbf{f} \|_{L^{2}(\Delta_{\kappa}^{P})} + \sum_{e \in \varepsilon_{\kappa}} h_{e}^{1/2} \| \left[ (\mathbf{f} - \mathbf{f}_{h}).\mathbf{n} \right] \|_{L^{2}(e)} \right)
\end{cases} (5.15)$$

**Proof**: The error function  $p - p_h$  belongs to  $H^1(\Omega)$  and satisfies, using (3.6), for all  $q \in H^1(\Omega)$  and  $q_h \in Q_h$ :

$$\mu(\mathbf{u} - \mathbf{u}_h, \nabla q)_{\Omega_P} + (\nabla(p - p_h), \nabla q) = \mu(\mathbf{u} - \mathbf{u}_h, \nabla(q - q_h))_{\Omega_P} + (\nabla(p - p_h), \nabla(q - q_h))$$
$$= \int_{\Omega} \mathbf{f} \nabla(q - q_h) - \mu \int_{\Omega_P} \mathbf{u}_h \nabla(q - q_h) - \int_{\Omega} \nabla p_h \nabla(q - q_h)$$
(5.16)

We replace  $\mathbf{u} - \mathbf{u}_h$  by  $\nabla \lambda + \mathbf{w}$  and we obtain for all  $q \in H^1(\Omega)$  and  $q_h \in Q_h$ :

$$\begin{aligned} (\nabla(p-p_h), \nabla q) &= \int_{\Omega} (\mathbf{f} - \nabla p_h) \nabla(q-q_h) - \mu \int_{\Omega_P} \mathbf{u}_h \nabla(q-q_h) - \mu \int_{\Omega_P} \nabla \lambda \nabla q - \mu \int_{\Omega_P} \mathbf{w} \nabla q \\ &= \int_{\Omega} (\mathbf{f} - \mathbf{f}_h) \nabla(q-q_h) - \mu \int_{\Omega_P} \nabla \lambda \nabla q + \mu \int_{\Omega_F} \mathbf{w} \nabla q \\ &+ \int_{\Omega_P} (\mathbf{f}_h - \nabla p_h + \mu \mathbf{u}_h) \nabla(q-q_h) + \int_{\Omega_F} (\mathbf{f}_h - \nabla p_h) \nabla(q-q_h) \end{aligned}$$
(5.17)

Integrating by part and remarking that div  $\mathbf{f}_h = \text{div } \mathbf{u}_h = \text{div } \nabla p_h = 0$  in every element  $\kappa \in \tau_h$ , we obtain:

$$(\nabla(p-p_{h}),\nabla q) = -\mu \int_{\Omega_{P}} \nabla \lambda \nabla q + \mu \int_{\Omega_{F}} \mathbf{w} \nabla q + \sum_{\kappa \in \tau_{h}} \left\{ -\int_{\kappa} \operatorname{div} \mathbf{f} (q-q_{h}) + \frac{1}{2} \sum_{e \in \varepsilon_{\kappa}} \int_{e} [(\mathbf{f}-\mathbf{f}_{h}).\mathbf{n}](q-q_{h}) \right\} - \frac{1}{2} \sum_{\kappa \in \tau_{h}^{P}} \left\{ \sum_{e \in \varepsilon_{\kappa}} \int_{e} [(\mathbf{f}_{h}-\nabla p_{h}).\mathbf{n}](q-q_{h}) \right\} - \frac{1}{2} \sum_{\kappa \in \tau_{h}^{P}} \left\{ \sum_{e \in \varepsilon_{\kappa}} \int_{e} [(\mathbf{f}_{h}-\nabla p_{h}+\mu \mathbf{u}_{h}).\mathbf{n}](q-q_{h}) \right\}$$

$$(5.18)$$

We take  $q = p - p_h$  and  $q_h = I_h q$ , we use the relation  $a.b \leq \frac{1}{2\varepsilon}a^2 + \frac{\varepsilon}{2}b^2$  with a suitable choice of  $\varepsilon$ , the properties of  $I_h$  and the theorem (2.2) to obtain the inequality (5.14).

To prove the inequality (5.15), we take  $q_h = 0$ ,  $q = \mathcal{L}_e^F([(\mathbf{f}_h - \nabla p_h).\mathbf{n}]\psi_e)$  (resp.  $q = \mathcal{L}_e^P([(\mathbf{f}_h - \nabla p_h).\mathbf{n}]\psi_e))$  in the equation (5.18) and we use the property (5.1) to obtain the first inequality of (5.15) (resp. the second inequality).

To complete the upper and lower bounds of  $\mathbf{w}$ , we show bound on  $\mathbf{w}$  in  $\Omega_P$ . We introduce the indicators

$$\gamma_{\kappa,P} = \| \mathbf{f}_h - \nabla p_h + \mu \mathbf{u}_h \|_{0,\kappa} \quad \text{if } \kappa \in \Omega_P$$
(5.19)

**Theorem 5.5.** The following bounds hold:

$$\mu ||\mathbf{w}||_{0,\Omega_P} \le \left(\sum_{\kappa \in \tau_h^P} ||\mathbf{f} - \mathbf{f}_h||_{0,\kappa}^2\right)^{1/2} + \left(\sum_{\kappa \in \tau_h^F} \gamma_{\kappa,P}^2\right)^{1/2} + \mu ||\nabla\lambda||_{L^2(\Omega_P)} + ||\nabla(p - p_h)||_{L^2(\Omega_P)}$$
(5.20)

and

$$\gamma_{\kappa,P} \le C \left( ||\mathbf{f} - \mathbf{f}_h||_{0,\kappa}^2 + ||\mathbf{w}||_{0,\kappa}^2 + |p - p_h|_{1,\kappa}^2 + |\lambda|_{1,k}^2 \right)^{1/2}$$
(5.21)

**Proof**: In the equation (5.10), we replace  $\mathbf{u} - \mathbf{u}_h = \mathbf{w} + \nabla \lambda$  and we take  $\mathbf{v} = \mathbf{w}$  in  $\Omega_P$  and  $\mathbf{0}$  in  $\Omega_F$ . We choose  $\mathbf{v}_h = 0$  and we obtain:

$$\mu ||\mathbf{w}||_{0,\Omega_P}^2 = \int_{\Omega_P} (\mathbf{f} - \mathbf{f}_h) \mathbf{w} + \int_{\Omega_P} (\mathbf{f}_h - \nabla p_h + \mu \mathbf{u}_h) \mathbf{w} - \mu \int_{\Omega_P} \mathbf{w} \nabla \lambda - \int_{\Omega_P} \nabla (p - p_h) \mathbf{w}$$
(5.22)

Then we get the upper bound. For the lower bound, we choose  $\mathbf{v}_h = 0$  in the equation (5.10) and we take for an element  $\kappa \in \Omega_P$ ,  $\mathbf{v} = (\mathbf{f}_h - \nabla p_h + \mu \mathbf{u}_h)\psi_{\kappa}$  to obtain the lower bound.

To simplify the notations, we define the indicators:

$$\gamma_{\kappa} = \begin{cases} \gamma_{\kappa,F} & \text{if } \kappa \in \Omega_F \\ \gamma_{\kappa,P} & \text{if } \kappa \in \Omega_P \end{cases}$$

**Corollary 5.6.** Let  $\Omega_F$  be convex. The optimal a posteriori estimate holds

$$||\mathbf{u} - \mathbf{u}_{h}||_{X} + |p - p_{h}|_{1,\Omega} \leq \left\{ \sum_{\kappa \in \tau_{h}} \left( \gamma_{\kappa}^{2} + \xi_{\kappa}^{2} + \eta_{\kappa}^{2} + \|\mathbf{f} - \mathbf{f}_{h}\|_{0,\kappa}^{2} + h_{\kappa}^{2} \|\operatorname{div} \mathbf{f}\|_{L^{2}(\kappa)}^{2} \right) + \left( \sum_{e \in \varepsilon_{\kappa}} h_{e}^{1/2} \| \left[ (\mathbf{f} - \mathbf{f}_{h}) \cdot \mathbf{n} \right] \|_{L^{2}(e)} \right)^{2} \right\}^{1/2}$$
(5.23)

where  $\eta_{\kappa}$ ,  $\xi_{\kappa}$  and  $\gamma_{\kappa}$  are given by the formulas (5.5), (5.9), (5.15) and (5.21).

**Conclusion:** We observe that estimate (5.23) is optimal: up to the terms involving the data, the full error is bounded by a constant times the sum of all indicators. Estimates (5.5), (5.9), (5.15) and (5.21) are local, i.e., only involve the error in a neighborhood of K or e. The indicators  $\eta_{\kappa}$ ,  $\xi_{\kappa}$  and  $\gamma_{\kappa}$  can be viewed as a measure for the error of the space discretization and can be used to adapt the mesh-size in space.
