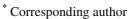

A Spatial Knowledge Sharing Platform Using the Visualization Approach

Abstract

Applications of information technologies have significantly improved efficiency of electronic document processing and management. The speed and amount of knowledge accumulation in the cyberspace have exceeded what common users can perceive. In order to enhance the efficiency and accuracy for knowledge receivers to acquire domain knowledge, an appropriate knowledge representation scheme is required. Most of the traditional schemes for explicit knowledge representation are text-oriented and much time is required for knowledge receivers to recognize the contents, especially for the spatial knowledge (e.g., the geographical or assembly information). This research develops a knowledge visualization methodology that computer systems can automatically convert the textual knowledge into visualized display. In addition to the proposed methodology, a Web-based prototype system is developed to support spatial knowledge sharing. In the prototype system, the free-form documents with spatial knowledge can be converted into formatted ones and the corresponding visualized display can be established based on the formatted contents. Feasibility and effectiveness of the proposed model are evaluated via a demonstration case. The goal of this research is to provide a knowledge visualization approach that can be widely applied in enterprise e-training to enhance the effectiveness of enterprise knowledge reuse.

Keywords: Knowledge Visualization, Knowledge Management, Knowledge Representation, Fragmentation, Virtual Reality Modeling Language (VRML).

1. Background

Due to the rapid accumulation of enterprise knowledge and the need for enterprise knowledge management, the traditional approach used to enhance acquisition of enterprise knowledge is teaching by domain experts (Moody et al., 1998; TerjeKarlsen and Gottschalk, 2004). However, such an approach is not cost effective since it requires professionals to extract and provide their expertise and therefore enterprises have to rely on experts for

knowledge sharing. Furthermore, in view of the space and time limitations of training, the enterprise knowledge sharing model should be re-engineered (Hou and Lin, 2004). Knowledge acquisition would be more efficient in speed and accuracy if the visualization approach (e.g., illustration or animated simulation) can be utilized to display the knowledge contents. In this way, knowledge receivers can improve their efficiency in knowledge recognition and increase their willingness in knowledge acquisition (Liebowitz, J., 2004; Gottschalk and Khandelwal, 2004).

The text-based knowledge and the knowledge sharing mechanism via traditional education usually have the disadvantages of insufficiency and the lack of concrete expression of knowledge contents. Therefore, if knowledge is presented via a visualization mechanism, the spatial contents of knowledge can be illustrated. Due to the experiences of human beings, the visualized representation mechanism is more direct and efficient in knowledge representation and absorbing. In order achieve the above aims brought by knowledge visualization, the text-based knowledge should first be analyzed and parsed based on its vocabulary structure. Then the literal content should be converted into corresponding illustration and orientation via visualization or simulation techniques to assist the knowledge receivers in knowledge acquisition. That is, with the knowledge visualization approach, knowledge expression could be more user-friendly and the knowledge acquisition and application could also be more efficient. The high efficiency of self-learning successfully gets rid of the defection of space and time limitations during knowledge sharing and thus the cost of knowledge sharing could be reduced.

Recently, the knowledge visualization concept has been applied to establish relations between objects in knowledge documents by deduction principle or to represent the hierarchical structure of knowledge contents. Such applications can assist document receivers to explore the overall distribution and structure of knowledge documents. However, in these applications, knowledge contents and meaning cannot be correctly and accurately expressed. Furthermore, previous research focuses mainly on natural language (NL) processing and complicated and time-consuming processes are required for knowledge content analysis. Automatic and rapid identification of semantic structure of the knowledge contents cannot be achieved. This research utilizes the representation and identification methodologies of spatial knowledge and establishes the domain thesaurus, rule database and illustration bank to automatically analyze the semantic structure of spatial knowledge within domain documents and generate the visualized display of spatial knowledge. As a result, the knowledge contents can be concretely and efficiently represented for the knowledge receivers.

This paper is organized as follows. In Section 2, the related studies about applications of the visualization technology and knowledge visualization are surveyed. The algorithms for identification and visualization of the spatial knowledge are represented in Section 3. Section 4 introduces the web-based spatial knowledge service platform developed in this research. Feasibility and performance of the proposed models are evaluated in Section 5. Conclusions are given in Section 6 to show some useful extensions of the proposed model.

2. Literature Review

This research emphasizes application of the visualization approach on spatial knowledge representation. Previous literature about applications of the visualization technology and knowledge visualization is reviewed in the following subsections.

2.1 Applications of the Visualization Technology

With the rapid development of information technologies, the 3D image processing technique has gradually taken the place of the traditional 2D plane technique. This trend enables the 3D technique to be extensively applied in different applications. Recently, with the development of multi-media technologies, virtual reality (VR) has emerged to be one of the popular technologies. Owing to the rapid calculation, drawing, animation processing of personal computers, the computer hardware and software can be used to simulate the real environment or real objects and thus users can acquire the learning and training materials in an instant and interactive environment. The characteristics (e.g., imagination, immersion and interaction) of the visualization technology can be utilized to provide users a more interactive channel for information sharing (Li, 2003).

Due to the great advancement of network communication bandwidth, instant and visualized interaction through network has become one of the major approaches for

information transmission. The 3D visualization software is powerful in processing and representing different types of information. Currently, the 3D software that is widely applied in real cases is 3D Studio MAX, VRML and Java 3D:

- 3D Studio MAX: 3D Studio MAX is developed by Autodesk for 3D animation. Its sophisticated functions can be divided into four main modules including modeling, compiling, scene and animation. Among the traditional researches, 3D Studio MAX has been used as an animation platform for customized digital body (Wu, 2003) or used to set up VR scene to simulate driving behaviors.
- VRML: VRML refers to Virtual Reality Modeling Language. Based on the hyper-text concept of HTML, VRML mainly defines a set of presentation standards of 3D graphs, by which Internet users are able to browse 3D illustrations. VRML is an object-oriented modeling language deployed with illustrations to describe 3D scenes and to display the 3D objects. In addition, it enables instant and distant interactions among Internet users (Wang, 2001; Chiou, 2000; Cao, 2000). VRML can also be used to develop 3D homepage design systems and Web page designers can easily establish 3D homepages without the knowledge of 3D language (Xue et al., 1999; Wasfy et al., 2004; Zhang, 2001).
- Java 3D: Java 3D is a program library that can be applied in Java platform for creating 3D objects. The library was designed based on the object-oriented concept. Java 3D was utilized to assemble the 3D components in database and to simulate the operation of mechanisms. The engineering information presented in a 3D simulation environment can be served as the communication channel between enterprises and clients (Chen, 2003).

In addition, in the current 3D interactive environment, more and more applications call for visualized presentation of instant operations. The related applications involve educational training, medical treatment and civil engineering, etc. As the 3D representation mechanism is applied in educational training, users can interact with each other in the virtual environment. Previous research has indicated that users in the VR environment could effectively and efficiently receive information (Jan, 2002) and interact with computer systems (Erenay, Hashemipour and Kayaligil, 2002). Furthermore, dynamic materials can be converted into 3D animation and be converted to interactive e-learning materials. With 3D software, animation modeling could be accomplished so that users can initiatively observe objects in any direction of a 3D space (Chu, 2002).

In the fields related to medical treatment, the 3D VR technique with 3D medical video and medical raster display can be brought into telemedicine systems (Chang, 1999). In addition, the virtual reality technique can be used to develop a computer-aided simulation system for intravenous injection and the operators can efficiently learn and practice the related procedure for intravenous injection (Hsiao, 2001).

As to civil engineering, after selection and analysis of the project blueprints, a 3D VR structure model proportional to the real one can be produced and users can quickly acquire the related information of the construction projects through the visualized interface (Hong, 2002; Yan, 2001).

2.2 Knowledge Visualization

Previous studies about knowledge management focus mainly on knowledge discovery (Neaga and Harding, 2005), knowledge extraction (Hou, Chuo, and Sun, 2003) and knowledge reuse (Shaw and Edwards, 2006). Concerning the knowledge sharing issues, the visualized display of information or knowledge can bring users into image and enhance their comprehension and cognition about the aim of learning. The traditional approach of representing the knowledge in text or in plane illustration has the defection of information insufficiency. With the 3D visualized simulation technique, knowledge can be represented via the visualization mechanism. Due to the similar experience in visualization of human beings, visualized knowledge representation is more direct and efficient for users to acquire knowledge. The visualized knowledge representation mechanisms can be divided into knowledge map representation and knowledge level representation. With The knowledge map representation mechanism, the knowledge contents and their corresponding relationship can be depicted via the landscape map. In the knowledge level representation mechanism, the relationship of knowledge contents can be represented via directories or a hierarchical tree.

A knowledge map displays the knowledge structure in the form of map to show the relevance of knowledge. Knowledge maps can be classified into three sub-categories (Tsai, 2002):

Conception knowledge map: Characterizing of the themes and conceptions of knowledge

Workflow knowledge map: Composed of a series of activities

Ability knowledge map: Used to explore relation between knowledge and human beings

The display methodologies of knowledge maps can be divided into landscape map and visualization of space-time relevance. The landscape map shows the knowledge and concept structure in the form of map or graph (Hadley, 1996). Large amount of knowledge is marked according to its characteristics and information and knowledge with high correlation is clustered and linked. The marked and linked information will be presented visually on the map. The structural map expression makes it easier for users to be acquainted with the complicated relevance and meanings of knowledge (Chen and Paul, 2001; Morris et al., 2002; Yeap et al., 2003). With a 3D space composed of longitude, latitude and time, visualization of space-time relevance is a special model showing the relation between time and space information in the documents (Hewagamage and Hirakawa, 2001; Yost et al., 1997).

Knowledge level representation categorizes the disordered information according to its attributes in order to obtain the visualized hierarchical structure of information. Lou et al. (2000) categorize information visualization into three levels namely basic visualization, conceptual visualization and evolutional visualization and propose different process models for distinct information visualization levels. Kanno et al. (1999) establish a visualized e-training support system and present a four-level knowledge model (i.e., configuration, causality, state and goal) to describe the domain knowledge. Ohwada and Mizoguchi (2003) utilize the information visualization and retrieval techniques in Internet knowledge searching. A 3D hyperbolic tree is used to reveal the linkage structure of Web pages and user preferences for the Web pages. In addition to exploring the level relation of knowledge, the Web pages that do not meet user preferences can be filtered out to enhance accuracy of information retrieval. Other knowledge visualization concepts include the visualized teaching algorithm (Hanson et al., 2002), knowledge-based multimedia medical distributed database system KmeD (Chu et al., 1995) and the integrated knowledge visualization scheme with three

fundamental views (i.e., knowledge type, recipient type and visualization type) (Burkhard, 2004).

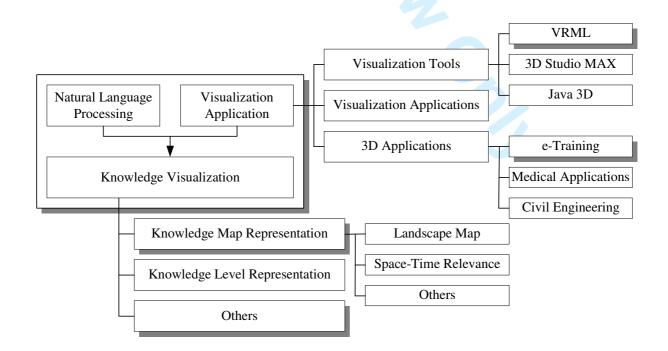


Figure 1. The research roadmap about knowledge visualization

In general, compared with the previous research, the achievements of this research can be shown in Figure 1. Those with shaded areas are the topics (i.e., knowledge content analysis and visualization) emphasized in this paper. Previous studies focus mainly on natural language processing for knowledge content analysis. The knowledge visualization concept has been applied to establish relations between objects in knowledge documents by deduction principle or to represent the hierarchical structure of knowledge contents. Such applications can simply assist document receivers to explore the overall distribution and structure of knowledge documents. However, in these applications, knowledge contents and meaning cannot be correctly and accurately expressed. In this research, the knowledge contents and meaning are taken into consideration for visualization. As a result, the knowledge receiver can more accurately recognize the knowledge contents.

On the other hand, the visual display has many advantages for learning and applied commonly in software learning/help applications. However, different from the other studies, this research recognizes the advantages of visual display and thus proposes a model to automatically convert the text-based contents into visualized display. As a result, rely on domain experts for generating the visual display can be reduced

3. Visualization Model for Spatial Knowledge

As shown in Section 2, in most of the previous research, the clusters or structural relation is presented in the form of graphs or hierarchical structure via the knowledge visualization technique. However, few papers are concentrated on the visualization of spatial knowledge contents. Therefore, in this research, the Cartesian coordinates are used to visualize the spatial knowledge represented in text. The visualization model for spatial knowledge first explores the standardized format for spatial knowledge expression (Pai and Hou, 2005). The standardized format can be represented as a geographic information matrix M:

M=[Object point, Reference point, Position, Proportion, Distance]

Taking the sentence "A is on the right of B, 10 meters away" for example, the free form sentence can be converted into a geographic information matrix with the object point (A), reference point (B), position (right), proportion (meter) and distance (10):

M=[A, B, right, meter, 10]

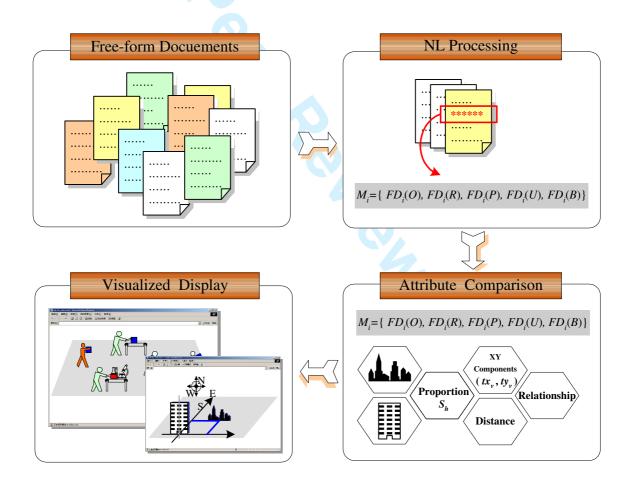


Figure 2. Procedure for knowledge visualization

Based on the derived information matrix, an attribute comparison procedure for information visualization can be carried out and the visualized display of knowledge contents can be obtained. The procedure for knowledge visualization can be illustrated via Figure 2. The free-form documents should first be converted into the formatted information matrix via knowledge structure analysis (Pai and Hou, 2005). First, a thesaurus containing three predefined tables (object, position and unit tables) and a rule database are established to denote the domain terms and semantic rules for expressing spatial knowledge. Then contents of a free-form document are fragmented into meaning units via a document fragmentation algorithm (Hou and Lin, 2005). The fragmented meaning units of each sentence are compared with the predefined thesaurus and rule to identify roles of the meaning

units in a sentence and thus a geographic information matrix can be established for each sentence containing spatial knowledge. For instance, "Proportion" in the geographic information matrix M denotes the unit (e.g., meter) used in the target sentence and can be automatically extracted by looking up a predefined unit table. Since the distance between the object and reference points is usually expressed via a numeric value followed by a unit, Distance in the geographic information matrix M can be automatically obtained by extracting the numeric value followed by a unit.

The formatted contents can be further converted into visualized display by looking up predefined tables, e.g., Object Relation Table, Direction Definition Table, Object Definition Table and Unit Conversion Table (details about these tables are provided in the following).

Before discussing details of the knowledge visualization procedure, the symbols used in the proposed methodology are defined as follows:

A_m B_i	The region attribute of the m'th relation rule INC_R_m in Object Relation Table The distance attribute in the i'th information matrix M_i of the target document
INC_R_m	The m'th relation rule in Object Relation Table
L_m	The location attribute of the m'th relation rule INC_R_m in Object Relation Table
O_i	The object point in the i'th information matrix M_i of the target document
P_i	The position attribute in the i'th information matrix M_i of the target document
R_i	The reference point in the i'th information matrix M_i of the target document
S_h	The conversion ratio of U_h with respect to meter
T_{v}	The v'th direction described in Direction Definition Table

U_i	The unit attribute in the i'th information matrix M_i of the target document

Since some critical information including distance, object illustration, unit conversion is required for spatial knowledge visualization, four fundamental tables namely Object Relation Table, Direction Definition Table, Object Definition Table and Unit Conversion Table are established for mapping visualization information:

Object Relation Table defines the relation between regions and sub-regions. As shown in Table 1, the relation rule *INC_R_i* defines that sub-region *L_i* is included in region *A_i*. That is, the object relation rules can be used to identify if two regions have subordination relation.

- Direction Definition Table can be used to define the direction P_i in information matrix M_i (as shown in Table 2). After looking up the table, the corresponding unit vector t_v of direction P_i can be applied to identify the relative position of objects in the information matrix for knowledge visualization.
- Object Definition Table can be used to map the object point O_i or the reference point R_i in the information matrix M_i to the corresponding path and file name PN_l of the visualized illustration C_l (as shown in Table 3).
- Unit Conversion Table can be used to convert the unit UC_h in the information matrix M_i into standard unit (i.e., meter) (as shown in Table 4). That is, the table lists the conversion ratios between the commonly used units and the standard unit.

The knowledge visualization methodology proposed in this research focuses on mapping the attributes in the information matrix to the related visualization parameters, including the subordination relation of objects and geographic definition of positions and directions. Details of the corresponding procedure are as follows.

Step (A1): Determine the subordination relation

In the attribute mapping procedure, the attributes in the information matrix are converted into illustrations. First the subordination relation of the object point and reference point (i.e., O_i and R_i) should be determined via the rules in Object Relation Table (L_m). The concept can be expressed as follows:

If there exits
$$INC_R_m$$
 that $O_i \in L_m$ and $R_i \in A_m$
Then O_i is in R_i (1)
Otherwise O_i and R_i are exclusive (2)

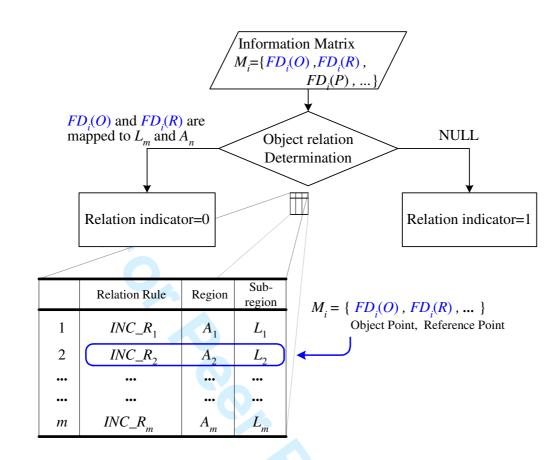


Figure 2. Procedure for subordination relation determination

In case (1), there exists subordination relation between R_i and O_i , and O_i is contained in R_i . In case (2), R_i and O_i are mutually exclusive. The procedure for determining the subordination relation between the object point and reference point is shown in Figure 2.

Step (A2): Determine the respective direction of objects

After determining the subordination relation between the object point and reference point in Step (A1), the position attribute P_i in information matrix M_i should be mapped to the related direction T_v in Direction Definition Table. As a result, a unit vector (tx_v, ty_v) indicating the respective direction of the object point and reference point can be obtained (as shown in Figure 3).

Step (A3): Convert the unit

In this step, the unit attribute U_i in the information matrix M_i should be mapped to UC_h defined in Unit Conversion Table which denotes the ratio between the target and default units. That is, according to the unit used in the target sentence and the default unit (i.e., meter), the ratio used to determine size of the visualized display can be determined by looking up the table. As a result, the unit conversion ratio S_h can be obtained for determining the respective position of the object point O_i and reference point R_i (Figure 6).

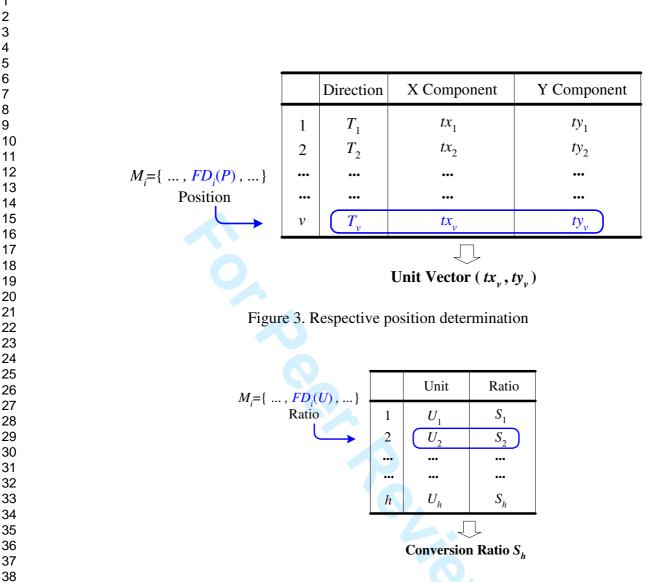


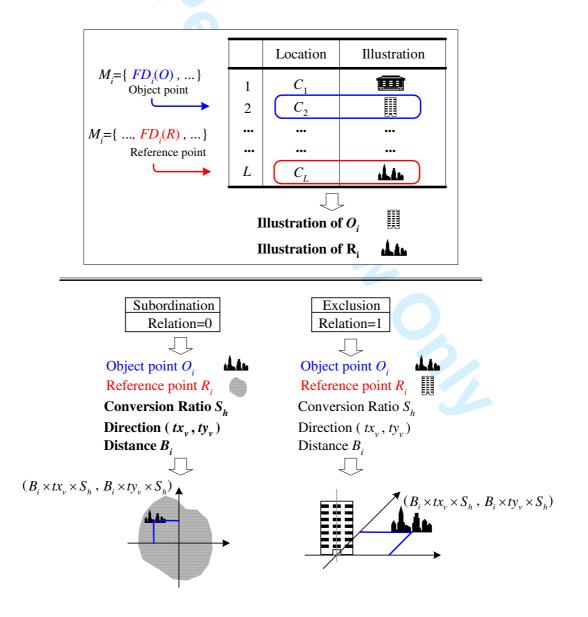
Figure 4. Illustration of Unit Conversion

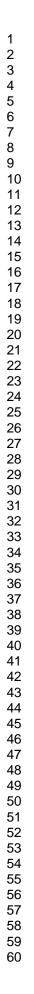
Step (A4): Visualize knowledge contents

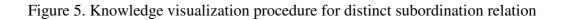
In this step, the related illustrations for knowledge visualization can be obtained after mapping the object point O_i and reference point R_i to Object Definition Table. The unit vector (tx_v, ty_v) and the conversion ratio S_h derived in Steps (A2) and (A3) can be used to generate the visualized display according to the subordination relation or exclusive relation determined in Step (A1). Without loss of generality, center of the illustration of the reference point is defined as the origin in the Cartesian coordinate and center of the object point is positioned on the $(B_i \times tx_v \times S_h, B_i \times ty_v \times S_h)$. The visualization process for the two distinct subordination relations is illustrated in Figure 5.

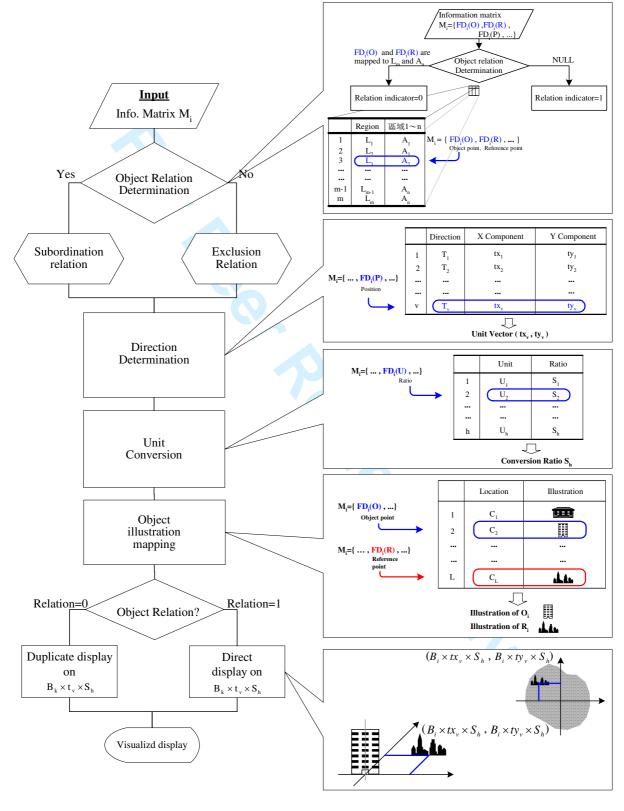
The entire procedure for knowledge visualization is revealed in Figure 6. After the

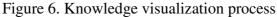
above knowledge visualization procedure, the corresponding visualized display of the information matrix M_i can be generated. The proposed methodology provides a systematic procedure for spatial knowledge visualization via looking up the domain thesaurus. Owing to the user-friendliness and easiness of the visualized display, the knowledge contents can be efficiently captured by users. On the other hand, the traditional knowledge visualization mechanism that simply presents the information hierarchy is unable to accurately show the knowledge contents. Via the proposed approach in this research, the Cartesian coordinate as well as the predefined illustrations can be used to visualize the spatial knowledge expressed in text. Through knowledge visualization, users can efficiently and accurately acquire spatial knowledge.

4. Spatial Knowledge Service Platform

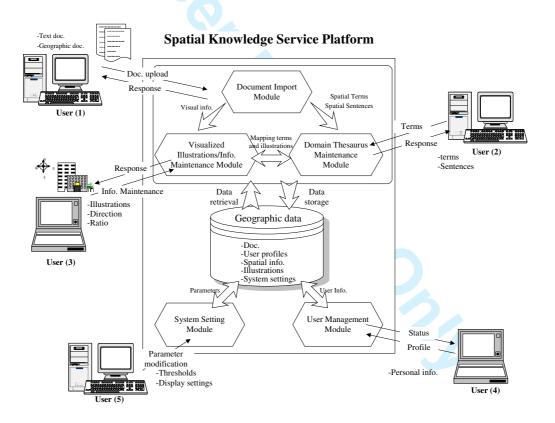


Figure 7. Operation framework of spatial knowledge service platform

In addition to the knowledge visualization algorithm, another purpose of this research is to develop a spatial knowledge service platform over the Internet. In the service platform, a semantic analysis module is developed to acquire and analyze the spatial knowledge in the free-form documents. On the other hand, a visualization module is developed for spatial knowledge visualization and presentation. Users can access the spatial knowledge service platform via the browser to share and manage the knowledge for visualization. There are five main modules namely Document Import Module, Domain Thesaurus Maintenance Module, Visualized Illustrations/Information Maintenance Module, User Management Module and System Setting Module. The relationship of the modules and information access mechanism are illustrated in Figure 7.

In this section, the manual for PC component assembly is taken as a demonstration case to show the knowledge visualization capability of the proposed system. For a PC retailer,

most employees are temporary staff (or self-supporting students) of short work term and high mobility. It usually costs the employers a lot of time and efforts to train the employees about PC component assembly. However, once the employees quit or newcomers are recruited, such time-consuming and costly training programs have to be resumed. It rather difficult for the staff to get acquainted with the assembly processes of all types of computers. As the knowledge visualization platform is applied in this domain, the technical personnel can equip the system with manuals and illustrations about PC component assembly in advance. Newcomers can acquire knowledge about PC component assembly by themselves and the cost of human resources and time devoted in repetitive training can be reduced. Furthermore, the system can facilitate staff's autonomous learning without limitations on time and space and risk of expertise loss can be reduced. Functions of the platform for two distinct roles, i.e., the knowledge provider (computer technicians) and the knowledge demander (new employees), will be introduced in the following.

(A) Knowledge providers (computer technicians)

For a PC retailer, the computer technicians are the providers of PC component assembly knowledge. The technicians are responsible for importing the manuals and illustrations of PC components onto the system so that the knowledge demanders can acquire related knowledge online. The technicians should maintain the following data:

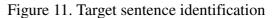
Figure 8. Thesaurus maintenance

- Thesaurus about PC component assembly: Computer technicians can input the domain vocabulary related to PC component assembly into the system via Domain Thesaurus Maintenance Module (Figure 8) including IDs of computer components (e.g., "RAM" and "CPU"), behaviors (e.g., "Install to", "Insert in" and "Link with") and location descriptions (e.g., "Below" and "Above").
- Illustrations of PC components: Illustrations of PC components can be maintained in the system for visualized presentation of text-based descriptions. In addition, subordination relation between components should also be identified to ensure correct visualization (Figure 9).
- Manuals for PC component assembly: As the manuals about PC component assembly are

imported onto the system via Document Import Module, the system will automatically analyze the uploaded files to identify the target sentences about assembly knowledge that can be represented visually. The target sentences are segmented and tagged to generate geographic information matrices. After mapping the information matrices with the domain thesaurus and illustrations, the related visual representation of the extracted target sentences can be displayed on the user interface and stored in the system database for the other employees to access. In addition, other materials about software and driver installation can be available to the staff as well (Figures 10 and 11).

(B) Knowledge Demanders (new employees)

With assistance of the system, new employees can examine the outlooks of various PC

components in order to get familiar with the visual instructions about PC component assembly. Three types of information available to knowledge demanders are as follows:

- Assembly information: New employees can realize the outlooks of all the PC components in the backend database via Visualized illustrations/Information Maintenance Module. As a result, new employees will not select the incorrect components during hardware installation (Figures 9 and 12).
- Text-based/visualized documents: New employees can acquire the documents uploaded by computer technicians via Visualized illustrations/Information Maintenance Module and learn PC assembly know-how by going over the illustrations. The non-spatial documents (e.g., installation instructions or notes) in pure text format are also available online (Figures 11 and 13).
- Documents for visualization: New employees can upload component assembly manuals by themselves through Document Import Module to the system. Contents of the manuals will automatically be analyzed and the corresponding visualized presentations can be generated for the other staff to browse. On the other hand, employees can also upload the visual illustrations of components to the database for more accurate visual display.

In summary, the thesaurus and illustrations used for spatial knowledge identification and visualization should be maintained in the platform via the interfaces of Figure 8 to Figure 9

respectively. Based on the predefined thesaurus and illustrations, the target document uploaded onto the platform (via the interface of Figure 10) can be analyzed to extract and visualize the spatial knowledge (via the interface of Figure 11).

5. Performance Evaluation

In order to evaluate the effectiveness of knowledge content analysis and visualized presentation, visualization of the PC component assembly knowledge is selected for demonstration.

Evaluation Scenario

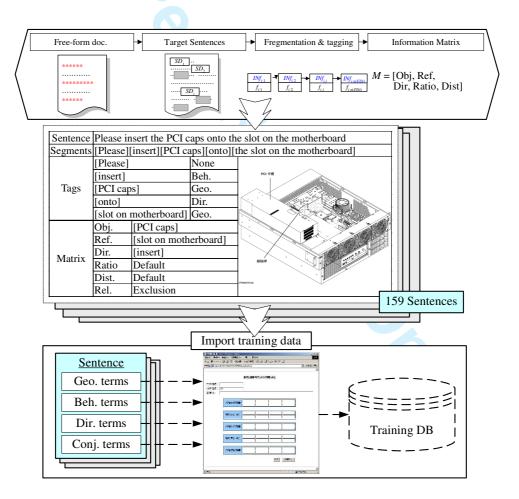


Figure 14. Target sentence identification and segmentation

At first, 62 manuals about PC component assembly are selected. The target sentences describing the spatial knowledge are also identified from the manuals and 159 sentences are selected for visualized presentation. Furthermore, the target sentences are segmented into meaningful units and each segment is marked with appropriate tag to denote its role in the geographic information matrix (i.e., object point, reference point, position, proportion or distance). The analysis procedure is revealed in Figure 14. Among the 62 manuals, 10 manuals and 10 target sentences are randomly selected to test the reasoning accuracy of the proposed methodology. In order to explore the learning capability of the proposed methodology, eight test stages with different numbers of training sentences (i.e., 20, 40,60, 80, 100, 120, 140 and 159 sentences) are carried out.

Performance Indices

In this research, six quantitative indices for target sentence identification, sentence fragmentation and tagging, and information matrix generation are employed to evaluate the performance of the proposed methodology.

(A) Target sentence identification

In a free-from document, the target sentences that express spatial knowledge will be extracted and visualized. In the developed platform, a sentence with the attributes of "object

point", "reference point" and "position" is regarded as a target sentence. That is, "proportion" and "distance" are considered as the required attributes for spatial knowledge representation and default values of "proportion" and "distance" are assigned to the target sentence without the two optional attributes. The parameters used to derived the recall rate and accuracy of target sentence identification are defined as follows:

The recall rate of target sentence identification $(R_S(Doc))$ denotes the system

performance in capturing the right target sentences. The accuracy of target sentence identification $(A_s(Doc))$ denotes correctness of the target sentences acquired. These two indices can be obtained as follows:

(B) Sentence fragmentation and tagging

The parameters used to derived the recall rate and accuracy of sentence fragmentation and tagging are defined as follows:

The recall rate of sentence fragmentation and tagging $(R_M(SD))$ represents capability of the system in fragmenting the target sentences into segments. The accuracy of sentence fragmentation and tagging $(A_M(SD))$ refers to correctness of the system in fragmenting the target sentences into segments. These two indices can be determined via the following equations:

Information matrix generation

The parameters used to derived the recall rate and accuracy of information matrix generation are defined as follows:

The recall rate of information matrix generation ($R_E(SD)$) refers to the system capability in parsing the target sentences into matrix elements. The accuracy of information matrix generation ($A_E(SD)$) represents correctness of the system in parsing the target sentences into matrix elements. These indices can be calculated as follows:

The above indices can be used in the eight test stages to evaluate performance of the developed system in spatial knowledge identification and visualization.

Result Analysis

(A) Target sentences Identification

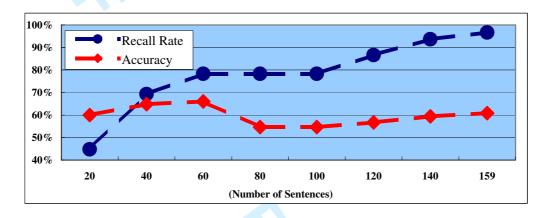


Figure 15. Performance tendency of target sentence identification

As shown in Table 5 and Figure 15, the recall rate of target sentence identification is at the lowest (44.76%) at the first stage (with 20 training sentences) and climbs up with increase of training sentences (amount to 159 sentences) to reach the peak (96.67%; the corresponding standard deviation is 0.105). Except that the recall rate at the fourth stage (with 80 training sentences) is equivalent to that at the fifth stage (with 100 training sentences), the recall rates at all stages feature an upward trend, which reveals the learning capacity of the target sentence identification.

The accuracy of target sentence identification with 20, 40 and 60 training sentences grows upward from 60.0%, 64.84% to 66.0%, while decreases by 11.33% to 54.67% with 80 It indicates that the system performs poor in target sentence training sentences. identification at the early stages (with fewer predefined domain terms). The accuracy grows slightly by 6.14% from the fourth stage to the eighth stage and it can be concluded that the accuracy of target sentence identification features the learning capacity. Higher accuracy can be achieved if the threshold value for target sentence identification can be adjusted with respect to the number of predefined domain terms.

(B) Sentence fragmentation and tagging

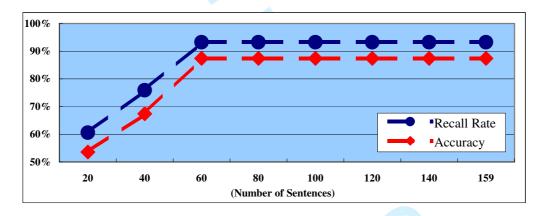


Figure 16. Performance tendency of sentence fragmentation and tagging

According to Table 6 and Figure 16, the recall rate of sentence fragmentation and tagging strikes the lowest at 66.55% (with a standard deviation of 0.255) at the first stage and ascends rapidly to the highest of 93.24% (with the lowest standard deviation of 0.118) at the third stage. The accuracy is at the lowest of 53.57% (with a standard deviation 0.260) at the first stage and increases to the highest of 87.38% at the third stage. It indicates that the recall rate and accuracy of sentence fragmentation and tagging feature learning capability. Moreover, small-scale application domains with limited domain knowledge or domain terms require less training stages for more reliable sentence identification, fragmentation and tagging.

(C) Information matrix generation

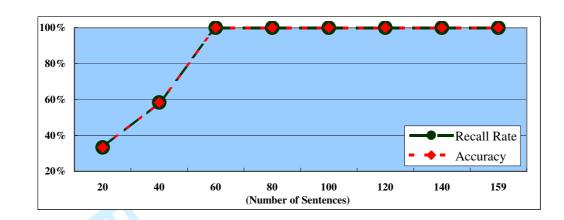


Figure 17. Performance tendency of information matrix generation

Based on Table 7 and Figure 17, the recall rate of information matrix generation hits the lowest at 33.33% (with a standard deviation of 0.471) at the first stage and climbs up quickly to 100% at the third stage. The accuracy is at the lowest of 33.33% (with a standard

deviation of 0.471) at the first stage and rises rapidly to 100% at the third stage. Information matrix generation relies much on the accuracy of sentence fragmentation and tagging. Therefore, as the recall rate and accuracy of sentence fragmentation and tagging reach the peak at the third stage, the performance of information matrix generation also strikes the highest.

The summarized results and the tendency graphs above reveal the learning capability of the system. As more domain terms are maintained in the system, the recall rate and accuracy of each type of performance indices can be enhanced. For domain knowledge with limited domain terms, less training stages are required for high effectiveness. Thus the proposed methodology and system can be applied to application domains with spatial terms in order to visually present domain knowledge.

On the other hand, comparing the engineer exploded map with the proposed methodology, the engineer exploded map accurately reveals the relationship of components of the target object. The exploded map is usually established by domain experts. This research develops an algorithm and a platform to automatically convert the text-based contents into visualized display (ideally the engineer exploded map). Based on the proposed methodology, rely on domain experts to establish the exploded map can be reduced. However, the shortcoming of this methodology is that accuracy of the visualized display generated via the proposed methodology cannot totally be guaranteed.

6. Conclusions

This research is dedicated to visual representation of spatial knowledge. At first, this study explores the spatial knowledge acquisition and presentation models for automatic structure analysis of spatial knowledge. Based on spatial information glossary and rule base, accurate visual representation of spatial knowledge contents can be generated. A Web-based system is developed to facilitate knowledge receivers to study the visualized domain

knowledge through highly user-friendly interface. Based on a demonstration case of PC component assembly, the proposed system is verified to effectively identify spatial knowledge and visually display the knowledge contents as an appropriate number of terms are maintained in the system. By application of the system, organizations can more effectively manage and share domain knowledge and the staff can more efficiently capture domain expertise through the knowledge visualization mechanism. In the future, the text-to-speech (TTS) technology can be integrated into the system to enhance the comprehensive interpretation and representation of spatial and non-spatial knowledge.
