#### 22 Abstract

23 The field of Biobanking requires extensive work in order to maintain traceability of 24 samples. However, sometimes the necessity to authenticate a sample may arise. To 25 address these circumstances, we herein present a method for authenticating derivatives 26 by using a blood spot from each donor, attached to a sample authentication form, by 27 means of genetic profiling. Blood spots are collected at the time a blood sample is 28 donated at a health centre and before processing the blood sample at the biobank. To 29 test the validity of our approach over time, we analyzed 26 blood spots stored at room 30 temperature in our facilities for more than 15 years. DNA was successfully extracted 31 from the three storage materials tested in this study and 15 STR markers plus 32 amelogenin were subsequently analyzed. The storage of a small blood spot attached to a 33 sample authentication form proved to be efficient for genetic profiling and, therefore, 34 may constitute a long-lasting (at least 15 years), cost-effective and effortless approach 35 for genetic authentication of samples in biobanks.

#### 39 Introduction

Traceability of samples constitutes one of the cornerstones in the emerging field of
Biobanking, but there are divergent viewpoints within the scientific community
regarding the way to implement it efficiently. The development of automatic and
robotic procedures has partially helped to overcome this difficulty. Yet, even with the
assistance of new high-tech procedures, a biobank may on occasion need to authenticate

45 the origin of a particular sample. Whenever a doubt related to traceability arises in a 46 biobank it is usually very difficult to check whether a sample does belong to a specific 47 donor. In such a case, the biobank will not be able to certify that samples are correctly 48 supplied to other biobanks or research groups. It is therefore crucial for biobanking 49 activities to implement a consistent system to guarantee authentication of biological 50 samples.

51 Genetic identification techniques used in the field of Forensic Genetics might be 52 successfully applied in sample authentication since they provide very high power of 53 discrimination (in the order of 1 in several thousand million). Currently, the most 54 common method utilized for human genetic identification is based on microsatellite or short tandem repeat (STR) loci.<sup>1-3</sup> By using less than 5 ng of DNA, up to fifteen 55 56 autosomal STR loci, plus the amelogenin gender-determining marker, can be 57 simultaneously amplified by means of some commercial multiplex PCR reaction kits with fluorescently labeled PCR primers,<sup>4</sup> including the 13 STR loci of the CODIS 58 59 system<sup>5</sup> which is used worldwide. The main drawback to this genetic profiling system 60 arises when it is necessary to process a large amount of samples as this is an expensive, 61 labour-intensive technique.

With the aim of avoiding a genetic profile analysis of every donor when the samples enter a biobank, the DNA Bank of the University of the Basque Country (UPV/EHU) has devised a cost-effective and reliable method for genetic authentication of biological samples through the collection of blood spots from the original donor. These blood spots are available for further analyses if authentication is required. This procedure is

67 applicable to any derivative such as cell collections, biological fluids or DNA obtained68 from blood samples in biobanks.

#### 70 Materials and Methods

71 The procedure presented herein is based on the preservation of small blood spots in 10 72 mm discs of storage material. A first blood spot collected for authentication purposes is 73 attached to a sample authentication form by health staff at the time the blood sample is 74 donated and the informed consent is signed (Figure S1). Once the blood sample and all 75 associated information have been received at the biobank, an aliquot is collected from 76 the blood sample to create a second blood spot which is also attached to the sample 77 authentication form to be used by the biobank as an internal control. In order to ensure 78 the privacy of donors, each sample authentication form is linked to information 79 associated with the corresponding donor and every derivative of the blood sample by 80 means of barcode labels generated by a Laboratory Information Management System 81 (LIMS). Blood spots, which are suitably protected from any manipulation and/or 82 contamination (Figure 1), can be stored at room temperatures for long periods of time. 83 The validation of our approach was performed by analyzing 26 blood spots of more 84 than 15 years old stored at room temperature, all of them belonging to 12 people 85 (named S01 to S12; see table 1) who worked in our laboratory and who voluntarily 86 agreed to participate in the study. Genetic profiles of each participant used as reference 87 in the present study were obtained from DNA stored at -20°C. Six out of the 26 blood 88 samples were preserved on absorbent paper, eight in a piece of lint and 12 stored on 89 non-colored cotton fabric. The blood spots collected at the beginning of 1994 were at

92	temperature in a security cabinet, protected from sunlight and at variable moisture

94	Blood spot samples were retrieved for DNA extraction in autumn 2008. We used a 3.0
95	mm Whatman Harris punch to obtain a portion of the storage material. This portion was
96	subsequently cut into small pieces using sterile scissors. Samples were incubated
97	overnight at 56°C in 500 µl of lysis solution (NaCl 0.2M, EDTA 10mM, Tris 10mM,
98	SDS 2%, DTT 40mM and 0.8 mg/ml proteinase K as final concentration). DNA
99	extraction was performed using the standard phenol-chloroform procedure. <sup>7</sup> Firstly, 200
100	$\mu$ l of phenol/chloroform-isoamyl alcohol in a proportion of 25:24:1 were added to each
101	tube. After centrifugation and recovery of the aqueous phase, two additional washes
102	with chloroform-isoamyl alcohol were carried out to further purify the samples. Once
103	the aqueous phase was recovered, we added NaAc 2M in a proportion of 1/10 to the
104	volume of aqueous phase, 1 $\mu l$ of glycogen (10mg/ml) and two volumes of cold
105	absolute ethanol (-20°C). To facilitate DNA precipitation, sample tubes containing the
106	precipitation mix were stored at -20°C for two hours. Subsequent centrifugation at
107	14,000 g was carried out to obtain the DNA pellet; this pellet is frequently not visible
108	when extracting DNA from old blood spots. After a final wash with EtOH 70%,
109	samples were introduced into a centrifugal evaporator (DNA mini; Heto Holten,
110	Allerød, Denmark) to get the pellet dried. Finally, samples were resuspended in 20 $\mu$ l of
111	sterile water.

112 The Quant-iT<sup>™</sup> PicoGreen<sup>®</sup> dsDNA Assay Kit (Invitrogen, Carlsbad, CA) was used to 113 quantify the extracted DNA. We added 1 µl of each sample to 199 µl of the 114 quantification mix (1/400 PicoGreen and 1/20 Buffer TE 20x) and DNA concentration 115 was obtained in a VersaFluor fluorometer (BioRad, Richmond, CA). Genetic profiles of 116 microsatellite loci for each sample (including reference samples) were obtained by 117 means of PCR amplification in a GeneAmp 9700 Gold (Applied Biosystems, Foster 118 City, CA) using two commercial kits: AmpFlSTR<sup>®</sup> Identifiler<sup>™</sup> PCR Amplification 119 Kit and AmpFlSTR® SGM Plus<sup>™</sup> PCR Amplification Kit (Applied Biosystems). Only 120 2 ng of DNA were used for each amplification reaction. Fragment analysis of PCR 121 products was carried out by capillary electrophoresis using an ABI3130 Genetic 122 Analyzer (Applied Biosystems). Finally, GeneMapper® Software v4.0 (Applied 123 Biosystems) was utilized for allele designation. 124 We conducted a one-way analysis of variance (ANOVA) followed by a Tukey-Kramer 125 multiple-comparison post-hoc test to determine whether mean DNA concentrations 126 obtained for the three different storage materials showed significant differences.

#### 128 **Results**

129 The blood spots stored in the three different support media (absorbent paper, lint or non-

130 colored cotton fabric) did not show notable degradation signs, irrespective of the

131 material used. Likewise, oscillations of moisture levels over years did not seem to affect

132 blood spot conservation, since no fungal growth was observed in any of the samples.

133	DNA extraction from blood spots was successful in the three types of storage material
134	tested in our study. Nevertheless, DNA extraction from lint proved to be somewhat
135	complicated since it was rather difficult to manipulate this kind of material, particularly
136	when we attempted to cut it into smaller pieces to facilitate the extraction procedure.
137	Subsequent DNA quantification with PicoGreen confirmed DNA isolation: all the
138	samples rendered concentrations that varied between 1.5 and 28 ng/ $\mu$ l of double strand
139	DNA. Mean DNA concentrations ( $\pm$ standard error) obtained for lint, absorbent paper
140	and cotton fabric were 7.3 $\pm$ 1.6, 14.8 $\pm$ 3.1 and 13.2 $\pm$ 1.8 ng/µl, respectively.
141	Significant differences between the DNA concentrations obtained in each material were
142	revealed by the ANOVA results (F = 4.36; df = 2, 25; p < 0.05). The Tukey test showed
143	no differences between the DNA concentrations of cotton fabric and absorbent paper,
144	which in turn differed from the concentration obtained in lint ( $p < 0.05$ ).

#### 159 **Discussion**

160 Authentication procedures are fundamental to biobanking services, because they must 161 ensure that a specific sample or set of samples come from a specific donor before 162 supplying them to the scientific community. Therefore, biobanks are required for 163 preventing and identifying errors, such as sample misplacement. In fact, an emphasis on 164 high standards in traceability is recommended by many European initiatives for the international networking of Biobanking.<sup>8-10</sup> Genetic profiling seems to be an efficient 165 166 approach for sample authentication. Interestingly, there are very few studies focusing on 167 authentication procedures in biobanks by means of genetic profiling, most of them centred on cell line authentication.<sup>11-14</sup> Indeed, obtaining the genetic profile for the 168 169 whole collection of a biobank might be extremely expensive and laborious. To 170 overcome this limitation, we have devised a system based on the conservation of blood 171 spots that allows a biobank to resort to using the genetic profile of the donor only when 172 strictly necessary. The collection of the first blood spot at the time a blood sample is 173 donated at a health centre is crucial in order to carry out our method of authentication. 174 Thus, this blood spot would allow authentication of any derivative to the original donor, 175 whereas the second blood spot would be used to trace sample processing at the biobank 176 as a kind of internal control.

177 There are various commercial systems for fluid storage at room temperature, such as
178 FTA® cards (Whatman®) or IsoCode DNA matrix (Schleicher & Schuell BioScience,

179 Inc.). Yet, biobanks often have to operate within a limited budget in a relatively 180 expensive field and, therefore, implementing low-cost systems may be a valid 181 alternative. In this sense, all the storage materials tested in this study proved to be 182 effective for the conservation of blood spots at room temperature for long periods of 183 time. However, taking into account the DNA concentration obtained for each substrate, 184 non-colored cotton fabric and absorbent paper seem to be the most effective for long-185 term conservation. It is likely that cotton strands in lint form an excessively open net in 186 which the DNA is more accessible by any degrading agent. It might be advisable to 187 analyze a larger sample set in order to replicate these results. However, even though the 188 DNA Bank of the UPV/EHU accumulates a very large number of samples, only the 189 blood spots from the 12 individuals included in this study were stored exactly in the 190 conditions presented herein and for a period of more than 15 years. 191 The method of genetic profiling presented herein involves the use of two commercial

192 kits. Two main reasons led us to select these kits: 1) the SGM Plus<sup>™</sup> Kit shares its 10 193 STR markers with 10 out of 15 microsatellite markers of the Identifiler<sup>™</sup> PCR 194 Amplification Kit. Therefore, the genetic profile of each sample is partially double 195 checked, thereby avoiding a potential error in the designation of alleles caused by allelic 196 drop-out due to DNA degradation and, at the same time, improving the quality and 197 reliability of the results; and 2) the use of standardized and validated commercial kits for STR genotyping provides the possibility of managing comparable data<sup>15</sup> between 198 199 biobanks and conducting inter-laboratory quality controls. In addition, the genetic 200 profiling step would not routinely be carried out, so that the cost increase is not 201 expected to be high.

In cases where misplacement is detected, our approach would allow the biobank to confirm a putative traceability gap and, once confirmed, to undertake appropriate corrective actions. It would be advisable to analyze all the derivatives related to the affected sample (plasma, DNA, cell lines, etc.). Thus, the confirmation of a mismatch would involve, at the very least, discarding the "orphan" derivatives from the biobank collection and, therefore, stopping the supply of incorrectly stored derivatives.

208 Concerning the legal and ethical aspects involving sample genotyping for authentication purposes, each biobank must follow the governing laws in the corresponding country.<sup>16</sup> 209 210 The blood preservation method presented herein complies both with Spanish biomedical research law 14/2007<sup>17</sup> on the traceability of data and biological samples and Organic 211 Law 15/1999<sup>18</sup> on personal data protection. According to these laws, all the information 212 213 related to each sample should be kept at the biobank as classified information. In 214 compliance with these laws, we have developed a sample authentication form 215 specifically designed to store blood spots for long periods of time. This method makes it 216 possible to maintain the anonymity of the donor and, at the same time, make use of a 217 blood spot from the original sample for authentication purposes. To further comply with 218 ethical recommendations about information to donors, notification about the collection 219 and storage of blood spots for sample authentication should be included as part of the 220 informed consent.

Further to the above, genetic data generated during the authentication process should be stored at biobanks, bearing in mind that they take responsibility for all data resulting from the collection, storage, processing and shipment of each sample. However, in compliance with the governing laws in many countries such as Spain, upon a donor's request, a biobank is obliged to destroy the sample and all its derivatives. Our approach

226	conforms to legal requirements as barcode labels generated during sample processing
227	allow us to identify and discard all components of any sample, including any
228	authentication forms.
229	To summarize, the results of the present study obtained from samples which are years
230	old indicate that the storage of small spots of dried blood preserved at room temperature
231	in 10 mm discs of non-colored cotton fabric or absorbent paper, attached to a sample
232	authentication form and conveniently protected from mishandling and/or contamination,
233	could be a long-lasting (at least 15 years), cost-effective and effortless approach for
234	subsequent genetic authentication of biobank samples. In addition, any analysis of
235	genetic profiles through use of commercial, standardized kits for STR typing provides
236	for the quality requirements of a biobank which is an issue of vital importance in the up-
237	and-coming field of biobank networking.

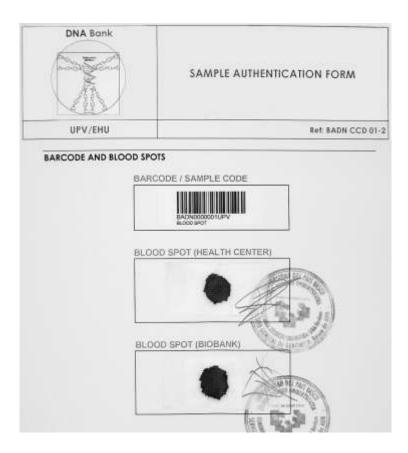
### 297 Titles and legends to figures

Figure 1. Blood spots attached to a sample authentication form covered with surgical tape. Blood spot collection at the time the sample is donated allows for genetic authentication of samples from the original donor. This collection is certified by the signatures of health staff. The signature of a member of the biobank staff validates the collection of the second blood spot when the sample enters the biobank; this blood spot would be used to trace sample processing in the laboratory. A rubber stamp allows further detection of any uncontrolled manipulation of blood spots.

2 Figure S1. Sample processing workflow. Once a donor signs the informed consent at 3 the health centre, associated information as well as the blood sample can be collected by 4 health centre staff. At that time a first blood spot is directly added to the corresponding 5 gap in the sample authentication form (SAF). All these elements make up the sample 6 and are linked through barcode labels. On entering the biobank, an aliquot is collected 7 from the blood sample to attach a second blood spot to the SAF. The first bloodspot is 8 used for sample authentication since it is collected directly from the original donor, 9 whereas the second blood spot allows internal control within the confines of the 10 biobank.

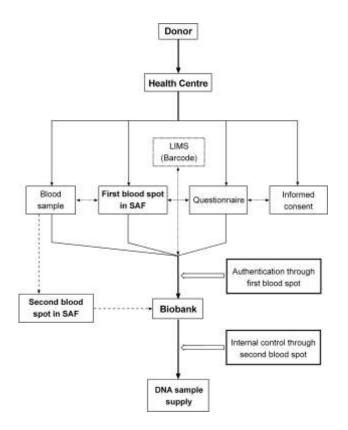
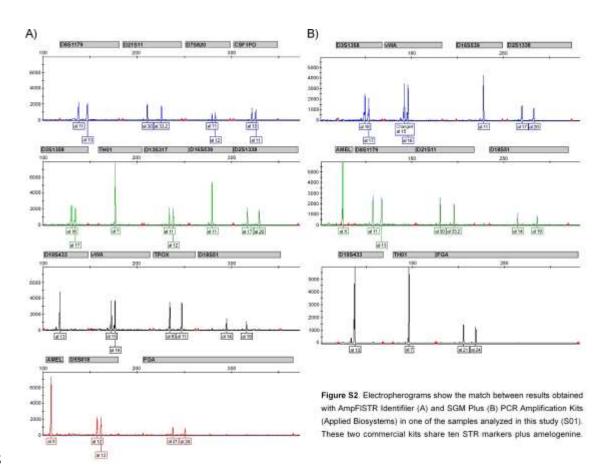


Figure S2. Electropherograms show the matching between genetic profiles obtained

(Applied Biosystems) in one of the samples analyzed in this study (S01).

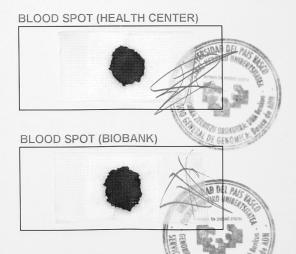
