# On a nonlinear heat equation associated with Dirichlet - Robin conditions

#### Abstract

This paper is devoted to the study a nonlinear heat equation associated with Dirichlet-Robin conditions. At first, we use the Faedo - Galerkin and the compactness method to prove existence and uniqueness results. Next, we consider the properties of solutions. We obtain that if the initial condition is bounded then so is the solution and we also get asymptotic behavior of solutions as $t \rightarrow+\infty$. Finally, we give numerical results.


Keywords: Faedo - Galerkin method, nonlinear heat equation, Robin conditions, Asymptotic behavior of the solution.

## 1 Introduction

In this paper, we consider the following nonlinear heat equation

\end{equation*}

associated with conditions

u_{x}(0, t)=h_{0} u(0, t)+g_{0}(t), \quad-u_{x}(1, t)=h_{1} u(1, t)+g_{1}(t), \tag{1.2}
\end{equation*}
$$

and initial condition

\end{equation*}

where $u_{0}, \mu, f, f_{1}, g_{0}, g_{1}$ are given functions satisfying conditions, which will be specified later, and $h_{0}, h_{1} \geq 0$ are given constants, with $h_{0}+h_{1}>0$.

The conditions (1.2) are commonly known as Dirichlet - Robin conditions. They connect Dirichlet and Neumann conditions. Theses conditions arise from the effect of excess inert electrolytes in an electrochemical system through perturbation analysis ( [2], [6], [7], [8]).

The governing equations (1.2) are the equation usually used in a diffusion, convection, migration transport system with electrochemical reactions occurring at the boundary electrodes and submitted to non linear constraints.

In electrochemistry, the oxidation-reduction reactions producing the current is modeled by a non linear elliptic boundary value problem, linearization of which gives the Dirichlet - Robin conditions ([3] ). Theses conditions also appear in the response of an electrochemical thin film, such as separation in a micro - battery. His analyze is made by solving the Poisson - Nernst - Planck equation subject to boundary conditions appropriate (Dirichlet - Robin conditions) for an electrolytic cell ([7]).

The paper consists of six sections. In Section 2, we present some preliminaries. Using the Faedo - Galerkin method and the compactness method, in Section 3, we establish the existence of a unique weak solution of the problem (1.1) - (1.3) on $(0, T)$, for every $T>0$. In section 4, we prove that if the initial condition is bounded, then so is the solution. In section 5 , we study asymptotic behavior of the solution as $t \rightarrow+\infty$. In section 6 we give numerical results.

## 2 Preliminaries

Put $\Omega=(0,1), Q_{T}=\Omega \times(0, T)$. We will omit the definitions of the usual function spaces and denote them by the notations $L^{p}=L^{p}(\Omega), H^{m}=H^{m}(\Omega)$. Let $\langle\cdot, \cdot\rangle$ be either the scalar product in $L^{2}$ or the dual pairing of a continuous linear functional and an element of a function space. The notation $\|\cdot\|$ stands for the norm in $L^{2}$ and we denote by $\|\cdot\|_{X}$ the norm in the Banach space $X$. We call $X^{\prime}$ the dual space of $X$. We denote $L^{p}(0, T ; X), 1 \leq p \leq \infty$ the Banach space of real functions $u:(0, T) \rightarrow X$ measurable, such that $\|u\|_{L^{p}(0, T ; X)}<+\infty$, with

Let $u(t), u^{\prime}(t)=u_{t}(t)=\dot{u}(t), u_{x}(t)=\nabla u(t), u_{x x}(t)=\Delta u(t)$, denote $u(x, t)$, $\frac{\partial u}{\partial t}(x, t), \frac{\partial u}{\partial x}(x, t), \frac{\partial^{2} u}{\partial x^{2}}(x, t)$, respectively.

On $H^{1}$ we shall use the following norms $\|v\|_{H^{1}}=\left(\|v\|^{2}+\left\|v_{x}\right\|^{2}\right)^{1 / 2},\|v\|_{i}=$ $\left(v^{2}(i)+\left\|v_{x}\right\|^{2}\right)^{1 / 2}, i=0,1$.

Let $\mu \in C^{0}\left(\bar{Q}_{T}\right)$, with $\mu(x, t) \geq \mu_{0}>0$, for all $(x, t) \in \bar{Q}_{T}$, and the constants $h_{0}, h_{1} \geq 0$, with $h_{0}+h_{1}>0$, we consider a familly of symmetric bilinear forms $\{a(t ; \cdot, \cdot)\}_{0 \leq t \leq T}$ on $H^{1} \times H^{1}$ as follows

Then, the symmetric bilinear form $a(t ; \cdot, \cdot)$ is continuous on $H^{1} \times H^{1}$ and coercive on $H^{1}$, i.e.,

The proofs of these lemmas are straightforward. We shall omit the details.
Remark 2.1. It follows from (2.2) that on $H^{1}, v \longmapsto\|v\|_{H^{1}}$ and $v \longmapsto\|v\|_{i}$ are two equivalent norms satisfying

## 3 The existence and uniqueness theorem

We make the following assumptions:

$\left(H_{3}\right) \quad g_{0}, g_{1} \in W^{1,1}(0, T)$,
$\left(H_{4}\right) \quad \mu \in C^{1}([0,1] \times[0, T]), \mu(x, t) \geq \mu_{0}>0, \forall(x, t) \in[0,1] \times[0, T]$,
$\left(H_{5}\right) \quad f_{1} \in L^{1}\left(0, T ; L^{2}\right)$,
$\left(H_{6}\right) \quad f \in C^{0}(\mathbb{R})$ satisfies the condition, there exist positive constants $C_{1}, C_{1}^{\prime}, C_{2}$ and $p>1$,
(i) $u f(u) \geq C_{1}|u|^{p}-C_{1}^{\prime}$,
(2i) $|f(u)| \leq C_{2}\left(1+|u|^{p-1}\right)$, for all $u \in \mathbb{R}$.
The weak formulation of the initial boundary valued (1.1) - (1.3) can then be given in the following manner: Find $u(t)$ defined in the open set $(0, T)$ such that $u(t)$ satisfies the following variational problem

We then have the following theorem.
Theorem 3.1. Let $T>0$ and $\left(H_{1}\right)-\left(H_{6}\right)$ hold. Then, there exists a weak solution $u$ of problem (1.1) - (1.3) such that

then the solution is unique.
Proof. The proof consists of several steps.
Step 1: The Faedo - Galerkin approximation (introduced by Lions (5).
Let $\left\{w_{j}\right\}$ be a denumerable base of $H^{1}$. We find the approximate solution of the problem (1.1) - (1.3) in the form

It is clear that for each $m$ there exists a solution $u_{m}(t)$ in form (3.4) which satisfies (3.5) and (3.6) almost everywhere on $0 \leq t \leq T_{m}$ for some $T_{m}, 0<T_{m} \leq T$. The following estimates allow one to take $T_{m}=T$ for all $m$.

Step 2. A priori estimates.
a) The first estimate. Multiplying the $j^{\text {th }}$ equation of (3.5) by $c_{m j}(t)$ and summing up with respect to $j$, afterwards, integrating by parts with respect to the time variable from 0 to $t$, we get after some rearrangements

b) The second estimate. Multiplying the $j^{t h}$ equation of the system (3.5) by $t^{2} c_{m j}^{\prime}(t)$ and summing up with respect to $j$, we have

Lemma 3.3. Put $\lambda_{0}=\left(\frac{C_{1}^{\prime}}{C_{1}}\right)^{1 / p}, m_{0}=\int_{-\lambda_{0}}^{\lambda_{0}}|f(y)| d y$, and $\bar{f}(z)=\int_{0}^{z} f(y) d y$, $z \in \mathbb{R}$.

& \int_{0}^{1} z_{t} z^{+} d x=\int_{0, z>0}^{1}\left(z^{+}\right)_{t} z^{+} d x=\frac{1}{2} \frac{d}{d t} \int_{0, z>0}^{1}\left|z^{+}\right|^{2} d x=\frac{1}{2} \frac{d}{d t} \int_{0}^{1}\left|z^{+}\right|^{2} d x=\frac{1}{2} \frac{d}{d t}\left\|z^{+}(t)\right\|^{2} . \tag{4.7}
\end{align*}

and on the domain $z>0$ we have $z^{+}=z$ and $z_{x}=\left(z^{+}\right)_{x}$.
On the other hand, by the assumption $\left(H_{2}^{\prime}\right)$ and the inequality (2.3), we obtain

The case $-M \leq u_{0}(x)$, a.e., $x \in \Omega$, and $M \geq \max \left\{\frac{1}{h_{0}}\left\|g_{0}\right\|_{L^{\infty}(0, T)}, \frac{1}{h_{1}}\left\|g_{1}\right\|_{L^{\infty}(0, T)}\right\}$ can be dealt with, in the same manner as above, by considering $z=u+M$ and $z^{-}=\frac{1}{2}(|z|-z)$, we also obtain $z^{-}=0$ and hence $u(x, t) \geq-M$, for a.e. $(x, t) \in Q_{T}$.

From all above, one obtains $|u(x, t)| \leq M$, a.e. $(x, t) \in Q_{T}$, i.e.,

## 5 Asymptotic behavior of the solution as $t \rightarrow+\infty$.

In this part, let $T>0,\left(H_{1}\right)-\left(H_{7}\right)$ hold. Then, there exists a unique solution $u$ of problem (1.1) - (1.3) such that

We shall study asymptotic behavior of the solution $u(t)$ as $t \rightarrow+\infty$.
We make the following supplementary assumptions on the functions $\mu(x, t), f_{1}(x, t)$, $g_{1}(t), g_{2}(t)$.

Furthermore, if $f$ satisfies the following condition, in addition,

Then the solution is unique.

## 6 Numerical results

First, we present some results of numerical comparison of the approximated representation of the solution of a nonlinear problem of the type (1.1) - (1.3) and the corresponding exact solution of this problem.

Let the problem

The exact solution of the problem (6.1), (6.2) is $u(x, t)=\left(1+e^{-t}\right) e^{x}$.
To solve numerically the problem ( $(6.1),(6.2)$, we consider the nonlinear differential system for the unknowns $u_{k}(t)=u\left(x_{k}, t\right), x_{k}=k h, h=1 / N$.

u_{0}=\frac{1}{1+2 h}\left(u_{1}-h g_{0}(t)\right), u_{N}=\frac{1}{1+h}\left(u_{N-1}-h g_{1}(t)\right) \\
u_{k}(0)=\widetilde{u}_{0}\left(x_{k}\right), k=1,2, \ldots, N-1
\end{array}\right.
$$

or

\frac{d u_{1}}{d t}(t)=\frac{-1}{h^{2}}\left(\frac{1+4 h}{1+2 h}\right) u_{1}+\frac{1}{h^{2}} u_{2}-f\left(u_{1}\right)-\frac{1}{h(1+2 h)} g_{0}(t)+f_{1}\left(x_{1}, t\right)  \tag{6.3}\\
\frac{d u_{k}}{d t}(t)=\frac{1}{h^{2}} u_{k-1}-\frac{2}{h^{2}} u_{k}+\frac{1}{h^{2}} u_{k+1}-f\left(u_{k}\right)+f_{1}\left(x_{k}, t\right), \quad k=\overline{2, N-2} \\
\frac{d u_{N-1}}{d t}(t)=\frac{1}{h^{2}} u_{N-2}-\frac{1}{h^{2}}\left(\frac{1+2 h}{1+h}\right) u_{N-1}-f\left(u_{N-1}\right)-\frac{1}{h(1+h)} g_{1}(t)+f_{1}\left(x_{N-1}, t\right), \\
u_{k}(0)=\widetilde{u}_{0}\left(x_{k}\right), \quad k=\overline{1, N-1} .
\end{array}\right.
$$

To solve the nonlinear differential (6.3) at the time $t$, we use the following linear recursive scheme generated by the nonlinear term $f\left(u_{k}\right)$ :

\frac{d u_{n}^{(n)}}{d t}(t)=\frac{-1}{h^{2}}\left(\frac{1+4 h}{1+2 h}\right) u_{1}^{(n)}+\frac{1}{h^{2}} u_{2}^{(n)}-f\left(u_{1}^{(n-1)}\right)-\frac{1}{h(1+2 h)} g_{0}(t)+f_{1}\left(x_{1}, t\right),  \tag{6.4}\\
\frac{d u_{k}^{(n)}}{d t}(t)=\frac{1}{h^{2}} u_{k-1}^{(n)}-\frac{2}{h^{2}} u_{k}^{(n)}+\frac{1}{h^{2}} u_{k+1}^{(n)}-f\left(u_{k}^{(n-1)}\right)+f_{1}\left(x_{k}, t\right), \quad k=\overline{2, N-2}, \\
\frac{d u_{N-1}^{(n)}}{d t}(t)=\frac{1}{h^{2}} u_{N-2}^{(n)}-\frac{1}{h^{2}}\left(\frac{1+2 h}{1+h}\right) u_{N-1}^{(n)}-f\left(u_{N-1}^{(n-1)}\right)-\frac{1}{h(1+h)} g_{1}(t)+f_{1}\left(x_{N-1}, t\right), \\
u_{k}^{(n)}(0)=\widetilde{u}_{0}\left(x_{k}\right), \quad k=\overline{1, N-1} .
\end{array}\right.
$$

The linear differential system (6.4) is solved by searching the associated eigenvalues and eigenfunctions. With a spatial step $h=\frac{1}{5}$ on the interval $[0,1]$ and for $t \in[0,3]$, we have drawn the corresponding approximate surface solution $(x, t) \longrightarrow u(x, t)$ in figure 1, obtained by successive re-initializations in $t$ with a time step $\Delta t=\frac{1}{50}$. For comparison in figure 2 , we have also drawn the exact surface solution $(x, t) \longrightarrow u(x, t)$.

Note that, the approximate solution $u(x, t)$ decreases exponentially to $u_{\infty}(x)$ as $t$ tends to infinity, $u_{\infty}$ being the unique solution of the corresponding steady state problem
