# BOUNDING THE SUPPORT OF A MEASURE FROM ITS MARGINAL MOMENTS

JEAN B. LASSERRE

ABSTRACT. Given all moments of the marginals of a measure  $\mu$  on  $\mathbb{R}^n$ , one provides (a) explicit bounds on its support and (b) a numerical scheme to compute the smallest box that contains the support of  $\mu$ .

## 1. INTRODUCTION

Inverse problems in probability are ubiquitous in several important applications, and among them shape reconstruction problems. For instance, exact recovery of two-dimensional objects from finitely many moments is possible for polygons and so-called quadrature domains as shown in Golub et al. [2] and Gustafsson et al. [6], respectively. But so far, there is no inversion algorithm from moments for  $n$ -dimensional shapes. However, more recently Cuyt et al. [4] have shown how to approximately recover numerically an unknown density  $f$  defined on a compact region of  $\mathbb{R}^n$ , from the only knowledge of its moments. So when  $f$  is the indicator function of a compact set  $A \subset \mathbb{R}^n$  one may thus recover the shape of  $A$  with good accuracy, based on moment information only. The elegant methodology developed in [4] is based on multi-dimensional homogeneous Padé approximants and uses a nice Padé *slice property*, the analogue for the moment approach of the Fourier slice theorem for the Radon transform (or projection) approach; see [4] for an illuminating discussion.

In this paper we are interested in the following inverse problem. Given an *arbitrary* finite Borel measure  $\mu$  on  $\mathbb{R}^n$  (not necessarily having a density with respect to the Lebesgue measure), can we compute (or at least approximate) the smallest box  $\prod_{i=1}^n [a_i, b_i] \subset \mathbb{R}^n$  which contains the support of  $\mu$  (not necessarily compact), from the only knowledge of its moments?

**Contribution.** Obviously, as we look for a box, the problem reduces to find for each  $i = 1, \dots, n$ , the smallest interval  $[a_i, b_i]$  (not necessarily compact) that contains the support of the marginal  $\mu_i$  of  $\mu$ . Of course, to bound  $a_i$  and  $b_i$ , one possibility is to compute zeros of the polynomials  $(p_d)$ ,  $d \in \mathbb{N}$ , orthogonal with respect to the measure  $\mu_i$ . Indeed, for every  $d$ , the smallest (resp. largest) zero of  $p_d$  provides an upper bound on  $a_i$  (resp. a lower bound on  $b_i$ ), and there is a systematic way to compute the  $p_d$ 's from the given moments of  $\mu$ ; see e.g. Gautschi [5, §1.2 and §2.1].

Our contribution is to provide a convergent numerical scheme for computing this smallest interval  $[a_i, b_i]$ , which (i) is based on the only knowledge of the moments of the marginals  $\mu_i$ ,  $i = 1, \dots, n$ , and (ii) *avoids* computing orthogonal polynomials.

For each  $i$ , it consists of solving 2 hierarchies (associated with each of the end points  $a_i$  and  $b_i$ ) of so called *semidefinite programs*<sup>1</sup> in only one variable (and therefore those semidefinite programs are generalized eigenvalue problems for which even more specialized softwares exist). Importantly, we do not make any assumption on  $\mu$  and in particular,  $\mu$  may not have a density with respect to the Lebesgue measure as in the above cited works. In solving the two semidefinite programs at step  $d$  of the hierarchy, one provides an inner approximation  $[a_d, b_d] \subset [a_i, b_i]$  such that the sequence  $(a_d)$  (resp.  $(b_d)$ ),  $d \in \mathbb{N}$ , is monotone nonincreasing (resp. nondecreasing) and converges to  $a_i$  (resp. to  $b_i$ ) as  $d \rightarrow \infty$  (with possibly  $a_i = -\infty$  and/or  $b_i = +\infty$ ). Interestingly, some explicit upper (resp. lower) bounds on  $a_i$  (resp.  $b_i$ ) in terms of the moments of  $\mu_i$  are also available.

## 2. NOTATION AND DEFINITIONS

Let  $\mathbb{N}$  be the set of natural numbers and denote by  $\mathbf{x} = (x_1, \dots, x_n)$  a vector of  $\mathbb{R}^n$  whereas  $x$  will denote a scalar. Let  $\mathbb{R}[x]$  be the ring of real univariate polynomials in the single variable  $x$ , and denote by  $\mathbb{R}[x]_d$  the vector space of polynomials of degree at most  $d$ . Let  $\Sigma[x] \subset \mathbb{R}[x]$  be the set of polynomials that are sums of squares (s.o.s.), and  $\Sigma[x]_d$  its subspace of s.o.s. polynomials of degree at most  $2d$ . In the canonical basis  $(x^k)$ ,  $k = 0, \dots, d$ , of  $\mathbb{R}[x]_d$ , a polynomial  $f \in \mathbb{R}[x]_d$  is written

$$x \mapsto f(x) = \sum_{k=0}^d f_k x^k,$$

for some vector  $\mathbf{f} = (f_k) \in \mathbb{R}^{d+1}$ .

**Moment matrix.** Given a infinite sequence  $\mathbf{y} := (y_k)$ ,  $k \in \mathbb{N}$ , indexed in the canonical basis  $(x^k)$  of  $\mathbb{R}[x]$ , let  $\mathbf{H}_d(\mathbf{y}) \in \mathbb{R}^{(d+1) \times (d+1)}$  be the real Hankel matrix defined by:

$$(2.1) \quad \mathbf{H}_d(\mathbf{y})(i, j) = y_{i+j-2}, \quad \forall i, j \leq d.$$

The matrix  $\mathbf{H}_d(\mathbf{y})$  is called the *moment* matrix associated with the sequence  $\mathbf{y}$  (see e.g. Curto and Fialkow [3] and Lasserre [7]). If  $\mathbf{y}$  has a *representing measure*  $\mu$  (i.e., if there exists a finite Borel measure  $\mu$  such that  $y_k = \int \mathbf{x}^k d\mu$  for every  $k \in \mathbb{N}$ ) then

$$(2.2) \quad \langle \mathbf{f}, \mathbf{H}_d(\mathbf{y})\mathbf{f} \rangle = \int f(x)^2 d\mu(x) \geq 0, \quad \forall f \in \mathbb{R}[x]_d,$$

so that  $\mathbf{H}_d(\mathbf{y}) \succeq 0$ , where for a real symmetric matrix  $\mathbf{A}$ , the notation  $\mathbf{A} \succeq 0$  (resp.  $\mathbf{A} \succ 0$ ) stands for  $\mathbf{A}$  is positive semidefinite (resp. positive definite).

**Localizing matrix.** Similarly, given  $\theta \in \mathbb{R}[x]_s$  with vector of coefficients  $(\theta_k)$ , let  $\mathbf{H}_d(\theta \mathbf{y}) \in \mathbb{R}^{(d+1) \times (d+1)}$  be the real symmetric matrix defined by:

$$(2.3) \quad \mathbf{H}_d(\theta \mathbf{y})(i, j) := \sum_{k=0}^s \theta_k y_{i+j+k-2}, \quad \forall i, j \leq d.$$

The matrix  $\mathbf{H}_d(\theta \mathbf{y})$  is called the *localizing* matrix associated with the sequence  $\mathbf{y}$  and the polynomial  $\theta$  (see again Lasserre [7]). Notice that the localizing matrix with respect to the constant polynomial  $\theta \equiv 1$  is the moment matrix  $\mathbf{H}_d(\mathbf{y})$  in

(2.1). If  $\mathbf{y}$  has a representing measure  $\mu$  with support contained in the level set  $\{x \in \mathbb{R} : \theta(x) \geq 0\}$ , then

$$(2.4) \quad \langle \mathbf{f}, \mathbf{H}_d(\theta \mathbf{y}) \mathbf{f} \rangle = \int f(x)^2 \theta(x) d\mu(x) \geq 0 \quad \forall f \in \mathbb{R}[x]_d,$$

so that  $\mathbf{H}_d(\theta \mathbf{y}) \succeq 0$ .

Finally, for a finite Borel measure  $\mu$ , denote its support by  $\text{supp } \mu$ , that is,  $\text{supp } \mu$  is the smallest closed set  $B$  such that  $\mu(B^c) = 0$  (where  $B^c$  denotes the complement of  $B$ ).

### 3. MAIN RESULT

We may and will restrict to the one-dimensional case because if  $\mu$  is a finite Borel measure on  $\mathbb{R}^n$ , and if we look for a box  $\mathbf{B} := \prod_{i=1}^n [a_i, b_i]$  such that  $\text{supp } \mu \subseteq \mathbf{B}$ , then we have the following result. For every  $i = 1, \dots, n$ , let  $\mu_i$  be the marginal of  $\mu$  with respect to the variable  $x_i$ .

**Lemma 3.1.** *Let  $\mathbf{B} \subset \mathbb{R}^n$  be the box  $\prod_{i=1}^n [a_i, b_i]$  with possibly  $a_i = -\infty$  and/or  $b_i = +\infty$ . Then  $\text{supp } \mu \subseteq \mathbf{B}$  if and only if  $\text{supp } \mu_i \subseteq [a_i, b_i]$  for every  $i = 1, \dots, n$ .*

*Proof.* For every  $i = 1, \dots, n$ , let  $A_i \subset \mathbb{R}^n$  be the Borel set  $\{\mathbf{x} \in \mathbb{R}^n : x_i \in \mathbb{R} \setminus [a_i, b_i]\}$ . Then  $0 = \mu(A_i) = \mu_i(\mathbb{R} \setminus [a_i, b_i])$ , shows that  $\text{supp } \mu_i \subseteq [a_i, b_i]$ ,  $i = 1, \dots, n$ . Conversely, if  $\mu_i \subseteq [a_i, b_i]$ ,  $i = 1, \dots, n$ , then  $0 = \mu_i(\mathbb{R} \setminus [a_i, b_i]) = \mu(A_i)$ ,  $i = 1, \dots, n$ . But since  $\mathbf{B}^c = \cup_{i=1}^n A_i$  we also obtain  $\mu(\mathbf{B}^c) = 0$ .  $\square$

So Lemma 3.1 tells us that it is enough to consider separate conditions for the marginals  $\mu_i$ ,  $i = 1, \dots, n$ . Therefore, all we need to know is the sequence of moments

$$\mathbf{y}_k^i := \int x_i^k d\mu(\mathbf{x}) = \int x_i^k d\mu_i(x), \quad k = 0, 1, \dots$$

of the marginal  $\mu_i$  of  $\mu$ , for every  $i = 1, \dots, n$ .

Hence we now consider the one-dimensional case. For a real number  $a$ , let  $\theta_a \in \mathbb{R}[x]$  be the polynomial  $x \mapsto \theta_a(x) = (x - a)$ . Recall that the support of a finite Borel measure  $\mu$  on  $\mathbb{R}$  (denoted  $\text{supp } \mu$ ) is the smallest closed set  $B$  such that  $\mu(\mathbb{R} \setminus B) = 0$ . For instance if  $\mu$  is supported on  $(a, b] \cup [c, d] \cup \{e\}$ , with  $a < b < c < d < e$  then  $\text{supp } \mu$  is the closed set  $[a, b] \cup [c, d] \cup \{e\}$  and is contained in the interval  $[a, e]$ .

**3.1. Bounds on  $\text{supp } \mu$ .** We first derive bounds on scalars  $a$  and  $b$  that satisfy  $\text{supp } \mu \subseteq (-\infty, a]$  and/or  $\text{supp } \mu \subseteq [b, +\infty)$ .

**Proposition 3.2.** *Let  $\mu$  be a finite and non trivial Borel measure on the real line  $\mathbb{R}$ , with associated sequence of moments  $\mathbf{y} = (y_k)$ ,  $k \in \mathbb{N}$ , all finite. Then:*

(i)  $\text{supp } \mu \subseteq [a, +\infty)$  if and only if

$$(3.1) \quad \mathbf{H}_d(\theta_a \mathbf{y}) \succeq 0, \quad \forall d \in \mathbb{N}.$$

(ii)  $\text{supp } \mu \subseteq (-\infty, b]$  if and only if

$$(3.2) \quad \mathbf{H}_d(-\theta_b \mathbf{y}) \succeq 0, \quad \forall d \in \mathbb{N}.$$

For each fixed  $d \in \mathbb{N}$ , the condition  $\mathbf{H}_d(\theta_a \mathbf{y}) \succeq 0$  (resp.  $\mathbf{H}_d(-\theta_b \mathbf{y}) \succeq 0$ ) determines a basic semi-algebraic set of the form  $\{(a, \mathbf{y}) : p_{dk}(a, \mathbf{y}) \geq 0, k = 0, \dots, d-1\}$

(resp.  $\{(a, \mathbf{y}) : (-1)^{d-k} p_{dk}(b, \mathbf{y}) \geq 0, k = 0, \dots, d-1\}$ ) for some polynomials  $(p_{dk}) \subset \mathbb{R}[x, \mathbf{y}]$ .

With  $\mathbf{y}$  and  $d$  fixed, the condition (3.1) (resp. (3.2)) yields an upper bound  $a \leq \underline{a}_d$  (resp. a lower bound  $b \geq \bar{b}_d$ ), and the sequence  $(\underline{a}_d)$  (resp.  $(\bar{b}_d)$ ),  $d \in \mathbb{N}$ , is monotone nonincreasing (resp. nondecreasing). In particular,

$$(3.3) \quad a \leq \min \left[ \frac{y_1}{y_0}, \frac{y_1 + y_3}{y_0 + y_2} \right] \quad \text{and} \quad a \leq \min \left[ \frac{y_1}{y_0}, \frac{y_3}{y_2}, \frac{y_1 + y_3}{y_0 + y_2} \right] \quad \text{if } y_2 \neq 0$$

$$(3.4) \quad b \geq \max \left[ \frac{y_1}{y_0}, \frac{y_1 + y_3}{y_0 + y_2} \right] \quad \text{and} \quad b \geq \max \left[ \frac{y_1}{y_0}, \frac{y_3}{y_2}, \frac{y_1 + y_3}{y_0 + y_2} \right] \quad \text{if } y_2 \neq 0,$$

as well as

$$(3.5) \quad a \leq \frac{y_0 y_3 - y_1 y_2 - \sqrt{(y_0 y_3 - y_1 y_2)^2 - 4(y_0 y_2 - y_1^2)(y_1 y_3 - y_2^2)}}{2(y_0 y_2 - y_1^2)}$$

$$(3.6) \quad b \geq \frac{y_0 y_3 - y_1 y_2 + \sqrt{(y_0 y_3 - y_1 y_2)^2 - 4(y_0 y_2 - y_1^2)(y_1 y_3 - y_2^2)}}{2(y_0 y_2 - y_1^2)}$$

if  $(y_0 y_3 - y_1 y_2)^2 \geq 4(y_0 y_2 - y_1^2)(y_1 y_3 - y_2^2)$ .

*Proof.* (3.1) and (3.2) is well-known and can be found in e.g. Lasserre [7, Theorem 3.2]. Next, write the characteristic polynomial  $t \mapsto c(t)$  of  $\mathbf{H}_d(\theta_a, \mathbf{y})$  in the form

$$c(t) (= \det(tI - \mathbf{H}_d(\theta_a, \mathbf{y}))) = t^d + \sum_{k=0}^{d-1} (-1)^{d-k} p_{dk}(a, \mathbf{y}) t^k, \quad t \in \mathbb{R},$$

for some polynomials  $(p_{dk}) \subset \mathbb{R}[a, \mathbf{y}]$ , and where  $p_{dk}$  is of degree  $k$  in the variable  $a$ . Then  $\mathbf{H}_d(a, \mathbf{y}) \succeq 0$ , if and only if  $c$  has all its roots nonnegative, which in turn, by Descartes's rule, happens if and only if  $p_{dk}(a, \mathbf{y}) \geq 0$ , for every  $k = 0, \dots, d-1$ . In fact  $(a, \mathbf{y})$  belong to the closure of a convex connected component of  $\{(a, \mathbf{y}) : p_{d0}(a, \mathbf{y}) (= \det H_d(\theta_a, \mathbf{y})) > 0\}$ . A similar argument applies for (3.2) with now the characteristic polynomial

$$\tilde{c}(t) = \det(tI - \mathbf{H}_d(-\theta_b, \mathbf{y})) = (-1)^d c(-t) = t^d + \sum_{k=0}^{d-1} p_{dk}(b, \mathbf{y}) t^k, \quad t \in \mathbb{R}.$$

So with  $\mathbf{y}$  and  $d$  fixed,  $a \mapsto p_{dk}(a, \mathbf{y})$  is a univariate polynomial for every  $k$ , and so the conditions (3.1) provide a bound of the form  $a \leq \underline{a}_d$  for some  $\underline{a}_d$  since if  $a$  satisfies (3.1) then so does  $a' \leq a$ . Similarly, the conditions (3.2) provide a bound of the form  $b \geq \bar{b}_d$  since if  $b$  satisfies (3.2) then so does  $b' \geq b$ . The scalar  $\underline{a}_d$  (resp.  $\bar{b}_d$ ) may be taken as the smallest (resp. largest) root of the polynomial  $x \mapsto p_{d0}(x, \mathbf{y})$ ; bounds in terms of the coefficients of  $p_{d0}(x, \mathbf{y})$  are available in the literature.

Finally (3.3)-(3.6) are obtained with  $d = 1$  in which case (3.1) and (3.2) read:

$$\begin{bmatrix} y_1 - ay_0 & y_2 - ay_1 \\ y_2 - ay_1 & y_3 - ay_2 \end{bmatrix} \succeq 0; \quad \begin{bmatrix} by_0 - y_1 & by_1 - y_2 \\ by_1 - y_2 & by_2 - y_3 \end{bmatrix} \succeq 0.$$

□

### 3.2. Computing the smallest interval $[a, b] \supseteq \text{supp } \mu$ .

Theorem 3.2 provides bounds (some of them explicit) in terms of bounds on the largest (or smallest) root of some univariate polynomial whose coefficients are polynomials in  $\mathbf{y}$ . But one may also get numerical sharp bounds via solving the following sequence of semidefinite programs, indexed by  $d$ :

$$(3.7) \quad a_d = \max_a \{ a : \mathbf{H}_d(\theta_a \mathbf{y}) \succeq 0 \}$$

$$(3.8) \quad b_d = \min_b \{ b : \mathbf{H}_d(\theta_b \mathbf{y}) \succeq 0 \},$$

where  $\mathbf{H}_d(\theta_* \mathbf{y})$  is the localizing matrix associated with the polynomial  $\theta_* \in \mathbb{R}[x]$ . Observe that (3.7) and (3.8) are semidefinite programs with only one variable! For instance for  $d = 1$ , (3.7) reads

$$a_1 = \max_a \left\{ a : \begin{bmatrix} y_1 - ay_0 & y_2 - ay_1 \\ y_2 - ay_1 & y_3 - ay_2 \end{bmatrix} \succeq 0 \right\},$$

whereas (3.8) reads

$$b_1 = \min_b \left\{ b : \begin{bmatrix} by_0 - y_1 & by_1 - y_2 \\ by_1 - y_2 & by_2 - y_3 \end{bmatrix} \succeq 0 \right\}$$

For more details on semidefinite programming the interested reader is referred to e.g. [9]. And we obtain:

**Theorem 3.3.** *Let  $\mu$  be a finite Borel measure with all moments  $\mathbf{y} = (y_k)$  finite. Then  $\text{supp } \mu \subseteq [a^*, b^*]$ , with possibly  $a^* = -\infty$  and/or  $b^* = +\infty$ , and where:*

(i)  $a_d$  is an optimal solution of (3.7) for all  $d \in \mathbb{N}$ , and the sequence  $(a_d)$ ,  $d \in \mathbb{N}$ , is monotone nonincreasing with  $a_d \downarrow a^*$  as  $d \rightarrow \infty$ .

(ii)  $b_d$  is an optimal solution of (3.8) for all  $d \in \mathbb{N}$ , and the sequence  $(b_d)$ ,  $d \in \mathbb{N}$ , is monotone nondecreasing with  $b_d \uparrow a^*$  as  $d \rightarrow \infty$ .

(iii)  $a^*$  (resp.  $b^*$ ) is the largest (resp. smallest) scalar such that  $\text{supp } \mu \subseteq [a^*, b^*]$ .

*Proof.* We prove the statements for (i) and (iii) only because similar arguments hold for (ii). We first prove that (3.7) has always a feasible solution. If  $\text{supp } \mu \subset [a, +\infty)$  for some  $a > -\infty$ , then  $a$  is obviously feasible for the semidefinite program (3.7), for every  $d \in \mathbb{N}$ . If there is no such  $a$ , consider the finite sequence of moments  $\mathbf{y}_d = (y_0, \dots, y_{2d+1})$ . By Tchakaloff's theorem (see e.g. [1, 8], [7, Theorem B.12]) there exists a measure  $\nu$  supported on finitely many points  $x_0 \leq x_1 \leq \dots \leq x_t$ , with  $t \leq 2d + 2$  (hence  $\text{supp } \nu = \cup_{i=0}^t \{x_i\} \subset [x_0, +\infty)$ ), and with same moments as  $\mu$ , up to degree  $2d + 1$ . Hence in view of what precedes,  $x_0$  is feasible for (3.7). Next, as every feasible solution is bounded above by  $y_1/y_0$  and as we maximize, it follows that (3.7) has an optimal solution  $a_d$  for every  $d \in \mathbb{N}$ .

Next, observe that  $a_d \leq a_k$  whenever  $d \geq k$  because the feasible set of (3.7) for  $d$  is contained in that for  $k$  and every feasible solution is bounded above by  $y_1/y_0$ . Therefore the sequence  $(a_d)$ ,  $d \in \mathbb{N}$ , is monotone nonincreasing and thus, converges to  $a^*$  with possibly  $a^* = -\infty$ .

If  $a^* = -\infty$  then there is no  $a$  such that  $\text{supp } \mu \subseteq [a, +\infty)$  because we would have  $a_d \geq a$  for all  $d$ . Next, consider the case  $a^* > -\infty$ , and let  $d \in \mathbb{N}$  be fixed. Using  $\mathbf{H}_d(\theta_{a_d} \mathbf{y}) \succeq 0$  and the continuity of  $a \mapsto \mathbf{H}_d(\theta_a \mathbf{y})$ , one obtains  $\mathbf{H}_d(\theta_{a^*} \mathbf{y}) \succeq 0$ . As  $d$  fixed was arbitrary, we then obtain  $\mathbf{H}_d(\theta_{a^*} \mathbf{y}) \succeq 0$  for every  $d \in \mathbb{N}$ . But then by [7, Theorem 3.2],  $\mu$  is supported on the set  $\{x : \theta_{a^*}(x) \geq 0\}$ , which shows that  $\text{supp } \mu \subseteq [a^*, +\infty)$ .

Concerning (iii), if  $a^* > -\infty$  then  $a^*$  is the largest  $a$  such that  $\text{supp } \mu \subseteq [a, +\infty)$  because if  $\text{supp } \mu \subseteq [a, +\infty)$  then  $a$  is feasible for (3.7), for every  $d \in \mathbb{N}$ ; therefore,  $a \leq a_d$  for every  $d$ , which in turn implies  $a \leq a^*$ .  $\square$

Next, in the case where  $\mu$  is known to have compact support one may even consider the following single hierarchy of semidefinite programs

$$(3.9) \quad \rho_d = \min_{b,a} \{ b - a : \mathbf{H}_d(\theta_a \mathbf{y}), \mathbf{H}_d(-\theta_b \mathbf{y}) \succeq 0 \},$$

indexed by  $d$ , and with now two variables  $a$  and  $b$ . We obtain the following result of which the proof is omitted.

**Corollary 3.4.** *Assume that  $\mu$  has compact support. Then:*

(a) *The semidefinite program (3.9) has an optimal solution  $(a_d, b_d)$  for every  $d \in \mathbb{N}$ .*

(b) *Let  $(a_d, b_d)$ ,  $d \in \mathbb{N}$ , be a sequence of optimal solutions of (3.9). As  $d \rightarrow \infty$ ,  $(a_d, b_d) \rightarrow (a^*, b^*)$  and  $\text{supp } \mu \subseteq [a^*, b^*]$ . Moreover,  $[a^*, b^*]$  is the smallest interval which contains  $\text{supp } \mu$  and if the support of  $\mu$  is an interval then  $\text{supp } \mu = [a^*, b^*]$ .*

**3.3. Duality.** We interpret the dual of the semidefinite program (3.7). Let  $\mathcal{S}_d \subset \mathbb{R}^{(d+1) \times (d+1)}$  be the cone of real symmetric matrices. The dual of (3.7) is the semidefinite program:

$$(3.10) \quad \begin{aligned} a_d^* &= \min_{\mathbf{Z} \in \mathcal{S}_d} \langle \mathbf{H}_d(x \mathbf{y}), \mathbf{Z} \rangle \\ &\text{s.t. } \langle \mathbf{H}_d(\mathbf{y}), \mathbf{Z} \rangle = 1; \mathbf{Z} \succeq 0. \end{aligned}$$

If  $\mathbf{Z} \succeq 0$  is feasible, using the singular value decomposition of  $\mathbf{Z}$  one may write  $\mathbf{Z} = \sum_i \mathbf{f}_i \mathbf{f}_i^T$  for some vectors  $(\mathbf{f}_i) \subset \mathbb{R}^{d+1}$ , and so

$$1 = \langle \mathbf{H}_d(\mathbf{y}), \mathbf{Z} \rangle = \sum_i \langle \mathbf{f}_i, \mathbf{H}_d(\mathbf{y}) \mathbf{f}_i \rangle = \sum_i \int f_i^2 d\mu = \int \sigma d\mu,$$

with  $\sigma = \sum_i f_i^2 \in \Sigma[x]_d$ , and similarly

$$\langle \mathbf{H}_d(x \mathbf{y}), \mathbf{Z} \rangle = \sum_i \langle \mathbf{f}_i, \mathbf{H}_d(x \mathbf{y}) \mathbf{f}_i \rangle = \sum_i \int x f_i(x)^2 d\mu(x) = \int x \sigma(x) d\mu(x).$$

Therefore, equivalently, (3.10) reads

$$(3.11) \quad a_d^* = \min_{\sigma \in \Sigma[x]_d} \left\{ \int x \underbrace{\sigma(x) d\mu(x)}_{d\nu(x)} : \int \underbrace{\sigma d\mu}_{d\nu} = 1 \right\},$$

and  $a_d^* \geq a_d$  (which is called *weak duality*). Indeed, for any two feasible solutions  $a, \mathbf{Z}$  of (3.9) and (3.10) respectively, using  $\mathbf{Z} \succeq 0$  and  $\mathbf{H}_d(\theta_a \mathbf{y}) \succeq 0$ , yields

$$0 \leq \langle \mathbf{Z}, \mathbf{H}_d(\theta_a \mathbf{y}) \rangle = \int (x - a) \sigma(x) d\mu(x) = \int x \sigma(x) d\mu(x) - a,$$

that is,  $a \leq \int x \sigma(x) d\mu(x)$ . So in the dual semidefinite program (3.11), one searches for a sum of squares polynomial  $\sigma \in \Sigma[x]_d$  of degree at most  $2d$  (normalized to satisfy  $\int \sigma d\mu = 1$ ), which minimizes  $\int x \sigma d\mu$ . Equivalently, one searches for a probability measure  $\nu$  with density  $\sigma \in \Sigma[x]_d$  with respect to  $\mu$ , which minimizes the upper bound  $\int x d\nu$  on the global minimum of  $x$  on the support of  $\mu$ .

Similarly, the dual of (3.8) is the semidefinite program:

$$(3.12) \quad b_d^* = \max_{\sigma \in \Sigma[x]_d} \left\{ \int x \underbrace{\sigma(x) d\mu(x)}_{d\nu(x)} : \int \underbrace{\sigma}_{d\nu} d\mu = 1. \right\}.$$

Again, by weak duality,  $b_d^* \leq b_d$  and in (3.12) one searches for a probability measure  $\nu$  with density  $\sigma \in \Sigma[x]_d$  with respect to  $\mu$ , which maximizes the lower bound  $\int x d\nu$  on the global maximum of  $x$  on the support of  $\mu$ .

**Theorem 3.5.** *Suppose that  $\mu$  is such that  $\mathbf{H}_d(\mathbf{y}) \succ 0$  for all  $d$  (for instance if  $\mu$  has no atom). Then there is no duality gap between (3.7) and (3.11) (resp. (3.8) and (3.12)), i.e.  $a_d = a_d^*$  (resp.  $b_d = b_d^*$ ). In addition (3.11) (resp. (3.12)) has an optimal solution  $\sigma^* \in \Sigma[x]_d$  (resp.  $\psi^* \in \Sigma[x]_d$ ), and*

$$(3.13) \quad \int (x - a_d) \sigma^*(x) d\mu(x) = 0 = \int (b_d - x) \psi^*(x) d\mu(x).$$

*Proof.* From Theorem 3.3, we know that (3.7) has an optimal solution  $a_d$ . By Tchakaloff's theorem, let  $\nu$  be the measure supported on the finitely many points  $x_0, \dots, x_t$  (with  $t \leq 2d + 2$ ), and with same moments as  $\mu$ , up to degree  $2d + 1$ . There are positive weights  $\lambda_k$ ,  $k = 1, \dots, t$ , such that

$$\int p d\mu = \int p d\nu = \sum_{k=0}^t \lambda_k p(x_k) \quad \forall p \in \mathbb{R}[x]_{2d+1}$$

(see e.g. [1, 8]). Hence  $\mathbf{H}_d(\theta_a \mathbf{y}) \succ 0$  for every  $a < x_0$ , because for every  $\mathbf{f} (\neq 0) \in \mathbb{R}^{d+1}$  (hence every  $f (\neq 0) \in \mathbb{R}[x]_d$ ),  $\langle \mathbf{f}, \mathbf{M}_d(\mathbf{y}) \mathbf{f} \rangle = \sum_k \lambda_k f(x_k)^2 > 0$ , and so

$$\begin{aligned} \langle \mathbf{f}, \mathbf{H}_d(\theta_a \mathbf{y}) \mathbf{f} \rangle &= \int f(x)^2 (x - a) d\mu(x) \\ &= \int f(x)^2 (x - a) d\nu(x) = \sum_{k=0}^t f(x_k)^2 (x_k - a) \lambda_k > 0. \end{aligned}$$

Hence every  $a < x_0$  is strictly feasible for (3.7), that is, Slater's condition<sup>2</sup> holds. But this implies that there is no duality gap, i.e.,  $a_d = a_d^*$ , and in addition, the dual (3.11) has an optimal solution  $\sigma^*$ ; see e.g. [9]. For same reasons,  $b_d = b_d^*$  and (3.12) has an optimal solution. Therefore,

$$0 = \int x \sigma^*(x) d\mu(x) - a_d^* = \int (x - a_d^*) \sigma^*(x) d\mu(x) = \int (x - a_d) \sigma^*(x) d\mu(x),$$

and similarly,

$$0 = b_d^* - \int x \psi^*(x) d\mu(x) = \int (b_d^* - x) \psi^*(x) d\mu(x) = \int (b_d - x) \psi^*(x) d\mu(x),$$

which is the desired result (3.13).  $\square$

In Theorem 3.5, write  $\sigma^* \in \Sigma[x]_d$  as  $\sigma^* = \sum_{\ell} p_{\ell}^2$  for some polynomials  $(p_{\ell}) \subset \mathbb{R}[x]_d$ , with respective coefficient vectors  $\mathbf{p}_{\ell} \in \mathbb{R}^{d+1}$ . Then by (3.13)

$$\int \sigma^*(x) (x - a_d) d\mu(x) = \sum_{\ell} \int p_{\ell}(x)^2 (x - a_d) d\mu(x) = \sum_{\ell} \langle \mathbf{p}_{\ell}, \mathbf{H}_d(\theta_{a_d} \mathbf{y}) \mathbf{p}_{\ell} \rangle = 0,$$

<sup>2</sup>For a convex optimization problem  $\min_{\mathbf{x}} \{ f(\mathbf{x}) : g_j(\mathbf{x}) \geq 0, j = 1, \dots, m \}$ , Slater's condition states that there exists  $\mathbf{x}_0$  such that  $g_j(\mathbf{x}_0) > 0$  for every  $j = 1, \dots, m$ .

so that for every  $\ell$ ,  $\langle \mathbf{p}_\ell, \mathbf{H}_d(\theta_{a_d} \mathbf{y}) \mathbf{p}_\ell \rangle = 0$  (since  $\mathbf{H}_d(\theta_{a_d} \mathbf{y}) \succeq 0$ ), that is, every  $\mathbf{p}_\ell$  is in the kernel of  $\mathbf{H}_d(\theta_{a_d} \mathbf{y})$ .
