### 25 Abstract

26

27 Actinobacillus pleuropneumoniae is a facultative anaerobic pathogen of the 28 porcine respiratory tract requiring anaerobic metabolic activity for persistence on lung 29 epithelium. The ArcAB two-component system facilitating metabolic adaptation to 30 anaerobicity was investigated with regard to its impact on virulence and colonization 31 of the porcine respiratory tract. Using pig infection experiments we demonstrate that 32 deletion of arcA renders A. pleuropneumoniae significantly attenuated in acute 33 infection and reduced long term survival on unaltered lung epithelium as well as in 34 sequesters. Contrary to its role in enterobacteria, the deletion of arcA in A. 35 pleuropneumoniae does not effect growth and survival under anaerobic conditions. 36 Instead, other than the parent strain A. pleuropneumoniae  $\Delta arcA$  does not show 37 autoaggregation under anaerobic conditions and is deficient in biofilm formation. It is hypothesised that the lack of these functions is, at least in part, responsible for the 38 39 reduction of virulence.

### 40 **1. Introduction**

41

42 Actinobacillus (A.) pleuropneumoniae is the causative agent of a porcine 43 pleuropneumonia causing high economic losses worldwide (Fenwick and Henry, 44 1994). After inhalation of A. pleuropneumoniae containing aerosols the pathogen 45 colonizes the respiratory epithelium of its host and persists on tonsils, on healthy lung 46 epithelium, and in sequestered lesions (Sidibe et al., 1993). Our previous studies 47 implied that the ability to adapt to anaerobic conditions is crucial for the development 48 of persistent infections; thus, the deletion of hlyX, the homologue to the global 49 regulator for anaerobic metabolism FNR in *E. coli* (Shaw and Guest, 1982), caused a 50 clear attenuation of *A. pleuropneumoniae* (Baltes et al., 2005).

51 The ArcAB two-component system, like FNR, is a global regulatory 52 mechanism facilitating the adaptation to a changing redox potential and anaerobic 53 conditions in enterobacteria (luchi and Lin, 1988). The ArcAB system is composed of 54 the transmembrane sensor kinase ArcB and the cytosolic response regulator ArcA 55 (luchi and Lin, 1995, Lynch and Lin, 1996). Salmonella arcA mutants have been 56 shown to grow more slowly than the wild-type strain in both aerobic and microaerobic 57 conditions (Sevcik et al., 2001), and E. coli arcA mutants are unable to survive 58 prolonged starvation (Nystrom et al., 1996). For Haemophilus influenzae deletion of 59 arcA is accompanied with attenuation in septic infection (Souza-Hart et al., 2003), 60 and in the intestinal pathogen Vibrio cholerae ArcA was found to modulate the 61 expression of virulence factors (Sengupta et al., 2003).

The role of ArcA in an extracellular respiratory tract pathogen has not been investigated to date. Therefore, we constructed an isogenic *A. pleuropneumoniae arcA* deletion mutant, investigated its growth under aerobic and anaerobic conditions and determined its virulence in a pig aerosol infection model.

## 66 **2. Materials and methods**

- 68 2.1. Bacterial strains, plasmids, and primers
- 69
- 70 Bacterial strains, plasmids, and primers used in this work are listed in Table 1.

- 72 2.2. Media and growth conditions
- 73

74 E. coli strains were cultured in Luria-Bertani medium supplemented with the 75 appropriate antibiotics (ampicillin, 100 µg/ml; chloramphenicol, 25 µg/ml) at 37°C; for 76 cultivation of *E. coli* β2155 (Δ*dapA*), diaminopimelic acid (1 mM; Sigma Chemical 77 Company, Deisenhofen, Germany) was added. A. pleuropneumoniae parent and 78 mutant strain were cultured at 37°C and 5% CO<sub>2</sub> in PPLO medium or on PPLO agar 79 (Difco GmbH, Augsburg, Germany) supplemented with NAD (10 µg/ml; Merck AG, 80 Darmstadt, Germany), L-cysteine hydrochloride (260 µg/ml; Sigma), L-cystine 81 dihydrochloride (10 µg/ml; Sigma), and dextrose (1 mg/ml). The aerobic culture grown for experimental aerosol infection in addition contained Tween<sup>®</sup>80 (0.1%). For 82 83 selection of A. pleuropneumoniae transconjugants (single crossing-overs) 84 chloramphenicol (5 µg/ml) was added, and the medium for counter selection was 85 prepared as described previously (Tonpitak et al., 2002). For cultivation of the 86 complemented mutant kanamycin (25 µg/ml) was added.

For anaerobic growth supplemented medium was preincubated in an anaerobic chamber (DonWhitley Scientific, Shipley, England) in an atmosphere containing 5% CO<sub>2</sub>, 10% H<sub>2</sub>, and 85% N<sub>2</sub> at 37°C and then inoculated with 1% of log phase aerobic culture with an optical density at 600 nm (OD<sub>600</sub>) of 0.3. Anaerobicity of the medium was confirmed using a dissolved oxygen sensor (CellOx<sup>®</sup> 325; WTW,

Weilheim, Germany) linked to an inoLab<sup>®</sup> instrument (WTW, Weilheim, Germany).
For recording of growth curves bacteria were harvested at 2, 4, 6, 8, 10 and 24 h
post inoculation by centrifugation. As *A. pleuropneumoniae* showed heavy clumping
upon growth under anaerobic conditions the protein content of whole-cell lysates was
determined. Statistical analyses were performed using the Student's t-test.

- 98 2.3. Preparation of whole-cell lysates
- 99

Cells were harvested by centrifugation (13,000 x g, 10 min, 4°C), washed once with a buffer containing 10 mM Tris-HCI (pH 8.0) and 5 mM magnesium acetate. Pellets were resuspended in 50 mM Tris-HCI (pH 7.3) and stored at  $-70^{\circ}$ C overnight. Cells were thawed, ruptured using the FastPrep<sup>®</sup> Instrument (Qbiogene, Heidelberg, Germany) three times for 40 sec at intensity setting 5.0, and cell debris was removed by centrifugation (15,000 x g, 30 min). Protein concentration was determined with the MicroBC<sup>®</sup> assay (Uptima Interchim, Montlucon Cedex, France).

108 2.4. Manipulation of DNA

109

110 DNA modifying enzymes were purchased from New England Biolabs (Bad 111 Schwalbach, Germany) and used according to the manufacturer's instructions. Tag 112 polymerase was purchased from Gibco-BR Life Technologies (Karlsruhe, Germany). 113 Chromosomal and plasmid DNA preparations, PCR, Southern blottina. 114 transformation, and gel electrophoresis were done by standard procedures 115 (Sambrook et al., 1989), and pulsed field gel electrophoresis (PFGE) was performed 116 as described previously (Oswald et al., 1999a).

- 118 2.5. Construction of an isogenic A. pleuropneumoniae arcA in-frame mutant
- 119

120 The upstream and downstream parts of the *arcA* gene and flanking sequence 121 were amplified from genomic A. pleuropneumoniae AP76 DNA using primers oArcA1 122 and oArcA2 or oArcA3 and oArcA4 and cloned into pCR2.1 TOPO, resulting in 123 pARC810 and pARC800, respectively (Table 1). The downstream fragment was 124 removed from pARC800 using HindIII and BsmBI and cloned into plasmid pARC810 125 to obtain pARC820 harbouring the truncated arcA sequence. Plasmid pARC820 was 126 restricted with Notl and PspOMI, and the 1264-bp fragment was ligated into the 127 conjugation vector pEMOC2 resulting in plasmid pARC700. Plasmid pARC700 was 128 used in the single step transconjugation system (Oswald et al., 1999b) to construct A. 129 *pleuropneumoniae*  $\Delta arcA$ . Colonies with the correct PCR profile were confirmed by 130 Southern blot analysis (Sambrook et al., 1989) using the PCR product obtained with 131 primers oArcA5 and oArcA6 from A. pleuropneumoniae  $\Delta arcA$  as a probe, and by 132 nucleotide sequence analysis (Seqlab, Göttingen, Germany). The absence of 133 genomic rearrangements was confirmed by PFGE.

- 135 2.6. Complementation of A. pleuropneumoniae *A*arcA
- 136

A 1236 bp fragment was obtained by PCR using *A. pleuropneumoniae* AP76 genomic DNA and primers oArcA1 and oArcA8 (Table 1). This PCR product harbours 505 bp of *arcA* upstream sequence likely including regulatory sequences crucial for *arcA* expression. The PCR products was cloned into pCR2.1 TOPO, restricted with EcoRI and ligated into EcoRI restricted plasmid pLS88 yielding pARC1340, containing the *arcA* gene in a 5'-3' orientation with respect to the vector-derived *sulll* promotor. The plasmid was electroporated into *A. pleuropneumoniae*  $\Delta arcA$ .

### 144 2.7. Virulence studies

145

146 Virulence of *A. pleuropneumoniae* ∆*arcA* compared to the parental strain was 147 assessed in an aerosol infection model as previously described (Maas et al., 2006). 148 A. pleuropneumoniae-free pigs (no clinical symptoms and no serological responses 149 in the ApxII-ELISA ([Leiner et al., 1999]), 8 to 9 weeks of age, were randomly 150 assigned to the different groups (8 pigs per group) and cared for in accordance with 151 the principles outlined by the European Convention for the Protection of Vertebrate 152 Animals Used for Experimental and Other Scientific Purposes (European Treaty 153 Series, no. 123 [http://conventions.coe.int/treaty/EN/V3menutraites.asp; permit no. 154 05/919]). Clinical examinations were performed daily or as needed. Body 155 temperature and clinical symptoms were recorded as described before (Maas et al., 156 2006). Statistical analysis of the total clinical score was performed using the 157 Wilcoxon Signed-Rank Test. Pigs were euthanized by intravenous injection of 158 pentobarbital. Post mortem analysis and determination of reisolation score were 159 performed as described previously (Maas et al., 2006).

### 161 2.8. Autoaggregation, electron microskopy and biofilm assays

162

A. *pleuropneumoniae* was grown in supplemented liquid medium under anaerobic conditions for six hours. Then cultures were removed from the anaerobic chamber and transferred on ice. For photography the liquid cultures were transferred into petri dishes.

167 To perform raster electron microscopy these anaerobically grown cultures 168 were transferred onto 0.2 μm membrane filters (Schleicher & Schuell, Dassel,

169 Germany) and fixed with 2 N dimethylarsinic acid and 25 % (w/v) glutaraldehyde.

170 Electron microscopy was performed at 10,000 fold enlargement.

171 For the investigation of biofilm formation 20 ml of supplemented liquid medium 172 in 200 ml glass Erlenmeyer flasks were inoculated with colony material from an agar 173 plate and incubated for 6 h, 12 h, 18 h or 24 h at 37°C and 5% CO<sub>2</sub> without shaking. 174 After incubation the OD<sub>600</sub> was measured. The bacterial suspension was removed 175 and the flasks were washed rigorously with water before staining. Then 2 ml of a 176 0.3% crystal violet solution (Merck) were added and the flasks were incubated for 5 177 min with gentle agitation. After staining the flasks were washed rigorously with water 178 and then dried. The crystal violet-stained biofilm on the glass surface was solubilized 179 with 10 ml of a solution comprised of 50% ethanol, 30% acetone and 20% acetic 180 acid. The  $OD_{600}$  was determined and, using a calibration curve, the amount of crystal 181 violet bound by the biofilm was calculated. All strains were tested in a minimum of 182 four independent experiments. The flasks used were new and intensively cleaned and washed with distilled water between experiments. Statistical analyses were 183 184 performed using the Student's t-test.

185

186 **3. Results** 

187

188 3.1. Construction of an arcA deletion mutant of A. pleuropneumoniae

189

A BLAST search identified a protein (gi:53729099) encoded on the genome of *A. pleuropneumoniae* strain 4074 which was 80 % identical to *E. coli* ArcA (gi:16132218) at the amino acid level. PCR and nucleotide sequence analysis revealed that a protein entirely identical to the *A. pleuropneumoniae* serotype 1 ArcA homologue is encoded by *A. pleuropneumoniae* AP76.

195 An isogenic arcA deletion mutant of A. pleuropneumoniae AP76 was 196 constructed by allelic exchange of the wild type *arc*A gene with an in frame deletion 197 lacking 186 bp at position 94 to 279 of the arcA ORF. The truncated ArcA protein 198 lacks the putative phosphorylation site on Asp54. The resulting A. pleuropneumoniae 199 arcA mutant was designated as A. pleuropneumoniae  $\Delta arcA$ ; it was verified using 200 PCR, Southern blotting, and nucleotide sequence analysis; the absence of gross 201 genomic rearrangements was confirmed by PFGE (supplementary material, Fig. S1). 202 For complementation A. pleuropneumoniae  $\Delta arcA$  was transformed with plasmid 203 pARC1340 and designated as A. pleuropneumoniae  $\triangle$  arcA + pARC1340.

205 3.2. Virulence studies

206

Aerosol infection with both *A. pleuropneumoniae* wt (group 1) and *A. pleuropneumoniae*  $\Delta arcA$  (group 2) led to an increase in body temperature above 40°C in all infected animals. However, animals infected with *A. pleuropneumoniae*  $\Delta arcA$  showed a significantly lower clinical score (p = 0.043) than animals infected with *A. pleuropneumoniae* wt (Fig. 1A).

In order to investigate if the *arcA* deletion mutant could persist at least one week we decided to sacrifice four animals in group 2 seven days post infection. All remaining animals were sacrificed on day 21 post infection. At necropsy, three of eight pigs in group 2 had no macroscopically visible lung lesions compared to one out of eight animals in group 1. The lung lesion score of group 2 was clearly lower than that of group 1 (Fig. 1B). Histological examination revealed no differences in the morphology of lung lesions in both groups.

219 Reisolation of the challenge strain from intact lung at necropsy 21 days post 220 infection succeeded in all animals of group 1 but only in one out of four animals of

group 2; at necropsy on day 7 post infection reisolation succeeded in two out of four animals of group 2 (Table 2). The reisolation score of *A. pleuropneumoniae*  $\Delta arcA$ was clearly reduced in comparison to the *A. pleuropneumoniae* wt group (Fig. 1C). From pneumonic lung the challenge strain could be reisolated in all seven animals with lesions in group 1 and in four out of five animals with lesions in group 2 with no difference seen between day 7 and day 21 post infection (Table 2).

227 Serum samples were obtained 1 week before and 3 weeks after experimental 228 infection. Before infection, no *A. pleuropneumoniae* specific antibodies could be 229 detected. On day 21 post challenge animals in both groups showed a strong humoral 230 immune response, and no significant difference was observed (Table 2).

231

232 3.3. Growth and survival of A. pleuropneumoniae ⊿arcA

233

234 The A. pleuropneumoniae arowth between Α. rates wt and 235 pleuropneumoniae  $\Delta arcA$  exhibited no significant differences over a 24 h incubation 236 period under both aerobic (Fig. S2 A) or anaerobic (Fig. S2 B) conditions. In addition, 237 long term survival kinetics of A. pleuropneumoniae wt and A. pleuropneumoniae 238  $\Delta arcA$  in an anaerobic liquid culture were indistinguishable. Sixty hours post 239 inoculation no culturable A. pleuropneumoniae wt or A. pleuropneumoniae  $\Delta arcA$ 240 were detectable (Fig. S2 C).

241

3.4. Effect of arcA deletion on bacterial autoaggregation and biofilm formation

243

In liquid culture under aerobic or microaerophilic conditions both *A*. *pleuropneumoniae* wt and *A. pleuropneumoniae*  $\triangle$ *arcA* grew as a homogenous

suspension (data not shown). Upon growth under anaerobic conditions *A. pleuropneumoniae* wt showed heavy autoaggregation. This phenotype was completely abolished by deletion of the *arcA* gene, and transformation of *A. pleuropneumoniae*  $\Delta arcA$  with plasmid pARC1340 restored the autoaggregating phenotype (Fig. 2A).

Raster electron microscopy of anaerobically grown cultures showed that *A. pleuropneumoniae* wt was embedded in a threadlike extracellular matrix. In *A. pleuropneumoniae*  $\Delta arcA$  an exogenous threadlike compound could also be observed. However, it seemed not to be attached to the bacterial surface, and threads had a relaxed structure. Complementation of *A. pleuropneumoniae*  $\Delta arcA$ with plasmid pARC1340 resulted in a phenotype which appeared to be associated even more tightly to the extracellular matrix than the wt strain (Fig. 2B).

258 As autoaggregation and the ability to form biofilm have been reported to be 259 associated (Schembri et al., 2003) we investigated the ability of A. pleuropneumoniae 260 *AarcA* to form biofilms. *A. pleuropneumoniae* wt attached to glass surfaces and 261 formed biofilm. Six hours after inoculation was no significant difference in biofilm 262 formation on the bottom of the Erlenmeyer flask between A. pleuropneumoniae wt 263 and A. pleuropneumoniae  $\Delta arcA$ . In A. pleuropneumoniae wt the biofilm further 264 increased until 12 hours post inoculation (p. i.). Only at 18 p. i. a reduction of biofilm 265 mass obtained by quantitative crystal violet staining was apparent. In A. 266 pleuropneumoniae  $\Delta arcA$ , however, the amount of biofilm was clearly reduced in 267 comparison to the wildtype at 12 hours p. i., and the difference was statistically significant at 18 and 24 hours p.i. (p = 0.013 and 0.014, respectively, Fig. 3A). 268 269 Complementation of A. pleuropneumoniae  $\Delta arcA$  in trans with plasmid pARC1340 slightly overcompensated the defect in biofilm formation, which likely is due to the 270

multiple copy number of *arcA* in the pARC1340 transformants; transformants containing the empty plasmid vector pLS88 behaved like the wild type (Fig. 3B). The lack of biofilm formation in *A. pleuropneumoniae*  $\Delta arcA$  was not caused by differences in cell densities as obtained by determination of OD<sub>600</sub> (data not shown).

#### **4. Discussion**

277

Anaerobic metabolism generally is a virulence-associated trait in the respiratory tract pathogen *A. pleuropneumoniae* (Baltes et al., 2003, Jacobsen et al., 2005, Baltes et al., 2005). Since bacteria are also able to sense low oxygen concentrations by the ArcAB system (Georgellis et al., 2001) and since ArcAdependent regulation of virulence factors has been shown for the intestinal pathogen *Vibrio cholerae* (Sengupta et al., 2003) we set out to investigate if a comparative relationship between virulence and ArcA also occurs in a respiratory tract pathogen.

The finding that the *A. pleuropneumoniae*  $\Delta arcA$  strain constructed was highly attenuated initially led us to hypothesize that the physiological key features described for *arcA* mutants of *Enterobacteriaceae* (i.e. delayed growth under anaerobic [Sevcik et al., 2001] or under aerobic conditions [Oshima et al., 2002] or reduced long term survival [Nystrom et al., 1996]) might be responsible. However, contrary to its role in *Enterobacteriaceae A. pleuropneumoniae* ArcA did influence neither growth nor survival and, therefore, appears to have different functions in *A. pleuropneumoniae*.

We observed that deletion of ArcA reduced the ability of *A. pleuropneumoniae* for autoaggregation and biofilm formation under oxygen-deprived growth conditions, and both phenotypes are known to be associated (Schembri et al., 2003). Since biofilm formation has been shown to be common for field isolates of *A. pleuropneumoniae* (Kaplan and Mulks, 2005), we hypothesized that the attenuation

297 of A. pleuropneumoniae  $\triangle$  arcA might be linked to this defect in autoaggregation and 298 biofilm formation. To investigate possible causes for this defect we performed 299 scanning electron microscopy and observed a difference in threadlike extracellular 300 material between A. pleuropneumoniae wt and A. pleuropneumoniae  $\triangle$  arcA. This 301 extracellular matrix - although present – appears to not be appropriately anchored to 302 A. pleuropneumoniae  $\Delta arcA$ . It might be PGA, a linear exopolysaccharide composed 303 of N-acetylglucosamine which has been described for A. pleuropneumoniae to be 304 involved in biofilm formation by acting as an extracellular adhesin (Kaplan et al., 305 2004; Izano et al., 2007). Alternatively, the structures might be extracellular DNA as 306 suggested to be present in Haemophilus influenzae (Jurcisek and Bakaletz, 2007) or 307 adhesive pili as shown in Actinobacillus actinomycetomcomitans (Fine et al., 1999). 308 A reason for the apparent defect in association of cells and matrix in A. 309 *pleuropneumoniae*  $\Delta arcA$  might be the lack of an ArcA regulated surface anchor or, 310 alternatively, an upregulation of the biofilm releasing enzyme dispersin B (Kaplan et 311 al., 2004) cutting the fibres of an extracellular N-acetylglucosamine polymer that 312 binds to the bacterial surface. These results, which provide evidence for a direct 313 influence of ArcA on biofilm formation, are supported by a recent report showing that 314 the deletion of *arcA* in *E. coli* reduces competitiveness in biofilm formation (Junker et 315 al., 2006).

Taken together our results support the hypothesis that ArcA of *A. pleuropneumoniae* is less important in acute infection but plays an essential role in respiratory tract persistence of *A. pleuropneumoniae*. This implies that an in-depth investigation of the ArcA regulon in the respiratory tract pathogen *A. pleuropneumoniae* might lead to the identification of previously unknown persistenceassociated factors and metabolic pathways and, therefore, improve our

### 455 **Figure legends**

457 Fig 1. Virulence of A. pleuropneumoniae wt and A. pleuropneumoniae  $\triangle arcA$ 458 compared in an aerosol infection model. Clinical score (A), lung lesion score (B) and 459 reisolation score (C) of pigs infected with A. pleuropneumoniae wt ( $\blacktriangle$ ) or  $\triangle$ arcA ( $\bigcirc$ 460 [sacrificed on day 7]; • [sacrificed on day 21]) . Each triangle or circle represents one 461 animal. The horizontal line represents the arithmetic mean and the error bar denotes 462 the standard deviation. The asterisks denote statistical significance (p < 0.05) of 463 differences between the entire A. pleuropneumoniae ∆arcA group (animals sacrificed 464 at day 7 [four animals] and 21 post infection [four animals]) and A. pleuropneumoniae 465 wt group (all sacrificed on day 21 post infection) as obtained using the Wilcoxon 466 Signed-Rank Test. The animals sacrificed at different time points post infection were 467 considered as a single group since both lung lesion and reisolation scores do not increase after day 7 of an A. pleuropneumoniae infection. Therefore, the approach 468 469 can have resulted at the most in an underestimation of differences between the two 470 groups.

480 *pleuropneumoniae*  $\Delta arcA$  complemented with the empty vector pLS88 (B). The 481 biofilm was stained with crystal violet. Crystal violet bound to the biofilm was 482 solubilized and measured at OD<sub>600</sub>. Using a calibration curve the amount of crystal 483 violet was calculated as ppm [w/v]. Error bars represent the standard deviation. 484 Statistical analysis was performed using Student's t-test. Asterisks denote statistical 485 significance (p < 0.05).
