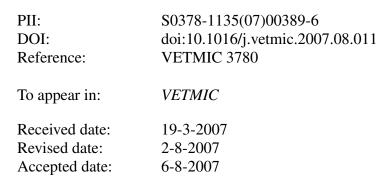

#### 26 ABSTRACT

*Renibacterium salmoninarum* is the etiologic agent of bacterial kidney disease (BKD)
occurring worldwide in salmonid fish. This bacterium has previously been regarded as a
strict aerobic species. However, in this study it is shown that *R. salmoninarum* grows well
in microaerophilic atmosphere, the colony size being larger and the colonies being more
mucoid than in aerobic conditions. Microaerophilic cultivation might be one possibility to
increase the sensitivity of the cultivation method for the detection of this slowly growing
pathogen.

#### 35 INTRODUCTION

Renibacterium salmoninarum is the etiologic agent of bacterial kidney disease (BKD) in 36 37 salmonid fish, a chronic, systemic infection characterized by granulomatous lesions in the 38 kidney and other organs (Fryer and Sanders, 1981; Fryer and Lannan, 1993). This 39 bacterium is widespread in nearly all countries where salmonid fish are cultured and it also 40 affects wild fish populations (Fryer and Sanders, 1981; Klontz, 1983). It was characterized 41 in terms of the G+C% content of the DNA, the cell wall sugar composition and the amino 42 acid composition of the peptidoglycan cell wall layer and was recognised as forming a 43 single species belonging to a new genus, *Renibacterium* (Sanders and Fryer, 1980).

*R. salmoninarum* is a Gram-positive short rod occurring frequently in pairs. It is aerobic, catalase positive, cytochrome oxidase negative, non-acid fast and non-motile, does not produce acid from sugars and does not form endospores. All strains require cysteine for growth. Optimal growth occurs at 15 to 18°C, and growth is very slow at 5 or 22°C and non-existent at 37°C. Growth on all media is slow, often requiring several weeks of incubation (Sanders and Fryer, 1980; Benediktsdottir et al., 1991). *R. salmoninarum* strains isolated from different regions form a very homogeneous group in terms of both

52	their morphological, biochemical and physiological (Goodfellow et al., 1985; Bruno and
53	Munro, 1986) and also their antigenic properties (Bullock et al., 1974; Getchell et al., 1985;
54	Daly and Stevenson, 1990). The bacterium is a highly conserved genospieces, and
55	studies on isolates from different parts of the world indicate relatively low genetic diversity
56	(Starliper, 1996; Grayson et al., 1999; Rhodes et al., 2000).
57	
58	R. salmoninarum has been described as an aerobic bacterial species (Sanders and Fryer,
59	1980). In BKD there are often large granulomatous lesions in the internal organs of the
60	diseased fish, pointing to an ability to survive and proliferate in circumstances involving a
61	decrease in oxygen concentration. In this study we tested the growth of R. salmoninarum
62	under aerobic, microaerophilic and anaerobic conditions.

- tested using *Campylobacter fetus* subsp. *fetus* (ATCC 27374) as a control strain. The
  KDM2 plates were observed for growth after 5 and 12 wks.

81 One microaerophilic subculture per strain used in Trial 1 was identified as R. 82 salmoninarum (Table 1), based on the observation of small Gram-positive rods occurring 83 in pairs in Gram staining, a negative oxidase test (Spot test, Difco/BBL), a positive 84 catalase test, a positive result in fluorescent antibody (FA) staining, typical results with API 85 ZYM test strips (bioMérieux, France) and little or no growth on TSA agar. A polymerase 86 chain reaction (PCR) was also used as a confirmatory test. In the FA staining a fixed 87 smear of bacterial culture was covered with polyclonal rabbit anti-Renibacterium salmoninarum serum, incubated in a moist chamber at 37 + 1°C for 30 min, rinsed with 88 89 PBS and covered with fluorescein isothiocyanate (FITC)-conjugated swine anti-rabbit IgG 90 (Nordic Immunological Laboratories, the Netherlands). It was then incubated as above, 91 rinsed and covered with phosphate-buffered glycerol and examined under an 92 epifluorescence microscope. The API ZYM test strips were incubated at 16 + 1°C for 18-24 93 h and the results were compared with those described in the World Organisation for 94 Animal Health's Diagnostic Manual for Aquatic Animal Diseases (OIE, 2006), combined 95 with those obtained with R. salmoninarum ATCC 33209 in our laboratory. PCR was 96 performed according to Miriam et al. (1997) with some minor modifications (Hirvelä-Koski 97 et al., 2006). Amplification was performed in a 50 µl volume containing 0.3 µM primers FL7 98 and RL5, 0.2 mM each of nucleotide triphosphate and 2.5 mM MgCl<sub>2</sub>. 99

100 Trial 2:

A total of 19 strains of *R. salmoninarum* were used, ten of which had been isolated from
 different fish species in northern Finland during the years 1997-2002 through the fish

103 health control programme, using the icelandic cultivation method (Benediktsdottir et al.,

104 1991). Six strains were obtained from Sweden and three from Denmark. The bacterial
105 strains were cultivated on three parallel KDM2 agar plates. One of them was incubated
106 aerobically, one anaerobically and one in a microaerophilic atmosphere. The anaerobic
107 atmosphere (carbon dioxide content 8-14 %, oxygen content below 1 %) was generated
108 using AnaeroGen<sup>™</sup> (Oxoid) and anaerobiosis in the incubation jars was checked using
109 Anaerotest strips (Merck,Darmstadt, Germany). The incubation temperature was 16±1°C.
110 The plates were observed for growth after 15 d.

112 RESULTS AND DISCUSSION

113

114 A dense growth was observed with all the Renibacterium salmoninarum strains after 115 incubation under microaerophilic conditions in both trials. All isolates were in pure culture 116 and confirmed as *R. salmoninarum* by PCR. The number of colonies was slightly smaller 117 than on the aerobically incubated plates in Trial 1 (Table 1), but the colony size was larger 118 than in the aerobically incubated cultures (Fig. 1). After 12 wks the diameter of the single 119 colonies was 1-2 mm in aerobic cultivation and 3-4 mm under microaerophilic conditions, 120 and their appearance was more mucoid and more yellowish in the latter case. The fact that 121 the bacterial suspensions were prepared using aerobically cultivated plates may 122 nevertheless have influenced the number of colonies detected, for if the bacterial strains 123 tested here had been incubated in a microaerophilic atmosphere several times before the 124 trial, the result might have been different. No growth could be observed in any of the 19 R. 125 salmoninarum strains after anaerobic incubation.

Even though the incubation temperature used here was not optimal for *Campylobacter fetus* subsp. *fetus*, growth of this bacterium was observed, indicating the presence of a

129 microaerophilic atmosphere in the incubation jars.

131 The results show that *R. salmoninarum* grows well in a microaerophilic atmosphere. This 132 is the first report on this phenomenon for *R. salmoninarum*, which has been regarded as a 133 strict aerobic species (Sanders and Fryer, 1980). The phylogenetic position of R. 134 salmoninarum was determined as being the actinomycetes subdivision (Stackebrandt et 135 al., 1988), and the bacterium was first grouped within the Arthrobacter/Micrococcus 136 subline, as supported by the strict aerobic metabolism of these genera (Stackebrandt et 137 al., 1988). Later, based on an almost complete 16S rRNA sequence and the unique 138 phenotypic characteristics of this bacterium, it was stated that *R*. salmoninarum should be 139 considered a separate genus of the high G+C% Gram-positive eubacterial subdivision 140 (Gutenberger et al., 1991; Banner et al., 1991). The microaerophilic growth of R. 141 salmoninarum observed here also supports the suggestions of Gutenberger et al. (1991). 142 143 It is well known that *R. salmoninarum* is very difficult to detect in subclinically infected fish 144 populations. Several authors have reported that, even though its presence in kidney tissue 145 is demonstrable by FA, ELISA or PCR, for example, efforts to isolate it by a culture method can be unsuccessful (Mitchum et al., 1979; Paterson et al., 1979; Evelyn et al., 1981; 146 147 Pascho & Mulcahy, 1987; Griffiths et al., 1991; Sakai & Kobayashi, 1992; Gudmundsdottir 148 et al., 1993; Jansson et al., 1996; Miriam et al., 1997; Cvitanich, 2004). Microaerophilic 149 cultivation could be one possibility for increasing the sensitivity of the cultivation method 150 for detecting *R. salmoninarum* in fish tissues. 151 152 153 ACKNOWLEDGEMENTS
