14 Abstract

Organic poultry breeding allows for increased exposure of birds to soil, faeces, and wildlife, which have been associated with the transmission of mycobacterial infections. Therefore the aim of this study was to investigate the spread of the major pathogenic mycobacteria in organically reared broilers in Greece using a diagnostic algorithm that relied on a combination of the Polymerase Chain Reaction (PCR) and the Restriction Fragment Length Polymorphism analysis (RFLP).

21 Liver, spleen and gonads from 81-150 days old broilers were aseptically 22 collected post-mortem. 500 broilers from a population of 35370, reared in the 25 23 registered as organic farms in Greece for the 2005 were used. DNA was isolated and 24 incorporated to PCR targeted to 16s-rRNA gene (for Mycobacterium spp.), IS6110 (for 25 *M. tuberculosis complex*-MTBc), IS1245 (for *M. avium complex*-MAC), IS901 (for *M.* 26 avium subsp. avium - MAA) and hsp65 (for M. genavense, by PCR-RFLP). The mean prevalence of mycobacteria detected by PCR with a 95% confidence interval was 27 28 estimated to 4.4 - 8.8%. The relevant percentage with regard to the mycobacterial 29 species that were included in this study was 0.17-2.03% for MAC, 2.11-3.39% for 30 MTBc and 0.66-3.08% for mycobacteria not belonging to any of the above groups. 31 None of the mycobacteria detected were identified as MAA or M. genavense.

Considering that avian tuberculosis has been eradicated from conventional farms, the level and the pattern of positivity recorded here, indicates that our results may be associated with the specific conditions that apply to organic breeding.

40 Introduction

41

42 Avian tuberculosis is usually caused by *Mycobacterium avium* complex (MAC) 43 serovars 1 to 3 (*M. avium* subsp. avium - MAA) and *M. genavense* (Böttger et al., 1993; 44 Tell et al., 2001; Saif, 2003; Shitaye et al., 2008). The incidence of the disease is sporadic and it is rarely reported in intensively reared flocks (Tell et al., 2001). Organic 45 46 farming is gradually becoming very popular among farmers and consumers in Europe, 47 but it increases exposure of fowl to soil and faeces, and has been associated with the spread of mycobacterial infections (Hoop et al., 1996; Martin and Schimmel, 2000; 48 49 Gonzalez et al., 2002; Saif, 2003). Despite the assessment of the prevalence of various 50 pathogens in organic farms of birds, there seems to be, to the best of our knowledge, no 51 evidence with respect to mycobacteria (Permin and Nansen, 1996; Lund and Algers, 52 2003; Maag et al., 2003).

The aim of this study was therefore to investigate the spread of the major pathogenic mycobacteria (*M. avium complex, M. genavense, M. tuberculosis complex*) in organically reared broilers in Greece using a diagnostic algorithm that relied on a combination of the Polymerase Chain Reaction (PCR) and the Restriction Fragment Length Polymorphism analysis (RFLP).

60 Materials and Methods

61 Samples

62 The sampling plan covered 25 broiler farms that represented the total of those 63 registered as organic in Greece in the year 2005, based on the records of the National 64 Authorized Certification Institutes. Liver, spleen, and gonads were collected aseptically 65 post-mortem, from 500 of the 35370, 81-150 days old, organically reared broilers. The 66 required sample size was calculated (STATGRAPHICS Plus 5.1) to estimate a 95% confidence interval for the prevalence of mycobacteria no wider than 4%, when the 67 68 expected mycobacteria prevalence is reported to be 5% (Tell et al., 2001; Saif, 2003). The sample size that was thus estimated (n=457) was finally defined to 500 for practical 69 70 reasons, and was distributed equally among the farms, the broiler population of which 71 was considered homogenous. Fowl within each flock was randomly selected among

clinically healthy broilers, based on the records of the farm and the evaluation of the
birds by Veterinary Inspectors. Collection of samples was performed from June to
August 2005.

The tissue samples of each bird were pooled in 20 ml, screw-cup containers and were stored at 4-6°C for up to 6 hours, until transportation to the laboratory. The material was then homogenised in a stomacher blender at 260 rpm for 5 min and it was processed for DNA isolation.

80 **DNA isolation**

81 A portion of 0.5 ml of the tissue homogenate of each sample was used for DNA 82 isolation with the NucleoSpin® Tissue kit (Macherey-Nagel, Germany) according to the 83 instructions of the manufacturer. The DNA solution was evaluated for purity and 84 integrity by spectrophotometry and gel-electrophoresis (Sambrook et al., 1989). The 85 presence of PCR inhibitors in the DNA preparations was assessed by a PCR assay 86 targeted to an in-house gene (cytochrome b), based on a method originally described by 87 Zehner et al., 1998 (data not shown). DNA samples of low quality, and those failing to 88 produce the expected amplification product from the PCR assay mentioned above, were 89 discarded and DNA isolation was repeated from the original material.

91 **PCR**

The detection and the differential identification of mycobacteria relied on a
PCR-based diagnostic algorithm (Dvorska et al., 2001), modified to include *M*. *genavense* (Mendenhall et al., 2000), (Figure 1). Within this context a combination of 5
PCR assays was applied targeted to 16s-rRNA gene (for *Mycobacterium spp.*), IS6110
(for *M. tuberculosis complex*), IS1245 (for *M. avium complex*), IS901 (for *M. avium*subsp. *avium*), and hsp65 followed by RFLP (for *M. genavense*) (Table 1).

98 PCR products were analysed by submerged electrophoresis on a 2% agarose gel.
99 Samples were evaluated and processed together with positive and negative controls that
100 consisted of confirmed, PCR-positive and negative, DNA preparations, respectively.
101 Test tubes, containing only the reaction mixture and water of the same source used for
102 the dilution of DNA, were also included in each PCR assay, as negative controls.

103 **Results**

104

105 Fifty of the 500 (10%) samples examined were found positive for mycobacteria. Of 106 these, 8 (1.6%) were identified as *Mycobacterium avium complex* (2 positive to 16s-107 rRNA and IS1245, 6 positive to 16S-rRNA and hsp65), 18 (3.6%) as Mycobacterium 108 tuberculosis complex (MTBc) (16S-rRNA and IS6110-positive, with the exception of 109 one sample that reacted positively only to IS6110), and 24 (4.8%) as mycobacteria not 110 belonging to any of the groups (OM-other mycobacteria) previously mentioned (16s-111 rRNA-positive), (Table 2). After exclusion of a farm in which mycobacteria-specific 112 DNA was detected by PCR in 90% of the tested samples and was therefore considered 113 an outlier, the above percentages were formulated respectively to the following: 1% 114 MAC (5/480), 3,75% MTBc (18/480), and 1,87% OM (9/480).

Twelve of the 25 (48%) flocks tested where found PCR-positive with prevalence ranging (excluding the outlier flock) from 5 to 35%. Within this group, the majority of the farms (6/11, 54,5%) were positioned at 10% (4/11) and 20% (2/11). Of the reactor flocks, 3 were found positive only to OM, 3 to MAC, 5 to MTBc, and 1 to a combination of OM and MAC.

120 Hypothesis tests proved that mycobacterial prevalence in organic broilers' 121 population was similar to the 5% estimated prevalence in conventional broilers 122 populations (p-value=0.12 > 0.05).

The mean prevalence of mycobacteria detected by PCR in organic broilers in Greece, with a 95% confidence interval, was estimated to 4.4 - 8.8%. The relevant percentage with regard to the mycobacterial species that were investigated was 0.17-2.03% for *Mycobacterium avium complex*, 2.11-3.39% for *Mycobacterium tuberculosis complex* and 0.66-3.08% for other mycobacteria not belonging to any of the above groups.

131 Discussion

132

133 The results of this study show that DNA that belongs to pathogenic mycobacteria 134 can be detected in viscera (not inclusive of the intestine which might contain

environmental mycobacteria) of clinically healthy organic broilers in Greece. The young age of the birds examined and possibly the fact that none of the positive reactions referred to mycobacteria known to specifically infect fowl (*M. avium* subsp. *avium* and *M. genavense*) may account for the absence of any disease symptoms in the tested population, even though the presence of mycobacterial DNA in the visceral organs indicates invading bacteria (Ashour, 1972; Ashford et al., 2001).

141 In studies such as the one described here, reservations on the reliability of the 142 results can be attributed mainly to false positive reactions usually due to the carry over 143 effect or the use of low specificity PCR assays. To avoid this, the evaluation of the 144 samples was performed under vigorous precautions such as the use of dedicated space, 145 equipment, and consumables, as well as negative controls that were processed together 146 with the tested material during both, DNA isolation and PCR. The low specificity of the 147 methodology followed in this study was eliminated by the use of PCR assays 148 thoroughly evaluated and repeatedly used in the past by the same and other groups 149 (Hance et al., 1989; Huard et al., 2003; Ikonomopoulos et al., 2004; Ikonomopoulos, 150 2006; Ikonomopoulos et al., 2007). Furthermore, the use of the specific diagnostic 151 algorithm was selected because in addition to the identification of the targeted 152 mycobacteria, it allowed confirmation of the results by the amplification of more than 153 one gene for each of the pathogens detected.

154 This approach was however responsible, for some discrepancies results because 155 of the expected inconsistency among the positive reactions of PCR assays designed for 156 gene-targets of the same mycobacterial groups (Hance et al., 1989; Gazouli et al., 2002 157 Ikonomopoulos, 2006; Ikonomopoulos et al., 2007). Indeed this was observed for 2 158 IS1245 and 16rRNA-positive samples, which came from the same farm that reacted 159 negatively to the PCR assay targeted to hsp65. Furthermore, one IS6110-positive 160 sample did not produce the expected 16S rRNA-positive result, despite the fact that 161 evaluation of these samples was repeated more than once from the same DNA 162 preparation and the original material. These observations could be attributed to atypical 163 strains, were not considered unreliable and therefore they were included in the final 164 evaluation of the tested population.

165 A high level of awareness was also imposed by the effort to eliminate false 166 negative reactions, especially since these could easily be the cause of considerable 167 under-evaluation, given that the expected positivity of the tested material was small. 168 Therefore all our DNA preparations were assessed before PCR by several methods 169 (electrophoresis, measurement of optical density, and PCR targeted to an in-house gene) 170 for DNA fragmentation and presence of PCR inhibitors. Apparently, detection and 171 identification of mycobacteria was always performed in correlation with positive 172 controls that represented no less than 10% of the tested samples of each batch, and 173 consisted of DNA preparations of visceral organs inoculated with pure growth of each 174 of the mycobacteria included in our investigation.

175 Considering that avian tuberculosis has been eradicated from conventional farms 176 and that nowadays the disease is reported mostly in wild (Tell et al., 2001; Milan et al., 177 2004), or captive fowl (Portaels et al., 1996), and pet birds (Bottger et al 1993; Hoop et 178 al., 1996; Hoop, 2002), the level of positivity recorded here may be associated with the 179 specific conditions that apply to organic farming. According to the relevant regulations, 180 birds have to be housed in specifically designed facilities but never in cages, and they 181 have to be able to spend at least one third of their lives in open fields covered with 182 vegetation (Council of European Communities-EEL198, 22/7/1991). Evidently this 183 increases exposure of fowl to worms, rodents, arthropods, and wild birds that have all 184 been found to carry mycobacteria and play an important role in their spread in nature 185 and the livestock (Fischer et al., 2001; Fischer et al., 2003a; Fischer et al., 2003b; 186 Tadesse et al., 2003). This may justify the high percentage of OM detected in the 187 samples, which probably represent non-pathogenic mycobacteria broadly found in the 188 environment. The characteristics of the organic farming system mentioned above may 189 also account for the level of PCR-positivity of the tested samples recorded in a specific 190 flock that was finally considered an outlier, since detection of mycobacterial DNA in all 191 the other farms was comparatively much lower (90% compared to 14.5% mean 192 average). Admittedly this finding may consist an indication of a mycobacterial outbreak 193 that could be associated with organic farming or just malpractice, something that could 194 not be investigated by a study such as this. On the other hand failure to detect any M. 195 genavense or MAA-positive samples may result from the fact that as opposed to animal 196 tuberculosis, the disease in fowl has been eradicated and effectively exposure of birds to

these pathogens is small. The negativity of the samples to the mycobacteria that specifically infect fowl may be reflecting, at least in Greece, the situation in conventional farms for yet another reason: based on the regulations mentioned above, the fowl of organic farms often derive from conventional flocks with the restriction to be of no more than 3 days of age, since this is the suggested alternative in the event that availability of organic breeding stock is small.

203 In conclusion

DNA belonging to MAC, MTBc, and MO, but not to *M. genevense* or MAA, was detected by PCR in the viscera of organically reared broilers in Greece. The level and the pattern of sample positivity recorded, indicate that our results may be associated with the specific conditions that apply to organic farming, probably with connection to increased exposure of birds to the environment.
