# ON THE TOPOLOGY OF SEMI-ALGEBRAIC FUNCTIONS ON CLOSED SEMI-ALGEBRAIC SETS 

NICOLAS DUTERTRE


#### Abstract

We consider a closed semi-algebraic set $X \subset \mathbb{R}^{n}$ and a $C^{2}$ semi-algebraic function $f: \mathbb{R}^{n} \rightarrow \mathbb{R}$ such that $f_{\mid X}$ has a finite number of critical points. We relate the topology of $X$ to the topology of the sets $\{f * \alpha\}$, where $* \in\{\leq,=, \geq\}$ and $\alpha \in \mathbb{R}$, and the indices of the critical points of $f_{\mid X}$ and $-f_{\mid X}$. We also relate the topology of $X$ to the topology of the links at infinity of the sets $\{f * \alpha\}$ and the indices of these critical points. We give applications when $X=\mathbb{R}^{n}$ and when $f$ is a generic linear function.


## 1. Introduction

Let $f:\left(\mathbb{R}^{n}, 0\right) \rightarrow(\mathbb{R}, 0)$ be an analytic function-germ with an isolated critical point at 0 . The Khimshiashvili formula $[\mathrm{Kh}]$ states that:

$$
\chi\left(f^{-1}(\delta) \cap B_{\varepsilon}^{n}\right)=1-\operatorname{sign}(-\delta)^{n} \operatorname{deg}_{0} \nabla f
$$

where $0<|\delta| \ll \varepsilon \ll 1, B_{\varepsilon}^{n}$ is a closed ball of radius $\varepsilon$ centered at $0, \nabla f$ is the gradient of $f$ and $\operatorname{deg}_{0} \nabla f$ is the topological degree of the mapping $\frac{\nabla f}{\nabla f \mid}: S_{\varepsilon}^{n-1} \rightarrow S^{n-1}$. As a corollary of this formula, one gets (see [Ar] or [Wa]):

$$
\begin{gathered}
\chi\left(\{f \leq 0\} \cap S_{\varepsilon}^{n-1}\right)=1-\operatorname{deg}_{0} \nabla f, \\
\chi\left(\{f \geq 0\} \cap S_{\varepsilon}^{n-1}\right)=1+(-1)^{n-1} \operatorname{deg}_{0} \nabla f,
\end{gathered}
$$

and:

$$
\chi\left(\{f=0\} \cap S_{\varepsilon}^{n-1}\right)=2-2 \operatorname{deg}_{0} \nabla f \text { if } n \text { is even. }
$$

In [Se], Sekalski gives a global counterpart of Khimshiashvili's formula for a polynomial mapping $f: \mathbb{R}^{2} \rightarrow \mathbb{R}$ with a finite number of critical points. He considers the set $\Lambda_{f}=\left\{\lambda_{1}, \cdots, \lambda_{k}\right\}$ of critical values of $f$ at infinity, where $\lambda_{1}<\ldots<\lambda_{k}$, and its complement $\left.\mathbb{R} \backslash \Lambda_{f}=\cup_{i=0}^{k}\right] \lambda_{i}, \lambda_{i+1}\left[\right.$ where $\lambda_{0}=-\infty$ and $\lambda_{k+1}=+\infty$. Denoting by $r_{\infty}(g)$ the numbers of real branches at infinity of a curve $\{g=0\}$ in $\mathbb{R}^{2}$, he proves that:

$$
\operatorname{deg}_{\infty} \nabla f=1+\sum_{i=1}^{k} r_{\infty}\left(f-\lambda_{i}\right)-\sum_{i=0}^{k} r_{\infty}\left(f-\lambda_{i}^{+}\right)
$$

[^0]where for $i=0, \ldots, k, \lambda_{i}^{+}$is an element of $] \lambda_{i}, \lambda_{i+1}\left[\right.$ and $\operatorname{deg}_{\infty} \nabla f$ is the topological degree of the mapping $\frac{\nabla f}{\|\nabla f\|}: S_{R}^{n-1} \rightarrow S^{n-1}, R \gg 1$. Here a real branch is homeomorphic to a neighborhood of infinity in $\mathbb{R}$ and hence has two connected components.

Our aim is to generalize Sekalski's formula and to establish other similar results. We consider a closed semi-algebraic set $X \subset \mathbb{R}^{n}$ equipped with a finite semi-algebraic Whitney stratification $\left(S_{\alpha}\right)_{\alpha \in A}$ and a $C^{2}$ semi-algebraic function $f: \mathbb{R}^{n} \rightarrow \mathbb{R}$ such that $f_{\mid X}$ has a finite number of critical points $p_{1}, \ldots, p_{l}$. The index of $f_{\mid X}$ at $p_{i}$ is defined by:

$$
\operatorname{ind}\left(f, X, p_{i}\right)=1-\chi\left(X \cap\left\{f=f\left(p_{i}\right)-\delta\right\} \cap B_{\varepsilon}^{n}\left(p_{i}\right)\right)
$$

where $0<\delta \ll \varepsilon \ll 1$. In Section 3, Proposition 3.6 and Corollary 3.7, we give relations between the Euler characteristics of the sets $\{f * \alpha\}$, where $* \in\{\leq,=, \geq\}$ and $\alpha \in \mathbb{R}$, the indices of the critical points of $f_{\mid X}$ and $-f_{\mid X}$ and four numbers $\lambda_{f, \alpha}, \lambda_{-f,-\alpha}, \mu_{f, \alpha}$ and $\mu_{-f-, \alpha}$. These numbers are defined in terms of the behavior of $f_{\mid X}$ at infinity (Definition 3.5). Then we consider the following finite subset of $\mathbb{R}$ :

$$
\begin{array}{r}
\Lambda_{f}^{*}=\left\{\alpha \in \mathbb{R} \mid \beta \mapsto \chi\left(\operatorname{Lk}^{\infty}(X \cap\{f * \beta\})\right)\right. \text { is not constant } \\
\text { in a neighborhood of } \alpha\}
\end{array}
$$

where $* \in\{\leq,=, \geq\}$ and $\mathrm{Lk}^{\infty}(-)$ denotes the link at infinity. Writing $\left.\Lambda_{f}^{\leq}=\left\{b_{1}, \ldots, b_{r}\right\}, \mathbb{R} \backslash \Lambda_{f}^{\leq}=\cup_{i=0}^{r}\right] b_{i}, b_{i+1}\left[\right.$ with $b_{0}=-\infty$ and $b_{r+1}=+\infty$ and studying the behavior at infinity of the numbers $\lambda_{f, \alpha}, \lambda_{-f,-\alpha}, \mu_{f, \alpha}$ and $\mu_{-f-, \alpha}$, we show that (Theorem 3.16):

$$
\begin{aligned}
& \chi(X)=\sum_{i=1}^{k} \operatorname{ind}\left(f, X, p_{i}\right)+\sum_{j=0}^{r} \chi\left(\operatorname{Lk}^{\infty}\left(X \cap\left\{f \leq b_{j}^{+}\right\}\right)\right) \\
&-\sum_{j=1}^{r} \chi\left(\operatorname{Lk}^{\infty}\left(X \cap\left\{f \leq b_{j}\right\}\right)\right),
\end{aligned}
$$

where for $\left.j \in\{0, \ldots, r\}, b_{j}^{+} \in\right] b_{j}, b_{j+1}$. Similar formulas involving $\Lambda_{f}^{\geq}$and $\Lambda_{f}^{\overline{\bar{f}}}$ are proved in Theorem 3.17 and Corollary 3.18.

Next we consider the finite subset $\tilde{B}_{f}=f\left(\left\{p_{1}, \ldots, p_{l}\right\}\right) \cup \Lambda_{f}^{\leq} \cup \Lambda_{f}^{\geq}$of $\mathbb{R}$. We show that if $\alpha \notin \tilde{B}_{f}$ then the functions $\beta \mapsto \chi(X \cap\{f * \beta\}), * \in\{\leq,=, \geq\}$, are constant in a neighborhood of $\alpha$ (Proposition 3.19). In Theorem 3.20 and Theorem 3.21 we express $\chi(X)$ in terms of the indices of the critical points of $f_{\mid X}$ and $-f_{\mid X}$ and the variations of the Euler characteristics of the sets $\{f * \alpha\}, \alpha \in\{\leq,=, \geq\}$.

In Section 4, we apply all these results to the case $X=\mathbb{R}^{n}$ in order to recover and generalize Sekalski's formula (Theorem 4.4).

In Section 5, we apply the results of Section 3 to generic linear functions. For $v \in S^{n-1}$, we denote by $v^{*}$ the function $v^{*}(x)=\langle v, x\rangle$. We show that
for $v$ generic in $S^{n-1}$, the sets $\Lambda_{v^{*}}^{\leq}, \Lambda_{v^{*}}^{=}$and $\Lambda_{v^{*}}^{\geq}$are empty. Hence for such a $v$, the Euler characteristics of the sets $X \cap\left\{v^{*} ? \alpha\right\}, ? \in\{\leq,=, \geq\}$ and $\alpha \in \mathbb{R}$, as well as the Euler characteristics of their links at infinity, can be expressed only in terms of the critical points of $v_{\mid X}^{*}$ and $-v_{\mid X}^{*}$ (Proposition 5.4 and Proposition 5.5). We use these results to give a new proof of the Gauss-Bonnet formula for closed semi-algebraic set (Theorem 5.8), that we initially proved in [Dut3, Corollary 5.7] using the technology of the normal cycle $[\mathrm{Fu}]$ and a deep theorem of Fu and McCrory [FM, Theorem 3.7].

Section 2 of this paper contains three technical lemmas.
We will use the following notations: for $p \in \mathbb{R}^{n}$ and $\varepsilon>0, B_{\varepsilon}^{n}(p)$ is the ball of radius $\varepsilon$ centered at $p$ and $S_{\varepsilon}^{n-1}(p)$ the sphere of radius $\varepsilon$ centered at $p$. If $p=0$, we simply set $B_{\varepsilon}^{n}$ and $S_{\varepsilon}^{n-1}$ and if $p=0$ and $\varepsilon=1$ we use the standard notations $B^{n}$ and $S^{n-1}$. If $\mathcal{E}$ is a subset of $\mathbb{R}^{n}$ then $\mathcal{E}$ denotes its topological interior.

## 2. Some Lemmas

Let $X \subset \mathbb{R}^{n}$ be a closed semi-algebraic set equipped with a semi-algebraic Whitney stratification $\left(S_{\alpha}\right)_{\alpha \in A}: X=\sqcup_{\alpha \in A} S_{\alpha}$. Let $g: \mathbb{R}^{n} \rightarrow \mathbb{R}$ be a $C^{2}$ semi-algebraic function such that $g^{-1}(0)$ intersects $X$ transversally (in the stratified sense). Then the following partition:

$$
X \cap\{g \leq 0\}=\bigsqcup_{\alpha \in A} S_{\alpha} \cap\{g<0\} \sqcup \bigsqcup_{\alpha \in A} S_{\alpha} \cap\{g=0\}
$$

is a Whitney stratification of the closed semi-algebraic set $X \cap\{g \leq 0\}$.
Let $f: \mathbb{R}^{n} \rightarrow \mathbb{R}$ be another $C^{2}$ semi-algebraic function such that $f_{\mid X \cap\{g \leq 0\}}$ admits an isolated critical point $p$ in $X \cap\{g=0\}$ which is not a critical point of $f_{\mid X}$. If $S$ denotes the stratum of $X$ that contains $p$, this implies that:

$$
\nabla\left(f_{\mid S}\right)(p)=\lambda(p) \nabla\left(g_{\mid S}\right)(p)
$$

with $\lambda(p) \neq 0$. We assume that $f_{\mid\{g=0\}}$ is a submersion in the neighborhood of $p$ if $\operatorname{dim} S<n$ and, for simplicity, that $f(p)=0$.

Lemma 2.1. For $0<\delta \ll \varepsilon \ll 1$, we have:

$$
\begin{aligned}
& \chi\left(f^{-1}(-\delta) \cap B_{\varepsilon}^{n}(p) \cap X \cap\{g \leq 0\}\right)=1 \text { if } \lambda(p)>0 \\
& \chi\left(f^{-1}(-\delta) \cap B_{\varepsilon}^{n}(p) \cap X \cap\{g \leq 0\}\right)= \\
& \quad \chi\left(f^{-1}(-\delta) \cap B_{\varepsilon}^{n}(p) \cap X \cap\{g=0\}\right) \text { if } \lambda(p)<0 .
\end{aligned}
$$

Proof. We assume first that $\operatorname{dim} X<n$. Let $h: \mathbb{R}^{n} \rightarrow \mathbb{R}$ be a semialgebraic approximating function for $X$ from outside (see [BK, Definition 6.1]). This implies that $h$ satisfies the following conditions:
(i) The function $h$ is nonnegative and $h^{-1}\{0\}=X$.
(ii) The function $h$ is of class $C^{3}$ on $\mathbb{R}^{n} \backslash X$.
(iii) There exists $\delta>0$ such that all $t \in] 0, \delta]$ are regular values of $f$.
(iv) If $\left(y_{k}\right)_{k \in \mathbb{N}}$ is a sequence of points in $\mathbb{R}^{n}$ tending to a point $x$ in $X$ such that $\left.\left.h\left(y_{k}\right) \in\right] 0, \delta\right]$ and $\frac{\nabla h}{\|\nabla h\|}\left(y_{k}\right)$ tends to $v$, then $v$ is normal to $T_{x} S, S$ being the stratum containing $x$.
Let us choose $\varepsilon$ sufficiently small so that the ball $B_{\varepsilon^{\prime}}^{n}(p)$ intersect $X,\{g \leq 0\}$ and $X \cap\{g \leq 0\}$ transversally for $\varepsilon^{\prime} \leq \varepsilon$. For $r>0$ sufficiently small, the set $W_{\varepsilon, r}=B_{\varepsilon}^{n}(p) \cap\{g \leq 0\} \cap\{h \leq r\}$ is a manifold with corners. To see this, it is enough to prove that $r$ is not a critical value of $h_{\mid B_{\varepsilon}^{n}(p) \cap\{g \leq 0\}}$, which means that $r$ is not a critical value of:

$$
h_{1}=h_{\mid B_{\varepsilon}^{n^{\circ}}(p) \cap\{g<0\}}, h_{2}=h_{\mid B_{\varepsilon}^{\circ}(p) \cap\{g=0\}}, h_{3}=h_{\mid S_{\varepsilon}^{n-1}(p) \cap\{g<0\}},
$$

and:

$$
h_{4}=h_{\mid S_{\varepsilon}^{n-1}(p) \cap\{g=0\}} .
$$

The fact that $r$ is not a critical value of $h_{1}$ is trivial by Condition (iii) above. If for $r>0$ small, $r$ is a critical value of $h_{2}$ then we can find a sequence of points $\left(q_{n}\right)$ in $B_{\varepsilon}^{n}(p) \cap\{g=0\}$ such that $h\left(q_{n}\right) \rightarrow 0$ and $h_{\mid\{g=0\}}$ admits a critical point at $q_{n}$. Applying Condition (iv) above, we see that there exists a point $q$ in $B_{\varepsilon}^{n}(p) \cap X \cap\{g=0\}$ such that $g^{-1}(0)$ does not intersect $X$ transversally at $q$, which is impossible. Similarly, we can prove that $r$ is not a critical value of $h_{3}$ and $h_{4}$.

Let $\delta$ be such that $0<\delta \ll \varepsilon$ and the fibres $f^{-1}(-\delta)$ and $f^{-1}(\delta)$ intersect $X \cap\{g \leq 0\} \cap B_{\varepsilon}^{n}(p)$ transversally. This is possible since $f$ has an isolated critical point at $p$ on $X \cap\{g \leq 0\}$. Let us study the critical points of $f_{\mid W_{\varepsilon, r}}$ and $f_{\mid W_{\varepsilon, r} \cap\{g=0\}}$ lying in $f^{-1}([-\delta, \delta])$, when $r$ is small. Always using Condition (iv) above, we can see that they only appear in $\{h=r\} \cap\{g=$ $0\} \cap B_{\varepsilon}^{n^{\circ}}(p)$. Furthermore, with the terminology introduced in [Dut2, $\S 2$ ], if $\lambda(p)>0$ then they are all outwards for $f_{\mid W_{\varepsilon, r}}$. If $\lambda(p)<0$ then such a critical point is inwards for $f_{\mid W_{\varepsilon, r}}$ if and only if it is inwards for $f_{\mid W_{\varepsilon, r} \cap\{g=0\}}$. Moving $f$ a little, we can assume that these critical points are non-degenerate for $f_{\mid\{h=r\} \cap\{g=0\} \cap B_{\varepsilon}^{n^{\circ}(p)}}$. Applying Morse theory for manifolds with corners, if $\lambda(p)>0$ then we get:

$$
\chi\left(f^{-1}([-\delta, \delta]) \cap W_{\varepsilon, r}\right)-\chi\left(f^{-1}(-\delta) \cap W_{\varepsilon, r}\right)=0
$$

If $\lambda(p)<0$ then we get:

$$
\begin{gathered}
\chi\left(f^{-1}([-\delta, \delta]) \cap W_{\varepsilon, r}\right)-\chi\left(f^{-1}(-\delta) \cap W_{\varepsilon, r}\right)= \\
\chi\left(f^{-1}([-\delta, \delta]) \cap\{g=0\} \cap W_{\varepsilon, r}\right)-\chi\left(f^{-1}(-\delta) \cap\{g=0\} \cap W_{\varepsilon, r}\right) .
\end{gathered}
$$

We conclude remarking that:

$$
\begin{gathered}
\chi\left(f^{-1}([-\delta, \delta]) \cap W_{\varepsilon, r}\right)=\chi\left(f^{-1}([-\delta, \delta]) \cap X \cap\{g \leq 0\} \cap B_{\varepsilon}^{n}(p)\right)= \\
\chi\left(f^{-1}(0) \cap X \cap\{g \leq 0\} \cap B_{\varepsilon}^{n}(p)\right)=1 \\
\chi\left(f^{-1}(-\delta) \cap W_{\varepsilon, r}\right)=\chi\left(f^{-1}(-\delta) \cap X \cap\{g \leq 0\} \cap B_{\varepsilon}^{n}(p)\right) \\
\chi\left(f^{-1}([-\delta, \delta]) \cap\{g=0\} \cap W_{\varepsilon, r}\right)=\chi\left(f^{-1}([-\delta, \delta]) \cap X \cap\{g=0\} \cap B_{\varepsilon}^{n}(p)\right)=1
\end{gathered}
$$

and:

$$
\chi\left(f^{-1}(-\delta) \cap\{g=0\} \cap W_{\varepsilon, r}\right)=\chi\left(f^{-1}(-\delta) \cap X \cap\{g=0\} \cap B_{\varepsilon}^{n}(p)\right)
$$

if $r$ is sufficiently small.
If $\operatorname{dim} X=n$ then we apply the previous case to the semi-algebraic set $X \times\{0\} \subset \mathbb{R}^{n+1}$ and the functions $F$ and $G$ defined by $F(x, t)=f(x)+t$ and $G(x, t)=g(x)$, where $(x, t)$ is a coordinate system of $\mathbb{R}^{n+1}=\mathbb{R}^{n} \times \mathbb{R}$.

This lemma was inspired by results on indices of vector fields or 1-forms on stratified sets with boundary (see [KT] or [Sc, Chapter 5]).

Let $M \subset \mathbb{R}^{n}$ be a $C^{2}$ semi-algebraic manifold of dimension $k$. Let $f$ : $\mathbb{R}^{n} \rightarrow \mathbb{R}$ be a $C^{2}$ semi-algebraic function. Let $\Sigma_{f}^{M}$ be the critical set of $f_{\mid M}$. For any $a=\left(a_{1}, \ldots, a_{n}\right) \in \mathbb{R}^{n}$, we denote by $\rho_{a}$ the function $\rho_{a}(x)=$ $\frac{1}{2} \sum_{i=1}^{n}\left(x_{i}-a_{i}\right)^{2}$ and by $\Gamma_{f, a}^{M}$ the following semi-algebraic set:

$$
\Gamma_{f, a}^{M}=\left\{x \in M \mid \operatorname{rank}\left[\nabla\left(f_{\mid M}\right)(x), \nabla\left(\rho_{a \mid M}\right)(x)\right]<2\right\}
$$

Lemma 2.2. For almost all $a \in \mathbb{R}^{n}, \Gamma_{f, a}^{M} \backslash \Sigma_{f}^{M}$ is a smooth semi-algebraic curve (or empty).

Proof. Let $Z$ be the semi-algebraic set of $\mathbb{R}^{n} \times \mathbb{R}^{n}$ defined as follows:

$$
\begin{aligned}
& Z=\left\{(x, a) \in \mathbb{R}^{n} \times \mathbb{R}^{n} \mid x \in M \backslash \Sigma_{f}^{M}\right. \text { and } \\
&\left.\operatorname{rank}\left[\nabla\left(f_{\mid M}\right)(x), \nabla\left(\rho_{a \mid M}\right)(x)\right]<2\right\} .
\end{aligned}
$$

Let $(x, a)$ be a point in $Z$. We can suppose that around $x, M$ is defined by the vanishing of $l=n-k$ semi-algebraic functions $g_{1}, \ldots, g_{l}$ of class $C^{2}$. Hence in a neighborhood of $(x, a), Z$ is defined by the vanishing of $g_{1}, \ldots, g_{l}$ and the minors:

$$
\frac{\partial\left(g_{1}, \ldots, g_{l}, f, \rho_{a}\right)}{\partial\left(x_{i_{1}}, \ldots, x_{i_{l+2}}\right)}
$$

Furthermore since $x$ belongs to $M \backslash \Sigma_{f}^{M}$, we can assume that:

$$
\frac{\partial\left(g_{1}, \ldots, g_{l}, f\right)}{\partial\left(x_{1}, \ldots, x_{l}, x_{l+1}\right)}(x) \neq 0
$$

Therefore $Z$ is locally defined by $g_{1}=\ldots=g_{l}=0$ and:

$$
\frac{\partial\left(g_{1}, \ldots, g_{l}, f, \rho_{a}\right)}{\partial\left(x_{1}, \ldots, x_{l+1}, x_{l+2}\right)}=\cdots=\frac{\partial\left(g_{1}, \ldots, g_{l}, f, \rho_{a}\right)}{\partial\left(x_{1}, \ldots, x_{l+1}, x_{n}\right)}=0
$$

(see [Dut1,§5] for a proof of this fact). Since the gradient vectors of these functions are linearly independent, we see that $Z$ is a smooth semi-algebraic manifold of dimension $2 n-(l+n-(l+2)+1)=n+1$. Now let us consider the projection $\pi_{2}: Z \rightarrow \mathbb{R}^{n},(x, a) \mapsto a$. Bertini-Sard's theorem (see [BCR, Théorème 9.5.2]) implies that the set $D_{\pi_{2}}$ of critical values of $\pi_{2}$ is a semi-algebraic set of dimension strictly less than $n$. Hence, for all
$a \notin D_{\pi_{2}}, \pi_{2}^{-1}(a)$ is a smooth semi-algebraic curve (maybe empty). But this set is exactly $\Gamma_{f, a}^{M} \backslash \Sigma_{f}^{M}$.

Now consider a semi-algebraic set $Y \subset M$ of dimension strictly less than $k$. We will need the following lemma.
Lemma 2.3. For almost all $a \in \mathbb{R}^{n},\left(\Gamma_{f, a}^{M} \backslash \Sigma_{f}^{M}\right) \cap Y$ is a semi-algebraic set of dimension at most 0 .

Proof. Since $Y$ admits a finite Whitney semi-algebraic stratification, we can assume that $Y$ is smooth of dimension $d<k$. Let $W$ be the semialgebraic set of $\mathbb{R}^{n} \times \mathbb{R}^{n}$ defined by:

$$
\begin{aligned}
& W=\left\{(x, a) \in \mathbb{R}^{n} \times \mathbb{R}^{n} \mid x \in Y \backslash \Sigma_{f}^{M}\right. \text { and } \\
&\left.\operatorname{rank}\left[\nabla\left(f_{\mid M}\right)(x), \nabla\left(\rho_{a \mid M}\right)(x)\right]<2\right\} .
\end{aligned}
$$

Using the same method as in the previous lemma, we can prove that $W$ is a smooth semi-algebraic manifold of dimension $n+1+d-k$. We can conclude as in the previous lemma, remarking that $d-k \leq-1$.

## 3. Topology of semi-algebraic functions

For any closed semi-algebraic set equipped with a Whitney stratification $X=\sqcup_{\alpha \in A} S_{\alpha}$, we denote by $\operatorname{Lk}^{\infty}(X)$ the link at infinity of $X$. It is defined as follows. Let $\rho: \mathbb{R}^{n} \rightarrow \mathbb{R}$ be a $C^{2}$ proper semi-algebraic positive function. Since $\rho_{\mid X}$ is proper, the set of critical points of $\rho_{\mid X}$ (in the stratified sense) is compact. Hence for $R$ sufficiently big, the map $\rho: X \cap \rho^{-1}([R,+\infty[) \rightarrow \mathbb{R}$ is a stratified submersion. The link at infinity of $X$ is the fibre of this submersion. The topological type of $\operatorname{Lk}^{\infty}(X)$ does not depend on the choice of the function $\rho$. Indeed, if $\rho_{0}$ and $\rho_{1}: \mathbb{R}^{n} \rightarrow \mathbb{R}$ are two $C^{2}$ proper semialgebraic functions then $X \cap \rho_{0}^{-1}\left(R_{0}\right)$ and $X \cap \rho_{1}^{-1}\left(R_{1}\right)$ are homeomorphic for $R_{0}$ and $R_{1}$ big enough. To see this, we can apply the procedure described by Durfee in [Dur]. First we remark that, applying the Curve Selection Lemma at infinity [NZ, Lemma 2], for each stratum $S_{\alpha}$ of $X$, the gradient vector fields $\nabla\left(\rho_{0 \mid S_{\alpha}}\right)$ and $\nabla\left(\rho_{1 \mid S_{\alpha}}\right)$ do not point in opposite direction in a neighborhood of infinity. Next we choose $R_{0}$ and $R_{1}$ sufficiently big so that $\rho_{0}^{-1}\left(\left[R_{0},+\infty[) \subset \rho_{1}^{-1}\left(\left[R_{1},+\infty[)\right.\right.\right.\right.$ and all the gradient vector fields $\nabla\left(\rho_{0 \mid S_{\alpha}}\right)$ and $\nabla\left(\rho_{1 \mid S_{\alpha}}\right)$ do not point in opposite direction in $\rho_{0}^{-1}\left(\left[R_{0},+\infty[)\right.\right.$. Then the function $\rho:\left(\rho_{0}^{-1}\left(\left[R_{0},+\infty[) \backslash \rho_{1}^{-1}\left(\left[R_{1},+\infty[)\right) \cap X \rightarrow[0,1]\right.\right.\right.\right.$ defined by:

$$
\rho(x)=\frac{R_{1}-\rho_{1}(x)}{R_{1}-\rho_{1}(x)+\rho_{0}(x)-R_{0}},
$$

is a proper stratified submersion such that $\rho^{-1}(0)=X \cap \rho_{1}^{-1}\left(R_{1}\right)$ and $\rho^{-1}(1)=X \cap \rho_{0}^{-1}\left(R_{0}\right)$.

Let $f: \mathbb{R}^{n} \rightarrow \mathbb{R}$ be a $C^{2}$ semi-algebraic function such that $f_{\mid X}: X \rightarrow \mathbb{R}$ has a finite number of critical points (in the stratified sense) $p_{1}, \ldots, p_{l}$. For
each $p_{i}$, we define the index of $f_{\mid X}$ at $p_{i}$ as follows:

$$
\operatorname{ind}\left(f, X, p_{i}\right)=1-\chi\left(X \cap\left\{f=f\left(p_{i}\right)-\delta\right\} \cap B_{\varepsilon}^{n}\left(p_{i}\right)\right)
$$

where $0<\delta \ll \varepsilon \ll 1$. Since we are in the semi-algebraic setting, this index is well-defined thanks to Hardt's theorem [Ha]. The following theorem is well-known.

Theorem 3.1. If $f_{\mid X}$ is proper then for any $\alpha \in \mathbb{R}^{n}$, we have:

$$
\chi(X \cap\{f \geq \alpha\})-\chi(X \cap\{f=\alpha\})=\sum_{i: f\left(p_{i}\right)>\alpha} \operatorname{ind}\left(f, X, p_{i}\right)
$$

and:

$$
\chi(X \cap\{f \leq \alpha\})-\chi\left(\operatorname{Lk}^{\infty}(X \cap\{f \leq \alpha\})\right)=\sum_{i: f\left(p_{i}\right) \leq \alpha} \operatorname{ind}\left(f, X, p_{i}\right)
$$

Proof. We use Viro's method of integration with respect to the Euler characteristic with compact support, denoted by $\chi_{c}$.

For all $x \in X$, let $\varphi(x)=\chi_{c}\left(X \cap f^{-1}\left(x^{-}\right) \cap B_{\varepsilon}^{n}(x)\right)$ where $x^{-}$is a regular value of $f$ close to $f(x)$ with $x^{-} \leq f(x)$. Applying Fubini's theorem [Vi, Theorem 3.A] to the restriction of $f$ to $X \cap\{f>\alpha\}$, we get:

$$
\int_{X \cap\{f>\alpha\}} \varphi(x) d \chi_{c}(x)=\int_{] \alpha,+\infty[ }\left(\int_{f^{-1}(y)} \varphi(x) d \chi_{c}(x)\right) d \chi_{c}(y)
$$

For any $y \in \mathbb{R}$, let $y^{-}$be a regular value of $f_{\mid X}$ close to $y$ with $y^{-} \leq y$. Let us denote by $z_{1}, \ldots, z_{s}$ the critical points of $f_{\mid X}$ lying in $f^{-1}(y)$. We have:

$$
\begin{aligned}
& \begin{array}{l}
\chi_{c}\left(X \cap f^{-1}\left(y^{-}\right)\right)=\chi_{c}\left(X \cap f^{-1}\left(y^{-}\right) \backslash \cup_{i=1}^{s} B_{\varepsilon}^{n}\left(z_{i}\right)\right)+ \\
\sum_{i=1}^{s} \chi_{c}\left(X \cap f^{-1}\left(y^{-}\right) \cap B_{\varepsilon}^{n}\left(z_{i}\right)\right)= \\
\chi_{c}\left(X \cap f^{-1}(y) \backslash \cup_{i=1}^{s} B_{\varepsilon}^{n}\left(z_{i}\right)\right)+\sum_{i=1}^{s} \varphi\left(z_{i}\right)= \\
\chi_{c}\left(X \cap f^{-1}(y) \backslash\left\{z_{1}, \ldots, z_{s}\right\}\right)+\sum_{i=1}^{s} \varphi\left(z_{i}\right)= \\
\int_{X \cap f^{-1}(y) \backslash\left\{z_{1}, \ldots, z_{s}\right\}} \varphi(x) d \chi_{c}(x)+\sum_{i=1}^{s} \varphi\left(z_{i}\right)=\int_{f^{-1}(y)} \varphi(x) d \chi_{c}(x)
\end{array}
\end{aligned}
$$

Let us write:

$$
] \alpha,+\infty[=] \alpha, \alpha_{1}\right] \cup\right] \alpha_{1}, \alpha_{2}\right] \cup \ldots \cup\right] \alpha_{j-1}, \alpha_{j}\right] \cup\right] \alpha_{j},+\infty[
$$

where $\alpha_{1}, \ldots, \alpha_{j}$ are the critical values of $f_{\mid X}$ strictly greater than $\alpha$. Since $\left.\left.\chi_{c}(] \alpha_{k}, \alpha_{k+1}\right]\right)=0$ and $f_{\mid X \cap] \alpha_{k}, \alpha_{k+1}[ }$ is locally trivial, we obtain that:

$$
\int_{X \cap\{f>\alpha\}} \varphi(x) d \chi_{c}(x)=-\chi_{c}\left(X \cap f^{-1}(\beta)\right),
$$

where $\beta$ is a regular value of $f$ strictly greater than $\alpha_{j}$ and therefore:

$$
\chi_{c}(X \cap\{f>\alpha\})+\chi_{c}\left(X \cap f^{-1}(\beta)\right)=\sum_{i: f\left(p_{i}\right)>\alpha} \operatorname{ind}\left(f, X, p_{i}\right)
$$

Applying this equality to $\alpha=\beta$ and using the local triviality of $f_{\mid X}$ over $[\beta,+\infty[$, we get:

$$
\chi_{c}(X \cap\{f>\beta\})+\chi_{c}\left(X \cap f^{-1}(\beta)\right)=0
$$

Therefore:

$$
\begin{gathered}
\chi_{c}(X \cap\{f>\alpha\})+\chi_{c}\left(X \cap f^{-1}(\beta)\right)= \\
\chi_{c}(X \cap\{\alpha \leq f \leq \beta\})-\chi_{c}(X \cap\{f=\alpha\})-\chi_{c}(X \cap\{f>\beta\})+\chi_{c}\left(X \cap f^{-1}(\beta)\right)= \\
\chi(X \cap\{\alpha \leq f \leq \beta\})-\chi(X \cap\{f=\alpha\}) .
\end{gathered}
$$

To conclude, we remark that, since $f_{\mid X \cap\{f \geq \alpha\}}$ is proper and locally trivial over $[\beta,+\infty[, X \cap\{\alpha \leq f \leq \beta\}$ is a deformation retract of $X \cap\{\alpha \leq f\}$. The second equality is proved with the same method and the fact that $\chi_{c}(Y)=\chi(Y)-\chi\left(\mathrm{Lk}^{\infty}(Y)\right)$ for any closed semi-algebraic set $Y \subset \mathbb{R}^{n}$.

The following corollaries are straightforward consequences of the previous theorem.

Corollary 3.2. If $f_{\mid X}$ is proper then for any $\alpha \in \mathbb{R}$, we have:

$$
\chi(X \cap\{f=\alpha\})=\chi(X)-\sum_{i: f\left(p_{i}\right)>\alpha} \operatorname{ind}\left(f, X, p_{i}\right)-\sum_{i: f\left(p_{i}\right)<\alpha} \operatorname{ind}\left(-f, X, p_{i}\right)
$$

and:

$$
\begin{aligned}
& \chi(X \cap\{f \geq \alpha\})-\chi(X \cap\{f \leq \alpha\})=\sum_{i: f\left(p_{i}\right)>\alpha} \operatorname{ind}\left(f, X, p_{i}\right)- \\
& \sum_{i: f\left(p_{i}\right)<\alpha} \operatorname{ind}\left(f, X, p_{i}\right)
\end{aligned}
$$

Corollary 3.3. If $f_{\mid X}$ is proper then for any $\alpha \in \mathbb{R}^{n}$, we have :

$$
\chi\left(\operatorname{Lk}^{\infty}(X \cap\{f \leq \alpha\})\right)=\chi(X)-\sum_{i=1}^{l} \operatorname{ind}\left(f, X, p_{i}\right)
$$

Corollary 3.4. If $f_{\mid X}$ is proper then we have:

$$
2 \chi(X)-\chi\left(\operatorname{Lk}^{\infty}(X)\right)=\sum_{i=1}^{l} \operatorname{ind}\left(f, X, p_{i}\right)+\sum_{i=1}^{l} \operatorname{ind}\left(-f, X, p_{i}\right)
$$

Now we want to investigate the case when $f_{\mid X}$ is not proper. Keeping the notations of the previous section, for $a \in \mathbb{R}^{n}$, we define $\Gamma_{f, a}^{X}$ and $\Gamma_{f, a}$ by:

$$
\begin{gathered}
\Gamma_{f, a}^{X}=\left\{x \in X \mid \operatorname{rank}\left[\nabla\left(f_{\mid S}\right)(x), \nabla\left(\rho_{a \mid S}\right)(x)\right]<2\right. \\
\text { where } S \text { is the stratum that contains } x\} \\
\Gamma_{f, a}=\left\{x \in \mathbb{R}^{n} \mid \operatorname{rank}\left[\nabla f(x), \nabla \rho_{a}(x)\right]<2\right\}
\end{gathered}
$$

By Lemma 2.2, we can choose $a$ such that $\Gamma_{f, a}^{X}$ is a smooth semi-algebraic curve outside a compact set of $X$. Applying Lemma 2.3 to $M=\mathbb{R}^{n}$ and $Y$ the closed semi-algebraic set defined as the union of the strata of $X$ of dimension strictly less than $n$, we can choose $a$ such that $\Gamma_{f, a}^{X}$ and $\Gamma_{f, a}$ do not intersect outside a compact set of $Y$. Let us fix $\alpha \in \mathbb{R}$ and $R \gg 1$ such that:
(1) $X \cap B_{R}^{n}(a)$ is a deformation retract of $X$,
(2) $X \cap\{f * \alpha\} \cap B_{R}^{n}(a)$ is a deformation retract of $X \cap\{f * \alpha\}$ where $* \in\{\leq,=, \geq\}$,
(3) $S_{R}^{n-1}(a)$ intersects $X$ and $X \cap\{f * \alpha\}$ transversally,
(4) $\Gamma_{f, a}^{X} \cap S_{R}^{n-1}(a)$ is a finite set of points $q_{1}^{R}, \ldots, q_{m}^{R}$,
(5) $p_{1}, \ldots, p_{l} \in B_{R}^{n^{\circ}}(a)$.

For each $j \in\{1, \ldots, m\}, q_{j}^{R}$ is a critical point of $f_{\mid X \cap S_{R}^{n-1}(a)}$ but not a critical point of $f_{\mid X}$. Hence there exists $\mu_{j}^{R} \neq 0$ such that:

$$
\nabla\left(f_{\mid S}\right)\left(q_{j}^{R}\right)=\mu_{j}^{R} \nabla\left(\rho_{a \mid S}\right)\left(q_{j}^{R}\right)
$$

where $S$ is the stratum that contains $q_{j}^{R}$.
Definition 3.5. We set:

$$
\begin{aligned}
\lambda_{f, \alpha} & =\sum_{\substack{j: f\left(F_{j}^{R}\right)>\alpha \\
\mu_{j}^{R}<0}} \operatorname{ind}\left(f, X \cap S_{R}^{n-1}(a), q_{j}^{R}\right), \\
\mu_{f, \alpha} & =\sum_{\substack{j: f\left(q_{j}^{R}\right)<\alpha \\
\mu_{j}^{R}>0}} \operatorname{ind}\left(f, X \cap S_{R}^{n-1}(a), q_{j}^{R}\right), \\
\nu_{f, \alpha} & =\sum_{\substack{j: f\left(q_{j}^{R}\right)<\alpha \\
\mu_{j}^{R}<0}} \operatorname{ind}\left(f, X \cap S_{R}^{n-1}(a), q_{j}^{R}\right) .
\end{aligned}
$$

The fact that $\lambda_{f, \alpha}, \mu_{f, \alpha}$ and $\nu_{f, \alpha}$ do not depend on $R$ will appear in the next propositions. Let us remark that if $\mu_{j}^{R}<0$ then $f\left(q_{j}^{R}\right)$ decreases to $-\infty$ or to a finite value as $R$ tends to $+\infty$, and that if $\mu_{j}^{R}>0$ then $f\left(q_{j}^{R}\right)$ increases to $+\infty$ or to a finite value as $R$ tends to $+\infty$. This implies that when $f_{\mid X}$ is proper, the numbers $\lambda_{f, \alpha}$ and $\mu_{f, \alpha}$ vanish.

Proposition 3.6. For any $\alpha \in \mathbb{R}$, we have:

$$
\chi(X \cap\{f \geq \alpha\})-\chi(X \cap\{f=\alpha\})=\sum_{i: f\left(p_{i}\right)>\alpha} \operatorname{ind}\left(f, X, p_{i}\right)+\lambda_{f, \alpha}
$$

and:

$$
\chi(X \cap\{f \leq \alpha\})-\chi(X \cap\{f=\alpha\})=\sum_{i: f\left(p_{i}\right)<\alpha} \operatorname{ind}\left(-f, X, p_{i}\right)+\lambda_{-f,-\alpha}
$$

Proof. We apply Theorem 3.1 to $f_{\mid X \cap B_{R}^{n}(a)}$ and we get:

$$
\begin{aligned}
& \chi\left(X \cap B_{R}^{n}(a) \cap\{f \geq \alpha\}\right)-\chi\left(X \cap B_{R}^{n}(a) \cap\{f=\alpha\}\right)= \\
& \sum_{i: f\left(p_{i}\right)>\alpha} \operatorname{ind}\left(f, X, p_{i}\right)+\sum_{j: f\left(q_{j}^{R}\right)>\alpha} \operatorname{ind}\left(f, X \cap B_{R}^{n}(a), q_{j}^{R}\right),
\end{aligned}
$$

and:

$$
\begin{aligned}
& \chi\left(X \cap B_{R}^{n}(a) \cap\{f \leq \alpha\}\right)-\chi\left(X \cap B_{R}^{n}(a) \cap\{f=\alpha\}\right)= \\
& \sum_{i: f\left(p_{i}\right)<\alpha} \operatorname{ind}\left(-f, X, p_{i}\right)+\sum_{j: f\left(q_{j}^{R}\right)<\alpha} \operatorname{ind}\left(-f, X \cap B_{R}^{n}(a), q_{j}^{R}\right) .
\end{aligned}
$$

Since $\Gamma_{f, a}^{X}$ and $\Gamma_{f, a}$ do not intersect outside a compact set of $Y$, we can use Lemma 2.1 to evaluate $\operatorname{ind}\left(f, X \cap B_{R}^{n}(a), q_{j}^{R}\right)$ and $\operatorname{ind}\left(-f, X \cap B_{R}^{n}(a), q_{j}^{R}\right)$. Namely, if $\mu_{j}^{R}>0$ then we have:

$$
\operatorname{ind}\left(f, X \cap B_{R}^{n}(a), q_{j}^{R}\right)=0
$$

and:

$$
\operatorname{ind}\left(-f, X \cap B_{R}^{n}(a), q_{j}^{R}\right)=\operatorname{ind}\left(-f, X \cap S_{R}^{n-1}(a), q_{j}^{R}\right)
$$

If $\mu_{j}^{R}<0$ then we have:

$$
\operatorname{ind}\left(f, X \cap B_{R}^{n}(a), q_{j}^{R}\right)=\operatorname{ind}\left(f, X \cap S_{R}^{n-1}(a), q_{j}^{R}\right)
$$

and:

$$
\operatorname{ind}\left(-f, X \cap B_{R}^{n}(a), q_{j}^{R}\right)=0
$$

Moreover, by our choice on $R, \chi\left(X \cap B_{R}^{n}(a) \cap\{f * \alpha\}\right)=\chi(X \cap\{f * \alpha\})$ for $* \in\{\leq,=, \geq\}$.
Corollary 3.7. For any $\alpha \in \mathbb{R}$, we have:

$$
\begin{array}{r}
\chi(X \cap\{f=\alpha\})=\chi(X)-\sum_{i: f\left(p_{i}\right)>\alpha} \operatorname{ind}\left(f, X, p_{i}\right)-\sum_{i: f\left(p_{i}\right)<\alpha} \operatorname{ind}\left(-f, X, p_{i}\right) \\
-\lambda_{f, \alpha}-\lambda_{-f,-\alpha},
\end{array}
$$

and:

$$
\begin{aligned}
\chi(X \cap\{f \geq \alpha\})-\chi(X \cap\{f \leq \alpha\}) & =\sum_{i: f\left(p_{i}\right)>\alpha} \operatorname{ind}\left(f, X, p_{i}\right)+\lambda_{f, \alpha} \\
& -\sum_{i: f\left(p_{i}\right)>\alpha} \operatorname{ind}\left(f, X, p_{i}\right)-\lambda_{-f,-\alpha}
\end{aligned}
$$

It is also possible to write indices formulas for $\chi\left(\operatorname{Lk}^{\infty}(X \cap\{f * \alpha\})\right.$, $* \in\{\leq,=, \geq\}$.

Proposition 3.8. For any $\alpha \in \mathbb{R}$, we have:

$$
\begin{gathered}
\chi\left(\operatorname{Lk}^{\infty}(X \cap\{f \leq \alpha\})=\chi(X)-\sum_{i=1}^{l} \operatorname{ind}\left(f, X, p_{i}\right)-\lambda_{f, \alpha}+\mu_{f, \alpha},\right. \\
\chi\left(\operatorname{Lk}^{\infty}(X \cap\{f \geq \alpha\})=\chi(X)-\sum_{i=1}^{l} \operatorname{ind}\left(-f, X, p_{i}\right)-\lambda_{-f,-\alpha}+\mu_{-f,-\alpha} .\right.
\end{gathered}
$$

Proof. By Theorem 3.1 applied to $f_{\mid X \cap S_{R}^{n-1}(a)}$, we have:

$$
\chi\left(\operatorname{Lk}^{\infty}(X \cap\{f \leq \alpha\})=\mu_{f, \alpha}+\nu_{f, \alpha},\right.
$$

and, by Corollary 3.3 applied to $f_{\mid X \cap B_{R}^{n}(a)}$ and by Lemma 2.1:

$$
\chi(X)=\sum_{i=1}^{l} \operatorname{ind}\left(f, X, p_{i}\right)+\lambda_{f, \alpha}+\nu_{f, \alpha},
$$

because $f^{-1}(\alpha)$ intersect $X \cap S_{R}^{n-1}(a)$ transversally. Similarly, we can write:

$$
\chi\left(\operatorname{Lk}^{\infty}(X \cap\{f \geq \alpha\})=\mu_{-f,-\alpha}+\nu_{-f,-\alpha}\right.
$$

and:

$$
\chi(X)=\sum_{i=1}^{l} \operatorname{ind}\left(-f, X, p_{i}\right)+\lambda_{-f,-\alpha}+\nu_{-f,-\alpha} .
$$

Corollary 3.9. For any $\alpha \in \mathbb{R}$, we have:

$$
\begin{aligned}
\chi\left(\operatorname{Lk}^{\infty}(X \cap\{f=\right. & \alpha\})=2 \chi(X)-\chi\left(\operatorname{Lk}^{\infty}(X)\right)-\sum_{i=1}^{l} \operatorname{ind}\left(f, X, p_{i}\right) \\
& -\sum_{i=1}^{l} \operatorname{ind}\left(-f, X, p_{i}\right)-\lambda_{f, \alpha}+\mu_{f, \alpha}-\lambda_{-f,-\alpha}+\mu_{-f,-\alpha} .
\end{aligned}
$$

In the sequel, we will use these results to establish relations between $\chi(X)$, the indices of the critical points of $f_{\mid X}$ and $-f_{\mid X}$ and the variations of the Euler characteristics $\chi\left(\operatorname{Lk}^{\infty}(\{f * \alpha\})\right)$, where $* \in\{\leq,=, \geq\}$ and $\alpha \in \mathbb{R}$. We start with definitions.

Definition 3.10. Let $\Lambda_{f}$ be the following set:

$$
\Lambda_{f}=\left\{\alpha \in \mathbb{R} \mid \exists\left(x_{n}\right)_{n \in \mathbb{N}} \text { in } \Gamma_{f, a}^{X} \text { such that }\left\|x_{n}\right\| \rightarrow+\infty \text { and } f\left(x_{n}\right) \rightarrow \alpha\right\} .
$$

Since $\Gamma_{f, a}^{X}$ is a curve, $\Lambda_{f}$ is clearly a finite set. The set $\Lambda_{f}$ was introduced and studied by Tibar [Ti1] when $X=\mathbb{R}^{n}$ and $f: \mathbb{R}^{n} \rightarrow \mathbb{R}$ is a polynomial. Following his terminology, $\Lambda_{f}$ is the set of points $\alpha$ such that the fibre $f^{-1}(\alpha)$ is not $\rho_{a}$-regular.
Definition 3.11. Let $* \in\{\leq,=, \geq\}$. We define $\Lambda_{f}^{*} b y$ :
$\Lambda_{f}^{*}=\left\{\alpha \in \mathbb{R} \mid \beta \mapsto \chi\left(\operatorname{Lk}^{\infty}(X \cap\{f * \beta\})\right)\right.$ is not constant in a neighborhood of $\alpha\}$.
Lemma 3.12. The sets $\Lambda_{f}^{\leq}, \Lambda_{f}^{\bar{f}}$ and $\Lambda_{f}^{\geq}$are included in $\Lambda_{f}$.
Proof. If $\alpha$ does not belong to $\Lambda_{f}$ then we can find a small interval $]-\delta+\alpha, \alpha+\delta\left[\right.$ such that $\Gamma_{f, a}^{X}$ and $f^{-1}(]-\delta+\alpha, \alpha+\delta[) \cap X$ do not intersect outside a compact set of $X$. Then we can choose $R \gg 1$ such that for all $\beta \in]-\delta+\alpha, \alpha+\delta\left[, \operatorname{Lk}^{\infty}(X \cap\{f * \beta\})=X \cap\{f * \beta\} \cap S_{R}^{n-1}(a)\right.$. But $f$ has no critical point in $X \cap\{-\delta+\alpha<f<\alpha+\delta\} \cap S_{R}^{n-1}(a)$, so the Euler characteristics $\chi(X \cap\{f * \beta\})$ are constant in $]-\delta+\alpha, \alpha+\delta[$.

Corollary 3.13. The sets $\Lambda_{f}^{\leq}, \Lambda_{f}^{\overline{\bar{f}}}$ and $\Lambda_{\bar{f}}^{\geq}$are finite.

Lemma 3.14. We have: $\Lambda_{f}^{\overline{\bar{x}}} \subset \Lambda_{f}^{\leq} \cup \Lambda_{f}^{\geq}, \Lambda_{f}^{\leq} \subset \Lambda_{f}^{\overline{=}} \cup \Lambda_{f}^{\geq}, \Lambda_{f}^{\geq} \subset \Lambda_{f}^{\leq} \cup \Lambda_{f}^{\overline{\bar{\prime}}}$.
Proof. If $\alpha \notin \Lambda_{f}^{\leq} \cup \Lambda_{f}^{\geq}$, then $\beta \mapsto \chi\left(\operatorname{Lk}^{\infty}(X \cap\{f \leq \beta\})\right)$ and $\beta \mapsto$ $\chi\left(\operatorname{Lk}^{\infty}(X \cap\{f \geq \beta\})\right)$ are constant in an interval $]-\delta+\alpha, \alpha+\delta[$. By the Mayer-Vietoris sequence, $\beta \mapsto \chi\left(\operatorname{Lk}^{\infty}(X \cap\{f=\beta\})\right)$ is also constant in $]-\delta+\alpha, \alpha+\delta[$.

Corollary 3.15. We have: $\Lambda_{f}^{\leq} \cup \Lambda_{f}^{\geq}=\Lambda_{f}^{\leq} \cup \Lambda_{f}^{\overline{\bar{\prime}}}=\Lambda_{f}^{\overline{\bar{f}} \cup \Lambda_{f}^{\geq}}$.
Since $\Lambda_{f}^{\leq}$is finite, we can write $\Lambda_{f}^{\leq}=\left\{b_{1}, \ldots, b_{r}\right\}$ where $b_{1}<b_{2}<\ldots<b_{r}$ and:

On each connected component of $\mathbb{R} \backslash \Lambda_{f}^{\leq}$, the function $\beta \mapsto \chi\left(\operatorname{Lk}^{\infty}(X \cap\{f \leq\right.$ $\beta\}$ ) is constant. For each $j \in\{0, \ldots, r\}$, let $b_{j}^{+}$be an element of $] b_{j}, b_{j+1}[$ where $b_{0}=-\infty$ and $b_{r+1}=+\infty$.
Theorem 3.16. We have:

Proof. Assume first that $\Lambda_{f}=\Lambda_{f}^{\leq}$. Let us choose $R \gg 1$ such that $X \cap B_{R}^{n}(a)$ is a deformation retract of $X,\left\{p_{1}, \ldots, p_{l}\right\} \subset B_{R}^{n^{\circ}}(a)$ and:

Since $\mu_{j}^{R}<0$, the points $q_{j}^{R}$ lie in $\left\{f>b_{i}\right\}$. Let us choose $R \gg 1$ and $b_{i}^{+}$ close to $b_{i}$ in $] b_{i}, b_{i+1}[$ such that:

f\left(q_{j}^{R}\right) \rightarrow-\infty}} \operatorname{ind}\left(f, X \cap S_{R}^{n-1}(a), q_{j}^{R}\right) .
\end{aligned}

To get the final result, we just remark that if $b \notin \Lambda_{f}^{\leq}$then:

Let us write $\Lambda_{f}^{\overline{=}}=\left\{d_{1}, \ldots, d_{t}\right\}$ with $d_{1}<d_{2}<\ldots<d_{t}$ and:

By Hardt's theorem, we know that there is a finite subset $B(f)$ of $\mathbb{R}$ such that $f_{\mid X \cap f^{-1}(B(f))}$ is a semi-algebraic locally trivial fibration. Hence outside $B(f)$, the function $\beta \mapsto \chi(X \cap\{f=\beta\})$ is locally constant. In the sequel, we will give formulas relating the topology of $X$ and the variations of topology in the fibres of $f$. Let us set $\tilde{B}(f)=f\left(\left\{p_{1}, \ldots, p_{l}\right\}\right) \cup \Lambda_{f}^{\leq} \cup \Lambda_{f}^{\geq}$. This set is clearly finite.

Proposition 3.19. If $\alpha \notin \tilde{B}(f)$ then the following functions:

are constant in a neighborhood of $\alpha$.
Proof. We study the local behaviors of the numbers $\lambda_{f, \alpha}$ and $\mu_{f, \alpha}, \alpha \in \mathbb{R}$. We denote by $\alpha^{+}$(resp. $\alpha^{-}$) an element of $] \alpha,+\infty[$ (resp. ] $-\infty, \alpha[$ ) close to $\alpha$. If $R \gg 1$ is big enough and $\alpha^{+}$is close enough to $\alpha$ then in $S_{R}^{n-1}(a) \cap\{\alpha \leq$ $\left.f \leq \alpha^{+}\right\}$, there is no points $q_{j}^{R}$ such that $\nabla\left(f_{\mid S}\right)\left(q_{j}^{R}\right)=\mu_{j}^{R} \nabla\left(\rho_{a \mid S}\right)\left(q_{j}^{R}\right)$ with $\mu_{j}^{R}>0$ because $f\left(q_{j}^{R}\right)$ decreases to $\alpha$ as $R$ tends to infinity. Hence if $\alpha^{+}$ is close enough to $\alpha$ then $\mu_{f, \alpha^{+}}=\mu_{f, \alpha}$. In the same way, we can show that $\lambda_{f, \alpha^{-}}=\lambda_{f, \alpha}$. Applying this argument to $-f$ and $-\alpha$, we see that $\lambda_{-f,-\alpha^{+}}=\lambda_{-f,-\alpha}$ and $\mu_{-f,-\alpha^{-}}=\mu_{-f,-\alpha}$. If $\alpha \notin \tilde{B}(f)$ then, by Proposition $3.8, \lambda_{f, \alpha^{+}}=\lambda_{f, \alpha}, \mu_{f, \alpha^{-}}=\mu_{f, \alpha}, \lambda_{-f,-\alpha^{-}}=\lambda_{f,-\alpha}$ and $\mu_{-f,-\alpha^{+}}=\mu_{-f,-\alpha}$. The formulas established in Proposition 3.6 and Corollary 3.7 enable us to conclude.

Let us write $\tilde{B}(f)=\left\{\gamma_{1}, \ldots, \gamma_{u}\right\}$ and:

Proof. Let us assume first that $\tilde{B}(f)=f\left(\left\{p_{1}, \ldots, p_{l}\right\}\right) \cup \Lambda_{f}$, i.e that $\Lambda_{f}^{\leq} \cup \Lambda_{f}^{\geq}=\Lambda_{f}$. For $k \in\{1, \ldots, u\}$, we have by Corollary 3.7:

\lambda_{f, \gamma_{k}^{+}}-\lambda_{-f,-\gamma_{k}^{+}},
\end{array}
\end{gathered}

hence:

because as already noticed, $\lambda_{-f,-\gamma_{k}^{+}}=\lambda_{-f,-\gamma_{k}}$. If $\gamma_{k}$ does not belong to $\Lambda_{f}$ then $\lambda_{f, \gamma_{k}^{+}}=\lambda_{f, \gamma_{k}}$. If $\gamma_{k}$ belongs to $\Lambda_{f}$ then:

Combining these equalities, we get the result when $\tilde{B}_{f}=\Lambda_{f} \cup f\left(\left\{p_{1}, \ldots, p_{l}\right\}\right)$. But if $\gamma \notin \Lambda_{f}^{\leq} \cup \Lambda_{f}^{\geq} \cup f\left(\Sigma_{f_{\mid X}}\right)$ then $\chi\left(X \cap\left\{f=\gamma^{+}\right\}\right)-\chi(X \cap\{f=\gamma\})=0$.

& \chi(X)=\sum_{i=1}^{l} \operatorname{ind}\left(-f, X, p_{i}\right)+\sum_{k=0}^{u} \chi\left(X \cap\left\{f \geq \gamma_{k}^{+}\right\}\right)-\sum_{k=1}^{u} \chi\left(X \cap\left\{f \geq \gamma_{k}\right\}\right) .
\end{aligned}
$$

Proof. We prove the first equality in the case $\tilde{B}(f)=f\left(\left\{p_{1}, \ldots, p_{l}\right\}\right) \cup \Lambda_{f}$. For $k \in\{1, \ldots, u\}$, we have by Proposition 3.6:

$$
\begin{gathered}
\chi\left(X \cap\left\{f \leq \gamma_{k}\right\}\right)-\chi\left(X \cap\left\{f=\gamma_{k}\right\}\right)=\sum_{i: f\left(p_{i}\right)<\gamma_{k}} \operatorname{ind}\left(-f, X, p_{i}\right)+\lambda_{-f,-\gamma_{k}}, \\
\chi\left(X \cap\left\{f \leq \gamma_{k}^{+}\right\}\right)-\chi\left(X \cap\left\{f=\gamma_{k}^{+}\right\}\right)=\sum_{i: f\left(p_{i}\right)<\gamma_{k}^{+}} \operatorname{ind}\left(-f, X, p_{i}\right)+\lambda_{-f,-\gamma_{k}^{+}} .
\end{gathered}
$$

Hence,

$$
\begin{aligned}
& {\left[\chi\left(X \cap\left\{f \leq \gamma_{k}^{+}\right\}\right)-\chi\left(X \cap\left\{f \leq \gamma_{k}\right\}\right)\right]-} \\
& \quad\left[\chi\left(X \cap\left\{f=\gamma_{k}^{+}\right\}\right)-\chi\left(X \cap\left\{f=\gamma_{k}\right\}\right)\right]=\sum_{i: f\left(p_{i}\right)=\gamma_{k}} \operatorname{ind}\left(-f, X, p_{i}\right),
\end{aligned}
$$

so:

$$
\begin{aligned}
& \sum_{k=1}^{u}\left[\chi\left(X \cap\left\{f \leq \gamma_{k}^{+}\right\}\right)-\chi\left(X \cap\left\{f \leq \gamma_{k}\right\}\right)\right]- \\
& \quad \sum_{k=1}^{u}\left[\chi\left(X \cap\left\{f=\gamma_{k}^{+}\right\}\right)-\chi\left(X \cap\left\{f=\gamma_{k}\right\}\right)\right]=\sum_{i=1}^{l} \operatorname{ind}\left(-f, X, p_{i}\right) .
\end{aligned}
$$

But, we remark that $\chi\left(X \cap\left\{f \leq \gamma_{0}^{+}\right\}\right)=\chi\left(X \cap\left\{f=\gamma_{0}^{+}\right\}\right)$because $\lambda_{-f,-\gamma_{0}^{+}}=0$, which implies that:

$$
\begin{aligned}
& \sum_{k=0}^{u} \chi\left(X \cap\left\{f \leq \gamma_{k}^{+}\right\}\right)-\sum_{k=1}^{u} \chi\left(X \cap\left\{f \leq \gamma_{k}\right\}\right)= \\
& \sum_{k=0}^{u} \chi\left(X \cap\left\{f=\gamma_{k}^{+}\right\}\right)-\sum_{k=1}^{u} \chi\left(X \cap\left\{f=\gamma_{k}\right\}\right)+\sum_{i=1}^{l} \operatorname{ind}\left(-f, X, p_{i}\right)= \\
& \chi(X)-\sum_{i=1}^{l} \operatorname{ind}\left(f, X, p_{i}\right) .
\end{aligned}
$$

Corollary 3.22. We have:

$$
\begin{aligned}
& \sum_{k=0}^{u} \chi\left(X \cap\left\{f \geq \gamma_{k}^{+}\right\}\right)-\chi\left(X \cap\left\{f \leq \gamma_{k}^{+}\right\}\right) \\
& \quad-\sum_{k=1}^{u} \chi\left(X \cap\left\{f \geq \gamma_{k}\right\}\right)-\chi\left(X \cap\left\{f \leq \gamma_{k}\right\}\right)= \\
& \quad \sum_{i=1}^{l} \operatorname{ind}\left(f, X, p_{i}\right)-\operatorname{ind}\left(-f, X, p_{i}\right)
\end{aligned}
$$

## 4. CASE $X=\mathbb{R}^{n}$

In this section, we apply our previous results to the case $X=\mathbb{R}^{n}$. In this case $\operatorname{ind}\left(f, X, p_{i}\right)=(-1)^{n} \operatorname{ind}\left(-f, X, p_{i}\right)=\operatorname{deg}_{p_{i}} \nabla f$, the local degree of $\nabla f$ at $p_{i}$ and $\sum_{i=1}^{l} \operatorname{ind}\left(f, X, p_{i}\right)=\operatorname{deg}_{\infty} \nabla f$, the degree of $\nabla f$ at infinity, i.e the topological degree of $\frac{\nabla f}{|\nabla f|}: S_{R}^{n-1} \rightarrow S^{n-1}$ where $S_{R}^{n-1}$ is a sphere of big radius $R$. Furthermore, $\mu_{f, \alpha}=(-1)^{n-1} \lambda_{-f,-\alpha}$ and $\mu_{-f,-\alpha}=(-1)^{n-1} \lambda_{f, \alpha}$. We can restate our result in this setting.
Proposition 4.1. For all $\alpha \in \mathbb{R}$, we have:

$$
\begin{gathered}
\chi(\{f \geq \alpha\})-\chi(\{f=\alpha\})=\sum_{i: f\left(p_{i}\right)>\alpha} \operatorname{deg}_{p_{i}} \nabla f+\lambda_{f, \alpha}, \\
\chi(\{f \leq \alpha\})-\chi(\{f=\alpha\})=(-1)^{n} \sum_{i: f\left(p_{i}\right)<\alpha} \operatorname{deg}_{p_{i}} \nabla f+(-1)^{n-1} \mu_{f, \alpha} .
\end{gathered}
$$

Corollary 4.2. If $n$ is even then for all $\alpha \in \mathbb{R}$, we have:

$$
\begin{gathered}
\chi(\{f=\alpha\})=1-\sum_{i: f\left(p_{i}\right) \neq \alpha} \operatorname{deg}_{p_{i}} \nabla f-\lambda_{f, \alpha}+\mu_{f, \alpha} \\
\chi(\{f \geq \alpha\})-\chi(\{f \leq \alpha\})=\sum_{i: f\left(p_{i}\right)>\alpha} \operatorname{deg}_{p_{i}} \nabla f-\sum_{i: f\left(p_{i}\right)<\alpha} \operatorname{deg}_{p_{i}} \nabla f+\lambda_{f, \alpha}+\mu_{f, \alpha}
\end{gathered}
$$

If $n$ is odd then for all $\alpha \in \mathbb{R}$, we have:

$$
\begin{gathered}
\chi(\{f=\alpha\})=1-\sum_{i: f\left(p_{i}\right)>\alpha} \operatorname{deg}_{p_{i}} \nabla f+\sum_{i: f\left(p_{i}\right)<\alpha} \operatorname{deg}_{p_{i}} \nabla f-\lambda_{f, \alpha}+\mu_{f, \alpha} \\
\chi(\{f \geq \alpha\})-\chi(\{f \leq \alpha\})=\sum_{i: f\left(p_{i}\right) \neq \alpha} \operatorname{deg}_{p_{i}} \nabla f+\lambda_{f, \alpha}+\mu_{f, \alpha}
\end{gathered}
$$

The above formulas can be viewed as real versions of results on the topology of the fibres of a complex polynomial (see for instance $[\mathrm{Pa}]$ or $[\mathrm{ST}]$ ).

Proposition 4.3. If $n$ is even then, for all $\alpha \in \mathbb{R}$, we have:

$$
\begin{gathered}
\chi\left(\operatorname{Lk}^{\infty}(\{f \leq \alpha\})\right)=\chi\left(\operatorname{Lk}^{\infty}(\{f \geq \alpha\})\right)=1-\operatorname{deg}_{\infty} \nabla f-\lambda_{f, \alpha}+\mu_{f, \alpha}, \\
\chi\left(\operatorname{Lk}^{\infty}(\{f=\alpha\})\right)=2-2 \operatorname{deg}_{\infty} \nabla f-2 \lambda_{f, \alpha}+2 \mu_{f, \alpha} .
\end{gathered}
$$

If $n$ is odd then, for all $\alpha \in \mathbb{R}$, we have:

$$
\begin{aligned}
& \chi\left(\operatorname{Lk}^{\infty}(\{f \leq \alpha\})\right)=1-\operatorname{deg}_{\infty} \nabla f-\lambda_{f, \alpha}+\mu_{f, \alpha}, \\
& \chi\left(\operatorname{Lk}^{\infty}(\{f \geq \alpha\})\right)=1+\operatorname{deg}_{\infty} \nabla f+\lambda_{f, \alpha}-\mu_{f, \alpha} .
\end{aligned}
$$

We also obtain generalizations of Sekalski's formula [Se]. We keep the notations introduced in the general case.

Theorem 4.4. We have:

$$
\begin{aligned}
& 1=\operatorname{deg}_{\infty} \nabla f+\sum_{i=0}^{r} \chi\left(\operatorname{Lk}^{\infty}\left(\left\{f \leq b_{i}^{+}\right\}\right)\right)-\sum_{i=1}^{r} \chi\left(\operatorname{Lk}^{\infty}\left(\left\{f \leq b_{i}\right\}\right)\right)= \\
& (-1)^{n} \operatorname{deg}_{\infty} \nabla f+\sum_{i=0}^{s} \chi\left(\operatorname{Lk}^{\infty}\left(\left\{f \geq c_{i}^{+}\right\}\right)\right)-\sum_{i=1}^{s} \chi\left(\operatorname{Lk}^{\infty}\left(\left\{f \geq c_{i}\right\}\right)\right) .
\end{aligned}
$$

If $n$ is even then we have:

$$
2=2 \operatorname{deg}_{\infty} \nabla f+\sum_{i=0}^{t} \chi\left(\operatorname{Lk}^{\infty}\left(\left\{f=d_{i}^{+}\right\}\right)\right)-\sum_{i=1}^{t} \chi\left(\operatorname{Lk}^{\infty}\left(\left\{f=d_{i}\right\}\right)\right) .
$$

Theorem 4.5. If $n$ is even, we have:

$$
\begin{gathered}
1=2 \operatorname{deg}_{\infty} \nabla f+\sum_{k=0}^{u} \chi\left(\left\{f=\gamma_{k}^{+}\right\}\right)-\sum_{k=1}^{u} \chi\left(\left\{f=\gamma_{k}\right\}\right), \\
1=\operatorname{deg}_{\infty} \nabla f+\sum_{k=0}^{u} \chi\left(\left\{f \leq \gamma_{k}^{+}\right\}\right)-\sum_{k=1}^{u} \chi\left(\left\{f \leq \gamma_{k}\right\}\right), \\
1=\operatorname{deg}_{\infty} \nabla f+\sum_{k=0}^{u} \chi\left(\left\{f \geq \gamma_{k}^{+}\right\}\right)-\sum_{k=1}^{u} \chi\left(\left\{f \geq \gamma_{k}\right\}\right), \\
\sum_{k=0}^{u} \chi\left(\left\{f \geq \gamma_{k}^{+}\right\}\right)-\chi\left(\left\{f \leq \gamma_{k}^{+}\right\}\right)=\sum_{k=1}^{u} \chi\left(\left\{f \geq \gamma_{k}\right\}\right)-\chi\left(\left\{f \leq \gamma_{k}\right\}\right) .
\end{gathered}
$$

If $n$ is odd, we have:

$$
\begin{gathered}
1=\sum_{k=0}^{u} \chi\left(\left\{f=\gamma_{k}^{+}\right\}\right)-\sum_{k=1}^{u} \chi\left(\left\{f=\gamma_{k}\right\}\right) \\
1=\operatorname{deg}_{\infty} \nabla f+\sum_{k=0}^{u} \chi\left(\left\{f \leq \gamma_{k}^{+}\right\}\right)-\sum_{k=1}^{u} \chi\left(\left\{f \leq \gamma_{k}\right\}\right)
\end{gathered}
$$

$$
\begin{gathered}
1=-\operatorname{deg}_{\infty} \nabla f+\sum_{k=0}^{u} \chi\left(\left\{f \geq \gamma_{k}^{+}\right\}\right)-\sum_{k=1}^{u} \chi\left(\left\{f \geq \gamma_{k}\right\}\right) \\
\sum_{k=0}^{u} \chi\left(\left\{f \geq \gamma_{k}^{+}\right\}\right)-\chi\left(\left\{f \leq \gamma_{k}^{+}\right\}\right)=\sum_{k=1}^{u} \chi\left(\left\{f \geq \gamma_{k}\right\}\right)-\chi\left(\left\{f \leq \gamma_{k}\right\}\right) \\
\\
+2 \operatorname{deg}_{\infty} \nabla f .
\end{gathered}
$$

## 5. Application to generic Linear functions

We apply the results of Section 3 to the case of a generic linear function. Let $X \subset \mathbb{R}^{n}$ be a closed semi-algebraic set. For $v \in S^{n-1}$, let us denote by $v^{*}$ the function $v^{*}(x)=\langle v, x\rangle$. We are going to study the critical points of $v_{\mid X \cap S_{R}^{n-1}(a)}^{*}$ for $v$ generic and $R$ sufficiently big.

Let $\Gamma_{1}(X)$ be the subset of $S^{n-1}$ defined as follows: a vector $v$ belongs to $\Gamma_{1}(X)$ if there exists a sequence $\left(x_{k}\right)_{k \in \mathbb{N}}$ such that $\left\|x_{k}\right\| \rightarrow+\infty$ and a sequence $\left(v_{k}\right)_{k \in \mathbb{N}}$ of vectors in $S^{n-1}$ such that $v_{k} \perp T_{x_{k}} S\left(x_{k}\right)$ and $v_{k} \rightarrow v$, where $S\left(x_{k}\right)$ is the stratum containing $x_{k}$.
Lemma 5.1. The set $\Gamma_{1}(X)$ is a semi-algebraic set of $S^{n-1}$ of dimension strictly less than $n-1$.

Proof. If we write $X=\sqcup_{\alpha \in A} S_{\alpha}$, where $\left(S_{\alpha}\right)_{\alpha \in A}$ is a finite semi-algebraic Whitney stratification of $X$, then we see that $\Gamma_{1}(X)=\sqcup_{\alpha \in A} \Gamma_{1}\left(S_{\alpha}\right)$. Hence it is enough to prove the lemma when $X$ is a smooth semi-algebraic manifold of dimension $n-k, 0<k<n$.

Let us take $x=\left(x_{1}, \ldots, x_{n}\right)$ as a coordinate system for $\mathbb{R}^{n}$ and $\left(x_{0}, x\right)$ for $\mathbb{R}^{n+1}$. Let $\varphi$ be the semi-algebraic diffeomorphism between $\mathbb{R}^{n}$ and $S^{n} \cap\left\{x_{0}>0\right\}$ given by:

$$
\varphi(x)=\left(\frac{1}{\sqrt{1+\|x\|^{2}}}, \frac{x_{1}}{\sqrt{1+\|x\|^{2}}}, \ldots, \frac{x_{n}}{\sqrt{1+\|x\|^{2}}}\right)
$$

Observe that $\left(x_{0}, x\right)=\varphi(z)$ if and only if $z=\frac{x}{x_{0}}$. The set $\varphi(X)$ is a smooth semi-algebraic set of dimension $n-k$. Let $M$ be the following semi-algebraic set:

$$
M=\left\{\left(x_{0}, x, y\right) \in \mathbb{R}^{n+1} \times \mathbb{R}^{n} \mid\left(x_{0}, x\right) \in \varphi(X) \text { and } y \perp T_{\frac{x}{x_{0}}} X\right\}
$$

We will show that $M$ is a smooth manifold of dimension $n$. Let $p=\left(x_{0}, x, y\right)$ be a point in $M$ and let $z=\varphi^{-1}\left(x_{0}, x\right)=\frac{x}{x_{0}}$. In a neighborhood of $z, X$ is defined by the vanishing of smooth functions $g_{1}, \ldots, g_{k}$. For $i \in\{1, \ldots, k\}$, let $G_{i}$ be the smooth function defined by:

$$
G_{i}\left(x_{0}, x\right)=g_{i}\left(\frac{x}{x_{0}}\right)=g_{i}\left(\varphi^{-1}\left(x_{0}, x\right)\right)
$$

Then in a neighborhood of $\left(x_{0}, x\right), \varphi(X)$ is defined by the vanishing of $G_{1}, \ldots, G_{k}$ and $x_{0}^{2}+x_{1}^{2}+\cdots+x_{n}^{2}-1$. Note that for $i, k \in\{1, \ldots, n\}^{2}$, $\frac{\partial G_{i}}{\partial x_{k}}\left(x_{0}, x\right)=\frac{1}{x_{0}} \frac{\partial g_{i}}{\partial x_{k}}(x)$. Hence in a neighborhood of $p, M$ is defined by the vanishing of $G_{1}, \ldots, G_{k}, x_{0}^{2}+x_{1}^{2}+\cdots+x_{n}^{2}-1$ and the following minors $m_{i_{1} i_{2} \ldots i_{k+1}},\left(i_{1}, \ldots, i_{k+1}\right) \in\{1, \ldots, n\}^{k+1}$, given by:

$$
m_{i_{1} i_{2} \ldots i_{k+1}}\left(x_{0}, x, y\right)=\left|\begin{array}{ccc}
\frac{\partial G_{1}}{\partial x_{i_{1}}}\left(x_{0}, x\right) & \cdots & \frac{\partial G_{1}}{\partial x_{i_{k+1}}}\left(x_{0}, x\right) \\
\vdots & \ddots & \vdots \\
\frac{\partial G_{k}}{\partial x_{i_{1}}}\left(x_{0}, x\right) & \cdots & \frac{\partial G_{k}}{\partial x_{i_{k+1}}}\left(x_{0}, x\right) \\
y_{i_{1}} & \cdots & y_{i_{k+1}}
\end{array}\right|
$$

Since $\operatorname{rank}\left(\nabla g_{1}, \ldots, \nabla g_{k}\right)=k$ at $z=\varphi^{-1}\left(x_{0}, x\right)$, one can assume that:

$$
\left|\begin{array}{ccc}
\frac{\partial G_{1}}{\partial x_{1}}\left(x_{0}, x\right) & \cdots & \frac{\partial G_{1}}{\partial x_{k}}\left(x_{0}, x\right) \\
\vdots & \ddots & \vdots \\
\frac{\partial G_{k}}{\partial x_{1}}\left(x_{0}, x\right) & \cdots & \frac{\partial G_{k}}{\partial x_{k}}\left(x_{0}, x\right)
\end{array}\right| \neq 0
$$

This implies that around $p, M$ is defined by the vanishing of $G_{1}, \ldots, G_{k}$, $m_{1 \ldots k k+1}, \ldots, m_{1 \ldots k n}$ and $x_{0}^{2}+x_{1}^{2}+\cdots+x_{n}^{2}-1$ (a similar argument is given and proved in [Dut1, $\S 5]$ ). It is straightforward to see that the gradient vectors of these functions are linearly independent. Then $\bar{M} \backslash M$ is a semi-algebraic set of dimension less than $n$. If $\pi_{y}: \mathbb{R}^{n+1} \times \mathbb{R}^{n} \rightarrow \mathbb{R}^{n}$ denotes the projection on the last $n$ coordinates, then we have $\Gamma_{1}(X)=S^{n-1} \cap \pi_{y}(\bar{M} \backslash M)$.

Corollary 5.2. Let $v$ be vector in $S^{n-1}$ and let $a \in \mathbb{R}^{n}$. If there exists a sequence $\left(x_{k}\right)_{k \in \mathbb{N}}$ of points in $X$ such that:

- $\left\|x_{k}\right\| \rightarrow+\infty$,
- $v \in N_{x_{k}} S\left(x_{k}\right) \oplus \mathbb{R}\left(x_{k}-a\right)$,
- $\lim _{k \rightarrow+\infty}\left|v^{*}\left(x_{k}\right)\right|<+\infty$,
then $v$ belongs to $\Gamma_{1}(X)$ (Here $N_{x_{k}} S\left(x_{k}\right)$ is the normal space to the stratum $S\left(x_{k}\right)$ ).

Proof. We can assume that $v=e_{1}=(1,0, \ldots, 0)$. In this case, $v^{*}=x_{1}$. Since the stratification is finite, we can assume that $\left(x_{k}\right)_{k \in \mathbb{N}}$ is a sequence of points lying in a stratum $S$. By the Curve Selection Lemma at infinity, there exists an analytic curve $p(t):] 0, \varepsilon\left[\rightarrow S\right.$ such that $\lim _{t \rightarrow 0}\|p(t)\|=+\infty$, $\lim _{t \rightarrow 0} p_{1}(t)<+\infty$ and for $\left.t \in\right] 0, \varepsilon\left[, e_{1}\right.$ belongs to the space $N_{p(t)} S \oplus \mathbb{R}(p(t)-$ $a)$. Let us consider the expansions as Laurent series of the $p_{i}$ 's:

$$
p_{i}(t)=h_{i} t^{\alpha_{i}}+\cdots, i=1, \ldots, n
$$

Let $\alpha$ be the minimum of the $\alpha_{i}$ 's. Necessarily, $\alpha<0$ and $\alpha_{1} \geq 0$. It is straightforward to see that $\|p(t)-a\|$ has an expansion of the form:

$$
\|p(t)-a\|=b t^{\alpha}+\cdots, b>0
$$

Let us denote by $\pi_{t}$ the orthogonal projection onto $T_{p(t)} S$. For every $\left.t \in\right] 0, \varepsilon[$, there exists a real number $\lambda(t)$ such that:

$$
\pi_{t}\left(e_{1}\right)=\lambda(t) \pi_{t}(p(t)-a)=\lambda(t)\left\|\pi_{t}(p(t)-a)\right\| \frac{\pi_{t}(p(t)-a)}{\left\|\pi_{t}(p(t)-a)\right\|}
$$

Observe that if $t$ is small enough, we can assume that $\pi_{t}(p(t)-a)$ does not vanish because $S_{\|p(t)-a\|}(a)$ intersects $S$ transversally. Using the fact that $p^{\prime}(t)$ is tangent to $S$ at $p(t)$, we find that:

$$
p_{1}^{\prime}(t)=\left\langle p^{\prime}(t), e_{1}\right\rangle=\left\langle p^{\prime}(t), \pi_{t}\left(e_{1}\right)\right\rangle=\lambda(t)\left\langle p^{\prime}(t), p(t)-a\right\rangle .
$$

This implies that $\operatorname{ord}(\lambda) \geq \alpha_{1}-2 \alpha$. Let $\beta$ be the order of $\left\|\pi_{t}(p-a)\right\|$. Since $\|p(t)-a\| \geq\left\|\pi_{t}(p(t)-a)\right\|, \beta$ is greater or equal to $\alpha$. Finally we obtain that ord $\left(\lambda\left\|\pi_{t}(p(t)-a)\right\|\right)$ is greater or equal to $\alpha_{1}-2 \alpha+\beta$, which is strictly positive. This proves the lemma.

Lemma 5.3. There exists a semi-algebraic set $\Gamma_{2}(X) \subset S^{n-1}$ of dimension strictly less than $n-1$ such that if $v \notin \Gamma_{2}(X)$, then $v_{\mid X}^{*}$ has a finite number of critical points.

Proof. It is enough to prove the lemma for a semi-algebraic stratum $S$ of dimension $s<n$. Let $N_{S}$ be the following semi-algebraic set:

$$
N_{S}=\left\{(x, y) \in \mathbb{R}^{n} \times \mathbb{R}^{n} \mid x \in S \text { and } y \perp T_{x} S\right\} .
$$

Using the same kind of arguments as in Lemmas 2.2, 2.3, and 5.1, we see that $N_{S}$ is a smooth semi-algebraic manifold of dimension $n$. Let

$$
\begin{array}{rlll}
\pi_{y}: & N_{S} & \rightarrow \mathbb{R}^{n} \\
(x, y) & \mapsto y
\end{array}
$$

be the projection onto the last $n$ coordinates. The Bertini-Sard theorem implies that the set $D_{\pi_{y}}$ of critical values of $\pi_{y}$ is semi-algebraic of dimension strictly less than $n$. We take $\Gamma_{2}(X)=S^{n-1} \cap D_{\pi_{y}}$.

Let us set $\Gamma(X)=\Gamma_{1}(X) \cup \Gamma_{2}(X)$, it is a semi-algebraic set of $S^{n-1}$ of dimension strictly less than $n-1$. If $v \notin \Gamma(X)$ then $v_{\mid X}^{*}$ admits a finite number of critical points $p_{1}, \ldots, p_{l}$. Moreover, if there is a family of points $q_{j}^{R}$ in $S \cap S_{R}^{n-1}(a)$ such that $\nabla v_{\mid S}^{*}\left(q_{j}^{R}\right)=\mu_{j}^{R} \nabla \rho_{a \mid S}\left(q_{j}^{R}\right)$, where $S$ is a stratum of $X$, and $\mu_{j}^{R}<0$ then $v^{*}\left(q_{j}^{R}\right) \rightarrow-\infty$ because $v \notin \Gamma_{1}$. Similarly if $\mu_{j}^{R}>0$ then $v^{*}\left(q_{j}^{R}\right) \rightarrow+\infty$. We conclude that the set $\Lambda_{v^{*}}$ is empty and that for all $\alpha \in \mathbb{R}$ :

$$
\lambda_{v^{*}, \alpha}=\mu_{v^{*}, \alpha}=\lambda_{-v^{*},-\alpha}=\mu_{-v^{*},-\alpha}=0 .
$$

Hence, we can restate the results of Section 3 in this setting and get relations between the topology of $X$ and the topology of generic hyperplane sections of $X$ (see [Ti2] for similar relations in the complex setting).

Proposition 5.4. If $v \notin \Gamma(X)$ then for all $\alpha \in \mathbb{R}$, we have:

$$
\chi\left(X \cap\left\{v^{*} \geq \alpha\right\}\right)-\chi\left(X \cap\left\{v^{*}=\alpha\right\}\right)=\sum_{i: v^{*}\left(p_{i}\right)>\alpha} \operatorname{ind}\left(v^{*}, X, p_{i}\right),
$$

$$
\begin{gathered}
\chi\left(X \cap\left\{v^{*} \leq \alpha\right\}\right)-\chi\left(X \cap\left\{v^{*}=\alpha\right\}\right)=\sum_{i: v^{*}\left(p_{i}\right)<\alpha} \operatorname{ind}\left(-v^{*}, X, p_{i}\right), \\
\chi\left(X \cap\left\{v^{*}=\alpha\right\}\right)=\chi(X)-\sum_{i: v^{*}\left(p_{i}\right)>\alpha} \operatorname{ind}\left(v^{*}, X, p_{i}\right)-\sum_{i: v^{*}\left(p_{i}\right)<\alpha} \operatorname{ind}\left(-v^{*}, X, p_{i}\right), \\
\chi\left(X \cap\left\{v^{*} \geq \alpha\right\}\right)-\chi\left(X \cap\left\{v^{*} \leq \alpha\right\}\right)= \\
\sum_{i: v^{*}\left(p_{i}\right)>\alpha} \operatorname{ind}\left(v^{*}, X, p_{i}\right)-\sum_{i: v^{*}\left(p_{i}\right)<\alpha} \operatorname{ind}\left(-v^{*}, X, p_{i}\right) .
\end{gathered}
$$

Proposition 5.5. If $v \notin \Gamma(X)$ then for all $\alpha \in \mathbb{R}$, we have:

$$
\begin{array}{r}
\chi\left(\operatorname{Lk}^{\infty}\left(X \cap\left\{v^{*} \leq \alpha\right\}\right)\right)=\chi(X)-\sum_{i=1}^{l} \operatorname{ind}\left(v^{*}, X, p_{i}\right), \\
\chi\left(\operatorname{Lk}^{\infty}\left(X \cap\left\{v^{*} \geq \alpha\right\}\right)\right)=\chi(X)-\sum_{i=1}^{l} \operatorname{ind}\left(-v^{*}, X, p_{i}\right), \\
\chi\left(\operatorname{Lk}^{\infty}\left(X \cap\left\{v^{*}=\alpha\right\}\right)\right)=2 \chi(X)-\chi\left(\operatorname{Lk}^{\infty}(X)\right) \\
-\sum_{i=1}^{l} \operatorname{ind}\left(v^{*}, X, p_{i}\right)-\sum_{i=1}^{l} \operatorname{ind}\left(-v^{*}, X, p_{i}\right) .
\end{array}
$$

Note that the functions $\beta \mapsto \chi\left(\operatorname{Lk}^{\infty}\left(X \cap\left\{v^{*} ? \beta\right\}\right)\right), ? \in\{\leq,=, \geq\}$, are constant on $\mathbb{R}$. Theorem 3.20, Theorem 3.21 and Corollary 3.22 are also valid in this context. They have the same formulation as in the general case with the difference that $\tilde{B}\left(v^{*}\right)=v^{*}\left(\left\{p_{1}, \ldots, p_{l}\right\}\right)$.

As an application, we will give a short proof of the Gauss-Bonnet formula for closed semi-algebraic sets. Let $\Lambda_{0}(X,-)$ be the Gauss-Bonnet measure on $X$ defined by:

$$
\Lambda_{0}(X, U)=\frac{1}{\operatorname{Vol}\left(S^{n-1}\right)} \int_{S^{n-1}} \sum_{x \in U} \operatorname{ind}\left(v^{*}, X, x\right) d v
$$

where $U$ is a Borel set of $X$. Note that if $x$ is not a critical point of $v_{\mid X}^{*}$ then $\operatorname{ind}\left(v^{*}, X, x\right)=0$ and therefore that for $v \notin \Gamma(X)$, the sum $\sum_{x \in U} \operatorname{ind}\left(v^{*}, X, x\right)$ is finite. The Gauss-Bonnet theorem for compact semialgebraic sets is due to $\mathrm{Fu}[\mathrm{Fu}]$ and Broecker and Kuppe [BK].
Theorem 5.6. If $X$ is a compact semi-algebraic set then:

$$
\Lambda_{0}(X, X)=\chi(X)
$$

Now assume that $X$ is just closed. Let $\left(K_{R}\right)_{R>0}$ be an exhaustive family of compact Borel sets of $X$, that is a family $\left(K_{R}\right)_{R>0}$ of compact Borel sets
of $X$ such that $\cup_{R>0} K_{R}=X$ and $K_{R} \subseteq K_{R^{\prime}}$ if $R \leq R^{\prime}$. For every $R>0$, we have:

$$
\Lambda_{0}\left(X, X \cap K_{R}\right)=\frac{1}{\operatorname{Vol}\left(S^{n-1}\right)} \int_{S^{n-1}} \sum_{x \in X \cap K_{R}} \operatorname{ind}\left(v^{*}, X, x\right) d v
$$

Moreover the following limit:

$$
\lim _{R \rightarrow+\infty} \sum_{x \in X \cap K_{R}} \operatorname{ind}\left(v^{*}, X, x\right)
$$

is equal to $\sum_{x \in X} \operatorname{ind}\left(v^{*}, X, x\right)$ which is uniformly bounded by Hardt's theorem. Applying Lebesgue's theorem, we obtain:

$$
\begin{array}{r}
\lim _{R \rightarrow+\infty} \Lambda_{0}\left(X, X \cap K_{R}\right)=\frac{1}{\operatorname{Vol}\left(S^{n-1}\right)} \int_{S^{n-1}} \lim _{R \rightarrow+\infty} \sum_{x \in X \cap K_{R}} \operatorname{ind}\left(v^{*}, X, x\right) d v= \\
\frac{1}{\operatorname{Vol}\left(S^{n-1}\right)} \int_{S^{n-1}} \sum_{x \in X} \operatorname{ind}\left(v^{*}, X, x\right) d v
\end{array}
$$

Definition 5.7. We set:

$$
\Lambda_{0}(X, X)=\lim _{R \rightarrow+\infty} \Lambda_{0}\left(X, X \cap K_{R}\right)
$$

where $\left(K_{R}\right)_{R>0}$ is an exhaustive family of compact Borel sets of $X$.
Theorem 5.8. If $X$ is a closed semi-algebraic set then:

$$
\begin{aligned}
\Lambda_{0}(X, X)=\chi(X)- & \frac{1}{2} \chi\left(\operatorname{Lk}^{\infty}(X)\right) \\
& -\frac{1}{2 \operatorname{Vol}\left(S^{n-1}\right)} \int_{S^{n-1}} \chi\left(\mathrm{Lk}^{\infty}\left(X \cap\left\{v^{*}=0\right\}\right)\right) d v
\end{aligned}
$$

Proof. We have:

$$
\begin{gathered}
\Lambda_{0}(X, X)=\frac{1}{\operatorname{Vol}\left(S^{n-1}\right)} \int_{S^{n-1}} \sum_{x \in X} \operatorname{ind}\left(v^{*}, X, x\right) d v= \\
\frac{1}{2 \operatorname{Vol}\left(S^{n-1}\right)} \int_{S^{n-1}} \sum_{x \in X} \operatorname{ind}\left(v^{*}, X, x\right)+\operatorname{ind}\left(-v^{*}, X, x\right) d v= \\
\frac{1}{2 \operatorname{Vol}\left(S^{n-1}\right)} \int_{S^{n-1}} 2 \chi(X)-\chi\left(\operatorname{Lk}^{\infty}(X)\right)-\chi\left(\operatorname{Lk}^{\infty}\left(X \cap\left\{v^{*}=0\right\}\right)\right) d v
\end{gathered}
$$

by Proposition 5.5.
