# New estimates for the div-curl-grad operators and elliptic problems with $\mathrm{L}^{1}$-data in the half-space

#### Abstract

In this Note, we study some properties of the div-curl-grad operators and elliptic problems in the half-space. We consider data in weighted Sobolev spaces and in $L^{1}$.


Keywords: div-curl-grad operators, elliptic, half-space, weighted Sobolev spaces

## 1. Introduction

The purpose of this Note is to give some estimates for div-curl-grad operators and elliptic problems with $L^{1}$-data in the half-space. We know that if $f \in$ $L^{n}\left(\mathbb{R}_{+}^{n}\right)$, there exists $\boldsymbol{u} \in \stackrel{\circ}{\mathbf{W}}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right)$ such that $\operatorname{div} \boldsymbol{u}=f$ holds, but does $\boldsymbol{u} \in \dot{\mathbf{W}}^{\circ}{ }_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right)$ hold? This is indeed true. In section 2 , we give new estimates for $L^{1}$-vector fields, which improve estimates for the solutions of elliptic systems in $\mathbb{R}_{+}^{n}$ with data in $L^{1}$.
In this Note, we use bold type characters to denote vector distributions or spaces of vector distributions with $n$ components and $C>0$ usually denotes a generic constant (the value of which may change from line to line). For any $q \in \mathbb{N}, \mathscr{P}_{q}$ (respectively, $\mathscr{P}_{q}^{\Delta}$ ) stands for the space of polynomials (respectively harmonic polynomials) of degree $\leq q$. If $q$ is strictly negative integer, we set by convention $\mathscr{P}_{q}=\{0\}$. Let $\Omega$ be an open subset in the $n$-dimensional real Euclidean space. A typical point in $\mathbb{R}^{n}$ is denoted by $\boldsymbol{x}=\left(x_{1}, \ldots, x_{n}\right)$ and its norm is given by $r=|\boldsymbol{x}|=\left(x_{1}^{2}+\ldots+x_{n}^{2}\right)^{\frac{1}{2}}$. We define the weight function $\rho(\boldsymbol{x})=1+r$. For each $p \in \mathbb{R}$ and $1<p<\infty$, the conjugate exponent $p^{\prime}$ is given by the relation $\frac{1}{p}+\frac{1}{p^{\prime}}=1$. We now define the weighted Sobolev space $W_{0}^{1, p}(\Omega)=\left\{u \in \mathcal{D}^{\prime}(\Omega), \frac{u}{w_{1}} \in L^{p}(\Omega), \nabla u \in \mathbf{L}^{p}(\Omega)\right\}$, where $w_{1}=1+r$ if $p \neq n$

[^0]and $w_{1}=(1+r) \ln (2+r)$ if $p=n$. This space is a reflexive Banach space when endowed with the norm:
$$
\|u\|_{W_{0}^{1, p}(\Omega)}=\left(\left\|\frac{u}{w_{1}}\right\|_{L^{p}(\Omega)}^{p}+\|\nabla u\|_{\mathbf{L}^{p}(\Omega)}^{p}\right)^{1 / p}
$$

We also introduce the space $W_{0}^{2, p}(\Omega)=\left\{u \in \mathcal{D}^{\prime}(\Omega), \frac{u}{w_{2}} \in L^{p}(\Omega), \frac{\nabla u}{w_{1}} \in\right.$ $\left.\mathbf{L}^{p}(\Omega), D^{2} u \in \mathbf{L}^{p}(\Omega)\right\}$, where $w_{2}=(1+r)^{2}$ if $p \notin\left\{\frac{n}{n-1}, n\right\}$ and $w_{2}=(1+$ $r)^{2} \ln (2+r)$ in the remaining case. This space is a reflexive Banach space endowed with its natural norm given by

$$
\|u\|_{W_{0}^{2, p}(\Omega)}=\left(\left\|\frac{u}{w_{2}}\right\|_{L^{p}(\Omega)}^{p}+\left\|\frac{\nabla u}{w_{1}}\right\|_{\mathbf{L}^{p}(\Omega)}^{p}+\left\|D^{2} u\right\|_{\mathbf{L}^{p}(\Omega)}^{p}\right)^{1 / p} .
$$

We note that the logarithmic weight only appears if $p=n$ or $p=\frac{n}{n-1}$ and all the local properties of $W_{0}^{1, p}(\Omega)$ (respectively, $W_{0}^{2, p}(\Omega)$ ) coincide with those of the corresponding classical Sobolev space $W^{1, p}(\Omega)$ (respectively, $W^{2, p}(\Omega)$ ). For $m=1$ or $m=2$, we set $\stackrel{\circ}{W}_{0}^{m, p}(\Omega)=\overline{\mathcal{D}(\Omega)} W_{0}^{m, p}(\Omega)$ and we denote the dual space of $\stackrel{\circ}{W}_{0}^{m, p}(\Omega)$ by $W_{0}^{-m, p^{\prime}}(\Omega)$, which is the space of distributions. When $\Omega=\mathbb{R}^{n}$, we have $W_{0}^{m, p}\left(\mathbb{R}^{n}\right)=\stackrel{\circ}{W_{0}^{m, p}}\left(\mathbb{R}^{n}\right)$ (see [2] for more details).

## 2. The div-grad-curl operators and elliptic systems

First of all, we set $B_{a}^{+}=\left\{\boldsymbol{x} \in \mathbb{R}_{+}^{n} ;|\boldsymbol{x}|<a\right\}$ with $a>0$. In this section, we consider the case $n \geq 2$. We introduce the following theorem.

Theorem 2.1. Let $f \in L^{n}\left(\mathbb{R}_{+}^{n}\right)$. Then there exists $\boldsymbol{u} \in \mathbf{W}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right)$ such that $\operatorname{div} \boldsymbol{u}=f$. Moreover, we have the following estimate

$$
\begin{equation*}
\|\boldsymbol{u}\|_{\mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right)}+\|\boldsymbol{u}\|_{\mathbf{W}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right)} \leq C\|f\|_{L^{n}\left(\mathbb{R}_{+}^{n}\right)} . \tag{1}
\end{equation*}
$$

Proof. Let $\left(f_{k}\right)_{k \in \mathbb{N}} \subset \mathcal{D}\left(\mathbb{R}_{+}^{n}\right)$ converges towards $f \in L^{n}\left(\mathbb{R}_{+}^{n}\right)$ and $B_{r_{k}}^{+} \subset \mathbb{R}_{+}^{n}$ such that supp $f_{k} \subset B_{r_{k}}^{+}$. We set $g(\boldsymbol{x})=r_{k} f\left(r_{k} \boldsymbol{x}\right)$. Thanks to Theorem 3 [4], there exists $\boldsymbol{v} \in \mathbf{W}_{0}^{1, n}\left(B_{1}^{+}\right) \cap \mathbf{L}^{\infty}\left(B_{1}^{+}\right)$satisfying $\operatorname{div} \boldsymbol{v}=g$ in $B_{1}^{+}$and the following estimate

$$
\|\boldsymbol{v}\|_{\mathbf{L}^{\infty}\left(B_{1}^{+}\right)}+\|\nabla \boldsymbol{v}\|_{\mathbf{L}^{n}\left(B_{1}^{+}\right)} \leq C\|g\|_{L^{n}\left(B_{1}^{+}\right)} .
$$

We now set $\boldsymbol{u}_{k}(\boldsymbol{x})=\boldsymbol{v}\left(\frac{\boldsymbol{x}}{r_{k}}\right)$ with $\boldsymbol{x} \in B_{r_{k}}^{+}$. It is easy to show that $\boldsymbol{u}_{k} \in$ $\mathbf{W}_{0}^{1, n}\left(B_{r_{k}}^{+}\right) \cap \mathbf{L}^{\infty}\left(B_{r_{k}}^{+}\right)$satisfies div $\boldsymbol{u}_{k}=f_{k}$ and we have the following estimate

$$
\left\|\boldsymbol{u}_{k}\right\|_{\mathbf{L}^{\infty}\left(B_{r_{k}}^{+}\right)}+\left\|\nabla \boldsymbol{u}_{k}\right\|_{\mathbf{L}^{n}\left(B_{r_{k}}^{+}\right)} \leq C\left\|f_{k}\right\|_{L^{n}\left(B_{r_{k}}^{+}\right)} \leq C\left\|f_{k}\right\|_{L^{n}\left(\mathbb{R}_{+}^{n}\right)}
$$

where $C$ depends only on $n$. By extending $\boldsymbol{u}_{k}$ in $\mathbb{R}_{+}^{n}$ by zero outside $B_{r_{k}}^{+}$and denoting $\widetilde{\boldsymbol{u}_{k}}$ its extended function, we have $\left\|\widetilde{\boldsymbol{u}_{k}}\right\|_{\mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right)}=\left\|\boldsymbol{u}_{k}\right\|_{\mathbf{L}^{\infty}\left(B_{\left.r_{k}\right)}^{+}\right.}$and
$\left\|\widetilde{\boldsymbol{u}_{k}}\right\|_{\mathbf{W}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right)}=\left\|\boldsymbol{u}_{k}\right\|_{\mathbf{W}_{0}^{1, n}\left(B_{r_{k}}^{+}\right)}$. Then $\left(\widetilde{\boldsymbol{u}_{k}}\right)_{k}$ is bounded in $\stackrel{\circ}{\mathbf{W}}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right) \cap$ $\mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right)$ and we can deduce that there exists a subsequence, again denoted by $\left(\widetilde{\boldsymbol{u}_{k}}\right)_{k}$ such that $\widetilde{\boldsymbol{u}_{k}} \rightharpoonup \boldsymbol{u}$ in $\stackrel{\circ}{\mathbf{W}}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right)$ and $\widetilde{\boldsymbol{u}_{k}} \xrightarrow{*} \boldsymbol{u}$ in $\mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right)$. Hence, we have $\operatorname{div} \boldsymbol{u}=f$ and the estimate (1).

The conclusion of Theorem 2.1 is equivalent to the estimate

$$
\begin{equation*}
\forall u \in L^{n /(n-1)}\left(\mathbb{R}_{+}^{n}\right),\|u\|_{L^{n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)} \leq C_{n}\|\nabla u\|_{\mathbf{L}^{1}\left(\mathbb{R}_{+}^{n}\right)+\mathbf{W}_{0}^{-1, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)} \tag{2}
\end{equation*}
$$

Indeed, let us consider the following unbounded operator

$$
A=-\nabla: L^{n /(n-1)}\left(\mathbb{R}_{+}^{n}\right) \rightarrow \mathbf{L}^{1}\left(\mathbb{R}_{+}^{n}\right)+\mathbf{W}_{0}^{-1, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)
$$

Then the domain $D(A)$ is dense in $L^{n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$ and $A$ is closed. Because the adjoint operator

$$
A^{*}=\operatorname{div}: \mathbf{W}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right) \rightarrow L^{n}\left(\mathbb{R}_{+}^{n}\right)
$$

is surjective, we deduce the estimate (2).
It follows from (2) and that range A is closed in $\mathbf{L}^{1}\left(\mathbb{R}_{+}^{n}\right)+\mathbf{W}_{0}^{-1, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$. Then $\left(\operatorname{Ker} A^{*}\right)^{\perp}=\operatorname{Im} A$ and as consequence we obtain the following version of De Rham's Theorem: for any $\boldsymbol{f}$ belonging to the space $\mathbf{L}^{1}\left(\mathbb{R}_{+}^{n}\right)+$ $\mathbf{W}_{0}^{-1, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$ and satisfying the following compatibility condition

$$
\begin{equation*}
\forall \boldsymbol{v} \in \mathbf{W}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right), \quad \text { with div } \boldsymbol{v}=0, \quad<\boldsymbol{f}, \boldsymbol{v}>=0 \tag{3}
\end{equation*}
$$

then there exists a unique $\pi \in L^{n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$ such that $\boldsymbol{f}=\nabla \pi$.
The following theorem, given without proof, is proved by J. Bourgain - H. Brézis [5] (see also [6]) in the case where $\mathbb{R}_{+}^{n}$ is replaced by a bounded smooth domain $\Omega$.

Theorem 2.2. i) Let $\varphi \in \mathbf{W}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right)$. Then there exists $\boldsymbol{\psi}=\left(\psi_{1}, \ldots, \psi_{n}\right) \in$ $\mathbf{W}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right)$ and $\eta \in W_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right)$ such that $\psi_{n}=0$ on $\Gamma=\mathbb{R}^{n-1} \times\{0\}$ satisfying

$$
\varphi=\boldsymbol{\psi}+\nabla \eta
$$

and the following estimate holds

$$
\begin{equation*}
\|\boldsymbol{\psi}\|_{\mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right)}+\|\boldsymbol{\psi}\|_{\mathbf{W}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right)}+\|\eta\|_{W_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right)} \leq C\|\boldsymbol{\varphi}\|_{\mathbf{W}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right)} \tag{4}
\end{equation*}
$$

ii) If $\boldsymbol{\varphi} \in \stackrel{\circ}{\mathbf{W}}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right)$, then the same result holds with $\boldsymbol{\psi} \in \stackrel{\circ}{\mathbf{W}}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right)$ and $\eta \in \stackrel{\circ}{W}_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right)$ and the corresponding estimate.

Define the space $\mathbf{X}\left(\mathbb{R}_{+}^{n}\right)=\left\{\boldsymbol{v} \in \mathbf{L}^{1}\left(\mathbb{R}_{+}^{n}\right) ; \operatorname{div} \boldsymbol{v} \in W_{0}^{-2, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)\right\}$. Let $\boldsymbol{f} \in \mathbf{X}\left(\mathbb{R}_{+}^{n}\right)$. Thanks to Theorem 2.2, the linear operator $\boldsymbol{F}: \boldsymbol{\varphi} \longmapsto \int_{\mathbb{R}_{+}^{n}} \boldsymbol{f} \cdot \boldsymbol{\varphi} d \boldsymbol{x}$ satisfies

$$
\forall \varphi \in \mathcal{D}\left(\mathbb{R}_{+}^{n}\right), \quad|<\boldsymbol{F}, \boldsymbol{\varphi}>| \leq C\|\boldsymbol{f}\| \mathbf{x}\|\boldsymbol{\varphi}\|_{\mathbf{W}_{0}^{1, n}}
$$

As $\mathcal{D}\left(\mathbb{R}_{+}^{n}\right)$ is dense in $\stackrel{\circ}{\mathbf{W}}{ }_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right)$ and by applying Hahn-Banach Theorem, we can uniquely extend $\boldsymbol{F}$ by an element $\widetilde{\boldsymbol{F}} \in \mathbf{W}_{0}^{-1, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$ satisfying $\|\widetilde{\boldsymbol{F}}\|_{\mathbf{W}_{0}^{-1, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)} \leq C\|\boldsymbol{f}\|_{\mathbf{X}_{\left(\mathbb{R}_{+}^{n}\right)} \text {. Besides, the following linear operator }}$ $\boldsymbol{f} \longrightarrow \widetilde{\boldsymbol{F}}$ from $\mathbf{X}\left(\mathbb{R}_{+}^{n}\right)$ into $\mathbf{W}_{0}^{-1, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$ is continuous and injective. Therefore, $\mathbf{X}\left(\mathbb{R}_{+}^{n}\right)$ can be identified to a subspace of $\mathbf{W}_{0}^{-1, n /(n-1)}\left(\mathbb{R}^{n}\right)$ with continuous and dense embedding. Thanks to [3], we can then deduce that for any $f \in \mathbf{X}\left(\mathbb{R}_{+}^{n}\right)$, the following problem

$$
\begin{equation*}
-\Delta \boldsymbol{u}=\boldsymbol{f} \text { in } \mathbb{R}_{+}^{n} \text { and } \boldsymbol{u}=\mathbf{0} \text { on } \Gamma \tag{5}
\end{equation*}
$$

has a unique solution $\boldsymbol{u} \in \mathbf{W}_{0}^{1, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$ satisfying the following estimate $\|\boldsymbol{u}\|_{\mathbf{W}_{0}^{1, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)} \leq C\|\boldsymbol{f}\|_{\mathbf{X}\left(\mathbb{R}_{+}^{n}\right)}$.

The first statement of the following corollary is the equivalent of Theorem 2.1 for the curl operator and the second statement gives a Helmholtz decomposition.

Corollary 2.3. i) Let $\boldsymbol{f} \in \mathbf{L}^{3}\left(\mathbb{R}_{+}^{3}\right)$ such that $\operatorname{div} \boldsymbol{f}=0$ in $\mathbb{R}_{+}^{3}$ and $f_{3}=0$ on $\Gamma$. Then there exists $\boldsymbol{\psi} \in \stackrel{\circ}{\mathbf{W}}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{3}\right)$ such that $\boldsymbol{f}=\mathbf{c u r l} \boldsymbol{\psi}$ and we have the following estimate

$$
\begin{equation*}
\|\boldsymbol{\psi}\|_{\mathbf{W}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right)}+\|\boldsymbol{\psi}\|_{\mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{3}\right)} \leq C\|f\|_{\mathbf{L}^{3}\left(\mathbb{R}_{+}^{3}\right)} \tag{6}
\end{equation*}
$$

ii) Let $\boldsymbol{f} \in \mathbf{L}^{3}\left(\mathbb{R}_{+}^{3}\right)$. Then there exist $\boldsymbol{\varphi} \in \stackrel{\circ}{\mathbf{W}}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{3}\right)$ and $\pi \in$ $W_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right)$ unique up to an additive constant and satisfying

$$
\begin{equation*}
\boldsymbol{f}=\operatorname{curl} \varphi+\nabla \pi . \tag{7}
\end{equation*}
$$

Moreover, we have the following estimate

$$
\begin{equation*}
\|\varphi\|_{\mathbf{W}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right)}+\|\varphi\|_{\mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{3}\right)}+\|\nabla \pi\|_{\mathbf{L}^{3}\left(\mathbb{R}_{+}^{3}\right)} \leq C\|\boldsymbol{f}\|_{\mathbf{L}^{3}\left(\mathbb{R}_{+}^{3}\right)} \tag{8}
\end{equation*}
$$

In the following proposition, we improve the estimate given by Corollary 1.4 of Van Schaftingen [8].

Proposition 2.4. Let $\boldsymbol{f} \in \mathbf{L}^{1}\left(\mathbb{R}_{+}^{3}\right)$ such that $\operatorname{div} \boldsymbol{f}=0$. Then we have the following estimate

$$
\begin{equation*}
\forall \boldsymbol{\varphi} \in \stackrel{\circ}{\mathbf{W}}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right), \quad|<\boldsymbol{f}, \boldsymbol{\varphi}>| \leq C\|\boldsymbol{f}\|_{\mathbf{L}^{1}\left(\mathbb{R}_{+}^{3}\right)}\|\operatorname{curl} \boldsymbol{\varphi}\|_{\mathbf{L}^{3}\left(\mathbb{R}_{+}^{3}\right)} \tag{9}
\end{equation*}
$$

Proof. First remark that from the hypothesis, we deduce $\boldsymbol{f} \in \mathbf{W}_{0}^{-1,3 / 2}\left(\mathbb{R}_{+}^{3}\right)$. Let $\boldsymbol{\varphi} \in \stackrel{\circ}{\mathbf{W}}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right)$. Then we have $\operatorname{curl} \boldsymbol{\varphi} \in \mathbf{L}^{3}\left(\mathbb{R}_{+}^{3}\right)$. Thanks to Corollary 2.3, there exists $\boldsymbol{\psi} \in \stackrel{\circ}{\mathbf{W}}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{3}\right)$ such that $\operatorname{curl} \boldsymbol{\psi}=\operatorname{curl} \varphi$ with the following estimate

$$
\begin{equation*}
\|\boldsymbol{\psi}\|_{\mathbf{W}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right)}+\|\boldsymbol{\psi}\|_{\mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{3}\right)} \leq C\|\operatorname{curl} \varphi\|_{\mathbf{L}^{3}\left(\mathbb{R}_{+}^{3}\right)} \tag{10}
\end{equation*}
$$

Besides, there exists $\eta \in W_{0}^{2,3}\left(\mathbb{R}_{+}^{3}\right)$ such that $\varphi=\psi+\nabla \eta$ in $\mathbb{R}_{+}^{3}$. Then we have

$$
\begin{aligned}
<f, \varphi>_{\mathbf{w}_{0}^{-1,3 / 2}\left(\mathbb{R}_{+}^{3}\right) \times \stackrel{\circ}{\mathbf{w}}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right)} & =\int_{\mathbb{R}_{+}^{3}} f \cdot \boldsymbol{\psi}+<\boldsymbol{f}, \nabla \eta>_{\mathbf{w}_{0}^{-1,3 / 2}\left(\mathbb{R}_{+}^{3}\right) \times \dot{\mathbf{w}}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right)} \\
& =\int_{\mathbb{R}_{+}^{3}} f \cdot \boldsymbol{\psi}
\end{aligned}
$$

Therefore, the estimate (9) is deduced from the estimate (10).
Here is a variant of Theorem 2.2.
Theorem 2.5. Let $\boldsymbol{\varphi} \in \stackrel{\circ}{\mathbf{W}}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right)$. Then there exist $\boldsymbol{\psi} \in \stackrel{\circ}{\mathbf{W}}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{3}\right)$ and $\boldsymbol{\eta} \in \stackrel{\circ}{\mathbf{W}}_{0}^{2,3}\left(\mathbb{R}_{+}^{3}\right)$ such that

\varphi=\boldsymbol{\psi}+\operatorname{curl} \boldsymbol{\eta} \text { with } \operatorname{div} \Delta^{2} \boldsymbol{\eta}=0 \text { in } \mathbb{R}_{+}^{3}
$$

However, we have the following estimate

\|\boldsymbol{\psi}\|_{\mathbf{W}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right)}+\|\boldsymbol{\psi}\|_{\mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{3}\right)}+\|\boldsymbol{\eta}\|_{\mathbf{W}_{0}^{2,3}\left(\mathbb{R}_{+}^{3}\right)} \leq C\|\boldsymbol{\varphi}\|_{\mathbf{W}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right)}
$$

Proof. From the hypothesis, we have $\operatorname{div} \varphi \in L^{3}\left(\mathbb{R}_{+}^{3}\right)$. Thanks to Theorem 2.1, there exists $\boldsymbol{\psi}$ in $\stackrel{\circ}{\mathbf{W}}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{3}\right)$ such that $\operatorname{div} \boldsymbol{\psi}=\operatorname{div} \boldsymbol{\varphi}$ and we have the following estimate

$$
\|\boldsymbol{\psi}\|_{\mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{3}\right)}+\|\boldsymbol{\psi}\|_{\mathbf{W}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right)} \leq C\|\operatorname{div} \boldsymbol{\varphi}\|_{L^{3}\left(\mathbb{R}_{+}^{3}\right)}
$$

We set $\boldsymbol{f}=\boldsymbol{\varphi}-\boldsymbol{\psi}$, then $\boldsymbol{f} \in \stackrel{\circ}{\mathbf{W}}_{0}^{1,3}\left(\mathbb{R}_{+}^{3}\right)$ and $\operatorname{div} \boldsymbol{f}=0$. We extend $\boldsymbol{f}$ to $\mathbb{R}^{3}$ as follows

$$
\widetilde{\boldsymbol{f}}\left(\boldsymbol{x}^{\prime}, x_{3}\right)= \begin{cases}\boldsymbol{f}\left(\boldsymbol{x}^{\prime}, x_{3}\right) & \text { if } x_{3}>0 \\ \left(f_{1}\left(\boldsymbol{x}^{\prime},-x_{3}\right), f_{2}\left(\boldsymbol{x}^{\prime},-x_{3}\right),-f_{3}\left(\boldsymbol{x}^{\prime},-x_{3}\right)\right) & \text { if } x_{3}<0\end{cases}
$$

Then we have $\tilde{f} \in \mathbf{W}_{0}^{1,3}\left(\mathbb{R}^{3}\right)$ and $\operatorname{div} \tilde{\boldsymbol{f}}=0$ in $\mathbb{R}^{3}$. Thanks to [2], there exists $\boldsymbol{y} \in \mathbf{W}_{0}^{2,3}\left(\mathbb{R}^{3}\right)$ such that $-\Delta \boldsymbol{y}=\operatorname{curl} \widetilde{\boldsymbol{f}}$ in $\mathbb{R}^{3}$. As $\operatorname{div} \boldsymbol{y} \in W_{0}^{1,3}\left(\mathbb{R}^{3}\right)$ and is harmonic, then $\operatorname{div} \boldsymbol{y}=a$ where $a$ is a constant. Thus, we have $\operatorname{curl}$ (curl $\boldsymbol{y}-$ $\widetilde{\boldsymbol{f}})=\mathbf{0}$. Therfore, we deduce $-\Delta(\operatorname{curl} \underset{\sim}{\boldsymbol{y}})=\boldsymbol{\operatorname { c u r l }} \boldsymbol{\operatorname { c u r l }} \widetilde{\boldsymbol{f}}=-\Delta \widetilde{\boldsymbol{f}}$, it means that $\widetilde{\boldsymbol{f}}-\operatorname{curl} \boldsymbol{y} \in \mathbf{W}_{0}^{1,3}\left(\mathbb{R}^{3}\right)$ and again, $\widetilde{\boldsymbol{f}}-\operatorname{curl} \boldsymbol{y}=\boldsymbol{b}$ where $\boldsymbol{b}$ is a constant vector in $\mathbb{R}^{3}$. Thanks to Lemma 3.1 [7], there exists a polynomial $s \in \mathscr{P}_{1}$ such that $\operatorname{curl} \underset{\sim}{s}=\boldsymbol{b}$ and $\operatorname{div} s=-a$. The function $\boldsymbol{z}:=\boldsymbol{y}+\boldsymbol{s}$ belongs to $\mathbf{W}_{0}^{2,3}\left(\mathbb{R}^{3}\right)$ and $\widetilde{\boldsymbol{f}}=\operatorname{curl} \boldsymbol{z}$ in $\mathbb{R}^{3}$ with $\operatorname{div} \boldsymbol{z}=0$ in $\mathbb{R}^{3}$. Let $\boldsymbol{w}$ be the vector field defined on $\mathbb{R}_{-}^{3}$ by $\boldsymbol{w}\left(\boldsymbol{x}^{\prime}, x_{3}\right)=\left(-z_{1}\left(\boldsymbol{x}^{\prime}, x_{3}\right),-z_{2}\left(\boldsymbol{x}^{\prime}, x_{3}\right), z_{3}\left(\boldsymbol{x}^{\prime}, x_{3}\right)\right)$ with $x_{3}<0$. It is easy to show $\operatorname{curl} \boldsymbol{w}=\operatorname{curl} \boldsymbol{z}$ in $\mathbb{R}_{-}^{3}$. Then we have

$$
\begin{equation*}
\boldsymbol{w}=\boldsymbol{z}+\nabla \theta \text { in } \mathbb{R}_{-}^{3} \tag{11}
\end{equation*}
$$

with $\theta \in \mathcal{D}^{\prime}\left(\mathbb{R}_{-}^{3}\right)$. As $\nabla \theta$ belongs to $\mathbf{W}_{0}^{1,3}\left(\mathbb{R}_{-}^{3}\right)$, we can show $\theta \in W_{0}^{2,3}\left(\mathbb{R}_{-}^{3}\right)$. Let $\theta_{0} \in W_{0}^{2,3}\left(\mathbb{R}_{+}^{3}\right)$ (cf. [3]) such that $\Delta \theta_{0}=0$ in $\mathbb{R}_{+}^{3}$ and $\theta_{0}=\theta$ on $\Gamma$. We
set $\boldsymbol{\zeta}=\boldsymbol{z}-\frac{1}{2} \nabla \theta_{0}$. Then we have $\operatorname{curl} \boldsymbol{\zeta}=\boldsymbol{f}$ and $\operatorname{div} \boldsymbol{\zeta}=0$ in $\mathbb{R}_{+}^{3}$. Remark now that from (11), we deduce $2 \boldsymbol{z}^{\prime}=\nabla^{\prime} \theta=\nabla^{\prime} \theta_{0}$ on $\Gamma$, i.e., $\boldsymbol{\zeta}^{\prime}=\mathbf{0}$ on $\Gamma$. Let $\chi \in W_{0}^{3,3}\left(\mathbb{R}_{+}^{3}\right)$ be a solution of the system: $\Delta^{2} \chi=0$ in $\mathbb{R}_{+}^{3}, \quad \chi=$ 0 and $\frac{\partial \chi}{\partial x_{3}}=\zeta_{3}$ on $\Gamma$. We set $\boldsymbol{h}=\boldsymbol{\zeta}-\nabla \chi$. Then $\boldsymbol{h} \in \mathbf{W}_{0}^{2,3}\left(\mathbb{R}_{+}^{3}\right)$ such that $\boldsymbol{f}=\operatorname{curl} \boldsymbol{h}$ and $\operatorname{div} \Delta \boldsymbol{h}=0$ in $\mathbb{R}_{+}^{3}, \quad \boldsymbol{h}=\mathbf{0}$ on $\Gamma$. We know that there exists $\mu \in W_{0}^{3,3}\left(\mathbb{R}_{+}^{3}\right)$ satisfying $\Delta^{3} \mu=0$ in $\mathbb{R}_{+}^{3}, \frac{\partial \mu}{\partial x_{3}}=0$ and $\frac{\partial^{2} \mu}{\partial x_{3}^{2}}=\frac{\partial h_{3}}{\partial x_{3}}$ on $\Gamma$. We set $\boldsymbol{\eta}=\boldsymbol{h}-\nabla \mu$. Then $\boldsymbol{\eta} \in \mathbf{W}_{0}^{2,3}\left(\mathbb{R}_{+}^{3}\right), \operatorname{curl} \boldsymbol{\eta}=\boldsymbol{f}$ in $\mathbb{R}_{+}^{3}$ and $\boldsymbol{\eta}=\mathbf{0}$ on $\Gamma$. It is easy to show that $\frac{\partial \boldsymbol{\eta}}{\partial x_{3}}=0$ on $\Gamma$ and then $\boldsymbol{\eta} \in \stackrel{\circ}{\mathbf{W}}_{0}^{2,3}\left(\mathbb{R}_{+}^{3}\right)$. The proof is finished.

We introduce the following proposition.
Proposition 2.6. Let $\boldsymbol{f} \in \mathbf{L}^{1}\left(\mathbb{R}_{+}^{3}\right)$ such that $\operatorname{div} \boldsymbol{f}=0$ in $\mathbb{R}_{+}^{3}$. Then there exists a unique $\varphi \in \mathbf{L}^{3 / 2}\left(\mathbb{R}_{+}^{3}\right)$ such that $\operatorname{curl} \varphi=f$, $\operatorname{div} \varphi=0$ in $\mathbb{R}_{+}^{3}$ and $\varphi_{3}=0$ on $\Gamma$ satisfying the following estimate

$$
\|\boldsymbol{\varphi}\|_{\mathbf{L}^{3 / 2}\left(\mathbb{R}_{+}^{3}\right)} \leq C\|\boldsymbol{f}\|_{\mathbf{L}^{1}\left(\mathbb{R}_{+}^{3}\right)}
$$

Proof. It is easy to show the uniqueness of $\boldsymbol{\varphi}$. We now try to prove the existence of $\boldsymbol{\varphi}$. We know that $\boldsymbol{f} \in \mathbf{W}_{0}^{-1,3 / 2}\left(\mathbb{R}_{+}^{3}\right)$. Then, there exists a unique $\boldsymbol{z} \in \stackrel{\circ}{\mathbf{W}}_{0}^{1,3 / 2}\left(\mathbb{R}_{+}^{3}\right)$ satisfying $-\Delta \boldsymbol{z}=\boldsymbol{f}$, with $\operatorname{div} \boldsymbol{z}=0$ in $\mathbb{R}_{+}^{3}$. The function $\varphi=\operatorname{curl} \boldsymbol{z}$ is the required function.

A variant of this result can be obtained. If $\boldsymbol{f} \in \mathbf{L}^{1}\left(\mathbb{R}_{+}^{3}\right)$ such that $\operatorname{div} \boldsymbol{f}=0$ in $\mathbb{R}_{+}^{3}$ and $f_{3}=0$ on $\Gamma$, then we can prove the existence of a unique $\varphi \in$ $\mathbf{L}^{3 / 2}\left(\mathbb{R}_{+}^{3}\right)$ such that $\boldsymbol{f}=\boldsymbol{\operatorname { c u r l }} \boldsymbol{\varphi}$ with $\operatorname{div} \boldsymbol{\varphi}=0$ in $\mathbb{R}_{+}^{3}$ and $\boldsymbol{\varphi}^{\prime}=\mathbf{0}$ on $\Gamma$.

More generally, we can prove the following result.
Theorem 2.7. i) Let $\boldsymbol{f} \in \mathbf{L}^{1}\left(\mathbb{R}_{+}^{3}\right)+\mathbf{W}_{0}^{-1,3 / 2}\left(\mathbb{R}_{+}^{3}\right)$ such that $\operatorname{div} \boldsymbol{f}=0$. Then there exists a unique $\boldsymbol{\varphi} \in \mathbf{L}^{3 / 2}\left(\mathbb{R}_{+}^{3}\right)$ such that curl $\boldsymbol{\varphi}=\boldsymbol{f}$ with $\operatorname{div} \boldsymbol{\varphi}=0$ in $\mathbb{R}_{+}^{3}$ and $\varphi_{3}=0$ on $\Gamma$ satisfying the following estimate

$$
\|\boldsymbol{\varphi}\|_{\mathbf{L}^{3 / 2}\left(\mathbb{R}_{+}^{3}\right)} \leq C\|\boldsymbol{f}\|_{\mathbf{L}^{1}\left(\mathbb{R}_{+}^{3}\right)+\mathbf{W}_{0}^{-1,3 / 2}\left(\mathbb{R}_{+}^{3}\right)}
$$

ii) Let $\boldsymbol{f} \in \mathbf{X}\left(\mathbb{R}_{+}^{3}\right)$. Then there exists a unique $\boldsymbol{\varphi} \in \mathbf{L}^{3 / 2}\left(\mathbb{R}_{+}^{3}\right)$ such that $\operatorname{div} \varphi=0$ with $\varphi_{3}=0$ on $\Gamma$ and a unique $\pi \in L^{3 / 2}\left(\mathbb{R}_{+}^{3}\right)$ satisfying $\boldsymbol{f}=\operatorname{curl} \varphi+\nabla \pi$ with the corresponding estimate.

Combining the above results with [1] and [3], we can solve the follow elliptical systems.

Theorem 2.8. i) Let $\boldsymbol{g}^{\prime} \in \mathbf{L}^{1}(\Gamma)$ and $g_{n} \in W_{0}^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma)$ satisfying the compatibility condition $\int_{\Gamma} \boldsymbol{g}^{\prime}=\mathbf{0}$ and $<g_{n}, 1>=0$. If $\operatorname{div}^{\prime} \boldsymbol{g}^{\prime} \in W_{0}^{-2+\frac{1}{n}, \frac{n}{n-1}}(\Gamma)$, then the system

$$
\begin{equation*}
-\Delta \boldsymbol{u}=\mathbf{0} \text { in } \mathbb{R}_{+}^{n} \quad \text { and } \quad \boldsymbol{u}=\boldsymbol{g} \text { on } \Gamma \tag{12}
\end{equation*}
$$

has a unique very weak solution $\boldsymbol{u} \in \mathbf{L}^{n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$.
ii) Let $\boldsymbol{f} \in \mathbf{L}^{1}\left(\mathbb{R}_{+}^{n}\right)$, $\boldsymbol{g}^{\prime} \in \mathbf{L}^{1}(\Gamma)$ and $g_{n} \in W_{0}^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma)$ satisfying the compatibility condition $\int_{\mathbb{R}_{+}^{n}} \boldsymbol{f}^{\prime}+\int_{\Gamma} \boldsymbol{g}^{\prime}=\mathbf{0}$ and $\int_{\mathbb{R}_{+}^{n}} f_{n}+<g_{n}, 1>=0$. If

\left[\boldsymbol{f}, \boldsymbol{g}^{\prime}\right]=\sup _{\xi \in W_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right), \xi \neq 0} \frac{\left|\int_{\mathbb{R}_{+}^{n}} \boldsymbol{f} \cdot \nabla \xi+\int_{\Gamma} \boldsymbol{g}^{\prime} \cdot \nabla^{\prime} \xi\right|}{\|\xi\|_{W_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right)}}<\infty
$$

then the system

-\Delta \boldsymbol{u}=\boldsymbol{f} \text { in } \mathbb{R}_{+}^{n} \quad \text { and } \quad \frac{\partial \boldsymbol{u}}{\partial x_{n}}=\boldsymbol{g} \text { on } \Gamma \tag{13}
\end{equation*}
$$

has a unique solution $\boldsymbol{u} \in \mathbf{W}_{0}^{1, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$.
iii) Let $\boldsymbol{f} \in \mathbf{L}^{1}\left(\mathbb{R}_{+}^{n}\right)$ such that $\operatorname{div} \boldsymbol{f} \in\left[W_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right) \cap \stackrel{\circ}{W}_{-1}^{1, n}\left(\mathbb{R}_{+}^{n}\right)\right]^{\prime}$ and $\int_{\mathbb{R}_{+}^{n}} f_{n}=0$.

Then $\boldsymbol{f} \in \mathbf{W}_{0}^{-1, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$ and the system

\begin{equation*}
-\Delta \boldsymbol{u}=\boldsymbol{f} \text { in } \mathbb{R}_{+}^{n} ; \quad \boldsymbol{u}^{\prime}=\mathbf{0} \quad \text { and } \quad \frac{\partial u_{n}}{\partial x_{n}}=0 \quad \text { on } \Gamma \tag{14}
\end{equation*}
$$

has a unique solution $\boldsymbol{u} \in \mathbf{W}_{0}^{1, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$.
iv) Let $\boldsymbol{f} \in \mathbf{L}^{1}\left(\mathbb{R}_{+}^{n}\right)$ such that $\int_{\mathbb{R}_{+}^{n}} \boldsymbol{f}^{\prime}=\mathbf{0}$. If

$$
[\boldsymbol{f}]=\sup _{\xi \in \mathcal{D}\left(\overline{\mathbb{R}_{+}^{n}}\right), \frac{\partial \xi}{\partial x_{n}}=0 \text { on } \Gamma} \frac{\left|\int_{\mathbb{R}_{+}^{n}} f \cdot \nabla \xi\right|}{\|\xi\|_{W_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right)}}<\infty
$$

holds, then the system

$$
-\Delta \boldsymbol{u}=\boldsymbol{f} \text { in } \mathbb{R}_{+}^{n}, \quad u_{n}=0 \quad \text { and } \quad \frac{\partial \boldsymbol{u}^{\prime}}{\partial x_{n}}=\mathbf{0} \quad \text { on } \Gamma
$$

has a unique solution $\boldsymbol{u} \in \mathbf{W}_{0}^{1, n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$.
Proof. We will prove only the first point i).
Step 1: The proof will be started by showing $\boldsymbol{g}^{\prime} \in \mathbf{W}_{0}^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma)$. Let $\boldsymbol{\mu} \in$ $\mathcal{D}(\Gamma)$ and $\boldsymbol{\varphi} \in \mathbf{W}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right)$ such that $\boldsymbol{\varphi}=\boldsymbol{\mu}$ on $\Gamma$. Thanks to Theorem 2.2, there exist $\boldsymbol{\psi} \in \mathbf{W}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right)$ and $\eta \in W_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right)$ such that $\psi_{n}=0$ on $\Gamma$ satisfying $\boldsymbol{\varphi}=\boldsymbol{\psi}+\nabla \eta$ and the estimate

\begin{equation*}
\|\boldsymbol{\psi}\|_{\mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right)}+\|\boldsymbol{\psi}\|_{\mathbf{W}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right)}+\|\eta\|_{W_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right)} \leq C\|\boldsymbol{\varphi}\|_{\mathbf{W}_{0}^{1, n}\left(\mathbb{R}_{+}^{n}\right)} \tag{15}
\end{equation*}
$$

Then

<\boldsymbol{g}, \boldsymbol{\mu}>_{\mathcal{D}^{\prime}(\Gamma) \times \mathcal{D}(\Gamma)} & =\int_{\Gamma} \boldsymbol{g}^{\prime} \cdot \boldsymbol{\psi}^{\prime}-<\operatorname{div}^{\prime} \boldsymbol{g}^{\prime}, \eta>_{W_{0}^{-2+\frac{1}{n}, \frac{n}{n-1}}(\Gamma) \times W_{0}^{2-\frac{1}{n}, n}(\Gamma)} \\
& +<g_{n}, \varphi_{n}>_{W_{0}^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma) \times W_{0}^{1-\frac{1}{n}, n}(\Gamma)}
\end{aligned}
$$

and

\begin{aligned}
\left|<\boldsymbol{g}, \boldsymbol{\mu}>_{\mathcal{D}^{\prime}(\Gamma) \times \mathcal{D}(\Gamma)}\right| & \leq\left\|\boldsymbol{g}^{\prime}\right\|_{\mathbf{L}^{1}(\boldsymbol{\Gamma})}\left\|\boldsymbol{\psi}^{\prime}\right\|_{\mathbf{L}^{\infty}\left(\mathbb{R}_{+}^{n}\right)}+\left\|\operatorname{div}^{\prime} \boldsymbol{g}^{\prime}\right\|_{W_{0}^{-2+\frac{1}{n}, \frac{n}{n-1}(\Gamma)}} \times \\
& \times\|\eta\|_{W_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right)}+\left\|g_{n}\right\|_{W_{0}^{-1+\frac{1}{n}, \frac{n}{n-1}(\Gamma)}}\left\|\varphi_{n}\right\|_{W_{0}^{1-\frac{1}{n}, n}(\Gamma)} .
\end{aligned}
$$

Thanks to the density of $\mathcal{D}(\Gamma)$ in $\mathbf{W}_{0}^{1-\frac{1}{n}, n}(\Gamma)$ and (15), we can deduce $\boldsymbol{g}^{\prime} \in$ $\mathbf{W}_{0}^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma)$.
Step 2: The system (13) is equivalent to the following one: Find $\boldsymbol{u}$ belonging $\mathbf{L}^{n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$ such that for all $\boldsymbol{v} \in \mathbf{W}_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right) \cap \stackrel{\circ}{\mathbf{W}}_{-1}^{1, n}\left(\mathbb{R}_{+}^{n}\right)$,

$$
\int_{\mathbb{R}_{+}^{n}} \boldsymbol{u} \cdot \Delta \boldsymbol{v}=-<\boldsymbol{g}, \frac{\partial \boldsymbol{v}}{\partial \boldsymbol{n}}>_{\mathbf{W}_{0}^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma) \times \mathbf{W}_{0}^{1-\frac{1}{n}, n}(\Gamma)}
$$

But for all $\boldsymbol{F} \in \mathbf{L}^{n}\left(\mathbb{R}_{+}^{n}\right)$, there exists $\boldsymbol{v} \in \mathbf{W}_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right) \cap \stackrel{ }{\mathbf{W}}_{-1}^{1, n}\left(\mathbb{R}_{+}^{n}\right)$, unique up to an element of $x_{n} \mathbb{R}^{n}$, such that $-\Delta \boldsymbol{v}=\boldsymbol{F}$ in $\mathbb{R}_{+}^{n}, \boldsymbol{v}=\mathbf{0}$ on $\Gamma$ and the following estimate holds

$$
\|\boldsymbol{v}\|_{\mathbf{W}_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right) / x_{n} \mathbb{R}^{n}} \leq C\|\boldsymbol{F}\|_{\mathbf{L}^{n}\left(\mathbb{R}_{+}^{n}\right)} .
$$

Then, we have for all $\boldsymbol{a} \in \mathbb{R}^{n}$,

$$
\begin{aligned}
& \left|<\boldsymbol{g}, \frac{\partial \boldsymbol{v}}{\partial x_{n}}>\mathbf{W}_{0}^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma) \times \mathbf{W}_{0}^{1-\frac{1}{n}, n}{ }_{(\Gamma)}\right| \\
& =\left|<\boldsymbol{g}, \frac{\partial\left(\boldsymbol{v}+\boldsymbol{a} x_{n}\right)}{\partial x_{n}}>\mathbf{W}_{0}^{-1+\frac{1}{n}, \frac{n}{n-1}(\Gamma) \times \mathbf{W}_{0}^{1-\frac{1}{n}, n}(\Gamma)}\right| \\
& \leq C\|\boldsymbol{g}\|_{\mathbf{W}_{0}^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma)}\left\|\boldsymbol{v}+\boldsymbol{a} x_{n}\right\|_{\mathbf{W}_{0}^{2, n}\left(\mathbb{R}_{+}^{n}\right) .} .
\end{aligned}
$$

Consequently, taking the infinum, we have

$$
\left|<\boldsymbol{g}, \frac{\partial \boldsymbol{v}}{\partial x_{n}}>\mathbf{W}_{\mathbf{W}_{0}^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma) \times \mathbf{W}_{0}^{1-\frac{1}{n}, n}(\Gamma)}\right| \leq C\|\boldsymbol{g}\|_{\mathbf{W}_{0}^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma)}\|\boldsymbol{F}\|_{\mathbf{L}^{n}\left(\mathbb{R}_{+}^{n}\right)}
$$

Then, the linear operator

$$
T: \boldsymbol{F} \longrightarrow<\boldsymbol{g}, \frac{\partial \boldsymbol{v}}{\partial x_{n}}>\mathbf{w}_{0}^{-1+\frac{1}{n}, \frac{n}{n-1}(\Gamma) \times \mathbf{w}_{0}^{1-\frac{1}{n}, n}(\Gamma)}
$$

is continuous on $\mathbf{L}^{n}\left(\mathbb{R}_{+}^{n}\right)$ and thanks to the Riesz reprensentation theorem, there exists a unique $\boldsymbol{u} \in \mathbf{L}^{n /(n-1)}\left(\mathbb{R}_{+}^{n}\right)$ such that $T(\boldsymbol{F})=\int_{\mathbb{R}_{+}^{n}} \boldsymbol{u} \cdot \boldsymbol{F}$, i.e., $\boldsymbol{u}$ is the solution of (13).
