New estimates for the div-curl-grad operators and elliptic problems with L¹-data in the half-space

Abstract

In this Note, we study some properties of the div-curl-grad operators and elliptic problems in the half-space. We consider data in weighted Sobolev spaces and in L^1 .

Keywords: div-curl-grad operators, elliptic, half-space, weighted Sobolev spaces

1. Introduction

The purpose of this Note is to give some estimates for div-curl-grad operators and elliptic problems with L^1 -data in the half-space. We know that if $f \in L^n(\mathbb{R}^n_+)$, there exists $\boldsymbol{u} \in \overset{\circ}{\mathbf{W}} {}^{1,n}_0(\mathbb{R}^n_+)$ such that div $\boldsymbol{u} = f$ holds, but does $\boldsymbol{u} \in \overset{\circ}{\mathbf{W}} {}^{1,n}_0(\mathbb{R}^n_+) \cap \mathbf{L}^{\infty}(\mathbb{R}^n_+)$ hold? This is indeed true. In section 2, we give new estimates for L^1 -vector fields, which improve estimates for the solutions of elliptic systems in \mathbb{R}^n_+ with data in L^1 .

In this Note, we use bold type characters to denote vector distributions or spaces of vector distributions with n components and C > 0 usually denotes a generic constant (the value of which may change from line to line). For any $q \in \mathbb{N}$, \mathscr{P}_q (respectively, \mathscr{P}_q^{Δ}) stands for the space of polynomials (respectively harmonic polynomials) of degree $\leq q$. If q is strictly negative integer, we set by convention $\mathscr{P}_q = \{0\}$. Let Ω be an open subset in the *n*-dimensional real Euclidean space. A typical point in \mathbb{R}^n is denoted by $\boldsymbol{x} = (x_1, ..., x_n)$ and its norm is given by $r = |\boldsymbol{x}| = (x_1^2 + ... + x_n^2)^{\frac{1}{2}}$. We define the weight function $\rho(\boldsymbol{x}) = 1 + r$. For each $p \in \mathbb{R}$ and 1 , the conjugate exponent <math>p' is given by the relation $\frac{1}{p} + \frac{1}{p'} = 1$. We now define the weighted Sobolev space $W_0^{1,p}(\Omega) = \{u \in \mathcal{D}'(\Omega), \ \frac{u}{w_1} \in L^p(\Omega), \ \nabla u \in \mathbf{L}^p(\Omega)\}$, where $w_1 = 1 + r$ if $p \neq n$

and $w_1 = (1+r) \ln(2+r)$ if p = n. This space is a reflexive Banach space when endowed with the norm:

$$||u||_{W_0^{1,p}(\Omega)} = (||\frac{u}{w_1}||_{L^p(\Omega)}^p + ||\nabla u||_{\mathbf{L}^p(\Omega)}^p)^{1/p}$$

We also introduce the space $W_0^{2,p}(\Omega) = \{u \in \mathcal{D}'(\Omega), \frac{u}{w_2} \in L^p(\Omega), \frac{\nabla u}{w_1} \in \mathbf{L}^p(\Omega), D^2 u \in \mathbf{L}^p(\Omega)\}$, where $w_2 = (1+r)^2$ if $p \notin \{\frac{n}{n-1}, n\}$ and $w_2 = (1+r)^2 \ln(2+r)$ in the remaining case. This space is a reflexive Banach space endowed with its natural norm given by

$$||u||_{W_0^{2,p}(\Omega)} = (||\frac{u}{w_2}||_{L^p(\Omega)}^p + ||\frac{\nabla u}{w_1}||_{\mathbf{L}^p(\Omega)}^p + ||D^2 u||_{\mathbf{L}^p(\Omega)}^p)^{1/p}.$$

We note that the logarithmic weight only appears if p = n or $p = \frac{n}{n-1}$ and all the local properties of $W_0^{1,p}(\Omega)$ (respectively, $W_0^{2,p}(\Omega)$) coincide with those of the corresponding classical Sobolev space $W^{1,p}(\Omega)$ (respectively, $W^{2,p}(\Omega)$). For m = 1 or m = 2, we set $\overset{\circ}{W}_{0}^{m,p}(\Omega) = \overline{\mathcal{D}(\Omega)}^{W_0^{m,p}(\Omega)}$ and we denote the dual space of $\overset{\circ}{W}_{0}^{m,p}(\Omega)$ by $W_0^{-m,p'}(\Omega)$, which is the space of distributions. When $\Omega = \mathbb{R}^n$, we have $W_0^{m,p}(\mathbb{R}^n) = \overset{\circ}{W}_0^{m,p}(\mathbb{R}^n)$ (see [2] for more details).

2. The div-grad-curl operators and elliptic systems

First of all, we set $B_a^+ = \{ \boldsymbol{x} \in \mathbb{R}_+^n; |\boldsymbol{x}| < a \}$ with a > 0. In this section, we consider the case $n \ge 2$. We introduce the following theorem.

Theorem 2.1. Let $f \in L^n(\mathbb{R}^n_+)$. Then there exists $\boldsymbol{u} \in \overset{\circ}{\mathbf{W}}_0^{1,n}(\mathbb{R}^n_+) \cap \mathbf{L}^{\infty}(\mathbb{R}^n_+)$ such that div $\boldsymbol{u} = f$. Moreover, we have the following estimate

$$|| \boldsymbol{u} ||_{\mathbf{L}^{\infty}(\mathbb{R}^{n}_{+})} + || \boldsymbol{u} ||_{\mathbf{W}^{1,n}_{0}(\mathbb{R}^{n}_{+})} \leq C || f ||_{L^{n}(\mathbb{R}^{n}_{+})}.$$
(1)

Proof. Let $(f_k)_{k \in \mathbb{N}} \subset \mathcal{D}(\mathbb{R}^n_+)$ converges towards $f \in L^n(\mathbb{R}^n_+)$ and $B^+_{r_k} \subset \mathbb{R}^n_+$ such that supp $f_k \subset B^+_{r_k}$. We set $g(\boldsymbol{x}) = r_k f(r_k \boldsymbol{x})$. Thanks to Theorem 3 [4], there exists $\boldsymbol{v} \in \mathbf{W}^{1,n}_0(B^+_1) \cap \mathbf{L}^{\infty}(B^+_1)$ satisfying div $\boldsymbol{v} = g$ in B^+_1 and the following estimate

$$\| \boldsymbol{v} \|_{\mathbf{L}^{\infty}(B_{1}^{+})} + \| \nabla \boldsymbol{v} \|_{\mathbf{L}^{n}(B_{1}^{+})} \leq C \| g \|_{L^{n}(B_{1}^{+})}.$$

We now set $\boldsymbol{u}_k(\boldsymbol{x}) = \boldsymbol{v}(\frac{\boldsymbol{x}}{r_k})$ with $\boldsymbol{x} \in B^+_{r_k}$. It is easy to show that $\boldsymbol{u}_k \in \mathbf{W}^{1,n}_0(B^+_{r_k}) \cap \mathbf{L}^{\infty}(B^+_{r_k})$ satisfies div $\boldsymbol{u}_k = f_k$ and we have the following estimate

$$|| \boldsymbol{u}_k ||_{\mathbf{L}^{\infty}(B_{r_k}^+)} + || \nabla \boldsymbol{u}_k ||_{\mathbf{L}^n(B_{r_k}^+)} \leq C || f_k ||_{L^n(B_{r_k}^+)} \leq C || f_k ||_{L^n(\mathbb{R}^n_+)}$$

where C depends only on n. By extending \boldsymbol{u}_k in \mathbb{R}^n_+ by zero outside $B^+_{r_k}$ and denoting $\widetilde{\boldsymbol{u}_k}$ its extended function, we have $|| \widetilde{\boldsymbol{u}_k} ||_{\mathbf{L}^{\infty}(\mathbb{R}^n_+)} = || \boldsymbol{u}_k ||_{\mathbf{L}^{\infty}(B^+_{r_k})}$ and

 $\|\widetilde{\boldsymbol{u}}_{k}\|_{\mathbf{W}_{0}^{1,n}(\mathbb{R}_{+}^{n})} = \|\boldsymbol{u}_{k}\|_{\mathbf{W}_{0}^{1,n}(B_{r_{k}}^{+})}.$ Then $(\widetilde{\boldsymbol{u}}_{k})_{k}$ is bounded in $\overset{\circ}{\mathbf{W}} \overset{1,n}{_{0}^{n}(\mathbb{R}_{+}^{n})} \cap \mathbf{L}^{\infty}(\mathbb{R}_{+}^{n})$ and we can deduce that there exists a subsequence, again denoted by $(\widetilde{\boldsymbol{u}}_{k})_{k}$ such that $\widetilde{\boldsymbol{u}}_{k} \rightharpoonup \boldsymbol{u}$ in $\overset{\circ}{\mathbf{W}} \overset{1,n}{_{0}^{n}(\mathbb{R}_{+}^{n})}$ and $\widetilde{\boldsymbol{u}}_{k} \overset{*}{\rightharpoonup} \boldsymbol{u}$ in $\mathbf{L}^{\infty}(\mathbb{R}_{+}^{n})$. Hence, we have div $\boldsymbol{u} = f$ and the estimate (1).

The conclusion of Theorem 2.1 is equivalent to the estimate

$$\forall u \in L^{n/(n-1)}(\mathbb{R}^{n}_{+}), \quad || \, u \, ||_{L^{n/(n-1)}(\mathbb{R}^{n}_{+})} \leq C_{n} \, || \, \nabla u \, ||_{\mathbf{L}^{1}(\mathbb{R}^{n}_{+}) + \mathbf{W}_{0}^{-1, n/(n-1)}(\mathbb{R}^{n}_{+})}.$$

$$\tag{2}$$

Indeed, let us consider the following unbounded operator

$$A = -\nabla : L^{n/(n-1)}(\mathbb{R}^n_+) \to \mathbf{L}^1(\mathbb{R}^n_+) + \mathbf{W}_0^{-1,n/(n-1)}(\mathbb{R}^n_+).$$

Then the domain D(A) is dense in $L^{n/(n-1)}(\mathbb{R}^n_+)$ and A is closed. Because the adjoint operator

$$A^* = \operatorname{div} : \mathbf{W}_0^{1,n}(\mathbb{R}^n_+) \cap \mathbf{L}^{\infty}(\mathbb{R}^n_+) \to L^n(\mathbb{R}^n_+)$$

is surjective, we deduce the estimate (2).

It follows from (2) and that range A is closed in $\mathbf{L}^{1}(\mathbb{R}^{n}_{+}) + \mathbf{W}_{0}^{-1,n/(n-1)}(\mathbb{R}^{n}_{+})$. Then (Ker $A^{*})^{\perp} = \text{Im } A$ and as consequence we obtain the following version of De Rham's Theorem: for any \boldsymbol{f} belonging to the space $\mathbf{L}^{1}(\mathbb{R}^{n}_{+}) + \mathbf{W}_{0}^{-1,n/(n-1)}(\mathbb{R}^{n}_{+})$ and satisfying the following compatibility condition

$$\forall \boldsymbol{v} \in \mathbf{W}_0^{1,n}(\mathbb{R}^n_+) \cap \mathbf{L}^{\infty}(\mathbb{R}^n_+), \text{ with div } \boldsymbol{v} = 0, < \boldsymbol{f}, \boldsymbol{v} > = 0, \qquad (3)$$

then there exists a unique $\pi \in L^{n/(n-1)}(\mathbb{R}^n_+)$ such that $f = \nabla \pi$.

The following theorem, given without proof, is proved by J. Bourgain - H. Brézis [5] (see also [6]) in the case where \mathbb{R}^n_+ is replaced by a bounded smooth domain Ω .

Theorem 2.2. i) Let $\varphi \in \mathbf{W}_0^{1,n}(\mathbb{R}^n_+)$. Then there exists $\psi = (\psi_1, \ldots, \psi_n) \in \mathbf{W}_0^{1,n}(\mathbb{R}^n_+) \cap \mathbf{L}^{\infty}(\mathbb{R}^n_+)$ and $\eta \in W_0^{2,n}(\mathbb{R}^n_+)$ such that $\psi_n = 0$ on $\Gamma = \mathbb{R}^{n-1} \times \{0\}$ satisfying

$$\boldsymbol{\varphi} = \boldsymbol{\psi} +
abla \eta$$

and the following estimate holds

$$||\psi||_{\mathbf{L}^{\infty}(\mathbb{R}^{n}_{+})} + ||\psi||_{\mathbf{W}^{1,n}_{0}(\mathbb{R}^{n}_{+})} + ||\eta||_{W^{2,n}_{0}(\mathbb{R}^{n}_{+})} \leq C ||\varphi||_{\mathbf{W}^{1,n}_{0}(\mathbb{R}^{n}_{+})}.$$
 (4)

ii) If $\varphi \in \overset{\circ}{\mathbf{W}}_{0}^{1,n}(\mathbb{R}^{n}_{+})$, then the same result holds with $\psi \in \overset{\circ}{\mathbf{W}}_{0}^{1,n}(\mathbb{R}^{n}_{+}) \cap \mathbf{L}^{\infty}(\mathbb{R}^{n}_{+})$ and $\eta \in \overset{\circ}{W}_{0}^{2,n}(\mathbb{R}^{n}_{+})$ and the corresponding estimate.

Define the space $\mathbf{X}(\mathbb{R}^n_+) = \{ \boldsymbol{v} \in \mathbf{L}^1(\mathbb{R}^n_+); \text{ div } \boldsymbol{v} \in W_0^{-2,n/(n-1)}(\mathbb{R}^n_+) \}$. Let $\boldsymbol{f} \in \mathbf{X}(\mathbb{R}^n_+)$. Thanks to Theorem 2.2, the linear operator $\boldsymbol{F} : \boldsymbol{\varphi} \longmapsto \int_{\mathbb{R}^n_+} \boldsymbol{f} \cdot \boldsymbol{\varphi} \, d\boldsymbol{x}$ satisfies

$$orall oldsymbol{arphi} \in oldsymbol{\mathcal{D}}(\mathbb{R}^n_+), \;\; \mid < oldsymbol{F}, oldsymbol{arphi} > \mid \; \leq \; C \, ||oldsymbol{f}|\, ||_{\mathbf{X}} ||oldsymbol{arphi}| \, oldsymbol{arphi}_{0}^{1,n}.$$

As $\mathcal{D}(\mathbb{R}^n_+)$ is dense in $\overset{\circ}{\mathbf{W}} {}_{0}^{1,n}(\mathbb{R}^n_+)$ and by applying Hahn-Banach Theorem, we can uniquely extend \mathbf{F} by an element $\widetilde{\mathbf{F}} \in \mathbf{W}_{0}^{-1,n/(n-1)}(\mathbb{R}^n_+)$ satisfying $||\widetilde{\mathbf{F}}||_{\mathbf{W}_{0}^{-1,n/(n-1)}(\mathbb{R}^n_+)} \leq C ||\mathbf{f}||_{\mathbf{X}(\mathbb{R}^n_+)}$. Besides, the following linear operator $\mathbf{f} \longrightarrow \widetilde{\mathbf{F}}$ from $\mathbf{X}(\mathbb{R}^n_+)$ into $\mathbf{W}_{0}^{-1,n/(n-1)}(\mathbb{R}^n_+)$ is continuous and injective. Therefore, $\mathbf{X}(\mathbb{R}^n_+)$ can be identified to a subspace of $\mathbf{W}_{0}^{-1,n/(n-1)}(\mathbb{R}^n)$ with continuous and dense embedding. Thanks to [3], we can then deduce that for any $\mathbf{f} \in \mathbf{X}(\mathbb{R}^n_+)$, the following problem

$$-\Delta \boldsymbol{u} = \boldsymbol{f} \quad \text{in } \mathbb{R}^n_+ \quad \text{and} \quad \boldsymbol{u} = \boldsymbol{0} \quad \text{on } \boldsymbol{\Gamma}, \tag{5}$$

has a unique solution $\boldsymbol{u} \in \mathbf{W}_0^{1,n/(n-1)}(\mathbb{R}^n_+)$ satisfying the following estimate $||\boldsymbol{u}||_{\mathbf{W}_0^{1,n/(n-1)}(\mathbb{R}^n_+)} \leq C ||\boldsymbol{f}||_{\mathbf{X}(\mathbb{R}^n_+)}$.

The first statement of the following corollary is the equivalent of Theorem 2.1 for the curl operator and the second statement gives a Helmholtz decomposition.

Corollary 2.3. *i)* Let $\mathbf{f} \in \mathbf{L}^3(\mathbb{R}^3_+)$ such that $\operatorname{div} \mathbf{f} = 0$ in \mathbb{R}^3_+ and $f_3 = 0$ on Γ . Then there exists $\boldsymbol{\psi} \in \overset{\circ}{\mathbf{W}}_{0}^{1,3}(\mathbb{R}^3_+) \cap \mathbf{L}^{\infty}(\mathbb{R}^3_+)$ such that $\mathbf{f} = \operatorname{curl} \boldsymbol{\psi}$ and we have the following estimate

$$\|\psi\|_{\mathbf{W}_{0}^{1,3}(\mathbb{R}^{3}_{+})} + \|\psi\|_{\mathbf{L}^{\infty}(\mathbb{R}^{3}_{+})} \leq C \|f\|_{\mathbf{L}^{3}(\mathbb{R}^{3}_{+})}.$$
 (6)

ii) Let $\mathbf{f} \in \mathbf{L}^3(\mathbb{R}^3_+)$. Then there exist $\boldsymbol{\varphi} \in \overset{\circ}{\mathbf{W}} {}^{1,3}_0(\mathbb{R}^3_+) \cap \mathbf{L}^\infty(\mathbb{R}^3_+)$ and $\pi \in W^{1,3}_0(\mathbb{R}^3_+)$ unique up to an additive constant and satisfying

$$\boldsymbol{f} = \operatorname{\mathbf{curl}} \boldsymbol{\varphi} + \nabla \pi. \tag{7}$$

Moreover, we have the following estimate

$$||\varphi||_{\mathbf{W}_{0}^{1,3}(\mathbb{R}^{3}_{+})} + ||\varphi||_{\mathbf{L}^{\infty}(\mathbb{R}^{3}_{+})} + ||\nabla\pi||_{\mathbf{L}^{3}(\mathbb{R}^{3}_{+})} \leq C ||f||_{\mathbf{L}^{3}(\mathbb{R}^{3}_{+})}.$$
 (8)

In the following proposition, we improve the estimate given by Corollary 1.4 of Van Schaftingen [8].

Proposition 2.4. Let $f \in L^1(\mathbb{R}^3_+)$ such that $\operatorname{div} f = 0$. Then we have the following estimate

$$\forall \boldsymbol{\varphi} \in \overset{\circ}{\mathbf{W}}_{0}^{1,3}(\mathbb{R}^{3}_{+}), \quad | < \boldsymbol{f}, \boldsymbol{\varphi} > | \leq C ||\boldsymbol{f}||_{\mathbf{L}^{1}(\mathbb{R}^{3}_{+})} ||\mathbf{curl} \boldsymbol{\varphi}||_{\mathbf{L}^{3}(\mathbb{R}^{3}_{+})}.$$
(9)

Proof. First remark that from the hypothesis, we deduce $\boldsymbol{f} \in \mathbf{W}_0^{-1,3/2}(\mathbb{R}^3_+)$. Let $\boldsymbol{\varphi} \in \overset{\circ}{\mathbf{W}}_0^{1,3}(\mathbb{R}^3_+)$. Then we have $\mathbf{curl} \boldsymbol{\varphi} \in \mathbf{L}^3(\mathbb{R}^3_+)$. Thanks to Corollary 2.3, there exists $\boldsymbol{\psi} \in \overset{\circ}{\mathbf{W}}_0^{1,3}(\mathbb{R}^3_+) \cap \mathbf{L}^\infty(\mathbb{R}^3_+)$ such that $\mathbf{curl} \boldsymbol{\psi} = \mathbf{curl} \boldsymbol{\varphi}$ with the following estimate

$$\|\psi\|_{\mathbf{W}_{0}^{1,3}(\mathbb{R}^{3}_{+})} + \|\psi\|_{\mathbf{L}^{\infty}(\mathbb{R}^{3}_{+})} \leq C \|\operatorname{curl}\varphi\|_{\mathbf{L}^{3}(\mathbb{R}^{3}_{+})}.$$
 (10)

Besides, there exists $\eta \in W_0^{2,3}(\mathbb{R}^3_+)$ such that $\varphi = \psi + \nabla \eta$ in \mathbb{R}^3_+ . Then we have

$$egin{aligned} &_{\mathbf{W}_0^{-1,3/2}(\mathbb{R}^3_+) imes \overset{\circ}{\mathbf{W}}_0^{1,3}(\mathbb{R}^3_+)} &= \int_{\mathbb{R}^3_+} oldsymbol{f} \cdot oldsymbol{\psi} + _{\mathbf{W}_0^{-1,3/2}(\mathbb{R}^3_+) imes \overset{\circ}{\mathbf{W}}_0^{1,3}(\mathbb{R}^3_+)} \ &= \int_{\mathbb{R}^3_+} oldsymbol{f} \cdot oldsymbol{\psi}. \end{aligned}$$

Therefore, the estimate (9) is deduced from the estimate (10).

Here is a variant of Theorem 2.2.

Theorem 2.5. Let $\varphi \in \overset{\circ}{\mathbf{W}}_{0}^{1,3}(\mathbb{R}^{3}_{+})$. Then there exist $\psi \in \overset{\circ}{\mathbf{W}}_{0}^{1,3}(\mathbb{R}^{3}_{+}) \cap \mathbf{L}^{\infty}(\mathbb{R}^{3}_{+})$ and $\eta \in \overset{\circ}{\mathbf{W}}_{0}^{2,3}(\mathbb{R}^{3}_{+})$ such that

$$\boldsymbol{\varphi} = \boldsymbol{\psi} + \operatorname{\mathbf{curl}} \boldsymbol{\eta} \text{ with } \operatorname{div} \Delta^2 \boldsymbol{\eta} = 0 \text{ in } \mathbb{R}^3_+.$$

However, we have the following estimate

$$||\psi||_{\mathbf{W}_{0}^{1,3}(\mathbb{R}^{3}_{+})} + ||\psi||_{\mathbf{L}^{\infty}(\mathbb{R}^{3}_{+})} + ||\eta||_{\mathbf{W}_{0}^{2,3}(\mathbb{R}^{3}_{+})} \leq C ||\varphi||_{\mathbf{W}_{0}^{1,3}(\mathbb{R}^{3}_{+})}$$

Proof. From the hypothesis, we have div $\varphi \in L^3(\mathbb{R}^3_+)$. Thanks to Theorem 2.1, there exists ψ in $\overset{\circ}{\mathbf{W}}_0^{1,3}(\mathbb{R}^3_+) \cap \mathbf{L}^{\infty}(\mathbb{R}^3_+)$ such that div $\psi = \operatorname{div} \varphi$ and we have the following estimate

$$||\psi||_{\mathbf{L}^{\infty}(\mathbb{R}^{3}_{+})} + ||\psi||_{\mathbf{W}^{1,3}_{0}(\mathbb{R}^{3}_{+})} \leq C ||\operatorname{div} \varphi||_{L^{3}(\mathbb{R}^{3}_{+})}.$$

We set $\boldsymbol{f} = \boldsymbol{\varphi} - \boldsymbol{\psi}$, then $\boldsymbol{f} \in \overset{\circ}{\mathbf{W}}_{0}^{1,3}(\mathbb{R}^{3}_{+})$ and div $\boldsymbol{f} = 0$. We extend \boldsymbol{f} to \mathbb{R}^{3} as follows

$$\widetilde{\boldsymbol{f}}(\boldsymbol{x}', x_3) = \begin{cases} \boldsymbol{f}(\boldsymbol{x}', x_3) & \text{if } x_3 > 0, \\ (f_1(\boldsymbol{x}', -x_3), f_2(\boldsymbol{x}', -x_3), -f_3(\boldsymbol{x}', -x_3)) & \text{if } x_3 < 0. \end{cases}$$

Then we have $\tilde{f} \in \mathbf{W}_0^{1,3}(\mathbb{R}^3)$ and $\operatorname{div} \tilde{f} = 0$ in \mathbb{R}^3 . Thanks to [2], there exists $\mathbf{y} \in \mathbf{W}_0^{2,3}(\mathbb{R}^3)$ such that $-\Delta \mathbf{y} = \operatorname{curl} \tilde{f}$ in \mathbb{R}^3 . As $\operatorname{div} \mathbf{y} \in W_0^{1,3}(\mathbb{R}^3)$ and is harmonic, then $\operatorname{div} \mathbf{y} = a$ where a is a constant. Thus, we have $\operatorname{curl}(\operatorname{curl} \mathbf{y} - \tilde{f}) = \mathbf{0}$. Therfore, we deduce $-\Delta(\operatorname{curl} \mathbf{y}) = \operatorname{curl}\operatorname{curl} \tilde{f} = -\Delta \tilde{f}$, it means that $\tilde{f} - \operatorname{curl} \mathbf{y} \in \mathbf{W}_0^{1,3}(\mathbb{R}^3)$ and again, $\tilde{f} - \operatorname{curl} \mathbf{y} = \mathbf{b}$ where \mathbf{b} is a constant vector in \mathbb{R}^3 . Thanks to Lemma 3.1 [7], there exists a polynomial $\mathbf{s} \in \mathscr{P}_1$ such that $\operatorname{curl} \mathbf{s} = \mathbf{b}$ and $\operatorname{div} \mathbf{s} = -a$. The function $\mathbf{z} := \mathbf{y} + \mathbf{s}$ belongs to $\mathbf{W}_0^{2,3}(\mathbb{R}^3)$ and $\tilde{f} = \operatorname{curl} \mathbf{z}$ in \mathbb{R}^3 with $\operatorname{div} \mathbf{z} = 0$ in \mathbb{R}^3 . Let \mathbf{w} be the vector field defined on \mathbb{R}^3_- by $\mathbf{w}(\mathbf{x}', \mathbf{x}_3) = (-z_1(\mathbf{x}', \mathbf{x}_3), -z_2(\mathbf{x}', \mathbf{x}_3), z_3(\mathbf{x}', \mathbf{x}_3))$ with $x_3 < 0$. It is easy to show $\operatorname{curl} \mathbf{w} = \operatorname{curl} \mathbf{z}$ in \mathbb{R}^3_- . Then we have

$$\boldsymbol{w} = \boldsymbol{z} + \nabla \theta \quad \text{in } \mathbb{R}^3_- \tag{11}$$

with $\theta \in \mathcal{D}'(\mathbb{R}^3_-)$. As $\nabla \theta$ belongs to $\mathbf{W}_0^{1,3}(\mathbb{R}^3_-)$, we can show $\theta \in W_0^{2,3}(\mathbb{R}^3_-)$. Let $\theta_0 \in W_0^{2,3}(\mathbb{R}^3_+)$ (cf. [3]) such that $\Delta \theta_0 = 0$ in \mathbb{R}^3_+ and $\theta_0 = \theta$ on Γ . We set $\boldsymbol{\zeta} = \boldsymbol{z} - \frac{1}{2}\nabla\theta_0$. Then we have $\operatorname{curl}\boldsymbol{\zeta} = \boldsymbol{f}$ and $\operatorname{div}\boldsymbol{\zeta} = 0$ in \mathbb{R}^3_+ . Remark now that from (11), we deduce $2\boldsymbol{z}' = \nabla'\theta = \nabla'\theta_0$ on Γ , *i.e.*, $\boldsymbol{\zeta}' = \boldsymbol{0}$ on Γ . Let $\chi \in W_0^{3,3}(\mathbb{R}^3_+)$ be a solution of the system: $\Delta^2\chi = 0$ in \mathbb{R}^3_+ , $\chi =$ 0 and $\frac{\partial\chi}{\partial x_3} = \zeta_3$ on Γ . We set $\boldsymbol{h} = \boldsymbol{\zeta} - \nabla\chi$. Then $\boldsymbol{h} \in \mathbf{W}_0^{2,3}(\mathbb{R}^3_+)$ such that $\boldsymbol{f} = \operatorname{curl}\boldsymbol{h}$ and $\operatorname{div}\Delta\boldsymbol{h} = 0$ in \mathbb{R}^3_+ , $\boldsymbol{h} = \boldsymbol{0}$ on Γ . We know that there exists $\mu \in W_0^{3,3}(\mathbb{R}^3_+)$ satisfying $\Delta^3\mu = 0$ in \mathbb{R}^3_+ , $\frac{\partial\mu}{\partial x_3} = 0$ and $\frac{\partial^2\mu}{\partial x_3^2} = \frac{\partial h_3}{\partial x_3}$ on Γ . We set $\boldsymbol{\eta} = \boldsymbol{h} - \nabla\mu$. Then $\boldsymbol{\eta} \in \mathbf{W}_0^{2,3}(\mathbb{R}^3_+)$, $\operatorname{curl}\boldsymbol{\eta} = \boldsymbol{f}$ in \mathbb{R}^3_+ and $\boldsymbol{\eta} = \boldsymbol{0}$ on Γ . It is easy to show that $\frac{\partial\eta}{\partial x_3} = 0$ on Γ and then $\boldsymbol{\eta} \in \overset{\circ}{\mathbf{W}}_0^{2,3}(\mathbb{R}^3_+)$. The proof is finished.

We introduce the following proposition.

Proposition 2.6. Let $\mathbf{f} \in \mathbf{L}^1(\mathbb{R}^3_+)$ such that $\operatorname{div} \mathbf{f} = 0$ in \mathbb{R}^3_+ . Then there exists a unique $\boldsymbol{\varphi} \in \mathbf{L}^{3/2}(\mathbb{R}^3_+)$ such that $\operatorname{curl} \boldsymbol{\varphi} = \mathbf{f}$, $\operatorname{div} \boldsymbol{\varphi} = 0$ in \mathbb{R}^3_+ and $\varphi_3 = 0$ on Γ satisfying the following estimate

$$\|\varphi\|_{\mathbf{L}^{3/2}(\mathbb{R}^3_+)} \leq C \|f\|_{\mathbf{L}^1(\mathbb{R}^3_+)}.$$

Proof. It is easy to show the uniqueness of φ . We now try to prove the existence of φ . We know that $\boldsymbol{f} \in \mathbf{W}_0^{-1,3/2}(\mathbb{R}^3_+)$. Then, there exists a unique $\boldsymbol{z} \in \overset{\circ}{\mathbf{W}}_0^{1,3/2}(\mathbb{R}^3_+)$ satisfying $-\Delta \boldsymbol{z} = \boldsymbol{f}$, with div $\boldsymbol{z} = 0$ in \mathbb{R}^3_+ . The function $\varphi = \operatorname{curl} \boldsymbol{z}$ is the required function.

A variant of this result can be obtained. If $\mathbf{f} \in \mathbf{L}^1(\mathbb{R}^3_+)$ such that $\operatorname{div} \mathbf{f} = 0$ in \mathbb{R}^3_+ and $f_3 = 0$ on Γ , then we can prove the existence of a unique $\varphi \in \mathbf{L}^{3/2}(\mathbb{R}^3_+)$ such that $\mathbf{f} = \operatorname{curl} \varphi$ with $\operatorname{div} \varphi = 0$ in \mathbb{R}^3_+ and $\varphi' = \mathbf{0}$ on Γ .

More generally, we can prove the following result.

Theorem 2.7. i) Let $\mathbf{f} \in \mathbf{L}^1(\mathbb{R}^3_+) + \mathbf{W}_0^{-1,3/2}(\mathbb{R}^3_+)$ such that div $\mathbf{f} = 0$. Then there exists a unique $\boldsymbol{\varphi} \in \mathbf{L}^{3/2}(\mathbb{R}^3_+)$ such that $\operatorname{curl} \boldsymbol{\varphi} = \mathbf{f}$ with div $\boldsymbol{\varphi} = 0$ in \mathbb{R}^3_+ and $\varphi_3 = 0$ on Γ satisfying the following estimate

$$\| \varphi \|_{\mathbf{L}^{3/2}(\mathbb{R}^3_+)} \le C \| f \|_{\mathbf{L}^1(\mathbb{R}^3_+) + \mathbf{W}_0^{-1,3/2}(\mathbb{R}^3_+)}$$

ii) Let $\mathbf{f} \in \mathbf{X}(\mathbb{R}^3_+)$. Then there exists a unique $\boldsymbol{\varphi} \in \mathbf{L}^{3/2}(\mathbb{R}^3_+)$ such that div $\boldsymbol{\varphi} = 0$ with $\varphi_3 = 0$ on Γ and a unique $\pi \in L^{3/2}(\mathbb{R}^3_+)$ satisfying $\mathbf{f} = \operatorname{curl} \boldsymbol{\varphi} + \nabla \pi$ with the corresponding estimate.

Combining the above results with [1] and [3], we can solve the follow elliptical systems.

Theorem 2.8. i) Let $\mathbf{g}' \in \mathbf{L}^1(\Gamma)$ and $g_n \in W_0^{-1+\frac{1}{n},\frac{n}{n-1}}(\Gamma)$ satisfying the compatibility condition $\int_{\Gamma} \mathbf{g}' = \mathbf{0}$ and $\langle g_n, 1 \rangle = 0$. If $\operatorname{div}' \mathbf{g}' \in W_0^{-2+\frac{1}{n},\frac{n}{n-1}}(\Gamma)$, then the system

$$-\Delta \boldsymbol{u} = \boldsymbol{0} \text{ in } \mathbb{R}^n_+ \text{ and } \boldsymbol{u} = \boldsymbol{g} \text{ on } \Gamma$$
 (12)

has a unique very weak solution $\mathbf{u} \in \mathbf{L}^{n/(n-1)}(\mathbb{R}^n_+)$. ii) Let $\mathbf{f} \in \mathbf{L}^1(\mathbb{R}^n_+)$, $\mathbf{g}' \in \mathbf{L}^1(\Gamma)$ and $g_n \in W_0^{-1+\frac{1}{n},\frac{n}{n-1}}(\Gamma)$ satisfying the compatibility condition $\int_{\mathbb{R}^n_+} \mathbf{f}' + \int_{\Gamma} \mathbf{g}' = \mathbf{0}$ and $\int_{\mathbb{R}^n_+} f_n + \langle g_n, 1 \rangle = 0$. If

$$[\boldsymbol{f}, \boldsymbol{g}'] = \sup_{\boldsymbol{\xi} \in W_0^{2,n}(\mathbb{R}^n_+), \ \boldsymbol{\xi} \neq 0} \frac{\left| \int_{\mathbb{R}^n_+} \boldsymbol{f} \cdot \nabla \boldsymbol{\xi} + \int_{\Gamma} \boldsymbol{g}' \cdot \nabla' \boldsymbol{\xi} \right|}{||\boldsymbol{\xi}||_{W_0^{2,n}(\mathbb{R}^n_+)}} < \infty$$

then the system

$$-\Delta \boldsymbol{u} = \boldsymbol{f} \text{ in } \mathbb{R}^n_+ \text{ and } \frac{\partial \boldsymbol{u}}{\partial x_n} = \boldsymbol{g} \text{ on } \Gamma$$
 (13)

has a unique solution $\mathbf{u} \in \mathbf{W}_{0}^{1,n/(n-1)}(\mathbb{R}^{n}_{+})$. *iii)* Let $\mathbf{f} \in \mathbf{L}^{1}(\mathbb{R}^{n}_{+})$ such that $\operatorname{div} \mathbf{f} \in [W_{0}^{2,n}(\mathbb{R}^{n}_{+}) \cap \overset{\circ}{W}_{-1}^{1,n}(\mathbb{R}^{n}_{+})]'$ and $\int_{\mathbb{R}^{n}_{+}} f_{n} = 0$. Then $\mathbf{f} \in \mathbf{W}_{0}^{-1,n/(n-1)}(\mathbb{R}^{n}_{+})$ and the system

$$-\Delta \boldsymbol{u} = \boldsymbol{f} \text{ in } \mathbb{R}^n_+; \quad \boldsymbol{u}' = \boldsymbol{0} \quad \text{and} \quad \frac{\partial u_n}{\partial x_n} = 0 \quad \text{on } \Gamma$$
 (14)

has a unique solution $\mathbf{u} \in \mathbf{W}_0^{1,n/(n-1)}(\mathbb{R}^n_+)$. iv) Let $\mathbf{f} \in \mathbf{L}^1(\mathbb{R}^n_+)$ such that $\int_{\mathbb{R}^n_+} \mathbf{f}' = \mathbf{0}$. If

holds, then the system

$$-\Delta \boldsymbol{u} = \boldsymbol{f} \text{ in } \mathbb{R}^n_+, \quad u_n = 0 \text{ and } \frac{\partial \boldsymbol{u}'}{\partial x_n} = \boldsymbol{0} \text{ on } \Gamma$$

has a unique solution $\boldsymbol{u} \in \mathbf{W}_0^{1,n/(n-1)}(\mathbb{R}^n_+)$.

Proof. We will prove only the first point i).

Step 1: The proof will be started by showing $\boldsymbol{g}' \in \mathbf{W}_0^{-1+\frac{1}{n},\frac{n}{n-1}}(\Gamma)$. Let $\boldsymbol{\mu} \in \boldsymbol{\mathcal{D}}(\Gamma)$ and $\boldsymbol{\varphi} \in \mathbf{W}_0^{1,n}(\mathbb{R}^n_+)$ such that $\boldsymbol{\varphi} = \boldsymbol{\mu}$ on Γ . Thanks to Theorem 2.2, there exist $\boldsymbol{\psi} \in \mathbf{W}_0^{1,n}(\mathbb{R}^n_+) \cap \mathbf{L}^{\infty}(\mathbb{R}^n_+)$ and $\eta \in W_0^{2,n}(\mathbb{R}^n_+)$ such that $\psi_n = 0$ on Γ satisfying $\boldsymbol{\varphi} = \boldsymbol{\psi} + \nabla \eta$ and the estimate

$$||\psi||_{\mathbf{L}^{\infty}(\mathbb{R}^{n}_{+})} + ||\psi||_{\mathbf{W}^{1,n}_{0}(\mathbb{R}^{n}_{+})} + ||\eta||_{W^{2,n}_{0}(\mathbb{R}^{n}_{+})} \leq C||\varphi||_{\mathbf{W}^{1,n}_{0}(\mathbb{R}^{n}_{+})}.$$
 (15)

Then

$$< \boldsymbol{g}, \boldsymbol{\mu} >_{\boldsymbol{\mathcal{D}}'(\Gamma) \times \boldsymbol{\mathcal{D}}(\Gamma)} = \int_{\Gamma} \boldsymbol{g}' \cdot \boldsymbol{\psi}' - < \operatorname{div}' \boldsymbol{g}', \eta >_{W_0^{-2+\frac{1}{n}, \frac{n}{n-1}}(\Gamma) \times W_0^{2-\frac{1}{n}, n}(\Gamma)} + < \boldsymbol{g}_n, \varphi_n >_{W_0^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma) \times W_0^{1-\frac{1}{n}, n}(\Gamma)}$$

and

$$\begin{split} | < g, \mu >_{\mathcal{D}'(\Gamma) \times \mathcal{D}(\Gamma)} | & \leq ||g'||_{\mathbf{L}^{1}(\Gamma)} ||\psi'||_{\mathbf{L}^{\infty}(\mathbb{R}^{n}_{+})} + ||\operatorname{div}'g'||_{W_{0}^{-2+\frac{1}{n},\frac{n}{n-1}}(\Gamma)} \times \\ & \times ||\eta||_{W_{0}^{2,n}(\mathbb{R}^{n}_{+})} + ||g_{n}||_{W_{0}^{-1+\frac{1}{n},\frac{n}{n-1}}(\Gamma)} ||\varphi_{n}||_{W_{0}^{1-\frac{1}{n},n}(\Gamma)} \end{split}$$

Thanks to the density of $\mathcal{D}(\Gamma)$ in $\mathbf{W}_0^{1-\frac{1}{n},n}(\Gamma)$ and (15), we can deduce $g' \in \mathbf{W}_0^{-1+\frac{1}{n},\frac{n}{n-1}}(\Gamma)$.

Step 2: The system (13) is equivalent to the following one: Find \boldsymbol{u} belonging $\mathbf{L}^{n/(n-1)}(\mathbb{R}^n_+)$ such that for all $\boldsymbol{v} \in \mathbf{W}^{2,n}_0(\mathbb{R}^n_+) \cap \overset{\circ}{\mathbf{W}}^{1,n}_{-1}(\mathbb{R}^n_+)$,

$$\int_{\mathbb{R}^n_+} \boldsymbol{u} \cdot \Delta \boldsymbol{v} = - < \boldsymbol{g}, \frac{\partial \boldsymbol{v}}{\partial \boldsymbol{n}} >_{\mathbf{W}_0^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma) \times \mathbf{W}_0^{1-\frac{1}{n}, n}(\Gamma)}$$

But for all $\boldsymbol{F} \in \mathbf{L}^{n}(\mathbb{R}^{n}_{+})$, there exists $\boldsymbol{v} \in \mathbf{W}_{0}^{2,n}(\mathbb{R}^{n}_{+}) \cap \overset{\circ}{\mathbf{W}}_{-1}^{1,n}(\mathbb{R}^{n}_{+})$, unique up to an element of $x_{n}\mathbb{R}^{n}$, such that $-\Delta \boldsymbol{v} = \boldsymbol{F}$ in \mathbb{R}^{n}_{+} , $\boldsymbol{v} = \mathbf{0}$ on Γ and the following estimate holds

$$||\boldsymbol{v}||_{\mathbf{W}_0^{2,n}(\mathbb{R}^n_+)/x_n\mathbb{R}^n} \leq C||\boldsymbol{F}||_{\mathbf{L}^n(\mathbb{R}^n_+)}.$$

Then, we have for all $\boldsymbol{a} \in \mathbb{R}^n$,

$$\begin{split} &| < \boldsymbol{g}, \frac{\partial \boldsymbol{v}}{\partial x_n} >_{\mathbf{W}_0^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma) \times \mathbf{W}_0^{1-\frac{1}{n}, n}(\Gamma)} \mid \\ &= | < \boldsymbol{g}, \frac{\partial (\boldsymbol{v} + \boldsymbol{a} x_n)}{\partial x_n} >_{\mathbf{W}_0^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma) \times \mathbf{W}_0^{1-\frac{1}{n}, n}(\Gamma)} \\ &\leq C ||\boldsymbol{g}||_{\mathbf{W}_0^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma)} ||\boldsymbol{v} + \boldsymbol{a} x_n||_{\mathbf{W}_0^{2, n}(\mathbb{R}^n_+)}. \end{split}$$

Consequently, taking the infinum, we have

$$| < \boldsymbol{g}, \frac{\partial \boldsymbol{v}}{\partial x_n} >_{\mathbf{W}_0^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma) \times \mathbf{W}_0^{1-\frac{1}{n}, n}(\Gamma)} | \leq C ||\boldsymbol{g}||_{\mathbf{W}_0^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma)} ||\boldsymbol{F}||_{\mathbf{L}^n(\mathbb{R}^n_+)}.$$

Then, the linear operator

$$T: \boldsymbol{F} \longrightarrow \langle \boldsymbol{g}, \frac{\partial \boldsymbol{v}}{\partial x_n} \rangle_{\mathbf{W}_0^{-1+\frac{1}{n}, \frac{n}{n-1}}(\Gamma) \times \mathbf{W}_0^{1-\frac{1}{n}, n}(\Gamma)}$$

is continuous on $\mathbf{L}^{n}(\mathbb{R}^{n}_{+})$ and thanks to the Riesz representation theorem, there exists a unique $\boldsymbol{u} \in \mathbf{L}^{n/(n-1)}(\mathbb{R}^{n}_{+})$ such that $T(\boldsymbol{F}) = \int_{\mathbb{R}^{n}_{+}} \boldsymbol{u} \cdot \boldsymbol{F}$, *i.e.*, \boldsymbol{u} is the solution of (13).
