# DENSE ORBITS FOR ABELIAN AFFINE GROUPS 

ADLENE AYADI


#### Abstract

In this paper, we give a characterization of existence of a dense orbit for the action on $\mathbb{C}^{n}$ of an abelian affine subgroup $\mathcal{G}$ of $G A(n, \mathbb{C})$. We prove in particular that if $\mathcal{G}$ has a dense orbit then the closure $\overline{\mathcal{G}}$ is an affine space of dimension $n$. If $\mathcal{G}$ is finitely generated, this characterization is explicit.


## 1. Introduction

Let $M_{n}(\mathbb{C})$ be the set of all square matrices of order $n \geq 1$ with entries in $\mathbb{C}$ and $G L(n, \mathbb{C})$ be the group of all invertible matrices of $M_{n}(\mathbb{C})$. A map $f: \mathbb{C}^{n} \longrightarrow \mathbb{C}^{n}$ is called an affine map if there exist $A \in M_{n}(\mathbb{C})$ and $a \in \mathbb{C}^{n}$ such that $f(x)=A x+a$, $x \in \mathbb{C}^{n}$. We denote $f=(A, a)$, we call $A$ the linear part of $f$. Denote by $M A(n, \mathbb{C})$ the set of all affine maps and $G A(n, \mathbb{C})$ the set of all invertible affine maps of $M A(n, \mathbb{C}) . M A(n, \mathbb{C})$ is a vector space and for composition of maps, $G A(n, \mathbb{C})$ is a group.

Let $\mathcal{G}$ be an abelian affine subgroup of $G A(n, \mathbb{C})$. For a vector $v \in \mathbb{C}^{n}$, we consider the orbit of $\mathcal{G}$ through $v: \mathcal{G}(v)=\{f(v): f \in \mathcal{G}\} \subset \mathbb{C}^{n}$. A subset $E \subset \mathbb{C}^{n}$ is called $\mathcal{G}$-invariant if $f(E) \subset E$ for any $f \in \mathcal{G}$; that is $E$ is a union of orbits. Before stating our main results, we introduce the following notions:

A subset $\mathcal{H}$ of $\mathbb{C}^{n}$ is called an affine subspace of $\mathbb{C}^{n}$ if there exist a vector subspace $H$ of $\mathbb{C}^{n}$ and $a \in \mathbb{C}^{n}$ such that $\mathcal{H}=H+a$. For $a \in \mathbb{C}^{n}$, denote by $T_{a}: \mathbb{C}^{n} \longrightarrow \mathbb{C}^{n}$; $x \longmapsto x+a$ the translation map by vector $a$, so $\mathcal{H}=T_{a}(H)$. We say that $\mathcal{H}$ has dimension $p(0 \leq p \leq n)$, denoted $\operatorname{dim}(\mathcal{H})=p$, if $H$ has dimension $p$.

Denote by $\bar{A}$ the closure of a subset $A \subset \mathbb{C}^{n}$. A subset $E$ of $\mathbb{C}^{n}$ is called $a$ minimal set of $\mathcal{G}$ if $E$ is closed in $\mathbb{C}^{n}$, non empty, $\mathcal{G}$-invariant and has no proper subset with these properties. It is equivalent to say that $E$ is a $\mathcal{G}$-invariant set such that every orbit contained in $E$ is dense in it.

If $V$ is a $\mathcal{G}$-invariant open set in $\mathbb{C}^{n}$, we say that $E$ is a minimal set in $V$ if it is a minimal set of the restriction $\mathcal{G}_{/ V}$ of $\mathcal{G}$ to $V$.

Define the map

\Phi: G A(n, \mathbb{C}) \longrightarrow \Phi(G A(n, \mathbb{C})) \subset G L(n+1, \mathbb{C})
$$

We have the following composition formula

Then $\Phi$ is a homomorphism of groups.
Let $\mathcal{G}$ be an abelian affine subgroup of $G A(n, \mathbb{C})$. Then $\Phi(\mathcal{G})$ is an abelian subgroup of $G L(n+1, \mathbb{C})$.

Let $\pi: \mathbb{C}^{n} \longrightarrow\{1\} \times \mathbb{C}^{n}$ be the map defined by $\pi(y)=(1, y)$. Clearly $\pi$ is an invertible affine maps and we have for every $x \in \mathbb{C}^{n}$,

\pi(\mathcal{G}(x))=\Phi(\mathcal{G})(1, x)=\{1\} \times \mathcal{G}(x) \subset\{1\} \times \mathbb{C}^{n}
$$

Let $n \in \mathbb{N}_{0}$ be fixed. For each $m=1,2, \ldots, n+1$, denote by:

- $\mathbb{C}^{*}=\mathbb{C} \backslash\{0\}$ and $\mathbb{N}_{0}=\mathbb{N} \backslash\{0\}$.
- $\mathcal{B}_{0}=\left(e_{1}, \ldots, e_{n+1}\right)$ the canonical basis of $\mathbb{C}^{n+1}$ and $I_{n+1}$ the identity matrix of $G L(n+1, \mathbb{C})$.
- $\mathbb{T}_{m}(\mathbb{C})$ the set of matrices over $\mathbb{C}$ of the form

- $\mathbb{T}_{m}^{*}(\mathbb{C})$ the group of matrices of the form (1) with $\mu \neq 0$.

Let $r \in \mathbb{N}$ and $\eta=\left(n_{1}, \ldots, n_{r}\right)$ be a sequence of positive integers such that $n_{1}+\cdots+n_{r}=n+1$. In particular, $r \leq n+1$.
Write

- $\mathcal{K}_{\eta, r}(\mathbb{C}):=\mathbb{T}_{n_{1}}(\mathbb{C}) \oplus \cdots \oplus \mathbb{T}_{n_{r}}(\mathbb{C})$. In particular if $r=1$, then $\mathcal{K}_{\eta, 1}(\mathbb{C})=\mathbb{T}_{n+1}(\mathbb{C})$ and $\eta=(n+1)$.
- $\mathcal{K}_{\eta, r}^{*}(\mathbb{C}):=\mathcal{K}_{\eta, r}(\mathbb{C}) \cap \mathrm{GL}(n+1, \mathbb{C})$.

Define the map

$$

\Psi: M A(n, \mathbb{C}) & \longrightarrow \Psi(G A(n, \mathbb{C})) \subset M_{n+1}(\mathbb{C}) \\
f & =(A, a)
\end{aligned}>\left[\begin{array}{ll}

\end{array}\right]
$$

We have $\Psi$ is an isomorphism. Remark that $\Phi(f)=\Psi(f)+D_{1}$, where $D_{1}=$ $\left[\begin{array}{ll}1 & 0 \\ 0 & 0\end{array}\right] \in M_{n+1}(\mathbb{C}), f \in G A(n, \mathbb{C})$, so $\Phi$ is an affine map.
Denote by:

- $\mathcal{F}_{n+1}=\left\{\left[\begin{array}{ll}0 & 0 \\ b & B\end{array}\right] \in M_{n+1}(\mathbb{C}), \quad B \in M_{n}(\mathbb{C}), b \in \mathbb{C}^{n}\right\}=\Psi(M A(n, \mathbb{C}))$.
- $\exp : \mathbb{M}_{n+1}(\mathbb{C}) \longrightarrow \mathrm{GL}(n+1, \mathbb{C})$ is the matrix exponential map; set $\exp (M)=$ $e^{M}$.

There always exists a $P \in \Phi(\operatorname{GA}(n, \mathbb{C}))$ and a partition $\eta$ of $n+1$ such that $G^{\prime}=P^{-1} G P \subset \mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap \Phi(G A(n, \mathbb{C})$ ) (see Proposition 2.3). For such a choice of matrix $P$, we let

- $\mathrm{g}=\exp ^{-1}(G) \cap\left(P\left(\mathcal{K}_{\eta, r}(\mathbb{C})\right) P^{-1}\right) \cap \mathcal{F}_{n+1}$. If $G \subset \mathcal{K}_{\eta, r}^{*}(\mathbb{C})$, we have $\mathrm{g}=$ $\exp ^{-1}(G) \cap \mathcal{K}_{\eta, r}(\mathbb{C}) \cap \mathcal{F}_{n+1}$.
- $\mathrm{g}_{u}=\{B u: B \in \mathrm{~g}\}, u \in \mathbb{C}^{n+1}$.
- $\mathfrak{g}=\Psi^{-1}(\mathrm{~g})$.
- $\mathfrak{g}_{v}=\{f(v), \quad f \in \mathfrak{g}\}, v \in \mathbb{C}^{n}$.

Let $\widetilde{\pi}: \mathbb{C}^{n} \longrightarrow\{0\} \times \mathbb{C}^{n}$ be the map defined by $\widetilde{\pi}(y)=(0, y)$. Clearly $\widetilde{\pi}$ is an isomorphism.

Denote by:

- $u_{0}=\left[e_{1,1}, \ldots, e_{r, 1}\right]^{T} \in \mathbb{C}^{n+1}$ where $e_{k, 1}=[1,0, \ldots, 0]^{T} \in \mathbb{C}^{n_{k}}$, for $k=1, \ldots, r$.

One has $u_{0} \in\{1\} \times \mathbb{C}^{n}$.

- $w_{0}=\pi^{-1}\left(P u_{0}\right) \in \mathbb{C}^{n}$. As $P \in \Phi(G A(n, \mathbb{C})), P u_{0} \in\{1\} \times \mathbb{C}^{n}$. So $\pi\left(w_{0}\right)=$ $\left(1, w_{0}\right)=P u_{0}$.
- $e^{(k)}=\left[e_{1}^{(k)}, \ldots, e_{r}^{(k)}\right]^{T} \in \mathbb{C}^{n+1}$ where

e_{j}^{(k)}=\left\{\begin{array}{ll}
0 \in \mathbb{C}^{n_{j}} & \text { if } j \neq k \\
e_{k, 1} & \text { if } j=k
\end{array} \quad \text { for every } 1 \leq j, k \leq r\right.
$$

- $p_{2}: \mathbb{C}^{n+1} \longrightarrow \mathbb{C}^{n}$ the projection defined by $p_{2}\left(x_{1}, \ldots, x_{n+1}\right)=\left(x_{2}, \ldots, x_{n+1}\right)$.

Notice that $\pi^{-1}$ is the restriction of $p_{2}$ to $\{1\} \times \mathbb{C}^{n}$.

- $M^{T}$ is the transpose of any $M \in M_{m}(\mathbb{C}), m \leq n+1$.
- $\overline{\mathcal{G}}$ is the closure of $\mathcal{G}$ in $M A(n, \mathbb{C})$, which is considered as a vector space with the norm defined by $\|f\|=\max (\|A\|,\|a\|)$ the maximum of $\|A\|$ and $\|a\|$, for every $f=(A, a) \in M A(n, \mathbb{C})$.

For a finitely generated subgroup $\mathcal{G} \subset \mathrm{GA}(n, \mathbb{R})$, let introduce the following property. Consider the following rank condition on a collection of affine maps $f_{1}, \ldots, f_{p} \in G A(n, \mathbb{C})$, where $f_{1}^{\prime}, \ldots, f_{p}^{\prime} \in \mathfrak{g}$ such that $e^{\Psi\left(f_{k}^{\prime}\right)}=\Phi\left(f_{k}\right), k=$ $1, \ldots, p$.

We say that $f_{1}, \ldots, f_{p}$ satisfy property $\mathcal{D}$ if for every $\left(s_{1}, \ldots, s_{p} ; t_{1}, \ldots, t_{r}\right) \in$ $\mathbb{Z}^{p+r} \backslash\{0\}$ :

\operatorname{Re}\left(f_{1}^{\prime}\left(w_{0}\right)\right) & \ldots & \operatorname{Re}\left(f_{p}^{\prime}\left(w_{0}\right)\right) & 0 & \ldots & 0 \\
\operatorname{Im}\left(f_{1}^{\prime}\left(w_{0}\right)\right) & \ldots & \operatorname{Im}\left(f_{p}^{\prime}\left(w_{0}\right)\right) & 2 \pi e^{(1)} & \ldots & 2 \pi e^{(r)} \\
s_{1} & \ldots & s_{p} & t_{1} & \ldots & t_{r}
\end{array}\right]=n+1
$$

For a vector $v \in \mathbb{C}^{n}$, we write $v=\operatorname{Re}(v)+i \operatorname{Im}(v)$ where $\operatorname{Re}(v)$ and $\operatorname{Im}(v) \in \mathbb{R}^{n}$.

For groups of affine maps on $\mathbb{K}^{n}(\mathbb{K}=\mathbb{R}$ or $\mathbb{C})$, their dynamics were recently initiated for some classes in different point of view, (see for instance, (3], (4), [5], [6]). The purpose here is to give analogous results of that theorem for linear abelian subgroup of $G L(n, \mathbb{C})$ proved in [1]. Our main results are the following:

Theorem 1.1. Let $\mathcal{G}$ be an abelian subgroup of $G A(n, \mathbb{C})$. The following are equivalent:
(i) $\mathcal{G}$ has a dense orbit in $\mathbb{C}^{n}$
(ii) The orbit $\mathcal{G}\left(w_{0}\right)$ is dense in $\mathbb{C}^{n}$
(iii) $\mathfrak{g}_{w_{0}}$ is an additive subgroup dense in $\mathbb{C}^{n}$

Corollary 1.2. If $\mathcal{G}$ has a dense orbit then $\overline{\mathcal{G}}$ is an affine subspace of $G A(n, \mathbb{C})$ of dimension $n$.

For a finitely generated subgroup $\mathcal{G}$, the Theorem can be stated as follows:
Theorem 1.3. Let $\mathcal{G}$ be an abelian subgroup of $G A(n, \mathbb{C})$ generated by $f_{1}, \ldots, f_{p}$ and let $f_{1}^{\prime}, \ldots, f_{p}^{\prime} \in \mathfrak{g}$ such that $e^{\Psi\left(f_{1}^{\prime}\right)}=\Phi\left(f_{1}\right), \ldots, e^{\Psi\left(f_{p}^{\prime}\right)}=\Phi\left(f_{p}\right)$. Then the following are equivalent:
(i) $\mathcal{G}$ has a dense orbit in $\mathbb{C}^{n}$
(ii) the maps $f_{1}, \ldots, f_{p}$ satisfy property $\mathcal{D}$
(iii) $\mathfrak{g}_{w_{0}}=\sum_{k=1}^{p} \mathbb{Z} f_{k}^{\prime}\left(w_{0}\right)+2 i \pi \sum_{k=1}^{r} \mathbb{Z}\left(p_{2} \circ P e^{(k)}\right)$ is an additive group dense in $\mathbb{C}^{n}$.

Corollary 1.4. If $\mathcal{G}$ is of finite type $p$ with $p \leq 2 n-r$, then it has no dense orbit.

Corollary 1.5. If $\mathcal{G}$ is of finite type $p$ with $p \leq n$, then it has no dense orbit.

## 2. Notations and Lemmas

Denote by $\mathcal{L}_{\mathcal{G}}$ the set of the linear parts of all elements of $\mathcal{G}$ and $\operatorname{vect}(F)$ is the vector space generated by a subset $F \subset \mathbb{C}^{n+1}$.

Lemma 2.1. Let $P \in \Phi(G A(n, \mathbb{C}))$ and $h: M_{n+1}(\mathbb{C}) \longrightarrow M_{n+1}(\mathbb{C})$ the isomorphism defined by $h(A)=P A P^{-1}$. Then $h\left(\mathcal{F}_{n+1}\right)=\mathcal{F}_{n+1}$ and $h(\Phi(G A(n, \mathbb{C})))=$ $\Phi(G A(n, \mathbb{C}))$.

Proof. Let $f=(A, a) \in M A(n, \mathbb{C})$. As $P \in \Phi(G A(n, \mathbb{C}))$, write

\end{array}\right], C \in G L(n, \mathbb{C}), d \in \mathbb{C}^{n}
$$

Then

$$

h(\Psi(f)) & =\left[\begin{array}{ll}
1 & 0 \\
d & C
\end{array}\right]\left[\begin{array}{cc}
0 & 0 \\
a & A
\end{array}\right]\left[\begin{array}{cc}
1 & 0 \\
-C^{-1} d & C^{-1}
\end{array}\right] \\
& =\left[\begin{array}{cc}
0 & 0 \\
d+C a-C A C^{-1} d & C A C^{-1}
\end{array}\right]
\end{aligned}
$$

so $h(\Psi(f)) \in \mathcal{F}_{n+1}$. It follows that $h\left(\mathcal{F}_{n+1}\right) \subset \mathcal{F}_{n+1}$. Conversely, let $h^{\prime}=h^{-1}$, so $h^{\prime}: M_{n+1}(\mathbb{C}) \longrightarrow M_{n+1}(\mathbb{C})$ is the isomorphism defined by $h(B)=P^{-1} B P$. By replacing $h$ by $h^{\prime}$ in above, we have $h^{\prime}\left(\mathcal{F}_{n+1}\right) \subset \mathcal{F}_{n+1}$. It follows that

$$
\mathcal{F}_{n+1}=h \circ h^{\prime}\left(\mathcal{F}_{n+1}\right) \subset h\left(\mathcal{F}_{n+1}\right)
$$

The same proof is used to show $h(\Phi(G A(n, \mathbb{C})))=\Phi(G A(n, \mathbb{C}))$.

Proposition 2.2. (11], Proposition 2.3) Let $G$ be an abelian subgroup of $G L(n, \mathbb{C})$. Then there exists $P \in G L(n, \mathbb{C})$ such that $P^{-1} G P$ is a subgroup of $\mathcal{K}_{\eta^{\prime}, r^{\prime}}(\mathbb{C})$, for some $r^{\prime} \leq n$ and $\eta^{\prime}=\left(n_{1}^{\prime}, \ldots, n_{r^{\prime}}^{\prime}\right) \in \mathbb{N}_{0}^{r^{\prime}}$.

Proposition 2.3. Let $\mathcal{G}$ be an abelian subgroup of $G A(n, \mathbb{C})$ and $G=\Phi(\mathcal{G})$. Then there exists $P \in \Phi(G A(n, \mathbb{C}))$ such that $P^{-1} G P$ is a subgroup of $\mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap$ $\Phi(G A(n, \mathbb{C}))$, for some $r \leq n+1$ and $\eta^{\prime}=\left(n_{1}, \ldots, n_{r}\right) \in \mathbb{N}_{0}^{r}$. In particular, $P u_{0} \in\{1\} \times \mathbb{C}^{n}$.

Proof. We have $\mathcal{L}_{\mathcal{G}}$ is an abelian subgroup of $G L(n, \mathbb{C})$. By Proposition 2.2, there exists $P_{1} \in G L(n, \mathbb{C})$ such that $P_{1}^{-1} G P_{1}$ is a subgroup of $\mathcal{K}_{\eta^{\prime}, r^{\prime}}^{*}(\mathbb{C})$ for some $r^{\prime} \leq n$ and $\eta^{\prime}=\left(n_{1}^{\prime}, \ldots, n_{r^{\prime}}^{\prime}\right) \in \mathbb{N}_{0}^{r^{\prime}}$ such that $n_{1}^{\prime}+\ldots, n_{r^{\prime}}^{\prime}=n$. Write for every $A \in \mathcal{L}_{\mathcal{G}}$, $P_{1}^{-1} A P_{1}=\operatorname{diag}\left(A_{1}, \ldots, A_{r^{\prime}}^{\prime}\right)$ with $A_{k} \in \mathbb{T}_{n_{k}^{\prime}}^{*}$ and $\mu_{A_{k}}$ is the only eigenvalue of $A_{k}$, $k=1, \ldots, r^{\prime}$. Let $J=\left\{k \in\left\{1, \ldots, r^{\prime}\right\}, \quad \mu_{A_{k}}=1, \forall A \in \mathcal{L}_{\mathcal{G}}\right\}$. There are two cases:

- Case1: Suppose that $J=\left\{k_{1}, \ldots, k_{s}\right\}$ for some $s \leq r^{\prime}$. We can take $J=\{1, \ldots, s\}$, otherwise, we replace $P_{1}$ by $R P_{1}$ for some permutation matrix $R$ of $G L(n, \mathbb{C})$. Let $P=\operatorname{diag}\left(1, P_{1}\right)$, so $P \in \Phi(G A(n, \mathbb{C}))$ and

P^{-1} \Phi(f) P=\left[\begin{array}{cc}
1 & 0 \\
P_{1}^{-1} a & P_{1}^{-1} A P_{1}
\end{array}\right]
$$

Write $P\left(\mathcal{B}_{0}\right)=\left(e_{1}, \mathcal{C}_{1}, \ldots, \mathcal{C}_{r^{\prime}}\right)$, where $\mathcal{C}_{k}=\left(e_{k, 1}^{\prime}, \ldots, e_{k, n_{k}^{\prime}}^{\prime}\right)$ is a basis of $\mathbb{C}^{n_{k}^{\prime}}$, $k=1, \ldots, r^{\prime}$. Then $H=\operatorname{vect}\left(e_{1}, \mathcal{C}_{1}, \ldots, \mathcal{C}_{s}\right)$ is $G$-invariant and the restriction $\Phi(f)_{/ H}$ has 1 as only eigenvalue for every $f \in \mathcal{G}$. Therefore for every $f=(A, a) \in \mathcal{G}$ we have

P^{-1} \Phi(f) P=\left[\begin{array}{cc}
A_{1} & 0 \\
0 & A_{2}
\end{array}\right]
$$

where $A_{1} \in \mathbb{T}_{q}^{*}(\mathbb{C}), q=1+n_{1}^{\prime}+\cdots+n_{s}^{\prime}$ and $A_{2} \in \mathcal{K}_{\eta^{\prime \prime}, r^{\prime}-s}(\mathbb{C})$ with $\eta^{\prime \prime}=$ $\left(n_{s+1}^{\prime}, \ldots, n_{r^{\prime}}^{\prime}\right)$. As $\mu_{A_{1}}=1$ is the only eigenvalue of $A_{1}$, so $P^{-1} \Phi(f) P \in \Phi(G A(n, \mathbb{C}))$. It follows that $P^{-1} G P$ is a subgroup of $\mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap \Phi(G A(n, \mathbb{C}))$, where $r=r^{\prime}-s+1$ and $\eta=\left(q, n_{s+1}^{\prime}, \ldots, n_{r^{\prime}}^{\prime}\right)$.

- Case:2 Suppose that $J=\emptyset$, then 1 is the commune eigenvalue of all element of $G$ and let $v$ be the commune eigenvector of all element of $G$ associated to 1 . Since $\{0\} \times \mathbb{C}^{n}$ is $G$-invariant, one has $v \in \mathbb{C}^{*} \times \mathbb{C}^{n}$, so we can take $v=\left(1, v_{1}\right), v_{1} \in \mathbb{C}^{n}$, otherwise, if $v=\left(\lambda, v_{1}^{\prime}\right)$ we replace $v$ by $\frac{1}{\lambda} v$. As $\Phi(f)\left(1, v_{1}\right)=\left(1, f\left(v_{1}\right)\right)=\left(1, v_{1}\right)$
so $f\left(v_{1}\right)=\pi^{-1}\left(\Phi(f)\left(1, v_{1}\right)\right)=\pi^{-1}\left(1, v_{1}\right)=v_{1}$, hence $f\left(v_{1}\right)=A v_{1}+a=v_{1}$. Let $P=\left[\begin{array}{cc}1 & 0 \\ v_{1} & P_{1}\end{array}\right] \in \Phi(G A(n, \mathbb{C}))$, so for every $f=(A, a) \in \mathcal{G}$

$$
\begin{aligned}
P^{-1} \Phi(f) P & =\left[\begin{array}{cc}
1 & 0 \\
-P_{1}^{-1} v_{1} & P_{1}^{-1}
\end{array}\right]\left[\begin{array}{cc}
1 & 0 \\
a & A
\end{array}\right]\left[\begin{array}{cc}
1 & 0 \\
v_{1} & P_{1}
\end{array}\right] \\
& =\left[\begin{array}{cc}
1 & 0 \\
P_{1}^{-1}\left(A v_{1}+a-v_{1}\right) & P_{1}^{-1} A P_{1}
\end{array}\right] \\
& =\left[\begin{array}{cc}
1 & 0 \\
0 & P_{1}^{-1} A P_{1}
\end{array}\right] .
\end{aligned}
$$

It follows that $P^{-1} G P$ is a subgroup of $\mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap \Phi(G A(n, \mathbb{C}))$, where $r=r^{\prime}+1$ and $\eta=\left(1, n_{1}^{\prime}, \ldots, n_{r^{\prime}}^{\prime}\right)$.
Since $u_{0} \in\{1\} \times \mathbb{C}^{n}$ and $P \in \Phi(G A(n, \mathbb{C}))$, so $P u_{0} \in\{1\} \times \mathbb{C}^{n}$.
Denote by:

- $G^{\prime}=P^{-1} G P$.
- $\mathrm{g}^{\prime}=\exp ^{-1}\left(G^{\prime}\right) \cap \mathcal{K}_{\eta, r}(\mathbb{C}) \cap \mathcal{F}_{n+1}$.
- $\mathcal{C}\left(G^{\prime}\right)=\left\{B \in \mathcal{K}_{\eta, r}(\mathbb{C}), A^{\prime} B=B A^{\prime}, A^{\prime} \in G^{\prime}\right\}$.
- $\mathcal{C}(G)=P C\left(G^{\prime}\right) P^{-1}$.

Proposition 2.4. (Under above notation), we have $\exp (\mathrm{g})=G$. In particular, $\exp \left(\mathrm{g}^{\prime}\right)=G^{\prime}$.

The proof of Proposition 2.4 uses the following Lemmas:

Lemma 2.5. (込, Lemma 4.2) Let $G$ be an abelian subgroup of $G L(n+1, \mathbb{C})$ and $P \in G L(n+1, \mathbb{C})$ such that $P^{-1} G P$ is a subgroup of $\mathcal{K}_{\eta, r}(\mathbb{C})$. If $\mathrm{g}_{1}=\exp ^{-1}(G) \cap$ $\left(P \mathcal{K}_{\eta, r}(\mathbb{C}) P^{-1}\right)$ then:
(i) $\exp \left(\mathrm{g}_{1}\right)=G$.
(ii) $\mathrm{g}_{1} \subset \mathcal{C}(G)$.

Lemma 2.6. (迤, Proposition 3.2) $\exp \left(\mathcal{K}_{\eta, r}(\mathbb{C})\right)=\mathcal{K}_{\eta, r}^{*}(\mathbb{C})$.
Lemma 2.7. (i) If $N \in P \mathcal{K}_{\eta, r}(\mathbb{C}) P^{-1}$ such that $e^{N} \in \Phi(G A(n, \mathbb{C}))$, so $N$ $2 i k \pi I_{n+1} \in \mathcal{F}_{n+1}$, for some $k \in \mathbb{Z}$.
(ii) $\exp \left(\mathcal{F}_{n+1}\right)=\Phi(G A(n, \mathbb{C}))$.
(iii) $\exp \left(\mathcal{F}_{n+1} \cap \mathcal{K}_{\eta, r}(\mathbb{C})\right)=\Phi(G A(n, \mathbb{C})) \cap \mathcal{K}_{\eta, r}^{*}(\mathbb{C})$.

Proof. (i) Let $N^{\prime}=P^{-1} N P \in \mathcal{K}_{\eta, r}(\mathbb{C}), M=e^{N}$ and $M^{\prime}=P^{-1} M P$. We have $e^{N^{\prime}}=M^{\prime}$ and by Lemma 2.6, $M^{\prime} \in \mathcal{K}_{\eta, r}^{*}(\mathbb{C})$. Write $M^{\prime}=\operatorname{diag}\left(M_{1}^{\prime}, \ldots, M_{r}^{\prime}\right)$ and $N^{\prime}=\operatorname{diag}\left(N_{1}^{\prime}, \ldots, N_{r}^{\prime}\right), M_{k}^{\prime}, N_{k}^{\prime} \in \mathbb{T}_{n_{k}}(\mathbb{C}), k=1, \ldots, r$. Then $e^{N^{\prime}}=\operatorname{diag}\left(e^{N_{1}^{\prime}}, \ldots, e^{N_{r}^{\prime}}\right)$, so $e^{N_{1}^{\prime}}=M_{1}^{\prime}$. As 1 is the only eigenvalue of $M_{1}^{\prime}, N_{1}^{\prime}$ has an eigenvalue $\mu \in \mathbb{C}$ such that $e^{\mu}=1$. Thus $\mu=2 i k \pi$ for some $k \in \mathbb{Z}$. Therefore, $N^{\prime \prime}=N^{\prime}-2 i k \pi I_{n+1} \in$ $\mathcal{F}_{n+1}$ and satisfying $e^{N^{\prime \prime}}=e^{-2 i k \pi} e^{N^{\prime}}=M^{\prime}$. It follows by Lemma 2.1, that $N-2 i k \pi I_{n+1}=P N^{\prime \prime} P^{-1} \in P \mathcal{F}_{n+1} P^{-1}=\mathcal{F}_{n+1}$, since $P \in \Phi(G A(n, \mathbb{C}))$.
(ii) let $N=\left[\begin{array}{cc}0 & 0 \\ b & B\end{array}\right] \in \mathcal{F}_{n+1}$, we have $N^{k}=\left[\begin{array}{cc}0 & 0 \\ B^{k-1} b & B^{k}\end{array}\right] \in \mathcal{F}_{n+1}$ for every $k \in \mathbb{N}_{0}$, so

$$
\begin{aligned}
e^{N} & =I_{n+1}+\sum_{k \in \mathbb{N}_{0}} \frac{1}{k!} N^{k} \\
& =\left[\begin{array}{cc}
1 & 0 \\
\sum_{k \in \mathbb{N}_{0}} \frac{1}{k!} B^{k-1} b & I_{n}+\sum_{k \in \mathbb{N}_{0}} \frac{1}{k!} B^{k}
\end{array}\right] \\
& =\left[\begin{array}{cc}
1 & 0 \\
\sum_{k \in \mathbb{N}_{0}} \frac{1}{k!} B^{k-1} b & e^{B}
\end{array}\right]
\end{aligned}
$$

Then $e^{N} \in \Phi(G A(n, \mathbb{C}))$. It follows that $\exp \left(\mathcal{F}_{n+1}\right) \subset \Phi(G A(n, \mathbb{C}))$.
Conversely, let $M=\left[\begin{array}{ll}1 & 0 \\ a & A\end{array}\right] \in \Phi(G A(n, \mathbb{C}))$. By applying Proposition 2.3 on the group generated by $M$, there exists $P \in \Phi(G A(n, \mathbb{C}))$ such that $M^{\prime}=$ $P^{-1} M P \in \mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap \Phi(G A(n, \mathbb{C}))$. By Lemma 2.6, there exists $N^{\prime} \in \mathcal{K}_{\eta, r}(\mathbb{C})$ such that $e^{N^{\prime}}=M^{\prime}$. By (i), $N^{\prime \prime}=N^{\prime}-2 i k \pi I_{n+1} \in \mathcal{F}_{n+1}$ for some $k \in \mathbb{Z}$ and satisfying $e^{N^{\prime \prime}}=M^{\prime}$. Hence, $N=P N^{\prime} P^{-1} \in P \mathcal{F}_{n+1} P^{-1}$ and satisfying $e^{N}=P e^{N^{\prime \prime}} P^{-1}=P M^{\prime} P^{-1}=M$. By Lemma 2.1. $N \in \mathcal{F}_{n+1}$. It follows that $\Phi(G A(n, \mathbb{C})) \subset \exp \left(\mathcal{F}_{n+1}\right)$.
(iii) By Lemma 2.6 and (ii) we have $\exp \left(\mathcal{F}_{n+1} \cap \mathcal{K}_{\eta, r}(\mathbb{C})\right) \subset \Phi(G A(n, \mathbb{C})) \cap \mathcal{K}_{\eta, r}^{*}(\mathbb{C})$. Conversely, let $M=\left[\begin{array}{ll}1 & 0 \\ a & A\end{array}\right] \in \Phi(G A(n, \mathbb{C})) \cap \mathcal{K}_{\eta, r}^{*}(\mathbb{C})$. By Lemma 2.6, there exists $N^{\prime} \in \mathcal{K}_{\eta, r}(\mathbb{C})$ such that $e^{N^{\prime}}=M$. By (i), $N=N^{\prime}-2 i k \pi I_{n+1} \in \mathcal{F}_{n+1}$ for some $k \in \mathbb{Z}$ and satisfying $e^{N}=e^{-2 i k \pi} e^{N^{\prime}}=M$. It follows that $\Phi(G A(n, \mathbb{C})) \cap \mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \subset$ $\exp \left(\mathcal{F}_{n+1}\right)$. The proof is complete.

Proof of Proposition 2.4. By Lemma 2.5.(i), we have $\exp \left(\mathrm{g}_{1}\right)=G$. Since $\mathrm{g}=$ $\mathrm{g}_{1} \cap \mathcal{F}_{n+1}$ then

$$
\exp (\mathrm{g}) \subset \exp \left(\mathrm{g}_{1}\right)=G
$$

Conversely, let $M \in G$. By lemma 2.5.(i) we have $\exp \left(\mathrm{g}_{1}\right)=G$ then there exists $N \in \mathrm{~g}_{1} \subset \mathcal{K}_{\eta, r}(\mathbb{C})$ such that $e^{N}=M$. By Lemma 2.7.(i), there exists $k \in \mathbb{Z}$ such that $N^{\prime}=N-2 i k \pi I_{n+1} \in \mathcal{F}_{n+1}$. Since $N$ and $2 i k \pi I_{n+1} \in P \mathcal{K}_{\eta, r}(\mathbb{C}) P^{-1}$, $N^{\prime} \in \mathrm{g}_{1} \cap \mathcal{F}_{n+1}=\mathrm{g}$. It follows that $M=e^{N^{\prime}} \in \exp (\mathrm{g})$. The proof is complete. In particular if $P=I_{n+1}$, we have $\exp \left(\mathrm{g}^{\prime}\right)=G^{\prime}$.

## 3. Parametrization

Let $\mathcal{G}$ be an abelian subgroup of $G A(n, \mathbb{C})$ and $G=\Phi(\mathcal{G})$. In all the following, $P$ denotes the matrix defined in Proposition 2.3 (i.e. $P \in \Phi(G A(n, \mathbb{C}))$ such that $P^{-1} G P$ is a subgroup of $\left.\mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap \Phi(G A(n, \mathbb{C}))\right)$. Recall that $G^{\prime}=P^{-1} G P$ and $\mathrm{g}^{\prime}=\exp ^{-1}\left(G^{\prime}\right) \cap \mathcal{K}_{\eta, r}(\mathbb{C}) \cap \mathcal{F}_{n+1}$, so every $A^{\prime} \in G^{\prime}$ is in the form

A^{\prime}=\operatorname{diag}\left(A_{1}^{\prime}, \ldots, A_{r}^{\prime}\right) \in \mathcal{K}_{\eta, r}^{*}(\mathbb{C}), \quad A_{k}^{\prime} \in \mathbb{T}_{n_{k}}^{*}(\mathbb{C}), k=1, \ldots, r
$$

and every $B^{\prime} \in \mathrm{g}^{\prime}$ is in the form

$$
B^{\prime}=\operatorname{diag}\left(B_{1}^{\prime}, \ldots, B_{r}^{\prime}\right) \in \mathcal{K}_{\eta, r}(\mathbb{C}), \quad B_{k}^{\prime} \in \mathbb{T}_{n_{k}}(\mathbb{C}), k=1, \ldots, r
$$

For every $k=1, \ldots, r$, denote by:

- $G_{k}^{\prime}=\left\{A_{k}^{\prime}, \quad A^{\prime} \in G^{\prime}\right\}$.
- $\mathrm{g}_{k}^{\prime}=\left\{B_{k}^{\prime}, \quad B^{\prime} \in \mathrm{g}^{\prime}\right\}$.
- $F_{G_{k}^{\prime}}=\left\{\left(A_{k}^{\prime}-\mu_{A_{k}^{\prime}} I_{n_{k}}\right) e_{k, i}, \quad A^{\prime} \in G^{\prime}, 1 \leq i \leq n_{k}-1\right\}$.
- $F_{\mathrm{g}_{k}^{\prime}}=\left\{\left(B_{k}^{\prime}-\mu_{B_{k}^{\prime}} I_{n_{k}}\right) e_{k, i}, \quad B^{\prime} \in \mathrm{g}^{\prime}, 1 \leq i \leq n_{k}-1\right\}$.
where $\mu_{A_{k}^{\prime}}$ (resp. $\mu_{B_{k}^{\prime}}$ ) is the only eigenvalue of $A_{k}^{\prime}$. (resp. $\left.B_{k}^{\prime}\right)$ and $\left(e_{k, 1}, \ldots, e_{k, n_{k}}\right)$ is the canonical basis of $\mathbb{C}^{n_{k}}$.
- Let $h: M_{n+1}(\mathbb{C}) \longrightarrow M_{n+1}(\mathbb{C})$ be the isomorphism defined by $h(B)=P B P^{-1}$. one has $h\left(G^{\prime}\right)=G$.

See that $\pi$ is an affine map, because $\pi=\left(D_{0}, e_{1}\right)$, where $D_{0}=\operatorname{diag}\left(0, I_{n}\right)$. Remark that $\pi \notin G A(n, \mathbb{C})$, however $\pi: \mathbb{C}^{n} \longrightarrow\{1\} \times \mathbb{C}^{n}$ is invertible.
Denote by :

- $U=\prod_{k=1}^{r} \mathbb{C}^{*} \times \mathbb{C}^{n_{k}-1}$, we have $U$ is a $G^{\prime}$-invariant open set.
- $V=\pi^{-1} \circ P\left(U \cap\left(\{1\} \times \mathbb{C}^{n}\right)\right)$.

We have $V$ is an open subset of $\mathbb{C}^{n}$, because $V=\pi^{-1}\left(P(U) \cap P\left(\{1\} \times \mathbb{C}^{n}\right)\right)$, $\pi$ is continuous and $P(U) \cap P\left(\{1\} \times \mathbb{C}^{n}\right)=P(U) \cap\left(\{1\} \times \mathbb{C}^{n}\right)$ is an open set of $\{1\} \times \mathbb{C}^{n}$ (since $P \in \Phi(G A(n, \mathbb{C}))$ and so $\left.P\left(\{1\} \times \mathbb{C}^{n}\right)=\{1\} \times \mathbb{C}^{n}\right)$.

- $\mathcal{C}\left(\mathrm{g}^{\prime}\right)=\left\{B \in \mathcal{K}_{\eta, r}(\mathbb{C}), A^{\prime} B=B A^{\prime}, A^{\prime} \in \mathrm{g}^{\prime}\right\}$.
- $\mathcal{C}(\mathrm{g})=P C\left(\mathrm{~g}^{\prime}\right) P^{-1}$ (i.e. $\left.\mathcal{C}(\mathrm{g})=h\left(\mathcal{C}\left(\mathrm{~g}^{\prime}\right)\right)\right)$.
- $\mathcal{C}(\mathcal{G})=\Phi^{-1}(\mathcal{C}(G) \cap \Phi(G A(n, \mathbb{C})))$.
- $\mathcal{C}(\mathfrak{g})=\Psi^{-1}\left(\mathcal{C}(\mathrm{~g}) \cap \mathcal{F}_{n+1}\right)$.

Notice that by construct, $\mathcal{C}(\mathcal{G})$ is an affine subspace of $M A(n, \mathbb{C})$, since $\Phi$ is affine map. However, $\mathcal{C}(\mathfrak{g})$ is a vector subspace of $M A(n, \mathbb{C})$, since $\Psi$ is a linear map.
Recall the following results proved in [1] for an abelian subgroup $G^{\prime}$ of $\mathcal{K}_{\eta, r}^{*}(\mathbb{C})$.
Lemma 3.1. (迫, Lemma 4.2) We have $\mathcal{C}\left(G^{\prime}\right)=\mathrm{C}\left(\mathrm{g}^{\prime}\right)$.
By Lemma 3.1 we have $\mathcal{C}\left(G^{\prime}\right)=\mathcal{C}\left(\mathrm{g}^{\prime}\right)$ and so $\mathcal{C}(G)=\mathcal{C}(\mathrm{g})$. By construct, this identification can not be true in the affine case (i.e. $\mathcal{C}(\mathcal{G}) \neq \mathcal{C}(\mathfrak{g})$ ). Because $f_{0}=(0,0) \notin \mathcal{C}(\mathcal{G})$ and $\mathcal{C}(\mathfrak{g})$ is a vector space.

Proposition 3．2．（［⿴囗 subgroup of $\mathcal{K}_{\eta, r}^{*}(\mathbb{C})$ ．If $\operatorname{rank}\left(F_{G_{k}^{\prime}}\right)=n_{k}-1\left(\operatorname{resp} . \operatorname{rank}\left(F_{\mathrm{g}_{k}^{\prime}}\right)=n_{k}-1\right)$ ， $k=1, \ldots, r$ ，then there exists a linear injective map $\varphi: \mathbb{C}^{n+1} \longrightarrow \mathcal{K}_{\eta, r}(\mathbb{C})($ resp ． $\left.\psi: \mathbb{C}^{n+1} \longrightarrow \mathcal{K}_{\eta, r}(\mathbb{C})\right)$ such that：
（i） $\mathcal{C}\left(G^{\prime}\right) \subset \varphi\left(\mathbb{C}^{n+1}\right),\left(\right.$ resp． $\left.\mathcal{C}\left(G^{\prime}\right) \subset \psi\left(\mathbb{C}^{n+1}\right)\right)$ ．
（ii）For every $v \in \mathbb{C}^{n+1}, \varphi(v) u_{0}=v$ ，（resp．$\left.\psi(v) u_{0}=v\right)$ ．In particular $\varphi\left(G^{\prime}\left(u_{0}\right)\right)=$ $G^{\prime}$ and $\varphi\left(\mathrm{g}_{u_{0}}^{\prime}\right)=\mathrm{g}^{\prime}\left(\right.$ resp．$\psi\left(G^{\prime}\left(u_{0}\right)\right)=G^{\prime}$ and $\left.\psi\left(\mathrm{g}_{u_{0}}^{\prime}\right)=\mathrm{g}^{\prime}\right)$ ．

Lemma 3．3．（1］，Corollaries 2．7 and 3．2．（ii））The linear injective map $\psi: \mathbb{C}^{n+1} \longrightarrow$ $\mathcal{K}_{\eta, r}(\mathbb{C})$ ）defined in Proposition 3.2 satisfies $\exp \left(\mathcal{C}\left(\mathrm{g}^{\prime}\right)\right)=\mathcal{C}\left(G^{\prime}\right) \cap \mathcal{K}_{\eta, r}^{*}(\mathbb{C})$ ．

Corollary 3．4．（［1］，Proposition 6．2）If $\overline{G^{\prime}\left(u_{0}\right)}=\mathbb{C}^{n+1}$（resp．$\overline{\mathrm{g}_{u_{0}}^{\prime}}=\mathbb{C}^{n+1}$ ）then $\varphi$ （resp．$\psi$ ）is an isomorphism of $\mathbb{C}^{n+1}$ on $\mathcal{C}\left(G^{\prime}\right)$ ．

Corollary 3．5．（［］］，Corollary 3.7 and Propositions 3．6，3．2）The restriction exp $\mathcal{K}_{\eta, r}(\mathbb{C})$ ： $\mathcal{K}_{\eta, r}(\mathbb{C}) \longrightarrow \mathcal{K}_{\eta, r}^{*}(\mathbb{C})$ is a local diffeomorphism．

Lemma 3．6．The restriction $\exp _{/\left(\mathcal{K}_{\eta, r}(\mathbb{C}) \cap \mathcal{F}_{n+1}\right)}: \mathcal{K}_{\eta, r}(\mathbb{C}) \cap \mathcal{F}_{n+1} \longrightarrow \Phi(G A(n, \mathbb{C})) \cap$ $\mathcal{K}_{\eta, r}^{*}(\mathbb{C})$ is a local diffeomorphism．

Proof．The proof results from Corollary 3.5 and Lemma 2．7．（iii）．
Recall the following Proposition：
Proposition 3．7．（迥，Proposition 6．6）$U$ is $G^{\prime}$－invariant dense open set in $\mathbb{C}^{n+1}$ and all orbits of $G^{\prime}$ in $U$ are minimal in $U$ ．

Lemma 3．8．Under notation of Proposition 3．2，we have：
（i）$h\left(\mathrm{~g}^{\prime}\right)=\mathrm{g}$ and $P^{-1}\left(\mathrm{~g}_{\left(1, w_{0}\right)}\right)=\mathrm{g}_{u_{0}}^{\prime}$ ．
（ii）$\varphi\left(\mathbb{C}^{n+1}\right) \cap \Phi(G A(n, \mathbb{C})) \subset \varphi\left(\{1\} \times \mathbb{C}^{n}\right)$ and $\varphi\left(\mathbb{C}^{n+1}\right) \cap \mathcal{F}_{n+1} \subset \varphi\left(\{0\} \times \mathbb{C}^{n}\right)$ ．
（iii）$h\left(\mathcal{C}\left(G^{\prime}\right)\right)=\mathcal{C}(G)$ ．
（iv）$\widetilde{\pi}\left(f^{\prime}(u)\right)=\Psi\left(f^{\prime}\right)(1, u)$ ，for every $f^{\prime} \in \mathfrak{g}$ and $u \in \mathbb{C}^{n}$ ．In particular，$\widetilde{\pi}\left(\mathfrak{g}_{u}\right)=$ $\mathrm{g}_{(1, u)}$ ．

Proof．（i）Let $B^{\prime} \in \mathrm{g}^{\prime}=\exp ^{-1}(G) \cap \mathcal{K}_{\eta, r}(\mathbb{C}) \cap \mathcal{F}_{n+1}$ ，so $e^{h(B)}=h\left(e^{B}\right) \in h\left(G^{\prime}\right)=G$ and since $h\left(\mathcal{F}_{n+1}\right)=\mathcal{F}_{n+1}$ so $h(B) \in \mathcal{F}_{n+1}$ ，then

$$
h(B) \in \exp ^{-1}(G) \cap h\left(\mathcal{K}_{\eta, r}(\mathbb{C})\right) \cap \mathcal{F}_{n+1}=\mathrm{g} .
$$

Conversely, we use the same proof by replacing $h$ by $h^{-1}$.
Since $h\left(\mathrm{~g}^{\prime}\right)=\mathrm{g}$, so $\mathrm{g}=h^{-1}\left(\mathrm{~g}^{\prime}\right)=P^{-1} \mathrm{~g}^{\prime} P$. Then

$$
\begin{aligned}
P^{-1}\left(\mathrm{~g}_{\left(1, w_{0}\right)}\right) & =\left\{P^{-1} B\left(1, w_{0}\right): \quad B \in \mathrm{~g}\right\} \\
& =\left\{P^{-1} B P u_{0}: \quad B \in \mathrm{~g}\right\} \\
& =\left\{B^{\prime} u_{0}: \quad B^{\prime} \in \mathrm{g}^{\prime}\right\} \\
& =\mathrm{g}_{u_{0}}^{\prime}
\end{aligned}
$$

(ii) Let $v=\left[x_{1}, \ldots, x_{n+1}\right]^{T} \in \mathbb{C}^{n+1}$ such that $\varphi(v) \in \Phi(G A(n, \mathbb{C}))$, so by Proposition 3.2. (ii), $\varphi(v) u_{0}=v$. It follows that $x_{1}=1$ and so $v \in\{1\} \times \mathbb{C}^{n}$.
(iii) Since $h\left(G^{\prime}\right)=G$ and $A B=B A$ if and only if $h(A) h(B)=h(B) h(A)$, for every $A, B \in M_{n+1}(\mathbb{C})$, it follows that $h\left(\mathcal{C}\left(G^{\prime}\right)\right)=\mathcal{C}(G)$.
(iv) Let $f^{\prime}=(B, b) \in \mathfrak{g}$ and $u \in \mathbb{C}^{n}$, then

so

\widetilde{\pi}\left(\mathfrak{g}_{u}\right)=\Psi(\mathfrak{g})_{(1, u)}=\mathrm{g}_{(1, u)}=\{0\} \times \mathfrak{g}_{u} \subset\{0\} \times \mathbb{C}^{n} .
$$

Proposition 3.9. Let $\mathcal{G}$ be an abelian subgroup of $G A(n, \mathbb{C}), G=\Phi(\mathcal{G})$ and $P \in$ $\Phi(G A(n, \mathbb{C}))$ so that $G^{\prime}=P^{-1} G P$ is a subgroup of $\mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap \Phi(G A(n, \mathbb{C}))$. If $\operatorname{rank}\left(F_{G_{k}^{\prime}}\right)=n_{k}-1\left(\right.$ resp. $\left.\operatorname{rank}\left(F_{\mathrm{g}_{k}^{\prime}}\right)=n_{k}-1\right), k=1, \ldots, r-1$, then there exists two injective affine maps $\gamma: \mathbb{C}^{n} \longrightarrow G A(n, \mathbb{C})$ and $\widetilde{\gamma}: \mathbb{C}^{n} \longrightarrow M A(n, \mathbb{C})$ (resp. $\delta: \mathbb{C}^{n} \longrightarrow G A(n, \mathbb{C})$ and $\left.\widetilde{\delta}: \mathbb{C}^{n} \longrightarrow M A(n, \mathbb{C})\right)$ such that :
(i) $\mathcal{C}(\mathcal{G}) \subset \gamma\left(\mathbb{C}^{n}\right)$ and $\mathcal{C}(\mathfrak{g}) \subset \widetilde{\gamma}\left(\mathbb{C}^{n}\right)\left(\right.$ resp. $\mathcal{C}(\mathcal{G}) \subset \delta\left(\mathbb{C}^{n}\right)$ and $\left.\mathcal{C}(\mathfrak{g}) \subset \widetilde{\delta}\left(\mathbb{C}^{n}\right)\right)$.
(ii) $\gamma\left(\mathcal{G}\left(w_{0}\right)\right)=\mathcal{G}$ and $\widetilde{\gamma}\left(\mathfrak{g}_{w_{0}}\right)=\mathfrak{g} .\left(\operatorname{resp} . \delta\left(\mathcal{G}\left(w_{0}\right)\right)=\mathcal{G}\right.$ and $\left.\widetilde{\delta}\left(\mathfrak{g}_{w_{0}}\right)=\mathfrak{g}\right)$.

Proof. Let's prove the Proposition for $\operatorname{rank}\left(F_{G_{k}}\right)=n_{k}-1$. The proof for $\operatorname{rank}\left(F_{\mathrm{g}_{k}}\right)=$ $n_{k}-1, k=1, \ldots, r$ is analogous.
(ii) As $G\left(1, w_{0}\right)=\{1\} \times \mathcal{G}\left(w_{0}\right)$ we have $\pi\left(\mathcal{G}\left(w_{0}\right)\right)=G\left(1, w_{0}\right)$. Then

P^{-1} \circ \pi\left(\mathcal{G}\left(w_{0}\right)\right)=P^{-1} G\left(1, w_{0}\right)=P^{-1} G P\left(u_{0}\right)=G^{\prime}\left(u_{0}\right) \tag{2}

By proposition 3.2, there exists a linear injective map $\varphi: \mathbb{C}^{n+1} \longrightarrow \mathcal{K}_{\eta, r}(\mathbb{C})$ such that $\varphi\left(G^{\prime}\left(u_{0}\right)\right)=G^{\prime}$. Then by (2) we have

Since $\Phi^{-1}(G)=\mathcal{G}$ then by (3), we have

(Because $\pi$ and $\Phi$ are invertible affine maps; $h, P$ are isomorphisms and $\varphi$ is an injective linear map)

Let $\widetilde{\gamma}=\Psi^{-1} \circ h \circ \varphi \circ P^{-1} \circ \widetilde{\pi}$, so $\widetilde{\gamma}$ is an injective affine map from $\mathbb{C}^{n}$ to $M A(n, \mathbb{C})$ and satisfying:

& =\Psi^{-1} \circ h \circ \varphi \circ P^{-1}\left(\mathrm{~g}_{\left(1, w_{0}\right)}\right) & & \text { (by Lemma 3.8. (iv)) } \\
& =\Psi^{-1} \circ h \circ \varphi\left(\mathrm{~g}_{u_{0}}^{\prime}\right) & & \text { (by Lemma 3.8. }(i)) \\
& =\Psi^{-1} \circ h\left(\mathrm{~g}^{\prime}\right) & & \\
& =\Psi^{-1}(\mathrm{~g}) & & \text { (by Lemma 3.8. }(i)) \\
& =\mathfrak{g} & &
\end{aligned}
$$

By analogous proof, we replace $\varphi$ by $\psi$ in the construction of $\gamma$ and $\widetilde{\gamma}$ and we find

(i) By Lemma 3.8.(iii), $h\left(\mathcal{C}\left(G^{\prime}\right)\right)=\mathcal{C}(G)$ and by proposition 3.2, $\mathcal{C}\left(G^{\prime}\right) \subset \varphi\left(\mathbb{C}^{n+1}\right)$.

Then we have:

& \subset \Phi^{-1} \circ h\left(\varphi\left(\mathbb{C}^{n+1}\right) \cap h^{-1}(\Phi(G A(n, \mathbb{C})))\right) & & \\
& \subset \Phi^{-1} \circ h\left(\varphi\left(\mathbb{C}^{n+1}\right) \cap \Phi(G A(n, \mathbb{C}))\right) & & \text { (by Lemma 2.1 } \\
& \subset \Phi^{-1} \circ h \circ \varphi\left(\{1\} \times \mathbb{C}^{n}\right) & & \text { (by Lemma 3.8.(ii)) } \tag{5}
\end{align*}
$$

On the other hand, we have $P^{-1}\left(\{1\} \times \mathbb{C}^{n}\right)=\{1\} \times \mathbb{C}^{n}$, because $P \in \Phi(G A(n, \mathbb{C}))$. As $\{1\} \times \mathbb{C}^{n}=\pi\left(\mathbb{C}^{n}\right)$, so $\{1\} \times \mathbb{C}^{n}=P^{-1}\left(\{1\} \times \mathbb{C}^{n}\right)=P^{-1} \circ \pi\left(\mathbb{C}^{n}\right)$. By (5), we have

By Lemma 3.1 and Proposition 3.2, $\mathcal{C}\left(\mathrm{g}^{\prime}\right)=\mathcal{C}\left(G^{\prime}\right) \subset \varphi\left(\mathbb{C}^{n+1}\right)$. By Lemma 3.8.(iii), $h\left(\mathcal{C}\left(\mathrm{~g}^{\prime}\right)\right)=\overline{\mathcal{C}}(\mathrm{g})$, then we have:

& =\Psi^{-1}\left(h\left(\mathcal{C}\left(\mathrm{~g}^{\prime}\right)\right) \cap h\left(\mathcal{F}_{n+1}\right)\right) & & \text { (by Lemma 2.1) } \\
& \subset \Psi^{-1} \circ h\left(\varphi\left(\mathbb{C}^{n+1}\right) \cap \mathcal{F}_{n+1}\right) \\
& \subset \Psi^{-1} \circ h \circ \varphi\left(\{0\} \times \mathbb{C}^{n}\right) & \quad \text { (by Lemma 3.8. }(i)) \tag{6}
\end{array}
$$

On the other hand, we have $P^{-1}\left(\{0\} \times \mathbb{C}^{n}\right)=\{0\} \times \mathbb{C}^{n}$, because $P \in \Phi(G A(n, \mathbb{C}))$. As $\{0\} \times \mathbb{C}^{n}=\widetilde{\pi}\left(\mathbb{C}^{n}\right)$, so $\{0\} \times \mathbb{C}^{n}=P^{-1}\left(\{0\} \times \mathbb{C}^{n}\right)=P^{-1} \circ \widetilde{\pi}\left(\mathbb{C}^{n}\right)$. By (6), we have

This completes the proof.

Corollary 3.10. If $\overline{\mathcal{G}\left(w_{0}\right)}=\mathbb{C}^{n}$ (resp. $\overline{\mathfrak{g}_{w_{0}}}=\mathbb{C}^{n}$ ) then $\gamma: \mathbb{C}^{n} \longrightarrow \mathcal{C}(\mathcal{G})$ and $\widetilde{\gamma}: \mathbb{C}^{n} \longrightarrow \mathcal{C}(\mathfrak{g})\left(\right.$ resp. $\delta: \mathbb{C}^{n} \longrightarrow \mathcal{C}(\mathcal{G})$ and $\left.\widetilde{\delta}: \mathbb{C}^{n} \longrightarrow \mathcal{C}(\mathfrak{g})\right)$ are homeomorphisms.

Proof. Suppose that $\overline{\mathcal{G}\left(w_{0}\right)}=\mathbb{C}^{n}$. Then by Proposition 3.9 there exists an injective affine map $\gamma: \mathbb{C}^{n} \longrightarrow G A(n, \mathbb{C})$ such that $\mathcal{C}(\mathcal{G}) \subset \gamma\left(\mathbb{C}^{n}\right)$. Let's prove that $\gamma\left(\mathbb{C}^{n}\right) \subset \mathcal{C}(\mathcal{G}):$
By proposition 3.9. (ii), we have $\gamma\left(\mathcal{G}\left(w_{0}\right)\right)=\mathcal{G}$. Then since $\gamma$ is continuous, we have:

\gamma\left(\mathbb{C}^{n}\right)=\gamma\left(\overline{\mathcal{G}\left(w_{0}\right)}\right) \subset \overline{\gamma\left(\mathcal{G}\left(w_{0}\right)\right)}=\overline{\mathcal{G}}

By construction, $\mathcal{C}(\mathcal{G})$ is an affine subspace of $\mathbb{C}^{n}$ then it is closed and so $\overline{\mathcal{G}} \subset \mathcal{C}(\mathcal{G})$. Hence $\gamma\left(\mathbb{C}^{n}\right) \subset \mathcal{C}(\mathcal{G})$. We conclude that $\gamma$ is an homeomorphism of $\mathbb{C}^{n}$ on $\mathcal{C}(\mathcal{G})$.

The same proof is given for $\widetilde{\gamma}, \delta$ and $\widetilde{\delta}$.

Corollary 3.11. If $\overline{\mathcal{G}\left(w_{0}\right)}=\mathbb{C}^{n}$ then the map $\alpha: \mathbb{C}^{n} \longrightarrow \mathbb{C}^{n}$ defined by $\alpha=\gamma^{-1} \circ \Phi^{-1} \circ h \circ\left(\exp _{/ \mathcal{K}_{\eta, r}(\mathbb{C}) \cap \mathcal{F}_{n+1}}\right) \circ h^{-1} \circ \Psi \circ \widetilde{\gamma}$ satisfies:
(i) $\alpha$ is an open map
(ii) $\alpha^{-1}\left(\mathcal{G}\left(w_{0}\right)\right)=\mathfrak{g}_{w_{0}}$.

Proof. If $\overline{\mathcal{G}\left(w_{0}\right)}=\mathbb{C}^{n}$ then $\varphi$ is invertible so are $\gamma$ and $\widetilde{\gamma}$. Hence $\alpha$ is well defined.
(i) Since $\exp / \mathcal{K}_{\eta, r}(\mathbb{C})$ is a local diffeomorphism (Corollary 3.5) then $\alpha$ is open.
(ii) By Proposition 3.9. (ii), we have $\widetilde{\gamma}^{-1}(\mathfrak{g})=\mathfrak{g}_{u_{0}}$ and $\gamma\left(\mathcal{G}\left(w_{0}\right)\right)=\mathcal{G}$. Then

\alpha^{-1}\left(\mathcal{G}\left(w_{0}\right)\right) & =\widetilde{\gamma}^{-1} \circ \Psi^{-1} \circ h \circ\left(\exp /\left(\mathcal{K}_{\eta, r}(\mathbb{C}) \cap \mathcal{F}_{n+1}\right)\right. & )^{-1} \circ h^{-1} \circ \Phi \circ \gamma\left(\mathcal{G}\left(w_{0}\right)\right) \\
& =\widetilde{\gamma}^{-1} \circ \Psi^{-1} \circ h \circ\left(\exp /\left(\mathcal{K}_{\eta, r}(\mathbb{C}) \cap \mathcal{F}_{n+1}\right)\right)^{-1} \circ h^{-1} \circ \Phi(\mathcal{G}) \\
& =\widetilde{\gamma}^{-1} \circ \Psi^{-1} \circ h \circ\left(\exp /\left(\mathcal{K}_{\eta, r}(\mathbb{C}) \cap \mathcal{F}_{n+1}\right)\right)^{-1} \circ h^{-1}(G) \\
& =\widetilde{\gamma}^{-1} \circ \Psi^{-1} \circ h \circ\left(\exp /\left(\mathcal{K}_{\eta, r}(\mathbb{C}) \cap \mathcal{F}_{n+1}\right)\right)^{-1}\left(G^{\prime}\right) & \\
& =\widetilde{\gamma}^{-1} \circ \Psi^{-1} \circ h\left(\mathrm{~g}^{\prime}\right) & & \\
& =\widetilde{\gamma}^{-1} \circ \Psi^{-1}(\mathrm{~g}) & & \\
& =\widetilde{\gamma}^{-1}(\mathfrak{g}) & \text { (by Lefinition of } \left.\mathrm{g}^{\prime}\right) \\
& =\mathfrak{g}_{w_{0}} . & &
\end{array}
$$

Lemma 3.12. Let $v \in \mathbb{C}^{n+1}$. Then $v \in U \cap\left(\{1\} \times \mathbb{C}^{n}\right)$ if and only if $\psi(v) \in$ $\mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap \Phi(G A(n, \mathbb{C}))$. Moreover, $\psi^{-1}\left(\mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap \Phi(G A(n, \mathbb{C}))=U \cap\left(\{1\} \times \mathbb{C}^{n}\right)\right.$.

Proof. Let $x=\left[x_{1,1}, \ldots, x_{1, n_{1}} ; \ldots ; x_{r, 1}, \ldots, x_{r, n_{r}}\right]^{T} \in \mathbb{C}^{n+1}$. By Proposition 3.2.(i), $\psi(x)=\operatorname{diag}\left(B_{1}, \ldots, B_{r}\right) \in \mathcal{K}_{\eta, r}(\mathbb{C})$ with $B_{k} \in \mathbb{T}_{n_{k}}(\mathbb{C}), k=1, \ldots, r$. By Proposition3.2.(ii), $x=\psi(x) u_{0}=\left[B_{1} e_{1,1}, \ldots B_{r} e_{r, 1}\right]^{T}$. Therefore $B_{1} e_{1,1}=\left[1, x_{1,2}, \ldots, x_{1, n_{1}}\right]^{T}$ and $B_{k} e_{k, 1}=\left[x_{k, 1}, \ldots, x_{k, n_{k}}\right]^{T}, k=2, \ldots, r$. The proof of Lemma 3.12 follows, since $B_{k}$ has $x_{k, 1}$ as only eigenvalue, for every $k=1, \ldots, r$.

Lemma 3.13. (両, Proposition 2.3) If $A, B \in \mathcal{K}_{\eta, r}(\mathbb{C})$ satisfy $e^{A} e^{B}=e^{B} e^{A}$ then $A B=B A$.

Lemma 3.14. Under notation of Proposition 3.9. If $\overline{\mathfrak{g}_{w_{0}}}=\mathbb{C}^{n}$ then:
(i) $U \cap\left(\{1\} \times \mathbb{C}^{n}\right)=\psi^{-1}\left(\mathcal{C}\left(G^{\prime}\right) \cap \Phi(G A(n, \mathbb{C})) \cap \mathcal{K}_{\eta, r}^{*}(\mathbb{C})\right)$.
(ii) $V=\delta^{-1}\left(\mathcal{C}(\mathcal{G}) \cap \Phi^{-1} \circ h\left(\mathcal{K}_{\eta, r}^{*}(\mathbb{C})\right)\right)$.
(iii) $\exp \left(\mathcal{C}\left(\mathrm{g}^{\prime}\right) \cap \mathcal{F}_{n+1}\right)=\mathcal{C}\left(G^{\prime}\right) \cap \mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap \Phi(G A(n, \mathbb{C}))$.

Proof. (i) By Lemma 3.12, we have
$\psi^{-1}\left(\mathcal{C}\left(G^{\prime}\right) \cap \Phi(G A(n, \mathbb{C})) \cap \mathcal{K}_{\eta, r}^{*}(\mathbb{C})\right) \subset \psi^{-1}\left(\mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap \Phi(G A(n, \mathbb{C}))\right)=U \cap\left(\{1\} \times \mathbb{C}^{n}\right)$.
Conversely, let $x \in U \cap\left(\{1\} \times \mathbb{C}^{n}\right)$, so $x_{k, 1} \neq 0, k=2, \ldots, r$. Then $\psi(x) \in \psi\left(\mathbb{C}^{n}\right)=$ $\mathcal{C}\left(G^{\prime}\right)$ (Corollary 3.4. By Lemma 3.12, $\psi(x) \in \mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap \Phi(G A(n, \mathbb{C})$ ). It follows that $\psi(x) \in \mathcal{C}\left(G^{\prime}\right) \cap \Phi(G A(n, \mathbb{C})) \cap \mathcal{K}_{\eta, r}^{*}(\mathbb{C})$.

& =\left(\pi^{-1} \circ P \circ \psi^{-1} \circ h^{-1} \circ \Phi\right)\left(\Phi^{-1}[\mathcal{C}(G) \cap \Phi(G A(n, \mathbb{C}))] \cap \Phi^{-1} \circ h\left(\mathcal{K}_{\eta, r}^{*}(\mathbb{C})\right)\right) \\
& =\delta^{-1}\left(\mathcal{C}(\mathcal{G}) \cap \Phi^{-1} \circ h\left(\mathcal{K}_{\eta, r}^{*}(\mathbb{C})\right)\right)
\end{array}
$$

(iii) By Lemma 3.3(i), $\exp \left(\mathcal{C}\left(\mathrm{g}^{\prime}\right)\right)=\mathcal{C}\left(G^{\prime}\right) \cap \mathcal{K}_{\eta, r}^{*}(\mathbb{C})$ and by Lemma 2.7.(i), $\exp \left(\mathcal{F}_{n+1}\right)=\Phi(G A(n, \mathbb{C}))$. So $\exp \left(\mathcal{C}\left(\mathrm{g}^{\prime}\right) \cap \mathcal{F}_{n+1}\right) \subset \mathcal{C}\left(G^{\prime}\right) \cap \mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap \Phi(G A(n, \mathbb{C}))$. (iii). there exists $N \in \mathcal{F}_{n+1} \cap \mathcal{K}_{\eta, r}(\mathbb{C})$ such that $e^{N}=M$. As $M \in \mathcal{C}\left(G^{\prime}\right)=\mathcal{C}\left(\mathrm{g}^{\prime}\right)$ (Lemma 3.1), so $M A=A M$ for every $A \in \mathrm{~g}^{\prime}$ thus $M e^{A}=e^{A} M$ then $e^{N} e^{A}=e^{A} e^{N}$. Since $A, N \in \mathcal{K}_{\eta, r}(\mathbb{C})$, then by Lemma 3.13, $N A=A N$, so $N \in \mathcal{C}\left(\mathrm{~g}^{\prime}\right)$. It follows that $M=e^{N} \in \exp \left(\mathcal{C}\left(\mathrm{~g}^{\prime}\right) \cap \mathcal{F}_{n+1}\right)$.

Corollary 3.15. If $\overline{\mathfrak{g}_{w_{0}}}=\mathbb{C}^{n}$ then the map $\beta: \mathbb{C}^{n} \longrightarrow \mathbb{C}^{n}$ defined by $\beta=\delta^{-1} \circ \Phi^{-1} \circ h \circ\left(\exp / \mathcal{K}_{\eta, r}(\mathbb{C})\right) \circ h^{-1} \circ \Psi \circ \widetilde{\delta}$ satisfies:
(i) $\beta\left(\mathfrak{g}_{w_{0}}\right)=\mathcal{G}\left(w_{0}\right)$.
(ii) $\beta\left(\mathbb{C}^{n}\right)=V$.

Proof. If $\overline{\mathfrak{g}_{w_{0}}}=\mathbb{C}^{n}$ then by Corollary 3.10, $\delta: \mathbb{C}^{n} \longrightarrow \mathcal{C}(\mathcal{G})$ and $\widetilde{\delta}: \mathbb{C}^{n} \longrightarrow \mathcal{C}(\mathfrak{g})$ are homeomorphisms, so $\widetilde{\delta}\left(\mathbb{C}^{n}\right)=\mathcal{C}(\mathfrak{g})$.
(i) By proposition 2.4, we have $\exp \left(\mathrm{g}^{\prime}\right)=G^{\prime}$. By Proposition 3.9, we have $\widetilde{\delta}\left(\mathfrak{g}_{w_{0}}\right)=$ $\mathfrak{g}$ and $\delta\left(\mathcal{G}\left(w_{0}\right)\right)=\mathcal{G}$. As $\delta$ is invertible, then $\delta^{-1}(\mathcal{G})=\mathcal{G}\left(w_{0}\right)$. Therefore :

$$
\begin{aligned}
\beta\left(\mathfrak{g}_{w_{0}}\right) & =\delta^{-1} \circ \Phi^{-1} \circ h \circ\left(\exp / \mathcal{K}_{\eta, r}(\mathbb{C})\right) \circ h^{-1} \circ \Psi \circ \widetilde{\delta}\left(\mathfrak{g}_{w_{0}}\right) \\
& =\delta^{-1} \circ \Phi^{-1} \circ h \circ\left(\exp / \mathcal{K}_{\eta, r}(\mathbb{C})\right) \circ h^{-1} \circ \Psi(\mathfrak{g}) \\
& =\delta^{-1} \circ \Phi^{-1} \circ h \circ\left(\exp / \mathcal{K}_{\eta, r}(\mathbb{C})\right) \circ h^{-1}(\mathrm{~g}) \\
& =\delta^{-1} \circ \Phi^{-1} \circ h \circ\left(\exp / \mathcal{K}_{\eta, r}(\mathbb{C})\right)\left(\mathrm{g}^{\prime}\right) \\
& =\delta^{-1} \circ \Phi^{-1} \circ h\left(G^{\prime}\right) \\
& =\delta^{-1} \circ \Phi^{-1}(G) \\
& =\delta^{-1}(\mathcal{G}) \\
& =\mathcal{G}\left(w_{0}\right) .
\end{aligned}
$$

(ii) By Lemma 2.1, $h\left(\mathcal{F}_{n+1}\right)=\mathcal{F}_{n+1}$ and $h(\Phi(G A(n, \mathbb{C})))=\Phi(G A(n, \mathbb{C}))$ and by Lemma 3.14, we have:

$$
\begin{aligned}
\beta\left(\mathbb{C}^{n}\right) & =\delta^{-1} \circ \Phi^{-1} \circ h \circ\left(\exp / \mathcal{K}_{\eta, r}(\mathbb{C})\right) \circ h^{-1} \circ \Psi \circ \widetilde{\delta}\left(\mathbb{C}^{n}\right) \\
& =\delta^{-1} \circ \Phi^{-1} \circ h \circ\left(\exp / \mathcal{K}_{\eta, r}(\mathbb{C})\right) \circ h^{-1} \circ \Psi(\mathcal{C}(\mathfrak{g})) \\
& =\delta^{-1} \circ \Phi^{-1} \circ h \circ\left(\exp / \mathcal{K}_{\eta, r}(\mathbb{C})\right) \circ h^{-1}\left(\mathcal{C}(\mathrm{~g}) \cap \mathcal{F}_{n+1}\right) \\
& =\delta^{-1} \circ \Phi^{-1} \circ h \circ\left(\exp / \mathcal{K}_{\eta, r}(\mathbb{C})\right)\left(\mathcal{C}\left(\mathrm{g}^{\prime}\right) \cap h^{-1}\left(\mathcal{F}_{n+1}\right)\right) \\
& =\delta^{-1} \circ \Phi^{-1} \circ h \circ\left(\exp / \mathcal{K}_{\eta, r}(\mathbb{C})\right)\left(\mathcal{C}\left(\mathrm{g}^{\prime}\right) \cap \mathcal{F}_{n+1}\right) \\
& =\delta^{-1} \circ \Phi^{-1} \circ h\left(\mathcal{C}\left(G^{\prime}\right) \cap \mathcal{K}_{\eta, r}^{*}(\mathbb{C}) \cap \Phi(G A(n, \mathbb{C}))\right) \\
& \left.=\delta^{-1} \circ \Phi^{-1}\left(\mathcal{C}(G) \cap \Phi(G A(n, \mathbb{C})) \cap h\left(\mathcal{K}_{\eta, r}^{*}(\mathbb{C})\right)\right)\right) \\
& =\delta^{-1}\left(\mathcal{C}(\mathcal{G}) \cap \Phi^{-1} \circ h\left(\mathcal{K}_{\eta, r}^{*}(\mathbb{C})\right)\right) \\
& =V .
\end{aligned}
$$

Proposition 3.16. $V$ is $\mathcal{G}$-invariant dense open set of $\mathbb{C}^{n}$ and every orbit of $\mathcal{G}$, contained in $V$ is minimal in $V$.

Proof. Let $x \in V$ and $f=(A, a) \in \mathcal{G}$. Then $\pi(x)=(1, x) \in P(U)$ and $\Phi(f) \in G$. By Proposition 3.7, $U$ is $G^{\prime}$-invariant so $P(U)$ is $G$-invariant. Then $\Phi(f)(1, x)=$ $(1, f(x)) \in P(U)$, so $f(x)=\pi^{-1}(1, f(x)) \in \pi^{-1} \circ P(U)=V$. It follows that $V$ is $\mathcal{G}$-invariant.
By proposition 3.7, we have all orbits of $G^{\prime}=P^{-1} G P$ and contained in $U$ are minimal in $U$. Let $x \in V$ and $y \in \overline{\mathcal{G}(x)} \cap V$, so $P^{-1} \circ \pi(x)=P^{-1}(1, x) \in U$ and also $P^{-1}(1, y) \in U$. We have

$$
\begin{equation*}
\{1\} \times \overline{\mathcal{G}(x)}=\overline{G(1, x)}=P\left(\overline{G^{\prime}\left(P^{-1}(1, x)\right)}\right) \tag{7}
\end{equation*}
$$

As $\quad P^{-1}(1, x), P^{-1}(1, y) \in U$, then

$$
\overline{G^{\prime}\left(P^{-1}(1, x)\right)} \cap U=\overline{G^{\prime}\left(P^{-1}(1, y)\right)} \cap U .
$$

Therefore

$$
\begin{align*}
(\{1\} \times \overline{\mathcal{G}(x)}) \cap P(U) & =\overline{G(1, x)} \cap P(U) \\
& =P\left(\overline{G^{\prime}\left(P^{-1}(1, x)\right)} \cap U\right) \\
& =P\left(\overline{G^{\prime}\left(P^{-1}(1, y)\right)} \cap U\right) \\
& =\overline{G(1, y)} \cap P(U) \\
& =(\{1\} \times \overline{\mathcal{G}(y)}) \cap P(U) \tag{7}
\end{align*}
$$

Thus

$$
(\{1\} \times \overline{\mathcal{G}(x)}) \cap P\left(U \cap\left(\{1\} \times \mathbb{C}^{n}\right)\right)=(\{1\} \times \overline{\mathcal{G}(y)}) \cap P\left(U \cap\left(\{1\} \times \mathbb{C}^{n}\right)\right)
$$

Then

$$
\overline{\mathcal{G}(x)} \cap\left[\pi^{-1} \circ P\left(U \cap\left(\{1\} \times \mathbb{C}^{n}\right)\right)\right]=\overline{\mathcal{G}(y)} \cap\left[\pi^{-1} \circ P\left(U \cap\left(\{1\} \times \mathbb{C}^{n}\right)\right)\right]
$$

So

$$
\overline{\mathcal{G}(x)} \cap V=\overline{\mathcal{G}(y)} \cap V
$$

The proof is complete.

Lemma 3.17. $\mathbb{C}^{n} \backslash V$ is union of at most $n, \mathcal{G}$-invariant affine spaces with dimension less to $n-1$.

Proof. We have $\mathbb{C}^{n+1} \backslash U=\bigcup_{k=1}^{r} H_{k}$, where
$H_{k}=\left\{u=\left(u_{1}, \ldots, u_{r}\right) \in \mathbb{C}^{n+1}: u_{k} \in\{0\} \times \mathbb{C}^{n_{k}-1}, u_{i} \in \mathbb{C}^{*} \times \mathbb{C}^{n_{i}-1}, 1 \leq i \leq r, i \neq k\right\}$
is a vector space $G^{\prime}$-invariant with dimension $n, k=1, \ldots, r$. Since $r \leq n+1$, $\mathbb{C}^{n+1} \backslash U$ is a union of at most $n+1, G^{\prime}$-invariant vector spaces with dimension $n$. Then $\mathbb{C}^{n+1} \backslash P(U)$ is a union of at most $n+1, G$-invariant vector spaces with dimension $n$. As $H_{1} \cap\left(\{1\} \times \mathbb{C}^{n}\right)=\emptyset$, so

$$
\begin{align*}
\left(\{1\} \times \mathbb{C}^{n}\right) \backslash\left(U \cap\left(\{1\} \times \mathbb{C}^{n}\right)\right) & =\left(\mathbb{C}^{n+1} \backslash U\right) \cap\left(\{1\} \times \mathbb{C}^{n}\right) \\
& =\bigcup_{k=2}^{r}\left(H_{k} \cap\left(\{1\} \times \mathbb{C}^{n}\right)\right) \tag{8}
\end{align*}
$$

Since $P\left(\{1\} \times \mathbb{C}^{n}\right)=\{1\} \times \mathbb{C}^{n}$, then by (8), we have

$$
\begin{aligned}
\mathbb{C}^{n} \backslash V & =\pi^{-1}\left(\{1\} \times \mathbb{C}^{n}\right) \backslash \pi^{-1} \circ P\left(U \cap\left(\{1\} \times \mathbb{C}^{n}\right)\right) \\
& =\pi^{-1} \circ P\left(\left(\{1\} \times \mathbb{C}^{n}\right) \backslash\left(U \cap\left(\{1\} \times \mathbb{C}^{n}\right)\right)\right) \\
& =\pi^{-1} \circ P\left(\bigcup_{k=2}^{r}\left(H_{k} \cap\left(\{1\} \times \mathbb{C}^{n}\right)\right)\right) \\
& =\bigcup_{k=2}^{r} E_{k}
\end{aligned}
$$

where $E_{k}=\pi^{-1} \circ P\left(H_{k} \cap\left(\{1\} \times \mathbb{C}^{n}\right)\right)$ is $\mathcal{G}$-invariant affine space for every $2 \leq k \leq r$. As $H_{k} \neq\{1\} \times \mathbb{C}^{n}$, then $\operatorname{dim}\left(H_{k} \cap\left(\{1\} \times \mathbb{C}^{n}\right)\right) \leq n-1$, so $\operatorname{dim}\left(E_{k}\right) \leq n-1$. It follows that $\mathbb{C}^{n} \backslash V$ is union of at most $n$ spaces $E_{k}$, since $r \leq n+1$.

Corollary 3.18. If $\mathcal{G}$ has a dense orbit in $\mathbb{C}^{n}$ then all orbits of $V$ are dense in $\mathbb{C}^{n}$. Proof. Let $u \in \mathbb{C}^{n}$ such that $\overline{\mathcal{G}(u)}=\mathbb{C}^{n}$. By Lemma 3.17, $\mathbb{C}^{n} \backslash V$ is union of at most $n, \mathcal{G}$-invariant affine spaces with dimension less to $n-1$, so $u \in V$. Let $v \in V$. Since $V=\overline{\mathcal{G}(u)} \cap V$ then by Proposition $\overline{3.16}, \overline{\mathcal{G}(v)} \cap V=\overline{\mathcal{G}(u)} \cap V=V$. As $\bar{V}=\mathbb{C}^{n}$, one has $\overline{\mathcal{G}(v)}=\mathbb{C}^{n}$.

## 4. Proof of Theorem 1.1 and corollary 1.2

4.1. Proof of Theorem 1.1. Let $\mathcal{G}$ be an abelian affine subgroup of $G A(n, \mathbb{C})$ and let $P \in \Phi(G A(n, \mathbb{C}))$ defined in Proposition 2.3. Recall that $G=\Phi(\mathcal{G})$ and $\mathrm{g}=\exp ^{-1}(G) \cap\left(P \mathcal{K}_{\eta, r}(\mathbb{C}) P^{-1}\right) \cap \mathcal{F}_{n+1}$.
ii) $\Longrightarrow \mathbf{i}$ ) is clear.
i) $\Longrightarrow$ ii) This follows from Corollary 3.18, since $u_{0} \in U$ and so $w_{0}=\pi^{-1} \circ P\left(u_{0}\right) \in$ $V$.
iii) $\Rightarrow$ ii) : Suppose that $\overline{\mathfrak{g}_{w_{0}}}=\mathbb{C}^{n}$. Then by Corollary 3.15 there exists a continuous map $\beta: \mathbb{C}^{n} \longrightarrow \mathbb{C}^{n}$ such that $\beta\left(\mathfrak{g}_{w_{0}}\right)=\mathcal{G}\left(w_{0}\right)$ and $\beta\left(\mathbb{C}^{n}\right)=V$. By continuity, one has:

$$
V=\beta\left(\mathbb{C}^{n}\right)=\beta\left(\overline{\mathfrak{g}_{w_{0}}}\right) \subset \overline{\beta\left(\mathfrak{g}_{w_{0}}\right)}=\overline{\mathcal{G}\left(w_{0}\right)}
$$

Since $V$ is a dense open set in $\mathbb{C}^{n}$ then $\overline{\mathcal{G}\left(w_{0}\right)}=\mathbb{C}^{n}$.
ii) $\Rightarrow$ iii) : Suppose that $\overline{\mathcal{G}\left(w_{0}\right)}=\mathbb{C}^{n}$.

By Corollary 3.11, there exists an open map $\alpha: \mathbb{C}^{n} \longrightarrow \mathbb{C}^{n}$ such that $\mathfrak{g}_{w_{0}}=$ $\alpha^{-1}\left(\mathcal{G}\left(w_{0}\right)\right)$. Then:

$$
\mathbb{C}^{n}=\alpha^{-1}\left(\mathbb{C}^{n}\right)=\alpha^{-1}\left(\overline{G\left(w_{0}\right)}\right) \subset \overline{\alpha^{-1}\left(G\left(w_{0}\right)\right)}=\overline{\mathfrak{g}_{w_{0}}}
$$

4.2. Proof of Corollary 1.2. Let $\mathcal{G}$ be an abelian subgroup of $G A(n, \mathbb{C})$ having a dense orbit. By Theorem 1.1, $\overline{\mathcal{G}\left(w_{0}\right)}=\mathbb{C}^{n}$. Then by Proposition 3.2 and corollary 3.10, there exists an invertible affine map $\gamma: \mathbb{C}^{n} \longrightarrow \mathcal{C}(\mathcal{G})$ such that $\gamma\left(\mathcal{G}\left(w_{0}\right)\right)=\mathcal{G}$. Therefore:

$$
\gamma\left(\mathbb{C}^{n}\right)=\gamma\left(\overline{\mathcal{G}\left(w_{0}\right)}\right)=\overline{\gamma\left(\mathcal{G}\left(w_{0}\right)\right)}=\overline{\mathcal{G}}
$$

It follows that $\overline{\mathcal{G}}$ is an affine space of dimension $n$.

## 5. Finitely generated subgroups

### 5.1. Proof of Theorem 1.3.

Denote by $v_{0}=P u_{0}=\left(1, w_{0}\right)$. So $w_{0}=p_{2}\left(v_{0}\right)$.
Lemma 5.1. We have $p_{2}\left(\Psi\left(f^{\prime}\right) v_{0}\right)=f^{\prime}\left(w_{0}\right)$, for every $f^{\prime} \in \mathfrak{g}$. In particular, $\mathfrak{g}_{w_{0}}=p_{2}\left(\mathrm{~g}_{v_{0}}\right)$.

Proof. Let $f^{\prime}=(B, b) \in \mathfrak{g}$, then

$$
\begin{aligned}
\Psi\left(f^{\prime}\right) v_{0} & =\left[\begin{array}{cc}
0 & 0 \\
b & B
\end{array}\right]\left[\begin{array}{c}
1 \\
w_{0}
\end{array}\right] \\
& =\left[\begin{array}{c}
0 \\
b+B v_{0}
\end{array}\right] .
\end{aligned}
$$

$$
\text { So } \quad p_{2}\left(\Psi\left(f^{\prime}\right) v_{0}\right)=b+B v_{0}=f^{\prime}\left(w_{0}\right)
$$

Proposition 5.2. ([1], Proposition 8.1) Let $G$ be a subgroup of $G L(n+1, \mathbb{C})$ generated by $A_{1}, \ldots, A_{p}$. Let $B_{1}, \ldots, B_{p} \in \mathrm{~g}$ such that $A_{k}=e^{B_{k}}, k=1, \ldots, p$. Then:

$$
\mathrm{g}_{v_{0}}=\sum_{k=1}^{p} \mathbb{Z} B_{k} v_{0}+\sum_{k=1}^{r} 2 i \pi \mathbb{Z} P e^{(k)}
$$

Proposition 5.3. (Under notations of Proposition 2.3) Let $\mathcal{G}$ be an abelian subgroup of $G A(n, \mathbb{C})$ generated by $f_{1}, \ldots, f_{p}$ and let $f_{1}^{\prime}, \ldots, f_{p}^{\prime} \in \mathfrak{g}$ such that $\Phi\left(f_{k}\right)=$ $e^{\Psi\left(f_{k}^{\prime}\right)}, k=1, . ., p$. Then:

$$
\mathfrak{g}_{w_{0}}=\sum_{k=1}^{p} \mathbb{Z} f_{k}^{\prime}\left(w_{0}\right)+\sum_{k=1}^{r} 2 i \pi \mathbb{Z}\left(p_{2} \circ P e^{(k)}\right) .
$$

Proof. Let $G=\Phi(\mathcal{G})$. Then $G$ is generated by $\Phi\left(f_{1}\right), \ldots, \Phi\left(f_{p}\right)$ and g is the additive group generated by $\Psi\left(f_{1}^{\prime}\right), \ldots, \Psi\left(f_{p}^{\prime}\right)$. By proposition 5.2 we have

$$
\mathrm{g}_{v_{0}}=\sum_{k=1}^{p} \mathbb{Z} \Psi\left(f_{k}^{\prime}\right) v_{0}+\sum_{k=1}^{r} 2 i \pi \mathbb{Z} P e^{(k)}
$$

By Lemma 5.1. we have $\mathfrak{g}_{w_{0}}=p_{2}\left(\mathrm{~g}_{v_{0}}\right)$ and $p_{2}\left(\Psi\left(f_{k}^{\prime}\right) v_{0}\right)=f_{k}^{\prime}\left(w_{0}\right)$. then

$$
\begin{aligned}
\mathfrak{g}_{w_{0}} & =p_{2}\left(\sum_{k=1}^{p} \mathbb{Z} \Psi\left(f_{k}^{\prime}\right) v_{0}+\sum_{k=1}^{r} 2 i \pi \mathbb{Z} P e^{(k)}\right) . \\
& =\sum_{k=1}^{p} \mathbb{Z} f_{k}^{\prime}\left(w_{0}\right)+\sum_{k=1}^{r} 2 i \pi \mathbb{Z}\left(p_{2} \circ P e^{(k)}\right) .
\end{aligned}
$$

Recall the following Proposition which was proven in (2):
Proposition 5.4. (cf. [2], page 35). Let $H=\mathbb{Z} u_{1}+\cdots+\mathbb{Z} u_{p}$ with $u_{k}=$ $\left(u_{k, 1}, \ldots, u_{k, n}\right) \in \mathbb{C}^{n}$ and $u_{k, i}=\operatorname{Re}\left(u_{k, i}\right)+i \operatorname{Im}\left(u_{k, i}\right), k=1, \ldots, p, i=1, \ldots, n$. Then $H$ is dense in $\mathbb{C}^{n}$ if and only if for every $\left(s_{1}, \ldots, s_{p}\right) \in \mathbb{Z}^{p} \backslash\{0\}$ :

$$
\operatorname{rank}\left[\begin{array}{cccc}
\operatorname{Re}\left(u_{1,1}\right) & \ldots & \ldots & \operatorname{Re}\left(u_{p, 1}\right) \\
\vdots & \vdots & \vdots & \vdots \\
\operatorname{Re}\left(u_{1, n}\right) & \ldots & \ldots & \operatorname{Re}\left(u_{p, n}\right) \\
\operatorname{Im}\left(u_{1,1}\right) & \ldots & \ldots & \operatorname{Im}\left(u_{p, 1}\right) \\
\vdots & \vdots & \vdots & \vdots \\
\operatorname{Im}\left(u_{1, n}\right) & \ldots & \ldots & \operatorname{Im}\left(u_{p, n}\right) \\
s_{1} & \ldots & \ldots & s_{p}
\end{array}\right]=2 n+1 .
$$

Proof of Theorem 1.9: This follows directly from Theorem 1.1, Propositions 5.3 and 5.4 .

### 5.2. Proof of Corollaries 1.4 and 1.5.

Proof of Corollary 1.4: We show first that if $H=\mathbb{Z} u_{1}+\cdots+\mathbb{Z} u_{m}, u_{k} \in \mathbb{C}^{n}$ with $m \leq 2 n$, then $H$ can not be dense: Write $u_{k} \in \mathbb{C}^{n}, u_{k}=\operatorname{Re}\left(u_{k}\right)+i \operatorname{Im}\left(u_{k}\right)$ and $v_{k}=\left[\operatorname{Re}\left(u_{k}\right) ; \operatorname{Im}\left(u_{k}\right) ; s_{k}\right]^{T} \in \mathbb{R}^{2 n+1}, 1 \leq k \leq m$. Since $m \leq 2 n$, it follows that $\operatorname{rank}\left(v_{1}, \ldots, v_{m}\right) \leq 2 n$, and so $H$ is not dense in $\mathbb{C}^{n}$ by Proposition 5.4 .
Now, by applying Theorem 1.3 and the fact that $m=p+r \leq 2 n$, the Corollary 1.4 follows.

Proof of Corollary 1.5: Since $p \leq n$ and $r \leq n$ then $p+r \leq 2 n$. Corollary 1.5 follows from Corollary 1.4 .

### 5.3. The case: $\mathrm{n}=1$.

Let $\mathcal{G}$ be a subgroup of $G A(1, \mathbb{C})$, generated by $f_{1}=\left(a_{1}, \lambda_{1}\right), \ldots, f_{p}=\left(a_{p}, \lambda_{p}\right)$, where $a_{k}=\rho_{k} e^{i \theta_{k}}, \lambda_{k}=r_{k} e^{i \alpha_{k}}, \rho_{k}, r_{k}>0, \theta_{k}, \alpha_{k} \in \mathbb{R}, 1 \leq k \leq p$. Therefore $G=\Phi(\mathcal{G})$ is an abelian subgroup of $G L(2, \mathbb{C})$. Let $f_{1}^{\prime}, \ldots, f_{p}^{\prime} \in \mathfrak{g}$ such that $e^{\Psi\left(f_{k}^{\prime}\right)}=$ $\Phi\left(f_{k}\right), 1 \leq k \leq p$. Since $\mathcal{G}$ is abelian then there are two cases:
$\diamond$ Case 1: $\mathcal{G}$ is a group of translations.

In this case $\mathcal{G}(x)=T_{x}\left(\sum_{k=1}^{p} \lambda_{k} \mathbb{Z}\right)$. Then $\mathcal{G}$ has a dense orbit if and only if $\mathcal{G}(0)=$ $\sum_{k=1}^{p} \lambda_{k} \mathbb{Z}$ has a dense orbit, which is equivalent, by Proposition 5.4, to:

For every $\left(s_{1}, \ldots, s_{p}, t\right) \in \mathbb{Z}^{p+1} \backslash\{0\}$ :

$$
\operatorname{rank}\left[\begin{array}{cccc}
\log \left(r_{1}\right) & \ldots & \log \left(r_{p}\right) & 0 \\
\alpha_{1} & \ldots & \alpha_{p} & 2 \pi \\
s_{1} & \ldots & s_{p} & t
\end{array}\right]=3
$$

$\diamond$ Case 2: $\mathcal{G}$ contains no translation:
In this case $u_{0}=(1,1), a_{k} \neq 1$ for every $k=1, \ldots, p$ and $f_{k}^{\prime}=\left(B_{k}, b_{k}\right)$ is defined by:

$$
B_{k}=\left[\begin{array}{cc}
0 & 0 \\
b_{k} & \mu_{k}
\end{array}\right], \quad \text { where } b_{k}=\log \left(r_{k}\right)+i \theta_{k} \quad \text { and } \quad \mu_{k}=\frac{\lambda_{k}\left(\log \left(r_{k}\right)+i \theta_{k}\right)}{\left(a_{k}-1\right)} .
$$

Since $w_{0}=1$ then

$$
\begin{aligned}
\mathfrak{g}_{w_{0}} & =f_{1}^{\prime}\left(w_{0}\right) \mathbb{Z}+\cdots+f_{p}^{\prime}\left(w_{0}\right) \mathbb{Z}+2 i \pi \mathbb{Z} \\
& =\left(b_{1}+\mu_{1}\right) \mathbb{Z}+\cdots+\left(b_{p}+\mu_{p}\right) \mathbb{Z}+2 i \pi \mathbb{Z}
\end{aligned}
$$

Moreover, the property $\mathcal{D}$ in this cases is as follow:
$f_{1}, \ldots, f_{p}$ satisfy property $\mathcal{D}$ if and only if for every $\left(s_{1}, \ldots, s_{p}, t\right) \in \mathbb{Z}^{p+1}-\{0\}$ :

$$
\operatorname{rank}\left[\begin{array}{cccc}
\log \left|b_{1}+\mu_{1}\right| & \ldots & \log \left|b_{p}+\mu_{p}\right| & 0 \\
\arg \left(b_{1}+\mu_{1}\right) & \ldots & \arg \left(b_{p}+\mu_{p}\right) & 2 \pi \\
s_{1} & \ldots & s_{p} & t
\end{array}\right]=3 .
$$

where $\arg (z)=\theta \in\left[0,2 \pi\left[\right.\right.$ for every $z=r e^{i \theta} \in \mathbb{C}, r>0$. Therefore, from Theorem 1.3, we obtain:

Proposition 5.5. If $\mathcal{G}$ is a subgroup of $G A(1, \mathbb{C})$ generated by $f_{1}=\left(a_{1}, \lambda_{1}\right), \ldots, f_{p}=$ $\left(a_{p}, \lambda_{p}\right)$, where $a_{k}=\rho_{k} e^{i \theta_{k}} \neq 1, \lambda_{k}=r_{k} e^{i \alpha_{k}}, \rho_{k}, r_{k}>0, \theta_{k}, \alpha_{k} \in \mathbb{R}, 1 \leq k \leq p$. Then the following are equivalent:
(i) $G$ is minimal (i.e. every orbit of $\mathcal{G}$ is dense in $\mathbb{C}$ ).
(ii) $G$ has a dense orbit
(iii) $\sum_{k=1}^{p}\left(b_{k}+\mu_{k}\right) \mathbb{Z}+2 i \pi \mathbb{Z}$ is dense in $\mathbb{C}$, where $b_{k}=\log \left(r_{k}\right)+i \theta_{k}$ and $\mu_{k}=$ $\left(\log \rho_{k}+i \theta_{k}\right)\left(1+\frac{\lambda_{k}}{a_{k}-1}\right)$.
(iv) for every $\left(s_{1}, \ldots, s_{p}, t\right) \in \mathbb{Z}^{p+1} \backslash\{0\}$ :

$$
\operatorname{rank}\left[\begin{array}{cccc}
\log \left|b_{1}+\mu_{1}\right| & \ldots & \log \left|b_{p}+\mu_{p}\right| & 0 \\
\arg \left(b_{1}+\mu_{1}\right) & \ldots & \arg \left(b_{p}+\mu_{p}\right) & 2 \pi \\
s_{1} & \ldots & s_{p} & t
\end{array}\right]=3 .
$$

## 6. Examples

Example 6.1. Let $a_{k}=e^{\pi\left(s_{k}+i t_{k}\right)}, s_{k}, t_{k} \in \mathbb{Q}, 1 \leq k \leq p$ and let $\mathcal{G}$ be the subgroup of translations of $\mathbb{C}$ generated by $T_{a_{1}}, \ldots, T_{a_{p}}$. Then $\mathcal{G}$ has no dense orbit.
Proof. We can write $s_{k}=\frac{m_{k}}{q}$ and $t_{k}=\frac{p_{k}}{q}, q \in \mathbb{N}^{*}$ and $m_{k}, p_{k} \in \mathbb{Z}$ for every $1 \leq k \leq p$. One has: $\mathfrak{g}_{x}=T_{x}\left(\mathfrak{g}_{0}\right)$, where

$$
\mathfrak{g}_{0}=\frac{\pi}{q}\left(\sum_{k=1}^{p}\left(m_{k}+i p_{k}\right) \mathbb{Z}+2 i q \mathbb{Z}\right) \subset \frac{\pi}{q}(\mathbb{Z}+i \mathbb{Z}) .
$$

So $\overline{\mathfrak{g}_{0}} \neq \mathbb{C}$. By Theorem $1.1, \overline{\mathcal{G}(0)} \neq \mathbb{C}$. It follows by Proposition 5.5, that $\overline{\mathcal{G}(x)} \neq \mathbb{C}$.

Example 6.2. Let $\mathcal{G}$ the group generated by $f_{1}=\left(A_{1}, a_{1}\right), f_{2}=\left(A_{2}, a_{2}\right)$ and $f_{3}=\left(A_{3}, a_{3}\right)$, where:

$$
\begin{gathered}
A_{1}=I_{2}, \quad a_{1}=(1+i, 0), \quad A_{2}=\operatorname{diag}\left(1, e^{-2+i}\right), \quad a_{2}=(0,0) \\
A_{3}=\operatorname{diag}\left(1, e^{\frac{-\sqrt{2}}{\pi}+i\left(\frac{\sqrt{2}}{2 \pi}-\frac{\sqrt{7}}{2}\right)}\right) \quad \text { and } a_{3}=\left(\frac{-\sqrt{3}}{2 \pi}+i\left(\frac{\sqrt{5}}{2}-\frac{\sqrt{3}}{2 \pi}\right), 0\right) .
\end{gathered}
$$

Then every orbit in $V=\mathbb{C} \times \mathbb{C}^{*}$ is dense in $\mathbb{C}^{2}$.

Proof. Denote by $G=\Phi(\mathcal{G})$. Then $G$ generated by

$$
A_{1}^{\prime}=\Phi\left(f_{1}\right)=\left[\begin{array}{ccc}
1 & 0 & 0 \\
1+i & 1 & 0 \\
0 & 0 & 1
\end{array}\right], A_{2}^{\prime}=\Phi\left(f_{2}\right)=\left[\begin{array}{ccc}
1 & 0 & 0 \\
0 & 1 & 0 \\
0 & 0 & e^{-2+i}
\end{array}\right]
$$

and

$$
A_{3}^{\prime}=\Phi\left(f_{3}\right)=\left[\begin{array}{ccc}
1 & 0 & 0 \\
\frac{-\sqrt{3}}{2 \pi}+i\left(\frac{\sqrt{5}}{2}-\frac{\sqrt{3}}{2 \pi}\right) & 1 & 0 \\
0 & 0 & e^{\frac{-\sqrt{2}}{\pi}+i\left(\frac{\sqrt{2}}{2 \pi}-\frac{\sqrt{7}}{2}\right)}
\end{array}\right]
$$

Let $f_{1}^{\prime}=\left(B_{1}, b_{1}\right), f_{2}^{\prime}=\left(B_{2}, b_{2}\right)$ and $f_{2}^{\prime}=\left(B_{2}, b_{2}\right)$ such that $e^{\Psi\left(f_{k}^{\prime}\right)}=A_{k}^{\prime}$, $k=1,2,3$. We have

$$
\begin{gathered}
B_{1}=\operatorname{diag}(0,0), \quad B_{2}=\operatorname{diag}(0,-2+i) \\
B_{3}=\operatorname{diag}\left(0, \quad \frac{-\sqrt{2}}{\pi}+i\left(\frac{\sqrt{2}}{2 \pi}-\frac{\sqrt{7}}{2}\right)\right), \\
b_{1}=(1+i, 0), \quad b_{2}=(0,0), \quad \text { and } \quad b_{3}=\left(\frac{-\sqrt{3}}{2 \pi}+i\left(\frac{\sqrt{5}}{2}-\frac{\sqrt{3}}{2 \pi}\right), 0\right) .
\end{gathered}
$$

Here, we have:

- $P=I_{3}, U=\mathbb{C}^{*} \times \mathbb{C} \times \mathbb{C}^{*}, u_{0}=(1,0,1)$.
- $V=\mathbb{C} \times \mathbb{C}^{*}, w_{0}=(0,1)$.

The additive group $\mathrm{g}=\exp ^{-1}(G) \cap\left(\mathcal{K}_{(2,1), 2}(\mathbb{C})\right) \cap \mathcal{F}_{3}$ is generated by $N_{1}, N_{2}$ and $N_{3}$, where

$$
N_{k}=\Psi\left(f_{k}^{\prime}\right)=\left[\begin{array}{cc}
0 & 0 \\
b_{k} & B_{k}
\end{array}\right], \quad 1 \leq k \leq 3
$$

In the other hand, for every $\left(s_{1}, s_{2}, s_{3}, t_{1}, t_{2}\right) \in \mathbb{Z}^{5} \backslash\{0\}$, one has the determinant:

$$
\begin{aligned}
\Delta & =\left|\begin{array}{ccccc}
\operatorname{Re}\left(B_{1} w_{0}+b_{1}\right) & \operatorname{Re}\left(B_{2} w_{0}+b_{2}\right) & \operatorname{Re}\left(B_{3} w_{0}+b_{3}\right) & 0 & 0 \\
\operatorname{Im}\left(B_{1} w_{0}+b_{1}\right) & \operatorname{Im}\left(B_{2} w_{0}+b_{2}\right) & \operatorname{Im}\left(B_{3} w_{0}+b_{3}\right) & 2 \pi e_{1} & 2 \pi e_{2} \\
s_{1} & s_{2} & s_{3} & t_{1} & t_{2}
\end{array}\right| \\
& =\left|\begin{array}{cccc}
-\frac{\sqrt{3}}{2 \pi} & 1 & 0 & 0 \\
0 \\
-\frac{\sqrt{2}}{\pi} & 0 & -2 & 0 \\
\pi & 0 \\
\frac{\sqrt{5}}{2}-\frac{\sqrt{3}}{2 \pi} & 1 & 0 & 2 \pi \\
\frac{\sqrt{2}}{2 \pi}-\frac{\sqrt{7}}{2} & 0 & 1 & 0 \\
s_{1} & s_{2} & s_{3} & t_{1} \\
t_{2}
\end{array}\right| \\
& =-2 \pi\left(\left(4 s_{1}\right) \pi-\left(2 s_{3}\right) \sqrt{2}+\left(2 s_{2}\right) \sqrt{3}+t_{1} \sqrt{5}+t_{2} \sqrt{7}\right) .
\end{aligned}
$$

Since $\pi, \sqrt{2}, \sqrt{3}, \sqrt{5}$ and $\sqrt{7}$ are rationally independent then $\Delta \neq 0$ for every $\left(s_{1}, s_{2}, s_{3}, t_{1}, t_{2}\right) \in \mathbb{Z}^{5} \backslash\{0\}$. It follows that:
$\operatorname{rank}\left[\begin{array}{ccccc}-\frac{\sqrt{3}}{2 \pi} & 1 & 0 & 0 & 0 \\ -\frac{\sqrt{2}}{\pi} & 0 & -2 & 0 & 0 \\ \frac{\sqrt{5}}{2}-\frac{\sqrt{3}}{2 \pi} & 1 & 0 & 2 \pi & 0 \\ \frac{\sqrt{2}}{2 \pi}-\frac{\sqrt{7}}{2} & 0 & 1 & 0 & 2 \pi \\ s_{1} & s_{2} & s_{3} & t_{1} & t_{2}\end{array}\right]=5$
and by Theorem 1.3, $\mathcal{G}$ has a dense orbit and every orbit of $V$ is dense in $\mathbb{C}^{2}$.
