# 1 ABSTRACT

Background: Obesity and overweight have been positively related to gastroesophageal reflux disease (GERD). It has been suggested, that this relation is due to an increased gastric acid reflux which is caused by an enhanced intra-abdominal pressure.

*Aim:* We aimed to assess potential interaction of the association between body mass
index (BMI) and GERD by chronic atrophic gastritis (CAG) which goes along with
reduced acid production.

*Methods:* In the baseline examination of ESTHER, a study conducted in 9953 older
adults in Saarland, information on frequency of heartburn, potential risk factors and
medical history were obtained by self-administered standardized questionnaire.
Serological measurements of pepsinogen I and II were taken for definition of CAG.

*Results:* In total, 2,565 (28.7%) of the included subjects experienced heartburn within the past 4 weeks. A pronounced dose-response relation was observed between BMI and heartburn occurrence (p<0.001) among people without CAG, but not among people with CAG (p-value for interaction=0.018). Obese/overweight people with CAG had a much lower risk of heartburn compared to obese/overweight people without CAG (OR=0.31, 95% CI=0.24-0.40).

*Conclusions:* Our results are consistent with the hypothesis that BMI is positively
 related to GERD symptoms by its impact on acid reflux.

# 1 INTRODUCTION

Gastroesophageal reflux disease (GERD) is defined as chronic symptoms and/or mucosal damage produced by the abnormal reflux in the esophagus, with heartburn and acid regurgitation being the most common symptoms. GERD has become a worldwide frequent health problem in the past decades and been related to the development of esophagus cancer.<sup>1, 2</sup> There is substantial evidence to suggest a causal link between the increasing of body mass index (BMI) and GERD symptoms.<sup>3-5</sup> Apart from the parallel trends in frequency of obesity and GERD, the proposed underlying mechanisms are also physiologically plausible.<sup>6</sup> Overweight and obesity have been suggested to be associated with increased intra-abdominal pressure and subsequent relaxation of the lower esophagus sphincter, thus leading to increased esophagus acid exposure and higher risk of GERD.<sup>7-9</sup> 

Chronic atrophic gastritis (CAG) is an established precursor of gastric cancer, which is most frequently caused by infection with *Helicobacter pylori*.<sup>10, 11</sup> CAG is a process of chronic inflammation of the stomach mucosa, leading to loss of gastric glandular cells and their eventual replacement by intestinal and fibrous tissues.<sup>12-14</sup> GERD has been suggested to be inversely associated with CAG due to impaired gastric acid secretion.<sup>15-17</sup> Therefore, assessing the effect of CAG on the association between BMI and GERD may help to confirm the postulated underlying mechanisms. However, to our knowledge, this study question has not been addressed so far. 

The objective of this study was to assess potential effect modification of the relation between BMI and the frequency of heartburn by CAG in a large population-based study among older adults from Germany. 1 MATERIALS AND METHODS

# 2 Study population

Our analyses are based on baseline data of ESTHER, a large population-based cohort study conducted among older adults in Germany to investigate new avenues of prevention and early detection of chronic diseases in the elderly. Details of the study design have been described elsewhere.<sup>18</sup> Briefly, 9953 participants (45% males), aged 50-74 years (mean age: 62 years) were recruited between July 2000 and December 2002 by their general practitioners during a general health check-up in Saarland, a state in the south-west of Germany. The distribution of major sociodemographic factors and risk factors was very similar as in representative samples from the general population.<sup>19</sup> The study was approved by the ethics committees of the medical faculty of the University of Heidelberg and of the medical board of the state of Saarland. Written informed consent was obtained from each participant. 

# 14 Data collection

### 15 Questionnaires

A detailed questionnaire was completed by every participant, asking for information on socio-demographic characteristics, medical history, health status, family history and lifestyle factors in a standardized manner. Alcohol and coffee drinking was quantified by the self-reported average consumption within the past 12 months. Self-reported smoking status was classified into three groups (current smoker, former smoker and never smoker). The frequency of heartburn was reported as never, seldom, sometimes, frequently and always within the past 4 weeks. It was dichotomously classified as presence (sometimes, frequently or always) and absence (never or seldom) in our main analyses. In additional sensitivity analysis, subjects reporting to have heartburn seldom were included in the former rather than the latter group. 

26 Serological examinations

Serum samples were obtained from all participants and stored at -80°C. Serum concentrations of pepsinogen (PG) I and II were measured by ELISA (Biohit, Helsinki, Finland). Presence of CAG was determined by the following serological definition which has been used in previous epidemiological studies: PG I < 70 ng/mL and PG I/PG II < 3.<sup>20</sup> All analyses were carried out in a blinded fashion in the same laboratory.

## 7 Statistical analysis

8 The study population was characterized with respect to sex, age, education, smoking, 9 alcohol drinking, coffee drinking, history of diabetes, presence of CAG and BMI. 10 Differences in frequency of heartburn according to these variables were assessed by 11 Pearson's chi-square test. In addition, Mantel-Haenszel chi-square test was used to 12 assess dose-response trends.

The association of BMI with heartburn prevalence was estimated with odds ratios (OR) and 95% confidence intervals (CI) using unconditional multiple logistic regression. BMI was categorized into 4 subgroups: <18.5 (underweight); 18.5 to 25.0 (normal); 25.0 to 30.0 (overweight); and >30.0 (obese). Estimates of association were adjusted for age and sex, and, in addition, for other covariates that were previously reported to be associated with gastrointestinal reflux including education, smoking, alcohol drinking, coffee drinking and history of diabetes.<sup>21-23</sup> Evidence for interaction of BMI with sex and CAG were assessed using the likelihood ratio test (LRT) by comparing logistic regression models with and without an interaction term. Tests for trend by BMI were performed by treating BMI categories as continuous variable in the logistic regression analysis. 

All statistical analyses were carried out using SAS statistical software, release 9.1.

#### RESULTS

Of the 9953 participants in the ESTHER baseline examination, 8 were excluded from the analyses because of a history of gastroesophageal cancer, 502 because PG concentrations were not available and 507 because information on heartburn was missing, leading to a final study population of 8936. Overall, 4105 men and 4831 women were included with a mean age of 62 years. Table 1 shows the main characteristics of the study population with respect to the presence of heartburn. The overall prevalence of heartburn was 28.7%, no substantial difference was observed between men (28.3%) and women (29.1%). A positive trend of prevalence of heartburn with increasing age was observed (p < 0.001). Among participants with serologically defined CAG, much lower prevalence (13.2%) was found as compared to those without CAG (29.6%) (p<0.001). History of diabetes was not found to be related with heartburn. Furthermore, frequency of heartburn also varied with education, smoking, alcohol consumption and coffee drinking (data not shown).

As shown in Table 2, a clear dose-response relationship between BMI and frequency of heartburn persisted in logistic regression analysis (p<0.001) after adjustment for age and sex, and in addition, for other multiple covariates including education, smoking, alcohol drinking, coffee drinking and history of diabetes. Such a dose-response relationship was observed both for men and women. The associations were more pronounced for women than for men (p value of LRT for interaction <0.001). 

As shown in Figure 1 and Table 3, the dose-response relationship between BMI and frequency of heartburn was pronounced among participants without CAG and essentially absent among those with CAG (p value of LRT for interaction = 0.018). When the analyses were restricted to obese/overweight subjects (BMI  $\geq$ 25.0), people with CAG showed a significantly lower risk of heartburn compared to those without CAG with a fully adjusted OR of 0.31 (95%CI: 0.24-0.40). Alternative classification of heartburn prevalence in additional sensitivity analyses as outlined in the methods

## 1 DISCUSSION

To our knowledge, this is the first epidemiological study addressing potential
modification of the association between BMI and occurrence of heartburn by CAG.
Our results are consistent with the hypothesis that BMI is positively related to GERD
symptoms by its impact on acid reflux which is reduced in the presence of CAG.

The prevalence of GERD has steadily increased to 10-20% in Western countries in the past decades.<sup>1</sup> This increase closely paralleled an increase in obesity.<sup>24</sup> Epidemiologic studies have consistently found positive associations between BMI and symptoms of GERD.<sup>3, 4</sup> In this study population among 8936 older adults from Germany, we also observed the prevalence of heartburn to gradually increase from 16.7% for underweight subjects to 34.5% for obese subjects. There are two major physiological mechanisms that have been suggested to account for this association. First, the relation between BMI and GERD symptoms might be mediated by hormonal factors. Studies from Northern Europe suggested that circulating estrogen may play an important role in the presence of GERD symptoms, because obese women had an increased risk compared to obese men, and because the highest risk was found for postmenopausal women receiving estrogen therapy.<sup>25, 26</sup> Effect modification by sex showed a stronger association of BMI with heartburn among women than among men in our study and would be consistent with this hypothesis. Second, weight gain may lead to an increase of intra-gastric pressure due to the extrinsic gastric compression caused by surrounding adipose tissue, and subsequent relaxation of the lower esophagus sphincter may increase esophagus acid exposure and risk of related symptoms.<sup>7, 8, 27</sup> This mechanism is physiologically plausible and the dose-response relation consistently observed among both men and women in our study suggest that it may play a major role for the presence of GERD symptoms independent of potential estrogen mediated effects. 

Our findings on the modifying effect of CAG are of particular interest with respect to the second hypothesis. In our study population, lower prevalence of heartburn was

observed for subjects with CAG, which is consistent with the hypothesis that GERD is inversely associated with the presence of CAG due to the impaired gastric acid secretion.<sup>16, 17</sup> This mechanism may also partly contribute to the increase of prevalence of GERD symptoms in recent decades, because over the same period the incidence of CAG has substantially decreased.<sup>28, 29</sup> More intriguingly, the positive relation between BMI and heartburn was not observed among subjects with CAG, and a significantly lower risk of heartburn was found among obese/overweight people with CAG as compared to obese/overweight people without CAG. CAG related impaired gastric acid secretion which attenuates the risk of esophagus acid exposure caused by weight gain associated intra-gastric pressures might be a plausible explanation. It is worthy, however, to note that among participants with CAG, as shown in Figure 1, there was a slight increase for the prevalence of heartburn in the obese group (BMI > 30.0) as compared to the normal and overweight groups. This observation suggests that CAG might not completely neutralize the effect of obesity. 

In the interpretation of our data, some limitations have to be considered. First, data of heartburn symptoms, socio-demographic and lifestyle factors were based on a self-administered standardized questionnaire. Potential bias caused by inaccurate response can therefore not be excluded. Second, we can not completely exclude that the effect of BMI on the presence of heartburn may be confounded by dietary intake or physical activity, even though the effect of BMI has been suggested to be independent of these factors.<sup>3, 30, 31</sup> No definitive data exist regarding the role of diet and, in particular, of specific foods or drinks, in influencing GERD clinical manifestations.<sup>32, 33</sup> The negative relations of heartburn with the consumption of alcohol and coffee observed in our study might be explained by the possibility that people who are prone to heartburn avoid coffee and alcohol since they know it might stimulate the stomach and trigger symptoms. In addition, using of proton pump inhibitors (PPIs), which has been related to both CAG and GERD,<sup>34</sup> might be a potential confounder. However, it was rare in our study population (3.7%) and exclusion of people with PPI intake in sensitivity analyses did not affect the results 

(data not shown). Third, the definition of CAG based on serum pepsinogen concentrations cannot be claimed to be perfect. However, high levels of agreement with classification by gastroscopy with subsequent histological examination of biopsies have been observed.<sup>35</sup> Also, studies with CAG definitions based on gastroscopy with either biopsy or the PG I/PG II ratio (alone or in combination with PG I) yielded similarly strong associations of H. pylori with CAG.<sup>36</sup> Furthermore, a commonly used definition for severe CAG (PG I < 20 ng/mL)<sup>18</sup> was used in the sensitivity analysis in this study, which did not materially alter the results (data not shown).

In conclusion, our results are consistent with the hypothesis that overweight and obesity are positively related to GERD symptoms. Furthermore, this association was found to be modified by the presence of CAG which supports the hypothesis that acid reflux might be the underlying key mechanism.

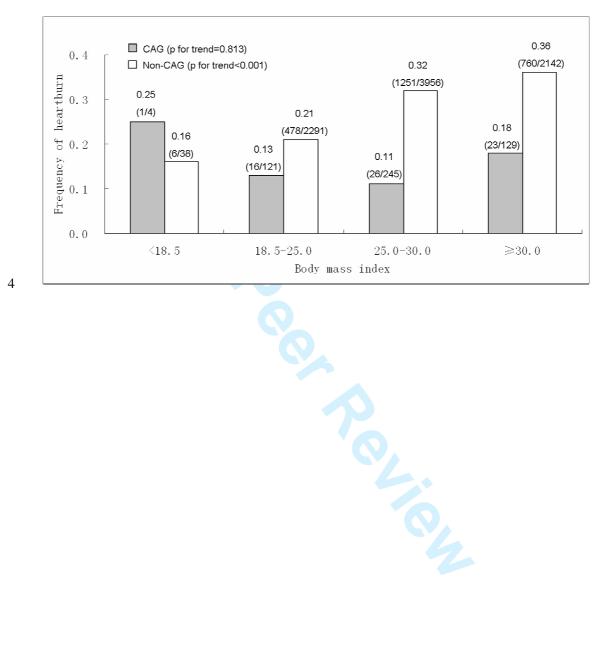
