Abstract

Background: Nocturnal urinary sodium excretion is related to blood pressure (BP) levels. Elevated BP and increased nocturnal natriuresis have been demonstrated in adults with sleep apnea. Although evidence indicates increased BP in children with obstructive sleep-disordered breathing (SDB), it is unknown whether these children have also enhanced urinary sodium excretion.

Objective: To evaluate the effects of SDB and morning BP on urinary sodium excretion. **Methods:** Consecutive children with snoring (n=95) underwent polysomnography and morning BP measurement. Fractional excretion of sodium (FE_{Na}) was the primary outcome measure and was calculated using sodium and creatinine concentrations in early morning serum and urine specimens.

Results: Subjects with moderate-to-severe SDB had similar log-transformed FE_{Na} to that of children with mild SDB and higher than children with primary snoring: -0.13 \pm 0.53 vs. -0.28 \pm 0.41 vs. -0.61 \pm 0.65 (p=0.657 and p=0.003). Obstructive apnea-hypopnea index was significantly related to FE_{Na} after adjustment for age, gender and body mass index z-score (p=0.002). Children with moderate-to-severe SDB had similar systolic BP z-scores to those of subjects with mild SDB and higher than participants with primary snoring: 0.7 \pm 1.2 vs. 0.1 \pm 1.0 vs. -0.02 \pm 1.0 (p=0.074 and p=0.046). In addition, participants with diastolic BP z-scores in the upper quartile of measured values had higher FE_{Na} than subjects with z-scores in the lower quartiles: -0.08 \pm 0.39 vs. -0.41 \pm 0.57 (p=0.007).

Conclusions: Morning natriuresis is related to severity of SDB in children and this association may be mediated in part by elevated BP. (249 words)

Introduction

Obstructive sleep apnea-hypopnea is an established risk factor for cardiovascular disease in adults. ¹ Elevated blood pressure (BP) and increased BP variability are some of the mechanisms that may contribute to cardiovascular morbidity. ¹⁻⁴ Obstructive events during sleep are accompanied by episodically increased sympathetic output, intermittent peripheral vasoconstriction and repeated BP surges. ⁵ The baroreflex system, which should regularly smooth these BP fluctuations, has reduced sensitivity in sleep apneic adults. ⁴

Renal excretion of sodium and water is an additional protective mechanism against elevated BP. ⁶ The rate of nocturnal natriuresis in healthy adults and children is positively associated with BP levels, a phenomenon described by the term "pressure natriuresis". ^{7,8} Indeed, increased nocturnal diuresis and natriuresis have been reported in adults with obstructive sleep apnea-hypopnea compared to healthy controls. ⁹⁻¹¹ Renal sodium excretion correlates with diastolic BP levels and diminishes after treatment of sleep apnea with nasal continuous positive airway pressure (nCPAP). ⁹⁻¹¹ Hence, it has been proposed that increased BP in adults with sleep apnea may be responsible for the enhanced nocturnal natriuresis in these patients. ¹⁰

Although recent evidence suggests that similar to adults, children with obstructive sleep-disordered breathing (SDB) have high levels of sympathetic activity, increased BP levels and BP variability and reduced sensitivity of the baroreflex system, ¹²⁻¹⁶ no pediatric studies have explored the potential relationship between severity of intermittent upper airway obstruction during sleep and natriuresis. Thus, in the current investigation

it was hypothesized that there is a positive association of urine excretion of sodium with severity of SDB.

Patients and Methods

Participants and clinical evaluation

The study protocol was approved by the Larissa University Hospital Ethics Committee and parents of participants provided informed consent. Consecutive children with snoring (> 3 nights/week) for the last six months who were referred to the Sleep Disorders Laboratory for polysomnography were recruited in the study. *Exclusion criteria* for participation were: i) symptoms of respiratory tract infection or acute gastroenteritis; ii) history of renal disease or use of diuretics or antihypertensive medications; and iii) history of cardiovascular, neuromuscular or genetic disorders.

All subjects underwent physical examination. Body mass index (BMI) and BMI z-score were calculated. ¹⁷ Obesity was defined as BMI z-score > 1.645. ¹⁷ Participants voided in the evening prior to polysomnography and none of them had urine loss or voided overnight. Upon morning arousal from sleep and after the child had been sitting quietly for about 5 minutes, BP was measured three times using the right arm and a cuff of appropriate size (Dinamap Pro 100; Criticon; Tampa, FL, USA). To adjust for the effects of age, gender and height, BP z-scores were determined. ¹⁸

Shortly after BP measurement and without having drunk any water, children were instructed to empty their bladder in a container and venipuncture was also performed. Urine and venous blood samples were collected and processed immediately in the Central Biochemistry Laboratory. Serum and urine sodium and creatinine concentrations were measured using standard laboratory methods.

Polysomnography

Overnight polysomnography in a single night was performed under the supervision of trained personnel. ¹⁹ The following parameters were recorded: electroencephalogram (C3/A2, C4/A1, O1/A2); right and left oculogram; submental and tibial electromyogram; body position; electrocardiogram; thoracic and abdominal wall motion; oronasal airflow; and oxygen saturation of hemoglobin.

Obstructive apnea was defined as the presence of chest/abdominal wall motion in the absence of airflow for at least two breaths in duration. ²⁰ Hypopnea was: i) a reduction in the airflow signal amplitude of at least 50% compared to baseline; ii) in the presence of chest/abdominal wall motion; and iii) associated with oxygen desaturation of hemoglobin equal to or greater than 4% or with an arousal. Obstructive apnea-hypopnea index (OAHI) was equal to the number of obstructive and mixed apneas (apneas with both central and obstructive components) and hypopneas per hour of sleep.

Primary outcome measure

Fractional urinary excretion of sodium (FE_{Na}) was the primary outcome measure. FE_{Na} was calculated as:

 FE_{Na} = (urine sodium concentration X serum creatinine concentration)/

(urine creatinine concentration X serum sodium concentration).

All concentrations were measured in early morning urine and serum specimens, and were expressed in mg/dL. FE_{Na} values were log-transformed (natural logarithm) to approach a normal distribution.

Data analysis

Severity of SDB was classified as: i) primary snoring (OAHI < 1 episode/hour); ii) mild SDB (OAHI 1-5 episodes/h); and iii) moderate-to-severe SDB (OAHI > 5 episodes/hour). The three groups of children were compared in terms of age, gender, obesity status, BP and polysomnography indices using χ^2 for categorical characteristics and one-way analysis of variance (ANOVA), followed by post-hoc tests (Bonferroni), for continuous variables.

BP measurements were categorized as those: i) in the upper quartile of values for all participants; or ii) in the lower three quartiles of BP values for all participants. Univariate logistic regression analysis was applied to assess the risk for having systolic or diastolic BP in the upper quartile of measurements, in children with moderate-to-severe or mild SDB compared to those with primary snoring (reference group).

Two general linear models (GLM) were tested to describe the potential effects on FE_{Na} of: i) severity of SDB; ii) systolic or diastolic BP; and iii) the interaction of SDB severity with systolic or diastolic BP, after adjustment for age, gender and obesity (SPSS version 16.0; SPSS, Chicago, IL). In order to assess whether natriuresis was increasing linearly to severity of SDB, linear regression analysis was carried out using FE_{Na} as the dependent variable and OAHI, age, gender and BMI z-score as independent variables.

Results

Subjects' characteristics

A total of 95 children were recruited. Subjects' characteristics and polysomnography findings are summarized in Table 1. There were no significant

differences in terms of age, female-to-male ratio, body mass index z-score or proportion of obese subjects between the three study groups. Children with moderate-to-severe SDB had similar morning systolic BP z-score to those of subjects with mild SDB and higher than subjects with primary snoring (p=0.074 and p=0.046, respectively). A nonsignificant trend for higher diastolic BP with higher OAHI was noted (Table 1).

Effects of SDB severity and BP on FE_{Na}

The cut-off value separating the upper quartile from the lower quartiles for systolic BP z-score was 0.78. The respective cut-off value for diastolic BP z-score was 1.14. Children with moderate-to-severe SDB-but not with mild SDB-were at increased risk for having systolic BP in the upper quartile of measured values compared to subjects with primary snoring [odds ratios (95% confidence intervals): 4.12 (1.12-15.16); p = 0.033 and 1.33 (0.36-4.97); p=0.669]. The association between severity of SDB and diastolic BP was not significant (p>0.05).

SDB and diastolic BP had significant effects on FE_{Na} (p<0.05 and p=0.007, respectively), whereas systolic BP had no effect on FE_{Na} (p=0.715) (Table 2 and Figure 1). More specifically, subjects with moderate-to-severe SDB had similar log-transformed FE_{Na} to that of children with mild SDB (p=0.657) and higher than participants with primary snoring (p=0.003). The interactions between SDB and systolic or diastolic BP were not significant (p=0.246 and p=0.225, respectively). In linear regression analysis, OAHI was significantly associated with FE_{Na} after adjustment for age, gender and BMI z-score (p=0.002) (Table 3).

Discussion

In the present study, it was demonstrated that severity of SDB and morning BP in children have significant effect on renal excretion of sodium. Since sleep apnea in childhood has been related to elevated BP, ^{15,21} the association between SDB and natriuresis may be mediated in part by BP elevation.

According to traditional physiology teaching, systemic BP and blood volume are tightly regulated. ⁶ Any increase in systemic BP is buffered by activation of the baroreflex system (arterial, venous and cardiac baroreceptors, brainstem, sympathetic and parasympathetic neurons) that decreases heart rate, cardiac output and systemic vascular resistance. BP elevation promotes renal excretion of sodium and water both directly, by decreased renal tubular reabsorption of sodium (pressure natriuresis), and indirectly via reduced activity of the renin-angiotensin-aldosterone system. ⁶⁻⁸ Moreover, any blood volume expansion leads to atrial and ventricular distention, and release of ANP and BNP. ^{22,23} Natriuretic peptides inhibit renal tubular reabsorption of sodium and accentuate renal sodium filtration. ²⁴

Studies in adults and children with sleep apnea indicate that at the termination of obstructive events repetitive increases in systemic BP take place.²⁵⁻²⁷ Although the baroreflex system should normally attenuate excessive BP variability, both adults and children with obstructive sleep apnea have reduced nighttime baroreflex gain and increased BP variability.^{4,16} Therefore, reduction of the intravascular volume by renal excretion of sodium and water could be another defense mechanism to or biomarker of SDB-related BP fluctuations. Studies in sleep apneic adults have consistently shown increased nocturnal renal excretion of sodium that diminishes after treatment with

nCPAP. ^{9-11,28} Results of the present investigation extend the observations from adults to children with obstructive SDB. Of note, children with obstructive sleep apnea or primary snoring have increased prevalence of nocturnal enuresis that frequently resolves after adenotonsillectomy or treatment of adenoidal hypertrophy and SDB with nasal corticosteroids. ²⁹⁻³² Increased nocturnal natriuresis and diuresis could conceivably contribute to nocturnal urine loss.

The exact pathophysiologic mechanisms underlying increased renal excretion of sodium in sleep apnea have not been elucidated. Similarly to the current report, Gjorup et al have found that diastolic BP and FE_{Na} in sleep apneic adults were positively correlated. ¹⁰ Hence, the investigators proposed that this association may be due to pressure natriuresis. Other studies have revealed increased levels of ANP and BNP that could represent the pathophysiologic link between sleep apnea and nocturnal diuresis and natriuresis. ^{33,34}

A few methodologic issues should be discussed. First, sodium and creatinine concentrations in an early morning urine specimen were used to calculate FE_{Na} . Since the recruited children have not voided overnight, we speculate that the calculated FE_{Na} reflects nocturnal urinary excretion of sodium. Second, hydration status and sodium losses via the sweat glands and the gastrointestinal system and daily sodium intake may influence FE_{Na} . Nevertheless, none of the study participants was dehydrated, was exposed to high temperatures or had symptoms or signs of gastroenteritis. Third, recent studies have documented significant associations between systolic or diastolic BP and severity of SDB using ambulatory BP monitoring. ^{15,21} A trend for higher morning diastolic BP with increasing OAHI was identified in the present report and the absence of

statistical significance may be attributed to the fact that overnight BP monitoring was not performed in the current report. Finally, a healthy control group including children without SDB, who were of normal weight or overweight, was not included. The absence of such a group possibly limited the statistical comparisons and the delineation of an interaction effect between SDB, obesity and BP in natriuresis. Furthermore, the use of a control group with OAHI < 1 episode/hour may be suboptimal, since even primary snoring could be associated with BP elevation. ³⁵

In conclusion, severity of obstructive SDB and diastolic BP are positively associated with urinary excretion of sodium in childhood. Natriuresis may be a defense mechanism to systemic blood pressure fluctuations related to intermittent upper airway obstruction during sleep.

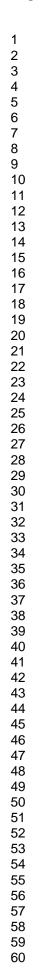

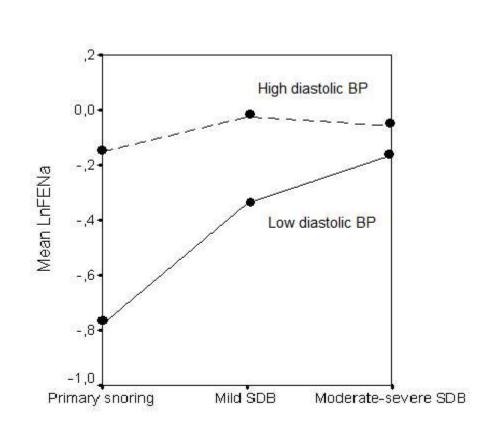

RESPONSE TO REVIEWER'S COMMENTS

1. "In pg 6 para 2, some non-significant results were presented in details with ORs and CI. As these data were non-significant, their ORs are meaningless in a strict sense and their detail reportings are misleading (mild SDB vs primary snoring in systolic BP; and effect of SDB on dBP)".

In the revised manuscript, odds ratios for non-significant results were deleted.

2. "Most p-values are reported in 3 digits. This is overkill, probably 2 digits are alright".

This comment is very reasonable. However, few p-values of the present manuscript are close to 0.05 and three digits are necessary to indicate that the respective comparisons are significant (e.g. p=0.046). Thus, for consistency all p-values are presented in 3 digits.

3. "The conclusive statement on pg 9, 'Elevated FEna...snoring....related to intermittent upper airway obstruction...' is unclear and unrelated"

The conclusion in the revised manuscript has been modified.

4. "Table 2 is redundant. Either you may combine both tables 2 and 3 or you can drop table 2."

Table 2 was deleted.

5. "Figure 1 is uninformative. Please drop it. In addition, the description of axis and figure is unclear."

Figure 1 may help the reader to have an overall impression of the numeric data presented in the manuscript. We have made the figure more self-explanatory according to the reviewer's suggestion

Abstract

Background: Nocturnal urinary sodium excretion is related to blood pressure (BP) levels. Elevated BP and increased nocturnal natriuresis have been demonstrated in adults with sleep apnea. Although evidence indicates increased BP in children with obstructive sleep-disordered breathing (SDB), it is unknown whether these children have also enhanced urinary sodium excretion.

Objective: To evaluate the effects of SDB and morning BP on urinary sodium excretion. **Methods:** Consecutive children with snoring (n=95) underwent polysomnography and morning BP measurement. Fractional excretion of sodium (FE_{Na}) was the primary outcome measure and was calculated using sodium and creatinine concentrations in early morning serum and urine specimens.

Results: Subjects with moderate-to-severe SDB had similar log-transformed FE_{Na} to that of children with mild SDB and higher than children with primary snoring: -0.13 \pm 0.53 vs. -0.28 \pm 0.41 vs. -0.61 \pm 0.65 (p=0.657 and p=0.003). Obstructive apnea-hypopnea index was significantly related to FE_{Na} after adjustment for age, gender and body mass index z-score (p=0.002). Introduction

Obstructive sleep apnea-hypopnea is an established risk factor for cardiovascular disease in adults. ¹ Elevated blood pressure (BP) and increased BP variability are some of the mechanisms that may contribute to cardiovascular morbidity. ¹⁻⁴ Obstructive events during sleep are accompanied by episodically increased sympathetic output, intermittent peripheral vasoconstriction and repeated BP surges. ⁵ The baroreflex system, which should regularly smooth these BP fluctuations, has reduced sensitivity in sleep apneic adults. ⁴

Renal excretion of sodium and water is an additional protective mechanism against elevated BP. ⁶ The rate of nocturnal natriuresis in healthy adults and children is positively associated with BP levels, a phenomenon described by the term "pressure natriuresis". ^{7,8} Indeed, increased nocturnal diuresis and natriuresis have been reported in adults with obstructive sleep apnea-hypopnea compared to healthy controls. ⁹⁻¹¹ Renal sodium excretion correlates with diastolic BP levels and diminishes after treatment of sleep apnea with nasal continuous positive airway pressure (nCPAP). ⁹⁻¹¹ Hence, it has been proposed that increased BP in adults with sleep apnea may be responsible for the enhanced nocturnal natriuresis in these patients. ¹⁰

Although recent evidence suggests that similar to adults, children with obstructive sleep-disordered breathing (SDB) have high levels of sympathetic activity, increased BP levels and BP variability and reduced sensitivity of the baroreflex system, ¹²⁻¹⁶ no pediatric studies have explored the potential relationship between severity of intermittent upper airway obstruction during sleep and natriuresis. Thus, in the current investigation

it was hypothesized that there is a positive association of urine excretion of sodium with severity of SDB.

Patients and Methods

Participants and clinical evaluation

The study protocol was approved by the Larissa University Hospital Ethics Committee and parents of participants provided informed consent. Consecutive children with snoring (> 3 nights/week) for the last six months who were referred to the Sleep Disorders Laboratory for polysomnography were recruited in the study. *Exclusion criteria* for participation were: i) symptoms of respiratory tract infection or acute gastroenteritis; ii) history of renal disease or use of diuretics or antihypertensive medications; and iii) history of cardiovascular, neuromuscular or genetic disorders.

All subjects underwent physical examination. Body mass index (BMI) and BMI z-score were calculated. ¹⁷ Obesity was defined as BMI z-score > 1.645. ¹⁷ Participants voided in the evening prior to polysomnography and none of them had urine loss or voided overnight. Upon morning arousal from sleep and after the child had been sitting quietly for about 5 minutes, BP was measured three times using the right arm and a cuff of appropriate size (Dinamap Pro 100; Criticon; Tampa, FL, USA). To adjust for the effects of age, gender and height, BP z-scores were determined. ¹⁸

Shortly after BP measurement and without having drunk any water, children were instructed to empty their bladder in a container and venipuncture was also performed. Urine and venous blood samples were collected and processed immediately in the Central Biochemistry Laboratory. Serum and urine sodium and creatinine concentrations were measured using standard laboratory methods.

Polysomnography

Overnight polysomnography in a single night was performed under the supervision of trained personnel. ¹⁹ The following parameters were recorded: electroencephalogram (C3/A2, C4/A1, O1/A2); right and left oculogram; submental and tibial electromyogram; body position; electrocardiogram; thoracic and abdominal wall motion; oronasal airflow; and oxygen saturation of hemoglobin.

Obstructive apnea was defined as the presence of chest/abdominal wall motion in the absence of airflow for at least two breaths in duration. ²⁰ Hypopnea was: i) a reduction in the airflow signal amplitude of at least 50% compared to baseline; ii) in the presence of chest/abdominal wall motion; and iii) associated with oxygen desaturation of hemoglobin equal to or greater than 4% or with an arousal. Obstructive apnea-hypopnea index (OAHI) was equal to the number of obstructive and mixed apneas (apneas with both central and obstructive components) and hypopneas per hour of sleep.

Primary outcome measure

Fractional urinary excretion of sodium (FE $_{Na}$) was the primary outcome measure.

All concentrations were measured in early morning urine and serum specimens, and were expressed in mg/dL. FE_{Na} values were log-transformed (natural logarithm) to approach a normal distribution.

Severity of SDB was classified as: i) primary snoring (OAHI < 1 episode/hour); ii) mild SDB (OAHI 1-5 episodes/h); and iii) moderate-to-severe SDB (OAHI > 5 episodes/hour). The three groups of children were compared in terms of age, gender, obesity status, BP and polysomnography indices using χ^2 for categorical characteristics and one-way analysis of variance (ANOVA), followed by post-hoc tests (Bonferroni), for continuous variables.

BP measurements were categorized as those: i) in the upper quartile of values for all participants; or ii) in the lower three quartiles of BP values for all participants. Univariate logistic regression analysis was applied to assess the risk for having systolic or diastolic BP in the upper quartile of measurements, in children with moderate-to-severe or mild SDB compared to those with primary snoring (reference group).

Two general linear models (GLM) were tested to describe the potential effects on FE_{Na} of: i) severity of SDB; ii) systolic or diastolic BP; and iii) the interaction of SDB severity with systolic or diastolic BP, after adjustment for age, gender and obesity (SPSS version 16.0; SPSS, Chicago, IL). In order to assess whether natriuresis was increasing linearly to severity of SDB, linear regression analysis was carried out using FE_{Na} as the dependent variable and OAHI, age, gender and BMI z-score as independent variables.

Results

Subjects' characteristics

A total of 95 children were recruited. Subjects' characteristics and polysomnography findings are summarized in Table 1. There were no significant

differences in terms of age, female-to-male ratio, body mass index z-score or proportion of obese subjects between the three study groups. Children with moderate-to-severe SDB had similar morning systolic BP z-score to those of subjects with mild SDB and higher than subjects with primary snoring (p=0.074 and p=0.046, respectively). A nonsignificant trend for higher diastolic BP with higher OAHI was noted (Table 1).

Effects of SDB severity and BP on FE_{Na}

The cut-off value separating the upper quartile from the lower quartiles for systolic BP z-score was 0.78. The respective cut-off value for diastolic BP z-score was 1.14. Children with moderate-to-severe SDB-but not with mild SDB-were at increased risk for having systolic BP in the upper quartile of measured values compared to subjects with primary snoring [odds ratios (95% confidence intervals): 4.12 (1.12-15.16); p = 0.033 and 1.33 (0.36-4.97); p=0.669]. The association between severity of SDB and diastolic BP was not significant (p>0.05).

SDB and diastolic BP had significant effects on FE_{Na} (p<0.05 and p=0.007, respectively), whereas systolic BP had no effect on FE_{Na} (p=0.715) (Table 2 and Figure 1). More specifically, subjects with moderate-to-severe SDB had similar log-transformed FE_{Na} to that of children with mild SDB (p=0.657) and higher than participants with primary snoring (p=0.003). The interactions between SDB and systolic or diastolic BP were not significant (p=0.246 and p=0.225, respectively). In linear regression analysis, OAHI was significantly associated with FE_{Na} after adjustment for age, gender and BMI z-score (p=0.002) (Table <u>3</u>).

Discussion

In the present study, it was demonstrated that severity of SDB and morning BP in children have significant effect on renal excretion of sodium. Since sleep apnea in childhood has been related to elevated BP, ^{15,21} the association between SDB and natriuresis may be mediated in part by BP elevation.

According to traditional physiology teaching, systemic BP and blood volume are tightly regulated. ⁶ Any increase in systemic BP is buffered by activation of the baroreflex system (arterial, venous and cardiac baroreceptors, brainstem, sympathetic and parasympathetic neurons) that decreases heart rate, cardiac output and systemic vascular resistance. BP elevation promotes renal excretion of sodium and water both directly, by decreased renal tubular reabsorption of sodium (pressure natriuresis), and indirectly via reduced activity of the renin-angiotensin-aldosterone system. ⁶⁻⁸ Moreover, any blood volume expansion leads to atrial and ventricular distention, and release of ANP and BNP. ^{22,23} Natriuretic peptides inhibit renal tubular reabsorption of sodium and accentuate renal sodium filtration. ²⁴

Studies in adults and children with sleep apnea indicate that at the termination of obstructive events repetitive increases in systemic BP take place.²⁵⁻²⁷ Although the baroreflex system should normally attenuate excessive BP variability, both adults and children with obstructive sleep apnea have reduced nighttime baroreflex gain and increased BP variability.^{4,16} Therefore, reduction of the intravascular volume by renal excretion of sodium and water could be another defense mechanism to or biomarker of SDB-related BP fluctuations. Studies in sleep apneic adults have consistently shown increased nocturnal renal excretion of sodium that diminishes after treatment with

nCPAP. ^{9-11,28} Results of the present investigation extend the observations from adults to children with obstructive SDB. Of note, children with obstructive sleep apnea or primary snoring have increased prevalence of nocturnal enuresis that frequently resolves after adenotonsillectomy or treatment of adenoidal hypertrophy and SDB with nasal corticosteroids. ²⁹⁻³² Increased nocturnal natriuresis and diuresis could conceivably contribute to nocturnal urine loss.

The exact pathophysiologic mechanisms underlying increased renal excretion of sodium in sleep apnea have not been elucidated. Similarly to the current report, Gjorup et al have found that diastolic BP and FE_{Na} in sleep apneic adults were positively correlated. ¹⁰ Hence, the investigators proposed that this association may be due to pressure natriuresis. Other studies have revealed increased levels of ANP and BNP that could represent the pathophysiologic link between sleep apnea and nocturnal diuresis and natriuresis. ^{33,34}

A few methodologic issues should be discussed. First, sodium and creatinine concentrations in an early morning urine specimen were used to calculate FE_{Na} . Since the recruited children have not voided overnight, we speculate that the calculated FE_{Na} reflects nocturnal urinary excretion of sodium. Second, hydration status and sodium losses via the sweat glands and the gastrointestinal system and daily sodium intake may influence FE_{Na} . Nevertheless, none of the study participants was dehydrated, was exposed to high temperatures or had symptoms or signs of gastroenteritis. Third, recent studies have documented significant associations between systolic or diastolic BP and severity of SDB using ambulatory BP monitoring. ^{15,21} A trend for higher morning diastolic BP with increasing OAHI was identified in the present report and the absence of

statistical significance may be attributed to the fact that overnight BP monitoring was not performed in the current report. Finally, a healthy control group including children without SDB, who were of normal weight or overweight, was not included. The absence of such a group possibly limited the statistical comparisons and the delineation of an interaction effect between SDB, obesity and BP in natriuresis. Furthermore, the use of a control group with OAHI < 1 episode/hour may be suboptimal, since even primary snoring could be associated with BP elevation.³⁵

In conclusion, severity of obstructive SDB and diastolic BP are positively associated with urinary excretion of sodium in childhood. <u>Natriuresis may be a defense</u> <u>mechanism to systemic blood pressure fluctuations related to intermittent upper airway</u>

obstruction during sleep.
