# THE CHARACTERISTIC POLYNOMIALS OF ABELIAN VARIETIES OF DIMENSIONS 4 OVER FINITE FIELDS

#### Abstract

We describe the set of characteristic polynomials of abelian varieties of dimension 4 over finite fields


## 1. Introduction and results

The aim of this paper is to give a description of the set of characteristic polynomials of abelian varieties of dimension 4 as it was done in for dimension 3.

It is well known that the characteristic polynomial of an abelian variety of dimension $g$ over $\mathbb{F}_{q}$ (with $q=p^{n}$ ) is monic, with integer coefficients, of degree $2 g$ and that the sets of its roots consist of couples of complex conjugated numbers of modulus $\sqrt{q}$. Any polynomial having those properties is called a Weil polynomial. Obviously, every Weil polynomial of degree 8 has the form

$$
p(t)=t^{8}+a_{1} t^{7}+a_{2} t^{6}+a_{3} t^{5}+a_{4} t^{4}+q a_{3} t^{3}+q^{2} a_{2} t^{2}+q^{3} a_{1} t+q^{4}
$$

for certain integers $a_{1}, a_{2}, a_{3}$ and $a_{4}$. In Section 2 we prove the following proposition which gives a characterization of the quadruples ( $a_{1}, a_{2}, a_{3}, a_{4}$ ) corresponding to Weil polynomials of degree 8 (see [8, 田 1] for a characterization of Weil polynomials of lower degrees):

Theorem 1.1. Let $p(t)=t^{8}+a_{1} t^{7}+a_{2} t^{6}+a_{3} t^{5}+a_{4} t^{4}+q a_{3} t^{3}+q^{2} a_{2} t^{2}+q^{3} a_{1} t+q^{4}$ be a polynomial with integer coefficients. Then $p(t)$ is a Weil polynomial if and only if either

p(t)=\left(t^{2} \pm \sqrt{q}\right)^{2} h(t)
$$

where $h(t)$ is a Weil polynomial, or the following conditions hold:
(1) $\left|a_{1}\right|<8 \sqrt{q}$,
(2) $6 \sqrt{q}\left|a_{1}\right|-20 q<a_{2} \leq \frac{3 a_{1}^{2}}{8}+4 q$,
(3) $-9 q a_{1}-4 \sqrt{q} a_{2}-16 q \sqrt{q}<a_{3}<-9 q a_{1}+4 \sqrt{q} a_{2}+16 q \sqrt{q}$,
(4) $-\frac{a_{1}^{3}}{8}+\frac{a_{1} a_{2}}{2}+q a_{1}-\left(\frac{2}{3}\left(\frac{3 a_{1}^{2}}{8}-a_{2}+4 q\right)\right)^{3 / 2} \leq a_{3} \leq-\frac{a_{1}^{3}}{8}+\frac{a_{1} a_{2}}{2}+q a_{1}+\left(\frac{2}{3}\left(\frac{3 a_{1}^{2}}{8}-\right.\right.$ $\left.\left.a_{2}+4 q\right)\right)^{3 / 2}$,
(5) $2 \sqrt{q}\left|q a_{1}+a_{3}\right|-2 q a_{2}-2 q^{2}<a_{4}$,
(6) $\frac{9 a_{1}^{4}}{256}-\frac{3 a_{1}^{2} a_{2}}{16}+\frac{a_{1} a_{3}}{4}+\frac{a_{2}^{2}}{6}+\frac{2 q a_{2}}{3}+\frac{2 q^{2}}{3}+\omega+\bar{\omega} \leq a_{4} \leq \frac{9 a_{1}^{4}}{256}-\frac{3 a_{1}^{2} a_{2}}{16}+\frac{a_{1} a_{3}}{4}+$ $\frac{a_{2}^{2}}{6}+\frac{2 q a_{2}}{3}+\frac{2 q^{2}}{3}+j \omega+j^{2} \bar{\omega}$
where
$\omega=\frac{1}{24}\left(8\left(-\frac{3 a_{1}^{2}}{8}+a_{2}-4 q\right)^{6}+540\left(-\frac{3 a_{1}^{2}}{8}+a_{2}-4 q\right)^{3}\left(\frac{a_{1}^{3}}{8}-q a_{1}-\frac{a_{1} a_{2}}{2}+a_{3}\right)^{2}\right.$
$-729\left(\frac{a_{1}^{3}}{8}-q a_{1}-\frac{a_{1} a_{2}}{2}+a_{3}\right)^{4}$

[^0]$\left.+i 9\left|\frac{a_{1}^{3}}{8}-q a_{1}-\frac{a_{1} a_{2}}{2}+a_{3}\right|\left(-\left(\frac{a_{1}^{3}}{8}-q a_{1}-\frac{a_{1} a_{2}}{2}+a_{3}\right)^{2}-\frac{8}{27}\left(-\frac{3 a_{1}^{2}}{8}+a_{2}-4 q\right)^{3}\right)^{3 / 2}\right)^{1 / 3}$, $\omega^{1 / 3}=|\omega|^{1 / 3} e^{\frac{\arg (\omega) i}{3}}$ and $j=e^{\frac{2 i \pi}{3}}$.

Now it remains to give criterions to determine when a Weil polynomial is the characteristic polynomial of an abelian variety of dimension 4 . Since the characteristic polynomial of a non-simple abelian variety is a product of characteristic polynomials of abelian varieties of smaller dimensions and our problem is already solved for smaller dimensions [8, 4, 1] , it is sufficient to consider the simple case.

By results of Honda and Tate, the characteristic polynomial of a simple abelian variety of dimension 4 over $\mathbb{F}_{q}$ has the form $p(t)=h(t)^{e}$ where $h(t)$ is an irreducible Weil polynomial and $e$ is an integer. Xing 10] and Maisner and Nart [2] gave independently a description of characteristic polynomials of abelian varieties of dimension 4 with $e>1$. Therefore, we can restrict our attention to the case $e=1$, that is, $p(t)$ is irreducible.

If $p(t)$ is irreducible, the determination of the possible Newton polygons for $p(t)$ (Section 3) gives us the following proposition:
Theorem 1.2. Let $p(t)=t^{8}+a_{1} t^{7}+a_{2} t^{6}+a_{3} t^{5}+a_{4} t^{4}+q a_{3} t^{3}+q^{2} a_{2} t^{2}+q^{3} a_{1} t+q^{4}$ be an irreducible Weil polynomial. Then $p(t)$ is the characteristic polynomial of an abelian variety of dimension 4 if and only if one of the following conditions holds:
(1) $v_{p}\left(a_{4}\right)=0$,
(2) $v_{p}\left(a_{3}\right)=0, v_{p}\left(a_{4}\right) \geq n / 2$ and $p(t)$ has no root of valuation $n / 2$ in $\mathbb{Q}_{p}$,
(3) $v_{p}\left(a_{2}\right)=0, v_{p}\left(a_{3}\right) \geq n / 2, v_{p}\left(a_{4}\right) \geq n$ and $p(t)$ has no root of valuation $n / 2$ in $\mathbb{Q}_{p}$,
(4) $v_{p}\left(a_{1}\right)=0, v_{p}\left(a_{2}\right) \geq n / 2, v_{p}\left(a_{3}\right) \geq n, v_{p}\left(a_{4}\right) \geq 2 n$ and $p(t)$ has no root of valuation $n / 2$ nor factor of degree 3 in $\mathbb{Q}_{p}$,
(5) $v_{p}\left(a_{1}\right)=0, v_{p}\left(a_{2}\right) \geq n / 3, v_{p}\left(a_{3}\right) \geq 2 n / 3, v_{p}\left(a_{4}\right)=n$ and $p(t)$ has no root of valuation $n / 3$ and $2 n / 3$ in $\mathbb{Q}_{p}$,
(6) $v_{p}\left(a_{1}\right) \geq n / 3, v_{p}\left(a_{2}\right) \geq 2 n / 3, v_{p}\left(a_{3}\right)=n$, $v_{p}\left(a_{4}\right) \geq 3 n / 2$ and $p(t)$ has no root in $\mathbb{Q}_{p}$,
(7) $v_{p}\left(a_{1}\right) \geq n / 4, v_{p}\left(a_{2}\right) \geq n / 2, v_{p}\left(a_{3}\right)=3 n / 4, v_{p}\left(a_{4}\right)=n$ and $p(t)$ has no root nor factor of degree 2 and 3 in $\mathbb{Q}_{p}$,
(8) $v_{p}\left(a_{1}\right) \geq n / 2, v_{p}\left(a_{2}\right) \geq n, v_{p}\left(a_{3}\right)=3 n / 2, v_{p}\left(a_{4}\right) \geq 2 n$ and $p(t)$ has no root nor factor of degree 3 in $\mathbb{Q}_{p}$.
The p-ranks of abelian varieties in cases (1), (2), (3), (4), (5), (6), (7) and (8) are respectively 4, 3, 2, 1, 1, 0,0 and 0 . The abelian varieties in case (8) are supersingular.

It is possible to make condition (8) of Theorem 1.2 more explicit. Indeed, in [6], Singh, McGuire and Zaytsev gave the list of irreducible characteristic polynomials of supersingular abelian varieties of dimension 4 , where $q$ is not a square. We complete the classification by finding the list in the case $q$ is a square in the following proposition (see Section 4).

Theorem 1.3. The polynomial $p(t)$ is the irreducible characteristic polynomial of a supersingular abelian variety of dimension 4 if and only if one of the following conditions holds

- $q$ is a square and $\left(a_{1}, a_{2}, a_{3}, a_{4}\right)$ belongs to the following list:
(1) $\left(-q^{1 / 2}, 0, q^{3 / 2},-q^{2}\right), p \not \equiv 1 \bmod 15$,
(2) $\left(q^{1 / 2}, 0,-q^{3 / 2},-q^{2}\right), p \neq 1 \bmod 30$,
(3) $(0,0,0,0), p \not \equiv 1 \bmod 16$,
(4) $\left(0,-q, 0, q^{2}\right), p \not \equiv 1 \bmod 20$,
(5) $\left(0,0,0,-q^{2}\right), p \not \equiv 1 \bmod 24$,
- $q$ is not a square and $\left(a_{1}, a_{2}, a_{3}, a_{4}\right)$ belongs to the following list:
(1) $\left( \pm \sqrt{p q}, q, 0,-q^{2}\right), p=2$,
(2) $\left( \pm \sqrt{p q}, 2 q, \pm q \sqrt{p q}, q^{2}\right), p=3$,
(3) $(0,0,0,0)$,
(4) $\left(0,-q, 0, q^{2}\right)$,
(5) $\left(0, q, 0, q^{2}\right), p \neq 5$,
(6) $\left(0,0,0,-q^{2}\right), p \neq 2$,
(7) $\left( \pm \sqrt{p q}, 2 q, \pm q \sqrt{p q}, 3 q^{2}\right), p=5$.


## 2. The coefficients of Weil polynomials of degree 8

In this section, we prove Theorem 1.1. It is clear that a Weil polynomial with a real root must have the form

$$
p(t)=\left(t^{2} \pm \sqrt{q}\right)^{2} h(t)
$$

where $h(t)$ is a Weil polynomial. Conversely, these polynomials are Weil polynomials.

Let $p(t)=t^{8}+a_{1} t^{7}+a_{2} t^{6}+a_{3} t^{5}+a_{4} t^{4}+q a_{3} t^{3}+q^{2} a_{2} t^{2}+q^{3} a_{1} t+q^{4} \in \mathbb{Z}[t]$ be a polynomial with no real root. Then the set of the roots of $p(t)$ consists of pairs of complex conjugated numbers, say $\omega_{1}, \overline{\omega_{1}}, \ldots, \omega_{4}, \overline{\omega_{4}}$. Letting $x_{i}=-\left(\omega_{i}+\overline{\omega_{i}}\right)$ we have $p(t)=\prod_{i=1}^{4}\left(t^{2}+x_{i} t+q\right)$. Arguing as in [1],$p(t)$ is a Weil polynomial if and only if the polynomials $f^{+}(t)=\prod_{i=1}^{4}\left(t-\left(2 \sqrt{q}+x_{i}\right)\right)$ and $f^{-}(t)=\prod_{i=1}^{4}\left(t-\left(2 \sqrt{q}-x_{i}\right)\right)$ have only real and positive roots.

First, we determine a necessary and sufficient condition of some polynomial of degree 4 having all real roots.

Let $f(t)=t^{4}+r_{1} t^{3}+r_{2} t^{2}+r_{3} t+r_{4}$ be a monic polynomial of degree 4 with real coefficients. Looking at the table of variation of $f(t)$, we see that there exists some $r_{4}$ for which $f(t)$ has all real roots if and only if $f^{\prime}(t)$ has all real roots. This condition is equivalent to

$$
\begin{equation*}
\Delta_{f^{\prime}} \geq 0 \tag{1}
\end{equation*}
$$

where $\Delta_{f}$ is the discriminant of $f^{\prime}(t)$.
The discriminant of $f(t)$ is a polynomial of degree 3 in $r_{4}$ which we will denote $\Delta_{f}(t)$ (that is, $\Delta_{f}\left(r_{4}\right)$ is the discriminant of $f(t)$ ). It is well known that if $f(t)$ has all real roots then $\Delta_{f}\left(r_{4}\right) \geq 0$. Moreover, the function which associate to $r_{4}$ the number of roots of $f(t)$ is constant on the intervals delimited by the roots of $\Delta_{f}(t)$ (because $\Delta_{f}\left(r_{4}\right)=0$ when $f(t)$ has a multiple root).

When $r_{4}$ is very big, the graph of $f(t)$ doesn't touch the $x$-axis and therefore $f(t)$ has no real roots. Thus if $\gamma_{3}$ is the biggest root of $\Delta_{f}(t)$, by the previous discussion, $f(t)$ has no real root for $\left.r_{4} \in\right] \gamma_{3} ;+\infty[$.

We deduce that if (II) is satisfied then $\Delta_{f}(t)$ must have 3 real roots $\gamma_{1} \leq \gamma_{2} \leq \gamma_{3}$ and $f(t)$ has all real roots if and only if

$$
\begin{equation*}
\gamma_{1} \leq r_{4} \leq \gamma_{2} \tag{2}
\end{equation*}
$$

The roots of $\Delta_{f}(t)$ can be found using Cardan's method. Let us recall quickly what it is.

Given a polynomial $h(t)=t^{3}+u_{2} t+u_{3}$, we set $\delta=-u_{3}^{2}-\frac{4}{27} u_{2}^{3}$. Then $h(t)$ has all real roots if and only if $\delta \geq 0$. If this is the case, the roots of $h(t)$ are $\gamma_{1}=\omega+\bar{\omega}$, $\gamma_{2}=j \omega+j^{2} \bar{\omega}$ and $\gamma_{3}=j^{2} \omega+j \bar{\omega}$ where $j=e^{\frac{2 i \pi}{3}}$ and $\omega=\left(\frac{-u_{3}+i \sqrt{\delta}}{2}\right)^{1 / 3}$. Moreover, with the convention $\omega^{1 / 3}=|\omega|^{1 / 3} e^{\frac{\arg (\omega) i}{3}}$, we have $\gamma_{1} \leq \gamma_{2} \leq \gamma_{3}$.

In the general case, we have $h(t)=v_{0} t^{3}+v_{1} t^{2}+v_{2} t+v_{3}$ and we conclude using the fact that $\frac{1}{v_{0}} h\left(t-\frac{v_{1}}{3 v_{0}}\right)=t^{3}+u_{2} t+u_{3}$ with $u_{2}=-\frac{v_{1}^{2}}{3 v_{0}^{2}}+\frac{v_{2}}{v_{0}}$ and $u_{3}=\frac{2 v_{1}^{3}}{27 v_{0}^{3}}-\frac{v_{1} v_{2}}{3 v_{0}^{2}}+\frac{v_{3}}{v_{0}}$.

For $i=1,2,3,4$, let $s_{i}$ denote the $i$ th symmetric function of the $x_{i}$ 's (that is, $\left.\prod_{i=1}^{4}\left(t+x_{i}\right)=t^{4}+\sum_{i=1}^{4} s_{i} t^{4-i}\right)$. Expanding the expression $p(t)=\prod_{i=1}^{4}\left(t^{2}+x_{i} t+q\right)$, we find:

$$
\begin{aligned}
& s_{1}=a_{1} \\
& s_{2}=a_{2}-4 q \\
& s_{3}=a_{3}-3 q a_{1} \\
& s_{4}=a_{4}-2 q a_{2}+2 q^{2}
\end{aligned}
$$

Now, in order to simplify the calculation, we remark that $f^{+}(t)$ and $f^{-}(t)$ have all real roots if and only if the polynomial $f(t)=\prod_{i=1}^{4}\left(t+x_{i}-\frac{a_{1}}{4}\right)$ has. Therefore, it is equivalent to apply our results to $f(t)$.

Expanding the expression of $f(t)$, we find that $f(t)=t^{4}+r_{2} t^{2}+r_{3} t+r_{4}$, where

\begin{aligned}
& r_{2}=-\frac{3 s_{1}^{2}}{8}+s_{2} \\
& r_{3}=\frac{s_{1}^{3}}{8}-\frac{s_{1} s_{2}}{2}+s_{3} \\
& r_{4}=-\frac{3 s_{1}^{4}}{256}+\frac{s_{1}^{2} s_{2}}{16}-\frac{s_{1} s_{3}}{4}+s_{4}
\end{aligned}
$$

Substituting $s_{1}, s_{2}, s_{3}$ and $s_{4}$ with their expressions in $a_{1}, a_{2}, a_{3}$ and $a_{4}$ we obtain

$$
\begin{aligned}
& r_{2}=-\frac{3 a_{1}^{2}}{8}+a_{2}-4 q \\
& r_{3}=\frac{a_{1}^{3}}{8}-q a_{1}-\frac{a_{1} a_{2}}{2}+a_{3} \\
& r_{4}=-\frac{3 a_{1}^{4}}{256}+\frac{q a_{1}^{2}}{2}+\frac{a_{1}^{2} a_{2}}{16}-\frac{a_{1} a_{3}}{4}-2 q a_{2}+2 q^{2}+a_{4}
\end{aligned}
$$

We have

$$
\Delta_{f}(t)=256 t^{3}-128 r_{2}^{2} t^{2}+16 r_{2}\left(r_{2}^{3}+9 r_{3}^{2}\right) t-r_{3}^{2}\left(4 r_{2}^{3}+27 r_{3}^{2}\right)
$$

Now, we use Cardan's method. Set

$$
\begin{aligned}
u_{2} & =-\frac{r_{2}^{4}}{48}+\frac{9 r_{2} r_{3}^{2}}{16} \\
u_{3} & =\frac{r_{2}^{6}}{864}+\frac{5 r_{2}^{3} r_{3}^{2}}{64}-\frac{27 r_{3}^{4}}{256} \\
\delta & =-u_{3}^{2}-\frac{4}{27} u_{2}^{3}=\frac{r_{3}^{2}\left(-8 r_{2}^{3}-27 r_{3}^{2}\right)^{3}}{1769472}
\end{aligned}
$$

Suppose that (11) is satisfied. Then $\delta \geq 0$ and the roots of $\Delta_{f}(t)$ are

$$
\begin{aligned}
& \gamma_{1}=\omega+\bar{\omega}+\frac{r_{2}^{2}}{6} \\
& \gamma_{2}=j \omega+j^{2} \bar{\omega}+\frac{r_{2}^{2}}{6} \\
& \gamma_{3}=j^{2} \omega+j \bar{\omega}+\frac{r_{2}^{2}}{6} .
\end{aligned}
$$

where

$$
\omega=\frac{1}{24}\left(8 r_{2}^{6}+540 r_{2}^{3} r_{3}^{2}-729 r_{3}^{4}+i 9\left|r_{3}\right|\left(-r_{3}^{2}-\frac{8}{27} r_{2}^{3}\right)^{3 / 2}\right)^{1 / 3}
$$

Substituting $r_{2}, r_{3}$ and $r_{4}$ with their expressions in $a_{1}, a_{2}, a_{3}$ and $a_{4}$ we obtain condition (6) of Theorem 1.1.

Next we have to determine when (11) is satisfied. We have:

$$
\Delta_{f^{\prime}}=-16\left(8 r_{2}^{3}+27 r_{3}^{2}\right)
$$

Therefore, (11) is equivalent to

$$
r_{2} \leq 0 \text { and }-\left(\frac{-2 r_{2}}{3}\right)^{3 / 2} \leq r_{3} \leq\left(\frac{-2 r_{2}}{3}\right)^{3 / 2}
$$

This gives us the second inequality of condition (2) and condition (4) of Theorem 1.1.

Finally, we determine when the polynomials $f^{+}(t)$ and $f^{-}(t)$ have only positive roots.

For $i=1,2,3$, let $r_{i}^{+}$and $r_{i}^{-}$denote the respective $i$ th coefficients of $f^{+}(t)$ and $f^{-}(t)$. Expending the expressions $f^{+}(t)=\prod_{i=1}^{4}\left(t-\left(2 \sqrt{q}+x_{i}\right)\right)$ and $f^{-}(t)=$ $\prod_{i=1}^{4}\left(t-\left(2 \sqrt{q}-x_{i}\right)\right)$, we find:

r_{2}^{+} & =24 q+6 \sqrt{q} s_{1}+s_{2} \\
r_{3}^{+} & =-32 q \sqrt{q}-12 q s_{1}-4 \sqrt{q} s_{2}-s_{3} \\
r_{4}^{+} & =16 q^{2}+8 q \sqrt{q} s_{1}+4 q s_{2}+2 \sqrt{q} s_{3}+s_{4}
\end{aligned}
$$

and

$$
\begin{aligned}
r_{1}^{-} & =-8 \sqrt{q}+s_{1} \\
r_{2}^{-} & =24 q-6 \sqrt{q} s_{1}+s_{2} \\
r_{3}^{-} & =-32 q \sqrt{q}+12 q s_{1}-4 \sqrt{q} s_{2}+s_{3} \\
r_{4}^{-} & =16 q^{2}-8 q \sqrt{q} s_{1}+4 q s_{2}-2 \sqrt{q} s_{3}+s_{4}
\end{aligned}
$$

Substituting $s_{1}, s_{2}, s_{3}$ and $s_{4}$ with their expressions in $a_{1}, a_{2}, a_{3}$ and $a_{4}$ we obtain

r_{1}^{+} & =-8 \sqrt{q}-a_{1} \\
r_{2}^{+} & =20 q+6 \sqrt{q} a_{1}+a_{2} \\
r_{3}^{+} & =-16 q \sqrt{q}-9 q a_{1}-4 \sqrt{q} a_{2}-a_{3} \\
r_{4}^{+} & =2 q^{2}+2 q \sqrt{q} a_{1}+2 q a_{2}+2 \sqrt{q} a_{3}+a_{4}
\end{aligned}
$$

and

$$
\begin{aligned}
r_{1}^{-} & =-8 \sqrt{q}+a_{1} \\
r_{2}^{-} & =20 q-6 \sqrt{q} a_{1}+a_{2} \\
r_{3}^{-} & =-16 q \sqrt{q}+9 q a_{1}-4 \sqrt{q} a_{2}+a_{3} \\
r_{4}^{-} & =2 q^{2}-2 q \sqrt{q} a_{1}+2 q a_{2}-2 \sqrt{q} a_{3}+a_{4} .
\end{aligned}
$$

Suppose that $f^{+}(t)$ and $f^{-}(t)$ have all real roots. Then by [7, $\S 2$, Lemma], $f^{+}(t)$ and $f^{-}(t)$ have only positive roots if and only if $(-1)^{i} r_{i}^{+}>0$ and $(-1)^{i} r_{i}^{-}>0$ for $i=1,2,3,4$. This gives us the remaining conditions of Theorem 1.1 and concludes the proof.

Remark. We could have used [7, §2, Lemma] to determine when a polynomial of degree 4 has only real roots but the computation and the results would have been longer.

## 3. Newton polygons

Let $p(t)$ be an irreducible Weil polynomial. By [3], $p(t)^{e}$ is the characteristic polynomial of a simple abelian variety, where $e$ the least common denominator of $v_{p}(f(0)) / n$ where $f(t)$ runs through the irreducible factors of $p(t)$ over $\mathbb{Q}_{p}$. Thus $p(t)$ is the characteristic polynomial of an abelian variety of dimension 4 if and only if $e$ is equal to 1 that is, $v_{p}(f(0)) / n$ are integers.

In order to determine when this condition is satisfied, we consider the Newton polygon of $p(t)$ (see [9]). Each of its edges define a factor of $p(t)$ over $\mathbb{Q}_{p}$. The degree of this factor is the length of the projection onto the $x$-axis of the edge and all the roots of this factor have a valuation equal to the slope of the edge. Therefore $e=1$ implies that the length of the projection onto the $x$-axis of any edge times its slope is a multiple of $n$.

We graph the Newton polygons satisfying this condition and in each case, we give a necessary and sufficient condition to have $e=1$. The obtained results are summarized in Theorem 1.2.

Ordinary case: $\mathbf{v}_{\mathbf{p}}\left(\mathbf{a}_{\mathbf{4}}\right)=\mathbf{0}$
The Newton polygon of $p(t)$ is represented in Figure 1 and we always have $e=1$.

p-rank 3 case: $v_{p}\left(a_{4}\right)>0$ and $v_{p}\left(a_{3}\right)=0$
The only Newton polygon for which $e=1$ is represented in Figure 2 .


This is the Newton polygon of $p(t)$ if and only if $v_{p}\left(a_{4}\right) \geq n / 2$. If this condition holds, $p(t)$ has a factor in $\mathbb{Q}_{p}$ of degree 2 with roots of valuation $n / 2$ and $e=1$ if and only if this factor is irreducible, that is, if and only if $p(t)$ has no root of valuation $n / 2$ in $\mathbb{Q}_{p}$.
p-rank 2 case: $v_{p}\left(a_{4}\right)>0, v_{p}\left(a_{3}\right)>0$ and $v_{p}\left(a_{2}\right)=0$
The only Newton polygon for which $e=1$ is represented in Figure 3 .


This is the Newton polygon of $p(t)$ if and only if $v_{p}\left(a_{3}\right) \geq n / 2$ and $v_{p}\left(a_{4}\right) \geq n$. If these conditions hold, $p(t)$ has a factor in $\mathbb{Q}_{p}$ of degree 4 with roots of valuation $n / 2$ and $e=1$ if and only if this factor has no root in $\mathbb{Q}_{p}$, that is, if and only if $p(t)$ has no root of valuation $n / 2$ in $\mathbb{Q}_{p}$.
p-rank 1 case: $v_{p}\left(a_{4}\right)>0, v_{p}\left(a_{3}\right)>0, v_{p}\left(a_{2}\right)>0$ and $v_{p}\left(a_{1}\right)=0$
There are two Newton polygons for which $e=1$. One is represented in Figure 4.


This is the Newton polygon of $p(t)$ if and only if $v_{p}\left(a_{2}\right) \geq n / 2, v_{p}\left(a_{3}\right) \geq n$ and $v_{p}\left(a_{4}\right) \geq 2 n$. If these conditions hold, $e=1$ if and only if $p(t)$ has no root of valuation $n / 2$ nor factor of degree 3 in $\mathbb{Q}_{p}$.

The other Newton polygon is represented in Figure 5 .
This is the Newton polygon of $p(t)$ if and only if $v_{p}\left(a_{2}\right) \geq n / 3, v_{p}\left(a_{3}\right) \geq 2 n / 3$ and $v_{p}\left(a_{4}\right)=n$. If these conditions hold $e=1$ if and only if $p(t)$ has no root of valuation $n / 3$ and $2 n / 3$ in $\mathbb{Q}_{p}$.
p-rank 0 case: $v_{p}\left(a_{4}\right)>0, v_{p}\left(a_{3}\right)>0, v_{p}\left(a_{2}\right)>0$ and $v_{p}\left(a_{1}\right)>0$
There are three Newton polygons for which $e=1$. One is represented in Figure 6.

This is the Newton polygon of $p(t)$ if and only if $v_{p}\left(a_{1}\right) \geq n / 3, v_{p}\left(a_{2}\right) \geq 2 n / 3$, $v_{p}\left(a_{3}\right)=n$ and $v_{p}\left(a_{4}\right) \geq 3 n / 2$. If these conditions hold, $e=1$ if and only if $p(t)$ has no root in $\mathbb{Q}_{p}$.

The second Newton polygon is represented in Figure 7.




This is the Newton polygon of $p(t)$ if and only if $v_{p}\left(a_{1}\right) \geq n / 4, v_{p}\left(a_{2}\right) \geq n / 2$, $v_{p}\left(a_{3}\right) \geq 3 n / 4$ and $v_{p}\left(a_{4}\right)=n$. If these conditions hold, $e=1$ if and only if $p(t)$ has no factor of degrees 1,2 and 3 in $\mathbb{Q}_{p}$.

The last Newton polygon is represented in Figure ; the corresponding abelian varieties are supersingular.

This is the Newton polygon of $p(t)$ if and only if $v_{p}\left(a_{1}\right) \geq n / 2, v_{p}\left(a_{2}\right) \geq n$, $v_{p}\left(a_{3}\right) \geq 3 n / 2$ and $v_{p}\left(a_{3}\right) \geq 2 n$. If these conditions hold, $e=1$ if and only if $p(t)$ has no root nor factor of degree 3 in $\mathbb{Q}_{p}$.

## 4. Supersingular case

In [6], Singh, McGuire and Zaytsev gave the list of irreducible characteristic polynomials of supersingular abelian varieties of dimension 4 , where $q$ is not a square. Here we derive the list when $q$ is a square.


Let $p(t)$ be an irreducible supersingular Weil polynomial of degree 8 , where $q$ is a square. By Honda-Tate Theorem, $\frac{1}{q^{4}} p(\sqrt{q} t)$ is a cyclotomic polynomial of degree 8 i.e; $\frac{1}{q^{4}} p(t \sqrt{q})=\Phi_{m}(t)$ such that $\phi(m)=8$ or $m \in\{15,16,20,24,30\}$. Therefore for each $m$ above, $p(t)=q^{g} \Phi_{m}\left(\frac{t}{\sqrt{q}}\right)$ gives a supersingular Weil polynomial of degree 8. Let $p(t)=\prod_{i} p_{i}(t)$ be the decomposition in irreducible factors of $p(t)$ over $\mathbb{Q}_{p}$ with $\pi=\sqrt{q} \zeta_{n}$ as a root, where $\zeta_{n}$ is primitive $n$th root of unity. To determine the dimension of the corresponding abelian variety, recall from [3], $p(t)^{e}$ is a characteristic polynomial of an abelian variety of dimension $4 e$, where $e$ is the least common denominator of $\frac{v_{p}(\pi)}{v_{p}(q)} \operatorname{deg} p_{i}(t)=\frac{\operatorname{deg} p_{i}}{2}$. Since $p(t)=q^{g} \Phi_{m}\left(\frac{t}{\sqrt{q}}\right)$, $\operatorname{deg} p_{i}=\operatorname{deg} r_{i}$ where $\Phi_{m}(t)=\prod_{i} r_{i}(t)$. But from chapter IV. 4 in 5, we have $\operatorname{deg} r_{i}=r$ where $r$ is the multiplicative order of $p$ in $\left(\frac{\mathbb{Z}}{m \mathbb{Z}}\right)^{*}$.
Hence, $e=1$ if $r$ is even. In each case of $m$ above, since $\phi(m)=2^{3}, r$ is either even or $r=1$. The later case only happens when $p \equiv 1 \bmod m$. Hence, $p(t)=q^{g} \Phi_{m}\left(\frac{t}{\sqrt{q}}\right)$, where $p \not \equiv 1 \bmod m$ is an irreducible characteristic polynomial of a supersingular abelian variety of dimension 4 , for each $m \in\{15,16,20,24,30\}$.
