#### 25 Abstract

26

27 We deployed semi-permeable membrane devices (SPMDs) on beaches for 28 days at 53 28 sites in Prince William Sound (PWS), Alaska, to evaluate the induction potential from 29 suspected sources of cytochrome P450 1A (CYP1A)-inducing contaminants. Sites were 30 selected to assess known point sources, or were chosen randomly to evaluate the region-31 wide sources. After deployment, SPMD extracts were analyzed chemically for persistent 32 organic pollutants (POPs) and polycyclic aromatic hydrocarbons (PAH). These results 33 were compared with hepatic CYP1A enzyme activity of juvenile rainbow trout injected 34 with the same extracts prior to clean-up for the chemical analyses. Increased CYP1A 35 activity was strongly associated with PAH concentrations in extracts, especially chrysene homologues but was not associated with POPs. The only apparent sources of chrysene 36 homologues were lingering oil from Exxon Valdez, asphalt and bunker fuels released 37 38 from storage tanks during the 1964 Alaska earthquake, creosote leaching from numerous 39 pilings at one site, and PAH-contaminated sediments at Cordova Harbor. Our results 40 indicate that PWS is remarkably free of pollution from PAH when nearby sources are absent as well as from pesticides and PCBs generally. 41

- 45 **1. Introduction**
- 46

47	Oil from the T/V Exxon Valdez (EVO) has been surprisingly persistent on some
48	beaches in western Prince William Sound (PWS), after deposition following the spill in
49	1989. Estimated loss rates of $< 4\%$ yr <sup>-1</sup> for the buried oil imply persistence for decades
50	(Short et al. 2007), presenting a potentially long-term reservoir of bioaffective
51	contaminants to wildlife. However, distinguishing any long term biological effects of
52	this oil from those of other contaminant sources is highly problematic.
53	
54	Several species that interact with the intertidal zone in the spill-impacted part of
55	PWS have shown prolonged expression of cytochrome P450 1A (CYP1A), a substrate-
56	inducible enzyme that is a sensitive biomarker of exposure to planar contaminants such
57	as polycyclic aromatic hydrocarbons (PAH), certain polychlorinated biphenyls (PCBs)
58	and other persistant organic pollutants (POPs). Expression of CYP1A in PWS nearshore
59	vertebrates such as sea otters (Enhydra lutris) harlequin ducks (Histrionicus histrionicus)
60	and crescent gunnels (Pholis laeta) has been highest in animals taken from locations
61	where EVO has been most persistent, and has appeared to decrease as the oil dispersed
62	(Bodkin et al. 2002, Jewett et al. 2002, Trust et al. 2000). These patterns suggest that
63	exposure to remaining EVO, a known CYP1A inducer (Woodin et al., 1997), may be the
64	source of the CYP1A induction observed in these animals.
65	

66 Whether the EVO remaining on PWS beaches is sufficiently bioavailable to 67 induce CYP1A in wildlife is a matter of some controversy. Once hardened into highly 68 viscous tar mats and asphalt pavements, the resistance to mass transfer of PAH is so great 69 that loss rates of PAH may become extremely low. However, sea otters and ducks can

disturb sediments while foraging (Kvitek and Oliver 1992; Calkins 1978), and any
subsurface oil encountered could contaminate their pelage or plumage. Oil ingested
during subsequent preening (Bodkin et al. 2002, Trust et al. 2000) provides an exposure
pathway for eliciting CYP1A induction and potentially toxic effects (Schwartz et al.
2004).

76 Evidence of CYP1A induction alone is not sufficient to identify the source of the 77 inducing agent when numerous potential sources may be present (Short and Springman 78 2006). In PWS, several sources of potential CYP1A inducers besides EVO must be considered. Putative sources include atmospheric transport of POPs (Stern et al. 1997), 79 PAH associated with erosion of terrestrial hydrocarbon source rock outcrops transported 80 81 hydraulically to the northern Gulf of Alaska and then by the Alaska Coastal Current to 82 PWS where they are deposited on the seafloor (Page et al. 1996, Short et al. 2007), POPs 83 associated with adult salmon returning to PWS to spawn (Krümmel et al. 2003, Ewald et 84 al. 1998), small spills of diesel and bilge oils from marine vessels, residues of asphalt and 85 bunker fuels derived from the Monterey Formation in California and released from 86 storage tanks in PWS that ruptured during the 1964 Alaska earthquake (Kvenvolden et al. 87 1995), and operations associated with continuing industrial activity in PWS such as 88 salmon hatcheries. Resolving contributions from these prospective sources to observed 89 CYP1A responses in biota presents a considerable challenge.

One promising approach for evaluating the CYP1A induction potential of a
 contaminant source involves injecting fish with contaminants accumulated by semi-

93	permeable membrane devices (SPMDs) deployed at locations strongly affected by the
94	candidate source (Springman et al. 2008). This approach does not require knowledge of
95	the chemical identity of the suspected contaminant, although analysis may provide this.
96	Rather, it examines the biomarker response from the bioavailable complex mixture
97	without selective filtration if the accumulated contaminants are injected without cleanup.
98	At a minimum, prospective contaminant sources that are not capable of eliciting CYP1A
99	responses in biota can be identified at high confidence when the injected contaminants
100	fail to elicit a response, provided the amount of contaminant injected is comparable with
101	those likely to be accumulated through passive equilibrium partitioning by the same
102	organisms exposed in the field.
103	
104	Our objectives in this study are to distinguish which contaminant sources in PWS
105	are capable of eliciting CYP1A activity in dosed fish and to identify which compounds of
106	the sampled complex mixture are most responsible. To accomplish this, we deployed
107	SPMDs at a variety of locations that included all the prospective contaminant sources
108	mentioned above. In Part I of this study, we measured the CYP1A induction potential of
109	contaminants extracted from deployed SPMDs and injected without clean-up into
110	juvenile rainbow trout (Oncorhynchus mykiss, Springman et al. 2008). Here we present
111	chemical analysis results of extracts from SPMDs deployed to evaluate the compounds
112	most likely responsible for induction, and of additional SPMDs deployed to better
113	characterize contaminant sources and distributions in PWS.

**2. Methods** 

116

117 2.1 Study Sites

118

119 We deployed SPMDs at 53 sites within PWS, including known and suspected 120 contaminant source sites and sites selected at random to characterize the pollution burden 121 of the Sound (Fig. 1). Known contaminant source sites include boat harbors at Cordova 122 (site 1, Table 1) and Chenega (site 2), patches of Alaska North Slope (ANS) oil 123 remaining from the 1989 Exxon Valdez oil spill (sites 3 - 7) or of Monterey Formation 124 bunker fuels released from ruptured fuel tanks at industrial "human activity" (HA) sites 125 during the 1964 Alaska earthquake (sites 8 - 12), and salmon hatcheries (sites 13 - 17). 126 Salmon streams (sites 18 - 22) are suspected as a source of contaminants released from 127 decomposing carcasses of mainly pink salmon (Oncorhynchus gorbuscha) following 128 spawning. One stream from each of the five largest Alaska Department of Fish and 129 Game districts was selected based on three criteria: 1) large returns of salmon during our 130 study period, 2) small stream channels and narrow deltas where fish (with putative contaminants) would be concentrated, and 3) accessibility via float plane. 131 132

To characterize region-wide, non-point contaminant sources, 30 sites were distributed at random among 5 sectors partitioning the Sound (depicted in Fig. 1). The number of sites within each sector was proportional to the total sector shoreline length (sites 23 – 52). This stratification reduced site clustering that could result from unrestricted random selection, ensuring site dispersion throughout the sound. Additionally, to better evaluate PAH availability, one SPMD was located at a long-term monitoring

139	station (Karinen et al., 1993) in Constantine Harbor (site 53). At this site, PAH
140	associated with hydrocarbon-rich rocks eroded from geologic sources east of PWS have
141	an intertidal sediment concentration of $561 \pm 15.2$ ng/g (± standard error here and
142	following) including the same suites of 2- to 4-ring PAH as are typically found in crude
143	oils (Short and Babcock 1996). Finally, one site was located in Graves Harbor (site 54),
144	a remote site in southeast Alaska ~ 300 km east of PWS and upcurrent of the geologic
145	hydrocarbon sources east of PWS to serve as a regional control.
146	
147	The ANS sites $(3 - 7)$ correspond with the following respective beach segment
148	identifiers that are used extensively in the literature on the Exxon Valdez oil spill,
149	including Part I of this study (Springman et al. 2008): DI067A, EL056C, KN109A,
150	KN114A, and KN136A. These sites are on Disk Island, Eleanor Island and Knight
151	Island.
152	
153	Random site locations were determined by considering the shoreline within a
154	sector as a continuous line of total length $L$ , generating a random number $r$ between 0 and
155	1, and finding the location coordinates associated with the product ( $r \cdot L$ ). The SPMD was
156	deployed at the nearest suitable location to the calculated coordinates.
157	
158	Additional local control sites were selected for the ANS and HA sites to evaluate
159	the spatial extent of contaminants from these sources. At the ANS sites, SPMDs were
160	deployed within patches of beach that contained obvious subsurface oil, to promote
161	accumulation of dissolved oil components. Associated local control deployments were

162	on apparently un-oiled beaches within 0.5 km of the oiled SPMD deployment location.
163	At the HA sites, SPMDs were deployed within patches of surface asphalt (4 sites), or
164	subsurface oil at one site (site 9), again to promote accumulation of dissolved oil
165	components, and local control SPMDs were deployed along shore on un-oiled portions of
166	the same beach, within 100 m either side of the oil deposit.
167 168 169	2.2 SPMD Deployment and Processing
170	All the SPMDs were deployed at mid-tide height on beaches, in one of 2 types of
171	canisters. The SPMDs were obtained from Environmental Sampling Technologies (EST,
172	St. Joseph, MO), and were usually deployed in cylindrical cages 30 cm long, each
173	containing 5 SPMDs woven on stainless steel carriers stacked within the cage. Only 1
174	SPMD was deployed at the local HA control locations and at 21 of the random sites,
175	contained within a canister housing 6 cm long. Each SPMD was 91.4 cm long and 2.5
176	cm wide, and contained 1 ml of ultra-high purity triolein. Canisters containing 5 SPMDs
177	were used to increase the amount of accumulated contaminants available for chemical
178	analysis and for injection into juvenile rainbow trout that were assayed for CYP1A
179	induction (see Springman et al. 2008 for details), while those containing only 1 SPMD
180	were used to extend the geographic range of contaminant surveillance and were only
181	analyzed chemically.
182	
183	At each deployment site, the cages were half-buried in pits excavated on

184 shorelines at the mid-tide level of each site, with the other half exposed to the

185 atmosphere. After placement in a pit, the excavated material was replaced to the level of 186 the beach surface, surrounding, but not covering, the cage. The grain sizes of sediments 187 on most PWS beaches range from pebbles to boulders, with relatively little mass 188 associated with sand and finer-grained sediments that could pass through the 2 mm 189 diameter of the SPMD cage perforations (Hayes and Michel 1999). Hence, little 190 sediment accumulated within the cages while deployed, and in no case more than 191 partially covered the bottom-most SPMD in the cage. This deployment arrangement 192 therefore exposed SPMDs to the atmosphere at lower tides, to surface seawater at higher 193 tides, and to mainly interstitial water flow within the upper 15 cm of beach for the larger 194 canisters, while minimizing biofouling and direct contact with beach sediments. Field 195 blank cages were briefly exposed to the atmosphere during some of the deployments. 196 Cages were deployed for 27 - 28 days, and then retrieved for dialysis of accumulated 197 contaminants.

198

199 Contaminants accumulated by the SPMDs were recovered by dialysis into hexane 200 at EST labs as described in Huckins et al. (2000). The dialysates from all SPMDs within 201 a deployment canister were combined to create a composite sample. Following 202 concentration of the dialysates to ~1 ml hexane, samples were partitioned into 203 subsamples for analysis. For samples derived from 5 SPMDs, the sample was partitioned 204 into 3 aliquots for chemical analyses each containing 5% of the sample, and 2 more 205 aliquots of 42.5% each for injection into juvenile trout for determination of CYP1A 206 activity. One each of the aliquots for injection and for chemical analysis was archived in 207 the event of accidental losses. For samples derived from 1 SPMD, the sample was split

208	into 2 aliquots for chemical analysis of PAH and POPs with no sample spared for
209	archives. This arrangement produced twice as much contaminant mass available for
210	chemical analysis from the single-SPMD deployments compared with the deployments
211	involving 5 SPMDs (0.5 vs. (5 x $0.05 = 0.25$ )) assuming equivalent deployment
212	conditions and performance, resulting in expected environmental detection limits for the
213	single-SPMD deployments to be lower by a factor of 2.
214	
215	2.3 Sample Analysis
216	5
217	The sample extracts were analyzed chemically for suites of 2- to 5-ring PAH
218	(including alkyl-substituted and dibenzothiophene homologues, the latter more accurately
219	denoted as polycyclic aromatic compounds but included here as PAH), selected legacy
220	pesticides and selected PCBs listed in Table 1. The PAH were analyzed in sets of twelve
221	plus one method blank, one spiked blank, and two reference samples at ABL following
222	the method described in Short et al. (1996). Briefly, the hexane aliquot for PAH analysis
223	was purified by 20 g:5 g silica: alumina column chromatography and gel permeation
224	HPLC, following addition of a suite of perdeuterated PAH used as internal standards.
225	Purified PAH were measured by gas chromatography/mass spectrometry (GCMS)
226	operated in the selected ion monitoring mode, and were quantified on the basis of a 5-
227	point calibration curve of the most similar PAH standard available.
228	
229	The POPs were analyzed in sets of four to twelve SPMD samples plus one

230 method blank and one spiked method blank. Method blanks were prepared by adding 0.5

231	ml of dichloromethane to a 2-ml vial. Spiked method blanks were prepared by adding
232	0.5 ml of dichloromethane and a spiking solution of analytes to a 2-ml vial; PCBs were
233	spiked at approximately 0.3-1.3 ng sample <sup>-1</sup> and pesticides were spiked at approximately
234	6 ng sample <sup>-1</sup> . An internal standard (PCB 103) was added to each method blank, spiked
235	blank and SPMD sample in its original 2-ml vial. PCBs are identified here according to
236	the scheme presented by Ballschmiter et al. (1992)
237	
238	Samples were cleaned up by size-exclusion high-performance liquid
239	chromatography using a 350-mm x 21.2-mm Envirosep ABC <sup>®</sup> preparatory column and a
240	60-mm x 21.2-mm Envirosep ABC <sup>®</sup> guard column, (Phenomenex, Inc., Torrance, CA),
241	with dichloromethane as the mobile phase (Sloan et al. 2005). Extracts containing low
242	amounts of PAH etc. were also cleaned up by gravity-flow silica/alumina
243	chromatography using columns packed with 20 cc of silica gel on top of 10 cc of alumina
244	wetted with dichloromethane, and the samples were eluted with 45 ml of
245	dichloromethane (Sloan et al. 2005). Extracts containing high amounts of PAH etc. were
246	cleaned up by gravity-flow acidic/basic silica chromatography. Columns were packed
247	with 5 cc of neutral silica gel (lower layer), 5 cc of KOH impregnated silica gel (middle
248	layer), and 15 cc of 40% (w/w) sulfuric acidic impregnated silica gel (upper layer) wetted
249	with 60 ml of 1:1 dichloromethane:hexane. The samples were eluted with 45 ml of 1:1
250	dichloromethane:hexane 40 minutes after being loaded on the column to allow reaction
251	with the acidic silica (Krahn et al. 1994, modified; see also Sloan et al. 2005 for further
252	details).

254	All samples were analyzed by GCMS in selected-ion monitoring mode using a
255	60-m x 0.25-mm, 0.25-µm film thickness DB-5 <sup>®</sup> GC column (J & W Scientific, Folsom,
256	CA) and a 10-m x 0.53-mm deactivated fused-silica guard column, with cool on-column
257	injection and helium carrier gas (Sloan et al. 2005). The concentrations of analytes were
258	calculated based on the internal standard and point-to-point (also known as piece-wise
259	linear) calibration using six concentrations of calibration standards ranging from
260	approximately 0.001 to 0.1 ng $\mu$ l <sup>-1</sup> for each analyte. The lower limit of quantitation
261	(LOQ) was reported when the GCMS response for that analyte in that sample was below
262	the GCMS calibration range. LOQs were calculated individually by analyte and by
263	sample (Sloan et al. 2004).
264	
265	Induction of CYP1A in juvenile trout livers following injection of sample aliquots
266	was evaluated by the ethoxyresorufin-O-deethylase (EROD) assay, based on an original
267	method by Pohl and Fouts (1980) and modified for a microplate spectrofluorometer
268	(Hodson et al. 1996). Molar specific activity was reported as picomole resorufin per mg
269	protein per minute (pmol mg <sup>-1</sup> min <sup>-1</sup> ). Details of the exposure conditions and assay
270	methods are given in Springman et al. (2008).

271

The oil in the patches at the ANS sites had previously been confirmed as remnants from the 1989 Exxon Valdez oil spill (Short et al. 2004). The Monterey Formation source of the oil at the HA sites was confirmed on the basis of tricyclic and tetracyclic terpane analysis as described by Kvenvolden et al. (1995).

277 2.4 Data Analysis

279	Concentrations of PAH in the SPMDs are presented as ng $g_{SPMD}^{-1}$ , with three
280	figures significant. To facilitate comparison among samples, individual PAH
281	concentrations were normalized to the total PAH (TPAH) concentration of the sample.
282	Ó
283	A rough approximation of ambient dissolved PAH concentrations may be inferred
284	from concentrations measured in SPMDs. Sundberg et al. (2005) estimate dissolved
285	concentrations corresponding with contaminant concentrations measured in SPMDs as:
286	$C_w = C_{SPMD} \cdot k_{I(s)}^{-1} \cdot t^{-1} \tag{1}$
287	where $C_w$ and $C_{SPMD}$ are the contaminant concentrations in water and the SPMD, $k_{I(s)}$ is
288	the sampling uptake rate constant of the SPMD for the contaminant in $1 d^{-1} g_{SPMD}^{-1}$ , and t
289	is the exposure time of the SPMD to the sampled medium. Luellen and Shea (2002)
290	present estimates of PAH uptake rates as device sampling rates $R_S$ (in 1 d <sup>-1</sup> ), where $R_S$ =
291	$m \cdot k_{I(s)}$ , and m is the mass of the SPMD. The average value of $R_s$ for the 2 – 4 ring PAH
292	listed by Luellen and Shea (2002) is 4.4 l d <sup>-1</sup> for SPMDs identical with ours, implying
293	values of $k_{I(s)}$ near 1 l d <sup>-1</sup> g <sub>SPMD</sub> <sup>-1</sup> , and $k_{I(s)}$ estimated for PCBs are also near 1 l d <sup>-1</sup> g <sub>SPMD</sub> <sup>-1</sup>
294	(Meadows et al. 1998). Assuming an effective exposure time of 14 d (because the
295	SPMDs were submerged half the time during 28 days and neglecting PAH absorbed from
296	the atmosphere) implies aqueous TPAH concentrations on the order of $C_w = C_{SPMD} \cdot (14$
297	d) <sup>-1</sup> ng l <sup>-1</sup> when $C_{SPMD}$ is given as ng $g_{SPMD}$ <sup>-1</sup> . Given the numerous assumptions
298	involved, including neglect of partitioning with particulate organic matter, constant
299	uptake rates during the exposure period and neglect of increased uptake from direct

300	contact with sediments infiltrating the deployment cages (Booij et al. 2003), this
301	approximation is probably only accurate to within a factor of $3 - 5$ , which suffices to
302	indicate the order of magnitude of the mean aqueous PAH concentrations.
303	
304	3. Results and Discussion
305	
306	3.1 Boat Harbors and Anchorages
307	$\mathcal{O}^*$
308	The entrance to Cordova Harbor is constricted, promoting retention of
309	contaminants released from the numerous potential sources within it, and leading to
310	substantial accumulation of PAH by the SPMD deployed there. The TPAH concentration
311	of the SPMD was 73,700 ng g <sup>-1</sup> , equivalent to ambient PAH concentrations on the order
312	of 5 $\mu$ g l <sup>-1</sup> (eq. 1). Phenanthrenes/anthracenes and fluoranthenes/pyrenes were the most
313	abundant homologous series, declining in abundance with increasing alkyl substitution
314	within each series (Fig. 2A). This PAH distribution pattern reflects the composite input
315	from multiple sources, including spilled fuels and lubricants, and combustion exhaust
316	products from inboard and outboard motors.
317	
318	The much smaller and less confined harbor at Chenega results in considerably
319	lower PAH concentrations compared with Cordova harbor. The TPAH concentration in
320	the Chenega SPMD, 1,690 ng g <sup>-1</sup> , was less than $2\%$ of the concentration accumulated
321	during the Cordova harbor deployment, and equivalent to dissolved concentrations on the

322 order of  $\sim$ 121 ng l<sup>-1</sup>. The PAH distribution pattern from Chenega resembled that of the

323 Cordova deployment, with phenanthrenes/anthracenes and fluoranthenes/pyrenes the 324 most abundant homologous series, and with declining abundance with increasing alkyl 325 substitution within each series (Fig. 2B). Nearly identical patterns were evident at the 326 two random sites where TPAH were greatest, in Sawmill Bay (site 26, about 3 km from 327 the Chenega harbor site and within the same embayment), and at Windy Bay (site 44, an 328 embayment on the eastern side of PWS enclosing a commercial oyster farm), where the TPAH concentrations were 374 and 442 ng  $g^{-1}$ , respectively (Table 2). These SPMD 329 330 concentrations imply that embayments that are more open than the harbor at Cordova have TPAH concentrations on the order of 30 ng l<sup>-1</sup>, likely from outboard motors and 331 332 other small boat activity.

333

334 The concentrations of total PCBs and pesticides in the SPMDs indicate that these contaminants rarely exceeded 1 ng  $l^{-1}$  in ambient seawater. At 32.9 ng  $g^{-1}$ , the total PCB 335 336 concentration in the SPMD deployed at Chenega harbor was among the highest of any found during this study (41.8 ng g<sup>-1</sup> at nearby Sawmill Bay, site 26; Table 2). At 337 Cordova harbor the SPMD concentration was only 6.31 ng  $g^{-1}$ . Elsewhere, 90% of the 338 SPMD concentrations were below 7 ng g<sup>-1</sup> (median = 2.67 ng g<sup>-1</sup>, N = 89). These 339 concentrations substantially exceeded those of the laboratory blanks (range: <LOQ – 0.40 340 ng g<sup>-1</sup>, N = 4) but not the field blanks (range: 2.00 – 16.3 ng g<sup>-1</sup>, N = 8). The distribution 341 342 of relative PCB concentrations was nearly identical among all the samples analyzed, 343 including field blanks, with almost all the PCBs present within the congener range 17 - 100344 153 inclusive (Fig. 3). This distribution pattern is similar to that evident in alpine lakes 345 of Europe (Fernandez and Grimalt 2003, Van Drooge et al. 2004) or in open waters of the

346	Baltic Sea (Sundberg et al. 2005), indicating surface water absorption of gas-phase PCBs
347	from the atmosphere. These concentrations imply total aqueous PCB concentrations
348	were below ~ 1 ng $l^{-1}$ throughout PWS, except near Sawmill Bay where concentrations
349	approach 3 ng l <sup>-1</sup> . As noted by Sundberg et al. (2005), these part per trillion
350	concentrations are unlikely to stimulate CYP1A induction in exposed biota.
351	
352	Pesticide concentrations in the deployed SPMDs were at least as low as those of
353	the PCBs, and were within the range of concentrations found in field and dialysis blanks.
354	The summed concentrations of the pesticides listed in Table 1 ranged from $<$ LOQ – 5.52
355	ng g <sup>-1</sup> ( $N = 87$ ), compared with concentrations in field blanks ranging from 0.08 – 4.73 ng
356	$g^{-1}$ (N = 8), and in dialysis blanks ranging from 0.03 – 2.92 ng $g^{-1}$ . The similarity of
357	these concentrations suggests that the detected pesticides were trace level residues
358	incorporated during SPMD manufacture or processing, rather than an indication of
359	ambient environmental concentrations in PWS. Because the concentrations of PCBs and
360	pesticides were uniformly below thresholds likely to induce CYP1A in biota throughout
361	PWS, we dismissed them as material factors and focused on PAH at the other sites
362	considered in more detail below.

363

364Injection of the SPMD extracts from the Cordova harbor SPMD elicited a strong3652 d EROD response of 36 pmol mg<sup>-1</sup> min<sup>-1</sup>, compared with a weak response from the366Chenega harbor SPMD (5.8 pmol mg<sup>-1</sup> min<sup>-1</sup>; Table 2). The 7 d EROD response from367Chenega was 2.97 pmol mg<sup>-1</sup> min<sup>-1</sup>, and all these responses were significantly (P < 0.001)</td>368greater than those from control and un-contaminated sites

*3.2 ANS Sites* 

372	The SPMDs deployed at the oiled ANS sites (sites $3 - 7$ , Table 2) consistently
373	accumulated substantial PAH burdens. The TPAH concentration in the SPMDs ranged
374	from 8,920 – 263,000 ng g <sup>-1</sup> , equivalent to aqueous concentrations of $640 - 19,000$ ng $I^{-1}$
375	(eq. 1). These aqueous concentration estimates are comparable with direct measurements
376	of dissolved-phase PAH in interstitial water that drained similar ANS oil patches in 2002,
377	which ranged from $76 - 4,600 \text{ ng l}^{-1}$ (average = 1,200 ng l <sup>-1</sup> ; Payne et al. 2005). The
378	distribution of PAH homologues showed the characteristic preponderance of alkyl-
379	substituted PAH (Fig. 4A), which followed a weathering pattern diagnostic of ANS oil
380	(Short and Heintz 1997), with chrysene homologues accounting for $5 - 9\%$ of the TPAH.
381	Accumulated PAH in replicate SPMD deployments at 2 of the 3 replicated sites agreed
382	within a factor of 2, but at site 3 (at Disk Island), the PAH concentration in one replicate
383	was ~ 19-fold greater than the other. The Disk Island replicates were separated by 25 m
384	in an extensive deposit of peat, and the low-PAH replicate was located in a surface
385	stream above the peat layer that continually flushed the SPMD, which may have
386	suppressed PAH accumulation. Previous studies have shown that humic substances
387	(including peat) increase the CYP1A induction of oil when the two are co-located,
388	possibly by increasing the solubility of petroleum hydrocarbons (Matsuo et al. 2006).
389	The stream at the Disk Island low PAH replicate transported the humic substances from
390	the deployment site, and these results were reflected in the EROD activity elicited by
391	extracts from these sites, particularly at 7 d.

393	The injected aliquots of the SPMD extracts from the oiled ANS sites consistently
394	elicited strong 2 d EROD responses, and often these responses persisted through 7 d
395	(Table 2). The 2 d EROD responses ranged from $27.5 - 59.4$ pmol mg <sup>-1</sup> min <sup>-1</sup> , and the 7
396	d responses ranged from $2.73 - 100 \text{ pmol mg}^{-1} \text{ min}^{-1}$ . The EROD replicates also
397	corresponded within factors of ~ 1.5 except for the 7 d responses at the Disk Island site
398	(site 3), where the EROD response of the replicate in the stream-flushed peat was lower
399	than that of the other less well flushed replicate by a factor of $\sim 6$ (Springman et al.
400	2008).
401	
402	The SPMDs deployed at the local control sites within the ANS sites accumulated
403	far less PAH than those deployed at the oiled sites. The TPAH concentrations ranged
404	from 132 – 299 ng g <sup>-1</sup> , implying ambient seawater concentrations below ~20 ng l <sup>-1</sup> ,
405	consistent with results from direct measurements of background PAH in PWS seawater
406	(Boehm et al. 2007, 2005; Carls et al. 2006, Neff et al. 2006). Extracts from these
407	SPMDs consistently failed to elicit a significant EROD response following injection into
408	juvenile trout (Table 2; Springman et al. 2008).
409	
410	3.3 Human Activity Sites
411	
412	Although PAH were readily accumulated by SPMDs deployed within patches of
413	oil lingering from fuel tanks damaged by the 1964 Alaska earthquake, the induction of
414	hepatic CYP1A following injection of extracted contaminants into trout was more

415	variable than results from the oiled ANS sites. The patches of remnant oil at 4 of the HA
416	sites were surficial asphalt pavements, and the SPMDs deployed within them
417	accumulated TPAH concentrations ranging from $392 - 20,900 \text{ ng g}^{-1}$ (Table 2). The
418	distribution of PAH homologues resembled that found at the small boat harbors (compare
419	Figs. 2B and 4B), with phenanthrenes/anthracenes and fluoranthenes/pyrenes the most
420	abundant homologous series, declining abundance with increasing alkyl substitution
421	within each series, and chrysenes accounting for $0.5 - 5\%$ of the TPAH. Following
422	injection into trout, these extracts consistently elicited low but significant 2 d EROD
423	responses ranging from $2.91 - 6.40$ pmol mg <sup>-1</sup> min <sup>-1</sup> (Table 2; Springman et al. 2008).
424	These responses subsided substantially by 7 d, ranging from $1.75 - 2.74$ pmol mg <sup>-1</sup> min <sup>-1</sup> .
425	
426	In contrast with the surficial asphalt patches at 4 of the HA sites, the SPMD at site
427	9 (at McClure Bay) was deployed in contact with the only occurrence of subsurface
428	Monterey Formation oil we have found in PWS, despite extensive sampling (Short et al.
429	2004, 2006). Chemical analysis confirmed the Monterey Formation origin of this oil,
430	which is still semi-liquid after 40 years. The distribution of PAH homologues at site 9
431	resembles those of the SPMDs deployed at the ANS sites, showing the preponderance of
432	alkyl-substituted PAH characteristic of crude and heavy refined oils, with chrysene
433	homologues accounting for 6.7% of the TPAH (Fig. 4). Although the TPAH
434	concentration in the site 9 SPMD was not the greatest among the HA deployments, the
435	combined chrysene homologues were (Table 2), and the associated EROD response was
436	also much greater at 2 d (at 37.6 pmol mg <sup>-1</sup> min <sup>-1</sup> ) and at 7 d (at 15.7 pmol mg <sup>-1</sup> min <sup>-1</sup> ).
437	These results illustrate how burial preserves CYP1A-inducing components of the oil, and

438	suggest that buried ANS oil may remain a potent source of CYP1A-inducing compounds
439	for decades, given the current slow loss rate of subsurface ANS oil from beaches in PWS.
440	
441	The SPMDs deployed at the local control locations within the HA sites show that
442	the PAH contamination from the asphalt patches did not extend much beyond them. Just
443	100 m on either side of these patches, TPAH concentrations in SPMDs ranged from 41 –
444	229 ng $g^{-1}$ , similar to results from the control locations within the ANS sites. As with the
445	ANS local controls, extracts from the HA control SPMDs consistently failed to elicit a
446	significant EROD response following injection into juvenile trout (Table 2; Springman et
447	al. 2008).
448	
449	3.4 Salmon Hatcheries
450	
451	Substantial PAH were accumulated by the SPMDs deployed at 2 of the salmon
452	hatcheries (sites 13 and 15, Table 2), only one of which induced CYP1A. The
453	deployment at the hatchery in Sawmill Bay (site 13) was near several hundred creosote
454	pilings. This SPMD accumulated a TPAH concentration of 15,200 ng g <sup>-1</sup> , with a PAH
455	homologue distribution similar to those elsewhere in Sawmill Bay (compare Figs. 2B and
456	2C), except for the greater contributions from chrysenes and 5-ring PAH. The higher

concentrations and proportions of 4- and 5-ring PAH from site 13 resulted in a stronger 2 457

d EROD response (34.8 pmol mg<sup>-1</sup> min<sup>-1</sup>) compared with extracts from the other sites 458

459 within Sawmill Bay (sites 2 and 44, Table 2), and this response remained elevated

through 7 d (at 4.90 pmol  $mg^{-1} min^{-1}$ ). 460

461

462	In contrast, a TPAH concentration of 10,900 ng g <sup>-1</sup> accumulated by the SPMD
463	deployed at Noerenburg hatchery (site 15) failed to elicit a significant EROD response
464	following injection into trout ( $P > 0.92$ for 2 d results; Springman et al. 2008; Table 2).
465	The distribution pattern of the accumulated PAH indicates a diesel oil source, because the
466	homologue distribution is truncated beyond the phenanthrenes/anthracenes (Fig. 5),
467	reflecting the effect of distillation during refining. The failure of this extract to induce
468	CYP1A corroborates the low induction potency of lower molecular mass PAH noted
469	previously (Sundberg et al. 2005, Barron et al. 2004). Hence diesel spills, although
470	chronic in PWS as a result of marine vessel traffic associated with commercial fishing,
471	tourism, and personal transportation, may be discounted as a significant cause of CYP1A
472	induction in biota.

473

474 3.5 Salmon Streams

475

Concentrations of PAH accumulated by SPMDs deployed at the salmon streams 476 during spring and summer ranged from 57 - 585 ng g<sup>-1</sup> (N = 10; Table 2), similar to 477 ranges from other sites not impacted by obvious local sources of PAH. Despite these low 478 479 TPAH concentrations, there was a small but significant increase in EROD response from 480 the late summer deployments compared with those of late spring (Springman et al. 2008). 481 The salmon streams sampled (N = 5) exhibited a high degree of inter-site consistency in spring (2 d mean value of  $2.7 \pm 0.062$  pmol mg<sup>-1</sup> min<sup>-1</sup>, CV = 0.052), which was repeated 482 483 for the summer sampling with consistent, slightly elevated 2 d responses ranging from

484 3.24 - 5.73. This slight seasonal increase in EROD response was attributed to

- 485 contaminants associated with decomposing salmon carcasses by Springman et al. (2008).
- 486

487 3.6 Random Sites, Constantine Harbor and the Regional Control Site

488

The TPAH concentrations of SPMDs deployed at the random sites were 489 consistently low, and showed no evidence of a seasonal difference. The TPAH 490 concentrations of the spring deployments ranged from  $25 - 374 \text{ ng g}^{-1}$  (mean = 130 ng g<sup>-1</sup> 491 <sup>1</sup>, N = 31), compared with a summer range of 40 – 442 ng g<sup>-1</sup> (mean = 126 ng g<sup>-1</sup>, N = 13). 492 493 Aside from the two sites where TPAH concentrations were greatest, (sites 26 and 44, discussed in sec. 3.1 above) and one site where naphthalenes account for over half the 494 PAH detected (site 33, where TPAH =  $332 \text{ ng g}^{-1}$ ), the TPAH concentrations were below 495 212 ng g<sup>-1</sup>. This range of concentrations was similar to those found in the SPMD field 496 blanks, where TPAH ranged from  $63 - 213 \text{ ng g}^{-1}$ , consisting mostly of naphthalenes with 497 some phenanthrenes and fluoranthenes/pyrenes detected consistently, and 498 499 dibenzothiophenes and chrysenes occasionally detected near MDLs. Because random 500 deployment sites may be taken as characteristic of PWS as a whole, these results imply that ambient concentrations of TPAH in seawater within the Sound were usually less than 501 ~ 15 ng  $l^{-1}$ , similar to results from the local control deployments at the ANS and HA sites. 502 503 Collectively these results indicate that PWS is remarkably free of pollution from PAH, as 504 well as from pesticides and PCBs, when nearby sources are absent. 505

506	The SPMD extracts from the random sites failed to induce significant EROD
507	responses following injection into trout (Table 2). The 2 d EROD responses ranged from
508	$1.70 - 4.78 \text{ pmol mg}^{-1} \text{ min}^{-1}$ (N = 9), compared with responses from field and laboratory
509	blanks that ranged from $2.80 - 6.40 \text{ pmol mg}^{-1} \text{ min}^{-1}$ ( $N = 5$ ). This confirms that EROD
510	inducing agents were generally absent in PWS.
511	
512	The low ambient PAH concentrations of PWS are probably typical of seawater in
513	the northern Gulf of Alaska generally. Comparable TPAH concentrations were found in
514	SPMDs deployed at Constantine Harbor and at the regional control site in northern
515	southeast Alaska (sites 53 and 54 respectively, Table 2). The SPMD deployed at
516	Constantine Harbor accumulated a TPAH concentration similar to those found in the field
517	blanks (Table 2), despite exposure to interstitial water draining sediments containing a
518	TPAH concentration of ~ 560 ng $g^{-1}$ (Short and Babcock 1996). This failure of the
519	SPMD to accumulate TPAH from these sediments demonstrates that PAH associated
520	with hydrocarbon source rock that is eroded by glaciers and then transported by the
521	Alaska Coastal Current along the northern Gulf of Alaska into PWS do not induce
522	CYP1A in fish and other biota, contrary to Huggett et al. (2003) (see Springman et al.
523	2008 for more discussion).
524	
525	3.7 Identification of CYP 1A-Inducing Compounds in PWS
526	
527	We sought to identify which components of the injected PAH mixtures are most
528	closely associated with CYP 1A induction by regression analysis. We began with a

529	comparison of linear and non-linear regressions of EROD activity on TPAH using a
530	variety of functions and ranking results according to the goodness-of-fit as determined by
531	the adjusted multiple- $R^2$ and model parsimony. The relation EROD = a [TPAH] <sup>b</sup> (eq. 2)
532	accounted for the variability of the data better than any other function evaluated,
533	including those with as many as four parameters (Marquardt-Levenberg non-linear
534	regression $R^2 = 0.87$ , N = 62; Fig. 10A). When the TPAH concentration of the injection
535	mixtures is low, EROD activity is consistently at the basal level, implying that PAH are
536	the likely inducing compounds rather than some other unknown contaminants absorbed
537	by the SPMDs but not measured by our chemical analysis.
538	
539	The CYP 1A induction potencies of PAH vary depending on the number of
540	aromatic rings, with 4- and 5-ring compounds much more potent than PAH with fewer
541	rings (Barron et al. 2004). We therefore compared non-linear regressions of TPAH, total
542	4- & 5-ring PAH and total chrysenes with EROD activity to identify more precisely
543	which PAH homologues in our injection mixtures best account for EROD induction.
544	Using the same 62 samples that were used above to determine the functional form for
545	EROD response to TPAH (eq. 2), the adjusted multiple- $R^2$ values for total 4- & 5-ring
546	PAH and total chrysenes were 0.87 and 0.92 respectively. This indicates the chrysenes
547	account best for the EROD activity for the mixtures we injected, whereas the total 4- &
548	5-ring PAH account no better than do the TPAH. The closer association of the
549	chrysenes implies that other PAH do not materially contribute to EROD induction in the
550	mixtures we injected. The regression equation for the chrysenes is $EROD = 58.3$
551	[chrysenes] <sup>0.306</sup> . Comparison of a plot of this equation and associated data with the

552 original plot for TPAH (Fig. 6) illustrates the better fit with the chrysenes, caused mostly 553 by 3 samples that had elevated TPAH but undetectable chrysenes and low associated 554 EROD activities. Note that the functional form of the EROD response implies that 555 increasing responses imply disproportionately larger increases in exposure 556 concentrations, which should be considered when interpreting results of monitoring 557 programs based on the SPMD-extract injection method presented here. 558 559 The close association of chrysenes and EROD response is not surprising, given 560 the PAH composition of the sources we evaluated and the general absence of other 561 CYP1A-inducing compounds in PWS. Compared with the model CYP 1A inducer 562 benzo[a]pyrene, chrysene is more abundant in these sources (especially in ANS oil, where its concentration is more than 50-fold greater), and it is about as water-soluble 563 564 (Mackay et al. 1992). This higher abundance offsets the lower CYP1A induction potency 565 of chrysene, which is  $\sim 25\%$  that of benzo[a]pyrene (Barron et al. 2004). In addition, 566 alkyl-chrysenes are even more abundant in ANS oil and other PWS sources, although 567 considerably less water soluble. Alkyl-phenanthrenes are both abundant in PWS sources and substantially more soluble than are correspondingly-substituted chrysenes (Mackay 568 569 et al. 1992), but their CYP1A induction potencies are lower by at least one order of 570 magnitude. Other PAH are either not as abundant or are not as potent (or both) as are the 571 chrysene homologues. We therefore conclude that chrysenes are primarily responsible 572 for CYP 1A induction in PWS, at least when exposure occurs through aquatic contact 573 (ingestion of prey contaminated by CYP 1A-inducing compounds is an independent 574 exposure route that is not assessed by the SPMD-extract injection method described

575	here). Hence, bioavailable sources containing substantial concentrations of chrysene
576	homologues are likely to stimulate CYP1A induction in appropriate test organisms
577	through aquatic exposure, and induction in resident biota exposed to these sources would
578	not be surprising. Such sources are relatively few in PWS and are limited to specific
579	anthropogenic impacts, the <i>Exxon Valdez</i> oil spill being the largest.
