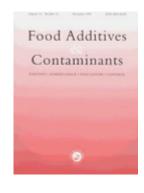

Brominated dioxins (PBDD/Fs) and PBDEs in Marine Shellfish in the UK

ABSTRACT

The occurrence of brominated dioxins (PBDD/Fs) and polybrominated diphenyl ethers (PBDEs) was investigated in commonly consumed species of marine shellfish in the UK. Individual samples of Pacific oysters (Crassostrea gigas), native oysters (Ostrea edulis), mussels (Mytilus edulis), scallops (Pecten maximus), and cockles (Cerastoderma edule) were collected from different coastal regions between 2006-2007. Samples of a particular species from each site were composited and 60 samples were analysed. Polybrominated dibenzofurans (PBDFs) occurred more frequently and generally at a higher level than polybrominated dibenzodioxins (PBDDs), except for 237-TriBDD which was the predominant PBDD/F congener in some of the species, notably oysters. This profile may reflect the environmental distribution of these compounds and the effects of removal mechanisms - degradation, selective uptake and metabolism. PBDEs were detected in all samples. The dominant congeners were BDEs 47, 49, 99 and 100 and, to a lesser extent, BDEs 66 and 154. The occurrence of BDE-209 was observed in most samples and appears to be species selective, with the highest values occurring almost exclusively in mussels and cockles. Among the species studied, oysters and mussels displayed relatively higher levels of both sets of contaminants; native oysters in particular, showed elevated levels of 237-TriBDD (up to 14.5 ng/kg). In general, contaminant levels appeared to be consistent with the extent of local industrialisation with lower levels observed in more remote areas such as the north of Scotland. Polybrominated biphenyls (PBBs) were also measured and PBBs 49, 52 and 77 were the most frequently detected, although levels were very low. Dietary intakes, estimated for PBDD/Fs showed that 237-TriBDD from single portions of oysters constituted a high proportion of the total dietary intake of the congener, but otherwise, dietary intakes of PBDD/Fs from shellfish were relatively low.

INTRODUCTION

Fish and shellfish are generally recommended by nutritionists and the medical profession as healthy foods that provide a good source of protein. Many oily fish species contain nutrients such as omega-3 fatty acids, which may reduce the risk of heart disease and stroke, and it is suggested that the consumption of one to two fish meals per week is helpful in preventing heart disease. The Food Standards Agency advises that consumers should eat two portions of fish a week, one of which should be oily, as part of a balanced diet, and also recommends maximum amounts of fish that should be consumed (Food Standards Agency, 2004). Similarly, bivalve shellfish are an excellent source of protein and are high in essential minerals, and low in calories and fat. However, fish and shellfish can accumulate contaminants from the water in which they live or from the food they eat. Shellfish classed as bivalve molluscs feed by filtering plankton from the surrounding water that washes through their habitat. This feeding mechanism leads to the bio-accumulation of pollutants of anthropogenic and biogenic origin from the surrounding waters even at a considerable distance from pollution sources.

Polybrominated diphenyl ethers (PBDEs), also known as polybrominated diphenyl oxides, and polybrominated biphenyls (PBBs) are mass-produced additive brominated flame retardants (BFRs) used in a variety of plastics, textiles, surface coatings, foams and manmade fibres. Their use has undoubtedly resulted in a reduction in human injury and fatality as a result of fires (Spiegelstein, 2001, Emsley et al 2002). However, the unrestricted application of these materials in the past has allowed diffusion of the contaminants into the environment during manufacture, use and disposal and continues to do so. This release is evident from the occurrence of PBDEs in environmental compartments such as water, sediments and biota (D'Silva et al 2004) and accompanies an increasing amount of evidence on potential detrimental human health effects (D'Silva et al 2004, Darnerud 2003, Hakk and Letcher 2003). Emerging toxicological data shows that PBDEs can cause liver and neurodevelopmental toxicity and affect thyroid hormone levels. In recent years the EU has carried out a comprehensive risk assessment under the Existing Substances Regulation (793/93/EEC) of commercial PBDE products. The outcome was a ban on

the use of mixtures such as Penta- and Octa-BDE since 2004, whilst deca-BDE remains under review until additional toxicological and occurrence data are finalised.

One of the principal sources of PBDD/Fs is widely accepted as being combustion processes such as incineration. However they can also occur as trace contaminants in brominated flame retardants such as PBDEs, and studies on formation chemistry show that the incineration of products containing BFRs as well as thermolysis of BFR material such as PBDEs is an important source of PBDD/F emissions. The substantial usage of BFRs will ensure that they remain a significant source of these contaminants. It has also been demonstrated that PBDD/Fs can be formed during ultra-violet irradiation of decabromodiphenyl ether (Olsman et al 2002). Recently, there have been reports that some lower brominated PBDD congeners (tri- tetra-) may be produced through biogenic formation via precursor pollutants in the marine environment and bio-accumulate in some marine species such as shellfish (Malmvern et al 2005, Haglund et al 2007). Toxicologically, studies that have been carried out on PBDD/Fs show biological responses that are comparable to the chlorinated dioxins. Structure activity relationship studies on PBDD/Fs suggest a similar mode of biological activity to the chlorinated analogues, which is likely to be initiated by Ah receptor binding (Mason et al 1987, Birnbaum et al 2003). There are of course likely to be subtle biochemical differences even between laterally-substituted compounds within the same homologue group. This would be due not only to the difference in substitution pattern as observed for the chlorinated dioxins but also to the differences in size and reactivity of the bromine and chlorine atoms and the difference in bond strengths for the organic carbon-bromine (weaker) and carbon-chlorine (stronger) bonds. Additionally, the larger size of the bromine atom and the degree of halogenation is also likely to alter the elicitation of biological effects (Birnbaum et al 2003).

The occurrence of PBDEs in shellfish has been documented in a number of publications, some of which have used shellfish as indicators of marine and aquatic pollution rather than as food. Reports on PBDD/Fs are far less frequent and may be a reflection of the greater difficulty in measuring PBDD/Fs reliably at comparable concentrations to the chlorinated dioxins. More recently, structured studies that are directed towards the estimation of human dietary exposure to these compounds have

investigated occurrence in different foods including fish and shellfish. Data for the sum of PBDE congeners in different foods in North America from a market basket survey showed that the maximum whole weight median concentrations (1725 ng/kg) occurred in fish (Schecter et al 2004). A recent survey of fish in Canada showed whole weight mean PBDE values ranging from 100 ng/kg for shrimp and tilapia to 2200 ng/kg for farmed salmon (Health Canada 2005). Similarly a study on different foods collected in the Catalonian region of Spain showed that the highest whole weight concentrations of PBDEs (1010 ng/kg) were found in blue fish. A recent Japanese Total Diet Study (TDS) found the highest average PBDE concentrations (1259 ng/kg) in the fish group (Ashizuka et al 2005), and a similar TDS study in the UK (Fernandes et al 2005) also found the highest average PBDE concentrations (500 ng/kg) in the fish group (not including BDE-209). Some recent studies have also shown evidence of the occurrence of these contaminants in shellfish. A study on a range of fish and shellfish species showed the occurrence of PBDEs and brominated dioxins in a number of the species, but particularly shellfish (Food Standards Agency 2006). Certain PBDEs were present in most or all of the shellfish analysed, the most abundant congeners being PBDEs 28, 47, 49, 66, 99, 100, 153 and 154 and among the PBDD/F congeners more PBDFs were detected than PBDDs.

This study aimed to investigate commonly consumed shellfish species such as oysters, mussels, scallops and cockles collected from different coastal regions around the UK. The occurrence levels of these brominated contaminants were determined and will be discussed in the context of currently available information. The human exposure arising from the consumption of these foods will also be discussed.

EXPERIMENTAL

Individual sub-samples of mussels, oysters and scallops were collected from coastal locations around Scotland between January and March 2006. Further samples of oysters, mussels and cockles from England, Wales and Northern Ireland (NI) were collected during the latter half of 2006 to early 2007. The individual samples were shucked and the flesh obtained from this process was representatively pooled and homogenised to yield 60 analytical samples – 17 mussels, 19 oysters, 4 cockles and 10+10 scallops. As scallops are sometimes retailed as the adductor muscle alone,

these samples were divided into separate adductor and gonad portions prior to pooling. The composite samples were freeze-dried and ground and the resulting powders were thoroughly mixed before taking sub-samples for analysis.

The composite samples were analysed for the following compounds:

Brominated dioxins - 2,3,7-triBDD, 2,3,8-triBDF, 2,3,7,8-Br substituted PBDD/Fs: tetra – hexa brominated congeners (note that this includes only one hexa-Bromosubstituted furan as no standards were available for the other three congeners). Polybrominated diphenylethers (PBDEs) - IUPAC numbers 17, **28**, **47**, 49, 66, 71, 77, 85, **99**, 100, 119, 126, 138, **153**, **154**, **183** and **209**. PBB congeners: IUPAC numbers 15, 49, **52**, **77**, 80, 101, **126**, 169, **153** and 209. (Those for which ¹³Carbon labeled standards were used as internal or sensitivity standards are shown in bold type and these also included six PBDD/F congeners). Additionally, chlorinated dioxins and PCBs and, in some cases, tetrabromobisphenol-A and hexabromocyclododecane were also determined but these are reported elsewhere (Driffield et al 2008, Fernandes et al 2007, Fernandes et al 2008,).

The analytical standards used, native as well as ¹³Carbon labeled for the individual analyte groups, were obtained as nonane solutions either from Cambridge Isotope Labs, Mass. USA or from Wellington Laboratories Inc. Ontario, Canada.

The methodology used for the analysis has been robustly validated and accredited to the ISO17025 standard. A full description of the procedures has been reported elsewhere (Fernandes et al 2008, Fernandes et al 2004). In brief, samples were fortified with ¹³C-labelled analogues of target compounds and exhaustively extracted using mixed organic solvents. PBDEs were chromatographically fractionated from the brominated dioxins and furans on activated carbon. The two fractions were further purified using high resolution gas chromatography coupled to high resolution mass spectrometry (HRGC-HRMS, Waters Autospec Ultima instrument fitted with a Hewlett Packard 6890N gas chromatograph). Additional control was provided by the inclusion of methods blanks and a reference material. Where reliable inter-calibration schemes exist for food matrices (PBDEs), the methodology has been further validated by successful participation in these studies (e.g. Dioxins in Food, Quasimeme) over

 the last 3 years (Quasimeme 2004, Norwegian Institute of Public Health 2005, 2007). The Z-scores achieved for fish and fish based matrices in these studies, ranged from – 0.61 to 0.81.

RESULTS AND DISCUSSION

A full version of the detailed results for all of the analytes described in this work is presented elsewhere (Fernandes et al 2006, Fernandes et al 2007) and contains in addition to the PBDD/Fs and PBDEs described in this paper, data on PBBs chlorinated dioxins/PCBs and for some samples, speciated HBCD and TBBPA. Due to the large volume of PBDD/F and PBDE data, only a summarised version of the results are presented in this paper. These are shown in Table 1. Data for the sum of the 17 PBDEs measured and for the PBDD/F TEQ are reported as *upper-bound*, i.e. where congeners were not detected they were assumed to be present at the level of the limit of detection. All concentrations are expressed on a whole weight basis to allow comparison with other data. The key statistics for this data are summarised in Table 2.

PBDEs are presented as the sum of 17 different congeners but, due to the high level of current interest in BDE-209, data for this congener is presented separately, as is data for BDE-47, BDE-99 and BDE-100. PBDD/F data is presented as toxic equivalents (TEQs) based on the use of the analogous chlorinated dioxin and furan (PCDD/F) toxic equivalent factors (TEFs) (Van den Berg et al 1998), an approach that has been used in other studies (Ohta et al 2004, Colles et al 2008, Fernandes et al 2008, Food Standards Agency 2006). Although the TEF scheme was updated in 2005 (Van den Berg et al 2006) the 1998 scheme values are ones used by regulators, and in current legislation. Similarly the comparative literature quoted here also uses the 1998 scheme. It should be recognised that this is an interim measure until a more rigorously evaluated set of TEF values specifically for the brominated dioxin/furan congeners become available (Food Standards Agency 2006B). The detection of brominated dioxins in foods, particularly fish and shellfish (Fernandes et al 2006B, Fernandes et al 2008) makes this a very necessary requirement, particularly as an obvious limitation of the approach used here is the exclusion of toxicity relating to the tribrominated congeners which have been shown to exhibit a similar mode of Ah receptor activity as the 2378-substituted dioxins and furans (Mason et al 1987,

Birnbaum et al 2003). The approach however provides data to allow comparisons with other studies that have provided similar data (Ohta et al 2004, Fernandes et al 2005, Fernandes et al 2008, Food Standards Agency 2006).

PBDEs were detected in all the shellfish species and, although the relative distributions of the lower- to mid-brominated congeners (BDE-47, 99, 100) measured in this study were very similar across the species, the relative distributions of the higher brominated congeners (BDE-183, BDE-209) varied. This was evident for BDE-209 in mussels and, particularly, in cockles (Table 1). The two groupings of congeners may be associated with commercial mixtures such as "Penta" which contains BDE-47, 99 &100, and "Deca" which is predominantly BDE-209 (BDE-183 is an expected breakdown product of "Deca"). Analysis of the congener distribution also shows that the levels of BDE-47 correlate well ($R^2 > 0.98$) with the total PBDE level for all species except cockles. As observed elsewhere (D'Silva et al 2004), BDE-47 is the major component of "Penta". On the other hand, BDE-209 does not correlate well with total PBDE in oysters or scallops, but shows strong correlation in cockles ($R^2 = 0.95$). These distributions of BDE congeners within the species may be indicative of the differences in bio-accumulative potential between species, with mussels showing the potential to bio-accumulate both Penta and Deca; oysters show very low levels for Deca and cockles the highest. It is unlikely that spatial distribution influences the correlation between BDE-209 and mussels through the selective loading of this contaminant at particular locations, because different species collected in the same area do not show relatively similar amounts of this congener. It is pertinent at this stage to mention the potential difficulties with the measurement of BDE-209 (De Boer 2004, Fernandes et al 2008). Laboratory blanks invariably show the presence of this congener, so blank subtraction is necessary, but removal mechanisms such as degradation during sample extraction/purification due to UV exposure (Olsman et al 2002), and other processes such as adsorption, are also known to occur. Hence the monitoring of the measurement process with the use of the commercially available ¹³C labelled BDE-209 as used in this work is strongly recommended in order to provide better measurement control (Fernandes et al 2008).

In terms of absolute concentrations, higher levels of PBDEs were observed in mussels compared to the other species, with the lowest levels being observed in cockles. The

observed predominance of BDE-47, 49, 99 and 100 and to a lesser extent BDE-66 and BDE-154 is similar to that observed in other studies (Ashizuka et al 2005, Fernandes et al 2008, Food Standards Agency 2006, Van Leeuven and De Boer 2008) and demonstrates the persistence of these contaminants, as the use of the commercial formulations from which these congeners derive has been banned for some years now.

There are very few reports on the occurrence of brominated dioxins and furans in food or biota. Recently however, PBDDs have been reported as occurring in marine biota, including shellfish taken from the Baltic Sea (Malmvern et al 2005, Haglund et al 2007). These studies targeted the brominated dibenzo-p-dioxin rather than dibenzofuran molecules and the occurrence of specific di and tri-brominated dioxins was recorded, with lower levels of tetrabrominated congeners. The authors suggest that this specific distribution originates from marine biogenic processes. The formation of individual brominated dioxin congeners is thought to proceed through condensation reactions of naturally occurring bromophenols mediated by the action of bromoperoxidases in the presence of bromide (Haglund et al 2007). This formation pathway is likely to be governed by kinetic processes and would explain the relative abundances of the individual congeners. However, the shellfish samples analysed in this work showed not only the congener profiles discussed above (for PBDDs); they also showed the presence of significant levels of PBDFs (Figure 1). The chromatographic profiles for the furans (tri- to penta-brominated) show similarities to those observed for environmental samples, in that a wide range of furan congeners are observed. This observed occurrence of a range of congeners rather than specific compounds suggest an origin from thermodynamic processes and it is likely that the observed profile and levels are due to combustion processes such as incineration. The predominance of PBDFs over PBDDs has also been observed in other studies involving combustion. Thus it is likely that the PBDD/Fs observed in these samples reflect both types of sources, biogenically mediated (Haglund et al 2007) as well as anthropogenic.

PBDD/Fs were detected in most of the samples at varying concentrations depending on the species. The calculated TEQs were higher in scallop gonad than in mussels (0.083 ng/kg compared to 0.055 ng/kg whole weight respectively), although mussels showed a more complete range of detectable congeners, particularly the PBDFs (Figure 1). Relatively lower TEQ levels were detected in the scallop adductor muscle and this may relate to the lower lipid content of the adductor. The contribution to TEQ was derived mainly from 2,3,7,8-TBDF, 2,3,4,7,8-PBDF and 2,3,7,8-TBDD (Fernandes et al, 2007). This composition is similar to the TEQ distribution of PCDD/Fs where, for fish and shellfish, these congeners, along with 1,2,3,7,8-PCDD, are often the main contributors. Most samples in this study showed the presence of tribromo dioxins and furans. In particular, 2,3,7-tribromo dioxin was the predominant congener in oysters, native oysters (Ostrea edulis) showing relatively elevated levels (up to 14.5 ng/kg whole weight). The toxicology of the tri-brominated dioxins and furans is the subject of continuing international study (Hornung et al 1997, Birnbaum 2003, Behnisch et al 2003,) with available toxicological data indicating that these compounds elicit more potent biological responses than their chlorinated analogues (Behnisch et al 2003). It should particularly be noted that the concentrations of tribromo substituted PBDD/F congeners reported here have not been included in the summed TEQs, as there are no recognised analogous TEF values for tri-chloro substituted PCDD/Fs. Moreover, although the levels of tri- and tetra- BDD/BDF congeners are elevated in comparison to the other 2,3,7,8-Br substituted compounds, they occur at a relatively low level in comparison to other non-laterally substituted triand tetra- congeners that were present in the samples. The greater abundance of these congeners (some are orders of magnitude higher in occurrence), merits further research, both in terms of toxicology - none is currently available - as well as occurrence in other marine and aquatic species, particularly those used as food. Although PBDD/Fs exposure in humans has been reported (Ohta et al, Colles et al), data on the tri-brominated compounds was not available. However, apart from the levels reported in this work, tri-brominated compounds have also been detected in other foods (Food Standards Agency, 2006c), which makes it likely that humans are exposed to these compounds. Apart from 2,3,7-tribromoBDD, the occurrence of PBDFs generally predominates that of PBDDs, reflecting profiles observed for environmental samples which in turn mirror the formation chemistry of these molecules through thermodynamic pathways that are a feature of combustion processes.

PBDE commercial mixtures are reported to be one of the major sources of PBDD/Fs (Hayakawa 2004 et al 2004, D'Silva et al 2004, Hagberg 2008), which occur as contaminants in the mixtures. Hayakawa et al report a positive correlation between these two groups in atmospheric deposition. There is very little information on pathways for PBDD/Fs or the occurrence of these compounds in sediments or soils, but given the similarities in physical and chemical properties to the chlorinated dioxins, it is not unreasonable to expect similar transfer mechanisms, although the PBDD/Fs are more likely to suffer degradation due to the higher susceptibility of the C-Br bond. In these samples, apart from the set of cockles (which should be interpreted with care because of the low number of samples) there is poor correlation between the various degradation/absorption/metabolic/bio-accumulation processes that define the occurrence of both these sets of contaminants in shellfish.

Although the data for PBBs is reported elsewhere (Fernandes et al 2007, Fernandes et al 2008), they were measured in all the samples and generally showed relatively low levels of occurrence. The most frequently detected congeners were PBB 49 and PBB 52 and these occurred typically in the range 0.2 - 1.0 ng/kg. The non-ortho substituted PBBs (congeners PBB77, PBB126 and PBB169) were also measured and of these PBB 77 was the most frequently detected, typically in the range of 0.01 - 0.05 ng/kg. The relative concentrations of the flame retardants – PBBs (low levels) and PBDEs (higher levels) is consistent with the greater and more recent usage of PBDEs in the UK. The low levels of PBBs observed are likely to arise from long range marine and aerial transport as observed in the detection of this contaminant in tissue from Arctic polar bear (D'Silva et al 2006).

Geographically, the spatial distribution of the sampling sites covers most of the shellfish harvesting areas around the UK coastline. The different levels of contaminants observed appear to be consistent with the levels of industrial activity in these regions. In general, mussels from locations in Scotland, particularly the north and north west (the Orkneys, Western Isles and Northern Highlands) showed, on average, lower levels of PBDEs and broadly similar levels of PBDD/Fs to locations in the rest of Britain and Northern Ireland. For Pacific oysters the situation was reversed, with higher levels observed in Scottish samples. The concentrations of the

tri-brominated dioxins, however, appear to be species dependent with average concentrations over an order of magnitude higher in samples of native oysters compared with Pacific oysters. This observation is valid even for samples of the two species harvested in the same location and may be related to the individual uptake and metabolism processes of the different species. The detection of most contaminants, albeit at low levels in all samples, some taken from the more remote areas confirms the long-range transport of these compounds, which is a defining characteristic of persistent organic pollutants.

Dietary Intakes

Dietary intakes from the shellfish alone were estimated from the average concentrations found in the different types of shellfish, assuming a portion size of 70 g. Dietary intakes from the whole diet excluding fish and shellfish were estimated from the results of a survey for brominated chemicals in samples from a Total Diet Study (TDS) (Food Standards Agency, 2006c). The TDS is a model of the typical UK diet. Foods were purchased from 24 randomly selected locations in the United Kingdom, and these were combined into 20 food groups. Foods that are consumed in large quantities such as bread, milk and potatoes, and foods that are susceptible to contamination such as fish (which includes shellfish) and offals, are kept separate.

Table 3 shows the estimated dietary intakes by 60 kg adults, of PBDD/Fs and dioxinlike PBBs, from single 70 g portions on their own, and from one and two weekly 70 g portions in combination with the rest of the diet, from shellfish.. In the case of oysters, especially native oysters, the estimated dietary intake of 2,3,7-triBDD by those who consume the species exceeds the average dietary intake from the rest of the diet by the UK population by a large margin. Otherwise, the estimated dietary intakes of brominated chemicals from shellfish alone are a low proportion of those from the rest of the diet. The difference between upper and lower bound values is likely due to the absence of PBDDs (apart from tri- and tetra-brominated dioxins) which have higher TEF values and would therefore have contributed to ~ two-thirds of the TEQ. This contrasts with PCDD/Fs in shellfish where most PCDDs and PCDFs are usually present.

 The results of a previous survey for brominated chemicals in farmed and wild fish and shellfish (Food Standards Agency, 2006a) were assessed by the independent expert Committee on Toxicty of Chemicals in Food, Consumer Products and the Environment (COT). The COT concluded that consumption of the shellfish was unlikely to pose a hazard to human health (Food Standards Agency, 2006b). The current results were similar to those for shellfish tested in the previous survey.

CONCLUSION

The data presented here confirms the widespread occurrence of PBDEs and PBDD/Fs in shellfish. The differences in levels for some congeners, notably 2,3,7-triBDD may suggest differences in bioaccumulation potential among the species. The dioxin-like toxicity arising from the occurrence of PBDD/F TEQ levels are lower than those reported for chlorinated dioxins (Fernandes et al 2008), and the assessment of the average dietary intake of these contaminants in the UK as a result of shellfish consumption shows that it is unlikely that toxicity arising from these contaminants alone is of concern. However, the TEQ from PBDD/Fs is an important contribution to the overall burden of human exposure to dioxin-like TEQ that results from PCDD/Fs, PCBs, PCNs and other similar halogenated aromatic compounds, and may be particularly significant for high level shellfish consumers. The exact magnitude of the contribution will remain indicative until toxicological studies provide a specific and comprehensive set of toxicity factors for PBDD/Fs including the contribution from the tri-brominated compounds.

The universal occurrence of PBDEs in these samples, characterised by the dominance of BDE-47, 99, 100 (and to a lesser extent BDE 209) in the congener profiles, demonstrates the persistence of these contaminants, as the use of the commercial formulations from which these congeners derive have seen a reduction in usage or have been banned for a few years. With the exception of 2,3,7-triBDD from oysters, estimated dietary intakes of brominated chemicals from shellfish were low compared to those from the rest of the diet. No change to the Food Standards Agency's advice on fish and shellfish consumption was needed on the basis of these results.
