# THE SINGULAR VALUES AND VECTORS OF LOW RANK PERTURBATIONS OF LARGE RECTANGULAR RANDOM MATRICES 

FLORENT BENAYCH-GEORGES AND RAJ RAO NADAKUDITI


#### Abstract

In this paper, we consider the singular values and singular vectors of finite, low rank perturbations of large rectangular random matrices. Specifically, we prove almost sure convergence of the extreme singular values and appropriate projections of the corresponding singular vectors of the perturbed matrix.

As in the prequel, where we considered the eigenvalue aspect of the problem, the non-random limiting value is shown to depend explicitly on the limiting singular value distribution of the unperturbed matrix via an integral transforms that linearizes rectangular additive convolution in free probability theory. The large matrix limit of the extreme singular values of the perturbed matrix differs from that of the original matrix if and only if the singular values of the perturbing matrix are above a certain critical threshold which depends on this same aforementioned integral transform.

We examine the consequence of this singular value phase transition on the associated left and right singular eigenvectors and discuss the finite $n$ fluctuations above these non-random limits.


## 1. Introduction

In many applications, the $n \times m$ signal-plus-noise data or measurement matrix formed by stacking the $m$ samples or measurements of $n \times 1$ observation vectors alongside each other can be modeled as:

\widetilde{X}=\sum_{i=1}^{k} \sigma_{i} u_{i} v_{i}^{*}+X \tag{1}
\end{equation*}

where $u_{i}$ and $v_{i}$ are left and right "signal" column vectors, $\sigma_{i}$ are the associated "signal" values and $X$ is the noise-only matrix of random noises. This model is ubiquitous in signal processing [40, 36], statistics [31, 2, 24] and machine learning [26] and is known under various guises as a signal subspace model [37], a latent variable statistical model [28], or a probabilistic PCA model [39].

Relative to this model a common application-driven objective is to estimate the signal subspaces $\operatorname{Span}\left\{u_{1}, \ldots, u_{k}\right\}$ and $\operatorname{Span}\left\{v_{1}, \ldots, v_{k}\right\}$ that contain signal energy. This is accomplished by computing the singular value decomposition (SVD) of $\widetilde{X}$ and extracting the $k$ largest singular values and the associated singular vectors of $\tilde{X}$ - these are referred

[^0]to as the $k$ principal components 35 and the famous Eckart-Young-Mirsky theorem states that they provide the best rank- $k$ approximation of the matrix $\widetilde{X}$ for any unitarily invariant norm [17, 30]. This theoretical justification combined with the fact that these vectors can be efficiently computed using now-standard numerical algorithms for the SVD [19] has led to the ubiquity of the SVD in applications such as array processing [40], genomics [1], wireless communications [16], information retrieval [18] to list a few [27].

In this paper, motivated by emerging high-dimensional statistical applications [25], we place ourselves in the setting where $n$ and $m$ are large and the SVD of $\widetilde{X}$ is used to form estimates $\left\{\widetilde{\sigma}_{i}\right\},\left\{\widetilde{u}_{i}\right\}_{i=1}^{k},\left\{\widetilde{v}_{i}\right\}_{i=1}^{k}$ of $\left\{\sigma_{i}\right\},\left\{u_{i}\right\}_{i=1}^{k}$ and $\left\{v_{i}\right\}_{i=1}^{k}$. We provide a precise characterization of the relationship between the estimated singular values of $\widetilde{X}$ and the true "signal" singular values $\sigma_{i}$ and the angle between the estimated and true singular vectors (see Section (2)).

In the limit of large matrices, these quantities only depend on integral transforms of the distribution of the singular values of the noise-only matrix $X$ in (11) and exhibit a phase transition about a critical value that also depends on the same aforementioned integral transforms which arises from rectangular free probability theory [8, 9]. We also characterize the fluctuations of the singular values about these asymptotic limit. The results obtained are precise in the large matrix limit and akin to our results in [13] go beyond answers that might be obtained using matrix perturbation theory [38].

Our results are very general (in terms of possible distributions for the noise model $X$ ) and recover as a special case results found in the literature for the eigenvalues [5, 6] and eigenvectors [23, 34, 33] of $\widetilde{X} \widetilde{X}^{*}$ in the setting where $X$ in (1) is Gaussian. For the Gaussian setting we provide new results for the right singular vectors. We follow the strategy developed in [13] for our proofs; we derive master equation representations that implicitly encode the relationship between the singular values and singular vectors of $X$ and $\widetilde{X}$ and use concentration results for vectors uniformly distributed on the unit sphere to obtain the stated analytical expressions.

This paper is organized as follows. We state our main results in Section 2 and provide some examples in Section 3. The proofs are provided in Sections 477 with some technical details relegated to the appendix in Section 8 ,

## 2. Main Results

2.1. Definitions and hypotheses. Let $X_{n}$ be a $n \times m$ real or complex random matrix. Throughout this paper we assume that $n \leq m$ so that we may simplify the exposition of the proofs. We may do so without loss of generality because in the setting where $n>m$, the expressions derived will hold for $X_{n}^{*}$. Let the $n \leq m$ singular values of $X_{n}$ be $\sigma_{1} \geq \sigma_{2} \geq \ldots \geq \sigma_{n}$. Let $\mu_{X_{n}}$ be the empirical singular value distribution, i.e., the probability measure defined as

$$
\mu_{X_{n}}=\frac{1}{n} \sum_{i=1}^{n} \delta_{\sigma_{i}} .
$$

Let $m$ depend on $n$ - we denote this dependence explicitly by $m_{n}$ which we will sometimes omit for brevity by substituting $m$ for $m_{n}$. Assume that as $n \longrightarrow \infty, n / m_{n} \longrightarrow c \in[0,1]$ and that the following hypothesis holds.

Hypothesis 2.1. The probability measure $\mu_{X_{n}}$ converges almost surely weakly to a nonrandom compactly supported probability measure $\mu_{X}$. Let $a$ and $b$ be, respectively, the infimum and supremum of the support of $\mu_{X}$. The smallest and largest singular values of $X_{n}$ converge almost surely to $a$ and $b$, respectively.

In this problem, we shall consider the extreme singular values and the associated singular vectors of $\widetilde{X}_{n}$, which is the random $n \times m$ matrix:

$$
\widetilde{X}_{n}=X_{n}+P_{n}
$$

where $P_{n}$ is defined as described below.
For a given $r \geq 1$, let $\theta_{1} \geq \cdots \geq \theta_{r}>0$ be deterministic non-zero real numbers, chosen independently of $n$. For every $n$, let $G_{u}^{(n)}, G_{v}^{(n)}$ be two independent matrices with sizes respectively $n \times r$ and $m \times r$, with i.i.d. entries distributed according to a fixed probability measure $\nu$ on $\mathbb{K}=\mathbb{R}$ or $\mathbb{C}$. We introduce the column vectors $u_{1}, \ldots, u_{r} \in \mathbb{K}^{n \times 1}$ and $v_{1}, \ldots, v_{r} \in \mathbb{K}^{m \times 1}$ obtained from $G_{u}^{(n)}$ and $G_{v}^{(n)}$ by either:
(1) Setting $u_{i}$ and $v_{i}$ to equal the $i$-th column of $\frac{1}{\sqrt{n}} G_{u}^{(n)}$ and $\frac{1}{\sqrt{m}} G_{v}^{(n)}$ respectively or,
(2) Setting $u_{i}$ and $v_{i}$ to equal to the vectors obtained from a Gram-Schmidt (or QR factorization) of $G_{u}^{(n)}$ and $G_{v}^{(n)}$ respectively.

We shall refer to the model (1) as the i.i.d. model and to the model (2) as the orthonormalized model. With the $u_{i}$ 's and $v_{i}$ 's constructed as above, we define the random perturbing matrix $P_{n} \in \mathbb{K}^{n \times m}$ as:

P_{n}=\sum_{i=1}^{r} \theta_{i} u_{i} v_{i}^{*}
$$

In the orthonormalized model, the $\theta_{i}$ 's are the non zero singular values of $P_{n}$ and the $u_{i}$ 's and the $v_{i}$ 's are the left and right associated singular vectors.

Hypothesis 2.2. The probability measure $\nu$ has mean zero, variance one and that satisfies a log-Sobolev inequality. If $\nu$ is entirely supported by the real line, $\int x^{4} \mathrm{~d} \nu(x)=3$. If $\nu$ is not entirely supported by the real line, the real and imaginary parts of a $\nu$-distributed random variables and independent and identically distributed with $\int|z|^{4} \mathrm{~d} \nu(z)=2$.

Remark 2.3. We note that there is small albeit non-zero probability that r i.i.d. copies of a random vector are not linearly independent. Consequently, there is a small albeit non-zero probability that the $r$ vectors obtained as in (2) via the Gram-Schmidt orthogonalization may not be well defined. However, in the limit of large matrices, this process produces well-defined vectors with overwhelming probability. This is implicitly assumed in what follows.

Remark 2.4. We also note if $\nu$ is the standard real or complex Gaussian distribution, then the singular vectors produced using the orthonormalized model will have uniform distribution on the set of $r$ orthogonal random vectors.
Remark 2.5. If $X_{n}$ is random but has a bi-unitarily invariant distribution and $P_{n}$ is non-random with rank $r$, then we are in same setting as the orthonormalized model for the results that follow.
2.2. Notation. Throughout this paper, for $f$ a function and $d \in \mathbb{R}$, we set

$$
f\left(d^{+}\right):=\lim _{z \downarrow d} f(z) ; \quad f\left(d^{-}\right):=\lim _{z \uparrow d} f(z),
$$

we also let $\xrightarrow{\text { a.s. }}$ denote almost sure convergence. The (ordered) singular values of an $n \times m$ Hermitian matrix $M$ will be denoted by $\sigma_{1}(M) \geq \cdots \geq \sigma_{n}(M)$. Lastly, for a subspace $F$ of a Euclidian space $E$ and a unit vector $x \in E$, we denote the norm of the orthogonal projection of $x$ onto $F$ by $\langle x, F\rangle$.

### 2.3. Largest singular values and singular vectors phase transition.

Theorem 2.6 (Largest singular value phase transition). The $r$ largest singular values of the $n \times m$ perturbed matrix $\widetilde{X}_{n}$ exhibit the following behavior as $n, m_{n} \rightarrow \infty$ and $n / m_{n} \rightarrow c$. We have that for each fixed $1 \leq i \leq r$,

$$
\sigma_{i}\left(\widetilde{X}_{n}\right) \xrightarrow{\text { a.s. }} \begin{cases}D_{\mu_{X}}^{-1}\left(1 / \theta_{i}^{2}\right) & \text { if } \theta_{i}^{2}>1 / D_{\mu_{X}}\left(b^{+}\right), \\ b & \text { otherwise },\end{cases}
$$

where $D_{\mu_{X}}$, the $D$-transform of $\mu_{X}$ is the function, depending on $c$, defined by

$$
D_{\mu_{X}}(z):=\left[\int \frac{z}{z^{2}-t^{2}} \mathrm{~d} \mu_{X}(t)\right] \times\left[c \int \frac{z}{z^{2}-t^{2}} \mathrm{~d} \mu_{X}(t)+\frac{1-c}{z}\right] \quad \text { for } z>b
$$

and $D_{\mu_{X}}^{-1}(\cdot)$ denotes its functional inverse on $[b,+\infty)$. Moreover, for each fixed $i>r$, we have that $\sigma_{i}\left(\widetilde{X}_{n}\right) \xrightarrow{\text { a.s. }} b$.

Theorem 2.7 (Norm of projection of largest singular vectors). Consider indices $i_{0} \in$ $\{1, \ldots, r\}$ such that $1 / \theta_{i_{0}} \in\left(0, D_{\mu_{X}}\left(b^{+}\right)\right)$. For each $n$, define $\widetilde{\sigma}_{i_{0}}=\sigma_{i_{0}}\left(\widetilde{X}_{n}\right)$ and let $\widetilde{u}$ and $\widetilde{v}$ be left and right unit singular vectors of $\widetilde{X}_{n}$ associated with the singular value $\widetilde{\sigma}_{i_{0}}$. Then we have, as $n \longrightarrow \infty$,

where $\rho=D_{\mu_{X}}^{-1}\left(1 / \theta_{i_{0}}^{2}\right)$ is the limit of $\widetilde{\sigma}_{i_{0}}$ and $\widetilde{\mu}_{X}=c \mu_{X}+(1-c) \delta_{0}$ and for any probability measure $\mu$,

c) Furthermore, in the same asymptotic limit, we have

Theorem 2.8 (Largest singular vector phase transition). When $r=1$, let the sole singular value of $P_{n}$ be denoted by $\theta$. Suppose that

$$
\begin{equation*}
\theta^{2} \leq 1 / D_{\mu_{X}}\left(b^{+}\right) \quad \text { and } \quad \varphi_{\mu_{X}}^{\prime}\left(b^{+}\right)=-\infty . \tag{5}
\end{equation*}
$$

For each $n$, let $\widetilde{u}$ and $\widetilde{v}$ denote, respectively, left and right unit singular vectors of $\widetilde{X}_{n}$ associated with its largest singular value of $\widetilde{X}_{n}$. Then

$$
\left\langle\widetilde{u}, \operatorname{ker}\left(\theta^{2} I_{n}-P_{n} P_{n}^{*}\right)\right\rangle \xrightarrow{\text { a.s. }} 0, \quad \text { and } \quad\left\langle\widetilde{v}, \operatorname{ker}\left(\theta^{2} I_{m}-P_{n}^{*} P_{n}\right)\right\rangle \xrightarrow{\text { a.s. }} 0,
$$

as $n \longrightarrow \infty$.
The following proposition allows to assert that in many classical matrix models, the above phase transitions actually occur with a finite threshold. The proof relies on a straightforward computation which we omit.

Proposition 2.9 (Edge density decay condition for phase transition). Assume that the limiting singular distribution $\mu_{X}$ has a density $f_{\mu_{X}}$ with a power decay at $b$, i.e., that, as $t \rightarrow b$ with $t<b, f_{\mu_{X}}(t) \sim M(b-t)^{\alpha}$ for some exponent $\alpha>-1$ and some constant $M$. Then:

$$
D_{\mu_{X}}\left(b^{+}\right)<\infty \Longleftrightarrow \alpha>0 \quad \text { and } \quad D_{\mu_{X}}^{\prime}\left(b^{+}\right)=-\infty \Longleftrightarrow \alpha \leq 1
$$

so that the phase transitions in Theorems 2.6 and 2.8 manifest for $\alpha=1 / 2$.
Remark 2.10 (Necessity of singular value repulsion for the singular vector phase transition). Under additional hypotheses on the manner in which the empirical singular distribution of $X_{n} \xrightarrow{\text { a.s. }} \mu_{X}$ as $n \longrightarrow \infty$, Theorem 2.8 can be generalized to any singular value with limit $b$ such that $D_{\mu_{X}}^{\prime}(\rho)$ is infinite. The specific hypothesis has to do with requiring the spacings between the singular values of $X_{n}$ to be more "random matrix like" and exhibit repulsion instead of being "independent sample like" with possible clumping. We plan to develop this line of inquiry in a separate paper.
2.4. Smallest singular values and vectors for square matrices. We now consider the phase transition exhibited by the smallest singular values and vectors. We restrict ourselves to the setting where $\widetilde{X}_{n}$ is a square matrix; this restriction is necessary because the non-monotonicity of the function $D_{\mu_{X}}$ on $[0, a)$ when $c=\lim n / m<1$, poses some technical difficulties that do not arise in the square setting.

Theorem 2.11 (Smallest singular value phase transition for square matrices). When $a>0$ and $m=n$, the $r$ smallest singular values of $\widetilde{X}_{n}$ exhibit the following behavior. We have that for each fixed $1 \leq i \leq r$,

$$
\sigma_{n+1-i}\left(\widetilde{X}_{n}\right) \xrightarrow{\text { a.s. }} \begin{cases}\varphi_{\mu_{X}}^{-1}\left(1 / \theta_{i}\right) & \text { if } \theta_{i}>1 / \varphi_{\mu_{X}}\left(a^{-}\right), \\ a & \text { otherwise. }\end{cases}
$$

where $\varphi_{\mu_{X}}^{-1}(\cdot)$ denotes the functional inverse of $\varphi_{\mu_{X}}(\cdot)$ in Equation (44), but with $z \in[0, a)$. Moreover, for each fixed $i>r$, we have that $\sigma_{n+1-i}\left(\widetilde{X}_{n}\right) \xrightarrow{\text { a.s. }} a$.
Theorem 2.12 (Norm of projection of smallest singular vector for square matrices). Consider indices $i_{0} \in\{1, \ldots, r\}$ such that $1 / \theta_{i_{0}} \in\left(0, D_{\mu_{X}}\left(b^{+}\right)\right)$. For each $n$, define $\widetilde{\sigma}_{i_{0}}=\sigma_{n+1-i_{0}}\left(\widetilde{X}_{n}\right)$ and let $\widetilde{u}$ and $\widetilde{v}$ be left and right unit singular vectors of $\widetilde{X}_{n}$ associated with the singular value $\widetilde{\sigma}_{i_{0}}$. Then we have, as $n \longrightarrow \infty$,

Theorem 2.13 (Smallest singular vector phase transition). When $r=1$ and $m=n$, let the smallest singular value of $\widetilde{X}_{n}$ be denoted by $\widetilde{\sigma}_{n}$ with $\widetilde{u}$ and $\widetilde{v}$ representing associated left and right unit singular vectors respectively. Suppose that

$$
a>0, \quad \theta \leq 1 / \varphi_{\mu_{X}}\left(a^{-}\right) \quad \text { and } \quad \varphi_{\mu_{X}}^{\prime}\left(a^{-}\right)=-\infty
$$

Then

$$
\left\langle\widetilde{u}, \operatorname{ker}\left(\theta^{2} I_{n}-P_{n} P_{n}^{*}\right)\right\rangle \xrightarrow{\text { a.s. }} 0, \quad \text { and } \quad\left\langle\widetilde{v}, \operatorname{ker}\left(\theta^{2} I_{m}-P_{n}^{*} P_{n}\right)\right\rangle \xrightarrow{\text { a.s. }} 0,
$$

as $n \longrightarrow \infty$.
The analogue of Remark 2.10 also applies here.
2.5. The $D$-transform in free probability theory. The $C$-transform with ratio $c$ of a probability measure $\mu$ on $\mathbb{R}_{+}$, defined as:

\begin{equation*}
C_{\mu}(z)=U\left(z\left(D_{\mu}^{-1}(z)\right)^{2}-1\right) \tag{8}
\end{equation*}
$$

where the function $U$, defined as:

$$
U(z)= \begin{cases}\frac{-c-1+\left[(c+1)^{2}+4 c z\right]^{1 / 2}}{2 c} & \text { when } c>0 \\ z & \text { when } c=0\end{cases}
$$

is the analogue of the logarithm of the Fourier transform for the rectangular free convolution with ratio $c$ (see [8, 10, 11] for an introduction to the theory of rectangular free convolution) in the sense described next.

Let $A_{n}$ and $B_{n}$ be independent $n \times m$ rectangular random matrices that are invariant, in law, by conjugation by any orthogonal (or unitary) matrix. Suppose that, as $n, m \rightarrow \infty$ with $n / m \rightarrow c$, the empirical singular values distributions $\mu_{A_{n}}$ and $\mu_{B_{n}}$ of $A_{n}$ and $B_{n}$ satisfy $\mu_{A_{n}} \longrightarrow \mu_{A}$ and $\mu_{B_{n}} \longrightarrow \mu_{B}$. Then by [8], the empirical singular values distribution $\mu_{A_{n}+B_{n}}$ of $A_{n}+B_{n}$ satisfies $\mu_{A_{n}+B_{n}} \longrightarrow \mu_{A} \boxplus_{c} \mu_{B}$, where $\mu_{A} \boxplus_{c} \mu_{B}$ is a probability measure which can be characterized in terms of the $C$-transform as

$$
C_{\mu_{A} \boxplus \mu_{B}}(z)=C_{\mu_{A}}(z)+C_{\mu_{B}}(z) .
$$

The coefficients of the series expansion of $U(z)$ are the rectangular free cumulants with ratio $c$ of $\mu$ (see [9] for an introduction to the rectangular free cumulants). The connection between free rectangular additive convolution and $D_{\mu}^{-1}$ (via the $C$-transform) and the appearance of $D_{\mu}^{-1}$ in Theorem 2.6 could be of independent interest to free probabilists:
the emergence of this transform in the study of isolated singular values completes the picture of [13], where the transforms linearizing additive and multiplicative free convolutions already appeared in similar contexts.
2.6. Fluctuations of the largest singular value. Assume that the empirical singular value distribution of $X_{n}$ converges to $\sigma_{X}$ faster than $1 / \sqrt{n}$. More precisely,
Hypothesis 2.14. Assume $\sqrt{n}\left(c-n / m_{n}\right) \underset{n \rightarrow \infty}{\longrightarrow} 0, r=1, \theta:=\theta_{1}^{2}>1 / D_{\sigma_{X}}\left(b^{+}\right)$and

$$
\sqrt{n}\left(\frac{1}{n} \operatorname{Tr}\left(\rho^{2}-X_{n} X_{n}^{*}\right)^{-1}-\int \frac{1}{\rho^{2}-t^{2}} \mathrm{~d} \mu_{X}(t)\right) \underset{n \rightarrow \infty}{\longrightarrow} 0
$$

for $\rho=D_{\mu_{X}}^{-1}\left(1 / \theta^{2}\right)$ the limit of $\sigma_{1}\left(\widetilde{X}_{n}\right)$.
Theorem 2.15. Let $\widetilde{\sigma}_{1}$ denote the largest singular value of $\widetilde{X}_{n}$. Then as $n \longrightarrow \infty$,

n^{1 / 2}\left(\widetilde{\sigma}_{1}-\rho\right) \xrightarrow{\mathcal{D}} \mathcal{N}\left(0, s^{2}\right),
$$

where $\rho=D_{\sigma_{X}}^{-1}\left(c, 1 / \theta^{2}\right)$ and

$$
s^{2}= \begin{cases}\frac{f^{2}}{2 \beta} & \text { for the i.i.d. model, } \\ \frac{f^{2}-2}{2 \beta} & \text { for the orthonormalized model, }\end{cases}
$$

with $\beta=1$ (or 2) when $X$ is real (or complex). Here,

$$
f^{2}:=\frac{\int \frac{\mathrm{d} \mu_{X}(t)}{\left(\rho^{2}-t^{2}\right)^{2}}}{\left(\int \frac{\mathrm{~d} \mu_{X}(t)}{\rho^{2}-t^{2}}\right)^{2}}+\frac{\int \frac{\mathrm{d} \widetilde{\mu}_{X}(t)}{\left(\rho^{2}-t^{2}\right)^{2}}}{\left(\int \frac{\mathrm{~d} \widetilde{\mu}_{X}(t)}{\rho^{2}-t^{2}}\right)^{2}}+2 \frac{\int \frac{t^{2} \mathrm{~d} \mu_{X}(t)}{\left(\rho^{2}-t^{2}\right)^{2}}}{\int \frac{\rho d \tilde{\mu}_{X}(t)}{\rho^{2}-t^{2}} \int \frac{\rho d}{\rho^{2}-t^{2}}},
$$

with $\widetilde{\mu}_{X}=c \sigma_{X}+(1-c) \delta_{0}$.
2.7. Fluctuations of the smallest singular value of square matrices. When $m_{n}=$ $n$ so that $c=1$, assume that:

Hypothesis 2.16. For all $n, m_{n}=n, r=1, \theta:=\theta_{1}>\varphi_{\mu_{X}}\left(a^{-}\right)$and

\sqrt{n}\left(\frac{1}{n} \operatorname{Tr}\left(\rho^{2}-X_{n} X_{n}^{*}\right)^{-1}-\int \frac{1}{\rho^{2}-t^{2}} \mathrm{~d} \mu_{X}(t)\right) \underset{n \rightarrow \infty}{\longrightarrow} 0
$$

for $\rho:=\varphi_{\mu_{X}}^{-1}(1 / \theta)$ the limit of the smallest singular value of $\widetilde{X}_{n}$.
Theorem 2.17. Let $\widetilde{\sigma}_{n}$ denote the smallest singular value of $\widetilde{X}_{n}$. Then as $n \longrightarrow \infty$ of

$$

where

s^{2}= \begin{cases}\frac{f^{2}}{2 \beta} & \text { for the i.i.d. model } \\ \frac{f^{2}-2}{2 \beta} & \text { for the orthonormalized model }\end{cases}
$$

with $\beta=1$ (or 2 ) when $X$ is real (or complex). Here,

$$
f^{2}=2 \theta^{2} \int \frac{\kappa^{2}+t^{2}}{\left(\kappa^{2}-t^{2}\right)^{2}} \mathrm{~d} \mu_{X}(t)
$$

## 3. Examples

3.1. Gaussian rectangular random matrices with non-zero mean. Let $X_{n}$ be an $n \times m$ real (or complex) matrix with independent, zero mean, normally distributed entries with variance $1 / m$. It is known [29, 4] that, as $n, m \longrightarrow \infty$ with $n / m \rightarrow c \in(0,1]$, the spectral measure of the singular values of $X_{n}$ converges to the distribution with density

$$
\mathrm{d} \mu_{X}(x)=\frac{\sqrt{4 c-\left(x^{2}-1-c\right)^{2}}}{\pi c x} \mathbb{1}_{(a, b)}(x) d x,
$$

where $a=1-\sqrt{c}$ and $b=1+\sqrt{c}$ are the end points of the support of $\sigma_{X}$. It is known [4] that the extreme eigenvalues converge to the bounds of this support.

Associated with this singular measure, we have, by an application of the result in [7, Sect. 4.1] and Equation (8),

$$
\begin{gathered}
D_{\mu_{X}}^{-1}(z)=\sqrt{\frac{(z+1)(c z+1)}{z}}, \\
D_{\mu_{X}}(z)=\frac{z^{2}-(c+1)-\sqrt{\left(z^{2}-(c+1)\right)^{2}-4 c}}{2 c}, \quad D_{\mu_{X}}\left(b^{+}\right)=\frac{1}{\sqrt{c}} .
\end{gathered}
$$

Thus for any $n \times m$ deterministic matrix $P_{n}$ with $r$ non-zero singular values $\theta_{1} \geq \cdots \geq \theta_{r}$ ( $r$ independent of $n, m$ ), for any fixed $i \geq 1$, by Theorem 2.6, we have

$$
\sigma_{i}\left(X_{n}+P_{n}\right) \xrightarrow{\text { a.s. }} \begin{cases}\sqrt{\frac{\left(1+\theta_{i}^{2}\right)\left(c+\theta_{i}^{2}\right)}{\theta_{i}^{2}}} & \text { if } i \leq r \text { and } \theta_{i}>c^{1 / 4}  \tag{9}\\ 1+\sqrt{c} & \text { otherwise. }\end{cases}
$$

as $n \longrightarrow \infty$. As far as the i.i.d. model is concerned, this formula allows us to recover some of the results of [5].

Now, onto the singular vectors. In the setting where $r=1$, let $P_{n}=\theta u v^{*}$. Then, by Theorems 2.7 and 2.8, we have

|\langle\widetilde{u}, u\rangle|^{2} \xrightarrow{\text { a.s. }} \begin{cases}1-\frac{c\left(1+\theta^{2}\right)}{\theta^{2}\left(\theta^{2}+c\right)} & \text { if } \theta \geq c^{1 / 4},  \tag{10}\\ 0 & \text { otherwise. }\end{cases}
$$

The phase transitions for the eigenvectors of $\widetilde{X}_{n}^{*} \widetilde{X}_{n}$ or for the pairs of singular vectors of $\widetilde{X}_{n}$ can be similarly computed to yield the expression:

|\langle\widetilde{v}, v\rangle|^{2} \xrightarrow{\text { a.s. }} \begin{cases}1-\frac{\left(c+\theta^{2}\right)}{\theta^{2}\left(\theta^{2}+1\right)} & \text { if } \theta \geq c^{1 / 4},  \tag{11}\\ 0 & \text { otherwise. }\end{cases}
$$

3.2. Square Haar unitary matrices. Let $X_{n}$ be Haar distributed unitary (or orthogonal) random matrix. All of its singular values are equal to one, so that it has limiting spectral measure

$$
\mu_{X}(x)=\delta_{1},
$$

with $a=b=1$ being the end points of the support of $\sigma_{X}$.
Associated with this spectral measure, we have (of course, $c=1$ )

$$
D_{\mu_{X}}(z)=\frac{z^{2}}{\left(z^{2}-1\right)^{2}} \quad \text { for } z \geq 0, z \neq 1
$$

thus for all $\theta>0$,

$$
D_{\mu_{X}}^{-1}\left(1 / \theta^{2}\right)= \begin{cases}\frac{\theta+\sqrt{\theta^{2}+4}}{2} & \text { if the inverse is computed on }(1,+\infty) \\ \frac{-\theta+\sqrt{\theta^{2}+4}}{2} & \text { if the inverse is computed on }(0,1)\end{cases}
$$

Thus for any $n \times n$, rank $r$ perturbing matrix $P_{n}$ with $r$ non-zero singular values $\theta_{1} \geq \cdots \geq \theta_{r}$ where neither $r$, nor the $\theta_{i}$ 's depend on $n$, for any fixed $i=1, \ldots, r$, by Theorem 2.6 we have

$$
\sigma_{i}\left(X_{n}+P_{n}\right) \xrightarrow{\text { a.s. }} \frac{\theta_{i}+\sqrt{\theta_{i}^{2}+4}}{2} \quad \text { and } \quad \sigma_{n+1-i}\left(X_{n}+P_{n}\right) \xrightarrow{\text { a.s. }} \frac{-\theta_{i}+\sqrt{\theta_{i}^{2}+4}}{2}
$$

while for any fixed $i \geq r+1$, both $\sigma_{i}\left(X_{n}+P_{n}\right)$ and $\sigma_{n+1-i}\left(X_{n}+P_{n}\right) \xrightarrow{\text { a.s. }} 1$.

## 4. Proof of Theorems 2.6 and 2.11

The proofs of both theorems are quite similar. As a consequence, we only prove Theorem 2.6.

The sequence of steps described below yields the desired proof (which is very close to the one of Theorem 2.1 of [13]):
(1) The first, rather trivial, step in the proof of Theorem 2.6 is to use Weyl's interlacing inequalities to prove that any fixed-rank singular value of $\widetilde{X}_{n}$ which does not tend to a limit $>b$ tends to $b$.
(2) Then, we utilize Lemma 4.1 below to express the extreme singular values of $\widetilde{X}_{n}$ as the $z$ 's such that a certain random $2 r \times 2 r$ matrix $M_{n}(z)$ is singular.
(3) We then exploit convergence properties of certain analytical functions (derived in the appendix) to prove that almost surely, $M_{n}(z)$ converges to a certain deterministic matrix $M(z)$, uniformly in $z$.
(4) We then invoke a continuity lemma (see Lemma 8.1 in the appendix) to claim that almost surely, the $z$ 's such that $M_{n}(z)$ is singular (i.e. the extreme singular values of $\left.\widetilde{X}_{n}\right)$ converge to the $z$ 's such that $M(z)$ is singular.
(5) We conclude the proof by noting that, for our setting, the $z$ 's such that $M(z)$ is singular are precisely the $z$ 's such that for some $i \in\{1, \ldots, r\}, D_{\mu_{X}}(z)=\frac{1}{\theta_{i}^{2}}$. Part (ii) of Lemma 8.1, about the rank of $M_{n}(z)$, will be useful to assert that when the $\theta_{i}$ 's are pairwise distinct, the multiplicities of the isolated singular values are all equal to one.

Firstly, up to a conditioning by the $\sigma$-algebra generated by the $X_{n}$ 's, one can suppose them to be deterministic and all the randomness supported by the perturbing matrix $P_{n}$.
Secondly, by [22, Th. 3.1.2], one has, for all $i \geq 1$,

$$
\sigma_{i+r}\left(X_{n}\right) \leq \sigma_{i}\left(\widetilde{X}_{n}\right) \leq \sigma_{i-r}\left(X_{n}\right)
$$

with the convention $\sigma_{j}\left(X_{n}\right)=+\infty$ for $i \leq 0$ and 0 for $i>n$. By the same proof as in [13, Sect. 6.2.1], it follows that for all $i \geq 1$ fixed,

\lim \inf \sigma_{i}\left(\widetilde{X}_{n}\right) \geq b \tag{12}
\end{equation*}
$$

and that for all $i>r$,

\sigma_{i}\left(\widetilde{X}_{n}\right) \underset{n \rightarrow \infty}{\longrightarrow} b . \tag{13}
\end{equation*}
$$

Our approach is based on the following lemma, which reduces the problem to the study of $2 r \times 2 r$ random matrices. Recall that the constants $r, \theta_{1}, \ldots, \theta_{r}$, and the random column vectors (which depend on $n$, even though this dependence does not appear in the notation) $u_{1}, \ldots, v_{r}, v_{1}, \ldots, v_{r}$ have bee introduced in Section 2.1 and that the perturbing matrix $P_{n}$ is given by

$$

Recall also that the singular values of $X_{n}$ are denoted by $\sigma_{1} \geq \cdots \geq \sigma_{n}$. Let us define the matrices

\Theta=\operatorname{diag}\left(\theta_{1}, \ldots, \theta_{r}\right) \in \mathbb{R}^{r \times r}, \quad U_{n}=\left[u_{1} \cdots u_{r}\right] \in \mathbb{K}^{n \times r}, \quad V_{m}=\left[v_{1} \cdots v_{r}\right] \in \mathbb{K}^{m \times r} .
$$

Lemma 4.1. The positive singular values of $\widetilde{X}_{n}$ which are not singular values of $X_{n}$ are the $z \notin\left\{\sigma_{1}, \ldots, \sigma_{n}\right\}$ such that the $2 r \times 2 r$ matrix

$$
M_{n}(z):=\left[\begin{array}{cc}
U_{n}^{*}\left(z^{2} I_{n}-X_{n} X_{n}^{*}\right)^{-1} U_{n} & U_{n}^{*}\left(z^{2} I_{n}-X_{n} X_{n}^{*}\right)^{-1} X_{n} V_{m} \\
V_{m}^{*} X_{n}^{*}\left(z^{2} I_{n}-X_{n} X_{n}^{*}\right)^{-1} U_{n} & V_{m}^{*}\left(z^{2} I_{m}-X_{n}^{*} X_{n}\right)^{-1} V_{m}
\end{array}\right]-\left[\begin{array}{cc}
0 & \Theta^{-1} \\
\Theta^{-1} & 0
\end{array}\right]
$$

is not invertible.
Proof. Firstly, [21, Th. 7.3.7] states that the non-zero singular values of $\widetilde{X}_{n}$ are the positive eigenvalues of $\left[\begin{array}{cc}0 & \widetilde{X}_{n} \\ \widetilde{X}_{n}^{*} & 0\end{array}\right]$. Secondly, for any $z>0$ which is not a singular value of $X_{n}$, by [12, Lem. 6.1],

\operatorname{det}\left(z I_{n}-\left[\begin{array}{cc}
0 & \widetilde{X}_{n} \\
\widetilde{X}_{n}^{*} & 0
\end{array}\right]\right)=\operatorname{det}\left(z I_{n}-\left[\begin{array}{cc}
0 & X_{n} \\
X_{n}^{*} & 0
\end{array}\right]\right)^{-1} \times \prod_{i=1}^{r} \theta_{i}^{2} \times \operatorname{det} M_{n}(z)
$$

which allows to conclude, since by hypothesis, $\operatorname{det}\left(z I_{n+m}-\left[\begin{array}{cc}0 & X_{n} \\ X_{n}^{*} & 0\end{array}\right]\right)^{-1} \neq 0$.
Note that by Hypothesis 2.1,

& \frac{1}{m} \operatorname{Tr} \frac{z}{z^{2} I_{m}-X_{n}^{*} X_{n}} \\
& \underset{n \rightarrow \infty}{\longrightarrow} \int \frac{z}{z^{2}-t^{2}} \mathrm{~d} \mu_{X}(t) \\
& z^{2}-t^{2} \\
& \mathrm{~d} \widetilde{\mu}_{X}(t) \quad\left(\widetilde{\mu}_{X}=c \sigma_{X}+(1-c) \delta_{0}\right),
\end{aligned}
$$

uniformly on any subset of $\{z \in \mathbb{C}$ s.t. $\Re(z)>b+\eta\}, \eta>0$. It follows, by a direct application of Ascoli's Theorem and Proposition 8.2, that almost surely, we have the following convergence (which is uniform in $z$ )

$$
\begin{aligned}
U_{n}^{*} \frac{z}{z^{2} I_{n}-X_{n} X_{n}^{*}} U_{n} & \underset{n \rightarrow \infty}{\longrightarrow}\left(\int \frac{z}{z^{2}-t^{2}} \mathrm{~d} \sigma_{X}(t)\right) \cdot I_{r}, \\
V_{m}^{*} \frac{1}{n} \operatorname{Tr} \frac{z}{z^{2} I_{m}-X_{n}^{*} X_{n}} V_{m} & \underset{n \rightarrow \infty}{\longrightarrow}\left(\int \frac{z}{z^{2}-t^{2}} \mathrm{~d} \widetilde{\mu_{X}}(t)\right) \cdot I_{r} .
\end{aligned}
$$

In the same way,

U_{n}^{*}\left(z^{2} I_{n}-X_{n} X_{n}^{*}\right)^{-1} X_{n} V_{m} \underset{n \rightarrow \infty}{\longrightarrow} 0 \quad \text { and } \quad V_{m}^{*} X_{n}^{*}\left(z^{2} I_{n}-X_{n} X_{n}^{*}\right)^{-1} U_{n} \underset{n \rightarrow \infty}{\longrightarrow} 0
$$

It follows that

M_{n}(z) \underset{n \rightarrow \infty}{\longrightarrow} M(z):=\left[\begin{array}{cc}
\varphi_{\mu_{X}}(z) I_{r} & 0  \tag{14}\\
0 & \varphi_{\tilde{\mu}_{X}}(z) I_{r}
\end{array}\right]-\left[\begin{array}{cc}
0 & \Theta^{-1} \\
\Theta^{-1} & 0
\end{array}\right]
$$

where $\varphi_{\mu_{X}}$ and $\varphi_{\tilde{\mu}_{X}}$ are the functions defined in the statement of Theorem [2.7.
In the case where the $\theta_{i}$ 's are pairwise distinct, Lemma 8.1 allows to conclude the proof of Theorem 2.6. Indeed, Lemma 8.1 says that exactly as much singular values of $\widetilde{X}_{n}$ as predicted by the theorem have limits $>b$ and that their limits are exactly the ones predicted by the Theorem. The part of the theorem devoted to singular values tending to $b$ can then be deduced from (12) and (13).

In the case where the $\theta_{i}$ 's are not pairwise distinct, an approximation approach allows to conclude (proceed for example as in Section 6.2.3 of [13], using [21, Cor. 7.3.8 (b)] instead of [21, Cor. 6.3.8]).

## 5. Proof of Theorems 2.7 and 2.12

The proofs of both theorems are quite similar. As a consequence, we only prove Theorem 2.7 .

As above, up to a conditioning by the $\sigma$-algebra generated by the $X_{n}$ 's, one can suppose them to be deterministic and all the randomness supported by the perturbing matrix $P_{n}$.

Firstly, by the Law of Large Numbers, even in the i.i.d. model, the $u_{i}$ 's and the $v_{i}$ 's are almost surely asymptotically orthonormalized. More specifically, for all $i \neq j$,

(the same being true for the $v_{i}$ 's). As a consequence, it is enough to prove that

\end{equation*}

c')

$$
\begin{equation*}
\sum_{i \text { s.t. } \theta_{i} \neq \theta_{i_{0}}}\left|\left\langle\widetilde{u}, u_{i}\right\rangle\right|^{2}+\left|\left\langle\widetilde{v}, v_{i}\right\rangle\right|^{2} \xrightarrow{\text { a.s. }} 0, \tag{17}
\end{equation*}

d')

\begin{equation*}
\sum_{i \text { s.t. } \theta_{i}=\theta_{i_{0}}}\left|\varphi_{\mu_{X}}(\rho) \theta_{i_{0}}\left\langle\widetilde{v}, v_{i}\right\rangle-\left\langle\widetilde{u}, u_{i}\right\rangle\right|^{2} \xrightarrow{\text { a.s. }} 0, \tag{18}

Again, the proof is based on a lemma which reduces the problem to the study of the kernel of a random $2 r \times 2 r$ matrix. The matrices $\Theta, U_{n}$ and $V_{m}$ are the ones introduced before Lemma 4.1.

Lemma 5.1. Let $z$ be a singular value of $\widetilde{X}_{n}$ which is not a singular value of $X_{n}$ and let $(u, v)$ be a corresponding singular pair of unit vectors. Then the column vector

+v^{*} P_{n}^{*} \frac{z}{\left(z^{2} I_{n}-X_{n} X_{n}^{*}\right)^{2}} X_{n} P_{n}^{*} u+u^{*} P_{n} X_{n}^{*} \frac{z}{\left(z^{2} I_{n}-X_{n} X_{n}^{*}\right)^{2}} P_{n} v=1 . \tag{19}
\end{gather*}

Proof. The first part of the lemma is easy to verify with the formula $X_{n}^{*} f\left(X_{n} X_{n}^{*}\right)=$ $f\left(X_{n}^{*} X_{n}\right) X_{n}^{*}$ for any function $f$ defined on $[0,+\infty)$. For the second part, use the formulas

to establish $u=\left(z^{2} I_{n}-X_{n} X_{n}^{*}\right)^{-1}\left(z P_{n} v+X_{n} P_{n}^{*} u\right)$, and then use the fact that $u^{*} u=1$.
Let us consider $z_{n},(\widetilde{u}, \widetilde{v})$ as in the statement of Theorem 2.7. Note firstly that for $n$ large enough, $z_{n}>\sigma_{1}\left(X_{n}\right)$, hence Lemma 5.1 can be applied, and the vector

\end{array}\right]=\left[\theta_{1}\left\langle v_{1}, \widetilde{v}\right\rangle, \ldots, \theta_{r}\left\langle v_{r}, \widetilde{v}\right\rangle, \theta_{1}\left\langle u_{1}, \widetilde{u}\right\rangle, \ldots, \theta_{r}\left\langle u_{r}, \widetilde{u}\right\rangle\right]^{T}
$$

belongs to ker $M_{n}\left(z_{n}\right)$. As explained in the proof of Theorem 2.6, the random matrixvalued function $M_{n}(\cdot)$ converges almost surely uniformly to the matrix-valued function $M(\cdot)$ introduced in Equation (14). Hence $M_{n}\left(z_{n}\right)$ converges almost surely to $M(\rho)$, and it follows that the orthogonal projection on $(\operatorname{ker} M(\rho))^{\perp}$ of the vector of (20) tends almost surely to zero.

Let us now compute this projection. For $x, y$ column vectors of $\mathbb{K}^{r}$,

Note that $\rho$ is precisely defined by the relation $\theta_{i_{0}}^{2} \varphi_{\mu_{X}}(\rho) \varphi_{\tilde{\mu}_{X}}(\rho)=1$. Hence with $\beta:=$ $-\theta_{i_{0}} \varphi_{\widetilde{\mu}_{X}}(\rho)$, we have,

and the orthogonal projection of any vector $\left[\begin{array}{l}x \\ y\end{array}\right]$ on $(\operatorname{ker} M(\rho))^{\perp}$ is the vector $\left[\begin{array}{l}x^{\prime} \\ y^{\prime}\end{array}\right]$ such that for all $i$,

& b_{n}=\widetilde{u}^{*} P_{n} \frac{X_{n}^{*} X_{n}}{\left(z_{n}^{2} I_{m}-X_{n}^{*} X_{n}\right)^{2}} P_{n}^{*} \widetilde{u}=\sum_{i, j=1}^{r} \theta_{i} \theta_{j} \overline{\left\langle u_{i}, \widetilde{u}\right\rangle}\left\langle u_{j}, \widetilde{u}\right\rangle v_{i}{ }^{*} \frac{X_{n}^{*} X_{n}}{\left(z_{n}^{2} I_{m}-X_{n}^{*} X_{n}\right)^{2}} v_{j}  \tag{23}\\

Since the limit of $z_{n}$ is out of the support of $\sigma_{X}$, one can apply Proposition 8.2 to assert that both $c_{n}$ and $d_{n}$ have almost sure limit zero and that in the sums (22) and (23), any term such that $i \neq j$ tends almost surely to zero. Moreover, by (17), these sums can also be reduced to the terms with index $i$ such that $\theta_{i}=\theta_{i_{0}}$. Tu sum up, we have

\underset{n \rightarrow \infty}{\longrightarrow} \int \frac{t^{2}}{\left(\rho^{2}-t^{2}\right)^{2}} \mathrm{~d} \widetilde{\mu}_{X}(t),
\end{gathered}

hence by Proposition 8.2, almost surely,

allow to recover the RHS of (16) easily. Via (18), one easily deduces (15).

## 6. Proof of Theorems 2.8 and 2.13

Again, we shall only prove Theorem 2.8 and suppose the $X_{n}$ 's to be non random.
Let us consider the matrix $M_{n}(z)$ introduced in Lemma 4.1. Here, $r=1$, so one easily gets, for each $n$,

Moreover, for $b_{n}:=\sigma_{1}\left(X_{n}\right)$ the largest singular value of $X_{n}$, looking carefully at the term in $\frac{1}{z^{2}-b_{n}^{2}}$ in $\operatorname{det} M_{n}(z)$, it appears that with a probability which tends to one as $n \longrightarrow \infty$, we have

It follows that with a probability which tends to one as $n \longrightarrow \infty$, the largest singular value $\widetilde{\sigma}_{1}$ of $\widetilde{X}_{n}$ is $>b_{n}$.

Then, one concludes using the second part of Lemma 5.1, as in the proof of Theorem 2.3 of [13].

## 7. Proof of Theorems 2.15 and 2.17

We shall only prove Theorem 2.15, because Theorem 2.17 can be proved similarly.
We have supposed that $r=1$. Let us denote $u=u_{1}$ and $v=v_{1}$. Then we have

with $u \in \mathbb{K}^{n \times 1}, v \in \mathbb{K}^{m \times 1}$ random vectors whose entries are $\nu$-distributed independent random variables, renormalized in the orthonormalized model, and divided by respectively $\sqrt{n}$ and $\sqrt{m}$ in the i.i.d.. model. We also have that the matrix $M_{n}(z)$ defined in Lemma 4.1 is a $2 \times 2$ matrix.

Let us fix an arbitrary $b^{*}$ such that $b<b^{*}<\rho$. Theorem 2.6 implies that almost surely, for $n$ large enough, $\operatorname{det}\left[M_{n}(\cdot)\right]$ vanishes exactly once in $\left(b^{*}, \infty\right)$. Since moreover, almost surely, for all $n$,

we deduce that almost surely, for $n$ large enough, $\operatorname{det}\left[M_{n}(z)\right]>0$ for $b^{*}<z<\widetilde{\sigma}_{1}$ and $\operatorname{det}\left[M_{n}(z)\right]<0$ for $\widetilde{\sigma}_{1}<z$.

As a consequence, for any real number $x$, for $n$ large enough,

for $X, Y, Z$ (resp. $X, Y, \Re(Z), \Im(Z)$ ) independent standard real Gaussian variables if $\beta=1$ (resp. if $\beta=2$ ) and for $c_{1}, c_{2}, d$ some real constants given by the following formulas:

& c_{2}^{2}= \begin{cases}\frac{2}{\beta} \int \frac{\rho^{2}}{\left(\rho^{2}-t^{2}\right)^{2}} \mathrm{~d} \widetilde{\mu}_{X}(t) & \text { in the i.i.d. model, } \\
\frac{2}{\beta}\left(\int \frac{\rho^{2}}{\left(\rho^{2}-t^{2}\right)^{2}} \mathrm{~d} \widetilde{\mu}_{X}(t)-\left(\varphi_{\widetilde{\mu}_{X}}(\rho)\right)^{2}\right) & \text { in the orthonormalized model, }\end{cases}  \tag{26}\\
& d^{2}=\frac{1}{\beta} \int \frac{t^{2}}{\left(\rho^{2}-t^{2}\right)^{2}} \mathrm{~d} \mu_{X}(t) . \tag{27}
\end{align*}

\end{array}\right]

Let us for example expand the upper left entry of $\Gamma_{n, 1,1}$ of $\Gamma_{n}$. We have

& +\sqrt{n}\left(\frac{1}{n} \operatorname{Tr} \frac{z_{n}}{z_{n}^{2} I_{n}-X_{n} X_{n}^{*}}-\varphi_{\mu_{X}}\left(z_{n}\right)\right)+\sqrt{n}\left(\varphi_{\mu_{X}}\left(z_{n}\right)-\varphi_{\mu_{X}}(\rho)\right) \tag{28}

The third term of the RHS of (28) tends to $x \varphi_{\mu_{X}}^{\prime}(\rho)$ as $n \longrightarrow \infty$. By Taylor-Lagrange Formula, there is $\xi_{n} \in(0,1)$ such that the second one is equal to

\end{aligned}
$$

It follows that the distribution of $\sqrt{n}\left(\widetilde{\sigma}_{1}-\rho\right)$ converges weakly to the one of $s X$, for $X$ a standard Gaussian random variable on $\mathbb{R}$ and

$$
s^{2}=\frac{\theta^{4}}{4}\left(\left(\varphi_{\tilde{\mu}_{X}}(\rho) c_{1}\right)^{2}+\left(\varphi_{\mu_{X X}}(\rho) c_{2}\right)^{2}+4\left(\theta^{-1} d\right)^{2}\right) .
$$

One can easily recover the formula given in Theorem 2.15 for $s^{2}$, using the relation $\varphi_{\mu_{X}}(\rho) \varphi_{\tilde{\mu}_{X}}(\rho)=\theta^{-2}$.

## 8. Appendix

We now state the continuity lemma that we use in the proof of Theorem 2.6. We note that nothing in its hypotheses is random. As hinted earlier, we will invoke it to localize the extreme eigenvalues of $\widetilde{X}_{n}$.

Lemma 8.1. We suppose the positive real numbers $\theta_{1}, \ldots, \theta_{r}$ to be pairwise distinct. Let us fix a real number $0 \leq b$ and two analytic functions $\varphi_{1}, \varphi_{2}$ defined on $\{z \in \mathbb{C}$ s.t. $\Re(z)>$ $0\} \backslash[0, b]$ such that for all $i=1,2$,
a) $\varphi_{i}(z) \in \mathbb{R} \Longleftrightarrow z \in \mathbb{R}$,
b) for all $z>b, \varphi_{i}(z)<0$,
c) $\varphi_{i}(z) \longrightarrow 0$ as $|z| \longrightarrow \infty$.

Let us define the $2 r \times 2 r$-matrix-valued function

$$
M(z):=\left[\begin{array}{cc}
0 & \Theta^{-1} \\
\Theta^{-1} & 0
\end{array}\right]-\left[\begin{array}{cc}
\varphi_{1}(z) I_{r} & 0 \\
0 & \varphi_{2}(z) I_{r}
\end{array}\right]
$$

and denote by $z_{1}>\cdots>z_{p}$ the $z$ 's in $(b, \infty)$ such that $M(z)$ is not invertible, where $p \in\{0, \ldots, r\}$ is the number of $\theta_{i}$ 's such that

$$
\lim _{z \downarrow b} \varphi_{1}(z) \varphi_{2}(z)>\frac{1}{\theta_{i}^{2}}
$$

Let us also consider a sequence $0<b_{n}$ with limit $b$ and, for each n, a $2 r \times 2 r$-matrix-valued function $M_{n}(\cdot)$, defined on

$$
\{z \in \mathbb{C} \text { s.t. } \Re(z)>0\} \backslash\left[0, b_{n}\right],
$$

which coefficient are analytic functions, such that
d) for all $z \notin \mathbb{R}, M_{n}(z)$ is invertible,
e) for all $\eta>0, M_{n}(\cdot)$ converges to the function $M(\cdot)$ uniformly on $\{z \in \mathbb{C}$ s.t. $\Re(z)>$ $b+\eta\}$.

Then
(i) there exists $p$ real sequences $z_{n, 1}>\cdots>z_{n, p}$ converging respectively to $z_{1}, \ldots, z_{p}$ such that for any $\varepsilon>0$ small enough, for $n$ large enough, the $z$ 's in $(b+\varepsilon, \infty)$ such that $M_{n}(z)$ is not invertible are exactly $z_{n, 1}, \ldots, z_{n, p}$,
(ii) for $n$ large enough, for each $i, M_{n}\left(z_{n, i}\right)$ has rank $2 r-1$.

Proof. To prove this lemma, we use the formula

$$
\operatorname{det}\left[\begin{array}{cc}
x I_{r} & \operatorname{diag}\left(\alpha_{1}, \ldots, \alpha_{r}\right) \\
\operatorname{diag}\left(\alpha_{1}, \ldots, \alpha_{r}\right) & y I_{r}
\end{array}\right]=\prod_{i=1}^{r}\left(x y-\alpha_{i}^{2}\right)
$$

in the appropriate place and proceed as the proof of Lemma 6.1 in [13].
We also need the following proposition. The $u_{i}$ 's and the $v_{i}$ 's are the random column vectors introduced in Section 2.1.

Proposition 8.2. Let, for each $n, A_{n}, B_{n}$ be complex $n \times n, n \times m$ matrices which operator norms, with respect to the canonical Hermitian structure, are bounded independently of $n$. Then for any $\eta>0$, there exists $C, \alpha>0$ such that for all $n$, for all $i, j, k \in\{1, \ldots, r\}$ such that $i \neq j$,

$$
\mathbb{P}\left\{\left|\left\langle u_{i}, A_{n} u_{i}\right\rangle-\frac{1}{n} \operatorname{Tr}\left(A_{n}\right)\right|>\eta \text { or }\left|\left\langle u_{i}, A_{n} u_{j}\right\rangle\right|>\eta \text { or }\left|\left\langle u_{i}, B_{n} v_{k}\right\rangle\right|>\eta\right\} \leq C e^{-n^{\alpha}} .
$$

Proof. In the i.i.d. model, this result is an obvious consequence of [12, Prop. 6.2]. In the orthonormalized model, one also has to use [12, Prop. 6.2], which states that the $u_{i}$ 's (the same holds for the $v_{i}$ 's) are obtained from the $n \times r$ matrix $G_{u}^{(n)}$ with i.i.d. entries distributed according to $\nu$ by the following formula: for all $i=1, \ldots, r$,

$$
u_{i}=\frac{i \text { th column of } G_{u}^{(n)} \times\left(W^{(n)}\right)^{T}}{\| i \text { th column of } G_{u}^{(n)} \times\left(W^{(n)}\right)^{T} \|_{2}},
$$

where $W^{(n)}$ is a (random) $r \times r$ matrix such that for certain positive constants $D, c, \kappa$, for all $\varepsilon>0$ and all $n$,
$\mathbb{P}\left\{\left\|W^{(n)}-I_{r}\right\|>\varepsilon\right.$ or $\max _{1 \leq i \leq r} \left\lvert\, \frac{1}{\sqrt{n}}\right. \| i$ th column of $\left.G_{u}^{(n)} \times\left(W^{(n)}\right)^{T} \|_{2}-1 \mid>\varepsilon\right\} \leq D\left(e^{-c n \varepsilon}+e^{-c \sqrt{n}}\right)$.
