Abstract

The presence of sulfamethazine (SMZ) residues in pig and calf hair was compared with the residual levels encountered in the corresponding edible tissues (liver and muscle) as a consequence of drug administration. SMZ up to 84.7 mg/kg was found in calf hair samples after a pharmacological treatment, with a significant effect on hair pigmentation. High concentrations of the parent drug were detected in calf hair for four weeks after administration, when SMZ residues were no longer detectable in the corresponding edible tissues. In a similar way, pig hair also accumulated SMZ residues up to 40.5 mg/kg, which was more than the amount detected in the corresponding muscle and liver samples at slaughter. Hair analysis seems a suitable tool to improve the s, thus th Z in animal h efficacy of regulatory controls, and thus the safety of the food chain and to discourage the improper use of SMZ in animal farming.

31 Introduction

Sulfonamides (SAs) are an important group of synthetic bacteriostatics which are approved as therapeutic agents for use on farm. The sub-therapeutic addition to feeding to improve growth promotion and food efficiency is permitted in the USA (Animal Health Institute) but is prohibited within the European Union (EC 2003). Several years ago the scientific community was alerted to the excessive use of SAs (and other antimicrobials) which can promote the development of microbial resistance (WHO 1997, WHO 1998, Cruz et al., 2003; Pena et al., 2004; Miko et al., 2005) as well as a progressive environmental contamination (Verstraete 2004; Kay 2005a: 2005b). Significantly. sulfamethazine (SMZ), one of the most used SAs, has also been proved to induce tumors in the thyroid gland of rodents (Littlefield et al., 1989).

At the same time, the illegal or improper administration of SAs, such as the nonobservance of withdrawal time or the use without veterinary prescription, may cause residues in the edible tissues of slaughtered animals that could represent a potential risk to consumer health due to the short-term toxic and allergic phenomena in sensitized consumers (European Medicines Agency).

50 Following the rules established for other veterinary drug, a Maximum Residue 51 Level (MRL), which has also been called Safe Level or Tolerance Limit, has 52 been defined for SAs in edible animal tissues or other foodstuffs of animal origin 53 in several countries (Codex Alimentarius, EC 1990, Code of Federal 54 Regulation). The MRL represents a drug residual level which is virtually 55 associated with no toxicological risk for the consumer, and is calculated taking 56 into account toxicity studies, food daily intake as well as other safety factors. 57 The MRL for the SMZ is set at 100 μ g/Kg for all the animal species and tissues 58 (EC 1990).

The official target samples (meat, kidney, fat and liver) are usually taken at the time of slaughter to verify the compliance with withdrawal time and MRL. Nevertheless the *post-mortem* sampling of edible tissues can only be made on a limited percentage of carcasses and may delay the commercialization of the edible parts. Furthermore the half-life of drug residues in other samples taken from living animals (milk, urine, faeces) is generally shorter compared to the withdrawal period for edible tissues (USP DI), limiting the efficacy of these matrices for screening controls at farm and at slaughter.

Recently, hair analysis has been proposed as an interesting technique to increase the time window in retrospective detection of veterinary drug residues, offering at the same time the advantage of non-invasive collection on living animals (Durant et al., 2002; Nielen et al., 2003; Dunnett and Lees 2004a; 2005b). It is well known that hair structure is rather biologically inert allowing this to produce a protected microenvironment where the drug residue would be preserved from degrading agents during a long period of time (Dunnett and Lees, 2004a; 2004b).

At present, hair analysis is considered an effective tool to detect banned drugs as anabolic hormones (Gratacós-Cubarsí et al., 2006c), but it seems also interesting to control the administration of compounds authorized only for

therapeutic uses (corticosteroids, antibiotics) which should be dispensed under
strict veterinary prescription.

It has been established that SAs are deposited in the hair structure after oral administration or intravenous injection in racehorses (Dunnett and Lees, 2004b), calf and pig (Gratacós-Cubarsi et al., 2006a) hairs. SAs residues at mg/kg level have been detected in hair several months after administration, and a relationship between administered dose and residue level in hair was established for horsehair (Dunnett and Lees, 2004b). To the best of our knowledge, no bibliographic data is available to compare the residue levels in hair and other biological samples of the same animal after SA treatment.

The primary objective of the work reported here was the comparison of the residual SMZ levels in edible tissues (liver and muscle) and hair of pigs and calves which received a pharmacological treatment during the rearing. The effects of several factors (hair pigmentation, individual response, time between administration and sampling) on SMZ accumulation in hair samples were also determined, to assess the suitability of hair analysis as a complementary tool in official residues monitoring plans.

101 Methods and Procedures

102 Reagents

103 Sulfamethazine (SMZ, min 99%) [4-amino-N-(4,6-dimethyl-2-pyrimidinyl)-104 benzenesulfonamide] and ammonium hydroxide ACS reagents were purchased 105 from Sigma-Aldrich[®] (Madrid, Spain). Organic solvents (methanol and

acetonitrile liquid chromatography grade), ammonium acetate and acetic acid glacial were from Merck (Darmstadt, Germany). Ultra-pure water was obtained using an E-pure system (Barnstead Thermolyne, Dubugue IA-USA). Two different veterinary drugs were employed for the pharmacological solution (Copisulf, treatments. an injectable containing mg/mL sulfamethazine sodium salt, from FEDRA S.A., Girona, Spain) and a soluble powder (Torul S, containing 550 mg/g SMZ sodium salt, from Lamons, Tarragona, Spain). A standard stock solution [1 g/L] of SMZ was prepared by dissolving 100 mg of pure standard in 100 mL of methanol. The standard working solution [1 mg/L] was prepared weekly by dilution of standard stock solution in ammonium acetate 0,01M pH 4.5: acetonitrile (85:15 v/v) and stored at 4 °C. SPE HLB-OASIS[®] (6cc/200 mg) cartridges were obtained from Waters Corp. (Barcelona, Spain) while strong cationic exchange cartridges (Accubond^{II} SCX, 6cc/500 mg) were acquired from Agilent Technologies S.L. (Madrid, Spain). Animal treatment

122 Six Friesian calves were reared in our experimental farm to 8 months receiving 123 no medication containing sulfonamides. At five weeks before slaughter they 124 were divided into three groups, and kept in separate stalls during the last 125 growing phase.

The first group (Control) did not receive any veterinary drug. The second group (WP, see Figure 1), complying with a withdrawal period of 28 days, was given a daily subcutaneous dose of Copisulf (40 mL) per animal for 5 days (corresponding to 150-165 mg sulfamethazine sodium salt/kg live weight). A third group received the same treatment with Copisulf just one week before slaughter without having the withdrawal period (NoWP, see Figure 1). Treated animals received the daily dose in different zones of the thorax to avoid the development of epithelial lesions.

Six Landrace pigs were also reared in the same experimental farm to 3 months receiving no drugs containing sulfonamides. Four weeks before slaughter, a group of three animals (NoWP, see Figure 1) started receiving a daily oral dose of 10 g of Torul S mixed with feeding for 28 days (corresponding to a SMZ dose of 1.40 - 1.54 g sulfamethazine sodium salt/Kg live weight). The other group of three animals received no medication (Control).

140 Sampling

Pigmented and non-pigmented hair samples were taken (2.0-3.0 g. approx.
each) from both treated and control animals before and after the beginning of

143 the pharmacological treatments with SMZ (Figure 1).

144 Sequential samples of the same animal were taken from different zones of the 145 upper area of the neck (to limit external contamination) using a hair clipper 146 ARCO 1854 (MOSER, Germany) with a cut height of 1 mm.

In the case of the calves having a withdrawal period (WP), additional samples
were taken from the areas of the first sampling, corresponding to the hair shaft
grown during the two weeks after the first sampling (NG-1) or the last three
weeks before slaughter (NG-2) (Figure 1).

At slaughter samples of muscle and liver were taken from both Control and
treated animals. These tissues were immediately stored at -20 °C and analyzed
within 3 months.

155	SMZ extraction
156	Hair samples were washed three times using ultra-pure water, dried in an oven
157	at 37 $^{\circ}\text{C}$ for one hour and then analyzed by HPLC-DAD to quantify the SMZ
158	content as previously described (Gratacós-Cubarsí et al., 2006a).
159	Briefly, 50 mg of finely cut calf hair or pulverized pig hair were extracted with 4
160	ml of aqueous alkaline solution. Crude alkaline extracts were centrifuged and
161	filtered through a paper filter. Centrifuged alkaline extracts were directly loaded
162	onto an OASIS [®] -HLB cartridge, washed with 2 mL of 5 % methanol in water.
163	SMZ was eluted with 4 mL acetic acid: acetonitrile (5:95 v/v), and directly
164	loaded onto the SCX cartridge. After washing with 5 mL methanol:acetonitrile
165	(1:1 v/v), SMZ was eluted with 5 mL of ammonium hydroxide: methanol (5:95
166	v/v).
167	Eluates containing SMZ were evaporated under nitrogen at 25 °C, reconstituted
168	with 400 μL of ammonium acetate 0,01M pH 4.5: acetonitrile (88:12 v/v) and
169	filtered through a 0.45 µm nylon filter.
170	To evaluate the SMZ residues in muscle and liver, 4 g of sample were extracted
171	with 20 mL of acetonitrile and centrifuged. One mL of the supernatant was
172	evaporated with nitrogen, reconstituted with 0.5 mL of the mobile phase, filtered

173 with 0.45 μm nylon membranes and analyzed by HPLC (Gratacós-Cubarsi et174 al., 2006b).

177 Chromatographic separations were carried out on an 1100 liquid 178 chromatograph (Agilent Technologies, Palo Alto, CA - US) equipped with a 179 quaternary pump and a diode array detector.

The analysis of hair extracts were carried out with a Luna[®] RP-C₁₈ (150 mm x 2.0 mm i.d.) analytical column (Phenomenex[®], Torrance - CA, US). A binary gradient elution (flow rate 0.35 mL/min) was realized varying the composition of the mobile phase linearly from 88 % A (ammonium acetate 0.01M solution, acidified to pH 4.5 with acetic acid glacial) and 12 % B (acetonitrile) to 82 % A and 18 % B at 12 min. The limit of quantification (LOQ) was 155 μ g/Kg. (Gratacós-Cubarsi et al., 2006a).

Muscle and liver extracts were analysed on a Synergy[™] MAX-RP 4µm (150
mm x 3.0 mm i.d.) analytical column (Phenomenex[®], Torrance, CA-US). Elution
of SA was realized with binary linear gradient (flow rate 0.75 mL/min) between
solvent A (ammonium acetate 0,01M, pH 4.5) and solvent B (acetonitrile). The
LOQ was 55 µg/Kg for all matrices (Gratacós-Cubarsi et al., 2006b).

The identification of SMZ peak in hair and edible tissues extracts was made comparing both retention time and spectra (collected between 240 and 400 nm) with those of the SMZ pure standard solutions. SMZ was quantified at a wavelength of 270 nm (16 nm bandwidth) with a reference signal of 450 nm (80 nm bandwidth) using an external standard calibration curve.

197 All samples (hair, muscle and liver) were extracted and injected in duplicate.

 199 Statistical analysis

200 The results of SMZ analysis in pig samples were submitted to a two-way 201 ANOVA and Tukey test, considering the "kind of matrix" (liver, muscle, non-202 pigmented hair) and animal as independent variables.

Data from calf samples were evaluated with two separated three-way ANOVA and Tukey tests. In the first analysis only hair samples were considered, setting animal, sampling point and hair colour as independent variables. In the second analysis the results obtained from samples taken at slaughter were evaluated, with animal, treatment (WP, NoWP) and kind of matrix (liver, muscle, pigmented hair ad non-pigmented hair) as independent variables.

209 Control sample (C1, C2) and WP1, NoWP1 samples were not considered.

210 Residual concentration of SMZ in the different samples was always the 211 dependent variable; replicates of analysis were taken into account. All the 212 statistical treatment was carried out with the software package Statistica 5.0 213 (StatSoft[®] Inc. Tulsa, OK-US).

Results

216 SMZ accumulation in hair

None of the hair samples obtained from "Control" animals (C1, C2) or taken before the pharmacological treatment (WP1, NoWP1) contained detectable residues of SMZ. On the contrary, SMZ residues were detected, in a range from 0.4 to 84.7 mg/kg, in the hair samples obtained from treated calves and pigs (Table 1). Figure 2 shows the typical chromatographic profile of contaminated pig and calf hair extracts.

The mean SMZ levels in non-pigmented hair of pigs and calves not having the withdrawal period (NoWP2) comprised between 15.9 and 40.5 mg/Kg in pig and between 7.2 and 24.0 mg/Kg in calves (Table 1).

The SMZ accumulation in hair samples was significantly influenced (p<0.01) by the inter-individual variance both in pigs and calves. The quantities of SMZ accumulated in calf hair samples were also significantly influenced (p<0.01) by both sampling point and hair color. The mean concentration of SMZ detected in pigmented hairs was higher than the corresponding non-pigmented samples, with the exception of the samples taken one week after the beginning of the pharmacological treatment (NoWP2).

- 236 SMZ content in hair, muscle and liver

The comparison of the SMZ concentration in hair, muscle and liver at slaughter are shown in Figure 3. The statistical analysis indicates a significant effect (p < 0.05) of the kind of sample matrix taken at slaughter on the SMZ residual content for both pigs and calves. As showed in figure 3, at slaughter the SMZ concentration found in hair samples of pigs and calves which did not have a withdrawal period (NoWP2) was higher than those found in the corresponding muscle or liver samples taken from the same animals. At the same time, SMZ residues were found in hair samples of calves having a withdrawal period (WP3), but not in the corresponding edible tissues.

247 Discussion

The levels of SMZ residues found in calf and pig hair samples are in agreement with those reported by Dunnet & Lees (2004b), who detected SA residues up to 25 mg/kg in racehorse tails from treated animals. The similar levels of SMZ residues in calf and pig hairs is guite a surprising result, taking into account the higher quantities of SMZ per kg of live weight that were administered to pigs (about ten fold more than calves), but the different type of SMZ administration (oral in pigs and subcutaneous in cattle) should also be considered as it may have influenced the drug bioavailability (USP DI), the maximum plasmatic levels and finally the drug deposition in hair.

 The high variability observed for the SMZ accumulation in hair of different animals, even if statistically significant, should be further investigated with specific studies on a larger population. Anyway, several factors (drug metabolism, hair growth rate, hair composition, feed intake, live weight), which may vary significantly between animals, have been previously described as affecting the drug deposition rate in hair (Henderson, 1993).

Pigmented hairs accumulated higher quantities of SMZ than the non-pigmented ones, in agreement with previous studies which underlined the binding capacity of SMZ (a basic drug) with the melanin pigments to form adducts (Dunnett and Lees, 2004b). Moreover, in non-pigmented samples (WP2, WP3) and in the new growing samples (NG1, NG2) the concentration of SMZ progressively decreased in the weeks following the treatment, while the corresponding pigmented calf hair gradually accumulated more SMZ residues. This different time-course in pigmented and non-pigmented samples could be explained

considering both the binding capacity of the melanin and the multiple mechanisms which may control the drug deposition in the hair shaft (Henderson, 1993). According to the literature on this matter, if drug incorporation follows the "passive diffusion" model, the drug concentration in the blood is the primary factor which controls deposition (Henderson, 1993). As the drug molecules diffuse from blood to the growing cells of the follicle they are trapped in the hair structure during the keratogenesis. After a variable length of time from the drug administration the portion of hair containing the drug residue appears over the skin surface and can be sampled and analyzed. A more complex mechanism has also been suggested - "multiple pool" model - to take into account that drugs may also be transferred to hair shaft from sweat and sebum or from external environment after the hair has emerged from the skin (Henderson, 1993). Considering that the average growth rate of calf hair is of 6-7 mm/month and that the skin thickness is 2.5-3.0 mm (Durant et al., 2002), our experimental data are in agreement with the hypothesis that the prevalent mechanism for SMZ accumulation in calf hairs is the formation of bonded forms with the melanin during the keratogenesis in the follicles under the skin ("passive diffusion"). Other ways of incorporation from the surface of the skin can justify the premature detection of SMZ residues in calf hair 7 days after the administration (NoWP2) and are probably the predominant mechanism in nonpigmented hairs.

Finally, a very interesting result is that, when SMZ residues were not more detected in edible tissues of calves which had the withdrawal period (WP3), they were found at mg/Kg levels in both pigmented and non-pigmented hairs of the same animals, indicating a good capacity of hair analysis for theretrospective detection of SMZ administration.

Conclusions

These results demonstrate that SMZ was accumulated in calf and pig hair in a stable way at ng/mg level, more than in the corresponding edible tissues. Furthermore, SMZ residues have been detected in calf hair since the first seven days and up to four weeks after the subcutaneous administration, when SMZ residues where no longer detected in edible tissues of the same animal.

The high concentration of SMZ residues (mg/kg) accumulated in hair simplifies the interpretation of analytical results, one of the principal drawbacks of hair analysis. Even if more studies are required to establish the possible relationships between administered dose and quantities of SMZ accumulated in hair, these data show that hair analysis may be a complementary tool in residue monitoring plans. Hair analysis allows a rapid and cost-effective screening for SMZ administration and could improve the time window in retrospective detection of SMZ administration to food producing animals.

Hair analysis can be carried out easily as screening procedure on a large number of animals directly in the farms. Positive hair analysis results, if not justified by veterinary prescriptions, could indicate how increase or modify the official sampling in a specific farm or group of animals, improving the efficacy of control and surveillance plans on the edible tissues and discouraging the improper uses of veterinary drugs.
