# Determination of the level of Benzo[a]pyrene in fatty foods and food supplements

A routine method was developed for the quantification of benzo[a]pyrene (BaP) in edible oils and food supplements. BaP is often taken as an indicator of the presence of polycyclic aromatic hydrocarbons. The method consists of on-line LC-clean up followed by injection to an HPLC-system with fluorescence detection. The method has good performance characteristics and gave good results in proficiency tests. From 2002 to 2004 about 1350 samples of oils and food supplements, were analysed using this method to test the level of benzo[a]pyrene. About 20% of the edible oils contained more than 1.2 μg/kg BaP (which is the limit applied by the Dutch Food and Consumer Product Safety Authority until 1 April 2005, and includes measurement uncertainty). In the case of food supplements more then 30% contained too high levels of BaP, ranging from 1.2 to 135 μg/kg.

#### Introduction

Polycyclic aromatic hydrocarbons (PAHs) ubiquitous environmental are contaminants, a number of which are considered to be human carcinogens. In foodstuffs, PAHs can be formed directly as a result of some heat processes (charcoal grilling, roasting, smoke drying) or by addition of smoke flavouring additives (Garcia-Falcon et al. 2000; Simko 2002; Barranco et al. 2003). It has been estimated that human intake of PAHs from food is considerably higher than that from air or drinking water, edible oils and fats being the most significant sources because of their lipophilic nature (Garcia-Falcon et al. 2000; Barranco et al. 2003). PAHs can be removed from edible oils by treatment with activated charcoal, a practice that has been widely used for a long time (Weisshaar 2002). More than 100 PAHs have been found in nature; however, only 16 have been selected as priority pollutants by the United States Environmental Protection Agency (EPA) on the basis of occurrence and carcinogenicity (Barranco et al. 2003; Teixeira et al. 2003). In Commission Recommendation 2005/108/EC, the Commission of the European Communities (2005) also selected 15 priority PAHs, based on their carcinogenicity (some being different from the EPA PAHs). At a special workshop organised jointly by the European Commission (Directorate Joint Research Centre and Directorate Health and Consumer Protection) and the European Food Safety Authority (EFSA), it was decided to add one more PAH (benzo[c]fluorene) to this list, the later also recommended by JECFA.

Benzo[*a*]pyrene is often used as an indicator of the presence of PAHs in water and foodstuffs, even though it is well known that this compound is usually generated together with many other PAHs which contaminate the food [Garcia-Falcon et al. 2000, Simko 2002, Bogusz et al. 2004). The Scientific Committee on Food (SCF 2002) concluded that BaP could be used as a marker for the occurrence and effect of carcinogenic PAH in food. However further analysis of the relative proportions of these 16 PAHs (15 EU + 1 JECFA) in foods is necessary, to review the suitability of maintaining BaP as a marker (SCF 2002, Commission of the European Communities 2005).

The International Olive Oil Council recommended in 2001 a value of 2  $\mu$ g/kg as a maximum tolerable concentration of BaP as well as other PAHs in olive-pomace oil (International Olive Oil Council 2001). It is generally recognised that total PAHs in a refined oil or fat should not exceed 25  $\mu$ g/kg, of which not more than 5  $\mu$ g/kg should be heavy PAHs (5- and 6-nuclear PAHs) (Fediol 2003). The SCF recommended, in their opinion of 2002, that exposure to PAHs from food should be as low as reasonably achievable (ALARA principle), due to the carcinogenicity and genotoxicity, the most critical effects of PAHs. Prior to April 2005 the majority of European countries set independently limits . The Dutch Food and Consumer Product Safety Authority (VWA) had set a limit of 1  $\mu$ g/kg for BaP in oils and food supplements in 2002. Based on the ALARA principle a level of 1  $\mu$ g/kg was used, as the presence of BaP is avoidable, due to processing steps which can reduce the content of PAHs. Based on a report by Kroese et al. (2001), which set the virtual sate dose at 0.5 ng/kg bodyweight, an Acceptable Daily Intake (ADI) was calculated based on an average of people weighing 60 kg. This ADI of 30 ng was taken as a

threshold above which additional measures were required in order to minimise the risk to public health. Due to the fact that several member states of the EU have set their own legal limits, the Commission of the European Communities (2005) issued a Regulation (No 208/2005) amending Regulation (EC) No 466/2001 with regard to polycyclic aromatic hydrocarbons. This regulation sets the maximum level for BaP at 2 µg/kg for oils and fats for human consumption as well for those used as ingredients in foods and food supplements. In order to obtain more information about the patterns of PAH distributions (profiles) relative to BaP in various foods, the Commission recommended that monitoring studies be carried out on 16 PAHs (15 EU and 1 JECFA) in various foods . This dataset can then be used to evaluate if maximum levels should be set for other PAHs and the accuracy of using BaP as a marker for all PAHs.

The principal problems associated with the determination of BaP in foods are the low detection levels (µg/kg) and the diversity of potential interferences present in food and food supplements (Garcia-Falcon et al. 2000). Although all sample preparation steps are important, chromatographic separation is considered as most significant for correct results (Simko 2002). There are several HPLC methods for the determination of PAH in edible oils, using on-line sample clean-up followed by injecting to an analytical C18-column and fluorescence detection (Garcia-Falcon et al. 2000, Moret and Conte 2002, Bogusz et al. 2004). Fluorescence detection is often used due to its selectivity and sensitivity (Barranco et al. 2003). GC-MS methods as well as HPLC methods are regarded as complementary in the analysis of PAHs (Bogusz et al 2004).

The objectives of this study were (1) to develop a routine method for the determination of BaP and (2) to perform a monitoring study on edible oils and oil-based food supplements. The development of the method was based on the methodology of Stijn et al. (1996), in which PAHs were under investigation. In this method, a donor-acceptor complex chromatography (DACC) technique was been used for the on-line sample clean-up. PAHs are electron donors (π-electrons) and the strong interaction of the PAHs with an electron acceptor stationary phase results in retention of the PAHs and elution of (the bulk of) the other compounds in the oil. By coupling the DACC-column automated to the analytical column for separation of the PAHs (a LC-LC coupling), the method can be applied easily for routine analysis.

In 2002 a monitoring study was initiated to investigate the amounts of BaP in olive oils, of which several rapid alerts (a notification of a direct or indirect risk to human health deriving from Food or Feed, for which EU has set up a system) were reported. Soon it was decided to broaden the monitoring study to other kind of edible oils, for example corn oil and sunflower oil as well as Evening Primrose oil (*Oenothera biennes*). This latter oil is often used as an ingredient for food supplements, e.g. for fat burners. Because it was found that "special oils", which are being used as a raw material for food supplements quite often exceeded the limit of 1.2  $\mu$ g/kg BaP (the Dutch limit including measurement uncertainty) the research was broadened to further analyse food supplements. The food supplements of interest were oil capsules, e.g. fat burners, vitamin supplements.

### Method

Experimental Part

The method reported here is based on donor-acceptor complex chromatography (DACC) (Stijn et al. 1996). First, the samples were homogenized, then 10 ml isopropyl alcohol and 200 µl benzo[b]chrysene (10 ng/ml, Dr. Ehrenstorfer) were added to 500 mg of sample. The PAHs were extracted from the sample by shaking for 30 min. Benzo[b]chrysene was added for quality control purposes, to check the stability of retention times and recovery - it was not used as an internal standard for the correction of recovery. After filtration, the extract was injected on a DACC column (Chromspher-phi 7µm 80 mm). The DACC column was connected to an HPLC system (Agilent) with a switch system. The DACC column was first washed with isopropyl alcohol, then the PAHs are eluted from the column with 30% acetonitril/70% ethylacetate and finally the DACC column was cleaned with isopropyl alcohol. Only the eluted PAHs were injected onto the HPLC column by the switch system. The analytical column was a reversed phase column (Lichrocart 250-4 Lichrospher PAH RP-18 5 µm, 2\* in series), held at 30 °C. The HPLC conditions are listed in table I. Detection of the eluted PAHs was carried out by application of a variable wavelength fluorescence detector (Agilent). Excitation and emission wavelengths are given in Table II. A standard mix of PAHs was applied by Dr. Ehrenstorfer (PAH Mix 9, 10 ng/µl of each PAH in acetonitril). This standard mixture contains the 16 EPA PAHs, however, not all 16 EPA PAHs can be detected with the method.

Sample collection

All samples were collected by inspectors of the Dutch Food and Consumer Product Safety Authority (VWA). Several kinds of oils for human consumption (e.g. sunflower oil, olive oil) were taken from shops (e.g. supermarkets) for analysis. When these samples appeared to be above the limit, samples of the same charge and also of other charges were collected at producers and/or importers before actions, like discarding a whole charge from the market, were taken. All food supplements collected were supplements on an oil base (oil capsules). For these samples the same strategy was followed as for the oil samples; thus if a food supplement from a shop appeared to be above the limit, same and other charges at producers or importers side were collected and analysed.

## **Results and Discussion**

Method characteristics

The method of Stijn et al. (1996) was optimised giving special attention to fluorescence detection. The following parameters were optimised: injection volume of samples on DACC-column, back flush of the components of the DACC-column, removal of isopropylacohol from DACC-column before injection on the analytical column, the level of concentration of acetonitrile necessary to strip off the PAHs from the DACC column, column temperature of the analytical column, gradients of the analytical column and wavelengths of the fluorescence detection. In addition, benzo[b]chrysene was added to each sample for quality control purposes. If the column switching system does not work correctly, retention times change and/or there is no evidence of benzo[b]chrysene.

The method of Stijn et al. (1996) differs from the developed method in the injection volume (250  $\mu$ l compared to 100 $\mu$ l), column temperature of the HPLC-columns (20  $^{\circ}$ C compared to 30  $^{\circ}$ C), the excitation and emission wavelengths of the fluorescence

detection of the PAHs and the back flush of the PAHs from the DACC column. The method of Stijn et al. (1996) uses both water/acetonitrile (15%/85%) and acetonitrile/ethyl acetate (30%/70%) to strip the PAHs off the DACC column, while in this method the PAHs were stripped off the DACC column by only 30% acetonitrile / 70% ethyl acetate. The method of Stijn et al. (1996) shows peak identification of 17 PAHs. Applying the method described in this study, 12 PAHs of the 16 EPA PAHs were identified,. 7 of these 12 identified PAHs are also mentioned in the list of the 15 'priority PAHs' by the SCF. Figure 1 shows an example of a chromatogram of a standard containing 12 PAHs. Because BaP was considered a key component, the method has been especially validated for this component, however the other PAHs identified here, can also be quantified.

For the in-house validation of the method, first the limit of detection and quantification (LOD and LOQ) were determined. The LOD was defined as the concentration which is three times higher than the standard deviation of the chromatographic background. The limit of detection determined in this way was 0.07  $\mu$ g/kg. The limit of quantification has been defined as twice the limit of detection and was thus 0.14  $\mu$ g/kg. The calibration curve showed linearity with a correlation coefficient of at least 0.9995 in the range of 0.14  $\mu$ g to 8.0  $\mu$ g/kg. Therefore the range of application has been determined as 0.14 to 8.0  $\mu$ g/kg. Samples containing higher values of BaP have to be diluted with isopropyl alcohol. The validity of the calibration was checked with each series of samples. The recovery of BaP from a spiked blank sunflower sample (determined from 6 replicate measurements under repeatability conditions)

was 99.9% with a relative standard deviation (RSD) of 2.8%. The reproducibility, determined with different operators and different intervals of time and using a standardised control material (SCM, sunflower oil) at a level of 1  $\mu$ g/kg BaP was 0.18  $\mu$ g/kg. The measurement uncertainty at the level of 1  $\mu$ g/kg was established at 0.2  $\mu$ g/kg. The recovery and the RSD were also determined under repeatability conditions in a herbal food supplement (oil capsules), where they were 100.1% and 4.1% respectively. The reproducibility of using a food supplement at a level of 1.4  $\mu$ g/kg was 0.40  $\mu$ g/kg, slightly higher than for oil. The method performed well in proficiency tests with oil samples (Central Science Laboratory 2003, FAPAS Proficiency Testing 2004). The Z-scores obtained applying this method in these proficiency tests were -1.3 respectively +0.8 for benzo[a]pyrene.

# Samples analysed

For every series of samples the analytical protocol included several quality control (QC) measurements, e.g. check of validity of calibration, and the analysis of QC samples. A reference material (oil) was used as QC material for oils, whereas a herbal food supplement in form of oil capsules was applied for the measurements of food supplements. The mean values and the 95% confidence interval of these QC materials are  $2.21 \pm 0.27$  and  $1.28 \pm 0.30$  respectively. The results of analysis of the QC samples had to be within these limits. When all quality checks for a series of samples are in line with the performance expected, samples can be evaluated on their level of BaP.

Ten oil samples, taken from the market (shops), analysed with this DACCmethod were sent to a national research laboratory in the Netherlands, where they were analysed with another LC-method and a GCMS-method. These samples contained BaP levels ranging from 1 to 30  $\mu$ g/kg.The results of each of the samples obtained by these three methods were similar, all results were within the measurement uncertainty of the level of BaP in the sample.

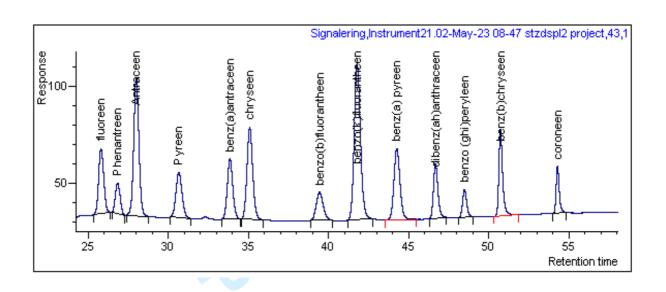


Figure 2: The levels of benzo[a]pyrene in several edible oils, foodsupplements and raw materials (oils) used for food supplements.

In the monitoring study about 1350 samples were analysed between 2002 and 2004 for their BaP content, this being around 170 olive oils, 170 other oils fpr human consumption and 950 supplements. Additionally 60 further oils (raw materials), used as ingredients for food supplements, were also analysed. These latter oils were different kind of oils, collected at producers. The results are shown in figure 2.

As can be seen in figure 2 about 80% of the olive oils and other oils for human consumption (eg. Sunflower oil) contained less than 1.2  $\mu$ g/kg BaP, however there were some olive oils which contained up to 50  $\mu$ g/kg BaP and one with 85  $\mu$ g/kg BaP. The UK Food Standards Agency (2001) reported similar results with levels of BaP ranging from 9 to 43  $\mu$ g/kg in some olive-pomace oil samples, originating from Greece, Spain and Italy. In the other oils for human consumption the amounts of BaP were much lower, the highest level rising to 9  $\mu$ g/kg BaP. At inspections of producers and importers of oils for human consumption in the Netherlands by the VWA, it was noticed that producers and importers are aware of the possibility of contamination of PAHs and are taking action to reduce the amount of BaP in their oils. During the research over the last three years a slight decrease in the number of oil samples exceeding the limit of 1.2  $\mu$ g/kg BaP was seen.

Nearly half of the raw materials (oils) which are used as a basis for food supplements exceeded the limit of 1.2 µg/kg BaP, containing up to 80 µg/kg BaP, with 2 exceedances of 200 and 275 µg/kg BaP. During inspection of the producers of food supplements it was found that some of them were not aware of the fact that BaP could be present in their raw (oil) materials. These special oils were not controlled for PAHs or other contaminants before dissolution of the supplements and encapsulation of the products. Most of the food supplements under investigation were fat burners (herbal extracts) and fat-soluble vitamin preparations. A lot of supplements with tocopherols (vitamin E) were analysed. Tocopherols may interfere in the determination of PAHs (Joint DG JRC/DG SANCO/EFSA workshop, 2005). However with this DACC-method such problems were not found. Since the end products contain additional substances apart from oils, which probably do not contribute to the PAH contamination, the actual concentration of PAHs in those products, expressed as a fraction of the sample weight, has to be lower than that of the oil itself. Of the food supplements which were analysed 30% contained too much BaP with values of 140 and even 200 μg/kg. The percentage of food supplement samples that exceeded the limit for BaP was the same in 2004 as in 2002. This suggests that companies producing these type of products regularly ignore or are not aware of the presence of PAHs in their raw materials (oils) and/or products. Thus, action on the part of the producers as well as of the authorities is still needed to monitor this situation.

#### Conclusions

The method developed for the determination of BaP in edible oils and oil based food supplements is suitable to be applied as routine laboratory analysis and is relatively fast (about 90 min per analysis). The validation characteristics of the method are in line with international standards, as can be expected. The range of application is from 0.14 up to 8.0 μg/kg BaP, so even low levels of BaP can be determined. The recovery in oil was 99.9% with an RSDr of 2.8%, in a food supplement the recovery had a value of 100.1% with an RSDr of 4.1%. The performance of the method in proficiency tests was good and samples analysed with other methods (LC and GC-MS) showed similar results. With this method other PAHs can also be identified and quantified. However, the method is not validated for these components at present. For the time being, the method is single laboratory validated for BaP only. It is intended to expand the validation to cover various PAHs, by a collaborative method validation study to become an ISO standard (ISO/TC34/SC11 2005).

About 1350 samples were analysed for their BaP content, covering both oils for human consumption and food supplements. In the oils about 20% exceeded the limit of 1.2 µg/kg BaP applied by the VWA. In food supplements over 30% exceeded the legal limit, which might be due to the raw materials (oil) which is being used as basis for food supplements. Producers of food supplements need to become aware of the presence of BaP in oils/oil extracts. More attention must be paid in the coming years to the presence of BaP and other PAHs in food supplements. In addition, oils for human consumption have to be checked, although to lesser extent than with food supplements.

#### **Acknowledgement**

Figure 1: Chromatogram of a standard containing 12 PAHs
