24 In this paper we report a duplex real-time PCR assay for the simultaneous detection of 25 members of the A. niger aggregate and A. carbonarius, which are the main responsible 26 species for ochratoxin A (OTA) contamination in grapes. This single tube reaction targets 27 the β -ketosynthase and the acyl transferase domains of the poliketide synthase of A. 28 carbonarius and the A. niger aggregate, respectively. Melting curve analysis using a SYBR 29 Green I real-time PCR approach showed characteristic Tm values demonstrating the 30 specific, efficient and balanced amplification of the two PCR fragments. Subsequently, a 31 TaqMan real-time PCR approach was settled, using FAM and VIC labeled specific probes 32 for an automated detection. Results indicated no differences in sensitivity when using either 33 the two sets of primers and probes in separate or in the same reaction. However, when both 34 targets are in very different amounts, there is a preferential amplification of the target which 35 is in more concentration. C_T values obtained in the presence of grape DNA were very 36 similar to those observed when only fungal purified DNA was present, indicating that the 37 grape DNA does not interfere in the real-time PCR reaction. This procedure provides a fast 38 and accurate tool to monitor, in a single reaction, the presence of OTA-producing species in 39 grapes which, to some extent, will facilitate OTA contamination surveys to guarantee food 40 safety in the wine industry.

Introduction

Ochratoxin A (OTA) is a mycotoxin with nephrotoxic, carcinogenic, immunotoxic, genotoxic and teratogenic effects, which has been associated with Balkan Endemic Nephropathy (Krogh 1978; Kuiper-Goodman & Scott 1989; Abouzied et al. 2002). In the European diet, wine and especially red wine, has been identified as the second major source of human exposure to OTA, following cereals (Anonymous 1998). As a consequence, the European Commission has considered the need of imposing regulatory limits and has established 2 ng g^{-1} as the maximum level of OTA in wine and grape products (Commission regulation No 123/2005 amending Regulation No 67 446/2001 as regards ochratoxin A) (Varga & Kozakiewicz 2006).

Aspergillus species belonging to section Nigri, commonly known as black aspergilli in particular, Aspergillus carbonarius and species belonging to the Aspergillus niger aggregate, have been identified as the main fungi responsible for OTA contamination in grapes and wine (for an overview see Abarca et al. 2003; Samson et al. 2004; Battilani et al. 2006). A. carbonarius is considered the mayor responsible for OTA contamination in grapes because the reported percentages of OTA-producing strains in this species are higher than those reported for members of the A. niger aggregate. Nevertheless, the black aspergilli most frequently isolated from grapes are species belonging to the A. niger aggregate, mainly A. niger and Aspergillus tubingensis (Cabañes et al. 2002; Abarca et al. 2003; Battilani et al. 2003; Bellí et al. 2004; 2006; Martínez-Culebras & Ramón 2007). Recently, Martínez-Culebras & Ramón (2007) reported the existence of a new OTA producing group of strains, frequently found in grapes, which is related to A. tubingensis and might be considered within the A. niger aggregate. These data provide strong evidence

of an important contribution to OTA contamination in grapes by species belonging to the *A*.

niger aggregate. Therefore, a quick assay capable of quantifying the presence of both *A*.
 carbonarius and the *A*. *niger* aggregate in grapes would improve OTA risk assessment.

Recent advances in DNA-based techniques such as real-time PCR are providing new tools for fungal detection and quantification by detecting and quantifying their DNA. Multiplex real-time PCR allows the simultaneous amplification of more than one target sequence in a single reaction. This saves considerable time and effort, and decreases the number of reactions that need to be performed to detect fungal pathogens in vegetable samples (Brandfass & Karlovsky 2006). Several real-time PCR assays have proven useful in monitoring and quantification of OTA-producing fungi such as *Penicillium nordicum* (Geisen et al. 2004) and Aspergillus ochraceus (Schmidt et al. 2004). Regarding black aspergilli, single real-time PCR assays for the detection and quantification of A. carbonarius have been described (Mulè et al. 2006; Atoui et al. 2007; Selma et al. 2008). However, no real-time PCR assay is currently available for the simultaneous quantitative detection of A. carbonarius and species belonging to the A. niger aggregate.

A specific real-time PCR assay for the quantitative detection of A. carbonarius in combination with a rapid and efficient fungi DNA extraction procedure has already been developed (Selma et al. 2008). This assay targets a 161 bp fragment in the β -ketosynthase domain of a polyketide synthase (PKS) from A. carbonarius. DNA extraction procedure includes a pulsifier equipment to remove conidia from grapes which prevents releasing of PCR inhibitors. It is highly selective, sensitive and suitable for the accurate quantification of all strains of A. carbonarius. In the present study, we describe a duplex real-time PCR assay that combines the A. carbonarius-specific β -ketosynthase domain assay and the

amplification of the acyl transferase (AT) domain of the species belonging to the *A. niger*aggregate.

95 Materials and Methods

96 Fungal strains and growth conditions

97 Black Aspergillus strains were isolated from Spanish vineyards and are held in the Institute 98 of Agrochemistry and Food Technology (IATA-CSIC). They were previously identified by 99 ITS-RFLP profiles and tested for OTA-production (Martínez-Culebras & Ramón 2007). 100 Reference strains were provided by Centralbureau voor Schimmelcultures (CBS, Utrecht, 101 The Netherlands) and the Spanish Type Culture Collection (CECT, Valencia, Spain) (see 102 Table 1). The reference strains used in the present study were previously tested for OTA 103 production (Samson et al. 2004; Martínez-Culebras et al., 2008). They were all grown in 104 Malt Extract Agar (MEA) plates at 25 ± 1 °C for 5-7 days (Pitt & Hocking 1997).

106 Fungal and grape DNA isolation

Mycelia were collected from cultures growing on MEA plates frozen in liquid nitrogen and ground to a fine powder. Fungal DNA extractions were performed using 100 mg of powder and the commercial EZNA Fungal DNA kit (Omega bio-teck, Doraville, USA) according to the manufacturer's instructions. Accurate DNA quantification for real-time PCR assays was approached using the 'Fluorescent DNA Quantitation Kit' (BioRad, California, USA) and a VersaFluor® spectrofluorimeter (BioRad, California, USA)

For grape DNA extraction, 25 g of grapes were homogenized in 100 mL of sterile 0.1 % buffered peptone water (BPW, AES Laboratoire, Combourg, France) using a pulsifier equipment (Microgen bioproducts, Surrey, UK). One milliliter of pulsified grape samples were centrifuged for 3 min at 13,000 g. Pellets were washed in 0.5 mL of TE (10 mmol L⁻¹

Tris-HCl; 1mmol L⁻¹ EDTA, pH 8), centrifuged at 13,000 g for 3 min and resuspended in 50 µL of sterile nanopure water. They were boiled (95 °C for 10 min) to release the DNA. Samples were cooled on ice for 10 min. Finally DNA isolation was performed by EZNA Fungal DNA kit (Omega bio-teck, Doraville, USA), following the manufacturer's recommendations and starting from step 1 of protocol B where 600 μ L of buffer FG1 were added to 50 μ L of pellets resuspended in water. In the final step, DNA was eluted in 100 μ L of sterile nanopure water and kept at – 20 °C until used as template for PCR amplification.

126 Primer and TaqMan probe design

127A. carbonarius specific primers and probe reported in Table 2 were designed in a previous128study (Selma et al. 2008). They are targeted to a conserved region in the β-ketosynthase129(KS) domain of a PKS gene (AcKS10) from *A. carbonarius* (Genbank accession number:130AY540952). Primers delimit a 161 bp fragment. The *A. carbonarius* TaqMan probe (AC131probe) was labeled at the 5' and 3' ends with a 6-carboxy-fluorescein group (FAM) and 6-132carboxy-tetramethyl-rhodamine (TAMRA), respectively.

Specific primers and probe for Aspergillus strains belonging to A. niger aggregate (Table 2) were designed in the present study and they were derived from a conserved region in the acyl transferase (AT) domain sequences of PKS genes after comparison with different Aspergillus and Penicillium species (Genbank accession numbers: EF527410 A. awamori; EF527411 A. foetidus; EF527408 A. niger; EF527818 A. ochraceus; EF527414 A. tuningensis; EF527415 A. tubingensis; EF527412 A. tubingensis-like; EF527413 A. tuningensis-like; EF527409 A. usamii; F527416 A. wenti; EF527417 A. wenti; EF527419 P. citrinum; EF527421 P. griseoroseum; EF527420 P. verrucosum; EF527423 P.

viridicatum). The design of the primers and Taqman probe for real-time PCR assays was
carried out using the Primer Express, version 2.0 software (Applied Biosystems Division,
Perkin-Elmer Co., Foster city, CA, USA). Primers delimit a 120 bp fragment. *A. niger*aggregate specific TaqMan probe (AN probe) designed in the present study was labeled at
the 5' and 3' ends with a VIC[®] group and a non-fluorescent quencher, respectively. Primer
and probe synthesis were ordered from ABI PRISM Primers and TaqMan Probe Synthesis
Service (Applied Biosystems, Madrid, Spain).

149 Specificity of the conventional PCR assays

A total of 47 strains were used for specificity assays of the newly designed primers AtNig1/ AtNig2 by conventional PCR (Table 1). They included 42 strains belonging to Aspergillus species and 5 to other fungal species commonly isolated from grapes. PCR reactions using the A. niger aggregate specific primers AtNig1 / AtNig2 and the universal primers its5/its4 (White et al. 1990) were performed in 50 µL as final volume, containing 200 ng of DNA, 50 mM KCl ,10 mM Tris-HCl, 100 µM (each) dNTP, 1 µM of each primer, 2 mM MgCl₂ and 1 U of DNA polymerase (Netzyme, Molecular Netline Bioproducts, N.E.E.D, SL, Valencia, Spain).

Amplification conditions were: 35 cycles consisting of 1 min at 95 °C, 1 min at 52 ° C and 1 min at 72 °C. Reactions were carried out in a GeneAmp PCR System 9700 (PE Applied Biosystems, Norwalk, CT, USA) thermal cycler. Fifteen microlitres of PCR products were electrophoresed through 2 % agarose (Pronadisa, Hispanlab, Madrid, Spain) gel in TAE buffer [40 mM Tris-acetate, pH 7.6 and 1 mM Na acetic acid (EDTA)]. After electrophoresis, gels were stained with ethidium bromide (0.5 mg mL⁻¹), and the DNA 164 bands visualized under UV light. Sizes were estimated by comparison with a DNA standard

165 length (GeneRuler TM 100 bp DNA ladder, MBI Fermentans, Vilnius, Lithuania).

167 Specificity of the real-time PCR assays

A total of 39 strains were used for specificity assays of the newly designed primers AtNig1/ AtNig2 by real-time PCR (Table 1). Real-time PCR reactions, with SYBR-Green I and TaqMan probe, were performed using the SYBR-Green I Core Reagents and the TaqMan Core Reagents, respectively (both from Applied Biosystems, Madrid, Spain). Amplification mixtures for real-time PCR reactions with SYBR-Green I, contained in a final volume of 20 µL, 1 x PCR Buffer, 200 µM each dATP, dCTP, dGTP and 400 µM dUTP; 1 U of Amperase uracil N-glycosidase; 3 mM MgCl₂; 0.9 U of AmpliTag Gold DNA polymerase, 200 nM each primer (AtNig1/ AtNig2) and 5 μ L of template DNA (10 ng for specificity assay). Amplification mixtures for real-time PCR reactions with TaqMan probe, contained in a final volume of 20 µL, 1x TaqMan Buffer A, 200 µM each dATP, dCTP, dGTP, and 400 µM dUTP; 1 U of Amperase uracil N-glycosidase; 3.5 mM MgCl₂; 1 U of AmpliTaq Gold DNA polymerase, 200 nM each primer (AtNig1/ AtNig2), 5 µL of template DNA. The following concentrations of the AN probe were assayed: 50, 100, 150 and 200 nM. Real-time PCR assays, using either SYBR-Green I or TaqMan probe for fluorescence emission, were carried out in a GeneAmp® 5700 Sequence Detection System (PE Biosystems, Foster city, CA, USA) programmed to hold at 50 °C for 2 min and at 95 °C for 10 min, and to complete 40 cycles of 95 °C for 15 s and 60 °C for 1 min. Reactions were done in triplicate. PCR results were given as the increase in the fluorescence signal of the reporter dye detected and visualized by the GeneAmp 5700 SDS software provided with the GeneAmp® 5700 SDS (Applied Biosystems). Threshold cycle (C_T) values represent the PCR cycle in which an increase in fluorescence, over a defined threshold, first occurred foreach amplification plot.

- 191 Multiplex real-time PCR

Real-time PCR reactions were performed using both the SYBR-Green I Core Reagents and TaqMan Core Reagents (Applied Biosystems Madrid Spain). Amplification mixtures for Real-time PCR, contained in a final volume of 20 µL, 1x buffer (SYBR-Green I PCR Buffer or TagMan PCR buffer), 200 µM each dATP, dCTP, dGTP, and 400 µM dUTP; 1 U of Amperase uracil N-glycosidase; 1 U of AmpliTaq Gold DNA polymerase; and 5 µL of template DNA. Concentration of primers, probes and MgCl₂ were optimized for the simultaneous amplification of the two amplicons. The following concentrations were assayed: 3, 3.5, 4 and 5 mM of MgCl₂; 100, 200, 300 and 400 nM of primers; 50, 100, 150, and 200 nM of TaqMan probes. Real-time PCR assays were carried out in a GeneAmp 5700 Sequence Detection System (PE Biosystems Foster City Calif.) programmed to hold at 50 °C for 5 min, to hold at 95 °C for 10 min, and to complete 40 cycles of 95 °C for 15 s and (60-63 °C) for 1 min. Several annealing temperatures were assayed to optimize the multiplex amplification. Reactions were done in triplicate. SYBR Green I reactions were carried out in a GeneAmp® 5700 Sequence Detection System (Applied Biosystems). For multiplex real-time PCR reactions using TaqMan probes, an ABI Prism 7000 Sequence Detection System (Applied Biosystems) was used. In both cases, PCR results were given as the increase in the fluorescence signal of the reporter dye detected and visualized by the corresponding software, as indicated above.

214 *Melting-curve analysis*

Melting-curves were programmed in order to check the expected amplification product when using SYBR Green I approach. The thermal protocol for dissociation is defined as 15 s at 95 °C, 20 s at 60 °C and 20 min slow ramp between 60 and 95 °C, after the real-time PCR program. The data for the dissociation curve is captured during this slow ramp. The melting curve was visualized with the software in the 'Dissociation Window' using the corresponding GeneAmp 5700 SDS software procedure (Applied Biosystems).

222 Sensitivity of the multiplex real-time PCR reaction

In order to establish detection limits of the multiplex TaqMan real-time PCR, amplifications were carried out for each targeted ochratoxigenic organism using both the uniplex and the multiplex reaction. To that purpose, tenfold serial dilutions of DNA extracted from the reference strains *A. carbonarius* CBS 11380 and *A. tubingensis* CBS 134.48 were done covering a range from 3 to 3 x 10⁵ genome equivalents, that were calculated assuming it to be similar to that of *A. niger* $(4.13 \times 10^{-5} \text{ ng}, \text{ for a haploid}$ genome).

Sensitivity of the multiplex real-time PCR reaction was also analyzed in the presence of grape DNA and different concentrations of fungi DNAs. Grape DNA was obtained from pulsified grape samples as described above (section 2.2.) and tested in triplicate by realtime PCR using the *A. carbonarius* specific primers AcKS10L/ AcKS10R and the *A. niger* aggregate specific primers AtNig1/ AtNig2, under the amplification conditions established in the study. Grape DNA that tested negative for both *A. carbonarius* and *A. tubingensis*

 was added with DNA from A. carbonarius CBS 11380 and A. tubingensis CBS 134.48 in different concentrations. Samples were tested in triplicate by real-time PCR and a non-template negative control was included in each experiment. Analysis of variance with a significance level of $P \le 0.05$ was carried out on these data using SPSS (Windows 2000, Statistical Analysis).

Results

Specificity of the real-time PCR assays

A new set of specific primers and a probe were designed to target a conserved region in the acyl transferase (AT) domain sequences of PKS genes of all strains belonging to the A. niger aggregate. Specificity was tested by conventional PCR using purified DNA from 47 strains (Table 1). The expected 120 bp amplicon was obtained from strains belonging to the species included in the A. niger aggregate (A. awamori, A. foetidus, A. niger, A. tubingensis, A. tubingensis-like, and A. usamii). The 120 bp amplicon was also obtained using DNA from A. lacticofeatus and A. pulverulentus, two OTA-producing species closely related to the A. niger aggregate (Sanson et al. 2004; Perrone et al. 2006) (Table 1). Amplification of the 5.8S-ITS region using universal primers its5/its4 was obtained in all strains, thus confirming the DNA suitability when negative amplification results were obtained using the specific primers AtNig1/AtNig2.

Specificity of the newly designed primers AtNig1/AtNig2 was also tested by SYBR Green I and TaqMan real-time PCR using 10 ng of template DNA/reaction of 39 strains representing the species included in the study (Table 1). The melting curve analysis showed a Tm value 80.5±0.5 in the A. niger aggregate species. Strains belonging to other genera, showed no melting curve, revealing that no amplification products were obtained.

260 Specificity of primers AcKS10L/AckS10R used for the real-time PCR detection of A.

carbonarius had previously been demonstrated by Selma et al. (2008).

263 Set up of the multiplex real-time PCR reaction

Optimized reaction conditions for the duplex real-time PCR were obtained by using 3.5 mM MgCl₂, 200 nM of A. niger aggregate specific primers and 100 nM of A. carbonarius specific primers. Melting curve analysis of amplicons corresponding to strains belonging to A. niger aggregate and A. carbonarius showed Tm values of 80.5±0.5 and 83.4±0.4, respectively, thus allowing the differentiation between the two targeted organisms (Figure 1). For the TaqMan assay, reaction annealing temperature allowing both primers and probes to hybridize was established at 60 °C. Primer and MgCl₂ concentration was maintained identical to the SYBR Green I reaction. Optimized probe concentration was 200 nM for AN probe targeting A. niger aggregate and 150 nM for AC probe targeting A. carbonarius.

274 Sensitivity of the multiplex Taqman real-time PCR compared to uniplex real-time PCR 275 assay

Tenfold serial dilutions of DNA extracted from the reference strains A. carbonarius CBS 11380 and A. tubingensis CBS 134.48 covering 6 log orders, were used for multiplex and uniplex TaqMan real-time PCR assays in order to establish detection limits of the multiplex real-time PCR reaction compared to the uniplex real-time PCR (Table 3). For A. *carbonarius*, C_T values obtained by multiplex real-time PCR were slightly higher than those obtained with the uniplex (Table 3). Linear regression analysis of C_T values corresponding to A. carbonarius DNA suspensions yielded R^2 values above 0.99 and the slopes were -2.57 with uniplex and -2.56 with multiplex. For A. tubingensis, no differences were

observed between C_T values obtained by multiplex real-time PCR and uniplex real-time PCR. At the lowest concentration tested (3 genome equivalents/reaction), a slight amplification signal was obtained in 1 out of 3 replicates with the uniplex reaction and no amplification was observed with the multiplex real-time PCR. Linear regression analysis of C_T values corresponding to A. tubingensis DNA suspensions yielded R² values above 0.99 and the slopes were -2.73 with uniplex and -2.67 with multiplex. These results indicate no differences in sensitivity when using either the two sets of primers and probes, in separate, or in the same reaction. *Co-amplification using different amounts of target DNA* To evaluate the sensitivity of the multiplex real-time PCR, a combination of 10, 10^2 , 10^3 and 10^4 genome equivalents of A. carbonarius and A. tubingensis was analyzed (Table 4). Moreover, these combinations were assayed with and without the presence of grape purified DNA. Amplification was observed in all combinations with both SYBR Green and TaqMan. However, when both targets were in very different amounts (10 and 10^4 or 10^2 and 10^4 genome equivalents) the one that was in less concentration obtained significantly higher C_T value (P<0.01) compared to the corresponding C_T when both were at the same concentration (Table 4). On the other hand, C_T values obtained in the presence of grape DNA were very similar to those observed when only conidial purified DNA was present, indicating that the grape DNA, extracted as previously described, does not interfere in the real-time PCR reaction.

307 The PCR reaction is a well recognized rapid technique widely used for detection of 308 foodborne pathogens. Recently, it is also being applied for detection of toxinogenic 309 microorganisms such us mycotoxin producing fungi. PCR detection of ochratoxigenic fungi 310 has been approached using primers targeted to single species, i.e. A. carbonarius (Mulè et 311 al. 2006; Atoui et al. 2007; Selma et al. 2008), A. ochraceus (Dao et al. 2005), P. nordicum 312 (Geisen et al. 2004) or to several species including citrinin producers (Dao et al. 2005). 313 Sartori et al. (2006) developed a multiplex conventional PCR for the simultaneous detection 314 of A. carbonarius, A. niger and A. ochraceus in green coffee. In the present study we have 315 developed a rapid, specific and sensitive duplex real-time PCR assay that allows the 316 simultaneous detection of members of the A. niger aggregate and A. carbonarius, which are 317 the main species responsible for OTA contamination in grapes and wine (Abarca et al. 318 2003; Samson et al. 2004; Battilani et al. 2006; Martínez-Culebras & Ramon 2007).

319 With this aim, we combined the previously published A. carbonarius-specific real-time 320 PCR (Selma et al. 2008) with a newly designed real-time PCR targeted to the acyl 321 transferase (AT) domain of a PKS gene of the species belonging to the A. niger aggregate. 322 Grapes isolates belonging to the A. niger aggregate (A. niger, A. tubingensis and A. 323 tubingensis-like) were successfully amplified using the primer pair AtNig1/AtNig2. 324 Additionally, strains belonging to the species A. awamori, A. foetidus and A. usamii, which 325 are also included into the A. niger aggregate, were also amplified by these primers. OTA-326 producing strains of the aforementioned species have commonly been found in different 327 foods and feeds, including grapes (Chulze et al. 2006; Ponsone et al. 2006). The newly 328 developed primers also amplified DNA from A. lacticofeatus and A. pulverulentus, two 329 OTA-producing species of the Aspergillus section Nigri closely related to the A. niger 330 aggregate (Sanson et al. 2004; Perrone et al. 2006). Nevertheless, these two Aspergillus

species have never been isolated from grapes. Negative results with DNA from other *Aspergillus* section *Nigri* and additional fungal species commonly found in grapes
confirmed the specificity of the newly designed primers.

For the development of a suitable duplex real-time PCR, relative concentration of primers and probes, cycling temperatures and amounts of template DNA and Taq DNA polymerase have to be optimized (Markoulatos et al. 2002). In this study, SYBR Green I system, was used for the optimization of the reaction as it is the simplest and least expensive of the real-time PCR methods. By using SYBR Green, amplification products can be identified by their different Tm, by analysing the melting curve of the amplicon (Wittwer et al. 2001). The presence of a single peak at the corresponding Tm, indicates the specificity of the reaction. In a duplex real-time PCR, both amplicons can be distinguished by differences of at least 1 °C in Tm (Lipsky et al. 2001; Ririe et al. 1997). The duplex real-time PCR developed in this study yielded two peaks with clearly different Tm values: 80.5 \pm 0.5 for A. niger aggregate and 83.4 \pm 0.4 for A. carbonarius, which confirmed the specificity of the two sets of primers. As a later approach, the duplex assay was adapted to be used in the TaqMan system by adding hybridization probes labeled with two different fluorescent dyes (FAM and VIC).

Following optimization of the reaction conditions, the TaqMan duplex real-time PCR developed, was compared with both single real-time PCR reactions using purified DNA. This assay revealed very similar C_T values at any *A. tubingensis* DNA concentration with similar efficiency for uniplex and multiplex assays using as template only 1 target. For *A. carbonarius*, C_T values obtained by multiplex real-time PCR were slightly higher than those obtained with the uniplex but not significant differences in the reaction efficiency were found. Both approaches uniplex and duplex allowed the detection of 30 genome

 equivalents/reaction. Although, the uniplex assay was able to detect as far as 3 genome equivalents/reaction in some replicates, C_T values obtained for this concentration were 40 or very close to 40 which is at the border line to be considered positive. Thus, the amplification of the two targets is efficient in the presence of the other competing primers and probe keeping the detection limit in 30 genome equivalents/reaction for both of them. These results are in the same range as the detection limit reported for the single detection of A. carbonarius with the TaqMan real-time PCR system developed by Mulè et al. (2006), and about 1 log order lower (more sensitive) than the detection limits reported for the single detection of A. carbonarius with the SYBR-Green I system used by Atoui et al. (2007). The suitability of this duplex real-time PCR system to detect A. carbonarius and A. *niger* aggregate strains, was evaluated by co-amplifying both targets present in different proportions using template DNA from both species with and without grape DNA. Both targets were detected in all combinations when using either SYBR Green or TaqMan. However, when both targets are in very different amounts (10 and 10^4 genome equivalents/reaction) the one that is in less concentration renders a C_T value very close to 40 which indicates the preferential amplification of one of the targets in a multiplex PCR. These results were also obtained when both DNA were present in 10^2 and 10^4 genome equivalents/reaction. This fact can be induced in the presence of very low template concentration, as in this case, due to fluctuation in the interactions of PCR reagents, particularly in the early cycles (Mutter & Boyton 1995). As concentration and C_T values do not show a linear correlation when applied to very different amounts of target DNA, quantification would not be possible in these cases.

The advantages of the multiplex real-time PCR developed in this study, besides the advantages of the real-time PCR, i.e. highly sensitive and reliable detection technique

379 (Schaad & Frederick 2002), are the simultaneous detection of the main OTA producing 380 species in grapes, A. carbonarius and A. niger aggregate. To our knowledge this is the first 381 report on a multiplex real-time PCR reaction for the simultaneous detection of A. 382 carbonarius and A. niger aggregate in grape.

383 This procedure provides a fast and accurate tool to monitor in a single reaction the 384 presence of OTA producing species in grapes which, to some extent, will facilitate OTA 385 contamination surveys to guarantee food safety in the wine industry.
