# Doubloons and $q$-secant numbers 

Dominique Foata and Guo-Niu Han


#### Abstract

Based on the evaluation at $t=-1$ of the generating polynomial for the hyperoctahedral group by the number of descents, an observation recently made by Hirzebruch, a new $q$-secant number is derived by working with the Chow-Gessel $q$-polynomial involving the flag major index. Using the doubloon combinatorial model we show that this new $q$-secant number is a polynomial with positive integral coefficients, a property apparently hard to prove by analytical methods.


## 1. Introduction

This paper, in harmony with our previous two papers on doubloons [FH09a, FH09b], is motivated by our intention of finding a combinatorial connection between the Eulerian polynomials, on the one hand, and the trigonometric functions, tangent and secant, on the other hand, when the connection is further carried over to a $q$-analog environment.

Let $(t ; q)_{n}:=(1-t)(1-t q) \cdots\left(1-t q^{n-1}\right)$ if $n \geq 1$ and $(t ; q)_{0}:=1$ be the traditional $q$-ascending factorial and $[j]_{q}:=1+q+\cdots+q^{j-1}$ be the $q$-analog of the positive integer $j$. The $q$-analogs $A_{n}(t, q)$, introduced by Carlitz ([Ca54], [Ca75]), of the Eulerian polynomials, may be defined by the identity

\frac{A_{n}(t, q)}{(t ; q)_{n+1}}=\sum_{j \geq 0} t^{j}\left([j+1]_{q}\right)^{n} \quad(n \geq 0) \tag{1.1}
\end{equation*}
$$

For each $n \geq 0$ the $q$-analog $A_{n}(t, q)$ is a polynomial with positive integral coefficients [in short, a PIC polynomial], such that $A_{n}(t, 1)$ is equal to the traditional Eulerian polynomial $A_{n}(t)$ introduced by Euler himself [Eul1755], who also derived the exponential generating function:

\sum_{n \geq 0} \frac{u^{n}}{n!} A_{n}(t)=\frac{1-t}{-t+\exp (u(t-1))} \tag{1.2}
\end{equation*}
$$

As $A_{n}(1,1)=A_{n}(1)=n$ !, each PIC polynomial $A_{n}(t)\left(\right.$ resp. $\left.A_{n}(t, q)\right)$ has been regarded as a generating function for the symmetric group $\mathfrak{S}_{n}$ by several integral-valued statistics (resp. pairs of such statistics) ([Ri58], [FZ70], [Ca75]). Note that (1.2) is easily derived from (1.1).

In the same manner, the next two identities

\begin{align*}
\frac{B_{n}(t, q)}{\left(t ; q^{2}\right)_{n+1}} & =\sum_{j \geq 0} t^{j}\left([2 j+1]_{q}\right)^{n} \quad(n \geq 0)  \tag{1.3}\\
\sum_{n \geq 0} \frac{u^{n}}{n!} B_{n}(t) & =\frac{(1-t) \exp (u(t-1))}{-t+\exp (2 u(t-1))} \tag{1.4}
\end{align*}
$$

may serve to define two families of polynomials $\left(B_{n}(t)\right),\left(B_{n}(t, q)\right)(n \geq 0)$.
Again, both $B_{n}(t)$ and $B_{n}(t, q)$ are PIC polynomials and $B_{n}(t)=$ $B_{n}(t, 1)$. Moreover, (1.4) is easily derived from (1.3). The interpretation of $B_{n}(t)$ as a generating polynomial for the hyperoctahedral group $B_{n}$, together with the derivations of (1.3) for $q=1$ and (1.4), was first obtained by Reiner [Re93], also by Cohen [Co08] in the general context of the Coxeter groups of spherical type. Formula (1.3) was derived and fully interpreted by Chow and Gessel [CG07].

While studying the signatures of the toric varieties, Hirzebruch [Hi09] is led to calculate the values of both polynomials $A_{n}(t)$ and $B_{n}(t)$ at $t=-1$. He first quotes Euler's identities [Eul1755]

\end{equation*}

where the coefficients $T_{2 n+1}(n \geq 0)$ are the tangent numbers occurring in the Taylor expansion of $\tan u$ :

\tan u & =\sum_{n \geq 0} \frac{u^{2 n+1}}{(2 n+1)!} T_{2 n+1}  \tag{1.6}\\
& =\frac{u}{1!} 1+\frac{u^{3}}{3!} 2+\frac{u^{5}}{5!} 16+\frac{u^{7}}{7!} 272+\frac{u^{9}}{9!} 7936+\frac{u^{11}}{11!} 353792+\cdots
\end{align*}
$$

Then, he notes that

$$
\begin{equation*}
B_{2 n+1}(-1)=0(n \geq 0) ; \quad(-1)^{n} B_{2 n}(-1)=2^{2 n} E_{2 n}(n \geq 0) \tag{1.7}
\end{equation*}
$$

where the coefficients $E_{2 n}(n \geq 0)$ are the secant numbers occurring in the Taylor expansion of $\sec u$

$$
\begin{align*}
\sec u=\frac{1}{\cos u} & =\sum_{n \geq 0} \frac{u^{2 n}}{(2 n)!} E_{2 n}  \tag{1.8}\\
& =1+\frac{u^{2}}{2!} 1+\frac{u^{4}}{4!} 5+\frac{u^{6}}{6!} 61+\frac{u^{8}}{8!} 1385+\frac{u^{10}}{10!} 50521+\cdots
\end{align*}
$$

since, by (1.4),

$$
\sum_{n \geq 0} \frac{(i u)^{n}}{2^{n} n!} B_{n}(-1)=\frac{2}{e^{i u}+e^{-i u}}=\sec u=\sum_{n \geq 0} \frac{u^{2 n}}{(2 n)!} E_{2 n}
$$

It so happens that (1.7) is just the relation needed to construct a new $q$ analog of the secant number, in parallel with what has been done already for the tangent number.

Theorem 1.1. Let $\left(B_{n}(t, q)\right)(n \geq 0)$ be the sequence of polynomials defined by (1.3) and let

E_{2 n}(q):=(-1)^{n} q^{n^{2}} B_{2 n}\left(-q^{-2 n}, q\right) \quad(n \geq 1) \tag{1.9}
\end{equation*}
$$

Then,
(a) each $E_{2 n}(q)$ is a PIC polynomial;
(b) it admits the factorization

$$
\begin{equation*}
E_{2 n}(q)=\left(1+q^{2}\right)\left(1+q^{4}\right) \cdots\left(1+q^{2 n}\right) F_{2 n}(q) \tag{1.10}
\end{equation*}
$$

where $F_{2 n}(q)$ is a PIC polynomial;
(c) $E_{2 n}(1)=2^{n} F_{2 n}(1)=2^{2 n} E_{2 n}\left(E_{2 n}\right.$ the secant number);
(d) $B_{2 n+1}\left(-q^{-(2 n+1)}, q\right)=0(n \geq 0)$.

Property (c) follows from (1.7) and (1.9). Property (d) is proved in Section 5 . As is often the case, it is much harder to derive the factorization shown in (b) and prove that the coefficients of $E_{2 n}(q)$ are positive. It requires a long combinatorial development, given in the next three Sections. We reproduce the first values of the polynomials $B_{n}(t, q)$ and $E_{2 n}(q)$ in Tables 1.1 and 1.2.

Following the method developed in [FH09a] and [FH09b], the proof of Theorem $1.1(a)$ and (b) will consist of making the polynomial $E_{2 n+2}(q)$, defined in (1.9), appear as a generating function by an appropriate statistic "smaj," combined with a sign "sgn"

$$
E_{2 n+2}(q)=\sum_{w \in B_{2 n+2}} \operatorname{sgn} w q^{\operatorname{smaj} w} \quad(n \geq 1)
$$

and constructing a sign-reversing involution on $B_{2 n+2}$, in such a way that after its application the remaining terms in the sum have positive signs. We leave out the banal case: $E_{2}(q)=2\left(1+q^{2}\right)$.

The final step is then to prove the identity

$$
\begin{equation*}
E_{2 n+2}(q)=\left(1+q^{2}\right)\left(1+q^{4}\right) \cdots\left(1+q^{2 n+2}\right) \sum_{w \in \mathcal{S N}_{2 n+2}} q^{\mathrm{smaj} w} \tag{1.11}
\end{equation*}
$$

where the sum is over a specific class $\mathcal{S N}_{2 n+2}$ of signed permutations, called normalized signed doubloons (see Section 4).

More importantly, the generating polynomial for $\mathcal{S N}_{2 n+2}$ occurring in (1.11) will be explicitly calculated by means of the doubloon polynomials $\left(d_{n, j}(q)\right)(n \geq 1,2 \leq j \leq 2 n)$, which are defined by the recurrence
(D1) $d_{0, j}(q)=\delta_{1, j}$ (Kronecker symbol);
(D2) $d_{n, j}(q)=0$ for $n \geq 1$ and $j \leq 1$ or $j \geq 2 n+1$;
(D3) $d_{n, 2}(q)=\sum_{j} q^{j-1} d_{n-1, j}(q)$ for $n \geq 1$;
$(D 4) d_{n, j}(q)-2 d_{n, j-1}(q)+d_{n, j-2}(q)$

\begin{aligned}
= & -(1-q) \sum_{i=1}^{j-3} q^{n+i+1-j} d_{n-1, i}(q) \\
& -\left(1+q^{n-1}\right) d_{n-1, j-2}(q)+(1-q) \sum_{i=j-1}^{2 n-1} q^{i-j+1} d_{n-1, i}(q)
\end{aligned}
$$

for $n \geq 2$ and $3 \leq j \leq 2 n$;
the first values being:

& d_{1,2}(q)=1 ; \quad d_{2,2}(q)=q ; \quad d_{2,3}(q)=q+1 ; \quad d_{2,4}(q)=1 ; \\

Those polynomials were introduced and used in [FH09b] to evaluate a new $q$-analog

$$
\begin{equation*}
T_{2 n+1}(q):=(-1)^{n} q^{\binom{n}{2}} A_{2 n+1}\left(-q^{-n}, q\right) \tag{1.12}
\end{equation*}
$$

of the tangent number based on the Carlitz $q$-Eulerian polynomial $A_{n}(t, q)$ defined in (1.1). It was shown that $T_{2 n+1}(q)$ was a PIC polynomial equal to

\begin{equation*}
T_{2 n+1}(q)=(1+q)\left(1+q^{2}\right) \cdots\left(1+q^{n}\right) \sum_{k=2}^{2 n+2} d_{n, k}(q) . \tag{1.13}
\end{equation*}
$$

The parallel expression for the PIC polynomials $E_{2 n+2}(q)$ is next stated.

## DOUBLOONS AND $q$-SECANT NUMBERS

Theorem 1.2. For each $n \geq 1$ the polynomial $E_{2 n+2}(q)$ has the following expression:

E_{2 n+2}(q)=\left(1+q^{2}\right)\left(1+q^{4}\right) \cdots\left(1+q^{2 n+2}\right) \sum_{k=2}^{2 n} d_{n, k}\left(q^{2}\right) P_{n, k}(q), \tag{1.14}
\end{equation*}
$$

where the coefficients $P_{n, k}(q)(n \geq 1,2 \leq j \leq 2 n)$ are defined by

$$
\begin{equation*}
P_{n, k}(q):=\sum_{i=0}^{2 n+1-k} q^{n-1-2 i} \sum_{l=i+1}^{i+k}\binom{2 n+2}{l} q^{l} \tag{1.15}
\end{equation*}
$$

The quantities $Q_{n, k}(q):=q^{n+1-k} P_{n, k}(q)$ are PIC polynomials. Their first values are listed in Table 1.3.

The proofs of Theorems 1.1 and 1.2 are given in Sections 3 and 4. In the last Section we obtain a global expression for the generating polynomial for the group $B_{n}$ by a five-variable statistic, which takes the two classical descent definitions into account.

To end this introduction we point out that the identity

$$
\begin{equation*}
T_{2 n+1}=2^{n} \sum_{k=2}^{2 n} d_{n, k} \tag{1.16}
\end{equation*}
$$

which is the $q=1$ version of (1.13), is originally due to Christiane Poupard [Po89], who worked out the recurrence for the now called Poupard triangle $d_{n, k}:=d_{n, k}(1)(n \geq 1,2 \leq k \leq 2 n)$, obtainable from (D1)-(D4) for $q=1$.

We reproduce the first values of the Poupard triangle $\left(d_{n, k}\right)$, together with the first values of

Q_{n, k}:=Q_{n, k}(1)=P_{n, k}(1)=\sum_{i=0}^{2 n+1-k} \sum_{l=i+1}^{i+k}\binom{2 n+2}{l} . \tag{1.17}

Both $d_{n, k}$ and $Q_{n, k}$ are displayed in triangles $(2 \leq k \leq 2 n, 1 \leq n \leq 4)$, as shown in Fig. 1.4.

The $q=1$ version of identity (1.14) reads:

$$
\begin{equation*}
2^{n+1} E_{2 n+2}=\sum_{k=2}^{2 n} d_{n, k} Q_{n, k} \tag{1.18}
\end{equation*}
$$

For instance, (1.18) for $n=2$ yields: $2^{3} E_{6}=8 \times 61=488=1 \times 112+2 \times$ $132+1 \times 112$. There exists a rich formulary of relations for tangent and secant numbers (see, e.g., the old monograph by Nielsen [Ni23]). Identities (1.16) and (1.18) provide a new parametrization of those coefficients by means of the Poupard triangle $\left(d_{n, k}\right)$.

## 2. Statistics on the hyperoctahedral group

The elements of the hyperoctahedral group $B_{n}$, usually called signed permutations, may be viewed as words $w=x_{1} x_{2} \cdots x_{n}$, where each $x_{i}$ belongs to the set $\{-n, \ldots,-1,1, \ldots, n\}$ and $\left|x_{1}\right|\left|x_{2}\right| \cdots\left|x_{n}\right|$ is a permutation of $12 \ldots n$. The set (resp. the number) of negative letters among the $x_{i}$ 's is denoted by Neg $w$ (resp. neg $w$ ). In the same manner, let Pos $w$ (resp. pos $w$ ) be the set (resp. the number) of all positive letters in $w$. It is convenient to write $\bar{i}:=-i$ for each integer $i$. There are $2^{n} n!$ signed permutations of order $n$. The symmetric group $\mathfrak{S}_{n}$ may be considered as the subset of all $w$ from $B_{n}$ such that $\operatorname{Neg} w=\emptyset$.

For each statement $A$ let $\chi(A)=1$ or 0 depending on whether $A$ is true or not. The usual number of descents and major index of each word $w=x_{1} x_{2} \cdots x_{n}$ are defined by

\begin{align*}
\operatorname{des} w & :=\sum_{i=1}^{n-1} \chi\left(x_{i}>x_{i+1}\right)  \tag{2.1}\\
\operatorname{maj} w & :=\sum_{i=1}^{n-1} i \chi\left(x_{i}>x_{i+1}\right) . \tag{2.2}
\end{align*}
$$

When $B_{n}$ is regarded as a Coxeter group, an extra descent is counted, when the first letter $x_{1}$ of the signed permutation $w=x_{1} x_{2} \cdots x_{n}$ is negative.

In the literature two definitions are then used:

\begin{align*}
\operatorname{des}_{B} w & :=\chi\left(x_{1}<0\right)+\operatorname{des} w  \tag{2.3}\\
\operatorname{fdes} w & :=\chi\left(x_{1}<0\right)+2 \operatorname{des} w . \tag{2.4}
\end{align*}
$$

Furthermore, a flag major index "fmaj" defined by

$$
\begin{equation*}
\operatorname{fmaj} w:=2 \operatorname{maj} w+\operatorname{neg} w \tag{2.5}
\end{equation*}
$$

has been adopted for $B_{n}$, because it is equidistributed with the Coxeter length " $\ell$ " for $B_{n}$ (see, e.g., [ABR01], [FH07]), a property that extends the corresponding property for the symmetric group $\mathfrak{S}_{n}$, which says that the major index "maj" and the number of inversions "inv" (the Coxeter length for $\mathfrak{S}_{n}$ ) are equidistributed.
Proposition 2.1. The polynomial $B_{n}(t, q)$ defined by (1.3) has the following combinatorial interpretation:

$$
\begin{equation*}
B_{n}(t, q)=\sum_{w \in B_{n}} t^{\operatorname{des}_{B} w} q^{\mathrm{fmaj} w} \tag{2.6}
\end{equation*}
$$

In other words, $B_{n}(t, q)$ is the generating polynomial for the hyperoctahedral group $B_{n}$ by the pair ( $\left.\operatorname{des}_{B}, f m a j\right)$.

The proof of the proposition can be found in [CG07]. This is also a consequence of Theorem 6.2, that takes both "des ${ }_{B}$ " and "fdes" into account (see (6.15) and (6.16)).

From the definition of the polynomials $E_{2 n+2}(q)$ given in (1.9) and (2.6) it follows that

E_{2 n+2}(q)=(-1)^{n+1} q^{(n+1)^{2}} B_{2 n+2}\left(-q^{-2 n+2}, q\right)
$$

may be expressed as

$$
\begin{equation*}
E_{2 n+2}(q)=(-1)^{n+1} \sum_{w=x_{1} \cdots x_{2 n+2} \in B_{2 n+2}}(-1)^{\chi\left(x_{1}<0\right)+\operatorname{des} w} q^{\text {smaj } w} \tag{2.7}
\end{equation*}
$$

where "smaj" is a new statistic - call it signed major index - defined for each signed permutation $w=x_{1} x_{2} \cdots x_{2 n+2} \in B_{2 n+2}$ by
(2.8) $\operatorname{smaj} w:=(n+1)^{2}-2(n+1)\left(\chi\left(x_{1}<0\right)+\operatorname{des} w\right)+2 \operatorname{maj} w+\operatorname{neg} w$.

A compressed major index "cmaj" was defined in [FH09a], [FH09b] on the symmetric group $\mathfrak{S}_{n}$. Extend its definition to each $w \in B_{2 n+2}$, as follows

\operatorname{cmaj} w:=\operatorname{maj} w-(n+1) \operatorname{des} w+(n-1) n / 2 \tag{2.9}
\end{equation*}
$$

The next lemma only needs a straightforward calculation.

Lemma 2.2. For each $w=x_{1} x_{2} \cdots x_{2 n+2} \in B_{2 n+2}$ we have:
(2.10) $\operatorname{smaj} w-2 \operatorname{cmaj} w=3 n+1+\operatorname{neg} w-2(n+1) \chi\left(x_{1}<0\right)$; so that
(2.11) $\operatorname{smaj} w-2 \operatorname{cmaj} w=n+\operatorname{neg} w-1, \quad$ if $x_{1}<0$.

The mirror image of a signed permutation $w=x_{1} x_{2} \cdots x_{2 n+2}$ is defined by $\mathbf{r} w:=x_{2 n+2} \cdots x_{2} x_{1}$. It is easily verified that
(2.12) $\operatorname{des} \mathbf{r} w=(2 n+1)-\operatorname{des} w$;

$$
\begin{equation*}
\operatorname{maj} \mathbf{r} w=(2 n+2)(2 n+1) / 2-(2 n+2) \operatorname{des} w+\operatorname{maj} w \tag{2.13}
\end{equation*}
$$

Those two relations suffice to prove the next lemma.
Lemma 2.3. For each $w=x_{1} x_{2} \cdots x_{2 n+2} \in B_{2 n+2}$ we have:

\operatorname{smaj} \mathbf{r} w-\operatorname{smaj} w=2(n+1)\left(\chi\left(x_{1}<0\right)-\chi\left(x_{2 n+2}<0\right)\right) ; \tag{2.14}
\end{equation*}

\begin{equation*}
(-1)^{\operatorname{des} \mathbf{r} w+\chi\left(x_{2 n+2}<0\right)} \times(-1)^{\operatorname{des} w+\chi\left(x_{1}<0\right)} \tag{2.15}
\end{equation*}
$$

$$
=-(-1)^{\chi\left(x_{1}<0\right)+\chi\left(x_{2 n+2}<0\right)} .
$$

The sum displayed in (2.7) may be decomposed into four subsums:

$$
\begin{aligned}
\sum_{w=x_{1} \cdots x_{2 n+2} \in B_{2 n+2}} & =\sum_{\substack{x_{1} x_{2 n+2}>0, x_{1}<x_{2 n+},}}+\sum_{\substack{x_{1} x_{2 n+2}>0, x_{1}>x_{2 n+2}}}+\sum_{\substack{x_{1}<0, x_{2 n+}>0}}+\sum_{\substack{x_{1}>0, x_{2 n+2}<0}}=\sum_{\substack{x_{1} x_{2 n+2}>0, x_{1}<x_{2 n+2}}}+\mathbf{r} \sum_{\substack{x_{1} x_{2 n+2}>0, x_{1}<x_{2 n+2}}}+\sum_{\substack{x_{1}<0, x_{2 n+2}>0}}+\mathbf{r} \sum_{\substack{x_{1}<0, x_{2 n+2}>0}} .
\end{aligned}
$$

It follows from Lemma 2.3 that the sum of the first two subsums vanishes, and the fourth one is equal to the product of the third one by $q^{2 n+2}$. Thus,

\end{equation*}

since $\chi\left(x_{1}<0\right)=1$ for every $w$ occurring in the sum. To pursue the calculation of $E_{2 n+2}(q)$ we use the doubloon calculus, as developed in our previous two papers.

## 3. Doubloons

A doubloon of order $(2 n+1)$ is defined to be a permutation of the word $012 \cdots(2 n+1)$, represented as a $2 \times(n+1)$-matrix $\delta=\binom{a_{0} \cdots a_{n}}{b_{0} \cdots b_{n}}$. The word
$a_{0} \cdots a_{n} b_{n} \cdots b_{0}$ is called the reading $\rho(\delta)$ of $\delta$. Define stat $\delta:=\operatorname{stat} \rho(\delta)$, whenever "stat" is equal to "des," "maj," "fmaj," "cmaj," or "smaj." Let $F \delta:=a_{0}, L \delta:=b_{0}$. The set of all doubloons of order $(2 n+1)$ is denoted by $\mathcal{D}_{2 n+1}$. The subset of all doubloons $\delta$ such that $L \delta=j$ (resp. $F \delta=i$ and $L \delta=j$ ) is denoted by $\mathcal{D}_{2 n+1, j}\left(\right.$ resp. $\left.\mathcal{D}_{2 n+1, j}^{i}\right)$.

Each doubloon $\delta=\binom{a_{0} \cdots a_{n}}{b_{0} \cdots b_{n}}$ from $\mathcal{D}_{2 n+1}$ is said to be interlaced (resp. normalized), if for every $k=1,2, \ldots, n$ the sequence ( $a_{k-1}, a_{k}, b_{k-1}, b_{k}$ ) or one of its three cyclic rearrangements is monotonic increasing or decreasing (resp. decreasing). Let $\mathcal{I}_{2 n+1}^{i}$ (resp. $\mathcal{I}_{2 n+1, j}^{i}$, resp. $\mathcal{N}_{2 n+1}^{i}$, resp. $\mathcal{N}_{2 n+1, j}^{i}$ ) denote the set of all doubloons $\delta$ from $\mathcal{D}_{2 n+1}^{i}$, which are interlaced (resp. interlaced with $L \delta=j$, resp. normalized, resp. normalized with $L \delta=j$ ).

For instance, the doubloon $\delta=\left(\begin{array}{lll}0 & 4 & 3 \\ 2 & 1\end{array}\right)$ is normalized, since both sequences $(4,2,1,0)$ and $(5,4,3,1)$, which are cyclic rearrangements of $(0,4,2,1)$ and $(4,3,1,5)$, respectively, are decreasing.

The geometry of interlaced and normalized doubloons has been studied in [FH09a]. The connection between interlaced doubloons and split-pair arrangements, introduced by Graham and Zang [GZ08], is explicitly made in [FH09b].

We now recall several properties on doubloons already proved in [FH09a], [FH09b]. For each doubloon $\delta=\binom{a_{0} a_{1} \cdots a_{n}}{b_{0} b_{1} \cdots b_{n}}$ from $\mathcal{D}_{2 n+1}$ and each integer $h$ let $\delta+h$ be the doubloon

\delta+h:=\left(\begin{array}{llll}
a_{0}+h & a_{1}+h & \cdots & a_{n}+h  \tag{3.1}\\
b_{0}+h & b_{1}+h & \cdots & b_{n}+h
\end{array}\right)
$$

where each entry is expressed as a residue $\bmod (2 n+2)$.
Property 3.1. The mapping $\delta \mapsto \delta+h$ is a bijection of $\mathcal{I}_{2 n+1, j}^{i}$ (resp. $\mathcal{N}_{2 n+1, j}^{i}$ ) onto $\mathcal{I}_{2 n+1, j+h}^{i+h}$ (resp. $\mathcal{N}_{2 n+1, j+h}^{i+h}$ ) (superscript and subscript being taken $\bmod (2 n+2)$ ).

See [FH09b], Proposition 2.1.
Property 3.2. Let $0 \leq i<j$ and $\delta=\binom{a_{0} a_{1} \cdots a_{n}}{b_{0} b_{1} \cdots b_{n}}$ be a doubloon from $\mathcal{D}_{2 n+1, j}^{i}$, so that $\delta-i=\left(\begin{array}{c}0 \\ a_{1}-i b_{1}-i \cdots a_{n}-i \\ j\end{array}\right)$ belongs to $\mathcal{D}_{2 n+1, j-i}^{0}$. Then,

$$
\begin{equation*}
\operatorname{des}(\delta-i)=\operatorname{des} \delta, \quad \operatorname{cmaj}(\delta-i)=\operatorname{cmaj} \delta+i \tag{3.2}
\end{equation*}
$$

See [FH09b], Lemma 3.2.
Property 3.3. For each integer $k$ there is a sign-reversing involution on $\mathcal{D}_{2 n+1, k}^{0} \backslash \mathcal{I}_{2 n+1, k}^{0}$ having the property that

\begin{equation*}
\sum_{\delta \in \mathcal{D}_{2 n+1, k}^{0}}(-1)^{n+\operatorname{des} \delta} q^{\mathrm{cmaj} \delta}=\sum_{\delta \in \mathcal{I}_{2 n+1, k}^{0}} q^{\mathrm{cmaj} \delta} \tag{3.3}
\end{equation*}
$$

Moreover,

$$
\begin{equation*}
\sum_{\delta \in \mathcal{I}_{2 n+1, k}^{0}} q^{\mathrm{cmaj} \delta}=(1+q)\left(1+q^{2}\right) \cdots\left(1+q^{n}\right) \sum_{\delta^{\prime} \in \mathcal{N}_{2 n+1, k}^{0}} q^{\mathrm{cmaj} \delta} ; \tag{3.4}
\end{equation*}
$$

Proof. Refer to the proofs of Theorems 4.2 and 1.6 in [FH09a], and observe that the first column $\binom{0}{k}$ is left invariant under each macro flip.

## 4. Signed doubloons

Now, we extend the notion of doubloon to the group of signed permutations and speak of signed doubloons, but only for those signed permutations $w=x_{1} x_{2} \cdots x_{2 n+2} \in B_{2 n+2}$ occurring in the summation displayed in (2.16). They have the property that $F w:=x_{1}<0<x_{2 n+2}=: L w$. We represent them as $2 \times(n+1)$-matrices $w=\left(\begin{array}{cccc}x_{1} & x_{2} & \cdots & x_{n+1} \\ x_{2 n+2} & x_{2 n+1} & \cdots & x_{n+2}\end{array}\right)$. The set of all those signed doubloons will be denoted by $\mathcal{S D}_{2 n+2}$.

For each $w=\left(\begin{array}{cccc}x_{1} & x_{2} & \cdots & x_{n+1} \\ x_{2 n+2} & x_{2 n+1} & \cdots & x_{n+2}\end{array}\right)$ from $\mathcal{S D}_{2 n+2}$ let $\phi_{w}$ be the increasing bijection of $\left\{x_{1}, x_{2}, \ldots, x_{2 n+2}\right\}$ onto $\{0,1,2, \ldots, 2 n+1\}$ and form the (unnsigned) doubloon $\delta_{w}:=\left(\begin{array}{ccc}\phi_{w}\left(x_{1}\right) & \phi_{w}\left(x_{2}\right) & \cdots \phi_{w}\left(x_{n+1}\right) \\ \phi_{w}\left(x_{2 n+2}\right) & \phi_{w}\left(x_{2 n+1}\right) & \cdots \phi_{w}\left(x_{n+2}\right)\end{array}\right)$. The signed doubloon $w$ is characterized by the pair $\left(\delta_{w},-\operatorname{Neg} w\right)$. Moreover, stat $w=\operatorname{stat} \delta_{w}$ whenever "stat" is equal to "des," "maj," "fmaj," "cmaj," or "smaj." The signed doubloon $w$ is said to be interlaced (resp. normalized), if $\delta_{w}$ is interlaced (resp. normalized).

As $F w<0<L w$ when $w$ belongs to $\mathcal{S D}_{2 n+2}$, the mapping

$$
\begin{equation*}
w \mapsto\left(\delta_{w},-\operatorname{Neg} w\right) \tag{4.1}
\end{equation*}
$$

is a bijection of the set $\mathcal{S D}_{2 n+2}$ onto the set of pairs $(\delta, J)$ such that $\delta \in$ $\mathcal{D}_{2 n+1}$, and $J$ a subset of $\{1,2, \ldots, 2 n+2\}$ such that $F \delta+1 \leq \# J \leq L \delta$.

For instance, if $\delta=\binom{042}{315} \in \mathcal{D}_{5}$, then $F \delta+1=1 \leq \# J \leq 3=L \delta$. Take $J=\{3\},\{1,3\},\{2,3,5\}$ for example, the three signed doubloons $w \in \mathcal{S D}_{6}$ associated with those three subsets $J$ are the following:

\begin{aligned}
& \left.\binom{\overline{3} 52}{416} \mapsto\binom{042}{315},\{3\}\right), \\
& \binom{\overline{3} 52}{4 \overline{1} 6} \mapsto\left(\binom{042}{315},\{1,3\}\right), \\
& \binom{54 \overline{2}}{136} \mapsto\left(\binom{042}{315},\{2,3,5\}\right) .
\end{aligned}
$$

If $\left(\delta_{w},-\operatorname{Neg} w\right)=(\delta, J)$, then $($ see $(2.11))$

$$
\begin{equation*}
\operatorname{des} w=\operatorname{des} \delta ; \quad \operatorname{smaj} w=2 \operatorname{cmaj} \delta+\# J+n-1 \tag{4.2}
\end{equation*}
$$

We next make the composition product of the two mappings described in (3.1) and (4.1).

Theorem 4.1. For each pair $(i, k)$ of integers such that $1 \leq k \leq 2 n$ and $0 \leq i \leq 2 n+1-k$ the mapping

w \mapsto\left(\delta_{w}-i,-\operatorname{Neg} w\right) \tag{4.3}
\end{equation*}
$$

is a bijection of the set $\mathcal{S D}_{2 n+2, i+k}^{i}$ of the signed doubloons $w$ satisfying $F \delta_{w}=i, L \delta_{w}=i+k$ onto the set of pairs $(\delta, J)$ such that $\delta \in \mathcal{D}_{2 n+1, k}^{0}$ and $J \subset[1,2 n+2]$ with $i+1 \leq \# J \leq i+k$. Moreover, if $w$ is interlaced (resp. normalized), so is $\delta_{w}-i$, and conversely. Finally, if $\delta=\delta_{w}-i$, then (4.4) $\quad \operatorname{des} w=\operatorname{des} \delta ; \quad \operatorname{smaj} w=2 \mathrm{cmaj} \delta-2 i+\# J+n-1$.

Proof. The theorem is a consequence of Properties 3.1 and 3.2 and the properties of the bijection $w \mapsto\left(\delta_{w},-\operatorname{Neg} w\right)$ given in (4.2).

Identity (2.16) may be rewritten as

E_{2 n+2}(q) & =(-1)^{n+1}\left(1+q^{2 n+2}\right) \sum_{w \in \mathcal{S D}_{2 n+2}}(-1)^{\operatorname{des} w+1} q^{\text {smaj } w} \\
& =\left(1+q^{2 n+2}\right) \sum_{k=1}^{2 n} \sum_{i=0}^{2 n+1-k} \sum_{w \in \mathcal{S D}_{2 n+2, i+k}^{i}}(-1)^{n+\operatorname{des} w} q^{\text {smaj } w}
\end{aligned}
$$

Let

$$
\begin{equation*}
P_{n, i, k}(q):=q^{n-1-2 i} \sum_{l=i+1}^{i+k}\binom{2 n+2}{l} q^{l} \tag{4.5}
\end{equation*}
$$

Using the preceding theorem and Property 3.3 we evaluate the third sum as follows.

\begin{aligned}
& \sum_{w \in \mathcal{S D}_{2 n+2, i+k}^{i}}(-1)^{n+\operatorname{des} w} q^{\text {smaj } w} \\
& =\sum_{\delta \in \mathcal{D}_{2 n+1, k}^{0}} \sum_{i+1 \leq \# J \leq i+k}(-1)^{n+\operatorname{des} \delta} q^{2 \mathrm{cmaj} \delta-2 i+\# J+n-1} \\
& =q^{n-1-2 i} \sum_{\delta \in \mathcal{D}_{2 n+1, k}^{0}}(-1)^{n+\operatorname{des} \delta} q^{2 \mathrm{cmaj} \delta} \sum_{l=i+1}^{i+k}\binom{2 n+2}{l} q^{l} \\
& =P_{n, i, k}(q) \sum_{\delta \in \mathcal{D}_{2 n+1, k}^{0}}(-1)^{n+\operatorname{des} \delta} q^{2 \mathrm{cmaj} \delta} \\
& =P_{n, i, k}(q) \sum_{\delta \in \mathcal{I}_{2 n+1, k}^{0}} q^{2 \mathrm{cmaj} \delta} \\
& =\left(1+q^{2}\right) \cdots\left(1+q^{2 n}\right) P_{n, i, k}(q) \sum_{\delta \in \mathcal{N}_{2 n+1, k}^{0}} q^{2 \mathrm{cmaj} \delta} \\
& =\left(1+q^{2}\right) \cdots\left(1+q^{2 n}\right) P_{n, i, k}(q) d_{n, k}\left(q^{2}\right),
\end{aligned}
$$

where the last equality follows from [FH09b], Theorem 1.2. By multiplying (4.6) by $\left(1+q^{2 n+2}\right)$ and summing over all pairs $(k, i)$ such that $1 \leq k \leq 2 n$ and $0 \leq i \leq 2 n+1-k$ we derive identity (1.14), keeping in mind that $P_{n, k}(q)=\sum_{0 \leq i \leq 2 n+1-k} P_{n, i, k}$.

This achieves the proofs of both Theorems 1.1 and 1.2, except part (d).
Let $\mathcal{S N}_{2 n+2, i+k}^{i}$ be the set of the normalized signed doubloons $w$ satisfying $F \delta_{w}=i, L \delta_{w}=i+k$. It also follows from Theorem 4.1 that

\sum_{w \in \mathcal{S} \mathcal{N}_{2 n+2, i+k}^{i}} q^{\text {smaj } w}=P_{n, i, k}(q) \sum_{\delta \in \mathcal{N}_{2 n+1, k}^{0}} q^{2 \mathrm{cmaj} \delta} \tag{4.7}
\end{equation*}
$$

From (4.6) it follows that

\begin{equation*}
\text { 8) } \sum_{w \in \mathcal{S D}_{2 n+2, i+k}^{i}}(-1)^{n+\operatorname{des} w} q^{\text {smaj } w}=\left(1+q^{2}\right) \cdots\left(1+q^{2 n}\right) \sum_{w \in \mathcal{S N}_{2 n+2, i+k}^{i}} q^{\text {smaj } w} \text {. } \tag{4.8}
\end{equation*}
$$

By multiplying (4.8) by $\left(1+q^{2 n+2}\right)$ and summing over all pairs $(k, i)$ such that $1 \leq k \leq 2 n$ and $0 \leq i \leq 2 n+1-k$ we derive identity (1.11).

## 5. Proof of Theorem 1.1 (d)

Recall that for each $w=x_{1} x_{2} \cdots x_{2 n+1} \in B_{2 n+1}$ we have used the notations $F w:=x_{1}$ and $L w:=x_{2 n+1}$. As $B_{2 n+1}(t, q)=\sum_{w \in B_{2 n+1}} t^{\operatorname{des}_{B} w} q^{\mathrm{fmaj} w}$,
we may write

$$
\begin{equation*}
B_{2 n+1}\left(-q^{-(2 n+1)}, q\right)=\sum_{w \in B_{2 n+1}}(-1)^{\operatorname{sgn} w} q^{\operatorname{smaj} w} \tag{5.1}
\end{equation*}
$$

where

\begin{align*}
\operatorname{sgn} w & :=(-1)^{\operatorname{des} w+\chi(F w<0)} ;  \tag{5.2}\\
\operatorname{smaj} w & :=2 \operatorname{maj} w+\operatorname{neg} w-(2 n+1)(\operatorname{des} w+\chi(F w<0), \tag{5.3}
\end{align*}
$$

as there is no ambiguity to adopt this definition of "smaj" for signed permutations from $B_{2 n+1}$.

For proving the identity $A_{2 n}\left(-q^{-n}, q\right)=0$ in [FH09a] we had recourse to the classical properties of the dihedral group acting on $\mathfrak{S}_{2 n}$. Actually, the mirror image $\mathbf{r}$ provided the sign-reversing involution that was needed. With the group $B_{2 n+1}$ the supplementary descent to be counted, when the first letter is negative, makes it necessary to include another dihedral group involution, as well as a sign change operation.

In this section the elements of $B_{2 n+1}$ will be regarded as two-row matrices $w=\binom{|w|}{\epsilon}:=\left(\begin{array}{ccc}\left|x_{1}\right|\left|x_{2}\right| \cdots\left|x_{2 n+1}\right| \\ \epsilon_{1} \epsilon_{2} & \cdots & \epsilon_{2 n+1}\end{array}\right)$, where $|w|:=\left|x_{1}\right|\left|x_{2}\right| \cdots\left|x_{2 n+1}\right|$

becomes an ordinary permutation and $\epsilon:=\epsilon_{1} \epsilon_{2} \cdots \epsilon_{2 n+1}$ is the sign word defined by $\epsilon_{i}:=1$ or -1 , dependeing on whether $x_{i}$ is positive or negative $(1 \leq i \leq 2 n+1)$.

Three operations $\mathbf{r}, \mathbf{c}, \mathbf{s}$ are now introduced and further extended to all of $B_{2 n+1}$ : first, the mirror image

$$
\mathbf{r}: y_{1} y_{2} \cdots y_{2 n+1} \mapsto y_{2 n+1} \cdots y_{2} y_{1},
$$

defined for every arbitrary word; second, the complement to $(2 n+2)$, defined for each permutation from $\mathfrak{S}_{2 n+1}$, by

$$
\mathbf{c}: y_{1} y_{2} \cdots y_{2 n+1} \mapsto\left(2 n+2-y_{1}\right)\left(2 n+2-y_{2}\right) \cdots\left(2 n+2-y_{2 n+1}\right)
$$

third, the sign change $\mathbf{s}$, defined for each binary word, such as $\epsilon=$ $\epsilon_{1} \epsilon_{2} \cdots \epsilon_{2 n+1}$, whose letters are equal to +1 or -1 , by

$$
\mathbf{s}: \epsilon_{1} \epsilon_{2} \cdots \epsilon_{2 n+1} \mapsto \bar{\epsilon}_{1} \bar{\epsilon}_{2} \cdots \bar{\epsilon}_{2 n+1}
$$

We use the same symbols for their extensions to $B_{2 n+1}$ :
$\mathbf{c}:\binom{|w|}{\epsilon}=\left(\begin{array}{ccc}\left|x_{1}\right| & \cdots\left|x_{2 n+1}\right| \\ \epsilon_{1} & \cdots & \epsilon_{2 n+1}\end{array}\right) \mapsto\binom{\mathbf{c}|w|}{\epsilon}=\binom{\left(2 n+2-\left|x_{1}\right| \mid \cdots\left(2 n+2-\left|x_{2 n+1}\right|\right)\right.}{\epsilon_{1}}$ ( $\left.\begin{array}{c}\epsilon_{2 n+1}\end{array}\right)$;

Note that the three involutions $\mathbf{r}, \mathbf{c}, \mathbf{s}$, defined on $B_{2 n+1}$ by (5.4), (5.5) and (5.6) commute. The composition product $\mathbf{b}:=\mathbf{c s r}$ can also be written as

\epsilon_{1}
\end{array} \cdots\left|\epsilon_{2 n+1}\right| \begin{array}{c}

\left(n+2-\left|x_{2 n+1}\right| \mid \cdots\left(n+2-\left|x_{1}\right|\right)\right. \\
\bar{\epsilon}_{2 n+1} \\
\cdots
\end{array} \underset{\bar{\epsilon}_{1}}{(1)} .\right.
$$

Theorem 5.1. The composition product $\mathbf{b}$ defined in (5.7) is a signreversing involution of $B_{2 n+1}$, i.e.,

(\operatorname{sgn}, \operatorname{smaj})\binom{|w|}{\epsilon}=(-\operatorname{sgn}, \operatorname{smaj}) \mathbf{b}\binom{|w|}{\epsilon} . \tag{5.8}

The proof of the theorem is based on the next three lemmas. The first two ones being easy to verify are given without proofs.
Lemma 5.2. For each $w=\binom{|w|}{\epsilon} \in B_{2 n+1}$ we have

If $\binom{\left|x_{i}\right|}{\epsilon_{i}}>\binom{\left|x_{i+1}\right|}{\epsilon_{i+1}}\left(\right.$ resp. $\left.\binom{\left|x_{i}\right|}{\epsilon_{i}}<\binom{\left|x_{i+1}\right|}{\epsilon_{i+1}}\right)$ say that $i$ is an interior descent (resp. rise), if $\left|x_{i}\right|>\left|x_{i+1}\right|$ (resp. $\left|x_{i}\right|<\left|x_{i+1}\right|$ ) and $\epsilon_{i}=\epsilon_{i+1}$. Denote the set of all descents (resp. rises) of $w$ by DES $w$ (resp. RISE $w$ ), the set of all interior descents (resp. rises) being designated by DES ${ }^{i} w$ (resp. $\operatorname{RISE}^{i} w$ ), so that DES $w=\operatorname{DES}^{i} w+\operatorname{DES} \epsilon$ and RISE $w=\operatorname{RISE}^{i} w+\operatorname{RISE} \epsilon$.

First, $\operatorname{DES}^{i} w=\operatorname{RISE}^{i} \mathbf{c} w$ and RISE ${ }^{i} w=\operatorname{DES}^{i} \mathbf{c} w$. Hence,

& =2 n+(\# \operatorname{DES} \epsilon-\# \operatorname{RISE} \epsilon) \\
& :=2 n+\text { drise } \epsilon .
\end{aligned}
$$

In the same way, let DRISE $\epsilon:=\sum_{i} i(\chi(i \in \operatorname{DES} \epsilon)-\chi(i \in \operatorname{RISE} \epsilon))$. Then,

& \quad+\sum_{i} i(\chi(i \in \operatorname{DES} \epsilon)-\chi(i \in \operatorname{RISE} \epsilon)) \\
= & (1+2+\cdots+2 n)+\operatorname{DRISE} \epsilon \\
= & n(2 n+1)+\operatorname{DRISE} \epsilon .
\end{aligned}
$$

Let $d_{1}<d_{2}<\cdots$ (resp. $r_{1}<r_{2}<\cdots$ ) denote the sequence of the descents (resp. rises) of $\epsilon$, when reading the word $\epsilon$ from left to right. Four cases are now considered.
(a) $\epsilon_{1}=\epsilon_{2 n+1}=-1$; the rises and descents alternate in such a way that $1 \leq r_{1}<d_{1}<r_{2}<d_{2}<\cdots<r_{k}<d_{k} \leq 2 n$ and $k \geq 0$. Hence, drise $\epsilon=0$ and DRISE $\epsilon=\sum_{i=1}^{k}\left(d_{i}-r_{i}\right)=\operatorname{pos} w$.
(b) $\epsilon_{1}=+1, \epsilon_{2 n+1}=-1$; the alternation becomes: $1 \leq d_{1}<r_{1}<d_{2}<$ $r_{2}<\cdots<d_{k}<r_{k}<d_{k+1} \leq 2 n(k \geq 0)$. In this case, drise $\epsilon=1$ and DRISE $\epsilon=\operatorname{pos} w$.

(c) $\epsilon_{1}=\epsilon_{2 n+1}=1$; the sequence is then: $1 \leq d_{1}<r_{1}<d_{2}<r_{2}<\cdots<$ $d_{k}<r_{k} \leq 2 n(k \geq 0)$. Hence, drise $\epsilon=0$ and DRISE $\epsilon=-\operatorname{neg} w$.
(d) $\epsilon_{1}=-1, \epsilon_{2 n+1}=1$; then $1 \leq r_{1}<d_{2}<r_{2}<\cdots<r_{k}<d_{k}<$ $r_{r+1} \leq 2 n(k \geq 0)$. Hence, drise $\epsilon=-1$ and DRISE $\epsilon=-\operatorname{neg} w$.

Thus, $\operatorname{sgn} w+\operatorname{sgn} \mathbf{c} w=\operatorname{des} w+\chi\left(\epsilon_{1}<0\right)+\operatorname{des} \mathbf{c} w+\chi\left(\epsilon_{1}<0\right) \equiv \operatorname{drise} \epsilon$ $(\bmod 2)$, which is 0 when $\epsilon_{1}$ and $\epsilon_{2 n+1}$ are of the same sign (cases (a) and (c)), equal to 1 when $\epsilon_{1}=1, \epsilon_{2 n+1}=-1$ (case (b)) and -1 when $\epsilon_{1}=-1$ and $\epsilon_{2 n+1}=+1$ (case (d)). Gathering in a common formula: $\operatorname{sgn} w+\operatorname{sgn} \mathbf{c} w \equiv \chi\left(\epsilon_{1}=1\right)-\chi\left(\epsilon_{2 n+1}=1\right)$. This implies (5.13).

Finally,

\quad-(2 n+1)\left(\operatorname{des} \mathbf{c} w+\operatorname{des} w+2 \chi\left(\epsilon_{1}<0\right)\right) \\
=2 n(2 n+1)+2 \operatorname{DRISE} \epsilon+2 \operatorname{neg} w \\
-(2 n+1)\left(2 n+\operatorname{drise} \epsilon+2 \chi\left(\epsilon_{1}<0\right)\right) \\
=2 \operatorname{DRISE} \epsilon+2 \operatorname{neg} w \\
-(2 n+1)\left(\operatorname{drise} \epsilon+2 \chi\left(\epsilon_{1}<0\right)\right)
\end{array}\right] \begin{aligned}
& 2 \operatorname{pos} w+2 \operatorname{neg} w-(2 n+1) 2=0, \text { in case (a); } \\
&= \begin{cases}2 \operatorname{pos} w+2 \operatorname{neg} w-(2 n+1)=2 n+1, & \text { in case (b); } \\
-2 \operatorname{neg} w+2 \operatorname{neg} w-(2 n+1) 0=0, & \text { in case (c); } \\
-2 \operatorname{neg} w+2 \operatorname{neg} w-(2 n+1)=-(2 n+1), & \text { in case (d). }\end{cases}
\end{aligned}
$$

Altogether, $\operatorname{smaj} \mathbf{c} w=-\operatorname{smaj} w-(2 n+1)\left(\chi\left(\epsilon_{1}=-1\right)-\chi\left(\epsilon_{2 n+1}=-1\right)\right)$. This proves (5.14) and also Lemma 5.4.

## 6. Which descent for the hyperoctahedral group?

The purpose of this Section is to work out a global expression for the generating polynomial for $B_{n}$ by the five-term statistic (neg, pos, $\Xi$, des, fmaj), where $\Xi w$ is equal to 1 or 0 , depending on whether the first letter of $w$

is negative or positive, and to derive the specializations when the pair $\left(\Xi\right.$, des) is replaced either by "des ${ }_{B}$," or by "fdes," defined in (2.3) and (2.4). Our main result is the following.

Theorem 6.1. Let

B_{n}(X, Y, Z ; t, q)=\sum_{w \in B_{n}} X^{\operatorname{neg} w} Y^{\operatorname{pos} w} Z^{\chi\left(x_{1}<0\right)} t^{\operatorname{des} w} q^{\mathrm{fmaj} w} \tag{6.1}
\end{equation*}
$$

Then,

$$
\begin{align*}
\frac{B_{n}(X, Y, Z ; t, q)}{\left(t ; q^{2}\right)_{n+1}} & =\frac{t-Z}{t-1} \sum_{s \geq 0} t^{s}\left((q X+Y)[s+1]_{q^{2}}\right)^{n}  \tag{6.2}\\
& +\frac{Z-1}{t-1} \sum_{s \geq 0} t^{s}\left((q X+Y)[s+1]_{q^{2}}-X q^{2 s+1}\right)^{n}
\end{align*}
$$

When $q=1$, write $B_{n}(X, Y, Z ; t):=B_{n}(X, Y, Z ; t, 1)$. The exponential generating function for the latter polynomials can be derived in the following form.
Theorem 6.2. The following identity holds:

Let $w=x_{1} x_{2} \cdots x_{n}$ be a signed permutation from $B_{n}$ and $\phi$ be the unique increasing bijection of the set $\left\{x_{1}, x_{2}, \ldots, x_{n}\right\}$ onto the interval $[n]:=\{1,2, \ldots, n\}$. The word $\sigma=\sigma(1) \sigma(2) \cdots \sigma(n):=$ $\phi\left(x_{1}\right) \phi\left(x_{2}\right) \cdots \phi\left(x_{n}\right)$ is then an (ordinary) permutation from $\mathfrak{S}_{n}$ and the $\operatorname{map} w \mapsto(\operatorname{Neg} w, \sigma)$ a bijection of $B_{n}$ onto the Cartesian product $2^{[n]} \times \mathfrak{S}_{n}$ having the following properties:

For convenience, introduce the polynomial

$$

and express $B_{n}(X, Y, Z ; t, q)$ in terms of the latter polynomials, to get:

B_{n}(X, Y, Z ; t, q) & =\sum_{k=0}^{n} \sum_{|E|=k} \sum_{\mathrm{Neg} w=E}(q X)^{\operatorname{neg} w} Y^{\mathrm{pos} w} Z^{\chi\left(x_{1}<0\right)} t^{\operatorname{des} w} q^{2 \operatorname{maj} w} \\
& =\sum_{k=0}^{n}(q X)^{k} Y^{n-k} \sum_{|E|=k} \sum_{(E, \sigma)} Z^{\chi(\sigma(1) \leq k)} t^{\operatorname{des} \sigma} q^{2 \operatorname{maj} \sigma} \\
& =\sum_{k=0}^{n}\binom{n}{k}(q X)^{k} Y^{n-k} A_{n}^{k}\left(Z ; t, q^{2}\right)
\end{aligned}
$$

Next, with each permutation $\sigma=k \sigma(2) \cdots \sigma(n)$ starting with $k$ associate the permutation $\sigma^{\prime}=\sigma^{\prime}(1) \cdots \sigma^{\prime}(n-1):=\psi(\sigma(2)) \cdots \psi(\sigma(n))$, where $\psi$ is the unique increasing bijection of $[n] \backslash\{k\}$ onto $[n-1]$. If $\sigma(2) \leq k-1$, then $\operatorname{des} \sigma=\operatorname{des} \sigma^{\prime}+1$, while maj $\sigma=\operatorname{maj} \sigma^{\prime}+\operatorname{des} \sigma^{\prime}+1$ and $\sigma^{\prime}(1) \leq k-1$. If $\sigma(2) \geq k+1$, then $\operatorname{des} \sigma=\operatorname{des} \sigma^{\prime}$, while maj $\sigma=\operatorname{maj} \sigma^{\prime}+\operatorname{des} \sigma^{\prime}$ and $\sigma^{\prime}(1) \geq k$. Hence,

\sum_{\substack{\sigma(1)=k, \sigma(2) \leq k-1}} Z^{\chi(\sigma(1) \leq k)} t^{\operatorname{des} \sigma} q^{\operatorname{maj} \sigma}= & Z \sum_{\sigma^{\prime}(1) \leq k-1} t^{\operatorname{des} \sigma^{\prime}+1} q^{\operatorname{maj} \sigma^{\prime}+\operatorname{des} \sigma^{\prime}+1} \\
= & Z \sum_{\sigma^{\prime}(1) \leq k-1}(t q)^{\chi(\sigma(1) \leq k-1)}(t q)^{\operatorname{des} \sigma^{\prime}} q^{\operatorname{maj} \sigma^{\prime}}
\end{aligned}
$$

while

\begin{aligned}
\sum_{\substack{\sigma(1)=k, \sigma(2) \geq k+1}} Z^{\chi(\sigma(1) \leq k)} t^{\operatorname{des} \sigma} q^{\operatorname{maj} \sigma} & =Z \sum_{\sigma^{\prime}(1) \geq k} t^{\operatorname{des} \sigma^{\prime}} q^{\operatorname{maj} \sigma^{\prime}+\operatorname{des} \sigma^{\prime}} \\
& =Z \sum_{\sigma^{\prime}(1) \geq k}(t q)^{\chi(\sigma(1) \leq k-1)}(t q)^{\operatorname{des} \sigma^{\prime}} q^{\operatorname{maj} \sigma^{\prime}} .
\end{aligned}
$$

Altogether

But, the variable $Z$ vanishes from $A_{n}^{k}(Z ; t, q)$ when $k=0$ and then $A_{n}^{0}(Z ; t, q)=A_{n}(t, q)$, which is the Carlitz $q$-analog of the Eulerian polynomial ([Ca54], [Ca75]) appearing in (1.1). Hence,

& =\frac{t-Z}{t-1} A_{n}(t, q)+\frac{Z-1}{t-1} \sum_{j=0}^{k}\binom{k}{j}(-1)^{j}(t ; q)_{j} A_{n-j}\left(t q^{j}, q\right) .

The next step is to report this new expression of $A_{n}^{k}(Z ; t, q)$ into the polynomial $B_{n}(X, Y, Z ; t, q)$. We get:

& \left.\quad+\frac{Z-1}{t-1} \sum_{j=0}^{k}\binom{k}{j}(-1)^{j}\left(t ; q^{2}\right)_{j} A_{n-j}\left(t q^{2 j}, q^{2}\right)\right) \\
& =\frac{t-Z}{t-1}(q X+Y)^{n} A_{n}\left(t, q^{2}\right) \\
& \quad+\frac{Z-1}{t-1} \sum_{\substack{j, l, m \geq 0 \\
j+l+m=n}} \frac{n!}{j!l!m!}(q X)^{j+l} Y^{m}(-1)^{j}\left(t ; q^{2}\right)_{j} A_{l+m}\left(t q^{2 j}, q^{2}\right)
\end{aligned}
$$

where $k=j+l$.
Next, with $r=l+m$ we get

& \quad+\frac{Z-1}{t-1} \sum_{j+r=n} \frac{n!}{r!j!}(-q X)^{j} \frac{A_{r}\left(t q^{2 j}, q^{2}\right)}{\left(t q^{2 j} ; q^{2}\right)_{r+1}} \sum_{l+m=r} \frac{r!}{l!m!}(q X)^{l} Y^{m} \\
& =\frac{t-Z}{t-1}(q X+Y)^{n} \frac{A_{n}\left(t, q^{2}\right)}{\left(t ; q^{2}\right)_{n+1}} \\
& \quad \quad+\frac{Z-1}{t-1} \sum_{j+r=n} \frac{n!}{r!j!}(-q X)^{j} \frac{A_{r}\left(t q^{2 j} q^{2}\right)}{\left(t q^{2 j} ; q^{2}\right)_{r+1}}(q X+Y)^{r}
\end{aligned}
$$

Furthermore,

+\frac{Z-1}{t-1} \sum_{j \geq 0} \frac{(-q X u)^{j}}{j!} \sum_{r \geq 0} \frac{A_{r}\left(t q^{2 j}, q^{2}\right)}{\left(t q^{2 j}, q^{2}\right)_{r+1}} \frac{((q X+Y) u)^{r}}{r!}
\end{aligned}
$$

Now, make use of the classical identity on the Carlitz $q$-Eulerian polynomials

\sum_{n \geq 0} \frac{B_{n}(X, Y, Z ; t, q)}{\left(t ; q^{2}\right)_{n+1}} \frac{u^{n}}{n!}=\frac{t-Z}{t-1} \sum_{s \geq 0} t^{s} \exp \left((q X+Y) u[s+1]_{q^{2}}\right) \\
+\frac{Z-1}{t-1} \sum_{j \geq 0} \frac{(-q X u)^{j}}{j!} \sum_{s \geq 0}\left(t q^{2 j}\right)^{s} \exp \left((q X+Y) u[s+1]_{q^{2}}\right) .
\end{array}
$$

There remains to extract the coefficient of $u^{n}$ on both sides. This leads to:

$$
\begin{equation*}
\frac{B_{n}(X, Y, Z ; t, q)}{n!\left(t ; q^{2}\right)_{n+1}}=\frac{t-Z}{t-1} \sum_{s \geq 0} t^{s}\left((q X+Y)[s+1]_{q^{2}}\right)^{n}+\frac{Z-1}{t-1} C, \tag{6.7}
\end{equation*}
$$

where $C$ is the coefficient of $u^{n}$ in

$$
\sum_{j \geq 0} \frac{(-q X u)^{j}}{j!} \sum_{s \geq 0}\left(t q^{2 j}\right)^{s} \sum_{m \geq 0} \frac{\left((q X+Y) u[s+1]_{q^{2}}\right)^{m}}{m!}
$$

that is,

$$
\begin{aligned}
C & =\sum_{s \geq 0} t^{s} \sum_{j \geq 0} \frac{(-q X)^{j}}{j!} q^{2 j s} \frac{\left((q X+Y)[s+1]_{q^{2}}\right)^{n-j}}{(n-j)!} \\
& =\frac{1}{n!} \sum_{s \geq 0} t^{s} \sum_{j \geq 0}\binom{n}{j}\left(-q X q^{2 s}\right)^{j}\left((q X+Y)[s+1]_{q^{2}}\right)^{n-j} \\
& =\frac{1}{n!} \sum_{s \geq 0} t^{s}\left((q X+Y)[s+1]_{q^{2}}-X q^{2 s+1}\right)^{n}
\end{aligned}
$$

Reporting the last expression in (6.7) yields identity (6.2).
Proof of Theorem 6.2. When $q=1$ in (6.2), we obtain

$$
\begin{align*}
\frac{B_{n}(X, Y, Z ; t)}{(1-t)^{n+1}}=\frac{t-Z}{t-1} \sum_{s \geq 0} & t^{s}((X+Y)(s+1))^{n}  \tag{6.8}\\
& +\frac{Z-1}{t-1} \sum_{s \geq 0} t^{s}((X+Y)(s+1)-X)^{n}
\end{align*}
$$

Hence,

$$
\begin{aligned}
& \sum_{n \geq 0} \frac{u^{n}}{(1-t)^{n}} B_{n}(X, Y, Z ; t) \\
& \quad=(Z-t) \sum_{s \geq 0} t^{s} \sum_{n \geq 0} \frac{(u(X+Y)(s+1))^{n}}{n!} \\
& \quad+(1-Z) \sum_{s \geq 0} t^{s} \sum_{n \geq 0} \frac{(u(X+Y)(s+1)-X)^{n}}{n!}
\end{aligned}
$$

$$
\begin{aligned}
& =(Z-t) \sum_{s \geq 0} t^{s} \exp (u(X+Y)(s+1)) \\
& \quad \quad+(1-Z) \sum_{s \geq 0} t^{s} \sum_{n \geq 0} \exp (u(X+Y)(s+1)-X) \\
& =\left((Z-t)(\exp (u(X+Y))+(1-Z) \exp (u Y)) \sum_{s \geq 0} t^{s} \exp (u(X+Y) s)\right. \\
& = \\
& =\frac{(Z-t) \exp (u(X+Y)(1-Z)) \exp (u Y)}{1-t \exp (u(X+Y))},
\end{aligned}
$$

which is identity (6.3) by replacing $u$ by $u(1-t)$.
Next, we derive specializations of Theorems 6.1 and 6.2 when the pair ( $\Xi$, des) is replaced by "des ${ }_{B}$ " and "fdes" (see (2.3) and (2.4)). We get:

$$
\begin{align*}
\sum_{w \in B_{n}} X^{\mathrm{neg} w} Y^{\mathrm{pos} w} t^{\operatorname{des} B_{B} w} q^{\mathrm{fmaj} w} & =B_{n}(X, Y, t ; t, q)  \tag{6.9}\\
\sum_{w \in B_{n}} X^{\mathrm{neg} w} Y^{\operatorname{pos} w} t^{\mathrm{fdes} w} q^{\mathrm{fmaj} w} & =B_{n}\left(X, Y, t ; t^{2}, q\right) \tag{6.10}
\end{align*}
$$

Also, note that $B_{n}(0,1,1 ; t, q)$ is the Carlitz $q$-Eulerian polynomial $A_{n}(t, q)$.
First,

$$
\begin{align*}
\frac{B_{n}(X, Y, t ; t, q)}{\left(t ; q^{2}\right)_{n+1}} & =\sum_{s \geq 0} t^{s}\left((q X+Y)[s+1]_{q^{2}}-X q^{2 s+1}\right)^{n}  \tag{6.11}\\
\frac{B_{n}(1,1, t ; t, q)}{\left(t ; q^{2}\right)_{n+1}} & =\sum_{w \in B_{n}} t^{\operatorname{des}_{B} w} q^{\mathrm{fmaj} w}=\sum_{s \geq 0} t^{s}\left([2 s+1]_{q}\right)^{n} \tag{6.12}
\end{align*}
$$

Second,

$$
\begin{aligned}
& \frac{B_{n}\left(X, Y, t ; t^{2}, q\right)}{\left(t^{2} ; q^{2}\right)_{n+1}}=\frac{t^{2}-t}{t-1} \sum_{s \geq 0} t^{2 s}\left((q X+Y)[s+1]_{q^{2}}\right)^{n} \\
& \quad+\frac{t-1}{t^{2}-1} \sum_{s \geq 0} t^{2 s}\left((q X+Y)[s+1]_{q^{2}}-X q^{2 s+1}\right)^{n}
\end{aligned}
$$

so that
(6.13) $\frac{(1+t) B_{n}\left(X, Y, t ; t^{2}, q\right)}{\left(t^{2} ; q^{2}\right)_{n+1}}=\sum_{s \geq 0} t^{2 s+1}\left((q X+Y)[s+1]_{q^{2}}\right)^{n}$

$$
+\sum_{s \geq 0} t^{2 s}\left((q X+Y)[s]_{q^{2}}+Y q^{2 s}\right)^{n}
$$

In particular,
(6.14) $\frac{(1+t) B_{n}(1,1, t ; t, q)}{\left(t^{2} ; q^{2}\right)_{n+1}}=\sum_{w \in B_{n}} t^{\mathrm{fdes} w} q^{\mathrm{fmaj} w}=\sum_{s \geq 0} t^{s}\left([s+1]_{q}\right)^{n}$.

The specializations of (6.12) and (6.14) for $q=1$ are banal and not reproduced. However, it is worth writing the exponential generating functions for the polynomials $B_{n}(1,1, t ; t)$ and $B_{n}\left(1,1, t ; t^{2}\right)$ directly obtained from (6.3):

$$
\begin{align*}
\sum_{n \geq 0} \frac{u^{n}}{n!} B_{n}(1,1, t ; t) & =\sum_{n \geq 0} \frac{u^{n}}{n!} \sum_{w \in B_{n}} t^{\operatorname{des}_{B} w}=\frac{(1-t) \exp (u(t-1))}{-t+\exp (2 u(t-1))}  \tag{6.15}\\
\sum_{n \geq 0} \frac{u^{n}}{n!} B_{n}\left(1,1, t ; t^{2}\right) & =\frac{(1-t)\left(t+\exp \left(u\left(t^{2}-1\right)\right)\right)}{-t^{2}+\exp \left(2 u\left(t^{2}-1\right)\right)} ;
\end{align*}
$$

so that

$$
\begin{equation*}
\sum_{n \geq 0} \frac{u^{n}}{n!} B_{n}\left(1,1, t ; t^{2}\right)=\sum_{n \geq 0} \frac{u^{n}}{n!} \sum_{w \in B_{n}} t^{\mathrm{fdes} w}=\frac{1-t}{-t+\exp \left(u\left(t^{2}-1\right)\right)} \tag{6.16}
\end{equation*}
$$

The statistics "fdes" and "fmaj" were introduced by Adin and Roichman [AR01]. Identity (6.14) with their equivalent adaptations were derived by Brenti et al. [ABR01], Haglund et al. [HLR05] and reproved by the authors ([FH06], [FH09]) as specializations of identities involving severalvariable statistics. Note that (6.16) implies that $\sum_{w \in B_{n}}(-1)^{\mathrm{fdes} w}$ is null for every $n \geq 1$. Accordingly, the statistic "fdes" would have been a wrong choice for obtaining a $q$-extension!
