I. Introduction

A notable trend in recent years has been the swift growth in the intensity of firm alliance strategies¹ with a consequent proliferation in research studies on the subject. Among all the respective topics, one important question has merited particular attention from researchers: what motivates firms to enter into alliances with other firms?

The literature reveals a large number of motives for cooperative arrangements drawn from several approaches to firm behavior: transaction cost theory (Williamson, 1979), resource dependence theory (Barley *et al.*, 1992), resource-based view (Das and Teng, 2000), organizational learning (Kogut, 1988), relationship marketing (Arndt, 1979), strategic behavior theory (Kogut, 1988), and so on. Each one of these approaches stresses specific aspects of alliance motivation. Transaction cost theory focuses on cost minimization, resource dependence theory on getting the resources to survive and the resource-based view on synergy. In turn, organizational learning rests on knowledge, relationship marketing on providing superior customer value and strategic behavior theory on profit maximization.

Despite the proliferation of motives, the most cited has been the desire to reduce transaction costs. Thus, transaction cost economics has

3 become the most often mentioned approach in theoretical and empirical
4 studies seeking to understand the drivers of alliance formation. Other points
5 of view, namely those related to the internal resource situation of the firms
6 and their external environment, are not yet so frequently taken into account
7 as the transactional approach.

17 In this article, we analyze the impact of firm internal resources and
18 perceived environmental uncertainty on the probability of a firm to
19 establish an alliance. Thus, our theoretical framework is based on the
20 resource dependence and resource-based view approaches, by one side, and
21 on the literature about the role of environmental uncertainty on strategic
22 alliances, by the other side.

33 Both the resource dependence theory and the resource-based view
34 see firm resource conditions as prime drivers for alliance behavior: the
35 probability of a firm entering into an alliance will be a function of the need
36 to acquire external resources. However, according to our point of view, the
37 first one is more adequate to explain alliances involving resource-poor
38 firms while the latter fits better for firms that are relatively well resource-
39 endowed. Our contribution is to show that results predicted by these two
40 approaches should be moderated by perceived environmental uncertainty.
41 Specifically, predictions of the resource dependence theory are more likely
42 to occur in contexts of high perceived environmental uncertainty while the
43 resource-based view fits better when this kind of uncertainty is not very
44 high.

3 The departing point of our study is the research made by Park *et al*
4 (2002). We take the challenge made by the authors when they suggest that
5 future studies should consider managerial perceptions of the environment in
6 order to better understand how firms react to environmental changes
7 through strategic alliances. Our research and the above cited study have in
8 common two basic assumptions: 1) alliance formation as a mechanism to
9 adapt to environment is contingent on internal resources, and 2) resource-
10 poor firms and resource-rich firms can react differently in the same
11 environmental context.

27 However, our study differs from that of Park *et al* in a considerable
28 number of points: a) the type of uncertainty used to explain the propensity
29 of firms to enter into alliances; b) the expected behaviour of firms in
30 different environmental contexts; c) the kind of firms included in the
31 sample for empirical test purposes; and d) the achieved results.

40 Park *et al* (2002) consider the state of the market (stable, declining
41 and growing) objectively measured as the sole environmental factor
42 influencing the alliance behaviour of the firms. We don't question the
43 appropriateness of this indicator for the purposes of the study, but the
44 market is not the only source of uncertainty for firms. Hence, we followed
45 the suggestion made by the authors themselves, and use several measures of
46 perceived environmental context, that is, measures that reflect the way
47 managers evaluate the external context of their firms. In particular, we aim
48 to understand if different levels of perceived environmental uncertainty are
49

3 associated with different firm behaviours regarding inter-firm alliances. In
4
5 our study, the level of environmental uncertainty is dependent on several
6
7 external factors (subjectively evaluated by managers), including the state of
8
9 the market.

14 Park *et al* (2002) hypothesize that resource-rich firms are more likely
15
16 to settle alliances when the market demand declines or grows, suggesting a
17
18 U-shaped relationship between the level of environmental uncertainty and
19
20 the propensity of firms to enter into alliances. They hypothesize also that
21
22 resource-poor firms are more likely to enter into alliances when the market
23
24 demand grows, suggesting a direct and positive relationship between the
25
26 level of environmental uncertainty and the propensity to ally for this kind of
27
28 firms. Based on the resource dependence theory and the resource-based
29
30 view, we argue that the above cited relationship will be negative for the
31
32 resource-rich firms and positive for the resource-poor ones.

41 In order to empirically test their hypotheses, Park *et al* (2002) use a
42
43 sample based on a sole industrial sector (semiconductor industry),
44
45 recognizing that this is a limitation of their work. Additionally, they only
46
47 consider start-up firms. We considered several industrial sectors as well as
48
49 start-up and non-start-up firms. Hence, our study is more general, although
50
51 recognizing that firm alliance behaviours can change across industries.
52
53

57 Finally, regarding the results, Park *et al* (2002) conclude that
58
59 resource-rich firms are more active in volatile markets while resource-poor
60
firms are more active in relatively stable markets. We conclude that

3 resource rich firms are more prone to settle alliances in relatively
4
5 predictable environmental contexts while resource-poor ones have a higher
6
7 propensity to ally in uncertain environmental contexts. However, these
8
9 differences in the results will be moderated if we take into account that we
10
11 use a different measure for the environmental context.

17 The paper is structured in two sections, in addition to this
18
19 introduction and the conclusions. In section II, we conceptualize how
20
21 perceived environmental uncertainty and resource conditions independently
22
23 affect the propensity of firms to collaborate (model 1). Then, we let
24
25 resource conditions and environmental uncertainty interact in order to
26
27 obtain different resource condition impacts on the probability of firms
28
29 engaging in alliances (model 2). In section III, the two models are
30
31 formalized and applied to our sample in order to obtain a set of probabilities
32
33 for alliance formation.

43 **II. Theoretical framework and hypotheses**

44
45
46
47
48

49
50 As said above, we agree with Park *et al* (2002) that alliances can be
51
52 viewed as an adaptive response to changes in the environment. However,
53
54 introducing environmental uncertainty as a key determinant factor of firm
55
56 alliance strategies raises three important questions: 1) what are the sources
57
58 of environmental uncertainty, 2) what type of environmental uncertainty
59
60

3 should we be dealing with, and 3) what measures of environmental
4
5
6 uncertainty (objective or perceived) are most adequate.
7

8
9 All these questions were already discussed by Milliken (1987),
10
11 whose point of view could be summarized as follows: a) environmental
12
13 uncertainty is a multidimensional concept; b) there are three types of
14
15 environmental uncertainty: state uncertainty, that is, unpredictability of
16
17 particular components of the environment; effect uncertainty, that is,
18
19 unpredictability about the impact on the organization of particular
20
21 environmental events; and response uncertainty, that is, inability to predict
22
23 the consequences of a choice; and c) environmental uncertainty should be
24
25 distinguished as a descriptor of the state of organizational environments,
26
27 that is, as a characteristic of the environment objectively measurably, and as
28
29 a descriptor of the state of a person who perceives himself/herself to be
30
31 lacking critical information about the environment, that is, as a perceptual
32
33 phenomenon.

43 Based on Milliken's (1987) classification, we deal with state
44
45 uncertainty and adopt the notion of perceived environmental uncertainty,
46
47 that is, the firms's perceived inability to predict something accurately. Our
48
49 argument is that environmental uncertainty is perceptual in nature, that is, it
50
51 is not unpredictable change *per se* that has implications on alliance
52
53 decisions, but the perception of managers about the likelihood of such
54
55 changes. At the same time, we consider that environmental changes have to
56
57

3 do with three main fields: market, external resources (technology, human
4 resources and so on) and competition.
5
6

8
9 Many researchers have studied the effects of environmental
10 uncertainty on firm alliance strategies (Beckman *et al*, 2004; Burgers *et al*,
11 1993; Dickson and Weaver, 1997; Robertson and Gatignon, 1998; Sarkar *et*
12 *al*, 2001; Steensma *et al*, 2000). According to these studies, the general
13 conclusion is that firms enter into alliances in order to attain flexibility and
14 enable prompt reactions to changes (Child and Faulkner, 1998). The higher
15 the level of environmental uncertainty, the greater the need a firm has to
16 engage in collaboration with other firms. Thus, following these studies, the
17 relationship between this factor and the propensity to alliance formation
18 would be positive.

35 But the decision to ally is also contingent on the internal resource
36 situation of the firm. The most adequate theoretical approaches to
37 understand the role of resources in alliance formation are the resource
38 dependence theory (Pfeffer and Nowak, 1976; Pfeffer and Salancik, 1978)
39 and the resource-based view (Das and Teng, 2000; Dussauge and Garrette,
40 1999; Faulkner and De Rond, 2000). Both theories emphasize the internal
41 resource situation of the firm as the prime driver for alliance formation.
42
43 However, while the former emphasizes internal resource scarcity and the
44 need to survive, the latter puts forward the internal resource capacities and
45 the willingness to generate competitive advantages.

Specifically, the resource dependence theory argues that some firms cannot internally generate all the resources they need. In a resource scarce context, the need for acquiring resources generates weaknesses. A fast and efficient mechanism to overcome these weaknesses is to establish alliances (Park *et al*, 2002). Thus, cooperation is seen as a result of the desire of firms to acquire resources they lack internally but that are necessary for their survival.

Insofar as deficiencies in resources are viewed as driving forces for collaboration, alliance strategies are particularly relevant for resource-poor firms because they sharply experience resource dependency rather than any resource sufficiency (Steensma *et al*, 2000). If a firm controls all the resources it needs, the desire to enter into an alliance will be very low, that is, resource shortages foster support for alliances whilst a situation of resource self-sufficiency ensures a lesser propensity to collaboration. Compared to those resource-rich, resource-poor firms would be more motivated to enter into alliances (Burgers *et al*, 1993) so that the relationship between the probability of a firm engaging in an alliance and the resources it controls would tend to be negative according to the resource dependence theory.

The resource-based view also emphasizes the role of resources to explain inter-firm alliance strategies, but puts things in a different way. Firms are supposed to be well endowed in resources that they want to capitalize on through alliances in order to generate value and reinforce their

3 competitive advantage. The main argument for alliance formation is that
4
5 firms try to leverage their superior resources with complementary resources
6
7 owned by other firms (Stein, 1997). As a result, according to this theory,
8
9 resource-rich firms would tend to be more active in creating alliances,
10
11 unless they control all the needed resources.
12

17 If we combine the theoretical outcomes of both approaches, the
18
19 result will be undetermined. According to the resource dependence theory,
20
21 the relationship between the propensity to ally and the number of resources
22
23 a firm controls would be negative, but the opposite is expected from the
24
25 resource-based approach. Combining environmental uncertainty and firm
26
27 resources in a model with no interaction (model 1), the hypothesis to be
28
29 tested will be the following:

38 *H1 – The probability of a firm entering into an alliance is directly*
39
40 *and positively related to the level of environmental uncertainty it perceives*
41
42 *and depends on the number of resources it controls.*

51 However, our point of view is that this model is not adequate to fully
52
53 explain alliance behavior. The adaptive response of firms to environment is
54
55 conditioned by their internal situations, notably in terms of the resources
56
57 they control, as Park *et al* (2002) also point out. Our main argument is that
58
59 if we want to make full use of the explanatory power of both approaches
60

4 (resource dependence and resource-based views), we have to allow
5
6 interaction between resource conditions and environmental uncertainty. The
7
8 strong propensity of resource-rich (resource-poor) firms to engage in
9
10 alliances predicted by the resource-based view (resource dependence
11
12 theory) may be moderated by perceived environmental conditions,
13
14 according to our line of reasoning. Therefore, a more complex explanation
15
16 is needed and other hypotheses have to be tested in order to understand the
17
18 role that resources and perceived environmental uncertainty interactively
19
20 play in alliance formation (model 2).
21

28 Resources obtained through alliances help firms to overcome
29
30 resource shortages or to take the most from market opportunities. Resource
31
32 shortages are particularly pressing in uncertain environmental contexts and
33
34 market opportunities tend to arise more frequently in stable environmental
35
36 contexts. So, external situation determines the kind of alliance that is more
37
38 probable to occur: an alliance to fill a resource gap or an alliance to enhance
39
40 a resource advantage. Hence, external situation determines also the kind of
41
42 firms that set alliances with a higher probability: resource-poor or resource-
43
44 rich firms, respectively.
45
46

51 The use of the concepts of “exploitation alliance” and “exploration
52
53 alliance” is useful at this point. Park *et al* (2002) define an “exploitation
54
55 alliance” as a pull-oriented alliance, that is, “a need-based alliance to
56
57 sustain a firm’s survival”, and an “exploration alliance” as a push-oriented
58
59 alliance, that is, an alliance “to create new opportunities”. The first type of
60

3 alliance tends to occur more frequently in contexts of high environmental
4
5 uncertainty, when survival is the main objective of firms. When
6
7 environmental uncertainty is not so high, this kind of alliances has a lower
8
9 probability to arise because firms are more interested in taking advantage
10
11 from the environment and the need to survive is less pressing. Alliances of
12
13 the latter type, that is, “exploration alliances” are then more frequent. This
14
15 is to say that the environmental context tends to determine the nature of the
16
17 alliance.
18

24 Hence, environmental uncertainty determines also the type of firm
25
26 more prone to settle alliances. Resource gaps and the need to survive are
27
28 more frequent for resource-poor firms. As a consequence, resource-poor
29
30 firms tend to engage more in alliances when environmental uncertainty is
31
32 high (alliances enhance the short-term viability of these kind of firms) and
33
34 less in relatively stable contexts. This is in accordance with the resource
35
36 dependence theory. So, the hypothesis to test will be,
37

46 *H2 – The probability of a firm entering into an alliance is negatively*
47
48 *related to the number of resources it controls when the level of*
49
50 *environmental uncertainty it perceives is high.*
51

57 Resource advantages and the capability to take advantage from new
58
59 opportunities characterize better resource-rich firms. This situation can not
60

3 be well understood using the resource dependence theory. In order to
4
5 capture windows of opportunity, firms must be strong in internal resources,
6
7 that is, they must be resource-rich, as postulated by the resource-based
8
9 approach. Empirical results also support the view that these firms are more
10
11 able to diversify products and activities (Gourlay and Seaton, 2004),
12
13 creating new chances to ally.
14

20 Environmental opportunities are more probable to arise when
21
22 uncertainty is not very high. As stated by Park *et al* (2002), “in a declining
23
24 market, firms [that is, resource-rich firms] refrain from expanding or
25
26 acquiring new resources, which further reduces opportunities for inter-firm
27
28 collaboration”. Following Park & Russo (1996), they argue that “any
29
30 potential benefits of alliances would be offset by high costs and risks
31
32 involved in setting up and managing strategic alliances”. Hence,

*H3 – The probability of a firm entering into an alliance is positively
related to the number of resources it controls when the level of
environmental uncertainty it perceives is low.*

Summing up, the resource based view and the resource dependence theory have a strong explanation power for the behaviour of firms regarding strategic alliances. However, we contest the possibility of each one of these approaches being tested with models that do not allow for the interaction

3 between the level of environmental uncertainty and the number of resources
4 firms control. Regarding the resource dependence theory, what is surprising
5 is that albeit the importance that resources and uncertainty separately play
6 in the framework, they do not act interactively to explain alliances. If they
7 do, theoretical results would be somewhat different.

17 Thus, the conclusions of our integrative model support both the
18 resource dependence theory and the resource-based view (table 1). The
19 probability of a firm establishing an alliance rises when the number of
20 resources it controls increases if perceived environmental uncertainty is not
21 a serious constraint (the resource-based view). Otherwise, we have an
22 inverse relationship (resource dependence theory).

45 **III. Data, econometric models and results**

46
47
48
49
50

51 The data used in our models were collected through a survey made to a
52 sample of Portuguese firms. The set of firms to be surveyed was selected
53 from an official database (Base Belém) published by the Portuguese
54 Statistical Institute (INE), containing the largest 10.000 Portuguese firms.
55
56
57
58
59
60 In order to select the firms to be inquired, we used as criteria the sub-sector

3 of activity and the size of the firm. Concretely, we selected only firms
4
5 belonging to 29 industrial sub-sectors and, within each sub-sector, the 50%
6
7 largest ones. The number of firms enquired was 2751 and the number of
8
9 respondent firms with complete data for estimation purposes was 310, of
10
11 which 83 correspond to effective alliances.
12
13

15
16 The survey was put in place at the end of 1999 and was directed to
17
18 the CEOs of the firms. Questions included the following categories: a)
19
20 general information (sector of activity, size of the firm, year of
21
22 establishment, R&D activities, level of internationalization); b) evaluation
23
24 of the environmental context (market, technology and competition
25
26 constraints); c) establishment of alliances with other firms during 1995-
27
28 1999 and data related to them (main objective, number and nationality of
29
30 partners, type of alliance).
31

37 In cases with no alliance, all data are for 1997. For firms with only
38
39 one alliance created in the period 1995-1999, the data are for the year of the
40
41 alliance. When two or more alliances were created in this period, we asked
42
43 the CEOs to consider only the first one and to report all the relevant data for
44
45 the year of the establishment of this alliance.
46

51 Table 2 shows descriptive statistics and the correlation matrix for the
52
53 explanatory variables used in the econometric analysis.

6 The probability of alliance formation is modeled as:

33 where *PEU* (perceived environmental uncertainty) and *NRES* (number of
34 resources the focal firm controls) are the main variables, and *AGE* (age of
35 the focal firm, in years), *SIZE* (size of the focal firm measured by number
36 of employees), and *EFF* (efficiency of the focal firm measured by the ratio
37 sales turnover / number of employees) are control variables. In both cases, a
38 *logit* specification was adopted.

49 Before presenting the results of the two models, a more accurate
50 explanation and justification of the independent variables are needed.
51
52

53
54 As regards *PEU*, we have taken into account that our sample mainly
55 includes SMEs, though they are among the biggest Portuguese firms.
56
57 Although this kind of firm may be just as sensitive to many types of
58
59
60

4 uncertainty as any other company, we expect their engagement in alliances
5
6 to be especially sensitive to particular sources of uncertainty. So and
7
8 following Burgers *et al* (1993), Dickson and Weaver (1997) and Sarkar *et*
9
10 *al* (2001), we have considered technology, market and competition
11
12 constraints as relevant sources of uncertainty for our sample of firms.
13
14

15
16
17 Technological complexity and volatility and increasing technological
18
19 development costs threaten the relevance of existing competencies making
20
21 alliances a source of advantages in the process of getting new technological
22
23 knowledge. In the same way, demand uncertainty has been found to
24
25 influence investment (Caselli *et al*, 2003; Price, 1996). In turbulent markets
26
27 where customer needs evolve rapidly, collaboration helps firms to develop
28
29 new products and services that satisfy emerging consumer needs and
30
31 enhances their capacity to enter new markets and segments. As regards
32
33 competition constraints, in rapidly changing competitive environments
34
35 firms never know in advance whether or not their actions will invite
36
37 retaliation or which moves by competitive rivals will bear a direct impact
38
39 upon them (Burgers *et al*, 1993). In this situation, firms can improve their
40
41 positions by creating new networks with new partners or maintain them by
42
43 reinforcing existing relationships through additional alliances in order to
44
45 increase entry barriers and reduce the level of competitive intensity (Sarkar
46
47 *et al*, 2001).

58 Therefore, and in order to test the influence of environmental
59
60 constraints on the propensity of firms to engage into alliances, we have used

1
2
3 a composed variable including items related to technology, demand and
4
5
6 competition indicators. Each of these three items was expressed in a five-
7
8
9 point response scale in order to assess manager perception of environmental
10
11 constraints. Specifically, we asked CEOs to respond to what extent 1) the
12
13 pace and complexity of contemporary technological developments, 2)
14
15 consumer behavior and 3) the behavior of competitors, are constraining
16
17 factors in the development of firm strategy. Then, for each firm we have
18
19 calculated the simple average of the three results, thus obtaining a scale of
20
21
22
23
24 1 to 5 for our composite variable.
25
26

27
28 In order to evaluate the extent to which resources controlled by the
29
30 firm are important for engagement in alliance strategies, we have
31
32 considered five critical resources: the existence of R&D activities in the
33
34 focal firm, access to technology and general know-how, experience in
35
36 internationalization processes, access to financial resources and access to a
37
38 specialized work-force. The first item was objectively measured (the firm
39
40 develops or not R&D activities) and for the latter four we have used five-
41
42 point scale perceived measures. For each of these latter four items, we
43
44 calculated the simple average of all responses at the sector level, in order to
45
46 take into consideration sectoral specificities. Accordingly, we considered as
47
48 weak those cases with worst situations than the sector average and as strong
49
50 all other cases. The variable measuring resource strength was then
51
52 graduated from 0 (the focal firm is weak in all items) to 5 (the focal firm is
53
54 strong in all items).

3 While our explanatory variable NRES measures internal resources,
4 the variable PEU is linked to external conditions. As we can see in table 2,
5 the correlation coefficient between these two variables is negative and equal
6 to -0.32.

12 The choice of control variables (*AGE*, *SIZE* and *EFF*) aims to
13 incorporate into the models the variables most often used in other studies².
14 We do not expect specific results for these variables because the extant
15 literature is not consensual in this field.

20 Summing up, the two models differ, not in their original explanatory
21 variables (exactly the same in both models) but in the way they combine to
22 produce results and test hypotheses. In model 1, no interaction between
23 independent variables is assumed. In model 2, we let perceived
24 environmental uncertainty and the number of resources interact and we
25 admit a non-linear relationship between the probability of alliance
26 formation and each of these independent variables.

43 Our expectation is that model 1 will produce increasing probabilities
44 of alliance formation with the increase of *PEU* (hypothesis *H1*). As regards
45 model 2, and having in mind *H2* and *H3*, our expectation is that the
46 probability of alliance formation will increase with the rise in *PEU* (*NRES*)
47 for low levels of *NRES* (*PEU*) and decreases with *PEU* (*NRES*) for high
48 levels of *NRES* (*PEU*).

3 Results of model 1 support *H1* (table 3). The coefficient of *PEU* is
4 positive and statistically significant. Regarding the variable *NRES* we see
5 that the coefficient is also positive and statistically significant. This means
6 that the probability of a firm entering into an alliance increases with the
7 level of environmental uncertainty it perceives and the number of resources
8 it controls.

19 The probability of alliance formation for all levels of *PEU* and *NRES*
20 can be calculated using the results of model 1 (table 4). With a level 1 of
21 perceived environmental uncertainty, the probability of a firm entering into
22 an alliance when it controls none of the included resources is 1.45%. The
23 probability rises to 88.9% when we consider a firm that controls all the five
24 resources considered and has a level 5 of perceived environmental
25 uncertainty.

38 In general, the results are in accordance with the predictions of the
39 resource-based view, independent of the level of perceived environmental
40 uncertainty. However, we can see that low levels of environmental
41 uncertainty produce lower probabilities of alliance formation, regardless of
42 the number of resources the firm controls. This already serves as a first
43 indication that environmental conditions matter in the behavior of firms.

Results of model 2 also corroborate our expectations (table 3). All the estimated coefficients for the main variables are statistically significant. In particular, we obtained negative estimates for the coefficients of *PEU*-squared and *NRES*-squared, indicating an inverted U-shaped relationship between the probability of alliance formation and the level of perceived environmental uncertainty, on the one hand, and this probability and the number of resources, on the other. This means that alliance events seem to be more common for conjointly intermediate values of these variables than for the conjointly extreme values. The interaction term is also significant indicating strong crossed effects of the two explanatory variables on the probabilities of alliance formation.

Both in models 1 and 2, the high value of the likelihood ratio (LR) rejects the hypothesis of joint exclusion of all the explanatory variables. Furthermore, the joint exclusion of the additional variables in model 2 is clearly rejected by the data (the value of the LR test statistic is 27.0, quite above the critical value of 7.81 corresponding to a $\chi^2_{(3;0.05)}$), thus giving a clear preference for this model when we confront it with model 1.

The estimated probabilities (table 5) show that for the first three levels of perceived environmental uncertainty, the probability of alliance formation increases with the number of resources in accordance with the resource-based view. Conversely, for the highest levels of that variable, the probability of an alliance event tends to decrease with the number of

3 resources controlled by the firm. Thus, as expected, the resource-based
4
5 view holds for low levels of environmental uncertainty and the resource
6
7 dependence theory can be applied when firms face sharply adverse external
8
9 conditions.

17 **IV. Conclusions**

23 The resource dependence theory and the resource-based view both
24
25 emphasize the role of internal resource conditions on inter-firm alliance
26
27 formation. The first one is more appropriate to explain cooperation
28
29 involving resource-poor firms while the latter is more adequate to
30
31 understand alliances between resource-rich ones. The main contribution of
32
33 this article is to show that these results are contingent on environmental
34
35 uncertainty perceived by firms. So, we let resource conditions and
36
37 perceived environmental uncertainty interact in order to fully assess their
38
39 impact on the probability of firms to engage in alliances.

47 We have argued that for high levels of perceived environmental
48
49 uncertainty, resource-rich firms are not predisposed to collaborate because
50
51 the costs of collaboration are greater than the potential benefits. Despite of
52
53 also suffering from high collaboration costs, resource-poor firms have no
54
55 viable alternative and prefer to support the costs of collaboration rather than
56
57 perish. Hence, volatile environmental conditions are more prone for the
58

3 establishment of alliances involving resource-poor firms than that involving
4
5 resource-rich ones.

9 Even if environmental conditions are not particularly constraining,
10
11 firms may still experience a high desire to collaborate. However, the
12
13 resource-poor encounter difficulty in finding potential partners because they
14
15 have no relevant resources to share. This makes the cost of collaboration
16
17 very high because partners can impose unacceptable conditions in a context
18
19 where the survival of the firm is not threatened. These firms then show a
20
21 low propensity to ally. On the contrary, resource-rich firms are interesting
22
23 partners in a context where the benefits of allying exceed the costs.
24
25 Therefore, for low levels of environmental uncertainty, alliances are mainly
26
27 developed by this kind of firms and “exploration” alliances are particularly
28
29 relevant in this context.

37 Our empirical results support the theoretical arguments. Confronting
38
39 the estimates obtained with models 1 and 2, the data give a clear preference
40
41 to the model with interaction between resources and environmental
42
43 uncertainty. That is, the impact of resources on alliance activity is
44
45 moderated by perceived uncertainty. In fact, table 5 shows that, for high
46
47 levels of environmental uncertainty, the probability of alliance formation
48
49 tends to be negatively related to the number of resources a firm controls, a
50
51 result that is in accordance with our hypothesis *H2*. For low levels of
52
53 uncertainty, the probability of alliances increases with the number of
54
55 resources, in line with our hypothesis *H3*.

These results contrast with those of Park *et al* (2002), although they work with a different concept of uncertainty and use only star-up firms in the semiconductor industry. In our case, we used data concerning 29 industrial sub-sectors. Sectoral specificities are partially taken into account by the way we defined the resources variable. It would be interesting to further differentiate between sectors and also particular types of alliances. However, the limited number of alliances in our database does not allow us to exploit this type of analysis.

So, the main conclusion of this paper is that the resource-based view holds for low levels of perceived environmental uncertainty whilst the resource dependence theory fits better to severe adverse conditions. Our interpretation is that, in the first case, alliances are mainly explained by the capacity to find partners, that is, by the availability of internal resources. In the second case, they are activated by a lack of resources and the fear of bankruptcy within a context of great environmental uncertainty.
