# Existence, blow-up and exponential decay estimates for a nonlinear wave equation with boundary conditions of two-point type

#### Abstract

This paper is devoted to studying a nonlinear wave equation with boundary conditions of two-point type. First, we state two local existence theorems and under the suitable conditions, we prove that any weak solutions with negative initial energy will blow up in finite time. Next, we give a sufficient condition to guarantee the global existence and exponential decay of weak solutions. Finally, we present numerical results.

## 1 Introduction

In this paper, we consider the following nonlinear wave equation with initial conditions and boundary conditions of two-point type

-u_{x}(1, t)=-|u(1, t)|^{\beta-2} u(1, t)+\lambda_{1} u_{t}(1, t)+\widetilde{h}_{0}(t) u(0, t)+\widetilde{\lambda}_{0} u_{t}(0, t), t>0,  \tag{1.3}\\

where $\lambda_{0}, \lambda_{1}, \widetilde{\lambda}_{0}, \widetilde{\lambda}_{1}, \lambda, p$ are constants and $u_{0}, u_{1}, \widetilde{h}_{0}, \widetilde{h}_{1}$ are given functions satisfying conditions specified later.

The wave equation

with the different boundary conditions, has been extensively studied by many authors, see ( [1] , [2], [6] $-[20])$ and references therein. In these works, many interesting results about the existence, regularity and the asymptotic behavior of solutions were obtained.

In [16], J.E. Munoz-Rivera and D. Andrade dealt with the global existence and exponential decay of solutions of the nonlinear one-dimensional wave equation with a viscoelastic boundary condition.

In [17] - [19], Santos also studied the asymptotic behavior of solutions to a coupled system of wave equations having integral convolutions as memory terms. The main results show that solutions of that system decay uniformly in time, with rates depending on the rate of decay of the kernel of the convolutions.

In [20], the global existence and regularity of weak solutions for the linear wave equation

with the initial conditions as in (1.4) and the two-point boundary conditions

were proved, where $h_{0}, h_{1}, \widetilde{h}_{0}, \widetilde{h}_{1}, \lambda_{0}, \lambda_{1}, \widetilde{\lambda}_{0}, \widetilde{\lambda}_{1}, K, \lambda$ are constants and $u_{0}, u_{1}, g_{0}, g_{1}, f$ are given functions. Furthermore, the exponential decay of solutions were also given there by using Lyapunov's method.

We note more that, the following nonhomogeneous boundary conditions were considered by Hellwig (3), p.151):

where $\alpha_{i j}, \beta_{i j}, i=0,1, j=1,2,3$ are constants and $f_{0}(t), f_{1}(t)$ are given functions.
Let $\Delta=\alpha_{02} \beta_{12}-\alpha_{12} \beta_{02} \neq 0,(1.8)$ is transformed into

The main goal of this paper is to extend some results of [20]. Motivated by the problem of the exponential decay of solutions for (1.6) - (1.7), we establish a blow up result and a decay result for the general problem (1.1) - (1.4).

In Theorem 3.1, by applying techniques as in (14 with some necessary modifications and with some restrictions on the initial data, we prove that the solution of (1.1) - (1.4) blows up in finite time.

In Theorem 4.1, by the construction of a suitable Lyapunov functional we also prove that the solution will exponential decay if the initial energy is positive and small.

The paper consists of five sections. In Section 2, we present some preliminaries and the existence results. The proofs of Theorems 3.1 and 4.1 are done in Sections 3 and 4. Finally, in Section 5 we give numerical results.

## 2 Existence and uniqueness of solution

First, we put $\Omega=(0,1) ; Q_{T}=\Omega \times(0, T), T>0$ and we denote the usual function spaces used in this paper by the notations $C^{m}(\bar{\Omega}), W^{m, p}=W^{m, p}(\Omega), L^{p}=W^{0, p}(\Omega), H^{m}=W^{m, 2}(\Omega)$, $1 \leq p \leq \infty, m=0,1, \ldots$ Let $\langle\cdot, \cdot\rangle$ be either the scalar product in $L^{2}$ or the dual pairing of a continuous linear functional and an element of a function space. The notation $\|\cdot\|$ stands for the norm in $L^{2}$ and we denote by $\|\cdot\|_{X}$ the norm in the Banach space $X$. We call $X^{\prime}$ the dual space of $X$. We denote by $L^{p}(0, T ; X), 1 \leq p \leq \infty$ for the Banach space of the real functions $u:(0, T) \rightarrow X$ measurable, such that

Let $u(t), u^{\prime}(t)=u_{t}(t), u^{\prime \prime}(t)=u_{t t}(t), u_{x}(t), u_{x x}(t)$ denote $u(x, t), \frac{\partial u}{\partial t}(x, t), \frac{\partial^{2} u}{\partial t^{2}}(x, t), \frac{\partial u}{\partial x}(x, t)$, $\frac{\partial^{2} u}{\partial x^{2}}(x, t)$, respectively.

On $H^{1}$, we use the following norm $\|v\|_{1}=\left(\|v\|^{2}+\left\|v_{x}\right\|^{2}\right)^{1 / 2}$.
We have the following lemmas.
Lemma 2.1. $\|v\|_{C^{0}([0,1])} \leq \sqrt{2}\|v\|_{1}$, for all $v \in H^{1}$.
Lemma 2.2. Let $\lambda_{0}, \lambda_{1}>0$ and $\widetilde{\lambda}_{0}, \widetilde{\lambda}_{1} \in \mathbb{R}$, such that $\left|\widetilde{\lambda}_{0}+\widetilde{\lambda}_{1}\right|<2 \sqrt{\lambda_{0} \lambda_{1}}$. Then

The proofs of these lemmas are straightforward. We shall omit the details
Next, we state two local existence theorems. We make the following assumptions:
Suppose that $p, \alpha, \beta, \lambda, \lambda_{0}, \lambda_{1}, \widetilde{\lambda}_{0}, \widetilde{\lambda}_{1} \in \mathbb{R}$, are constants satisfying

Theorem 2.3. Suppose that $\left(A_{1}\right)-\left(A_{3}\right)$ hold and the initial data $\left(u_{0}, u_{1}\right) \in H^{2} \times H^{1}$ satisfies the compatibility conditions

## Remark 2.1.

The regularity obtained by (2.4) shows that problem (1.1) - (1.4) has a unique strong solution

With less regular initial data, we obtain the following theorem about the existence of a weak solution.

Then problem (1.1) - (1.4) has a unique local solution

## Proof of Theorem 2.3.

The proof is established by a combination of the arguments in 20. It consits of steps $1-4$.
Step 1. The Faedo-Galerkin approximation. Let $\left\{w_{j}\right\}$ be a denumerable base of $H^{1}$. We find the approximate solution of the problem (1.1) - (1.4) in the form

From the assumptions of Theorem 2.3, system (2.8) has a solution $u_{m}$ on an interval $\left[0, T_{m}\right] \subset[0, T]$.
Step 2. The first estimate. Multiplying the $j^{t h}$ equation of (2.8) by $c_{m j}^{\prime}(t)$ and summing up with respect to $j$, afterwards, integrating by parts with respect to the time variable from 0 to $t$, after some rearrangements and using Lemma 2.2, we get

Applying the classical inequalities, we estimate the terms on the right-hand side of (2.9) and obtain

Then, by solving a nonlinear Volterra integral equation (based on the methods in (T) ) , we get the following lemma.

Lemma 2.5. There exists a constant $T_{*}>0$ depending on $T$ (independent of $m$ ) such that

## The second estimate.

First of all, we estimate $u_{m}^{\prime \prime}(0)$. By taking $t=0$ and $w_{j}=u_{m}^{\prime \prime}(0)$ in (??), we assert

& \frac{d}{d t}\left\langle u^{\prime}(t), v\right\rangle+\left\langle u_{x}(t), v_{x}\right\rangle+\langle u(t), v\rangle+\lambda\left\langle u^{\prime}(t), v\right\rangle  \tag{2.51}\\
&+\left(\lambda_{0} u^{\prime}(0, t)+\widetilde{h}_{1}(t) u(1, t)+\widetilde{\lambda}_{1} u^{\prime}(1, t)\right) v(0) \\
&+\left(\lambda_{1} u^{\prime}(1, t)+\widetilde{h}_{0}(t) u(0, t)+\widetilde{\lambda}_{0} u^{\prime}(0, t)\right) v(1) \\
&\left.=\left.\langle | u\right|^{p-2} u, v\right\rangle+|u(0, t)|^{\alpha-2} u(0, t) v(0)+|u(1, t)|^{\beta-2} u(1, t) v(1), \text { for all } v \in H^{1}, \\
& u(0)=u_{0}, u^{\prime}(0)=u_{1} .
\end{align*}\right.
$$

Next, the uniqueness of a weak solution is obtained by using the well-known regularization procedure due to Lions. See for example Ngoc et al. 15].

Theorem 2.4 is proved completely.
Remark 2.2. In case $1<p, \alpha, \beta \leq 2$, and $\widetilde{h}_{0}, \widetilde{h}_{1} \in L^{\infty}(0, T),\left(u_{0}, u_{1}\right) \in H^{1} \times L^{2}$, the integral inequality (??) leads to the following global estimation

However, in case $1<p, \alpha, \beta<2$, we do not imply that a weak solution obtained here belongs to $C\left([0, T] ; H^{1}\right) \cap C^{1}\left([0, T] ; L^{2}\right)$. Furthermore, the uniqueness of a weak solution is also not asserted.

## 3 Finite time blow up

In this section we show that the solution of problem (1.1) - (1.4) blows up in finite time if $\widetilde{\lambda}_{0}=\widetilde{\lambda}_{1}=\widetilde{\lambda}$, with $|\widetilde{\lambda}|<\sqrt{\lambda_{0} \lambda_{1}}$, and

-H(0)=\frac{1}{2}\left\|u_{1}\right\|^{2}+\frac{1}{2}\left\|u_{0}\right\|_{1}^{2}-\frac{1}{p}\left\|u_{0}\right\|_{L^{p}}^{p}-\frac{1}{\alpha}\left|u_{0}(0)\right|^{\alpha}-\frac{1}{\beta}\left|u_{0}(1)\right|^{\beta}+\widetilde{h} u_{0}(0) u_{0}(1)<0 \tag{3.1}
\end{equation*}
$$

First, in order to obtain the blow up result, we make the following assumptions

& \left(A_{2}^{\prime}\right) \widetilde{\lambda}_{0}=\widetilde{\lambda}_{1}=\widetilde{\lambda}, \text { with }|\widetilde{\lambda}|<\sqrt{\lambda_{0} \lambda_{1}} \\
& \left(A_{3}^{\prime}\right) \widetilde{h}_{0}(t)=\widetilde{h}_{1}(t)=\widetilde{h}, \text { where } \widetilde{h} \text { is a constant satisfies }|\widetilde{h}|<\frac{q-2}{4(q+2)}, q=\min \{p, \alpha, \beta\}
\end{aligned}
$$

Then we obtain the theorem.
Theorem 3.1. Let the assumptions $\left(A_{1}\right),\left(A_{2}^{\prime}\right),\left(A_{3}^{\prime}\right)$ hold and $H(0)>0$. Then, for any $\left(u_{0}, u_{1}\right) \in$ $H^{1} \times L^{2}$, the solution $u$ of problem (1.1) - (1.4) blows up in finite time.

Proof. We denote by $E(t)$ the energy associated to the solution $u$, defined by

On the other hand, by multiplying (1.1) by $u^{\prime}(x, t)$ and integrating over $[0,1]$, we get

$\lambda_{0}\left|u^{\prime}(0, t)\right|^{2}+\lambda_{1}\left|u^{\prime}(1, t)\right|^{2}+2 \widetilde{\lambda} u^{\prime}(0, t) u^{\prime}(1, t) \geq \frac{1}{2} \mu_{*}\left(\left|u^{\prime}(0, t)\right|^{2}+\left|u^{\prime}(1, t)\right|^{2}\right), \forall t \in\left[0, T_{*}\right)$,
where

\mu_{*}=\left(\lambda_{0} \lambda_{1}-\widetilde{\lambda}^{2}\right) \min \left\{\frac{1}{\lambda_{0}}, \frac{1}{\lambda_{1}}\right\}>0 . \tag{3.7}

Hence, we can deduce from (3.5), (3.6) and $H(0)>0$ that

\end{equation*}

Now, we define the functional

\end{equation*}

for $\varepsilon$ small enough and

0<\eta \leq \frac{p-2}{2 p}<\frac{1}{2} . \tag{3.11}
\end{equation*}
$$

Lemma 3.2. There exists a constant $d_{1}>0$ such that

& -\varepsilon\|u(t)\|_{1}^{2}-2 \varepsilon \widetilde{h} u(0, t) u(1, t) .

Since (3.5), (3.14) and the following inequality

& -\varepsilon(1+4|\widetilde{h}|)\|u(t)\|_{1}^{2} .
\end{align*}

On the other hand, it follows from (3.8) and the following inequality

\end{equation*}

where $q=\min \{p, \alpha, \beta\}$.
Combining (3.16) and (3.18), we have

& \left.\quad+|u(0, t)|^{2 /(1-\eta)}+|u(1, t)|^{2 /(1-\eta)}+|u(0, t) u(1, t)|^{1 /(1-\eta)}\right)  \tag{3.24}\\
& \leq \operatorname{Const}\left(H(t)+\left|\left\langle u(t), u^{\prime}(t)\right\rangle\right|^{1 /(1-\eta)}+|u(0, t)|^{2 /(1-\eta)}+|u(1, t)|^{2 /(1-\eta)}+\|u(t)\|_{L^{p}}^{2 /(1-\eta)}\right)
\end{align*}
$$

On the other hand, by using the Young's inequality

\left|\left\langle u(t), u^{\prime}(t)\right\rangle\right|^{1 /(1-\eta)} & \leq\|u(t)\|^{1 /(1-\eta)}\left\|u^{\prime}(t)\right\|^{1 /(1-\eta)} \\
& \leq \text { Const }\|u(t)\|_{L^{p}}^{1 /(1-\eta)}\left\|u^{\prime}(t)\right\|^{1 /(1-\eta)}  \tag{3.25}\\
& \leq \text { Const }\left(\|u(t)\|_{L^{p}}^{s}+\left\|u^{\prime}(t)\right\|^{2}\right)
\end{align*}
$$

where $s=2 /(1-2 \eta) \leq p$ by (3.11).
Now, we need the following lemma.
Lemma 3.3. Let $2 \leq r_{1} \leq p, 2 \leq r_{2} \leq \alpha, 2 \leq r_{3} \leq \beta$, we have

By $2 \leq r_{2} \leq \alpha$, we have

## 4 Exponential decay

In this section we show that each solution $u$ of (1.1) - (1.4) is global and exponential decay provided that $I(0)=\left\|u_{0}\right\|_{1}^{2}-\left\|u_{0}\right\|_{L^{p}}^{p}-\left|u_{0}(0)\right|^{\alpha}-\left|u_{0}(1)\right|^{\beta}>0$ and $E(0)$ is small enough.

First, we construct the following Lyapunov functional

where $\delta>0$ is chosen later and

\end{equation*}
$$

Put

I(t)=I(u(t))=\|u(t)\|_{1}^{2}-\|u(t)\|_{L^{p}}^{p}-|u(0, t)|^{\alpha}-|u(1, t)|^{\beta} . \tag{4.3}
\end{equation*}

We make the following assumption
$\left(A_{3}^{\prime \prime}\right) \widetilde{h}_{i} \in L^{\infty}\left(\mathbb{R}_{+}\right) \cap L^{2}\left(\mathbb{R}_{+}\right), i=1,2$.
Then we have the following theorem.
Theorem 4.1. Assume that $\left(A_{1}\right),\left(A_{2}\right),\left(A_{3}^{\prime \prime}\right)$ hold. Let $I(0)>0$ and the initial energy $E(0)$ satisfies

with $q=\min \{p, \alpha, \beta\}$, and

r=\exp \left[\frac{4 q}{\mu_{*}(q-2)}\left(\left\|\widetilde{h}_{0}\right\|_{L^{2}\left(\mathbb{R}_{+}\right)}^{2}+\left\|\widetilde{h}_{1}\right\|_{L^{2}\left(\mathbb{R}_{+}\right)}^{2}\right)\right] \tag{4.5}
\end{equation*}
$$

and $C_{p}$ is a constant verifying the inequality $\|v\|_{L^{p}} \leq C_{p}\|v\|_{1}$, for all $v \in H^{1}$.
Then, there exist positive constants $C, \gamma$ such that, for $\left\|\widetilde{h}_{0}\right\|_{L^{2}\left(\mathbb{R}_{+}\right)},\left\|\widetilde{h}_{1}\right\|_{L^{2}\left(\mathbb{R}_{+}\right)}$sufficiently small, we have

E(t) \leq C \exp (-\gamma t), \text { for all } t \geq 0 \tag{4.6}
\end{equation*}
$$

## Proof.

First, we need the following lemmas
Lemma 4.2. The energy functional $E(t)$ satisfies

Proof of Lemma 4.2. Multiplying (1.1) by $u^{\prime}(x, t)$ and integrating over $[0,1]$, we get

& -\widetilde{h}_{0}(t) u(0, t) u^{\prime}(1, t)-\widetilde{h}_{1}(t) u(1, t) u^{\prime}(0, t)
\end{align*}
$$

Again, by lemma 2.2, we have

\lambda_{0}\left|u^{\prime}(0, t)\right|^{2}+\lambda_{1}\left|u^{\prime}(1, t)\right|^{2}+\left(\widetilde{\lambda}_{0}+\widetilde{\lambda}_{1}\right) u^{\prime}(0, t) u^{\prime}(1, t)  \tag{4.9}\\
\geq \frac{1}{2} \mu_{*}\left[\left|u^{\prime}(0, t)\right|^{2}+\left|u^{\prime}(1, t)\right|^{2}\right] .
\end{array}
$$

On the other hand

Now, we put $T_{*}=\sup \{T>0: I(u(t))>0, \forall t \in[0, T]\}$. If $T_{*}<+\infty$ then, by the continuity of $I(t)$, we have $I\left(T_{*}\right) \geq 0$. By the same arguments as in above part we can deduce that there exists $T_{2}>T_{*}$ such that $I(t)>0, \forall t \in\left[0, T_{2}\right]$. Hence, we conclude that $I(t)>0, \forall t \geq 0$.

Lemma 4.3 is proved completely.

The exact solution of the problem (5.1) - (5.3) with $\widetilde{u}_{0}, \widetilde{u}_{1}, \widetilde{h}_{0}, \widetilde{h}_{1}, g_{0}, g_{1}$ and $f$ defined in (5.4) respectively, is the function $U_{e x}$ given by

To solve the nonlinear differential system (5.6), we use the following linear recursive scheme gen-
erated by the nonlinear terms

To solve the linear differential system (5.10), we use a spectral method with a time step $\Delta t=0.08$
and a spacial step $\Delta x=0.1$

In fig. 1 we have drawn the approximated solution of the problem (5.1) - (5.3) while fig. 2 represents his corresponding exact solution (5.5). So in both cases we notice the very good decay of these surfaces from $T=0$ to $T=5$.
