# Lieb-Thirring inequalities for radial magnetic bottles in the disk 

Françoise Truc*

#### Abstract

We consider a Schrödinger operator $H$ with a magnetic field and Dirichlet boundary conditions on the unit disk. We assume growth conditions on the magnetic field near the boundary which guarantee compactness of the resolvent of this operator. Under some assumptions on an additional potential $V$ the operator $H+V$ has a discrete negative spectrum and we prove a Lieb-Thirring inequality on these negative eigenvalues if moreover the magnetic field and the potential are assumed to be radially symmetric.


## 1 Introduction

Let us consider a particle in a domain $\Omega$ in $\mathbb{R}^{2}$ in the presence of a magnetic field $B$. We define the 2-dimensional magnetic Laplacian associated to this particle as follows:

Let $A$ a magnetic potential associated to $B$; it means that $A$ is a smooth real one-form on $\Omega \subset \mathbb{R}^{2}$, given by $A=\sum_{j=1}^{2} a_{j} d x_{j}$, and that the magnetic field $B$ is the two-form $B=d A$. We have $B(x)=\mathbf{b}(x) d x_{1} \wedge d x_{2}$ with $\mathbf{b}(x)=$ $\partial_{1} a_{2}(x)-\partial_{2} a_{1}(x)$. The magnetic connection $\nabla=\left(\nabla_{j}\right)$ is the differential operator defined by

$$
\nabla_{j}=\frac{\partial}{\partial x_{j}}-i a_{j} .
$$

The 2-dimensional magnetic Schrödinger operator $H_{A}$ is defined by

$$
H_{A}=-\sum_{j=1}^{2} \nabla_{j}^{2}
$$

[^0]The magnetic Dirichlet integral $h_{A}=\left\langle H_{A} . \mid.\right\rangle$ is given, for $u \in C_{0}^{\infty}(\Omega)$, by

$$
\begin{equation*}
h_{A}(u)=\int_{\Omega} \sum_{j=1}^{2}\left|\nabla_{j} u\right|^{2}|d x| . \tag{1.1}
\end{equation*}
$$

From the previous definitions and the fact that the formal adjoint of $\nabla_{j}$ is $-\nabla_{j}$, it is clear that the operator $H_{A}$ is symmetric on $C_{0}^{\infty}(\Omega)$.

In [⿴囗 dimension 2 is the following

Theorem 1.1 Assume that $\partial \Omega$ is compact and that $B(x)$ satisfies near $\partial \Omega$

$$
\begin{equation*}
\mathbf{b}(x) \geq(D(x))^{-2} \tag{1.2}
\end{equation*}
$$

then the Schrödinger operator $H_{A}$ is essentially self-adjoint. $(D(x)$ denotes the distance to the boundary). This still holds true for any gauge $A^{\prime}$ such that $d A^{\prime}=$ $d A=B$.

We have, using Cauchy-Schwarz inequality,

$$
|\langle\mathbf{b}(x) u, u\rangle|=\left|\left\langle\left[\nabla_{1}, \nabla_{2}\right] u, u\right\rangle\right| \leq\left\|\nabla_{1} u\right\|^{2}+\left\|\nabla_{2} u\right\|^{2} \quad u \in C_{o}^{\infty}(\Omega) .
$$

This gives the well-known lower bound

$$
\begin{equation*}
\forall u \in C_{o}^{\infty}(\Omega), h_{A}(u) \geq\left.\left|\int_{\Omega} \mathbf{b}(x)\right| u\right|^{2}|d x| \mid \tag{1.3}
\end{equation*}
$$

In this paper, we do not use the conditions (1.2) but we assume nevertheless that $\mathbf{b}(\mathbf{x})$ grows to infinity as $x$ approaches the boundary. The operator $H_{A}^{D}$ defined by Friedrich's extension of the quadratic form $h_{A}$ has a compact resolvent. We call such an operator a magnetic bottle, by similarity with magnetic bottles in the whole space ( [1] , [3] , 20]). We add a suitable negative potential in order to have a discrete negative spectrum and we address the question of the existence of Lieb-Thirring inequalities ( [16], [14]) in the radially symmetric case.

## 2 Inequalities: the main results

Consider a magnetic field $B=\mathbf{b}(x) d x_{1} \wedge d x_{2}$ on the unit disk $\Omega=\{x=$ $\left.\left(x_{1}, x_{2}\right) \in \mathbb{R}^{2} \mid x_{1}^{2}+x_{2}^{2}=r^{2}<1\right\}$ so that

- ( $H_{1}$ ) $\quad \mathbf{b}(x)>0 \quad \forall x \in \Omega$ and $\mathbf{b}(x) \rightarrow+\infty$ as $D(x) \rightarrow 0$ (i.e as $x$ approaches the boundary.)

Then we deduce from inequality (1.3) that for any gauge $A$ associated to $B$, the operator $H_{A}^{D}$ has a compact resolvent. Consider a potential $V$ so that

- ( $H_{2}$ ) $\quad V \in L^{1}(\Omega), V$ radial and non negative, and such that the negative spectrum of $H_{A}^{D}-V$ is discrete (for example $V$ bounded from above),
where $H_{A}^{D}-V$ denotes the operator defined by Friedrich's extension of the quadratic form $h_{A}-V$. We are interested in the number $N(A, V)$ of negative eigenvalues of the operator $H_{A}^{D}-V$. Then, with the additional assumption that
- $\left(H_{3}\right) \quad B$ is radially symmetric,
we prove the following
Theorem 2.1 If assumptions $\left(H_{1}\right)\left(H_{2}\right)\left(H_{3}\right)$ are verified and if moreover

$$
\begin{equation*}
\mathbf{b}(x) \leq(D(x))^{-\beta}, \quad \beta<\frac{3}{2} \tag{2.1}
\end{equation*}
$$

then

$$
N(A, V) \leq \frac{1}{2 \sqrt{1-\alpha}} \int_{[0,1[ }\left[\left(\frac{1}{\alpha}-1\right) A^{2}(r)+V(r)\right] r d r
$$

for any $\alpha \in] 0,1[$ and any radial gauge $A$ associated to $B$.
Noticing that for any $\lambda>0$ the constant potential $V(x)=\lambda$ is in $L^{1}(\Omega)$, and that $N(A, \lambda)$ denotes the number of eigenvalues of the operator $H_{A}^{D}$ less than $\lambda$, we get the
Corollary 2.2 If assumptions $\left(H_{1}\right)$ and $\left(H_{3}\right)$ are verified and if moreover

$$
\begin{equation*}
\mathbf{b}(x) \leq(D(x))^{-\beta}, \quad \beta<\frac{3}{2} \tag{2.2}
\end{equation*}
$$

then the number of eigenvalues of the operator $H_{A}^{D}$ less than $\lambda$ satisfies the following inequality

$$
\begin{equation*}
N(A, \lambda) \leq \frac{\lambda}{4 \sqrt{1-\alpha}}+\frac{\sqrt{1-\alpha}}{2 \alpha} \int_{[0,1[ } r A^{2}(r) d r \tag{2.3}
\end{equation*}
$$

for any $\alpha \in] 0,1[$ and any radial gauge $A$ associated to $B$.

Remark 2.3 The minimum of the righthandside is obtained by choosing the radial gauge $A_{\beta}$ so that $\int_{0}^{1} A_{\beta}(r) r d r=0$, and then by taking $\alpha_{\lambda}=\frac{-6 I+\sqrt{I^{2}+4 I \lambda}}{\lambda-2 I}$ with $I:=\int_{[0,1[ } r A_{\beta}^{2}(r) d r$.

Remark 2.4 The inequality of Theorem 2.1 is a "magnetic" version of the Cwikel-Lieb-Rosenblum inequality [3] [15] [17]. CLR inequalities apply to Schrödinger operators in $\mathbb{R}^{d}$ for $d \geq 3$ and $A \equiv 0$ and are a particular case of Lieb-Thirring inequalities. In the case of $\operatorname{dim} 2($ and $A \neq 0)$, analogues of $C L R$ inequalities can be found in [2] and [13] (for a Aharanov-Bohm magnetic field) and more recently in 11] (for a large class of magnetic fields, in a weighted version). Our result can not be derived from [11]. Lieb-Thirring inequalities for constant magnetic fields in dim 2 and 3 are proved in [9]. In [7] and [7] magnetic Lieb-Thirring inequalities are proved for Pauli operators. For links between magnetic and non magnetic Lieb-Thirring inequalities see [/].

Example 2.5 Assume $b(r) \equiv 1$ in (3.1) and $\beta \neq 1$. Then the optimal gauge is $A=A_{\beta}(r) d \theta$ with

$$
\begin{equation*}
A_{\beta}=\frac{1}{1-\beta}\left[\frac{1}{(1-r)^{\beta-1}}-\frac{2}{(2-\beta)(3-\beta)}\right] \tag{2.4}
\end{equation*}
$$

and the corresponding minimal value of $I=\int_{0}^{1} A^{2}(r) r d r$ is

$$
\begin{equation*}
I_{\beta}=\frac{P(\beta)}{2(1-\beta)^{2}(3-2 \beta)(2-\beta)^{2}(3-\beta)^{2}}, \tag{2.5}
\end{equation*}
$$

where

$$
\begin{equation*}
P(\beta)=6-13 \beta+8 \beta^{2}-\beta^{3} \tag{2.6}
\end{equation*}
$$

is a polynomial function positive for the values of $\beta$ considered in Corollary 2.2.

## 3 Proof of Theorem 2.1

Proof.
Let us introduce the polar coordinates $x=(r, \theta), r \in \mathbb{R}^{+}, \theta \in[0,2 \pi[$. Due to assumption (2.1) the magnetic field we have to consider is of the type

$$
\begin{equation*}
B(r)=\frac{b(r)}{(1-r)^{\beta}} d r \wedge d \theta, \text { with } \max _{[0,1[ } b(r) \leq M \text { and } \quad \beta<\frac{3}{2} . \tag{3.1}
\end{equation*}
$$

We first prove the following

Lemma 3.1 If $A$ is a radial magnetic potential associated to $B$, then there exists a constant $K$ such that $A$ writes

$$
\text { if } \beta \neq 1 \quad A=A(r) d \theta=\frac{a(r)}{(1-r)^{\beta-1}} d \theta
$$

with

$$
\begin{aligned}
& a(r)=K(1-r)^{\beta-1}+\tilde{a}, \quad \max _{[0,1[ } \tilde{a}(r) \leq C . \\
& \text { if } \beta=1 \quad A=A(r) d \theta=a(r) \ln (1-r) d \theta
\end{aligned}
$$

with

$$
a(r)=\frac{K}{\ln (1-r)}+\tilde{a}, \quad \max _{[0,1[ } \tilde{a}(r) \leq C .
$$

In particular

$$
\int_{[0,1[ } r A^{2}(r) d r<\infty .
$$

Proof.-
Let us explain the case $\beta \neq 1$. The method for the case $\beta=1$ is the same.
$a$ satisfies the equation

$$
(\beta-1) a(r)-(1-r) a^{\prime}(r)=b(r) .
$$

This implies that

$$
\begin{equation*}
a(r)=k(r)(1-r)^{\beta-1}, \text { with } \quad k(r)=\int_{r}^{1} b(t)(1-t)^{-\beta} d t+K . \tag{3.2}
\end{equation*}
$$

From (3.1) we get

$$
\left|\int_{r}^{1} b(t)(1-t)^{-\beta} d t\right| \leq M \int_{r}^{1}(1-t)^{-\beta} d t \leq M \frac{(1-r)^{-\beta+1}}{1-\beta}
$$

and the result follows.

We come now to the proof of Theorem 2.1, following the method of (12].

The quadratic form associated to $H_{A}^{D}-V$ can be rewritten as

$$
\begin{equation*}
h_{A, V}(u)=\int_{0}^{1} \int_{0}^{2 \pi}\left[\left|\frac{\partial u}{\partial r}\right|^{2}-V(r)\left|u^{2}\right|+r^{-2}\left[\left[\frac{\partial}{\partial \theta}-i A(r)\right] u\right]^{2}\right] r d r d \theta \tag{3.3}
\end{equation*}
$$

for

$$
u \in C_{0}^{\infty}([0,1[\times[0,2 \pi[)
$$

Changing variables $r=e^{t}$ and denoting $w(t, \theta)=u\left(e^{t}, \theta\right)$ for $t \in$ $]-\infty, 0\left[\right.$ and $\theta \in\left[0,2 \pi\left[\right.\right.$ we transfer the form $h_{A, V}(u)$ to

$$
\begin{equation*}
\tilde{h}_{A, V}(w)=\int_{-\infty}^{0} \int_{0}^{2 \pi}\left[\left|\frac{\partial w}{\partial t}\right|^{2}-\tilde{V}(t)\left|w^{2}\right|+\left[\left[\frac{\partial}{\partial \theta}-i f(t)\right] w\right]^{2}\right] d t d \theta \tag{3.4}
\end{equation*}
$$

with

$$
\tilde{V}(t)=e^{2 t} V\left(e^{t}\right), \quad f(t)=e^{t} A\left(e^{t}\right) .
$$

By expanding a given function $w \in C_{0}^{\infty}([-\infty, 0[\times[0,2 \pi[)$ into a Fourier series we obtain that $\tilde{h}_{A, V}(w)=\oplus h_{\ell}\left(w_{\ell}\right)$ with

$$
h_{\ell}(v)=\int_{-\infty}^{0}\left|\frac{\partial v}{\partial t}\right|^{2}+\left[(\ell-f(t))^{2}-\tilde{V}(t)\right]\left|v^{2}\right| d t
$$

and $w_{\ell}=\Pi_{\ell}(w)$ where $\Pi_{\ell}$ is the projector acting as

$$
\Pi_{\ell}(w)(r, \theta)=\frac{1}{2 \pi} \int_{0}^{2 \pi} e^{i l\left(\theta-\theta^{\prime}\right)} w\left(r, \theta^{\prime}\right) d \theta^{\prime}
$$

We have, for any $\alpha \in] 0,1[$

$$
h_{\ell}(v) \geq \int_{-\infty}^{0}\left|\frac{\partial v}{\partial t}\right|^{2}+\left[\left(1-\frac{1}{\alpha}\right) f^{2}(t)-\tilde{V}(t)+(1-\alpha) \ell^{2}\right]\left|v^{2}\right| d t
$$

Let us denote by $L_{\alpha}$ the operator associated via Friedrich's extension to the quadratic form

$$
q_{\alpha}(v)=\int_{-\infty}^{0}\left|\frac{\partial v}{\partial t}\right|^{2} D_{t}^{2}+\left[\left(1-\frac{1}{\alpha}\right) f^{2}(t)-\tilde{V}(t)\right]\left|v^{2}\right| d t .
$$

Since

$$
h_{\ell} \geq q_{\alpha}+(1-\alpha) \ell^{2}
$$

the number of negative eigenvalues of $h_{\ell}$ is less than the number of negative eigenvalues of $L_{\alpha}+(1-\alpha) \ell^{2}$. So denoting by $\left\{-\mu_{k}^{\alpha}\right\}$ the negative eigenvalues of $L_{\alpha}$ and by $I_{\ell}$ the set $\left\{k \in \mathbb{N} ;-\mu_{k}^{\alpha}+(1-\alpha) \ell^{2}<\right.$ $0\}$ we get

$$
N(A, V) \leq \sum_{\ell} \sum_{k \in I_{\ell}} 1
$$

Noticing that the sum in the righthandside is taken over the $(\ell, k)$ so that $\ell \leq \frac{1}{\sqrt{1-\alpha}} \sqrt{\mu_{k}^{\alpha}}$ we write

$$
\begin{equation*}
N(A, V) \leq \frac{1}{\sqrt{1-\alpha}} \sum_{k \in \mathbb{N}} \sqrt{\mu_{k}^{\alpha}} \tag{3.5}
\end{equation*}
$$

Let us extend the functions $f$ and $\tilde{V}$ to $\mathbb{R}$ by zero and denote respectively by $f_{1}$ and $\tilde{V}_{1}$ these extensions.

Since $C_{0}^{\infty}\left(\left[-\infty, 0[) \subset C_{0}^{\infty}(\mathbb{R})\right.\right.$, the negative eigenvalues $\left\{-\nu_{k}^{\alpha}\right\}$ of the operator $L_{1}^{\alpha}$ associated via Friedrich's extension to the quadratic form

$$
q_{1}^{\alpha}(v)=\int_{-\infty}^{0}\left|\frac{\partial v}{\partial t}\right|^{2} D_{t}^{2}+\left[\left(1-\frac{1}{\alpha}\right) f_{1}^{2}(t)-\tilde{V}_{1}(t)\right]\left|v^{2}\right| d t
$$

verify

$$
\begin{equation*}
\sum_{k \in \mathbb{N}} \sqrt{\mu_{k}^{\alpha}} \leq \sum_{k \in \mathbb{N}} \sqrt{\nu_{k}^{\alpha}} . \tag{3.6}
\end{equation*}
$$

Applying the sharp inequality of Hundertmarkt-Lieb-Thomas [10] (see Appendix) to the operator $L_{1}^{\alpha}$ we get

$$
\begin{aligned}
\sum_{k \in \mathbb{N}} \sqrt{\nu_{k}^{\alpha}} & \leq \frac{1}{2} \int_{-\infty}^{+\infty}\left[\left(\frac{1}{\alpha}-1\right) f_{1}^{2}(t)+\tilde{V}_{1}(t)\right] d t \\
& \leq \frac{1}{2} \int_{-\infty}^{0}\left[\left(\frac{1}{\alpha}-1\right) f^{2}(t)+\tilde{V}(t)\right] d t \\
& \leq \frac{1}{2} \int_{0}^{1}\left[\left(\frac{1}{\alpha}-1\right) A^{2}(r)+V(r)\right] r d r
\end{aligned}
$$

In view of (3.5) and (3.6) we get the result.

## Proof of Remark 2.3

The choice of $A$ is obtained by taking the minimum over the constants $c$ of the function $F(c)=\int_{0}^{1}(A+c)^{2}(r) r d r$. To get the minimum over the values of $\alpha$ we study the sign of the expression, for any $\alpha \in] 0,1\left[\right.$, of $g_{\lambda}(\alpha):=\frac{\lambda}{2 \sqrt{1-\alpha}}+\frac{\sqrt{1-\alpha}}{\alpha} I$. A direct computation shows that the value $\alpha_{\lambda}$ which realizes the minimum of $g_{\lambda}(\alpha)$ is the positive solution of

$$
\begin{equation*}
\alpha^{2}(\lambda-2 I)+6 \alpha I-4 I=0 . \tag{3.7}
\end{equation*}
$$

## 4 An eigenvalue asymptotic upperbound

From Corollary 2.2 we get easily an asymptotic estimate for the righthandside of (2.3) when $\lambda$ tends to $\infty$ :

Corollary 4.1 If assumptions $\left(H_{1}\right)$ and $\left(H_{3}\right)$ are verified and if moreover

$$
\begin{equation*}
\mathbf{b}(x) \leq(D(x))^{-\beta}, \quad \beta<\frac{3}{2} \tag{4.1}
\end{equation*}
$$

then, for any radial gauge $A$ associated to $B$, the number of eigenvalues of the operator $H_{A}^{D}$ less than $\lambda$ satisfies, as $\lambda$ tends to $\infty$

$$
\begin{equation*}
N(A, \lambda) \leq \frac{\lambda}{4}+\frac{\sqrt{\lambda} \sqrt{I}}{2}+O(1) \tag{4.2}
\end{equation*}
$$

where

$$
I=\int_{0}^{1} A^{2}(r) r d r
$$

Remark: the minimum of the righthandside is obtained by choosing the gauge so that $\int_{0}^{1} A(r) r d r=0$.

Example 4.2 Assume $b(r) \equiv 1$ in (3.1) and $\beta \neq 1$. Then the minimum is obtained for $I=I_{\beta}=\int_{0}^{1} A_{\beta}^{2}(r) r d r$, where $A_{\beta}$ is defined as in (2.4), so that

$$
\begin{equation*}
I_{\beta}=\frac{P(\beta)}{2(1-\beta)^{2}(3-2 \beta)(2-\beta)^{2}(3-\beta)^{2}}, \tag{4.3}
\end{equation*}
$$

where $P(\beta)$ is defined by (2.0).
Proof.-
We define as previously, for any $\alpha \in] 0,1[$,

$$
g_{\lambda}(\alpha):=\frac{\lambda}{2 \sqrt{1-\alpha}}+\frac{\sqrt{1-\alpha}}{\alpha} I
$$

and we want to determine the asymptotic behavior as $\lambda$ tends to $\infty$ of $g_{\lambda}\left(\alpha_{\lambda}\right)$, where $\alpha_{\lambda}$ is the minimum of $g_{\lambda}(\alpha)$.

From (3.7) we compute the following asymptotics

$$
\begin{gathered}
\alpha_{\lambda}=\frac{2 \sqrt{I}}{\sqrt{\lambda}}+O\left(\frac{1}{\lambda}\right) \\
\sqrt{1-\alpha_{\lambda}}=1-\frac{\sqrt{I}}{\sqrt{\lambda}}+O\left(\frac{1}{\lambda}\right),
\end{gathered}
$$

and this gives the result.
The minimal value is obtained as previously by taking the minimum over the constants $c$ of the function $F(c)=\int_{0}^{1}(A+c)^{2}(r) r d r$.

Remark 4.3 The leading term in the estimate (4.2) is also the leading term in the Weyl formula for the Dirichlet Laplacian (corresponding to the case $A=0$ ) in the unit disk.

## 5 Appendix

We recall the sharp inequality of H undertmarkt-Lieb-Thomas
Theorem 5.1 Let

$$
L v(t)=-v^{\prime \prime}(t)-W(t) v(t), \quad W \geq 0 \quad W \in L^{1}(\mathbb{R})
$$

be defined in the sense of quadratic forms on $\mathbb{R}$, and assume that the negative spectrum of $\operatorname{Lv}(t)$ is discrete. Denote by $\left\{-\nu_{k}, k \in \mathbb{N}\right\}$ the negative eigenvalues of $L$. Then

$$
\sum_{k \in \mathbb{N}} \sqrt{\nu_{k}} \leq \frac{1}{2} \int_{-\infty}^{+\infty} W(t) d t
$$
