# Conditioning diffusions with respect to partial observations

#### Abstract

In this paper, we prove a result of equivalence in law between a diffusion conditioned with respect to partial observations and an auxiliary process. By partial observations we mean coordinates (or linear transformation) of the process at a finite collection of deterministic times. Apart from the theoritical interest, this result allows to simulate the conditioned diffusion through Monte Carlo's method, using the fact that the auxiliary process is easy to simulate.


Keywords: Conditioned diffusion, Partial observations, Simulation

## 1 Introduction

We are interessed in multidimensional diffusions solutions of stochastic differential equations (SDE's) generated by a Brownian motion. For a $n$-dimensional diffusion solution on $[0, T]$ of the following

\mathrm{d} x_{t}=b_{t}\left(x_{t}\right) \mathrm{d} t+\sigma_{t}\left(x_{t}\right) \mathrm{d} w_{t}, \quad x_{0}=u \tag{1}
\end{equation*}
$$

where $w$ is a $n$-dimensional Brownian motion, it is known (see e.g. [7) that its conditional law $\mathscr{L}\left(x \mid x_{T}=v\right)$ is given by the law of a bridge process (as extension of Brownian bridge) $y$ solution of

$$
\mathrm{d} y_{t}=b_{t}\left(y_{t}\right) \mathrm{d} t+\sigma_{t}\left(y_{t}\right) \mathrm{d} \tilde{w}_{t}+\left.\sigma_{t}\left(y_{t}\right) \sigma_{t}\left(y_{t}\right)^{*} \nabla_{z} \log p_{t, T}(z, v)\right|_{z=y_{t}} \mathrm{~d} t, \quad y_{0}=u
$$

where $\tilde{w}$ is a Brownian motion and $p_{s, t}(z,$.$) is the density of x_{t}$ knowing $x_{s}=z$. But in most cases this density is not explicitely known so that we are not able to simulate it easily. For practical purposes, e.g. parameter estimation of diffusion processes, simulation of paths corresponding to the conditional law is needed.

In their paper [4] , B.Delyon and Y.Hu studied the following equation on $[0, T]$

\end{equation*}
$$

where $\tilde{w}$ is a $n$-dimensional Brownian motions. Under adequate assumptions, the process $y$ is unique on $[0, T], \lim _{t \rightarrow T} y_{t}=v$, a.s. and for all positive function $f$ in $C\left([0, T], \mathbb{R}^{n}\right)$ we have

$$
\mathbb{E}\left[f(x) \mid x_{T}=v\right]=C \mathbb{E}[f(y) R(y)]
$$

where $R$ is a functional of whole path $y$ on $[0, T]$. The quantity $R(y)$ is computable knowing parameters $b, \sigma, T$ and $v$. The constant $C$ is unknown, but in practice the conditional law is estimated through

$$
\mathbb{E}\left[f(x) \mid x_{T}=v\right] \simeq \frac{\sum_{i} f\left(y^{i}\right) R\left(y^{i}\right)}{\sum_{i} R\left(y^{i}\right)}
$$

where each $y^{i}$ is an independant sample of (2). In this case, we call the process $y$ a bridge even if $y$ does not have the right targeted law. If $b=0$ and $\sigma=I_{n}$ (identity $n$-dimensional matrix), the process $x$ is a $n$-dimensional Brownian motion and process $y$ is a $n$-dimensional Brownian bridge so that $C=R=1$. This theorem applies in the case of more than one observation. The Markov property indeed implies that the conditional law is the tensor product of each bridge.

The aim of this paper is to extend this result to solve this problem with only partial observations. The previous remark does not apply; indeed we have to treat simultaneously all conditionings . To give an idea, let $w=\binom{w^{1}}{w^{2}}$ be a 2-dimensional Brownian motion. The law of $w$ conditioned on $w_{S}^{1}=u$ and $w_{T}^{2}=v$ with $S<T$ is given by that one of $y$ solution of

$$
\mathrm{d} y_{t}=\mathrm{d} \tilde{w}_{t}-\binom{\frac{y_{t}^{1}-u}{S-t} \mathbf{1}_{t<S}}{\frac{y_{t}^{2}-v}{T-t} \mathbf{1}_{t<T}} \mathrm{~d} t, \quad y_{0}=u
$$

each coordinate is a Brownian bridge.
Let us define our observations. At each deterministic positive observation time of the sequence $0<T_{1}<\cdots<T_{k}<\cdots<T_{N}=T$, we get a partial information given by a linear transformation of $x_{T_{k}}$, $L_{k} x_{T_{k}}$, where $L_{k}$ is a deterministic matrix in $M_{m_{k}, n}(\mathbb{R})$ whose $m_{k}$ rows form an orthonormal family. So that our aim is to be able to describe the conditional law $\mathscr{L}\left(x \mid\left(L_{k} x_{T_{k}}=v_{k}\right)_{1 \leq k \leq N}\right)$ where $v_{k}$ is an arbitrary deterministic $m_{k}$-dimensional vector.

We define process $y$ to be the solution of

$$
\left\{\begin{array}{l}
\mathrm{d} y_{t}=b_{t}\left(y_{t}\right) \mathrm{d} t+\sigma_{t}\left(y_{t}\right) \mathrm{d} \tilde{w}_{t}-\sum_{k=1}^{N} P_{t}^{k}\left(y_{t}\right) \frac{y_{t}-u_{k}}{T_{k}-t} \mathbf{1}_{\left(T_{k}-\varepsilon_{k}, T_{k}\right)}(t) \mathrm{d} t  \tag{3}\\
y_{0}=u
\end{array}\right.
$$

where for all time $t$, all vector $z$ and for all $1 \leq k \leq N$, the matrix $P_{t}^{k}(z)$ is an oblique projection and $u_{k}$ is any vector satisfying $L_{k} u_{k}=v_{k}$. The correction term operates only on the interval $\left(T_{k}-\varepsilon_{k}, T_{k}\right)$ where $T_{k}-\varepsilon_{k}<T_{k}$ for technical reasons. We will show that with a good choice for those projections (see Equation (6)) we have the following equivalence in law

$$
\mathscr{L}\left(x \mid\left(L_{k} x_{T_{k}}=v_{k}\right)_{1 \leq k \leq N}\right) \sim \mathscr{L}(y)
$$

with an explicit density (Theorem below).

In this paper a first part is devoted to the study of general bridges which will provide us the good candidate whose law is absolutely continuous with respect to targeted one. The second one provides the main result. Some properties and proofs are postponed in the appendix to ease the reading.

Notations For the sake of readibility, we choose not to specify arguments when not necessary. For example (11) becomes

For all $z$, the matrix $a_{t}(z)$ is defined by

we suppose that there exists a positive number $\rho$ such that for all $(t, z)$

\rho^{-1} I_{n}<a_{t}(z)<\rho I_{n}
$$

in the sense of symmetric matrices, where $I_{n}$ is the $n$ - dimensional identity matrix. The function $a^{-1}$ is defined by

(t, x) & \mapsto\left(a_{t}(x)\right)^{-1}

We define the infimum of all the $\varepsilon_{k}$

$$

## 2 Bridges and bridges approximations

## Bridges

We recall that a bridge is defined as a solution of (3)

\mathrm{d} y_{t}=b_{t}\left(y_{t}\right) \mathrm{d} t+\sigma_{t}\left(y_{t}\right) \mathrm{d} \tilde{w}_{t}-\sum_{k=1}^{N} P_{t}^{k}\left(y_{t}\right) \frac{y_{t}-u_{k}}{T_{k}-t} \mathbf{1}_{\left(T_{k}-\varepsilon_{k}, T_{k}\right)}(t) \mathrm{d} t \\
y_{0}=u_{0}
\end{array}\right.
$$

We assume that the deterministic parameters $b$ and $\sigma$ are $C_{b}^{1,2}$ functions (bounded with bounded derivatives). We assume that

$$
(t, z) \mapsto P_{t}^{k}(z)
$$

is a $C_{b}^{1,2}$ function and that for any $z$

L_{k} P_{t}^{k}(z)=L_{k} \quad \text { and } \quad \operatorname{ker}\left(L_{k}\right)=\operatorname{ker}\left(P_{t}^{k}(z)\right) \tag{4}
\end{equation*}

First of all, a lemma to describe the behaviour of process $y$
Lemma 1. The SDE (S) admits a unique solution on $[0, T]$ in the absolute convergence's sense meaning that

\int_{T_{k}-\varepsilon_{k}}^{T_{k}} \frac{\left\|P_{t}^{k}\left(y_{t}\right)\left(y_{t}-u_{k}\right)\right\|}{T_{k}-t} \mathrm{~d} t<+\infty
$$

For all $k$ we have $L_{k} y_{T_{k}}=L_{k} u_{k}$ almost surely (a.s.). Moreover for $T_{k}-\varepsilon_{k}<t<T_{k},\left\|L_{k}\left(y_{t}-u_{k}\right)\right\| \leq$ $C_{k}(\omega)\left(T_{k}-t\right) \log \log \left[\left(T_{k}-t\right)^{-1}+e\right]$ a.s., where $C_{k}$ is a positive random variable.
Proof. Let us remark that for times in $\left[T_{k-1}, T_{k}\right]$ (with $T_{0}=0$ ) the SDE (3) becomes

$$
\mathrm{d} y_{t}=b_{t} \mathrm{~d} t-P_{t}^{k} \frac{y_{t}-u_{k}}{T_{k}-t} \mathbf{1}_{\left(T_{k}-\varepsilon_{k}, T_{k}\right)}(t) \mathrm{d} t+\sigma\left(y_{t}\right) \mathrm{d} \tilde{w}_{t}
$$

So that we may reduce the proof to the study of (3) with only one observation time, but we here have to consider random initial conditions. If unicity holds it will lead to the result by concatenation. The proof in the case $N=1$ is given in the appendix with Lemma 6.

## Bridges approximations

We now introduce approximations that will be useful in the proof of the main result in next section. Let $0<\varepsilon<\varepsilon_{0}$, we set

\mathrm{d} y_{t}^{\varepsilon}=b_{t}^{\varepsilon}\left(y_{t}^{\varepsilon}\right) \mathrm{d} t+\sigma_{t}\left(y_{t}^{\varepsilon}\right) \mathrm{d} \tilde{w}_{t}-\sum_{k} P_{t}^{k}\left(y_{t}^{\varepsilon}\right) \frac{y_{t}^{\varepsilon}-u_{k}}{T_{k}-t} \mathbf{1}_{\left(T_{k}-\varepsilon_{k}, T_{k}-\varepsilon\right)}(t) \mathrm{d} t, \quad y_{0}^{\varepsilon}=u_{0} \tag{5}
\end{equation*}
$$

The only difference with the Bridge Equation (3) is that each correction term is stopped from a distance $\varepsilon$ from the observation time.

Lemma 2. There exists a constant $0<\kappa<1$ such that

$$
\sup _{t \in[0, T]} \mathbb{E}\left[\left\|y_{t}^{\varepsilon}-y_{t}\right\|^{2}\right] \leq C \varepsilon^{\kappa}
$$

for all $0<\varepsilon<\left(\varepsilon_{0} \wedge 1\right)$ where $C$ is a positive constant. The numbers $C$ and $\kappa$ depend on $T, N$, the $\left(\varepsilon_{k}\right)_{k}$, the $\left(A_{k}\right)_{k}$, and the bounds for $b$ and $\sigma$.

Proof. Given in the appendix, the proof uses classical techniques and auxiliary processes each defined on $\left[T_{k-1}, T_{k}\right]$.

## 3 Result in the case of partial observation

## Case where $b$ is bounded

We aim to obtain a Delyon\&Hu-type theorem that gives absolute continuity of process $x$ solution of (11) conditioned on observations $\left(L_{k} x_{T_{k}}=v_{k}\right)_{1 \leq k \leq N}$ with respect to a bridge process $y$ solution of (3).

We now consider a peculiar projection $P$, for all $k$ and $z$

P_{t}^{k}(z)=a_{t}(z) L_{k}^{*}\left(L_{k} a_{t}(z) L_{k}^{*}\right)^{-1} L_{k} \tag{6}
\end{equation*}
$$

We set

A_{t}^{k}(z)=\left(L_{k} a_{t}(z) L_{k}^{*}\right)^{-1}
$$

and also

$$
\beta_{t}(z)^{k}=\sigma_{t}(z)^{*} L_{k}^{*} A_{t}^{k}(z) \quad \text { and } \quad \eta_{k}(z)=\sqrt{\operatorname{det}\left(A_{t}^{k}(z)\right)}
$$

Let us remark that

$$
\begin{equation*}
\beta_{t}^{k}(z)^{*} \beta_{t}^{k}(z)=A_{t}^{k}(z) \quad \text { and } \quad L_{k} \sigma_{t}(z) \beta_{t}^{k}(z)=I_{m_{k}} \tag{7}
\end{equation*}
$$

where $I_{m_{k}}$ is the identity $m_{k}$-dimensional matrix. Here are both systems we now consider

$$
\begin{align*}
& \mathrm{d} x_{t}=b_{t}\left(x_{t}\right) \mathrm{d} t+\sigma_{t}\left(x_{t}\right) \mathrm{d} w_{t}, \quad x_{0}=u \\
& \mathrm{~d} y_{t}=b_{t}\left(y_{t}\right) \mathrm{d} t+\sigma_{t}\left(y_{t}\right) \mathrm{d} \tilde{w}_{t}-\sum_{k=1}^{N} \sigma_{t}\left(y_{t}\right) \beta_{t}^{k}\left(y_{t}\right) \frac{L_{k} y_{t}-v_{k}}{T_{k}-t} \mathbf{1}_{\left(T_{k}-\varepsilon_{k}, T_{k}\right)} \mathrm{d} t, \quad y_{0}=u \tag{8}
\end{align*}
$$

The result is the following
Theorem 1. Suppose b, $\sigma$ and $a^{-1}$ to be $C_{b}^{1,2}$-functions. Then for any bounded continuous function $f$

\begin{align*}
& \mathbb{E}\left[f(x) \mid\left(L_{k} x_{T_{k}}=v_{k}\right)_{1 \leq k \leq N}\right] \\
& \quad=C \mathbb{E}\left[f ( y ) \prod _ { k = 1 } ^ { N } \eta _ { k } ( y _ { T _ { k } } ) \operatorname { e x p } \left\{-\frac{\left\|\beta_{T_{k}-\varepsilon_{k}}^{k}\left(L_{k} y_{T_{k}-\varepsilon_{k}}-v_{k}\right)\right\|^{2}}{2 \varepsilon_{k}}+\int_{T_{k}-\varepsilon_{k}}^{T_{k}}-\frac{\left(L_{k} y_{s}-v_{k}\right)^{*} L_{k} b_{s}\left(y_{s}\right) \mathrm{d} s}{T_{k}-s}\right.\right. \\
& \left.\quad-\frac{\left(L_{k} y_{s}-v_{k}\right)^{*} \mathrm{~d}\left(A_{t}^{k}\left(y_{t}\right)\right)\left(L_{k} y_{s}-v_{k}\right)}{2\left(T_{k}-s\right)}-\sum_{1 \leq i, j \leq m_{k}} \frac{\mathrm{~d}\left\langle A^{k}(y .)_{i, j},\left(L_{k} y .-v_{k}\right)_{i}\left(L_{k} y .-v_{k}\right)_{j}\right\rangle_{s}}{2\left(T_{k}-s\right)}\right] \tag{9}

where $C$ is a positive constant.
Proof. This one consists in using approximations $y^{\varepsilon}$ solutions of (5) of process $y$ solution of (8). Thanks to Girsanov's theorem, we are able to obtain an equality for all bounded continuous function $f$

$$
\mathbb{E}\left[f(x) G^{\varepsilon}(x)\right]=\mathbb{E}\left[f\left(y^{\varepsilon}\right) H^{\varepsilon}\left(y^{\varepsilon}\right)\right]
$$

where $G^{\varepsilon} / H^{\varepsilon}$ is the density given by Girsanov's theorem. We want to prove that with a good choice for $G^{\varepsilon}$ and $H^{\varepsilon}$, the lefthand member of the last inequality converges to the conditional expectation, and the righthand one converges to what appears in the Theorem 1 .

We set for all $z \in \mathbb{R}^{n}$

h_{t}^{\varepsilon}(z)=\sum_{k=1}^{N} \beta_{t}^{k}(z) \frac{v_{k}-L_{k} z}{T_{k}-t} \mathbf{1}_{\left(T_{k}-\varepsilon_{k}, T_{k}-\varepsilon\right)}(t)

Then for all bounded continuous function $f$

\mathbb{E}\left[f\left(y^{\varepsilon}\right)\right]=\mathbb{E}\left[f(x) \exp \left\{-\int_{0}^{T} h_{t}^{\varepsilon}\left(x_{t}\right)^{*} \mathrm{~d} w_{t}+\frac{1}{2}\left\|h_{t}^{\varepsilon}\left(x_{t}\right)\right\|^{2} \mathrm{~d} t\right\}\right]
$$

We are looking for a different expression of the argument of the exponential function. We use Itô's formula for $T_{k}-\varepsilon_{k}<t<T_{k}-\varepsilon$ and use (7) to get

The $k^{\text {th }}$ term of $\left(h_{t}^{\varepsilon}\right)^{*} \mathrm{~d} w_{t}$ coming from that one in $\mathrm{d} x_{t}$ is now isolated

& -\frac{2\left(L_{k} x_{t}-v_{k}\right)^{*} A_{t}^{k} \sigma_{t} \mathrm{~d} w_{t}}{T_{k}-t}-\frac{\left\|\beta_{t}^{k}\left(L_{k} x_{t}-v_{k}\right)\right\|^{2}}{\left(T_{k}-t\right)^{2}} \mathrm{~d} t=-\mathrm{d}\left(\frac{\left\|\beta_{t}^{k}\left(L_{k} x_{t}-v_{k}\right)\right\|^{2}}{T_{k}-t}\right)+\frac{m_{k}}{T_{k}-t} \mathrm{~d} t \\
+ & \frac{2\left(L_{k} x_{t}-v_{k}\right)^{*} A_{t}^{k} b_{t} \mathrm{~d} t}{T_{k}-t}+\frac{\left(L_{k} x_{t}-v_{k}\right)^{*} \mathrm{~d} A_{t}^{k}\left(L_{k} x_{t}-v_{k}\right)}{T_{k}-t}+\sum_{1 \leq i, j \leq m_{k}} \frac{\mathrm{~d}\left\langle A_{i, j}^{k},\left(L_{k} x-v_{k}\right)_{i}\left(L_{k} x-v_{k}\right)_{j}\right\rangle_{t}}{T_{k}-t} \tag{10}

Since we have

\left\|h_{t}^{\varepsilon}\right\|^{2} \mathrm{~d} t=\sum_{k} \frac{\left\|\beta_{t}^{k}\left(L_{k} x_{t}-v_{k}\right)\right\|^{2}}{\left(T_{k}-t\right)^{2}} \mathbf{1}_{\left(T_{k}-\varepsilon_{k}, T_{k}-\varepsilon\right)}(t) \mathrm{d} t
$$

and

\left(h_{t}^{\varepsilon}\right)^{*} \mathrm{~d} w_{t}=-\sum_{k} \mathbf{1}_{\left(T_{k}-\varepsilon_{k}, T_{k}-\varepsilon\right)}(t) \frac{\left(L_{k} x_{t}-v_{k}\right)^{*} A_{t}^{k} \sigma_{t} \mathrm{~d} w_{t}}{T_{k}-t}
$$

we obtain $-2\left(h_{t}^{\varepsilon}\right)^{*} \mathrm{~d} w_{t}-\left\|h_{t}^{\varepsilon}\right\|^{2} \mathrm{~d} t$ adding the terms given by (10). Finally, it leads us to a new expression for the density given by Girsanov's theorem

In an equivalent way, even if it means changing $f$

We now use Markov's property to get independance between Past and Future knowing Present (cf [3] see last chapter about conditional expectations)

\mathbb{E}\left[C^{\varepsilon} \psi^{\varepsilon} \mathbf{1}_{\tau^{\varepsilon}=\tau_{k}^{\varepsilon}}\right] & =\mathbb{E}\left[F_{1} \mathbb{E}\left[F_{2} F_{3} \mathbf{1}_{\tau^{\varepsilon}=\tau_{k}^{\varepsilon}} \mid \tau_{k}^{\varepsilon}, x_{\tau_{k}^{\varepsilon}}\right]\right]=\mathbb{E}\left[F_{1} \mathbb{E}\left[F_{2} \mathbf{1}_{\tau^{\varepsilon}=\tau_{k}^{\varepsilon}} \mid \tau_{k}^{\varepsilon}, x_{\tau_{k}^{\varepsilon}}\right] \mathbb{E}\left[F_{3} \mid x_{\tau_{k}^{\varepsilon}}\right]\right]  \tag{15}\\
& =\mathbb{E}\left[F_{1} \mathbb{E}\left[F_{2} \mathbf{1}_{\tau^{\varepsilon}=\tau_{k}^{\varepsilon}} \mid \tau_{k}^{\varepsilon}, x_{\tau_{k}^{\varepsilon}}\right] \mathbb{E}\left[F_{3} \mid x_{T_{k}-\varepsilon}\right]\right] \tag{16}

In order to study the factor $\mathbb{E}\left[F_{2} \mathbf{1}_{\tau^{\varepsilon}=\tau_{k}^{\varepsilon}} \mid \mathscr{F}_{\tau_{k}^{\varepsilon}}\right]$ we introduce

\theta_{t}=\frac{1}{\sqrt{T_{k}-t}} \exp \left\{-\frac{\left\|\beta_{t}^{k}\left(L_{k} x_{t}-v_{k}\right)\right\|^{2}}{2\left(T_{k}-t\right)}\right\}

For $t \in\left[T_{k-1}, T_{k}-\varepsilon\right]$, we set $z_{t}=L_{k} x_{t}-v_{k}, p_{t}=\left\|\beta_{t}^{k}\left(L_{k} x_{t}-v_{k}\right)\right\|$. We recall that $\beta_{t}^{k}=\sigma_{t}^{*} L_{k}^{*} A_{t}^{k}$ with $A_{t}^{k}=\left(\beta_{t}^{k}\right)^{*} \beta_{t}^{k}=\left(L_{k} a_{t} L_{k}^{*}\right)^{-1}$. With respect to these notations, we have

and then $\mathrm{d}\langle z\rangle_{t}=L_{k} a_{t} L_{k}^{*} \mathrm{~d} t=\left(A_{t}^{k}\right)^{-1} \mathrm{~d} t$. We use Itô's formula

$$

Then

\mathrm{d} \frac{p_{t}^{2}}{T_{k}-t}=\frac{2 z_{t} A_{t}^{k} \mathrm{~d} z_{t}}{T_{k}-t}+\frac{p_{t}^{2} \mathrm{~d} t}{\left(T_{k}-t\right)^{2}}+\frac{z_{t}^{*} \mathrm{~d} A_{t}^{k} z_{t}}{T_{k}-t}+\frac{m_{k} \mathrm{~d} t}{T_{k}-t}+\frac{\sum_{i, j} \mathrm{~d}\left\langle\Delta_{i, j}, z_{i} z_{j}\right\rangle_{t}}{T_{k}-t}
$$

First using definitions of $z, \beta^{k}$ and $A^{k}$ we get

& =z_{t}^{*}\left(\beta_{t}^{k}\right)^{*} \sigma_{t}^{-1} b_{t} \mathrm{~d} t+z_{t}^{*}\left(\beta_{t}^{k}\right)^{*} \mathrm{~d} w_{t}
\end{aligned}
$$

This leads us to the existence of two bounded adapted processes $r^{(1)}$ and $r^{(2)}$ defined on $\left[T_{k-1}, T_{k}-\varepsilon\right]$ such that

We deduce from the three last equations after simplification of four terms that there exists a martingale $M$ and a bounded adapted process $r^{\prime \prime}$ both defined on $\left[T_{k-1}, T_{k}-\varepsilon\right]$ such that

This gives us the existence of a bounded adapted process $\pi$ defined on $\left[T_{k-1}, T_{k}-\varepsilon\right]$ that allows us to write

where $\bar{\pi}=\sup _{s}\left|\pi_{s}\right|$. So $\mathbb{E}\left[\theta 1_{\tau_{k}^{\varepsilon}<t}\right]$ is bounded by the solution $u$ of

In particular when $t=T_{k}-\varepsilon$

We now come back to equation (15), we get a first bound

In order to treat the factor $\mathbb{E}\left[F_{3} \mid x_{T_{k}-\varepsilon}\right]$ we use Aronson's estimate to get

$$

where $G$ is a positive constant. We just have to use Lemma 11 given in the appendix to obtain an positive constant upper bound. The same Lemma 11 brings us a positive constant upper bound for $\mathbb{E}\left[F_{1}\right]$. Finally the inequation we get from equation (15) is the following

According to this last result and using the lower bound of $C^{\varepsilon} \mathbb{E}\left[\psi^{\varepsilon}\right]$ given by Proposition 1 we finally have

Indeed by definition of $\tau^{\varepsilon}$ we can get upper bounds depending on $J$ for the different factors in Expression (12) of $\varphi^{\varepsilon}$ or (14) of $\varphi$, for all $0 \leq \varepsilon<1$

&\left.-\sum_{1 \leq i, j \leq m_{k}} \frac{\mathrm{~d}\left\langle A_{i, j}^{k},\left(L_{k} y^{\varepsilon}-v_{k}\right)_{i}\left(L_{k} y^{\varepsilon}-v_{k}\right)_{j}\right\rangle_{t}}{2\left(T_{k}-t\right)}-\frac{\left\|\beta_{T_{k}-\varepsilon_{k}}^{k}\left(y_{T_{k}-\varepsilon_{k}}^{\varepsilon}\right)\left(L_{k} y_{T_{k}-\varepsilon_{k}}^{\varepsilon}-v_{k}\right)\right\|^{2}}{2 \varepsilon_{k}}\right\}
\end{aligned}
$$

in fact " $\varphi^{0}=\varphi$ ". We recall that $b$ and $\sigma$ are bounded so is $\eta$. Then on $\left\{\tau^{\varepsilon}=T\right\}$

\left\|\frac{\left(L_{k} y_{t}^{\varepsilon}-v_{k}\right)^{*} A_{t}^{k} L_{k} b_{t}}{T_{k}-t}\right\| \leq \frac{C}{\sqrt{T_{k}-t}} \sqrt{\log \left(\frac{J}{\left(T_{k}-t\right)^{\frac{m_{k}}{2}}}\right)}
$$

which is an integrable quantity in $T_{k}$, and $C$ is a positive constant depending on the choice of $b$ and $\sigma$. A same method gives an upper bound for the terms where quadratic variation appears. For the terms in $\mathrm{d} A_{t}^{k}$, we decompose with respect to integrals with respect to $\mathrm{d} t$ and $\mathrm{d} w_{t}$

$$

where $r^{k}$ and $q^{k}$ are bounded adapted functions. Then for fixed $J$, there exists a constant $K$ such that

\varphi^{\varepsilon} \mathbf{1}_{T=\tau^{\varepsilon}} \leq C \prod_{k} \exp \left\{\int_{T_{k}-\varepsilon_{k}}^{T_{k}} \frac{\left\|L_{k} y_{t}-v_{k}\right\|^{2}}{T_{k}-t} r_{t}^{k} \mathrm{~d} w_{t}-\frac{1}{2} \frac{\left\|L_{k} y_{t}-v_{k}\right\|^{4}}{\left(T_{k}-t\right)^{2}}\left\|r_{t}^{k}\right\|^{2} \mathrm{~d} t\right\}
$$

where $C$ is a positive constant. Let us recall the following lemma (cf [6] p.198)

Lemma 4 (Novikov). Let $\left(M_{t}\right)_{t \in \mathbb{R}}$ be a continuous local martingale, we set for all $t$

$$

where $C$ is a positive constant. Thus, we apply Novikov's lemma to get uniform integrability. Then we take the $\lim \inf _{\varepsilon \rightarrow 0}$ and use Lebesgue's theorem to obtain

## Case where $b$ is unbounded

Suppose now that $b$ is locally Lipschitz with respect to $x$ and is locally bounded. Moreover the SDE (11) admits a strong solution. We use a Girsanov theorem to reduce the problem to the case of a bounded drift.

We recall the Girsanov theorem for unbounded drifts introduced in [4]
Theorem 2. Let $b$, $h$ and $\sigma$ be measurable functions from $\mathbb{R}^{+} \times \mathbb{R}^{n}$ to $\mathbb{R}^{n}, \mathbb{R}^{d}$ and $\mathbb{R}^{n \times d}$ locally Lipschitz with respect to $x$; consider the following SDE's

& x_{0}=y_{0}
\end{aligned}
$$

on the finite interval $[0, T]$. We assume the existence of strong solution for each equation. We assume in addition that $h$ is bounded on compact sets. Then the Girsanov formula holds: for any non negative Borel function $f$ defined on $C\left([0, T], \mathbb{R}^{n}\right)$, one has

where $\tilde{w}^{h}=\tilde{w}_{t}+\int_{0}^{t} h_{s}\left(y_{s}\right) \mathrm{d} s$.

Thanks to both Theorems 1 and 2 we obtain
Theorem 3. Suppose $\sigma$ and $a^{-1}$ to be $C_{b}^{1,2}$-functions. Assume that $b$ is a locally Lipschitz with respect to $x$ and locally bounded function. Let $y$ be the solution of

where $C$ is a positive constant and $\check{b}=b-\hat{b}$.

\mathbb{E}\left[\left\|y_{t}^{\varepsilon}-y_{t}\right\|^{2}\right] \leq 2 \mathbb{E}\left[\left\|y_{t}^{\varepsilon}-y_{t}^{k}\right\|^{2}\right]+2 \mathbb{E}\left[\left\|y_{t}^{k}-y_{t}\right\|^{2}\right] \tag{28}
\end{equation*}
$$

We will study both terms separately.
For the first one, on $\left[T_{k-1}, T_{k}-\varepsilon\right)$ the term $\left\|y_{t}^{\varepsilon}-y_{t}^{k}\right\|$ is 0 a.s. and on $\left[T_{k}-\varepsilon, T_{k}\right)$, we can reduce the study to that of $\left\|x_{t}-y_{t}\right\|^{2}$ with a same initialization $y_{T_{k}-\varepsilon}^{\varepsilon}$ at time $T_{k}-\varepsilon$.

$$

Figure 1: Illustration of the three different dynamics considered


Let us recall

(1) First, the three processes follow the dynamics of the initial diffusion (1) with a different initialization for $y$.
(2) Now, the three processes follow the dynamics of the bridge (3), that means that the correction term operates and forces these processes to get closer to the observation
(3) At the end, only the processes $y$ and $y^{k}$ go on following the dynamics of the bridge (3) and both tends to the obervation, while $y^{\varepsilon}$ follows the initial dynamics (11)

We then use Lemma (7) given in the appendix and classical technique (see e.g. 国 p.170) to obtain upper bounds

where $0<\alpha<1$ and $c^{\prime}$ is a positive constant only depending on $T$, bounds $b$ and $\sigma$. We show by induction that there exists some constant $C$ such that for all $1 \leq k \leq N$

The base case is given by Equation (29). Indeed on $\left[0, T_{1}\right]$ processes $y^{1}$ and $y$ are indistinguishable since they have a same initialization at time 0 . Suppose now for some $k$ that Inequality (31) holds. We now use Equation (30) to get

where $c_{k}$ is a positive constant depending on $L_{k+1}, u_{k}$ and $u_{k+1}$. That gives us thanks to the induction hypothesis

where $C$ is a positive constant. This concludes the proof.
Lemma 9. Let $\left(t_{k, q}\right)_{\substack{1 \leq k \leq N \\ 1 \leq q \leq M_{k}}}$ be a sequence such that $t_{k, q} \in\left(T_{k-1}, T_{k}\right)$ and for all $k,\left(t_{k, q}\right)_{q}$ is an increasing sequence. Then for all bounded continuous function $g$

Let introduce Aronson's estimates (see e.g. [1], 8] or [2]) that gives bounds for the transition density. If $p_{s, t}(u,$.$) (with s<t$ ) is the density of $x_{t}$ knowing that $x_{s}=u$, we have for all $z$

The transition densities allow to expand the density $q^{\varepsilon}$ of $\left(x_{t_{1,1}}, \ldots, x_{t_{N, M_{N}}}, x_{T_{1}-\varepsilon}, \ldots, x_{T_{N}-\varepsilon}\right)$

q^{\varepsilon}\left(z_{1,1}, \ldots, z_{t_{N, M_{N}}}, \zeta_{1}, \ldots, \zeta_{N}\right)=p_{0, t_{1,1}}\left(u, z_{1,1}\right) \ldots p_{t_{1, M_{1}, T_{1}-\varepsilon}}\left(z_{0, M_{0}}, \zeta_{1}\right) \ldots p_{t_{N, M_{N}}, T_{N}-\varepsilon}\left(z_{N, M_{N}}, \zeta_{N}\right)

Then we set for $\varepsilon \geq 0$

This application is continuous according to Aronson's estimates. From this expression it comes

We recall that the rows of each matrix $L_{k}$ form an orthonormal family. We now complete arbitrarily each family into an orthonormal basis of $\mathbb{R}^{n}$. We denote $P_{k}$ an arbitrary matrix whose first rows are given by $L_{k}$. Then we make a basis change with respect to those matrices $P_{k}$ for each $\zeta_{k}$. Thus

For the first term, since $b$ and $\beta$ are bounded, we use Lemma 1 to get

For the second term in (33), we recall that for all $z$ we have $A_{t}(z)=\beta_{t}(z)^{*} \beta_{t}(z)=\left(L a_{t}(z) L^{*}\right)^{-1}$, hence

Using Lemma 1, we obtain that the quantities $\frac{\left\|L y_{t}-v\right\|^{2}}{T-t}, \frac{\left\|L y_{t}-v\right\|^{2}}{(T-t)^{2}}$ and $\frac{\left\|L y_{t}-v\right\|^{4}}{(T-t)^{2}}$ are integrable in a left neighboorhood of $T$.

For the last term in (33), we use Itô's formula and the fact that $L \sigma_{t}(z) \beta_{t}(z)=I_{d}$, so that on $\left(T-\varepsilon_{k}, T_{k}\right)$

is the density of the family $\left(V_{j}=W_{j}+Z_{j}\right)_{1 \leq j \leq K}$ where each of the $W_{j}$ whose law is given by $g_{j}$ is independent with respect to the $\left(Z_{j}\right)_{1 \leq j \leq K}$ and $\left(\bar{W}_{k}\right)_{k \neq j}$.
Proof. Let $f$ be a bounded continuous function

where $W_{j}$ admits $g_{j}$ as density.
