Shape derivatives of boundary integral operators in electromagnetic scattering. Part II: Application to scattering by a homogeneous dielectric obstacle

Abstract. We develop the shape derivative analysis of solutions to the problem of scattering of time-harmonic electromagnetic waves by a penetrable bounded obstacle. Since boundary integral equations are a classical tool to solve electromagnetic scattering problems, we study the shape differentiability properties of the standard electromagnetic boundary integral operators. The latter are typically bounded on the space of tangential vector fields of mixed regularity $\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma)$. Using Helmholtz decomposition, we can base their analysis on the study of pseudo-differential integral operators in standard Sobolev spaces, but we then have to study the Gâteaux differentiability of surface differential operators. We prove that the electromagnetic boundary integral operators are infinitely differentiable without loss of regularity. We also give a characterization of the first shape derivative of the solution of the dielectric scattering problem as a solution of a new electromagnetic scattering problem.

Keywords. Maxwell's equations, boundary integral operators, surface differential operators, shape derivatives, Helmholtz decomposition.

1. Introduction

Consider the scattering of time-harmonic electromagnetic waves by a bounded obstacle Ω in \mathbb{R}^3 with a smooth and simply connected boundary Γ filled with an homogeneous dielectric material. This problem is described by the system of Maxwell's equations with piecewise constant electric permittivity and magnetic permeability, valid in the sense of distributions, which implies two transmission conditions on the boundary of the obstacle guaranteeing the continuity of the tangential components of the electric and magnetic fields

across the interface. The transmission problem is completed by the Silver–Müller radiation condition at infinity (see [27] and [28]). Boundary integral equations are an efficient method to solve such problems for low and high frequencies. The dielectric scattering problem is usually reduced to a system of two boundary integral equations for two unknown tangential vector fields on the interface (see [5] and [28]). We refer to [8] for methods developed by the authors to solve this problem using a single boundary integral equation.

Optimal shape design with a goal function involving the modulus of the far field pattern of the dielectric scattering problem has important applications, such as antenna design for telecommunication systems and radars. The analysis of shape optimization methods is based on the analysis of the dependency of the solution on the shape of the dielectric scatterer, and a local analysis involves the study of derivatives with respect to the shape. An explicit form of the shape derivatives is desirable in view of their implementation in shape optimization algorithms such as gradient methods or Newton’s method.

In this paper, we present a complete analysis of the shape differentiability of the solution of the dielectric scattering problem and of its far field pattern, using integral representations. Even if numerous works exist on the calculus of shape derivatives of various shape functionals [11, 12, 13, 15, 34], in the framework of boundary integral equations the scientific literature is not extensive. However, one can cite the papers [29], [31] and [30], where R. Potthast has considered the question, starting with his PhD thesis [32], for the Helmholtz equation with Dirichlet or Neumann boundary conditions and the perfect conductor problem, in spaces of continuous and Hölder continuous functions. Using the integral representation of the solution, one is lead to study the Gâteaux differentiability of boundary integral operators and potential operators with weakly singular and hypersingular kernels.

The natural space of distributions (energy space) which occurs in the electromagnetic potential theory is $\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma)$, the set of tangential vector fields whose components are in the Sobolev space $H^{-\frac{1}{2}}(\Gamma)$ and whose surface divergence is in $H^{-\frac{1}{2}}(\Gamma)$. We face two main difficulties: On one hand, the solution of the scattering problem is given in terms of products of boundary integral operators and their inverses. In order to be able to construct shape derivatives of such products, it is not sufficient to find shape derivatives of the boundary integral operators, but it is imperative to prove that the derivatives are bounded operators between the same spaces as the boundary integral operators themselves. On the other hand, the very definition of shape differentiability of operators defined on the shape-dependent space $\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma)$ poses non-trivial problems. Our strategy consists in using the Helmholtz decomposition of this Hilbert space which gives a representation of a tangential vector field in terms of (tangential derivatives of) two scalar potentials. In this way, we split the analysis into two steps: First the Gâteaux differentiability analysis of scalar boundary integral operators and potential

operators with strongly and weakly singular kernels, and second the study of shape derivatives of surface differential operators.

This work contains results from the thesis [24] where this analysis has been used to develop a shape optimization algorithm of dielectric lenses in order to obtain a prescribed radiation pattern.

This is the second of two papers on shape derivatives of boundary integral operators, the first one [9] being aimed at a general theory of shape derivatives of singular integral operators appearing in boundary integral equation methods.

The paper is organized as follows:

In Section 2 we recall some standard results about trace mappings and regularity properties of the boundary integral operators in electromagnetism. In Section 3 we define the scattering problem for time-harmonic electromagnetic waves at a dielectric interface. We then give an integral representation of the solution — and of the quantity of interest, namely the far field of the dielectric scattering problem — following the single source integral equation method developed in [8].

The remaining parts of the paper are dedicated to the shape differentiability analysis of the solution of the dielectric scattering problem. We use the results of our first paper [9] on the Gâteaux differentiability of boundary integral operators with pseudo-homogeneous kernels. We refer to this paper for a discussion of the notion of Gâteaux derivatives in Fréchet spaces and of some of their basic properties. In Section 4 we discuss the difficulties posed by the shape dependency of the function space $\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma)$ on which the integral operators are defined, and we present a strategy for dealing with this difficulty, namely using the well-known tool [10] of Helmholtz decomposition. In our approach, we map the variable spaces $\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma_r}, \Gamma_r)$ to a fixed reference space with a transformation that preserves the Hodge structure. This technique involves the analysis of surface differential operators that have to be considered in suitable Sobolev spaces. Therefore in Section (5) we recall and extend the results on the differentiability properties of surface differential operators established in [9, Section 5]. Using the rules on derivatives of composite and inverse functions, we obtain in Section 6 the shape differentiability properties of the solution of the scattering problem. More precisely, we prove that the boundary integral operators are infinitely Gâteaux differentiable without loss of regularity, whereas previous results allowed such a loss [30], and we prove that the shape derivatives of the potentials are smooth away from the boundary but they lose regularity in the neighborhood of the boundary. This implies that the far field is infinitely Gâteaux differentiable, whereas the shape derivatives of the solution of the scattering problem lose regularity.

These new results generalize existing results: In the acoustic case, using a variational formulation, a characterization of the first Gâteaux derivative was given by A. Kirsch [21] for the Dirichlet problem and then by Hettlich

[16, 17] for the impedance problem and the transmission problem. An alternative technique was introduced by Kress and Päiväranta in [23] to investigate Fréchet differentiability in acoustic scattering by the use of a factorization of the difference of the far-field pattern of the scattered wave for two different obstacles. In the electromagnetic case, Potthast used the integral equation method to obtain a characterization of the first shape derivative of the solution of the perfect conductor scattering problem. In [22], Kress improved this result by using a far-field identity and in [14] Kress and Haddar extended this technique to acoustic and electromagnetic impedance boundary value problems.

At the end of Section 6 we obtain a characterization of the first shape derivative of the solution of the dielectric scattering problem as the solution of a new electromagnetic transmission problem. We show by deriving the integral representation of the solution that the first derivative satisfies the homogeneous Maxwell equations, and by directly deriving the boundary values of the solution itself we see that the first derivative satisfies two new transmission conditions on the boundary.

In the end we will have obtained two different algorithms for computing the shape derivative of the solution of the dielectric scattering problem and of the far field pattern: A first one by differentiating the integral representations and a second one by solving the new transmission problem associated with the first derivative.

The characterization of the derivatives as solutions to boundary value problems has been obtained in the acoustic case by Kress [6], Kirsch [21], Hettlich and Rundell [18] and Hohage [19] and has been used for the construction of Newton-type or second degree iterative methods in acoustic inverse obstacle scattering. Whereas the use of these characterizations requires high order regularity assumption for the boundary, we expect that the differentiation of the boundary integral operators does not require much regularity. Although in this paper we treat the case of a smooth boundary, in the last section we give some ideas on possible extensions of the results of this paper to non-smooth domains.

A final remark on the terminology of derivatives with respect to the variation of the domain: For the solutions of boundary value problems with a moving boundary, in the context of continuum mechanics one distinguishes frequently between *material derivatives* and *shape derivatives*. The former correspond to the Gâteaux derivative with respect to the deformation, which is then interpreted as a flow associated with a velocity field, when the solution is pulled back to a fixed undeformed reference domain (Lagrangian coordinates). Depending on the interpretation of the flow, other names are used, such as “Lagrangian derivative”, or “substantial derivative”. The shape derivatives, on the other hand, correspond to the Gâteaux derivative of the solution in the deformed domain (Eulerian coordinates). One also talks about “Eulerian derivative”. The difference between the two has the form of a convection term, which can lead to a loss of one order of regularity of the shape

derivative on the support of the velocity field [25]. In the context of this terminology, the derivatives of the boundary integral operators that we studied in Part I of this paper [9] for general pseudohomogeneous kernels and in this paper for the boundary integral operators of electromagnetism, correspond to the Lagrangian point of view, because they are obtained by pull-back to a fixed reference boundary. However, the derivative of the solution of dielectric scattering problem that we construct in Section 6 – with the help of the derivatives of the boundary integral operators – is the Eulerian shape derivative. We also observe the loss of one order of regularity of the shape derivative with respect to the solution of the transmission problem. Finally, for the far field, the two notions of derivative coincide, because the deformation has compact support.

2. Boundary integral operators and their main properties

Let Ω be a bounded domain in \mathbb{R}^3 and let Ω^c denote the exterior domain $\mathbb{R}^3 \setminus \overline{\Omega}$. Throughout this paper, we will for simplicity assume that the boundary Γ of Ω is a smooth and simply connected closed surface, so that Ω is diffeomorphic to a ball.

We use standard notation for surface differential operators and boundary traces. More details can be found in [28]. For a vector function $\mathbf{v} \in \mathcal{C}^k(\mathbb{R}^3, \mathbb{C}^3)$ with $k \in \mathbb{N}^*$, we denote by $[\nabla \mathbf{v}]$ the matrix the i -th column of which is the gradient of the i -th component of \mathbf{v} , and we set $[D\mathbf{v}] = [\nabla \mathbf{v}]^T$. Let \mathbf{n} denote the outer unit normal vector on the boundary Γ . The tangential gradient of a complex-valued scalar function $u \in \mathcal{C}^k(\Gamma, \mathbb{C})$ is defined by

$$\nabla_{\Gamma} u = \nabla \tilde{u}|_{\Gamma} - (\nabla \tilde{u}|_{\Gamma} \cdot \mathbf{n}), \quad (2.1)$$

and the tangential vector curl is defined by

$$\mathbf{curl}_{\Gamma} u = \nabla \tilde{u}|_{\Gamma} \wedge \mathbf{n}, \quad (2.2)$$

where \tilde{u} is a smooth extension of u to the whole space \mathbb{R}^3 . For a complex-valued vector function $\mathbf{u} \in \mathcal{C}^k(\Gamma, \mathbb{C}^3)$, we denote $[\nabla_{\Gamma} \mathbf{u}]$ the matrix the i -th column of which is the tangential gradient of the i -th component of \mathbf{u} and we set $[D_{\Gamma} \mathbf{u}] = [\nabla_{\Gamma} \mathbf{u}]^T$.

The surface divergence of $\mathbf{u} \in \mathcal{C}^k(\Gamma, \mathbb{C}^3)$ is defined by

$$\operatorname{div}_{\Gamma} \mathbf{u} = \operatorname{div} \tilde{\mathbf{u}}|_{\Gamma} - ([\nabla \tilde{\mathbf{u}}|_{\Gamma}] \mathbf{n} \cdot \mathbf{n}), \quad (2.3)$$

and the surface scalar curl is defined by

$$\operatorname{curl}_{\Gamma} \mathbf{u} = \mathbf{n} \cdot (\mathbf{curl} \tilde{\mathbf{u}}).$$

These definitions do not depend on the choice of the extension $\tilde{\mathbf{u}}$.

Definition 2.1. For a vector function $\mathbf{v} \in \mathcal{C}^{\infty}(\overline{\Omega}, \mathbb{C}^3)$ a scalar function $v \in \mathcal{C}^{\infty}(\overline{\Omega}, \mathbb{C})$ and $\kappa \in \mathbb{C} \setminus \{0\}$, we define the traces :

$$\gamma v = v|_{\Gamma},$$

$$\begin{aligned}\gamma_n v &= \frac{\partial}{\partial \mathbf{n}} v = \mathbf{n} \cdot (\nabla v)|_\Gamma, \\ \gamma_D \mathbf{v} &:= \mathbf{n} \wedge (\mathbf{v})|_\Gamma \text{ (Dirichlet),} \\ \gamma_{N_\kappa} \mathbf{v} &:= \frac{1}{\kappa} \mathbf{n} \wedge (\mathbf{curl} \mathbf{v})|_\Gamma \text{ (Neumann).}\end{aligned}$$

We define in the same way the exterior traces γ^c , γ_n^c , γ_D^c and $\gamma_{N_\kappa}^c$.

For a domain $G \subset \mathbb{R}^3$ we denote by $H^s(G)$ the usual L^2 -based Sobolev space of order $s \in \mathbb{R}$, and by $H_{\text{loc}}^s(\overline{G})$ the space of functions whose restrictions to any bounded subdomain B of G belong to $H^s(B)$. Spaces of vector functions will be denoted by boldface letters, thus

$$\mathbf{H}^s(G) = (H^s(G))^3.$$

If D is a differential operator, we write:

$$\begin{aligned}\mathbf{H}^s(D, \Omega) &= \{u \in \mathbf{H}^s(\Omega) : Du \in \mathbf{H}^s(\Omega)\} \\ \mathbf{H}_{\text{loc}}^s(D, \overline{\Omega^c}) &= \{u \in \mathbf{H}_{\text{loc}}^s(\overline{\Omega^c}) : Du \in \mathbf{H}_{\text{loc}}^s(\overline{\Omega^c})\}.\end{aligned}$$

The space $\mathbf{H}^s(D, \Omega)$ is endowed with the natural graph norm. When $s = 0$, this defines in particular the Hilbert spaces $\mathbf{H}(\mathbf{curl}, \Omega)$ and $\mathbf{H}(\mathbf{curl} \mathbf{curl}, \Omega)$. We introduce the Hilbert spaces $H^s(\Gamma) = \gamma \left(H^{s+\frac{1}{2}}(\Omega) \right)$, and $\mathbf{TH}^s(\Gamma) = \gamma_D \left(\mathbf{H}^{s+\frac{1}{2}}(\Omega) \right)$. For $s > 0$, the trace mappings

$$\begin{aligned}\gamma : H^{s+\frac{1}{2}}(\Omega) &\rightarrow H^s(\Gamma), \\ \gamma_n : H^{s+\frac{3}{2}}(\Omega) &\rightarrow H^s(\Gamma), \\ \gamma_D : \mathbf{H}^{s+\frac{1}{2}}(\Omega) &\rightarrow \mathbf{TH}^s(\Gamma)\end{aligned}$$

are then continuous. The dual of $H^s(\Gamma)$ and $\mathbf{TH}^s(\Gamma)$ with respect to the L^2 (or \mathbf{L}^2) scalar product is denoted by $H^{-s}(\Gamma)$ and $\mathbf{TH}^{-s}(\Gamma)$, respectively.

The surface differential operators defined above can be extended to Sobolev spaces: For $s \in \mathbb{R}$ the tangential gradient and the tangential vector curl are obviously linear and continuous operators from $H^{s+1}(\Gamma)$ to $\mathbf{TH}^s(\Gamma)$. The surface divergence and the surface scalar curl can then be defined on tangential vector fields by duality, extending duality relations valid for smooth functions

$$\int_\Gamma (\text{div}_\Gamma \mathbf{j}) \cdot \varphi \, ds = - \int_\Gamma \mathbf{j} \cdot \nabla_\Gamma \varphi \, ds \quad \text{for all } \mathbf{j} \in \mathbf{TH}^{s+1}(\Gamma), \varphi \in H^{-s}(\Gamma), \quad (2.4)$$

$$\int_\Gamma (\mathbf{curl}_\Gamma \mathbf{j}) \cdot \varphi \, ds = \int_\Gamma \mathbf{j} \cdot \mathbf{curl}_\Gamma \varphi \, ds \quad \text{for all } \mathbf{j} \in \mathbf{TH}^{s+1}(\Gamma), \varphi \in H^{-s}(\Gamma). \quad (2.5)$$

We have the following equalities:

$$\mathbf{curl}_\Gamma \nabla_\Gamma = 0 \text{ and } \text{div}_\Gamma \mathbf{curl}_\Gamma = 0 \quad (2.6)$$

$$\text{div}_\Gamma (\mathbf{n} \wedge \mathbf{j}) = - \mathbf{curl}_\Gamma \mathbf{j} \text{ and } \mathbf{curl}_\Gamma (\mathbf{n} \wedge \mathbf{j}) = \text{div}_\Gamma \mathbf{j} \quad (2.7)$$

Definition 2.2. Let $s \in \mathbb{R}$. We define the Hilbert space

$$\mathbf{TH}^s(\operatorname{div}_\Gamma, \Gamma) = \{\mathbf{j} \in \mathbf{TH}^s(\Gamma); \operatorname{div}_\Gamma \mathbf{j} \in H^s(\Gamma)\}$$

endowed with the norm

$$\|\cdot\|_{\mathbf{TH}^s(\operatorname{div}_\Gamma, \Gamma)} = \left(\|\cdot\|_{\mathbf{TH}^s(\Gamma)}^2 + \|\operatorname{div}_\Gamma \cdot\|_{H^s(\Gamma)}^2 \right)^{\frac{1}{2}}.$$

Lemma 2.3. *The operators γ_D and γ_N are linear continuous from $\mathcal{C}^\infty(\overline{\Omega}, \mathbb{C}^3)$ to $\mathbf{TL}^2(\Gamma)$ and they can be extended to continuous linear operators from $\mathbf{H}(\operatorname{curl}, \Omega)$ and $\mathbf{H}(\operatorname{curl}, \Omega) \cap \mathbf{H}(\operatorname{curl} \operatorname{curl}, \Omega)$, respectively, to $\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma)$.*

For $\mathbf{u} \in \mathbf{H}_{\text{loc}}(\operatorname{curl}, \overline{\Omega}^c)$ and $\mathbf{v} \in \mathbf{H}_{\text{loc}}(\operatorname{curl} \operatorname{curl}, \overline{\Omega}^c)$ we define $\gamma_D^c \mathbf{u}$ and $\gamma_N^c \mathbf{v}$ in the same way and the same mapping properties hold true.

Recall that we assume that the boundary Γ is smooth and topologically trivial. For a proof of the following result, we refer to [1, 7, 28].

Lemma 2.4. *Let $s \in \mathbb{R}$. The Laplace–Beltrami operator defined by*

$$\Delta_\Gamma u = \operatorname{div}_\Gamma \nabla_\Gamma u = -\operatorname{curl}_\Gamma \operatorname{curl}_\Gamma u. \quad (2.8)$$

is linear and continuous from $H^{s+2}(\Gamma)$ to $H^s(\Gamma)$. For $f \in H^s(\Gamma)$ and $u \in H^{s+2}(\Gamma)$, the equation $\Delta_\Gamma u = f$ has the equivalent formulation

$$\int_\Gamma \nabla_\Gamma u \cdot \nabla_\Gamma \varphi \, ds = - \int_\Gamma f \cdot \varphi \, ds, \quad \text{for all } \varphi \in H^{-s}(\Gamma). \quad (2.9)$$

The operator $\Delta_\Gamma : H^{s+2}(\Gamma) \rightarrow H^s(\Gamma)$ is Fredholm of index zero, its kernel and cokernel consisting of constant functions, so that $\Delta_\Gamma : H^{s+2}(\Gamma)/\mathbb{C} \rightarrow H_^s(\Gamma)$ is an isomorphism. Here we define the space $H_*^s(\Gamma)$ by*

$$f \in H_*^s(\Gamma) \iff f \in H^s(\Gamma) \text{ and } \int_\Gamma f \, ds = 0.$$

For $f \in H_^s(\Gamma)$ we denote the unique solution $u \in H^{s+2}(\Gamma)/\mathbb{C}$ of (2.9) by $u = \Delta_\Gamma^{-1} f$.*

This result is due to the injectivity of the operator ∇_Γ from $H^{s+2}(\Gamma)/\mathbb{C}$ to $\mathbf{TH}^{s+1}(\Gamma)$, the Lax–Milgram lemma applied to (2.9) for $s = -1$, and standard elliptic regularity theory. Note that $\operatorname{curl}_\Gamma$ is also injective from $H^{s+2}(\Gamma)/\mathbb{C}$ to $\mathbf{TH}^{s+1}(\Gamma)$, and by duality both $\operatorname{div}_\Gamma$ and $\operatorname{curl}_\Gamma$ are surjective from $\mathbf{TH}^{s+1}(\Gamma)$ to $H_*^s(\Gamma)$.

Notice that $\operatorname{curl}_\Gamma$ is defined in a natural way on all of $\mathbf{H}^{s+1}(\Gamma)$ and maps to $H_*^s(\Gamma)$, because we have $\operatorname{curl}_\Gamma(\varphi \mathbf{n}) = 0$ for any scalar function $\varphi \in H^{s+1}(\Gamma)$. Thus (2.5) is still valid for a not necessarily tangential density $\mathbf{j} \in \mathbf{H}^{s+1}(\Gamma)$. An analogous property for $\operatorname{div}_\Gamma$ defined by (2.3) is not available.

We now recall some well known results about electromagnetic potentials. Details can be found in [1, 3, 4, 5, 20, 28].

Let κ be a positive real number and let $G_a(\kappa, |x - y|) = \frac{e^{i\kappa|x-y|}}{4\pi|x-y|}$ be the fundamental solution of the Helmholtz equation $\Delta u + \kappa^2 u = 0$. The single layer potential Ψ_κ is given by

$$\Psi_\kappa u(x) = \int_\Gamma G_a(\kappa, |x-y|)u(y)ds(y) \quad x \in \mathbb{R}^3 \setminus \Gamma,$$

and its trace by

$$V_\kappa u(x) = \int_\Gamma G_a(\kappa, |x-y|)u(y)ds(y) \quad x \in \Gamma.$$

As discussed in the first part of this paper [9], the fundamental solution is pseudo-homogeneous of class -1 . The single layer potential $\Psi_\kappa u$ is continuous across the boundary Γ . As a consequence we have the following result :

Lemma 2.5. *Let $s \in \mathbb{R}$. The operators*

$$\begin{aligned} \Psi_\kappa &: H^{s-\frac{1}{2}}(\Gamma) \rightarrow H^{s+1}(\Omega) \cap H_{\text{loc}}^{s+1}(\overline{\Omega^c}) \left(H^{s-\frac{1}{2}}(\Gamma) \rightarrow H_{\text{loc}}^{s+1}(\mathbb{R}^3) \text{ if } s < \frac{1}{2} \right) \\ V_\kappa &: H^{s-\frac{1}{2}}(\Gamma) \rightarrow H^{s+\frac{1}{2}}(\Gamma) \end{aligned}$$

are continuous.

The electric potential operator Ψ_{E_κ} is defined for $\mathbf{j} \in \mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$ by

$$\Psi_{E_\kappa} \mathbf{j} := \kappa \Psi_\kappa \mathbf{j} + \frac{1}{\kappa} \nabla \Psi_\kappa \text{div}_\Gamma \mathbf{j}.$$

In $\mathbb{R}^3 \setminus \Gamma$, this can be written as $\Psi_{E_\kappa} \mathbf{j} := \frac{1}{\kappa} \mathbf{curl} \mathbf{curl} \Psi_\kappa \mathbf{j}$ because of the Helmholtz equation and the identity $\mathbf{curl} \mathbf{curl} = -\Delta + \nabla \text{div}$.

The magnetic potential operator Ψ_{M_κ} is defined for $\mathbf{m} \in \mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$ by

$$\Psi_{M_\kappa} \mathbf{m} := \mathbf{curl} \Psi_\kappa \mathbf{m}.$$

We denote the identity operator by \mathbf{I} .

Lemma 2.6. *The potentials operators Ψ_{E_κ} and Ψ_{M_κ} are continuous from $\mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$ to $\mathbf{H}_{\text{loc}}(\mathbf{curl}, \mathbb{R}^3)$. For $\mathbf{j} \in \mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$ we have*

$$(\mathbf{curl} \mathbf{curl} - \kappa^2 \mathbf{I}) \Psi_{E_\kappa} \mathbf{j} = 0 \text{ and } (\mathbf{curl} \mathbf{curl} - \kappa^2 \mathbf{I}) \Psi_{M_\kappa} \mathbf{m} = 0 \text{ in } \mathbb{R}^3 \setminus \Gamma,$$

and $\Psi_{E_\kappa} \mathbf{j}$ and $\Psi_{M_\kappa} \mathbf{m}$ satisfy the Silver-Müller condition.

We define the electric and the magnetic far field operators for a density \mathbf{j} and an element \hat{x} of the unit sphere S^2 of \mathbb{R}^3 by

$$\begin{aligned} \Psi_{E_\kappa}^\infty \mathbf{j}(\hat{x}) &= \kappa \hat{x} \wedge \left(\int_\Gamma e^{-i\kappa \hat{x} \cdot y} \mathbf{j}(y) ds(y) \right) \wedge \hat{x}, \\ \Psi_{M_\kappa}^\infty \mathbf{j}(\hat{x}) &= i\kappa \hat{x} \wedge \left(\int_\Gamma e^{-i\kappa \hat{x} \cdot y} \mathbf{j}(y) ds(y) \right). \end{aligned} \tag{2.10}$$

These operators are bounded from $\mathbf{TH}^s(\text{div}_\Gamma, \Gamma)$ to

$$\mathbf{TL}^2(S^2) = \{ \mathbf{h} \in \mathbf{L}^2(S^2); \mathbf{h}(\hat{x}) \cdot \hat{x} = 0 \}, \text{ for all } s \in \mathbb{R}.$$

We can now define the main boundary integral operators:

$$\begin{aligned} C_\kappa \mathbf{j}(x) &= - \int_\Gamma \mathbf{n}(x) \wedge \mathbf{curl} \mathbf{curl}^x \{ G_a(\kappa, |x-y|) \mathbf{j}(y) \} ds(y) \\ &= \left(-\kappa \mathbf{n} \wedge V_\kappa \mathbf{j} + \frac{1}{\kappa} \mathbf{curl}_\Gamma V_\kappa \text{div}_\Gamma \mathbf{j} \right) (x), \end{aligned} \tag{2.11}$$

and

$$\begin{aligned} M_\kappa \mathbf{j}(x) &= - \int_\Gamma \mathbf{n}(x) \wedge \mathbf{curl}^x \{G_a(\kappa, |x-y|) \mathbf{j}(y)\} ds(y) \\ &= (D_\kappa \mathbf{j} - B_\kappa \mathbf{j})(x), \end{aligned} \quad (2.12)$$

with

$$\begin{aligned} B_\kappa \mathbf{j}(x) &= \int_\Gamma \nabla^x G_a(\kappa, |x-y|) (\mathbf{j}(y) \cdot \mathbf{n}(x)) ds(y), \\ D_\kappa \mathbf{j}(x) &= \int_\Gamma (\nabla^x G_a(\kappa, |x-y|) \cdot \mathbf{n}(x)) \mathbf{j}(y) ds(y). \end{aligned}$$

The operators M_κ and C_κ are bounded operators from $\mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$ to itself.

3. The dielectric scattering problem

We consider the scattering of time-harmonic waves at a fixed frequency ω by a three-dimensional bounded and non-conducting homogeneous dielectric obstacle represented by the domain Ω . The electric permittivity ϵ and the magnetic permeability μ are assumed to take constant positive real values in Ω and Ω^c . Thus they will be discontinuous across the interface Γ , in general. The wave number is given by $\kappa = \omega \sqrt{\mu\epsilon}$. We distinguish the dielectric quantities related to the interior domain Ω through the index i and to the exterior domain Ω^c through the index e . The time-harmonic Maxwell system can be reduced to second order equations for the electric field only. The time-harmonic dielectric scattering problem is then formulated as follows.

The solution of the dielectric scattering problem : Consider the scattering of a given incident electric wave $\mathbf{E}^{inc} \in \mathbf{H}_{\text{loc}}(\mathbf{curl}, \mathbb{R}^3)$ that satisfies $\mathbf{curl} \mathbf{curl} \mathbf{E}^{inc} - \kappa_i^2 \mathbf{E}^{inc} = 0$ in a neighborhood of $\overline{\Omega}$. The interior electric field $\mathbf{E}^i \in \mathbf{H}(\mathbf{curl}, \Omega)$ and the exterior electric scattered field $\mathbf{E}^s \in \mathbf{H}_{\text{loc}}(\mathbf{curl}, \overline{\Omega^c})$ satisfy the time-harmonic Maxwell equations

$$\mathbf{curl} \mathbf{curl} \mathbf{E}^i - \kappa_i^2 \mathbf{E}^i = 0 \quad \text{in } \Omega, \quad (3.1)$$

$$\mathbf{curl} \mathbf{curl} \mathbf{E}^s - \kappa_e^2 \mathbf{E}^s = 0 \quad \text{in } \Omega^c, \quad (3.2)$$

the two transmission conditions,

$$\mathbf{n} \wedge \mathbf{E}^i = \mathbf{n} \wedge (\mathbf{E}^s + \mathbf{E}^{inc}) \quad \text{on } \Gamma \quad (3.3)$$

$$\mu_i^{-1} (\mathbf{n} \wedge \mathbf{curl} \mathbf{E}^i) = \mu_e^{-1} \mathbf{n} \wedge \mathbf{curl} (\mathbf{E}^s + \mathbf{E}^{inc}) \quad \text{on } \Gamma \quad (3.4)$$

and the Silver-Müller radiation condition:

$$\lim_{|x| \rightarrow +\infty} |x| \left| \mathbf{curl} \mathbf{E}^s(x) \wedge \frac{x}{|x|} - i \kappa_e \mathbf{E}^s(x) \right| = 0. \quad (3.5)$$

It is well known that the problem (3.1)-(3.5) admits a unique solution for any positive real values of the exterior wave number κ_e . We refer the reader to [5, 8, 26] for a proof via boundary integral equation methods.

To analyze the dependency of the solution on the shape of the scatterer Ω , we will use an integral representation of the solution, obtained by the single boundary integral equation method developed by the authors in [8]. It is based on the layer ansatz for the exterior electric field \mathbf{E}^s :

$$\mathbf{E}^s = -\Psi_{E_{\kappa_e}} \mathbf{j} - i\eta \Psi_{M_{\kappa_e}} C_0^* \mathbf{j} \quad \text{in } \mathbb{R}^3 \setminus \overline{\Omega} \quad (3.6)$$

where η is a positive real number, $\mathbf{j} \in \mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$ and the operator C_0^* is defined for $\mathbf{j} \in \mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$ by

$$C_0^* \mathbf{j} = -\mathbf{n} \wedge V_0 \mathbf{j} - \mathbf{curl}_\Gamma V_0 \text{div}_\Gamma \mathbf{j}.$$

Thanks to the transmission conditions and the Stratton-Chu formula, we have the integral representation of the interior field

$$\mathbf{E}^i = -\frac{1}{\rho} (\Psi_{E_{\kappa_i}} \{\gamma_{N_e}^c \mathbf{E}^{inc} + N_e \mathbf{j}\}) - (\Psi_{M_{\kappa_i}} \{\gamma_D^c \mathbf{E}^{inc} + L_e \mathbf{j}\}) \quad \text{in } \Omega \quad (3.7)$$

where $\rho = \frac{\kappa_i \mu_e}{\kappa_e \mu_i}$ and

$$L_e = C_{\kappa_e} + i\eta \left(-\frac{1}{2} \mathbf{I} + M_{\kappa_e} \right) C_0^*,$$

$$N_e = \left(-\frac{1}{2} \mathbf{I} + M_{\kappa_e} \right) + i\eta C_{\kappa_e} C_0^*.$$

The exterior Dirichlet trace applied to the right-hand side (3.7) vanishes. The density \mathbf{j} then solves the following boundary integral equation

$$\mathbf{S} \mathbf{j} \equiv \rho \left(-\frac{1}{2} \mathbf{I} + M_{\kappa_i} \right) L_e \mathbf{j} + C_{\kappa_i} N_e \mathbf{j} = -\rho \left(-\frac{1}{2} \mathbf{I} + M_{\kappa_i} \right) \gamma_D \mathbf{E}^{inc} + C_{\kappa_i} \gamma_{N_{\kappa_e}} \mathbf{E}^{inc}. \quad (3.8)$$

Theorem 3.1. *The operator \mathbf{S} from $\mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$ to itself is linear, bounded and invertible. Moreover, given the electric incident field $\mathbf{E}^{inc} \in \mathbf{H}_{\text{loc}}(\mathbf{curl}, \mathbb{R}^3)$, the integral representations (3.6), (3.7) of \mathbf{E}^i and \mathbf{E}^s give the unique solution of the dielectric scattering problem for all positive real values of the dielectric constants μ_i, μ_e, ϵ_i and ϵ_e .*

An important quantity that is of interest in many shape optimization problems is the far field pattern of the electric field, defined on the unit sphere of \mathbb{R}^3 by

$$\mathbf{E}^\infty(\hat{x}) = \lim_{|x| \rightarrow \infty} 4\pi |x| \frac{\mathbf{E}^s(x)}{e^{i\kappa_e |x|}}, \quad \text{with } \frac{x}{|x|} = \hat{x}.$$

We have $\mathbf{E}^\infty \in \mathbf{TL}^2(S^2) \cap \mathcal{C}^\infty(S^2, \mathbb{C}^3)$. To obtain the integral representation of the far field \mathbf{E}^∞ of the solution, it suffices to replace in (3.6) the potential operators $\Psi_{E_{\kappa_e}}$ and $\Psi_{M_{\kappa_e}}$ by the far field operators $\Psi_{E_{\kappa_e}}^\infty$ and $\Psi_{M_{\kappa_e}}^\infty$ defined in (2.10), respectively.

In the method we have described, the solution $\mathbf{E} = (\mathbf{E}^i, \mathbf{E}^s)$ and the far field \mathbf{E}^∞ are constructed from operators defined by integrals on the boundary Γ and the incident field. For a fixed incident field and fixed constants κ_i, κ_e ,

μ_i, μ_e , these quantities therefore depend on the geometry of the boundary Γ of the scatterer Ω only. In the sequel we analyze the Γ -dependence of the solution following the definition of shape derivatives and the notations of section 4 of the paper [9].

4. Shape dependence via Helmholtz decomposition

Let us fix a reference domain Ω . We consider variations of Ω generated by transformations of the form $x \mapsto x+r(x)$ of points $x \in \mathbb{R}^3$, where r is a smooth vector function defined on Γ . This transformation deforms the domain Ω in a domain Ω_r of boundary Γ_r . The functions r are assumed to belong to the Fréchet space $\mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$. For $\varepsilon > 0$ and some metric d_∞ on $\mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$, we set

$$B^\infty(0, \varepsilon) = \{r \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3), d_\infty(0, r) < \varepsilon\}.$$

In the following, we choose ε small enough so that for any $r \in B^\infty(0, \varepsilon)$, $(I+r)$ is a diffeomorphism from Γ to $\Gamma_r = (I+r)\Gamma = \{x_r = x + r(x); x \in \Gamma\}$.

The aim of this paper is to study the shape differentiability, that is, the Gâteaux differentiability with respect to r , of the functionals mapping r to the solution

$$(\mathcal{E}^i(r), \mathcal{E}^s(r)) = (\mathbf{E}^i(\Gamma_r), \mathbf{E}^s(\Gamma_r))$$

of the dielectric scattering problem with obstacle Ω_r , and to the far field $\mathcal{E}^\infty(r) = \mathbf{E}^\infty(\Gamma_r)$.

In the following, we use the superscript r for integral operators and trace mappings pertaining to Γ_r , while functions defined on Γ_r will often have a subscript r . According to the boundary integral equation method described in the previous section, we have

$$\mathcal{E}^s(r) = \left(-\Psi_{E_{\kappa_e}}^r - i\eta\Psi_{M_{\kappa_e}}^r C_0^{*,r} \right) \mathbf{j}_r \quad \text{in } \Omega_r^c = \mathbb{R}^3 \setminus \overline{\Omega_r}, \quad (4.1)$$

where \mathbf{j}_r solves the integral equation

$$\mathbf{S}^r \mathbf{j}_r = -\rho \left(-\frac{1}{2}\mathbf{I} + M_{\kappa_i}^r \right) \gamma_D^r \mathbf{E}^{inc} - C_{\kappa_i}^r \gamma_{N_{\kappa_e}}^r \mathbf{E}^{inc},$$

and

$$\mathcal{E}^i(r) = -\frac{1}{\rho} \Psi_{E_{\kappa_i}}^r \gamma_{N_{\kappa_e}}^{c,r} \mathcal{E}^{tot}(r) - \Psi_{M_{\kappa_i}}^r \gamma_D^{c,r} \mathcal{E}^{tot}(r) \quad \text{in } \Omega_r, \quad (4.2)$$

with

$$\mathcal{E}^{tot}(r) = \mathbf{E}^{inc} + \mathcal{E}^s(r). \quad (4.3)$$

The far field pattern of the dielectric scattering problem by the interface Γ_r is

$$\mathcal{E}^\infty(r) = \left(-\Psi_{E_{\kappa_e}}^{\infty,r} - i\eta\Psi_{M_{\kappa_e}}^{\infty,r} C_0^{*,r} \right) \mathbf{j}_r.$$

As defined in (3.8), the operator \mathbf{S}^r is composed of the operators $C_{\kappa_e}^r, M_{\kappa_e}^r, C_{\kappa_i}^r$ et $M_{\kappa_i}^r$, which are all bounded operators on the space $\mathbf{TH}^{-\frac{1}{2}}(\text{div}_{\Gamma_r}, \Gamma_r)$.

Therefore we have to study the Gâteaux differentiability of the following mappings on $B^\infty(0, \varepsilon)$

$$\begin{aligned} r &\mapsto M_\kappa^r, C_\kappa^r \in \mathcal{L}(\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma_r}, \Gamma_r)) \\ r &\mapsto \Psi_{M_\kappa}^r, \Psi_{E_\kappa}^r \in \mathcal{L}(\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma_r}, \Gamma_r), \mathbf{H}(\operatorname{curl}, \Omega_r) \cup \mathbf{H}_{loc}(\operatorname{curl}, \overline{\Omega_r^c})) \\ r &\mapsto \Psi_{M_\kappa}^{\infty, r}, \Psi_{E_\kappa}^{\infty, r} \in \mathcal{L}(\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma_r}, \Gamma_r), \mathbf{TL}^2(S^2) \cap \mathcal{C}^\infty(S^2, \mathbb{C}^3)). \end{aligned}$$

Finally, the differentiability properties of the mapping $r \mapsto C_0^{*r}$ can be deduced from those of the mapping $r \mapsto C_\kappa^r$.

In this approach, several difficulties have to be overcome. The first one is that if we want to find the derivatives of the solution of the scattering problem, which is given as a product of operators and of their inverses, all defined on the same space $\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma)$ (for the derivative at $r = 0$), it is necessary to prove that the derivatives themselves are defined as bounded operators on the same space, too. On the other hand, the very definition of the differentiability of operators defined on $\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma)$ raises non-trivial questions. For reducing the variable space $\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma_r}, \Gamma_r)$ to a fixed reference space, it is not sufficient, as we did in the scalar case studied in the first part [9], to use a change of variables. Let us discuss this question: *How to define the shape derivative of operators defined on the variable space $\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma_r}, \Gamma_r)$?* in detail.

We recall the notation τ_r for the “pullback” induced by the change of variables. It maps a function u_r defined on Γ_r to the function $\tau_r u_r = u_r \circ (\mathbf{I} + r)$ defined on Γ . For $r \in B^\infty(0, \varepsilon)$, the transformation τ_r is an isomorphism from $H^t(\Gamma_r)$ to $H^t(\Gamma)$. We have

$$(\tau_r u_r)(x) = u_r(x + r(x)) \text{ and } (\tau_r^{-1} u)(x_r) = u(x).$$

The natural idea to use this for a product of operators, proposed by Potthast in [29] in the acoustic case, is to insert the identity $\tau_r^{-1} \tau_r = \mathbf{I}_{\mathbf{H}^{-\frac{1}{2}}(\Gamma_r)}$ between the factors. This allows to consider integral operators on the fixed boundary Γ only and to would require study the differentiability of the mappings

$$r \mapsto \tau_r C_\kappa^r \tau_r^{-1}, \quad r \mapsto \tau_r M_\kappa^r \tau_r^{-1}, \quad r \mapsto \Psi_{E_\kappa}^r \tau_r^{-1}, \quad r \mapsto \Psi_{M_\kappa}^r \tau_r^{-1}, \quad (4.4)$$

but as has been already pointed out in [30], difficulties remain. The main cause for this is that τ_r does not map vector fields tangential to Γ_r to vector fields tangential to Γ , and in particular,

$$\tau_r(\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma_r}, \Gamma_r)) \neq \mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma).$$

This will lead to a loss of regularity if we simply try to differentiate the mappings in (4.4). Let us explain this for the operator M_κ . The operator M_κ^r , when acting on vector fields tangential to Γ_r , has additional regularity like what is known for the scalar double layer potential, namely it has a pseudo-homogeneous kernel of class -1 , whereas it is of class 0 when considered on all vector fields (see (2.12)). If we differentiate the kernel of $\tau_r M_\kappa^r \tau_r^{-1}$, we will not obtain a pseudo-homogeneous kernel of class -1 on the set of vector

fields tangential to Γ , so that we find a loss of regularity for the Gâteaux derivative of $\tau_r M_\kappa^r \tau_r^{-1}$.

For mapping tangent vector fields to tangent vector fields, the idea of Potthast was to use projectors from one tangent plane to the other. Let us denote by $\pi(r)$ the pullback τ_r followed by orthogonal projection to the tangent plane to Γ . This maps any vector function on Γ_r to a tangential vector function on Γ , and we have

$$(\pi(r)\mathbf{u}_r)(x) = \mathbf{u}_r(x + r(x)) - (\mathbf{n}(x) \cdot \mathbf{u}_r(x + r(x))) \mathbf{n}(x).$$

The restriction of $\pi(r)$ to tangential functions on Γ_r admits an inverse, denoted by $\pi^{-1}(r)$, if r is sufficiently small. The mapping $\pi^{-1}(r)$ is defined by

$$(\pi^{-1}(r)\mathbf{u})(x + r(x)) = \mathbf{u}(x) - \mathbf{n}(x) \frac{\mathbf{n}_r(x + r(x)) \cdot \mathbf{u}(x)}{\mathbf{n}_r(x + r(x)) \cdot \mathbf{n}(x)},$$

and it is easy to see that $\pi(r)$ is an isomorphism between the space of continuous tangential vector functions on Γ_r and on Γ , and for any t between $\mathbf{TH}^t(\Gamma_r)$ and $\mathbf{TH}^t(\Gamma)$.

In the framework of continuous tangential functions it suffices to insert the product $\pi^{-1}(r)\pi(r) = \mathbf{I}_{\Gamma \mathcal{C}^0(\Gamma_r)}$ between factors in the integral representation of the solution to reduce the analysis to the study of boundary integral operators defined on $\mathbf{TC}^0(\Gamma)$, which does not depend on r . In our case, we would obtain operators defined on the space

$$\pi(r) \left(\mathbf{TH}^{-\frac{1}{2}}(\text{div}_{\Gamma_r}, \Gamma_r) \right) = \left\{ u \in \mathbf{TH}^{-\frac{1}{2}}(\Gamma), \text{div}_{\Gamma_r}(\pi^{-1}(r)\mathbf{u}) \in H^{-\frac{1}{2}}(\Gamma_r) \right\},$$

which still depends on r and is, in general, different from $\mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$.

We propose a different approach, using the Helmholtz decomposition of the space $\mathbf{TH}^{-\frac{1}{2}}(\text{div}_{\Gamma_r}, \Gamma_r)$ to introduce a new pullback operator \mathbf{P}_r that defines an isomorphism between $\mathbf{TH}^{-\frac{1}{2}}(\text{div}_{\Gamma_r}, \Gamma_r)$ and $\mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$.

Recall that we assume that the boundary Γ is smooth and simply connected. We have the following decomposition. We refer to [10] for the proof.

Theorem 4.1. *The Hilbert space $\mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$ admits the following Helmholtz decomposition:*

$$\mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma) = \nabla_\Gamma H^{\frac{3}{2}}(\Gamma) \oplus \mathbf{curl}_\Gamma H^{\frac{1}{2}}(\Gamma). \quad (4.5)$$

Since ε is chosen such that for all $r \in B^\infty(0, \varepsilon)$ the surfaces Γ_r are still regular and simply connected, the spaces $\mathbf{TH}^{-\frac{1}{2}}(\text{div}_{\Gamma_r}, \Gamma_r)$ admit similar decompositions.

The operator of change of variables τ_r is an isomorphism from $H^{\frac{3}{2}}(\Gamma_r)$ to $H^{\frac{3}{2}}(\Gamma)$ and from $H^{\frac{1}{2}}(\Gamma_r)$ to $H^{\frac{1}{2}}(\Gamma)$, and it maps constant functions to constant functions. Let $\mathbf{j}_r \in \mathbf{TH}^{-\frac{1}{2}}(\text{div}_{\Gamma_r}, \Gamma_r)$ and let $\mathbf{j}_r = \nabla_{\Gamma_r} p_r + \mathbf{curl}_{\Gamma_r} q_r$ be its Helmholtz decomposition. The scalar functions p_r and q_r are determined

uniquely up to additive constants. The following operator :

$$\begin{aligned} \mathbf{P}_r : \mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma_r}, \Gamma_r) &\longrightarrow \mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma}, \Gamma) \\ \mathbf{j}_r = \nabla_{\Gamma_r} p_r + \mathbf{curl}_{\Gamma_r} q_r &\mapsto \mathbf{j} = \nabla_{\Gamma} (\tau_r p_r) + \mathbf{curl}_{\Gamma} (\tau_r q_r) \end{aligned} \quad (4.6)$$

is therefore well defined, linear, continuous and invertible. Its inverse \mathbf{P}_r^{-1} is given by

$$\begin{aligned} \mathbf{P}_r^{-1} : \mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma}, \Gamma) &\longrightarrow \mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma_r}, \Gamma_r) \\ \mathbf{j} = \nabla_{\Gamma} p + \mathbf{curl}_{\Gamma} q &\mapsto \mathbf{j}_r = \nabla_{\Gamma_r} \tau_r^{-1}(p) + \mathbf{curl}_{\Gamma_r} \tau_r^{-1}(q). \end{aligned} \quad (4.7)$$

Obviously for $r = 0$ we have $\mathbf{P}_r = \mathbf{P}_r^{-1} = \mathbf{I}_{\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma}, \Gamma)}$. We can now insert the identity $\mathbf{I}_{\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma_r}, \Gamma_r)} = \mathbf{P}_r^{-1} \mathbf{P}_r$ between factors in the integral representation of the solution $(\mathcal{E}^i(r), \mathcal{E}^s(r))$, and we are finally led to study the Gâteaux differentiability properties of the following mappings, defined on r -independent spaces.

$$\begin{aligned} B^\infty(0, \varepsilon) &\rightarrow \mathcal{L}(\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma}, \Gamma), \mathbf{H}(\mathbf{curl}, K_p)) &: r \mapsto \Psi_{E_\kappa}^r \mathbf{P}_r^{-1} \\ B^\infty(0, \varepsilon) &\rightarrow \mathcal{L}(\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma}, \Gamma), \mathbf{H}(\mathbf{curl}, K_p)) &: r \mapsto \Psi_{M_\kappa}^r \mathbf{P}_r^{-1} \\ B^\infty(0, \varepsilon_p) &\rightarrow \mathcal{L}(\mathbf{TH}^s(\operatorname{div}_{\Gamma}, \Gamma), \mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma}, \Gamma)) &: r \mapsto \mathbf{P}_r M_\kappa^r \mathbf{P}_r^{-1} \\ B^\infty(0, \varepsilon_p) &\rightarrow \mathcal{L}(\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma}, \Gamma), \mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma}, \Gamma)) &: r \mapsto \mathbf{P}_r C_\kappa^r \mathbf{P}_r^{-1} \end{aligned} \quad (4.8)$$

where K_p is a compact subset of $\mathbb{R}^3 \setminus \Gamma$. These mappings are composed of scalar singular integral operators, the shape derivatives of which we studied in the first part [9], of surface differential operators, and of the inverse of the Laplace–Beltrami operator, which appears in the construction of the Helmholtz decomposition.

Let us look at the representation of the operators in (4.8) in terms of the Helmholtz decomposition.

Helmholtz representation of $\Psi_{E_\kappa}^r \mathbf{P}_r^{-1}$

The operator $\Psi_{E_\kappa}^r \mathbf{P}_r^{-1}$ is defined for $\mathbf{j} = \nabla_{\Gamma} p + \mathbf{curl}_{\Gamma} q \in \mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma}, \Gamma)$ and $x \in K_p$ by:

$$\begin{aligned} \Psi_{E_\kappa}^r \mathbf{P}_r^{-1} \mathbf{j}(x) &= \kappa \int_{\Gamma_r} G_a(\kappa, |x - y_r|) (\nabla_{\Gamma_r} \tau_r^{-1} p)(y_r) ds(y_r) \\ &\quad + \kappa \int_{\Gamma_r} G_a(\kappa, |x - y_r|) (\mathbf{curl}_{\Gamma_r} \tau_r^{-1} q)(y_r) ds(y_r) \\ &\quad + \frac{1}{\kappa} \nabla \int_{\Gamma_r} G_a(\kappa, |x - y_r|) (\Delta_{\Gamma_r} \tau_r^{-1} p)(y_r) ds(y_r). \end{aligned}$$

Helmholtz representation of $\Psi_{M_\kappa}^r \mathbf{P}_r^{-1}$

The operator $\Psi_{M_\kappa}^r \mathbf{P}_r^{-1}$ is defined for $\mathbf{j} = \nabla_{\Gamma} p + \mathbf{curl}_{\Gamma} q \in \mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_{\Gamma}, \Gamma)$

and $x \in K_p$ by:

$$\begin{aligned} \Psi_{M_\kappa}^r \mathbf{P}_r^{-1} \mathbf{j}(x) &= \mathbf{curl} \int_{\Gamma_r} G_a(\kappa, |x - y_r|) (\nabla_{\Gamma_r} \tau_r^{-1} p)(y_r) ds(y_r) \\ &\quad + \mathbf{curl} \int_{\Gamma_r} G_a(\kappa, |x - y_r|) (\mathbf{curl}_{\Gamma_r} \tau_r^{-1} q)(y_r)(y_r) ds(y_r). \end{aligned}$$

Helmholtz representation of $\mathbf{P}_r C_\kappa^r \mathbf{P}_r^{-1}$

Recall that for $\mathbf{j}_r \in \mathbf{TH}^{-\frac{1}{2}}(\text{div}_{\Gamma_r}, \Gamma_r)$, the operator C_κ^r is defined by

$$\begin{aligned} C_\kappa^r \mathbf{j}_r(x_r) &= -\kappa \mathbf{n}_r(x_r) \wedge \int_{\Gamma_r} G_a(\kappa, |x_r - y_r|) \mathbf{j}_r(y_r) ds(y_r) \\ &\quad - \frac{1}{\kappa} \mathbf{n}_r(x_r) \wedge \nabla_{\Gamma_r}^{x_r} \int_{\Gamma_r} G_a(\kappa, |x_r - y_r|) \text{div}_{\Gamma_r} \mathbf{j}_r(y_r) ds(y_r). \end{aligned}$$

We want to write $C_\kappa^r \mathbf{j}_r$ in the form $\nabla_{\Gamma_r} P_r + \mathbf{curl}_{\Gamma_r} Q_r$. Using formulas (2.6)–(2.7), we find

$$\text{div}_{\Gamma_r} C_\kappa^r \mathbf{j}_r = \Delta_{\Gamma_r} P_r \quad \text{and} \quad \mathbf{curl}_{\Gamma_r} C_\kappa^r \mathbf{j}_r = -\Delta_{\Gamma_r} Q_r.$$

As a consequence we have for $x_r \in \Gamma_r$

$$P_r(x_r) = -\kappa \Delta_{\Gamma_r}^{-1} \text{div}_{\Gamma_r} \left(\mathbf{n}_r(x_r) \wedge \int_{\Gamma_r} G_a(\kappa, |x_r - y_r|) \mathbf{j}_r(y_r) ds(y_r) \right) \quad (4.9)$$

and

$$\begin{aligned} Q_r(x_r) &= -\kappa (-\Delta_{\Gamma_r}^{-1}) \mathbf{curl}_{\Gamma_r} \left(\mathbf{n}_r(x_r) \wedge \int_{\Gamma_r} G_a(\kappa, |x_r - y_r|) \mathbf{j}_r(y_r) ds(y_r) \right) \\ &\quad - \frac{1}{\kappa} (-\Delta_{\Gamma_r}) \mathbf{curl}_{\Gamma_r} \left(-\mathbf{curl}_{\Gamma_r} \int_{\Gamma_r} G_a(\kappa, |x_r - y_r|) \text{div}_{\Gamma_r} \mathbf{j}_r(y_r) ds(y_r) \right) \\ &= \kappa \Delta_{\Gamma_r}^{-1} \mathbf{curl}_{\Gamma_r} \left(\mathbf{n}_r(x_r) \wedge \int_{\Gamma_r} G_a(\kappa, |x_r - y_r|) \mathbf{j}_r(y_r) ds(y_r) \right) \\ &\quad + \frac{1}{\kappa} \int_{\Gamma_r} G_a(\kappa, |x_r - y_r|) \text{div}_{\Gamma_r} \mathbf{j}_r(y_r) ds(y_r). \end{aligned}$$

The operator $\mathbf{P}_r C_\kappa^r \mathbf{P}_r^{-1}$ is defined for $\mathbf{j} = \nabla_\Gamma p + \mathbf{curl}_\Gamma q \in \mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$ by

$$\mathbf{P}_r C_\kappa^r \mathbf{P}_r^{-1} = \nabla_\Gamma P(r) + \mathbf{curl}_\Gamma Q(r),$$

with

$$\begin{aligned} P(r)(x) &= \\ -\kappa (\tau_r \Delta_{\Gamma_r}^{-1} \text{div}_{\Gamma_r} \tau_r^{-1}) \left((\tau_r \mathbf{n}_r)(x) \wedge \tau_r \left\{ \int_{\Gamma_r} G_a(\kappa, |\cdot - y_r|) (\nabla_{\Gamma_r} \tau_r^{-1} p)(y_r) ds(y_r) \right. \right. \\ &\quad \left. \left. + \int_{\Gamma_r} G_a(\kappa, |\cdot - y_r|) (\mathbf{curl}_{\Gamma_r} \tau_r^{-1} q)(y_r) ds(y_r) \right\} (x) \right) \end{aligned}$$

and

$$\begin{aligned}
Q(r)(x) = & \\
\kappa (\tau_r \Delta_{\Gamma_r}^{-1} \mathbf{curl}_{\Gamma_r} \tau_r^{-1}) & \left((\tau_r \mathbf{n}_r)(x) \wedge \tau_r \left\{ \int_{\Gamma_r} G_a(\kappa, |\cdot - y_r|) (\nabla_{\Gamma_r} \tau_r^{-1} p)(y_r) ds(y_r) \right. \right. \\
& \left. \left. + \int_{\Gamma_r} G_a(\kappa, |\cdot - y_r|) (\mathbf{curl}_{\Gamma_r} \tau_r^{-1} q)(y_r) ds(y_r) \right\} (x) \right) \\
& + \frac{1}{\kappa} \tau_r \left(\int_{\Gamma_r} G_a(\kappa, |\cdot - y_r|) (\Delta_{\Gamma_r} \tau_r^{-1} p)(y_r) ds(y_r) \right) (x).
\end{aligned}$$

Helmholtz representation of $\mathbf{P}_r M_\kappa^r \mathbf{P}_r^{-1}$

Recall that for all $\mathbf{j}_r \in \mathbf{TH}^{-\frac{1}{2}}(\text{div}_{\Gamma_r}, \Gamma_r)$, the operator M_κ^r is defined by

$$\begin{aligned}
M_\kappa^r \mathbf{j}_r(x_r) = & \int_{\Gamma_r} ((\nabla^{x_r} G_a(\kappa, |x_r - y_r|)) \cdot \mathbf{n}_r(x_r)) \mathbf{j}_r(y_r) ds(y_r) \\
& - \int_{\Gamma_r} \nabla^{x_r} G_a(\kappa, |x_r - y_r|) (\mathbf{n}_r(x_r) \cdot \mathbf{j}_r(y_r)) ds(y_r).
\end{aligned}$$

Using the equalities (2.7) and the identity $\mathbf{curl} \mathbf{curl} = -\Delta + \nabla \text{div}$, we have

$$\begin{aligned}
\text{div}_{\Gamma_r} M_\kappa^r \mathbf{j}_r(x_r) = & \mathbf{n}_r(x_r) \cdot \int_{\Gamma_r} \mathbf{curl} \mathbf{curl}^{x_r} \{G_a(\kappa, |x_r - y_r|) \mathbf{j}_r(y_r)\} ds(y_r) \\
= & \kappa^2 \mathbf{n}_r(x_r) \cdot \int_{\Gamma_r} \{G_a(\kappa, |x_r - y_r|) \mathbf{j}_r(y_r)\} ds(y_r) \\
& + \int_{\Gamma_r} \frac{\partial}{\partial \mathbf{n}_r(x_r)} \{G_a(\kappa, |x_r - y_r|) \text{div}_{\Gamma_r} \mathbf{j}_r(y_r)\} ds(y_r).
\end{aligned}$$

Proceeding in the same way as with the operator $\mathbf{P}_r C_\kappa^r \mathbf{P}_r^{-1}$, we obtain that the operator $\mathbf{P}_r M_\kappa^r \mathbf{P}_r^{-1}$ is defined for $\mathbf{j} = \nabla_\Gamma p + \mathbf{curl}_\Gamma q \in \mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$ by:

$$\mathbf{P}_r M_\kappa^r \mathbf{P}_r^{-1} \mathbf{j} = \nabla_\Gamma P'(r) + \mathbf{curl}_\Gamma Q'(r),$$

with

$$\begin{aligned}
P'(r)(x) = & \\
(\tau_r \Delta_{\Gamma_r}^{-1} \tau_r^{-1}) \tau_r & \left\{ \kappa^2 \int_{\Gamma_r} \mathbf{n}_r \cdot \{G_a(\kappa, |\cdot - y_r|) \mathbf{curl}_{\Gamma_r} \tau_r^{-1} q(y_r)\} ds(y_r) \right. \\
& + \kappa^2 \int_{\Gamma_r} \mathbf{n}_r \cdot \{G_a(\kappa, |\cdot - y_r|) \nabla_{\Gamma_r} \tau_r^{-1} p(y_r)\} ds(y_r) \\
& \left. + \int_{\Gamma_r} \frac{\partial}{\partial \mathbf{n}_r} G_a(\kappa, |\cdot - y_r|) (\Delta_{\Gamma_r} \tau_r^{-1} p)(y_r) ds(y_r) \right\} (x),
\end{aligned}$$

and

$$\begin{aligned}
Q'_r(x) = & \\
& (\tau_r \Delta_{\Gamma_r}^{-1} \operatorname{curl}_{\Gamma_r} \tau_r^{-1}) \tau_r \left\{ \int_{\Gamma_r} (\nabla G_a(\kappa, |\cdot - y_r|) \cdot \mathbf{n}_r) (\mathbf{curl}_{\Gamma_r} \tau_r^{-1} q)(y_r) ds(y_r) \right. \\
& + \int_{\Gamma_r} ((\nabla G_a(\kappa, |\cdot - y_r|) \cdot \mathbf{n}_r) (\nabla_{\Gamma_r} \tau_r^{-1} p)(y_r) ds(y_r) \\
& - \int_{\Gamma_r} \nabla G_a(\kappa, |\cdot - y_r|) (\mathbf{n}_r \cdot (\mathbf{curl}_{\Gamma_r} \tau_r^{-1} q)(y_r)) ds(y_r) \\
& \left. - \int_{\Gamma_r} \nabla G_a(\kappa, |\cdot - y_r|) (\mathbf{n}_r \cdot (\nabla_{\Gamma_r} \tau_r^{-1} p)(y_r)) ds(y_r) \right\} (x).
\end{aligned}$$

These operators are composed of boundary integral operators with weakly singular kernel and of the surface differential operators defined in section 2. Each of these weakly singular boundary integral operators has a pseudo-homogeneous kernel of class -1. The \mathcal{C}^∞ -Gâteaux differentiability properties of such boundary integral operators has been established in the preceding paper [9]. It remains now to show that the surface differential operators, more precisely $\tau_r \nabla_{\Gamma_r} \tau_r^{-1}$, $\tau_r \mathbf{curl}_{\Gamma_r} \tau_r^{-1}$, $\tau_r \operatorname{div}_{\Gamma_r} \tau_r^{-1}$, $\tau_r \operatorname{curl}_{\Gamma_r} \tau_r^{-1}$, as well as $\tau_r \Delta_{\Gamma_r} \tau_r^{-1}$ and its inverse, preserve their mapping properties by differentiation with respect to r .

5. Gâteaux differentiability of surface differential operators

The analysis of the surface differential operators requires the differentiability properties of some auxiliary functions, such as the outer unit normal vector \mathbf{n}_r and the Jacobian J_r of the change of variable $x \mapsto x + r(x)$. We recall some results established in the first part [9, section 4]. For the definition of Gâteaux derivatives and the corresponding analysis, see [33].

Lemma 5.1. *The mapping $\mathcal{N} : B^\infty(0, \varepsilon) \ni r \mapsto \tau_r \mathbf{n}_r = \mathbf{n}_r \circ (\mathbf{I} + r) \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$ is \mathcal{C}^∞ -Gâteaux-differentiable and its first derivative in the direction of $\xi \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$ is given by*

$$d\mathcal{N}[r, \xi] = - [\tau_r \nabla_{\Gamma_r} (\tau_r^{-1} \xi)] \mathcal{N}(r).$$

Lemma 5.2. *The mapping \mathcal{J} from $r \in B^\infty(0, \varepsilon)$ to the surface Jacobian $J_r \in \mathcal{C}^\infty(\Gamma, \mathbb{R})$ is \mathcal{C}^∞ -Gâteaux differentiable and its first derivative in the direction of $\xi \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$ is given by*

$$d\mathcal{J}[r_0, \xi] = J_{r_0} \cdot (\tau_{r_0} \operatorname{div}_{\Gamma_{r_0}} (\tau_{r_0}^{-1} \xi)).$$

The differentiability properties of the tangential gradient and of the surface divergence in the framework of classical Sobolev spaces is established in [9, section 5].

Lemma 5.3. *The mapping*

$$\begin{aligned} \mathcal{G} : B^\infty(0, \varepsilon) &\rightarrow \mathcal{L}(H^{s+1}(\Gamma), \mathbf{H}^s(\Gamma)) \\ r &\mapsto \tau_r \nabla_{\Gamma_r} \tau_r^{-1} \end{aligned}$$

is \mathcal{C}^∞ -Gâteaux differentiable and its first derivative for $\xi \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$ is given by

$$d\mathcal{G}[r, \xi]u = -[\mathcal{G}(r)\xi]\mathcal{G}(r)u + (\mathcal{G}(r)u \cdot [\mathcal{G}(r)\xi]\mathcal{N}(r))\mathcal{N}(r).$$

Lemma 5.4. *The mapping*

$$\begin{aligned} \mathcal{D} : B^\infty(0, \varepsilon) &\rightarrow \mathcal{L}(\mathbf{H}^{s+1}(\Gamma), H^s(\Gamma)) \\ r &\mapsto \tau_r \operatorname{div}_{\Gamma_r} \tau_r^{-1} \end{aligned}$$

is \mathcal{C}^∞ -Gâteaux differentiable and its first derivative for $\xi \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$ is given by

$$d\mathcal{D}[r, \xi]\mathbf{u} = -\operatorname{Trace}([\mathcal{G}(r)\xi][\mathcal{G}(r)\mathbf{u}]) + ([\mathcal{G}(r)\mathbf{u}]\mathcal{N}(r) \cdot [\mathcal{G}(r)\xi]\mathcal{N}(r)).$$

Similar results can now be obtained for the tangential vector curl by composition of the tangential gradient with the normal vector.

Lemma 5.5. *The mapping*

$$\begin{aligned} \mathcal{R} : B^\infty(0, \varepsilon) &\rightarrow \mathcal{L}(H^{s+1}(\Gamma), \mathbf{H}^s(\Gamma)) \\ r &\mapsto \tau_r \operatorname{curl}_{\Gamma_r} \tau_r^{-1} \end{aligned}$$

is \mathcal{C}^∞ -Gâteaux differentiable and its first derivative for $\xi \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$ is given by

$$d\mathcal{R}[r, \xi]u = [\mathcal{G}(r)\xi]^\top \mathcal{R}(r)u - \mathcal{D}(r)\xi \cdot \mathcal{R}(r)u.$$

Proof. Let $u \in H^{s+1}(\Gamma)$. By definition, we have $\mathcal{R}(r)u = \mathcal{G}(r)u \wedge \mathcal{N}(r)$. By lemmas 5.1 and 5.3 this application is \mathcal{C}^∞ -Gâteaux differentiable. For the derivative in the direction $\xi \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$ we find

$$d\mathcal{R}[r, \xi]u = -[\mathcal{G}(r)\xi]\mathcal{G}(r)u \wedge \mathcal{N}(r) - \mathcal{G}(r)u \wedge [\mathcal{G}(r)\xi]\mathcal{N}(r).$$

For any (3×3) matrix A and vectors b and c there holds

$$(Ab) \wedge c + b \wedge Ac = \operatorname{Trace}(A)(b \wedge c) - A^\top(b \wedge c).$$

We obtain the expression of the first derivative with the choice $A = -[\mathcal{G}(r)\xi]$, $b = \mathcal{G}(r)u$ and $c = \mathcal{N}(r)$. \square

Lemma 5.6. *The mapping*

$$\begin{aligned} \mathcal{R} : B^\infty(0, \varepsilon) &\rightarrow \mathcal{L}(\mathbf{H}^{s+1}(\Gamma), H^s(\Gamma)) \\ r &\mapsto \tau_r \operatorname{curl}_{\Gamma_r} \tau_r^{-1} \end{aligned}$$

is \mathcal{C}^∞ -Gâteaux differentiable and its first derivative for $\xi \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$ is given by

$$d\mathcal{R}[r, \xi]\mathbf{u} = -\sum_{i=1}^3 (\mathcal{G}(r)\xi_i \cdot \mathcal{R}(r)u_i) - \mathcal{D}(r)\xi \cdot \mathcal{R}(r)\mathbf{u}$$

where $\mathbf{u} = (u_1, u_2, u_3)$ and $\xi = (\xi_1, \xi_2, \xi_3)$.

Proof. Let $\mathbf{u} \in \mathbf{H}^{s+1}(\Gamma)$. Notice that we have $\operatorname{curl}_{\Gamma} \mathbf{u} = -\operatorname{Trace}([\mathbf{curl}_{\Gamma} \mathbf{u}])$. We can therefore write

$$\mathcal{R}(r)\mathbf{u} = -\operatorname{Trace}(\mathcal{R}(r)\mathbf{u}).$$

The \mathcal{C}^{∞} -differentiability of R results from the \mathcal{C}^{∞} -differentiability of \mathcal{R} . The first derivative in the direction ξ is

$$\begin{aligned} d\mathcal{R}[r, \xi]\mathbf{u} &= -\operatorname{Trace}(d\mathcal{R}[r, \xi]\mathbf{u}) \\ &= -\operatorname{Trace}\left([\mathcal{G}(r)\xi]^{\top}[\mathcal{R}(r)\mathbf{u}]\right) - \mathcal{D}(r)\xi \cdot \operatorname{Trace}(-\mathcal{R}(r)\mathbf{u}) \\ &= -\sum_{i=1}^3 (\mathcal{G}(r)\xi_i \cdot \mathcal{R}(r)\mathbf{u}_i) - \mathcal{D}(r)\xi \cdot \mathcal{R}(r)\mathbf{u}. \end{aligned}$$

□

Higher order derivatives of the tangential vector curl operator and of the surface scalar curl operator can be obtained by applying these results recursively.

In view of the integral representations of the operators $\mathbf{P}_r C_{\kappa}^r \mathbf{P}_r^{-1}$ and $\mathbf{P}_r M_{\kappa}^r \mathbf{P}_r^{-1}$, we have to study the Gâteaux differentiability of the mappings

$$\begin{aligned} r &\mapsto \tau_r \Delta_{\Gamma_r}^{-1} \operatorname{div}_{\Gamma_r} \tau_r^{-1} \\ r &\mapsto \tau_r \Delta_{\Gamma_r}^{-1} \operatorname{curl}_{\Gamma_r} \tau_r^{-1}. \end{aligned}$$

We have seen that for $r \in B^{\infty}(0, \varepsilon)$ the operator $\operatorname{curl}_{\Gamma_r}$ is linear and continuous from $\mathbf{H}^{s+1}(\Gamma_r)$ to $H_*^s(\Gamma_r)$, that the operator $\operatorname{div}_{\Gamma_r}$ is linear and continuous from $\mathbf{TH}^{s+1}(\Gamma_r)$ to $H_*^s(\Gamma_r)$ and that $\Delta_{\Gamma_r}^{-1}$ is defined from $H_*^s(\Gamma_r)$ to $H^{s+2}(\Gamma_r)/\mathbb{C}$. To use the chain rules, it is necessary to prove that the derivatives at $r = 0$ act between the spaces $\mathbf{H}^{s+1}(\Gamma)$ and $H_*^s(\Gamma)$ for the scalar curl operator, between the spaces $\mathbf{TH}^{s+1}(\Gamma)$ and $H_*^s(\Gamma)$ for the divergence operator and between the spaces $H_*^s(\Gamma)$ and $H^{s+2}(\Gamma)/\mathbb{C}$ for the Laplace–Beltrami operator. An important observation is

$$u_r \in H_*^s(\Gamma_r) \text{ if and only if } J_r u_r \circ (\mathbf{I} + r) \in H_*^s(\Gamma).$$

Using the duality (2.5) on the boundary Γ_r we can write for any vector density $\mathbf{j} \in \mathbf{H}^{s+1}(\Gamma)$ and any scalar density $\varphi \in H^{-s}(\Gamma)$

$$\begin{aligned} \int_{\Gamma} \tau_r \left(\operatorname{curl}_{\Gamma_r}(\tau_r^{-1} \mathbf{j}) \right) \cdot \varphi J_r ds &= \int_{\Gamma_r} \operatorname{curl}_{\Gamma_r}(\tau_r^{-1} \mathbf{j}) \cdot (\tau_r^{-1} \varphi) ds \\ &= \int_{\Gamma_r} (\tau_r^{-1} \mathbf{j}) \cdot \mathbf{curl}_{\Gamma_r}(\tau_r^{-1} \varphi) ds \\ &= \int_{\Gamma} \mathbf{j} \cdot \tau_r \left(\mathbf{curl}_{\Gamma_r}(\tau_r^{-1} \varphi) \right) J_r ds. \end{aligned} \quad (5.1)$$

Taking $\varphi \in \mathbb{R}$ (i.e. φ is a constant function) then the right-hand side vanishes. This means that $J_r(\tau_r \operatorname{curl}_{\Gamma_r}(\tau_r^{-1} \mathbf{j}))$ is of vanishing mean value.

Lemma 5.7. *The mapping*

$$\begin{aligned} \mathcal{R}^* : B^\infty(0, \varepsilon) &\rightarrow \mathcal{L}(\mathbf{H}^{s+1}(\Gamma), \mathbf{H}_*^s(\Gamma)) \\ r &\mapsto J_r \tau_r \operatorname{curl}_{\Gamma_r} \tau_r^{-1} \end{aligned}$$

is \mathcal{C}^∞ -Gâteaux differentiable and we have in any direction $\xi = (\xi_1, \xi_2, \xi_3) \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$

$$\begin{cases} \frac{\partial \mathcal{R}^*}{\partial r}[r, \xi] &= -\mathcal{J}(r) \cdot \sum_{i=1}^3 (\mathcal{G}(r)\xi_i \cdot \mathcal{R}(r)\mathbf{u}_i), \\ \frac{\partial^m \mathcal{R}^*}{\partial r^m}[r, \xi] &= 0, \text{ for all } m \geq 2. \end{cases}$$

Proof. Looking at the expression of the derivatives of the tangential gradient and of the tangential vector curl in lemmas 5.3 and 5.5 we prove iteratively that all the derivatives of $\mathcal{G}(r)\varphi$ and of $\mathcal{R}(r)\varphi$ are composed of $\mathcal{G}(r)\varphi$ and $\mathcal{R}(r)\varphi$, so that for $\varphi \in \mathbb{R}$ the derivatives of the right-hand side of (5.1) vanishes. We have for all $m \in \mathbb{N}$ and $\mathbf{u} \in \mathbf{H}^{s+1}(\Gamma)$:

$$\frac{\partial^m}{\partial r^m} \left\{ \int_{\Gamma} J_r (\tau_r \operatorname{curl}_{\Gamma_r} (\tau_r^{-1} \mathbf{j})) ds \right\} [r, \xi] = \int_{\Gamma} \frac{\partial^m}{\partial r^m} \{ \mathcal{R}^* \} [r, \xi] \mathbf{j} ds = 0.$$

It can also be obtained by directly deriving the expression of $\mathcal{R}^* \mathbf{j}$ using the formulas obtained in the lemmas 5.1 to 5.6. The first derivative of \mathcal{R}^* is given by

$$\begin{aligned} d(\mathcal{R}^*) [r, \xi] \mathbf{u} &= -\mathcal{J}(r) \cdot \sum_{i=1}^3 (\mathcal{G}(r)\xi_i \cdot \mathcal{R}(r)\mathbf{u}_i) \\ &= -J_r \tau_r \cdot \left(\sum_{i=1}^3 \nabla_{\Gamma_r} (\tau_r^{-1} \xi_i) \cdot \operatorname{curl}_{\Gamma_r} (\tau_r^{-1} \mathbf{u}_i) \right) \end{aligned}$$

The right-hand side is of vanishing mean value since the space $\nabla_{\Gamma_r} H^s(\Gamma_r)$ is orthogonal to $\operatorname{curl}_{\Gamma_r} H^s(\Gamma_r)$ for the $\mathbf{L}^2(\Gamma_r)$ duality product. For the second order derivative we derive $r \mapsto d(\mathcal{R}^*) [r, \xi] \mathbf{j}$ in the direction $\eta = (\eta_1, \eta_2, \eta_3) \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$ and we obtain

$$\begin{aligned} d^2(\mathcal{R}^*) [r; \xi, \eta] \mathbf{u} &= \mathcal{J}(r) \cdot \sum_{i=1}^3 ([\mathcal{G}(r)\eta] \mathcal{G}(r)\xi_i \cdot \mathcal{R}(r)\mathbf{u}_i) \\ &\quad - \mathcal{J}(r) \cdot \sum_{i=1}^3 \left(\mathcal{G}(r)\xi_i \cdot [\mathcal{G}(r)\eta]^\top \mathcal{R}(r)\mathbf{u}_i \right) \\ &= 0. \end{aligned}$$

Higher order derivatives of \mathcal{R}^* vanish. □

For the surface divergence, similar arguments can be applied. Using the duality (2.4), we can write for $\mathbf{j} \in \mathbf{TH}^{s+1}(\Gamma)$:

$$\begin{aligned} \int_{\Gamma} \tau_r \left(\operatorname{div}_{\Gamma_r}(\pi(r)^{-1} \mathbf{j}) \right) \cdot \varphi J_r ds &= \int_{\Gamma_r} \operatorname{div}_{\Gamma_r}(\pi(r)^{-1} \mathbf{j}) \cdot (\tau_r^{-1} \varphi) ds \\ &= - \int_{\Gamma_r} (\pi(r)^{-1} \mathbf{j}) \cdot \nabla_{\Gamma_r}(\tau_r^{-1} \varphi) ds \\ &= - \int_{\Gamma} \tau_r(\pi(r)^{-1} \mathbf{j}) \cdot \tau_r \left(\nabla_{\Gamma_r}(\tau_r^{-1} \varphi) \right) J_r ds. \end{aligned}$$

This shows that for constant $\varphi \in \mathbb{R}$ the right-hand side vanishes and therefore $J_r(\tau_r \operatorname{div}_{\Gamma_r}(\pi^{-1}(r) \mathbf{j}))$ is of vanishing mean value. We obtain the following result.

Lemma 5.8. *The mapping*

$$\begin{aligned} \mathcal{D}^* : B^\infty(0, \varepsilon) &\rightarrow \mathcal{L}(\mathbf{TH}^{s+1}(\Gamma), \mathbf{H}_*^s(\Gamma)) \\ r &\mapsto J_r \tau_r \operatorname{div}_{\Gamma_r} \pi^{-1}(r) \end{aligned}$$

is \mathcal{C}^∞ -Gâteaux differentiable.

Now it remains to analyze the inverse of the Laplace–Beltrami operator Δ_Γ . We apply the following abstract result on the Gâteaux derivative of the inverse in a Banach algebra. We leave its proof to the reader.

Lemma 5.9. *Let U be an open subset of a Fréchet space \mathcal{X} and let \mathcal{Y} be a Banach algebra. Assume that $f : U \rightarrow \mathcal{Y}$ is Gâteaux differentiable at $r_0 \in U$ and that $f(r)$ is invertible in \mathcal{Y} for all $r \in U$. Then g is Gâteaux differentiable at r_0 and its first derivative in the direction $\xi \in \mathcal{X}$ is*

$$df[r_0, \xi] = -f(r_0)^{-1} \circ df[r_0, \xi] \circ f(r_0)^{-1}. \quad (5.2)$$

Moreover if f is \mathcal{C}^m -Gâteaux differentiable then g is, too.

From the preceding results we deduce the \mathcal{C}^∞ -Gâteaux differentiability of the mapping

$$\begin{aligned} \mathcal{L}^* : B^\infty(0, \varepsilon) &\rightarrow \mathcal{L}(H^{s+2}(\Gamma), H_*^s(\Gamma)) \\ r &\mapsto J_r \tau_r \Delta_{\Gamma_r} \tau_r^{-1} = -\mathcal{R}^*(r) \mathcal{R}(r). \end{aligned}$$

Let us note that τ_r induces an isomorphism between the quotient spaces $H^s(\Gamma_r)/\mathbb{C}$ and $H^s(\Gamma)/\mathbb{C}$.

Lemma 5.10. *The mapping*

$$\begin{aligned} B^\infty(0, \varepsilon) &\rightarrow \mathcal{L}(H_*^s(\Gamma), H^{s+2}(\Gamma)/\mathbb{C}) \\ r &\mapsto (\mathcal{L}^*(r))^{-1} \end{aligned}$$

is \mathcal{C}^∞ -Gâteaux differentiable and we have in any direction $\xi \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$

$$d \left\{ r \mapsto (\mathcal{L}^*(r))^{-1} \right\} [0, \xi] = -\Delta_\Gamma^{-1} \circ d\mathcal{L}^*[0, \xi] \circ \Delta_\Gamma^{-1}. \quad (5.3)$$

Proof. We have seen in section 2 that the Laplace–Beltrami operator is invertible from $H^{s+2}(\Gamma_r)/\mathbb{C}$ to $H_*^s(\Gamma_r)$. As a consequence $\mathcal{L}^*(r)$ is invertible from $H^{s+2}(\Gamma)/\mathbb{C}$ to $H_*^s(\Gamma)$. We conclude by using Lemma 5.9. \square

Let us give another formulation of (5.3). For any $u \in H^{s+2}(\Gamma)$ and $\varphi \in H^{-s}(\Gamma)$ we have

$$\int_{\Gamma} \tau_r \left(\Delta_{\Gamma_r} (\tau_r^{-1} u) \right) \cdot \varphi J_r ds = - \int_{\Gamma} \left(\mathcal{G}(r) u \cdot \mathcal{G}(r) \varphi \right) J_r ds.$$

It is more convenient to differentiate the right-hand side than the left hand side. For $f \in H_*^s(\Gamma_r)$, the element $(\mathcal{L}^*(r))^{-1} f$ is the solution u of

$$- \int_{\Gamma} \left(\mathcal{G}(r) u \cdot \mathcal{G}(r) \varphi \right) J_r ds = \int_{\Gamma} f \cdot \varphi ds, \quad \text{for all } \varphi \in H^s(\Gamma).$$

The formula (5.3) means that the first derivative at $r = 0$ in the direction $\xi \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$ of $r \mapsto (\mathcal{L}^*(r))^{-1} f$ is the solution v of

$$\int_{\Gamma} \frac{\partial}{\partial r} \left\{ \left(\mathcal{G}(r) u_0 \cdot \mathcal{G}(r) \varphi \right) J_r \right\} [0, \xi] ds = - \int_{\Gamma} \nabla_{\Gamma} v \cdot \nabla_{\Gamma} \varphi ds, \quad \text{for all } \varphi \in H^s(\Gamma), \quad (5.4)$$

with $u_0 = \Delta_{\Gamma}^{-1} f$.

Now we have all the tools to establish the differentiability properties of the electromagnetic boundary integral operators and then of the solution to the dielectric scattering problem.

6. Shape derivatives of the solution of the dielectric problem

For the shape-dependent integral operators we now use the following simplified notation

$$\begin{aligned} \Psi_{E_\kappa}(r) &= \Psi_{E_\kappa}^r \mathbf{P}_r^{-1}, & \Psi_{M_\kappa}(r) &= \Psi_{M_\kappa}^r \mathbf{P}_r^{-1}, \\ C_\kappa(r) &= \mathbf{P}_r C_\kappa^r \mathbf{P}_r^{-1}, & M_\kappa(r) &= \mathbf{P}_r M_\kappa^r \mathbf{P}_r^{-1}. \end{aligned}$$

In the following we use the results of the preceding paper [9] about the Gâteaux differentiability of potentials and boundary integral operators with pseudo-homogeneous kernels.

Theorem 6.1. *The mappings*

$$\begin{aligned} B^\infty(0, \varepsilon) &\rightarrow \mathcal{L}(\mathbf{TH}^{-\frac{1}{2}}(\text{div}_{\Gamma}, \Gamma), \mathbf{H}(\mathbf{curl}, K_p)) \\ r &\mapsto \Psi_{E_\kappa}(r) \\ r &\mapsto \Psi_{M_\kappa}(r) \end{aligned}$$

are infinitely Gâteaux differentiable. The derivatives can be written in explicit form by differentiating the kernels of the operators $\Psi_{E_\kappa}^r$ and $\Psi_{M_\kappa}^r$, see [9, Theorem 4.7], and by using the formulas for the derivatives of the surface differential operators given in Section 5. The first derivatives at $r = 0$ can be extended to bounded linear operators from $\mathbf{TH}^{\frac{1}{2}}(\text{div}_{\Gamma}, \Gamma)$ to $\mathbf{H}(\mathbf{curl}, \Omega)$ and to $\mathbf{H}_{loc}(\mathbf{curl}, \Omega^c)$. Given $\mathbf{j} \in \mathbf{TH}^{\frac{1}{2}}(\text{div}_{\Gamma}, \Gamma)$, the potentials $d\Psi_{E_\kappa}[0, \xi] \mathbf{j}$ and $d\Psi_{M_\kappa}[0, \xi] \mathbf{j}$ satisfy the Maxwell equations

$$\mathbf{curl} \mathbf{curl} \mathbf{u} - \kappa^2 \mathbf{u} = 0$$

in Ω and Ω^c , and the Silver-Müller radiation condition.

Proof. Let $\mathbf{j} \in \mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma)$ and let $\mathbf{j} = \nabla_\Gamma p + \mathbf{curl}_\Gamma q$ be its Helmholtz decomposition. Recall that $\Psi_{E_\kappa}(r)\mathbf{j}$ and $\Psi_{M_\kappa}(r)\mathbf{j}$ can be written as:

$$\begin{aligned}\Psi_{E_\kappa}(r)\mathbf{j} &= \kappa \Psi_\kappa^r \tau_r^{-1}(\tau_r \mathbf{P}_r^{-1} \mathbf{j}) - \frac{1}{\kappa} \nabla \Psi_\kappa^r \tau_r^{-1}(\tau_r \Delta_{\Gamma_r}(\tau_r^{-1} p)), \\ \Psi_{M_\kappa}(r)\mathbf{j} &= \operatorname{curl} \Psi_\kappa^r \tau_r^{-1}(\tau_r \mathbf{P}_r^{-1} \mathbf{j}).\end{aligned}$$

By composition of differentiable mappings, we deduce that $r \mapsto \Psi_{E_\kappa}(r)$ and $r \mapsto \Psi_{M_\kappa}(r)$ are infinitely Gâteaux differentiable far from the boundary and that their first derivatives are continuous from $\mathbf{TH}^{\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma)$ to $\mathbf{L}^2(\Omega) \cup \mathbf{L}_{\text{loc}}^2(\overline{\Omega^c})$. Recall that we have

$$\mathbf{curl} \Psi_{E_\kappa}(r)\mathbf{j} = \kappa \Psi_{M_\kappa}(r)\mathbf{j} \text{ and } \mathbf{curl} \Psi_{M_\kappa}(r)\mathbf{j} = \kappa \Psi_{E_\kappa}(r)\mathbf{j}.$$

Far from the boundary we can invert the differentiation with respect to x and the derivation with respect to r , which gives

$$\mathbf{curl} d\Psi_{E_\kappa}[0, \xi]\mathbf{j} = \kappa d\Psi_{M_\kappa}[0, \xi]\mathbf{j} \text{ and } \mathbf{curl} d\Psi_{M_\kappa}[0, \xi]\mathbf{j} = \kappa d\Psi_{E_\kappa}[0, \xi]\mathbf{j}.$$

It follows that $d\Psi_{E_\kappa}[0, \xi]\mathbf{j}$ and $d\Psi_{M_\kappa}[0, \xi]\mathbf{j}$ are in $\mathbf{H}(\mathbf{curl}, \Omega) \cup \mathbf{H}_{\text{loc}}(\mathbf{curl}, \overline{\Omega^c})$ and that they satisfy the Maxwell equations and the Silver-Müller condition. \square

We recall from Section 4 that with the notation of Section 5 the operator $C_\kappa(r)$ admits the following representation

$$C_\kappa(r)\mathbf{j} = \mathbf{P}_r C_\kappa^r \mathbf{P}_r^{-1} \mathbf{j} = \nabla_\Gamma P(r) + \mathbf{curl}_\Gamma Q(r), \quad (6.1)$$

where

$$P(r) = -\kappa (\mathcal{L}^*(r))^{-1} \mathcal{R}^*(r) (\tau_r V_\kappa^r \tau_r^{-1}) [\mathcal{G}(r)p + \mathcal{R}(r)q]$$

and

$$\begin{aligned}Q(r) &= -\kappa (\mathcal{L}^*(r))^{-1} \mathcal{D}^*(r) \pi(r) \tau_r^{-1} (\tau_r V_\kappa^r \tau_r^{-1}) [\mathcal{G}(r)p + \mathcal{R}(r)q] \\ &\quad + \frac{1}{\kappa} (\tau_r V_\kappa^r \tau_r^{-1}) (\tau_r \Delta_{\Gamma_r}(\tau_r^{-1} p)).\end{aligned}$$

Let $\mathbf{j} \in \mathbf{TH}^s(\operatorname{div}_\Gamma, \Gamma)$ and let $\mathbf{j} = \nabla_\Gamma p + \mathbf{curl}_\Gamma q$ be its Helmholtz decomposition. We want to derive

$$\begin{aligned}\mathbf{P}_r C_\kappa^r \mathbf{P}_r^{-1} \mathbf{j} &= \mathbf{P}_r C_\kappa^r (\nabla_{\Gamma_r} \tau_r^{-1} p + \mathbf{curl}_{\Gamma_r} \tau_r^{-1} q) \\ &= \mathbf{P}_r (\nabla_{\Gamma_r} P_r + \mathbf{curl}_{\Gamma_r} Q_r) \\ &= \nabla_\Gamma P(r) + \mathbf{curl}_\Gamma Q(r).\end{aligned}$$

We find

$$dC_\kappa[0, \xi]\mathbf{j} = \nabla_\Gamma dP[0, \xi] + \mathbf{curl}_\Gamma dQ[0, \xi].$$

Thus the derivative with respect to r of $\mathbf{P}_r C_\kappa^r \mathbf{P}_r^{-1} \mathbf{j}$ is given by the derivatives of the functions $P(r) = \tau_r(P_r)$ and of $Q(r) = \tau_r(Q_r)$.

We also note that for an r -dependent vector function $f(r)$ on Γ there holds

$$d\{\pi(r) \tau_r^{-1} f(r)\}[0, \xi] = \pi(0) df[0, \xi].$$

By composition of infinitely differentiable mappings we obtain the following theorem.

Theorem 6.2. *The mapping:*

$$\begin{aligned} B^\infty(0, \varepsilon) &\rightarrow \mathcal{L}\left(\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma), \mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma)\right) \\ r &\mapsto \mathbf{P}_r C_\kappa^r \mathbf{P}_r^{-1} \end{aligned}$$

is infinitely Gâteaux differentiable. The derivatives can be written in explicit form by differentiating the kernel of the operator C_κ^r , see [9, Corollary 4.5], and by using the formulas for the derivatives of the surface differential operators given in Section 5.

Similarly, recall that the operator $\mathbf{P}_r M_\kappa^r \mathbf{P}_r^{-1}$ admits the following representation :

$$\mathbf{P}_r M_\kappa^r \mathbf{P}_r^{-1} \mathbf{j} = \nabla_\Gamma P'(r) + \operatorname{curl}_\Gamma Q'(r),$$

where

$$\begin{aligned} P'(r) &= (\mathcal{L}^*(r))^{-1} (\kappa^2 J_r \cdot \tau_r \mathbf{n}_r \cdot (\tau_r V_\kappa^r \tau_r^{-1}) [\mathcal{G}(r)p + \mathcal{R}(r)q] \\ &\quad + (\mathcal{L}^*(r))^{-1} (J_r \cdot \tau_r D_\kappa^r \tau_r^{-1}) (\tau_r \Delta_{\Gamma_r} (\tau_r^{-1} p)) \end{aligned}$$

and

$$Q'(r) = (\mathcal{L}^*(r))^{-1} \mathcal{R}^*(r) (\tau_r (B_\kappa^r - D_\kappa^r) \tau_r^{-1}) [\mathcal{G}(r)p + \mathcal{R}(r)q]$$

with

$$\begin{aligned} \tau_r B_\kappa^r \mathbf{P}_r^{-1} \mathbf{j} &= \tau_r \left\{ \int_{\Gamma_r} \nabla G(\kappa, |\cdot - y_r|) (\mathbf{n}_r(\cdot) \cdot (\nabla_{\Gamma_r} \tau_r^{-1} p)(y_r)) ds(y_r) \right. \\ &\quad \left. + \int_{\Gamma_r} \nabla G(\kappa, |\cdot - y_r|) (\mathbf{n}_r(\cdot) \cdot (\operatorname{curl}_{\Gamma_r} \tau_r^{-1} q)(y_r)) ds(y_r) \right\}. \end{aligned}$$

Theorem 6.3. *The mapping:*

$$\begin{aligned} B^\infty(0, \varepsilon) &\rightarrow \mathcal{L}\left(\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma), \mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma)\right) \\ r &\mapsto \mathbf{P}_r M_\kappa^r \mathbf{P}_r^{-1} \end{aligned}$$

is infinitely Gâteaux differentiable. The Gâteaux derivatives have the same regularity as M_κ , so that they are compact operators in $\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma)$. The derivatives can be written in explicit form by differentiating the kernel of the operators M_κ^r , see [9, Corollary 4.5], and by using the formulas for the derivatives of the surface differential operators given in Section 5.

Proof. The differentiability of the double layer boundary integral operator is established in [9, Example 4.10]. It remains to prove the infinite Gâteaux differentiability of the mapping

$$\begin{aligned} B_\delta &\rightarrow \mathcal{L}\left(\mathbf{TH}^{-\frac{1}{2}}(\operatorname{div}_\Gamma, \Gamma), \mathbf{H}^{\frac{1}{2}}(\Gamma)\right) \\ r &\mapsto \tau_r B_\kappa^r \mathbf{P}_r^{-1}. \end{aligned}$$

The function $(x, y - x) \mapsto \nabla G(\kappa, |x - y|)$ is pseudo-homogeneous of class 0. We then have to prove that for any fixed $(x, y) \in (\Gamma \times \Gamma)^*$ and any function $p \in H^{\frac{3}{2}}(\Gamma)$ the Gâteaux derivatives of

$$r \mapsto (\tau_r \mathbf{n}_r)(x) \cdot (\tau_r \nabla_{\Gamma_r} \tau_r^{-1} p)(y)$$

behave as $|x - y|^2$ when $x - y$ tends to zero. To do so, either we write

$$(\tau_r \mathbf{n}_r)(x) \cdot (\tau_r \nabla_{\Gamma_r} \tau_r^{-1} p)(y) = ((\tau_r \mathbf{n}_r)(x) - (\tau_r \mathbf{n}_r)(y)) \cdot (\tau_r \nabla_{\Gamma_r} \tau_r^{-1} p)(y)$$

or we use Lemmas 5.1 and 5.3 and straightforward computations. \square

Theorem 6.4. *Assume that $\mathbf{E}^{inc} \in \mathbf{H}_{loc}^1(\mathbf{curl}, \mathbb{R}^3)$ and that the mappings*

$$\begin{aligned} B^\infty(0, \varepsilon) &\rightarrow \mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma) \\ r &\mapsto \mathbf{P}_r \left(\mathbf{n}_r \wedge \mathbf{E}_{|\Gamma_r}^{inc} \right) \\ r &\mapsto \mathbf{P}_r \left(\mathbf{n}_r \wedge (\mathbf{curl} \mathbf{E}^{inc})_{|\Gamma_r} \right) \end{aligned}$$

are Gâteaux differentiable at $r = 0$. Then the mapping from $r \in B^\infty(0, \varepsilon)$ to the solution $\mathcal{E}(r) = \mathbf{E}(\Omega_r) \in \mathbf{H}(\mathbf{curl}, \Omega_r) \cup \mathbf{H}_{loc}(\mathbf{curl}, \overline{\Omega^c})$ of the scattering problem by the obstacle Ω_r is Gâteaux differentiable at $r = 0$.

Proof. We use the integral equation method described in Theorem 3.1. Let \mathbf{j} be the solution of the integral equation (3.8). By composition of infinitely differentiable mappings we see that

$$\begin{aligned} B^\infty(0, \varepsilon) &\rightarrow \mathcal{L} \left(\mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma), \mathbf{TH}^{-\frac{1}{2}}(\text{div}_\Gamma, \Gamma) \right) \\ r &\mapsto \mathbf{S}(r) = \mathbf{P}_r \mathbf{S}^r \mathbf{P}_r^{-1} \end{aligned}$$

is \mathcal{C}^∞ -Gâteaux differentiable. Then with (3.6) and (3.8) we get for the exterior field \mathcal{E}^s

$$\begin{aligned} d\mathcal{E}^s[0, \xi] &= (-d\Psi_{E_{\kappa_e}}[0, \xi] - i\eta d\Psi_{M_{\kappa_e}}[0, \xi] C_0^* - i\eta \Psi_{M_{\kappa_e}} dC_0^*[0, \xi]) \mathbf{j} \\ &\quad + (-\Psi_{E_{\kappa_e}} - i\eta \Psi_{M_{\kappa_e}} C_0^*) \mathbf{S}^{-1} (-d\mathbf{S}[0, \xi] \mathbf{j}) \\ &\quad + (-\Psi_{E_{\kappa_e}} - i\eta \Psi_{M_{\kappa_e}} C_0^*) \mathbf{S}^{-1} (-\rho dM_{\kappa_i}[0, \xi] \gamma_D \mathbf{E}^{inc} - dC_{\kappa_i}[0, \xi] \gamma_{N_{\kappa_e}} \mathbf{E}^{inc}) \\ &\quad + (-\Psi_{E_{\kappa_e}} - i\eta \Psi_{M_{\kappa_e}} C_0^*) \mathbf{S}^{-1} \left(-\rho \left(\frac{1}{2} + M_{\kappa_i} \right) d \{ \mathbf{P}_r \gamma_D^r \mathbf{E}^{inc} \} [0, \xi] \right) \\ &\quad + (-\Psi_{E_{\kappa_e}} - i\eta \Psi_{M_{\kappa_e}} C_0^*) \mathbf{S}^{-1} \left(-C_{\kappa_i} d \{ \mathbf{P}_r \gamma_{N_{\kappa_e}}^r \mathbf{E}^{inc} \} [0, \xi] \right). \end{aligned}$$

We know that $\mathbf{j} \in \mathbf{TH}^{\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$, so that the first terms on the right-hand side are in $\mathbf{H}_{loc}(\mathbf{curl}, \overline{\Omega^c})$, and the hypotheses guarantee that the last two terms are in $\mathbf{H}_{loc}(\mathbf{curl}, \overline{\Omega^c})$. For the interior field we write

$$\begin{aligned} d\mathcal{E}^i[0, \xi] &= -\frac{1}{\rho} d\Psi_{E_{\kappa_i}}[0, \xi] \gamma_{N_{\kappa_e}}^c (\mathbf{E}^s + \mathbf{E}^{inc}) - d\Psi_{M_{\kappa_i}}[0, \xi] \gamma_D^c (\mathbf{E}^s + \mathbf{E}^{inc}) \\ &\quad - \frac{1}{\rho} \Psi_{E_{\kappa_i}} d \left\{ \mathbf{P}_r \gamma_{N_{\kappa_e}}^{c,r} (\mathcal{E}^s(r) + \mathbf{E}^{inc}) \right\} [0, \xi] \\ &\quad - \Psi_{M_{\kappa_i}} d \left\{ \mathbf{P}_r \gamma_D^{c,r} (\mathcal{E}^s(r) + \mathbf{E}^{inc}) \right\} [0, \xi]. \end{aligned}$$

The hypotheses guarantee that $\gamma_{N_{\kappa_e}}^c (\mathbf{E}^s + \mathbf{E}^{inc})$ and $\gamma_D^c (\mathbf{E}^s + \mathbf{E}^{inc})$ are in $\mathbf{TH}^{\frac{1}{2}}(\text{div}_\Gamma, \Gamma)$, which implies that the first two terms are in $\mathbf{H}(\mathbf{curl}, \Omega)$, and that the last two terms are in $\mathbf{H}(\mathbf{curl}, \Omega)$. \square

Theorem 6.5. *The mapping sending $r \in B^\infty(0, \varepsilon)$ to the far field pattern $\mathbf{E}^\infty(\Omega_r) \in \mathbf{T}\mathcal{C}^\infty(S^2)$ of the solution to the scattering problem by the obstacle Ω_r is \mathcal{C}^∞ -Gâteaux differentiable.*

Proof. The mapping $B^\infty(0, \varepsilon) \ni r \mapsto \{(\hat{x}, y) \mapsto e^{i\kappa\hat{x}\cdot(y+r(y))}\} \in \mathcal{C}^\infty(S^2 \times \Gamma)$ is \mathcal{C}^∞ -Gâteaux differentiable and the derivatives define smooth kernels. By the linearity of the integral we deduce that the boundary-to-far-field operators

$$\begin{aligned} B_\delta &\rightarrow \mathcal{L}(\mathbf{TH}^s(\operatorname{div}_\Gamma, \Gamma), \mathcal{C}^\infty(S^2)) \\ r &\mapsto \Psi_{E_\kappa}^\infty(r) = \Psi_{E_\kappa}^{\infty, r} \tau_r^{-1} \\ r &\mapsto \Psi_{M_\kappa}^\infty(r) = \Psi_{M_\kappa}^{\infty, r} \tau_r^{-1} \end{aligned}$$

are \mathcal{C}^∞ -Gâteaux differentiable. For $\mathbf{j} \in \mathbf{TH}^s(\operatorname{div}_\Gamma, \Gamma)$ we have:

$$d\Psi_{E_\kappa}^\infty[0, \xi] \mathbf{j}(\hat{x}) = i\kappa\hat{x} \wedge \left(\int_\Gamma e^{-i\kappa\hat{x}\cdot y} (\operatorname{div}_\Gamma \xi(y) - i\kappa\hat{x} \cdot \xi(y)) \mathbf{j}(y) ds(y) \right) \wedge \hat{x},$$

and

$$d\Psi_{M_\kappa}^\infty[0, \xi] \mathbf{j}(\hat{x}) = \kappa\hat{x} \wedge \left(\int_\Gamma e^{-i\kappa\hat{x}\cdot y} (\operatorname{div}_\Gamma \xi(y) - i\kappa\hat{x} \cdot \xi(y)) \mathbf{j}(y) ds(y) \right).$$

We conclude by using the integral representation of $\mathbf{E}^\infty(\Omega_r)$ and previous theorems. \square

6.1. Characterization of the first derivative

The following theorem gives a characterization of the first Gâteaux derivative of $r \mapsto \mathcal{E}(r)$ at $r = 0$.

Theorem 6.6. *Under the hypotheses of Theorem 6.4, the first derivative of the solution $\mathcal{E}(r)$ of the dielectric scattering problem at $r = 0$ in the direction $\xi \in \mathcal{C}^\infty(\Gamma, \mathbb{R}^3)$ solves the following transmission problem :*

$$\begin{cases} \operatorname{curl} \operatorname{curl} d\mathcal{E}^i[0, \xi] - \kappa_i^2 d\mathcal{E}^i[0, \xi] = 0 \\ \operatorname{curl} \operatorname{curl} d\mathcal{E}^s[0, \xi] - \kappa_e^2 d\mathcal{E}^s[0, \xi] = 0 \end{cases} \quad (6.2)$$

with the interface conditions

$$\begin{cases} \mathbf{n} \wedge d\mathcal{E}^i[0, \xi] - \mathbf{n} \wedge d\mathcal{E}^s[0, \xi] = g_D \\ \mu_i^{-1} \mathbf{n} \wedge \operatorname{curl} d\mathcal{E}^i[0, \xi] - \mu_e^{-1} \mathbf{n} \wedge \operatorname{curl} d\mathcal{E}^s[0, \xi] = g_N, \end{cases} \quad (6.3)$$

where with the solution $(\mathbf{E}^i, \mathbf{E}^s)$ of the scattering problem,

$$\begin{aligned} g_D &= -(\xi \cdot \mathbf{n}) \left(\mathbf{n} \wedge \operatorname{curl} \mathbf{E}^i - \mathbf{n} \wedge \operatorname{curl}(\mathbf{E}^s + \mathbf{E}^{inc}) \right) \wedge \mathbf{n} \\ &\quad + \operatorname{curl}_\Gamma \left((\xi \cdot \mathbf{n}) (\mathbf{n} \cdot \mathbf{E}^i - \mathbf{n} \cdot (\mathbf{E}^s + \mathbf{E}^{inc})) \right), \end{aligned}$$

and

$$\begin{aligned} g_N &= -(\xi \cdot \mathbf{n}) \left(\frac{\kappa_i^2}{\mu_i} \mathbf{n} \wedge \mathbf{E}^i - \frac{\kappa_e^2}{\mu_e} \mathbf{n} \wedge (\mathbf{E}^s + \mathbf{E}^{inc}) \right) \wedge \mathbf{n} \\ &\quad + \operatorname{curl}_\Gamma \left((\xi \cdot \mathbf{n}) (\mu_i^{-1} \operatorname{curl}_\Gamma \mathbf{E}^i - \mu_e^{-1} \operatorname{curl}_\Gamma (\mathbf{E}^s + \mathbf{E}^{inc})) \right), \end{aligned}$$

and $d\mathcal{E}^s[0, \xi]$ satisfies the Silver-Müller radiation condition.

Proof. We have shown in the previous paragraph that the potential operators and their Gâteaux derivatives satisfy the Maxwell equations and the Silver-Müller radiation condition. It remains to compute the boundary conditions. They can be obtained from the integral representation, but this is rather tedious. A simpler way consists in deriving for a fixed $x \in \Gamma$ the expression

$$\mathbf{n}_r(x + r(x)) \wedge (\mathcal{E}^i(r)(x + r(x)) - \mathcal{E}^s(r)(x + r(x)) - \mathbf{E}^{inc}(x + r(x))) = 0. \quad (6.4)$$

This gives

$$\begin{aligned} 0 &= d\mathcal{N}[0, \xi](x) \wedge (\mathbf{E}^i(x) - \mathbf{E}^s(x) - \mathbf{E}^{inc}(x)) \\ &\quad + \mathbf{n}(x) \wedge (d\mathcal{E}^i[0, \xi](x) - d\mathcal{E}^s[0, \xi](x)) \\ &\quad + \mathbf{n} \wedge (\xi(x) \cdot \nabla (\mathbf{E}^i - \mathbf{E}^s - \mathbf{E}^{inc})). \end{aligned}$$

We now use the explicit form of the shape derivatives of the normal vector given in Lemma 5.1 : $d\mathcal{N}[0, \xi] = -[\nabla_\Gamma \xi] \mathbf{n}$, and the formula $\nabla u = \nabla_\Gamma u + \left(\frac{\partial u}{\partial \mathbf{n}}\right) \mathbf{n}$. We obtain

$$\begin{aligned} \mathbf{n}(x) \wedge (d\mathcal{E}^i[0, \xi](x) - d\mathcal{E}^s[0, \xi](x)) &= \\ &[\nabla_\Gamma \xi] \mathbf{n} \wedge (\mathbf{E}^i(x) - \mathbf{E}^s(x) - \mathbf{E}^{inc}(x)) \\ &- \mathbf{n} \wedge (\xi(x) \cdot \nabla_\Gamma (\mathbf{E}^i(x) - \mathbf{E}^s(x) - \mathbf{E}^{inc}(x))) \\ &\quad - (\xi \cdot \mathbf{n}) \mathbf{n} \wedge \frac{\partial}{\partial \mathbf{n}} (\mathbf{E}^i(x) - \mathbf{E}^s(x) - \mathbf{E}^{inc}(x)). \end{aligned}$$

Since the tangential component of $\mathbf{E}^i - \mathbf{E}^s - \mathbf{E}^{inc}$ vanishes, we have

$$\begin{aligned} &(\xi(x) \cdot \nabla_\Gamma (\mathbf{E}^i(x) - \mathbf{E}^s(x) - \mathbf{E}^{inc}(x))) \\ &= (\mathbf{n} \cdot (\mathbf{E}^i(x) - \mathbf{E}^s(x) - \mathbf{E}^{inc}(x))) \left([\nabla_\Gamma \mathbf{n}^\top] \xi \right) \end{aligned}$$

and

$$\begin{aligned} &([\nabla_\Gamma \xi] \mathbf{n}) \wedge (\mathbf{E}^i(x) - \mathbf{E}^s(x) - \mathbf{E}^{inc}(x)) \\ &= ([\nabla_\Gamma \xi] \mathbf{n}) \wedge \mathbf{n} (\mathbf{E}^i(x) - \mathbf{E}^s(x) - \mathbf{E}^{inc}(x)) \cdot \mathbf{n}. \end{aligned}$$

Since we are on a regular surface, we have $\nabla_\Gamma \mathbf{n} = \nabla_\Gamma \mathbf{n}^\top$ and

$$([\nabla_\Gamma \xi] \mathbf{n}) \wedge \mathbf{n} - \mathbf{n} \wedge ([\nabla_\Gamma \mathbf{n}^\top] \xi) = \mathbf{curl}_\Gamma (\xi \cdot \mathbf{n}).$$

Using the expansion (see [28, p. 75])

$$\mathbf{curl} \mathbf{u} = (\mathbf{curl}_\Gamma \mathbf{u}) \mathbf{n} + \mathbf{curl}_\Gamma (\mathbf{u}_\Gamma \cdot \mathbf{n}) - \left([\nabla_\Gamma \mathbf{n}] \mathbf{u} \right) \wedge \mathbf{n} - \left(\frac{\partial \mathbf{u}}{\partial \mathbf{n}} \right) \wedge \mathbf{n}$$

we obtain that

$$\begin{aligned} -\mathbf{n} \wedge (\gamma_n \mathbf{E}^i - \gamma_n^c (\mathbf{E}^s + \mathbf{E}^{inc})) &= -\mathbf{n} \wedge (\gamma \mathbf{curl} \mathbf{E}^i - \gamma^c \mathbf{curl} (\mathbf{E}^s + \mathbf{E}^{inc})) \wedge \mathbf{n} \\ &\quad + \mathbf{curl}_\Gamma (\mathbf{n} \cdot (\gamma \mathbf{E}^i - \gamma^c (\mathbf{E}^s + \mathbf{E}^{inc}))). \end{aligned}$$

Here we used that the curvature operator $[\nabla_\Gamma \mathbf{n}]$ acts on the tangential component of vector fields, so that

$$[\nabla_\Gamma \mathbf{n}] (\gamma \mathbf{E}^i - \gamma^c (\mathbf{E}^s + \mathbf{E}^{inc})) = 0.$$

Thus we have

$$g_D = - (\xi \cdot \mathbf{n}) \mathbf{n} \wedge (\gamma \mathbf{curl} \mathbf{E}^i - \gamma^c \mathbf{curl} (\mathbf{E}^s + \mathbf{E}^{inc})) \wedge \mathbf{n} \\ + \mathbf{curl}_\Gamma ((\xi \cdot \mathbf{n}) (\mathbf{n} \cdot \gamma \mathbf{E}^i - \mathbf{n} \cdot \gamma^c (\mathbf{E}^s + \mathbf{E}^{inc}))).$$

To obtain the second transmission condition, we use similar computations with the electric field \mathbf{E} replaced by the magnetic field $\frac{1}{i\omega\mu} \mathbf{curl} \mathbf{E}$. \square

7. Perspectives: Non-smooth boundaries

We have presented a complete differentiability analysis of the electromagnetic integral operators with respect to smooth deformations of a smooth boundary in the framework of Sobolev spaces. Using the boundary integral equation approach we have established that the far-field pattern of the dielectric scattering problem is infinitely differentiable with respect to the deformations and we gave a characterization of the first derivative as the far-field pattern of a new transmission problem.

In the case of a non-smooth boundary — a polyhedral or more generally a Lipschitz boundary — the formulas determining the first derivative given in Theorem 6.6 are problematic. The normal vector field \mathbf{n} will have discontinuities, and the factor $\xi \cdot \mathbf{n}$ and vector product with \mathbf{n} that appear in the right-hand side of (6.3) may not be well defined in the energy trace spaces. It is, however, known for the acoustic case that the far field is infinitely shape differentiable for non-smooth boundaries, too, see [19] for a proof via the implicit function theorem.

Our procedure of using a boundary integral representation gives an alternative way of characterizing the shape derivatives of the solution of the dielectric scattering problem and of its far field. We do not require the computation of the boundary traces of the solution and taking tangential derivatives and multiplication by possibly discontinuous factors. Instead we determine the shape derivatives of the boundary integral operators. While the study of Gâteaux differentiability of boundary integral operators, for the case of smooth deformations of a Lipschitz domain, is still an open problem that will require further work, our approach via Helmholtz decompositions seems to be a promising starting point for tackling this question. Let us briefly indicate why we think this is so.

We consider the case where the boundary Γ is merely Lipschitz, but the deformation is defined by a vector field ξ that is smooth (at least \mathcal{C}^1) in a neighborhood of Γ . Note that the reduction to purely normal displacements that is often used for studying shape optimization problems for smooth boundaries does not make sense here, as soon as there are corners present.

In this situation, many of the ingredients of our toolbox are still available. Here are some of them.

First, the change of variables mapping τ_r still defines an isomorphism between $H^{\frac{1}{2}}(\Gamma_r)$ and $H^{\frac{1}{2}}(\Gamma)$. By duality, we see that the mapping $u_r \mapsto J_r \tau_r u_r$ defines an isomorphism between $H^{-\frac{1}{2}}(\Gamma_r)$ and $H^{-\frac{1}{2}}(\Gamma)$. When we want to transport the energy space $\mathbf{TH}^{-\frac{1}{2}}(\text{div}_{\Gamma_r}, \Gamma_r)$, we can still use Helmholtz decomposition. Namely, the following result is known, see [1, 2, 3, 4, 5].

Lemma 7.1. *Assume that Γ is a simply connected closed Lipschitz surface. The Hilbert space $\mathbf{TH}_{\parallel}^{-\frac{1}{2}}(\text{div}_{\Gamma}, \Gamma)$ admits the following Helmholtz decomposition:*

$$\mathbf{TH}_{\parallel}^{-\frac{1}{2}}(\text{div}_{\Gamma}, \Gamma) = \nabla_{\Gamma} \mathcal{H}(\Gamma) \oplus \mathbf{curl}_{\Gamma} H^{\frac{1}{2}}(\Gamma).$$

where

$$\mathcal{H}(\Gamma) = \{u \in H^1(\Gamma) : \Delta_{\Gamma} u \in H^{-\frac{1}{2}}(\Gamma)\}.$$

The notation $\mathbf{TH}_{\parallel}^{-\frac{1}{2}}(\text{div}_{\Gamma}, \Gamma)$ recalls the fact that special care has to be taken for the definition of the energy space.

A natural idea for the transport of the energy trace space is then, instead of (4.6), to define

$$\begin{aligned} \mathbf{P}_r : \quad \mathbf{TH}_{\parallel}^{-\frac{1}{2}}(\text{div}_{\Gamma_r}, \Gamma_r) &\longrightarrow \mathbf{TH}_{\parallel}^{-\frac{1}{2}}(\text{div}_{\Gamma}, \Gamma) \\ \nabla_{\Gamma_r} p_r + \mathbf{curl}_{\Gamma_r} q_r &\mapsto \nabla_{\Gamma} \Delta_{\Gamma}^{-1} (J_r (\tau_r \Delta_{\Gamma_r} p_r)) + \mathbf{curl}_{\Gamma} (\tau_r q_r). \end{aligned}$$

This is justified by the sequence of isomorphisms

$$\begin{array}{ccccccc} \mathcal{H}(\Gamma_r)/\mathbb{C} & \xrightarrow{\Delta_{\Gamma_r}} & H_*^{-\frac{1}{2}}(\Gamma_r) & \longrightarrow & H_*^{-\frac{1}{2}}(\Gamma) & \xrightarrow{\Delta_{\Gamma}^{-1}} & \mathcal{H}(\Gamma)/\mathbb{C} \\ p_r & \mapsto & \Delta_{\Gamma_r} p_r & \mapsto & J_r (\tau_r \Delta_{\Gamma_r} p_r) & \mapsto & \Delta_{\Gamma}^{-1} (J_r (\tau_r \Delta_{\Gamma_r} p_r)). \end{array}$$

The inverse of the transformation \mathbf{P}_r is given by

$$\begin{aligned} \mathbf{P}_r^{-1} : \quad \mathbf{TH}_{\parallel}^{-\frac{1}{2}}(\text{div}_{\Gamma}, \Gamma) &\longrightarrow \mathbf{TH}_{\parallel}^{-\frac{1}{2}}(\text{div}_{\Gamma_r}, \Gamma_r) \\ \nabla_{\Gamma} p + \mathbf{curl}_{\Gamma} q &\mapsto \nabla_{\Gamma_r} \tau_r^{-1} (\mathcal{L}^*(r))^{-1} \Delta_{\Gamma} p + \mathbf{curl}_{\Gamma_r} (\tau_r^{-1} q). \end{aligned}$$

In this situation it seems to be more convenient to rewrite the operators $\mathbf{P}_r C_{\kappa}^r \mathbf{P}_r^{-1}$ and $\mathbf{P}_r M_{\kappa}^r \mathbf{P}_r^{-1}$ as operators acting on the the scalar fields $p^* = \Delta_{\Gamma} p \in H_*^{-\frac{1}{2}}(\Gamma)$ and $q \in H^{\frac{1}{2}}(\Gamma_r)/\mathbb{C}$ instead of p and q . For example, the operator $\mathbf{P}_r C_{\kappa}^r \mathbf{P}_r^{-1}$ is defined for $\mathbf{j} = \nabla_{\Gamma} \Delta_{\Gamma}^{-1} p^* + \mathbf{curl}_{\Gamma} q \in \mathbf{TH}_{\parallel}^{-\frac{1}{2}}(\text{div}_{\Gamma}, \Gamma)$ by

$$\mathbf{P}_r C_{\kappa}^r \mathbf{P}_r^{-1} = \nabla_{\Gamma} \Delta_{\Gamma}^{-1} P^*(r) + \mathbf{curl}_{\Gamma} Q(r),$$

with

$$P(r) = -\kappa \mathcal{R}^*(r) (\tau_r V_{\kappa}^r \tau_r^{-1}) \left[\mathcal{G}(r) (\mathcal{L}^*(r))^{-1} p^* + \mathcal{R}(r) q \right]$$

and

$$\begin{aligned} Q(r) &= -\kappa (\mathcal{L}^*(r))^{-1} \mathcal{D}^*(r) \pi(r) (\tau_r V_{\kappa}^r \tau_r^{-1}) \left[\mathcal{G}(r) (\mathcal{L}^*(r))^{-1} p^* + \mathcal{R}(r) q \right] \\ &\quad + \frac{1}{\kappa} (\tau_r V_{\kappa}^r \tau_r^{-1}) (J_r^{-1} p^*). \end{aligned}$$

Here we have used the same notation for the surface differential operators as introduced in Section 5. These formulas together with similar ones for the operator $\mathbf{P}_r M_\kappa \mathbf{P}_r^{-1}$ can now be the starting point for generalization of the analysis of shape differentiability of the Maxwell boundary integral operators to Lipschitz domains. We expect that the results for the differentiability of the surface differential operators and then also of the boundary integral operators will be similar to what we have obtained for the case of smooth domains. This is, however, far from trivial and will require further work.
