2 Abstract

3

4 The *dltABCD* cluster is involved in the D-alanylation of teichoic acids in gram 5 positive bacteria. In order to determine the role of this alanylation in the physiology and virulence of Lactococcus garvieae, a previously isolated 6 7 dltA∆Tn917 signature tagged mutagenesis (STM) clone was analyzed. RT-PCR 8 results revealed that *dltABCD* genes form an operon. No major differences 9 could be established between the parental and mutant strains with respect to 10 growth rate, autolytic properties, and susceptibility to acid conditions, lysozyme 11 treatment, anionic detergents, or oxidant agents. However, the *dltA* mutant was 12 more susceptible to nisin than the parental strain, with minimum inhibitory 13 concentration (MIC) values of 8 µg/ml and 16 µg/ml, respectively. Less 14 proliferation of the mutant was observed in in vivo competence index 15 experiments (CI= 0.08). Furthermore, the mutant strain had a 50% lethal dose (LD₅₀) three-fold that of the parental strain. These results, together with the fact 16 17 that the *dltA* Δ Tn917 mutant was isolated as a STM clone, reveal that the *dltA* locus of L. garvieae is required for full growth and pathogenesis on rainbow 18 19 trout. 20

1 **1. Introduction**

2

3 L. garvieae is the etiological agent of lactococcosis that causes hyperacute, 4 haemorrhagic septicaemia in many fish species the world over with special 5 incidence in rainbow trout (Onchorhynchus mykiss) and yellowtail (Seriola 6 quinqueradiata) aquaculture (Vendrell et al., 2006). Moreover, this 7 microorganism is ubiquitous, as it has also been isolated in buffaloes suffering from mastitis (Teixeira et al., 1996) and even in humans, associated with 8 9 bacterial endocarditis and with different tissue infections (Fihman et al., 2006; Li 10 et al., 2008). This suggests that this bacterium might be considered an 11 emerging pathogen and potential zoonotic agent.

Despite the importance of this pathogen, little is known about the molecular basis of its mechanisms of virulence. According to several studies, the presence or absence of a capsule is a major determinant of virulence (Barnes et al., 2002) and putative siderophores have been reported in *L. garvieae* (Schmidtke and Carson, 2003).

dlt operon gene products reportedly participate in D-alanylation of teichoic acids in many gram positive bacteria (Neuhaus and Baddiley, 2003) and disturbances of this activity have been shown to produce a wide variety of phenotypic changes. Additionally, a correlation has been established between D-alanylation of teichoic acids and virulence in *Listeria monocytogenes* (Abachin et al., 2002), *Streptococcus agalactiae* (Poyart et al., 2003), and *Staphylococcus aureus* (Collins et al., 2002).

Here we report the identification and sequence of the *dlt* loci in *L. garvieae*. RT-PCR analyses have indicated that said genes form a *dltABCD* operon. Characterization of a *dltA* Δ Tn*917* mutant showed that the bacterium presents an alteration of the cell surface charge and increased susceptibility to nisin in comparison to the parental strain. Furthermore, the growth capacity of the bacterium was severely impaired in rainbow trout, its natural host.

2	2. Materials and methods			
3				
4	2.1. Bacterial strains and culture conditions			
5				
6	The strains used in this study were <i>L. garvieae</i> UNIUD074 (obtained from Dr L.			
7	Gusmani, University of Udine, Italy) and mutant XVIII (Menéndez et al., 2007).			
8	L. garvieae strains were routinely cultured at 20 C° in brain heart infusion (BHI)			
9	broth (Difco). Erythromycin, 1 µg/ml, was added to the medium when growing			
10	mutant XVIII. BHI plates contained 2% agar.			
11				
12	2.2. DNA manipulation			
13				
14	Chromosomal DNA extraction was conducted using the GenElute Bacterial			
15	Genomic DNA kit (Sigma-Aldrich Co.) following the manufacturer's instructions.			
16	Routine DNA manipulation was performed as described by Sambrook & Russell			
17	(2001). Phage T4 DNA ligase, calf intestinal alkaline phosphatase, and			
18	restriction enzymes were purchased from Amersham, and oligonucleotides			
19	were from Sigma-Aldrich Co.			
20				
21	2.3. Identification of genomic regions flanking Tn917 insertion in mutant XVIII			
22				
23	Tn917 insertion in mutant XVIII occurred in a gene encoding a protein			
24	homologous to DItA (Menéndez et al., 2007). The inverse PCR method (IPCR)			
25	was used to amplify Tn917-DNA flanking regions. L. garvieae UNIUD074			
26	genomic DNA was digested with Pstl at 37°C for 5 hours. The digested DNA			
27	was then circularized at 16°C overnight and the reaction mix was used as the			
28	template for IPCR under the following conditions: 10 min of denaturation at			
29	94°C, 35 1-min cycles at 94°C, 1 min at 60°C, and 10 min at 72°C, followed by			
30	10 min of final extension at 72°C. Primers dltA1: 5'			
31	GGTTCCACCCGTTGTCAAGC 3' and dltA2: 5' GCTATCACAAGTATTCA 3',			
32	designed from the known <i>dltA</i> sequence of <i>L. garvieae</i> (Menéndez et al., 2007),			
33	were used in the amplification process. The PCR product was purified with the			
34	GFX PCR DNA and Gel Band Purification Kit (GE Healthcare) and the			

sequence was obtained in an ABI Prism 310A automated DNA sequencer from
 Perkin-Elmer, according to the manufacturer's instructions, at the facilities' of
 the Universidad de Oviedo. Sequence analysis was performed using the
 BLASTX computer program (http://blast.ncbi.nlm.nih.gov/).

6 2.4. RNA isolation and RT-PCRs

7

8 Total RNA was obtained from 2 ml overnight cultures of parental and mutant 9 strains grown in BHI. RNA was isolated using an RNeasy Mini Kit (QIAGEN, 10 Valencia, CA.) and treated with DNase I-RNase-free (Ambion, Inc.) to eliminate 11 traces of DNA. Reverse transcriptions (RT-PCRs) were performed using 12 Superscript One-Step with Platinum Taq (Invitrogen Life Technologies, 13 Carlsbad, CA.). Seventy nanograms of RNA were used in each reaction. Control PCRs using Platinum Taq DNA polymerase (Invitrogen Life 14 15 Technologies, Carlsbad, CA.) were carried out to determine whether RNA was free of contaminant DNA and negative controls were included in each run by 16 17 omitting the reverse transcription step. The primers used for RT-PCR reactions 18 are listed in Table 1.

20 2.5. Alcian Blue binding assay

21

22 The binding capacity of the cationic colorant Alcian blue to both strains was 23 determined using the method described by Chan et al. (2007) with slight 24 modifications. Briefly put, cells grown in BHI and adjusted to an optical density 25 (OD) at 600 nm of 0.4, were harvested and washed once by centrifugation 26 $(10,000 \times g \text{ for 5 min})$ with 20 mM morpholinepropanesulfonic acid (MOPS) 27 buffer (pH 7). The cells were resuspended in MOPS buffer to a final OD at 600 28 nm of 0.4, and the cationic dye Alcian blue 8GX (Sigma Aldrich Co.) was added 29 to a final concentration of 250 µg/ml. Samples were rotated at room 30 temperature. After 10 min, the mixtures were centrifuged to pellet the bacteria 31 and the unbound Alcian blue present in the supernatants was measured at 32 OD₆₁₅ nm. In parallel, tubes containing the same amount of Alcian blue in 33 MOPS buffer but without bacteria were treated in identical manner as controls. 34 The amount of Alcian blue bound to the bacteria was calculated as (OD₆₁₅ of

control supernatant – OD₆₁₅ of sample supernatant) / OD₆₁₅ of control
 supernatant x 100. Each experiment was carried out three times.

4 2.6. Antimicrobial susceptibility test

5

Antimicrobial susceptibility tests were performed according to the broth 6 7 microdilution methods described by the Clinical and Laboratory Standards 8 Institute (CLSI, 2006). Three antimicrobial agents were used: nisin (0.0156–16 9 μ g/ml), vancomycin (0.0156–16 μ g/ml), and sodium collistimethate (16-4,096) 10 µg/ml). Antibacterial agents were serially diluted twice in cation-adjusted 11 Mueller-Hinton broth (CAMHB) in U-bottom 96-well microtiter plates. For 12 inoculation, 0.5 McFarland suspensions of the isolates were diluted 10-fold with 13 CAMHB. Diluted inocula (5 µl) were added to each microtiter well and incubated at 28°C for 24 h. Each panel contained a negative control well without 14 15 antibiotics or inoculum. The lowest concentration of antibiotic that visibly inhibited bacterial growth was regarded as the MIC (CLSI, 2006). Currently, no 16 17 criteria have been established for interpreting MIC test results in aquatic 18 pathogens (resistant, intermediate, or susceptible breakpoints). Each 19 experiment was carried out three times.

21 2.7. Competition experiments and LD₅₀ determination

22

For each *in vivo* experiment, rainbow trout (*Oncorrhynchus mykiss* weighing between 10 and 15 g) were obtained from a commercial fish farm and the animals were maintained in 60-litre plastic tanks supplied with well-aerated dechlorinated water at 18°C.

27 For *in vivo* competition assays, parental strain UNIUD074 and mutant XVIII 28 were grown separately in BHI at 20°C and adjusted to an OD at 600 nm of 0.5 (10⁸ CFU/mI). Bacteria were harvested and washed in phosphate-buffered 29 30 saline (PBS) and mutant XVIII was mixed with the parental strain. Dilutions of 31 the resultant suspension were plated onto BHI (to measure total CFU) and BHI 32 with erythromycin (to determine mutant CFU). From this, the exact mutant to parental input ratio was calculated. A sample of 10⁴ CFU of the mixed 33 34 suspension in 0.1 ml was used to infect ten rainbow trout by intraperitoneal

injection. After 72 h, three animals were sacrificed and dissected, and the liver
and spleen were homogenized in BHI with a stomacher. Homogenates were
plated onto selective media to determine the mutant to parental output ratio. CI
is defined as the output ratio (mutant/parental) divided by the input ratio
(mutant/parental). Each experiment was carried out twice.

7 For 50% lethal dose (LD₅₀) determinations, groups of 10 fish were challenged 8 by intraperitoneal injection of 0.1-ml serial tenfold dilutions of exponential-phase 9 cultures of the strains L. garvieae UNIUD074 and mutant XVIII corresponding to a range of 10² to 10⁷ CFU. The microorganisms were previously washed and 10 resuspended in PBS. A group of ten fish injected with 0.1 ml of PBS was used 11 12 as controls. Mortality of the fish was recorded over a period of 7 days post 13 injection and some dead specimens were removed and dissected for routine 14 bacteriological examination. Samples of the spleens and livers were plated onto 15 BHI and BHI with erythromycin; PCR analysis confirmed that L. garvieae colonies were present. Each experiment was carried out twice and LD₅₀ were 16 17 calculated three days post injection using Reed and Muench's statistical 18 approach (1938). All of the animal experiments were conducted in compliance 19 with European legislation governing animal welfare and were authorized and 20 supervised by the Animal Experimentation Ethics Committee from the Oviedo 21 University.

1 **3. Results and discussion**

2

3 The application of STM to L. garvieae UNIUD074 led to the identification of 29 4 mutants that could not be recovered from rainbow trout following infection 5 (Menéndez et al., 2007). Among them, mutant XVIII, which showed a single 6 Tn917 insertion in a *dltA* gene homologue, underwent further analysis. The 7 IPCR method was used to amplify the Tn917-DNA flanking regions. Sequence 8 analysis of the amplicon obtained led to the identification of a 4,700 bp DNA 9 segment containing five open reading frames (ORF), all in the same direction. 10 The deduced amino acid sequence of the first ORF revealed 39% identity to 11 the hypothetical protein L170548 of Lactococcus lactis subsp. lactis II1403 12 (accession number NP267886). This protein has an alpha/beta hydrolase 13 domain whose function has yet to be characterized and is encoded by the yriC 14 gene. The products of the transduction of the other four ORFs disclosed 15 significant identities to the proteins encoded by the *dlt* region, which has been 16 seen to be involved in the D-alanylation of teichoic acids in many gram positive 17 bacteria. These proteins are: DltA (with 62% identity to the DltA protein of 18 Lactococcus lactis subsp. cremoris MG1363), DltB, DltC, and DltD (revealing an 19 identity of 69%, 80%, and 49% to the DltB, DltC and DltD proteins of L. lactis subsp. lactis II1403, respectively). DltA gene product is a protein containing 501 20 21 amino acids (Accession number FJ973474); the Tn917 transposon insertion 22 into the gene occurred in the coding sequence at amino acid position 363. This 23 means that the Tn917 insertion site precedes two of the three regions proposed 24 by Heaton and Neuhaus (1992) as being essential to *dltA* gene function. In 25 order to examine the possibility of there being more than one copy of the dlt 26 genes, Southern Blot analysis of BamHI digested genomic DNA from L. 27 garvieae UNIUD074 was conducted using an internal labelled PCR dltA 28 generated fragment as a probe. A single hybridization band was observed 29 suggesting the presence of a single locus for the *dlt* operon (data not shown). 30 The *dltABCD* cluster in *L. garvieae* is flanked by two transcriptional terminators 31 (Fig. 1a). Analysis of *dltABCD* genetic organization showed that *dltB* overlaps 32 the stop codon of *dltA* by 1 bp, whereas *dltB* and *dltC* are separated by 24 bp 33 and *dltD* overlaps the stop codon of *dltC* by 14 bp. Therefore, a translation 34 coupling mechanism previously described in other *dlt* operons may be also

1 present in L. garvieae to provide coordinated synthesis of Dlt proteins. 2 However, it is worth noting that presumed ribosome binding sites (RBS) 3 preceded the dltA (GGAG), dltB (GGAGG), dltC (GAAG), and dltD (GGA) start 4 codons (Fig. 1a). Hence, the *dltABCD* gene translation in *L. garvieae* might also 5 be specific for each gene and independent from the preceding genes. This 6 putative RBS configuration is also present in the *dlt* operon of *L*. *lactis* 7 (accession number AE008562) and S. agalactieae (accession number 8 AJ291784). Further experiments are needed to determine the translational 9 process of the *dlt* operon.

11 The small size of the intergenic spaces, together with the presence of putative 12 transcriptional terminators flanking the *dltABCD* gene cluster of *L. garvieae*, 13 suggested that it might be transcribed as a single unit as occurs in other gram 14 positive bacteria. This was confirmed by RT-PCR analyses using the primers 15 listed in Table 1. Fragments corresponding to the overlapping regions of the dltABCD genes were amplified when RNA from the parental strain L. garvieae 16 17 UNIUD074 was used (Fig. 1b), revealing that the *dlt* loci form an operon. When 18 RNA from the *dltA*\DeltaTn917 strain was used in RT-PCR analysis, the *dltA* gene 19 was not amplified (Fig. 1c). Nevertheless, amplifications were obtained 20 corresponding to the overlapping region *dltA-dltB* and to an internal region of 21 the *dltB* locus (Fig. 1c). This indicates that the *dltA* mutation resulting from the Tn917 insertion does not have a polar effect. It could be due to the fact that the 22 23 transposon Tn917 has some kind of promoter activity. Thus, Dobinsky et al. 24 (2002) observed that transposon Tn917 allowed transcriptional read-through 25 into downstream located genes when Tn917 inserted in the same transcriptional 26 direction as those genes, as occurred in the *dltA*\DTn917 strain. However, the 27 translational coupling may compromise the expression of *dltA* downstream 28 genes.

In several previous studies, defects in the D-alanylation of teichoic acids were hypothesized to result in a more negative cell surface charge, since the positively charged amino groups of D-alanyl esters partially antagonize the negative charges of the backbone phosphate groups (Neuhaus and Baddiley, 2003). To examine this, the binding capacity of cationic dye Alcian blue to both

strains was determined following the method previously described by Chan et al. (2007). The results from the Alcian blue binding assay revealed that the mutant has an increased negative surface charge. Therefore, the *dlt*A Δ Tn*917* strain bound 89.9% ± 1.15 of the Alcian blue versus 80.48% ± 2.44 in the case of the parental strain. These values differ statistically (P<0.05) and are similar to the ones found in the Alcian blue binding assay of *Streptococcus gordonii dltA* mutants (Chan et al., 2007). These results are also consistent with those obtained in the cytochrome c binding assay of *Bacillus subtilis dlt* mutants (Wecke et al., 1997), which reflected an increase in anionic binding sites on the bacterial surface, indicating that the cell's surface charge had been modified

13 Teichoic acids are expected to bear a higher negative charge if defects in D-14 alanyl substitutions occur; consequently, *dlt* mutants in several gram positive 15 bacterial species exhibit enhanced sensitivity to antimicrobial cationic peptides 16 (Peschel et al., 1999; Kristian et al., 2005; Kovacs et al., 2006; Perea Velez et 17 al., 2007). Thus, the parental and *dltA* mutant strains were tested for 18 susceptibility to the antibiotics nisin, vancomycin, and sodium colistimethate. 19 Thanks to their increased negative cell surface charge, *dlt* mutants bind 20 positively charged compounds such as the cationic antimicrobial nisin more 21 avidly, resulting in increased sensitivity. Accordingly, the MIC determination of 22 nisin showed that the *dltA* mutant is more sensitive to the antibiotic than the 23 parental strain, with values of 8 µg/ml and 16 µg/ml, respectively. Sensitivity to 24 nisin in gram positive bacteria depends on different mechanisms. Thus, in S. 25 aureus, the absence of D-alanylation leads to increased sensitivity to nisin 26 (Peschel et al., 1999), albeit not in *L. monocytogenes* (Davies et al., 1996) or in 27 Streptococcus bovis (Mantovani and Russell, 2001). On the contrary, no 28 differences were observed in MIC values between parental and mutant strains 29 for vancomycin (MIC 0.5 µg/ml) and sodium colistimethate (MIC 4,096 µg/ml). It 30 should be noted that gram positive bacteria are less susceptible than gram 31 negative bacteria to sodium colistimethate and other polymyxin antibiotics due 32 to the protective effect of their cell wall. On the other hand, other cell surface 33 modifications may also contribute to resistance to antimicrobial peptides. 34 Similarly, deacetylation of the hexosamine residues of the peptidoglycan by

1 PgdA introduces positive charges into murein in Streptococcus pneumoniae 2 (Vollmer and Tomasz, 2000) and the modification of anionic membrane lipids 3 with L-lysine by *MprF* decreases the negative charge of the membrane surface in S. aureus (Peschel et al., 2001). Thus, a group of several mechanisms may 4 5 be responsible for conferring overall resistance to antimicrobial peptides and the 6 role D-alanylation of teichoic acids plays in resistance may vary considerably 7 from one bacterial species to another (Peschel et al., 1999; Abachin et al., 8 2002; Poyart et al., 2003).

9

10 Comparison of the growth curves of the parental and *dltA* Δ Tn917 strains 11 showed no differences (data not shown). No differences were detected in their 12 autolytic properties either as per the induced autolysis assay described by 13 Perea Velez et al. (2007) (data not shown). Likewise, both strains behaved 14 identically when grown on BHI media under acid conditions and presented 15 equal MIC values to lysozyme, SDS, and H_2O_2 (data not shown). These results 16 contrast those of previous reports that reported differences in growth rates 17 (Clemans et al., 1999), induced autolysis (Walter et al., 2007), and sensitivity to 18 acid conditions (Walter et al., 2007), lysozyme (Giaouris et al., 2008), anionic 19 detergents (Perea Vélez et al., 2007), or oxidant agents between parental 20 strains and *dlt* mutants of gram positive bacteria.

22 Transmission electron microscopy was performed with cells collected in 23 exponential growth and late stationary phases. No dramatic changes in cell 24 morphology were seen in the $dltA\Delta Tn917$ mutant strain populations, as occurs 25 in Lactobacillus plantarum (Palumbo et al., 2006), although some cells 26 presented irregular shapes which were not observed in the parental strain 27 populations (Fig. 2). This variety of physiological differences between dlt 28 mutants and parental strains is observed in other gram positive bacteria 29 (Kovacs et al., 2006; Fittipaldi et al., 2008), given that, while it is apparent that 30 the D-alanyl esters of teichoic acids play an important role in the physiology of 31 the individual species, there is no single phenotype common to all the species 32 examined (Neuhaus and Baddiley, 2003).

1 Despite the absence of any salient physiological changes related to the 2 inactivation of the *dltA* gene, experiments using rainbow trout made it possible 3 to evaluate the specific contribution of D-alanylation of teichoic acids to L. 4 garvieae pathogenesis. CI constitutes an alternative measuring tool to evaluate 5 the degree of growth due to a given mutation in mutant and parental strain 6 coinfections. A value of 0.082 \pm 0.1 was obtained in the *in vivo* competition 7 experiments. This result clearly establishes that the mutant strain has 8 significantly greater difficulty growing inside the host than the parental strain.

The mean LD₅₀ values obtained for the parental and mutant strains were 5.2 x 10 10³ and 4.2 x 10⁶ CFU per fish, respectively. Furthermore, following a seven-11 12 day post injection period, mean survival rates indicated that fish infected with 13 the mutant strain survived longer than those infected with the parental strain (data not shown). This demonstrates that the three-fold LD₅₀ value of the 14 15 dltAATn917 mutant strain versus the parental strain, is not a consequence of 16 attenuated virulence, but rather is due to the bacterium's limited capacity for 17 replication within the host. It is tempting to speculate that this might be a 18 consequence of greater sensitivity of the mutant strain to the peptide antibiotics called cathelicidins, which are produced by rainbow trout and are involved in the 19 20 innate immune response of the fish (Chang et al., 2006). Because they are not 21 commercially available as yet, they could not be assayed in MIC experiments.

23 Dlt mutants of different gram positive pathogens have been described as highly 24 susceptible to death by neutrophils and/or by macrophages (Abachin et al., 25 2002; Poyart et al., 2003; Kristian et al., 2005; Weidenmaier et al., 2005; Chan 26 et al., 2007) and present reduced biofilm formation (Gross et al., 2001) or 27 adherence (Abachin et al., 2002; Kristian et al., 2005). Furthermore, D-28 alanylation of teichoic acids has been seen to contribute to virulence in several 29 gram positive bacteria in surrogate models of infection (Abachin et al., 2002; 30 Collins et al., 2002; Poyart et al., 2003; Weidenmaier et al., 2005), but only one 31 dltA mutant of Streptococcus suis was tested in its natural host (Fittipaldi et al., 32 2008). Therefore, D-alanylation of teichoic acids may be involved in virulence in 33 bacteria by means of a combined action, interfering with the host's innate 34 immune clearance mechanisms and facilitating bacterial penetration through the

natural host's barriers. In this study we report what is, to our knowledge, the first
 evidence of the importance of D-alanylation of teichoic acids in the
 pathogenesis of *L. garvieae*.
