# COMPLEXIFIABLE CHARACTERISTIC CLASSES 

ALEXANDER D. RAHM


#### Abstract

We examine the topological characteristic cohomology classes of complexified vector bundles. In particular, all the classes coming from the real vector bundles underlying the complexification are determined.


## 1. Introduction and statement of the results

In the theory of characteristic classes [5], [4], it is well-known how the Chern classes are mapped to even Stiefel-Whitney classes when converting complex vector space bundles to real vector space bundles by forgetting the complex structure.

In the other direction, we have the fibre-wise complexification: Given a real vector bundle $F \rightarrow B$ with fibre $\mathbb{R}^{n}$, its complexification is the complex vector bundle $F^{\mathbb{C}}:=F \otimes_{\mathbb{R}} \mathbb{C} \rightarrow B$ obtained by declaring complex multiplication on $F \oplus F$ in each fibre $\mathbb{R}^{n} \oplus \mathbb{R}^{n}$ by $i(x, y):=(y, x)$ for the imaginary unit $i$. The Pontrjagin classes of a real vector bundle are (up to a sign) constructed as Chern classes of its complexification. Conversely, which classes of a real vector bundle can be attributed to its complexification? These are the complexifiable characteristic classes which we determine in this article.

Consider a real vector bundle $F \rightarrow B$ and a complex vector bundle $E \rightarrow B$ over the same base space $B$.
Definition 1. A real vector bundle $F$ is called a real generator bundle of $E$, if its complexification $F^{\mathbb{C}}$ is isomorphic to $E$. In the case that such a bundle $F$ exists, we call E real-generated.

Not every complex vector bundle is real-generated, as we shall see in remark 2 . We consider characteristic classes of vector bundles satisfying the axiom of naturality: A class $c$ shall for any morphism of vector bundles $\varphi: F \rightarrow G$ take as value $c\left(\varphi^{*} G\right)$ on the pullback bundle, the image $\varphi^{*} c(G)$ of the map induced on cohomology. Especially, consider a characteristic class $c$ of real vector bundles with the following property: For any real-generated bundle $E$, and any two real generator bundles $F$, $G$ of $E$, the identity $c(F)=c(G)$ holds. Then the values of the class $c$ depend only on the complex bundle $E$, and it is well-defined to consider $c$ as a characteristic class of real-generated complex vector bundles via its values on the real generator bundles. In this case, we will say that the characteristic class $c$ is complexifiable. More formally, we make the following definition.
Definition 2. A characteristic class c of real vector bundles is complexifiable if for all pairs $(F, G)$ of real vector bundles with isomorphic complexification $F^{\mathbb{C}} \cong G^{\mathbb{C}}$, the identity $c(F)=c(G)$ holds.

[^0]We will now give a complete classification of the complexifiable characteristic classes. Denote by $\mathbb{Z}_{2}:=\mathbb{Z} / 2 \mathbb{Z}$ the group with two elements.

Theorem 1. Let c be a polynomial in the Stiefel-Whitney classes $w_{i}$. Then the following two conditions are equivalent:
(i) The class $c$ is an element of the sub-ring $\mathbb{Z}_{2}\left[w_{i}^{2}\right]_{i \in \mathbb{N} \cup\{0\}}$ of the polynomials in the Stiefel-Whitney classes.
(ii) The class $c$ is complexifiable.

By their naturality, characteristic classes are uniquely determined by their value on the universal bundle over the classifying space ( $B \mathcal{O}$ for real vector bundles). As the cohomology ring $\mathrm{H}^{*}\left(B \mathcal{O}, \mathbb{Z}_{2}\right)$ is generated by the values of the Stiefel-Whitney classes, all modulo-2-classes are polynomials in the Stiefel-Whitney classes, and theorem 1 reveals which of them are complexifiable.

We build on this result to investigate which integral cohomology classes are complexifiable. To express our result, we use Feshbach's description [3] of the cohomology ring of the classifying space $B \mathcal{O}$ with $\mathbb{Z}$-coefficients. Consider the Steenrod squaring operation $S q^{1}$ and the mod-2-reduction homomorphism

$$
\rho: \mathrm{H}^{*}(B \mathcal{O}, \mathbb{Z}) \rightarrow \mathrm{H}^{*}\left(B \mathcal{O}, \mathbb{Z}_{2}\right) .
$$

Feshbach uses as generators Pontrjagin classes and classes $V_{I}$ with index sets $I$ that are finite nonempty subsets of $\left\{\frac{1}{2}\right\} \cup \mathbb{N}$, such that

$$
\rho\left(V_{I}\right)=S q^{1}\left(\bigcup_{i \in I} \omega_{2 i}\right),
$$

where $\omega_{i}$ is the $i$-th Stiefel Whitney class of the universal bundle over $B \mathcal{O}$. We give the details of Feshbach's description in the appendix on page 12. We will write $v_{I}$ for the characteristic class taking the value $V_{I}$ on the universal bundle over $B \mathcal{O}$. Our final result now takes the following shape.
Theorem 2. Let $C$ be a polynomial in $v_{I}^{2}$, with I arbitrary, $v_{\left\{\frac{1}{2}\right\}}$ and the Pontrjagin classes $p_{i}$. Then $C$ is complexifiable.

And conversely, we can say the following.
Theorem 3. Let $C$ be a complexifiable integral characteristic class. Then for any real vector bundle $\xi, C(\xi)$ is completely determined by some Chern classes $c_{k}\left(\xi^{\mathbb{C}}\right)$, $k \in \mathbb{N}$.

## 2. Classes in cohomology with $\mathbb{Z}_{2}$-Coefficients

In this section, we shall prove theorem 1, after developing all the tools we need to do so. The proof is cut into the two implication directions, and the implication (ii) $\Rightarrow$ (i) is prepared with several intermediary steps leading to it. One ingredient, lemma 2, follows essentially from work of Cartan on Hopf fibrations. But it only allows to show that complexifiable characteristic classes in cohomology with $\mathbb{Z}_{2}$-coefficients are contained in the ideal generated by the squares of the StiefelWhitney classes. To show that they constitute exactly the subring generated by the squares of the Stiefel-Whitney classes, which is much smaller, we need the technical decomposition of lemma 3 that we prove by induction.

For the whole of this section, we only consider classes in cohomology with $\mathbb{Z}_{2}{ }^{-}$ coefficients. Let $F \rightarrow B$ be a real vector bundle.

Definition 3. A characteristic class $c$ is transferred stable invariant if for any real vector bundle $F$ with trivial complexification ( $F^{\mathbb{C}} \cong B \times \mathbb{C}^{n}$ ), the equation $c(F \oplus G)=c(G)$ holds.
Lemma 1. Let $c=\sum \bigcup w_{i}$ be a polynomial in the Stiefel-Whitney classes, and assume that c is a complexifiable characteristic class. Then, the class c is transferred stable invariant.

Proof. Let $c$ be a complexifiable characteristic class, and let $F$ be a real vector bundle the complexification of which is trivial ( $F^{\mathbb{C}} \cong B \times \mathbb{C}^{n}$ ). Let $G \rightarrow B$ be a real bundle. Then, $c(F \oplus G)=c\left(\left(B \times \mathbb{R}^{n}\right) \oplus G\right)$ because $\left(B \times \mathbb{R}^{n}\right)^{\mathbb{C}}=B \times \mathbb{C}^{n} \cong F^{\mathbb{C}}$ and $c$ is complexifiable.
Thus, $c(F \oplus G)=\sum \bigcup w_{i}\left(\left(B \times \mathbb{R}^{n}\right) \oplus G\right)$ and due to the Whitney sum formula, this term equals $\sum \bigcup w_{i}(G)$, which we identify with $c(G)$.
Remark 1. Restricted to vector bundles with compact Hausdorff base space B, any transferred stable invariant characteristic class $c$ is complexifiable.
Proof. Let $F \rightarrow B, G \rightarrow B$ be real bundles with $F^{\mathbb{C}} \cong G^{\mathbb{C}}$. Forgetting the complex structure, this is $F \oplus F \cong G \oplus G$. As $B$ is compact Hausdorff, there is an inverse bundle $F^{-1} \rightarrow B$, such that $F \oplus F^{-1} \cong B \times \mathbb{R}^{N}$ for some dimension $N$.

Now,

$$
\left(G \oplus F^{-1}\right)^{\mathbb{C}}=G^{\mathbb{C}} \oplus\left(F^{-1}\right)^{\mathbb{C}} \cong F^{\mathbb{C}} \oplus\left(F^{-1}\right)^{\mathbb{C}}=\left(F \oplus\left(F^{-1}\right)\right)^{\mathbb{C}} \cong B \times \mathbb{C}^{N} .
$$

As $c$ is transferred stable invariant, this implies

$$
c\left(G \oplus\left(G \oplus F^{-1}\right)\right)=c(G)
$$

We add $F^{-1}$ to $F \oplus F \cong G \oplus G$ to obtain $c\left(F \oplus F \oplus F^{-1}\right)=c\left(G \oplus G \oplus F^{-1}\right)$, and apply the transferred stable invariance of $c$ also to the left hand side of this equation to deduce $c(F)=c(G)$.
Proof of theorem $1,(i) \Rightarrow(i i)$. Let $F \rightarrow B, G \rightarrow B$ be real bundles with $F^{\mathbb{C}} \cong G^{\mathbb{C}}$. Forgetting the complex structure, this is $F \oplus F \cong G \oplus G$. A consequence of working in $\mathbb{Z}_{2}$-coefficients is that all terms that appear twice in a sum vanish, just like

$$
\sum_{k=1}^{2 i} w_{k} w_{2 i-k}=w_{i}^{2}
$$

Knowing these two facts, and the naturality of Stiefel-Whitney classes under bundle isomorphisms, we apply the Whitney sum formula to check that $w_{i}^{2}$ is complexifiable:

$$
\begin{aligned}
& w_{i}^{2}(F)=\sum_{k=1}^{2 i} w_{k}(F) w_{2 i-k}(F)=w_{2 i}(F \oplus F) \\
= & w_{2 i}(G \oplus G)=\sum_{k=1}^{2 i} w_{k}(G) w_{2 i-k}(G)=w_{i}^{2}(G) .
\end{aligned}
$$

This equation being valid for all $i \in \mathbb{N} \cup\{0\}$, it only remains to check that polynomials of the form $\sum \bigcup w_{i}^{2}$ are complexifiable. To do this, we note that the following brackets commute, because $2=0$ in $\mathbb{Z}_{2}$-coefficients.

$$
\left(\sum \bigcup w_{i}^{2}\right)(F)=\sum \bigcup\left(w_{i}^{2}(F)\right)=\sum \bigcup\left(w_{i}^{2}(G)\right)=\left(\sum \bigcup w_{i}^{2}\right)(G)
$$

Now, we start preparing the proof of theorem $1,(i i) \Rightarrow(i)$. Let $c$ be a complexifiable polynomial in the Stiefel-Whitney classes $w_{i}$. From lemma 1, we see that it is transferred stable invariant.

Let $\mathcal{O}$ be the direct limit of the orthogonal groups, $U$ the direct limit of the unitary groups and $E U$ the universal total space to the classifying space $B U$ for stable complex vector bundles. Let $B \mathcal{O}:=E U / \mathcal{O}$, via the inclusion $\mathcal{O} \subset U$ induced by the canonical inclusion $\mathbb{R} \subset \mathbb{C}$. Let $\gamma\left(\mathbb{R}^{\infty}\right)$ be the universal bundle over $B \mathcal{O}$, and denote its Stiefel-Whitney classes by $\omega_{i}:=w_{i}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)$.

Lemma 2. Let c be a transferred stable invariant characteristic class in cohomology with $\mathbb{Z}_{2}$-coefficients. Then $c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)$ is contained in the ideal $\left\langle\omega_{i}^{2}\right\rangle_{i \in \mathbb{N} \backslash\{0\} \text {. }}$.

Proof. We use the Hopf spaces fibration of Cartan [2, p. 17-22],

$$
U / \mathcal{O} \xrightarrow{f} B \mathcal{O} \xrightarrow{p} B U
$$

where the projection $p$ is the rest class map to dividing the whole group $U$ out of $E U$; and $f: U / \mathcal{O} \rightarrow B \mathcal{O}$ embeds a fibre. The cohomology ring $\mathrm{H}^{*}\left(B \mathcal{O}, \mathbb{Z}_{2}\right)$ is the polynomial algebra $\mathbb{Z}_{2}\left[\omega_{1}, \omega_{2}, \ldots\right]$ with generators the Stiefel-Whitney classes of the universal bundle. Cartan [2, p. 17-22] has shown that $f^{*}$ maps these generators $\omega_{i}$ to the generators $\nu_{i}:=w_{i}\left(f^{*} \gamma\left(\mathbb{R}^{\infty}\right)\right)$ of the exterior algebra

$$
\mathrm{H}^{*}\left(U / \mathcal{O}, \mathbb{Z}_{2}\right)=\bigwedge\left(\mathbb{Z}_{2}\left[\nu_{1}, \nu_{2}, \ldots\right]\right)
$$

which is obtained by dividing the ideal $\left\langle\nu_{i}^{2}\right\rangle_{i \in \mathbb{N} \backslash\{0\}}$ out of the polynomial algebra $\mathbb{Z}_{2}\left[\nu_{1}, \nu_{2}, \ldots\right]$. Hence, exactly the ideal $\left\langle\omega_{i}^{2}\right\rangle_{i \in \mathbb{N} \backslash\{0\}}$ is mapped to zero. So to write

$$
\left\langle\omega_{i}^{2}\right\rangle_{i \in \mathbb{N} \backslash\{0\}}=\operatorname{ker} f^{*}
$$

Composing $f$ with the projection $p: B \mathcal{O} \rightarrow B U$, we obtain a constant map (the whole fibre is mapped to its basepoint) and therefore a trivial bundle $(p \circ f)^{*} \gamma\left(\mathbb{C}^{\infty}\right)$. This pullback of the complex universal bundle is the complexification of $f^{*} \gamma\left(\mathbb{R}^{\infty}\right)$ :

$$
\begin{gathered}
(p \circ f)^{*} \gamma\left(\mathbb{C}^{\infty}\right)=f^{*} p^{*} E U \times_{U} \mathbb{C}^{\infty}=f^{*} E \mathcal{O} \times_{\mathcal{O}} \mathbb{C}^{\infty}=f^{*}\left(E \mathcal{O} \times_{\mathcal{O}} \mathbb{R}^{\infty}\right)^{\mathbb{C}} \\
=f^{*} \gamma\left(\mathbb{R}^{\infty}\right)^{\mathbb{C}}=\left(f^{*} \gamma\left(\mathbb{R}^{\infty}\right)\right)^{\mathbb{C}}
\end{gathered}
$$

So, $f^{*} \gamma\left(\mathbb{R}^{\infty}\right)$ admits a trivial complexification, and all of the transferred stable invariant classes $c$ must treat it like the trivial bundle $\varepsilon$ : $c\left(f^{*} \gamma\left(\mathbb{R}^{\infty}\right)\right)=c(\varepsilon)$. A pullback of the trivial bundle is trivial too, so

$$
0=c\left(f^{*} \gamma\left(\mathbb{R}^{\infty}\right)\right)-c\left(f^{*} \varepsilon\right)=f^{*}\left(c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)\right)
$$

by naturality. Whence, $c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)$ is an element of the kernel of $f^{*}$, which we have identified with the ideal $\left\langle\omega_{i}^{2}\right\rangle_{i \in \mathbb{N} \backslash\{0\} \text {. }}$

Lemma 3. Any complexifiable characteristic class c admits a decomposition

$$
\begin{aligned}
& c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon) \\
& =\sum_{j_{1}=1}^{m} \omega_{i_{j_{1}}}^{2} \cup \sum_{j_{2}=1}^{m_{j_{1}}} \omega_{i_{\left(j_{1}, j_{2}\right)}^{2}}^{2} \cup \sum \ldots \cup \sum_{j_{k}=1}^{m_{\left(j_{1}, \ldots, j_{k-1}\right)}} \omega_{i_{\left(j_{1}, \ldots, j_{k}\right)}^{2}}^{2} \cup r_{\left(j_{1}, \ldots, j_{k}\right)}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right) \\
& +\sum_{j_{1}=1}^{m} \omega_{i_{j_{1}}}^{2} \cup r_{j_{1}}(\varepsilon)+\ldots+\sum_{j_{1}=1}^{m} \omega_{i_{j_{1}}}^{2} \cup \sum \ldots \cup \sum_{j_{k-1}=1}^{m_{\left(j_{1}, \ldots, j_{k-2}\right)}} \omega_{i_{\left(j_{1}, \ldots, j_{k-1}\right)}^{2} \cup r_{\left(j_{1}, \ldots, j_{k-1}\right)}(\varepsilon)}
\end{aligned}
$$

for some $m, m_{j_{1}}, \ldots, m_{\left(j_{1}, \ldots, j_{k-1}\right)} \in \mathbb{N} \cup\{0\}$, some $i_{j_{1}}, \ldots, i_{\left(j_{1}, \ldots, j_{k}\right)} \in \mathbb{N} \backslash\{0\}$,
some $r_{\left(j_{1}, \ldots, j_{k}\right)}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right) \in H^{*}\left(B \mathcal{O}, \mathbb{Z}_{2}\right)$,
and some coefficients $r_{j_{1}}(\varepsilon), \ldots, r_{\left(j_{1}, \ldots, j_{k-1}\right)}(\varepsilon) \in\{0,1\}$,
such that for all $\vec{j}:=\left(j_{1}, \ldots, j_{k}\right)$ and $I(\vec{j}):=\left\{i_{j_{1}}, \ldots, i_{\left(j_{1}, \ldots, j_{k}\right)}\right\}$, the following inequation holds:

$$
2 \sum_{p \in I(\vec{j})} p>\operatorname{deg} c
$$

Once this lemma is established, we use that the degree must be the same on both sides of its equation, to deduce that the sum over all terms containing a factor $\bigcup_{p \in I(\vec{j})} \omega_{p}^{2}$ of too high degree $\left(2 \sum_{p \in I(\vec{j})} p\right)$ must vanish.

As the classes $c(\varepsilon), r_{\vec{j}}(\varepsilon)$ of the trivial bundle $\varepsilon$ are just coefficients in $\mathrm{H}^{0}\left(B \mathcal{O}, \mathbb{Z}_{2}\right) \cong\{0,1\}$, a polynomial $c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)$ in some squares $\omega_{p}^{2}, p \in \mathbb{N} \cup\{0\}$ will remain:

$$
\begin{aligned}
& c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)=c(\varepsilon)+\sum_{j_{1}=1}^{m} \omega_{i_{j_{1}}}^{2} \cup r_{j_{1}}(\varepsilon)+\ldots+\ldots \\
& +\sum_{j_{1}=1}^{m} \omega_{i_{j_{1}}}^{2} \cup \sum \ldots \cup \sum_{j_{k-1}=1}^{m_{\left(j_{1}, \ldots, j_{k-2}\right)}} \omega_{i_{\left(j_{1}, \ldots, j_{k-1}\right)}^{2}}^{2} \cup r_{\left(j_{1}, \ldots, j_{k-1}\right)}(\varepsilon) .
\end{aligned}
$$

As characteristic classes are determined by their value on the universal bundle, this argument implies theorem $1,(\mathrm{ii}) \Rightarrow(\mathrm{i})$.

Before giving the proof of the required lemma 3, we shall introduce two notations just to make that proof more readable.

Definition 4. An index vector $\vec{j}$ appears in a given decomposition of $c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)$, if this decomposition admits a summand of the form

$$
r_{\vec{j}}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right) \cup \bigcup_{p \in I(\vec{j})} \omega_{p}^{2}
$$

and if $\left(2 \sum_{p \in I(\vec{j})} p\right) \leq \operatorname{deg} c$.

Note that the terms $\left(r_{\vec{j}}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right) \cup \bigcup_{p \in I(\vec{j})} \omega_{p}^{2}\right)$ with $\left(2 \sum_{p \in I(\vec{j})} p>\operatorname{deg} c\right)$ must vanish in any decomposition of $c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)$. That is why we do not let them contribute in the last definition.
Definition 5. Set $l:=\underset{\vec{j} \text { appears }}{\min } \max I(\vec{j})$. Consider an index vector $\vec{j}$ appearing in a given decomposition of $c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)$.
If $\max I(\vec{j})=l$, then we call $r_{\vec{j}}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-r_{\vec{j}}(\varepsilon)$ a low situated rest term.
As seen so far, $c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)$ lies in $\operatorname{ker} f^{*}=\left\langle\omega_{i}^{2}\right\rangle_{i \in \mathbb{N} \backslash\{0\}}$, so there is a decomposition

$$
c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)=\sum_{j_{1}=1}^{m} \omega_{i_{j_{1}}}^{2} \cup r_{j_{1}}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right),
$$

for some $m \in \mathbb{N} \cup\{0\}$, some $i_{j_{1}} \in \mathbb{N} \backslash\{0\}$, and some $r_{j_{1}}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right) \in \mathrm{H}^{*}\left(B \mathcal{O}, \mathbb{Z}_{2}\right)$. We will show that there is a low situated rest term $r_{j_{1}}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-r_{j_{1}}(\varepsilon)$ in this decomposition that lies in ker $f^{*}$. Then, that low situated rest term admits a decomposition as a linear combination of squares $\omega_{i_{\left(j_{1}, j_{2}\right)}}^{2}$ with coefficients $r_{\left(j_{1}, j_{2}\right)}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)$ in $\mathrm{H}^{*}\left(B \mathcal{O}, \mathbb{Z}_{2}\right)$, leading to a new decomposition of $c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)$. So, inductively, we will replace a low situated rest term in any given decomposition of $c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)$ by a linear combination the coefficients of which are rest terms with longer index vectors. That is why after a finite number of these steps, the index vectors $\vec{j}$ will no more appear, because the sums $\left(2 \sum_{p \in I(\vec{j})} p\right)$ will exceed the degree of $c$. This is the moment when all low situated rest terms are eliminated and the decomposition described in lemma 3 is achieved.

To carry out this strategy, we first need to introduce the following truncation procedure.
Truncated stable invariance. With lemma 4, we shall give a sense to "the truncation of the equation $c(F \oplus G)=c(G)$ at the dimension $l$ ". Define the bundles

$$
F:=p r_{1}^{*} f^{*} \gamma\left(\mathbb{R}^{\infty}\right) \longrightarrow U / \mathcal{O} \times B \mathcal{O}
$$

and

$$
G:=p r_{2}^{*} \gamma\left(\mathbb{R}^{\infty}\right) \longrightarrow U / \mathcal{O} \times B \mathcal{O},
$$

where $p r_{i}$ shall be the projection on the $i$-th factor of the base space $U / \mathcal{O} \times B \mathcal{O}$. Let $l \in \mathbb{N}$. Consider the map

$$
\left(i d, e m b_{l}\right):\left(U / \mathcal{O} \times B \mathcal{O}_{l}\right) \hookrightarrow(U / \mathcal{O} \times B \mathcal{O})
$$

where $e m b_{l}: B \mathcal{O}_{l} \hookrightarrow B \mathcal{O}$ shall be the natural embedding, recalling that $B \mathcal{O}$ is the direct limit over all $B \mathcal{O}_{l}, l \in \mathbb{N}$. Then the bundle $G_{l}:=\left(i d, e m b_{l}\right)^{*} G$ admits StiefelWhitney classes that are in bijective correspondence with those of the $l$-dimensional universal bundle $\gamma_{l}\left(\mathbb{R}^{\infty}\right) \rightarrow B \mathcal{O}_{l}$.

To be precise, $G_{l} \cong p r_{B \mathcal{O}_{l}}{ }^{*} \gamma_{l}\left(\mathbb{R}^{\infty}\right)$ and the situation is


Especially, $w_{p}\left(G_{l}\right)$ vanishes for $p>l$.
Lemma 4. Under the above assumptions, the following equation holds:

$$
\sum_{\vec{j} \text { appears }}^{\max I(\vec{j}) \leq l} r_{\vec{j}}\left(F \oplus G_{l}\right) \bigcup_{p \in I(\vec{j})} w_{p}^{2}\left(G_{l}\right)=\sum_{\vec{j} \text { appears }}^{\max I(\vec{j}) \leq l} r_{\vec{j}}\left(G_{l}\right) \bigcup_{p \in I(\vec{j})} w_{p}^{2}\left(G_{l}\right)
$$

We will call it the equation $c(F \oplus G)=c(G)$ truncated at dimension $l$.
Proof. The bundle $F$ inherits from $f^{*} \gamma\left(\mathbb{R}^{\infty}\right)$ the property to admit a trivial complexification. Therefore, the transferred stable invariance of $c$ applies:

$$
c(F \oplus G)=c(G)
$$

Applying the induced cohomology map $\left(i d, e m b_{l}\right)^{*}$ to this equation, we obtain

$$
c\left(i d^{*} F \oplus e m b_{l}^{*} G\right)=c\left(e m b_{l}^{*} G\right)
$$

and hence

$$
c\left(F \oplus G_{l}\right)=c\left(G_{l}\right)
$$

By the universality of $\gamma\left(\mathbb{R}^{\infty}\right)$, and the naturality of all characteristic classes with respect to the classifying maps of $G_{l}$ and $F \oplus G_{l}$, any given decomposition

$$
c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)=\sum_{\vec{j}} r_{\vec{j}}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right) \bigcup_{p \in I(\vec{j})} \omega_{p}^{2}
$$

gives analogous decompositions

$$
c\left(G_{l}\right)-c(\varepsilon)=\sum_{\vec{j}} r_{\vec{j}}\left(G_{l}\right) \bigcup_{p \in I(\vec{j})} w_{p}^{2}\left(G_{l}\right)
$$

and

$$
c\left(F \oplus G_{l}\right)-c(\varepsilon)=\sum_{\vec{j}} r_{\vec{j}}\left(F \oplus G_{l}\right) \bigcup_{p \in I(\vec{j})} w_{p}^{2}\left(F \oplus G_{l}\right)
$$

Theorem 1, (i) $\Rightarrow$ (ii) gives the transferred stable invariance of $w_{p}^{2}$, making it invariant under adding the bundle $F$, the complexification of which is trivial:

$$
w_{p}^{2}\left(F \oplus G_{l}\right)=w_{p}^{2}\left(G_{l}\right)
$$

Thus, the equation $c\left(F \oplus G_{l}\right)=c\left(G_{l}\right)$ can be rewritten using that all summands containing a factor $w_{p}\left(G_{l}\right)$ with $p>l$ vanish:

$$
\sum_{\vec{j}}^{\max I(\vec{j}) \leq l} r_{\vec{j}}\left(F \oplus G_{l}\right) \bigcup_{p \in I(\vec{j})} w_{p}^{2}\left(G_{l}\right)=\sum_{\vec{j}}^{\max I(\vec{j}) \leq l} r_{\vec{j}}\left(G_{l}\right) \bigcup_{p \in I(\vec{j})} w_{p}^{2}\left(G_{l}\right)
$$

For not to exceed the degree of $c$, also all terms with $2 \sum_{p \in I(\vec{j})} p>\operatorname{deg} c$ must vanish:

$$
\sum_{\vec{j} \text { appears }}^{\max I(\vec{j}) \leq l} r_{\vec{j}}\left(F \oplus G_{l}\right) \bigcup_{p \in I(\vec{j})} w_{p}^{2}\left(G_{l}\right)=\sum_{\vec{j} \text { appears }}^{\max I(\vec{j}) \leq l} r_{\vec{j}}\left(G_{l}\right) \bigcup_{p \in I(\vec{j})} w_{p}^{2}\left(G_{l}\right)
$$

So, this last equation is the equation $c(F \oplus G)=c(G)$ truncated at the dimension $l$.

Proof of lemma 3. We carry out the proof by induction over the index vector pointing at a low situated rest term.
Base case. Lemma 2 implies $c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)=\sum_{j_{1}=1}^{m} \omega_{i_{j_{1}}}^{2} \cup r_{j_{1}}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)$, with $r_{j_{1}}$ some polynomial in the Stiefel-Whitney classes.
Rename $i_{1}, \ldots, i_{m}$ such that $i_{1}<i_{2}<\ldots<i_{m}$.
We truncate the equation $c(F \oplus G)=c(G)$ at the dimension $i_{1}$, and obtain

$$
\sum_{j_{1} \text { appears }}^{i_{j_{1}} \leq i_{1}} r_{j_{1}}\left(F \oplus G_{i_{1}}\right) \cup w_{i_{j_{1}}}^{2}\left(G_{i_{1}}\right)=\sum_{j_{1} \text { appears }}^{i_{j_{1}} \leq i_{1}} r_{j_{1}}\left(G_{i_{1}}\right) \cup w_{i_{j_{1}}}^{2}\left(G_{i_{1}}\right) .
$$

As $i_{1}<i_{2}<\ldots<i_{m}$, this is just $r_{1}\left(F \oplus G_{i_{1}}\right) \cup w_{i_{1}}^{2}\left(G_{i_{1}}\right)=r_{1}\left(G_{i_{1}}\right) \cup w_{i_{1}}^{2}\left(G_{i_{1}}\right)$.
Injectivity of the multiplication map $\cup w_{i_{1}}^{2}\left(G_{i_{1}}\right)$ in $\mathrm{H}^{*}\left(U / \mathcal{O} \times B \mathcal{O}_{i_{1}}, \mathbb{Z}_{2}\right)$ then holds $r_{1}\left(F \oplus G_{i_{1}}\right)=r_{1}\left(G_{i_{1}}\right)$. Then we pull this back with

$$
(i d \times \text { const }): U / \mathcal{O} \rightarrow\left(U / \mathcal{O} \times B \mathcal{O}_{i_{1}}\right),
$$

(where the map const takes just one, arbitrary, value), to obtain

$$
r_{1}\left(f^{*} \gamma\left(\mathbb{R}^{\infty}\right) \oplus \varepsilon\right)=r_{1}(\varepsilon)
$$

Due to Whitney sum formula, the Stiefel-Whitney classes in which $r_{1}$ is a polynomial are stable under adding a trivial bundle, and the above left hand term equals $r_{1}\left(f^{*} \gamma\left(\mathbb{R}^{\infty}\right)\right)$. Using naturality of characteristic classes with respect to pullbacks, this shows that $r_{1}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-r_{1}(\varepsilon)$ lies in $\operatorname{ker} f^{*}$. So we can replace it with a linear combination of quadratic terms, providing a new decomposition,

$$
c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)=\omega_{i_{1}}^{2} \cup \sum_{j_{2}=1}^{m_{1}} \omega_{i_{\left(1, j_{2}\right)}}^{2} \cup r_{\left(1, j_{1}\right)}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)+\omega_{i_{1}}^{2} \cup r_{1}(\varepsilon)+\sum_{j_{1}=2}^{m} \omega_{i_{j_{1}}}^{2} \cup r_{j_{1}}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right) .
$$

Induction hypothesis. Consider a given decomposition

$$
\begin{gathered}
c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)=\sum_{\vec{j}} r_{\vec{j}}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right) \bigcup_{p \in I(\vec{j})} \omega_{p}^{2} \\
+\sum_{j_{1}=1}^{m} \omega_{i_{j_{1}}}^{2} \cup r_{j_{1}}(\varepsilon)+\ldots+\sum_{j_{1}=1}^{m} \omega_{i_{j_{1}}}^{2} \cup \sum \ldots \cup \sum_{j_{k-1}=1}^{m_{\left(j_{1}, \ldots, j_{k-2}\right)}} \omega_{i_{\left(j_{1}, \ldots, j_{k-1}\right)}^{2}}^{2} \cup r_{\left(j_{1}, \ldots, j_{k-1}\right)}(\varepsilon) .
\end{gathered}
$$

Inductive claim. The decomposition of the induction hypothesis admits a low situated rest term that lies in $\operatorname{ker} f^{*}$. We show this in the inductive step.

Inductive step. We truncate the equation $c(F \oplus G)=c(G)$ at the dimension

$$
l:=\min _{\vec{j} \text { appears }} \max I(\vec{j}) .
$$

Then the remaining terms of $c\left(G_{l}\right)-c(\varepsilon)$ do all have the common factor $w_{l}^{2}\left(G_{l}\right)$. This is no zero divisor in $\mathrm{H}^{*}\left(U / \mathcal{O} \times B \mathcal{O}_{l}, \mathbb{Z}_{2}\right)$ and further its multiplication map $\cup w_{l}^{2}\left(G_{l}\right)$ is injective. Now, in $c\left(F \oplus G_{l}\right)=c\left(G_{l}\right)$, this injectivity implies

$$
\sum_{\vec{j} \text { appears }}^{\max I(\vec{j}) \leq l} r_{\vec{j}}\left(F \oplus G_{l}\right) \bigcup_{p \in I(\vec{j}) \backslash\{l\}} w_{p}^{2}\left(G_{l}\right)=\sum_{\vec{j} \text { appears }}^{\max I(\vec{j}) \leq l} r_{\vec{j}}\left(G_{l}\right) \bigcup_{p \in I(\vec{j}) \backslash\{l\}} w_{p}^{2}\left(G_{l}\right) .
$$

$\diamond$ If there is just one low situated rest term $r_{\vec{j}}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-r_{\vec{j}}(\varepsilon)$, then we use the injectivity of the multiplication map

$$
\cup\left(\bigcup_{p \in I(\vec{j}) \backslash\{l\}} w_{p}^{2}\left(G_{l}\right)\right) \text { on } \mathrm{H}^{*}\left(U / \mathcal{O} \times B \mathcal{O}_{l}, \mathbb{Z}_{2}\right)
$$

to obtain $r_{\vec{j}}\left(F \oplus G_{l}\right)=r_{\vec{j}}\left(G_{l}\right)$. Then we pull this back with

$$
(i d \times \text { const }): U / \mathcal{O} \rightarrow\left(U / \mathcal{O} \times B \mathcal{O}_{l}\right)
$$

to obtain $r_{\vec{j}}\left(f^{*} \gamma\left(\mathbb{R}^{\infty}\right) \oplus \varepsilon\right)=r_{\vec{j}}(\varepsilon)$. Using naturality, we see now that the low situated rest term $r_{\vec{j}}\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-r_{\vec{j}}(\varepsilon)$ lies in ker $f^{*}$.
$\diamond$ Else we truncate the remaining equation again at the dimension

$$
l^{\prime}:=\underset{\vec{j} \text { appears }}{\max I(\vec{j})=l} \max (I(\vec{j}) \backslash\{l\}),
$$

such as to obtain

$$
\begin{aligned}
& \sum_{\vec{j} \text { appears }}^{\max (I(\vec{j}) \backslash\{l\}) \leq l^{\prime}} r_{\vec{j}}\left(F \oplus G_{l^{\prime}}\right) \bigcup_{p \in(I(\vec{j}) \backslash\{l\})} w_{p}^{2}\left(G_{l^{\prime}}\right) \\
& =\sum_{\vec{j} \text { appears }}^{\max (I(\vec{j}) \backslash\{l\}) \leq l^{\prime}} r_{\vec{j}}\left(G_{l^{\prime}}\right) \bigcup_{p \in(I(\vec{j}) \backslash\{l\})} w_{p}^{2}\left(G_{l^{\prime}}\right) .
\end{aligned}
$$

Now we proceed analogously with the choice marked with the " $\diamond$ " signs, and after finitely many steps, find a low situated rest term in ker $f^{*}$.
This low situated rest term can be replaced by a linear combination of squares, holding a new decomposition of $c\left(\gamma\left(\mathbb{R}^{\infty}\right)\right)-c(\varepsilon)$.

This completes the induction.

Proof of theorem 1, (ii) $\Rightarrow$ (i). Let $c$ be a complexifiable characteristic class. By the universality of $\gamma\left(\mathbb{R}^{\infty}\right)$, the decomposition of lemma 3 yields the decomposition

$$
\begin{gathered}
c=c(\varepsilon)+\sum_{j_{1}=1}^{m} w_{i_{j_{1}}}^{2} \cup r_{j_{1}}(\varepsilon)+\ldots+\ldots \\
+\sum_{j_{1}=1}^{m} w_{i_{j_{1}}}^{2} \cup \sum \ldots \cup \sum_{j_{k-1}=1}^{m_{\left(j_{1}, \ldots, j_{k-2}\right)}} w_{i_{\left(j_{1}, \ldots, j_{k-1}\right)}^{2} \cup r_{\left(j_{1}, \ldots, j_{k-1}\right)}(\varepsilon) .} .
\end{gathered}
$$

As $c(\varepsilon), r_{j_{1}}(\varepsilon), \ldots, r_{\left(j_{1}, \ldots, j_{k-1}\right)}(\varepsilon)$ are elements of $\left\{0,1=w_{0}=w_{0}^{2}\right\}$, the class $c$ is in the sub-ring $\mathbb{Z}_{2}\left[w_{i}^{2}\right]_{i \in \mathbb{N} \cup\{0\}}$ of the polynomial ring of Stiefel-Whitney classes.

This completes the proof of theorem 1.

## 3. Classes in cohomology with integral coefficients

We will build on our results obtained for $\mathbb{Z}_{2}$-coefficients and use the mod-2reduction homomorphism

$$
\rho: \mathrm{H}^{*}(-, \mathbb{Z}) \rightarrow \mathrm{H}^{*}\left(-, \mathbb{Z}_{2}\right)
$$

to prove the theorems with $\mathbb{Z}$-coefficients stated in the introduction. Define the element $V_{I} \in \mathrm{H}^{*}(B \mathcal{O}, \mathbb{Z})$ as in appendix A , and let $v_{I}$ be the characteristic class with value $V_{I}$ on the universal bundle.

Lemma 5. For any real bundle $\xi$, the mod-2-reduced class $\rho\left(v_{I}^{2}(\xi)\right)$ equals

$$
\left(\sum_{i \in I \cap\left\{\frac{1}{2}\right\}} w_{1}^{2} \cup \bigcup_{j \in I \backslash\{i\}} w_{4 j}+\sum_{i \in I \backslash\left\{\frac{1}{2}\right\}}\left(w_{4 i+2}+w_{2} \cup w_{4 i}\right) \cup \bigcup_{j \in I \backslash\{i\}} w_{4 j}\right)(\xi \oplus \xi) .
$$

Proof. Apply the mod-2-reduction homomorphism:

$$
\begin{gathered}
\rho\left(v_{I}^{2}(\xi)\right)=\left(\rho\left(v_{I}(\xi)\right)\right)^{2}=\left(S q^{1}\left(\bigcup_{i \in I} w_{2 i}(\xi)\right)\right)^{2} \\
=\left(\sum_{i \in I} S q^{1}\left(w_{2 i}(\xi)\right) \cup \bigcup_{j \in I \backslash\{i\}} w_{2 j}(\xi)\right)^{2} \\
=\left(\sum_{i \in I \cap\left\{\frac{1}{2}\right\}} w_{1}^{2} \cup \bigcup_{j \in I \backslash\{i\}} w_{2 j}+\sum_{i \in I \backslash\left\{\frac{1}{2}\right\}}\left(w_{2 i+1}+w_{1} \cup w_{2 i}\right) \cup \bigcup_{j \in I \backslash\{i\}} w_{2 j}\right)^{2}(\xi) .
\end{gathered}
$$

As $2=0$ in $\mathrm{H}^{*}\left(B \mathcal{O}, \mathbb{Z}_{2}\right)$, the above expression equals

$$
\left(\sum_{i \in I \cap\left\{\frac{1}{2}\right\}} w_{1}^{4} \cup \bigcup_{j \in I \backslash\{i\}} w_{2 j}^{2}+\sum_{i \in I \backslash\left\{\frac{1}{2}\right\}}\left(w_{2 i+1}^{2}+w_{1}^{2} \cup w_{2 i}^{2}\right) \cup \bigcup_{j \in I \backslash\{i\}} w_{2 j}^{2}\right)(\xi) .
$$

Using the Whitney sum formula and the symmetry of the terms, we deduce

$$
w_{4 i}(\xi \oplus \xi)=\sum_{k=1}^{4 i} w_{k}(\xi) w_{4 i-k}(\xi)=w_{2 i}^{2}(\xi) .
$$

Hence, the above term equals

$$
\left(\sum_{i \in I \cap\left\{\frac{1}{2}\right\}} w_{1}^{2} \cup \bigcup_{j \in I \backslash\{i\}} w_{4 j}+\sum_{i \in I \backslash\left\{\frac{1}{2}\right\}}\left(w_{4 i+2}+w_{2} \cup w_{4 i}\right) \cup \bigcup_{j \in I \backslash\{i\}} w_{4 j}\right)(\xi \oplus \xi) .
$$

Proof of theorem 2. For $v_{\left\{\frac{1}{2}\right\}}$ and the Pontrjagin classes $p_{i}$, the result is obvious. Now let $F \rightarrow B, G \rightarrow B$ be real bundles with $F^{\mathbb{C}} \cong G^{\mathbb{C}}$. Forgetting the complex structure, this is $F \oplus F \cong G \oplus G$. By naturality of the Stiefel-Whitney classes, the polynomial

$$
\sum_{i \in I \cap\left\{\frac{1}{2}\right\}} w_{1}^{2} \cup \bigcup_{j \in I \backslash\{i\}} w_{4 j}+\sum_{i \in I \backslash\left\{\frac{1}{2}\right\}}\left(w_{4 i+2}+w_{2} \cup w_{4 i}\right) \cup \bigcup_{j \in I \backslash\{i\}} w_{4 j}
$$

takes the same value on $(F \oplus F)$ as on $(G \oplus G)$, for any finite nonempty index set $I \subset\left(\left\{\frac{1}{2}\right\} \cup \mathbb{N} \backslash\{0\}\right)$. Applying lemma 5 , this means $\rho\left(v_{I}^{2}(F)\right)=\rho\left(v_{I}^{2}(G)\right)$.
As $V_{I}^{2}$ is in the torsion of $\mathrm{H}^{*}(B \mathcal{O}, \mathbb{Z})$, restricted on which $\rho$ is injective [3, p. 513], this proves the theorem: $v_{I}^{2}(F)=v_{I}^{2}(G)$.

Corollary from theorem 1. Let $C$ be a complexifiable integral characteristic class. Then $\rho(C)$ is an element of the ring $\mathbb{Z}_{2}\left[w_{i}^{2}\right]_{i \in \mathbb{N} \cup\{0\}}$.
Proof. Let $F \rightarrow B, G \rightarrow B$ be real bundles with $F^{\mathbb{C}} \cong G^{\mathbb{C}}$. The mod-2-reduction $\rho(C)$ is also complexifiable:

$$
\rho(C)(F)=\rho(C(F))=\rho(C(G))=\rho(C)(G)
$$

Theorem 1 now gives the result.
Proof of theorem 3. Feshbach [3, p. 513] shows that

$$
\mathrm{H}^{*}(B \mathcal{O}, \mathbb{Z})=\mathbb{Z}\left[\pi_{i}\right]_{i \in \mathbb{N}} \oplus\{2 \text {--torsion }\}
$$

where $\pi_{i}$ is the value of the Pontrjagin class $p_{i}$ on the universal bundle.
Then $C=\sum \bigcup p_{i}+T$ with some 2 -torsion class $T$.
So for every real bundle $\xi$,

$$
\rho(C)(\xi)=\sum \rho\left(\bigcup p_{i}(\xi)\right)+\rho(T)(\xi)
$$

By definition of the Pontrjagin classes,

$$
\rho(C)(\xi)=\sum \bigcup \rho\left((-1)^{i} c_{2 i}\left(\xi^{\mathbb{C}}\right)\right)+\rho(T)(\xi)
$$

Using the well-known relation [4] between Chern classes and Stiefel-Whitney classes $\rho\left(c_{2 i}\left(\xi^{\mathbb{C}}\right)\right)=w_{4 i}(\xi \oplus \xi)$, further the Whitney sum formula and the symmetry of the summands, we deduce

$$
\rho(C)(\xi)=\sum \bigcup w_{2 i}^{2}(\xi)+\rho(T)(\xi)
$$

Inserting the polynomial of the corollary from theorem 1 , another polynomial in squares is produced, and we obtain $\sum \bigcup w_{j}^{2}(\xi)=\rho(T)(\xi)$.

As according to [3, p. 513], $\rho$ is injective on the torsion elements, there is a local inverse $\left.\rho\right|_{\{2-\text { torsion }\}}{ }^{-1}$ lifting $\rho(T)$ back to $T$. So,

$$
\left.\rho\right|_{\{2-\text { torsion }\}}-1\left(\sum w_{j}^{2}(\xi)\right)=T(\xi)
$$

With the Whitney sum formula and the symmetry of the summands, further the well-known relation between Stiefel-Whitney classes and Chern classes $w_{4 i}(\xi \oplus \xi)=\rho\left(c_{2 i}\left(\xi^{\mathbb{C}}\right)\right)$, this yields

$$
\left.\rho\right|_{\{2-\text { torsion }\}}{ }^{-1}\left(\sum \bigcup \rho\left(c_{j}\left(\xi^{\mathbb{C}}\right)\right)\right)=T(\xi) .
$$

By the decomposition $\sharp$, we finally obtain

$$
C(\xi)=\sum \bigcup(-1)^{i} c_{2 i}\left(\xi^{\mathbb{C}}\right)+\left.\rho\right|_{\{2-\text { torsion }\}} ^{-1}\left(\sum \bigcup \rho\left(c_{j}\left(\xi^{\mathbb{C}}\right)\right)\right) .
$$

Remark 2. No complex vector bundle with some nonzero and non-2-torsion odd Chern class can admit a real generator bundle.

Proof. Consider a real vector bundle $F \rightarrow B$. By reflection on the real axes given by $F, F^{\mathbb{C}}$ is isomorphic to its complex conjugate bundle $\overline{F^{\mathbb{C}}}$. So, any complex bundle $E \rightarrow B$ that admits $F$ as a real generator bundle must be isomorphic to its own conjugate bundle:

$$
E \cong F^{\mathbb{C}} \cong \overline{F^{\mathbb{C}}} \cong \bar{E} .
$$

The odd Chern classes $c_{2 k+1}$ have the property $c_{2 k+1}(E)=-c_{2 k+1}(\bar{E})$ ([5, lemma 14.9]), so

$$
c_{2 k+1}(E)=-c_{2 k+1}(\bar{E})=-c_{2 k+1}(E) \in \mathrm{H}^{4 k+2}(B, \mathbb{Z})
$$

hence $2 c_{2 k+1}(E)=0$.

## Appendix A. The cohomology ring of $B \mathcal{O}$ with $\mathbb{Z}$-coefficients

The cohomology ring of $B \mathcal{O}$ with $\mathbb{Z}$-coefficients is known since Thomas [6], [7] and with all relations between its generators since Brown [1] and Feshbach [3]. It can be obtained as follows. Define the set of generators of $\mathrm{H}^{*}\left(B \mathcal{O}_{n}, \mathbb{Z}\right)$ as in $[3$, definition 1]:
It consists of the Pontrjagin classes $p_{i}$ of the universal bundle over $B \mathcal{O}_{n}$, and classes $V_{I}$ with $I$ ranging over all finite nonempty subsets of

$$
\left\{\frac{1}{2}\right\} \cup\left\{k \in \mathbb{N} \left\lvert\, 0<k<\frac{n+1}{2}\right.\right\}
$$

with the proviso that $I$ does not contain both $\frac{1}{2}$ and $\frac{n}{2}$, for $n>1$.
According to $\left[3\right.$, theorem 2], $\mathrm{H}^{*}\left(B \mathcal{O}_{n}, \mathbb{Z}\right)$ is for all $n \leq \infty$ isomorphic to the polynomial ring over $\mathbb{Z}$ generated by the above specified elements modulo the ideal generated by the following six types of relations.
In all relations except the first, the cardinality of $I$ is less than or equal to that of $J$ and greater than one. (Most of the restrictions on $I$ and $J$ are to avoid repeating relations). By convention, $p_{\frac{1}{2}}$ where it occurs means $V_{\left\{\frac{1}{2}\right\}}$. Also, if $\left\{\frac{n}{2}, \frac{1}{2}\right\} \subset I \cup J$, then $V_{I \cup J}$ shall mean $V_{\left\{\frac{n}{2}\right\}} V_{(I \cup J) \backslash\left\{\frac{n}{2}, \frac{1}{2}\right\}}$.

1) $2 V_{I}=0$.
2) $V_{I} V_{J}+V_{I \cup J} V_{I \cap J}+V_{I \backslash J} V_{J \backslash I} \prod_{i \in I \cap J} p_{i}=0 \quad($ for $I \cap J \neq \emptyset, I \nsubseteq J)$.
3) $V_{I} V_{J}+\sum_{i \in I} V_{\{i\}} V_{(J \backslash I) \cup\{i\}} \prod_{j \in I \backslash\{i\}} p_{j}=0 \quad($ for $I \subset J)$.
4) $V_{I} V_{J}+\sum_{i \in I} V_{\{i\}} V_{(I \cup J) \backslash\{i\}}=0 \quad$ (for $I \cap J=\emptyset$; if $I$ and $J$ have the same cardinality, then the smallest element of $I$ is less than that of $J$ ).
5) $\sum_{i \in I} V_{\{i\}} V_{I \backslash\{i\}}=0$.
6) $V_{\left\{\frac{1}{2}\right\}} p_{\frac{n}{2}}+V_{\left\{\frac{n}{2}\right\}}^{2}=0$, if $n$ is even.

Then $\rho\left(V_{I}\right)=S q^{1}\left(\bigcup_{i \in I} w_{2 i}\right)$, with the Steenrod squaring operation $S q^{1}$.
