² Impact of the herbicide metolachlor on river periphytic diatoms: experimental comparison of descriptors at different biological organization levels

8 **Abstract** – A microcosm experiment was carried out in order to test the effect of the herbicide metolachlor 9 on river periphytic diatoms and to find potential diatom bioindicators of contamination. Effects were
10 investigated at different biological organization levels (biofilm, diatom community, population and individual 10 investigated at different biological organization levels (biofilm, diatom community, population and individual 11 levels). The colonization of glass substrates by natural biofilm in artificial streams did not vary quantitatively
12 between control and contaminated conditions (5 and 30 $\mu g L^{-1}$). However, non-parametric multivaria 12 between control and contaminated conditions (5 and 30 μ g.L⁻¹). However, non-parametric multivariate 13 analysis of variance revealed a significant difference between contaminated and control diatom communities 14 with regard to species composition. The difference was due to the greater development of probably tolerant 15 species in the presence of the herbicide (e.g. Planothidium frequentissimum Planothidium lanceolatum) species in the presence of the herbicide $(e.g., Planothidiumfrequencies in Planothidiumlanceolatum,$ 16 Amphora montana, Surirella brebissonii and Nitzschia gracilis). An increase in the occurrence of abnormal 17 forms was observed in relation to metolachlor concentration. In particular, up to 8% of the frustules of the species Surizalla angusta exhibited prominent deformities. Monospecific acute toxicity tests were then perspecies Surirella angusta exhibited prominent deformities. Monospecific acute toxicity tests were then per-19 formed on two species to estimate toxicity parameters based on growth inhibition. These tests also confirmed 20 the teratogenic effect of the herbicide on S. angusta. This study shows that low concentrations of metolachlor 21 in natural streams may significantly alter diatom community structure and that abnormal diatom forms
22 should be taken into account in water contamination assessment should be taken into account in water contamination assessment.

24 Introduction

Metolachlor (metolachlor) is a herbicide that belongs to the chloroacetanilide class that has replaced triazines to become one of the most frequently occurring groups of herbicides in the French surface waters survey networks 29 (Dubois et al., 2010). It is commonly used before and after crop emergence to prevent weed growth (Kegley et al., 2010). The concentration of metolachlor in rivers is highly variable, peaking during the field application period and after heavy rain. Time-weighted concentrations of over 1 μ g.L⁻¹ were recorded in some rivers and peak concen-35 trations reached several tens of $\mu g \cdot L^{-1}$ (Battaglin et al., 2000; Clark and Goolsby, 2000; Dubois et al., 2010; Roubeix et al., in press). Since agricultural pesticides con- taminate rivers via runoff and spray drift, it has become essential to evaluate their impact on non-target aquatic organisms. AQ1 25

Herbicides contaminating rivers may be particularly 41 toxic to aquatic plants and algae. In shallow rivers, peri- 42 phytic diatoms are often the dominant group of primary 43 producers; they are at the basis of the trophic food 44 web and any alteration of their communities may have 45 repercussions at higher trophic levels. Diatoms are key 46 factors for water quality evaluation in the European 47 Water Framework Directive (European Commission, 48 2000). A good ecological status is attributed to rivers 49 where the species composition of periphytic diatom 50 communities is only slightly altered by human activities 51 (Hering *et al.*, 2010). The toxicity of metolachlor has 52 been assessed via monospecific toxicological tests on micro- 53 algae (Fairchild et al., 1997; Ma and Liang, 2001; 54 Junghans et al., 2003; Ma et al., 2003) but rarely with 55 diatoms (Battaglin et al., 2000). Such tests, based on a 56 single species and focusing on one endpoint (biomass 57 production), only give partial information about the 58 potential impact of the herbicide in the environment. 59 Although it is not yet a standard method, testing 60 *Corresponding author: vincent.roubeix@cemagref.fr microalgal communities sampled in the field assesses toxic 61

62 effects on the individual species as well as on the whole 63 assemblage.

 Communities increase their tolerance to toxicants through two mechanisms: (i) development of tolerant and competitive species and reduction of the relative abundance of sensitive species (Schmitt-Jansen and Altenburger, 2005; Pesce et al., 2010) and (ii) tolerance 69 acquisition of some species to toxic pressure (Ivorra *et al.*, 2002). As diatoms are useful bioindicators of river 71 eutrophication and saproby (Prygiel et al., 1999), there have been many attempts to find specific indicators of toxic pollution in diatom communities. Some field studies have tried to relate periphytic diatom community varia- tions to herbicide concentrations; however, the variations 76 in the field of many interfering factors $(e.g., t$ rophic level, shading and current velocity) make the isolation and clear demonstration of the toxic effect difficult (Morin et al., 2009; Roubeix et al., in press). The experimental exposure of diatom communities to a chosen toxicant in enclosed controlled systems is then a suitable complementary ap- proach. A large set of examples can be found in the literature with various herbicide molecules tested in either mesocosms or microcosms (Kosinski, 1984; Hamala and 85 Kollig, 1985; Noack et al., 2003; Schmitt-Jansen and 86 Altenburger 2005; Mohr et al., 2008; Ricart et al., 2009; Altenburger, 2005; Mohr et al., 2008; Ricart et al., 2009; Vera et al., 2010).

 In this study, microcosm experiments were designed to evaluate the effect of metolachlor on river periphytic diatoms. The objectives were (i) to assess the potential impact of water contamination on diatoms through different endpoints at different biological organization levels and (ii) to find potential indicators among diatoms of pollution by such a herbicide. In order to do this, an experiment using artificial channels was performed to ex- plore the impact of the herbicide on diatom communities grown from river biofilm. Then, the response to metola- chlor exposure of single species composing the commu- nities was assessed via acute toxicological tests using the same descriptors as for the channel experiment to better understand the results obtained with complex assem-102 blages.

103 Material and methods

104 Experimental design

105 Artificial channels

106 Natural diatom communities were collected in rivers by 107 scraping immerged substrates with a scalpel and were 108 maintained in bottled commercial spring water until return 109 to the lab. The diatoms were sampled at four stations 110 located on three small rivers in SW France (the Gèze, 111 Sousson and Save, 'Coteaux de Gascogne') with different 112 exposures to agricultural pollution to obtain maximal 113 species diversity. The upstream station on the Gèze River 114 (Organ, $43.273^{\circ}N$ 0.483 $^{\circ}E$) and the station on the Save 115 River (Montmaurin, $43.230^{\circ}N$ 0.654 $^{\circ}E$) were only slightly impacted by agricultural pollution, whereas significant 116 pesticide concentrations were found at the downstream 117 station on the Géze River (Peyret, $43.327^{\circ}N$ 0.535 $^{\circ}E$) and 118 at the station on the Sousson River (Aujan, 43.380° N 119 $(0.505^{\circ}E)$ (Roubeix *et al.*, in press). 120

The diatom samples were mixed before equal inocula- 121 tion into six glass flasks ('artificial channels') filled with 122 40 litres of filtered river water (Whatman GF/B filters, 123 1 mm pore size) from the station with the highest 124 water quality (Organ). In each channel, clean glass slides 125 $(6 \times 10 \text{ cm})$ were hung from the surface to mid depth and 126 served as substrate for diatom colonization. An immerged 127 pump (NEW-JET 2300) maintained a surface current 128 between the glass slides, and daylight neon lamps placed 129 over each channel gave a homogeneous illumination of 130 150 μ mol.m⁻².s⁻¹ with a 14:10 light-dark cycle. The 131 surface turbulence created by the pumps ensured efficient 132 oxygenation of the growth medium, which remained O_2 133
saturated during the experiment. The filtered river water 134 saturated during the experiment. The filtered river water was slightly enriched with nutrients following the compo- 135 sition of WC culture medium (Guillard and Lorenzen, 136 1972), providing oligotrophic growth condition compar- 137 able to the study zone (Roubeix *et al.*, in press). 138

Racemic metolachlor (98%, Dr. Ehrenstorfer, 139 Germany) was dissolved in ultrapure water at $100 \text{ mg} L^{-1}$ 140 and an increasing volume of the solution was poured into 141 the channels; this gave two controls (no metolachlor), two 142 channels at 5 μ g.L⁻¹ and two others at 30 μ g.L⁻¹. In the 143 following, the six channels are called 0a, 0b, 5a, 5b, 30a and 144 30b, the number corresponding to metolachlor concentra- 145 tion and the letters 'a' or 'b' to the duplicate channels for 146 each concentration. 147

Phosphate concentration was checked every 2 days and 148 after each diatom sampling. Nutrient consumption by 149 algae was compensated by the addition of concentrated 150 WC medium in the proportion of the loss of PQ_4 . At the 151 same frequency 10 mL water samples were taken at the 152 same frequency, 10 mL water samples were taken at the surface of channels 5 and 30 for control of metolachlor con- 153 centrations along the time course of the experiment. These 154 samples were filtered with Spartan RC 30 syringe filters 155 $(0.45 \text{ µm}, \text{regenerated cellulose}, \text{Whatman})$ and stored in 156 glass bottles at 4° C until HPLC-ESI-MS/MS analysis. 157 Two additional samples were taken from the control 158 channels at the end of the experiment to check if there had 159 not been any contamination. After 1 week of growth, a few 160 millilitres of concentrated metolachlor solution was added 161 to channels 5 and 30 to maintain concentration levels. 162 Water temperature was measured daily at different hours of 163 the day and averaged out at 21 °C (\pm 2.4 s.p., n = 27). The 164 loss of water volume by evaporation or sampling was 165 compensated daily by addition of distilled water. 166

Biofilm samples were taken after 2 weeks of coloniza- 167 tion from two glass slides. Glass slides were scraped with a 168 cutter blade on both sides and the biofilm was resuspended 169 in 200 mL of commercial spring water. From this 170 suspension, 5 mL was kept in a 5% formaldehyde solution 171 for diatom community examination and the rest was fil- 172 tered on 2 Whatman GF/F filters for dry mass and 173 chlorophyll-a measurements. After 1 week and following 174 175 diatom sampling, 0.5 litre water samples were taken from 176 each channel for chemical analysis.

177 Monospecific tests

The species Surirella angusta and Achnanthidium 179 minutissimum were isolated by V. Roubeix from the Gèze 180 (from station Organ, see above) and the Ruiné Rivers 181 (from a little polluted site: $45.4907^{\circ}N$, $0.0172^{\circ}E$), respec- tively, in summer 2009. These two species were chosen because they are common in the studied area and because they showed contrasting responses to exposure to metola- chlor in the channel experiments (see results). Moreover, focusing on the species S. angusta allowed a more specific study of the relationship between metolachlor concentra- tion and frustule deformation. The two diatoms were maintained in the same water as used for the artificial channels, enriched with nutrients from WC culture medium (with silicate). This growth medium was used to dissolve the racemic metolachlor and to dilute the concen-193 trated solution (100 mg.L⁻¹) to yield five test concentra-194 tions ranging from 30 to 38 880 μ g.L⁻¹ on a logarithmic scale with a factor 3. These concentrations were chosen to encompass the highest concentration tested in the channel experiment and concentrations at which the effect of metolachlor on diatom growth is visible. Concentrations were checked at this step by HPLC analysis. For each species, 15 autoclaved 50 mL glass bottles were filled with 30 mL of the obtained metolachlor solutions in triplicate plus five control bottles with metolachlor-free growth medium. Then, 1 mL of preconditioned exponentially growing culture was added to the bottles, which were 205 placed on a rotative disk in a culture chamber at 23 \degree C with 206 a 130 μ mol.m⁻².s⁻¹ illumination and a 14:10 light–dark cycle. Diatom biomass in the bottles was estimated by in vivo fluorescence using a bbe Fluoroprobe equipped with a 25 mL cuvette holder. Before pouring the content of the bottles into the cuvette, the bottom of the bottles was gently scraped with a brush to ensure complete resuspension of the benthic algae. Initial biomass was measured in an additional bottle for each species (5 and 214 3 μ g.L⁻¹ for *S. angusta* and *A. minutissimum*, respec- tively). Diatom growth during the test was assessed by the 216 final biomass (in µg chl a.L⁻¹). Culture samples (5 mL) were conserved in lugol for organic matter digestion and enumeration of abnormal forms.  As it is often hypothesized that Si limitation may be a cause of diatom frustule deformation, a complementary test was performed to demonstrate that the appearance of abnormal forms in the channel experiment could not be 223 attributed to Si depletion. For this, the species S. angusta was grown in six further bottles. Three of them contained normal growth medium (controls as above) whereas the three others contained filtered river water enriched with all nutrients except silicate. The cultures were carried out in the same conditions as the toxicological tests but for an extended time of 10 days. At the end, diatom biomass in the cultures without Si addition was 40% less than in the 231 controls $(368 \pm 88 \text{ (s.n.)})$ vs. $627 \pm 4 \text{ µg}$ chl a.L⁻¹) and residual Si(OH)₄ concentrations were only 0.18 ± 0.05 232 (s D) mg SiO₂ I ⁻¹ which shows that Si limitation was (s.p.) mg $SiO₂ L⁻¹$, which shows that Si limitation was 233 clearly reached. 234

Chemical measurements 235

Basic parameters 236

Two parameters, ash-free dry mass (AFDM) and 237 chlorophyll-a, were used as biomass indicators. Biofilm 238 dry mass was determined according to the European 239 standard NF EN 872. AFDM was estimated from the 240 difference between dry mass and final mass after sample 241 combustion in a muffle furnace at $500\,^{\circ}\text{C}$ for 1 h. 242 Chlorophyll-a content of the biofilm as well as water pH, 243 conductivity and nutrient concentrations were measured 244 following French and international standards (NF 245 T90-117, NF T90-008, NF EN 27888, NF EN ISO 246 13395, NF EN ISO 11732, NF T90-023 and NF T 90-007). 247

Metolachlor determination 248

For determination of metolachlor concentration, water 249 samples were transferred into 1 mL vials. An HPLC 250 Ultimate 3000 (Dionex, CA, USA) and with a triple quad- 251 rupole mass spectrometer API 2000 (Applied Biosystems, 252 CA, USA) were used. The chromatographic separation 253 was done on a Gemini-NX C18 3 μ m, 110 Å, 100 \times 2 mm 254 equipped with a SecurityGuard from Phenomenex (CA, 255 USA). The two eluents were acetonitrile (A) and ultrapure 256 water with 5 mM ammonium acetate (B), and a linear 257 gradient was applied: an isocratic 10% mixture of A for 258 1 min, then 30% A till 4 min, 40% A till 8 min, 80% A till 259 9.5 min, 80% isocratic A till 10.5 min, a decrease of A 260 to 10% till 11 min and then the initial composition 261 was maintained for 4 min. The total running time was 262 thus 15 min and the flow rate was kept constant at 263 400 μ L.min⁻¹. Multiple reaction monitoring (MRM) 264 mode was used for the metolachlor with a quantitative 265 transition $(284 > 252)$ and a second transition for the 266 confirmation (270 > 176). Metolachlor-d6 (290 > 258) was 267 used as internal standard. 268

Diatom microscopic examination 269

Biofilm samples were boiled in H_2O_2 for 30 min 270 to oxidize the organic matter. Then the remaining cleaned 271 diatom frustules were transferred to a glass micro- 272 scope slide in a high-refractive medium (Naphrax \odot , 273 Brunel Microscopes Ltd, UK). Diatom species were 274 identified at $\times1000$ magnification from the taxonomic 275 literature of Central Europe (Krammer and Lange- 276 Bertalot, 1986–1991) and recent nomenclature updates. 277 The relative abundance of each species was calculated 278 from a minimum total count of 400 diatom valves. 279

The bulk proportion of abnormal forms of diatom frus- 280 tules was estimated separately from a total count of 1000 281 valves at \times 2000 magnification. Only clear morphological 282

 deformities of the frustule outline were taken into account (Falasco et al., 2009) excluding irregular striation. The proportion of deformed valves of S. angusta was specifi-286 cally estimated from a mean total count of 75 ± 39 (s.p.) valves for the artificial channel samples and among 1000 valves for the monospecific test. In the latter, total cell counts were also performed to establish the linear relation- ship between chlorophyll-a concentration and cell abun-291 dance of *S. angusta* (ug chl a = 3×10^{-6} cell + 3, $R^2 = 0.98$).

292 Statistical analysis

 All statistical analyses were computed using the R software (Ihaka and Gentleman, 1996). Non-parametric multivariate analysis of variance (NP MANOVA) was used to compare diatom communities among treatments (Anderson, 2001). The analysis was performed on Bray– Curtis distances between samples, calculated on log- transformed abundance data of species representing more than 1% of a community in at least one channel (33 species). Homogeneity of multivariate dispersions within treatments was checked using traditional analysis of variance on residuals after principal coordinate analysis (Anderson, 2006). Two factors were tested in the analysis: the concentration of metolachlor (main factor) and the channel (nested factor: two channels per concentration). Permutations were constrained according to the factor tested. For the nested factor test, permutations of the replicates were done across channels within each contam- ination level and, for the main factor, channels were permuted across contamination levels keeping pairs of replicates associated with each channel. Nine hundred and ninety-nine permutations of raw data were used for each test. A posteriori pairwise comparisons between

treatments were performed with the same permutational 315 test (NP MANOVA) but in a one-way design. 316

The significance of metolachlor effect on biological 317 parameters (chl a, AFDM, species abundances and ab- 318 normal forms) was tested using univariate non-parametric 319 Kruskall–Wallis and Wilcoxon tests. 320

The Hill model (Hill, 1910) was used to fit the data of 321 the monospecific tests by non-linear regression: 322

where Chla₀ and Chla_f are initial and final diatom 324 biomasses C_{max} is the concentration of the herbicide 325 biomasses, C_{tox} is the concentration of the herbicide, 325
FC_{so} is the 50% effect concentration and α and β are other 326 EC_{50} is the 50% effect concentration and α and β are other model parameters. The NOEC (no observed effect con- 327 centration) was determined by comparing each treatment 328 with control using the one-tailed Wilcoxon test. 329

Results 330

Chemical conditions 331

Throughout the experiment pH and conductivity 332 remained approximately constant (Table 1). Phosphate, 333 which is often the limiting nutrient for algal growth in 334 rivers, was well controlled. Its concentration was low 335 $(0.05 \text{ mg } P.L^{-1})$ and similar to natural concentrations in 336 oligotrophic rivers. Ammonium and nitrite had low con- 337 centrations and only slight opposite variations. Nitrate 338 increased from about 1 to almost 2 mg N.L^{-1}, whereas 339 silicic acid concentrations fell during the last week in a 340 comparable way in each channel. Overall, in spite of 341 variations of some nutrients over time, for one given time, 342 there was only little difference between treatments. 343

344 Metolachlor concentrations varied only moderately 345 and maintained values close to the nominal concentrations 346 fixed at 5 and 30 μ g.L⁻¹ (Fig. 1). Time-weighted average 347 concentrations were 5.7 ± 1.1 , 3.9 ± 0.9 , 30.9 ± 4.8 and 348 30.6 \pm 4.1 µg.L⁻¹ (\pm s.d.) for channels 5a, 5b, 30a and 349 30b, respectively. The herbicide was not detected in the 350 control channels.

351 Effect on biomass

 The growth of biofilm on the glass slides in the artificial channels was assessed through the two biomass indicators: AFDM and chl a. Final biomass did not differ significantly between treatments (Fig. 2) as regards both indicators, and thus no effect of metolachlor was apparent on periphyton biomass. Chl a density and AFDM reached on average 358 0.04 mg.cm^{-2} and 0.04 mg.dm^{-2}, respectively, at the end of the experiment.

360 The monospecific toxicological tests showed no ap-361 parent effect of metolachlor on diatom growth at con-362 centrations under 100 μ g.L⁻¹. EC₅₀ values were estimated 363 at 2962 and 1880 $\mu g.L^{-1}$ metolachlor for S. angusta 364 and A. minutissimum, respectively (Fig. 3). The NOEC 365 amounted to 180 μ g.L⁻¹ for both species.

366 Effect on community composition

 The dominant species of diatom communities sampled at the end of the channel experiment are presented in Table 2. The communities were characterized by the predominance of small species (Nitzschia pusilla, Eolimna minima, Planothidium frequentissimum, Mayamaea permi- tis and Navicula seminulum) and by the relative importance of the centric Melosira varians and some larger species from the genus Nitzschia (Nitzschia palea and Nitzschia gracilis) and Surirella (Surirella angusta and Surirella brebissonii).

377 The application of non-parametric multivariate 378 ANOVA revealed a significant effect of metolachlor on

diatom community composition $(p=0.016)$ and the 379 absence of a channel effect ($p=0.108$) (Table 3). Pairwise 380 comparisons between treatments indicated that most of 381 the difference lay between control channels and the con- 382 taminated ones (5 and 30 μ g.L⁻¹) that did not significantly 383 differ from each other (Table 2 and Fig. 4). 384

Individual variations in the relative abundance of 385 some species among treatments can suggest sensitivity 386 or tolerance. The species Achnanthidium minutissimum, 387 Mayamaea permitis, Nitzschia palea and to a lesser extent 388 N. pusilla had lower abundance at high contamination 389 levels (Fig. 5) and may be considered sensitive to 390 metolachlor. Other species increased in abundance with 391 metolachlor concentration and therefore appeared rather 392 tolerant, especially Planothidium frequentissimum, P. lan- 393 ceolatum, Surirella brebissonii, Amphora montana and 394 Nitzschia gracilis. 395

Abnormal forms 396

A higher proportion of abnormal forms of diatom frus- 397 tules was observed in the contaminated channels (Fig. 6). 398 In whole communities, it remained very low $(<6\%$ ₀, 399 Fig. 7). Nevertheless the increase with metolachlor concen- 400 tration was significant. Deformities were particularly 401

prominent in the sub-dominant species Surirella angusta 410 (Fig. 6). Their frequency in the populations of S. angusta 411 increased significantly with contamination to reach 80% at 412 increased significantly with contamination to reach 80‰ at 412
the end of the experiment at 30 μg . L^{-1} (Fig. 7). 413 the end of the experiment at 30 μ g. L⁻¹ (Fig. 7). 413

In the monospecific cultures of S. angusta, abnormal 414 valves were approximately 2-fold more abundant in the 415 presence of metolachlor but no dose effect was evidenced 416 after 4 days exposure. Si-limited cultures exhibited signifi- 417 cantly less abnormal forms than contaminated cultures 418 and did not differ from controls in this aspect $(Fig. 8)$. 419

Structural vs. quantitative endpoints 421

The channel experiment demonstrated an effect of 422 tolachlor from a concentration of 5 $\mu g.L^{-1}$ on the 423 metolachlor from a concentration of 5 μ g.L⁻¹ on the 423

 species composition of diatom assemblages after 2 weeks of substrate colonization. This effect was revealed by maintaining the contamination level and all other factors that influence diatom communities, namely light, trophic level and current velocity. Starting from realistic oligotro- phic conditions, the regular addition of nutrients allowed biofilm growth on the substrates but could not prevent transient Si limitation at the end of the experiment. Indeed as biomass accumulates exponentially, the consumption of nutrient increases accordingly and the frequency of nutrient supply should have been increased likewise. Nevertheless Si limitation occurred similarly in each channel only at the end of the experiment and may not have differentially influenced the effect of the herbicide on diatom community composition.

 These results obtained under controlled conditions confirm that the diatom community alterations observed in the field can be the consequence of chronic river con- tamination by herbicides (Morin et al., 2009; Roubeix 443 et al., in press). Here, the demonstration of the toxic effect of metolachlor on river diatom community composition at environmental contamination levels is clearly evidenced. The relatively low difference between communities formed 447 at 5 and 30 $\mu g.L^{-1}$ of metolachlor suggests that most of the difference from control already lay in the communities 449 at 5 μ g.L⁻¹ and that the effect of the toxicant might be visible at even lower concentrations.

451 However, descriptors related to periphyton biomass 452 (chl a and AFDM) did not indicate any effect of metol-453 achlor at the tested concentrations. Moreover, EC_{50} values from the monospecific tests and from other similar studies 454 with microalgae based on short-term growth inhibition 455 tests (Junghans et al., 2003; Vallotton et al., 2008; Liu and 456 Xiong, 2009) suggest much higher effect thresholds. 457 Indeed, no significant effect of metolachlor was visible on 458 the growth of *S. angusta* and A . *minutissimum* up to a con- 459 centration of 180 μ g.L⁻¹ (NOEC). As tolerant species 460 progressively replace sensitive ones in a community 461 exposed to a toxicant, the effect on the whole community 462 biomass may not be visible unless the tolerance limit of the 463 most robust and competitive species is reached. Therefore 464 community composition change is a more sensitive end- 465 point to evaluate the toxicity of a pollutant on a natural 466 aquatic environment and deviation from the reference con- 467 dition, as requested by the European Water Framework 468 Directive. 469

Species sensitive/tolerant to metolachlor 470

The changes in composition of diatom communities 471 with metolachlor concentrations are informative about 472 the possible bioindication of herbicide contamination. 473 In such microcosm experiments, the decrease in abun- 474 dance of a species along a contamination gradient may 475 result from species sensitivity to the tested toxicant or to a 476 change in biological interactions linked to water toxicity. 477 Achnanthidium minutissimum is a species indicative of 478 good water quality (Coste *et al.*, 2009), which was shown 479 good water quality (Coste *et al.*, 2009), which was shown (as in this study) to maintain its relative abundance at low 480

481 herbicide concentration and to be strongly reduced at 482 higher contamination levels (Hamilton et al., 1987; Pérès 483 et al., 1996). Therefore, it seems that A. minutissimum is 484 rather sensitive to herbicides. This is supported by the 485 lower EC_{50} obtained for this species than for S. angusta,

which appeared indifferent to metolachlor in the channel 486 experiment. The species Mayamaea permitis and Nitzschia 487 palea may bring interesting information for separating 488 toxic vs. trophic effects, as they exhibited the same 489 toxic vs. trophic effects, as they exhibited the same sensitivity pattern as A . minutissimum (Fig. 5); however, 490

 they are known to be generally more tolerant to organic and trophic pollution. The species Nitzschia pusilla had a lower relative abundance in the two treatments with metolachlor. However, it remained the dominant species in almost all communities sampled. It may be rather indifferent to metolachlor and the drop in relative abun- dance would result from the greater development of tol-erant species in contaminated channels.

 Species increasing their proportion in communities formed at higher metolachlor concentrations may be considered tolerant. This is the case of the saprophilous Surirella brebissonii as well as P. frequentissimum and P. lanceolatum, which have already been identified as tolerant to pollution by herbicides including metolachlor in a previous field approach (Roubeix et al., in press). A. montana, N. gracilis and especially N. capitellata are characteristic of low water quality (Coste et al., 2009) and showed tolerance to metolachlor in this study. For M. varians, however, general knowledge of its sensitivity to pollution (eutrophication and saproby) is not consistent with the findings of certain herbicide studies. Indeed M. varians is generally recorded in clean rivers but appears to accommodate well to high herbicide concentrations (Spawn et al., 1997; Debenest et al., 2009).

515 Relevance of abnormal forms as an indication of 516 toxicity

 This experimental study clearly establishes the link be- tween abnormal forms and the herbicide. The appearance of diatom deformities is often presumed to result from 520 Si limitation (Debenest et al., 2010). However, from this study, this hypothesis can be rejected for several reasons: (1) there was a clear dose effect in the channels and there was most Si left in one of the most contaminated channels (30b), (2) in the monospecific test, deformities were

significantly more abundant in the contaminated cultures, 525 and (3) Si limitation did not produce more abnormal 526 forms than control conditions. The duration of the experi- 527 ments (14 *vs.* 4 days) may be the cause of the difference in 528 proportion and in response to concentration between the 529 channel experiment and the monospecific test. It is likely 530 that the proportion of abnormal forms in a population 531 increases with time at a rate depending on the exposure 532 level. It could also be hypothesized that the progressive de- 533 gradation of metolachlor may produce metabolites having 534 higher teratogenic effects than metolachlor (Osano et al., 535 2002; Hladik *et al.*, 2005). 536

Like other herbicides belonging to the chloroacetani- 537 lide class, metolachlor inhibits the biosynthesis of very 538 long chain fatty acids in plants and microalgae (Boger 539) et al., 2000) and consequently blocks cell division and en- 540 largement. Such a mode of action does not *a priori* suggest 541 an effect on diatom frustule structure. However, changes 542 in ultrastructural morphology were reported in a green 543 microalgae following exposure to metolachlor (Liu and 544 Xiong, 2009). As the synthesis of the diatom frustule 545 involves a special intracellular vesicle (SDV) and requires 546 the exocytosis of biogenic silica (Martin-Jezequel et al., 547 2000), any alteration of the cell membrane system may 548 have repercussions on frustule construction. 549

The link between abnormal diatom forms and con- 550 tamination by heavy metals has been well documented 551 (Gold et al., 2003; Cattaneo et al., 2004; Morin et al., 2008; 552 Falasco et al., 2009). However, the literature on the effect 553 of herbicides on diatom morphology is scarce. There are 554 now experimental studies reporting diatom deformities 555 due to herbicides with three different physiological targets: 556 photosynthesis (isoproturon), gene expression (maleic 557 hydrazide) and lipid synthesis (metolachlor, this study) 558 (Schmitt-Jansen and Altenburger, 2005; Debenest et al., 559 2008). The variety of toxicants giving the same effect on 560 diatoms suggests that toxic stress generally generates ab- 561 normal forms. 562

The frequency of abnormal forms has already been 563 proposed as a bioindicator of heavy metal contamination 564 (Cattaneo *et al.*, 2004). Recent results concerning the 565 effects of herbicides suggest that abnormal forms might 566 also be used to indicate herbicide contamination in the 567 field. However, as the relative abundance of deformities 568 is generally just a few ‰ (Fig. 7) (Morin *et al.*, 2009), this 569 would require a higher counting effort than bioindication 570 on a taxonomic basis (AFNOR, 2004). The example of 571 S. *angusta* shows that it would be easier to focus on wide- 572 spread sensitive species that could be used as sentinels. 573

Conclusion 574

The experiments conducted in this study showed that 575 tolachlor has toxic effects on river periphytic diatoms. 576 metolachlor has toxic effects on river periphytic diatoms. 576 The results are interesting for the toxicological assess- 577 ment of pesticides as well as for the bioindication of con- 578 tamination. It emerges that effect concentrations may vary 579 according to the species and the endpoint (biomass, 580

 deformities and community composition) considered. Microalgal tests based on biomass can be easily related to ecosystem functions (primary production and trophic pathways). However, diatom community composition 585 seems to be more sensitive to contamination and should
586 be considered as a relevant endpoint. Also the channel be considered as a relevant endpoint. Also the channel experiment provided information about the tolerance of some diatom species to metolachlor. These data will con- tribute to the knowledge of diatom sensitivity to toxicants, which could lead to the construction of new diatom indices of water quality. Our experimental results support the inclusion of abnormal diatom forms in water quality indices because they may reflect toxic stress.
