# KaZhDan's Property $(T)$ With respect TO NON-COMMUTATIVE $L_{p}$-SPACES

#### Abstract

We show that a group with Kazhdan's property $(T)$ has property $\left(T_{B}\right)$ for $B$ the Haagerup non-commutative $L_{p}(\mathcal{M})$-space associated with a von Neumann algebra $\mathcal{M}, 1<p<\infty$. We deduce that higher rank groups have property $F_{L_{p}(\mathcal{M})}$.


Keywords: Haagerup non-commutative $L_{p}(\mathcal{M})$-spaces, property $(T)$, group representations, Mazur map, property $F_{L_{p}(\mathcal{M})}$.

## 1 Introduction

Kazhdan's property $(T)$ of a topological group $G$ is an important rigidity property, defined in terms of the unitary representations of $G$ on Hilbert spaces. We recall the precise definition :

Definition 1.1. A pair $(G, H)$ of topological groups, where $H$ is a closed subgroup of $G$, is said to have relative property $(T)$ if there exist a compact subset $Q$ of $G$ and $\epsilon>0$ such that : whenever a unitary representation $\pi$ of $G$ on a Hilbert space $\mathcal{H}$ has a ( $Q, \epsilon$ )-invariant vector, that is a vector $\xi \in \mathcal{H}$ such that

$$
\sup _{g \in Q}\|\pi(g) \xi-\xi\|<\epsilon\|\xi\|
$$

then $\pi$ has a non-zero $\pi(H)$-invariant vector. The pair $(Q, \epsilon)$ is called a Kazhdan pair.
A topological group $G$ is said to have property $(T)$ if the pair $(G, G)$ has relative property $(T)$.

For more details on property $(T)$, see the monography [2].
The following variant of this property for Banach spaces was recently introduced by Bader, Furman, Gelander and Monod in [1]. Let $B$ be a Banach space and
$O(B)$ the orthogonal group of $B$, that is, the group of linear bijective isometries of $B$. Recall that an orthogonal representation of a topological group $G$ on a Banach space $B$ is a homomorphism $\rho: G \rightarrow O(B)$ such that the map $g \mapsto \rho(g) x$ is continuous for every $x \in B$. If $\rho: G \rightarrow O(B)$ is an orthogonal representation of a group $G$, we denote the subspace of $\rho(G)$-invariant vectors by

$$
B^{\rho(G)}=\{x \in B \mid \rho(g) x=x \text { for all } g \in G\}
$$

Observe that $B^{\rho(G)}$ is invariant under $G$. The representation $\rho$ is said to almost have invariant vectors if it has $(Q, \epsilon)$-invariant vector for every compact subset $Q$ of $G$ and $\epsilon>0$.

Definition 1.2. Let $G$ be a topological group and $H$ be a closed normal subgroup of $G$. The pair $(G, H)$ has relative property $\left(T_{B}\right)$ for a Banach space $B$ if, for any orthogonal representation $\rho: G \rightarrow O(B)$, the quotient representation $\rho^{\prime}: G \rightarrow$ $O\left(B / B^{\rho(H)}\right)$ does not almost have $\rho^{\prime}(G)$-invariant vectors.
A topological group $G$ has property $\left(T_{B}\right)$ if the pair $(G, G)$ has relative property $\left(T_{B}\right)$.

The authors of [1] studied the case where $B$ is a superreflexive Banach space, and among other things, they showed that a group which has property $(T)$ has property $\left(T_{L^{p}(\mu)}\right)$ for $\mu$ a $\sigma$-finite measure on a standard Borel space $(X, \mathcal{B})$ and $1<p<\infty$. We will extend this result to the non- commutative setting.
Non-commutative $L_{p}$-spaces were introduced by Dixmier [3] and studied by various authors, among them Yeadon [13] and Haagerup [4] (for a survey on these spaces, see Pisier and Xu [6]). Apart from the standard $L^{p}(\mu)$-spaces, common examples are the $p$-Schatten ideals

$$
S_{p}=\left\{x \in \mathcal{B}(\mathcal{H}) \mid \operatorname{tr}\left(|x|^{p}\right)<\infty\right\}
$$

where $\mathcal{H}$ is a separable Hilbert space.
We review below (in Section 2) Haagerup's definition of these non-commutative $L_{p}$-spaces. Here is our main result :

Theorem 1.3. Let $G$ be a topological group and $H$ a closed normal subgroup of $G$. Assume that the pair $(G, H)$ has relative property $(T)$. For every von Neumann algebra $\mathcal{M}$, the pair $(G, H)$ has relative property $\left(T_{L_{p}(\mathcal{M})}\right)$ for $1<p<\infty$.

In particular, if $G$ has property $(T)$, then $G$ has property $\left(T_{L_{p}(\mathcal{M})}\right)$ for $1<p<\infty$. Property ( $T_{B}$ ) has a stronger version which is a fixed point property for affine actions.

Definition 1.4. Let $B$ a Banach space. A topological group $G$ has property $\left(F_{B}\right)$ if every continuous action of $G$ by affine isometries on $B$ has a $G$-fixed point.

The authors of [1] showed that higher rank groups and their lattices have property $\left(F_{L^{p}(\mu)}\right)$.

Definition 1.5. For $1 \leq i \leq m$, let $k_{i}$ be local fields and $\mathbb{G}_{i}\left(k_{i}\right)$ be the $k_{i}$-points of connected simple $k_{i}$-algebraic groups $\mathbb{G}_{i}$. Assume that each simple factor $\mathbb{G}_{i}$ has $k_{i}$-rank $\geq 2$. The group $G=\prod_{i=1}^{m} \mathbb{G}_{i}\left(k_{i}\right)$ is called a higher rank group.

Our next result shows that Theorem B in [1] remains true for non-commutative $L_{p}$-spaces.

Theorem 1.6. Let $G$ be a higher rank group and $\mathcal{M}$ a von Neumann algebra. Then $G$, as well as every lattice in $G$, has property $F_{L_{p}(\mathcal{M})}$ for $1<p<\infty$.

Theorem 1.6 was proved by Puschnigg in [7] in the case $L_{p}(\mathcal{M})=S_{p}$. The strategy of the proof of Theorem 1.3 (as in [7]) follows the one from [1]. To achieve the result, we will need some results on the Mazur map and the description of the surjective isometries of $L_{p}(\mathcal{M})$ given by Sherman in [9].
The paper is organized as follows. In Section 2, useful properties of the Mazur map are established. Group representations on $L_{p}(\mathcal{M})$ are studied in Section 3. The proof of Theorem 1.3 is given in Section 4. In Section 5, we show how Theorem 1.6 can be obtained from a variant of Theorem 1.3.

## 2 Some properties of the Mazur map

Let $\mathcal{M}$ be a von Neumann algebra, acting on a Hilbert space $\mathcal{H}$, and equipped with a normal semi-finite weight $\varphi_{0}$. Let $t \mapsto \sigma_{t}^{\varphi_{0}}$ be the one-parameter group of modular automorphisms of $\mathcal{M}$ with respect to $\varphi_{0}$. We denote by $\mathcal{N}_{\varphi_{0}}=\mathcal{M} \rtimes_{\varphi_{0}} \mathbb{R}$ the crossed product von Neumann algebra, which is a von Neumann algebra acting on $L^{2}(\mathbb{R}, \mathcal{H})$, and generated by the operators $\pi_{\varphi_{0}}(x), x \in \mathcal{M}$, and $\lambda_{s}$, $s \in \mathbb{R}$, defined by

$$
\begin{aligned}
& \pi_{\varphi_{0}}(x)(\xi)(t)=\sigma_{-t}^{\varphi_{0}}(x) \xi(t) \\
& \lambda_{s}(\xi)(t)=\xi(t-s) \quad \text { for any } \xi \in L^{2}(\mathbb{R}, \mathcal{H}) \text { and } t \in \mathbb{R}
\end{aligned}
$$

There is a dual action $s \mapsto \theta_{s}$ of $\mathbb{R}$ on $\mathcal{N}_{\varphi_{0}}$. Then let $\tau_{\varphi_{0}}$ be the semi-finite normal trace on $\mathcal{N}_{\varphi_{0}}$ satisfying

$$
\tau_{\varphi_{0}} \circ \theta_{s}=\mathrm{e}^{-s} \tau_{\varphi_{0}} \text { for all } s \in \mathbb{R} .
$$

We denote by $L_{0}\left(\mathcal{N}_{\varphi_{0}}, \tau_{\varphi_{0}}\right)$ the ${ }^{*}$-algebra of $\tau_{\varphi_{0}}$-measurable operators affiliated with $\mathcal{N}_{\varphi_{0}}$. For $1 \leq p \leq \infty$, the Haagerup non-commutative $L_{p}$-space associated with $\mathcal{M}$ is defined by

$$
L_{p}(\mathcal{M})=\left\{x \in L_{0}\left(\mathcal{N}_{\varphi_{0}}, \tau_{\varphi_{0}}\right) \mid \theta_{s}(x)=\mathrm{e}^{-s / p} x \text { for all } s \in \mathbb{R}\right\}
$$

It is known that this space is independant of the weight $\varphi_{0}$ up to isomorphism. The space $L_{1}(\mathcal{M})$ is isomorphic to $\mathcal{M}_{*}$. The identification goes as follows : there
exists a normal faithful semi-finite operator valued weight from $\mathcal{N}_{\varphi_{0}}$ to $\mathcal{M}$ defined by

$$
\Phi_{\varphi_{0}}(x)=\pi_{\varphi_{0}}^{-1}\left(\int_{\mathbb{R}} \theta_{s}(x) \mathrm{d} s\right), \text { for } x \in \mathcal{N}_{\varphi_{0}} .
$$

Now, if $\varphi \in \mathcal{M}_{*}^{+}$, and $\hat{\varphi}$ denotes the extension of $\varphi$ to a a normal weight on $\hat{\mathcal{M}}^{+}$, the extended positive part of $\mathcal{M}$, we then put

$$
\tilde{\varphi}^{\varphi_{0}}=\hat{\varphi} \circ \Phi_{\varphi_{0}} .
$$

We associate to $\varphi$ the Radon-Nikodym derivative $\frac{d \tilde{\varphi}_{0}}{d \tau_{\varphi_{0}}}$ of $\tilde{\varphi}^{\varphi_{0}}$ with respect to the trace $\tau_{\varphi_{0}}$. This isomorphism between $\mathcal{M}_{*}^{+}$and $L_{1}(\mathcal{M})^{+}$extends to the whole spaces by linearity.
If $x \in L_{1}(\mathcal{M})$, and $\varphi_{x}$ is the element of $\mathcal{M}_{*}^{+}$associated to $x$, we define a linear functional $\operatorname{Tr}$ by

$$
\operatorname{Tr}(x)=\varphi_{x}(1)
$$

and we have, $p^{\prime}$ being the conjugate exponent of $p$,

$$
\operatorname{Tr}(x y)=\operatorname{Tr}(y x) \text { for } x \in L_{p}(\mathcal{M}), y \in L_{p^{\prime}}(\mathcal{M})
$$

For $1 \leq p<\infty$, if $x=u|x|$ is the polar decomposition of $x \in L_{p}(\mathcal{M})$, we define

$$
\|x\|_{p}=\operatorname{Tr}\left(|x|^{p}\right)^{1 / p} .
$$

Equipped with $\|.\|_{p}, L_{p}(\mathcal{M})$ is a Banach space. For $1<p<\infty$, the dual space of $L_{p}(\mathcal{M})$ is $L_{p^{\prime}}(\mathcal{M})$ and $L_{p}(\mathcal{M}, \tau)$ is known to be superreflexive.

We now introduce the Mazur map and establish some of its properties.
Definition 2.1. Let $1 \leq p, q<\infty$. For an operator $a$, let $\alpha|a|$ be its polar decomposition. The map

$$
\begin{gathered}
M_{p, q}: L_{0}\left(\mathcal{N}_{\varphi_{0}}, \tau_{\varphi_{0}}\right) \rightarrow L_{0}\left(\mathcal{N}_{\varphi_{0}}, \tau_{\varphi_{0}}\right) \\
\quad x=\alpha|a| \mapsto \alpha|a|^{\frac{p}{q}}
\end{gathered}
$$

is called the Mazur map.
We will need the following lemma.
Lemma 2.2. Let $1 \leq p, q, r<\infty$. Then $M_{r, q} \circ M_{p, r}=M_{p, q}$.
Proof. Let $\alpha|x|$ be the polar decomposition of $x \in L_{0}\left(\mathcal{N}_{\varphi_{0}}, \tau_{\varphi_{0}}\right)$. Let $\beta>0$, and set $y=\alpha|x|^{\beta}$. We claim that the polar decomposition of $y$ is given by $\alpha$ and $|x|^{\beta}$. To show this, it suffices to prove that $\overline{\operatorname{Im}\left(|x|^{\beta}\right)}=\overline{\operatorname{Im}(|x|)}$.

By taking orthogonals, we have to show that $\operatorname{Ker}(|x|)=\operatorname{Ker}\left(|x|^{\beta}\right)$ for all $\beta>0$. Recall that the domain $D\left(|x|^{\beta}\right)$ of $|x|^{\beta}$ is

$$
D\left(|x|^{\beta}\right)=\left\{\xi \mid \int_{0}^{\infty} \lambda^{2 \beta} d \mu_{\xi}(\lambda)<\infty\right\} .
$$

If $\xi \in \operatorname{Ker}(|x|)$, we have for all $\eta \in L^{2}(\mathbb{R}, \mathcal{H})$

$$
<|x| \xi, \eta>=\int_{0}^{\infty} \lambda d \mu_{\xi, \eta}(\lambda)=0
$$

In particular, $\mu_{\xi}(] 0, \infty[)=0$. So $\xi \in D\left(|x|^{\beta}\right)$ and $\xi \in \operatorname{Ker}\left(|x|^{\beta}\right)$ thanks to

$$
<|x|^{\beta} \xi, \eta>=\int_{0}^{\infty} \lambda^{\beta} d \mu_{\xi, \eta}(\lambda)=0 .
$$

By exchanging the role of $|x|$ and $|x|^{\beta}$, we get the equality.
Let $1 \leq p, q, r<\infty$, and $\beta=p / r$; then $M_{p, r}(x)=\alpha|x|^{\beta}$. It follows from what we have just seen that $M_{r, q}\left(M_{p, r}(x)\right)=\alpha|x|^{\frac{p}{q}}=M_{p, q}(x)$.

Proposition 2.3. Let $1 \leq p, q<\infty$, and $a \in L_{p}(\mathcal{M})$. Then

$$
\left\|M_{p, q}(a)\right\|_{q}^{q}=\|a\|_{p}^{p}
$$

Proof. We denote again by $\alpha|a|$ the polar decomposition of $a$. We have already seen that $\left|M_{p, q}(a)\right|=|a|^{\frac{p}{q}}$. So we have

$$
\operatorname{Tr}\left(\left|M_{p, q}(a)\right|^{q}\right)=\operatorname{Tr}\left(|a|^{p}\right) .
$$

Proposition 2.4. Let $p, q \in] 1, \infty[$ be conjugate. The map

$$
\begin{aligned}
L_{p}(\mathcal{M}) & \rightarrow L_{q}(\mathcal{M}) \\
x & \mapsto M_{p, q}(x)^{*}
\end{aligned}
$$

is the duality map from $L_{p}(\mathcal{M})$ to $L_{q}(\mathcal{M})$.
Proof. We first notice that $M_{p, q}$ sends $L_{p}(\mathcal{M})$ into $L_{q}(\mathcal{M})$. Let $x=\alpha|x| \in L_{p}(\mathcal{M})$ and $s \in \mathbb{R}$. By uniqueness in the polar decomposition, we have $\theta_{s}(\alpha)=\alpha$ and $\theta_{s}(|x|)=\mathrm{e}^{-s / p}|x|$, and then

$$
\begin{aligned}
\theta_{s}\left(M_{p, q}(x)\right) & =\theta_{s}(\alpha) \theta_{s}\left(|x|^{\frac{p}{q}}\right) \\
& =\alpha\left(\theta_{s}(|x|)^{\frac{p}{q}}\right) \\
& =\mathrm{e}^{-s / q} M_{p, q}(x) .
\end{aligned}
$$

Thanks to the uniqueness of the duality map in superreflexive spaces, we just have to check that $\operatorname{Tr}\left(M_{p, q}(a)^{*} a\right)=1$ for $a$ in the unit sphere $S\left(L_{p}(\mathcal{M})\right)$ of $L_{p}(\mathcal{M})$. Let $a=\alpha|a| \in S\left(L_{p}(\mathcal{M})\right.$ ); then $M_{p, q}(a)=\alpha|a|^{\frac{p}{q}}$. Since $\alpha^{*} \alpha|a|=|a|$, it follows that

$$
\operatorname{Tr}\left(|a|^{\frac{p}{q}} \alpha^{*} \alpha|a|\right)=\operatorname{Tr}\left(|a|^{\frac{p}{q}}|a|\right)=\operatorname{Tr}\left(|a|^{p}\right)=1 .
$$

Proposition 2.5. If $a, b \in L_{0}\left(\mathcal{N}_{\varphi_{0}}, \tau_{\varphi_{0}}\right)$ and if $e, f$ are two central projections in $\mathcal{N}_{\varphi_{0}}$ such that ef $=0$, then $M_{p, q}(a e+b f)=M_{p, q}(a e)+M_{p, q}(b f)$.

Proof. As is easily checked, we have

$$
|a e+b f|=|a| e+|b| f .
$$

Let $\gamma$ be the partial isometry occuring in the polar decomposition of $a e+b f$, and let $a=\alpha|a|, b=\beta|b|$ be the polar decompositions of $a$ and $b$. We claim that $\gamma=\alpha e+\beta f$. Indeed, we have

$$
\begin{aligned}
& a e+b f=\gamma|a e+b f| \\
& \text { and } a e+b f=(\alpha e)(|a| e)+(\beta f)(|b| f)=(\alpha e+\beta f)|a e+b f| .
\end{aligned}
$$

Since $\alpha e$ is zero on $\operatorname{Ker}(|a| e)$ and $\beta f$ is zero on $\operatorname{Ker}(|b| f), \alpha e+\beta f$ is zero on $\operatorname{Im}(|a e+b f|)^{\perp}=\operatorname{Ker}(|a e+b y|)=\operatorname{Ker}(|a| e) \cap \operatorname{Ker}(|b| f)(e f=0)$.
Using again the fact that ef $=0$ and that $e, f$ are central elements, we deduce that

$$
\begin{aligned}
M_{p, q}(a e+b f) & =(\alpha e+\beta f)|a e+b f|^{\frac{p}{q}} \\
& =(\alpha e+\beta f)\left(e|a|^{\frac{p}{q}}+f|b|^{\frac{p}{q}}\right) \\
& =M_{p, q}(a e)+M_{p, q}(b f) .
\end{aligned}
$$

Proposition 2.6. Let $J$ be a Jordan-isomorphism of $\mathcal{N}_{\varphi_{0}}$, and let $1 \leq p, q<\infty$. Then we have

$$
J(x)=M_{p, q} \circ J \circ M_{q, p}(x) \text { for all } x \in \mathcal{N}_{\varphi_{0}} .
$$

Proof. By Lemma 3.2 in [10], we have a decomposition $J=J_{1}+J_{2}$ with the following properties : $J_{1}$ is a ${ }^{*}$-homomorphism, $J_{2}$ is a ${ }^{*}$-anti-homomorphism and $J_{1}(x)=J(x) e, J_{2}(x)=J(x) f$ for all $x \in \mathcal{M}$, with $e, f$ two orthogonal and central projections such that $e+f=I$.
Observe first that, for $a \in \mathcal{N}_{\varphi_{0}}$ with $a \geq 0$ and a positive real number $r$, we have

$$
J_{1}\left(a^{r}\right)=J_{1}(a)^{r}
$$

and the same is true for $J_{2}$.
If $\alpha$ is a partial isometry, then $J_{1}(\alpha)$ and $J_{2}(\alpha)$ are partial isometries with initial
supports $J_{1}\left(\alpha^{*} \alpha\right)$ and $J_{2}\left(\alpha \alpha^{*}\right)$, and final supports $\left.J_{1}\left(\alpha \alpha^{*}\right)\right)$ and $\left.J_{2}\left(\alpha^{*} \alpha\right)\right)$ respectively.
Let $x=\alpha|x| \in \mathcal{N}_{\varphi_{0}}$. Since the supports of $J_{1}$ and $J_{2}$ are orthogonal, it follows from Proposition 2.5 that

$$
\begin{aligned}
M_{p, q} \circ J \circ M_{q, p}(x) & =M_{p, q}\left(J_{1}\left(M_{q, p}(x)\right)+J_{q}\left(M_{q, p}(x)\right)\right) \\
& =M_{p, q}\left(J_{1}\left(M_{q, p}(x)\right)\right)+M_{p, q}\left(J_{2}\left(M_{q, p}(x)\right)\right) .
\end{aligned}
$$

Moreover, we have

$$
\begin{aligned}
M_{p, q}\left(J_{1}\left(M_{q, p}(x)\right)\right) & =M_{p, q}\left(J_{1}\left(\alpha|x|^{\frac{2}{p}}\right)\right) \\
& =M_{p, q}\left(J_{1}(\alpha) J_{1}(|x|)^{\frac{2}{p}}\right) \\
& =J_{1}(x)
\end{aligned}
$$

and

$$
\begin{aligned}
M_{p, q}\left(J_{2}\left(M_{q, p}(x)\right)\right) & =M_{p, q}\left(J_{2}\left(\alpha|x|^{\frac{2}{p}} \alpha^{*} \alpha\right)\right) \\
& =M_{p, q}\left(J_{2}(\alpha) J_{2}\left(\alpha|x|^{\frac{2}{p}} \alpha^{*}\right)\right) \\
& =M_{p, q}\left(J_{2}(\alpha) J_{2}\left(\left(\alpha|x| \alpha^{*}\right)^{\frac{2}{p}}\right)\right) \\
& =M_{p, q}\left(J_{2}(\alpha) J_{2}\left(\alpha|x| \alpha^{*}\right)^{\frac{2}{p}}\right) \\
& =J_{2}(x) .
\end{aligned}
$$

An essential tool for the proof of Theorem 1.3 is the following result about the local uniform continuity of $M_{p, q}$, which is proved in Lemma 3.2 of [8] (for an independant proof in the case $L_{p}(\mathcal{M}, \tau)=S_{p}$, see [7]).

Proposition 2.7. [8] For $1 \leq p, q<\infty$, the Mazur map $M_{p, q}$ is uniformly continuous on the unit sphere $S\left(L_{p}(\mathcal{M})\right)$.

## 3 Group Representations on $L_{p}(\mathcal{M})$

Sherman's description of the surjective isometries of $L_{p}(\mathcal{M})$ in [9] is a crucial tool in the following result (non surjective isometries in the semi-finite case, and 2isometries in the general case are described in [14] and [5] respectively). This will allow us to transfer a representation of a group $G$ on $L_{p}(\mathcal{M})$ to a representation of $G$ on $L_{2}(\mathcal{M})$.

Proposition 3.1. For $p>2$, and $U \in O\left(L_{p}(\mathcal{M})\right)$, the map $V=M_{p, 2} \circ U \circ M_{2, p}$ belongs to $O\left(L_{2}(\mathcal{M})\right)$.

Proof. The fact that $\|V(x)\|_{2}=\|x\|_{2}$ for all $x \in L_{2}(\mathcal{M})$ follows from Proposition 2.3, and $V$ is bijective by Lemma 2.2. We have to prove that $V$ is linear on $L_{2}(\mathcal{M})$. By Theorem 1.2 in [9], there exist a Jordan-isomorphism $J$ of $\mathcal{M}$ and a unitary $w \in \mathcal{M}$ such that

$$
U\left(\varphi^{1 / p}\right)=w\left(\varphi \circ J^{-1}\right)^{1 / p} \text { for all } \varphi \in \mathcal{M}_{*}^{+} .
$$

It was shown in [12] that $J$ extends to a Jordan- ${ }^{*}$-isomorphism $\widetilde{J}$ between $L_{0}\left(\mathcal{N}_{\varphi_{0}}, \tau_{\varphi_{0}}\right)$ and $L_{0}\left(\mathcal{N}_{\varphi_{0} \mathrm{O}^{-1}}, \tau_{\varphi_{0} \mathrm{O}^{-1}}\right)$; moreover, $\widetilde{J}$ is an extension of an isomorphism between $\mathcal{N}_{\varphi_{0}}$ and $\mathcal{N}_{\varphi_{00 J^{-1}}}$ as well as a homeomorphism for the measure topology on $L_{0}\left(\mathcal{N}_{\varphi_{0}}, \tau_{\varphi_{0}}\right)$ and $L_{0}\left(\mathcal{N}_{\varphi_{0} \mathrm{~J}^{-1}}, \tau_{\varphi_{0} \mathrm{~J}^{-1}}\right)$. The isomorphism $\widetilde{J}$ satisfies the relations

$$
\begin{aligned}
& \tau_{\varphi_{0}} \circ \widetilde{J}^{-1}=\tau_{\varphi_{0} \circ J^{-1}} \\
& J^{-1} \circ \Phi_{\varphi_{0} \circ J^{-1}}=\Phi_{\varphi_{0}} \circ \widetilde{J}^{-1}
\end{aligned}
$$

Lemma 3.2. For $\varphi \in \mathcal{M}_{*}^{+}$, we have

$$
\frac{d \tilde{\varphi}_{\varphi_{0}}}{d \tau_{\varphi_{0}}}=\widetilde{J}^{-1}\left(\frac{d \varphi \circ \tilde{J}^{-1^{\varphi_{0} \circ J^{-1}}}}{d \tau_{\varphi_{0} \circ J^{-1}}}\right) .
$$

Proof. For all $\varphi \in \mathcal{M}_{*}^{+}$, we have

$$
\begin{aligned}
\tau_{\varphi_{0}}\left(\frac{d \tilde{\varphi}^{\varphi_{0}}}{d \tau_{\varphi_{0}}} \cdot\right) & =\varphi \circ \Phi_{\varphi_{0}} \\
& =\varphi \circ J^{-1} \circ \Phi_{\varphi_{0} \circ J^{-1} \circ} \circ \widetilde{J} \\
& =\tau_{\varphi_{0} \circ J^{-1}}\left(\frac{d \varphi \circ \tilde{J^{-1}}{ }^{\varphi_{0} \circ J^{-1}}}{d \tau_{\varphi_{00} J^{-1}}} \widetilde{J}(.)\right) \\
& =\tau_{\varphi_{0}} \circ \widetilde{J}^{-1}\left(\frac{d \varphi \circ \tilde{J^{-1} \varphi_{0} \circ J^{-1}}}{d \tau_{\varphi_{0} \circ J^{-1}}} \widetilde{J}(.)\right) \\
& =\tau_{\varphi_{0}}\left(\widetilde{J}^{-1}\left(\frac{d \varphi \circ \tilde{J}^{-1} \varphi_{0} J^{-1}}{d \tau_{\varphi_{0} \circ J^{-1}}}\right) .\right),
\end{aligned}
$$

where in the last equality we used the fact that $\widetilde{J}$ is Jordan homomorphism.
In Lemma 2.1 in [11], it is shown that there exists a topological $*$-isomorphism $\widetilde{\mathcal{K}}$ between $L_{0}\left(\mathcal{N}_{\varphi_{0}}, \tau_{\varphi_{0}}\right)$ and $L_{0}\left(\mathcal{N}_{\varphi_{0} J^{-1}}, \tau_{\varphi_{0} J^{-1}}\right)$ which satisfies the following relation on the Radon-Nikodym derivatives:

$$
\widetilde{\mathcal{K}}\left(\frac{d \tilde{\varphi}^{\varphi_{0}}}{d \tau_{\varphi_{0}}}\right)=\frac{d \tilde{\varphi}_{\varphi_{0} 0^{-1}}}{d \tau_{\varphi_{0} 0 J^{-1}}} \text { for all } \varphi \in \mathcal{M}_{*}^{+} .
$$

From Lemma 3.2, we obtain

$$
\frac{d \varphi \circ \tilde{J}^{-1} \varphi^{\varphi_{0}}}{d \tau_{\varphi_{0}}}=\widetilde{\mathcal{K}}^{-1} \circ \widetilde{J}\left(\frac{d \tilde{\varphi}^{\varphi_{0}}}{d \tau_{\varphi_{0}}}\right) \text { for all } \varphi \in \mathcal{M}_{*}^{+} .
$$

As a consequence, the linear and bijective isometry $U$ of $L_{p}(\mathcal{M})$ is given by the following relation on positive elements :

$$
U(x)=w\left(\widetilde{\mathcal{K}}^{-1} \circ \widetilde{J}(x)\right) \text { for all } x \in L_{p}(\mathcal{M})^{+}
$$

This relation extends by linearity to the whole $L_{p}(\mathcal{M})$.
Now notice that $\widetilde{\mathcal{K}}^{-1} \circ \widetilde{J}$ is a Jordan-isomorphism on $\mathcal{N}_{\varphi_{0}}$ and a topological isomorphism (for the measure topology) on $L_{0}\left(\mathcal{N}_{\varphi_{0}}, \tau_{\varphi_{0}}\right)$. By Proposition 2.6, for $x \in \mathcal{N}_{\varphi_{0}}$, we have

$$
\begin{aligned}
V(x) & =M_{p, 2} \circ U \circ M_{2, p}(x) \\
& =w\left(M_{p, 2} \circ \widetilde{\mathcal{K}}^{-1} \circ \widetilde{J} \circ M_{2, p}(x)\right) \\
& =w\left(\widetilde{\mathcal{K}}^{-1} \circ \widetilde{J}(x)\right) .
\end{aligned}
$$

Recall from [8] that the Mazur map is continuous for the measure topology on $L_{0}\left(\mathcal{N}_{\varphi_{0}}, \tau_{\varphi_{0}}\right)$. So by density of $\mathcal{N}_{\varphi_{0}}$ in $L_{0}\left(\mathcal{N}_{\varphi_{0}}, \tau_{\varphi_{0}}\right)$ for the measure topology, we have

$$
V(x)=w\left(\widetilde{\mathcal{K}}^{-1} \circ \widetilde{J}(x)\right) \text { for all } x \in L_{2}(\mathcal{M})
$$

which gives the linearity of $V$ on $L_{2}(\mathcal{M})$.
Remark 3.3. The proof of the linearity of the map $V$ in Proposition 3.1 is simpler in the case where $\mathcal{M}$ is a von Neumann algebra equipped with a faithful semi-finite normal trace $\tau$. Indeed, by Theorem 2 in [14], there exist a Jordanisomorphism $J$, a positive operator $B$ commuting with $J(\mathcal{M})$, and a partial isometry $W$ in $\mathcal{M}$ with the property that $W^{*} W$ is the support of $B$, such that

$$
U(x)=W B J(x) \text { for all } x \in \mathcal{M} \cap L_{p}(\mathcal{M}, \tau)
$$

Using the fact that $B$ commutes with $J(\mathcal{M})$, and as in the proof of Proposition 2.6 , for all $x=\alpha|x| \in \mathcal{M} \cap L_{p}(\mathcal{M}, \tau)$, we have

$$
\begin{aligned}
V(x) & =W M_{p, 2}\left(B J_{1}\left(\alpha|x|^{\frac{p}{2}}\right)+B J_{2}\left(\alpha|x|^{\frac{p}{2}}\right)\right) \\
& =W M_{p, 2}\left(B J_{1}\left(\alpha|x|^{\frac{p}{2}}\right)\right)+W M_{p, 2}\left(B J_{2}\left(\alpha|x|^{\frac{p}{2}}\right)\right) \\
& =W J_{1}(\alpha) B^{\frac{p}{2}} J_{1}(|x|)+W J_{2}(\alpha) B^{\frac{p}{2}} J_{2}\left(\alpha|x| \alpha^{*}\right) \\
& =W B^{\frac{p}{2}} J(x) .
\end{aligned}
$$

The linearity on the whole $L_{p}(\mathcal{M}, \tau)$ follows from the density of $\mathcal{M} \cap L_{p}(\mathcal{M}, \tau)$ in $L_{p}(\mathcal{M}, \tau)$.

Corollary 3.4. Let $G$ be a topological group, $p \geq 2$, and $U: G \rightarrow O\left(L_{p}(\mathcal{M})\right)$ be a representation on $L_{p}(\mathcal{M})$. For $g \in G$, define $V(g): L_{2}(\mathcal{M}) \rightarrow L_{2}(\mathcal{M})$ by

$$
V(g)=M_{p, 2} \circ U(g) \circ M_{2, p} .
$$

Then $V$ is a representation of $G$ on $L_{2}(\mathcal{M})$.
Proof. By the previous proposition, $V(g) \in O\left(L_{2}(\mathcal{M})\right)$ for every $g$ in $G$. Moreover, the map $g \mapsto V(g) x$ is continuous, since $g \mapsto U(g) M_{2, p}(x)$ is continuous and since $M_{p, 2}: L_{p}(\mathcal{M}) \rightarrow L_{2}(\mathcal{M})$ is continuous.
It remains to check that $V$ is a homomorphism. For this, let $g_{1}, g_{2} \in G$. Then, by Lemma 2.2,

$$
\begin{aligned}
V\left(g_{1}\right) V\left(g_{2}\right) & =M_{p, 2} \circ U\left(g_{1}\right) \circ M_{2, p} \circ M_{p, 2} \circ U\left(g_{2}\right) \circ M_{2, p} \\
& =M_{p, 2} \circ U\left(g_{1}\right) \circ U\left(g_{2}\right) \circ M_{2, p} \\
& =M_{p, 2} \circ U\left(g_{1} g_{2}\right) \circ M_{2, p} \\
& =V\left(g_{1} g_{2}\right) .
\end{aligned}
$$

Let $U$ be a representation of a topological group $G$ on $L_{p}(\mathcal{M})$ and let

$$
L_{p}(\mathcal{M})^{U(G)}=\left\{x \in L_{p}(\mathcal{M}) \mid U(g) x=x \text { for all } g \in G\right\}
$$

be the space of $U(G)$-invariant vectors in $L_{p}(\mathcal{M})$. Let $p^{\prime}$ be the conjugate of $p$ and $U^{*}$ the contragredient representation of $U$ on the dual space $L_{p^{\prime}}(\mathcal{M})$ of $L_{p}(\mathcal{M})$. Since $L_{p}(\mathcal{M})$ is superreflexive, there exists a complement $L_{p}(\mathcal{M})^{\prime}$ for $L_{p}(\mathcal{M})^{U(G)}$ (see Proposition 2.6 in [1]) and we have

$$
L_{p}(\mathcal{M})^{\prime}=\left\{v \in L_{p}(\mathcal{M}) \mid \operatorname{Tr}(v c)=0 \text { for all } c \in L_{p^{\prime}}(\mathcal{M})^{U^{*}(G)}\right\} .
$$

Proposition 3.5. Let $v \in S\left(L_{p}(\mathcal{M})^{\prime}\right)$, then

$$
d\left(v, L_{p}(\mathcal{M})^{U(G)}\right) \geq \frac{1}{2} .
$$

Proof. Assume, by contradiction, that there exists $b \in L_{p}(\mathcal{M})^{U(G)}$ such that

$$
\|v-b\|_{p}<\frac{1}{2} .
$$

Then $\frac{1}{2} \leq\|b\|_{p} \leq \frac{3}{2}$. Setting $c=\frac{b}{\|b\|_{p}}$, we have $\|b-c\|_{p} \leq \frac{1}{2}$.
Since $c \in L_{p}(\mathcal{M})^{U(G)}$, it is easily checked that $M_{p, p^{\prime}}(c)^{*} \in L_{p^{\prime}}(\mathcal{M})^{U^{*}(G)}$; hence

$$
\operatorname{Tr}\left((c-v) M_{p, p^{\prime}}(c)^{*}\right)=\operatorname{Tr}\left(c M_{p, p^{\prime}}(c)^{*}\right)=\|c\|_{p}^{p}=1
$$

On the other hand, using Hölder's inequality, we have

$$
\begin{aligned}
1 & =\operatorname{Tr}\left((c-v) M_{p, p^{\prime}}(c)^{*}\right) \\
& \leq\|c-v\|_{p}\left\|M_{p, p^{\prime}}(c)^{*}\right\| \|_{p^{\prime}} \\
& =\|c-v\|_{p}\|c\|_{p}^{\frac{p_{p}^{\prime}}{p}} \\
& =\|c-v\|_{p} .
\end{aligned}
$$

This implies that

$$
\begin{aligned}
\|v-b\|_{p} & \geq\|v-c\|_{p}-\|c-b\|_{p} \\
& \geq \frac{1}{2}
\end{aligned}
$$

and this is a contradiction.

## 4 Proof of Theorem 1.3

We follow the strategy of the proof of Theorem A in [1]. Let $p \in] 1, \infty[$. and let $U$ be a representation on $L_{p}(\mathcal{M})$ of a group $G$. Let $H$ be a closed subgroup of $G$ such that the pair $(G, H)$ has property $(T)$. We claim that the representation $U^{\prime}$ of $G$ on the complement $L_{p}(\mathcal{M})^{\prime}$ of $L_{p}(\mathcal{M})^{U(H)}$ has no almost $U^{\prime}(G)$-invariant vectors. This will prove Theorem 1.3.
Let $Q$ be a compact subset in $G$, and take $\epsilon>0$. Assume by contradiction that there exists almost $U(G)$-invariant vectors in $L_{p}(\mathcal{M})^{\prime}$. Then, we can find, for every $n$, a unit vector $v_{n}$ such that

$$
\sup _{g \in Q}\left\|U(g) v_{n}-v_{n}\right\|_{p}<\frac{1}{n} .
$$

By Corollary 3.4, $V=M_{p, 2} \circ U \circ M_{2, p}$ defines a representation of $G$ on $L_{2}(\mathcal{M})$. Let $w_{n}$ be the orthogonal projection of $M_{p, 2}\left(v_{n}\right)$ on the orthogonal complement $L_{2}(\mathcal{M})^{\prime}$ of $L_{2}(\mathcal{M})^{V(H)}$. We claim that $w_{n}$ is $(Q, \epsilon)$-invariant for $V$ for $n$ sufficiently large. This will contradict property $(T)$ for the pair $(G, H)$.

We first show that there exists $\delta^{\prime}>0$ such that

$$
d\left(M_{p, 2}\left(v_{n}\right), L_{2}(\mathcal{M})^{V(H)}\right) \geq \delta^{\prime} \text { for all } n
$$

Indeed, otherwise for some $n$, there exists $a_{k} \in L_{2}(\mathcal{M})^{V(H)}$ such that

$$
\left\|M_{p, 2}\left(v_{n}\right)-a_{k}\right\|_{2} \underset{k \rightarrow \infty}{ } 0
$$

By Proposition 2.3, we have

$$
\left\|M_{p, 2}\left(v_{n}\right)\right\|_{2}=\left\|v_{n}\right\|_{p}^{\frac{p}{2}}=1
$$

Since $\left\|a_{k}\right\|_{2} \underset{k \rightarrow \infty}{ }\left\|M_{p, 2}\left(v_{n}\right)\right\|_{2}=1$, we can assume that $\left\|a_{k}\right\|_{2}=1$. Notice that

$$
M_{2, p}\left(L_{2}(\mathcal{M})^{V(H)}\right)=L_{p}(\mathcal{M})^{U(H)}
$$

Hence, $M_{2, p}\left(a_{k}\right)$ belongs to $L_{p}(\mathcal{M})^{U(H)}$ for every $k$. Moreover

$$
\left\|v_{n}-M_{2, p}\left(a_{k}\right)\right\|_{p} \underset{k \rightarrow \infty}{\longrightarrow} 0
$$

by the uniform continuity of $M_{2, p}$ on the unit sphere (see Proposition 2.4). This is a contradiction to Proposition 3.5.
In particular, we have

$$
\left\|w_{n}\right\|_{2}=d\left(M_{p, 2}\left(v_{n}\right), L_{2}(\mathcal{M})^{V(H)}\right) \geq \delta^{\prime}
$$

For $g \in Q$, we have

$$
\begin{aligned}
\left\|V(g) w_{n}-w_{n}\right\|_{2} & \leq\left\|V(g) M_{p, 2}\left(v_{n}\right)-M_{p, 2}\left(v_{n}\right)\right\|_{2} \\
& =\left\|M_{p, 2}\left(U(g) v_{n}\right)-M_{p, 2}\left(v_{n}\right)\right\|_{2} .
\end{aligned}
$$

Recall that $\left\|v_{n}\right\|_{p}^{\frac{p}{2}}=1$ and that

$$
\sup _{g \in Q}\left\|U(g) v_{n}-v_{n}\right\|_{p}<\frac{1}{n} .
$$

Hence, by the uniform continuity of $M_{p, 2}$ on $S\left(L_{2}(\mathcal{M})\right)$, there exists an integer $N$ (depending only on $(Q, \epsilon)$ ) such that

$$
\sup _{g \in Q}\left\|V(g) w_{n}-w_{n}\right\|_{2}<\epsilon \delta^{\prime} \text { for } n \geq N
$$

Since $\left\|w_{n}\right\|_{2} \geq \delta^{\prime}$, it follows that

$$
\sup _{g \in Q}\left\|V(g) w_{n}-w_{n}\right\|_{2}<\epsilon\left\|w_{n}\right\|_{2} \text { for } n \geq N
$$

This shows that $w_{n}$ is $(Q, \epsilon)$-invariant for $U$ when $n \geq N$. This finishes the proof of Theorem 1.3.

## 5 Property $\left(F_{L_{p}(\mathcal{M})}\right)$ FOR HIGHER RANK GROUPS

Let $H$ be a closed normal subgroup of $G$ and let $L$ be a closed group of $G$. Assume that $G=L \ltimes H$. The following strong relative property $\left(T_{B}\right)$ was considered in [1] :

Definition 5.1. A pair $(L \ltimes H, H)$ has property $\left(T_{B}\right)$ if, for any orthogonal representation $\rho: L \ltimes H \rightarrow O(B)$, the quotient representation $\rho^{\prime}: L \rightarrow O\left(B / B^{\rho(H)}\right)$ does not almost have $\rho^{\prime}(L)$-invariant vectors.

A straightforward modification of our proof of Theorem 1.3 shows that we also have the following result :
Theorem 5.2. Let $(L \ltimes H, H)$ be a pair with strong relative property $(T)$. Then $(L \ltimes H, H)$ has strong relative property $\left(T_{L_{p}(\mathcal{M})}\right)$ for $1<p<\infty$.

Let $G$ be a higher rank group as defined in the introduction. Using an analogue of Howe-Moore's theorem on vanishing of matrix coefficients, the authors of [1] showed that $G$ has property $\left(F_{B}\right)$ whenever $B$ is a superreflexive Banach space and a certain pair $(L \ltimes H, H)$ of subgroups, which has property $(T)$, has also $\left(T_{B}\right)$. The property $\left(F_{L_{p}(\mathcal{M})}\right)$ for higher rank groups in Theorem 1.6 is then a consequence of Theorem 5.2. Moreover, the result for lattices in higher rank groups is obtained by an induction process exactly as in the Proposition 8.8 of [1].
