A NONLINEAR PARTIAL INTEGRO-DIFFERENTIAL EQUATION FROM MATHEMATICAL FINANCE

ABSTRACT. Consistently fitting vanilla option surfaces is an important issue when it comes to modeling in finance. As far as local and stochastic volatility models are concerned, this problem boils down to the resolution of a nonlinear integro-differential pde. The non-locality of this equation stems from the quotient of two integral terms and is not defined for all bounded continuous functions. In this paper, we use a fixed point argument and suitable a priori estimates to prove short-time existence of solutions for this equation.

1. Introduction. Financial modelling has been an area of extremely rapid growth in the past 30 years, and some extremely interesting mathematical challenges have emerged. One of the utmost importance for real-life applications to derivatives trading is that of calibration. Similar to common situations in many areas of physics and engineering, once a model has been suggested, its parameters have to be estimated using external data. In the case of derivative modelling, those data are the liquid (tradable) options, generally known as the vanilla products. It is well known since the pioneering work of Litzenberger and Breeden [4] and its celebrated extension by Bruno Dupire [5] that the knowledge of market data such as the prices of vanilla options across all strikes and maturities is equivalent to the knowledge of the riskneutral marginals of the underlying stock distribution, and moreover, that there is a unique one-dimensional driftless diffusion which recovers exactly such marginals. However, it has also been well-known for almost as many years that the evolution in time of the so-called local volatility is not stable, thereby leading researchers and financial engineers to look for a more robust, stochastic volatility type of modelling. In this paper, we consider the calibration problem for a generic stochastic volatility model: more precisely, we address the issue of calibrating to market data a generic model with a stochastic component and a local component for the volatility process. Such models are very useful in practice, since they offer both the flexibility and realistic dynamics of stochastic volatility models, and the exact calibration properties

of local volatility models. In mathematical terms, the problem we consider is a non linear partial integro-differential equation for which we are able to prove short-time existence of classical solutions under suitable assumptions. The paper is organized as follows: Section 2 is devoted to the mathematical formulation of the problem. Section 3, to notations and statement of the main result. In Section 4, we recall some important technical results stemming from the general theory of parabolic pdes. Section 5 contains the proof of the main result. Finally, Section 6 is a short conclusion.

2. Local and Stochastic Volatility model.

2.1. **Diffusion equations.** The LSV model is an extension of Dupire's local volatility model. In the simplest situation - the two-dimensional case - the dynamics of the model are given by the following system of SDEs

$$dY_t = \alpha(t, Y_t)dB_t^2 + \xi(t)dt$$

Here, $(S_t, t \ge 0)$ is the stock price process and $(Y_t, t \ge 0)$ the stochastic component of the volatility. The function b simply transforms that factor into a proper volatility. a is the local volatility part of the model, choosing its value properly will enable us to calibrate the vanillas of the model. α is the volatility of the volatility factor and μ and ξ are drift terms that may depend on the state variables and on time. B^1 and B^2 are standard brownian motions with correlation ρ .

2.2. **The LSV model calibration.** In order to fit the vanillas of this model, we write the Kolmogorov forward equation on the joint density p(t, S, y) of the couple (S_t, Y_t)

with (S_0, y_0) the initial conditions. Taking $q = \int p dy$ the marginal of S, we get the equation

$$\frac{\partial q}{\partial t} - \frac{\partial^2}{\partial S^2} (\frac{1}{2} a^2 S^2 (\int b^2 p dy)) + \frac{\partial}{\partial S} (rSq) + rq = 0$$

Using Dupire's results from [5], we know that q has to solve the following equation in order to fit perfectly the vanillas of the market

$$\frac{\partial q}{\partial t} - \frac{\partial^2}{\partial S^2} (\frac{1}{2} \sigma_D^2 S^2 q) + \frac{\partial}{\partial S} (rSq) + rq = 0$$

where σ_D is Dupire's local volatility and contains the information about the vanillas we want to reproduce. We identify the terms in this last formula. This gives us the value of $a^2(t,S) = \sigma_D^2(t,S) \frac{q}{\int b^2 p dy} = \sigma_D^2(t,S) \frac{\int p dy}{\int b^2 p dy}$. Eventually, the joint

density that calibrates the smile of our model is solution of the nonlinear partial integro-differential equation

$$\begin{split} \frac{\partial p}{\partial t} - \frac{\partial^2}{\partial S^2} (\frac{1}{2} \sigma_D^2 b^2 S^2 \frac{\int p dy}{\int b^2 p dy} p) - \frac{\partial^2}{\partial S \partial y} (\rho \sigma_D b \alpha S (\frac{\int p dy}{\int b^2 p dy})^{\frac{1}{2}} p) - \frac{\partial^2}{\partial y^2} (\frac{1}{2} \alpha^2 p)) \\ + \frac{\partial}{\partial S} (r S p) + \frac{\partial}{\partial y} (\xi p) + r p &= 0 \end{split}$$

The rest of this paper is devoted to the study of a more general n-dimensional version of this equation.

3. Generalized equation and notations. Throughout this article, we denote by $0 < t \le T$ the time-variable and by $x = (x_1, x_2, ..., x_n) \in \Omega \subset \mathbb{R}^n$ the n-dimensional space variable where Ω is an open subset with a sufficiently smooth boundary (we will precise this notion later). When we consider the equation from a financial point of view, the first-variable x_1 stands for the spot and the last n-1 for the volatility. Hence, we write $S = x_1, y = (x_2, ..., x_n)$. We also denote by $D^T =]0, T[\times \Omega$ the domain of definition and by $B = \{0\} \times \Omega, B^T = \{T\} \times \Omega$ and $C^T =]0, T[\times \partial \Omega$ the different parts of the boundary. Given the particular part played by the spot, we consider $\Omega_S = \{S \in \mathbb{R}/\exists y \in \mathbb{R}^{n-1}, (S, y) \in \Omega\}$ and $\forall S \in \Omega_S, \Omega_y^S = \{y \in \mathbb{R}^{n-1}/(S, y) \in \Omega\}$. We are interested in the following equation:

$$O(p) := \frac{\partial p}{\partial t} - \frac{\partial^2}{\partial S^2} (\rho_{11} \alpha_1^2 I(p) p) - \sum_{i=2}^n \frac{\partial^2}{\partial S \partial x_i} (\rho_{1i} \alpha_1 \alpha_i \sqrt{I(p)} p)$$

$$- \sum_{i,i=2}^n \frac{\partial^2}{\partial x_i \partial x_j} (\rho_{ij} \alpha_i \alpha_j p) + \sum_{i=1}^n \frac{\partial}{\partial x_i} (\beta_i p) + \gamma p = 0 \quad \text{on } D^T \cup B^T$$

where $(\rho_{ij})_{1 \leq i,j \leq n}$ is a correlation matrix ie is symetric positive definite and verifies: $\rho_{ii} = \frac{1}{2}$ for all i and $-\frac{1}{2} < \rho_{ij} < \frac{1}{2}$ for $i \neq j$. We add the boundary condition $p = \Psi$ on $\overline{B} \cup C^T$ with Ψ constant on C^T . We also let p_0 denote the function $p_0(t,S,y) = \Psi(S,y)$. The complexity of this equation stems from the following integral term:

$$I(p)(t,S) = \frac{\int_{\Omega_y^S} p(t,S,x_2,...,x_n) dx_2...dx_n}{\int_{\Omega_y^S} b^2(x_2,...,x_n) p(t,S,x_2,...,x_n) dx_2...dx_n} = \frac{\int_{\Omega_y^S} p(t,S,y) dy}{\int_{\Omega_y^S} b^2(y) p(t,S,y) dy}$$

(1) belongs to the class of nonlinear, parabolic and nonlocal equations. An interesting reference concerning that kind of equations is [2]. However, our case doesn't fall under the scope of that paper: the operator I(.) is not defined on $C_b(\overline{D^T})$. Let us now make a few remarks about our particular equation.

Remark 1. In the case of an equation with no I(p) term, it becomes a classic linear equation of parabolic type. That kind of equation has been properly solved for quite some time now, see [6] or [7]. When b is constant, the problem is reduced to the previous remark. This observation is the key to our resolution method. First, we suppose that b does not vary too much and approximate the nonlocal term I(p) with a suitable constant. We then isolate the error made during this process in the second term and use a fixed point method to solve the new equation. In order to use this method and the results from [6], one has to assume that the coefficients of the equation belong to Holder spaces $H^{k,h,h/2}$ (we shall define them in the preliminaries).

Remark 2. The question whether I is properly defined is natural. To answer it, we have to prove that $\int_{\Omega_y^S} b^2(y) p(t, S, y) dy$ is bounded away from 0. We assume that b is non-negative and that Ψ the initial condition is strictly positive. By restricting ourselves to short times, we are sure that p is not too far from its initial condition and thus is strictly positive.

Remark 3. From a financial viewpoint, it is natural to consider a domain Ω cylindrical with respect to the spot. However, since it is quite challenging to study a PDE on a domain with corners, we reduce our study to domains with an S-section depending on S.

Assumptions. The theorem we shall prove requires the following assumptions on b and Ψ .

(H1)

(H3) Ψ is strictly positive and in $H^{2,h,h/2}$. This gives us two results on p_0 . First, p_0 belongs to $H^{2,h,h/2}(D^T)$ and second

$$0 < p_0 = \inf p_0 \le \sup p_0 = \overline{p_0}$$

(H4) $O(\Psi) = 0$ on ∂B in a sense described in the preliminaries

Under the previous assumptions, we have the following result:

Theorem 3.1. If the α_i belong to $H^{2,h,h/2}(D^T)$, are positive and bounded away from 0 by a strictly positive constant e, if the β_i are in $H^{1,h,h/2}(D^T)$ and if γ belongs to $H^{0,h,h/2}(D^T)$, then, for b^* small enough, there exists $0 < T^* \le T$ and a solution of the equation (1) on $D^{T^*} \cup B^{T^*}$.

The rest of the paper will be devoted to the proof of Theorem 3.1 above. We start with the basic mathematical notions it requires.

4. Preliminaries.

4.1. **Holder Spaces.** In this section, we write ∂_{x_i} and $\frac{\partial}{\partial x_i}$ without distinction. Let us start as in [6] and [7] with the following notion of distance $d(P,Q) = [|x - x'|^2 + |t - t'|]^{1/2}$ where P = (t, x) and Q = (t', x') belong to D^T and |x| is the norm of the n-dimensionnal vector x. Given such a metric d, we can define the concept of h-Holder continuity (with h a number between 0 and 1 strictly). For a function u, we write:

$$|u|_0^{D^T} = \sup_{D^T} |u| \qquad H_h^{D^T}(u) = \sup_{P,Q \in D^T} \frac{|u(P) - u(Q)|}{d(P,Q)^h} \qquad |u|_h^{D^T} = |u|_0^{D^T} + H_h^{D^T}(u)$$

 $|u|_h^{D^T} < \infty$ if and only if u is uniformly holder (exponent h) in D^T . We denote by $H^{0,h,h/2}(D^T)$ the set of all functions u for which $|u|_h^{D^T} < \infty$. Now, if all the derivatives used in the equation exist, we write for $k \leq 2$:

where the sums are taken over all the partial derivatives of the indicated order. We denote by $H^{k,h,h/2}(D^T)$ the set of all functions u for which $|u|_{k+h}^{D^T} < \infty$. It is a Banach space and an algebra with the norm given by definition 2. Indeed, for all u,v in $H^{k,h,h/2}(D^T)$, we have:

$$|uv|_{k+h}^{D^T} \le |u|_{k+h}^{D^T} |v|_{k+h}^{D^T} \tag{3}$$

We can now make the assumptions about D^T more precise: for every point Q of $\overline{C^T}$, there exists an (n+1)-dimensional neighborhood V such that $V \cap \overline{C^T}$ can be represented, for some i $(1 \leq i \leq n)$, in the form $x_i = r(t, x_1, ..., x_{i-1}, x_{i+1}, ..., x_n)$ with $r, \partial_x r, \partial_{xx}^2 r, \partial_t r$ Holder continuous (exponent h) and $\partial_{xt}^2 r, \partial_{tt}^2 r$ simply continuous.

We also have to consider functions ψ defined on $\overline{B} \cup C^T$. Such a function ψ is said to belong to $H^{k,h,h/2}$ if there exists a Ψ in $H^{k,h,h/2}(D^T)$ such that $\Psi = \psi$ on $\overline{B} \cup C^T$. We then define $|\psi|_{k+h} = \inf |\Psi|_{k+h}^{D^T}$ where the inf is taken with respect to all the Ψ 's in $H^{k,h,h/2}(D^T)$ which coincide with ψ on $\overline{B} \cup C^T$. This process defines

4.2. Linear equations of parabolic type. The following results will be useful in the proof of our result. They concern the PDE:

We shall need the assumptions:

a norm on $H^{k,h,h/2}$.

- the coefficients of the operator L belong to $H^{0,h,h/2}(D^T)$, let K_1 be a bound on their norm
- for all (x,t) in D^T and for all $\xi \in \mathbb{R}^n$, $\sum_{i,j=1}^n a_{ij}(x,t)\xi_i\xi_j \geq K_2 \mid \xi \mid^2 (K_2 > 0)$
- $\psi \in H^{2,h,h/2}$ and $|f|_h^{D^T} < \infty$

In addition, given the assumption about D^T , if we consider a function $\psi \in H^{2,h,h/2}$, for any extension Ψ of ψ , $\partial_t \Psi$ is uniquely defined (by continuity) on the boundary ∂B of B, and the definition is independent of Ψ . We denote this function (on ∂B) by $\partial_t \psi$. The other terms of $L\psi$ are also uniquely defined (by continuity) on ∂B . Thus, the quantity $L\psi$ is well-defined on ∂B .

Theorem 4.1. Under the previous assumptions and if $L\psi = f$ on ∂B , there exists a unique solution of the equation 4, this solution belongs to $H^{2,h,h/2}(D^T)$ and we have the Schauder inequality (with K_{H^2} depending only on K_1 , on K_2 , on h and on D^T)

Furthermore, if $\psi = 0$, we can write a bound containing the time on the supremum of the solution

and K_0 only depends on K, on K' and on Ω .

Proof. The first part of the result is classic, its proof can be found in [6]. As to the result with $\psi=0$, which is more original, one needs a result from [7] about volume potentials and representation of solutions of parabolic equations. It is the theorem (16.2) of section IV.16 we shall use. One reads that the solution of the equation 4 with $\psi=0$ can be written as

where G is the Green's function for the operator L and verifies

with K and K' two constants depending on the data of the problem. Using both these results, we get, for all $t' \leq t$ and $x \in \Omega$

$$|u(x,t')| \le t|f|_0^{D^t} \int_0^t d\tau \int_\Omega K(t-\tau)^{-\frac{n}{2}-1} exp(-K'\frac{|x-y|^2}{t-\tau}) dz \le t|f|_0^{D^t} K_0$$

where K_0 depends on K_1 , on K_2 , on h and on D^T .

5. **Proof of Theorem 3.1.** We are interested in the equation

$$\frac{\partial p}{\partial t} - \frac{\partial^2}{\partial S^2} (\rho_{11} \alpha_1^2 I(p) p) - \sum_{i=2}^n \frac{\partial^2}{\partial S \partial x_i} (\rho_{1i} \alpha_1 \alpha_i \sqrt{I(p)} p)$$
$$- \sum_{i,j=2}^n \frac{\partial^2}{\partial x_i \partial x_j} (\rho_{ij} \alpha_i \alpha_j p) + \sum_{i=1}^n \frac{\partial}{\partial x_i} (\beta_i p) + \gamma p = 0 \quad \text{on } D^T \cup B^T$$

and want to prove the theorem:

If the α_i belong to $H^{2,h,h/2}(D^T)$, are positive and bounded away from 0 by a strictly positive constant e, if the β_i are in $H^{1,h,h/2}(D^T)$ and if γ belongs to $H^{0,h,h/2}(D^T)$, then, for b^* small enough, there exists $0 < T^* \le T$ and a solution of the equation (1) on $D^{T^*} \cup B^{T^*}$.

Proof. The assumption (H2) gives us some control over the variations of b. Let us denote by $\underline{b} = b(y_0)$ a strictly positive value taken by b (with $y_0 \in \Omega_y^S$ for some arbitrary $S \in \Omega_S$). We use the assumption on b to approximate the integral term I(p) with $1/\underline{b}^2$, the gap between those two quantities is quantified with the

Lemma 5.1. There exists a constant K_b (depending only on h, n, δ_1 , δ_2 , $\underline{p_0}$ and Ω) and a polynomial function P strictly positive and increasing on \mathbb{R}_+^* such that $\forall p \in H^{2,h,h/2}(D^T)$ verifying $p_0 \leq p$, we have

Remark 4. As a consequence of this lemma, we see that $\forall p \in H^{2,h,h/2}(D^T)$ verifying $\underline{p_0} \leq p$, I(p) belongs to $H^{2,h,h/2}(D^T)$.

We then write the equation as

$$+ \sum_{i=1}^n \frac{\partial}{\partial x_i} (\beta_i p) + \gamma p = \frac{\partial^2}{\partial S^2} (\rho_{11} \alpha_1^2 (I(p) - \frac{1}{\underline{b}^2}) p) + \sum_{i=2}^n \frac{\partial^2}{\partial S \partial x_i} (\rho_{1i} \alpha_1 \alpha_i (\sqrt{I(p)} - \frac{1}{\underline{b}}) p)$$

To solve this equation, we apply a fixed point method and use the lemma 5.1 to get an upper bound on the second term.

We take a real number $x \geq |p_0|_{2+h}^{D^T}$ and $t \in \mathbb{R}_+^*$ and let X_x^t denote the set

The set X_x^t clearly contains the function p_0 . We then consider the application M which takes a function $u \in X$ and sends it on $v \in H^{2,h,h/2}(D^T)$ solution of the equation

$$O'v := \frac{\partial v}{\partial t} - \frac{\partial^2}{\partial S^2} (\rho_{11}\alpha_1^2 \frac{1}{\underline{b}^2} v) - \sum_{i=2}^n \frac{\partial^2}{\partial S \partial x_i} (\rho_{1i}\alpha_1 \alpha_i \frac{1}{\underline{b}} v) - \sum_{i,j=2}^n \frac{\partial^2}{\partial x_i \partial x_j} (\rho_{ij}\alpha_i \alpha_j v)$$

$$+\sum_{i=1}^{n} \frac{\partial}{\partial x_{i}}(\beta_{i}v) + \gamma v = \frac{\partial^{2}}{\partial S^{2}}(\rho_{11}\alpha_{1}^{2}(I(u) - \frac{1}{\underline{b}^{2}})u) + \sum_{i=2}^{n} \frac{\partial^{2}}{\partial S\partial x_{i}}(\rho_{1i}\alpha_{1}\alpha_{i}(\sqrt{I(u)} - \frac{1}{\underline{b}})u)$$

with the boundary condition $v = \Psi$ on $\overline{B} \cup C^T$. The existence of v is given by Theorem 4.1. Indeed, the coefficients of this equation belong to the appropriate spaces and because of (H4) the necessary condition

on ∂B is verified. It remains to prove that this operator is elliptic: let $(\xi_i)_{1 \leq i \leq n}$ be n real numbers and $(t, S, y) \in D^T$. We write $f_1 = \frac{\alpha_1}{b}$ and $f_i = \alpha_i$ for $i \geq 2$, we have

$$\sum_{i,j=1}^{n} \rho_{ij} f_i(t,S,y) f_j(t,S,y) \xi_i \xi_j \ge K_\rho \sum_{i=1}^{n} f_i^2(t,S,y) \xi_i^2 \ge K_\rho e^2 \sum_{i=1}^{n} \xi_i^2$$

where the existence of K_{ρ} is a consequence of ρ being a positive definite matrix. This proves the ellipticity of the operator, v exists and belongs to $H^{2,h,h/2}(D^T)$. We now want to show that for suitable x and t, v belongs to X_x^t ie that

$$|v|_{2+h}^{D^t} \le x$$

$$\frac{\underline{p_0}}{2} \le v \le \overline{p_0} + \frac{\underline{p_0}}{2}$$

For the first inequality, we apply 5

$$\begin{split} |v|_{2+h}^{D^t} & \leq K_{H^2}(|\psi|_{2+h}^{D^t} + |\frac{\partial^2}{\partial S^2}(\rho_{11}\alpha_1^2(I(u) - \frac{1}{\underline{b}^2})u) \\ & + \sum_{i=2}^n \frac{\partial^2}{\partial S \partial x_i}(\rho_{1i}\alpha_1\alpha_i(\sqrt{I(u)} - \frac{1}{\underline{b}})u)|_h^{D^t}) \\ & \leq K_{H^2}(|\psi|_{2+h}^{D^T} + |\rho_{11}\alpha_1^2(I(u) - \frac{1}{\underline{b}^2})u|_{2+h}^{D^t} + \sum_{i=2}^n |\rho_{1i}\alpha_1\alpha_i(\sqrt{I(u)} - \frac{1}{\underline{b}})u|_{2+h}^{D^t}) \\ & \leq K_{H^2}(|\psi|_{2+h}^{D^T} + (|\rho_{11}\alpha_1^2|_{2+h}^{D^T} + \sum_{i=2}^n |\rho_{1i}\alpha_1\alpha_i|_{2+h}^{D^T}) \\ & \leq K_{H^2}(|\psi|_{2+h}^{D^T} + b^*K'P(|u|_{2+h}^{D^t})|u|_{2+h}^{D^t}) \\ & \leq K_{H^2}(|\psi|_{2+h}^{D^T} + b^*K'P(|u|_{2+h}^{D^t})|u|_{2+h}^{D^t}) \end{split}$$

where $K' = (|\rho_{11}\alpha_1^2|_{2+h}^{D^T} + \sum_{i=2}^n |\rho_{1i}\alpha_1\alpha_i|_{2+h}^{D^T})K_b$ (we apply lemma 5.1 for the last

line). We remember that u belongs to X_x^t , thus $|u|_{2+h}^{D^t} \leq x$ and then

$$|v|_{2+h}^{D^t} \le K_{H^2}(|\psi|_{2+h}^{D^T} + b^*K'P(x)x)$$

Taking $x^* = max(K_{H^2}(|\psi|_{2+h}^{D^T}+1), |p_0|_{2+h}^{D^T})$ and $b^* \leq \frac{1}{K'P(x^*)x^*}$, 7 gives us $|v|_{2+h}^{D^T} \leq x^*$. It remains to prove that $\frac{p_0}{2} \leq v \leq \overline{p_0} + \frac{p_0}{2}$. Let us write $\tilde{v} = v - p_0$. It is clear that \tilde{v} verifies

$$O'\tilde{v} = O'p_0 + \frac{\partial^2}{\partial S^2} (\rho_{11}\alpha_1^2 (I(u) - \frac{1}{\underline{b}^2})u) + \sum_{i=2}^n \frac{\partial^2}{\partial S \partial x_i} (\rho_{1i}\alpha_1\alpha_i (\sqrt{I(u)} - \frac{1}{\underline{b}})u)$$

on $D^T \cup B^T$ with $\tilde{v} = 0$ on $\overline{B} \cup C^T$ (here we use the fact that Ψ is constant on C^T). We now apply the second part of Theorem 4.1, the inequality 6, to this function \tilde{v}

$$|\tilde{v}|_{0}^{D^{t}} \leq tK_{0}|O'p_{0} + \frac{\partial^{2}}{\partial S^{2}}(\rho_{11}\alpha_{1}^{2}(I(u) - \frac{1}{\underline{b}^{2}})u) + \sum_{i=2}^{n} \frac{\partial^{2}}{\partial S\partial x_{i}}(\rho_{1i}\alpha_{1}\alpha_{i}(\sqrt{I(u)} - \frac{1}{\underline{b}})u)|_{0}^{D^{t}}$$

$$\leq tK_{0}(|O'p_{0}|_{0}^{D^{T}} + |\frac{\partial^{2}}{\partial S^{2}}(\rho_{11}\alpha_{1}^{2}(I(u) - \frac{1}{\underline{b}^{2}})u)$$

$$+ \sum_{i=2}^{n} \frac{\partial^{2}}{\partial S\partial x_{i}}(\rho_{1i}\alpha_{1}\alpha_{i}(\sqrt{I(u)} - \frac{1}{\underline{b}})u)|_{h}^{D^{t}})$$

$$\leq tK_{0}(|O'p_{0}|_{0}^{D^{T}} + 1)$$

Taking $T^*K_0(|O'p_0|_0^{D^T}+1)=\frac{p_0}{2}$, we get $|\tilde{v}|_0^{D^t}\leq \frac{p_0}{2}$. Eventually, since $v=p_0+\tilde{v}$, the last inequality is proved and v belongs to $X_{x^*}^{T^*}$. The application M maps $X_{x^*}^{T^*}$ into itself

Using this statement, we construct a bounded sequence $(p_n)_{n\in\mathbb{N}}$ of functions belonging to $X_{r^*}^{T^*}$

- \bullet p_0 has been previously defined
- by induction, we write $p_{n+1} = M(p_n)$

By construction, we have $\forall n \in \mathbb{N}, |p_n|_{2+h}^{D^T} \leq x^*$. Repeated applications of the Ascoli-Arzel theorem give us a function $p \in C^2(D^{T^*})$ limit in $C^2(D^{T^*})$ of a subsequence of p_n . Since

$$\sup\left\{\frac{\left|\frac{\partial^{2} p_{n}}{\partial x_{i} \partial x_{j}}(x,t) - \frac{\partial^{2} p_{n}}{\partial x_{i} \partial x_{j}}(x',t')\right|}{\left(\left|x - x'\right|^{2} + \left|t - t'\right|\right)^{\alpha/2}}; (x,t), (x',t') \in D^{T^{*}}\right\} \leq x$$

We have

$$\sup\left\{\frac{\left|\frac{\partial^2 p}{\partial x_i \partial x_j}(x,t) - \frac{\partial^2 p}{\partial x_i \partial x_j}(x',t')\right|}{(\left|x - x'\right|^2 + \left|t - t'\right|)^{\alpha/2}}, (x,t); (x',t') \in D^{T^*}\right\} \le x$$

And this computation being true for all the derivatives appearing in the norm $H^{2,h,h/2}$, we find that $p \in H^{2,h,h/2}$.

The last step of the proof is to take the limit in 7. The only result needed is $I(p_n) \to I(p)$. Since $p_n \in X_{x^*}^{T^*}$, the denominator is bounded away from 0. Two applications of the dominated convergence theorem give us the convergence we need. Thus, it is possible to take the limit in 7 which gives us

$$\begin{split} \frac{\partial p}{\partial t} - \frac{\partial^2}{\partial S^2} (\rho_{11} \alpha_1^2 \frac{1}{\underline{b}^2} p) - \sum_{i=2}^n \frac{\partial^2}{\partial S \partial x_i} (\rho_{1i} \alpha_1 \alpha_i \frac{1}{\underline{b}} p) - \sum_{i,j=2}^n \frac{\partial^2}{\partial x_i \partial x_j} (\rho_{ij} \alpha_i \alpha_j p) \\ + \sum_{i=1}^n \frac{\partial}{\partial x_i} (\beta_i p) + \gamma p &= \frac{\partial^2}{\partial S^2} (\rho_{11} \alpha_1^2 (I(p) - \frac{1}{\underline{b}^2}) p) + \sum_{i=2}^n \frac{\partial^2}{\partial S \partial x_i} (\rho_{1i} \alpha_1 \alpha_i (\sqrt{I(p)} - \frac{1}{\underline{b}}) p) \end{split}$$

That concludes the proof of the theorem, p is solution of our equation.

Let us now prove lemma 5.1.

Proof. By definition, we have:

$$\begin{split} |I(p) - \frac{1}{\underline{b}^2}|_{2+h}^{D^T} &= |\frac{\int p dy}{\int b^2 p dy} - \frac{1}{\underline{b}^2}|_{2+h}^{D^T} &= |\frac{\int p(\underline{b}^2 - b^2) dy}{\underline{b}^2 \int b^2 p dy}|_{2+h}^{D^T} \\ &\leq \frac{1}{b^2} |\frac{1}{\int b^2 p dy}|_{2+h}^{D^T} |\int p(\underline{b}^2 - b^2) dy|_{2+h}^{D^T} \end{split}$$

Let us compute one after another the terms appearing in this norm (we remember that those functions only depend on t and S). Let (t, S) belong to $]0, T[\times \Omega_S]$. We have

$$\begin{split} |\int_{\Omega_y^S} p(t,S,y)(\underline{b}^2 - b^2(y)) dy| &\leq \int_{\Omega_y^S} p(t,S,y) |\underline{b}^2 - b^2(y)| dy \\ &\leq |p|_0^{D^T} \int_{\Omega_y^S} |\underline{b}^2 - b^2(y)| dy \leq |p|_0^{D^T} \int_{\Omega_y^S} |b^2(y_0) - b^2(y)| dy \\ &\leq b^* (n-2) \int_{\Omega_y^S} |y_0 - y| dy \quad |p|_0^{D^T} \leq b^* K |p|_0^{D^T} \end{split}$$

here and in the rest of the proof, K stands for some constant depending only on the data of the problem $(\Omega, n, \delta_1...)$ but not on p nor on b^* . We get the last line from the following computation where $y = (x_2, ..., x_n)$ and $y_0 = (x'_2, ..., x'_n)$

$$|b^{2}(y_{0}) - b^{2}(y)| = |b^{2}(x'_{2}, ., x'_{n}) - b^{2}(x_{2}, ., x_{n})|$$

$$\leq \sum_{i=3}^{n} |b^{2}(x'_{2}, ., x'_{i}, x_{i+1}, ., x_{n}) - b^{2}(x'_{2}, ., x'_{i-1}, x_{i}, ., x_{n})|$$

$$\leq \sum_{i=3}^{n} |\frac{\partial (b^{2})}{\partial x_{i}}|_{0}^{D^{t}} |x'_{i} - x_{i}| \leq (n-2)b^{*}|y' - y|$$

Now, let (t, S) and (t', S') belong to $]0, T[\times \Omega_S]$. We compute

$$\begin{split} |\int_{\Omega_y^S} p(t,S,y)(b^2(y_0) - b^2(y)) dy - \int_{\Omega_y^{S'}} p(t',S',y)(b^2(y_0) - b^2(y)) dy| \\ & \leq \int_{\Omega_y^S \cap \Omega_y^S} |p(t,S,y) - p(t',S',y)| |b^2(y_0) - b^2(y)| dy \\ + \int_{\Omega_y^S \setminus \Omega_y^{S'}} p(t,S,y) |b^2(y_0) - b^2(y)| dy + \int_{\Omega_y^{S'} \setminus \Omega_y^S} |p(t,S,y)| |b^2(y_0) - b^2(y)| dy \\ & \leq H_h^{D^T}(p) D((t,S),(t',S')) \int_{\Omega_y^S \cap \Omega_y^S} |b^2(y_0) - b^2(y)| dy \\ + |p|_0^{D^T} \int_{\Omega_y^S \setminus \Omega_y^{S'}} |b^2(y_0) - b^2(y)| dy + |p|_0^{D^T} \int_{\Omega_y^{S'} \setminus \Omega_y^S} |b^2(y_0) - b^2(y)| dy \\ & \leq b^* K |p|_h^{D^T}(D((t,S),(t',S')) + \int_{\Omega_y^S \setminus \Omega_y^{S'}} |y_0 - y| dy + \int_{\Omega_y^{S'} \setminus \Omega_y^S} |y_0 - y| dy) \end{split}$$

By assumption on the boundary of our domain, it is possible to find a constant K depending only on Ω such as $\forall S, S' \in \Omega_S$, $\int_{\Omega_y^S \setminus \Omega_y^{S'}} |y_0 - y| dy \leq KD(S, S')$. This

gives us

$$|\int p(\underline{b}^2 - b^2) dy|_h^{D^T} \le b^* K |p|_h^{D^t}$$

And since

$$\begin{split} |\int p(\underline{b}^2 - b^2) dy|_{2+h}^{D^T} = &|\int p(\underline{b}^2 - b^2) dy|_h^{D^T} + |\int \frac{\partial p}{\partial t} (\underline{b}^2 - b^2) dy|_h^{D^T} \\ &+ |\int \frac{\partial p}{\partial S} (\underline{b}^2 - b^2) dy|_h^{D^T} + |\int \frac{\partial^2 p}{\partial S^2} (\underline{b}^2 - b^2) dy|_h^{D^T} \end{split}$$

We get from the previous computation

$$|\int p(\underline{b}^2 - b^2) dy|_{2+h}^{D^T} \le b^* K |p|_{2+h}^{D^t}$$

We now have to find a bound on $\left|\frac{1}{\int b^2 p dy}\right|_{2+h}^{D^T}$. Since p belongs to $X_{x^*}^{T^*}$, we have $\left|\frac{1}{\int b^2 p dy}\right|_0^{D^T} \leq \frac{2}{\delta_1^2 p_0 V(\Omega)}$. Now, let (t, S) and (t', S') belong to $]0, T[\times \Omega_S$. We write

$$\begin{split} |\frac{1}{\int_{\Omega_y^S} b^2(y) p(S,t,y) dy} - \frac{1}{\int_{\Omega_y^{S'}} b^2(y) p(S',t',y) dy}| \\ & \leq \frac{|\int_{\Omega_y^{S'}} b^2(y) p(S',t',y) dy - \int_{\Omega_y^S} b^2(y) p(S,t,y) dy|}{\int_{\Omega_y^S} b^2(y) p(S,t,y) dy \int_{\Omega_y^{S'}} b^2(y) p(S',t',y) dy} \\ & \leq K H_h^{D^t}(p) D((t,S),(t',S')) \end{split}$$

We used the same kind of arguments than earlier, K denotes here another constant depending on δ_1 , δ_2 , $\underline{p_0}$ and Ω . This gives us $|\frac{1}{\int b^2 p dy}|_h^{D^T} \leq K(1+|p|_h^{D^T})$. As for derivatives of $\frac{1}{\int b^2 p dy}$, for instance with respect to S, we have

$$\left| \frac{\partial}{\partial S} \left(\frac{1}{\int b^2 p dy} \right) \right|_h^{D^T} = \left| -\frac{\int b^2 \frac{\partial p}{\partial S} dy}{(\int b^2 p dy)^2} \right|_h^{D^T} \le K(1 + |p|_h^{D^T})^2 |p|_{1+h}^{D^T}$$

The same kind of computation is true for the derivative of second order

$$|\frac{\partial}{\partial S}(-\frac{\int b^2 \frac{\partial p}{\partial S} dy}{(\int b^2 p dy)^2})|_h^{D^T} = |\frac{2(\int b^2 \frac{\partial p}{\partial S} dy)^2}{(\int b^2 p dy)^3} - \frac{\int b^2 \frac{\partial^2 p}{\partial S^2} dy}{(\int b^2 p dy)^2}|_h^{D^T} \\ \leq K[(1+|p|_h^{D^T})^3(|p|_{1+h}^{D^T})^2 + (1+|p|_h^{D^T})^2|p|_{2+h}^{D^T}]$$

Eventually, we get

$$|\frac{1}{\int b^2 p dy}|_{2+h}^{D^T} \leq K \big(1 + |p|_{2+h}^{D^T} + (|p|_{2+h}^{D^T})^2 + (|p|_{2+h}^{D^T})^3 + (|p|_{2+h}^{D^T})^4 + (|p|_{2+h}^{D^T})^5 \big)$$

Combining this result with the previous computations, we find

$$|I(p) - \frac{1}{b^2}|_{2+h}^{D^T} \le b^* KP(|p|_{2+h}^{D^t})$$

with P a polynomial function of degree 6, strictly positive on \mathbb{R}_+^* . Now, writing $\sqrt{I(p)} - \frac{1}{\underline{b}} = \frac{I(p) - \frac{1}{\underline{b}^2}}{\sqrt{I(p)} + \frac{1}{\underline{b}}}$, we find the same kind of results for the second term involved in the lemma. This concludes the proof.

6. **Conclusion.** In this paper, we have shown that the equation driving the calibration problem for local and stochastic volatility models is well-posed in the case of suitably regularized initial conditions. It is however clear that the solution of the full Kolmogorov equation with Dirac initial condition is not obtained as a consequence of Theorem 1: possible extensions of our results towards this direction are currently being explored. Let us also mention that a generalization of Theorem 1 to multidimensional correlation calibration has already been investigated and will be presented in [1]
