# AROUND QUILLEN'S THEOREM A

#### Abstract

We introduce a notion of cellular functor. It allows us to give a variant of Quillen's proof of the Solomon-Tits theorem, which does not use Theorem A. We also use it to generalise some exact sequences of Quillen, and to reformulate them into a rank spectral sequence converging to the homology of the $K^{\prime}$-theory space of an integral scheme.

## Introduction

Let $A$ be a Dedekind domain. Inspection shows immediately that the exact sequences of [12, Th. 3], used by Quillen to prove that the $K$-groups of $A$ are finitely generated when $A$ is a ring of $S$-integers in a global field, assemble to define an exact couple, hence a spectral sequence converging to the homology of $K A$. This gives potentially more power to Quillen's method, which as such yields no information on the ranks of these $K$-groups.

A natural way to imagine such a spectral sequence is to consider the maps

$$
B Q_{n-1} \mathcal{P}(A) \rightarrow B Q_{n} \mathcal{P}(A)
$$

used by Quillen as homotopy cofibrations rather than homotopy fibrations. The resulting rank spectral sequence coincides with the abovementioned spectral sequence: this is not immediately obvious, but follows from a simple argument of Vogel, see Remark 4.3.4.

The aim of this note is to construct the rank spectral sequence in a way as functorial as possible. The two operative ingredients are Thomason's theorem on the nerve of a Grothendieck construction (Theorem 1.4.3) and the notion of cellular functor (Definition 2.3.2), which is well-adapted to the present context thanks to Proposition 2.3.5. After the first version of this paper was written, Sun Fei observed that Proposition 2.3.5 may also be used to recover part of Quillen's proof of the Solomon-Tits theorem in [12]. We complete Sun's remark in §3, by covering the missing part: unlike in Quillen's argument, Theorem A is not used there. In this light, one might think of Proposition 2.3.5 as "dual" to Theorem A, potentially playing a similar rôle for homotopy cofibrations as Theorem A plays for homotopy fibrations.

The main theorem is Theorem 4.3.3: we apply the theory in the slightly more general case of torsion-free sheaves over an integral scheme, which might be useful elsewhere.

The next step would be to describe, or compute, the $d^{1}$ differentials of this rank spectral sequence. This appears quite tricky and I don't tackle this issue here: see [13].

Acknowledgements. I thank Pierre Vogel for explaining me the argument of Remark 4.3.4 in 2008, and Georges Maltsiniotis for pointing out Thomason's paper [14]. I also thank Sun Fei for several discussions around these questions.

I don't think Theorem A is used explicitly anywhere. Yet I feel its spirit is prevalent in this text, hence the title.

Notation. We denote by Set, Ab, sSet, Cat the category of (small) sets, abelian groups, simplicial sets, categories. For $n \geq 0,[n]$ denotes the totally ordered set $\{0, \ldots, n\}$, considered as a small category. We write $*$ for the category with one object and one morphism (sometimes for the set with 1 element). Finally, $\boldsymbol{\Delta}$ denotes the category of simplices (objects: finite nonempty ordinals, morphisms: non-decreasing maps).

We shall use Mac Lane's comma notation [10, p. 47]: if we have a diagram of functors

$$
\mathcal{C} \stackrel{F}{\longrightarrow} \mathcal{D} \stackrel{F^{\prime}}{\leftarrow} \mathcal{C}^{\prime}
$$

the comma category $F \downarrow F^{\prime}$ has for objects the diagram $F(c) \rightarrow F^{\prime}\left(c^{\prime}\right)$, and for morphisms the obvious commutative diagrams. We use the
following abbreviations: if $c \in \mathcal{C}$, yielding the functor $F_{c}: * \rightarrow \mathcal{C}$, we write $F_{c} \downarrow F^{\prime}=c \downarrow F^{\prime}$; similarly on the right.

## 1. Nerves with coefficients

Subsections 1.1-1.3 can essentially be found in Goerss-Jardine [7, Ch. IV].

### 1.1. Set-valued coefficients.

1.1.1. Let $\mathcal{D} \in$ Cat be a small category. The nerve of $\mathcal{D}$ is the simplicial set $N(\mathcal{D})$ with

$$
N_{n}(\mathcal{D})=O b \operatorname{Cat}([n], \mathcal{D})=\coprod_{d_{0} \rightarrow \cdots \rightarrow d_{n}} *, d_{i} \in \mathcal{D}
$$

cf. [6, II, 4.1].
1.1.2. Let $\mathcal{D} \in$ Cat and let $F: \mathcal{D} \rightarrow$ Set be a covariant functor. The nerve of $\mathcal{D}$ with coefficients in $F$ is the simplicial set $N(\mathcal{D}, F)$ with

$$
N_{n}(\mathcal{D}, F)=\coprod_{d_{0} \rightarrow \cdots \rightarrow d_{n}} F\left(d_{0}\right), d_{i} \in \mathcal{D}
$$

cf. [6, App. II, 3.2]. For $F$ the constant functor with value $*$, we recover the nerve of $\mathcal{D}$.
1.1.3. Let $(\mathcal{D}, F)$ be as in 1.1.2. We have the associated category

$$
[\mathcal{D}, F]=\{(d, x) \mid d \in \mathcal{D}, x \in F(d)\}
$$

where a morphism $(d, x) \rightarrow\left(d^{\prime}, x^{\prime}\right)$ is a morphism $f \in \mathcal{D}\left(d, d^{\prime}\right)$ such that $F(f)(x)=x^{\prime}$. This category has two other equivalent descriptions:
(1) [6, II, 1.1] Let $y=\mathcal{D}^{o p} \rightarrow \boldsymbol{\operatorname { C a t }}(\mathcal{D}$, Set) be the "coYoneda" embedding: then $[\mathcal{D}, F] \simeq y \downarrow F$, where $F$ is considered as an object of $\operatorname{Cat}(\mathcal{D}$, Set $)$.
(2) $[\mathcal{D}, F] \simeq * \downarrow F$, where $* \in \operatorname{Cat}(\mathcal{D}$, Set) is the constant functor with value $*$ and $F$ is considered as a functor.
The following lemma is obvious:
1.1.4. Lemma. There is a canonical isomorphism: $N(\mathcal{D}, F) \simeq N([\mathcal{D}, F])$.
1.2. Abelian group-valued coefficients.
1.2.1. Suppose that $F$ takes its values in the category $\mathbf{A b}$ of abelian groups. Then $N(\mathcal{D}, F)$ is a simplicial abelian group; it has homology groups [6, App. II, 3.2, p. 153]

$$
H_{i}(\mathcal{D}, F)=H_{i}([N(\mathcal{D}, F)])=\pi_{i}(N(\mathcal{D}, F) ; 0)
$$

where $[X]$ is the chain complex associated to a simplicial abelian group $X$ by taking for differentials the alternating sums of the faces.
1.2.2. Let us recall the Eilenberg-Zilber-Cartier theorem as expounded in [8, p. 7] (see also [5, 2.9 and 2.16]). To a bisimplicial abelian group $X$, one may associate a double complex $[X]$ as in the simplicial case. To a bisimplicial object $X$ one may associate the diagonal simplicial object $\delta X$ :

$$
(\delta X)_{n}=X_{n, n}
$$

and to a double complex $C$ one may associate the total complex Tot $C$ :

$$
(\operatorname{Tot} C)_{n}=\bigoplus_{p+q=n} C_{p, q}
$$

Then, given the diagram of functors

there exist two natural transformations

$$
\begin{array}{r}
\operatorname{shuffle~}_{X}: \operatorname{Tot}[X] \rightarrow[\delta X] \\
\text { Alexander-Whitney } \\
X
\end{array}:[\delta X] \rightarrow \operatorname{Tot}[X]
$$

which are quasi-inverse homotopy equivalences.

### 1.3. Simplicial set-valued coefficients.

1.3.1. If $X$ is a simplicial set, we may associate to it the free simplicial abelian group $\mathbf{Z} X$ generated by $X$, with $(\mathbf{Z} X)_{n}=\mathbf{Z} X_{n}$. Similarly with a bisimplicial set. The homology of $X$ is the homotopy of $\mathbf{Z} X$, or equivalently the homology of $[\mathbf{Z} X]$. Similarly with coefficients in an abelian group $A$, using $\mathbf{Z} X \otimes A$.

We shall usually write $[\mathbf{Z} X]=: C_{*}(X)$; if $X=N(\mathcal{D})$ for a category $\mathcal{D}$, we abbreviate $C_{*}(X)$ into $C_{*}(\mathcal{D})$.
1.3.2. Let $\mathcal{D} \in \mathbf{C a t}$ and let $\mathbf{F}: \mathcal{D} \rightarrow$ sSet be a functor. We may generalise the definition of 1.1.2 to get a bisimplicial set $N(\mathcal{D}, \mathbf{F})$ :

$$
N_{p, q}(\mathcal{D}, \mathbf{F})=\coprod_{d_{0} \rightarrow \cdots \rightarrow d_{p}} \mathbf{F}_{q}\left(d_{0}\right), d_{i} \in \mathcal{D} .
$$

We may then take the diagonal $\delta N(\mathcal{D}, \mathbf{F})$, which is a simplicial set. We define

$$
\begin{aligned}
\pi_{i}\left(\mathcal{D}, \mathbf{F} ;\left(d_{0}, x_{0}\right)\right) & =\pi_{i}\left(\delta N(\mathcal{D}, \mathbf{F}) ;\left(d_{0}, x_{0}\right)\right) \\
C_{*}(\mathcal{D}, \mathbf{F} ; A) & =C_{*}(\delta N(\mathcal{D}, \mathbf{F})) \otimes A \\
H_{i}(\mathcal{D}, \mathbf{F} ; A) & =H_{i}\left(C_{*}(\mathcal{D}, \mathbf{F} ; A)\right)
\end{aligned}
$$

for $d_{0} \in \mathcal{D}_{0}$ and $x_{0} \in F_{0}\left(d_{0}\right)$ a chosen base point, and for $A$ an abelian group of coefficients.
1.3.3. Lemma. a) Let $X=\left(X_{p, q}\right), Y=\left(Y_{p, q}\right)$ be two bisimplicial sets and $\varphi: X \rightarrow Y$ a bisimplicial map. Suppose that, for each $p \geq 0$, $\varphi_{p, *}: X_{p, *} \rightarrow Y_{p, *}$ is a weak equivalence. Then $\delta \varphi: \delta X \rightarrow \delta Y$ is a weak equivalence.
b) Let $\mathbf{F}, \mathbf{G}: \mathcal{D} \rightarrow \mathbf{s S e t}$ be two functors, and let $\varphi: \mathbf{F} \rightarrow \mathbf{G}$ be a morphism of functors. Suppose that, for each $d \in \mathcal{D}, \varphi(d): \mathbf{F}(d) \rightarrow$ $\mathbf{G}(d)$ is a weak equivalence. Then $\delta N(\mathcal{D}, \varphi): \delta N(\mathcal{D}, \mathbf{F}) \rightarrow \delta N(\mathcal{D}, \mathbf{G})$ is a weak equivalence.

Proof. a) is well-known (for example, it is the special case of the Bous-field-Friedlander theorem of [7, Th. 4.9 p .229$]$ where $Y=W=*$ ), and b) follows from a).
1.3.4. For an abelian group $A$ and for $q \geq 0$, we may consider the additive functor

$$
\begin{aligned}
H_{q}(\mathbf{F}, A): \mathcal{D} & \rightarrow \mathbf{A b} \\
d & \mapsto H_{q}(\mathbf{F}(d), A) .
\end{aligned}
$$

This gives a meaning to:
1.3.5. Lemma. There is a spectral sequence

$$
E_{p, q}^{2}=H_{p}\left(\mathcal{D}, H_{q}(\mathbf{F}, A)\right) \Rightarrow H_{p+q}(\mathcal{D}, \mathbf{F} ; A)
$$

Proof. We shall use 1.2.2: it implies that $[\delta \mathbf{Z} N(\mathcal{D}, \mathbf{F})]$ is homotopy equivalent to $\operatorname{Tot}[\mathbf{Z} N(\mathcal{D}, \mathbf{F})]$. Therefore

$$
\begin{aligned}
& H_{*}(\mathcal{D}, \mathbf{F} ; A):=H_{*}([\delta \mathbf{Z} N(\mathcal{D}, \mathbf{F})] \otimes A) \\
& \quad \simeq H_{*}(\operatorname{Tot}[\mathbf{Z} N(\mathcal{D}, \mathbf{F})] \otimes A)=H_{*}\left(\operatorname{Tot} \bigoplus_{p, q} \bigoplus_{d_{0} \rightarrow \cdots \rightarrow d_{p}}\left[\mathbf{Z} F_{q}\left(d_{0}\right)\right] \otimes A\right) .
\end{aligned}
$$

Consider the first spectral sequence associated to this double complex in Cartan-Eilenberg [4, Ch. XV, §6]: the formula (1) of loc. cit, p. 331 shows that it is the desired spectral sequence.
1.4. Category-valued coefficients. (See also [15, IV.3].)
1.4.1. Let $\mathcal{D} \in \mathbf{C a t}$ and let $\mathbf{F}: \mathcal{D} \rightarrow \mathbf{C a t}$ be a functor. Composing $\mathbf{F}$ with the nerve functor, we get a functor $N \circ \mathbf{F}: \mathcal{D} \rightarrow \mathbf{s S e t}$, hence a bisimplicial set as in 1.3.2

$$
N(\mathcal{D}, \mathbf{F})=N(\mathcal{D}, N(\mathbf{F})) .
$$

1.4.2. We now extend the construction in 1.1.3. This yields the category $\mathcal{D} \int \mathbf{F}$ (Grothendieck construction, [SGA1, Exp. VI, $\left.\S \S 8,9\right]$ ):

- Objects are pairs $(d, x), d \in O b(\mathcal{D}), x \in O b(\mathbf{F}(d))$.
- For two objects $(d, x),\left(d^{\prime}, x^{\prime}\right)$, a morphism $(d, x) \rightarrow\left(d^{\prime}, x^{\prime}\right)$ is a morphism $f: d \rightarrow d^{\prime}$ and a morphism $g: \mathbf{F}(f)(x) \rightarrow x^{\prime}$.
- For three objects $(d, x),\left(d^{\prime}, x^{\prime}\right),\left(d^{\prime \prime}, x^{\prime \prime}\right)$ and two morphisms $(f, g)$ : $(d, x) \rightarrow\left(d^{\prime}, x^{\prime}\right),\left(f^{\prime}, g^{\prime}\right):\left(d^{\prime}, x^{\prime}\right) \rightarrow\left(d^{\prime \prime}, x^{\prime \prime}\right),\left(f^{\prime}, g^{\prime}\right) \circ(f, g):=$ $\left(f^{\prime} \circ f, g^{\prime} \circ \mathbf{F}\left(f^{\prime}\right)(g)\right)$.
The Grothendieck construction is covariant in $\mathbf{F}$. In particular, there is a canonical functor $\mathcal{D} \int \mathbf{F} \rightarrow \mathcal{D}$ induced by the morphism $\mathbf{F} \rightarrow *$, where $*$ is the constant functor with value the point category. We call this functor the augmentation.

Lemma 1.1.4 then generalises as
1.4.3. Theorem (Thomason [14, Th. 1-2]). There is a canonical weak equivalence

$$
\delta N(\mathcal{D}, \mathbf{F}) \rightarrow N\left(\mathcal{D} \int \mathbf{F}\right)
$$

sending a cell $\left(d_{0} \xrightarrow{f_{1}} \ldots \xrightarrow{f_{n}} d_{n}, x_{0} \xrightarrow{g_{1}} \ldots \xrightarrow{g_{n}} x_{n}\right)\left(x_{i} \in F\left(d_{0}\right)\right)$ to the cell

$$
\left(\left(d_{0}, y_{0}\right) \xrightarrow{h_{1}} \ldots \xrightarrow{h_{n}}\left(d_{n}, y_{n}\right)\right) \quad\left(y_{i} \in F\left(d_{i}\right)\right)
$$

with $y_{i}:=F\left(f_{i} \ldots f_{1}\right) x_{i}$ and $h_{i}=\left(f_{i}, F\left(f_{i} \ldots f_{1}\right) g_{i}\right)$.
1.4.4. Let $T: \mathcal{C} \rightarrow \mathcal{D}$ be a functor between two small categories. To $T$ we associate the functor $\mathbf{F}_{T}: \mathcal{D} \rightarrow$ Cat sending $d$ to $T \downarrow d$. The category $\mathcal{D} \int \mathbf{F}_{T}$ may be identified with the comma category $T \downarrow I d_{\mathcal{D}}$. Therefore there are 3 functors:

$$
p_{1}: \mathcal{D} \int \mathbf{F}_{T} \rightarrow \mathcal{C}, p_{2}: \mathcal{D} \int \mathbf{F}_{T} \rightarrow \mathcal{D}, s: \mathcal{C} \rightarrow \mathcal{D} \int \mathbf{F}_{T}
$$

with

$$
p_{1}([T(c) \xrightarrow{\varphi} d])=c, p_{2}([T(c) \xrightarrow{\varphi} d])=d, s(c)=[T(c)=T(c)] .
$$

We have:
1.4.5 Lemma. $s$ is left adjoint to $p_{1}$. Hence $s$ and $p_{1}$ induce quasiinverse homotopy equivalences $N(\mathcal{C}) \simeq N\left(\mathcal{D} \int \mathbf{F}_{T}\right)$.

From Theorem 1.4.3 and Lemma 1.3.5, we deduce
1.4.6. Corollary (cf. [6, App. II]). There is a spectral sequence

$$
E_{p, q}^{2}=H_{p}\left(\mathcal{D}, H_{q}\left(\mathbf{F}_{T}, A\right)\right) \Rightarrow H_{p+q}(\mathcal{C}, A)
$$

for any abelian group $A$.

## 2. A LONG HOMOLOGY EXACT SEQUENCE

### 2.1. Spectral sequences and exact couples.

2.1.1. Let $\mathcal{T}$ be a triangulated category with countable direct sums, and let $C_{0} \xrightarrow{i_{1}} \ldots \xrightarrow{i_{n}} C_{n} \xrightarrow{i_{n+1}} \ldots$ be a sequence of objects of $\mathcal{T}$. Let $C$ be a homotopy colimit (mapping telescope) of the $C_{n}[1]$. Let $H: \mathcal{T} \rightarrow \mathcal{A}$ be a (co)homological functor to some abelian category $\mathcal{A}$ : we assume that $H$ commutes with countable direct sums. (Alternately, we could refuse infinite direct sums and assume that $i_{n}$ is an isomorphism for $n$ large enough.) To get an associated spectral sequence, the simplest is the technique of exact couples [9, pp. 152-153]: for each $n$, choose a cone $C_{n / n-1}$ of $f_{n}$, so that the exact triangles

$$
C_{p-1} \xrightarrow{i_{p}} C_{p} \xrightarrow{j_{p}} C_{p / p-1} \xrightarrow{k_{p}} C_{p-1}[1]
$$

yield long homology exact sequences

$$
\ldots H_{n}\left(C_{p-1}\right) \xrightarrow{i_{p, n}} H_{n}\left(C_{p}\right) \xrightarrow{j_{p, n}} H_{n}\left(C_{p / p-1}\right) \xrightarrow{k_{p, n}} H_{n-1}\left(C_{p-1}\right) \ldots
$$

where $H_{n}(X):=H(X[-n])$. The exact couple defined by

$$
D_{p, q}=H_{p+q}\left(C_{p}\right), \quad E_{p, q}=H_{p+q}\left(C_{p / p-1}\right)
$$

and the relevant $i, j, k$ define a spectral sequence abutting to $H_{p+q}(C)$. The $E^{1}$-terms of this spectral sequence are simply $E_{p, q}^{1}=E_{p, q}$, and $d_{p, q}^{1}=j_{p-1, p+q-1} k_{p, p+q}$.

Here is a more concrete description of this differential:
2.1.2. Lemma. Let $C_{p / p-2}$ be a cone for $i_{p} i_{p-1}$, so that we may obtain a commutative diagram

$$
\begin{aligned}
& \begin{array}{c}
C_{p-2}=C_{p-2} \\
i_{p-1} \downarrow \\
i_{p} i_{p-1} \downarrow
\end{array} \\
& \begin{array}{ccccc}
C_{p-1} & \xrightarrow{i_{p}} & C_{p} & \xrightarrow{j_{p}} & C_{p / p-1} \\
j_{p-1} \downarrow & & \xrightarrow{k_{p}} & C_{p-1}[1] \\
& \downarrow & & &
\end{array} \\
& C_{p-1 / p-2} \xrightarrow{\bar{i}_{p}} C_{p / p-2} \xrightarrow{\bar{j}_{p}} C_{p / p-1} \xrightarrow{\bar{k}_{p}} C_{p-1 / p-2}[1]
\end{aligned}
$$

of exact triangles (from the suitable axiom of triangulated categories). Then $d_{p, q}^{1}$ is the boundary map $\bar{k}_{p, n}$ in the long exact sequence

$$
\begin{aligned}
\ldots H_{p+q}\left(C_{p-1 / p-2}\right) \xrightarrow{\bar{i}_{p, n}} & H_{p+q}\left(C_{p / p-2}\right) \\
& \xrightarrow{\bar{j}_{p, n}}
\end{aligned} H_{p+q}\left(C_{p / p-1}\right) \xrightarrow{\bar{k}_{p, n}} H_{p+q-1}\left(C_{p-1 / p-2}\right) \ldots .
$$

Proof. The diagram shows that $\bar{k}_{p}=j_{p-1}[1] \circ k_{p}$.
2.1.3. In the usual case of a filtered complex $C_{p}=F_{p} C$, we may of course choose $C_{p / p-1}=F_{p} C / F_{p-1} C$ and $C_{p / p-2}=F_{p} C / F_{p-2} C$.
2.1.4. Let $\mathcal{Q}_{0} \xrightarrow{T_{1}} \mathcal{Q}_{1} \xrightarrow{T_{2}} \cdots \rightarrow \mathcal{Q}_{n} \rightarrow \ldots$ be a sequence of categories and functors. Let $\mathcal{Q}=\underset{\longrightarrow}{\lim } \mathcal{Q}_{n}$. (Since there are no natural transformations involved this is a naïve colimit, defined objectwise and morphismwise.) Considering the corresponding sequence of chain complexes of nerves

$$
C_{*}\left(\mathcal{Q}_{0}\right) \xrightarrow{i_{1}} C_{*}\left(\mathcal{Q}_{1}\right) \ldots
$$

we get from the yoga of 2.1 .1 a spectral sequence abutting to $H_{*}(\mathcal{Q})$ (possibly with coefficients).

If the functors $T_{n}$ are faithful and injective on objects, the maps $i_{n}$ are injective and we are in the simpler situation of 2.1.3.

### 2.2. Unreduced and reduced homology.

2.2.1. Let $(X, x)$ be a pointed simplicial set. The reduced homology of $X$ with coefficients in an abelian group $A$ is

$$
\begin{aligned}
\tilde{H}_{i}(X, A)=H_{i}(X, x ; A):=\operatorname{Coker}\left(H_{i}(x, A) \rightarrow\right. & \left.H_{i}(X, A)\right) \\
& \left(=H_{i}(X, A) \text { if } i \neq 0\right) .
\end{aligned}
$$

This definition apparently depends on the choice of $x$ : if we don't want to choose a basepoint, we may alternately define

$$
\tilde{H}_{i}(X, A)=\operatorname{Ker}\left(H_{i}(X, A) \rightarrow H_{i}(*, A)\right) .
$$

Any choice of $x \in X_{0}$ will split the map $X \rightarrow *$, realising $\tilde{H}_{i}(X, A)$ as the above-described direct summand of $H_{i}(X, A)$.

A homotopy cofibre sequence $X \rightarrow Y \rightarrow Z$ is equivalent to a homotopy cocartesian square

hence the corresponding long exact homology sequence may be written (via Mayer-Vietoris!) as

$$
\ldots H_{i}(X, A) \rightarrow H_{i}(Y, A) \rightarrow \tilde{H}_{i}(Z, A) \rightarrow H_{i-1}(X, A) \rightarrow \ldots
$$

2.2.2. Suppose $\mathbf{F}: \mathcal{D} \rightarrow$ sSet is a functor; suppose that $\mathbf{F}(d) \neq \emptyset$ for any $d \in \mathcal{D}$. We then define

$$
C_{*}(\mathcal{D}, \tilde{\mathbf{F}} ; A)=\operatorname{Ker}\left(C_{*}(\mathcal{D}, \mathbf{F}) \rightarrow C_{*}(\mathcal{D})\right) \otimes A
$$

where the last map is induced by the natural transformation $\mathbf{F} \rightarrow *$, and

$$
H_{i}(\mathcal{D}, \tilde{\mathbf{F}} ; A)=H_{i}\left(C_{*}(\mathcal{D}, \tilde{\mathbf{F}} ; A)\right)
$$

(Here the map $\mathbf{F} \rightarrow *$ is not necessarily split, so we have to be more careful. We think of $\tilde{\mathbf{F}}$ as a desuspension of the homotopy cofibre of $\mathbf{F} \rightarrow *$.)

More generally, if $\mathbf{F} \rightarrow \mathbf{G}$ is a morphism of functors, we define

$$
C_{*}(\mathcal{D}, \mathbf{F} \rightarrow \mathbf{G} ; A)=\operatorname{cone}\left(C_{*}(\mathcal{D}, \mathbf{F}) \rightarrow C_{*}(\mathcal{D}, \mathbf{G})\right)[-1] .
$$

If $\mathbf{G}=*$, then $C_{*}(\mathcal{D}, \mathbf{F} \rightarrow * ; A)$ is homotopy equivalent to $C_{*}(\mathcal{D}, \tilde{\mathbf{F}} ; A)$ under the nonemptiness assumption on $\mathbf{F}$.
2.2.3. Suppose $\mathbf{F}: \mathcal{D} \rightarrow$ Cat is a functor. We have the projection $\mathbf{F} \rightarrow *$, where $*$ is the constant functor with values the category with 1 onject and 1 morphism. As in 2.2.2 we define

$$
\begin{aligned}
& C_{*}(\mathcal{D}, \tilde{\mathbf{F}} ; A)=\operatorname{Ker}\left(C_{*}(\mathcal{D}, \mathbf{F}) \rightarrow C_{*}(\mathcal{C})\right) \otimes A \\
& H_{i}(\mathcal{D}, \tilde{\mathbf{F}} ; A)=H_{i}\left(C_{*}(\mathcal{D}, \tilde{\mathbf{F}} ; A)\right) .
\end{aligned}
$$

provided $\mathbf{F}(d) \neq \emptyset$ for any $d \in \mathcal{D}$. In general, we define $H_{*}(\mathcal{D}, \tilde{\mathbf{F}} ; A)$ as the homology of $C_{*}(\mathcal{D}, \mathbf{F} \rightarrow * ; A)$ as before.

### 2.3. Cellular functors.

2.3.1. Lemma. Let $\mathbf{F}_{T}$ be as in 1.4.4. Suppose $T$ fully faithful. Then, for any $c \in \mathcal{C}, \mathbf{F}_{T}(T(c))$ has a final object.

Proof. Such a final object is given by $[T(c)=T(c)]$.
2.3.2. Definition. Let $T: \mathcal{C} \rightarrow \mathcal{D}$ be a functor. We say that $T$ is cellular if

- $T$ is fully faithful.
- For any $d \in \mathcal{D}-\mathcal{C}$ and any $c \in \mathcal{C}, \mathcal{D}(d, c)=\emptyset$.

If $T$ is cellular, then it defines a "stratification" $\mathcal{D}=\mathcal{C} \coprod(\mathcal{D}-\mathcal{C})$ in the following sense:
2.3.3. Lemma. Let $T: \mathcal{C} \rightarrow \mathcal{D}$ be a cellular functor; let $F_{1}, F_{2}: \mathcal{D} \rightarrow \mathcal{E}$ be two functors and let $\varphi: F_{1} \Rightarrow F_{2}$ be a natural transformation. Then there is a unique factorisation of $\varphi$ as a composition

$$
F_{1} \stackrel{\varphi_{1}}{\Rightarrow} F_{\varphi} \stackrel{\varphi_{2}}{\Rightarrow} F_{2}
$$

such that $F_{\varphi}(d)=F_{2}(d), \varphi_{2}(d)=1_{F_{2}(d)}$ for $d \in \mathcal{D}-T(\mathcal{C})$, and $F_{\varphi} T(c)=F_{1} T(c), \varphi_{1}(T(c))=1_{F_{1} T(c)}$ for $c \in \mathcal{C}$.

Proof. For simplicity, we drop the notation $T$ in this proof. Let us define a functor structure on $F_{\varphi}$ as follows: if $f: d \rightarrow d$ is a morphism in $\mathcal{D}$, then three cases may occur:

- $d, d^{\prime} \in \mathcal{D}-\mathcal{C}$. We define $F_{\varphi}(f)$ as $F_{2}(f)$.
- $d \in \mathcal{C}, d^{\prime} \in \mathcal{D}-\mathcal{C}$. We define $F_{\varphi}(f)$ as $\varphi_{d} F_{1}(f)=F_{2}(f) \varphi_{c}$.
- $d, d^{\prime} \in \mathcal{C}$. We define $F_{\varphi}(f)$ as $F_{1}(f)$.

Similarly, we define $\varphi_{1}(d)$ as $\varphi(d)$ for $d \in \mathcal{D}-\mathcal{C}$ and $\varphi_{2}(c)=\varphi(c)$ for $c \in \mathcal{C}$.

These definitions are the only possible ones if the lemma is correct. Checking that $F_{\varphi}$ respects composition of morphisms and that $\varphi_{1}, \varphi_{2}$ do define natural transformations is a matter of case-by-case bookkeeping.
2.3.4. Definition. A (naturally) commutative square of categories and functors is homotopy cocartesian if it is after applying the nerve functor.
2.3.5. Proposition. Let $\mathcal{D}-\mathcal{C}$ be the full subcategory of $\mathcal{D}$ given by the objects not in $\mathcal{C}$. If $T$ is cellular, the naturally commutative diagram of categories

is homotopy cocartesian, where $\varepsilon$ is the augmentation (see §1.4.2), $p$ is induced by the first projection $p_{1}$ of Lemma 1.4.5 and $\iota$ is the inclusion.

Proof. Note first the natural transformation

$$
\begin{aligned}
u: T \circ p & \Rightarrow \iota \circ \varepsilon \\
u_{[T(c) \xrightarrow{f} \rightarrow d]} & =f
\end{aligned}
$$

which explains "naturally commutative" (here in the weak sense). By Theorem 1.4.3 and Lemma 1.4.5, it suffices to prove that the (commutative) diagram of bisimplicial sets

is homotopy cocartesian, i.e becomes so after applying the diagonal $\delta$.

Applying Lemma 2.3.3 to the natural transformation $\mathbf{F}_{T} \rightarrow *$ yields a canonical factorisation

$$
\mathbf{F}_{T} \Rightarrow G \stackrel{\varphi}{\Rightarrow} *
$$

where

$$
G(d)= \begin{cases}\mathbf{F}_{T}(d) & \text { if } d \in T(\mathcal{C}) \\ * & \text { if } d \in \mathcal{D}-T(\mathcal{C})\end{cases}
$$

Hence we can enlarge the above diagram as follows:


It suffices to show that the top and bottom squares in (2.1) are both homotopy cocartesian.

By Lemma 2.3.1, $\varphi(d)_{*}$ is a weak equivalence for $d \in \mathcal{C}$, and it is trivially a weak equivalence for $d \in \mathcal{D}-\mathcal{C}$. Therefore, by Lemma 1.3 .3 b ), the two vertical maps in the bottom square of (2.1) become weak equivalences after applying $\delta$; a fortiori, this bottom square is homotopy cocartesian.

On the top right of (2.1), a typical term is

$$
\coprod_{d_{0} \rightarrow \cdots \rightarrow d_{p}} N\left(\mathbf{F}_{T}\left(d_{0}\right)\right) .
$$

We split this coproduct in two parts: one is where all the $d_{i}$ are in $\mathcal{D}-\mathcal{C}$ (call it $A_{T}$ ) and the other is the rest (call it $B_{T}$ ). Similarly on the middle right of (2.1) (call them $A_{G}$ and $B_{G}$ ).

Now the cellularity assumption implies that all cells in $B_{T}$ and $B_{G}$ begin with $d_{0} \in \mathcal{C}$. But for such a $d_{0}, N\left(\mathbf{F}_{T}\left(d_{0}\right)\right) \rightarrow G\left(d_{0}\right)$ is a bijection. Thus $B_{T} \rightarrow B_{G}$ is bijective. On the other hand, by definition of the cofibre, $A_{T}$ and $A_{G}$ become a point in the cofibres. Thus the induced map on cofibres is bijective, and the top square of (2.1) is homotopy cocartesian as well.
2.3.6. Theorem. Let $T: \mathcal{C} \rightarrow \mathcal{D}$ be a cellular functor. Then the mapping cone of

$$
C_{*}(T): C_{*}(\mathcal{C}) \rightarrow C_{*}(\mathcal{D})
$$

is quasi-isomorphic to $C_{*}\left(\mathcal{D}-\mathcal{C}, \tilde{\mathbf{F}}_{T}\right)[1]$ (cf. 2.2.2). In particular, we have a long exact sequence

$$
\begin{aligned}
\cdots \rightarrow H_{i}\left(\mathcal{D}-\mathcal{C}, \tilde{\mathbf{F}}_{T} ; A\right) & \rightarrow H_{i}(\mathcal{C}, A) \\
& \rightarrow H_{i}(\mathcal{D}, A) \rightarrow H_{i-1}\left(\mathcal{D}-\mathcal{C}, \tilde{\mathbf{F}}_{T} ; A\right) \rightarrow \ldots
\end{aligned}
$$

for any abelian group $A$.
Proof. This follows from Proposition 2.3.5 and Theorem 1.4.3.

### 2.4. Cellular filtrations.

2.4.1. Theorem. Let $\mathcal{Q}_{1} \rightarrow \mathcal{Q}_{2} \rightarrow \cdots \rightarrow \mathcal{Q}_{n} \rightarrow \cdots \rightarrow \mathcal{Q}$ be a sequence of categories. We assume:

- The functors $T_{n}: \mathcal{Q}_{n-1} \rightarrow \mathcal{Q}_{n}$ are cellular (2.3.2).
- $\mathcal{Q}=\underset{\longrightarrow}{\lim } \mathcal{Q}_{n}$.

Write $\mathbf{F}_{n}$ for $\mathbf{F}_{T_{n}}$. Then, for any abelian group $A$, there is a spectral sequence of homological type

$$
E_{p, q}^{1}=H_{p+q-1}\left(\mathcal{Q}_{p}-\mathcal{Q}_{p-1}, \tilde{\mathbf{F}}_{p} ; A\right) \Rightarrow H_{p+q}(\mathcal{Q}, A) .
$$

Proof. This is the spectral sequence of 2.1.4, taking Theorem 2.3.6 into account.

## 3. Cellular functors and the Solomon-Tits theorem

3.1. An abstract version of the Solomon-Tits theorem (for $\left.G L_{n}\right)$. This section was catalysed by Sun Fei's insight that one can use Proposition 2.3.5 to understand part of Quillen's proof of the SolomonTits theorem in [12]. We start with an abstraction of his argument.
3.1.1. Proposition (Sun, essentially). Let $\mathbf{V}$ be an poset (considered as a category), $\mathbf{H}$ a subset of maximal elements in $\mathbf{V}$ and $\mathbf{Y}=\mathbf{V}-\mathbf{H}$. For any $W \in \mathbf{V}$, write $\mathbf{V}_{W}=\{X \in \mathbf{V} \mid X<W\}$. Then the naturally commutative diagram

is homotopy cocartesian. Here $i$ is the inclusion, $j$ is componentwise the inclusion, $k$ is the tautological projection and $l$ is the inclusion of the discrete set $\underset{H \in \mathbf{H}}{\coprod^{*}} *=\mathbf{H}$ into $\mathbf{V}$; a natural transformation $i j \Rightarrow l k$ is defined by the inequality $W \leq H$ for $W \in \mathbf{V}_{H}$.

Proof. The hypotheses imply that $i$ is a cellular functor, so it suffices to compute $\mathbf{H} \int \mathbf{F}_{i}=\coprod_{H \in \mathbf{H}} i \downarrow H$. Clearly, $i \downarrow H=\mathbf{V}_{H}$.

Sun's second insight was that one can replace the simplicial complex $Y$ in the proof of Quillen's Claim in $[12, \S 2]$ by the poset of its vertices. We make use of this observation now.
3.1.2. Proposition. Keep the notation of Proposition 3.1.1, and write $\overline{\mathbf{V}}=\mathbf{V} \cup\{+\}$ where + is a new, maximal element. Assume that there exists $L \in \mathbf{V}$ such that
(i) For any $W \in \overline{\mathbf{V}}$, the supremum $L \vee W$ exists.
(ii) $\mathbf{H}=\{W \in \mathbf{V} \mid W$ maximal and $L \not \leq W\}$.

Then $\mathbf{Y}$ is contractible.
Proof. It is directily inspired by Quillen's proof of his claim (loc. cit.), but avoids the use of Theorem A.

Let $\varphi: \overline{\mathbf{V}} \rightarrow \overline{\mathbf{V}}$ be the functor defined by $\varphi(W)=L \vee W$ : the inequality $W \leq L \vee W$ defines a natural transformation $I d_{\overline{\mathrm{V}}} \Rightarrow \varphi$. Now $\varphi(\mathbf{Y}) \subset \mathbf{V}^{L} \subseteq \mathbf{Y}$, where

$$
\mathbf{V}^{L}=\{W \in \mathbf{V} \mid L \leq W\}
$$

This poset has the minimal element $L$, hence is contractible. Thus $\varphi$ preserves $\mathbf{Y}$ and factors through a contractible poset; since $\varphi_{\mid \mathbf{Y}}$ is homotopic to $I d_{\mathbf{Y}}$, this proves the claim.
3.1.3. Corollary. Under the assumptions of Proposition 3.1.2, there is a zigzag of homotopy equivalences

$$
\bigvee_{H \in \mathbf{H}} \Sigma N\left(\mathbf{V}_{H}\right) \xrightarrow{\sim} N(\mathbf{V}) / N(\mathbf{Y}) \stackrel{\sim}{\sim} N(\mathbf{V}) .
$$

Proof. Consider the strictly commutative diagram of functors


Here $i^{\prime}$ is componentwise the natural inclusion, $\bar{\jmath}$ sends $\mathbf{V}_{H}$ to itself and $+_{H}$ to $H$ while $\varepsilon$ sends $*_{H}$ to $+_{H}$. The latter functor has a retraction $\bar{k}$ which extends the functor $k$ of Proposition 3.1.1. From this and the latter proposition, we deduce that the top square is homotopy cocartesian. We deduce a homotopy equivalence

$$
\bigvee_{H \in \mathbf{H}} N\left(\overline{\mathbf{V}}_{H}\right) / N\left(\mathbf{V}_{H}\right) \xrightarrow{\sim} N(\mathbf{V}) / N(\mathbf{Y})
$$

induced by $\bar{\jmath}$. But $N\left(\overline{\mathbf{V}}_{H}\right) / N\left(\mathbf{V}_{H}\right)$ is canonically equivalent to $\Sigma N\left(\mathbf{V}_{H}\right)$; the conclusion then follows from Proposition 3.1.2.
3.2. From abstract to concrete. Given a poset V, write $\operatorname{Simpl}(\mathbf{V})$ for the abstract simplicial complex associated to $\mathbf{V}$ : the simplices of $\operatorname{Simpl}(\mathbf{V})$ are by definition the finite totally ordered subsets of $\mathbf{V}$.

Let $V$ be a finite-dimensional vector space over a [possibly skew] field $k$. Its Tits building $\mathbf{T}(V)$ is [canonically isomorphic to] the flag complex of $V$ : elements of $\mathbf{T}(V)$ are flags of proper subspaces of $V$ [12, §2]. It follows that $\mathbf{T}(V)=\operatorname{Simpl}(\mathbf{V})$, where $\mathbf{V}$ is the poset of proper subspaces of $V$. Thus $\mathbf{T}(V)=\emptyset$ if $\operatorname{dim} V \leq 1$; we now assume $\operatorname{dim} V \geq 2$.

The poset $\overline{\mathbf{V}}$ may be identified with the poset of nonzero subspaces of $V$; thus suprema exist in $\overline{\mathbf{V}}$. Choosing a line $L \subset V$ we thus get from Corollary 3.1.3 Quillen's decomposition

$$
\mathbf{T}(V) \sim \bigvee_{H \in \mathbf{H}} \Sigma \mathbf{T}(H)
$$

where $\mathbf{H}$ is the set of hyperplanes in $V$ which do not contain $L$. It follows inductively that $\mathbf{T}(V)$ has the homotopy type of a bouquet of ( $n-2$ )-spheres.
3.2.1. Remark. This proof, in the spirit of Quillen's, uses the vertices of the Tits building, unlike Solomon's original proof which uses its maximal simplices (chambers, see [3, Ch. IV, §6]). It can be generalised to the symplectic group $S p_{2 n}$ or to the odd special orthogonal group $S O_{2 n+1}$, since their Tits buildings are isomorphic to the flag complex of nonzero totally isotropic subspaces [2, p. 53, ex. 20 d )] or $[3, \mathrm{Ch}$. $\mathrm{V}, \S \S 6,7]$ ). In these cases we may even dispense of $\overline{\mathbf{V}}$ in Proposition 3.1.2, since $\mathbf{V}$ already has suprema.

On the other hand, it does not apply directly to the even special orthogonal group $S O_{2 n}$, since its Tits building is given by "oriflamme geometry" (ibid.) Nevertheless, the set of vertices still has a natural structure of category in this case, with morphisms given by incidence
relations. It would be interesting to see if one can find a uniform vertextheoretic proof of the Solomon-Tits theorem for the Tits building of a general reductive group.

## 4. The rank spectral sequence

4.1. $K$-theory of schemes. The first example of application of Theorem 2.4.1 is to Quillen's $Q$-construction $\mathcal{Q}(X)$ on the exact category of locally free sheaves of finite rank over a scheme $X$. Let $\mathcal{Q}_{n}=\mathcal{Q}_{n}(X)$ be the full subcategory of $\mathcal{Q}(X)$ consisting of locally free sheaves of rank $\leq n$. Then the assumptions of Theorem 2.4.1 are satisfied because, in $\mathcal{Q}(X)$, there are no morphisms from a locally free sheaf of rank $n$ to a locally free sheaf of rank $<n$. The resulting spectral sequence may be called the rank spectral sequence (for the homology of $\mathcal{Q}(X)$ ).

Note that $\mathcal{Q}_{n}-\mathcal{Q}_{n-1}$ is a groupoid, hence we get

$$
\begin{equation*}
E_{p, q}^{1}=\bigoplus_{E_{\alpha}} H_{p+q-1}\left(\operatorname{Aut}\left(E_{\alpha}\right), \tilde{\mathbf{F}}_{p}\right) \tag{4.1}
\end{equation*}
$$

where $E_{\alpha}$ runs through the set of isomorphism classes of locally free sheaves of rank $p$. We took coefficients $\mathbf{Z}$, for simplicity.
4.2. $K^{\prime}$-theory of integral schemes. Let $X$ be an integral scheme, with function field $K$. If $\eta=\operatorname{Spec} K$ is the generic point of $X$, we have the inclusion $j=\eta \rightarrow X$. If $E$ is a sheaf of $\mathcal{O}_{X}$-modules, we write $E_{K}$ for $j^{*} E$.
4.2.1. Definition. a) A coherent sheaf $E$ on $X$ is torsion-free if the map $E \rightarrow j_{*} E_{K}$ is a monomorphism.
b) A subsheaf $E^{\prime}$ of a coherent sheaf $E$ is pure if $E / E^{\prime}$ is torsion-free.
4.2.2. Inside the exact category of coherent sheaves, the full subcategory of torsion-free sheaves is closed under extensions and subobjects. A monomorphism $E^{\prime} \rightarrow E$ between torsion-free sheaves is admissible (within the exact category of torsion-free sheaves) if and only if $E^{\prime}$ is pure in $E$.
4.2.3. Lemma. Let $\mathcal{Q}^{\text {coh }}(X)$ be Quillen's $Q$-construction on the category of coherent sheaves of $\mathcal{O}_{X}$-Modules, and let $\mathcal{Q}^{\operatorname{tf}}(X)$ be the full subcategory of torsion-free sheaves. Then the inclusion $\mathcal{Q}^{\text {tf }}(X) \rightarrow \mathcal{Q}^{\text {coh }}(X)$ is a weak equivalence.

Proof. The conditions of the resolution theorem [11, Th. 3] are verified since any locally free sheaf is torsion-free.
4.2.4. Proposition. Let $E$ be a (coherent) torsion-free sheaf on $X$, with generic fibre $E_{K}$. Then the map

$$
F \mapsto F_{K}
$$

defines a bijection from the set $G r(E)$ of pure subsheaves of $E$ to the set $\operatorname{Gr}\left(E_{K}\right)$ of subvector spaces of $E_{K}$.

Proof. Let $V$ be a sub-vector space of $j^{*} E=E_{K}$. Define

$$
E \cap V=E \times_{j_{*} *^{*} E} j_{*} V
$$

Then $E \cap V \in G r(E)$, because the map $E /(E \cap V) \rightarrow j_{*} j^{*}(E /(E \cap V))$ is a monomorphism (by definition of $E \cap V$ ). So we have two maps:

$$
j^{*}: G r(E) \rightarrow G r\left(E_{K}\right) ; \quad E \cap-: G r\left(E_{K}\right) \rightarrow G r(E)
$$

We have
$(E \cap V)_{K}=j^{*}\left(E \times_{j_{*} j^{*} E} j_{*} V\right)=j^{*} E \times_{j^{*} j_{*} j^{*} E} j^{*} j_{*} V=j^{*} E \times_{j^{*} E} V=V$
so that $j^{*} \circ(E \cap-)=I d$. On the other hand, if $F$ is a pure subsheaf of $E$, then $F \subseteq E \cap j^{*} F$, and $j^{*} E=j^{*}\left(E \cap j^{*} F\right)$, hence (by exactness of $\left.j^{*}\right), j^{*}\left(E \cap j^{*} F / F\right)=0$. Thus $\left(E \cap j^{*} F\right) / F$ is a torsion subsheaf of the torsion-free sheaf $E / F$, hence is 0 , and our two maps are inverse to each other.
4.2.5. We write $\mathcal{Q}_{n}^{\mathrm{tf}}(X)$ for the full subcategory of $\mathcal{Q}^{\text {tf }}(X)$ of torsionfree sheaves $E$ such that $\operatorname{dim}_{K} E_{K} \leq n$. We get another rank spectral sequence

$$
\begin{equation*}
E_{p, q}^{1}=\bigoplus_{E_{\alpha}} H_{p+q-1}\left(\operatorname{Aut}\left(E_{\alpha}\right), \tilde{\mathbf{F}}_{p}\right) \Rightarrow H_{p+q}\left(\mathcal{Q}^{\mathrm{coh}}(X)\right) \tag{4.2}
\end{equation*}
$$

cf. Lemma 4.2.3.
4.2.6. Corollary. Let $E \in \mathcal{Q}_{n}^{\mathrm{tf}}(X)$, with generic fibre $E_{K} \in \mathcal{Q}_{n}(K)$. Then the functor

$$
j^{*}: \mathcal{Q}_{n-1}^{\mathrm{tf}}(X) \downarrow E \rightarrow \mathcal{Q}_{n-1}(K) \downarrow E_{K}
$$

is an isomorphism of categories.
Proof. These categories are those of proper admissible subsheaves of $E$ and $j^{*} E$, with morphisms the inclusions (thanks to the definition of morphisms in $\mathcal{Q}^{\text {tf }}(X)$ and $\left.\mathcal{Q}(K)\right)$. Thus they are posets, and the result directly follows from Proposition 4.2.4.
4.2.7. Example. Let $X$ be an integral Dedekind scheme (= noetherian, regular of Krull dimension $\leq 1$ ), with function field $K$. As is wellknown, a coherent sheaf $F$ over a Dedekind scheme is torsion-free if and only if it is locally free. (Being locally free is checked locally; a
module of finite type over a discrete valuation ring is free if and only if it is torsion-free.) Thus the above generalises the remark of $[12, \mathrm{pp}$. 191-192].

### 4.3. The Tits building.

4.3.1. In Corollary 4.2.6, suppose $n \geq 2$. By [12, Prop. p. 188], the classifying space of the poset $\mathcal{Q}_{n-1}(K) \downarrow E_{K}=J\left(E_{K}\right)$ is $G L\left(E_{K}\right)$ weakly equivalent to the suspension of nerve of the Tits building of $E_{K}$, which in turn is weakly equivalent to a wedge of $(n-2)$-spheres by the Solomon-Tits theorem ([12, Th. 2 p. 180], see §3.2). Hence $\left(N_{n}\right)_{\mid E}$ is $\operatorname{Aut}(E)$-weakly equivalent to a wedge of $(n-1)$-spheres.
4.3.2. In Corollary 4.2 .6 , suppose $n=1$. Then $\mathcal{Q}_{n-1}(K) \downarrow E_{K}$ has one element: $\{0\}$. Hence the conclusion of 4.3 .1 is still true.
4.3.3. Theorem. If $X$ is an integral scheme, then the $E^{1}$-terms of the rank spectral sequence (4.2) (with $\mathbf{Z}$-coefficients) are

$$
E_{p, q}^{1}=\bigoplus_{E_{\alpha}} H_{q}\left(\operatorname{Aut}\left(E_{\alpha}\right), \operatorname{st}\left(E_{\alpha}\right)\right)
$$

where $E_{\alpha}$ runs through the isomorphism classes of locally free sheaves of rank $p$, and $\operatorname{st}\left(E_{\alpha}\right)=\pi_{p-1}\left(\left(\mathbf{F}_{p}\right)_{\mid E_{\alpha}}\right)$ is the Steinberg module of $j^{*} E_{\alpha}$.
Proof. This follows from Corollary 4.2.6, 4.3.1, 4.3.2 and Lemma 1.3.5.
4.3.4. Remark. By an argument of Vogel, the exact sequences from Theorem 2.3.6 then coincide with those of Quillen in [12, Th. 3 p. 181]. In general, consider a map $f: E \rightarrow B$ whose homotopy fibre $F$ has the homotopy type of a bouquet of $n$-spheres, with $n>0$. So the Leray-Serre spectral sequence yields a long exact sequence

$$
\begin{equation*}
\cdots \rightarrow H_{p}(E) \rightarrow H_{p}(B) \rightarrow H_{p-n-1}\left(B, H_{n}(F)\right) \rightarrow H_{p-1}(E) \rightarrow \ldots \tag{4.3}
\end{equation*}
$$

If $C$ is the homotopy cofibre of $f$, we have another long exact sequence

$$
\begin{equation*}
\cdots \rightarrow H_{p}(E) \rightarrow H_{p}(B) \rightarrow \tilde{H}_{p}(C) \rightarrow H_{p-1}(E) \rightarrow \ldots \tag{4.4}
\end{equation*}
$$

and we want to know that the two sequences coincide.
Here is Vogel's argument. We may assume that $f$ is a Serre fibtration. Let $E^{\prime}$ be its mapping cylinder and $C F$ the cone over $F$, so that we have a fibration of pairs


Since $H_{q}(C F, F)=\left\{\begin{array}{ll}H_{n}(F) & \text { for } q=n+1 \\ 0 & \text { else }\end{array}\right.$, the Leray-Serre spectral sequence for the pair

$$
H_{p}\left(B, H_{q}(C F, F)\right) \Rightarrow H_{p+q}\left(E^{\prime}, E\right)
$$

yields isomorphisms
$\tilde{H}_{p}(C) \simeq H_{p}\left(E^{\prime}, E\right) \simeq H_{p-n-1}\left(B, H_{n+1}(C F, F)\right) \simeq H_{p-n-1}\left(B, H_{n}(F)\right)$
which commute with the differentials of (4.3) and (4.4) by functoriality.
