23 Abstract

Objective: Inter-cellular adhesion molecule 1 (ICAM-1), vascular cell adhesion 24 25 molecule 1 (VCAM-1) and tumor necrosis factor alpha (TNF-a), are implicated in atherogenesis. Additionally, several types of oil as part of different types of diet are 26 associated with the initiation of atherosclerosis and consequently with the risk of 27 28 cardiovascular disease. However, the exact role of oil consumption on vascular 29 inflammation remains unknown. In the present parallel study, we assessed the acute 30 effects of extra virgin olive oil, soy oil, corn oil and cod liver oil on circulating 31 soluble (s) forms of adhesion molecules and TNF-a.

Methods: Sixty seven healthy volunteers were randomized to receive 50 ml of oil.
Soluble forms of VCAM-1, ICAM-1 and TNF-a were measured by enzyme-linked
immunosorbent assay (ELISA) at baseline and 3 hours post oil consumption.

Results: All types of oil had no significant effect on sVCAM-1 levels (p=NS for all). On the contrary, all oil types decreased ICAM-1 levels (p<0.01). Olive oil (p<0.05), soy oil and cod liver oil (p<0.01 for both) reduced TNF-a levels significantly, in contrast to corn oil, which induced a non-significant decrease (p=NS). Moreover, there was a significant correlation between the absolute change in ICAM-1 and TNF-a levels (rho=0.379, p<0.05), but not between the absolute changes in VCAM-1 and TNF-a levels (rho=0.019, p=NS).

42 Conclusions: Acute consumption of all types of oil decreased significantly ICAM-1
43 levels. In addition, olive oil, soy oil and cod liver oil decreased significantly TNF-a
44 levels. Moreover, the absolute change in TNF-a levels was correlated with the

45	absolute change in ICAM-1 levels. These findings indicate that acute consumption of
46	specific types of oil is associated with specific significant anti-inflammatory effects.

64 Introduction

Evidence suggests that inflammatory process contributes to the development of atherosclerosis (Libby *et al.*, 2009). The role of several inflammatory biomarkers, such as acute phase proteins, proinflammatory cytokines and adhesion molecules, is nowadays under investigation as regards the relation with cardiovascular disease (Biasucci *et al.*, 2004).

70 Tumor necrosis factor alpha (TNF-a) is known to be released by macrophages, 71 as well as vascular endothelial and smooth muscle cells, promoting the expression of 72 cell adhesion molecules (CAMs) and the migration of leukocytes into and through the 73 vascular wall (Klein *et al.*, 1995). Migration to the arterial wall, rolling and tethering 74 of leukocytes to the endothelium (adhesion) play a crucial role in atherogenesis. 75 Adhesion is a complex process depending on interactions between molecules such as 76 the vascular adhesion molecule-1 (VCAM-1) and the intercellular molecule-1 (ICAM-77 1) on the endothelium and the integrins on neutrofils (Meydani, 2003). Interestingly, 78 studies have shown that despite the similar structure and function of VCAM-1 and 79 ICAM-1, these two molecules may participate at different stages of atherogenesis 80 (Blann et al., 2000).

Recently, it is widely reported that dietary habits may modify cardiovascular disease rates in diverse populations. Adhesion molecules and proinflammatory cytokines are implicated as important mediating pathways for cardiovascular diseases, activated though different intakes of food groups, such as alcohol (Bau *et al.*, 2007), as well as obesity (Forsythe *et al.*, 2008). Accordingly, despite the fact that it is not easy to specify substances with anti-atherosclerotic properties comprising diets, studies have shown that components such as olive oil or n-3 fatty acids may play a key role in cardiovascular protection, by especially inhibiting inflammatory process
(Perez-Martinez *et al.*, 2010; Massaro *et al.*, 2008). However, the impact of acute
consumption of different types of oil on proinflammatory cytokines and adhesion
molecules remains unknown.

Thus, the aim of the present study was to examine the acute effects of extra
virgin olive oil, soy oil, corn oil and cod-liver oil on circulating levels of sVCAM-1,
sICAM-1 and TNF-a in young, healthy individuals.

96 Materials and methods

97 Study population and protocol

A total number of 66 healthy young subjects were recruited randomly for this 98 parallel study according to their age, gender and body mass index (BMI). Exclusion 99 100 criteria were the presence of clinical evidence for atherosclerotic peripheral vascular 101 disease or coronary atherosclerosis, the presence of any acute or chronic inflammatory 102 disease (eg. liver disease). Subjects with any classic risk factor for atherosclerosis 103 such as smoking, as well as those receiving any systemic medication, were also 104 excluded from the study. Apart from the questionnaire given asking clinical and 105 medical variables, anthropometric and blood pressure assessments were made.

All the participants were randomly allocated into 4 groups to receive 4 different types of oil, in order to receive an equivalent amount of 50 ml (and almost equal kilocalories) (Tousoulis *et al.*, 2010 and Vogel *et al.*, 2000). Each type of oil had a known macronutrients composition commercially available. Thus, the composition (provided by the manufacturer) per 100ml of each type of oil was: extra 111 virgin olive oil (824 kcal or 3449.9 kJ, 91.6gr fatty acids, 12.8gr saturated, 70.5gr 112 monounsaturated, 8.3gr polyunsaturated), corn oil (825 kcal or 3454.1 kJ, 92gr fatty acids, 12gr saturated, 25gr monounsaturated, 55gr polyunsaturated), soy oil (825 kcal 113 114 or 3454.1 kJ, 92gr fatty acids, 14gr saturated, 23gr monounsaturated, 55gr polyunsaturated) and cod liver oil (830 kcal or 3475.0 kJ, 92gr cod oil, 0.00828gr 115 116 eicosapentaenoic acid, 0.00736gr docosahexaenoic acid, 46gr monounsaturated fatty 117 acids, 30gr polyunsaturated fatty acids, 0.0112gr vitamin A, 0.0001gr vitamin D, 118 0.068gr vitamin E). It is worth to mention that extra virgin olive oil was administered, 119 as minor components (eg. β -carotene, a-tocopherol, β -sitosterol, tyrosol, oleuropein, 120 hydroxytyrosol) of virgin olive oil are thought to be responsible for much of its 121 beneficial effects. Oils were administered directly from their commercial form (liquid) 122 and not as part of a meal. Measurements were performed at baseline (0 hours) and 3 123 hours post oil consumption. None of the participants followed any specific 124 recommendation regarding diet or physical activity prior to the study. All subjects 125 participated normally to all their daily activities without modifications. Briefly, all 126 measurements were performed in the morning in a dark quiet room under controlled 127 temperature (22-24°C) and after patients were at a rest for at least 10 minutes. All 128 subjects abstained from food, tobacco, alcohol and caffeine-containing drinks or 129 antioxidant supplements such as juices for at least 8 hours before oil ingestion 130 (baseline measurement). In addition all subjects abstained from the aforementioned 131 parameters during the 3 hours (before the second measurement) post oil consumption. 132 The study protocol was approved by the Institutional Ethics Committee and written 133 informed consent was obtained from all subjects. In addition, the study was carried 134 out in accordance with the Declaration of Helsinki II and European Union guidelines 135 for good clinical practice.

137 *Laboratory measurements*

Venous blood samples were obtained at the beginning of each protocol and at 138 139 3 hours post intervention. Routine chemical methods were used to determine serum 140 concentrations of total cholesterol, triglycerides, high density lipoprotein and lowdensity lipoprotein cholesterol. After centrifugation at 1150g at 4° C for 10 minutes, 141 serum was collected and stored at -80° C until assayed. Quantitative sandwich 142 enzyme immunoassay technique was used to determine serum sVCAM-1 (ng/mL) 143 (Quantikine human sVCAM-1 ELISA kit, R&D Systems), sICAM-1 (ng/mL) 144 145 (Quantikine human sICAM-1/CD54 ELISA kit, R&D Systems), as well as TNF-a levels (pg/ml) (Quantikine HS, human TNF-a/TNFSF1A ELISA kit, R&D systems). 146

148 Statistical analysis

149 All variables were tested for normal distribution by Kolmogorov–Smirnov 150 test. Normally distributed variables are presented as mean values with standard errors 151 (mean±SD), whereas not normally distributed data are presented as median (25–75th 152 percentiles values). Correlations were assessed by Spearman's correlation coefficient 153 (rho) due to not normally distributed data. Between groups comparisons were performed by X^2 test for categorical variables or one-way ANOVA, followed by 154 Bonferoni post hoc correction for multiple comparisons of normally distributed 155 156 continuous variables or by Kruskal-Wallis followed by Dunn's post test for not 157 normally distributed variables. Moreover, the effect of oil consumption on each 158 variable was examined by performing paired t-test or Wilcoxon signed-rank test as 159 appropriate. Our study was powered based on the data regarding to sICAM-1: pilot

data suggested that the difference in the response of matched pairs is normally distributed with standard deviation 13.0. If the true difference in the mean response of matched pairs is 66.77, we would need to study 4 pairs of subjects to be able to reject the null hypothesis that this response difference is zero with probability (power) 0.99. The Type I error probability associated with this test of this null hypothesis was 0.01. All analyses were carried out by using the SPSS v18.0 (SPSS, Chicago, IL) statistical package.

169 **Results**

The demographic characteristics and lipid profile of the participants are presentedin Table 1. There were no significant differences between the four groups at baseline.

173 Effect of oil consumption on sVCAM-1 and sICAM-1

Acute consumption of olive oil, soy oil, cod liver oil as well as corn oil had no
 significant effect on sVCAM-1 levels (p=NS for all) (Figure 1).

176 Interestingly, cod liver oil (p<0.01), olive oil (p<0.01), as well as soy oil 177 (p<0.01) decreased sICAM-1 levels significantly. Controversially to the 178 neutral/slightly negative effect of corn oil on sVCAM-1, the latter had also a 179 significant effect on sICAM-1 levels (p<0.01) (Figure 2).

181 Effect of oil consumption on TNF-a

Extra virgin olive (p<0.05), soy oil (p<0.01) and cod liver oil intakes (p<0.01) reduced significantly TNF-a levels, whereas corn oil induced a non-significant decrease in TNF-a levels (p=NS) (Figure 3). Interestingly, the absolute change in TNF-a levels (39 pairs) was significantly correlated with the absolute change in ICAM-1 levels (66 pairs) after oil consumption (rho=0.379, p<0.05) (Figure 4a). However, there was no significant correlation between absolute changes in TNF-a levels and VCAM-1 levels (59 pairs) (rho=0.019, p=NS) (Figure 4b).

192 **Discussion**

193 In the present study we assessed the acute effect of extra virgin olive oil, soy 194 oil, corn oil and cod liver oil consumption on adhesion molecules and 195 proinflammatory cytokines in healthy individuals. We found that all types of oil 196 induced a significant reduction in ICAM-1 levels. In addition, extra virgin olive oil, 197 soy oil and cod liver oil reduced also TNF-a levels. Moreover, we observed a 198 significant correlation between the absolute change of TNF-a and ICAM-1 levels. 199 These findings indicate that specific types of oil exert significant anti-inflammatory 200 effects by affecting proinflammatory cytokines and specific adhesion molecules.

202 *Effect of oil acute consumption on adhesion molecules*

It is a fact that adhesion molecules participate in the development of atherosclerosis. In addition, it has been shown that dietary habits or modifications may prevent atherogenesis by affecting inflammatory molecules such as VCAM-1 and ICAM-1.

207 Mena et al (Mena *et al.*, 2009) while assessing the relationship between 208 Mediterranean diet (supplemented with virgin olive oil) and adhesion molecules, 209 showed a significant inverse correlation of this dietary pattern with ICAM-1 and 210 VCAM serum levels. Interestingly, in the PREDIMED study (Salas-Salvadó et al., 211 2008) among middle aged individuals at high cardiovascular risk, the highest 212 consumption of nuts and virgin olive oil was associated with the lowest 213 concentrations of VCAM-1, ICAM-1, albeit only for ICAM-1 was this difference 214 statistically significant in the case of nuts and for VCAM-1 in the case of virgin olive 215 oil. The results were not in the same direction when analyzing n-3 fatty acids; in a 216 prospective, randomized, double-blind study enrolling patients with myocardial 217 infarction to receive highly concentrated n-3 polyunsaturated fatty acids (PUFAs) or 218 corn oil, inflammatory markers, such as E-selectin and ICAM-1 were unaffected 1 219 year later (Grundt et al., 2004). Importantly, Fuentes et al (Fuentes et al., 2008) 220 showed that different types of fat composition meals affected differentially (in 4 221 hours) VCAM-1 levels in healthy men, as monounsaturated fatty acids appeared to be 222 more beneficial than a-linoleic by reducing VCAM-1 levels. Data seem more 223 conflicting, when referring to healthy adults. Studies such as this by Eschen et al 224 (Eschen et al., 2004) have shown a dose dependent effect as it was observed a 225 significant decrease in ICAM-1 in the PUFA 2.0gr group and a significant increase in 226 VCAM-1 in the PUFA 6.6gr group. However, other studies conducted in young 227 healthy subjects, showed that diets rich in lean fish significantly decreased ICAM-1 228 levels, but had had no effect on VCAM-1 levels (Paulo et al., 2008).

In the present study we have shown that VCAM-1 levels are unaffected after ingestion of all types of oil, a finding which is in line with our previous observation in a smaller cohort (Tousoulis *et al.*, 2010). Importantly, we have demonstrated a significant non specific acute effect of olive, soy, corn and cod liver oil on circulating levels of sICAM-1. It is likely that a common ingredient in all types of oil may
modify the cleavage rate of sICAM-1 on cell membranes leading to rapid changes of
its circulating levels.

237 Effect of oil acute consumption on TNF-a

Tumor necrosis factor alpha has a crucial role in the inflammatory process implicated in atherogenesis. Thus, dietary modification targeting TNF-a could be beneficial in preventing atherosclerosis, as suggested by studies focusing on olive oil, soy oil and polyunsaturated lipids.

242 Consumption of olive oil as a single component reduced significantly not only 243 VCAM-1, but also TNF- α serum levels in coronary venous blood, as reported by 244 Serrano-Martinez et al (Serrano-Martinez et al., 2005). In addition, not only extra 245 virgin olive oil, but also refined olive oil has been found to downregulate TNF-a 246 (Marquez-Martin et al., 2006). Moreover, dietary intervention with n-3 PUFA and 247 plant sterols reduced systemic inflammation in hyperlipidemic individuals, reflected 248 in a decrease of TNF-a levels by 10% (Micallef et al., 2009). Interesting results have 249 been reported by studies of soy consumption. Thus, TNF-a levels were significantly 250 lower in the soy nut group compared to the soy protein and control groups as this was 251 demonstrated by Azadbakht et al (Azadbakht et al., 2008) implying a role in the soya 252 lipid fraction. In contrast to these findings, Jenkins et al (Jenkins et al., 2002) showed 253 that there was no significant effect on interleukin-6 or TNF-a in middle aged men and 254 women on the high-isoflavone versus the low-isoflavone soy food diet.

In the present study we have shown that acute consumption of extra virgin olive oil, soy oil and cod liver oil reduced significantly TNF-a levels, while corn oil induced a non significant decrease in TNF-a levels. It is likely that the different types 258 of oils may exert different intracellular "antioxidant" effects, which are then reflected 259 to a variable activation of intracellular redox sensitive pathways (such as nuclear 260 factor-kB and activator protein-1). This different effect on intracellular redox 261 signaling could perfectly explain the differences in the circulating levels of soluble 262 adhesion molecules, which represent a marker of the expression of these molecules on 263 the cellular surface, a process regulated by these redox-sensitive transcriptional 264 pathways. We have also found a significant association between the absolute changes 265 (d) in TNF-a levels and ICAM-1 levels. These findings indicate that the expression of 266 the proinflammatory cytokine TNF-a which was modified by oil consumption may 267 regulate the subsequent expression of ICAM-1. Therefore, a potential pathway linking 268 these molecules may be affected by the anti-inflammatory effects of specific oils. 269 Although our findings point-out a significant role for oil acute consumption in 270 inflammatory markers, it is difficult to extrapolate our results to clinical practice, as 271 our study was mainly a pathophysiological study designed to assess the potential 272 pathways mediating the effect of different oil acute consumption on inflammatory 273 process.

In conclusion, acute consumption of all types of oil decreased significantly ICAM-1 levels. In addition, olive oil, soy oil and cod liver oil decreased significantly TNF-a levels. Moreover, the degree of change in TNF-a levels was correlated with the degree of change in ICAM-1 levels, indicating that the expression of the proinflammatory cytokine TNF-a after oil consumption, may regulate the subsequent expression of ICAM-1 level. These findings suggest that soy oil, cod liver oil and virgin olive oil exert specific significant anti-inflammatory effects.
