# Decompositions of displacements of thin structures

**Abstract.** In this study we present first the main theorem of the unfolding method in linearized elasticity. Then we prove that every displacement of a thin structure (curved rod or shell) is the sum of an elementary displacement and a warping. Thanks to the previous theorem we obtain sharp estimates of the displacements of this decomposition.

**Résumé.** Dans cette étude on présente d’abord le théorème fondamental de la méthode de l’éclatement en élasticité linéaire. On montre ensuite que tout déplacement d’une structure mince (poutre courbe ou coque) se décompose en la somme d’un déplacement élémentaire et d’un gauchissement. Grâce au théorème fondamental on obtient les estimations des déplacements de cette décomposition.

**KEY WORDS:** linear elasticity, beams, curved rods, plates, shells, junctions, unfolding method.

## I. Introduction

Two mathematical methods have been developed to study thin structures. The first one is the formal asymptotic method in which we determine the first term of the asymptotic expansion and then justify the result by an error estimate (see books by J. Sanchez-Hubert and E. Sanchez-Palencia [22] (rods) and Ph. Destuynder [6] (plates)). The second one is the more recent variational asymptotic method in which, for the first time, linearized elasticity of rods, plates or shells has been studied without any geometrical or mechanical a priori hypotheses. This method is presented in works by L. Trabucho and J. M. Viano [24] (rods) and P.G. Ciarlet [4,5] (plates and shells). Our paper is dedicated to a new method in elasticity : the unfolding method in linearized elasticity. The unfolding method offers new tools to study the asymptotic behavior (see [10,11,14,15]) and the homogenization (see [12]) of structures formed by a large numbers of rods, plates or shells. These tools consist essentially in new decompositions of the displacements of a thin structure and in estimates of the elements of these decompositions. These decompositions make it quite easy to obtain the Korn inequality in a thin domain as well as the asymptotic behavior of the strain tensor of a sequence of displacements. The limits are expressed in terms of formal displacements of the reference structure (see [10,11,12, 13, 14,15]).

Our paper is organised into three parts. Section II is dedicated to Theorem 1.3. This theorem is the main result of the unfolding method in linearized elasticity (see [10,11,13]). It is a generalization of Lemma 3.1 in [10]. We choose a domain  $\mathcal{O}$  in  $\mathbb{R}^n$  included in a ball of radius less than  $R$  and star-shaped with respect to a ball of radius  $R_1$ . Theorem 1.3 gives estimates of the distances for different norms between an element belonging to  $W^{1,p}(\mathcal{O}; \mathbb{R}^n)$ ,  $1 < p < \infty$ , and the space of rigid body displacements. The constants appearing in these estimates depend on  $n$ ,  $p$  and on the two parameters  $R$  and  $R_1$  which characterize the geometry of the open set. To do so, we prove that a displacement  $u$  in  $W^{1,p}(\mathcal{O}; \mathbb{R}^n)$  is written  $u = v + w$  where  $v$  is defined thanks to Newtonian potentials and where  $w$  is a harmonic displacement. A rigid displacement  $r$  which approximates  $u$  is obtained with the mean value of  $u$  and the mean value of the skew-symmetric part of  $\nabla w$ . The estimates of  $u - r$  are due to the Poincaré-Wirtinger inequality for functions belonging

to  $W_{loc}^{1,p}(\mathcal{O})$  (Proposition 1.2). In fact in Theorem 1.3 we give an upper bound of the distance between the gradient of  $u$  and the space of the skew-symmetric matrices with the help of the strain tensor norm of  $u$ . This theorem can be compared with a result obtained by G. Friesecke, R. D. James and S. Müller which stands out in nonlinear elasticity. In [9] these authors have proved that the distance between the gradient of a function  $\phi \in H^1(\mathcal{O}; \mathbb{R}^n)$  and  $SO(n)$  is estimated by the  $L^2$  norm of  $dist(\nabla\phi, SO(n))$  and a constant which depends only of the open set  $\mathcal{O}$ .

The Korn inequality in an open bounded set star-shaped with respect to a ball is an immediate consequence of Theorem 1.3. We also deduce from this theorem Korn's inequality in an open bounded set with Lipschitzian boundary.

Several proofs (see [5,7,20]) of Korn's inequality refer to a lemma of J.-L. Lions [7,20], yet this lemma does not give the dependence of the constant in this inequality with respect to the open set. New proofs of this inequality for displacements in  $H^1(\mathcal{O}; \mathbb{R}^n)$  are given in [2,10,17]. In these articles we explicitly find the dependence of the constant in Korn's inequality with respect to the open set  $\mathcal{O}$ . We also find in [19] a proof of Korn's inequality for displacements belonging to  $W^{1,p}(\Omega; \mathbb{R}^n)$  where  $\Omega$  is an open bounded set with Lipschitzian boundary. But in this paper the authors do not give the dependence of the constant with respect to the open set.

Section III is dedicated to the decompositions of the displacements of a curved rod. The curved rod has a length of  $L$  and a thickness of order  $\delta$ . We define the class of elementary displacements of the curved rod (Definition 2). These displacements are the generalization of the Bernoulli-Navier displacements (see [10]). Then, to any displacement  $u$  of the curved rod we associate an elementary displacement  $U_e$  and a warping  $\bar{u}$ ,  $u = U_e + \bar{u}$  (Definition 3). Theorem 2.1 gives sharp estimates with respect to  $\delta$  and the strain energy of  $u$  for this kind of displacements. In order to study structures made of rods we give, Lemma 2.2, an extension of  $u$  at each of its extremities and, Proposition 2.3, a second decomposition of  $u$  in the sum of an elementary displacement and a residual one such that this new elementary displacement is equal to a rigid body displacement in a neighborhood of the extremities of the curved rod (see also [18]). Of course all results of this section are true for straight rods.

Section IV is dedicated to the decompositions of the displacements of a shell. The shell has a thickness of  $2\delta$ . As in the previous section we define the class of elementary displacements of the shell (Definition 6). These displacements are the generalization of the Kirchhoff-Love displacements (see [11]). Then, to any displacement  $u$  of a shell we associate an elementary displacement  $U_e$  and a warping  $\bar{u}$ ,  $u = U_e + \bar{u}$  (Definition 7). Theorem 3.1 gives sharp estimates with respect to  $\delta$  and the strain energy of  $u$  for this kind of displacements. Our first decomposition of a displacement is the simplest and the most natural. In this decomposition the normal component of the rotation is null. In order to obtain the Korn inequality more easily and to study structures made of several plates or shells we introduce a new decomposition of displacement  $u$  into the sum of an elementary displacement and a residual one. In this decomposition the normal component of the rotation vector will not be null any longer (Definition 8) and the estimates of this new decomposition (Theorem 3.3) are simpler than those of Theorem 3.1. To do so we must give, Lemma 3.2, an extension of  $u$  in a neighborhood of thickness  $2\delta$  of the lateral boundary of the shell. Of course all results of this section are true for plates.

The last section is dedicated to two geometrical lemmas and to the proof of Lemma 3.2.

As a rule, the Greek indices  $\alpha$  and  $\beta$  take values in  $\{1, 2\}$  and the Latin indices  $i, j, k, l$  and  $q$  take values in  $\{1, \dots, n\}$ .

## II. The fundamental theorem of the unfolding method in linerized elasticity

## 1. Poincaré-Wirtinger's inequality in an open bounded set star-shaped with respect to a ball

In this section  $\mathcal{O}$  denotes an open bounded subset of  $\mathbb{R}^n$  included in a ball of radius  $R$  and star-shaped with respect to the ball  $B(O; R_1)$ . The following lemma and proposition are the generalizations of the Lemma 2.6 and Proposition 2.5 in [10].

For any  $1 \leq p \leq \infty$  and any bounded open set  $\Omega$  de  $\mathbb{R}^n$  we denote

$$W_\rho^{1,p}(\Omega) = \left\{ \phi \in L^p(\Omega) \mid \rho \nabla \phi \in [L^p(\Omega)]^n \right\}$$

where  $\rho(x)$  is the distance between  $x$  and the boundary of  $\Omega$ .

**Lemma 1.1 .** *For any  $\phi$  belonging to  $W_\rho^{1,p}(\mathcal{O})$ ,  $1 \leq p < \infty$ , we have*

$$(1.1) \quad \|\phi\|_{L^p(\mathcal{O})}^p \leq 2^{n+3p} p^p \left\{ \frac{R}{R_1} \right\}^{n+p-1} \left\{ \|\phi\|_{L^p(B(O; R_1))}^p + \|\rho \nabla \phi\|_{[L^p(\mathcal{O})]^n}^p \right\}$$

**Proof .** Let  $\theta$  be a mapping belonging to  $\mathcal{C}^\infty(\mathbb{R}^+; [0, 1])$  and such that

$$\theta(t) = 0 \text{ if } 0 \leq t \leq \frac{R_1}{2} \quad \theta(t) = 1 \text{ if } R_1 \leq t \quad |\theta'(t)| \leq \frac{4}{R_1} \quad \forall t \in \mathbb{R}^+.$$

We recall that for any  $\psi \in W^{1,p}(0, a)$ ,  $a > 0$ , such that  $\psi(0) = 0$ , we have the Hardy's inequality

$$\int_0^a |\psi(x)|^p dx \leq p^p \int_0^a (a-x)^p |\psi'(x)|^p dx$$

Let  $\phi$  be in  $\mathcal{C}^\infty(\overline{\mathcal{O}})$ . We consider the segment joining the origin  $O$  to an arbitrary point  $P$  belonging to the boundary of  $\mathcal{O}$ . We apply the Hardy inequality to the restriction  $\theta(r)\phi(x)$  on this segment. We obtain

$$(1.2) \quad \int_0^{\|P\|_2} |\theta(r)\phi(x)|^p dr \leq p^p \int_0^{\|P\|_2} |r - \|P\|_2|^p \left| \frac{\partial(\theta\phi)}{\partial r} \right|^p dr$$

where  $r = \|x\|_2$  (euclidian norm of  $x$ ). The open set  $\mathcal{O}$  is star-shaped with respect to the ball  $B(O; R_1)$ . So we have

$$(1.3) \quad |r - \|P\|_2| = \|x - P\|_2 \leq \frac{R}{R_1} \rho(x) \quad \text{and} \quad |r - \|P\|_2| \leq R$$

From the inequalities (1.2) and (1.3) we deduce

$$(1.4) \quad \int_{R_1}^{\|P\|_2} |\phi(x)|^p dr \leq \frac{(2pR)^p}{R_1^p} \int_{\frac{R_1}{2}}^{\|P\|_2} |\rho(x)\nabla\phi(x)|^p dr + \frac{(8pR)^p}{R_1^p} \int_{\frac{R_1}{2}}^{R_1} |\phi(x)|^p dr$$

We multiply the above inequality by  $\left\{ \frac{R_1}{2} \right\}^{n-1}$ . Then, in the right hand side we replace this quantity by  $r^{n-1}$  and in the left hand side we replace it by  $\left( \frac{r}{R} \frac{R_1}{2} \right)^{n-1}$ . Finally we integrate on all rays (that is to say on the unit sphere of  $\mathbb{R}^n$ ) to obtain

$$\int_{\mathcal{O} \setminus B(O; R_1)} |\phi(x)|^p dx \leq 2^{n+3p-1} p^p \left\{ \frac{R}{R_1} \right\}^{n+p-1} \left\{ \|\rho \nabla \phi\|_{[L^p(\mathcal{O})]^n}^p + \|\phi\|_{L^p(B(O; R_1))}^p \right\}$$

To the above inequality we add  $\|\phi\|_{L^p(B(O;R_1))}^p$ . We have proved (1.1) for any function  $\phi$  belonging to  $C^\infty(\overline{\mathcal{O}})$ . The space  $C^\infty(\overline{\mathcal{O}})$  is dense in  $W^{1,p}(\mathcal{O})$  then we obtain (1.1) for any  $\phi \in W^{1,p}(\mathcal{O})$ .

Now we take  $\phi$  in  $W_\rho^{1,p}(\mathcal{O})$ . Let  $\mathcal{O}_\varepsilon$  be the range of  $\mathcal{O}$  in the homothety of center  $O$  and ratio  $1 - \varepsilon$ ,  $\varepsilon \in ]0, 1[$ . The restriction of  $\phi$  to  $\mathcal{O}_\varepsilon$  belongs to  $W^{1,p}(\mathcal{O}_\varepsilon)$ , hence

$$\|\phi\|_{L^p(\mathcal{O}_\varepsilon)}^p \leq 2^{n+3p} p^p \left\{ \frac{R}{R_1} \right\}^{n+p-1} \left\{ \|\rho_\varepsilon \nabla \phi\|_{[L^p(\mathcal{O}_\varepsilon)]^n}^p + \|\phi\|_{L^p(B(O;(1-\varepsilon)R_1))}^p \right\}$$

where  $\rho_\varepsilon(x)$  is the distance from  $x$  to the boundary of  $\mathcal{O}_\varepsilon$ . We have  $\rho_\varepsilon(x) \leq \rho(x)$ . Then (1.1) follows for any  $\phi \in W_\rho^{1,p}(\mathcal{O})$  by passing to limit as  $\varepsilon \rightarrow 0$  and thanks to the Beppo-Levi's Theorem.  $\square$

We denote  $\mathcal{M}_\Omega(\phi)$  the mean value of  $\phi$  in  $\Omega$ ,

$$\mathcal{M}_\Omega(\phi) = \frac{1}{|\Omega|} \int_\Omega \phi \quad \phi \in L^1(\Omega), \quad |\Omega| = \text{measure}(\Omega)$$

**Proposition 1.2 .** (Poincaré-Wirtinger's inequality.) For any function  $\phi$  belonging to  $W_\rho^{1,p}(\mathcal{O})$ ,  $1 \leq p < \infty$ , we have

$$(1.5) \quad \|\phi - \mathcal{M}_\mathcal{O}(\phi)\|_{L^p(\mathcal{O})} \leq p 2^{n+4+n/p} \left\{ \frac{R}{R_1} \right\}^{\frac{n+p-1}{p}} \|\rho \nabla \phi\|_{[L^p(\mathcal{O})]^n}$$

**Proof .** Let  $\phi$  be in  $W_\rho^{1,p}(\mathcal{O})$ . We apply the Poincaré-Wirtinger inequality to the restriction of  $\phi$  to the ball  $B(O; R_1/2)$  (see [8] chapter 7)

$$\|\phi - \mathcal{M}_{B(O;R_1/2)}(\phi)\|_{L^p(B(O;R_1/2))}^p \leq 2^{(n-1)p} R_1^p \int_{B(O;R_1/2)} |\nabla \phi(x)|^p dx$$

The distance from a point in  $B(O; R_1/2)$  and the boundary of  $\mathcal{O}$  is more than  $R_1/2$ , hence

$$\|\phi - \mathcal{M}_{B(O;R_1/2)}(\phi)\|_{L^p(B(O;R_1/2))}^p \leq 2^{np} \int_{B(O;R_1/2)} |\rho(x) \nabla \phi(x)|^p dx \leq 2^{np} \|\rho \nabla \phi\|_{[L^p(\mathcal{O})]^n}^p$$

We apply Lemma 1.1 to function  $\phi - \mathcal{M}_{B(O;R_1/2)}(\phi)$  and we use the above inequality. We obtain

$$\|\phi - \mathcal{M}_{B(O;R_1/2)}(\phi)\|_{L^p(\mathcal{O})}^p \leq 2^{np+n+3p} p^p \left\{ \frac{R}{R_1} \right\}^{n+p-1} \|\rho \nabla \phi\|_{[L^p(\mathcal{O})]^n}^p$$

We integrate  $\phi - \mathcal{M}_{B(O;R_1/2)}(\phi)$  on the open set  $\mathcal{O}$ . We deduce an estimate of  $\mathcal{M}_\mathcal{O}(\phi) - \mathcal{M}_{B(O;R_1/2)}(\phi)$ . Then, thanks to the above inequality we obtain the Poincaré-Wirtinger inequality for any function belonging to  $W_\rho^{1,p}(\mathcal{O})$ .  $\square$

## 2. Distances between a displacement and the set of the rigid body displacements

Let  $\Omega$  be an open set in  $\mathbb{R}^n$ . We denote ( $1 < p < \infty$ )

$$\begin{aligned} |u|_{\mathcal{D}, \Omega, p} &= \|\nabla u\|_{[L^p(\Omega)]^{n^2}}, & |u|_{\mathcal{E}, \Omega, p} &= \|(\nabla u)_S\|_{[L^p(\Omega)]^{n^2}}, \\ \mathcal{D}_p(u, \Omega) &= \|\nabla u\|_{[L^p(\Omega)]^{n^2}}^p, & \mathcal{E}_p(u, \Omega) &= \|(\nabla u)_S\|_{[L^p(\Omega)]^{n^2}}^p, \end{aligned} \quad u \in W^{1,p}(\Omega; \mathbb{R}^n).$$

where  $(\nabla u)_S$  is the symmetric part of the gradient of  $u$  or strain tensor. The elements of this matrix are

$$\gamma_{ij}(u) = \frac{1}{2} \left\{ \frac{\partial u_i}{\partial x_j} + \frac{\partial u_j}{\partial x_i} \right\}$$

We recall that a rigid body displacement  $r$  is a function from  $\mathbb{R}^n$  into itself such that there exist  $\mathbf{a} \in \mathbb{R}^n$  and a linear mapping  $\phi$  whose matrix is skew-symmetric,

$$r(x) = \mathbf{a} + \phi(x) \quad x \in \mathbb{R}^n.$$

**Theorem 1.3 .** *Let  $u$  be a displacement belonging to  $W^{1,p}(\mathcal{O}; \mathbb{R}^n)$ ,  $1 < p < \infty$ . There exists a rigid body displacement  $r$  such that*

$$(1.6) \quad |u - r|_{\mathcal{D}, \mathcal{O}, p} \leq C \left\{ \frac{R}{R_1} \right\}^{\frac{n+p-1}{p}} |u|_{\mathcal{E}, \mathcal{O}, p} \quad \|u - r\|_{L^p(\mathcal{O}; \mathbb{R}^n)} \leq CR \left\{ \frac{R}{R_1} \right\}^{\frac{n+p-1}{p}} |u|_{\mathcal{E}, \mathcal{O}, p}.$$

The constants depend on  $n$  and  $p$ .

**Proof .** In every estimate of this proof the constants depend only on  $n$  and  $p$ .

We recall (see [8] chapter 9) that the Newtonian potential  $F$  of function  $f$  belonging to  $L^p(\mathcal{O})$ ,  $1 < p < \infty$ , belongs to  $W^{2,p}(\mathcal{O})$  and verifies

$$\Delta F = f \quad \text{in } L^p(\mathcal{O}), \quad \int_{\mathcal{O}} \sum_{i,j=1}^n \left| \frac{\partial^2 F}{\partial x_i \partial x_j} \right|^p \leq C \|f\|_{L^p(\mathcal{O})}^p.$$

Let  $u$  be a displacement in  $W^{1,p}(\mathcal{O}; \mathbb{R}^n)$ . We denote  $v_{ij}$ ,  $(i, j) \in \{1, \dots, n\}^2$ , the Newtonian potential of  $\gamma_{ij}(u)$ . We define the displacement  $v$  by

$$v = (v_1, \dots, v_n) \quad \text{where} \quad v_k = \sum_{l=1}^n \left\{ 2 \frac{\partial}{\partial x_l} v_{kl} - \frac{\partial}{\partial x_k} v_{ll} \right\} \quad k \in \{1, \dots, n\}.$$

This displacement belongs to  $W^{1,p}(\mathcal{O}; \mathbb{R}^n)$  and verifies  $|v|_{\mathcal{E}, \mathcal{O}, p} \leq C |v|_{\mathcal{D}, \mathcal{O}, p} \leq C |u|_{\mathcal{E}, \mathcal{O}, p}$ . Now we consider the displacement  $w = u - v$ . It belongs to  $W^{1,p}(\mathcal{O}; \mathbb{R}^n)$ . From the estimate of  $|v|_{\mathcal{E}, \mathcal{O}, p}$  we deduce that  $|w|_{\mathcal{E}, \mathcal{O}, p} \leq C |u|_{\mathcal{E}, \mathcal{O}, p}$ . We have

$$\Delta v_k = \sum_{l=1}^n \left\{ 2 \frac{\partial}{\partial x_l} \gamma_{kl}(u) - \frac{\partial}{\partial x_k} \gamma_{ll}(u) \right\} = \Delta u_k \quad \text{in } \mathcal{D}'(\mathcal{O})$$

We recall the following classical result about the harmonic functions :

*Let  $\Omega$  be a bounded domain in  $\mathbb{R}^n$  with lipschitzian boundary. Any harmonic function  $u$  belonging to  $L^p(\Omega)$ ,  $1 \leq p \leq \infty$ , belongs to  $W_{\rho}^{1,p}(\Omega)$  and verifies the classical inequality*

$$\|\rho \nabla u\|_{[L^p(\Omega)]^n} \leq 4n \|u\|_{L^p(\Omega)}$$

The components of displacement  $w$  are harmonic functions in  $\mathcal{O}$  and we have

$$\frac{\partial^2 w_k}{\partial x_l \partial x_q} = \frac{\partial}{\partial x_l} \gamma_{kq}(w) + \frac{\partial}{\partial x_q} \gamma_{kl}(w) - \frac{\partial}{\partial x_k} \gamma_{lq}(w) \quad \text{and} \quad \Delta \gamma_{ij}(w) = 0 \quad \text{in } \mathcal{O}.$$

We apply the above estimate to the harmonic functions  $\gamma_{ij}(w)$ . We obtain

$$(1.7) \quad \sum_{i,j=1}^n \left\| \rho \frac{\partial^2 w}{\partial x_i \partial x_j} \right\|_{L^p(\mathcal{O})} \leq C \sum_{i,j=1}^n \|\rho \nabla \gamma_{ij}(w)\|_{[L^p(\mathcal{O})]^n} \leq C |w|_{\mathcal{E}, \mathcal{O}, p} \leq C |u|_{\mathcal{E}, \mathcal{O}, p}.$$



We suppose that the mapping  $s_3 \rightarrow M(s_3)$  belongs to  $\mathcal{C}^2(0, L; \mathbb{R}^3)$  and that it is injective. We have

$$\frac{dM}{ds_3} = \mathbf{t}, \quad \|\mathbf{t}\|_2 = 1,$$

where  $\|\cdot\|_2$  is the euclidian norm in  $\mathbb{R}^3$ .

Let  $\mathbf{n}_1$  be a function belonging to  $\mathcal{C}^1(0, L; \mathbb{R}^3)$  such that

$$\forall s_3 \in [0, L], \quad \|\mathbf{n}_1(s_3)\|_2 = 1 \quad \text{and} \quad \mathbf{t}(s_3) \cdot \mathbf{n}_1(s_3) = 0.$$

We put

$$\mathbf{n}_2 = \mathbf{t} \wedge \mathbf{n}_1.$$

In the sequel,  $\omega$  denotes a bounded domain in  $\mathbb{R}^2$  with lipschitzian boundary (while obviously,  $\bar{\omega}$  denotes the closure of  $\omega$ ). We choose the origin  $O$  of coordinates at the center of gravity of  $\omega$  and we choose as coordinates axes  $(O; \mathbf{e}_1)$  and  $(O; \mathbf{e}_2)$  the principal axes of inertia of  $\omega$ . The cross-section  $\omega_\delta$  of the rod is obtained by transforming  $\omega$  with a dilatation of ratio  $\delta > 0$ .

Introduce now the mapping  $\Phi : \mathbb{R}^2 \times [0, L] \rightarrow \mathbb{R}^3$  defined by

$$\Phi : (s_1, s_2, s_3) \mapsto M(s_3) + s_1 \mathbf{n}_1(s_3) + s_2 \mathbf{n}_2(s_3)$$

There exists  $\delta_0$  in  $]0, L/3]$  depending only on  $\zeta$ , such that the restriction of  $\Phi$  to the compact set  $\bar{\omega}_{\delta_0} \times [0, L]$  is a  $\mathcal{C}^1$ - diffeomorphism of that set onto its range. We can also choose  $\delta_0$  such that

$$\forall s \in \Omega_{\delta_0}, \quad \frac{1}{2} \leq \|\nabla \Phi(s)\|_2 \leq \frac{3}{2}$$

where  $\|A\|_2$  is the spectral norm of the matrix  $A$ .

**Definition 1 .** *The curved rod  $\mathcal{P}_\delta$  is defined as follows:*

$$\mathcal{P}_\delta = \Phi(\Omega_\delta), \quad \text{for } \delta \in ]0, \delta_0], \quad \Omega_\delta = \omega_\delta \times ]0, L[.$$

The cross-section of the curved rod is isometric to  $\omega_\delta$ . The point  $M(s_3)$  is the center of gravity and the axes of direction  $\mathbf{n}_1(s_3)$  and  $\mathbf{n}_2(s_3)$  are the principal axes of inertia of the cross-section of the curved rod.

**Notation (i).** *Reference domains and running points.* We denote  $x$  the running point of  $\mathcal{P}_\delta$ . The running point of the cylinder  $\Omega_\delta$  is  $s$ .

**(ii).** *Displacements.* For any displacement  $u \in L^1(\mathcal{P}_\delta; \mathbb{R}^3)$ , we write  $u$  instead of  $u \circ \Phi$ .

## 2. First decomposition of displacements of a curved rod.

**Definition 2 .** *We call elementary displacement of a rod, any element  $v$  of the space  $L^1(\Omega_\delta; \mathbb{R}^3)$  that is written in the form*

$$v(s) = \mathcal{V}(s_3) + \mathcal{A}(s_3) \wedge (s_1 \mathbf{n}_1(s_3) + s_2 \mathbf{n}_2(s_3)), \quad \text{for a.e. } s \in \Omega_\delta,$$

where  $\mathcal{V}$  and  $\mathcal{A}$  are functions in  $L^1(0, L; \mathbb{R}^3)$ .

The first component  $\mathcal{V}$  of  $v$  is the displacement of the center line. The second component  $\mathcal{A}$ , gives us an information about the relative displacement of the cross-section  $\Phi(\omega_\delta \times \{s_3\})$  of the rod, that is to say, rotations whose axis are directed along the vector  $\mathcal{A}(s_3)$ .

To any displacement  $u$  of the rod we associate an elementary displacement defined as follows :

**Definition 3 .** *The elementary displacement  $U_e$ , associated to  $u \in L^1(\mathcal{P}_\delta; \mathbb{R}^3)$ , is given by*

$$(2.1) \quad U_e(s_1, s_2, \cdot) = \mathcal{U} + \mathcal{R} \wedge (s_1 \mathbf{n}_1 + s_2 \mathbf{n}_2), \quad (s_1, s_2) \in \omega_\delta,$$

where

$$(2.2) \quad \begin{cases} \mathcal{U} = \frac{1}{\delta^2 |\omega|} \int_{\omega_\delta} u(s_1, s_2, \cdot) ds_1 ds_2, \\ \mathcal{R} \cdot \mathbf{t} = \frac{1}{(I_1 + I_2) \delta^4} \int_{\omega_\delta} [(s_1 \mathbf{n}_1 + s_2 \mathbf{n}_2) \wedge u(s_1, s_2, \cdot)] \cdot \mathbf{t} ds_1 ds_2, \\ \mathcal{R} \cdot \mathbf{n}_\alpha = \frac{1}{I_{3-\alpha} \delta^4} \int_{\omega_\delta} [(s_1 \mathbf{n}_1 + s_2 \mathbf{n}_2) \wedge u(s_1, s_2, \cdot)] \cdot \mathbf{n}_\alpha ds_1 ds_2, \quad I_\alpha = \int_{\omega} s_\alpha^2 ds_1 ds_2. \end{cases}$$

We write

$$(2.3) \quad u = U_e + \bar{u}$$

This displacement  $\bar{u}$  is the warping.

**Remark.** The elementary displacement  $U_e$  associated to the displacement  $u$  satisfies: for any elementary displacement  $V$ :

$$\int_{\omega_\delta \times \{s_3\}} \{u - U_e\} \cdot V = 0 \quad \text{for a. e. } s_3 \in ]0, L[.$$

The above equality can also serve as the definition of the elementary displacement  $U_e$ .  $\square$

The next theorem plays a fundamental role in the study of curved rods with the unfolding method. It provides sharp estimates of the components of the elementary displacement  $U_e$  and of the warping  $\bar{u}$  in terms of  $\delta$  and of the strain energy of  $u$ .

**Theorem 2.1 .** *Let  $u \in W^{1,p}(\mathcal{P}_\delta; \mathbb{R}^3)$ ,  $1 < p < \infty$ , and  $u = U_e + \bar{u}$  the decomposition of  $u$  given by (2.1)–(2.3). There exists  $\delta_1 \in ]0, \delta_0]$  which depends only on  $\omega$  and on the middle line of the rod such that for any  $\delta \leq \delta_1$  the following estimates hold :*

$$(2.4) \quad \begin{cases} \|\bar{u}\|_{\mathcal{D}, \mathcal{P}_\delta, p} \leq C |u|_{\mathcal{E}, \mathcal{P}_\delta, p}, & \|\bar{u}\|_{L^p(\Omega_\delta; \mathbb{R}^3)} \leq C \delta |u|_{\mathcal{E}, \mathcal{P}_\delta, p}, \\ \delta \left\| \frac{d\mathcal{R}}{ds_3} \right\|_{L^p(0, L; \mathbb{R}^3)} + \left\| \frac{d\mathcal{U}}{ds_3} - \mathcal{R} \wedge \mathbf{t} \right\|_{L^p(0, L; \mathbb{R}^3)} \leq \frac{C}{\delta^{2/p}} |u|_{\mathcal{E}, \mathcal{P}_\delta, p}. \end{cases}$$

The constants are independent of  $\delta$ .

**Proof .** Let  $N$  be an integer belonging to  $\left[ \frac{2L}{3\delta}, \frac{L}{\delta} \right]$ , and set  $\alpha_k = k \frac{L}{N}$ ,  $k \in \{0, \dots, N\}$ .

We have  $\delta \leq \frac{L}{N} \leq \frac{3}{2}\delta$ . The reference cross-section has a diameter less than  $2R$ . We choose  $R$  such that  $1 \leq R$ . Then the domain  $\Omega_{\delta, k} = \omega_\delta \times ]\alpha_k, \alpha_{k+1}[$  has a diameter less than  $3R\delta$ . The mapping  $s_3 \mapsto (\mathbf{t}, \mathbf{n}_1, \mathbf{n}_2)$  belongs to  $\mathcal{C}^1([0, L; (\mathbb{R}^3)^3])$ . Hence there exists  $C_0 > 0$  which does not depend on  $\delta$  such that

$$\forall (s, \tilde{s}) \in \Omega_{\delta, k} \times \Omega_{\delta, k}, \quad \|\nabla \Phi(s) - \nabla \Phi(\tilde{s})\|_2 \leq C_0 \delta$$

In the sequel we will work with portions of the rod  $\mathcal{P}_\delta$  denoted  $\mathcal{P}_{\delta,k}$

$$\mathcal{P}_{\delta,k} = \Phi(\omega_\delta \times ]\alpha_k, \alpha_{k+1}[) \quad k \in \{0, \dots, N-1\}.$$

• **First Case .** We suppose that the reference cross-section is star-shaped with respect to a disc of radius  $R_1$ ,  $0 < R_1 \leq 1/2$ . The domain  $\Omega_{\delta,k}$  is star-shaped with respect to a ball of radius  $R_1\delta$ . We take  $\delta$  such that

$$\delta \leq \inf \left\{ \frac{1}{2.3^2 C_0} \left( \frac{R_1}{4(3R)} \right)^3, \delta_0 \right\}.$$

So we have

$$C_0 \delta \leq \left( \frac{R_1}{4(3R)} \right)^3 \inf_{s \in \Omega_\delta} \{ \|\nabla \Phi(s)\|_2^3 \|(\nabla \Phi(s))^{-1}\|_2^2 \}$$

Thanks to the corollary of Lemmas 4.1 and 4.2 (see Section V) the domain  $\mathcal{P}_{\delta,k}$  has a diameter less than  $9R\delta$  and it is star-shaped with respect to a ball of radius  $R_1\delta/8$ .

From Theorem 1.3 there exist rigid body displacements  $r_k$  such that

$$\mathcal{D}_p(u - r_k, \mathcal{P}_{\delta,k}) \leq C \mathcal{E}_p(u, \mathcal{P}_{\delta,k}), \quad \|u - r_k\|_{L^p(\mathcal{P}_{\delta,k}; \mathbb{R}^3)}^p \leq C \delta^p \mathcal{E}_p(u, \mathcal{P}_{\delta,k}),$$

where the constants do not depend on  $k$  and  $\delta$ .

• **Second Case .** The cross-section is a bounded domain in  $\mathbb{R}^2$  with lipschitzian boundary. There exists a finite sequence of open sets  $\omega^{(1)}, \dots, \omega^{(K)}$  such that

$$\omega = \bigcup_{1 \leq l \leq K} \omega^{(l)}, \quad \omega_\delta = \bigcup_{1 \leq l \leq K} \omega_\delta^{(l)},$$

and such that every  $\omega^{(l)}$  is star-shaped with respect to a disc of radius  $R_1$ ,  $0 < R_1 \leq 1/2$ . Moreover, the open set  $\omega$  is connected, then there exists  $R_2 \in ]0, R_1]$  such that if  $\omega^{(r)} \cap \omega^{(s)} \neq \emptyset$  then this intersection contains a disc of radius  $R_2$ .

The domain  $\Omega_{\delta,k}^{(l)} = \omega_\delta^{(l)} \times ]\alpha_k, \alpha_{k+1}[$  is star-shaped with respect to a ball of radius  $R_1\delta$ . As in the first case, there exist rigid body displacements  $r_k^{(l)}$  such that

$$\mathcal{D}_p(u - r_k^{(l)}, \mathcal{P}_{\delta,k}^{(l)}) \leq C \mathcal{E}_p(u, \mathcal{P}_{\delta,k}^{(l)}), \quad \|u - r_k^{(l)}\|_{L^p(\mathcal{P}_{\delta,k}^{(l)}; \mathbb{R}^3)}^p \leq C \delta^p \mathcal{E}_p(u, \mathcal{P}_{\delta,k}^{(l)}), \quad \mathcal{P}_{\delta,k}^{(l)} = \Phi(\Omega_{\delta,k}^{(l)}).$$

If  $\omega^{(r)} \cap \omega^{(s)} \neq \emptyset$  the portion  $\mathcal{P}_{\delta,k}^{(r)} \cap \mathcal{P}_{\delta,k}^{(s)}$  contains a ball of radius  $R_2\delta/8$ . This allows us to compare the rigid body displacements  $r_k^{(r)}$  and  $r_k^{(s)}$ . Eventually we define  $r_k$  as the mean value of  $r_k^{(l)}$ . We obtain

$$(2.5) \quad \mathcal{D}_p(u - r_k, \mathcal{P}_{\delta,k}) \leq C \mathcal{E}_p(u, \mathcal{P}_{\delta,k}), \quad \|u - r_k\|_{L^p(\mathcal{P}_{\delta,k}; \mathbb{R}^3)}^p \leq C \delta^p \mathcal{E}_p(u, \mathcal{P}_{\delta,k}),$$

The constants do not depend on  $k$  and  $\delta$ . They depend only on  $\omega$  and on the middle line of the rod.

Now we go on as in Theorem 3.3 in [10]. Recall that the displacements  $r_k$  are of the form

$$r_k(x) = A_k + B_k \wedge (x - M(\alpha_k)), \quad x \in \mathcal{P}_{\delta,k}, \quad A_k, B_k \in \mathbb{R}^3.$$

Taking the mean value over the cross-sections of the curved rod, and using definition (2.2) of  $\mathcal{U}$  and  $\mathcal{R}$ , we deduce the inequalities

$$(2.6) \quad \frac{1}{\delta^p} \|\mathcal{U}(\cdot) - A_k - B_k \wedge (M(\cdot) - M(\alpha_k))\|_{L^p(\alpha_k, \alpha_{k+1}; \mathbb{R}^3)}^p + \|\mathcal{R}(\cdot) - B_k\|_{L^p(\alpha_k, \alpha_{k+1}; \mathbb{R}^3)}^p \leq \frac{C}{\delta^2} \mathcal{E}_p(u, \mathcal{P}_{\delta,k}).$$

Consequently  $\|u - U_e\|_{L^p(\Omega_\delta; \mathbb{R}^3)} \leq C\delta|u|_{\mathcal{E}, \mathcal{P}_{\delta,p}}$ , where  $C$  depends only on the center line of the rod.

Note now that both functions  $\mathcal{U}$  and  $\mathcal{R}$  belong to  $W^{1,p}(0, L; \mathbb{R}^3)$ . We compute the derivatives of the displacement  $u$  to get

$$\frac{\partial u}{\partial s_\alpha} = \nabla_x u \mathbf{n}_\alpha, \quad \frac{\partial u}{\partial s_3} = \nabla_x u \left[ \mathbf{t} + s_1 \frac{d\mathbf{n}_1}{ds_3} + s_2 \frac{d\mathbf{n}_2}{ds_3} \right].$$

Taking the restrictions of these derivatives to  $\Omega_{\delta,k} = \omega_\delta \times ]\alpha_k, \alpha_{k+1}[$ , from (2.5) we obtain

$$\left\| \frac{\partial u}{\partial s_\alpha} - B_k \wedge \mathbf{n}_\alpha \right\|_{L^p(\Omega_{\delta,k}; \mathbb{R}^3)}^p + \left\| \frac{\partial u}{\partial s_3} - B_k \wedge \left[ \mathbf{t} + s_1 \frac{d\mathbf{n}_1}{ds_3} + s_2 \frac{d\mathbf{n}_2}{ds_3} \right] \right\|_{L^p(\Omega_{\delta,k}; \mathbb{R}^3)}^p \leq C \mathcal{E}_p(u, \mathcal{P}_{\delta,k}).$$

Then, from (2.6) and by eliminating  $B_k$  we get

$$\left\| \frac{\partial u}{\partial s_\alpha} - \mathcal{R} \wedge \mathbf{n}_\alpha \right\|_{L^p(\Omega_\delta; \mathbb{R}^3)} + \left\| \frac{\partial u}{\partial s_3} - \mathcal{R} \wedge \left[ \mathbf{t} + s_1 \frac{d\mathbf{n}_1}{ds_3} + s_2 \frac{d\mathbf{n}_2}{ds_3} \right] \right\|_{L^p(\Omega_\delta; \mathbb{R}^3)} \leq C |u|_{\mathcal{E}, \mathcal{P}_{\delta,p}}.$$

By taking the mean value of  $\frac{\partial u}{\partial s_3} - \mathcal{R} \wedge \left[ \mathbf{t} + s_1 \frac{d\mathbf{n}_1}{ds_3} + s_2 \frac{d\mathbf{n}_2}{ds_3} \right]$  over the cross-section of the rod we obtain

$$\left\| \frac{d\mathcal{U}}{ds_3} - \mathcal{R} \wedge \mathbf{t} \right\|_{L^p(0, L; \mathbb{R}^3)} \leq \frac{C}{\delta^{2/p}} |u|_{\mathcal{E}, \mathcal{P}_{\delta,p}}.$$

We now estimate the  $L^p$  norm of  $\frac{d\mathcal{R}}{ds_3}$ . To begin with, let us introduce the function

$$V(s_3) = \frac{1}{\delta^4} \int_{\omega_\delta} \left( s_1 \mathbf{n}_1(s_3) + s_2 \mathbf{n}_2(s_3) \right) \wedge u(s) ds_1 ds_2.$$

We derive  $V$  with respect to  $s_3$

$$\frac{dV}{ds_3} = \frac{1}{\delta^4} \int_{\omega_\delta} \left[ (s_1 \mathbf{n}_1 + s_2 \mathbf{n}_2) \wedge \frac{\partial u}{\partial s_3}(s) + \left( s_1 \frac{d\mathbf{n}_1}{ds_3} + s_2 \frac{d\mathbf{n}_2}{ds_3} \right) \wedge u(s) \right] ds_1 ds_2.$$

We replace  $\frac{\partial u}{\partial s_3}$  by  $\mathcal{R} \wedge \left[ \mathbf{t} + s_1 \frac{d\mathbf{n}_1}{ds_3} + s_2 \frac{d\mathbf{n}_2}{ds_3} \right]$  and  $u$  by  $U_e$ . We obtain (summation on  $\alpha$ )

$$\left\| \frac{dV}{ds_3} + I_\alpha(\mathcal{R} \cdot \mathbf{n}_\alpha) \frac{d\mathbf{n}_\alpha}{ds_3} + I_\alpha(\mathcal{R} \cdot \frac{d\mathbf{n}_\alpha}{ds_3}) \mathbf{n}_\alpha \right\|_{L^p(0, L; \mathbb{R}^3)} \leq \frac{C}{\delta^{1+2/p}} |u|_{\mathcal{E}, \mathcal{P}_{\delta,p}}.$$

The derivatives of the functions  $\mathbf{t}$ ,  $\mathbf{n}_1$  and  $\mathbf{n}_2$  are

$$\frac{d\mathbf{t}}{ds_3} = a_1 \mathbf{n}_1 + a_2 \mathbf{n}_2 \quad \frac{d\mathbf{n}_1}{ds_3} = -a_1 \mathbf{t} + b \mathbf{n}_2 \quad \frac{d\mathbf{n}_2}{ds_3} = -a_2 \mathbf{t} - b \mathbf{n}_1$$

where  $a_\alpha$  and  $b$  are continuous functions defined on  $[0, L]$ . Hence (no summation on  $\alpha$ )

$$\begin{aligned} \left\| \frac{dV}{ds_3} \cdot \mathbf{t} - a_1 I_1(\mathcal{R} \cdot \mathbf{n}_1) - a_2 I_2(\mathcal{R} \cdot \mathbf{n}_2) \right\|_{L^p(0, L)} &\leq \frac{C}{\delta^{1+2/p}} |u|_{\mathcal{E}, \mathcal{P}_{\delta,p}} \\ \left\| \frac{dV}{ds_3} \cdot \mathbf{n}_\alpha - a_\alpha I_\alpha(\mathcal{R} \cdot \mathbf{t}) + b(I_1 - I_2)(\mathcal{R} \cdot \mathbf{n}_{3-\alpha}) \right\|_{L^p(0, L)} &\leq \frac{C}{\delta^{1+2/p}} |u|_{\mathcal{E}, \mathcal{P}_{\delta,p}}. \end{aligned}$$

Using the definition of  $\mathcal{R}$  and  $V$ , one can write (summation on  $\alpha$ )  $(I_1 + I_2)\mathcal{R} = V + \frac{I_\alpha}{I_{3-\alpha}}(V \cdot \mathbf{n}_\alpha)\mathbf{n}_\alpha$  and so (summation on  $\alpha$ )

$$(I_1 + I_2)\frac{d\mathcal{R}}{ds_3} = \frac{dV}{ds_3} + \frac{I_\alpha}{I_{3-\alpha}} \left[ \left( \frac{dV}{ds_3} \cdot \mathbf{n}_\alpha \right) \mathbf{n}_\alpha + \left( V \cdot \frac{d\mathbf{n}_\alpha}{ds_3} \right) \mathbf{n}_\alpha + \left( V \cdot \mathbf{n}_\alpha \right) \frac{d\mathbf{n}_\alpha}{ds_3} \right].$$

We deduce that (no summation on  $\alpha$ )

$$\begin{aligned} (I_1 + I_2)\frac{d\mathcal{R}}{ds_3} \cdot \mathbf{t} &= \frac{dV}{ds_3} \cdot \mathbf{t} - \frac{a_1 I_1}{I_2} (V \cdot \mathbf{n}_1) - \frac{a_2 I_2}{I_1} (V \cdot \mathbf{n}_2) \\ I_{3-\alpha} \frac{d\mathcal{R}}{ds_3} \cdot \mathbf{n}_\alpha &= \frac{dV}{ds_3} \cdot \mathbf{n}_\alpha - \frac{a_\alpha I_\alpha}{I_1 + I_2} (V \cdot \mathbf{t}) + \frac{b(I_1 - I_2)}{I_\alpha} (V \cdot \mathbf{n}_{3-\alpha}) \end{aligned}$$

Hence  $\delta \left\| \frac{d\mathcal{R}}{ds_3} \right\|_{L^p(0,L;\mathbb{R}^3)} \leq \frac{C}{\delta^{2/p}} |u|_{\mathcal{E},\mathcal{P}_\delta,p}$ . Now, observe that

$$\begin{aligned} \frac{\partial}{\partial s_\alpha} (u - U_e) &= \frac{\partial u}{\partial s_\alpha} - \mathcal{R} \wedge \mathbf{n}_\alpha, \\ \frac{\partial}{\partial s_3} (u - U_e) &= \frac{\partial u}{\partial s_3} - \frac{d\mathcal{U}}{ds_3} - \mathcal{R} \wedge \left[ s_1 \frac{d\mathbf{n}_1}{ds_3} + s_2 \frac{d\mathbf{n}_2}{ds_3} \right] - \frac{d\mathcal{R}}{ds_3} \wedge (s_1 \mathbf{n}_1 + s_2 \mathbf{n}_2), \\ &= \frac{\partial u}{\partial s_3} - \mathcal{R} \wedge \left[ \mathbf{t} + s_1 \frac{d\mathbf{n}_1}{ds_3} + s_2 \frac{d\mathbf{n}_2}{ds_3} \right] - \left( \frac{d\mathcal{U}}{ds_3} - \mathcal{R} \wedge \mathbf{t} \right) - \frac{d\mathcal{R}}{ds_3} \wedge (s_1 \mathbf{n}_1 + s_2 \mathbf{n}_2). \end{aligned}$$

From these expressions and taking into account the above inequalities, we finally obtain the estimate of gradient  $\bar{u}$ .  $\square$

**Remarks. i)** We have

$$|U_e|_{\mathcal{E},\mathcal{P}_\delta,p} \leq |U_e + \bar{u}|_{\mathcal{E},\mathcal{P}_\delta,p} + |\bar{u}|_{\mathcal{E},\mathcal{P}_\delta,p} \leq |u|_{\mathcal{E},\mathcal{P}_\delta,p} + |\bar{u}|_{\mathcal{D},\mathcal{P}_\delta,p} \leq C|u|_{\mathcal{E},\mathcal{P}_\delta,p}$$

By an easy computation we can see that this estimate of  $|U_e|_{\mathcal{E},\mathcal{P}_\delta,p}$  is equivalent to

$$\delta \left\| \frac{d\mathcal{R}}{ds_3} \right\|_{L^p(0,L;\mathbb{R}^3)} + \left\| \frac{d\mathcal{U}}{ds_3} - \mathcal{R} \wedge \mathbf{t} \right\|_{L^p(0,L;\mathbb{R}^3)} \leq \frac{C}{\delta^{2/p}} |u|_{\mathcal{E},\mathcal{P}_\delta,p}.$$

**ii)** If the rod is clamped at one of these extremities,  $\Phi(\omega_\delta \times \{0\})$  for example, we have  $\mathcal{R}(0) = \mathcal{U}(0) = 0$ .  $\square$

**Corollary of Theorem 2.1 . (Korn's inequality).** *We suppose that the rod is clamped at one of these extremities, then we have*

$$|u|_{\mathcal{D},\mathcal{P}_\delta,p} + \|u\|_{L^p(\mathcal{P}_\delta;\mathbb{R}^3)} \leq \frac{C}{\delta} |u|_{\mathcal{E},\mathcal{P}_\delta,p}$$

*The constant does not depend on  $\delta$ .*

**Proof .** This is an immediate consequence of (2.4).  $\square$

### 3. Second decomposition of displacements of a curved rod.

In this paragraph we suppose that the reference cross-section  $\omega$  is of diameter  $2R$  and that it is star-shaped with respect to a disc centered in the origin and of radius  $R_1$ ,  $R_1 \leq 1/2$  and  $R \geq 1$ .

Now we suppose that the mapping  $\Phi$  introduced in the previous subsection is defined on  $\bar{\omega}_{\delta_0} \times [-l, L+l]$ ,  $l > 0$ , and it is a  $\mathcal{C}^1$ - diffeomorphism of that set onto its range and verifies

$$\forall s \in \bar{\omega}_{\delta_0} \times [-l, L+l], \quad \frac{1}{2} \leq \| \nabla \Phi(s) \|_2 \leq \frac{3}{2}$$

**Lemma 2.2 .** *Let  $\rho$  be a strictly positive real and  $u$  a displacement belonging to  $W^{1,p}(\mathcal{P}_\delta; \mathbb{R}^3)$ ,  $1 < p < \infty$ . There exists an extension  $P(u)$  of  $u$  to the curved rod*

$$\mathcal{P}'_\delta = \Phi(\omega_\delta \times ] - \rho\delta, L + \rho\delta[) \quad (\delta \leq l/\rho)$$

such that

$$P(u) \in W^{1,p}(\mathcal{P}'_\delta; \mathbb{R}^3) \quad P(u)|_{\mathcal{P}_\delta} = u \quad |P(u)|_{\mathcal{E}, \mathcal{P}'_\delta, p} \leq C|u|_{\mathcal{E}, \mathcal{P}_\delta, p}.$$

The constant does not depend on  $\delta$ .

**Proof .** The domain  $\omega_\delta \times ] - \rho\delta, (2 + \rho)\delta[$  has a diameter less than  $2(R + 1 + \rho)\delta$  and it is star-shaped with respect to a ball of radius  $R_1\delta$ . We put

$$\mathcal{P}_{0,\rho\delta} = \Phi(\omega_\delta \times ]0, (2 + \rho)\delta[) \quad \mathcal{P}'_{0,\rho\delta} = \Phi(\omega_\delta \times ] - \rho\delta, 0[).$$

From Theorem 1.3, there exists a rigid body displacement  $r$  such that

$$\mathcal{D}_p(u - r, \mathcal{P}_{0,\rho\delta}) \leq C\mathcal{E}_p(u, \mathcal{P}_{0,\rho\delta}), \quad \|u - r\|_{L^p(\mathcal{P}_{0,\rho\delta}; \mathbb{R}^3)}^p \leq C\delta^p \mathcal{E}_p(u, \mathcal{P}_{0,\rho\delta}),$$

where the constants do not depend on  $\delta$ . Now we consider the restriction of  $(u - r) \circ \Phi$  to the domain  $\omega_\delta \times ]0, (2 + \rho)\delta[$ . By a reflexion with respect to the plane  $s_3 = 0$  we obtain an extension of  $(u - r) \circ \Phi$  on the open set  $\omega_\delta \times ] - \rho\delta, 0[$ . Hence an extension  $v$  of  $u - r$  on the portion  $\mathcal{P}'_{0,\rho\delta}$  of the curved rod. We define  $P(u)$  by  $P(u) = v + r$ . We do the same with the other extremity of the curved rod.  $\square$

From now on any displacement belonging to  $W^{1,p}(\mathcal{P}_\delta; \mathbb{R}^3)$  is extended to a displacement belonging to  $W^{1,p}(\mathcal{P}'_\delta; \mathbb{R}^3)$ . We denote again  $u$  this extension.

We denote  $B_1$  the ball centered at  $O$  and of radius  $R_1/16$ . We put

$$|B_1| = \int_{B_1} dx \quad M_1 = \int_{B_1} \|x\|_2^2 dx$$

Notice that for any  $s_3 \in [0, L]$  the ball centered in  $M(s_3)$  and of radius  $R_1/16$  is included in  $\mathcal{P}'_\delta$ .

To any displacement  $u$  of the curved rod we associate a new elementary displacement defined as follows :

**Definition 4 .** *The elementary displacement  $U'_e$ , associated to  $u \in L^1(\mathcal{P}'_\delta; \mathbb{R}^3)$ , is given by*

$$(2.7) \quad U'_e(s) = \mathcal{U}'(s_3) + \mathcal{R}'(s_3) \wedge (s_2 \mathbf{n}_1(s_3) + s_1 \mathbf{n}_2(s_3)), \quad \text{for a. e. } s \in \omega_\delta \times ] - \rho\delta, L + \rho\delta[,$$

where

$$(2.8) \quad \left\{ \begin{array}{l} \mathcal{U}'(s_3) = \frac{1}{|B_1|} \int_{B_1} u(M(s_3) + \delta x) dx, \\ \mathcal{R}'(s_3) = \frac{3}{2M_1\delta} \int_{B_1} x \wedge u(M(s_3) + \delta x) dx, \end{array} \right\} \quad s_3 \in [0, L],$$

$$\left\{ \begin{array}{l} \mathcal{U}'(s_3) = \mathcal{U}'(0) + \mathcal{R}'(0) \wedge (M(s_3) - M(0)) \quad s_3 \in ] - \rho\delta, 0[, \\ \mathcal{U}'(s_3) = \mathcal{U}'(L) + \mathcal{R}'(L) \wedge (M(s_3) - M(L)) \quad s_3 \in [L, L + \rho\delta[, \\ \mathcal{R}'(s_3) = \mathcal{R}'(0) \quad s_3 \in ] - \rho\delta, 0[, \quad \mathcal{R}'(s_3) = \mathcal{R}'(L) \quad s_3 \in [L, L + \rho\delta[. \end{array} \right.$$

We write

$$(2.9) \quad u = U'_e + \bar{u}'$$

The elementary displacement  $U'_e$  is a rigid body displacement in the additional parts of the curved rod.

**Proposition 2.3 .** *Let  $u \in W^{1,p}(\mathcal{P}_\delta; \mathbb{R}^3)$ ,  $1 < p < \infty$ , and  $u = U'_e + \bar{u}'$  the decomposition of the extension of  $u$  given by (2.7)–(2.9). There exists  $\delta'_1 \in ]0, \delta_0]$  which depends only on  $\omega$ ,  $\rho$  and on the middle line of the rod such that for any  $\delta \leq \delta'_1$  the following estimates hold :*

$$(2.10) \quad \begin{cases} \|\bar{u}'\|_{\mathcal{D}, \mathcal{P}'_{\delta,p}} \leq C \|u\|_{\mathcal{E}, \mathcal{P}_{\delta,p}}, & \|\bar{u}'\|_{L^p(\mathcal{P}'_{\delta}; \mathbb{R}^3)} \leq C \delta \|u\|_{\mathcal{E}, \mathcal{P}_{\delta,p}}, \\ \delta \left\| \frac{d\mathcal{R}'}{ds_3} \right\|_{L^p(0,L; \mathbb{R}^3)} + \left\| \frac{d\mathcal{U}'}{ds_3} - \mathcal{R}' \wedge \mathbf{t} \right\|_{L^p(0,L; \mathbb{R}^3)} \leq \frac{C}{\delta^{2/p}} \|u\|_{\mathcal{E}, \mathcal{P}_{\delta,p}}. \end{cases}$$

The constants are independent of  $\delta$ .

**Proof .** Let  $N$  and  $(\alpha_k)_{0 \leq k \leq N}$  be the integer and the sequence introduced in Theorem 2.1. We put

$$\alpha_{-1} = -\rho\delta \quad \alpha_{N+1} = L + \rho\delta$$

We denote  $\mathcal{P}'_{\delta,k}$  the rod portions

$$\mathcal{P}'_{\delta,0} = \Phi(\omega_\delta \times ]-\rho\delta, 2\delta]) \quad \mathcal{P}'_{\delta,k} = \Phi(\omega_\delta \times ](k-1)\delta, (k+2)\delta]) \quad 1 \leq k \leq N-1, \quad \mathcal{P}'_{\delta,N} = \Phi(\omega_\delta \times ]L-\delta, L+\rho\delta])$$

From Theorem 1.3 there exist rigid body displacements  $r_k$ ,  $0 \leq k \leq N$ , such that

$$\begin{aligned} \mathcal{D}_p(u - r_k, \mathcal{P}'_{\delta,k}) &\leq C \mathcal{E}_p(u, \mathcal{P}'_{\delta,k}), \\ \|u - r_k\|_{L^p(\mathcal{P}'_{\delta,k}; \mathbb{R}^3)}^p &\leq C \delta^p \mathcal{E}_p(u, \mathcal{P}'_{\delta,k}), \end{aligned} \quad r_k(x) = A_k + B_k \wedge (x - M(\alpha_k)), \quad x \in \mathcal{P}'_{\delta,k}, \quad A_k, B_k \in \mathbb{R}^3.$$

Now we go on as in proof of Theorem 2.1. Using definition (2.8) of  $\mathcal{U}'$  and  $\mathcal{R}'$  we obtain ( $s_3 \in [0, L]$ )

$$\begin{aligned} |\mathcal{U}'(s_3) - A_k - B_k \wedge (M(s_3) - M(\alpha_k))|^p &\leq \frac{1}{|B_1|} \int_{B_1} |(u - r_k)(M(s_3) + \delta x)|^p dx \\ &\leq \frac{1}{\delta^3 |B_1|} \int_{\mathcal{P}'_{\delta,k}} |(u - r_k)(x)|^p dx \\ |\mathcal{R}'(s_3) - B_k|^p &\leq \frac{C}{\delta^p} \int_{B_1} |(u - r_k)(M(s_3) + \delta x)|^p dx \\ &\leq \frac{C}{\delta^{p+3}} \int_{\mathcal{P}'_{\delta,k}} |(u - r_k)(x)|^p dx \end{aligned}$$

The constant depends only on  $p$ . We also have for  $s_3 \in [-\rho\delta, 0]$  and for  $s_3 \in [L, L + \rho\delta]$  ( $k = 0$  or  $N$ )

$$|\mathcal{U}'(s_3) - A_k - B_k \wedge (M(s_3) - M(\alpha_k))|^p + \delta^p |\mathcal{R}'(s_3) - B_k|^p \leq \frac{C}{\delta^3} \int_{\mathcal{P}'_{\delta,k}} |(u - r_k)(x)|^p dx.$$

We integrate on  $[\alpha_k, \alpha_{k+1}]$ ,  $-1 \leq k \leq N$ . We obtain

$$\frac{1}{\delta^p} \|\mathcal{U}' - A_k - B_k \wedge (M - M(\alpha_k))\|_{L^p(\alpha_k, \alpha_{k+1}; \mathbb{R}^3)}^p + \|\mathcal{R}' - B_k\|_{L^p(\alpha_k, \alpha_{k+1}; \mathbb{R}^3)}^p \leq \frac{C}{\delta^2} \mathcal{E}_p(u, \mathcal{P}'_{\delta,k}).$$

Consequently  $\|u - U_e'\|_{L^p(\mathcal{P}'_\delta; \mathbb{R}^3)} \leq C\delta|u|_{\mathcal{E}, \mathcal{P}_\delta, p}$ , where  $C$  depends on the middle line of the rod and on  $p$ .

Both functions  $\mathcal{U}'$  and  $\mathcal{R}'$  belong to  $W^{1,p}(-\rho\delta, L + \rho\delta; \mathbb{R}^3)$ . We compute the derivatives of  $\mathcal{U}'$  and  $\mathcal{R}'$ . First notice that

$$\frac{d\mathcal{R}'}{ds_3} = \frac{d\mathcal{U}'}{ds_3} - \mathcal{R}' \wedge \mathbf{t} = 0 \quad \text{on } ]-\rho\delta, 0[ \cup ]L, L + \rho\delta[.$$

We obtain ( $s_3 \in [0, L]$ )

$$\frac{d\mathcal{U}'}{ds_3}(s_3) = \frac{1}{|B_1|} \int_{B_1} \nabla_x u(M(s_3) + \delta x) \mathbf{t} \, dx, \quad \frac{d\mathcal{R}'}{ds_3}(s_3) = \frac{3}{2M_1\delta} \int_{B_1} x \wedge \nabla_x u(M(s_3) + \delta x) \mathbf{t} \, dx.$$

Hence

$$\left| \frac{d\mathcal{U}'}{ds_3}(s_3) - B_k \wedge \mathbf{t}(s_3) \right|^p + \left| \delta \frac{d\mathcal{R}'}{ds_3}(s_3) \right|^p \leq \frac{C}{\delta^3} \int_{\mathcal{P}'_{\delta,k}} |\nabla_x(u - r_k)(x)|^p \, dx.$$

By integrating over  $[\alpha_k, \alpha_{k+1}]$  we get

$$\left\| \frac{d\mathcal{U}'}{ds_3} - B_k \wedge \mathbf{t} \right\|_{L^p(\alpha_k, \alpha_{k+1}; \mathbb{R}^3)}^p + \delta^p \left\| \frac{d\mathcal{R}'}{ds_3} \right\|_{L^p(\alpha_k, \alpha_{k+1}; \mathbb{R}^3)}^p \leq \frac{C}{\delta^2} \mathcal{E}_p(u, \mathcal{P}'_{\delta,k}),$$

and then we obtain

$$\left\| \frac{d\mathcal{U}'}{ds_3} - \mathcal{R}' \wedge \mathbf{t} \right\|_{L^p(0, L; \mathbb{R}^3)} + \delta \left\| \frac{d\mathcal{R}'}{ds_3} \right\|_{L^p(0, L; \mathbb{R}^3)} \leq \frac{C}{\delta^{2/p}} |u|_{\mathcal{E}, \mathcal{P}'_\delta, p}.$$

Now we compute the derivatives of  $\bar{u}'$  ( $s \in \mathcal{P}'_{\delta,k}$ )

$$\begin{aligned} \frac{\partial \bar{u}'}{\partial s_\alpha} &= \frac{\partial u}{\partial s_\alpha} - \mathcal{R}' \wedge \mathbf{n}_\alpha = [\nabla_x u \mathbf{n}_\alpha - B_k \wedge \mathbf{n}_\alpha] - [\mathcal{R}' - B_k] \wedge \mathbf{n}_\alpha \\ \frac{\partial \bar{u}'}{\partial s_3} &= \frac{\partial u}{\partial s_3} - \frac{d\mathcal{U}'}{ds_3} - \frac{d\mathcal{R}'}{ds_3} \wedge (s_1 \mathbf{n}_1 + s_2 \mathbf{n}_2) - \mathcal{R}' \wedge \left( s_1 \frac{d\mathbf{n}_1}{ds_3} + s_2 \frac{d\mathbf{n}_2}{ds_3} \right) \\ &= \left[ \nabla_x u (\mathbf{t} + s_1 \frac{d\mathbf{n}_1}{ds_3} + s_2 \frac{d\mathbf{n}_2}{ds_3}) - B_k \wedge (\mathbf{t} + s_1 \frac{d\mathbf{n}_1}{ds_3} + s_2 \frac{d\mathbf{n}_2}{ds_3}) \right] - \left[ \frac{d\mathcal{U}'}{ds_3} - B_k \wedge \mathbf{t} \right] \\ &\quad - \frac{d\mathcal{R}'}{ds_3} \wedge (s_1 \mathbf{n}_1 + s_2 \mathbf{n}_2) - (\mathcal{R}' - B_k) \wedge \left( s_1 \frac{d\mathbf{n}_1}{ds_3} + s_2 \frac{d\mathbf{n}_2}{ds_3} \right) \end{aligned}$$

Eventually  $|\bar{u}'|_{\mathcal{D}, \mathcal{P}'_\delta, p} \leq C|u|_{\mathcal{E}, \mathcal{P}_\delta, p}$ . □

Now we modify the elementary displacement  $U_e'$  in order to obtain a new elementary displacement which is rigid in the neighborhood of the extremities of the curved rod.

Let  $m$  be an even function belonging to  $\mathcal{C}^\infty(\mathbb{R}; [0, 1])$ , which satisfies

$$m(t) = 0 \quad \forall t \in [0, \rho], \quad m(t) = 1 \quad \forall t \in [\rho + 1, +\infty[, \quad |m'(t)| \leq 2 \quad \forall t \in \mathbb{R}.$$

The new elementary displacement  $U_e''$  is defined by

$$(2.11) \quad \begin{cases} \mathcal{U}''(s_3) = m\left(\frac{s_3}{\delta}\right) m\left(\frac{s_3 - L}{\delta}\right) \mathcal{U}'(s_3) + \left(1 - m\left(\frac{s_3}{\delta}\right)\right) [\mathcal{U}'(0) + \mathcal{R}'(0) \wedge (M(s_3) - M(0))] \\ \quad + \left(1 - m\left(\frac{s_3 - L}{\delta}\right)\right) [\mathcal{U}'(L) + \mathcal{R}'(L) \wedge (M(s_3) - M(L))] \\ \mathcal{R}''(s_3) = m\left(\frac{s_3}{\delta}\right) m\left(\frac{s_3 - L}{\delta}\right) \mathcal{R}'(s_3) + \left(1 - m\left(\frac{s_3}{\delta}\right)\right) \mathcal{R}'(0) + \left(1 - m\left(\frac{s_3 - L}{\delta}\right)\right) \mathcal{R}'(L) \\ U_e''(s) = \mathcal{U}''(s_3) + \mathcal{R}''(s_3) \wedge (s_1 \mathbf{n}_1(s_3) + s_2 \mathbf{n}_2(s_3)) \quad s \in \omega_\delta \times ]-\rho\delta, L + \rho\delta[ \end{cases}$$

We have

$$U_e'' = U_e' \quad \text{in} \quad \Phi(\omega_\delta \times ](\rho + 1)\delta, L - (\rho + 1)\delta])$$

and  $U_e''$  is a rigid body displacement in the portions  $\Phi(\omega_\delta \times ]-\rho\delta, \rho\delta])$  and  $\Phi(\omega_\delta \times ]L - \rho\delta, L + \rho\delta])$ .

We write

$$(2.12) \quad u = U_e'' + \bar{u}''.$$

**Proposition 2.4 .** *Let  $u \in W^{1,p}(\mathcal{P}_\delta; \mathbb{R}^3)$ ,  $1 < p < \infty$ , and  $u = U_e'' + \bar{u}''$  the decomposition of the extension of  $u$  given by (2.11)-(2.12). There exists  $\delta_1'' \in ]0, \delta_0]$  wich depends only on  $\omega$ ,  $\rho$  and on the middle line of the rod such that for any  $\delta \leq \delta_1''$  the following estimates hold :*

$$(2.13) \quad \begin{cases} |\bar{u}''|_{\mathcal{D}, \mathcal{P}'_\delta, p} \leq C |u|_{\mathcal{E}, \mathcal{P}_\delta, p}, & \|\bar{u}''\|_{L^p(\mathcal{P}'_\delta; \mathbb{R}^3)} \leq C \delta |u|_{\mathcal{E}, \mathcal{P}_\delta, p}, \\ \delta \left\| \frac{d\mathcal{R}''}{ds_3} \right\|_{L^p(0, L; \mathbb{R}^3)} + \left\| \frac{d\mathcal{U}''}{ds_3} - \mathcal{R}'' \wedge \mathbf{t} \right\|_{L^p(0, L; \mathbb{R}^3)} \leq \frac{C}{\delta^{2/p}} |u|_{\mathcal{E}, \mathcal{P}_\delta, p}. \end{cases}$$

The constants are independent of  $\delta$ .

**Proof .** We easily verify that

$$\begin{aligned} \|\mathcal{R}'' - \mathcal{R}'\|_{L^p(0, L; \mathbb{R}^3)} + \delta \left\| \frac{d\mathcal{R}''}{ds_3} - \frac{d\mathcal{R}'}{ds_3} \right\|_{L^p(0, L; \mathbb{R}^3)} &\leq \frac{C}{\delta^{2/p}} |u|_{\mathcal{E}, \mathcal{P}_\delta, p} \\ \frac{1}{\delta} \|\mathcal{U}'' - \mathcal{U}'\|_{L^p(0, L; \mathbb{R}^3)} + \left\| \frac{d\mathcal{U}''}{ds_3} - \frac{d\mathcal{U}'}{ds_3} \right\|_{L^p(0, L; \mathbb{R}^3)} &\leq \frac{C}{\delta^{2/p}} |u|_{\mathcal{E}, \mathcal{P}_\delta, p} \end{aligned}$$

The constants depend on  $\rho$ . Hence we deduce

$$|U_e'' - U_e'|_{\mathcal{D}, \mathcal{P}'_\delta, p} \leq C |u|_{\mathcal{E}, \mathcal{P}_\delta, p} \quad \|U_e'' - U_e'\|_{L^p(\mathcal{P}'_\delta; \mathbb{R}^3)} \leq C \delta |u|_{\mathcal{E}, \mathcal{P}_\delta, p}.$$

Then from (2.10) we obtain the estimates (2.13). □

## IV. Decompositions of the displacements of a shell

### 1. Notation

Let  $\omega$  be a bounded domain in  $\mathbb{R}^2$  with lipschitzian boundary. We give us an injective mapping  $\phi$  from  $\bar{\omega}$  into  $\mathbb{R}^3$  of class  $\mathcal{C}^2$  and we denote  $S$  the surface  $\phi(\bar{\omega})$ . We suppose that the two vectors  $\frac{\partial \phi}{\partial s_1}(\hat{s})$  and  $\frac{\partial \phi}{\partial s_2}(\hat{s})$  are linearly independent at each point  $\hat{s} = (s_1, s_2) \in \bar{\omega}$ .

We denote

$$\mathbf{t}_1 = \frac{\partial \phi}{\partial s_1}, \quad \mathbf{t}_2 = \frac{\partial \phi}{\partial s_2}, \quad \mathbf{n} = \frac{\mathbf{t}_1 \wedge \mathbf{t}_2}{\|\mathbf{t}_1 \wedge \mathbf{t}_2\|_2}.$$

Vectors  $\mathbf{t}_1$  and  $\mathbf{t}_2$  are tangential vectors to the surface  $S$  and vector  $\mathbf{n}$  is a unit normal vector to this surface.

Now we consider the mapping  $\Phi : \bar{\omega} \times \mathbb{R} \longrightarrow \mathbb{R}^3$

$$s = (s_1, s_2, s_3) \longmapsto \phi(s_1, s_2) + s_3 \mathbf{n}(s_1, s_2)$$

There exists  $\delta_0 > 0$  depending only on  $S$ , such that the restriction of  $\Phi$  to the compact set  $\bar{\Omega}_{\delta_0} = \bar{\omega} \times [-\delta_0, \delta_0]$  is a  $\mathcal{C}^1$ - diffeomorphism of that set onto its range. We also choose  $\delta_0$  such that there exist constants  $c_0 > 0$  and  $c_1 \geq c_0$  verifying

$$\forall s \in \Omega_{\delta_0}, \quad c_0 \leq \|\nabla \Phi(s)\|_2 \leq c_1$$

These constants depend only on  $\phi$ .

**Definition 5 .** *The shell  $\mathcal{Q}_\delta$  is defined as follows :*

$$\mathcal{Q}_\delta = \Phi(\Omega_\delta) \quad \text{for } \delta \in ]0, \delta_0], \quad \Omega_\delta = \omega \times ]-\delta, \delta[.$$

The mid-surface of the shell is  $S$ . The lateral boundary of the shell is  $\Gamma_\delta = \Phi(\partial\omega \times ]-\delta, \delta[)$ .

**Notation (i).** *Reference domains and running points.* We denote  $x$  the running point of  $\mathcal{Q}_\delta$ . The running point of the domain  $\Omega_\delta$  is  $s$ .

**(ii).** *Displacements.* For any displacement  $u \in L^1(\mathcal{Q}_\delta; \mathbb{R}^3)$ , we write  $u$  instead of  $u \circ \Phi$ .

## 2. First decomposition of displacements of a shell.

**Definition 6 .** *We call elementary displacement of a shell, any element  $v$  of  $L^1(\Omega_\delta; \mathbb{R}^3)$  that is written in the form*

$$v(s) = \mathcal{V}(\hat{s}) + s_3 \mathcal{A}(\hat{s}) \wedge \mathbf{n}(\hat{s}), \quad s = (s_1, s_2, s_3) \in \Omega_\delta, \quad \hat{s} = (s_1, s_2) \in \omega,$$

where  $\mathcal{V}$  and  $\mathcal{A}$  are functions in  $L^1(\omega; \mathbb{R}^3)$ .

Notice that we can choose the function  $\mathcal{A}$  such that

$$\mathcal{A}(\hat{s}) \cdot \mathbf{n}(\hat{s}) = 0 \quad \text{for a. e. } \hat{s} \in \omega.$$

The first component  $\mathcal{V}$  of  $v$  is the displacement of the middle surface. The second component  $\mathcal{A}$ , gives us an information about the relative displacement of the fibers  $\Phi(\{\hat{s}\} \times ]-\delta, \delta[)$  of the shell, that is to say, rotations whose axis are directed along the vector  $\mathcal{A}(\hat{s})$ .

To any displacement  $u$  of the shell we associate an elementary displacement defined as follows:

**Definition 7 .** *The elementary displacement  $U_e$ , associated to  $u \in L^1(\mathcal{Q}_\delta; \mathbb{R}^3)$ , is given by*

$$(3.1) \quad U_e(\cdot, s_3) = \mathcal{U} + s_3 \mathcal{R} \wedge \mathbf{n}, \quad s_3 \in ]-\delta, \delta[,$$

where

$$(3.2) \quad \mathcal{U} = \frac{1}{2\delta} \int_{-\delta}^{\delta} u(\cdot, s_3) ds_3, \quad \mathcal{R} = \frac{3}{2\delta^3} \int_{-\delta}^{\delta} s_3 \mathbf{n}(\cdot) \wedge u(\cdot, s_3) ds_3.$$

We write

$$(3.3) \quad u = U_e + \bar{u}$$

This displacement  $\bar{u}$  is the warping.

**Remark.** The elementary displacement  $U_e$  associated to the displacement  $u$  satisfies: for any elementary displacement  $V$ :

$$\int_{\{\hat{s}\} \times ]-\delta, \delta[} \{u - U_e\} \cdot V = 0 \quad \text{for a. e. } \hat{s} \in \omega.$$

The above equality can also serve as the definition of the elementary displacement  $U_e$ . □

The next theorem plays a fundamental role in the studies of plates and shells with the unfolding method. It provides sharp estimates of displacements  $U_e$  and  $\bar{u}$  in terms of  $\delta$  and of the strain energy of  $u$ .

**Theorem 3.1.** *Let  $u \in W^{1,p}(\mathcal{Q}_\delta; \mathbb{R}^3)$ ,  $1 < p < \infty$ , and  $U_e$  be the elementary displacement defined by (3.1)–(3.3). There exists  $\delta_1 \in ]0, \delta_0]$  which depends only on the middle surface of the shell such that for any  $\delta \leq \delta_1$  the following estimates hold :*

$$(3.4) \quad |U_e|_{\mathcal{E}, \mathcal{Q}_\delta, p} + |\bar{u}|_{\mathcal{D}, \mathcal{Q}_\delta, p} \leq C |u|_{\mathcal{E}, \mathcal{Q}_\delta, p}, \quad \|\bar{u}\|_{L^p(\mathcal{Q}_\delta; \mathbb{R}^3)} \leq C \delta |u|_{\mathcal{E}, \mathcal{Q}_\delta, p}.$$

The constants are independent of  $\delta$ .

**Proof .**

**Step 1 .** We prove that there exist  $R \geq 1$  depending only on  $\partial\omega$  and a family of open sets  $(\omega_{\delta,k})_{k \in \mathcal{N}_\delta}$  verifying

$$\bar{\omega} = \bigcup_{k \in \mathcal{N}_\delta} \bar{\omega}_{\delta,k}$$

and such that every open set of this family has a diameter less than  $R\delta$  and is star-shaped with respect to a disc of radius  $\delta/2$  and moreover such that any point of  $\omega$  belongs to a finite number (independent of  $\delta$ ) of sets  $\bar{\omega}_{\delta,k}$ .

The boundary of  $\omega$  is lipschitzian. Hence there exist constants  $C < B < A$  and  $M$  strictly positive, a finite number  $K$  of local coordinate systems  $(s_{1r}, s_{2r})$  in  $(O_r; \mathbf{e}_{1r}, \mathbf{e}_{2r})$  and mappings  $f_r : [0, A] \longrightarrow \mathbb{R}$ , Lipschitz continuous with ratio  $M$ ,  $1 \leq r \leq K$ , such that

$$\left\{ \begin{array}{l} \partial\omega = \bigcup_{r=1}^K \left\{ (s_{1r}, s_{2r}) \mid s_{2r} = f_r(s_{1r}), \quad s_{1r} \in ]B/2, A - B/2[ \right\}, \\ \left\{ \widehat{s} \in \omega \mid \text{dist}(\widehat{s}, \partial\omega) < C \right\} \subset \bigcup_{r=1}^K \left\{ (s_{1r}, s_{2r}) \mid f_r(s_{1r}) - B < s_{2r} < f_r(s_{1r}), \quad s_{1r} \in ]0, A[ \right\} \subset \omega, \\ \omega_C \setminus \omega \subset \bigcup_{r=1}^K \left\{ (s_{1r}, s_{2r}) \mid f_r(s_{1r}) < s_{2r} < f_r(s_{1r}) + B, \quad s_{1r} \in ]0, A[ \right\} \subset \mathbb{R}^2 \setminus \omega. \end{array} \right.$$

Through the use of easy geometrical arguments we show that if  $\delta \leq \inf\{C/2, B/4(M+1)\}$ , we have

$$\left\{ \widehat{s} \in \omega \mid \text{dist}(\widehat{s}, \partial\omega) < 2\delta \right\} \subset \bigcup_{r=1}^K \left\{ (s_{1r}, s_{2r}) \mid f_r(s_{1r}) - 2\delta(1+M) < s_{2r} < f_r(s_{1r}), \quad s_{1r} \in ]0, A[ \right\}.$$

We suppose also that  $\delta \leq \inf\{A/6, B/(6M+2)\}$ . Let  $N$  be an integer belonging to  $\left[ \frac{2}{3} \frac{A}{2\delta}, \frac{A}{2\delta} \right]$ , and set  $\alpha_k = k \frac{A}{2N}$ ,  $k \in \{0, \dots, 2N\}$ . We have  $N$  greater than 3 and  $\delta \leq \frac{A}{2N} \leq \frac{3}{2}\delta$ . For any  $k \in \{0, \dots, N-1\}$  the domains

$$\mathcal{B}_{\delta,k}^{(r)} = \left\{ (s_{1r}, s_{2r}) \mid f_r(s_{1r}) - 2\delta(3M+1) < s_{2r} < f_r(s_{1r}), \quad s_{1r} \in ]\alpha_{2k}, \alpha_{2(k+1)}[ \right\}$$

are star-shaped with respect to the disc centered at  $(\alpha_{2k+1}, f_r(\alpha_{2k+1}) - (3M+1)\delta)$  and of radius  $\delta/2$  and they have a diameter less than  $(8M+5)\delta = R\delta$ .

Now we complete the family of sets  $\mathcal{B}_{\delta,k}^{(r)}$ ,  $r \in \{1, \dots, K\}$  and  $k \in \{0, \dots, N-1\}$ , by taking all domains

$$]k\delta, (k+1)\delta[ \times ]l\delta, (l+1)\delta[, \quad (k, l) \in \mathbb{Z}^2$$

included in  $\omega$ . We denote  $(\omega_{\delta,k})_{k \in \mathcal{N}_\delta}$  the family of all these sets.

**Step 2 .**

The open set  $\Omega_{\delta,k} = \omega_{\delta,k} \times ]-\delta, \delta[$  has a diameter less than  $2R\delta$  and is star-shaped with respect to a ball centered on  $\omega$  and of radius  $\delta/2$  (here  $R_1 = 1/2$ ). The mapping  $\widehat{s} \mapsto (\mathbf{t}_1, \mathbf{t}_2, \mathbf{n})$  belongs to  $C^1(\overline{\omega}; (\mathbb{R}^3)^3)$ . Hence, there exists  $C_0 > 0$  which does not depend on  $\delta$  such that

$$\forall s \in \Omega_{\delta,k}, \quad \forall \widehat{s} \in \Omega_{\delta,k}, \quad \|\|\nabla\Phi(s) - \nabla\Phi(\widehat{s})\|\|_2 \leq C_0\delta$$

In the sequel we will work with the portions  $\mathcal{Q}_{\delta,k} = \Phi(\Omega_{\delta,k})$ ,  $k \in \mathcal{N}_\delta$ , of the shell.

Now we take  $\delta$  such that

$$\delta \leq \inf \left\{ \frac{c_0^3}{C_0 c_1^2} \left( \frac{1/2}{4(2R)} \right)^3, \delta_0 \right\}$$

Then we have

$$C_0\delta \leq \left( \frac{1/2}{4(2R)} \right)^3 \inf_{s \in \Omega_\delta} \{ \|\|\nabla\Phi(s)\|\|_2^3 \|\|(\nabla\Phi(s))^{-1}\|\|_2^2 \}$$

Thanks to corollary of Lemmas 4.1 and 4.2 (see Annexes) the domain  $\mathcal{Q}_{\delta,k}$  has a diameter less than  $6R\delta$  and is star-shaped with respect to a ball of radius  $\delta/16$ .

From Theorem 1.3 there exist rigid body displacements  $r_k$  such that

$$(3.5) \quad \mathcal{D}_p(u - r_k, \mathcal{Q}_{\delta,k}) \leq C\mathcal{E}_p(u, \mathcal{Q}_{\delta,k}), \quad \|u - r_k\|_{L^p(\mathcal{Q}_{\delta,k}; \mathbb{R}^3)}^p \leq C\delta^p \mathcal{E}_p(u, \mathcal{Q}_{\delta,k}),$$

where the constants do not depend on  $k$  and  $\delta$ .

Now we go on as in Theorem 2.1. Recall that the displacements  $r_k$  are of the form

$$r_k(x) = A_k + B_k \wedge (x - \phi(\widehat{s}_k)), \quad x \in \mathcal{Q}_{\delta,k}, \quad A_k, B_k \in \mathbb{R}^3,$$

where  $\widehat{s}_k$  is chosen in  $\omega_{\delta,k}$ . Taking the mean value on the fibers of the shell, and using definition (3.2) of  $\mathcal{U}$  and  $\mathcal{R}$ , we deduce the inequalities

$$(3.6) \quad \begin{cases} \|\|\mathcal{U} - A_k - B_k \wedge (\phi - \phi(\widehat{s}_k))\|\|_{L^p(\omega_{\delta,k}; \mathbb{R}^3)}^p \leq C\delta^{p-1} \mathcal{E}_p(u, \mathcal{Q}_{\delta,k}), \\ \|\|\mathcal{R} \wedge \mathbf{n} - B_k \wedge \mathbf{n}\|\|_{L^p(\omega_{\delta,k}; \mathbb{R}^3)}^p \leq \frac{C}{\delta} \mathcal{E}_p(u, \mathcal{Q}_{\delta,k}), \end{cases}$$

where the constants are independent of  $k$  and  $\delta$ . Consequently  $\|u - U_e\|_{L^p(\Omega_\delta; \mathbb{R}^3)} \leq C\delta \|u\|_{\mathcal{E}, \mathcal{Q}_\delta, p}$ , where  $C$  depends only on the middle surface of the shell and on  $p$ .

Note now that both functions  $\mathcal{U}$  and  $\mathcal{R}$  belong to  $W^{1,p}(\omega; \mathbb{R}^3)$ . We compute the derivatives of the displacement  $u$  to get

$$\frac{\partial u}{\partial s_1} = \nabla_x u (\mathbf{t}_1 + s_3 \frac{\partial \mathbf{n}}{\partial s_1}), \quad \frac{\partial u}{\partial s_2} = \nabla_x u (\mathbf{t}_2 + s_3 \frac{\partial \mathbf{n}}{\partial s_2}), \quad \frac{\partial u}{\partial s_3} = \nabla_x u \mathbf{n}.$$

Taking the restrictions of these derivatives to  $\Omega_{\delta,k}$ , from (3.5) we have the estimates

$$\left\| \frac{\partial u}{\partial s_\alpha} - B_k \wedge (\mathbf{t}_\alpha + s_3 \frac{\partial \mathbf{n}}{\partial s_\alpha}) \right\|_{L^p(\Omega_{\delta,k}; \mathbb{R}^3)}^p + \left\| \frac{\partial u}{\partial s_3} - B_k \wedge \mathbf{n} \right\|_{L^p(\Omega_{\delta,k}; \mathbb{R}^3)}^p \leq C \mathcal{E}_p(u, \mathcal{Q}_{\delta,k}).$$

By taking the mean value of  $\frac{\partial u}{\partial s_\alpha} - B_k \wedge (\mathbf{t}_\alpha + s_3 \frac{\partial \mathbf{n}}{\partial s_\alpha})$  on the fibers we get

$$(3.7) \quad \left\| \frac{\partial \mathcal{U}}{\partial s_\alpha} - B_k \wedge \mathbf{t}_\alpha \right\|_{L^p(\omega_{\delta,k}; \mathbb{R}^3)}^p \leq \frac{C}{\delta} \mathcal{E}_p(u, \Omega_{\delta,k}).$$

We now estimate the  $L^p$  norm of the derivatives of  $\mathcal{R} \wedge \mathbf{n}$  with respect to  $s_\alpha$

$$\begin{aligned}\mathcal{R} \wedge \mathbf{n} &= \frac{3}{2\delta^3} \int_{-\delta}^{\delta} s_3 \left[ u(\cdot, s_3) - (u(\cdot, s_3) \cdot \mathbf{n}) \mathbf{n} \right] ds_3 \\ \frac{\partial}{\partial s_\alpha} (\mathcal{R} \wedge \mathbf{n}) &= \frac{3}{2\delta^3} \int_{-\delta}^{\delta} s_3 \left[ \frac{\partial u}{\partial s_\alpha}(\cdot, s_3) - \left( \frac{\partial u}{\partial s_\alpha}(\cdot, s_3) \cdot \mathbf{n} \right) \mathbf{n} - (u(\cdot, s_3) \cdot \frac{\partial \mathbf{n}}{\partial s_\alpha}) \mathbf{n} - (u(\cdot, s_3) \cdot \mathbf{n}) \frac{\partial \mathbf{n}}{\partial s_\alpha} \right] ds_3\end{aligned}$$

Then we replace  $\frac{\partial u}{\partial s_\alpha}$  by  $B_k \wedge (\mathbf{t}_\alpha + s_3 \frac{\partial \mathbf{n}}{\partial s_\alpha})$  and  $u$  by  $A_k + B_k \wedge (\phi - \phi(\widehat{s}_k) + s_3 \mathbf{n})$ . We obtain

$$(3.8) \quad \left\| \frac{\partial}{\partial s_\alpha} (\mathcal{R} \wedge \mathbf{n}) - B_k \wedge \frac{\partial \mathbf{n}}{\partial s_\alpha} \right\|_{L^p(\omega_{\delta,k}; \mathbb{R}^3)}^p \leq \frac{C}{\delta^{p+1}} \mathcal{E}_p(u, \Omega_{\delta,k}).$$

From the above inequalities and from (3.6) we get  $\left\| \frac{\partial \bar{u}}{\partial s_i} \right\|_{L^p(\omega_{\delta,k}; \mathbb{R}^3)}^p \leq C \mathcal{E}_p(u, \Omega_{\delta,k})$ , hence with a change of variables  $|\bar{u}|_{\mathcal{D}, \mathcal{Q}_{\delta,p}} \leq C |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}}$ . Eventually observe that

$$|U_e|_{\mathcal{E}, \mathcal{Q}_{\delta,p}} \leq |U_e + \bar{u}|_{\mathcal{E}, \mathcal{Q}_{\delta,p}} + |\bar{u}|_{\mathcal{E}, \mathcal{Q}_{\delta,p}} \leq |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}} + |\bar{u}|_{\mathcal{D}, \mathcal{Q}_{\delta,p}} \leq C |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}}$$

where the constant does not depend on  $\delta$ . □

**Remark.** Thanks to (3.7) and (3.6) it follows by eliminating  $B_k$

$$(3.9) \quad \left\| \frac{\partial \mathcal{U}}{\partial s_\alpha} \cdot \mathbf{t}_\beta + \frac{\partial \mathcal{U}}{\partial s_\beta} \cdot \mathbf{t}_\alpha \right\|_{L^p(\omega)} + \left\| \frac{\partial \mathcal{U}}{\partial s_\alpha} \cdot \mathbf{n} + (\mathcal{R} \wedge \mathbf{n}) \cdot \mathbf{t}_\alpha \right\|_{L^p(\omega)} \leq \frac{C}{\delta^{1/p}} |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}}.$$

Now from (3.7) and (3.8) we obtain by eliminating  $B_k$

$$(3.10) \quad \left\| \frac{\partial}{\partial s_\alpha} (\mathcal{R} \wedge \mathbf{n}) \cdot \mathbf{t}_\beta + \frac{\partial \mathcal{U}}{\partial s_\beta} \cdot \frac{\partial \mathbf{n}}{\partial s_\alpha} \right\|_{L^p(\omega)} \leq \frac{C}{\delta^{1+1/p}} |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}}.$$

The constants do not depend on  $\delta$ . The inequality  $|U_e|_{\mathcal{E}, \mathcal{Q}_{\delta,p}} \leq C |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}}$  is equivalent to the above estimates (3.9) and (3.10) (see [6] for the expressions of the covariant components of the strain tensor). □

### 3. Second decomposition of displacements of a shell.

For any  $\eta > 0$  we denote  $\omega_\eta$  the open set

$$\omega_\eta = \{(s_1, s_2) \in \mathbb{R}^2 \mid \text{dist}((s_1, s_2), \omega) < \eta\}$$

In this section we assume that there exists  $l > 0$  and an extension of the mapping  $\phi$  (still denoted  $\phi$ ) belonging to  $\mathcal{C}^2(\bar{\omega}_l; \mathbb{R}^3)$  and still injective. The function  $\Phi$  (introduced below) is now defined on  $\bar{\omega}_l \times [-\delta_0, \delta_0]$  and we assume that it is a  $\mathcal{C}^1$ - diffeomorphism of that set onto its range and again verifies

$$\forall s \in \bar{\omega}_l \times [-\delta_0, \delta_0], \quad c_0 \leq \|\nabla \Phi(s)\|_2 \leq c_1.$$

**Lemma 3.2 .** *Let  $u$  be a displacement in  $W^{1,p}(\mathcal{Q}_\delta; \mathbb{R}^3)$ ,  $1 < p < \infty$ . There exists an extension  $P(u)$  of  $u$  to the shell*

$$\mathcal{Q}'_\delta = \Phi(\omega_{2\delta} \times ]-\delta, \delta[)$$

such that

$$P(u) \in W^{1,p}(\mathcal{Q}'_\delta; \mathbb{R}^3) \quad P(u)|_{\mathcal{Q}_\delta} = u \quad |P(u)|_{\mathcal{E}, \mathcal{Q}'_\delta, p} \leq C|u|_{\mathcal{E}, \mathcal{Q}_\delta, p}.$$

The constant does not depend of  $\delta$  and of  $u$ .

**Proof .** See Section V. □

From now on any displacement belonging to  $W^{1,p}(\mathcal{Q}_\delta; \mathbb{R}^3)$  is extended to a displacement belonging to  $W^{1,p}(\mathcal{Q}'_\delta; \mathbb{R}^3)$ . Again we denote  $u$  this extension.

Let  $B$  be the ball centered at the origin and of radius  $1/16$ . We put

$$|B| = \int_B dx \quad M = \int_B \|x\|_2^2 dx$$

To any displacement  $u$  of the shell we associate a new elementary displacement defined as follows :

**Definition 8 .** The elementary displacement  $U'_e$ , associated to  $u \in L^1(\mathcal{Q}'_\delta; \mathbb{R}^3)$ , is given by

$$(3.11) \quad U'_e(\cdot, s_3) = \mathcal{U}' + s_3 \mathcal{R}' \wedge \mathbf{n}, \quad s_3 \in ]-\delta, \delta[$$

where

$$(3.12) \quad \mathcal{U}'(\hat{s}) = \frac{1}{|B|} \int_B u(\phi(\hat{s}) + \delta x) dx, \quad \mathcal{R}'(\hat{s}) = \frac{3}{2M\delta} \int_B x \wedge u(\phi(\hat{s}) + \delta x) dx \quad \hat{s} \in \omega.$$

We write

$$(3.13) \quad u = U'_e + \bar{u}'$$

**Theorem 3.3 .** Let  $u \in W^{1,p}(\mathcal{Q}_\delta; \mathbb{R}^3)$ ,  $1 < p < \infty$ , and  $u = U'_e + \bar{u}'$  be the decomposition of  $u$  given by (3.11)–(3.13). There exists  $\delta'_1 \in ]0, \delta_0]$  which depends only on the middle surface of the shell such that for any  $\delta \leq \delta'_1$  the following estimates hold :

$$(3.14) \quad \begin{cases} \|\bar{u}'\|_{\mathcal{D}, \mathcal{Q}_\delta, p} \leq C|u|_{\mathcal{E}, \mathcal{Q}_\delta, p}, & \|\bar{u}'\|_{L^p(\mathcal{Q}_\delta; \mathbb{R}^3)} \leq C\delta|u|_{\mathcal{E}, \mathcal{Q}_\delta, p}, \\ \left\| \frac{\partial \mathcal{U}'}{\partial s_\alpha} - \mathcal{R}' \wedge \mathbf{t}_\alpha \right\|_{L^p(\omega; \mathbb{R}^3)} + \delta \left\| \frac{\partial \mathcal{R}'}{\partial s_\alpha} \right\|_{L^p(\omega; \mathbb{R}^3)} \leq \frac{C}{\delta^{1/p}} |u|_{\mathcal{E}, \mathcal{Q}_\delta, p}. \end{cases}$$

The constants are independent of  $\delta$ .

**Proof .** Let  $\mathcal{N}_\delta$  be the set of every  $(k, l) \in \mathbb{Z}^2$  such that the open set

$$\omega'_{\delta, kl} = ](k - 1/3)\delta, (k + 4/3)\delta[ \times ](l - 1/3)\delta, (l + 4/3)\delta[$$

is included in  $\omega_{2\delta}$ . We put

$$\omega_{\delta, kl} = ]k\delta, (k + 1)\delta[ \times ]l\delta, (l + 1)\delta[$$

We have

$$\omega \subset \bigcup_{(k, l) \in \mathcal{N}_\delta} \bar{\omega}_{\delta, kl}$$

The open set  $\Omega'_{\delta,kl} = \omega'_{\delta,kl} \times ]-\delta, \delta[$  has a diameter less than  $4\delta$  and it is star-shaped with respect to the ball centered at the point  $((k+1/2)\delta, (l+1/2)\delta)$  belonging to  $\omega$  and of radius  $\delta/2$ . The mapping  $\widehat{s} \mapsto (\mathbf{t}_1, \mathbf{t}_2, \mathbf{n})$  belongs to  $\mathcal{C}^1(\overline{\omega}_{2\delta_0}; (\mathbb{R}^3)^3)$ . There exists  $C'_0 > 0$  which does not depend on  $\delta$  such that

$$\forall (s, \widehat{s}) \in \Omega'_{\delta,kl} \times \Omega'_{\delta,kl}, \quad \|\|\nabla\Phi(s) - \nabla\Phi(\widehat{s})\|\|_2 \leq C_0\delta$$

In the sequel we will work with the portions  $\mathcal{Q}'_{\delta,kl} = \Phi(\Omega'_{\delta,kl})$ ,  $(k, l) \in \mathcal{N}_\delta$ , of the shell.

Now we take  $\delta$  such that

$$\delta \leq \frac{c_0^3}{C'_0 c_1^2} \left(\frac{1/2}{4.4}\right)^3$$

then we have

$$C'_0\delta \leq \left(\frac{1/2}{4.4}\right)^3 \inf_{s \in \Omega'_\delta} \{ \|\|\nabla\Phi(s)\|\|_2^3 \|\|\nabla\Phi(s)\|^{-1}\|_2^2 \}$$

Thanks to corollary of Lemmas 4.1 and 4.2 (see Section V) the domain  $\mathcal{Q}'_{\delta,kl}$  has a diameter less than  $12\delta$  and it is star-shaped with respect to a ball of radius  $\delta/16$ .

From Theorem 1.3 there exist rigid body displacements  $r_{kl}$  such that

$$(3.15) \quad \mathcal{D}_p(u - r_{kl}, \mathcal{Q}'_{\delta,kl}) \leq C\mathcal{E}_p(u, \mathcal{Q}'_{\delta,kl}), \quad \|u - r_{kl}\|_{L^p(\mathcal{Q}'_{\delta,kl}; \mathbb{R}^3)}^p \leq C\delta^p \mathcal{E}_p(u, \mathcal{Q}'_{\delta,kl}),$$

where the constants do not depend on  $k, l$  and  $\delta$ .

Now we go on as in Theorem 3.1. Recall that the displacements  $r_{kl}$  are of the form

$$r_{kl}(x) = A_{kl} + B_{kl} \wedge (x - \phi(\widehat{s}_{kl})), \quad x \in \mathcal{Q}'_{\delta,kl}, \quad A_{kl}, B_{kl} \in \mathbb{R}^3,$$

where  $\widehat{s}_{kl} = (k\delta, l\delta)$ . Using definition (3.11) of  $\mathcal{U}'$  and  $\mathcal{R}'$  we obtain

$$\begin{aligned} |\mathcal{U}'(\widehat{s}) - A_{kl} - B_{kl} \wedge (\phi(\widehat{s}) - \phi(\widehat{s}_{kl}))|^p &\leq \frac{1}{|B|} \int_B |(u - r_{kl})(\phi(\widehat{s}) + \delta x)|^p dx \leq \frac{1}{\delta^3 |B|} \int_{\mathcal{Q}'_{\delta,kl}} |(u - r_{kl})(x)|^p dx \\ |\mathcal{R}'(\widehat{s}) - B_{kl}|^p &\leq \frac{C}{\delta^p} \int_B |(u - r_{kl})(\phi(\widehat{s}) + \delta x)|^p dx \leq \frac{C}{\delta^{p+3}} \int_{\mathcal{Q}'_{\delta,kl}} |(u - r_{kl})(x)|^p dx \end{aligned}$$

The constant depends only on  $p$ . We integrate on  $\omega_{\delta,kl}$ . Thanks to (3.15) we obtain

$$(3.16) \quad \begin{cases} \|\mathcal{U}' - A_{kl} - B_{kl} \wedge (\phi - \phi(\widehat{s}_{kl}))\|_{L^p(\omega_{\delta,kl}; \mathbb{R}^3)}^p \leq C\delta^{p-1} \mathcal{E}_p(u, \mathcal{Q}'_{\delta,kl}), \\ \|\mathcal{R}' - B_{kl}\|_{L^p(\omega_{\delta,kl}; \mathbb{R}^3)}^p \leq \frac{C}{\delta} \mathcal{E}_p(u, \mathcal{Q}'_{\delta,kl}). \end{cases}$$

Consequently  $\|u - U'_e\|_{L^p(\Omega_\delta; \mathbb{R}^3)} \leq C\delta \|u\|_{\mathcal{E}, \mathcal{Q}'_{\delta,p}}$ , where  $C$  depends only on the middle surface of the shell and on  $p$ . Both functions  $\mathcal{U}'$  and  $\mathcal{R}'$  belong to  $W^{1,p}(\omega; \mathbb{R}^3)$ . We compute the derivatives of  $\mathcal{U}'$  and  $\mathcal{R}'$  to get

$$\frac{\partial \mathcal{U}'}{\partial s_\alpha}(\widehat{s}) = \frac{1}{|B|} \int_B \nabla_x u(\phi(\widehat{s}) + \delta x) \mathbf{t}_\alpha dx, \quad \frac{\partial \mathcal{R}'}{\partial s_\alpha}(\widehat{s}) = \frac{3}{2M\delta} \int_B x \wedge \nabla_x u(\phi(\widehat{s}) + \delta x) \mathbf{t}_\alpha dx$$

Hence

$$\left| \frac{\partial \mathcal{U}'}{\partial s_\alpha}(\widehat{s}) - B_k \wedge \mathbf{t}_\alpha \right|^p + \delta^p \left| \frac{\partial \mathcal{R}'}{\partial s_\alpha}(\widehat{s}) \right|^p \leq \frac{C}{\delta^3} \int_{\mathcal{Q}'_{\delta,kl}} |\nabla_x (u - r_{kl})(x)|^p dx$$

By integrating over  $\omega_{\delta,kl}$  we obtain

$$(3.17) \quad \left\| \frac{\partial \mathcal{U}'}{\partial s_\alpha} - B_k \wedge \mathbf{t}_\alpha \right\|_{L^p(\omega_{\delta,kl}; \mathbb{R}^3)}^p + \delta^p \left\| \frac{\partial \mathcal{R}'}{\partial s_\alpha} \right\|_{L^p(\omega_{\delta,kl}; \mathbb{R}^3)}^p \leq \frac{C}{\delta} \mathcal{E}_p(u, \mathcal{Q}'_{\delta,kl}).$$

Thanks to (3.16) and by summation we get

$$\left\| \frac{\partial \mathcal{U}'}{\partial s_\alpha} - \mathcal{R}' \wedge \mathbf{t}_\alpha \right\|_{L^p(\omega; \mathbb{R}^3)} + \delta \left\| \frac{\partial \mathcal{R}'}{\partial s_\alpha} \right\|_{L^p(\omega; \mathbb{R}^3)} \leq \frac{C}{\delta^{1/p}} |u|_{\mathcal{E}, \mathcal{Q}'_{\delta,p}}.$$

Now we estimate  $|\bar{u}'|_{\mathcal{D}, \mathcal{Q}_{\delta,p}}$ . We have

$$\begin{aligned} \frac{\partial \bar{u}'}{\partial s_3} &= \frac{\partial u}{\partial s_3} - \mathcal{R}' \wedge \mathbf{n} = [\nabla_x u \mathbf{n} - B_{kl} \wedge \mathbf{n}] - [\mathcal{R}' - B_{kl}] \wedge \mathbf{n} \\ \frac{\partial \bar{u}'}{\partial s_\alpha} &= \frac{\partial u}{\partial s_\alpha} - \frac{\partial \mathcal{U}'}{\partial s_\alpha} - s_3 \frac{\partial \mathcal{R}'}{\partial s_\alpha} \wedge \mathbf{n} - s_3 \mathcal{R}' \wedge \frac{\partial \mathbf{n}}{\partial s_\alpha} = \left[ \nabla_x u (\mathbf{t}_\alpha + s_3 \frac{\partial \mathbf{n}}{\partial s_\alpha}) - B_{kl} \wedge (\mathbf{t}_\alpha + s_3 \frac{\partial \mathbf{n}}{\partial s_\alpha}) \right] \\ &\quad - \left[ \frac{\partial \mathcal{U}'}{\partial s_\alpha} - B_{kl} \wedge \mathbf{t}_\alpha \right] - s_3 \frac{\partial \mathcal{R}'}{\partial s_\alpha} \wedge \mathbf{n} - s_3 (\mathcal{R}' - B_{kl}) \wedge \frac{\partial \mathbf{n}}{\partial s_\alpha} \end{aligned}$$

Thanks to (3.15), (3.16) and (3.17) we obtain  $\left\| \frac{\partial \bar{u}'}{\partial s_i} \right\|_{L^p(\Omega_{\delta,kl}; \mathbb{R}^3)}^p \leq C \mathcal{E}_p(u, \mathcal{Q}'_{\delta,kl})$ , and eventually  $|\bar{u}'|_{\mathcal{D}, \mathcal{Q}_{\delta,p}} \leq C |u|_{\mathcal{E}, \mathcal{Q}'_{\delta,p}}$ .  $\square$

Notice that the functions  $\mathcal{U}'$  and  $\mathcal{R}'$  are defined in  $\omega_\delta$ . They satisfy the estimates given in Theorem 3.3 also in  $\omega_\delta$ . Now we compare the elementary displacements  $U_e$  and  $U'_e$ .

**Corollary 1 .** *We have*

$$|U_e - U'_e|_{\mathcal{D}, \mathcal{Q}_{\delta,p}} \leq C |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}}, \quad \|U_e - U'_e\|_{L^p(\mathcal{Q}_\delta; \mathbb{R}^3)} \leq C \delta |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}}$$

Moreover

$$\begin{cases} \|\mathcal{U}' - \mathcal{U}\|_{L^p(\omega; \mathbb{R}^3)} \leq C \delta^{1-1/p} |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}}, & \|\mathcal{R}' \wedge \mathbf{n} - \mathcal{R} \wedge \mathbf{n}\|_{L^p(\omega; \mathbb{R}^3)} \leq C \delta^{-1/p} |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}}, \\ \left\| \frac{\partial \mathcal{U}'}{\partial s_\alpha} - \frac{\partial \mathcal{U}}{\partial s_\alpha} \right\|_{L^p(\omega; \mathbb{R}^3)} \leq C \delta^{-1/p} |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}}, & \left\| \frac{\partial}{\partial s_\alpha} (\mathcal{R}' \wedge \mathbf{n} - \mathcal{R} \wedge \mathbf{n}) \right\|_{L^p(\omega; \mathbb{R}^3)} \leq C \delta^{-1-1/p} |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}}. \end{cases}$$

The constants do not depend on  $\delta$ .

**Proof .** These estimates are immediate consequences of (3.4) and (3.14).  $\square$

Now we assume that the shell is fixed over its lateral boundary  $\Gamma_{0,\delta} = \Phi(\partial\omega \times ]-\delta, \delta])$ . If the displacement  $u$  is null over  $\Gamma_{0,\delta}$  then we have  $\mathcal{U} = \mathcal{R} = 0$  a. e. on  $\partial\omega$ . We extend the displacement  $u$  in  $\mathcal{Q}'_\delta \setminus \mathcal{Q}_\delta$  by 0. In this way we have  $\mathcal{U}'$  and  $\mathcal{R}'$  in  $H_0^1(\omega_\delta; \mathbb{R}^3)$  and moreover

$$(3.18) \quad \|\mathcal{U}'\|_{L^p(\partial\omega; \mathbb{R}^3)} + \delta \|\mathcal{R}'\|_{L^p(\partial\omega; \mathbb{R}^3)} \leq C \delta^{1-2/p} |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}}.$$

**Corollary 2 .** *(Korn's inequality). We suppose that the shell is fixed over  $\Gamma_{0,\delta}$ . Then we have*

$$|u|_{\mathcal{D}, \mathcal{Q}_{\delta,p}} + \|u\|_{L^p(\mathcal{Q}_\delta; \mathbb{R}^3)} \leq \frac{C}{\delta} |u|_{\mathcal{E}, \mathcal{Q}_{\delta,p}}$$

The constant does not depend on  $\delta$ .

**Proof .** This is an immediate consequence of (3.14), (3.18) and the Poincaré's inequality.  $\square$

## V. Appendix

We denote

- $\|x\|_2$  the euclidian norm of  $x$ ,
- $\|A\|_2$  the spectral norm of the matrix  $A$ ,
- $B(a; r)$  the ball centered at  $a$  and of radius  $r$ ,
- $I_3$  the unit matrix.

**Lemma 4.1 :** *Let  $\mathcal{U}$  be an open set included in  $B(O; R)$ , star-shaped with respect to the ball  $B(O; R_1)$  and  $\Phi$  the linear transformation*

$$\Phi(x) = Ax + b \text{ where } A \text{ is an invertible matrix and where } b \in \mathbb{R}^3.$$

*The open set  $\mathcal{V} = \Phi(\mathcal{U})$  is included in the ball  $B(b; \|A\|_2 R)$  and it is star-shaped with respect to the ball  $B(b; R_1/\|A^{-1}\|_2)$ .*

**Proof .** The open set  $\mathcal{V}$  is star-shaped with respect to the points of the set  $\Phi(B(O; R_1))$ . This set is included in the ball  $B(b; R_1/\|A^{-1}\|_2)$ .  $\square$

**Lemma 4.2 :** *Let  $\mathcal{U}$  be an open set included in  $B(O; R)$ , star-shaped with respect to the ball  $B(O; R_1)$  and  $\Phi$  a  $C^1$  diffeomorphism from  $\bar{\mathcal{U}}$  onto  $\bar{\mathcal{V}} = \Phi(\bar{\mathcal{U}})$  verifying*

$$\Phi(O) = O \quad \text{and} \quad \forall x \in \bar{\mathcal{U}} \quad \|\nabla\Phi(x) - I_3\|_2 \leq \left(\frac{R_1}{4R}\right)^3$$

*The open set  $\mathcal{V} = \Phi(\mathcal{U})$  is included in the ball  $B(O; 2R)$  and is star-shaped with respect to the ball  $B(O; R_1/4)$ .*

**Proof .** We put  $c = \left(\frac{R_1}{4R}\right)^3$ . For any  $(x, y) \in \bar{\mathcal{U}} \times \bar{\mathcal{U}}$  such that  $[x, y] \subset \bar{\mathcal{U}}$  we have

$$(4.1) \quad \|\Phi(x) - \Phi(y) - (x - y)\|_2 \leq c\|x - y\|_2 \implies \|\Phi(x) - x\|_2 \leq c\|x\|_2$$

The open set  $\mathcal{V}$  is included in the ball  $B(O; 2R)$  since  $\|\Phi(x)\|_2 \leq 2\|x\|_2$ .

Now we prove that the open set  $\mathcal{V}$  is star-shaped with respect to any point of the ball  $B(O; R_1/4)$ .

Let  $A$  be a point in the ball  $B(O; R_1/3)$ . We prove by contradiction that the open segment joining  $\Phi(A)$  to any point on the boundary of  $\mathcal{V}$  is included in  $\mathcal{V}$ .

Let  $y'$  be a point on the boundary of  $\mathcal{V}$ . There exists  $y \in \partial\mathcal{U}$  such that  $y' = \Phi(y)$ . We put  $A' = \Phi(A)$ . If the segment  $[A', y'[,$  contains a point  $z' = \Phi(z)$  on the boundary of  $\mathcal{V}$  then

$$z \in \partial\mathcal{U} \quad \text{and} \quad z' = \lambda A' + (1 - \lambda)y' \quad \lambda \in ]0, 1[.$$

From the second inequality in (4.1) we deduce that

$$\left. \begin{array}{l} \|A' - A\|_2 = \|\Phi(A) - A\|_2 \leq c\|A\|_2 \leq cR_1/3 \\ \|y' - y\|_2 = \|\Phi(y) - y\|_2 \leq c\|y\|_2 \leq cR \end{array} \right\} \implies \|z' - (\lambda A + (1 - \lambda)y)\|_2 \leq cR$$

Besides we get

$$\|z - (\lambda A + (1 - \lambda)y)\|_2 = \|[z - \Phi(z)] + [z' - (\lambda A + (1 - \lambda)y)]\|_2 \leq c\|z\|_2 + cR \leq 2cR \leq \frac{R_1}{32}$$

Hence  $z$  belongs to the coloured cylinder (see Figure 1). In Figure 2 we consider the plan containing  $A$ ,  $y$  and  $z$ . The point  $z$  belongs to the exterior of the convex hull of the set  $\overline{B(A; R_1/3)} \cup \{y\}$  (this convex hull minus  $\{y\}$  is included in  $\mathcal{U}$ ) and in the same way  $y$  is outside the convex hull of the set  $\overline{B(A; R_1/3)} \cup \{z\}$ . Then we have  $\|y - z\|_2 \leq \frac{\|y - A\|_2}{10}$  and  $\alpha \leq \widehat{zyA} \leq \pi - \alpha$ . The open set  $\mathcal{U}$  is star-shaped with respect to every point in the ball centered at  $A$  and of radius  $R_1/3$ . Moreover  $\frac{2R_1}{3} \leq \|y - A\|_2 \leq R + \frac{R_1}{3} \leq \frac{4R}{3}$  and  $\|z - A\|_2 \leq R + \frac{R_1}{3} \leq \frac{4R}{3}$ . Then we have

$$\frac{R_1}{3} \frac{3}{4R} \leq \sin(\alpha) \leq \frac{1}{2} \quad \text{and} \quad \frac{R_1}{3} \frac{3}{4R} \leq \sin(\beta)$$





Let  $x$  be the common point to the two coloured lines. We have

$$\|y - x\|_2 \leq \frac{\|y - z\|_2}{\sin(2\alpha)} \leq \frac{8R}{3R_1} \|y - z\|_2 \quad \|x - z\|_2 \leq \frac{\|y - z\|_2}{\sin(2\alpha)} \leq \frac{8R}{3R_1} \|y - z\|_2$$

since  $\sin(2\alpha) \geq \frac{3R_1}{8R}$ . The segments  $[y, x]$  and  $[x, z]$  are included in  $\overline{\mathcal{U}}$  so, from the inequalities (4.1) we obtain

$$\begin{aligned} \|(\Phi(y) - \Phi(A)) \wedge (\Phi(y) - \Phi(z) - (y - z))\|_2 &\leq \|\Phi(y) - \Phi(A)\|_2 \|\Phi(y) - \Phi(z) - (y - z)\|_2 \\ &\leq (1 + c) \frac{4R}{3} \|\Phi(y) - \Phi(z) - (y - z)\|_2 \\ &\leq (1 + c) \frac{4R}{3} \|(\Phi(y) - \Phi(x) - (y - x)) + (\Phi(x) - \Phi(z) - (x - z))\|_2 \\ &\leq (1 + c) \frac{4R}{3} c \{\|y - x\|_2 + \|x - z\|_2\} \leq c(1 + c) \frac{64}{9} \frac{R^2}{R_1} \|y - z\|_2 \end{aligned}$$

The points  $y' = \Phi(y)$ ,  $z' = \Phi(z)$  and  $A' = \Phi(A)$  are on the same line, hence

$$\begin{aligned} \|(\Phi(y) - \Phi(A)) \wedge (\Phi(y) - \Phi(z) - (y - z))\|_2 &= \|(\Phi(y) - \Phi(A)) \wedge (y - z)\|_2 \\ &= \|(y - A + [\Phi(y) - \Phi(A) - (y - A)]) \wedge (y - z)\|_2 \\ &\geq \|(y - A) \wedge (y - z)\|_2 - c \frac{4R}{3} \|y - z\|_2 \end{aligned}$$

We recall that  $\|y - A\|_2 \geq \frac{2R_1}{3}$  and  $\frac{R_1}{4R} \leq \sin(\alpha) \leq \sin(\widehat{zyA})$ . That gives

$$\frac{R_1^2}{6R} \|y - z\|_2 \leq \frac{R_1}{4R} \|y - z\|_2 \|y - A\|_2 \leq \|(y - A) \wedge (y - z)\|_2 \leq c \frac{4R}{3} \left[ (1+c) \frac{16R}{3R_1} + 1 \right] \|y - z\|_2 \implies c \geq \frac{R_1^3}{60R^3}$$

which is a contradiction. The open set  $\mathcal{V}$  is star-shaped with respect to the point  $\Phi(A)$ .

The ball  $B(O; R_1/4)$  is included in the range by  $\Phi$  of the ball  $B(O; R_1/3)$  since for every  $x' \in \mathcal{V}$  we have

$$\frac{1}{1+c} \|x'\|_2 \leq \|\Phi^{-1}(x')\|_2 \leq \frac{1}{1-c} \|x'\|_2$$

□

**Corollary of Lemmas 4.1 and 4.2 .** *Let  $\mathcal{U}$  be an open set included in the ball  $B(O; R)$ , star-shaped with respect to the ball  $B(O; R_1)$  and  $\Phi$  a  $C^1$  diffeomorphism from  $\overline{\mathcal{U}}$  onto  $\overline{\mathcal{V}} = \Phi(\overline{\mathcal{U}})$  verifying*

$$\forall x \in \overline{\mathcal{U}} \quad \|\|\nabla\Phi(x) - \nabla\Phi(O)\|\|_2 \leq \left(\frac{R_1}{4R}\right)^3 \|\|\nabla\Phi(O)\|\|_2^3 \|\|(\nabla\Phi(O))^{-1}\|\|_2^2$$

*The open set  $\mathcal{V} = \Phi(\mathcal{U})$  is included in a ball of radius  $2\|\|\nabla\Phi(O)\|\|_2 R$  and is star-shaped with respect to a ball of radius  $R_1/(4\|\|(\nabla\Phi(O))^{-1}\|\|_2)$ .*

**Proof .** We consider the mapping

$$\Psi_0(x) = \Phi(O) + \nabla\Phi(O)x \quad x \in \overline{\mathcal{U}}$$

The open set  $\mathcal{W} = \Psi_0(\mathcal{U})$  is included in the ball  $B(\Phi(O); R')$  ( $R' = \|\|\nabla\Phi(O)\|\|_2 R$ ) and it is star-shaped with respect to the ball  $B(\Phi(O); R'_1)$  ( $R'_1 = R_1/\|\|(\nabla\Phi(O))^{-1}\|\|_2$ ). Now let  $\Psi_1$  be the mapping  $\Psi_1 = \Phi \circ \Psi_0^{-1}$ . This map is a  $C^1$  diffeomorphism from  $\overline{\mathcal{W}}$  onto  $\overline{\mathcal{V}}$ . We have  $\Psi_1(\Phi(O)) = \Phi(O)$  and  $\Psi'_1(\Phi(O)) = I_3$ . Moreover

$$\begin{aligned} \forall y \in \mathcal{W} \quad \|\|\Psi'_1(y) - I_3\|\|_2 &\leq \|\|\nabla\Phi(\Psi_1^{-1}(y)) - \nabla\Phi(O)\|\|_2 \|\|(\nabla\Phi(O))^{-1}\|\|_2 \\ &\leq \|\|\nabla\Phi(\Psi_1^{-1}(y)) - \nabla\Phi(O)\|\|_2 \|\|(\nabla\Phi(O))^{-1}\|\|_2 = \left(\frac{R'_1}{4R'}\right)^3 \end{aligned}$$

The open set  $\mathcal{V}$  is included in a ball of radius  $R'$  and it is star-shaped with respect to a ball of radius  $R'_1/4$ . □

**Proof of Lemma 3.2 .**

We use again the mappings introduced in Step 1 of Theorem 3.1. Through the use of easy geometrical arguments we show that if  $\delta \leq \inf\{C/2, B/4(M+1)\}$ , we have

$$\begin{aligned} \omega_{2\delta} \setminus \omega &\subset \bigcup_{r=1}^K \left\{ (s_{1r}, s_{2r}) \mid f_r(s_{1r}) < s_{2r} < f_r(s_{1r}) + 2\delta(M+1), \quad s_{1r} \in ]0, A[ \right\}, \\ \{\widehat{s} \in \omega \mid \text{dist}(\widehat{s}, \partial\omega) < 2\delta\} &\subset \bigcup_{r=1}^K \left\{ (s_{1r}, s_{2r}) \mid f_r(s_{1r}) - 2\delta(M+1) < s_{2r} < f_r(s_{1r}), \quad s_{1r} \in ]0, A[ \right\}. \end{aligned}$$

Now we extend the displacement  $u \in W^{1,p}(\mathcal{Q}_\delta; \mathbb{R}^3)$  near the portion of the boundary given by the mapping  $f_r$ . We begin with  $r = 1$ . Without being detrimental to the general case we can suppose that  $(O_1; \mathbf{e}_{11}, \mathbf{e}_{21}) = (O; \mathbf{e}_1, \mathbf{e}_2)$ . In order to simplify the notation we replace  $f_1$  by  $f$ .

We suppose also that  $\delta \leq \inf\{A/12, B/(18M+2)\}$ . Let  $N$  be an odd integer belonging to  $\left[\frac{2}{3} \frac{A}{2\delta}, \frac{A}{2\delta}\right]$ . We set  $\alpha_k = k \frac{A}{2N}$ ,  $k \in \{0, \dots, 2N\}$ . We have  $N$  greater than 3 and  $\delta \leq \frac{A}{2N} \leq \frac{3}{2}\delta$ . For any  $k \in \{0, \dots, N-1\}$  the domains

$$\begin{aligned} \mathcal{B}_{\delta,k} &= \{(s_1, s_2) \mid f(s_1) - 2\delta(9M+1) < s_2 < f(s_1), \quad s_1 \in ]\alpha_{2k}, \alpha_{2(k+1)}[ \} \times ]-\delta, \delta[ \\ \mathcal{B}'_{\delta,k} &= \{(s_1, s_2) \mid f(s_1) - 2\delta(9M+1) < s_2 < f(s_1) + 2\delta(9M+1), \quad s_1 \in ]\alpha_{2k}, \alpha_{2(k+1)}[ \} \times ]-\delta, \delta[ \end{aligned}$$

are star-shaped with respect to the ball of center  $(\alpha_{2k+1}, f(\alpha_{2k+1}) + \delta(9M+1), 0)$  and of radius  $\delta/2$  and they have a diameter less than  $\delta(42M+9)$ . We put

$$k \in \left\{0, \dots, \frac{N-3}{2}\right\} \quad \begin{cases} \mathcal{C}_{\delta,k} = \text{interior}(\overline{\mathcal{B}_{\delta,2k}} \cup \overline{\mathcal{B}_{\delta,2k+1}} \cup \overline{\mathcal{B}_{\delta,2k+2}}) \\ \mathcal{C}'_{\delta,k} = \text{interior}(\overline{\mathcal{B}'_{\delta,2k}} \cup \overline{\mathcal{B}'_{\delta,2k+1}} \cup \overline{\mathcal{B}'_{\delta,2k+2}}) \\ \mathcal{C}''_{\delta,k} = \text{interior}(\overline{\mathcal{B}'_{\delta,2k}} \cup \overline{\mathcal{B}_{\delta,2k+1}} \cup \overline{\mathcal{B}'_{\delta,2k+2}}) \end{cases}$$

The open sets  $\mathcal{C}_{\delta,k}$  and  $\mathcal{C}'_{\delta,k}$  are star-shaped with respect to the ball of center  $(\alpha_{4k+3}, f(\alpha_{4k+3}) - \delta(9M+1), 0)$  and of radius  $\delta/2$  and they have a diameter less than  $(42M+15)\delta = R\delta$ .




Figure 3. The domain  $\mathcal{C}_{\delta,k} \cap \{s_3 = 0\}$

There exists  $C_0 > 0$  which does not depend on  $\delta$  such that

$$\forall (s, \tilde{s}) \in \mathcal{C}'_{\delta,k} \times \mathcal{C}'_{\delta,k}, \quad \|\|\nabla\Phi(s) - \nabla\Phi(\tilde{s})\|\|_2 \leq C_0\delta$$

In the sequel we will work with the portions  $\mathbb{B}_{\delta,k} = \Phi(\mathcal{B}_{\delta,k})$ ,  $\mathbb{B}'_{\delta,k} = \Phi(\mathcal{B}'_{\delta,k})$  and  $\mathbb{C}'_{\delta,k} = \Phi(\mathcal{C}'_{\delta,k})$  of the shell.

Now we take  $\delta$  such that

$$\delta \leq \inf \left\{ \frac{c_0^3}{C_0 c_1^2} \left(\frac{1}{4R}\right)^3, \delta_0 \right\}$$

Then we have

$$C_0\delta \leq \left(\frac{1}{4R}\right)^3 \inf_{s \in \Omega_\delta} \{ \|\|\nabla\Phi(s)\|\|_2^3 \|\|(\nabla\Phi(s))^{-1}\|\|_2^2 \}$$

Thanks to the corollary of Lemmas 4.1 and 4.2 the domains  $\mathbb{B}_{\delta,k}$  have a diameter less than  $3R\delta$  and they are star-shaped with respect to a ball of radius  $\delta/16$ . From Theorem 1.3 there exist rigid body displacements  $r_{2k}$ ,  $k \in \{0, \dots, \frac{N-1}{2}\}$  and  $\tilde{r}_k$ ,  $k \in \{0, \dots, \frac{N-3}{2}\}$  such that

$$(4.3) \quad \begin{cases} \mathcal{D}_p(u - r_{2k}, \mathbb{B}_{\delta,2k}) \leq C\mathcal{E}_p(u, \mathbb{B}_{\delta,2k}), \\ \|u - r_{2k}\|_{L^p(\mathbb{B}_{\delta,2k}; \mathbb{R}^3)}^p \leq C\delta^p \mathcal{E}_p(u, \mathbb{B}_{\delta,2k}), \end{cases} \quad \begin{cases} \mathcal{D}_p(u - \tilde{r}_k, \mathbb{C}_{\delta,k}) \leq C\mathcal{E}_p(u, \mathbb{C}_{\delta,k}), \\ \|u - \tilde{r}_k\|_{L^p(\mathbb{C}_{\delta,k}; \mathbb{R}^3)}^p \leq C\delta^p \mathcal{E}_p(u, \mathbb{C}_{\delta,k}), \end{cases}$$

where the constants do not depend on  $k$  and  $\delta$ .

We define the one-to-one mapping  $\Psi : \mathcal{C}'_{\delta,k} \rightarrow ]-3, 3[ \times ]-1, 1[ \times ]-1, 1[$  by

$$(s_1, s_2, s_3) \mapsto \left( \frac{s_1 - \alpha_{4k+3}}{\delta}, \frac{s_2 - f(s_1)}{\delta(18M+2)}, \frac{s_3}{\delta} \right)$$

We have

$$\forall s \in \mathcal{C}'_{\delta,k} \quad \det(\nabla \Psi(s)) = \frac{1}{(18M+2)\delta^3}.$$

For every  $k$  in  $\{0, \dots, \frac{N-1}{2}\}$ , the function  $(u - r_{2k}) \circ \Phi$  is defined on  $\mathcal{B}_{\delta,2k}$ . We extend  $(u - r_{2k}) \circ \Phi \circ \Psi^{-1}$  by reflexion and then we return in  $\mathbb{B}'_{\delta,2k}$  and we add  $r_{2k}$  to the obtained displacement. We call again  $u$  this new displacement. We have (the constants do not depend on  $k$  and  $\delta$ )

$$\mathcal{E}_p(u, \mathbb{B}'_{\delta,2k}) + \mathcal{D}_p(u - r_{2k}, \mathbb{B}'_{\delta,2k}) \leq C\mathcal{E}_p(u, \mathbb{B}_{\delta,2k}), \quad \|u - r_{2k}\|_{L^p(\mathbb{B}'_{\delta,2k}; \mathbb{R}^3)}^p \leq C\delta^p \mathcal{E}_p(u, \mathbb{B}_{\delta,2k}).$$




Figure 4. A portion of the boundary of the shell and the first extension of displacement  $u$ .

Thanks to (4.3) we can compare  $\tilde{r}_k$ ,  $r_{2k}$  and  $r_{2k+2}$ . We obtain

$$\mathcal{E}_p(u, \mathcal{C}''_{\delta,k}) + \mathcal{D}_p(u - \tilde{r}_k, \mathcal{C}''_{\delta,k}) \leq C\mathcal{E}_p(u, \mathbb{C}_{\delta,k}), \quad \|u - \tilde{r}_k\|_{L^p(\mathcal{C}''_{\delta,k}; \mathbb{R}^3)}^p \leq C\delta^p \mathcal{E}_p(u, \mathbb{C}_{\delta,k})$$

The function  $(u - \tilde{r}_k) \circ \Phi$  is defined on  $\mathcal{C}''_{\delta,k}$ . There exists a linear and continuous extension operator  $P$  from  $W^{1,p}(\cdot) \times ]-3, 3[ \times ]-1, 1[ \times ]-1, 1[$  into  $W^{1,p}(\cdot) \times ]-3, 3[ \times ]-1, 1[ \times ]-1, 1[$ . Using  $P$  we extend  $(u - \tilde{r}_k) \circ \Phi \circ \Psi^{-1}$  then we return in  $\mathcal{C}'_{\delta,2k}$  and we add  $\tilde{r}_k$  to the obtained displacement. We call again  $u$  this new displacement. We have

$$\mathcal{E}_p(u, \bigcup_{k=0}^{(N-3)/2} \mathcal{C}'_{\delta,k}) \leq C\mathcal{E}_p(u, \bigcup_{k=0}^{(N-3)/2} \mathbb{C}_{\delta,k}) \leq C\mathcal{E}_p(u, \mathcal{Q}_\delta)$$

Now we go on with the other portions of the boundary of the shell. We take  $r = 2$ . If the extension is already defined on a part of the domain  $\{(s_{12}, s_{22}) \mid f_2(s_{12}) < s_{22} < f_2(s_{12}) + B, \quad s_{12} \in ]0, A[ \}$ , we preserve only the part defined on the first or on the last domain of type  $\mathcal{B}'_{\delta,k}$ .  $\square$
