RESOLVENT CONDITIONS FOR THE CONTROL OF UNITARY GROUPS AND THEIR APPROXIMATIONS

LUC MILLER

ABSTRACT. A self-adjoint operator \mathcal{A} and an operator \mathcal{C} bounded from the domain $\mathcal{D}(\mathcal{A})$ with the graph norm to another Hilbert space are considered. The admissibility or the exact observability in finite time of the unitary group generated by $i\mathcal{A}$ with respect to the observation operator \mathcal{C} are characterized by some spectral inequalities on \mathcal{A} and \mathcal{C} . E.g. both properties hold if and only if $x \mapsto \|(\mathcal{A}-\lambda)x\| + \|\mathcal{C}x\|$ is a norm on $\mathcal{D}(\mathcal{A})$ equivalent to $x \mapsto \|(\mathcal{A}-\lambda)x\| + \|x\|$ uniformly with respect to $\lambda \in \mathbb{R}$.

This paper generalizes and simplifies some results on the control of unitary groups obtained using these so-called resolvent conditions, also known as Hautus tests. It proves new theorems on the equivalence (with respect to admissibility and observability) between first and second order equations, between groups generated by $i\mathcal{A}$ and $if(\mathcal{A})$ for positive \mathcal{A} and convex f , and between a group and its Galerkin approximations. E.g. they apply to the control of linear Schrödinger, wave and plates equations and to the uniform control of their finite element semi-discretization.

1. INTRODUCTION

1.1. Resolvent conditions. The notion of resolvent condition considered in this paper was introduced in control theory by David Russell and George Weiss in [RW94] as an infinite-dimensional version, for exponentially stable semigroups, of the Hautus test for controllability. Although this paper is self-contained, we refer to the monograph [TW09] for an introduction to and a full account of the control theory of semigroups, e.g. admissibility, exact controllability and the Hautus test, with applications to PDEs. This paper deals with the controllability of unitary groups rather than exponentially stable semigroups. We refer to [JZ09] for the history of this latter issue since [RW94] and the extension of the results on unitary groups in [Mil05] to more general groups. We refer to [DM09] for the investigation of resolvent conditions for parabolic semigroups, using §3.2 of the present paper.

Readers more familiar with the spectral theory of semigroups may consider these resolvent conditions as analogous to the better known resolvent condition for exponential stability [EN00, theorem V.1.11] due to Jan Prüss [Prü84], Fa Lun Huang [Hua85] and Günther Greiner, (after a key result on contraction semigroup by Larry Gearhart [Gea78] generalized to any semigroup in [Her83, How84]). Indeed the growth abscissa of a semigroup $(e^{t\mathcal{G}})_{t \geq 0}$ satisfies [Prü84, proposition 2]:

$$\omega_0(\mathcal{G}) := \inf_{t > 0} \ln \frac{\|e^{t\mathcal{G}}\|}{t} = \inf \left\{ \omega \in \mathbb{R} \mid \sup_{\operatorname{Re} \lambda \geq \omega} \|(\lambda - \mathcal{G})^{-1}\| < \infty \right\}.$$

The Greiner-Huang-Prüss test [Prü84, corollary 4] for *exponential stability* follows:

$$(1) \quad \omega_0(\mathcal{G}) < 0 \quad \Leftrightarrow \quad \exists M > 0, \forall \lambda \in \mathbb{C} \text{ such that } \operatorname{Re} \lambda > 0, \|(\lambda - \mathcal{G})^{-1}\| \leq M.$$

The analogous result for *exact controllability* of unitary group, or equivalently *exact observability*, is stated precisely in theorem 2.4. A self-adjoint operator \mathcal{A} on a Hilbert space X and an operator \mathcal{C} bounded from the domain $\mathcal{D}(\mathcal{A})$ with the graph norm to another Hilbert space are considered. The resolvent condition involved for the exact observability in finite time of the unitary group generated by $i\mathcal{A}$ with respect to the observation operator \mathcal{C} is

$$(2) \quad \exists M > 0, m > 0, \forall x \in \mathcal{D}(\mathcal{A}), \lambda \in \mathbb{R}, \quad \|x\|^2 \leq M\|(\mathcal{A} - \lambda)x\|^2 + m\|\mathcal{C}x\|^2.$$

1.2. Outline. Starting from the basic resolvent conditions characterizing admissibility in theorem 2.3 and exact controllability in theorem 2.4, this paper investigates various *other forms of resolvent conditions*, with variable coefficients, with restricted spectral parameter, with fractional powers of the generator. A quasimode approach to disproving exact controllability is introduced in §2.7. In §3 and §4, resolvent conditions are applied to unitary groups $(e^{it\mathcal{A}})_{t \in \mathbb{R}}$ with various positive \mathcal{A} build on the same positive self-adjoint operator denoted A in order to characterize and compare their admissibility and controllability properties. This improves on earlier results in [Liu97, Mil05, RTTT05] linking first and second order equations, and in [Erv08, Erv09, Erv11] linking infinite-dimensional equations and their finite-dimensional semi-discretization.

The first main application is the following rough statement concerning the observability in time T by the same general operator C (bounded from $\mathcal{D}(A)$):

$$\begin{aligned} \text{Wave } \ddot{w} + Aw = 0 \text{ for some } T &\Leftrightarrow \text{Wave Group } i\dot{v} + \sqrt{A}v = 0 \text{ for some } T \\ &\quad \Downarrow \text{(for any } s > 1) \\ \ddot{z} + A^s z = 0, \text{ any } T \text{ if } \sigma_{ess}(A) = \emptyset &\Leftrightarrow i\dot{\psi} + (\sqrt{A})^s \psi = 0, \text{ any } T \text{ if } \sigma_{ess}(A) = \emptyset \\ \text{Plates if } s = 2 &\quad \text{Schrödinger if } s = 2 \end{aligned}$$

If for example the resolvent of A is compact then the condition $\sigma_{ess}(A) = \emptyset$ holds (i.e. the spectrum of A is formed of isolated eigenvalues with finite multiplicity). For $s = 2$, the implication from waves to plates and the bottom equivalence between plates and Schrödinger are proved in [Liu97, Theorem 5.2] for C bounded on X using the Greiner-Huang-Prüss test (1) hence without explicit constants, therefore without information on the time T . Still for $s = 2$, the implication from Schrödinger to plates with the same control time T is proved in [TW09, Theorem.6.8.2] for unbounded C but under an extra eigenvalue condition. The proof by a simple isomorphism with explicit constants of the top equivalence between the wave equation and the wave group in theorem 3.8 seems to be new. The analysis of the constants in the downward implication from \sqrt{A} to its fractional powers in theorem 3.5 also seems to be new. Putting these two new facts together proves the downward implication from the wave equation for some T to the plate equation with any $s > 0$ and, if $\sigma_{ess}(A) = \emptyset$, for any T . Moreover, it yields this full scale of equivalent resolvent conditions for the observability of the wave equation:

$\exists s > 1, M_s > 0$ and $m_s > 0$,

$$\|x\|_1^2 \leq \frac{M_s}{\lambda^{2(1-1/s)}} \|(A^{s/2} - \lambda)x\|_1^2 + m_s \|Cx\|^2, \quad x \in H_{1+s}, \quad \lambda > 0.$$

where $H_s = \mathcal{D}(A^{s/2})$ with norm $\|u\|_s = \|A^{s/2}u\|$, with Sobolev-type index $s \in \mathbb{R}$. Corollary 3.9 proves this result and remark 3.16 provides more background.

The second main application is to obtain filtering scales for the uniform exact observability of the *semi-discretization* of exactly observable equations. As surveyed in [Zua05], exact controllability may be lost under numerical discretization as the mesh size h tends to zero due to the existence of high-frequency spurious solutions for which the group velocity vanishes.

One of the remedies, called *filtering*, is to restrict the semi-discretized equation to modes with eigenvalues lower than η/h^σ for some positive η and σ . It is proved in [IZ99, LZ02] that $\sigma = 2$ is optimal for the boundary observation of one-dimensional wave and plates equations with constant coefficients discretized on a uniform mesh. Resolvent conditions were first used in this context by Sylvain Ervedoza to tackle any dimension and non-uniform meshes (cf. [EZZ08] for time discretization). In a framework which applies to the finite-element discretization on quasi-uniform shape-regular meshes (cf. remark 4.1), he obtained in [Erv08] a filtering scale σ for the uniform exact observability of approximations of unitary groups with mildly unbounded observation (excluding boundary observation), basically $\sigma = 2/5$ for interior observation. This was improved by the author into $\sigma = 2/3$ and published in [Erv09, Erv11], cf. remark 4.15.

Section 4 provides a more general framework in which theorems 4.11 and 4.18 yield respectively $\sigma = 1$ and $\sigma = 2/3$ for the semi-discretization of interior and boundary observability on shape-regular meshes in the sense of finite elements (for the observation of the Schrödinger equation this improves respectively into $\sigma = 4/3$ and $\sigma = 1$ under the geometric condition of [BLR92], which is always satisfied in one space dimension). Conversely, theorem 4.12 is a kind of Trotter-Kato theorem

deducing admissibility and exact observability of a group from resolvent conditions for its filtered approximations. In this framework, theorems 4.14 and 4.19 deduce from the uniform exact observability of the filtered approximations that the minimal control provided by the Hilbert Uniqueness Method is the limit of the minimal controls for the filtered approximations. For second order systems, theorems 4.24 and 4.23 yield respectively $\sigma = 4/3$ and $\sigma = 2/3$ for the semi-discretization of interior and boundary observability, improving [Erv09], cf. remark 4.26. A forthcoming paper compares the approximate observation operator (95) introduced in theorem 4.23 where $\sigma = 2/3$ to those in [IZ99, theorems 3.2 and 3.3] which concern only the simplest system but reach the optimal value $\sigma = 2$.

We refer to [CMT11] for a new approximation method for interior control of second order systems with error estimates.

The bottom-line of this paper is to deal with resolvent conditions in the abstract unitary group framework and keep track of the coefficients in the most explicit manner. Some applications to PDEs are briefly given. Many more details and examples are given in [TW09]. Examples 3.12 and 3.18 seem to be new.

The semiclassical approach to proving these resolvent conditions can be found in [BZ04, Mil08]. E.g. [BZ04, theorem 8] gives a much simpler proof (based on stationary semiclassical measures) of the boundary control of Schrödinger equation under the sharp geometric condition for the wave equation than the original microlocal proof of [Leb92] (or the proof in [Mil04] based the space-time semiclassical measures). The proof of [BZ04, theorem 8] combined with the above resolvent condition for $s = 2$ yields the famous results of [BLR92] on the boundary control of the wave equation in a simpler way but without estimate on the control time. Indeed, combining the result of [BLR92] for the wave equation and a control transmutation method similar to [Phu01], [Mil05, theorem 10.2] yields more information on the Schrödinger equation (more precisely on the cost of fast controls) than the current resolvent condition approach.

1.3. Background. The first condition of type (2) was introduced by Kangsheng Liu in [Liu97, theorem 3.4] for second-order equations like the wave equation (hence M was replaced by M/λ in (2)) under the name “frequency domain condition”. It was adapted to first-order equations in [ZY97]. Liu used the Greiner-Huang-Prüss test (1) with $\mathcal{G} = i\mathcal{A} - \mathcal{C}^*\mathcal{C}$ (hence \mathcal{C} was replaced by $\mathcal{C}^*\mathcal{C}$ in (2)) taking advantage of the equivalence between exact controllability and exponential stabilizability. This strategy was limited to observations operator \mathcal{C} which are bounded on X and did not give information on the controllability time.

Conditions of type (2) were independently introduced by Nicolas Burq and Maciej Zworski in [BZ04, theorems 4 and 7] as sufficient to deduce results in the Control Theory of distributed parameter systems from the Spectral Theory of differential operators (one of these theorems is both semiclassical and spectrally localized, both theorems make intricate compatibility assumptions in addition to the resolvent condition). Their direct strategy overcomes both limitations: it allows boundary observation operators and it links the controllability time to the behavior of M for high frequency modes.

The final form of the theorem states that the resolvent condition (2) is both necessary and sufficient for controllability in some time T , with explicit relations between the constants M and m in (2) on the one hand, the time T , the admissibility constant and the control cost on the other hand (it does not assume the boundedness of \mathcal{C} on X or the compactness of the resolvent of \mathcal{A}). This theorem and its proof are repeated here as theorem 2.4 (and e.g. in [TW09, theorem 6.6.1]) from [Mil05, theorem 5.1]. The proof that the resolvent condition is necessary is close to the proof

in [RW94] of the stronger resolvent condition implied by the stronger assumption of exact observability on $[0, \infty)$. The proof of sufficiency using the Fourier transform is close and was inspired by the proof of [BZ04, theorem 7] where the resolvent is assumed compact. This proof shortcuts the use of the Greiner-Huang-Prüss test in [Liu97, ZY97].

The analogous result for *admissibility* is theorem 2.3 first proved under the additional assumption that the resolvent of \mathcal{A} is compact in [Erv11, theorem 2.2]. The new proof of this theorem 2.3 shortcuts the use of packets of eigenvectors in [Erv11] and unifies it with the simple proof of theorem 2.4. From reading [Erv11], Marius Tucsnak proved independently theorem 2.3, explicit constants excepted, as a direct consequence of older results of George Weiss, cf. remark 2.8.

We emphasize that, as in the proof of Greiner-Huang-Prüss test, the key point in the proof that the resolvent condition is sufficient (for both admissibility and exact controllability) is *the unitarity of the Fourier transform in Hilbert spaces* (Plancherel theorem) used in lemma 2.7. N.b. the two alternative proofs for admissibility in remark 2.8 both use the Paley-Wiener theorem on the unitarity of the Laplace transform which is also a consequence of the Plancherel theorem.

Alternatively, the Hautus rank condition for finite-dimensional state space may be stated as the following *eigenvectors condition* discussed in §2.6: for all eigenvector x of \mathcal{A} , $\mathcal{C}x \neq 0$. An infinite-dimensional version was introduced in [CFNS91] for the exponential stabilizability of unitary groups by a bounded damping perturbation (which is equivalent to the exact observability with bounded observation). It assumes that the resolvent of \mathcal{A} is compact and considers clusters of eigenvectors of \mathcal{A} rather than single ones. This version was called *wavepackets conditions* in [RTTT05], where the assumption that \mathcal{C} is bounded has been dropped using the resolvent condition in [Mil05, theorem 5.1]. They are discussed in the more general framework in §2.5. Sylvain Ervedoza in [Erv11, Erv09] introduced another equivalent version of the resolvent condition obtained by optimizing λ . This paper does not deal with this condition which he called *interpolation inequalities*.

2. RESOLVENT CONDITIONS FOR ADMISSIBILITY AND OBSERVABILITY

Most of this paper is about resolvent conditions for the *observation* of unitary groups. The dual notions of *control* are recalled in parallel in §2.1, but they are not used in any statement or proof of §2 and §3. Therefore *all considerations of duality could be skipped* (i.e. all statements mentioning X' , Y' , \mathcal{A}' , \mathcal{B} , ξ , A' , B , ϕ , ζ).

2.1. Framework for the control of unitary groups. In this section, we review the general setting for control systems conserving some “energy”: admissibility, observability and controllability notions and their duality (cf. [DR77, Wei89, TW09]).

Let X and Y be Hilbert spaces. Let $\mathcal{A} : \mathcal{D}(\mathcal{A}) \rightarrow X$ be a self-adjoint operator. Equivalently, $i\mathcal{A}$ generates a strongly continuous group $(e^{it\mathcal{A}})_{t \in \mathbb{R}}$ of unitary operators on X . In particular the norm is conserved: $\|e^{it\mathcal{A}}x\| = \|x\|$, $x \in X$, $t \in \mathbb{R}$. Let X_1 denote $\mathcal{D}(\mathcal{A})$ with the norm $\|x\|_1 = \|(\mathcal{A} - \beta)x\|$ for some $\beta \notin \sigma(\mathcal{A})$ ($\sigma(\mathcal{A})$ denotes the spectrum of \mathcal{A} , this norm is equivalent to the graph norm and X_1 is densely and continuously embedded in X) and let X_{-1} be the completion of X with respect to the norm $\|x\|_{-1} = \|(\mathcal{A} - \beta)^{-1}x\|$.

Let X' be a Hilbert space and $J : X' \rightarrow \mathcal{L}(X, \mathbb{C})$ be a conjugate linear Hilbert space isomorphism defined by some pairing $\langle \cdot, \cdot \rangle$ on $X \times X'$ which is linear on X and conjugate-linear on X' , i.e. $(J\xi)x = \langle x, \xi \rangle$ where $\langle \cdot, \cdot \rangle$ is a non-degenerate sesquilinear form such that $|\langle x, \xi \rangle| \leq \|x\| \|\xi\|$ and J is onto, n.b. $J(\alpha\xi) = \bar{\alpha}J\xi$. *From now on, the dual space $\mathcal{L}(X, \mathbb{C})$ of X is identified with X' by this pairing.* E.g. if this pairing is the inner product of X as in (29), then $X = X'$ and this is the Riesz identification; if this pairing is the inner product of a Hilbert space X_0 in

which X is continuously embedded as in (51), then X' is the dual of X with respect to the pivot space X_0 , cf. [TW09, §2.9]; similarly, if X' is continuously embedded in X_0 , then X is the dual of X' with respect to X_0 ; in (49) this pairing is not an inner product.

The dual of \mathcal{A} is a self-adjoint operator \mathcal{A}' on X' (if $J_R : X \rightarrow \mathcal{L}(X, \mathbb{C})$ denotes the Riesz isomorphism as in [TW09, §1.1], then the Hilbert space adjoint of \mathcal{A} is $\mathcal{A}^* = J_R^{-1} J \mathcal{A}' J^{-1} J_R$). The dual of X_1 is the space X'_{-1} which is the completion of X' with respect to the norm $\|\xi\|_{-1} = \|(\mathcal{A}' - \bar{\beta})^{-1} \xi\|$ and the dual of X_{-1} is the space X'_1 which is $\mathcal{D}(\mathcal{A}')$ with the norm $\|\xi\|_1 = \|(\mathcal{A}' - \bar{\beta})\xi\|$, cf. [TW09, §2.10].

Let $\mathcal{C} \in \mathcal{L}(X_1, Y)$ and let $\mathcal{B} \in \mathcal{L}(Y', X'_{-1})$ denote its dual.

We consider the dual observation and control systems with output function y and input function u :

$$(3) \quad \dot{x}(t) - i\mathcal{A}x(t) = 0, \quad x(0) = x_0 \in X, \quad y(t) = \mathcal{C}x(t),$$

$$(4) \quad \dot{\xi}(t) - i\mathcal{A}'\xi(t) = \mathcal{B}u(t), \quad \xi(0) = \xi_0 \in X', \quad u \in L^2_{\text{loc}}(\mathbb{R}; Y').$$

The following dual admissibility notions for the observation operator \mathcal{C} and the control operator \mathcal{B} are equivalent.

Definition 2.1. The system (3) is *admissible* if for some time $T > 0$ (an thus for any times by the group property) there is an admissibility cost K_T such that:

$$(5) \quad \int_0^T \|\mathcal{C}e^{it\mathcal{A}}x_0\|^2 dt \leq K_T \|x_0\|^2, \quad x_0 \in \mathcal{D}(\mathcal{A}).$$

The system (4) is *admissible* if for some time $T > 0$ (an thus for any times) there is an admissibility cost K_T such that:

$$(6) \quad \left\| \int_0^T e^{it\mathcal{A}'} \mathcal{B}u(t) dt \right\|^2 \leq K_T \int_0^T \|u(t)\|^2 dt, \quad u \in L^2(\mathbb{R}; Y').$$

The *admissibility constant* in time T is the smallest constant in (5), or equivalently in (6), still denoted K_T .

Under the admissibility assumption, the output map $x_0 \mapsto y$ from $\mathcal{D}(\mathcal{A})$ to $L^2_{\text{loc}}(\mathbb{R}; Y)$ has a continuous extension to X . The equations (3) and (4) have unique solutions $x \in C(\mathbb{R}, X)$ and $\xi \in C(\mathbb{R}, X')$ defined by:

$$(7) \quad x(t) = e^{it\mathcal{A}}x_0, \quad \xi(t) = e^{it\mathcal{A}'}\xi(0) + \int_0^t e^{i(t-s)\mathcal{A}'}\mathcal{B}u(s)ds.$$

The following dual notions of observability and controllability are equivalent.

Definition 2.2. The system (3) is *exactly observable* in time T at cost κ_T if the following observation inequality holds:

$$(8) \quad \|x_0\|^2 \leq \kappa_T \int_0^T \|y(t)\|^2 dt, \quad x_0 \in \mathcal{D}(\mathcal{A}).$$

The system (4) is *exactly controllable* in time T at cost κ_T if for all ξ_0 in X' , there is a u in $L^2(\mathbb{R}; Y')$ such that $u(t) = 0$ for $t \notin [0, T]$, $\xi(T) = 0$ and:

$$(9) \quad \int_0^T \|u(t)\|^2 dt \leq \kappa_T \|\xi_0\|^2.$$

The *controllability cost* in time T is the smallest constant in (9), or in (8), still denoted κ_T .

N.b. if the system is exactly controllable then, using the group property, for all ξ_0 and ξ_T in X' , there is a u in $L^2(\mathbb{R}; Y')$ such that $\int_0^T \|u(t)\|^2 dt \leq \kappa_T \|e^{iT\mathcal{A}'}\xi_0 - \xi_T\|^2$, $u(t) = 0$ for $t \notin [0, T]$, and the solution of the system (4) satisfies $\xi(T) = \xi_T$.

N.b. the assumption $\mathcal{C} \in \mathcal{L}(X_1, Y)$ covers most applications to PDEs but is not really necessary to apply this theory since [Wei89, remark 3.7] proves that any operator \mathcal{C} with a dense domain $\mathcal{D}(\mathcal{C})$ invariant by $(e^{it\mathcal{A}})_{t \geq 0}$ satisfying (5) with $\mathcal{D}(\mathcal{A})$ replaced by $\mathcal{D}(\mathcal{C})$ is in some sense equivalent to an operator in $\mathcal{L}(X_1, Y)$.

2.2. Basic resolvent conditions. In the general framework of §2.1, we consider the following conditions on \mathcal{C} and \mathcal{A} which are reminiscent of relative boundedness of \mathcal{C} with respect to \mathcal{A} (e.g. [EN00, definition 2.1]) and resolvent estimates for \mathcal{A} :

$$(10) \quad \exists L > 0, l > 0, \quad \forall x \in \mathcal{D}(\mathcal{A}), \lambda \in \mathbb{R}, \quad \|\mathcal{C}x\|^2 \leq L\|(\mathcal{A} - \lambda)x\|^2 + l\|x\|^2,$$

$$(11) \quad \exists M > 0, m > 0, \quad \forall x \in \mathcal{D}(\mathcal{A}), \lambda \in \mathbb{R}, \quad \|x\|^2 \leq M\|(\mathcal{A} - \lambda)x\|^2 + m\|\mathcal{C}x\|^2.$$

The following theorems say that these conditions are necessary and sufficient for admissibility and exact controllability respectively.

Theorem 2.3. *The system (3) is admissible if and only if the resolvent condition (10) holds. More precisely, (5) implies (10) with $L = TK_T$ and $l = 2K_T/T$. Conversely (10) implies (5) with $K_T = lT + \sqrt{lL}$.*

Theorem 2.4. *Assume that the system (3) is admissible. It is exactly observable if and only if the resolvent condition (11) holds. More precisely, (8) implies (11) with $M = T^2\kappa_T K_T$ and $m = 2T\kappa_T$. Conversely (11) implies (8) for all $T > \pi\sqrt{M}$ with $\kappa_T = 2mT/(T^2 - M\pi^2)$.*

Corollary 2.5. *The system (4) is admissible and exactly controllable if and only if $x \mapsto \|(\mathcal{A} - \lambda)x\| + \|\mathcal{C}x\|$ is a norm on $\mathcal{D}(\mathcal{A})$ equivalent to $x \mapsto \|(\mathcal{A} - \lambda)x\| + \|x\|$ uniformly with respect to $\lambda \in \mathbb{R}$.*

The proof uses lemmas which do not rely on the assumption that \mathcal{A} is self-adjoint.

Lemma 2.6. *For all $T > 0$, $x_0 \in \mathcal{D}(\mathcal{A})$, $\lambda \in \mathbb{R}$:*

$$\begin{aligned} T\|\mathcal{C}x_0\|^2 &\leq 2 \int_0^T \|\mathcal{C}e^{it\mathcal{A}}x_0\|^2 dt + T^2 \int_0^T \|\mathcal{C}e^{it\mathcal{A}}(\mathcal{A} - \lambda)x_0\|^2 dt, \\ \int_0^T \|\mathcal{C}e^{it\mathcal{A}}x_0\|^2 dt &\leq 2T\|\mathcal{C}x_0\|^2 + T^2 \int_0^T \|\mathcal{C}e^{it\mathcal{A}}(\mathcal{A} - \lambda)x_0\|^2 dt. \end{aligned}$$

Proof. Set $x(t) = e^{it\mathcal{A}}x_0$, $z(t) = x(t) - e^{it\lambda}x_0$ and $f = i(\mathcal{A} - \lambda)x_0$. Since $\dot{x}(t) = i\mathcal{A}x(t) = e^{it\mathcal{A}}(i\lambda x_0 + f) = i\lambda x(t) + e^{it\mathcal{A}}f$, we have $\dot{z}(t) = i\lambda z(t) + e^{it\mathcal{A}}f$ and therefore $z(t) = \int_0^t e^{i(t-s)\lambda} e^{is\mathcal{A}}f ds$.

We plug it in $e^{it\lambda}x_0 = x(t) - z(t)$ and $x(t) = e^{it\lambda}x_0 + z(t)$ to estimate:

$$\begin{aligned} \int_0^T |e^{it\lambda}|^2 dt \|\mathcal{C}x_0\|^2 &\leq 2 \int_0^T \|\mathcal{C}x(t)\|^2 dt + 2 \int_0^T t \int_0^t |e^{i(t-s)\lambda}|^2 \|\mathcal{C}e^{is\mathcal{A}}f\|^2 ds dt, \\ \int_0^T \|\mathcal{C}x(t)\|^2 dt &\leq 2 \int_0^T |e^{it\lambda}|^2 dt \|\mathcal{C}x_0\|^2 + 2 \int_0^T t \int_0^t |e^{i(t-s)\lambda}|^2 \|\mathcal{C}e^{is\mathcal{A}}f\|^2 ds dt. \end{aligned}$$

Since $\lambda \in \mathbb{R}$, we have $|e^{it\lambda}| = |e^{i(t-s)\lambda}| = 1$. Now the inequality:

$$\int_0^T t \int_0^t F(s) ds dt \leq \int_0^T t \int_0^T F(s) ds dt = (T^2/2) \int_0^T F(s) ds$$

with $F(s) = \|\mathcal{C}e^{is\mathcal{A}}f\|^2$ completes the proof of the lemma. \square

Lemma 2.7. *For all Lipschitz function χ with compact support in \mathbb{R} , $x_0 \in \mathcal{D}(\mathcal{A})$,*

$$(10) \Rightarrow \int \|\mathcal{C}e^{it\mathcal{A}}x_0\|^2 \chi^2(t) dt \leq \int \|e^{it\mathcal{A}}x_0\|^2 (L\dot{\chi}^2(t) + l\chi^2(t)) dt,$$

$$(11) \Rightarrow \int \|e^{it\mathcal{A}}x_0\|^2 (\chi^2(t) - M\dot{\chi}^2(t)) dt \leq m \int \|\mathcal{C}e^{it\mathcal{A}}x_0\|^2 \chi^2(t) dt,$$

Proof. Let $x_0 \in \mathcal{D}(\mathcal{A})$, $x(t) = e^{it\mathcal{A}}x_0$, $z = \chi x$ and $f = \dot{z} - i\mathcal{A}z$. Since $\dot{x} = i\mathcal{A}x$, we have $f = \dot{\chi}x$. The Fourier transform of f is $\hat{f}(\tau) = -i(\mathcal{A} - \tau)\hat{z}(\tau)$. Applying (10) and (11) with $x = \hat{z}(\tau)$ and $\lambda = \tau$ and integrating with respect to τ yield:

$$\int \|\mathcal{C}\hat{z}\|^2 d\tau \leq L \int \|\hat{f}\|^2 d\tau + l \int \|\hat{z}\|^2 d\tau, \quad \int \|\hat{z}\|^2 d\tau \leq m \int \|\mathcal{C}\hat{z}\|^2 d\tau + M \int \|\hat{f}\|^2 d\tau.$$

The proof of the lemma is completed by plugging the equations

$$\int \|\hat{z}\|^2 d\tau = \int \|x\|^2 \chi^2 dt, \quad \int \|\hat{f}\|^2 d\tau = \int \|x\|^2 \dot{\chi}^2 dt, \quad \int \|\mathcal{C}\hat{z}\|^2 d\tau = \int \|\mathcal{C}x\|^2 \chi^2 dt.$$

resulting from the unitarity of the Fourier transform, i.e. Plancherel theorem. \square

Proof of theorems 2.3 and 2.4. The implications result immediately from lemma 2.6. The converse results from lemma 2.7 with the following choices of χ .

To prove the converse in theorem 2.3, we take $\chi(t) = 1$ on $[0, T]$. We have

$$(12) \quad \int_0^T \|\mathcal{C}e^{it\mathcal{A}}x_0\|^2 dt \leq \int \|\mathcal{C}e^{it\mathcal{A}}x_0\|^2 \chi^2(t) dt$$

and, since $(e^{it\mathcal{A}})_{t \geq 0}$ is a unitary group, the resolvent condition (10) and lemma 2.7 imply the admissibility inequality (5) with $K_T = \int (L\chi^2(t) + l\dot{\chi}^2(t)) dt$. Taking the support of χ equal to $[-\tau, T + \tau]$ and $\chi(T + t) = \chi(-t) = \sinh(\omega(\tau - t)) / \sinh(\omega\tau)$, $t \in [0, \tau]$, with $\omega = \sqrt{l/L}$, yields $K_T = Tl + \sqrt{Ll} \sinh(2\omega\tau) / \sinh^2(\omega\tau) \rightarrow Tl + \sqrt{Ll}$ as $\tau \rightarrow +\infty$.

To prove the converse in theorem 2.4, we take $\chi(t) = \phi(t/T)$ with the support of ϕ equal to $[0, 1]$ and $\phi(t) = \sin(\pi t)$ for $t \in [0, 1]$. We have

$$\int \|\mathcal{C}e^{it\mathcal{A}}x_0\|^2 \chi^2(t) dt \leq \|\phi\|_{L^\infty}^2 \int_0^T \|\mathcal{C}e^{it\mathcal{A}}x_0\|^2 dt = \int_0^T \|\mathcal{C}e^{it\mathcal{A}}x_0\|^2 dt,$$

and since $(e^{it\mathcal{A}})_{t \geq 0}$ is a unitary group:

$$\int \|e^{it\mathcal{A}}x_0\|^2 (\chi^2(t) - M\dot{\chi}^2(t)) dt = \|x_0\|^2 I_T$$

with

$$I_T = \int \left(\phi^2\left(\frac{t}{T}\right) - \frac{M}{T^2} \dot{\phi}^2\left(\frac{t}{T}\right) \right) dt = \frac{\int \phi^2(t) dt}{T} \left(T^2 - M \frac{\int \dot{\phi}^2(t) dt}{\int \phi^2(t) dt} \right) = \frac{T^2 - M\pi^2}{2T}.$$

Thus, for all $T > \sqrt{M}\pi$, (11) and lemma 2.7 imply (8) with $\kappa_T = m/I_T$. \square

REMARK 2.8. Concerning the first statement of the admissibility theorem 2.3 (i.e. without the explicit relation between the constants in (5) and (10)) Marius Tucsnak pointed out that the necessity of the resolvent condition (10) results directly from [TW09, theorem 4.3.7], and the sufficient from [TW09, corollary 5.2.4] with $\alpha = 1$. For completeness, we recall [TW09, corollary 5.2.4]: if \mathcal{G} generates a right-invertible semigroup, $\mathcal{C} \in \mathcal{L}(\mathcal{D}(\mathcal{G}), Y)$, $\alpha > \omega_0(\mathcal{G})$ and $\|\mathcal{C}(\alpha + i\lambda - \mathcal{G})^{-1}\|$ is bounded for $\lambda \in \mathbb{R}$ then the system $(\mathcal{G}, \mathcal{C})$ is admissible. N.b. taking $\mathcal{G} = i\mathcal{A}$, since \mathcal{A} is self-adjoint, $\|((1 + i\lambda) - \mathcal{G})x\|^2 = \|(\lambda - \mathcal{A})x\|^2 + \|x\|^2$. We also recall that [TW09, corollary 5.2.4] follows from a result of [Wei89], was first explicitly stated in [HW91], and was given an alternative shorter proof in [Zwa05, theorem 2.2]: as pointed out in the introduction, both proofs use the unitarity of the Laplace transform between $L^2(0, \infty)$ and the Hardy space \mathcal{H}^2 on the right half-plane.

2.3. Resolvent conditions with variable coefficients and restricted spectral interval. In this subsection, we consider resolvent conditions more general than (10) and (11) in two ways.

Firstly we allow the coefficients to vary (e.g. this is necessary to obtain the characterization for second order systems in §3.2):

$$(13) \quad \|Cx\|^2 \leq L(\lambda)\|(\mathcal{A} - \lambda)x\|^2 + l(\lambda)\|x\|^2, \quad x \in \mathcal{D}(\mathcal{A}), \quad \lambda \in \mathbb{R},$$

$$(14) \quad \|x\|^2 \leq M(\lambda)\|(\mathcal{A} - \lambda)x\|^2 + m(\lambda)\|Cx\|^2, \quad x \in \mathcal{D}(\mathcal{A}), \quad \lambda \in \mathbb{R},$$

where l, L, m and M are locally bounded positive functions on \mathbb{R} .

N.b. (13) and (14) can be easily extended to $\lambda \in \mathbb{C}$ since \mathcal{A} is self-adjoint: $\|(\mathcal{A} - \lambda - i\mu)x\|^2 = \|(\mathcal{A} - \lambda)x\|^2 + \mu^2\|x\|^2 \geq \|(\mathcal{A} - \lambda)x\|^2$ for real λ and μ .

Secondly we restrict the interval for the spectral parameter λ (many proofs of §3 rely on this). Recall that $\sigma(\mathcal{A})$ denotes the spectrum of \mathcal{A} . Let $\inf \mathcal{A}$, $\sup \mathcal{A}$ and $[\sigma](\mathcal{A})$ denote its infimum, supremum and convex hull (i.e. the smallest interval containing it). E.g. if $\inf \mathcal{A} > -\infty$ and $\sup \mathcal{A} = +\infty$ then $[\sigma](\mathcal{A}) = [\inf \mathcal{A}, +\infty)$. We always assume $\inf \mathcal{A} \neq \sup \mathcal{A}$. The following proposition says that there is no loss in restricting (13) and (14) to $\lambda \in [\sigma](\mathcal{A})$:

$$(15) \quad \|Cx\|^2 \leq L_\sigma(\lambda)\|(\mathcal{A} - \lambda)x\|^2 + l_\sigma(\lambda)\|x\|^2, \quad x \in \mathcal{D}(\mathcal{A}), \quad \lambda \in [\sigma](\mathcal{A}),$$

$$(16) \quad \|x\|^2 \leq M_\sigma(\lambda)\|(\mathcal{A} - \lambda)x\|^2 + m_\sigma(\lambda)\|Cx\|^2, \quad x \in \mathcal{D}(\mathcal{A}), \quad \lambda \in [\sigma](\mathcal{A}),$$

where $l_\sigma, L_\sigma, m_\sigma$ and M_σ are locally bounded positive functions on $[\sigma](\mathcal{A})$. This proposition discusses how to extend the functions $l_\sigma, L_\sigma, m_\sigma$ and M_σ in (15) and (16) into l, L, m and M for which (13) and (14) hold (the converse being obvious).

Proposition 2.9. *The restricted resolvent condition (16) implies (14) with functions (M, m) which are the following extensions of (M_σ, m_σ) :*

- (i) *If the spectrum of A is bounded from below but not from above then for each $\lambda < \inf \mathcal{A}$ define $(M, m)(\lambda) = (M_\sigma, m_\sigma)(2 \inf \mathcal{A} - \lambda)$. N.b. if $\inf \mathcal{A} \geq 0$, $\sup \mathcal{A} = +\infty$, M_σ and m_σ are nonincreasing then one may define more simply, for $\lambda \in \mathbb{R}$, $(M, m)(\lambda) = (M_\sigma, m_\sigma)(\max\{\inf \mathcal{A}, |\lambda|\})$.*
- (ii) *If the spectrum of A is bounded then for each $\lambda \notin [\sigma](\mathcal{A})$ define M and m as the supremum of M_σ and the supremum of m_σ respectively.*
- (iii) *In particular, if M_σ and m_σ are constants then $(M, m) = (M_\sigma, m_\sigma)$ is always suitable.*

With the same extensions of (L_σ, l_σ) into (L, l) , (15) implies (13).

Proof. The spectral theorem yields for any non-negative self-adjoint operators B :

$$(17) \quad \|(B - \mu)x\| \leq \|(B + \mu)x\|, \quad x \in \mathcal{D}(B), \quad \mu > 0.$$

This results from writing $B - \mu = (B + \mu)f(B/\mu)$, where $f(t) = (t - 1)/(t + 1)$ remains in $[-1, 1]$ for $t \in [0, \infty)$. Applying (17) with $\mu = \inf \mathcal{A} - \lambda$ yields,

$$(18) \quad \|(\mathcal{A} - (2 \inf \mathcal{A} - \lambda))x\| \leq \|(\mathcal{A} - \lambda)x\|, \quad \lambda \leq \inf \mathcal{A}.$$

The choice in (i) results from (18). The last sentence in (i) results from $2 \inf \mathcal{A} - \lambda \geq \max\{\inf \mathcal{A}, -\lambda\}$ for $\lambda \leq \inf \mathcal{A}$.

To prove (ii) we assume that both $\inf \mathcal{A}$ and $\sup \mathcal{A}$ are finite, (16) holds and we define M and m as the supremum of M_σ and m_σ respectively. Thanks to (18), (14) holds for $\lambda \in [2 \inf \mathcal{A} - \sup \mathcal{A}, \sup \mathcal{A}]$. Applying (17) recursively with $B = \mathcal{A} - (\inf \mathcal{A} - n(\sup \mathcal{A} - \inf \mathcal{A}))$ and $\mu = \inf \mathcal{A} - n(\sup \mathcal{A} - \inf \mathcal{A}) - \lambda$ for $n \in \mathbb{N}$ yields that it still holds for $\lambda \in [\inf \mathcal{A} - (n + 1)(\sup \mathcal{A} - \inf \mathcal{A}), \sup \mathcal{A}]$ for all $n \in \mathbb{N}$, i.e. for all $\lambda \leq \sup \mathcal{A}$. It still holds for all $\lambda \geq \sup \mathcal{A}$ by a similar recurrence with $B = \sup \mathcal{A} + n(\sup \mathcal{A} - \inf \mathcal{A}) - \mathcal{A}$ and $\mu = \lambda - (\sup \mathcal{A} + n(\sup \mathcal{A} - \inf \mathcal{A}))$. \square

The following proposition says that there is only a loss of a factor 4 in the main coefficient in restricting (13) and (14) to the sheer spectrum of \mathcal{A} :

$$(19) \quad \|\mathcal{C}x\|^2 \leq L_\sigma(\lambda)\|(\mathcal{A} - \lambda)x\|^2 + l_\sigma(\lambda)\|x\|^2, \quad x \in \mathcal{D}(\mathcal{A}), \quad \lambda \in \sigma(\mathcal{A}),$$

$$(20) \quad \|x\|^2 \leq M_\sigma(\lambda)\|(\mathcal{A} - \lambda)x\|^2 + m_\sigma(\lambda)\|\mathcal{C}x\|^2, \quad x \in \mathcal{D}(\mathcal{A}), \quad \lambda \in \sigma(\mathcal{A}),$$

where l_σ , L_σ , m_σ and M_σ are locally bounded positive functions on $\sigma(\mathcal{A})$.

Proposition 2.10. *The system (3) is admissible (resp. exactly observable) if and only if the resolvent condition (19) (resp. (20)) holds for some constant l_σ and L_σ (resp. for some constant m_σ and M_σ).*

More precisely, (20) implies (14) with functions $(M, m)(\lambda) = (4M_\sigma, m_\sigma)(\pi(\lambda))$ where $\pi(\lambda)$ denotes the spectral value closest to λ . When the distance of λ to the spectrum of \mathcal{A} is large enough this improves into $(M, m)(\lambda) = (|\lambda - \pi(\lambda)|^{-2}, 0)$. With the same definition of (L_σ, l_σ) from (L, l) , (19) implies (13).

Proof. If $\lambda \notin \sigma(\mathcal{A})$, then the spectral theorem yields $\|(\mathcal{A} - \lambda)^{-1}\| \leq |\pi(\lambda) - \lambda|^{-1}$. Hence $\|(\mathcal{A} - \pi(\lambda))x\| \leq \|(\mathcal{A} - \lambda)x\| + \|(\lambda - \pi(\lambda))x\| \leq 2\|(\mathcal{A} - \lambda)x\|$. \square

N.b. the characterization of observability in proposition 2.10 was proved by contradiction in [ZY97] (for bounded C) without explicit constants.

2.4. Resolvent conditions with variable coefficients and the controllability time. From theorem 2.4 and proposition 2.9(iii), if the resolvent condition (16) holds with constant M_σ and m_σ then exact controllability holds in time $T > \pi\sqrt{M_\sigma}$. Hence, if the resolvent condition (16) holds with a smaller coefficient M_σ on some part of the spectrum then the corresponding part of the system is controllable in a shorter time.

The following proposition ensures that the full system is actually controllable in this shorter time provided the spectral subspace of the complementary part of the spectrum is finite dimensional. Although its statement is slightly different from [TW09, proposition 6.4.4] (which does not assume that \mathcal{A} is self-adjoint), its proof is so close to that of Tucsnak and Weiss that it is omitted here. It is based on their earlier simultaneous controllability result in [TW00], cf. [TW09, theorem 6.4.2].

Proposition 2.11. *Assume that the system (3) is admissible and that there is a finite set S of eigenvalues λ of \mathcal{A} such that $V_\lambda = \ker(\mathcal{A} - \lambda)$ is finite dimensional and all the eigenvectors $x_\lambda \in V_\lambda$ satisfy $\mathcal{C}x_\lambda \neq 0$.*

If exact observability in time $T_0 > 0$ holds for the restricted system

$$\dot{x}(t) - i\mathcal{A}_0x(t) = 0, \quad x(0) = x_0 \in X_0, \quad y(t) = \mathcal{C}x(t),$$

where $\mathcal{A}_0 = \mathbf{1}_{\mathcal{A} \notin S} \mathcal{A}$ is the restriction of \mathcal{A} to the orthogonal space $X_0 = X_S^\perp$ of $X_S = \mathbf{1}_{\mathcal{A} \in S} X = \bigoplus_{\lambda \in S} V_\lambda$ in X , then it also holds for the full system (3).

The following propositions improve the basic time estimate in theorem 2.4. They says roughly that, when computing the control time from M_σ , any compact part of the discrete spectrum can be discarded: in other words, only the essential spectrum matters including $\pm\infty$ when they are limit points of the spectrum.

Proposition 2.12. *Assume that the system (3) is admissible and that the resolvent condition (16) holds with a constant coefficient m_σ . From the other coefficient M_σ , define the essential coefficient*

$$M_{ess} = \inf_{K \in \mathbb{R} \setminus \sigma_{ess}(\mathcal{A})} \sup_{\lambda \in [\sigma(\mathcal{A}) \setminus K]} M_\sigma(\lambda),$$

where $K \in \mathbb{R} \setminus \sigma_{ess}(\mathcal{A})$ means that K is a compact subset of \mathbb{R} which does not intersect the essential spectrum of \mathcal{A} .

Then the system (3) is exactly observable for all time $T > \pi\sqrt{M_{ess}}$.

N.b. if $\sigma(\mathcal{A})$ is bounded from below and $\sigma_{ess}(\mathcal{A}) = \emptyset$ then $M_{ess} = \limsup_{\lambda \rightarrow +\infty} M_\sigma(\lambda)$.

Proof. Let $T_0 > \pi\sqrt{M_{ess}}$ so that $M_0 := \pi^{-2}T_0^2 > M_{ess}$. By the definition of M_{ess} , there is a $K \in \mathbb{R} \setminus \sigma_{ess}(\mathcal{A})$ such that $\sup_{\lambda \in [\sigma(\mathcal{A}) \setminus K]} M_\sigma(\lambda) < M_0$.

Since the restriction $\mathcal{A}_0 = \mathbf{1}_{\mathcal{A} \notin K} \mathcal{A}$ satisfies $\mathcal{D}(\mathcal{A}_0) = \mathcal{D}(\mathcal{A}) \cap X_0$ and $\sigma(\mathcal{A}_0) = \sigma(\mathcal{A}) \setminus K$, the resolvent condition (16) and the definition of K imply

$$\|x\|^2 \leq M_0 \|(\mathcal{A}_0 - \lambda)x\|^2 + m_\sigma \|\mathcal{C}x\|^2, \quad x \in \mathcal{D}(\mathcal{A}_0), \quad \lambda \in [\sigma](\mathcal{A}_0).$$

By proposition 2.9(iii), this implies that the restricted system in proposition 2.11 is controllable in time T_0 .

By the definition of $\sigma_{ess}(\mathcal{A})$, $K \cap \sigma(\mathcal{A})$ is composed of isolated eigenvalues with finite multiplicities. Since K is compact, the cardinal of $K \cap \sigma(\mathcal{A})$ is finite. Since $m_\sigma > 0$, the resolvent condition (16) implies $\mathcal{C}x \neq 0$ for any eigenvector x of \mathcal{A} .

Applying proposition 2.11 with $S = K$ completes the proof. \square

N.b. the estimate of the controllability cost in theorem 2.4 is lost in proposition 2.12 due to the contradiction argument in the proof of proposition 2.11. This was the main reason for replacing it with the control transmutation method in [Mil05, §9].

The following version of proposition 2.12 is better e.g. when \mathcal{A} is neither bounded from below nor from above. The proof is the same except it uses proposition 2.10 instead of proposition 2.9. A simpler formula for M_{ess} is also given when the coefficient M in the resolvent condition (11) is continuous (n.b. $\sigma_{ess}(\mathcal{A})$ is closed).

Proposition 2.13. *Proposition 2.12 still holds if the resolvent condition (16) is replaced by (20) and the definition of the essential coefficient is replaced by*

$$M_{ess} = 4 \inf_{K \in \mathbb{R} \setminus \sigma_{ess}(\mathcal{A})} \sup_{\lambda \in \sigma(\mathcal{A}) \setminus K} M_\sigma(\lambda).$$

N.b. if $\sigma_{ess}(\mathcal{A}) = \emptyset$ then $M_{ess} = 4 \limsup M_\sigma(\lambda)$ as $|\lambda| \rightarrow +\infty$ in $\sigma(\mathcal{A})$.

Proposition 2.12 still holds if the resolvent condition (16) is replaced by (11) with continuous M and the definition of the essential coefficient is replaced by

$$M_{ess} = \max \left\{ \sup_{\lambda \in \sigma_{ess}(\mathcal{A})} M(\lambda), \limsup_{\lambda \rightarrow -\infty} M(\lambda), \limsup_{\lambda \rightarrow +\infty} M(\lambda) \right\}.$$

Corollary 2.14. *If $\sigma_{ess}(\mathcal{A}) = \emptyset$ (e.g. if the resolvent of \mathcal{A} is compact), the system (3) is admissible and the resolvent condition (20) holds with m_σ constant and*

$$M_\sigma(\lambda) \rightarrow 0 \text{ as } |\lambda| \rightarrow +\infty, \quad \lambda \in \sigma(\mathcal{A}),$$

then the system (3) is exactly observable for all times $T > 0$.

N.b. this corollary is inspired from [BZ04, theorem 7] which makes more involved assumptions on $(\mathcal{A}, \mathcal{C})$ but allows the coefficient m to vary.

REMARK 2.15. Under the additional assumption that \mathcal{A} is bounded from below, corollary 2.14 says that $M(\lambda) \rightarrow 0$ as $\lambda \rightarrow +\infty$ implies observability for all $T > 0$. But observability for all $T > 0$ does not imply $M(\lambda) \rightarrow 0$ as $\lambda \rightarrow +\infty$ (Schrödinger equation in a rectangle observed from a strip is a counter-example). What follows says, in a very vague sense: $M(\lambda) \rightarrow 0$ means fast observability of high modes at low cost $\kappa_T \sim \frac{1}{T}$. We refer to [Mil04, theorem 3.2] for a similar but rigorous statement about fast observability of high modes at low cost.

Recall the link of M and m to the time T , admissibility K_T and cost κ_T :

$$T > \pi\sqrt{M}, \quad \kappa_T = 2mT/(T^2 - M\pi^2), \quad \text{and} \quad M = T^2\kappa_T K_T, \quad m = 2T\kappa_T.$$

If the resolvent condition holds with $M(\lambda) \rightarrow 0$ as $\lambda \rightarrow +\infty$, then the restriction of \mathcal{A} to $\mathbf{1}_{|\mathcal{A}|>\lambda} X$ is observable in time $T(\lambda) = \pi\sqrt{2M(\lambda)}$ at cost $\kappa_{T(\lambda)} = 4m/T(\lambda)$. This should be considered as “low cost” since $\kappa_T \sim \frac{1}{T}$ whenever \mathcal{C} is the identity, i.e. full observation is available.

Conversely, if the restriction of \mathcal{A} to $\mathbf{1}_{|\mathcal{A}|>\lambda} X$ is observable in time $T(\lambda)$ with $T(\lambda) \rightarrow 0$ and $\gamma = \limsup T(\lambda)\kappa_{T(\lambda)} < \infty$ as $\lambda \rightarrow +\infty$, then the resolvent condition holds with $M(\lambda) < \gamma K_1 T(\lambda)$ for large λ . In particular, this implies observability of \mathcal{A} for all $T > 0$.

2.5. Wavepackets condition. The wavepackets condition introduced in [CFNS91, (H6’)] and [RTTT05, (1.6)] corresponds to (21) with constant d and D . The following proposition generalizes [RTTT05, Theorem 1.3]: the resolvent of A is not assumed to be compact, the functions in (21) and (14) are not assumed to be constants and their relation is explicit because the proof is direct (does not go through [RTTT05, (2.2)]).

Proposition 2.16. *The observability resolvent condition (14) implies the wavepackets condition, for any function $d > m$ and associated function $D = \frac{1-m}{m}$,*

$$(21) \quad \|x\|^2 \leq d(\lambda)\|\mathcal{C}x\|^2, \quad x \in \mathbf{1}_{|\mathcal{A}-\lambda|^2 \leq D(\lambda)} X, \quad \lambda \in \mathbb{R}.$$

The wavepackets condition (21) and the admissibility resolvent estimate (13) imply the observability resolvent estimate (14) for any function $m > d$ and associated function $M(\lambda) = \delta L + \frac{1+\delta l}{D}$, where $\delta = (\frac{1}{d} - \frac{1}{m})^{-1}$. N.b. $\delta > d$ and $m = (\frac{1}{d} - \frac{1}{\delta})^{-1}$.

Proof. Let $x \in \mathbf{1}_{|\mathcal{A}-\lambda|^2 \leq D(\lambda)} X$. By the spectral theorem $\|(\mathcal{A}-\lambda)x\|^2 \leq D(\lambda)\|x\|^2$. Plugging this in (14) yields (21) with $d(\lambda) = \frac{m}{1-DM}$ since $1-DM = \frac{m}{d} > 0$.

To prove the converse, we introduce the projection $x_\lambda = \mathbf{1}_{|\mathcal{A}-\lambda|^2 \leq D(\lambda)} x$ of $x \in \mathcal{D}(\mathcal{A})$, and $x_\lambda^\perp = x - x_\lambda$. Using $\|\mathcal{C}x_\lambda\|^2 \leq (1+\varepsilon^2)\|\mathcal{C}x\|^2 + (1+\varepsilon^{-2})\|\mathcal{C}x_\lambda^\perp\|^2$, $\varepsilon(\lambda) > 0$, and applying (13) to estimate this last term, then plugging this in (21) yields

$$\|x\|^2 \leq d(1+\varepsilon^2)\|\mathcal{C}x\|^2 + d(1+\varepsilon^{-2})L\|(\mathcal{A}-\lambda)x_\lambda^\perp\|^2 + (1+dl(1+\varepsilon^{-2}))\|x_\lambda^\perp\|^2.$$

But the spectral theorem implies $\|x_\lambda^\perp\|^2 \leq \frac{1}{D}\|(\mathcal{A}-\lambda)x_\lambda^\perp\|^2$, so that (14) holds with $m = d(1+\varepsilon^2)$ and $M = (1+\varepsilon^{-2})dL + \frac{1+dl(1+\varepsilon^{-2})}{D}$. \square

Combining this proposition 2.16 with theorem 2.3, yields this restatement of theorem 2.4 in terms of wavepackets:

Corollary 2.17. *Assume that the system (3) is admissible. It is exactly observable if and only if the following wavepackets condition holds:*

$$(22) \quad \exists D > 0, d > 0, \|x\| \leq \sqrt{d}\|\mathcal{C}x\|, \quad x \in \mathbf{1}_{|\mathcal{A}-\lambda| \leq \sqrt{D}} X, \quad \lambda \in \mathbb{R},$$

More precisely, (8) implies (11) implies (22) with $D = 1/(2M) = 1/(2T^2\kappa_T K_T)$ and $d = 2m = 4T\kappa_T$. Conversely (22) implies exact controllability (8) for all T such that $T^2 > \pi^2 (\frac{1}{D} + dK_T(T + \frac{2}{DT}))$, in particular for all $T > \frac{\pi}{\sqrt{D}} + \pi^2 dK_{\pi/\sqrt{D}}$. Moreover, (22) implies (8) with the simpler cost formula $\kappa_T = \frac{4dT}{\varepsilon}$ for all T such that $\varepsilon := T^2 - \pi^2 (\frac{1}{D} + 2dK_T(T + \frac{2}{DT})) > 0$.

Proof. We only make the lengthiest computation: assuming $T > \frac{\pi}{\sqrt{D}} + \pi^2 dK$, where $K := K_{\pi/\sqrt{D}}$, we deduce $(T/\pi)^2 > \frac{1}{D} + dK_T(T + \frac{2}{DT})$. Since $T \mapsto K_T$ is increasing, $T > \frac{\pi}{\sqrt{D}}$ implies $K_T > K$ and $\frac{2}{\pi\sqrt{D}} > \frac{2}{DT}$. Hence it suffices to prove that $x := T/\pi$ satisfies $x^2 > \frac{1}{D} + dK(T + \frac{2}{\pi\sqrt{D}}) =: \alpha + 2\beta x$, where $\alpha = \frac{2dK}{\pi\sqrt{D}} + \frac{1}{D}$ and $\beta = \frac{\pi dK}{2}$. This is equivalent to $x > \beta + \sqrt{\beta^2 + \alpha}$. Since $\pi > 2/\pi$, this is implied by the assumption which translates into $x > \frac{1}{\sqrt{D}} + \pi dK = \beta + \sqrt{\beta^2 + \frac{\pi dK}{\sqrt{D}} + \frac{1}{D}}$. \square

Corollary 2.18. *Assume that the system (3) is admissible, that $\sigma_{\text{ess}}(\mathcal{A}) = \emptyset$ (e.g. that the resolvent of \mathcal{A} is compact) and that there is a spectral gap $\gamma > 0$ in the following sense: $|\lambda - \mu| \geq \gamma$ for all distinct eigenvalues λ and μ .*

The system (3) is exactly observable if and only if the following eigenvectors condition holds:

$$(23) \quad \exists \delta > 0, \quad \text{for all eigenvector } x \text{ of } \mathcal{A}, \quad \|x\| \leq \delta \|\mathcal{C}x\|.$$

More precisely (23) is equivalent to (22) with $d = \delta^2$ and any $D < \gamma^2/4$.

REMARK 2.19. Corollary 2.18 slightly generalizes [TW09, Proposition 8.1.3], in particular eigenvalues of \mathcal{A} need not be simple. It could also be proved by the classical theorem of Ingham on non-harmonic Fourier series, cf. e.g. [TW09, Theorem 8.1.1], which would give the better time estimate $T > 2\pi/\gamma$. N.b. the time estimate in corollary 2.17 matches Ingham's $T > \pi/\sqrt{D}$ in both asymptotics $D \rightarrow 0$ or $d \rightarrow 0$, whereas the less general [Erv09, Theorem 2.5] does not, since its time estimate translates into: $T > \frac{2e}{\sqrt{D}} \left(\frac{\pi}{4} \ln L + \frac{3\pi}{4}\right)^{1+1/\ln L}$, with $L = \frac{2\pi}{3} K_{1/\sqrt{D}} d \sqrt{D}$.

EXAMPLE 2.20. Corollary 2.18 applies to the interior observability of the Schrödinger (with $\mathcal{A} = -\Delta_c$) and wave equations (with $\mathcal{A} = \sqrt{-\Delta_c}$, cf. theorems 3.8 and 3.13) where $\Delta_c = \partial_x(c(x)\partial_x)$ is the Laplacian with Dirichlet boundary conditions on a segment and c is a positive smooth function.

REMARK 2.21. Consider the Schrödinger equation on a rectangle $[0, a] \times [0, 1]$, $a^2 \notin \mathbb{Q}$, observed from a smaller rectangle $\omega_x \times \omega_y$, $\omega_x \subset [0, a]$, $\omega_y \subset [0, 1]$. Although the natural orthonormal basis of eigenfunctions satisfies (23) and although exact controllability does hold (this result due to Jaffard has been extended to any dimension by Komornik, and to partially rectangular billiards in [BZ04, BZ05]), corollary (2.18) (with $\mathcal{A} = -\Delta$) does not apply if $a^2 \notin \mathbb{Q}$, since the gap condition does not hold. It does apply in principle when $a^2 \in \mathbb{Q}$ (the gap condition holds) but it is not trivial to check (23) since there are eigenspaces with arbitrary large dimension (it is easy in the case of observation from a strip, i.e. $\omega_y = [0, 1]$, cf. [CFNS91, example 3.a]).

2.6. Eigenvectors condition. Although slightly off the topic of this paper, we comment on the following version of the Hautus test in finite dimension already mentioned in §1:

$$(24) \quad \text{for all eigenvector } x \text{ of } \mathcal{A}, \quad \mathcal{C}x \neq 0.$$

When the resolvent of A is compact, [TW09, Proposition 6.9.1] proves that it is equivalent to the following observability notion.

Definition 2.22. The system (3) is *approximately observable in infinite time* if $x = 0$ is the only $x \in \mathcal{D}(\mathcal{A})$ such that $y(t) = 0$ for all $t \geq 0$.

N.b. using the homeomorphism $(i - \mathcal{A})^{-1} : X \rightarrow \mathcal{D}(\mathcal{A})$, this is equivalent to

$$(25) \quad \bigcap_{t \in \mathbb{R}} \ker(\mathcal{C}e^{it\mathcal{A}}(i - \mathcal{A})^{-1}) = \{0\}.$$

N.b. when \mathcal{C} is admissible, this is equivalent to: $x = 0$ is the only $x \in X$ such that $y = 0$ in $L^2_{\text{loc}}(0, \infty)$. This results from considering x as a the limit in X of its usual smooth approximation $x_\varepsilon \in \mathcal{D}(\mathcal{A})$ as $\varepsilon \rightarrow 0^+$:

$$x_\varepsilon := \frac{1}{\varepsilon} \int_0^\varepsilon e^{it\mathcal{A}} x dt, \quad y_\varepsilon(T) := \mathcal{C}e^{iT\mathcal{A}} x_\varepsilon = \frac{1}{\varepsilon} \int_0^\varepsilon \mathcal{C}e^{i(T+t)\mathcal{A}} x dt = \int_T^{T+\varepsilon} y(t) dt.$$

Proposition 2.23. *Let \mathcal{B} denote the σ -algebra of Borel sets of \mathbb{R} . Consider a set $\mathcal{B}_\sigma \subset \mathcal{B}$ of bounded sets such that, for any $\Omega \in \mathcal{B}$, $\Omega \cap \sigma(\mathcal{A})$ is a countable disjoint union of elements of \mathcal{B}_σ (e.g. if \mathcal{B}_σ is the set of bounded Borel subset with diameter smaller than $\varepsilon > 0$, then any $\Omega \in \mathcal{B}$ can be written $\Omega = \bigsqcup_{k \in \mathbb{Z}} \Omega_k$ with $\Omega_k = \Omega \cap [k\varepsilon, (k+1)\varepsilon[\in \mathcal{B}_\sigma$).*

The system (3) is approximately observable in infinite time if and only if

$$\bigcap_{\Omega \in \mathcal{B}_\sigma} \ker(\mathcal{C} \mathbf{1}_{\mathcal{A} \in \Omega}) = \{0\}.$$

In particular, assuming $\sigma_{\text{ess}}(\mathcal{A}) = \emptyset$ and defining \mathcal{B}_σ as the set of singletons $\{\lambda\}$ for all eigenvalues λ of \mathcal{A} , we obtain that (3) is approximately observable in infinite time if and only if the eigenvector test (24) holds.

Proof. The second of the following equalities results from the spectral theorem:

$$\begin{aligned} (26) \quad \bigcap_{t \in \mathbb{R}} \ker(\mathcal{C} e^{it\mathcal{A}}(i - \mathcal{A})^{-1}) &= \bigcap_{f \in L^\infty(\mathbb{R})} \ker(\mathcal{C} f(\mathcal{A})(i - \mathcal{A})^{-1}) \\ &= \bigcap_{\Omega \in \mathcal{B}} \ker(\mathcal{C} \mathbf{1}_{\mathcal{A} \in \Omega}(i - \mathcal{A})^{-1}) = \bigcap_{\Omega \in \mathcal{B}_\sigma} \ker(\mathcal{C} \mathbf{1}_{\mathcal{A} \in \Omega}(i - \mathcal{A})^{-1}). \end{aligned}$$

The first equality (26) results from the Fourier transform in the following way. Consider $x \in \mathcal{D}(\mathcal{A})$, such that $\mathcal{C} e^{it\mathcal{A}} x = 0$, $t \geq 0$. For any $f \in C^\infty(\mathbb{R})$ with compact support, f is the Fourier transform of an $\check{f} \in L^1(\mathbb{R})$, hence

$$\mathcal{C} f(\mathcal{A})x = \mathcal{C} \int \check{f}(t) e^{-it\mathcal{A}} x dt = \int \check{f}(t) \mathcal{C} e^{-it\mathcal{A}} x dt = 0.$$

The property $\mathcal{C} f(\mathcal{A})x = 0$ extends to the set of continuous function f with compact support since $C^\infty(\mathbb{R})$ functions with compact support are dense in this set for the $L^\infty(\mathbb{R})$ norm (e.g. by convolution). To extend this property to an $f \in L^\infty(\mathbb{R})$, first consider a sequence of continuous functions with compact support $(f_n)_{n \in \mathbb{N}}$ bounded in $L^\infty(\mathbb{R})$ and converging pointwise to f (e.g. by Lusin theorem). Since $f_n(\mathcal{A})$ converges to $f(\mathcal{A})$ pointwise in X , $f_n(\mathcal{A})x$ converges to $f(\mathcal{A})x$ in $\mathcal{D}(\mathcal{A})$. Hence we still have $\mathcal{C} f(\mathcal{A})x = 0$ for any $f \in L^\infty(\mathbb{R})$.

If $\Omega \in \mathcal{B}$ can be written as the disjoint union $\Omega = \bigsqcup_{n \in \mathbb{N}} \Omega_n$ with $\Omega_n \in \mathcal{B}_\sigma$ then $\mathbf{1}_{\mathcal{A} \in \Omega} x = \sum_{n \in \mathbb{N}} \mathbf{1}_{\mathcal{A} \in \Omega_n} x$ converges in X . Since $\mathcal{C} \in \mathcal{L}(X_1, Y)$, this implies the convergence in Y of $\mathcal{C} \mathbf{1}_{\mathcal{A} \in \Omega}(i - \mathcal{A})^{-1} x = \sum_{n \in \mathbb{N}} \mathcal{C} \mathbf{1}_{\mathcal{A} \in \Omega_n}(i - \mathcal{A})^{-1} x$. Since $\Omega_n \in \mathcal{B}_\sigma$ is bounded, $\ker(\mathcal{C} \mathbf{1}_{\mathcal{A} \in \Omega_n}) = \ker(\mathcal{C} \mathbf{1}_{\mathcal{A} \in \Omega_n}(i - \mathcal{A})^{-1})$. This completes the proof of the last equality in (26).

Proposition 2.23 results from (26) and the equivalent definition (25). \square

It is not clear that approximate observability in infinite time is an interesting notion for controllability unless the semigroup is analytic. When the semigroup $t \mapsto e^{t\mathcal{A}}$ is analytic, the output $t \mapsto \mathcal{C} e^{t\mathcal{A}} x$ is analytic so that approximate observability in infinite time is equivalent to approximate observability in any time $T > 0$, which is equivalent to approximate controllability in any time $T > 0$. Nonetheless we mention the following easy implication in our context of unitary group.

Lemma 2.24. *Consider $\Omega \subset \mathbb{R}$ compact and the restriction \mathcal{A}_Ω of \mathcal{A} to the spectral subspace $X_\Omega = \mathbf{1}_{\mathcal{A} \in \Omega} X$. If the system (3) is approximately observable in infinite time then the system (4) obtained by replacing \mathcal{A} on X by \mathcal{A}_Ω on X_Ω is approximately observable in any time $T > 0$.*

Proof. The set Ω is compact, hence \mathcal{A}_Ω is bounded, hence the semigroup $t \mapsto e^{it\mathcal{A}_\Omega}$ is analytic, hence $y : t \mapsto \mathcal{C} e^{it\mathcal{A}_\Omega} x$ is analytic. By unique continuation, $(\mathcal{A}_\Omega, \mathcal{C})$ is approximately observable in infinite time if and only if it is approximately

observable in any time $T > 0$, i.e. $x = 0$ is the only $x \in X_\Omega$ such that $y(t) = 0$ for all $t \in [0, T]$. \square

2.7. Quasimode condition for the lack of exact controllability. The necessity of resolvent conditions has been widely overlooked as a means to disprove exact observability. There are two more common means. Firstly, to produce an eigenvector which is not observable in the sense that it violates the eigenvector test (24). Secondly, to produce an approximate solution of the system (3) which is close enough to an exact solution and little enough observable so that it violates (11), e.g. the exact observability of the wave equation is disproved in [Ral82] by a space-time Gaussian beams construction (microlocal measures extend this result from hyperbolic to diffractive and gliding geometric rays, cf. [BG97, Mil97]). Here we point out this intermediate means: to produce an almost not observable approximate eigenvector (approximate eigenvectors are also known as quasimode).

In addition to the first order system (3) we shall consider a second order system, anticipating on (48) in section 3.2. For this purpose we use the notations at the beginning of section 3 and consider the second order observation system associated to a self-adjoint, positive and boundedly invertible operator A on a Hilbert space H_0 with domain $\mathcal{D}(A)$, where H_1 is $\mathcal{D}(\sqrt{A})$ with the norm $\|x\|_1 = \|\sqrt{A}x\|_0$:

$$(27) \quad \ddot{z}(t) + Az(t) = 0, \quad z(0) = z_0 \in H_1, \quad \dot{z}(0) = z_1 \in H_0, \quad y(t) = Cz(t).$$

Definition 2.25. A *quasimode* for the system (3) at $\lambda \in \overline{\mathbb{R}}$ is a sequence $(x_n)_{n \in \mathbb{N}}$ in $\mathcal{D}(A)$ such that there is a real sequence $(\lambda_n)_{n \in \mathbb{N}}$ satisfying

$$\|x_n\| \rightarrow 1, \quad \|Cx_n\| \rightarrow 0, \quad \|(A - \lambda_n)x_n\| \rightarrow 0 \quad \text{and} \quad \lambda_n \rightarrow \lambda \quad \text{as} \quad n \rightarrow \infty.$$

A *quasimode for the second order system* (27) is a $(x_n)_{n \in \mathbb{N}}$ in $\mathcal{D}(A^{3/2})$ such that

$$\|x_n\|_1 \rightarrow 1, \quad \|Cx_n\| = o(1), \quad \|(A - \lambda_n)x_n\|_1 = o(\sqrt{\lambda_n}) \quad \text{and} \quad \lambda_n \rightarrow +\infty \quad \text{as} \quad n \rightarrow \infty.$$

This second definition anticipates on the study of second order systems in §3.2 to allow comparison: a quasimode for the wave-like system (27) must only satisfy $\|(A - \lambda)x_\lambda\|_1 = o(\sqrt{\lambda})$ whereas a quasimode for the corresponding Schrödinger-like system (50) with $s = 1$ must satisfy the stronger condition $\|(A - \lambda)x_\lambda\|_1 = o(1)$. The same comparison can be made in the context of interior observation in §3.2.3.

As a direct consequence of definition 2.25, theorem 2.4 and corollary 3.10:

Theorem 2.26. *Assume that the system (3) (resp. the second-order system (27)) is admissible. If there is a quasimode for (3) (resp. for (27)) then it is not exactly observable.*

Applying theorem 2.26 to the very large literature on quasimodes provides relevant specific PDEs systems where exact controllability does not hold. We dwell on this quasimode approach in a forthcoming paper. E.g. it deduces from a construction in [PV99] that the Schrödinger equation is not exactly controllable from the boundary of a domain where the diffusion constant takes some value outside a bounded strictly convex smooth subdomain and a lower value inside this subdomain, with transmission conditions at the boundary of the subdomain.

In keeping with the topic of this paper, we give two rather abstract applications.

Consider two positive self-adjoint operators A_1 and A_2 on two Hilbert spaces H^1 and H^2 . The operator $A_1 \otimes I + I \otimes A_2$ defined on the algebraic tensor product $\mathcal{D}(A_1) \otimes \mathcal{D}(A_2)$ is closable and its closure, denoted $A = A_1 + A_2$ is a positive self-adjoint operator on the closure $H^1 \overline{\otimes} H^2$ of the algebraic tensor products $H^1 \otimes H^2$.

Theorem 2.27. *Assume $C_1 \in \mathcal{L}(\mathcal{D}(A_1); Y)$, $C = C_1 \otimes I \in \mathcal{L}(\mathcal{D}(A); Y \overline{\otimes} H^2)$, and the second order system (27) with A and C is admissible. If $\ker C_1 \neq \{0\}$ and A_2^{-1} is compact then (27) is not exactly observable.*

Proof. Since A_2 has compact resolvent, there is a sequence Λ of eigenvalues tending to $+\infty$ and a corresponding sequence $(x_\lambda^2)_{\lambda \in \Lambda}$ in $\mathcal{D}(A_2^{3/2})$ of normalized eigenvectors, i.e. $(A_2 - \lambda)x_\lambda^2 = 0$ and $\|x_\lambda^2\|_1 = 1$. Since $\ker C_1 \neq \{0\}$ and $\mathcal{D}(A_1^{3/2})$ is dense in $\mathcal{D}(A_1)$, there exists $x^1 \in \mathcal{D}(A_1^{3/2})$ such that $C_1 x^1 = 0$ and $\|x^1\|_0 = 1$. Now $x_\lambda = x^1 \otimes x_\lambda^2$ defines a quasimode for (27), since $Cx_\lambda = C_1 x^1 \otimes x_\lambda^2 = 0$,

$$\begin{aligned} \|x_\lambda\|_1^2 &= \|\sqrt{A}x_\lambda\|_0^2 = \langle Ax_\lambda, x_\lambda \rangle_0 = \|x^1\|_1^2 \|x_\lambda^2\|_0^2 + \|x^1\|_0^2 \|x_\lambda^2\|_1^2 \\ &= (\|x^1\|_1^2/\lambda + \|x^1\|_0^2) \|x_\lambda^2\|_1^2 = 1 + \|x^1\|_1^2/\lambda \rightarrow 1, \end{aligned}$$

and $\|(A - \lambda)x_\lambda\|_1^2 = \|A_1 x^1 \otimes x_\lambda^2\|_1^2 = \|A_1 x^1\|_1^2/\lambda + \|A_1 x^1\|_0^2 = O(1) = o(\lambda)$. \square

The same theorem can be stated in the context of interior observation in §3.2.3 and its application to the wave equation was already stated in [Liu97, theorem 4.5].

In the second application $X = L^2(\mathbb{R}^d)$. Assume the self-adjoint operator \mathcal{A} on X is *locally compact*, i.e. for all compactly supported $\varphi \in C^\infty(\mathbb{R}^d)$ considered as a multiplication operator, $\varphi(\mathcal{A} - z)^{-1}$ is compact for some hence all $z \notin \sigma(\mathcal{A})$. Also assume that \mathcal{A} is *local*, i.e. there exists a non-negative compactly supported $\varphi \in C^\infty(\mathbb{R}^d)$ such that $\varphi(q) = 1$ for $|q| \leq 1$ and $\varphi_n(q) = \varphi(q/n)$ satisfies $\varphi_n \mathcal{D}(\mathcal{A}) \subset \mathcal{D}(\mathcal{A})$ and $\|(\mathcal{A}\varphi_n - \varphi_n \mathcal{A})(\mathcal{A} - i)^{-1}\| \rightarrow 0$. The observation operator $\mathcal{C} \in \mathcal{L}(\mathcal{D}(\mathcal{A}); Y)$ is *compactly supported* if there is a compact $K \subset \mathbb{R}^d$ such that $\mathcal{C}x = 0$ for any $x \in \mathcal{D}(\mathcal{A})$ with support in $\mathbb{R}^d \setminus K$.

Theorem 2.28. *Assume \mathcal{A} is locally compact and local as above. If $\sigma_{ess}(\mathcal{A}) \neq \emptyset$ then, for all compactly supported \mathcal{C} , the system (3) is not exactly observable.*

Proof. Let $\lambda \in \sigma_{ess}(\mathcal{A})$. Equivalently by [HS, theorem 10.6], there exists a Zhislin sequence $(x_n)_{n \in \mathbb{N}}$ for A and λ , i.e. $x_n \in \mathcal{D}(\mathcal{A})$, $\|x_n\| = 1$, the support of x_n is outside the ball of radius n and $\|(\mathcal{A} - \lambda)x_n\| \rightarrow 0$ as $n \rightarrow \infty$. Since \mathcal{C} is supported in some ball of radius n_0 , $\mathcal{C}x_n = 0$ for $n \geq n_0$. Hence $(x_n)_{n \in \mathbb{N}}$ is a quasimode for the system (3) and theorem 2.26 completes the proof. \square

3. LINKS BETWEEN SYSTEMS WITH GENERATOR BUILD ON A POSITIVE A

This section investigates the logical links between the control properties of various systems of the form (3) with various positive \mathcal{A} which are defined using the same building block: a positive self-adjoint operator denoted A .

The framework for this section is more specific than §2.1. Let H_0 and Y be Hilbert spaces with respective norms $\|\cdot\|_0$ and $\|\cdot\|$. When the context is unambiguous we shall omit the index 0 in $\|\cdot\|_0$. Let A be a self-adjoint, positive and boundedly invertible unbounded operator on H_0 with domain $\mathcal{D}(A)$.

We introduce the Sobolev scale of spaces based on A . For any positive s , let H_s denote the Hilbert space $\mathcal{D}(A^{s/2})$ with the norm $\|x\|_s = \|A^{s/2}x\|_0$ (which is equivalent to the graph norm $\|x\|_0 + \|A^{s/2}x\|_0$). We identify H_0 and Y with their duals with respect to their inner product (i.e. we use them as pivot spaces). Let H_{-s} denote the dual of H_s . Since H_s is densely continuously embedded in H_0 , the pivot space H_0 is densely continuously embedded in H_{-s} , and H_{-s} is the completion of H_0 with respect to the norm $\|x\|_{-s} = \|A^{-s/2}x\|_0$. We still denote by A the restriction of A to H_s with domain H_{s+2} . It is self-adjoint with respect to the H_s scalar product. We denote by A' its dual with respect to the duality between H_s and H_{-s} , which is an extension of A to H_{-s} with domain H_{2-s} .

Let $C \in \mathcal{L}(H_2; Y)$ and let $B \in \mathcal{L}(Y; H_{-2})$ denote its dual.

The dual observation and control systems for the generator A are:

$$(28) \quad \dot{x}(t) - iAx(t) = 0, \quad x(0) = x_0 \in H_0, \quad y(t) = Cx(t),$$

$$(29) \quad \dot{\xi}(t) - iA'\xi(t) = Bu(t), \quad \xi(0) = \xi_0 \in H_0, \quad u \in L_{loc}^2(\mathbb{R}; Y).$$

We consider the following resolvent conditions (which are restricted to the convex hull $[\sigma](A)$ of the spectrum of A with variable coefficients l , L , m and M):

$$(30) \quad \|Cx\|^2 \leq L(\lambda)\|(A - \lambda)x\|_0^2 + l(\lambda)\|x\|_0^2, \quad x \in \mathcal{D}(A), \quad \lambda \in [\sigma](A),$$

$$(31) \quad \|x\|_0^2 \leq M(\lambda)\|(A - \lambda)x\|_0^2 + m(\lambda)\|Cx\|^2, \quad x \in \mathcal{D}(A), \quad \lambda \in [\sigma](A),$$

where l , L , m and M are locally bounded positive functions on $[\sigma](A)$.

EXAMPLE 3.1. We refer to [TW09, §7.5] for the typical example of the free linear Schrödinger equation on a domain with Dirichlet boundary condition observed from a subset of the domain, or from the Neumann derivative on a subset of the boundary. Systems of such equations can also be written as (28).

3.1. Systems generated by fractional powers of A and other convex functions of A . For any function f of the form $f(\lambda) = \lambda h(\lambda)$ where $h : \sigma(A) \rightarrow [h_0, +\infty)$ is measurable and $h_0 > 0$, the spectral theorem defines a positive self-adjoint operator $f(A)$ such that $\mathcal{D}(f(A)) \subset \mathcal{D}(A)$ and $\sigma(f(A)) \subset f(\sigma(A))$. Therefore we may consider the systems generated by $f(A)$ fitting the general framework of §2.1 with $X = H_0 = X'$, $\beta = 0$, $\mathcal{C} = C$ and $\mathcal{A} = f(A)$:

$$(32) \quad \dot{x}(t) - if(A)x(t) = 0, \quad x(0) = x_0 \in H_0, \quad y(t) = Cx(t),$$

$$(33) \quad \dot{\xi}(t) - if(A')\xi(t) = Bu(t), \quad \xi(0) = \xi_0 \in H_0, \quad u \in L_{\text{loc}}^2(\mathbb{R}; Y').$$

This section investigates the link between the control properties of (29) and (33).

An example of particular interest is $f(\lambda) = \lambda^\alpha$ with $\alpha \geq 1$ which defines an operator $f(A)$ known as the fractional power A^α of the operator A with domain $\mathcal{D}(A^\alpha) = H_{2\alpha} \subset \mathcal{D}(A) = H_2$:

$$(34) \quad \dot{x}(t) - iA^\alpha x(t) = 0, \quad x(0) = x_0 \in H_0, \quad y(t) = Cx(t),$$

$$(35) \quad \dot{\xi}(t) - i(A')^\alpha \xi(t) = Bu(t), \quad \xi(0) = \xi_0 \in H_0, \quad u \in L_{\text{loc}}^2(\mathbb{R}; Y').$$

In deducing control properties of (33) from (29), convexity is the main property of $f : [0, +\infty) \rightarrow [0, +\infty)$ that our argument relies on. E.g. theorem 3.2 applies to $f(\lambda) = \lambda \ln(1 + \lambda)$ which has an interesting application (cf. [DM09]). Although systems generated by fractional powers of the Laplacian are a well established modeling tool, we do not know which range of the power-logarithm scale of the Laplacian has ever been actually considered for modeling purposes. Conversely in deducing control properties of (29) from (33), we use homogeneity as an additional property of f , therefore theorem 3.5 only concerns fractional powers.

Throughout this section the norm $\|\cdot\|_0$ on the state space H_0 is simply denoted $\|\cdot\|$ as the norm on the observation space Y without ambiguity.

Theorem 3.2. *If the system (28) for A is admissible (resp. exactly observable) then the system (32) for $f(A)$ is admissible (resp. exactly observable) for any convex function $f : [0, +\infty) \rightarrow [0, +\infty)$ which vanishes only at 0.*

More precisely (31) implies the observability resolvent estimate

$$\|x\|^2 \leq M_f(\lambda)\|(f(A) - \lambda)x\|^2 + m_f(\lambda)\|Cx\|^2, \quad x \in \mathcal{D}(f(A)), \quad \lambda \in f([\sigma](A)),$$

with $m_f(\lambda) = m(f^{-1}(\lambda))$ and $M_f(\lambda) = (f^{-1}(\lambda)/\lambda)^2 M(f^{-1}(\lambda))$. N.b. if moreover $f(\lambda) = \lambda h(\lambda)$ then this further simplifies as $M_f(\lambda) = M(f^{-1}(\lambda))/h^2(f^{-1}(\lambda))$. Similarly (30) implies the admissibility resolvent estimate for $f(A)$ with coefficients defined from l and L as m_f and M_f were defined from m and M .

N.b. f is strictly increasing since $0 < x < y$ implies $\frac{f(y)-f(x)}{y-x} \geq \frac{f(y)}{y} > 0$. Moreover convexity implies continuity. Hence f is bijective.

N.b. Since f is continuous, the spectrum of $f(A)$ is $\sigma(f(A)) = f(\sigma(A))$. Taking convex hulls and using the convexity of f yields $[\sigma](f(A)) = [f(\sigma(A))] = f([\sigma](A))$.

Theorem 3.2 results directly from the following simple convexity inequality.

Lemma 3.3. *If $f : [0, +\infty) \rightarrow [0, +\infty)$ is convex and vanishes only at 0 then*

$$(36) \quad \|(A - \mu)x\| \leq \frac{\mu}{f(\mu)} \|(f(A) - f(\mu))x\|, \quad x \in \mathcal{D}(f(A)), \quad \mu > 0.$$

Proof. The hypothesis implies that f is continuous and $t \mapsto t/f(t)$ is positive nonincreasing on $(0, +\infty)$ hence bounded on $[\varepsilon, +\infty)$ for all $\varepsilon > 0$. Therefore $f(A)$ is well defined and $\mathcal{D}(f(A)) \subset \mathcal{D}(A)$.

For all $\mu > 0$, the difference quotient g_μ is the left continuous function at $t = \mu$ defined on $[0, +\infty)$ by $g_\mu(t) = \frac{f(t) - f(\mu)}{t - \mu}$. Since f is convex, g_μ is increasing. Hence $g_\mu(t) \geq g_\mu(0) = \frac{f(\mu)}{\mu}$ for $t \geq 0$. Therefore, setting $h_\mu := 1/g_\mu$, the spectral theorem yields $\|h_\mu(A)\| \leq \frac{\mu}{f(\mu)}$. Now (36) results from $A - \mu = h_\mu(A)(f(A) - f(\mu))$. \square

EXAMPLE 3.4. E.g. theorem 3.2 applies when $f(t) = t \log^\alpha(1 + t) = th(t)$, $\alpha \geq 1$, and M is a constant. In this case we check that the coefficient M_f satisfies:

$$M_f(\lambda) = M/h^2(f^{-1}(\lambda)) \leq (1 + \alpha)^{2\alpha} M / \log^{2\alpha}(1 + \lambda).$$

Setting $\lambda = f(\mu) = \mu \log^\alpha(1 + \mu)$, we have $1/h(f^{-1}(\lambda)) = 1/\log^\alpha(1 + \mu)$ and we want to check $1/\log^\alpha(1 + \mu) \leq (1 + \alpha)^\alpha / \log^\alpha(1 + \lambda)$, which is equivalent to $1 + \lambda \leq (1 + \mu)^{1+\alpha}$. But this results from $1 + \mu^{1+\alpha} \leq (1 + \mu)^{1+\alpha}$ and this estimate of the logarithm: $\lambda = \mu \log^\alpha(1 + \mu) \leq \mu^{1+\alpha}$.

Applying theorem 3.2 to $f(\lambda) = \lambda^\alpha$ with $\alpha > 1$ yields $M_f(\lambda) = M(\lambda^{\frac{1}{\alpha}})/\lambda^{2-2/\alpha}$. This makes the following notations for the resolvent conditions more convenient when dealing with the fractional powers in (34):

$$(37) \quad \|Cx\|^2 \leq \frac{L_\alpha(\lambda)}{\lambda^{2-2/\alpha}} \|(A^\alpha - \lambda)x\|^2 + l_\alpha(\lambda)\|x\|^2, \quad x \in \mathcal{D}(A^\alpha), \quad \lambda \in [\sigma](A^\alpha),$$

$$(38) \quad \|x\|^2 \leq \frac{M_\alpha(\lambda)}{\lambda^{2-2/\alpha}} \|(A^\alpha - \lambda)x\|^2 + m_\alpha(\lambda)\|Cx\|^2, \quad x \in \mathcal{D}(A^\alpha), \quad \lambda \in [\sigma](A^\alpha).$$

where l_α , L_α , m_α and M_α are locally bounded positive functions on \mathbb{R} . The first part of the following theorem is the application of theorem 3.2 with these notations. The new feature is the converse in the second part using the homogeneity of f .

Theorem 3.5. *If the system (28) for A is admissible (resp. exactly observable) then the system (34) for A^α is admissible (resp. exactly observable) for any $\alpha > 1$. More precisely (31) implies (38) with $m_\alpha(\lambda) = m(\lambda^{1/\alpha})$ and $M_\alpha(\lambda) = M(\lambda^{1/\alpha})$. Similarly (30) implies (37) with $l_\alpha(\lambda) = l(\lambda^{1/\alpha})$ and $L_\alpha(\lambda) = L(\lambda^{1/\alpha})$.*

The system (28) for A is admissible if and only if the resolvent condition (37) for A^α holds for some $\alpha \geq 1$ and some constant L_α and l_α . Assuming that it is admissible, it is exactly observable if and only if the resolvent condition (38) for A^α holds for some $\alpha \geq 1$ and some constant M_α and m_α (if moreover $\sigma_{\text{ess}}(A) = \emptyset$ this implies that the system (34) for A^α is exactly observable for any positive time).

More precisely, (37) implies (30) with $L(\lambda) = 2 \max \left\{ (2^\alpha - 1)^2 L_\alpha(\lambda^\alpha), 4 \|C\|_{\mathcal{L}(H_2; Y)}^2 \right\}$ and $l(\lambda) = 2l_\alpha(\lambda^\alpha)$. Moreover (30) and (38) imply (31) with $m(\lambda) = 2m_\alpha(\lambda^\alpha)$ and $M(\lambda) = \max \left\{ (2^\alpha - 1)^2 M_\alpha(\lambda^\alpha), m(\lambda)L(\lambda) + (1 + m(\lambda)l(\lambda))/\inf A^2 \right\}$.

Proof. Thanks to theorem 3.2 and proposition 2.9 (and corollary 2.14 for the statement in parenthesis), we only need to prove the last paragraph. We shall prove (30) and (31) by density, taking $x \in \mathcal{D}(A^\alpha)$. Let $\mu \in [\sigma](A)$ and $\varepsilon > 0$. In each case we

use some spectral projection x_μ of x which depends on ε and take advantage of:

$$(39) \quad \|x\|^2 = \|x_\mu\|^2 + \|x - x_\mu\|^2$$

$$(40) \quad \begin{aligned} \|(A - \mu)x\|^2 &= \|(A - \mu)x_\mu\|^2 + \|(A - \mu)(x - x_\mu)\|^2, \\ \alpha\|(A - \mu)x_\mu\|^2 + \beta\|(A - \mu)(x - x_\mu)\|^2 &\leq \max\{\alpha, \beta\} \|(A - \mu)x\|^2. \end{aligned}$$

Since $f(\mu) = \mu^\alpha$ satisfies the homogeneity equality $f(t\mu) = t^\alpha f(\mu)$, the difference quotient function g_μ defined in lemma 3.3 satisfies $g_\mu(\mu t) = g(t)f(\mu)/\mu = \mu^{\alpha-1}g(t)$ where g is defined on $[0, +\infty)$ by $g(1) = \alpha$ and $g(t) = (1 - t^\alpha)/(1 - t)$.

We first assume only the admissibility condition (37) for A^α . We introduce the projection $x_\mu = \mathbf{1}_{A < (1+\varepsilon)\mu} x$ of x on the spectrum of A below $(1+\varepsilon)\mu$. The spectral theorem yields

$$(41) \quad \|A(x - x_\mu)\| \leq (1 + 1/\varepsilon)\|(A - \mu)(x - x_\mu)\|,$$

$$(42) \quad \frac{1}{\mu^{\alpha-1}}\|(A^\alpha - \mu^\alpha)x_\mu\| \leq g(1 + \varepsilon)\|(A - \mu)x_\mu\|.$$

The former inequality results from writing $A = (A - \mu)h(A/\mu)$ where $h(t) = 1/(1 - 1/t)$ is decreasing. The latter inequality results from writing $\mu^{1-\alpha}(A^\alpha - \mu^\alpha) = (A - \mu)g(A/\mu)$ where g is increasing. Using $C \in \mathcal{L}(H_2; Y)$ and (41) yields

$$(43) \quad \|C(x - x_\mu)\| \leq (1 + 1/\varepsilon)\|C\|\|(A - \mu)(x - x_\mu)\|.$$

Applying (37) to x_μ and plugging (42) yields

$$(44) \quad \|Cx_\mu\|^2 \leq g^2(1 + \varepsilon)L_\alpha(\mu^\alpha)\|(A - \mu)x_\mu\|^2 + l_\alpha(\mu^\alpha)\|x_\mu\|^2.$$

Plugging (43) and (44) in $\frac{1}{2}\|Cx\|^2 \leq \|Cx_\mu\|^2 + \|C(x - x_\mu)\|^2$ and simplifying by (40) yields (30) with

$$l(\mu) = 2l_\alpha(\mu^\alpha) \text{ and } L(\mu) = 2 \max\{g^2(1 + \varepsilon)L_\alpha(\mu^\alpha), (1 + 1/\varepsilon)^2\|C\|^2\}.$$

Taking $\varepsilon = 1$ completes the statement that (37) implies (30) in theorem 3.5.

Now we assume the admissibility condition (30) for A and the observability condition (38) for A^α . We introduce the projection $x_\mu = \mathbf{1}_{A < \mu + \varepsilon} x$ of x on the spectrum of A below $\mu + \varepsilon$. The spectral theorem yields

$$(45) \quad \|x - x_\mu\| \leq \frac{1}{\varepsilon}\|(A - \mu)(x - x_\mu)\|,$$

$$(46) \quad \frac{1}{\mu^{\alpha-1}}\|(A^\alpha - \mu^\alpha)x_\mu\| \leq g(1 + \varepsilon/\mu)\|(A - \mu)x_\mu\|.$$

Applying (38) to x_μ , plugging (46) in, and using the monotony of g yields

$$(47) \quad \|x_\mu\|^2 \leq g^2(1 + \varepsilon/\inf A)M_\alpha(\mu^\alpha)\|(A - \mu)x_\mu\|^2 + m_\alpha(\mu^\alpha)\|Cx_\mu\|^2.$$

To estimate the last term, we apply (30) to $x - x_\mu$:

$$\frac{1}{2}\|Cx_\mu\|^2 \leq \|Cx\|^2 + L(\mu)\|(A - \mu)(x - x_\mu)\|^2 + l(\mu)\|x - x_\mu\|^2.$$

Plugging this in (47), then plugging the resulting inequality in (39), and simplifying by (45) and finally by (40) yields (31) with $m(\mu) = 2m_\alpha(\mu^\alpha)$ and

$$M(\mu) = \max\left\{g^2\left(1 + \frac{\varepsilon}{\inf A}\right)M_\alpha(\mu^\alpha), 2m_\alpha(\mu^\alpha)L(\mu) + \frac{1 + 2m_\alpha(\mu^\alpha)l(\mu)}{\varepsilon^2}\right\}.$$

Taking $\varepsilon = \inf A$ yields the last statement in theorem 3.5. \square

REMARK 3.6. In the particular case of second-order equations, the part of the first sentence concerning exact observability was proved in [ZY97] (without explicit M_α and m_α).

3.2. Second order systems. In this section we start with the general framework for second order systems which suits the boundary control of PDEs. We finish with a framework which suits the interior control of PDEs better.

3.2.1. “Boundary” second order systems. In addition to first order systems for A , we consider the dual observation and control second order systems:

$$(48) \quad \ddot{z}(t) + Az(t) = 0, \quad z(0) = z_0 \in H_1, \quad \dot{z}(0) = z_1 \in H_0, \quad y(t) = Cz(t),$$

$$(49) \quad \ddot{\zeta}(t) + A'\zeta(t) = Bv(t), \quad \zeta(0) = \zeta_0 \in H_0, \quad \dot{\zeta}(0) = \zeta_1 \in H_{-1}, \quad v \in L_{\text{loc}}^2(\mathbb{R}; Y).$$

EXAMPLE 3.7. We refer to [TW09, §7.4 and 7.6] for the typical example of the wave equation on a domain with Dirichlet boundary condition observed from a subset of the domain, or from the Neumann derivative on a subset of the boundary. We refer to [TW09, §7.5] for the examples of plate equations.

We shall now explain how they fit in the general framework of §2.1. The states $x(t)$ and $\xi(t)$ of the systems (48) and (49) at time t and their state spaces X and X' are defined by:

$$x(t) = (z(t), \dot{z}(t)) \in X = H_1 \times H_0, \quad \xi(t) = (\zeta(t), \dot{\zeta}(t)) \in X' = H_0 \times H_{-1}.$$

X is a Hilbert space with the “energy norm” defined by $\|(z_0, z_1)\|^2 = \|\sqrt{A}z_0\|_0^2 + \|z_1\|_0^2$, X' is a Hilbert space with norm defined by $\|(\zeta_0, \zeta_1)\|^2 = \|\zeta_0\|_0^2 + \|\zeta_1\|_{-1}^2$, and X is densely continuously embedded in X' . These spaces are dual with respect to the pairing $\langle (z_0, z_1), (\zeta_0, \zeta_1) \rangle = \langle A^{1/2}z_0, A^{-1/2}\zeta_1 \rangle_0 - \langle z_1, \zeta_0 \rangle_0$.

The dual second-order systems (48) and (49) rewrite as dual first order systems (3) and (4), where $u = v$, \mathcal{A} is defined on the domain $\mathcal{D}(\mathcal{A}) = \mathcal{D}(A) \times \mathcal{D}(\sqrt{A})$ by $\mathcal{A}(z_0, z_1) = i(-z_1, Az_0)$, \mathcal{A}' is an extension of \mathcal{A} to X' with domain X , $\beta = 0$, X_1 is $H_2 \times H_1$ with the norm defined by $\|(z_0, z_1)\|_1^2 = \|\mathcal{A}(z_0, z_1)\|^2 = \|\sqrt{A}z_1\|_0^2 + \|Az_0\|_0^2$, $\mathcal{C} \in \mathcal{L}(X_1; Y)$ is defined by $\mathcal{C}(z_0, z_1) = Cz_0$ and $\mathcal{B} \in \mathcal{L}(Y; X'_{-1})$ is defined by $\mathcal{B}y = (0, By)$.

We also consider the dual observation and control first order systems for $A^{s/2}$, with $s \geq 1$:

$$(50) \quad \dot{f}(t) - iA^{s/2}f(t) = 0, \quad f(0) = f_0 \in H_1, \quad y(t) = Cf(t),$$

$$(51) \quad \dot{\phi}(t) - i(A')^{s/2}\phi(t) = Bu(t), \quad \phi(0) = \phi_0 \in H_{-1}, \quad u \in L_{\text{loc}}^2(\mathbb{R}; Y).$$

It fits in the general framework of §2.1 : $X = H_1$, $X' = H_{-1}$, $\mathcal{C} = C$, \mathcal{A} is $A^{s/2}$ with $\mathcal{D}(A^{s/2}) = H_{1+s}$, \mathcal{A}' is $(A')^{s/2}$ with $\mathcal{D}((A')^{s/2}) = H_{s-1}$, $\beta = 0$.

We consider the improved resolvent conditions for (50): $\exists L_s, l_s, M_s, m_s > 0$,

$$(52) \quad \|Cf\|^2 \leq \frac{L_s}{\lambda^{2(1-1/s)}} \|(A^{s/2} - \lambda)f\|_1^2 + l_s \|f\|_1^2, \quad f \in H_{1+s}, \quad \lambda \in [\sigma](A^{s/2}),$$

$$(53) \quad \|f\|_1^2 \leq \frac{M_s}{\lambda^{2(1-1/s)}} \|(A^{s/2} - \lambda)f\|_1^2 + m_s \|Cf\|^2, \quad f \in H_{1+s}, \quad \lambda \in [\sigma](A^{s/2}).$$

Theorem 3.8. *The second order system (48) generated by A is admissible (resp. exactly observable) if and only if the first order system (50) with $s = 1$ generated by \sqrt{A} is admissible (resp. exactly observable).*

More precisely, (10) implies (52) for $s = 1$ with $L_1 = 2L$ and $l_1 = 2l$; (11) implies (53) for $s = 1$ with $M_1 = M$ and $m_1 = m/2$; (52) for $s = 1$ implies (10) with $L = L_1$ and $l = l_1$; (53) for $s = 1$ implies (11) with $m = 4m_1$ and $M = \max \left\{ M_1, 2m_1 \|C\|_{\mathcal{L}(\mathcal{D}(A); Y)}^2 + 1/(\inf \sqrt{A})^2 \right\}$; (52) and (53) for $s = 1$ implies (11) with $m = 4m_1$ and $M = \max \left\{ M_1, 2m_1 L_1 + (2m_1 l_1 + 1)/(\inf \sqrt{A})^2 \right\}$.

For variable coefficients as in §2.3 the result still holds with $\inf \sqrt{A}$ replaced by $\lambda + \inf \sqrt{A}$ in the two formulas for M . E.g. if $m_1 = l_1$ is constant but $M_1 = L_1 \rightarrow 0$

slower than $1/\lambda^2$ as $\lambda \rightarrow +\infty$, then m is constant and $M \rightarrow 0$ as fast as M_1 in the second formula for M (whereas the first formula does not even ensure $M \rightarrow 0$).

Proof. The theorem follows from the Hilbert spaces isomorphism \mathcal{W} from $X = H_1 \times H_0$ onto $W = H_1 \times H_1$ defined by $\mathcal{W}(z_0, z_1) = (z_0 - iA^{-1/2}z_1, z_0 + iA^{-1/2}z_1)/\sqrt{2}$, with inverse $\mathcal{W}^{-1}(w_0, w_1) = (w_0 + w_1, i\sqrt{A}(w_0 - w_1))/\sqrt{2}$. Unitarity is easily checked: $\|(w_0, w_1)\|_W^2 := \|w_0\|_1^2 + \|w_1\|_1^2 = (\|\sqrt{A}z_0 - iz_1\|_0^2 + \|\sqrt{A}z_0 + iz_1\|_0^2)/2 = \|\sqrt{A}z_0\|_0^2 + \|-iz_1\|_0^2 = \|(z_0, z_1)\|^2$. The operator \mathcal{A} for the second order system (48) is isomorphic to $\mathcal{A}_H = \mathcal{W}\mathcal{A}\mathcal{W}^{-1} = \sqrt{A} \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}$.

The resolvent conditions (10) and (11) for (48) write: $\forall w_0, w_1 \in H_2, \lambda \in [\sigma](\sqrt{A})$,

$$\begin{aligned} \frac{1}{2}\|C(w_0 + w_1)\|^2 &\leq L \left(\|(\sqrt{A} - \lambda)w_0\|_1^2 + \|(\sqrt{A} + \lambda)w_1\|_1^2 \right) + l \left(\|w_0\|_1^2 + \|w_1\|_1^2 \right), \\ \|w_0\|_1^2 + \|w_1\|_1^2 &\leq M \left(\|(\sqrt{A} - \lambda)w_0\|_1^2 + \|(\sqrt{A} + \lambda)w_1\|_1^2 \right) + \frac{m}{2}\|C(w_0 + w_1)\|^2, \end{aligned}$$

(n.b. the symmetry between w_0 and w_1 allows to let λ vary only in the positive part of $[\sigma](\mathcal{A}) = [\sigma](\sqrt{A}) \cup [\sigma](-\sqrt{A})$). Taking $w_1 = 0$ proves the first two implications in the second statement of the theorem.

The converse for admissibility with $L = L_1$ and $l = l_1$ follows from writing $\frac{1}{2}\|C(w_0 + w_1)\|^2 \leq \|Cw_0\|^2 + \|Cw_1\|^2$ and applying (52) with $s = 1$ to $f = w_0$ and $f = w_1$. To prove the converse for observability, the main step is to apply (53) with $s = 1$ to $f = w_0$ and write $\|Cw_0\|^2 \leq 2\|C(w_0 + w_1)\|^2 + 2\|Cw_1\|^2$. The following two alternative subsidiary steps lead to the alternative values for M .

The first value of M results from $\|Cw_1\| \leq \|C\|\|\sqrt{A}w_1\|_1$, and finally simplifying by: $(\inf \sqrt{A} + \lambda)\|w_1\|_1 \leq \|(\sqrt{A} + \lambda)w_1\|_1$.

To prove the second value of M , apply (52) with $s = 1$ to $f = w_1$, change the sign of λ thanks to (17), and finally simplify by $\|w_1\|_1 \leq \frac{1}{\inf \sqrt{A} + \lambda}\|(\sqrt{A} + \lambda)w_1\|_1$. \square

3.2.2. Fractional second order systems. We also consider the dual observation and control second order systems for A^s , with $s \geq 1$:

$$(54) \quad \ddot{z}(t) + A^s z(t) = 0, \quad z(0) = z_0 \in H_1, \quad \dot{z}(0) = z_1 \in H_{1-s}, \quad y(t) = Cz(t),$$

$$(55) \quad \ddot{\zeta}(t) + (A')^s \zeta(t) = Bv(t), \quad \zeta(0) = \zeta_0 \in H_{s-1}, \quad \dot{\zeta}(0) = \zeta_1 \in H_{-1}, \quad v \in L_{\text{loc}}^2(\mathbb{R}; Y).$$

They fit the general framework of §2.1: $X = H_1 \times H_{1-s}$, $\mathcal{A}(z_0, z_1) = i(-z_1, A^s z_0)$ with the domain $X_1 = H_{1+s} \times H_1$, $X_{-1} = H_{1-s} \times H_{1-2s}$, $X' = H_{s-1} \times H_{-1}$, $\langle (z_0, z_1), (\zeta_0, \zeta_1) \rangle = \langle A^{1/2}z_0, A^{-1/2}\zeta_1 \rangle_0 - \langle A^{(1-s)/2}z_1, A^{(s-1)/2}\zeta_0 \rangle_0$ and therefore $\mathcal{A}'(\zeta_0, \zeta_1) = i(-\zeta_1, (A')^s \zeta_0)$ with $X'_1 = H_{2s-1} \times H_{s-1}$, $X'_{-1} = H_{-1} \times H_{-1-s}$, $\mathcal{C}(z_0, z_1) = Cz_0$ and therefore $\mathcal{B}y = (0, By)$.

The following corollary of theorem 3.8 (using theorem 3.5 with H_0 and A replaced by H_1 and \sqrt{A} , and using corollary 2.14 for the time), characterizes the properties of the second order system (48) in terms of improved resolvent conditions for the first order systems (50).

Corollary 3.9. *If the second order system (48) is admissible (resp. exactly observable) then for any $s > 1$ the first order system (50) and the second order system (54) are admissible (resp. exactly observable, moreover they are exactly observable for any positive time T if $\sigma_{ess}(A) = \emptyset$).*

More precisely, the second order system (48) is admissible if and only if (52) holds for some $s \geq 1$. Assuming that it is admissible, it is exactly observable if and only if (53) holds for some $s \geq 1$.

N.b. the constants L, l, M, m in (10) and (11) for (48) on the one hand, and L_s, l_s, M_s, m_s in (52) and (53) on the other hand are explicitly related here.

In particular, for $s = 2$ we have the following (using corollary 2.14 for the time)

Corollary 3.10. *Admissibility and exact observability for the wave-like equation (48) hold if and only if $\frac{1}{\sqrt{\lambda}}\|(A - \lambda)x\|_0 + \|CA^{-\frac{1}{2}}x\|$ is a norm on $\mathcal{D}(A)$ equivalent to $\frac{1}{\sqrt{\lambda}}\|(A - \lambda)x\|_0 + \|x\|_0$ uniformly for $\lambda \geq \inf A > 0$, and it implies admissibility and exact observability (in any positive time T if moreover $\sigma_{\text{ess}}(A) = \emptyset$) for the Schrödinger-like equation (50) and the Plate-like equation (54) both with $s = 2$.*

EXAMPLE 3.11. When A is the Dirichlet Laplacian and C is the Neumann derivative at the boundary, combining corollary 3.10 with [BLR92] gives another proof of [Leb92, theorem 4.1 and proposition 5.1.B]: under the geometric condition of Bardos, Lebeau and Rauch for the exact observability of the wave equation in $H_0^1 \times L_2$ with Neumann observation, exact observability in arbitrary time holds for the Schrödinger equation in H_0^1 with Neumann observation and for the plate equation in $H_0^1 \times H^{-1}$ with Neumann observation. N.b. under the same assumption, the control transmutation method in [Mil05, theorem 10.2] yields more information on the Schrödinger equation since it provides a geometric bound on the cost of fast controls.

EXAMPLE 3.12. We now use theorems 3.8 and 3.2 to interpret in terms of differential operators an initially abstract example due to Thomas Duyckaerts of a positive self-adjoint operator A_* with observation $C_* \in \mathcal{L}(\mathcal{D}(A_*); Y)$, $Y = \mathbb{C}$, such that the Schrödinger group e^{itA_*} is exactly observable for all positive time but the heat semigroup e^{-tA_*} is not final-observable for any time, cf. [DM09, §5.1]. Let Δ denote the Laplacian ∂_x^2 on the segment $[0, 1]$ with Dirichlet boundary condition, which is negative self-adjoint on $L^2(0, 1)$ with domain $\mathcal{D}(\Delta) = H_0^1(0, 1) \cap H^2(0, 1)$. Let ∂_ν denote the derivative at the endpoint 1. It is well-known that the wave equation $\ddot{w} - \Delta w = \partial_t^2 w - \partial_x^2 w = 0$ is observable by the Neumann derivative ∂_ν in any time $T \geq 2$ on the energy space $H_0^1(0, 1) \times L^2(0, 1)$ (by the unitarity of the discrete Fourier transform known as Parseval's theorem). Hence theorem 3.8 with $A = -\Delta$ and $s = 1$ yields that $\sqrt{-\Delta}$ on $X = L^2(0, 1)$ is observable by $C = \partial_\nu(-\Delta)^{-1/2} \in \mathcal{L}(H_1; Y)$, $Y = \mathbb{C}$. Applying theorem 3.2 with $A = \sqrt{-\Delta}$, $f(t) = t \log(1 + t)$ and constant M as in example 3.4 yields that $A_* := \sqrt{-\Delta} \log(1 + \sqrt{-\Delta})$ satisfies the *logarithmically improved resolvent condition*:

$$\|x\|^2 \leq \frac{M_*}{\log^2(1 + \lambda)} \|(A_* - \lambda)x\|^2 + m_* \|Cx\|^2, \quad x \in \mathcal{D}(A_*), \quad \lambda \in \mathbb{R}.$$

N.b. $\mathcal{D}((-\Delta)^{\varepsilon+1/2}) \subset \mathcal{D}(A_*) \subset \mathcal{D}(\sqrt{-\Delta})$ for all $\varepsilon > 0$ and $C \in \mathcal{L}(\mathcal{D}(A_*); Y)$.

3.2.3. *“Interior” second order systems.* The previous theorem 3.8 is adapted to boundary observability (for wave and Schrödinger equations) since $C \in \mathcal{L}(H_2; Y)$. For interior observability, we have $C \in \mathcal{L}(H_0; Y)$ and admissibility is obvious. In the following version of theorem 3.8, the assumption made on the observation operator C is in-between: $C \in \mathcal{L}(H_1; Y)$, equivalently $B \in \mathcal{L}(Y; H_{-1})$. Accordingly, we may consider a larger space of states (z_0, z_1) than the previous “energy space”:

$$(56) \quad \ddot{z}(t) + Az(t) = 0, \quad z(0) = z_0 \in H_0, \quad \dot{z}(0) = z_1 \in H_{-1}, \quad y(t) = Cz(t),$$

$$(57) \quad \ddot{\zeta}(t) + A'\zeta(t) = Bv(t), \quad \zeta(0) = \zeta_0 \in H_1, \quad \dot{\zeta}(0) = \zeta_1 \in H_0, \quad v \in L_{\text{loc}}^2(\mathbb{R}; Y).$$

It fits in the general framework of §2.1 : $X = H_0 \times H_{-1}$ with norm $\|(z_0, z_1)\|^2 = \|z_0\|_0^2 + \|z_1\|_{-1}^2$, $X' = H_1 \times H_0$ with the “energy norm” $\|(\zeta_0, \zeta_1)\|^2 = \|\zeta_0\|_1^2 + \|\zeta_1\|_0^2$, the duality pairing is $\langle (z_0, z_1), (\zeta_0, \zeta_1) \rangle = \langle z_0, \zeta_0 \rangle_0 - \langle A^{-1/2}z_1, A^{1/2}\zeta_0 \rangle_0$.

We rewrite the fractional first order systems (34) and (35) with $\alpha = s/2$:

$$(58) \quad \dot{x}(t) - iA^{s/2}x(t) = 0, \quad x(0) = x_0 \in H_0, \quad y(t) = Cx(t),$$

$$(59) \quad \dot{\xi}(t) - i(A')^{s/2}\xi(t) = Bu(t), \quad \xi(0) = \xi_0 \in H_0, \quad u \in L_{\text{loc}}^2(\mathbb{R}; Y').$$

We also consider the improved resolvent condition for (58): $\exists L_s, l_s, M_s, m_s > 0$,

$$(60) \quad \|Cx\|^2 \leq \frac{L_s}{\lambda^{2(1-1/s)}} \|(A^{s/2} - \lambda)x\|_0^2 + l_s \|x\|_0^2, \quad x \in H_s, \quad \lambda \in [\sigma](A^{s/2}),$$

$$(61) \quad \|x\|_0^2 \leq \frac{M_s}{\lambda^{2(1-1/s)}} \|(A^{s/2} - \lambda)x\|_0^2 + m_s \|Cx\|^2 \quad x \in H_s, \quad \lambda \in [\sigma](A^{s/2}).$$

Applying theorem 3.8 to the observation operator $CA^{1/2} \in \mathcal{L}(H_2; Y)$ and using theorem 3.5 and corollary 2.14 (as in corollary 3.9) yields

Theorem 3.13. *Assume $C \in \mathcal{L}(H_1; Y)$. The second order system (56) is admissible (resp. exactly observable) if and only if the first order system (58) with $s = 1$ is admissible (resp. exactly observable). These imply that, for any $s > 1$, (58) is admissible (resp. exactly observable, moreover it is exactly observable for any positive time T if $\sigma_{\text{ess}}(A) = \emptyset$).*

Moreover, (56) is admissible if and only if (60) holds for some $s \geq 1$. Assuming that it is admissible, it is exactly observable if and only if (61) holds for some $s \geq 1$.

N.b. the constants L, l, M, m in (10) and (11) for (56) on the one hand, and L_s, l_s, M_s, m_s on the other hand are explicitly related. In the following example, we only state these relations in the case $s = 1$ (e.g. this is used in [DM09]).

EXAMPLE 3.14. Assume the two resolvent conditions for A :

$$\|Cx\|^2 \leq L_2(\lambda) \left(\frac{1}{\lambda} \|(A - \lambda)x\|_0^2 + \|x\|_0^2 \right), \quad x \in \mathcal{D}(A), \quad \lambda \in [\sigma](A),$$

$$\|x\|^2 \leq M_2(\lambda) \left(\frac{1}{\lambda} \|(A - \lambda)x\|_0^2 + \|Cx\|_0^2 \right), \quad x \in \mathcal{D}(A). \quad \lambda \in [\sigma](A),$$

where L_2 is positively bounded from below and $M_2 \rightarrow +\infty$ as $\lambda \rightarrow +\infty$. We shall compute the asymptotics as $\lambda \rightarrow +\infty$ of the coefficients in the resolvent conditions (13) and (14) for the wave-like equation (57). Firstly, the converse in theorem 3.5 with $\alpha = 2$ yields

$$\|Cx\|^2 \leq L_1(\lambda) \|(\sqrt{A} - \lambda)x\|_0^2 + l_1(\lambda) \|x\|_0^2, \quad x \in \mathcal{D}(\sqrt{A}), \quad \lambda \in [\sigma](\sqrt{A}),$$

$$\|x\|^2 \leq M_1(\lambda) \|(\sqrt{A} - \lambda)x\|_0^2 + m_1(\lambda) \|Cx\|_0^2, \quad x \in \mathcal{D}(\sqrt{A}), \quad \lambda \in [\sigma](\sqrt{A}),$$

with $l_1(\lambda) = 2L_2(\lambda^2)$, $L_1(\lambda) = 2 \max \left\{ 9L_2(\lambda^2), 4\|C\|_{\mathcal{L}(H_1; Y)}^2 \right\}$, $m_1(\lambda) = 2M_2(\lambda^2)$

and $M_1(\lambda) \sim 2M_2(\lambda^2) \max \left\{ \frac{9}{2}, L_1(\lambda) + \frac{l_1(\lambda)}{\inf A} \right\}$. Secondly, with the same computations as in theorem 3.8, theorem 3.13 yields (13) and (14) with $l(\lambda) = l_1(\lambda) = 2L_2(\lambda^2)$, $L(\lambda) = L_1(\lambda) = 2 \max \left\{ 9L_2(\lambda^2), 4\|C\|_{\mathcal{L}(H_1; Y)}^2 \right\}$, $m(\lambda) = 4m_1(\lambda) = 8M_2(\lambda^2)$

and $M(\lambda) \sim 2M_2(\lambda^2) \max \left\{ \frac{9}{2}, L(\lambda) + \frac{2L_2(\lambda^2)}{\inf A}, 2L(\lambda) \right\}$. In particular, if L_2 is a constant, then L is a constant, and $M(\lambda) \sim 2M_2(\lambda^2) \max \left\{ \frac{9}{2}, L + \frac{2L_2}{\inf A}, 2L \right\}$. If $L_2 \rightarrow +\infty$ as $\lambda \rightarrow +\infty$, then $L(\lambda) \sim 18L_2(\lambda^2)$ and

$$M(\lambda) \sim 4L_2(\lambda^2)M_2(\lambda^2) \max \left\{ 9 + \frac{1}{\inf A}, 18 \right\}.$$

Similarly to corollary 3.10, we have in the case $s = 2$:

Corollary 3.15. *Admissibility and exact observability for the wave-like equation (57) hold if and only if $\frac{1}{\sqrt{\lambda}} \|(A - \lambda)x\|_0 + \|Cx\|$ is a norm on $\mathcal{D}(A)$ equivalent to $\frac{1}{\sqrt{\lambda}} \|(A - \lambda)x\|_0 + \|x\|_0$ uniformly for $\lambda \geq \inf A > 0$, and it implies admissibility and exact observability (in any positive time T if moreover $\sigma_{\text{ess}}(A) = \emptyset$) for the Schrödinger-like equation (29).*

REMARK 3.16. We first discuss earlier results concerning the first part of corollary 3.15, i.e. admissibility and observability resolvent conditions on A for the admissibility and the observability of the wave-like equation. The implication for observability was proved in [Mil05, proof of theorem 3.4]. The equivalence under the additional assumption that the resolvent of A is compact was proved in [RTT05, proposition 4.5] for observability, and in [Erv09, theorem 2.2] for admissibility by a proof through wavepackets conditions which does not relate explicitly the constants in the resolvent conditions (as partly explained after [Erv09, theorem 2.2], the submitted version of [Erv09, (2.9)] was [Erv08, (7.2.10)] which contains a spurious term in the right hand side; the privately communicated (52) for $s = 2$ gets rid of this spurious term and restricts the spectral interval; it was published as [Erv09, (2.10)]).

Concerning the implication from the wave-like equation to the Schrödinger-like equation in the second part of corollary 3.15: it was proved in [Mil05, theorem 3.1] for observability (cf. [TW09, theorem 6.7.2] for a simpler proof under the additional assumption that the resolvent of \mathcal{A} is compact, in which the cost cannot be estimated, cf. remark 3.17); it was proved in [TW09, proposition 6.8.1] for admissibility.

REMARK 3.17. Concerning the implication from the wave-like equation for some time $L > 0$ to the Schrödinger-like equation for all times $T > 0$ in corollaries 3.10 and 3.15, the following stronger result is proved in [Mil05]: without the assumption $\sigma_{\text{ess}}(A) = \emptyset$, for all times $T > 0$, the controllability cost $\kappa_{1,T}$ for the Schrödinger-like equation satisfies $\kappa_{1,T} \leq c \exp(\alpha L^2/T)$ where α is a universal constant and the positive constant c depends only on the uniform lower and upper bounds for the ratio between the two norms in corollaries 3.10 and 3.15 respectively (e.g. in the case of boundary observation, c depends only on L_s, l_s, M_s, m_s in (52) and (53) for $s = 2$). Although it is not explicit in [Mil05, theorem 3.1], this statement can be easily checked on the explicit bound of $\kappa_{1,T}$ at the end of its proof: α and γ come from an independent one dimensional problem, κ and d come from [Mil05, theorem 3.4] hence from [Mil05, theorem 6.1] hence depend only on the observability constants M_2 and m_2 of the wave-like equation, the admissibility constant $K_{1,1}$ of Schrödinger-like equation in time 1 comes from the corresponding constants L_2 and l_2 of the wave-like equation. We do not include here the proof of this result since it combines resolvent conditions with the quite different control transmutation method.

EXAMPLE 3.18. Combining corollary 3.15 with the interior control version of [BLR92] yields: under the geometric condition of Bardos, Lebeau and Rauch for the wave equation in $H_0^1 \times L^2$ with L^2 interior controls, exact controllability in arbitrary time holds for the Schrödinger equations generated by fractional Laplacians $(-\Delta)^\alpha$, $\alpha > 1/2$, in L^2 with L^2 interior controls. Recall that the heat equation generated by these fractional Laplacians (a.k.a. anomalous diffusion), is null-controllable in any positive time without geometric condition on the control set, cf. e.g. [Mil10].

4. SEMIDISCRETIZATION OF A SYSTEM WITH POSITIVE A

The framework of this section is the same as the previous section. In particular we keep the notations introduced at the beginning of section 3: a positive A , its scale of Sobolev spaces H_s and its observation system (28). This section introduces a finite-dimensional approximation of this system which encompasses a wide range of numerical schemes where the state space H_0 is a space of functions on the continuum \mathbb{R}^d discretized on non-uniform meshes. It investigates the links between the infinite-dimensional system (28) called the *continuous system* and such finite-dimensional

approximation called *semidiscretized system* because it applies to the discretization of spatial variables but not the time variable, cf. [EZZ08] for time discretization.

4.1. Approximation spaces. Let $(V^h)_{h>0}$ be a family of finite-dimensional vector spaces with injections $J_h : V^h \rightarrow H_0$. We assume that the range $H^h := J_h V^h$ of the injection J_h is included in $\mathcal{D}(\sqrt{A})$, therefore inducing a Hilbert structure on V^h from each H_s , $s \leq 1$. Let V_s^h denote V^h with the corresponding norm $\|v\|_s = \|J_h v\|_s$, $v \in V^h$. The dual $J_h^* : H_0 \rightarrow V_0^h$, defines the H_0 -orthogonal projection $J_h J_h^*$ from H_0 onto H^h , and the identity operator $J_h^* J_h$ on V^h .

Let π_h be the H_1 -orthogonal projection from H_1 onto H^h . The only *approximation assumption* we make is: $\|(I - \pi_h)A^{-1/2}\|_1 = O(h)$, i.e. $\exists c_0 > 0$,

$$(62) \quad \|x - \pi_h x\|_1 \leq c_0 h \|x\|_2, \quad x \in \mathcal{D}(A), \quad h > 0.$$

In other words $\|A^{1/2}x - A^{1/2}\pi_h x\|_0 \leq c_0 h \|Ax\|_0$, recalling $\|x\|_s = \|A^{s/2}x\|_0$.

N.b. only the asymptotics $h \rightarrow 0$ matters in this section, hence h can be restricted to a finite interval $h \in (0, h_0)$. When the approximation space V^h is based on a finite element, h is usually the maximal cell diameter of the mesh h_K , or $h = h_K^\theta$ for some fixed $\theta > 0$.

REMARK 4.1. The approximation assumption (62) is satisfied when J_h is the canonical injection of the H_1 -conformal approximation space $V^h = H^h$ based on the \mathbb{P}_1 Lagrange finite element for a shape-regular family of affine, simplicial, geometrically conformal meshes, cf. e.g. [EG04, Prop.1.134], where $J_h J_h^*$ and π_h are denoted $\Pi_{c,h}^{0,1}$ and $\Pi_{c,h}^{1,1}$, or [QV94, §3.5] where they are denoted P_h^1 and $\Pi_{1,h}^1$. N.b. in practice (62) is weaker than [Erv11, (1.9)] where $J_h J_h^*$ and h are denoted $\pi_h \pi_h^*$ and h^θ , since [Erv11, (1.9)] is satisfied only for quasi-uniform meshes, cf. e.g. [EG04, Prop.1.134(iii)] or [QV94, (3.5.21)]. N.b. quasi-uniform meshes satisfy the inverse inequality (65), cf. [EG04, Remark 1.143(i)] or [QV94, (6.3.21)], which is not assumed here unless explicitly.

REMARK 4.2. The following lemma 4.4 proves that (62) is equivalent to: $\exists c_1 > 0$,

$$\inf_{v \in V^h} (\|x - J_h v\|_0 + h \|x - J_h v\|_1) \leq c_1 h^2 \|x\|_2, \quad x \in \mathcal{D}(A), \quad h > 0,$$

or to the existence of an interpolation operator $I_h : \mathcal{D}(A) \rightarrow V^h$ such that: $\exists c_1 > 0$,

$$\|x - J_h I_h x\|_0 + h \|x - J_h I_h x\|_1 \leq c_1 h^2 \|x\|_2, \quad x \in \mathcal{D}(A), \quad h > 0.$$

The approximation assumption appears in the literature in one of these three forms.

REMARK 4.3. The framework of this section can be slightly generalized by considering two bounded linear operators: an injection $J_h : V^h \rightarrow H_0$ and an interpolation operator $J_h^* : H_0 \rightarrow V^h$ (not necessarily the adjoint of J_h) such that $J_h^* J_h$ is the identity operator on V^h . In this case $J_h^* J_h$ is still a projection from H_0 onto H^h although this projection is not necessarily orthogonal, hence the only failing statements in this section are the first two parts of lemma 4.8. Moreover, in practice lemma 4.8 holds anyway since interpolation operators are usually required to satisfy (71), e.g. finite element interpolation operators for a shape-regular family of affine meshes does, cf. e.g. [EG04, Cor.1.109]. This framework also generalizes to infinite-dimensional Hilbert spaces $(V^h)_{h>0}$. In this case, whenever the admissibility of finite-dimensional systems is used explicitly in a proof, the corresponding statement should assume the admissibility of the semidiscrete system.

The approximation assumption (62) is the same as [RTT07, (1.7)] (which deals with stabilization rather than observability, and with second rather than first order systems) and [CMT11, (1.4)] where h is denoted h^θ . Indeed, each of these papers makes a second approximation assumption: [RTT07, (1.8)] and [CMT11, (1.5)].

They are both a consequence of the first according to the following lemma (which is a simple version of the Aubin-Nitsche lemma, cf. e.g. [EG04, lemma 2.31]).

Lemma 4.4. *The approximation assumption (62) (in H_1) implies the approximation in H_0 : $\|(I - \pi_h)A^{-1/2}\|_{\mathcal{L}(H_0)} = O(h)$ and $\|(I - \pi_h)A^{-1}\|_{\mathcal{L}(H_0)} = O(h^2)$.*

More precisely, (62) implies, with the same constant c_0 ,

$$(63) \quad \|x - \pi_h x\|_0 \leq c_0 h \|x\|_1, \quad x \in H_1, \quad h > 0,$$

$$(64) \quad \|x - \pi_h x\|_0 \leq c_0^2 h^2 \|x\|_2, \quad x \in H_2, \quad h > 0.$$

Proof. Since A and π_h are selfadjoint on H_1 , the H_1 -adjoint of $(I - \pi_h)A^{-1/2}$ is $A^{-1/2}(I - \pi_h)$, hence they have the same H_1 operator norm and its square is the H_1 operator norm of the latter times the former. Therefore

$$\begin{aligned} \|(I - \pi_h)A^{-1/2}\|_{\mathcal{L}(H_0)} &= \|A^{-1/2}(I - \pi_h)\|_{\mathcal{L}(H_1)} = \|(I - \pi_h)A^{-1/2}\|_{\mathcal{L}(H_1)} = c_0 h, \\ \|(I - \pi_h)A^{-1}\|_{\mathcal{L}(H_0)} &= \|(I - \pi_h)^2 A^{-1}\|_{\mathcal{L}(H_0)} \\ &= \|A^{-1/2}(I - \pi_h)(I - \pi_h)A^{-1/2}\|_{\mathcal{L}(H_1)}, = \|(I - \pi_h)A^{-1/2}\|_{\mathcal{L}(H_1)}^2 = (c_0 h)^2. \end{aligned}$$

where $(I - \pi_h)^2 = I - \pi_h$ since $I - \pi_h$ is an H_1 -orthogonal projection as π_h . \square

4.2. Galerkin approximation of the unitary group. In the framework of § 4.1, the Ritz-Galerkin variational method considers the finite-dimensional positive selfadjoint operator $G_h = (\sqrt{A}J_h)^*(\sqrt{A}J_h) : V_h \rightarrow V_h$ and approximates A by the non-negative selfadjoint operator $A_h = (\sqrt{A}J_h J_h^*)^*(\sqrt{A}J_h J_h^*) = J_h G_h J_h^*$ on H_0 . Their spectra are related by $\sigma(A_h) = \sigma(G_h) \cup \{0\}$.

Lemma 4.5. *The infimum of the spectrum satisfies $\inf G_h \geq \inf A > 0$.*

The spectrum satisfies $\sigma(G_h) \subset [\inf A, \eta_0/h^2]$ if this inverse inequality holds

$$(65) \quad h \|x\|_1 \leq \sqrt{\eta_0} \|x\|_0, \quad x \in H^h.$$

Proof. The first inequality results from $(\inf \sqrt{A})^2 = \inf A$ and

$$\inf G_h = \inf_{v \in V_h} \frac{\langle G_h v, v \rangle_0}{\|v\|^2} = \inf_{x \in H^h} \frac{\langle \sqrt{A}x, \sqrt{A}x \rangle_0}{\|x\|_0^2} \geq \inf_{x \in \mathcal{D}(\sqrt{A})} \frac{\langle \sqrt{A}x, \sqrt{A}x \rangle_0}{\|x\|_0^2} = (\inf \sqrt{A})^2.$$

Using (65): $\sup G_h = \sup_{v \in V_h} \langle G_h v, v \rangle_0 / \|v\|^2 = \sup_{x \in H^h} \|x\|_1^2 / \|x\|_0^2 \leq \eta_0 / h^2$. \square

N.b. the definition of G_h implies that the norm in V_1^h coincides with the “ H_1 Sobolev norm corresponding to G_h ” and the dual norms also coincide, i.e.

$$(66) \quad \|v\|_1 = \|J_h v\|_1 = \|G_h^{1/2} v\|_0 \quad \text{and} \quad \|v\|_{-1} = \|J_h v\|_{-1} = \|G_h^{-1/2} v\|_0, \quad v \in V^h.$$

Lemma 4.6. *This equality of bounded operators on H_0 defines G_h in terms of π_h :*

$$(67) \quad \pi_h A^{-1} = J_h G_h^{-1} J_h^*.$$

The approximation assumption (62) is $\|(A^{-1} - J_h G_h^{-1} J_h^)x\|_1 \leq c_0 h \|x\|_0$, $x \in H_0$. It implies A_h converges to A in H_1 strongly in the resolvent sense, i.e.:*

$$(A - z)^{-1} x \rightarrow (A_h - z)^{-1} x \quad \text{in } H_1, \quad x \in H_1, \quad \text{Im } z \neq 0.$$

Proof. For all $v \in V^h$, $\langle \pi_h A^{-1} x, J_h v \rangle_1 = \langle A^{-1} x, J_h v \rangle_1 = \langle x, J_h v \rangle_0 = \langle J_h^* x, v \rangle_0 = \langle G_h^{-1} J_h^* x, v \rangle_1 = \langle J_h G_h^{-1} J_h^* x, J_h v \rangle_1$. This proves (67).

Let $R_0(z) = (A - z)^{-1}$, $z \notin \sigma(A)$, and $R_h(z) = J_h (G_h - z)^{-1} J_h^*$, $z \notin \sigma(G_h)$. According to lemma 4.5, the distance of 0 to $\sigma(A)$ and to $\sigma(G_h)$ is greater than $\inf A$, hence $\|R_h(0)\| \leq 1/\inf A$, $h \geq 0$. For all $z \in \mathbb{C}$ such that $|z| < \inf A$, the Neumann series $R_h(z) = \sum_{k=0}^{\infty} z^k R_h(0)^{k+1}$ converges for all $|z| < \inf A$ and $h \geq 0$ and the approximation assumption implies $R_h(0)x \rightarrow R_0(0)x$ in H_1 as $h \rightarrow 0$, hence $R_h(z)x \rightarrow R_0(z)x$ in H_1 . This property is propagated to all $z \in \mathbb{C}$ such that

$\text{Im } z \neq 0$ by Neumann series similarly, since the distance of z to $\sigma(A)$ and to $\sigma(G_h)$ is greater than $\text{Im } z$. This completes the proof of the convergence in the strong resolvent sense, since $\sigma(A_h) \subset \mathbb{R}$ and $R_h(z) = (A_h - z)^{-1}$ for $z \notin \sigma(A_h)$. \square

This convergence in the strong resolvent sense is called ‘‘convergence in the generalized sense’’ in [Kat95, §.VIII.1.2] where the following two spectral properties are deduced. All open set containing a point of $\sigma(A)$ contains at least a point of $\sigma(A_h)$ for sufficiently large h , i.e. the spectrum does not expand suddenly in the limit (in particular, with lemma 4.5: $\inf_h \inf G_h = \inf A$). If $\lambda \in \mathbb{R}$ is not an eigenvalue of A , then the finite dimensional spectral projections $\mathbf{1}_{A_h < \lambda} = J_h \mathbf{1}_{G_h < \lambda} J_h^*$ satisfy:

$$(68) \quad \|(\mathbf{1}_{A < \lambda} - \mathbf{1}_{A_h < \lambda})x\|_1 \rightarrow 0, \quad x \in H_1.$$

The following theorem is a quantitative version of the semigroup approximation [Kat95, theorem IX.2.16] (i.e. convergence in the strong resolvent sense implies strong convergence of the generated semigroups uniformly on finite time intervals).

Theorem 4.7. *If $x^h \rightarrow x$ in H_0 (resp. in H_1) then $e^{itA_h}x^h \rightarrow e^{itA}x$ in H_0 (resp. in H_1) uniformly on finite intervals of t .*

More precisely, (62) implies these convergence rates in H_1 and H_0 :

$$(69) \quad \|(e^{itA_h} - e^{itA})x\|_1 \leq c_0 h(t\|x\|_4 + 2\|x\|_2), \quad x \in H_4, \quad h > 0, \quad t \in \mathbb{R},$$

$$(70) \quad \|(e^{itA_h} - e^{itA})x\|_0 \leq c_0^2 h^2(t\|x\|_4 + 2\|x\|_2), \quad x \in H_4, \quad h > 0, \quad t \in \mathbb{R}.$$

Proof. We recall the formula [Kat95, (IX.2.27)] which is simply verified by taking time derivatives: with $R(\varepsilon) = (\varepsilon + A)^{-1}$ and $R_h(\varepsilon) = (\varepsilon + A_h)^{-1}$,

$$R_h(\varepsilon) (e^{itA_h} - e^{itA}) R(\varepsilon) = i \int_0^t e^{i(t-s)A_h} (R(\varepsilon) - R_h(\varepsilon)) e^{isA} ds.$$

Taking the limit $\varepsilon \rightarrow 0$ yields, since $R_h(\varepsilon) \rightarrow J_h G_h^{-1} J_h^* = \pi_h A^{-1}$ due to (67), and since $R_h(\varepsilon)e^{itA_h} = e^{itA_h} R_h(\varepsilon)$:

$$(e^{itA_h} \pi_h - \pi_h e^{itA}) A^{-2} = i \int_0^t e^{i(t-s)A_h} (I - \pi_h) A^{-1} e^{isA} ds.$$

Combining this with (62), (64) and the unitarity of the group first yields

$$\|(e^{itA_h} \pi_h - \pi_h e^{itA})x\|_1 \leq c_0 h t \|x\|_4, \quad x \in H_4, \quad h > 0, \quad t \in \mathbb{R},$$

$$\|(e^{itA_h} \pi_h - \pi_h e^{itA})x\|_0 \leq c_0^2 h^2 t \|x\|_4, \quad x \in H_4, \quad h > 0, \quad t \in \mathbb{R},$$

then completes the proof of (69) and (70). These imply the first statement of the theorem since $H_4 = D(A^2)$ is dense in H_1 and in H_0 , and the group is unitary. \square

The following lemma is used to approximate initial data in theorems 4.14 and 4.19.

Lemma 4.8. *The approximation assumption (62) implies*

$$(71) \quad \|x - J_h J_h^* x\|_0 \leq c_0 h \|x\|_1, \quad x \in H_1, \quad h > 0,$$

$$(72) \quad \|x - J_h J_h^* x\|_{-1} \leq c_0 h \|x\|_0, \quad x \in H_0, \quad h > 0,$$

$$(73) \quad \|x - J_h J_h^* x\|_{-1} \leq c_0^2 h^2 \|x\|_1, \quad x \in H_1, \quad h > 0,$$

$J_h J_h^ x \rightarrow x$ in H_0 for all $x \in H_0$ and $A_h \pi_h A^{-1} x \rightarrow x$ in H_{-1} for all $x \in H_{-1}$.*

Proof. Using that $J_h J_h^*$ hence $I - J_h J_h^*$ are H_0 -orthogonal projection, $\|J_h J_h^* \xi\|_0 \leq \|\xi\|_0$, $\xi \in H_0$, and $\|x - J_h J_h^* x\|_0 \leq \|x - \pi_h x\|_0$, $x \in H_1$, Hence (62) implies (71). Replacing π_h by $J_h J_h^*$ and H_1 by H_0 in the proof of lemma 4.4 deduces (72), (73).

To prove the first convergence, let $x \in H_0$ and $\varepsilon > 0$. There exists $x_\varepsilon \in H_1$ such that $\|x - x_\varepsilon\|_0 \leq \varepsilon$. Taking $\xi = x - x_\varepsilon$ yields $\|J_h J_h^*(x - x_\varepsilon)\|_0 \leq \varepsilon$ and (71) yields $\|x_\varepsilon - J_h J_h^* x_\varepsilon\|_0 \leq c_0 h \|x_\varepsilon\|_1$. Hence $\|x - J_h J_h^* x\|_0 \leq 2\varepsilon + c_0 h \|x_\varepsilon\|_1$. Taking first the lim sup as $h \rightarrow 0$ then the limit $\varepsilon \rightarrow 0$ completes the proof of the first convergence.

The second convergence is proved similarly by density of H_0 in H_{-1} since, for $x_\varepsilon \in H_0$, $A_h \pi_h A^{-1} x_\varepsilon = J_h G_h J_h^* J_h G_h^{-1} J_h^* x_\varepsilon = J_h J_h^* x_\varepsilon$, and, for $\xi = x - x_\varepsilon \in H_{-1}$, $\|A_h \pi_h A^{-1} \xi\|_{-1} = \|G_h J_h^* \pi_h A^{-1} \xi\|_{-1} = \|J_h^* \pi_h A^{-1} \xi\|_1 = \|\pi_h A^{-1} \xi\|_1 \leq \|A^{-1} \xi\|_1 = \|\xi\|_{-1}$ using (67), (66) and that π_h is an H_1 -orthogonal projection. \square

4.3. “Interior” semidiscrete systems. In order to define the semidiscrete observation system for the generator G_h :

$$(74) \quad v^h(t) - iG_h v^h(t) = 0, \quad v^h(0) = v_0^h \in H^h, \quad y^h(t) = C_h v^h(t),$$

it seems natural to approximate the observation operator C by

$$(75) \quad C_h = C J_h, \quad C \in \mathcal{L}(H_1; Y).$$

N.b. in order for this definition of C_h to make sense we must assume $C \in \mathcal{L}(H_1; Y)$. As already mentioned in §3.2.3, this assumption is in-between the general case $C \in \mathcal{L}(H_2; Y)$ adapted to boundary observability of PDEs and the bounded case $C \in \mathcal{L}(H_0; Y)$ adapted to interior observability of PDEs.

N.b. the norm of C_h in $\mathcal{L}(V_1^h; Y)$ is the norm of C in $\mathcal{L}(H_1; Y)$.

4.3.1. Convergence of the observation systems. In this framework, the following proposition discusses the convergence of the discrete observation y^h in (74) to the continuous observation y in (28) depending on the convergence of the initial data $J^h v_0^h$ to x_0 in H_1 . It uses the following lemma.

Lemma 4.9. *Assume (28) is admissible. Consider $(v^h)_{h>0}$ in V^h and $x \in H_0$. Weakly in $L^2(0, T; Y)$: $C_h e^{itG_h} G_h^{-1} v^h \rightarrow C e^{itA} A^{-1} x$ implies $C_h e^{itG_h} v^h \rightarrow C e^{itA} x$.*

Proof. If $x \in \mathcal{D}(A)$ then $CA^{-1} e^{itA} x \in C^1(0, T; Y)$ hence the following integration by parts is justified, therefore by admissibility of (28) and density of $\mathcal{D}(A)$ in H_0 :

$$i \int_0^T \langle CA^{-1} e^{itA} x, \varphi'(t) \rangle dt = \int_0^T \langle C e^{itA} x, \varphi(t) \rangle dt, \quad x \in H_0, \quad \varphi \in C_{\text{comp}}^1(0, T; Y).$$

Since H_h is finite dimensional, (74) is admissible and similarly

$$i \int_0^T \langle C_h G_h^{-1} e^{itG_h} v^h, \varphi'(t) \rangle dt = \int_0^T \langle C_h e^{itG_h} v^h, \varphi(t) \rangle dt, \quad v^h \in H^h.$$

The density of $C_{\text{comp}}^1(0, T; Y)$ in $L^2(0, T; Y)$ completes the proof. \square

Proposition 4.10. *Assume (75). Consider a family $(v^h)_{h>0}$ in V^h .*

If $J_h v^h \rightarrow x$ in H_1 then $C_h e^{itG_h} v^h \rightarrow C e^{itA} x$ in Y uniformly on finite intervals.

More precisely, (62) implies the convergence rate

$$\|(C_h e^{itG_h} J_h^* - C e^{itA})x\| \leq \|C\|_{\mathcal{L}(H_1; Y)} c_0 h(t\|x\|_4 + 2\|x\|_2), \quad x \in H_4, \quad h > 0, \quad t \in \mathbb{R}.$$

If $J_h v^h \rightarrow x$ in H_1 then $C_h e^{itG_h} v^h \rightarrow C e^{itA} x$ in $L^2(0, T; Y)$ for all $T > 0$.

If $J_h v^h \rightarrow x$ in H_{-1} , $x \in H_0$ and (28) is admissible then $C_h e^{itG_h} v^h \rightarrow C e^{itA} x$ in $L^2(0, T; Y)$ for all $T > 0$.

Proof. The first implication results from the convergence in H_1 in the first part of theorem 4.7, since $C_h e^{itG_h} = C e^{itA_h} J_h$ and $C \in \mathcal{L}(H_1; Y)$. Moreover (69) implies the convergence rate since $C_h e^{itG_h} J_h^* - C e^{itA} = C(e^{itA_h} - e^{itA})$.

The strong convergence implication in the first part of theorem 4.7 also implies the weak convergence implication: if $x^h \rightarrow x$ in H_1 then $e^{itA_h} x^h \rightarrow e^{itA} x$ in H_1 uniformly on finite intervals of t . Using $C_h e^{itG_h} = C e^{itA_h} J_h$ and $C \in \mathcal{L}(H_1; Y)$ again results in the second implication in proposition 4.10.

To prove the third implication, we assume $J_h v^h \rightarrow x$ in H_{-1} , equivalently $J_h G_h^{-1} v^h \rightarrow A^{-1} x$ in H_1 . By the second implication, $C_h e^{itG_h} G_h^{-1} v^h \rightarrow C A^{-1} e^{itA} x$ in $L^2(0, T; Y)$. Lemma 4.9 completes the proof. \square

4.3.2. *From continuous to filtered discrete observability.* We consider improved resolvent conditions for (28), $s \geq 0$: $\exists L_s, l_s, M_s, m_s > 0$,

$$(76) \quad \|Cx\|^2 \leq \frac{L_s}{\lambda^s} \|(A - \lambda)x\|_0^2 + l_s \|x\|_0^2, \quad x \in H_0, \quad \lambda \geq \inf A,$$

$$(77) \quad \|x\|_0^2 \leq \frac{M_s}{\lambda^s} \|(A - \lambda)x\|_0^2 + m_s \|Cx\|^2, \quad x \in H_0, \quad \lambda \geq \inf A.$$

Unfortunately such conditions do not imply the corresponding conditions for the semidiscrete system (74) uniformly with respect to h . Therefore we consider uniform conditions for the semidiscrete system (74) restricted to the *filtered space* $\mathbf{1}_{G_h < \eta/h^\sigma} V^h$, where η and σ are positive filtering parameters: $\exists L'_s, l'_s, M'_s, m'_s > 0$,

$$(78) \quad \|C_h v\|^2 \leq \frac{L'_s}{\lambda^s} \|(G_h - \lambda)v\|_0^2 + l'_s \|v\|_0^2, \quad v \in \mathbf{1}_{G_h < \eta/h^\sigma} V^h, \quad \eta/h^\sigma \geq \lambda \geq \inf A,$$

$$(79) \quad \|v\|_0^2 \leq \frac{M'_s}{\lambda^s} \|(G_h - \lambda)v\|_0^2 + m'_s \|C_h v\|^2, \quad v \in \mathbf{1}_{G_h < \eta/h^\sigma} V^h, \quad \eta/h^\sigma \geq \lambda \geq \inf A.$$

Theorem 4.11. *Assume (75). Recall the approximation assumption (62) with c_0 .*

If the continuous system (28) is admissible (resp. moreover exactly observable) then, for all $\eta > 0$ (resp. for $\eta > 0$ small enough), there exists $T > 0$ such that the semidiscrete system (74) restricted to the filtered space $\mathbf{1}_{G_h < \eta/h} V^h$ is admissible in time T (resp. moreover exactly observable in time T) uniformly in $h \in (0, \eta)$.

If the second order system (56) is admissible and exactly observable then, for all $\eta > 0$ small enough, for all $T > 0$, the semidiscrete system (74) restricted to the filtered space $\mathbf{1}_{G_h < \eta/h} V^h$ is admissible and exactly observable in time T uniformly in $h \in (0, \eta)$.

If $C \in \mathcal{L}(H_0; Y)$ and the second order system (56) is admissible and exactly observable then, for all $\eta > 0$ small enough, for all $T > 0$, the semidiscrete system (74) restricted to the filtered space $\mathbf{1}_{G_h < \eta/h^{4/3}} V^h$ is admissible and exactly observable in time T uniformly in $h \in (0, \eta)$.

More precisely, for $\sigma = 1$ and any $s \geq 0$, setting $c_\eta = \max\{(c_0\eta)^2, c_0\eta\}$: for all $\eta > 0$, (76) implies (78) with $L'_s = 4L_s$ and $l'_s = 4l_s + 2(\|C\|^2 + 2l_s + 2L_s/\inf A^s)c_\eta^2$; for $\eta > 0$ small enough such that $d_s = 1 - c_\eta^2(1 + 4m_s\|C\|^2 - 4M_s/\inf A^s) > 0$, (77) implies (79) with $M'_s = 2M_s/d_s$ and $m'_s = 2m_s/d_s$. Here $\|C\| = \|C\|_{\mathcal{L}(H_1; Y)}$.

Proof. According to proposition 2.9, $\lambda \geq \inf A$ in (76), (77), (78), (79) can be equivalently replaced by $\lambda > 0$ since $\inf G_h \geq \inf A > 0$. For $s = 0$, the range of λ can be equivalently replaced by $\lambda \in \mathbb{R}$. Thus, the first (resp. second) implication of the theorem results from the last part of the theorem with $s = 0$ (resp. $s = 1$) according to theorems 2.3 and 2.4 (resp. theorem 3.13 and remark 3.17).

To prove the last part of the theorem let $v \in V^h$ and consider $x^h = A^{-1}J_h G_h v$. It satisfies $Ax^h = J_h G_h v$ and $\pi_h x^h = J_h v$ due to (67), hence $x^h - J_h v = (I - \pi_h)x^h$,

$$(A - \lambda)x^h - J_h(G_h - \lambda)v = -\lambda(I - \pi_h)x^h, \quad Cx^h - C_h v = C(I - \pi_h)x^h.$$

Using lemma 4.4, $C \in \mathcal{L}(H_1; Y)$ and (62), this implies $\|x^h - J_h v\|_0 \leq c_0^2 h^2 \|Ax^h\|_0$,

$$\|(A - \lambda)x^h - J_h(G_h - \lambda)v\|_0 \leq c_0^2 h^2 \lambda \|Ax^h\|_0, \quad \|Cx^h - C_h v\|/\|C\| \leq c_0 h \|Ax^h\|_0.$$

Let $\sigma = 1$, $s > 0$, $\eta > 0$ and $\eta/h \geq \lambda > 0$. For $v \in \mathbf{1}_{G_h < \eta/h} V^h$, $\|Ax^h\|_0 = \|G_h v\|_0 \leq (\eta/h)\|v\|_0$. Hence all the above norms are bounded by $c_\eta \|v\|_0$ for $h < \eta$. Plugging these bounds in (76) and (77) for x^h , and factoring out $\|v\|_0^2$ yields (78) and (79) with the constants stated in the theorem.

To prove the third implication of the theorem, we assume $C \in \mathcal{L}(H_0; Y)$ and (76) and (77) with $s = 1$. The above bound is now replaced by

$$\|Cx^h - C_h v\|/\|C\| \leq c_0^2 h^2 \|Ax^h\|_0,$$

which is better than $\lambda^{-s/2} \|(A - \lambda)x^h - J_h(G_h - \lambda)v\|_0 \leq c_0^2 h^2 \lambda^{1-s/2} \|Ax^h\|_0$ for $s < 2$, $\lambda > 1$. For $v \in \mathbf{1}_{G_h < \eta/h^{4/3}} V^h$, $\|Ax^h\|_0 = \|G_h v\|_0 \leq (\eta/h)^{4/3} \|v\|_0$. Plugging these bounds in (76) and (77) with $s = 1$ for x^h , yield (78) and (79) with $s = 1$ and errors bounded by the square of $c_0^2 h^2 ((\eta/h)^{4/3})^{1-1/2+1} \|v\|_0$ for $h < \eta$, where the power of h is zero. \square

4.3.3. From filtered discrete to continuous observability. We prove that generalized resolvent conditions for the continuous system (28),

$$(80) \quad \|Cx\|^2 \leq L(\lambda) \|(A - \lambda)x\|_0^2 + l(\lambda) \|x\|_0^2, \quad x \in \mathcal{D}(A), \quad \lambda > \lambda_0 \geq 0,$$

$$(81) \quad \|x\|_0^2 \leq M(\lambda) \|(A - \lambda)x\|_0^2 + m(\lambda) \|Cx\|^2, \quad x \in \mathcal{D}(A), \quad \lambda > \lambda_0 \geq 0,$$

where l , L , m and M are bounded positive functions on $(0, +\infty)$, can be obtained as the h -limit of the following h -uniform resolvent conditions for the semidiscrete system (74) restricted to the *filtered space* $\mathbf{1}_{G_h < f(h)} V^h$, where $f : (0, h_0) \rightarrow (0, +\infty)$ decreases and $f(h) \rightarrow +\infty$ as $h \rightarrow 0$:

$$(82) \quad \|C_h v\|^2 \leq L(\lambda) \|(G_h - \lambda)v\|_0^2 + l(\lambda) \|v\|_0^2, \quad v \in \mathbf{1}_{G_h < f(h)} V^h, \quad \lambda \in [\lambda_0, f(h)),$$

$$(83) \quad \|v\|_0^2 \leq M(\lambda) \|(G_h - \lambda)v\|_0^2 + m(\lambda) \|C_h v\|^2, \quad v \in \mathbf{1}_{G_h < f(h)} V^h, \quad \lambda \in [\lambda_0, f(h)).$$

Theorem 4.12. *Assume (75). The semidiscrete admissibility (resp. observability) resolvent condition (82) implies (80) (resp. (83) implies (81)).*

Proof. Consider $x \in \mathcal{D}(A)$ and $\mu > \lambda > \lambda_0$. It is enough to prove (80) and (81) for x replaced by $\mathbf{1}_{A < \mu} x$ since $\|x - \mathbf{1}_{A < \mu} x\|_2 = \|A \mathbf{1}_{A \geq \mu} x\|_0 \rightarrow 0$ as $\mu \rightarrow \infty$. Let $h_\mu > 0$ such that $f(h_\mu) > \mu$, and let $v^h = \mathbf{1}_{G_h < \mu} J_h^* \pi_h x \in \mathbf{1}_{G_h < f(h)} V^h$ for all $h \in (0, h_\mu)$. Since $\mathbf{1}_{A_h < \mu} \pi_h - \mathbf{1}_{A < \mu} = (\mathbf{1}_{A_h < \mu} - \mathbf{1}_{A < \mu}) \pi_h + \mathbf{1}_{A_h < \mu} (I - \pi_h)$, using (68) and (62) yields $\|J_h v^h - \mathbf{1}_{A < \mu} x\|_1 = \|(\mathbf{1}_{A_h < \mu} \pi_h - \mathbf{1}_{A < \mu}) x\|_1 \rightarrow 0$ as $h \rightarrow 0$. Since $C \in \mathcal{L}(H_1; Y)$, this convergence implies $\|C_h v^h - C \mathbf{1}_{A < \mu} x\| = \|C(J_h v^h - \mathbf{1}_{A < \mu} x)\| \rightarrow 0$. Since $J_h G_h v^h = J_h \mathbf{1}_{G_h < \mu} G_h J_h^* \pi_h A^{-1} A x = \mathbf{1}_{A_h < \mu} A x$ due to (67), since $\|(\mathbf{1}_{A < \mu} - \mathbf{1}_{A_h < \mu}) A x\|_0 \rightarrow 0$ due to (68), the convergence $J_h v^h \rightarrow \mathbf{1}_{A < \mu} x$ in H_1 hence in H_0 implies $\|J^h(G_h - \lambda)v^h - (A - \lambda) \mathbf{1}_{A < \mu} x\|_0 \rightarrow 0$. Therefore, taking the limit $h \rightarrow 0$ in (82) and (83) for v^h implies (80) and (81) for $\mathbf{1}_{A < \mu} x$. \square

4.3.4. Convergence of the filtered control systems. We consider the semidiscrete control system dual to (74) with $B_h = (A^{1/2} J_h)^* A^{-1/2} B = G_h J_h^* \pi_h A^{-1} B$ (which is both the dual of $C_h : V_1^h \rightarrow Y$ and the adjoint of $C_h : V_0^h \rightarrow Y$),

$$(84) \quad \dot{\psi}^h(t) - iG_h \psi^h(t) = B_h u^h, \quad \psi^h(0) = \psi_0^h \in H^h, \quad u^h \in L_{\text{loc}}^2(\mathbb{R}; Y).$$

N.b. the norm of B_h in $\mathcal{L}(Y; V_{-1}^h)$ is the norm of C in $\mathcal{L}(H_1; Y)$. According to theorems 2.3 and 2.4, the admissibility and exact observability resolvent conditions (82) and (83) for constant l , L , m and M are equivalent to the admissibility and exact observability of (74) restricted to the filtered space $\mathbf{1}_{G_h < f(h)} V^h$ for some $T > 0$ uniformly in h . As in definitions 2.1 and 2.2, the dual notions for (84) are the following. There is an admissibility cost K_T such that:

$$(85) \quad \left\| \int_0^T e^{itG_h} B_h u^h(t) dt \right\|^2 \leq K_T \int_0^T \|u^h(t)\|^2 dt, \quad u^h \in L^2(\mathbb{R}; Y).$$

There is a controllability cost $\kappa_T > 0$ such that: $\forall \psi_0 \in H^h, \exists u^h \in L^2(\mathbb{R}; Y)$,

$$(86) \quad u^h(t) = 0, \quad t \notin [0, T], \quad \mathbf{1}_{G_h < f(h)} \psi^h(T) = 0 \quad \text{and} \quad \int_0^T \|u^h(t)\|^2 dt \leq \kappa_T \|\psi_0^h\|_0^2.$$

The following theorem discusses the convergence of the inputs u^h for the discrete system (84) to the input u for the continuous system (29) depending on the convergence of the initial data $J_h \psi_0^h$ to ξ_0 . It needs the notion of *minimal control* investigated by Jacques-Louis Lions, a.k.a. HUM control after the Hilbert Uniqueness Method he introduced (cf. [Lio88]), and the characterization of this minimal control u in (29) as the only control being also an observation y in (28). For completeness, we prove this result and the same result for the discrete system (84).

Proposition 4.13. *If (28) is admissible and exactly observable in time T at cost κ_T then among all the inputs u such that the solution of (29) satisfies $\xi(T) = 0$, there is one of minimal norm in $L^2(0, T; Y)$ and this is the only one for which there exists $x_0 \in H_0$ such that $u(t) = Ce^{itA}x_0$, $t \in [0, T]$. Moreover it satisfies*

$$(87) \quad \|x_0\|_0 \leq \kappa_T \|\xi_0\|_0 \quad \text{and} \quad -\langle x_0, \xi_0 \rangle_0 = \int_0^T \|u(t)\|^2 dt \leq \kappa_T \|\xi_0\|_0^2.$$

If (74) restricted to the filtered space $\mathbf{1}_{G_h < f(h)} V^h$ is exactly observable in time T , among all the inputs u^h such that the solution of (84) satisfies $\mathbf{1}_{G_h < f(h)} \psi^h(T) = 0$, there is one of minimal norm in $L^2(0, T; Y)$ and this is the only one for which there exists $v_0^h \in \mathbf{1}_{G_h < f(h)} V^h$ such that $u^h(t) = C_h e^{itG_h} v_0^h$, $t \in [0, T]$.

Proof. The Hilbert space H_0 with the hermitian scalar product $\langle \cdot, \cdot \rangle_0$ is also a real Hilbert space with the scalar product $\text{Re} \langle \cdot, \cdot \rangle_0$. Consider the strictly convex C^1 functional J defined on the real Hilbert space H_0 by density and admissibility as

$$(88) \quad J(x) = \frac{1}{2} \int_0^T \|Ce^{itA}x\|^2 dt + \text{Re} \langle x, \xi_0 \rangle_0, \quad x \in \mathcal{D}(A).$$

Exact observability implies $J(x) \geq \frac{1}{2\kappa_T} \|x\|^2 + \text{Re} \langle x, \xi_0 \rangle_0$, hence J is coercive. Therefore J has a unique minimizer $x_* \in H_0$, i.e. $J(x_*) = \inf_{x \in H_0} J(x)$, and the gradient ∇J computed with respect to the real scalar product $\text{Re} \langle \cdot, \cdot \rangle_0$ vanishes at x_* , hence

$$0 = e^{iT A} \nabla J(x_*) = \int_0^T e^{i(T-t)A} B C e^{itA} x_* dt + e^{iT A} \xi_0.$$

This equation also says that the solution of (29) with the input $u_*(t) = Ce^{itA}x_*$ reaches the final state $\xi(T) = 0$. In terms of this u_* , $\langle \nabla J(x_*), x_* \rangle_0 = 0$ writes

$$(89) \quad \int_0^T \|u_*(t)\|^2 dt = \int_0^T \|Ce^{itA}x_*\|^2 dt = -\langle x_*, \xi_0 \rangle_0.$$

The second equality and observability yield $\frac{1}{\kappa_T} \|x_*\|_0^2 \leq -\langle x_*, \xi_0 \rangle_0 \leq \|x_*\|_0 \|\xi_0\|_0$. Hence $\|x_*\|_0 \leq \kappa_T \|\xi_0\|_0$. Plugging this in (89) yields (87) for x_* and u_* .

Integrating by parts in time the scalar product in H_0 of (28) and (29) yields:

$$(90) \quad \langle e^{iT A} x_0, \xi(T) \rangle_0 = \langle x_0, \xi_0 \rangle_0 + \int_0^T \langle Ce^{itA} x_0, u(t) \rangle dt,$$

for all x_0, ξ_0 in H_0 and u in $L^2(\mathbb{R}; Y)$. Thus u controls ξ_0 in time T if and only if

$$(91) \quad 0 = \langle x, \xi_0 \rangle_0 + \int_0^T \langle Ce^{itA} x, u(t) \rangle dt, \quad x \in H_0.$$

The minimality of u_* results from this consequence of (89) and (91) with $x = x_*$:

$$\|u_*\|_{L^2(0, T; Y)}^2 = \int_0^T \|u_*(t)\|^2 dt = \int_0^T \langle u_*(t), u(t) \rangle dt \leq \|u_*\|_{L^2(0, T; Y)} \|u\|_{L^2(0, T; Y)}.$$

Writing (91) twice with $x = x_0 - x_*$, once with $u(t) = Ce^{itA}x_0$ and once with $u_*(t) = Ce^{itA}x_*$, then taking the difference of the two equations yields

$$0 = \int_0^T \langle Ce^{itA}x, u(t) - u_*(t) \rangle dt = \int_0^T \|Ce^{itA}x\|^2 dt.$$

Exact observability deduces $\|x\|^2 = 0$, therefore $x_0 = x_*$ hence $u = u_*$.

The second implication is proved similarly considering the functional J_h defined on the real Hilbert space $\mathbf{1}_{G_h < f(h)} V^h$ with scalar product $\text{Re}\langle \cdot, \cdot \rangle_0$ by

$$J_h(v) = \frac{1}{2} \int_0^T \|C_h e^{itG_h} v\|^2 dt + \text{Re}\langle v, \psi_0 \rangle_0, \quad v \in \mathbf{1}_{G_h < f(h)} V^h.$$

The projection $\mathbf{1}_{G_h < f(h)}$ commutes with $e^{iT G_h}$ and, for this scalar product,

$$\nabla J_h(v) = \mathbf{1}_{G_h < f(h)} \int_0^T e^{-itG_h} B_h C_h e^{itG_h} v dt + \mathbf{1}_{G_h < f(h)} \psi_0.$$

The solution of (84) with u^h satisfies $\mathbf{1}_{G_h < f(h)} \psi^h(T) = 0$ if and only if, as (91),

$$(92) \quad 0 = \langle v_0^h, \psi_0^h \rangle_0 + \int_0^T \langle C_h e^{itG_h} v_0^h, u^h(t) \rangle dt, \quad v_0^h \in \mathbf{1}_{G_h < f(h)} V^h.$$

N.b. admissibility holds since $\mathbf{1}_{G_h < f(h)} V^h$ is finite dimensional (this proposition does not mention uniformity in h). \square

Theorem 4.14. *Assume (75). Consider a family of initial data $(\psi_0^h)_{h>0}$ in V^h and a family of inputs $(u^h)_{h>0}$ in $L^2(0, T; Y)$ such that u^h controls ψ_0^h in time T in the filtered space $\mathbf{1}_{G_h < f(h)} V^h$, i.e. the solution of (84) satisfies $\mathbf{1}_{G_h < f(h)} \psi^h(T) = 0$.*

If $J_h \psi_0^h \rightarrow \xi_0$ weakly in H_{-1} and $u^h \rightarrow u$ weakly in $L^2(0, T; Y)$ then u controls ξ_0 in time T , i.e. the solution of (97) satisfies $\xi(T) = 0$.

Assume the discrete system (74) restricted to the filtered space $\mathbf{1}_{G_h < f(h)} V^h$ with the V_0^h norm and the system (28) are admissible and exactly observable in time T uniformly in h (equivalently (85) and (86) hold, and (29) is admissible and exactly controllable in time T). If $J_h \psi_0^h \rightarrow \xi_0$ in H_0 then the minimal control u^h of ψ_0^h converges in $L^2(0, T; Y)$ to the minimal control u of ξ_0 given in proposition 4.13. E.g. this applies to $\psi_0^h = J_h^ \xi_0$ for all ξ_0 in H_0 , cf. lemma 4.8.*

Proof. As in the proof of proposition 4.13, integrating by parts in time the duality pairing between H_1 and H_{-1} of (96) and (97), u controls ξ_0 if and only if

$$(93) \quad 0 = \langle x_0, \xi_0 \rangle_{1, -1} + \int_0^T \langle Ce^{itA}x_0, u(t) \rangle dt, \quad x_0 \in H_1,$$

and u^h controls ψ_0^h in time T in the filtered space $\mathbf{1}_{G_h < f(h)} V^h$ if and only if (92). As in the proof of theorem 4.12, consider $x_0 \in \mathcal{D}(A)$, $\mu > \lambda > 0$, $h_\mu > 0$ such that $f(h_\mu) > \mu$, and $v_0^h = \mathbf{1}_{G_h < \mu} J_h^* \pi_h x_0 \in \mathbf{1}_{G_h < f(h)} V^h$ for all $h \in (0, h_\mu)$. Recall from the proof of theorem 4.12, $J_h v_0^h \rightarrow \mathbf{1}_{A < \mu} x_0$ in H_1 as $h \rightarrow 0$. Proposition 4.10 deduces $C_h e^{itG_h} v_0^h \rightarrow Ce^{itA}x_0$ in $L^2(0, T; Y)$. Therefore the two assumptions of the first implication allows taking the limit $h \rightarrow 0$ in (92) and yield (93) for x_0 replaced by $\mathbf{1}_{A < \mu} x_0$. Taking the limit $\mu \rightarrow \infty$ and recalling from the proof of theorem 4.12 $\mathbf{1}_{A < \mu} x_0 \rightarrow x_0$ in H_2 , hence in H_1 , yield (93) for x_0 in H_2 , hence in H_1 by density. This completes the proof of the first implication.

Let $u^h(t) = C_h e^{itG_h} v_0^h$ be the minimal control of ψ_0^h and $u_*(t) = Ce^{itA}x_*$ be the minimal control of ξ_0 provided by the Hilbert Uniqueness Method in proposition 4.13. Similarly to (87) we have

$$(94) \quad \|v_0^h\|_0 \leq \kappa_T \|\psi_0^h\|_0 \quad \text{and} \quad -\langle v_0^h, \psi_0^h \rangle_0 = \int_0^T \|u^h(t)\|^2 dt \leq \kappa_T \|\psi_0^h\|_0^2,$$

where κ_T is the uniform controllability cost in (86). Since ψ_0^h converges in H_0 , we deduce that $J^h v_0^h$ and u^h are bounded respectively in H_0 and $L^2(0, T; Y)$. We deduce that, after extracting a sequence if needed, (u^h) has a weak limit u in $L^2(0, T; Y)$ and, after extracting again a sequence if needed, $(J^h v_0^h)$ has a weak limit x_0 in H_0 . Since $J_h \psi_0^h \rightarrow \xi_0$ in H_0 hence in H_{-1} , the first implication now ensures that u controls ξ_0 in time T . Since $J^h v_0^h \rightarrow x_0$ in H_0 hence in H_{-1} , proposition 4.10 ensures $u^h(t) = C_h e^{itG_h} v_0^h \rightarrow C e^{itA} x_0$ in $L^2(0, T; Y)$. Therefore $u(t) = C e^{itA} x_0$ in $L^2(0, T; Y)$. Hence proposition 4.13 ensures that $x_0 = x_*$ and $u = u_*$. Thus u_* is the only accumulation point of (u^h) weakly in $L^2(0, T; Y)$, hence $u^h \rightharpoonup u_*$ in $L^2(0, T; Y)$. Since $J^h v_0^h \rightarrow x_0 = x_*$ in H_0 and $J^h \psi_0^h \rightarrow \xi_0$ in H_0 , the left hand side of the equality in (94) converges to the right hand side of (89). Hence the norm of u^h converges to the norm of u_* . Since we already proved the weak convergence of u^h to u_* in $L^2(0, T; Y)$, this proves the strong convergence, which completes the proof of the second implication. \square

REMARK 4.15. The investigation in §4 was triggered by the approach introduced by Sylvain Ervedoza in [Erv08] under the assumptions $C \in \mathcal{L}(H_\gamma; Y)$, $\gamma \in [0, 1)$ and A^{-1} is compact. After the version of [Erv09, Erv11] in [Erv08] was submitted, the author privately communicated to Ervedoza an improvement of the filtering scale now included in [Erv09, Erv11]. E.g. with the current notations Ervedoza proved his main theorem with [Erv08, (6.1.11)] $\sigma = \min\{2(1-\gamma), 2/5\}$ using a version of the resolvent condition which he called interpolation inequalities; the author improved it to [Erv11, (1.11)] $\sigma = \min\{2(1-\gamma), 2/3\}$ using proposition 2.9 instead. Similarly, the author improved [Erv08, (7.1.12)] into [Erv09, (1.12)], cf. [Erv09, remark 3.1].

Theorem 4.11 improves [Erv11, theorem 1.3] in four ways: the approximation assumption (62) is weaker in practice (cf. remark 4.1), the assumption on the observation operator $C \in \mathcal{L}(H_1; Y)$ is weaker, A^{-1} is not assumed to be compact, the filtering power $\sigma = \min\{2(1-\gamma), 2/3\}$ is improved into $\sigma = 1$.

The converse Trotter-Kato type theorem 4.12 is not considered in [Erv11].

The second part of theorem 4.14 improves [Erv11, theorem 6.2] by eliminating, thanks to lemma 4.9, the dubiously used assumption [Erv11, (6.11)] which limited to $C \in \mathcal{L}(H_0; Y)$ the validity of [Erv11, theorem 6.2] and the validity of the convergence of the observation. Proposition 4.10 also improves this convergence of the observation in particular by providing explicit convergence rates. Theorem 4.7 is proved here, with no claim of originality, since we could not find the proof of the similar [Erv11, lemma 6.4] in the reference given for it.

4.4. “Boundary” semidiscrete systems. To address the general case of §3 which suits boundary observability of PDEs, i.e. $C \in \mathcal{L}(H_2; Y)$, we need to modify the definition (75) of the approximate observation operator. Thus we consider the semidiscrete observation system (74) with (75) replaced by:

$$(95) \quad C_h = CA^{-1} J_h G_h, \quad C \in \mathcal{L}(H_2; Y).$$

N.b. $\|C_h v\| \leq \|C\|_{\mathcal{L}(H_2; Y)} \|G_h v\|_0$ but the V_2^h norm $\|v\|_2$ was not defined as $\|G_h v\|_0$.

4.4.1. Convergence of the observation systems. Similarly to proposition 4.10:

Proposition 4.16. *Assume (95). Consider a family $(v^h)_{h>0}$ in V^h and $x \in \mathcal{D}(A)$.*

If $J_h G_h v^h \rightarrow Ax$ in H_0 then $C_h e^{itG_h} v^h \rightarrow C e^{itA} x$ in Y uniformly on finite intervals of t . More precisely, (62) implies the convergence rate: $\forall h > 0, \forall t \in \mathbb{R}$,

$$\|(C_h e^{itG_h} J_h^* \pi_h - C e^{itA})x\| \leq \|C\|_{\mathcal{L}(H_2; Y)} c_0^2 h^2 (t\|x\|_6 + 2\|x\|_4), \quad x \in H_6.$$

If $J_h G_h v^h \rightarrow Ax$ in H_0 then $C_h e^{itG_h} v^h \rightarrow C e^{itA} x$ in $L^2(0, T; Y)$ for all $T > 0$.

If $J_h v^h \rightarrow x$ in H_0 , $x \in H_1$ and (96) is admissible then $C_h e^{itG_h} v^h \rightarrow C e^{itA} x$ in $L^2(0, T; Y)$ for all $T > 0$.

Proof. The first implication results from the convergence in H_0 in theorem 4.7, since $C_h e^{itG_h} = CA^{-1} e^{itA_h} J_h G_h$ and $CA^{-1} \in \mathcal{L}(H_0; Y)$. Since (67) is equivalent to $A = J_h G_h J_h^* \pi_h$ on $\mathcal{D}(A)$, we have $C_h e^{itG_h} J_h^* \pi_h - C e^{itA} = CA^{-1} (e^{itA_h} - e^{itA}) A$. Therefore (70) implies the convergence rate in proposition 4.16.

The second implication in proposition 4.16. is proved as in proposition 4.10.

To prove the third implication, we rewrite the assumption $J_h v^h \rightarrow x$ in H_0 , as $J_h G_h (G_h^{-1} v^h) \rightarrow A^{-1}(Ax)$ in H_0 . The second implication yields $C_h e^{itG_h} G_h^{-1} v^h \rightarrow CA^{-1} e^{itA} x$ in $L^2(0, T; Y)$. Since $x \in H_1$ and (96) is admissible, this completes the proof as in lemma 4.9. \square

4.4.2. Continuous and filtered discrete observability. For boundary observation and in relation to the second order system (48), it is natural to consider the unitary group on H_1 instead of H_0 , i.e. we consider (50) and (51) for $s = 2$:

$$(96) \quad \dot{x}(t) - iAx(t) = 0, \quad x(0) = x_0 \in H_1, \quad y(t) = Cx(t),$$

$$(97) \quad \dot{\xi}(t) - iA'\xi(t) = Bu(t), \quad \xi(0) = \xi_0 \in H_{-1}, \quad u \in L^2_{\text{loc}}(\mathbb{R}; Y).$$

We consider improved resolvent conditions for (96): $\exists L_s, l_s, M_s, m_s > 0$,

$$(98) \quad \|Cx\|^2 \leq \frac{L_s}{\lambda^s} \|(A - \lambda)x\|_1^2 + l_s \|x\|_1^2, \quad x \in H_3, \quad \lambda > 0,$$

$$(99) \quad \|x\|_1^2 \leq \frac{M_s}{\lambda^s} \|(A - \lambda)x\|_1^2 + m_s \|Cx\|^2, \quad x \in H_3, \quad \lambda > 0.$$

Recall from (66) that the V_1^h norm on V^h is $\|v\|_1 = \|J_h v\|_1 = \|G_h^{1/2} v\|$, $v \in V^h$. We also consider the improved resolvent conditions (78) and (79) for the semidiscrete system (74) but with this V_1^h norm instead of the V_0^h norm: $\exists L'_s, l'_s, M'_s, m'_s > 0$,

$$(100) \quad \|C_h v\|^2 \leq \frac{L'_s}{\lambda^s} \|(G_h - \lambda)v\|_1^2 + l'_s \|v\|_1^2, \quad v \in \mathbf{1}_{G_h < \eta/h^\sigma} V^h, \quad \eta/h^\sigma \geq \lambda > 0,$$

$$(101)$$

$$\|v\|_1^2 \leq \frac{M'_s}{\lambda^s} \|(G_h - \lambda)v\|_1^2 + m'_s \|C_h v\|^2, \quad v \in \mathbf{1}_{G_h < \eta/h^\sigma} V^h, \quad \eta/h^\sigma \geq \lambda > 0.$$

Similarly to theorem 4.12, :

Theorem 4.17. *Assume (95). The semidiscrete admissibility (resp. observability) resolvent condition (82) implies (80) (resp. (83) implies (81)) when replacing the H_0 norms by H_1 norms and $\mathcal{D}(A)$ by H_3 in all these resolvent conditions.*

Proof. Few modifications of the proof of theorem 4.12 are necessary.

Consider $x \in H_3$ and $\mu > \lambda \geq \lambda_0$. It is enough to prove (80) and (81) for x replaced by $\mathbf{1}_{A < \mu} x$ since $\|x - \mathbf{1}_{A < \mu} x\|_3 = \|A \mathbf{1}_{A \geq \mu} x\|_1 \rightarrow 0$ as $\mu \rightarrow \infty$. Let $h_\mu > 0$ such that $f(h_\mu) > \mu$, and let $v^h = \mathbf{1}_{G_h < \mu} J_h^* \pi_h x \in \mathbf{1}_{G_h < f(h)} V^h$ for all $h \in (0, h_\mu)$. Recall from the proof of theorem 4.12 that $\|J_h v^h \rightarrow \mathbf{1}_{A < \mu} x\|_1 \rightarrow 0$ as $h \rightarrow 0$ and $J_h G_h v^h = \mathbf{1}_{A_h < \mu} Ax$. Moreover $\|(\mathbf{1}_{A < \mu} - \mathbf{1}_{A_h < \mu}) Ax\|_1 \rightarrow 0$ due to (68). Hence $\|J^h(G_h - \lambda)v^h - (A - \lambda) \mathbf{1}_{A < \mu} x\|_1 \rightarrow 0$. Since $C_h v^h = CA^{-1} J_h G_h v^h = CA^{-1} \mathbf{1}_{A_h < \mu} Ax$ and $CA^{-1} \in \mathcal{L}(H_0; Y)$ due to (95), this also implies $\|C_h v^h - C \mathbf{1}_{A < \mu} x\| = \|CA^{-1}(\mathbf{1}_{A_h < \mu} - \mathbf{1}_{A < \mu}) Ax\| \rightarrow 0$. Therefore, replacing the H_0 norms by H_1 norms and $\mathcal{D}(A)$ by H_3 and taking the limit $h \rightarrow 0$ in (82) and (83) for v^h implies (80) and (81) for $\mathbf{1}_{A < \mu} x$. \square

Similarly to theorem 4.11 for the direct implications and due to theorem 4.12 for the converse implications:

Theorem 4.18. *Assume that the observation operators satisfy (95).*

The continuous system (96) is admissible (resp. moreover exactly observable) if and only if, for all $\eta > 0$ (resp. for $\eta > 0$ small enough), there exists $T > 0$ such that the semidiscrete system (74) restricted to the filtered space $\mathbf{1}_{G_h < \eta/h^{2/3}} V^h$ with the V_1^h norm is admissible (resp. moreover exactly observable) in time T uniformly in $h \in (0, 1)$.

If the second order system (48) is admissible and exactly observable then, for $\eta > 0$ small enough, for all $T > 0$, the semidiscrete system (74) restricted to the filtered space $\mathbf{1}_{G_h < \eta/h} V^h$ with the V_1^h norm is admissible and exactly observable in time T uniformly in $h \in (0, 1)$.

The continuous system (28) is admissible (resp. moreover exactly observable) if and only if, for all $\eta > 0$ (resp. for $\eta > 0$ small enough), there exists $T > 0$ such that the semidiscrete system (74) restricted to the filtered space $\mathbf{1}_{G_h < \eta/h} V^h$ with the V_0^h norm is admissible (resp. moreover exactly observable) in time T uniformly in $h \in (0, 1)$.

More precisely, for $s \in [0, 4)$ and $\sigma = 1/(1 - s/4)$ (resp. $s \in [0, 3)$ and $\sigma = 2/(3 - s)$), for all $\eta > 0$, (76) implies (78) (resp. (98) implies (100)); for $\eta > 0$ small enough (77) implies (79) (resp. (98) implies (100)).

Proof. According to proposition 2.9, $\lambda > 0$ in (98), (99), (100), (101) can be equivalently replaced by $\lambda \geq \inf A$ since $\inf G_h \geq \inf A > 0$. For $s = 0$, the range of λ can be equivalently replaced by $\lambda \in \mathbb{R}$. Thus, the first and third (resp. second) implication of the theorem results from the last part of the theorem with $s = 0$ (resp. $s = 1$) according to theorems 2.3 and 2.4 (resp. theorem 3.8).

To prove the last part of the theorem let $v \in V^h$ and consider $x^h = A^{-1} J_h G_h v$ as in the proof of theorem 4.11. Due to (95), we now have $C_h v = C x^h$.

Recall from the proof of theorem 4.11 that lemma 4.4 implies:

$$\|x^h - J_h v\|_0 \leq c_0^2 h^2 \|A x^h\|_0, \quad \|(A - \lambda)x^h - J_h(G_h - \lambda)v\|_0 \leq c_0^2 h^2 \lambda \|A x^h\|_0.$$

For $v \in \mathbf{1}_{G_h < \eta/h^\sigma} V^h$, $\|A x^h\|_0 = \|G_h v\|_0 \leq (\eta/h^\sigma) \|v\|_0$. Plugging these bounds in (76) and (77) for x^h yield (78) and (79) with errors bounded by the square of $c_\eta h^{2-\sigma(2-s/2)} \|v\|_0$ for $h < 1$, where the power of h is zero for $\sigma = 1/(1 - s/4)$, and $c_\eta = \max\{(c_0 \eta)^2, c_0 \eta\} \rightarrow 0$ as $\eta \rightarrow 0$.

Similarly, the approximation assumption (62) yields:

$$\|x^h - J_h v\|_1 \leq c_0 h \|A x^h\|_0, \quad \|(A - \lambda)x^h - J_h(G_h - \lambda)v\|_1 \leq c_0 h \lambda \|A x^h\|_0.$$

For $v \in \mathbf{1}_{G_h < \eta/h^\sigma} V^h$, $\|A x^h\|_0 = \|G_h v\|_0 \leq (\eta/h^\sigma)^{1/2} \|v\|_1$. Plugging these bounds in (98) and (99) for x^h yield (100) and (101) with errors bounded by the square of $c_\eta h^{1-\sigma(3-s)/2} \|v\|_0$ for $h < 1$, and the power of h is now zero for $\sigma = 2/(3 - s)$. \square

4.4.3. Convergence of the filtered control systems. We consider the semidiscrete control system (84) dual to (74) with $B_h = G_h J_h^* A^{-1} B$ (which is both the dual of $C_h : V_2^h \rightarrow Y$ and the adjoint of $C_h : V_0^h \rightarrow Y$), n.b. $\|G_h^{-1} B_h y\|_0 \leq \|C\|_{\mathcal{L}(H_2; Y)} \|y\|$.

Theorem 4.19. *Assume (95). Consider a family of initial data $(\psi_0^h)_{h>0}$ in V^h and a family of inputs $(u^h)_{h>0}$ in $L^2(0, T; Y)$ such that u^h controls ψ_0^h in time T in the filtered space $\mathbf{1}_{G_h < f(h)} V^h$, i.e. the solution of (84) satisfies $\mathbf{1}_{G_h < f(h)} \psi^h(T) = 0$.*

If $J_h \psi_0^h \rightarrow \xi_0$ weakly in H_{-1} and $u^h \rightarrow u$ weakly in $L^2(0, T; Y)$ then u controls ξ_0 in time T , i.e. the solution of (97) satisfies $\xi(T) = 0$.

Assume the discrete system (74) restricted to the filtered space $\mathbf{1}_{G_h < f(h)} V^h$ with the V_1^h norm and the system (96) are admissible and exactly observable in time T uniformly in h . If $J_h \psi_0^h \rightarrow \xi_0$ in H_{-1} then the minimal control u^h of ψ_0^h converges in $L^2(0, T; Y)$ to the minimal control u of ξ_0 . E.g. this applies to $\psi_0^h = G_h J_h^ \pi_h A^{-1} \xi_0$ for all ξ_0 in H_{-1} , cf. lemma 4.8.*

Proof. Few modifications of the proof of theorem 4.14 are necessary.

In the proof of the first implication, proposition 4.16 replaces proposition 4.10. In order to apply this proposition 4.16 to v_0^h as in the proof of theorem 4.14, recall from the proof of theorem 4.12 that $J_h G_h v_0^h \rightarrow A \mathbf{1}_{A < \mu} x_0$ in H_0 as $h \rightarrow 0$.

The proof of the second implication uses the Hilbert Uniqueness Method as in proposition 4.13 but the H_0 scalar product in the functional (88) is replaced by the the duality pairing between H_1 and H_{-1} . Thus (87) and (94) are replaced by

$$(102) \quad \|x_0\|_1 \leq \kappa_T \|\xi_0\|_{-1} \quad \text{and} \quad -\langle x_0, \xi_0 \rangle_{1,-1} = \int_0^T \|u(t)\|^2 dt \leq \kappa_T \|\xi_0\|_{-1}^2,$$

$$(103) \quad \|v_0^h\|_1 \leq \kappa_T \|\psi_0^h\|_{-1} \quad \text{and} \quad -\langle v_0^h, \psi_0^h \rangle_{1,-1} = \int_0^T \|u^h(t)\|^2 dt \leq \kappa_T \|\psi_0^h\|_{-1}^2.$$

Since ψ_0^h converges in H_{-1} , we deduce that $J^h v_0^h$ and u^h are bounded respectively in H_1 and $L^2(0, T; Y)$. We deduce that, after extracting a sequence if needed, (u^h) has a weak limit u in $L^2(0, T; Y)$ and, after extracting again a sequence if needed, $(J^h v_0^h)$ has a weak limit x_0 in H_1 . Since $J_h \psi_0^h \rightarrow \xi_0$ in H_{-1} strongly hence weakly, the first implication now ensures that u controls ξ_0 in time T . Since $J^h v_0^h \rightarrow x_0$ in H_1 hence in H_0 , proposition 4.16 ensures $u^h(t) = C_h e^{itG_h} v_0^h \rightarrow C e^{itA} x_0$ in $L^2(0, T; Y)$. Therefore $u(t) = C e^{itA} x_0$ in $L^2(0, T; Y)$. As in proposition 4.13, we deduce $x_0 = x_*$ and $u = u_*$. Thus u_* is the only accumulation point of (u^h) weakly in $L^2(0, T; Y)$, hence $u^h \rightarrow u_*$ in $L^2(0, T; Y)$. Since $(J^h v_0^h) \rightarrow x_0 = x_*$ in H_1 and $(J^h \psi_0^h) \rightarrow \xi_0$ in H_{-1} , the left hand side of the equality in (103) converges to the left hand side of the equality in (102). Hence the norm of u^h converges to the norm of $u = u_*$. Since we already proved the weak convergence of u^h to u_* in $L^2(0, T; Y)$, this proves the strong convergence, which completes the proof of the second implication. \square

4.5. Second order semidiscrete systems.

4.5.1. *Framework for the Galerkin approximation of second order systems.* Section 3.2 explains how the second order observation systems both in the “boundary” case (48) and the “interior” case (56) fit in the general framework of §2.1. Since they are dual to each other, from now on the state space and the operator generating the observation system are denoted by X and \mathcal{A} in the “boundary” case, by X' and \mathcal{A}' in the “interior” case (X is the “energy space” for the wave equation). Using the new notation

$$Z_s = H_{s+1} \times H_s, \quad \|(z_0, z_1)\|_s^2 = \|Az_0\|^2 + \|z_1\|^2 = \|A^{(s+1)/2} z_0\|_0^2 + \|A^{s/2} z_1\|_0^2,$$

these state spaces and operators are defined by

$$X = Z_0 = X'_1 = \mathcal{D}(\mathcal{A}'), \quad \mathcal{D}(\mathcal{A}) = X_1 = Z_1, \quad X_{-1} = Z_{-1} = X', \quad Z_{-2} = X'_{-1},$$

with duality pairing $\langle (z_0, z_1), (\zeta_0, \zeta_1) \rangle = \langle A^{1/2} z_0, A^{-1/2} \zeta_1 \rangle_0 - \langle z_1, \zeta_0 \rangle_0$,

$$\mathcal{A}(z_0, z_1) = i(-z_1, Az_0), \quad \mathcal{A}'(z_0, z_1) = i(-z_1, A'z_0).$$

Thus \mathcal{A}' is an extension of \mathcal{A} to Z_{-1} with domain Z_0 .

The spectra and spectral projections of \mathcal{A} and A are linked by the isomorphism \mathcal{W} in the proof of theorem (3.8):

$$(104) \quad \sigma(\mathcal{A}) = \sigma(\sqrt{A}) \cup \sigma(-\sqrt{A}), \quad \mathbf{1}_{\mathcal{A}^2 < \lambda}(z_0, z_1) = (\mathbf{1}_{A < \lambda} z_0, \mathbf{1}_{A < \lambda} z_1).$$

In both cases the observation operator \mathcal{C} is bounded on the domain of the generator of the observation system, it is defined by $\mathcal{C}(z_0, z_1) = Cz_0$ and the dual control operator \mathcal{B} is defined by $\mathcal{B}y = (0, By)$. Thus $\mathcal{C} \in \mathcal{L}(Z_1; Y)$ and $\mathcal{B} \in \mathcal{L}(Y; Z_{-2})$ in the “boundary” case, $\mathcal{C} \in \mathcal{L}(Z_0; Y)$ and $\mathcal{B} \in \mathcal{L}(Y; Z_{-1})$ in the “interior” case.

The approximation spaces are $W^h = W^h \times W^h$ with injections $\mathcal{J}_h : W^h \rightarrow Z_0$ defined by $\mathcal{J}_h(w_0, w_1) = (J_h w_0, J_h w_1)$. Let W_s^h denote W^h with the norm $\|w\|_s = \|\mathcal{J}_h w\|_s$, $w \in W^h$, induced by \mathcal{J}_h from Z_s . The dual $\mathcal{J}_h^* : Z_0 \rightarrow W_0^h$ is defined by $\mathcal{J}_h^*(z_0, z_1) = (J_h^* \pi_h z_0, J_h^* z_1)$. The Z_0 -orthogonal projection from Z_0 onto Z^h is $\mathcal{J}_h \mathcal{J}_h^*$ defined by $\mathcal{J}_h \mathcal{J}_h^*(z_0, z_1) = (\pi_h z_0, J_h J_h^* z_1)$, and $\mathcal{J}_h^* \mathcal{J}_h$ is the identity operator on W^h .

The Ritz-Galerkin variational method considers the finite-dimensional positive self-adjoint operator on \mathcal{G}_h on W_0^h defined by $\mathcal{G}_h(w_0, w_1) = i(-w_1, G_h w_0)$, approximates \mathcal{A} by the non-negative selfadjoint operator $\mathcal{A}_h = \mathcal{J}_h \mathcal{G}_h \mathcal{J}_h^*$ on Z_0 defined by $\mathcal{A}_h(z_0, z_1) = (-J_h^* J_h z_1, A_h \pi_h z_0)$, approximates \mathcal{C} by the observation operator \mathcal{C}_h defined by $\mathcal{C}_h(w_0, w_1) = C_h w_0$, and approximates \mathcal{B} by the control operator \mathcal{B}_h defined by $\mathcal{B}_h y = (0, B_h y)$. In the ‘‘interior’’ case the definition of C_h is (75) thus $\mathcal{C}_h = \mathcal{C} \mathcal{J}_h$, in the ‘‘boundary’’ case the definition of C_h is (95) thus $\mathcal{C}_h = \mathcal{C} \mathcal{A}^{-1} \mathcal{J}_h \mathcal{G}_h$.

The dual observation and control systems generated by \mathcal{G}_h are:

$$(105) \quad \ddot{w}^h(t) + G_h w^h(t) = 0, w^h(0) = w_0 \in V^h, \dot{w}^h(0) = w_1 \in V^h, y(t) = C_h w^h(t),$$

$$(106)$$

$$\ddot{\Psi}^h(t) + G^h \Psi^h(t) = B_h u^h(t), \Psi(0) = \Psi_0 \in V^h, \dot{\Psi}(0) = \Psi_1 \in V^h, u \in L_{\text{loc}}^2(\mathbb{R}; Y).$$

We still denote by π_h the projection defined on $H_1 \times H_1$ by $\pi_h(z_0, z_1) = (\pi_h z_0, \pi_h z_1)$. The approximation assumption (62) and its consequence (63) write:

$$(107) \quad \|z - \pi_h z\|_0 \leq c_0 h \|z\|_1, \quad z \in Z_1, \quad h > 0.$$

As in lemma 4.6, in terms of π_h , \mathcal{G}_h is defined by

$$(108) \quad \pi_h \mathcal{A}^{-1} = \mathcal{J}_h \mathcal{G}_h^{-1} \mathcal{J}_h^*,$$

hence $\|(\mathcal{A}^{-1} - \mathcal{J}_h \mathcal{G}_h^{-1} \mathcal{J}_h^*)z\|_0 \leq c_0 h \|z\|_0$, $x \in H_0$. Therefore \mathcal{A}_h converges to \mathcal{A} in Z_0 strongly in the resolvent sense. In particular, if $\lambda \in \mathbb{R}$ is not an eigenvalue of \mathcal{A} , then the finite dimensional spectral projections $\mathbf{1}_{\mathcal{A}_h < \lambda} = \mathcal{J}_h \mathbf{1}_{\mathcal{G}_h < \lambda} \mathcal{J}_h^*$ satisfy:

$$(109) \quad \|(\mathbf{1}_{\mathcal{A} < \lambda} - \mathbf{1}_{\mathcal{A}_h < \lambda})z\|_0 \rightarrow 0, \quad z \in Z_0.$$

The proof of theorem 4.7, (107) and (108) yield:

Theorem 4.20. *If $z^h \rightarrow z$ in Z_0 then $e^{it\mathcal{A}_h} z^h \rightarrow e^{it\mathcal{A}} z$ in Z_0 uniformly on finite intervals of t , i.e. the solutions z and w of (48) and (105) satisfy:*

$$\sup_{t \in [0, T]} (\|w^h(t) - z(t)\|_1 + \|\dot{w}^h(t) - \dot{z}(t)\|_0) \rightarrow 0, \quad (z(0), \dot{z}(0)) \in H_1 \times H_0, \quad T \in \mathbb{R}.$$

More precisely, (62) implies the convergence rate:

$$(110) \quad \|(e^{it\mathcal{A}_h} - e^{it\mathcal{A}})z\|_0 \leq c_0 h (t \|z\|_2 + 2 \|z\|_1), \quad z \in W_2, \quad h > 0, \quad t \in \mathbb{R}.$$

If $(z(0), \dot{z}(0)) \in H_3 \times H_2$, $w^h(0) = \pi_h z(0)$ and $\dot{w}^h(0) = \pi_h \dot{z}(0)$ then the solutions z and w of (48) and (105) satisfy:

$$\|w^h(t) - \pi_h z(t)\|_1 + \|\dot{w}^h(t) - \pi_h \dot{z}(t)\|_0 \leq c_0 h t (\|z(0)\|_3 + \|\dot{z}(0)\|_2), \quad h > 0, \quad t \in \mathbb{R}.$$

4.5.2. *Convergence of the observation systems.* The proof of proposition 4.16 yields:

Proposition 4.21. *Assume (95). Consider a family $(w^h)_{h>0}$ in W^h and $z \in \mathcal{D}(\mathcal{A})$.*

If $\mathcal{J}_h \mathcal{G}_h w^h \rightarrow Az$ in Z_0 then $\mathcal{C}_h e^{it\mathcal{G}_h} w^h \rightarrow \mathcal{C} e^{it\mathcal{A}} z$ in Y uniformly on finite intervals of t . More precisely, (62) implies the convergence rate:

$$\|(\mathcal{C}_h e^{it\mathcal{G}_h} \mathcal{J}_h^* \pi_h - \mathcal{C} e^{it\mathcal{A}})z\| \leq \|C\|_{\mathcal{L}(H_2; Y)} c_0 h (t \|z\|_3 + 2 \|z\|_2), \quad z \in Z_3, \quad h > 0, \quad t \in \mathbb{R}.$$

If $\mathcal{J}_h \mathcal{G}_h w^h \rightarrow Az$ in Z_0 then $\mathcal{C}_h e^{it\mathcal{G}_h} w^h \rightarrow \mathcal{C} e^{it\mathcal{A}} z$ in $L^2(0, T; Y)$ for all $T > 0$.

If $\mathcal{J}_h v^h \rightarrow z$ in Z_0 and (48) is admissible then $\mathcal{C}_h e^{it\mathcal{G}_h} w^h \rightarrow \mathcal{C} e^{it\mathcal{A}} z$ in $L^2(0, T; Y)$ for all $T > 0$.

In the ‘‘interior’’ case, the proof of proposition 4.10 yields:

Proposition 4.22. *Assume (75). Consider a family $(w^h)_{h>0}$ in W^h and $z \in \mathcal{D}(\mathcal{A})$.*

If $\mathcal{J}_h w^h \rightarrow z$ in Z_0 then $C_h e^{it\mathcal{G}_h} w^h \rightarrow C e^{it\mathcal{A}} z$ in Y uniformly on finite intervals of t . More precisely, (62) implies the convergence rate:

$$\|(C_h e^{it\mathcal{G}_h} \mathcal{J}_h - C e^{it\mathcal{A}})z\| \leq \|C\|_{\mathcal{L}(H_1; Y)} c_0 h(t\|z\|_2 + 2\|z\|_1), \quad z \in Z_2, h > 0, t \in \mathbb{R}.$$

If $\mathcal{J}_h w^h \rightarrow z$ in Z_0 then $C_h e^{it\mathcal{G}_h} w^h \rightarrow C e^{it\mathcal{A}} z$ in $L^2(0, T; Y)$ for all $T > 0$.

If $\mathcal{J}_h w^h \rightarrow z$ in Z_{-1} and (56) is admissible then $C_h e^{it\mathcal{G}_h} w^h \rightarrow C e^{it\mathcal{A}} z$ in $L^2(0, T; Y)$ for all $T > 0$.

4.5.3. *Continuous and filtered discrete observability.* As in § 4.3.2, § 4.3.3, we consider the semidiscrete system (105) restricted to the filtered space $\mathbf{1}_{\mathcal{G}_h^2 < f(h)} W^h$, where $f : (0, h_0) \rightarrow (0, +\infty)$ decreases and $f(h) \rightarrow +\infty$ as $h \rightarrow 0$, and in particular we consider the filtering scale $f(h) = \eta/h^\sigma$, where η and σ are positive parameters.

As in (104), the link between the first and second order filtered spaces is:

$$\mathbf{1}_{\mathcal{G}_h^2 < f(h)} W^h = \mathbf{1}_{G_h < f(h)} V^h \times \mathbf{1}_{G_h < f(h)} V^h.$$

Due to theorem 3.8 and the last part of the theorem 4.18 with $s = 1$ for the direct implications, and due to theorem 4.17 for the converse implications:

Theorem 4.23. *Assume that the observation operators satisfy (95).*

The second order system (48) is admissible (resp. moreover exactly observable) if and only if, for all $\eta > 0$ (resp. for $\eta > 0$ small enough), there exists $T > 0$ such that the semidiscrete system (105) restricted to the filtered space $\mathbf{1}_{\mathcal{G}_h^2 < \eta/h^{2/3}} W^h$, with the W_0^h norm is admissible (resp. moreover exactly observable) in time T uniformly in $h \in (0, 1)$.

In the ‘‘interior’’ case, theorem 3.13 and the proof of theorem 4.11 yield:

Theorem 4.24. *Assume that the observation operators satisfy (75).*

The second order system (56) is admissible (resp. moreover exactly observable) if and only if, for all $\eta > 0$ (resp. for $\eta > 0$ small enough), there exists $T > 0$ such that the semidiscrete system (105) restricted to the filtered space $\mathbf{1}_{\mathcal{G}_h^2 < \eta/h} W^h$, with the W_{-1}^h norm is admissible (resp. moreover exactly observable) in time T uniformly in $h \in (0, 1)$.

Assume $C \in \mathcal{L}(H_0; Y)$. The second order system (56) is admissible (resp. moreover exactly observable) if and only if, for all $\eta > 0$ (resp. for $\eta > 0$ small enough), there exists $T > 0$ such that the semidiscrete system (74) restricted to the filtered space $\mathbf{1}_{\mathcal{G}_h^2 < \eta/h^{4/3}} W^h$, with the W_{-1}^h norm is admissible (resp. moreover exactly observable) in time T uniformly in $h \in (0, 1)$.

4.5.4. *Convergence of the filtered control systems.* The proofs of theorems 4.19 and 4.14 respectively in the ‘‘boundary’’ case (95) and ‘‘interior’’ case (75) yield:

Theorem 4.25. *Assume (95) (resp. assume (75)). Consider a family of initial data $(\Psi_0^h, \Psi_1^h)_{h>0}$ in W^h and a family of inputs $(u^h)_{h>0}$ in $L^2(0, T; Y)$ such that u^h controls (Ψ_0^h, Ψ_1^h) in time T in the filtered space $\mathbf{1}_{\mathcal{G}_h^2 < f(h)} W^h$, i.e. the solution of (106) satisfies $\mathbf{1}_{\mathcal{G}_h^2 < f(h)} \Psi^h(T) = \mathbf{1}_{\mathcal{G}_h^2 < f(h)} \dot{\Psi}^h(T) = 0$.*

If $(J_h \Psi_0^h, J_h \Psi_1^h) \rightarrow (\zeta_0, \zeta_1)$ weakly in Z_{-1} and $u^h \rightarrow u$ weakly in $L^2(0, T; Y)$ then u controls (ζ_0, ζ_1) in time T , i.e. the solution of (49) satisfies $\zeta(T) = \dot{\zeta}(T) = 0$.

Assume the discrete system (105) restricted to the filtered space $\mathbf{1}_{\mathcal{G}_h^2 < f(h)} W^h$ with the W_0^h norm (resp. the W_{-1}^h norm) and the system (48) (resp. the system (57)) are admissible and exactly observable in time T uniformly in h . If $(J_h \Psi_0^h, J_h \Psi_1^h) \rightarrow (\zeta_0, \zeta_1)$ in Z_{-1} (resp. in Z_0) then the minimal control u^h of (Ψ_0^h, Ψ_1^h) converges

in $L^2(0, T; Y)$ to the minimal control u of (ζ_0, ζ_1) in (49) (resp. in (57)). E.g. this applies to all $(\zeta_0, \zeta_1) \in Z_{-1}$, $(\Psi_0^h, \Psi_1^h) = (J^* \zeta_0, G_h J_h^* \pi_h A^{-1} \zeta_1)$, (resp. to all $(\zeta_0, \zeta_1) \in Z_0$, $(\Psi_0^h, \Psi_1^h) = (J^* \pi_h \zeta_0, J^* \zeta_1)$), cf. lemma 4.8.

REMARK 4.26. The direct implications in theorem 4.24 improve [Erv09, theorem 1.1] in four ways: the approximation assumption (62) is weaker in practice (cf. remark 4.1), the assumption on the observation operator $C \in \mathcal{L}(H_\gamma; Y)$, $\gamma \in [0, 1)$, is weakened into $C \in \mathcal{L}(H_1; Y)$, A^{-1} is not assumed to be compact, the filtering power $\sigma = \min \{2(1 - \gamma), 1\}$ in [Erv09, (1.12)] (which is already the author's improvement of Ervedoza's [Erv08, (7.1.12)]), cf. [Erv09, remark 3.1]) is improved into $\sigma = 1$ for $C \in \mathcal{L}(H_1; Y)$ and $\sigma = 4/3$ for $C \in \mathcal{L}(H_0; Y)$. The converse implications in theorem 4.24 are not considered in [Erv11].

The second part of theorem 4.25 in the “interior” case improves [Erv09, theorem 6.1] by eliminating the dubiously used assumption [Erv09, (6.11)] which limited to $C \in \mathcal{L}(H_0; Y)$ the validity of [Erv09, theorem 6.1]. The explicit convergence rates of the observations in proposition 4.22, and the “boundary” case in theorems 4.25 and 4.23 were not considered in [Erv11].
