# GLOBAL WELL-POSEDNESS AND LIMIT BEHAVIOR FOR A HIGHER-ORDER BENJAMIN-ONO EQUATION

#### Abstract

In this paper, we prove that the Cauchy problem associated to the following higher-order Benjamin-Ono equation


(0.1) $\quad \partial_{t} v-b \mathcal{H} \partial_{x}^{2} v-a \epsilon \partial_{x}^{3} v=c v \partial_{x} v-d \epsilon \partial_{x}\left(v \mathcal{H} \partial_{x} v+\mathcal{H}\left(v \partial_{x} v\right)\right)$,
is globally well-posed in the energy space $H^{1}(\mathbb{R})$. Moreover, we study the limit behavior when the small positive parameter $\epsilon$ tends to zero and show that, under a condition on the coefficients $a, b, c$ and $d$, the solution $v_{\epsilon}$ to (0.1) converges to the corresponding solution of the Benjamin-Ono equation.

## 1. Introduction

Considered here is the following higher-order Benjamin-Ono equation

\partial_{t} v-b \mathcal{H} \partial_{x}^{2} v-a \epsilon \partial_{x}^{3} v=c v \partial_{x} v-d \epsilon \partial_{x}\left(v \mathcal{H} \partial_{x} v+\mathcal{H}\left(v \partial_{x} v\right)\right) \tag{1.1}
\end{equation*}

where $x, t \in \mathbb{R}, v$ is a real-valued function, $a, b, c$ and $d$ are positive constants, $\epsilon>0$ is a small positive parameter and $\mathcal{H}$ is the Hilbert transform, defined on the line by

The equation above corresponds to a second order approximation of the unidirectional evolution of weakly nonlinear dispersive internal long waves at the interface of a two-layer system of fluids, the lower one being infinitely deep. It was derived by Craig, Guyenne and Kalisch (see equation (5.38) in [5]), using a Hamiltonian perturbation theory. Here, $v$ represents the dislocation of the interface around its position of equilibrium, the coefficients $a, b, c$ and $d$ are respectively given by

c & =\frac{3 \sqrt{2}}{4 \rho_{1}} \sqrt[4]{\frac{g \rho_{1}\left(\rho-\rho_{1}\right)}{h_{1}}} \quad \text { and } \quad d=\frac{\sqrt{2} \rho h_{1}}{2 \rho_{1}^{2}} \sqrt[4]{\frac{g \rho_{1}\left(\rho-\rho_{1}\right)}{h_{1}}}, \tag{1.4}
\end{align*}

[^0]where $h_{1}$ represents the depth of the upper layer when the fluid is at rest, $\rho_{1}$ is the density of the upper fluid and $\rho$ is the density of the lower fluid. Moreover, the system is assumed to be in a stable configuration, which is to say that $\rho>\rho_{1}$, so that the coefficients $a, b, c$ and $d$ are positive.

It is worth noting that the equation obtained at the first order approximation of the above physical model is the well-known Benjamin-Ono equation

and therefore equation (1.1) can be seen as an higher-order perturbation of equation (1.5). Moreover, the quantities

\end{equation*}

are conserved by the flow associated to (1.1).
The initial value problem (IVP) associated to the Benjamin-Ono equation on the line has been extensively studied in the recent years and has been proved to be globally well-posed in $L^{2}(\mathbb{R})$ by Ionescu and Kenig in [9] (see [23] for another proof and $[1,4,11,12,17,26,27]$ for former results). The IVP associated to (1.1) presents the same mathematical difficulties as for the Benjamin-Ono equation. Indeed, it has been shown in [25] that the flow map data-solution cannot be $C^{2}$ in any $L^{2}$ based Sobolev space $H^{s}(\mathbb{R}), s \in \mathbb{R}$, by using the same counter-example as for the Benjamin-Ono equation in [24]. On the other hand, the Cauchy problem associated to (1.1) was proved in [18] to be locally well-posed in $H^{s}(\mathbb{R})$, for $s \geq 2$ (and also in weighted Sobolev spaces $H^{k}(\mathbb{R}) \cap L^{2}\left(\mathbb{R} ; x^{2} d x\right)$, for $\left.k \in \mathbb{Z}_{+}, k \geq 2\right)$. However, there are no conserved quantities at the $H^{2}$ level and thus it is not known wether these local solutions extend globally in time or not. Therefore, as commented in [18], the question of the local well-posedness in $H^{1}(\mathbb{R})$, which would directly imply global well-posedness by using (1.6) and (1.7), arises naturally.

The first aim of this paper is to give a positive answer to this issue. The result states as follows.

Theorem 1.1. Fix $\epsilon>0$ and let $s \geq 1$ be given. Then, for all $v_{0} \in H^{s}(\mathbb{R})$ and all $T>0$, there exists a unique solution $v$ to equation (1.1) in the space

satisfying

\end{equation*}

and

w=\partial_{x} P_{+h i}\left(e^{-i F[v]}\right) \in X_{\epsilon, T}^{s, \frac{1}{2}, 1} \tag{1.10}
\end{equation*}

where $F[v]$ is a spatial primitive of $v$ defined in Section 3.
Moreover, $v \in C_{b}\left(\mathbb{R} ; H^{1}(\mathbb{R})\right)$ and the flow map data-solution $S_{\epsilon}: v_{0} \mapsto v$ is continuous from $H^{s}(\mathbb{R})$ into $C\left([0, T] ; H^{s}(\mathbb{R})\right)$.

Note that above $H^{s}(\mathbb{R})$ denotes the space of all real-valued functions with the usual norm, while $X_{\epsilon, T}^{s, b}$ and $X_{\epsilon, T}^{s, b, q}$ are Bourgain spaces defined in Subsection 2.2.

Since it follows from the result of ill-posedness in [25] that the Cauchy problem associated to (1.1) cannot be solved by using a fixed point theorem on the integral equation, we use a compactness argument based on the smooth solutions obtained in [18]. To derive a priori estimates at the $H^{1}$ level, we introduce a gauge transformation which weakens the high-low frequency interactions in the nonlinearity of (1.1), as it was done by Tao in [27] for the Benjamin-Ono equation. Note that the same kind of gauge transformation was already introduced in [18] to obtain the solutions in $H^{2}(\mathbb{R})$. However, to lower the regularity till $H^{1}(\mathbb{R})$, we will need to combine this transformation with the use of Bourgain's spaces (as it was already done in $[4,9,23]$ for BO). More precisely, we need to work in a Besov version of Bourgain's spaces (introcuded in [29] in the context of waves maps). Indeed, on one hand we have to work in Bourgain' spaces of conormal regularity $1 / 2$ to establish the main bilinear estimate (see Proposition 4.2 below). On the other hand, to control some remaining terms appearing in the transformation, we need the full Kato smoothing effect for functions that are localized in space frequencies (see Proposition 4.4). The rest of the proof follows closely the one in [23] for the Benjamin-Ono equation (see also [20]).

In the second part of this article, we investigate the limit behavior of the solutions $v_{\epsilon}$ to (1.1), obtained in Theorem 1.1, as $\epsilon$ tends to zero. First, it is interesting to observe that a direct argument based on compactness methods (see for example [22] in the case of the Benjamin-Ono-Burgers equation) does not seem to work. Indeed, the leading terms in the energy $H$, which is to say $a \epsilon\left(\partial_{x} v\right)^{2}$ and $b v \mathcal{H} v$, have opposite signs, so that (1.6) and (1.7) do not provide a priori bounds, uniformly in $\epsilon$, on $\epsilon\left\|v_{\epsilon}\right\|_{H^{1}}^{2}+\left\|v_{\epsilon}\right\|_{H^{\frac{1}{2}}}^{2}$. Therefore, the problem of studying the limit of $v_{\epsilon}$, as $\epsilon$ goes to zero, turns out to be far from trivial.

Nevertheless, we are able to prove the convergence of solutions of (1.1) toward a solution of the Benjamin-Ono equation in the special case where the ratio of the densities is equal to $\sqrt{3}$.

Theorem 1.2. Assume that $\frac{3 a c}{4 d}=b \quad \Leftrightarrow \quad \rho^{2}=3 \rho_{1}^{2}$. Let $v_{0} \in H^{1}(\mathbb{R})$ and for any $\varepsilon>0$ denote by $S_{\varepsilon}(t) v_{0} \in C\left(\mathbb{R} ; H^{1}(\mathbb{R})\right)$ the solution to (1.1) emanating from $v_{0}$. Then for any $T>0$ it holds

\left\|S_{\varepsilon}(t) v_{0}-S(t) v_{0}\right\|_{L^{\infty}\left(0, T ; H^{1}(\mathbb{R})\right)} \longrightarrow 0 \text { as } \varepsilon \rightarrow 0 \tag{1.11}
\end{equation*}

where $S(t) v_{0}$ is the solution to the Benjamin-Ono equation emanating from $v_{0}$.
In the case where $\frac{\rho}{\rho_{1}}=\sqrt{3}$, the spatial primitive chosen to perform the gauge transformation for equation (1.1) corresponds to the one chosen for the BenjaminOno equation. Then, we can show that the Cauchy problem associated to (1.1) is uniformly in $\epsilon$ well-posed in $H^{1}(\mathbb{R})$, which will in a classical way (see for example [7]) lead to Theorem 1.2. The main difficulty here arises from the fact that the dispersive linear terms $\epsilon \partial_{x}^{3}$ and $\mathcal{H} \partial_{x}^{2}$ compete together as in the Benjamin equation (see the introduction in [2]). Therefore, we are only allowed to use the dispersive smoothing effects associated to (1.1) in some well behaved regions in spatial frequency and we need to refine the bilinear estimates obtained in the proof of Theorem 1.1 in the other regions.

It would be interesting to derive a class of higher-order equation for internal long waves from the first order one derived by Bona, Lannes and Saut in [3]. Among those equations, which would be formally equivalent to (1.1), one might find some with better behaved linear parts, which would avoid to deal with those technical difficulties.

Finally, we observe that the techniques introduced here would likely lead to similar results for the following intermediate long wave equation

\partial_{t} u-b \mathcal{F}_{h} \partial_{x}^{2} u+\left(a_{1} \mathcal{F}_{h}^{2}+a_{2}\right) \epsilon \partial_{x}^{3} u=c u \partial_{x} u-d \epsilon \partial_{x}\left(u \mathcal{F}_{h} \partial_{x} u+\mathcal{F}_{h}\left(u \partial_{x} u\right)\right) \tag{1.12}
\end{equation*}
$$

where $\mathcal{F}_{h}$ is the Fourier multiplier $-i \operatorname{coth}(h \xi), u$ is a real-valued solution, and $a_{1}, a_{2}, b, c, d$ and $h$ are positive constants, and which was also derived in [5]. Note that the same ill-posedness results as for equation (1.1) also hold for this equation (see [25]).

The paper is organized as follows: in the next section, we introduce the notations, define the functions spaces and recall some classical estimates. Sections 3 and 4 are devoted the key nonlinear estimates, which are used in Section 5 to prove Theorem 1.1. Finally, in Section 6, we prove Theorem 1.2.

## 2. Notations, function spaces and preliminary estimates

2.1. Notation. For any positive numbers $a$ and $b$, the notation $a \lesssim b$ means that there exists a positive constant $c$ such that $a \leq c b$. We also denote $a \sim b$ when $a \lesssim b$ and $b \lesssim a$. Moreover, if $\alpha \in \mathbb{R}, \alpha_{+}$, respectively $\alpha_{-}$, will denote a number slightly greater, respectively lesser, than $\alpha$.

For $u=u(x, t) \in \mathcal{S}\left(\mathbb{R}^{2}\right), \mathcal{F} u=\widehat{u}$ will denote its space-time Fourier transform, whereas $\mathcal{F}_{x} u=(u)^{\wedge_{x}}$, respectively $\mathcal{F}_{t} u=(u)^{\wedge_{t}}$, will denote its Fourier transform in space, respectively in time. For $s \in \mathbb{R}$, we define the Bessel and Riesz potentials of order $-s, J_{x}^{s}$ and $D_{x}^{s}$, by

Throughout the paper, we fix a smooth cutoff function $\eta$ such that

Then if $A$ is a positive number, $P_{<A}$ denote the Fourier multiplier whose symbol is given by $\eta\left(\frac{\dot{c A}}{c A}\right)$ and $P_{\gtrsim A}$ is defined by $P_{\gtrsim A}=1-P_{\lesssim A}$. For $l \in \mathbb{Z}_{+}$, we define

and

By convention, we also denote

Any summations over capitalized variables such as $N, L, K$ or $M$ are presumed to be dyadic with $N, L, K$ or $M \geq 0$, i.e., these variables range over numbers of the form $\left\{2^{n}: n \in \mathbb{Z}_{+}\right\} \cup\{0\}$. Then, we have that
$\sum_{N} \phi_{N}(\xi)=1, \quad \operatorname{supp}\left(\phi_{N}\right) \subset\left\{\frac{N}{2} \leq|\xi| \leq 2 N\right\}, N \geq 1, \quad$ and $\quad \operatorname{supp}\left(\phi_{0}\right) \subset\{|\xi| \leq 1\}$.
Let us define the Littlewood-Paley multipliers by

Let $P_{+}$and $P_{-}$denote the projection on respectively the positive and the negative Fourier frequencies. Then

Observe that $P_{h i}, P_{H I}, P_{l o}, P_{L O}, P_{N}$ and $P_{ \pm N}$ are bounded (uniformly in $N$ ) operators on $L^{p}(\mathbb{R})$ for $1 \leq p \leq \infty$, while $P_{ \pm}$are only bounded on $L^{p}(\mathbb{R})$ for $1<p<\infty$. We also note that

Finally, we denote by $V_{\epsilon}(t)=e^{t\left(b \mathcal{H} \partial_{x}^{2}+a \epsilon \partial_{x}^{3}\right)}$ the free group associated with the linearized part of equation (1.1), which is to say,

2.2. Function spaces. For $1 \leq p \leq \infty, L^{p}(\mathbb{R})$ is the usual Lebesgue space with the norm $\|\cdot\|_{L^{p}}$, and for $s \in \mathbb{R}$, the real-valued Sobolev spaces $H^{s}(\mathbb{R})$ and $W^{s, p}(\mathbb{R})$ denote the spaces of all real-valued functions with the usual norms

If $f=f(x, t)$ is a function defined for $x \in \mathbb{R}$ and $t$ in the time interval $[0, T]$, with $T>0$, if $B$ is one of the spaces defined above, $1 \leq p \leq \infty$ and $1 \leq q \leq \infty$, we will define the mixed space-time spaces $L_{T}^{p} B_{x}, L_{t}^{p} B_{x}, L_{x}^{q} L_{T}^{p}$ by the norms

Moreover, if $s \in \mathbb{R}, 1 \leq q \leq \infty$ and $X$ denotes one of the mixed space-time spaces defined above, we define its dyadic version $\mathcal{B}^{s, q}(X)$ as

In the special case $(s, q)=(0,2)$, the space $\mathcal{B}^{s, q}(X)$ will be simply denoted by $\widetilde{X}$.
For $s, b \in \mathbb{R}$, we introduce the Bourgain spaces $X_{\epsilon}^{s, b}$ related to the linear part of (1.1) as the completion of the Schwartz space $\mathcal{S}\left(\mathbb{R}^{2}\right)$ under the norm

where $\langle x\rangle:=1+|x|$. We will also use a dyadic version of those spaces introduced in [29] in the context of wave maps. For $s, b \in \mathbb{R}, 1 \leq q \leq \infty, X_{\epsilon}^{s, b, q}$ will denote the completion of the Schwartz space $\mathcal{S}\left(\mathbb{R}^{2}\right)$ under the norm

Moreover, we define a localized (in time) version of these spaces. Let $T>0$ be a positive time and $Y=X_{\epsilon}^{s, b}$ or $Y=X_{\epsilon}^{s, b, q}$. Then, if $v: \mathbb{R} \times[0, T] \rightarrow \mathbb{C}$, we have that

When $\epsilon=1$, we will denote $X^{s, b}=X_{1}^{s, b}, X_{T}^{s, b}=X_{1, T}^{s, b}, X^{s, b, q}=X_{1}^{s, b, q}$ and $X_{T}^{s, b, q}=X_{1, T}^{s, b, q}$.

Finally we list some useful properties of the Bourgain spaces defined above.
Proposition 2.1. Fix $\delta>0, s \in \mathbb{R}$ and $\epsilon>0$. Then it holds that

\begin{align*}
&\|v\|_{X_{\epsilon}^{s, \frac{1}{2}}} \lesssim\|v\|_{X_{\epsilon}^{s, \frac{1}{2}, 1}} \lesssim\|v\|_{X_{\epsilon}^{s, \frac{1}{2}+\delta}}  \tag{2.4}\\
&\|v\|_{L_{t}^{\infty} H_{x}^{s}} \lesssim \widehat{J_{x}^{s} v}\left\|_{L_{\xi}^{2} L_{\tau}^{1}} \lesssim\right\| v \|_{X_{\epsilon}^{s, \frac{1}{2}, 1}} \tag{2.5}
\end{align*}
$$

and

$$
\begin{equation*}
\|f\|_{X_{\epsilon}^{s,-\frac{1}{2}+\delta}} \lesssim\|f\|_{L_{t}^{1+\delta^{\prime}} H_{x}^{s}}, \tag{2.6}
\end{equation*}
$$

for $\delta^{\prime}>0$ satisfying $1+\delta^{\prime}=\frac{1}{1-\delta}$. In other words, the injections

are continuous.
2.3. Linear estimates. First, we recall some linear estimates in Bourgain's spaces which will be needed later (see for instance [29]).

Lemma 2.2 (Homogeneous linear estimate). Let $s \in \mathbb{R}$ and $\epsilon>0$. Then

Next, we derive local and global smoothing effects associated to the group $\left\{V_{\epsilon}(t)\right\}$, for the KdV scaling, in the context of Bourgain's spaces. We begin with the Strichartz estimates.

Lemma 2.4. For all $0<\epsilon<1, T>0$ and $0 \leq \theta \leq 1$, we have that

\|v\|_{L_{x, T}^{p_{\theta}}} \lesssim \epsilon^{-\frac{9}{8}}\|v\|_{X_{\epsilon, T}^{0}, \frac{,}{2}+}, \tag{2.10}
\end{equation*}
$$

where $\frac{1}{p_{\theta}}=\frac{\theta}{8}+\frac{1-\theta}{2}$.
Proof. First, we observe, arguing as in Lemma 2.1 in [18], that $w$ is a solution to the linear equation

is a solution to

\partial_{t} u-a \epsilon \partial_{x}^{3} u=0 . \tag{2.13}
\end{equation*}
$$

Let us denote by $\left\{W_{\epsilon}^{ \pm}(t)\right\}$ and $\left\{U_{\epsilon}(t)\right\}$ the groups associated to (2.11) and (2.13). Since $U_{\epsilon}(t)=U_{1}(\epsilon t)$, we deduce from the classical Strichartz estimate for the KdV equation (cf. for example [19], chapter 4) that

Next, we use Lemma 3.3 in [6] to rewrite estimate (2.16) in the context of Bourgain's spaces. We get that

Therefore, we deduce by using Stein's theorem to interpolate estimate (2.17) with Plancherel's identity $\|v\|_{L_{x, t}^{2}}=\|v\|_{X_{e}^{0,0}}$, that

Next, we turn to the local Kato type smoothing effect.
Lemma 2.5. Let $0<\epsilon \leq 1$ and $T>0$ and $N \gtrsim \frac{1}{\epsilon}$. Then, it holds that

\left\|\partial_{x} v\right\|_{L_{x}^{x} L_{T}^{2}} \lesssim T^{\frac{1}{2}} \epsilon^{-\frac{3}{2}+}\|v\|_{X_{e}^{0, \frac{1}{2}, 1}} \tag{2.20}
\end{equation*}
$$

Proof. Since $N \gtrsim \frac{1}{\epsilon}$, we obtain applying estimate (4.3) in Theorem 4.1 of [13] that

& \lesssim \epsilon^{-\frac{1}{2}}\left\|P_{N} v_{0}\right\|_{L_{x}^{2}} .
\end{align*}

Moreover, by applying the Fourier inverse formula, it follows that

Therefore, Minkowski's inequality, estimate (2.21), Plancherel's identity and the Cauchy-Schwarz inequality imply that

\end{align*}

which leads to estimate (2.19) since

On the other hand, if $N \lesssim \frac{1}{\epsilon}$, we deduce from the Sobolev embedding $H^{s}(\mathbb{R}) \hookrightarrow$ $L^{\infty}(\mathbb{R})$, whenever $s>\frac{1}{2}$, that

& \lesssim T^{\frac{1}{2}}\left\|\partial_{x} V_{\epsilon}(t) P_{N} v_{0}\right\|_{L_{T}^{\infty} H_{x}^{s}} \\
& \lesssim T^{\frac{1}{2}} \epsilon^{-1}\left(1+\epsilon^{-s}\right)\left\|P_{N} v_{0}\right\|_{L_{x}^{2}} .
\end{aligned}
$$

Therefore, we deduce arguing as above that

\end{equation*}

whenever $N \lesssim \frac{1}{\epsilon}$.
Estimate (2.20) follows gathering estimates (2.19) and (2.23) and by squaring and summing over $N$.

Finally, we derive the maximal function estimate.
Lemma 2.6. Let $s>\frac{3}{4}, 0<\epsilon \leq 1$, and $T>0$ be such that $0<\epsilon T \leq 1$. Then, we have that

& =\left(\int_{\mathbb{R}} \sup _{|s| \leq \epsilon T}\left|U_{1}(s) u_{0}(x)\right|^{2} d x\right)^{\frac{1}{2}} \lesssim\left\|u_{0}\right\|_{H^{s}}^{2} \tag{2.26}
\end{align*}
$$

since $s>\frac{3}{4}$ and $0<\epsilon T \leq 1$.
Thus, if $w$ and $u$ are the solutions associated to (2.11) and (2.13) with respective initial data $w_{0}$ and $u_{0}$, it follows from (2.12) and (2.26) that

whenever $s>\frac{3}{4}$ and $\epsilon, T$ satisfying $0<\epsilon T \leq 1$. This implies estimate arguing as in (2.22) that

for any $N \geq 0$ and $s>\frac{3}{4}$, which leads to (2.24) by squaring and summing over $N$.
2.4. Fractional Leibniz's rules. First we state the classical fractional Leibniz rule estimate derived by Kenig, Ponce and Vega (See Theorems A. 8 and A. 12 in [15]).
Proposition 2.7. Let $0<\alpha<1$, $p, p_{1}, p_{2} \in(1,+\infty)$ with $\frac{1}{p_{1}}+\frac{1}{p_{2}}=\frac{1}{p}$ and $\alpha_{1}, \alpha_{2} \in[0, \alpha]$ with $\alpha=\alpha_{1}+\alpha_{2}$. Then,

\left\|D_{x}^{\alpha}(f g)-f D_{x}^{\alpha} g-g D_{x}^{\alpha} f\right\|_{L^{p}} \lesssim\left\|D_{x}^{\alpha_{1}} g\right\|_{L^{p_{1}}}\left\|D_{x}^{\alpha_{2}} f\right\|_{L^{p_{2}}} . \tag{2.29}
\end{equation*}
$$

Moreover, for $\alpha_{1}=0$, the value $p_{1}=+\infty$ is allowed.
The next estimate is a frequency localized version of estimate (2.29), proved in [20], in the same spirit as Lemma 3.2 in [27].
Lemma 2.8. Let $\alpha \geq 0$ and $1<q<\infty$. Then,

with $1<q_{i}<\infty, \frac{1}{q_{1}}+\frac{1}{q_{2}}=\frac{1}{q}$ and $\alpha_{1} \geq \alpha, \alpha_{2} \geq 0$ and $\alpha_{1}+\alpha_{2}=1+\alpha$.
We also state an estimate to handle the multiplication by a term on the form $e^{ \pm \frac{i}{2} F}$, where $F$ is a real-valued function, in fractional Sobolev spaces.
Lemma 2.9. Let $2 \leq q<\infty$ and $1 \leq s \leq \frac{3}{2}$. Consider $F$ and $F_{1}$ two real-valued functions such that $v=\partial_{x} F$ and $v_{1}=\partial_{x} F_{1}$ belong to $L^{2}(\mathbb{R})$. Then, it holds that

Remark 2.10. The proof follows the lines of Lemma 2.7 in [23] (see also [20, 21]). A version of Lemma 2.9 could also be stated for $s>\frac{3}{2}$.

## 3. The gauge transformation

The gauge transform we will use is the one introduced by Tao in [27]. First we define an antiderivative $F=F[v]$ of $v$. We determine $F$ on the time axis $x=0$ by solving the ODE

Then we extend $F$ on the whole plan by setting

Clearly, it holds

and, according to the choice of $F$ on the time axis, it satisfies the equation

\partial_{t} F-b \mathcal{H} \partial_{x}^{2} F-a \epsilon \partial_{x}^{3} F=\frac{c}{2} A^{-1} F_{x}^{2}-\frac{3}{2} a \epsilon\left(F_{x} \mathcal{H} F_{x x}+\mathcal{H}\left(F_{x} F_{x x}\right)\right) \tag{3.1}
\end{equation*}
$$

Now, we perform the following nonlinear transformation

W=P_{+h i}\left(e^{i F}\right) \quad \text { and } \quad w=W_{x}=i A P_{+h i}\left(e^{i F} v\right) \tag{3.2}
\end{equation*}
$$

First, using the identity $\mathcal{H} P_{+}=-i P_{+}$, we compute

\end{aligned}
$$

Then using (3.1) and the identity $\mathcal{H}+i=2 i P_{-}$it follows that

= & P_{+h i}\left(e^{i F}\left(i\left(\frac{c}{2} A^{-1}-b\right) F_{x}^{2}-i a \epsilon F_{x}^{3}-2 b P_{-} F_{x x}+3 a \epsilon F_{x} P_{-} F_{x x}+3 a \epsilon P_{-}\left(F_{x} F_{x x}\right)\right)\right) \\
= & P_{+h i}\left(e^{i F}\left(\alpha_{1} v^{2}+\alpha_{2} \epsilon v^{3}\right)\right)+\alpha_{3} P_{+h i}\left(W P_{-} v_{x}\right)+\alpha_{3} P_{+h i}\left(P_{l o}\left(e^{i F}\right) P_{-} v_{x}\right) \\
& +\alpha_{4} \epsilon P_{+h i}\left(w P_{-} v_{x}\right)+\alpha_{5} \epsilon P_{+h i}\left(P_{l o}\left(e^{i F} v\right) P_{-} v_{x}\right)+\alpha_{6} \epsilon P_{+h i}\left(W P_{-}\left(v v_{x}\right)\right) \\
& +\alpha_{6} \epsilon P_{+h i}\left(P_{l o}\left(e^{i F}\right) P_{-}\left(v v_{x}\right)\right),
\end{aligned}
$$

where $\alpha_{j}, j=1 \cdots 6$ are complex constants depending on $a, b, c$ and $d$.
Remark 3.1. We observe from the definition of the coefficients $a, b, c$ and $d$ in (1.3) and (1.4) that

& +\epsilon \partial_{x} P_{+h i}\left(w P_{-} v_{x}\right)+\epsilon \partial_{x} P_{+h i}\left(P_{l o}\left(e^{i F} v\right) P_{-} v_{x}\right)  \tag{3.4}\\
& +\epsilon \partial_{x} P_{+h i}\left(W P_{-}\left(v v_{x}\right)\right)+\epsilon \partial_{x} P_{+h i}\left(P_{l o}\left(e^{i F}\right) P_{-}\left(v v_{x}\right)\right) \\
& \quad:=N\left(e^{i F}, v, W, w\right) .
\end{align*}

On the other hand, we can recover $v$ as a function of $w$ by writing

Remark 3.3. It is worth noticing that estimates (3.8) and (3.9) could be rewritten in a convenient form for $s>\frac{3}{2}$.

## 4. Bilinear estimates

In this section, we fix $\epsilon=1$. The aim of this section is to derive an estimate on $\|w\|_{X_{T}^{s, \frac{1}{2}, 1}}$.
Proposition 4.1. Let $0<T \leq 1,1 \leq s \leq \frac{3}{2}$, $v$ be a solution to (1.1) on the time interval $[0, T]$ and $w$ defined in (3.2). Then it holds that

\end{align*}

where $p$ is a polynomial function at least quadratic in its arguments.
The main tools to prove Proposition 4.1 are the following crucial bilinear estimates.

Proposition 4.2. For any $s \geq 1$, we have that

(1) high-low interaction: $N_{1} \sim N$ and $N_{2} \leq N_{1}$
(2) high-high interaction: $N_{1} \sim N_{2}$ and $N \leq N_{1}$.

Moreover, the resonance identity

To estimate $I$, we will divide the sum in (4.9) depending on the high-low or high-high interactions regime and on wether $L_{\max }=L, L_{1}$ or $L_{2}$.

Case high-low interaction and $L_{\max }=L_{2}$. In this case, we can estimate $I$ as

Case high-high interaction and $L_{\max }=L_{2}$. This case works exactly as in the precedent case, summing in $N \leq N_{1}$ instead of $N_{2} \leq N$.

Case high-low interaction and $L_{\max }=L_{1}$. We obtain from the frequency localization properties that

Finally, we turn to the proof of estimate (4.17). We will only bound the first term on the left-hand side, since the other ones can be treated exactly by the same
way. The Cauchy-Schwarz inequality and estimate (2.6) imply that

## 5. Proof of Theorem 1.1

Without loss of generality, we will fix $\epsilon=1$ in this section. First observe that, unlike to the Benjamin-Ono equation, equation (1.1) is not invariant under scaling. However, if $v$ is a solution to the equation (1.1) on the time interval $[0, T]$ with initial data $v_{0}$, then for every $0<\lambda<\infty, v_{\lambda}(x, t)=\lambda v\left(\lambda x, \lambda^{3} t\right)$ is a solution to

on the time interval $\left[0, \lambda^{-3} T\right]$. Then, since

we can always force $v_{\lambda}(\cdot, 0)$ to belong to $B_{\alpha}$, where $B_{\alpha}$ is the open ball of $H^{1}(\mathbb{R})$ with radius $0<\alpha \ll 1$ and centered at the origin. Therefore the existence and uniqueness of a solution to (5.1) on the time interval $[0,1]$ for small initial data in $H^{1}(\mathbb{R})$ will ensure the existence and uniqueness of a solution to (1.1) on the time interval $[0, T]$ with $T \sim \lambda^{3} \sim \min \left\{1,\left\|v_{0}\right\|_{H^{1}}^{-6}\right\}$ for arbitrary initial data in $H^{1}(\mathbb{R})$. Moreover, using the conservation of the energy $H$ defined in (1.7), which controls the $H^{1}$-norm, will imply the global well-posedness of $(1.1)$ in $H^{1}(\mathbb{R})$.

Since all the estimates obtained in the precedent sections are still valid for (5.1) with implicit constants independent of $0<\lambda \leq 1$ and for sake of simplicity, we will continue working with equation (1.1), in the case $\epsilon=1$, i.e.,

instead of equation (5.1). The rest of the proof of Theorem 1.1 follows closely our proof for the Benjamin-Ono equation (see Theorem 1.1 in [23]). For this reason, we will only give a sketch of it.

As a consequence of the well-posedness theory for more regular solutions obtained in Theorem 1.3 of [18], we have the following result.

Proposition 5.1. For all $v_{0} \in H^{\infty}(\mathbb{R})$, there exists a positive time $T=T\left(\left\|v_{0}\right\|_{H^{2}}\right) \in$ $(0,1]$ and a solution $v \in C\left([0, T] ; H^{\infty}(\mathbb{R})\right)$ to equation (5.2). Moreover, $T$ is a nondecreasing function of its argument.

Note however that at this point, we still do not know wether those solutions are global or not.

The first step is to obtained a priori estimates for those smooth solutions. Let $v_{0} \in B_{\alpha} \cap H^{\infty}(\mathbb{R})$ be given. Here, we recall that $B_{\alpha}=\left\{\phi \in H^{1}(\mathbb{R}):\|\phi\|_{H^{1}} \leq \alpha\right\}$, where $\alpha>0$ will be choosen sufficiently small. For any $s \geq 1$, we will also denote

By continuity, estimate (5.4) for $s=1$ ensures that there exist two positive constants $\alpha_{1}$ and $C_{1}$ such that $N_{T}^{1}(v) \leq C_{1} \alpha$, provided $v_{0} \in B_{\alpha}$ with $0<\alpha<\alpha_{1}$. Moreover, using estimate (5.4) again implies that

Therefore, by using estimate (5.5) for $s=2$, we can reapply the result of Proposition 5.1 a finite number of time to extend the solution $v$ to the interval $[0,1]$, as soon as $\left\|v_{0}\right\|_{H^{1}}$ is small enough. We observe that the scaling argument explained above and the control of the $H^{1}$-norm by the Hamiltonian $H$ defined in (1.7), allow to extend our solution $v$ globally in time, so that $v \in C\left(\mathbb{R} ; H^{\infty}(\mathbb{R})\right)$.

To prove the uniqueness as well as the continuity of the flow map, we follow our argument in the proof of Theorem 1.1 of [23] and derive a Lipschitz bound on the flow map : $H^{s}(\mathbb{R}) \rightarrow L^{\infty}\left([0,1] ; H^{s}(\mathbb{R})\right)$ for initial data having the same low frequency part, and where $L^{\infty}\left([0,1] ; H^{s}(\mathbb{R})\right)$ is considered with the norm $N_{1}^{s}$ defined in (5.3). The idea is to apply similar estimates to (3.7)-(3.11) and (4.1) to the difference of two solutions $u:=v_{1}-v_{2}$ and to the difference of the gauges $z:=w_{1}-w_{2}$. Note that at this point a control on $G:=F\left[v_{1}\right]-F\left[v_{2}\right]$ in $L^{\infty}([0,1] \times \mathbb{R})$ is needed and can be obtained exactly as in Lemma 4.1 of [23] by splitting $G$ between its low and high frequency parts $G:=G_{l o}+G_{h i}$. We use the equation satisfied by $G_{l o}$ and evolving from 0 to control $G_{l o}$ and Bernstein's inequalities to control $G_{h i}$.

Finally to prove the existence in $H^{s}(\mathbb{R})$, for initial data and the continuity of the flow map, we fix an initial data $v_{0} \in B_{\alpha} \cap H^{s}(\mathbb{R})$ and an approximate sequence of initial data $v_{0}^{j}=\mathcal{F}_{x}^{-1}\left(\chi_{\left.\right|_{[-j, j]}} \mathcal{F}_{x} v_{0}\right)$. Then, as explained above, the associated sequence of solutions $\left\{v^{j}\right\}_{j}$ is a subset of $C\left([0,1] ; H^{\infty}(\mathbb{R})\right)$. Moreover, since it evolves from initial data having the same low frequency part, the Lipschitz bound implies that $\left\{v^{j}\right\}_{j}$ is a Cauchy sequence in all the norms appearing in $N_{1}^{s}$ and therefore converges strongly in those norms to a solution $v$ of (5.2) satisfying $v(\cdot, 0)=v_{0}$ and (1.8)-(1.10).

## 6. Convergence towards the Benjamin-Ono equation in $H^{1}(\mathbb{R})$ when $\rho=\sqrt{3} \rho_{1}$

In this section we prove that (1.1) is uniformly in $\varepsilon>0$ well-posed in $H^{1}(\mathbb{R})$ whenever the ratio of the density between the two fluids is given by $\rho=\sqrt{3} \rho_{1}$. This will in a classical way (see for instance [7]) lead to Theorem 1.2. According to Remark 3.1, this condition on this ratio permits to cancel the term $\partial_{x} P_{+h i}\left(e^{i F} v^{2}\right)$
in (3.4). Note that this term behaves mainly as the nonlinear term of the BenjaminOno equation $\partial_{x}\left(v^{2}\right)$. Therefore we do not know how deal with this term when $\varepsilon$ is going to zero. One possibility could be to use the variant of the Bourgain' space introduced in $[10,16]$ as it was done to study the inviscid limit of the the Benjamin-Ono-Burgers equation in [8]. However, there is another problem here since linear and bilinear estimates involving $V_{\varepsilon}$ are not uniform in $\varepsilon$ (see for instance (6.1)-(6.2)). This is due to the fact that the linear terms $\mathcal{H} u_{x x}$ and $\varepsilon \partial_{x}^{3}$ compete together as in the Benjamin equation (cf. [2]). This is reflected on the energy $H$ (see (1.7)) by the fact that the $\dot{H}^{1}$ and $\dot{H}^{1 / 2}$ components of the quadratic part are of opposite signs.
6.1. Some linear estimates. First we establish needed linear estimates on the group $V_{\varepsilon}(\cdot)$ (see also Lemmas 2.4-2.5).
Lemma 6.1. For any $0<\varepsilon \leq 1$, any $0<T \leq 1$ and any $\varphi \in L^{2}(\mathbb{R})$ it holds

Recall that the term $\partial_{x} P_{+h i}\left(e^{-i F} v^{2}\right)$ cancels in this section due to the choice of the ratio between $\rho$ and $\rho_{1}$.

\left(\sum_{N}\left|I_{N}^{\mathcal{e}}\right|^{2}\right)^{1 / 2} \lesssim\|\tilde{u}\|_{X^{0,1}}\left\|\mathcal{F}^{-1}\left(\left|\widehat{w_{1}}\right|\right)\right\|_{L_{t x}^{\infty}} \lesssim\|w\|_{X^{1,1 / 2,1}}\|\tilde{v}\|_{X^{0,1}}
$$

where $\widehat{\hat{v}}=\tilde{\eta}_{\epsilon} \hat{v}$ and $\tilde{\eta}_{\epsilon}$ is a smooth even function with support in $\left\{|\xi| \leq \frac{100}{\epsilon}\right\}$. Here we used that due to the frequency projections together with the frequency localization of $w_{1}$, the modulus of the frequencies of $v$ must be less than $10 / \varepsilon$. Now from the equation (1.1) satisfied by $v$ and the frequency localization of $\tilde{v}$, we deduce that

$$
\left\|\partial_{t} V_{\epsilon}(-t) \tilde{v}\right\|_{L_{t x}^{2}} \lesssim\left\|v v_{x}\right\|_{L_{t x}^{2}} \lesssim\|v\|_{L_{t}^{\infty} H_{x}^{1}}^{2} .
$$

This yields the desired result.
Lemma 6.4. Assume that supp $v \subset\{|t| \leq T\}$ with $1<T \leq 1$. Then for any $0<\epsilon \leq 1$ it holds

\begin{equation*}
\epsilon\left\|\partial_{x} P_{+h i}\left(w \partial_{x} P_{-h i} v\right)\right\|_{X_{\epsilon}^{1,-1 / 2,1}} \lesssim\|w\|_{X^{1,-1 / 2,1}}\left[\epsilon^{1 / 9}\left\|v_{x}\right\|_{L_{t x}^{4}}+\left(1+\|v\|_{L_{t}^{\infty} H_{x}^{1}}\right)\|v\|_{L_{t}^{\infty} H_{x}^{1}}\right] \tag{6.13}
\end{equation*}
$$

Proof. We rewrite $\hat{w}$ as $\zeta_{\epsilon} \hat{w}+\left(1-\zeta_{\epsilon}\right) \hat{w}:=\widehat{w_{1}}+\widehat{w_{2}}$ where $\zeta_{\epsilon}$ is a smooth even function with support in $|\xi| \in] \frac{1}{2 \epsilon}, \frac{1}{\epsilon}\left[\right.$ such that $\zeta_{\epsilon} \equiv 1$ on $] \frac{5}{9 \epsilon}, \frac{8}{9 \epsilon}[$.
By Sobolev embedding and the frequency localization of $w_{1}$ we have

$$
J_{1}:=\epsilon\left\|\partial_{x} P_{+h i}\left(w_{1} \partial_{x} P_{-h i} v\right)\right\|_{X_{\epsilon}^{1,-1 / 2,1}} \lesssim T^{1 / 3}\left\|\partial_{x} P_{+h i}\left(w_{1} \partial_{x} P_{-h i} v\right)\right\|_{L_{t}^{2} L_{x}^{2}}
$$

We proceed exactly as in the preceding lemma to get

$$
\begin{aligned}
\left\|\partial_{x} P_{2^{k}} P_{+h i}\left(w_{1} \partial_{x} P_{-h i} v\right)\right\|_{L_{t}^{2} L_{x}^{2}} & \lesssim 2^{2 k} \sum_{j \geq k}\left\|\partial_{x} P_{2^{k}} P_{+h i}\left(P_{2^{j}} w_{1} \partial_{x} P_{-h i} v\right)\right\|_{L_{t}^{2} L_{x}^{2}} \\
& \lesssim 2^{2 k} \sum_{j \geq k} 2^{-j}\left\|P_{2^{j}} w_{1}\right\|_{L_{t}^{4} L_{x}^{\infty}}\left\|\partial_{x} v\right\|_{L_{t}^{\infty} L_{x}^{2}} \\
& \lesssim \gamma_{k}\left\|\partial_{x} w_{1}\right\|_{\widetilde{L_{t}^{4} L_{x}^{\infty}}}\left\|\partial_{x} v\right\|_{L_{t}^{\infty} L_{x}^{2}}
\end{aligned}
$$

which is acceptable, according to (6.6), since $\widehat{w_{1}}$ cancels on $] \frac{1}{4 \epsilon}, \frac{1}{2 \epsilon}[$.
Now for the contribution of $w_{2}$ we will use that thanks to the frequency localization of $w_{2}$ and the resonance relation we have

$$
\max \left(|\sigma|,\left|\sigma_{i}\right|\right) \gtrsim \epsilon\left|\xi \xi_{1} \xi_{2}\right|
$$

on the space-time Fourier support of this contribution. We decompose this contribution as in the preceding lemma but with respect to $\epsilon N N_{1} N_{2}$ instead of $N_{1} N_{2}$.

- Bound on $\sum_{N}\left|I_{N}^{\mathcal{B}}\right|^{2}$.

$$
\begin{aligned}
I_{2^{k}}^{\mathcal{B}} & \lesssim \varepsilon 2^{2 k} \sum_{j \geq k} \sum_{q \leq j}\left\|P_{2^{k}} P_{+h i}\left(P_{2^{j}} w_{2} \partial_{x} P_{-h i} P_{2^{q}} v\right)\right\|_{L_{T}^{4 / 3} L_{x}^{2}} \\
& \lesssim \sqrt{\varepsilon} \sum_{j \geq k} \sum_{q \leq j} 2^{2 k} 2^{-j} 2^{-(k+q+j) / 2}\left\|P_{2^{j}} \partial_{x} w_{2}\right\|_{X^{0,1 / 2}}\left\|P_{2^{q}} \partial_{x} v\right\|_{L_{T}^{4} L_{x}^{\infty}} \\
& \lesssim \sqrt{\varepsilon} \sum_{j \geq k} \sum_{q \leq j} 2^{\frac{3}{2}(k-j)}\left\|P_{2^{j}} \partial_{x} w_{2}\right\|_{X^{0,1 / 2}}\left\|P_{2^{q}} D_{x}^{3 / 4} v\right\|_{L_{T, x}^{4}} \\
& \lesssim \varepsilon^{1 / 2-1 / 9} \gamma_{k}\left\|w_{x}\right\|_{X^{1,1 / 2}}\left(\varepsilon^{1 / 9}\left\|v_{x}\right\|_{L_{T, x}^{4}}\right)
\end{aligned}
$$

with $\left\|\gamma_{k}\right\|_{l^{2}\left(\mathbb{Z}_{+}\right)} \lesssim 1$.

- Bound on $\sum_{N}\left|I_{N}^{\mathcal{A}}\right|^{2}$. Note that since $|\sigma| \sim \varepsilon N N_{1} N_{2}$ in this region, we do not have to sum on $L$.

$$
\begin{aligned}
I_{2^{k}}^{\mathcal{A}} & \lesssim \sqrt{\varepsilon} 2^{2 k} \sum_{j \geq k} \sum_{q \leq j} 2^{-(k+q+j) / 2}\left\|P_{2^{k}} P_{+h i}\left(P_{2^{j}} w_{2} \partial_{x} P_{-h i} P_{2^{q}} v\right)\right\|_{L_{t x}^{2}} \\
& \lesssim \sqrt{\varepsilon} \sum_{j \geq k} \sum_{q \leq j} 2^{\frac{3}{2}(k-j)}\left\|P_{2^{j}} \partial_{x} w_{2}\right\|_{L_{t x}^{4}}\left\|P_{2^{q}} D_{x}^{1 / 2} v\right\|_{L_{T x}^{4}} \\
& \lesssim \varepsilon^{1 / 2-1 / 9} \gamma_{k}\left\|w_{x}\right\|_{X^{1,1 / 2}}\left(\varepsilon^{1 / 9}\left\|v_{x}\right\|_{L_{t x}^{4}}\right)
\end{aligned}
$$

with $\left\|\gamma_{k}\right\|_{l^{2}\left(\mathbb{Z}_{+}\right)} \lesssim 1$.

- Bound on $\sum_{N}\left|I_{N}^{\mathrm{e}}\right|^{2}$. We separate two subregions.
a) $\xi_{1} \leq \frac{50}{\epsilon}$ Then we have $\left|\xi_{2}\right| \leq \frac{50}{\epsilon}$. We write

$$
\left(\sum_{N}\left|I_{N}^{\mathcal{C}}\right|^{2}\right)^{1 / 2} \lesssim\|\tilde{v}\|_{X^{0,1}}\left\|\mathcal{F}^{-1}\left(\left|\widehat{w_{2}}\right|\right)\right\|_{L_{t x}^{\infty}} \lesssim\left\|w_{2}\right\|_{X^{1,1 / 2,1}}\|\tilde{v}\|_{X^{0,1}}
$$

where $\widehat{\tilde{v}}=\tilde{\eta}_{\epsilon} \hat{v}$ and $\tilde{\eta}_{\epsilon}$ is a smooth even function with support in $\left\{|\xi| \leq \frac{100}{\epsilon}\right\}$ This is acceptable since, as in the preceding lemma due to the frequency localization of $v$,

$$
\|\tilde{v}\|_{X^{0,1}} \lesssim\left(1+\|v\|_{L_{t}^{\infty} H_{x}^{1}}\right)\|v\|_{L_{t}^{\infty} H_{x}^{1}}
$$

b) $\xi_{1}>\frac{50}{\epsilon}$ Then we write

$$
\begin{aligned}
I_{2^{k}}^{\mathfrak{C}} & \lesssim \sum_{j \geq k} \epsilon\left\|\mathcal{F}^{-1}\left(\left|\xi^{2} \xi_{2} \| \hat{v}\right|\left|\widehat{P_{2^{j}} w_{2}}\right|\right)\right\|_{L_{t}^{4 / 3} L_{x}^{2}} \\
& \lesssim\|v\|_{X^{-1,1}} \sum_{j \geq k}\left\|\mathcal{F}^{-1}\left(\left|\widehat{P_{2^{j}} \partial_{x} w_{2}}\right|\right)\right\|_{L_{t}^{4} L_{x}^{\infty}} \\
& \lesssim \gamma_{k}\|v\|_{X^{-1,1}}\|w\|_{X^{1,1 / 2}}
\end{aligned}
$$

where we used (6.3) and the frequency localization of $w_{2}$ in this subregion. This is acceptable, since in view of (1.1) it is not too hard to check that

$$
\|v\|_{X^{-1,1}} \lesssim\left(1+\|v\|_{L_{t}^{\infty} H_{x}^{1}}\right)\|v\|_{L_{t}^{\infty} H_{x}^{1}} .
$$

Now the contribution of the term $\epsilon \partial_{x} P_{+h i}\left(W P_{-}\left(v v_{x}\right)\right)$ is easy to estimate as follows $\epsilon\left\|\partial_{x} P_{+h i}\left(W P_{-}\left(v v_{x}\right)\right)\right\|_{X^{1,-1 / 2,1}} \lesssim \epsilon\left\|\partial_{x}^{2} P_{+h i}\left(W P_{-}\left(v v_{x}\right)\right)\right\|_{L_{x, T}^{2}}$

$$
\begin{equation*}
\lesssim \epsilon^{2 / 3}\left(\epsilon^{1 / 9}\left\|w_{x}\right\|_{L_{x, T}^{6}}\right)\left(\epsilon^{1 / 9}\|v\|_{L_{x, T}^{6}}\right)\left(\epsilon^{1 / 9}\left\|v_{x}\right\|_{L_{x, T}^{6}}\right) \tag{6.14}
\end{equation*}
$$

which is acceptable thanks to (6.2). Moreover, the contributions of each term of the left-hand side of (4.17) is controlled by $\|v\|_{L_{t}^{\infty} H_{x}^{1}}^{2}$ since, by the frequency projections, only low frequencies of $v, v^{2}$ and $e^{i F} v$ are involved. It thus remains to control the term $\varepsilon\left\|\partial_{x} P_{+h i}\left(e^{i F} v^{3}\right)\right\|_{X^{1,-\frac{1}{2}, 1}}$. This is the aim of the following lemma.

## Lemma 6.5.

$\varepsilon\left\|\partial_{x} P_{+h i}\left(e^{i F} v^{3}\right)\right\|_{X^{1,-\frac{1}{2}, 1}} \lesssim\|v\|_{L_{T}^{\infty} H^{1}}^{3}+\varepsilon\|v\|_{L_{t}^{\infty} H_{x}^{1}}^{4}$

$$
\begin{equation*}
+\varepsilon\left[\|v\|_{L_{T}^{\infty} H^{1}}^{3}\left(1+\|v\|_{L_{T}^{\infty} H^{1}}\right)+\left\|v_{x x}\right\|_{\widetilde{L_{x}^{\infty} L_{t}^{2}}}\|v\|_{L_{x}^{4} L_{t}^{\infty}}^{2}\right] \tag{6.15}
\end{equation*}
$$

Proof. . First, proceeding as in the proof of Proposition 4.4, it is not too hard to see that
$\varepsilon\left\|\partial_{x} P_{+h i}\left(e^{i F} v^{3}\right)\right\|_{X^{1,-\frac{1}{2}, 1}} \lesssim\|v\|_{L_{t}^{\infty} H_{x}^{1}}^{3}+\varepsilon\|v\|_{L_{t}^{\infty} H_{x}^{1}}^{4}+\|v\|_{L_{t}^{\infty} H_{x}^{1}}^{4}+\varepsilon\left\|\partial_{x}^{2} P_{H I}\left(v^{3}\right)\right\|_{L_{t}^{2} L_{x}^{2}}$.
It thus remains to bound the last term of the right-hand side of the above inequality.
We notice that for $k \geq 4$ we may bound its $P_{2^{k}}$-projection by

$$
\left\|\partial_{x}^{2} P_{2^{k}} v^{3}\right\|_{L_{t x}^{2}} \lesssim\left\|\partial_{x}^{2} P_{2^{k}}\left(\sum_{j \geq k-4} P_{2^{j}} v S_{2^{j}} v S_{2^{j}} v\right)\right\|_{L_{t x}^{2}}
$$

Hence, proceeding as in Proposition 4.4, it is easy to check that for $k \geq 4$,

$$
\left\|\partial_{x}^{2} P_{2^{k}} v^{3}\right\|_{L_{t}^{2} L_{x}^{2}} \lesssim \gamma_{k}\left\|v_{x x}\right\|_{L_{x}^{\infty} L_{t}^{2}}\|v\|_{L_{x}^{4} L_{t}^{\infty}}^{2}
$$

where $\left\|\left(\gamma_{k}\right)\right\|_{l^{2}\left(\mathbb{Z}_{+}\right)} \lesssim 1$. This completes the proof of the lemma.
Finally to close the estimates we have to control some norms of $v$ in terms of $w$.
Lemma 6.6. Let $0<T \leq 1,0 \leq \theta \leq 1,0<\epsilon \leq 1$ and $v$ be a solution to (1.1) in the time interval $[0, T]$. Then, it holds that

$$
\begin{equation*}
\varepsilon^{1 / 9}\left\|\partial_{x} v\right\|_{L_{x, t}^{6}} \lesssim\left\|v_{0}\right\|_{H^{1}}+\left(1+\|v\|_{L_{T}^{\infty} H_{x}^{1}}^{2}\right)\|w\|_{X^{s, 1 / 2,1}}+\varepsilon^{1 / 9}\|v\|_{L_{T}^{\infty} H_{x}^{1}}\left\|\partial_{x} v\right\|_{L_{x, T}^{6}} \tag{6.16}
\end{equation*}
$$

$$
\begin{equation*}
\varepsilon^{1 / 4}\|v\|_{L_{x}^{4} L_{t}^{\infty}} \lesssim\left\|v_{0}\right\|_{H^{1}}+\left(1+\|v\|_{L_{T}^{\infty} H_{x}^{1}}^{2}\right)\|w\|_{X^{s, 1 / 2,1}}+\varepsilon^{1 / 4}\|v\|_{L_{T}^{\infty} H_{x}^{1}}\|v\|_{L_{x}^{4} L_{T}^{\infty}} \tag{6.17}
\end{equation*}
$$

and

$$
\begin{align*}
\varepsilon^{1 / 2}\left\|\partial_{x}^{2} v\right\|_{L_{x}^{\infty} L_{T}^{2}} & \left\|v_{0}\right\|_{H^{1}}+\left(1+\|v\|_{L_{T}^{\infty} H_{x}^{1}}^{2}\right)\|w\|_{X^{s, 1 / 2,1}} \\
& +\|v\|_{L_{T}^{\infty} H_{x}^{1}}\left(\|v\|_{L_{T}^{\infty} H_{x}^{1}}+\varepsilon^{1 / 2}\left\|\partial_{x}^{2} v\right\|_{\widetilde{L_{x}^{\infty} L_{T}^{2}}}\right) \tag{6.18}
\end{align*}
$$

Proof. (6.16) and (6.17) can be proven exactly as in Proposition 3.2 with (6.1)-(6.8) in hand. (6.18) can be proven as (3.11) in Proposition 3.2 with (6.9) in hand, using that by Bernstein inequality, for any $v \in L_{T, x}^{2}$ and $\varepsilon>0$ it holds

$$
\left\|P_{\leq 100 / \varepsilon} v\right\|_{L_{x}^{\infty} L_{T}^{2}} \lesssim \varepsilon^{-1 / 2}\|v\|_{L_{T x}^{2}} .
$$

Gathering Lemmas 6.3-6.6 we obtain that (1.1) is uniformly well-posed in $H^{1}(\mathbb{R})$, i.e.

Proposition 6.7. For any $R>0$ there exists a positive time $T=T(R)$ and a positive real number $C(R)$ such that for all $0<\varepsilon \leq 1$ and any initial data $v_{0} \in H^{1}(\mathbb{R})$, with $\left\|v_{0}^{j}\right\|_{H^{1}} \leq C(R)$, it holds

$$
\begin{equation*}
\left\|S_{\varepsilon}(t) v_{0}^{j}\right\|_{L_{T}^{\infty} H_{x}^{1}} \leq C(R) \tag{6.19}
\end{equation*}
$$

Moreover for any couple of initial data $\left(v_{0}^{1}, v_{0}^{2}\right) \in H^{1}(\mathbb{R})^{2}$ with $\left\|v_{0}^{j}\right\|_{H^{1}} \leq C(R)$ and $P_{1}\left(v_{0}^{1}\right)=P_{1}\left(v_{0}^{2}\right)$ it holds

$$
\begin{equation*}
\left\|S_{\varepsilon}(t) v_{0}^{1}-S_{\varepsilon}(t) v_{0}^{2}\right\|_{L_{T}^{\infty} H_{x}^{1}} \leq C(R)\left\|v_{0}^{1}-v_{0}^{2}\right\|_{H^{1}} \tag{6.20}
\end{equation*}
$$

With this proposition in hand, Theorem 1.2 follows by general arguments developed for instance in [7]. We fix an initial data $v_{0} \in H^{1}(\mathbb{R})$ and $\alpha>0$ and we would like to prove that for $\varepsilon>0$ small enough,

$$
\left\|S_{\varepsilon}(t) v-S(t) v\right\|_{L_{T}^{\infty} H_{x}^{1}} \leq \alpha
$$

where $T=T\left(\left\|v_{0}\right\|_{H^{1}}\right)$. The result for any fixed $T>0$ follows by iterating the argument and using the continuity of the flow-map for the Benjamin-Ono equation. First, thanks to (6.20) there exists $r_{\alpha}>1$ such that for all $\left.\left.\varepsilon \in\right] 0,1\right]$ it holds

$$
\left\|S_{\varepsilon}(t) v_{0}-S_{\varepsilon}(t) P_{\leq r_{\alpha}} v_{0}\right\|_{L_{T}^{\infty} H_{x}^{1}} \leq \alpha / 3 \text { and }\left\|S(t) v_{0}-S(t) P_{\leq r_{\alpha}} v_{0}\right\|_{L_{T}^{\infty} H_{x}^{1}} \leq \alpha / 3
$$

On the other hand, denoting by $w_{r_{\alpha}}$ the gauge transform of $S(t) P_{r_{\alpha}} v_{0}$ and noticing that the Benjamin-Ono equation (1.5) can be rewritten as

$$
\begin{aligned}
& \partial_{t} v-b \mathcal{H} \partial_{x}^{2} v-a \epsilon \partial_{x}^{3} v-c v \partial_{x} v+d \epsilon \partial_{x}\left(v \mathcal{H} \partial_{x} v-\mathcal{H}\left(v \partial_{x} v\right)\right) \\
& =d \epsilon \partial_{x}\left(v \mathcal{H} \partial_{x} v-\mathcal{H}\left(v \partial_{x} v\right)\right)-a \epsilon \partial_{x}^{3} v
\end{aligned}
$$

we can proceed exactly as in the obtention of the Lipschitz bound (6.20) to get

$$
\left\|S_{\varepsilon}(t) P_{\leq r_{\alpha}} v_{0}-S(t) P_{\leq r_{\alpha}} v_{0}\right\|_{L_{T}^{\infty} H_{x}^{1}} \lesssim C(R) T \varepsilon\left(\left\|w_{r_{\alpha}}\right\|_{L_{T}^{\infty} H^{3}}+p\left(N_{T}^{3}\left(S(t) P_{\leq r_{\alpha}} v_{0}\right)\right)\right.
$$

where $p$ is a polynomial function and the $N_{T}^{s}$-norm is defined in (5.3). This yields the result by taking $\varepsilon>0$ small enough.
