# PERTURBATIONS OF FLEXIBLE LATTÈS MAPS 

XAVIER BUFF AND THOMAS GAUTHIER


#### Abstract

We prove that any Lattès map can be approximated by strictly postcritically finite rational maps which are not Lattès maps.


## Introduction

A rational map of degree $D \geq 2$ is strictly postcritically finite if the orbit of each critical point intersects a repelling cycle. Among those, flexible Latts maps (the definition is given below) play a special role. The following result answers a question raised in BE .
Theorem. Every flexible Lattès map can be approximated by strictly postcritically finite rational maps which are not Lattès maps.

Given $D \geq 2$, denote by $\operatorname{Rat}_{D}$ the space of rational maps of degree $D$. A rational map $f \in \operatorname{Rat}_{D}$ has a Julia set $J_{f}$ which may be defined as the closure of the set of repelling cycles of $f$. The Julia set is the support of a measure $\mu_{f}$ which may be defined as the unique invariant measure of (maximal) entropy $\log D$.

The bifurcation locus in $\operatorname{Rat}_{D}$ is the closure of the set of discontinuity of the map $f \mapsto J_{f}$. Laura DeMarco DeM proved that the bifurcation locus is the support of a positive closed $(1,1)$-current $T_{\text {bif }}:=d d^{c} \mathfrak{L}$, where $\mathfrak{L}$ is the plurisubharmonic function which sends a rational map $f$ to its Lyapunov exponent with respect to $\mu_{f}$.

Möbius transformations act by conjugacy on $\operatorname{Rat}_{D}$ and the quotient space is an orbifold known as the moduli space $\mathcal{M}_{D}$ of rational maps of degree $D$. Giovanni Bassanelli and François Berteloot BB1 introduced a measure $\mu_{\text {bif }}$ on this moduli space, which may be obtained by pushing forward $T_{\text {bif }}^{\wedge(2 D-2)}$.

In [BE], the first author and Adam Epstein, using a transversality result in Rat ${ }_{D}$, proved that the conjugacy class of a strictly postcritically finite map which is not a flexible Lattès map is in the support of $\mu_{\text {bif }}$. Since the support of $\mu_{\text {bif }}$ is closed and since the conjugacy class of a strictly postcritically finite rational maps which is not a Lattès maps is in this support, our result has the following consequence.

Corollary 1. The classes of flexible Lattès maps in $\mathcal{M}_{D}$ lie in the support of the bifurcation measure $\mu_{\mathrm{bif}}$.

In (G1, the second author proved that the support of the bifurcation measure has maximal Hausdorff dimension, i.e. has dimension $2(2 D-2)$, and that it is homogeneous (the support of $\mu_{\text {bif }}$ has maximal dimension in any neighborhood of its points). Corollary 1 thus yields the following result.
Corollary 2. Let $f \in \operatorname{Rat}_{D}$ be a flexible Lattès map and let $V \subset \mathcal{M}_{D}$ be an open neighborhood of the conjugacy class of $f$. Then, $\operatorname{dim}_{H}\left(\operatorname{supp}\left(\mu_{\text {bif }}\right) \cap V\right)=2(2 D-2)$.

[^0]Bassanelli and Berteloot BB2 proved that every point in the support of $\mu_{\text {bif }}$ can be approximated by rational maps having $2 D-2$ distinct neutral cycles. Their argument can be adapted to prove that the support of $\mu_{\text {bif }}$ can be approximated by hyperbolic maps having $2 D-2$ distinct attracting cycles (see [B] Section 5.2). By Corollary 1, we have the following result.

Corollary 3. Any flexible Lattès map $f \in$ Rat $_{D}$ can be approximated by hyperbolic rational maps having $2 D-2$ distinct attracting cycles.

## 1. Flexible Lattès maps

Following Milnor [M], we define a flexible Lattès map of degree $D \geq 2$ to be a rational map $f: \widehat{\mathbb{C}} \rightarrow \widehat{\mathbb{C}}$ for which there is a commutative diagram :

where

- $\Lambda \subset \mathbb{C}$ is a lattice of rank 2 ;
- $\mathcal{T}:=\mathbb{C} / \Lambda$ is the quotient torus;
- $L: \mathcal{T} \ni \tau \mapsto a \tau+b \in \mathcal{T}$ with $a \in \mathbb{Z}, a^{2}=D$, and $2 b \in \Lambda /(2 \Lambda+(a-1) \Lambda)$;
- $\Theta: \mathcal{T} \rightarrow \widehat{\mathbb{C}}$ is a 2 -to- 1 holomorphic map ramifying at points in $\Lambda / 2$.

In the rest of the article, the lattice $\Lambda$ will be of the form $\Lambda=\mathbb{Z} \oplus \gamma \mathbb{Z}$, where $\gamma$ is a complex number which is allowed to vary in the upper half-plane $\mathbb{H}$ of complex numbers with positive imaginary part. We shall use the following normalization for $\Theta_{\gamma}: \mathcal{T} \rightarrow \widehat{\mathbb{C}}:$

$$
\Theta_{\gamma}(0)=0, \quad \Theta_{\gamma}\left(\frac{\gamma+1}{2}\right)=\infty, \quad \Theta_{\gamma}\left(\frac{1}{2}\right)=v(\gamma) \quad \text { and } \quad \Theta_{\gamma}\left(\frac{\gamma}{2}\right)=w(\gamma)
$$

where $v: \mathbb{H} \rightarrow \mathbb{C}-\{0\}$ and $w: \mathbb{H} \rightarrow \mathbb{C}-\{0\}$ are holomorphic functions (this may be achieved for example by requiring that $v \equiv 1$ ). Then, for all $\gamma \in \mathbb{H}, v(\gamma) \neq w(\gamma)$.

The derivative of the torus endomorphism $L_{\gamma}: \mathcal{T}_{\gamma} \rightarrow \mathcal{T}_{\gamma}$ will be a fixed integer $a$ which does not depend on $\gamma$. When $a= \pm 2$, the critical value set of the Lattès map $f_{\gamma}: \widehat{\mathbb{C}} \rightarrow \widehat{\mathbb{C}}$ is $\{\infty, v(\gamma), w(\gamma)\}$ and if $|a| \geq 3$, the critical value set is $\{0, \infty, v(\gamma), w(\gamma)\}$. In all cases, the postcritical set of $f_{\gamma}$ is $\{0, \infty, v(\gamma), w(\gamma)\}$. More precisely, we will have to study three cases :

- Case 1: $a$ is even and $L_{\gamma}(\tau)=a \tau$. In that case, all the critical values are mapped to 0 which is a fixed point of $f$.
- Case 2: $a$ is odd and $L_{\gamma}(\tau)=a \tau$. In that case, all the critical values are fixed with multiplier $a^{2}$.
- Case 3: $a$ is odd and $L_{\gamma}(\tau)=a \tau+(\gamma+1) / 2$. In that case, the Lattès map permutes the critical value at 0 with that at infinity. It also permutes the critical value at $v(\gamma)$ with the critical value at $w(\gamma)$. The multiplier of each cycle is $a^{4}$.

From now on, we assume that we are in one of those three cases, and we consider the analytic family of Lattès maps

$$
\mathbb{H} \ni \gamma \mapsto f_{\gamma} \in \operatorname{Rat}_{D}
$$

where $\operatorname{Rat}_{D}$ is the space of rational maps of degree $D$. We shall use the notation $f, v, w, \ldots$ in place of $f_{\gamma}, v(\gamma), w(\gamma), \ldots$ when $\gamma$ is assumed to be fixed and there is no confusion.

## 2. Estimates for $\Theta$

Lemma 1. As $\tau \rightarrow 0$, we have the following expansion

$$
\Theta(1 / 2+\tau)=v+\lambda \tau^{2}+o\left(\tau^{2}\right) \quad \text { and } \quad \Theta(\gamma / 2+\tau)=w+\mu \tau^{2}+o\left(\tau^{2}\right)
$$

with

$$
\frac{\lambda}{v}=-\frac{\mu}{w} \neq 0
$$

Proof. Since $\Theta$ has simple critical points at $1 / 2$ and $\gamma / 2$, we have an expansion as in the statement with $\lambda \neq 0$ and $\mu \neq 0$. Our work consists in proving the relation between $\lambda / v$ and $\mu / w$. Let $q$ be the meromorphic quadratic differential on $\widehat{\mathbb{C}}$ defined by:

$$
q:=\frac{d z^{2}}{z(z-v)(z-w)} .
$$

Since $q$ has simple poles and since $\Theta$ is totally ramified above the polar set of $q$, the quadratic differential $\Theta^{*} q$ is holomorphic on $\mathcal{T}$, whence

$$
\Theta^{*} q=\kappa \cdot d \tau^{2} \quad \text { with } \quad \kappa \in \mathbb{C}-\{0\}
$$

Let $\tau$ tend to 0 and set $z=\Theta(1 / 2+\tau)$. Then, $z-v \sim \lambda \tau^{2}$ and $d z^{2} \sim 4 \lambda^{2} \tau^{2} d \tau^{2}$. It follows that

$$
\frac{d z^{2}}{z(z-v)(z-w)} \sim \frac{4 \lambda^{2} \tau^{2} d \tau^{2}}{v \cdot(v-w) \cdot \lambda \tau^{2}}=\frac{4 \lambda d \tau^{2}}{v(v-w)} .
$$

This show that

$$
\kappa=\frac{4 \lambda}{v(v-w)} .
$$

Using the expansion of $\Theta$ at $\gamma / 2$ yields similarly

$$
\kappa=\frac{4 \mu}{w(w-v)} .
$$

The result now follows easily.

## 3. Hyperbolic sets

From now on, we let $\alpha, \alpha^{\prime}, \beta$ and $\beta^{\prime}$ be rational numbers. We assume that the denominators of $\alpha$ and $\beta$ are coprime with $a$ and 2 . We let $\sigma$ and $\tau$ be the points in the torus $\mathcal{T}$ defined by

$$
\sigma:=\alpha+\alpha^{\prime} \gamma \quad \text { and } \quad \tau:=\beta+\beta^{\prime} \gamma
$$

Remark that, as $\sigma$ and $\tau$ have rational coordinates, they are (pre)periodic under multiplication by $a$ and that $\sigma, \tau, a \sigma$ and $a \tau$ are (pre)periodic under multiplication by $a^{2}$. For each integer $k \geq 1$, let $\tau_{k}$ and $\sigma_{k}$ be the points in $\mathcal{T}$ defined by

$$
\sigma_{k}:=\frac{1}{2}+\frac{\sigma}{a^{k}} \quad \text { and } \quad \tau_{k}:=\frac{\gamma}{2}+\frac{\tau}{a^{k}}
$$

and let $x_{k}$ and $y_{k}$ be the points in $\widehat{\mathbb{C}}$ defined by

$$
x_{k}:=\Theta\left(\sigma_{k}\right) \quad \text { and } \quad y_{k}:=\Theta\left(\tau_{k}\right)
$$

We shall denote by $X, Y$, and $Z$ the following subsets of $\widehat{\mathbb{C}}$ :

$$
X:=\bigcup_{k \geq 1} \bigcup_{n \geq 0} f^{\circ n}\left(x_{k}\right), \quad Y:=\bigcup_{k \geq 1} \bigcup_{n \geq 0} f^{\circ n}\left(y_{k}\right) \quad \text { and } \quad Z:=X \cup Y \cup\{0, \infty, v, w\}
$$

Note that $Z$ is an invariant set.
Lemma 2. There is a neighborhood $\mathbf{G}$ of $f$ in $\operatorname{Rat}_{D}$ and a dynamical holomorphic motion $\phi: \mathbf{G} \times Z \rightarrow \widehat{\mathbb{C}}$ such that for all $g \in \mathbf{G}$ and all $z \in Z$, we have

$$
g(\phi(g, z))=\phi(g, g(z))
$$

Proof. Case 1 : $a$ is even. In that case, $f^{\circ k}$ maps $x_{k}$ to $\Theta(\sigma)$ and $y_{k}$ to $\Theta(\tau)$. Since $\sigma$ and $\tau$ are (pre)periodic under the action of $L$, the points $x_{k}$ and $y_{k}$ are (pre)periodic.

Case 2 : $a$ is odd and $b=0$. In that case, $f^{\circ k}$ maps $x_{k}$ to $\Theta\left(\frac{1}{2}+\sigma\right)$ and $y_{k}$ to $\Theta\left(\frac{\gamma}{2}+\tau\right)$. As $L\left(\frac{1}{2}+\sigma\right)=\frac{1}{2}+a \sigma$ and $L\left(\frac{\gamma}{2}+\tau\right)=\frac{\gamma}{2}+a \tau$ and as $\sigma$ and $\tau$ are (pre)periodic under multiplication by $a$, the points $\frac{1}{2}+\sigma$ and $\frac{\gamma}{2}+\tau$ are (pre)periodic under the action of $L$, which means that the points $x_{k}$ and $y_{k}$ are (pre)periodic.

Case 3: $a$ is odd and $b=(\gamma+1) / 2$. In that case, we use that

$$
L^{\circ 2}\left(\frac{1}{2}+z\right)=\frac{1}{2}+a^{2} z \quad \text { and } \quad L^{\circ 2}\left(\frac{\gamma}{2}+z\right)=\frac{\gamma}{2}+a^{2} z
$$

for any $z \in \mathcal{T}$. If $k$ is even, $f^{\circ k}$ maps $x_{k}$ to $\Theta\left(\frac{1}{2}+\sigma\right)$ and $y_{k}$ to $\Theta\left(\frac{\gamma}{2}+\tau\right)$. Since $\sigma$ and $\tau$ are (pre)periodic under multiplication by $a^{2}, \frac{1}{2}+\sigma$ and $\frac{\gamma}{2}+\tau$ are (pre)periodic under iteration of $L^{\circ 2}$ and the points $x_{k}$ and $y_{k}$ are (pre)periodic.

Now, if $k$ is odd, $f^{\circ k}$ maps $x_{k}$ to $\Theta\left(\frac{\gamma}{2}+\sigma\right)$ and $y_{k}$ to $\Theta\left(\frac{1}{2}+\tau\right)$. Since $L\left(\frac{\gamma}{2}+\sigma\right)=$ $\frac{1}{2}+a \sigma$ and $L\left(\frac{1}{2}+\tau\right)=\frac{\gamma}{2}+a \tau$ and since $a \sigma$ and $a \tau$ are (pre)periodic under multiplication by $a^{2}, \frac{1}{2}+a \sigma$ and $\frac{\gamma}{2}+a \tau$ are (pre)periodic under the action of $L^{\circ 2}$, which implies that the points $x_{k}$ and $y_{k}$ are (pre)periodic.

In all cases, the set $Z$ is closed and each point in $Z$ is (pre)periodic to a repelling cycle of $f$. Since the denominators of $\alpha$ and $\beta$ are coprime with $a$ and 2 , the cycles capturing points in $X$ and $Y$ are disjoint from the postcritical set of $f$. In particular, $Z$ does not contain critical points. As a consequence, $Z$ is a hyperbolic
invariant compact set (see [T] Theorem 1.2 page 266) and the result follows (see [S] (1.2) section 2 for a sketch of the proof, or G2] section 2.1 for a proof).

For all $g \in \mathbf{G}$, the map $\phi_{g}: z \mapsto \phi(g, z)$ is a homeomorphism from $Z$ to $Z_{g}:=\phi_{g}(Z)$ which conjugates $f: Z \rightarrow Z$ to $g: Z_{g} \rightarrow Z_{g}$. Every point $z \in Z_{g}$ is (pre)periodic under iteration of $g$ to a repelling cycle of $g$. For $k \geq 1$, we shall use the notation $\mathbf{x}_{k}(g):=\phi_{g}\left(x_{k}\right)$ and $\mathbf{y}_{k}(g):=\phi_{g}\left(y_{k}\right)$. As $k \rightarrow+\infty$, the sequence $x_{k}$ tends to $x_{\infty}:=v$. We set $\mathbf{x}_{\infty}(g):=\phi_{g}(v)$. Similarly, as $k \rightarrow+\infty$, the sequence $y_{k}$ tends to $y_{\infty}:=w$. We set $\mathbf{y}_{\infty}(g):=\phi_{g}(w)$.

## 4. A family of perturbations

Let us now restrict to the family of rational maps $t \mapsto f_{t}$ which is defined for $t \in \mathbb{C}$ by

$$
f_{t}:=(1+t) \cdot f
$$

If $t \neq-1$, the rational map $f_{t}$ has degree $D$ and $f_{0}=f$. The critical values of the rational map $f_{t}$ are contained in the set $\{0, \infty,(1+t) \cdot v,(1+t) \cdot w\}$ and for $t$ sufficiently close to 0 , the point 0 is either a repelling fixed point or a repelling periodic point of period 2 , and $\infty$ is either mapped to a repelling fixed point at 0 , or a repelling fixed point, or a repelling periodic point of period 2 . We will now study the relative motion of the critical values $\mathbf{v}\left(f_{t}\right):=(1+t) \cdot v$ and $\mathbf{w}\left(f_{t}\right):=(1+t) \cdot w$ with respect to the points $\mathbf{x}_{\infty}\left(f_{t}\right)$ and $\mathbf{y}_{\infty}\left(f_{t}\right)$. We will use the notations

$$
\begin{gathered}
\dot{\mathbf{v}}:=\left.\frac{d \mathbf{v}\left(f_{t}\right)}{d t}\right|_{t=0} \in T_{v} \widehat{\mathbb{C}}, \quad \dot{\mathbf{w}}:=\left.\frac{d \mathbf{w}\left(f_{t}\right)}{d t}\right|_{t=0} \in T_{w} \widehat{\mathbb{C}} \\
\dot{\mathbf{x}}_{\infty}:=\left.\frac{d \mathbf{x}_{\infty}\left(f_{t}\right)}{d t}\right|_{t=0} \in T_{v} \widehat{\mathbb{C}}, \quad \text { and } \quad \dot{\mathbf{y}}_{\infty}:=\left.\frac{d \mathbf{y}_{\infty}\left(f_{t}\right)}{d t}\right|_{t=0} \in T_{w} \widehat{\mathbb{C}}
\end{gathered}
$$

We shall also use the notation

$$
\dot{f}:=\left.\frac{d f_{t}}{d t}\right|_{t=0}
$$

which is a section of the pullback bundle $f^{\star} T \widehat{\mathbb{C}}$ : for all $z \in \widehat{\mathbb{C}}, \dot{f}(z) \in T_{f(z)} \widehat{\mathbb{C}}$.
Lemma 3. We have

$$
\frac{\dot{\mathbf{x}}_{\infty}-\dot{\mathbf{v}}}{v}=\frac{\dot{\mathbf{y}}_{\infty}-\dot{\mathbf{w}}}{w} \neq 0
$$

Proof. By construction,

$$
\dot{\mathbf{v}}=v \frac{d}{d z} \quad \text { and } \quad \dot{\mathbf{w}}=w \frac{d}{d z}
$$

In addition, for all $z \in \widehat{\mathbb{C}}$,

$$
\dot{f}(z)=f(z) \frac{d}{d z}
$$

Case 1 : $a$ is even. In that case, $f$ maps $x_{\infty}=v$ to 0 which is a fixed point. As $t$ varies, $f_{t}$ still maps $v$ to 0 and still fixes 0 . Thus, $\mathbf{x}_{\infty} \equiv v$ and $\dot{\mathbf{x}}_{\infty}=0$, whence

$$
\dot{\mathbf{x}}_{\infty}-\dot{\mathbf{v}}=-\dot{\mathbf{v}}
$$

Similarly

$$
\dot{\mathbf{y}}_{\infty}-\dot{\mathbf{w}}=-\dot{\mathbf{w}}
$$

Case 2: $a$ is odd and $b=0$. In that case, $f$ fixes $x_{\infty}=v$. So, $\mathbf{x}_{\infty}\left(f_{t}\right)$ is the fixed point of $f_{t}$ which is close to $v$. Derivating $f_{t}\left(\mathbf{x}_{\infty}\left(f_{t}\right)\right)=\mathbf{x}_{\infty}\left(f_{t}\right)$ with respect to $t$, and evaluating at $t=0$, we get :

$$
\dot{f}(v)+D_{v} f\left(\dot{\mathbf{x}}_{\infty}\right)=\dot{\mathbf{x}}_{\infty}
$$

Since $\dot{f}(v)=v \frac{d}{d z}=\dot{\mathbf{v}}$ and $D_{v} f$ is multiplication by $a^{2}$, we get

$$
\dot{\mathbf{x}}_{\infty}=\frac{\dot{\mathbf{v}}}{1-a^{2}}
$$

whence

$$
\dot{\mathbf{x}}_{\infty}-\dot{\mathbf{v}}=\left(\frac{1}{1-a^{2}}-1\right) \dot{\mathbf{v}}=\frac{a^{2}}{1-a^{2}} \dot{\mathbf{v}}
$$

Similarly

$$
\dot{\mathbf{y}}_{\infty}-\dot{\mathbf{w}}=\frac{a^{2}}{1-a^{2}} \dot{\mathbf{w}}
$$

Case 3 : $a$ is odd and $b=(\gamma+1) / 2$. In that case $f$ permutes $x_{\infty}=v$ and $y_{\infty}=w$. Derivating $f_{t}\left(\mathbf{x}_{\infty}\left(f_{t}\right)\right)=\mathbf{y}_{\infty}\left(f_{t}\right)$ and $f_{t}\left(\mathbf{y}_{\infty}\left(f_{t}\right)\right)=\mathbf{x}_{\infty}\left(f_{t}\right)$ with respect to $t$, and evaluating at $t=0$, we get :

$$
\begin{equation*}
\dot{f}(v)+D_{v} f\left(\dot{\mathbf{x}}_{\infty}\right)=\dot{\mathbf{y}}_{\infty} \quad \text { and } \quad \dot{f}(w)+D_{w} f\left(\dot{\mathbf{y}}_{\infty}\right)=\dot{\mathbf{x}}_{\infty} \tag{1}
\end{equation*}
$$

On the one hand $\dot{f}(v)=w \frac{d}{d z}=\dot{\mathbf{w}}$ and $\dot{f}(w)=v \frac{d}{d z}=\dot{\mathbf{v}}$. On the other hand,

$$
L\left(\frac{1}{2}+\tau\right)=\frac{\gamma}{2}+a \tau \quad \text { and } \quad L\left(\frac{\gamma}{2}+\tau\right)=\frac{1}{2}+a \tau
$$

Thus,
$f\left(v+\lambda \tau^{2}+o\left(\tau^{2}\right)\right)=w+\mu a^{2} \tau^{2}+o\left(\tau^{2}\right) \quad$ and $\quad f\left(w+\mu \tau^{2}+o\left(\tau^{2}\right)\right)=v+\lambda a^{2} \tau^{2}+o\left(\tau^{2}\right)$
which implies

$$
\lambda f^{\prime}(v)=\mu a^{2} \quad \text { and } \quad \mu f^{\prime}(w)=\lambda a^{2}
$$

By Lemma it follows that

$$
D_{v} f\left(\dot{\mathbf{x}}_{\infty}\right)=\frac{\mu a^{2}}{\lambda} \dot{\mathbf{x}}_{\infty}=-\frac{a^{2} w}{v} \dot{\mathbf{x}}_{\infty}
$$

Similarly,

$$
D_{w} f\left(\dot{\mathbf{y}}_{\infty}\right)=-\frac{a^{2} v}{w} \dot{\mathbf{x}}_{\infty}
$$

So, equation (1) yields

$$
\dot{\mathbf{w}}-\frac{a^{2} w}{v} \dot{\mathbf{x}}_{\infty}=\dot{\mathbf{y}}_{\infty} \quad \text { and } \quad \dot{\mathbf{v}}-\frac{a^{2} v}{w} \dot{\mathbf{y}}_{\infty}=\dot{\mathbf{x}}_{\infty}
$$

which boils down to

$$
\dot{\mathbf{x}}_{\infty}=\frac{1-a^{2}}{1-a^{4}} \dot{\mathbf{v}} \quad \text { and } \quad \dot{\mathbf{y}}_{\infty}=\frac{1-a^{2}}{1-a^{4}} \dot{\mathbf{w}}
$$

As a consequence

$$
\dot{\mathbf{x}}_{\infty}-\dot{\mathbf{v}}=\left(\frac{1-a^{2}}{1-a^{4}}-1\right) \dot{\mathbf{v}}=-\frac{a^{2}}{1+a^{2}} \dot{\mathbf{v}}
$$

Similarly

$$
\dot{\mathbf{y}}_{\infty}-\dot{\mathbf{w}}=-\frac{a^{2}}{1+a^{2}} \dot{\mathbf{w}} .
$$

In all cases, there is a constant $c \neq 0\left(c=-1\right.$ in the first case, $c=a^{2} /\left(1-a^{2}\right)$ in the second case and $c=-a^{2} /\left(1+a^{2}\right)$ in the third case) such that

$$
\dot{\mathbf{x}}_{\infty}-\dot{\mathbf{v}}=c \dot{\mathbf{v}}=c v \frac{d}{d z} \quad \text { and } \quad \dot{\mathbf{y}}_{\infty}-\dot{\mathbf{w}}=c \dot{\mathbf{w}}=c w \frac{d}{d z} .
$$

This shows that

$$
\frac{\dot{\mathbf{x}}_{\infty}-\dot{\mathbf{v}}}{v}=\frac{\dot{\mathbf{y}}_{\infty}-\dot{\mathbf{w}}}{w}=c \frac{d}{d z} \neq 0
$$

## 5. Proof of the Theorem

Let $\gamma_{0}:=x_{0}+i y_{0} \in \mathbb{H}$ be a point with rational real part $x_{0}$ and rational imaginary part $y_{0}$ which are coprime with $a$ and 2 . Set $\alpha:=-x_{0}, \alpha^{\prime}:=1, \beta:=y_{0}$ and $\beta^{\prime}:=0$. We will now allow $\gamma$ to vary in $\mathbb{H}$. So, $\sigma, \tau, v, w, \lambda, \mu, \sigma_{k}, \tau_{k}, x_{k}, y_{k}, x_{\infty}, y_{\infty}$ are functions of $\gamma$. For example,

$$
\sigma: \mathbb{H} \ni \gamma \mapsto \alpha+\alpha^{\prime} \gamma \in \mathbb{H} \quad \text { and } \quad \tau: \mathbb{H} \ni \gamma \mapsto \beta+\beta^{\prime} \gamma \in \mathbb{H} .
$$

Note that the Möbius transformation $\sigma / \tau$ sends $\gamma_{0}$ to $i$.
We still consider the family of flexible Lattès maps $\mathbb{H} \ni \gamma \mapsto f_{\gamma} \in \operatorname{Rat}_{D}$ and we introduce the family of perturbed maps

$$
\mathbb{H} \times(\mathbb{C}-\{-1\}) \ni(\gamma, t) \longmapsto f_{\gamma, t}:=(1+t) \cdot f_{\gamma} \in \operatorname{Rat}_{D} .
$$

As in the previous section, we will consider the critical value functions

$$
\mathbf{v}: f_{\gamma, t} \mapsto(1+t) \cdot v(\gamma) \quad \text { and } \quad \mathbf{w}: f_{\gamma, t} \mapsto(1+t) \cdot w(\gamma)
$$

The notation $\dot{\mathbf{v}}, \dot{\mathbf{w}}, \dot{\mathbf{x}}_{\infty}, \dot{\mathbf{y}}_{\infty}$ refers to the derivative with respect to $t$ evaluated at $t=0$. In particular, those are functions of $\gamma \in \mathbb{H}$.

Lemma 4. There are a neighborhood $\Gamma$ of $\gamma_{0}$ in $\mathbb{H}$, an integer $k_{0}$ and for $k \geq k_{0}$, holomorphic functions $s_{k}: \Gamma \rightarrow \mathbb{C}$ and $t_{k}: \Gamma \rightarrow \mathbb{C}$ such that :

- the sequences $\left(s_{k}\right)$ and $\left(t_{k}\right)$ converge uniformly on $\Gamma$ to 0 ,
- $\mathbf{x}_{k}\left(f_{\gamma, s_{k}(\gamma)}\right)=\mathbf{v}\left(f_{\gamma, s_{k}(\gamma)}\right), \mathbf{y}_{k}\left(f_{\gamma, t_{k}(\gamma)}\right)=\mathbf{w}\left(f_{\gamma, t_{k}(\gamma)}\right)$ and
- the sequence $\left(s_{k} / t_{k}\right)$ converges uniformly on $\Gamma$ to $-\sigma^{2} / \tau^{2}$.

Proof. First, note that as $k \rightarrow+\infty$, the holomorphic functions $x_{k}: \mathbb{H} \rightarrow \widehat{\mathbb{C}}$ and $v: \mathbb{H} \rightarrow \widehat{\mathbb{C}}$ satisfy

$$
x_{k}-v \sim \lambda \cdot\left(\sigma_{k}-\frac{1}{2}\right)^{2}=\frac{\lambda \sigma^{2}}{a^{2 k}} .
$$

Second, let us consider the sequence of functions

$$
\mathfrak{X}_{k}:=(\gamma, u) \mapsto a^{2 k} \cdot\left(\mathbf{x}_{k}\left(f_{\gamma, u / a^{2 k}}\right)-\mathbf{v}\left(f_{\gamma, u / a^{2 k}}\right)\right) .
$$

Note that as $k \rightarrow+\infty$,

$$
\begin{aligned}
\mathfrak{X}_{k}(\gamma, u) & =a^{2 k} \cdot\left(x_{k}(\gamma)+\frac{u}{a^{2 k}} \cdot \dot{\mathbf{x}}_{\infty}(\gamma)-v(\gamma)-\frac{u}{a^{2 k}} \cdot \dot{\mathbf{v}}(\gamma)+o\left(1 / a^{2 k}\right)\right) \\
& =\lambda(\gamma) \sigma^{2}(\gamma)+u \cdot\left(\dot{\mathbf{x}}_{\infty}(\gamma)-\dot{\mathbf{v}}(\gamma)\right)+o(1)
\end{aligned}
$$

So, as $k \rightarrow+\infty$, the sequence $\left(\mathfrak{X}_{k}\right)$ converges uniformly on every compact subset of $\mathbb{H} \times \mathbb{C}$ to the function

$$
\mathfrak{X}_{\infty}:(\gamma, u) \mapsto \lambda \sigma^{2}+u \cdot\left(\dot{\mathbf{x}}_{\infty}-\dot{\mathbf{v}}\right) .
$$

According to Lemma 3 $\dot{\mathbf{x}}_{\infty}-\dot{\mathbf{v}}$ does not vanish on $\mathbb{H}$. Thus, the function $\mathfrak{X}_{\infty}$ vanishes along the graph of a holomorphic function $u_{\infty}: \mathbb{H} \rightarrow \mathbb{C}$ which satisfies

$$
u_{\infty} \cdot\left(\dot{\mathbf{x}}_{\infty}-\dot{\mathbf{v}}\right)=-\lambda \sigma^{2}
$$

Since $\left(\mathfrak{X}_{k}\right)$ converges locally uniformly to $\mathfrak{X}_{\infty}$, given any neighborhood $\Gamma$ of $\gamma_{0}$ compactly contained in $\mathbb{H}$, there are, for $k$ large enough, holomorphic functions $u_{k}: \Gamma \rightarrow \mathbb{C}$ which satisfy

$$
(\forall \gamma \in \Gamma) \quad \mathfrak{X}_{k}\left(\gamma, u_{k}(\gamma)\right)=0
$$

the sequence $u_{k}$ converging uniformly on $\Gamma$ to $u_{\infty}$. Now, set

$$
s_{k}:=\frac{u_{k}}{a^{2 k}}: \Gamma \rightarrow \mathbb{C} .
$$

Then the sequence $\left(s_{k}\right)$ obviously converges uniformly to 0 on $\Gamma$ and

$$
\mathbf{x}_{k}\left(f_{\gamma, s_{k}(\gamma)}\right)=\mathbf{v}\left(f_{\gamma, s_{k}(\gamma)}\right) \quad \text { and } \quad a^{2 k} \cdot s_{k} \cdot\left(\dot{\mathbf{x}}_{\infty}-\dot{\mathbf{v}}\right) \underset{k \rightarrow+\infty}{\longrightarrow}-\lambda \sigma^{2}
$$

Similarly, there are, for $k$ large enough, holomorphic functions $t_{k}: \Gamma \rightarrow \mathbb{C}$ which converge uniformly on $\Gamma$ to 0 and satisfy

$$
\mathbf{y}_{k}\left(f_{\gamma, t_{k}(\gamma)}\right)=\mathbf{w}\left(f_{\gamma, t_{k}(\gamma)}\right) \quad \text { and } \quad a^{2 k} \cdot t_{k} \cdot\left(\dot{\mathbf{y}}_{\infty}-\dot{\mathbf{w}}\right) \underset{k \rightarrow+\infty}{\longrightarrow}-\mu \tau^{2}
$$

Those uniform convergences on $\Gamma$ may be reformulated as

$$
a^{2 k} \cdot \frac{s_{k}}{\sigma^{2}} \underset{k \rightarrow+\infty}{\longrightarrow}-\frac{\dot{\mathbf{x}}_{\infty}-\dot{\mathbf{v}}}{\lambda} \quad \text { and } \quad a^{2 k} \cdot \frac{t_{k}}{\tau^{2}} \underset{k \rightarrow+\infty}{\longrightarrow}-\frac{\dot{\mathbf{y}}_{\infty}-\dot{\mathbf{w}}}{\mu} .
$$

According to Lemma 1 and Lemma 3

$$
\frac{\dot{\mathbf{x}}_{\infty}-\dot{\mathbf{v}}}{\lambda}=-\frac{\dot{\mathbf{y}}_{\infty}-\dot{\mathbf{w}}}{\mu}
$$

are non-vanishing functions. This shows that the sequence $\left(s_{k} / t_{k}\right)$ converges uniformly on $\Gamma$ to $-\sigma^{2} / \tau^{2}$.

The previous construction yields, for $k$ large enough, functions $s_{k}$ and $t_{k}$ which are defined and holomorphic near $\gamma_{0}$. As $k \rightarrow+\infty$, the sequence of functions $\left(1-s_{k} / t_{k}\right)$ converges to $1+\sigma^{2} / \tau^{2}$ which has a simple zero at $\gamma_{0}$. Therefore, for $k$ large enough, the function $s_{k} / t_{k}$ takes the value 1 at a point $\gamma_{k}$ close to $\gamma_{0}$ :

$$
s_{k}\left(\gamma_{k}\right)=t_{k}\left(\gamma_{k}\right) \quad \text { with } \quad \gamma_{k} \underset{k \rightarrow+\infty}{\longrightarrow} \gamma_{0} .
$$

Let $g_{k} \in \operatorname{Rat}_{D}$ be the rational map

$$
g_{k}:=\left(1+r_{k}\right) \cdot f_{\gamma_{k}} \quad \text { with } \quad r_{k}:=s_{k}\left(\gamma_{k}\right)=t_{k}\left(\gamma_{k}\right) .
$$

Note that $r_{k}$ tends to 0 and that $g_{k}$ converges to $f_{\gamma_{0}}$ as $k$ tends to $+\infty$. The critical values of $g_{k}$ are contained in the set $\left\{0, \infty,\left(1+r_{k}\right) v,\left(1+r_{k}\right) w\right\}$ (if $a=2$, then 0 is not a critical value). By construction, 0 and $\infty$ are (pre)periodic to repelling cycles. In addition, $\left(1+r_{k}\right) v$ coincides with $x_{k}\left(r_{k}\right)$ which is (pre)periodic to a repelling cycle and $\left(1+r_{k}\right) w$ coincides with $y_{k}\left(r_{k}\right)$ which is also (pre)periodic to a repelling cycle. Thus, $g_{k}$ is strictly postcritically finite but is not a Lattès map.

We have just proved that $f_{\gamma_{0}}$ can be approximated by rational maps $g_{k}$ which are strictly postcritically finite but which are not Lattès maps. Since the set of allowable $\gamma_{0}$ is dense in the upper-half plane, this shows that any flexible Lattès map can be approximated by rational maps which are strictly postcritically finite but which are not Lattès maps.
